

Lack of postmaster puts Guilderland Center facility on the block

No decision has been made as to the future of the Guilderland Center post office, said Margaret Pepe, manager of marketing and customer relations for the Postal Service in the Albany postal district, but that was little consolation to residents who attended a discussion on the proposal at

"I think this would be an extreme inconvenience," said Rosemary Thomas, a 50-year resident of Guilderland Center who fears she may have to drive 10 miles round trip if her P.O. box is moved to the Altamont post office, which is one of the scenarios if the Guilderland Center post office is closed.







BC vandalism probe continues

Bethlehem police continue to investigate an instance of vandalism at the Bethlehem Central School District's Operations and Maintenance facility that crippled most the vehicle fleet for a day.

On Monday, May 9, district workers came to work to discover damage done to 15 vehicles and seven tractors or mowers, including punctured

tires and obscenities and swastikas etched into paint.

"Our detectives and our school resource officers are continuing to follow up on leads, but no arrests have been made at this time.' Lt. Thomas Heffernan of the Bethlehem Police Department said. "It continued to be an active and ongoing investigation. We're still working closely. with officials from the schools.'

The district was forced to replace more than 40 tires as the result of the vandalism and had to make other repairs, including removing grass and mud from fuel tanks and replacing broken windows. Altogether, the repairs set the district back \$26,000:

This brings me back to what I chose to do instead of complaining about all this awful weather: find the good in it. If the rains must come, then perhaps we should celebrate them.



Strawberry Rhubarb Bars with Grand Marnier

2-1/4 cups all purpose flour, sifted

1/2 cup powdered _sugar 🖫

1-1/2 sticks butter 1/4 cup olive oil pinch sea salt

rhubarb, cut into 1inch pieces

1-1/2 cups sliced fresh strawberries

1 tbsp lemon juice 1/2 cup sugar

2 tablespoons cornstarch

1/4 cup Grand Marnier

Crumble topping: 1-1/2 cups fresh 1/2 cup flour, 1/2 cup brown sugar, 1/4 cup almonds, 4 tablespoons unsalted butter

Preheat oven to 350 degrees. Sift the flour and powdered sugar together. Pulse together with the butter, oil and salt in a food processor until it resembles coarse meal. Press into a 13x9x2-inch pan. Bake for 20 minutes, until pale golden brown. Remove from the oven. In a medium saucepan, combine the rhubarb, strawberries, lemon juice and cornstarch. Bring to a simmer and lower the heat. Cook and stir for about 10 minutes, or until the mixture is very thick. Stir in the Grand Marnier. Pour over prepared crust. Pulse the topping ingredients in a food processor about 10 times, until chopped and well combined. Use your fingers to spread it over the top of the rhubarb mixture. Bake for 40 minutes. Cool completely and cut into squares.





GOP is MIA

Where is Bethlehem's Grand, Old Party?

In the last two supervisor races, the Bethlehem Republican Party has been unable to field a viable candidate from their own ranks, resorting to cherry picking candidates from other parties — Sam Messina, an Independent, in 2009 and now Kyle Kotary, a Democrat, for this year's election.

Ralph Ambrosio tells Charles Wiff in our story on page one. "We're not about party lines, we're not about doing anything other than trying to do what's best for the Town of Bethlehem."

That sounds great, and it certainly does jibe with the conventional wisdom that political parties are interchangeable at the local level, but something seems off about the whole situation.

First off, let's take a look at that particular piece of conventional wisdom: On most issues, sure, there can be very little difference between parties at the local level, but that's assuming these things exist in a vacuum — a vacuum that doesn't include the rest of Albany County and all of its upwardly mobile politicians. Transgressions that are forgivable at the town level can become fatal the farther up they go in the realm of politics. An Independent-cum-Republican-backed town supervisor may be acceptable at the local level, be considered an anomaly by those at the county level, but may be considered outright undesirable by those at the state level — which wouldn't be a problem for local parties if not for their county bosses' aspirations.

Admittedly, we're not exactly sure what was Messina's undoing with the Republican Party. Bidding on the Normanside was a very un-Republican thing to do, we guess, but Kotary was a part of that process too.

What we are sure of is that the GOP in Bethlehem has been MIA for the past two election cycles, and that's too bad. The voting public will no doubt see this as evidence of some back-door dealing between town and county politicians — they already have speculated as much on our website and others — and, to tell the truth, they would be wise in their questioning of every move these two parties make.

The decision by the GOP to endorse Kotary for the supervisor's race certainly raises a lot of questions, not the least of which is when will the Republicans in Bethlehem field a candidate from their own ranks for town supervisor and who will it be?

Town can do right for auto owner

Editor, The Spotlight:

The Spotlight reported in a series of articles that the collapse of part of the east parapet wall of Bethlehem Town Hall damaged or destroyed four vehicles.

Regarding the report that the town's insurer. has offered John Hotchin \$11,750 for his 2004 Toyota Prius and that the New York State Constitution bans municipalities from compensating a negligence victim in excess of actual damage, I would point out to the town council and The Spotlight readers that just because the town's insurer, Trident Argonaut Insurance, claims that an average 2004 Toyota Prius is worth \$11,750, probably a figure representing an average value from a guide such as the one published by the National **Auto Dealers Association** (N.A.D.A.), does not mean John Hotchin's Toyota Prius is worth \$11,750, since the specific Prius may be in better condition than the average Prius, may have more options than the average Prius or may be more expensive inthe Capital District used auto market than in other auto markets around the country.

Although I have no knowledge of whether John Hotchin's factual representations are true. unqualified claims such as Trident's, made without knowledge of relevant facts for a specific automobile. are patently ridiculous. I also would point out a claimant need not convert a valid claim to judgment in order for the town to meet its constitutional obligation not to provide a negligence victim compensation in excess of actual damage.

That is, John Hotchin does not need to file a lawsuit for his claim to

be valid, nor need the automobiles damaged town assume the cost of a legal defense and delegate the responsibility of determining the value of the 2004 Toyota Prius to a New York State Supreme Court judge.

The town council may, and, indeed, may be obligated to, determine the value of any of the or destroyed in order to insure the town does not make a payment in excess of actual damages; in so far as any claimant and the town agree on a value, litigation would be unnecessary.

GOP chair says party will have another candidate within ten davs

It was a very shortlived candidacy.

After media reports of her Republican candidacy for Albany County Executive appeared on Friday, May 20, Jennifer Whalen announced on Saturday, May 21, that she was not in the running.

Whalen, a Colonie resident and real estate broker who ran against Assemblyman Bob Reilly, D-Newtonville, for the 109th Assembly District back in November, said she had been seriously considering running for **Albany County Executive** but wants to focus on a chance to join the New York State Legislature.

"I was considering "But I really want to this juncture."

She came within 600 votes of beating Reilly.

Whalen also cited reasons such as running her own real estate brokerage company, The Whalen Group, and a very active family schedule to tend to. She said it was tough to run such a grueling race so soon after the race for the 109th Assembly seat, forcing her to miss time with her kids last summer.

"I have a very busy family life," she said. "My children play lacrosse and little league. I was at the fields for six hours on Saturday. So I have to tend to my family as well."

Albany County GOP Chairman Don Clarey told other media over the weekend that Whalen was a definite candidate and that the committee had begun lining up pledges for her. Whalen said she never issued any statements that she was running.

"I was considering, that was it," she said. "There are many candidates that are still in that stage, a lot of candidates.'

Whalen said she still has a lot of support in the Republican Party and that she has always had a good working relationship with Clarey. But after Clarey

had questioned whether she had the ability to run such a campaign, she said she would beg to differ.

"We have a good working relationship, but he wasn't really involved at all in the campaign that I ran," Whalen said of her race against Reilly. "Running a campaign in two counties and three towns means I have a great temperament for running. I could go into the racerunning business."

She said she even had some people who are democrats come up to her after church that heard she might run and urged her to do so. Whalen also touted her relationship with the Conservative Party and the Independence Party. But now that she isn't considering running

anymore, Whalen said that she is ready to get behind other GOP candidates, as long as she has the time tó do so.

Clarey, in an interview with The Spotlight on Monday, May 23, said he would not comment on the matter with Whalen, but said that all the party has lost is a week's worth of time. The GOP currently has inquiries from "potential quality candidates," said Clarey, but added he doesn't want to give names yet.

"We will field candidates that are quality candidates that we feel can win," he said, adding that while it is nearly June, he still has time. "The petitions don't go out until the 8th of June and then there are six weeks of signatures. I expect to have a candidate no later than 10 days from now."

When asked if the county Republican Party would support a Whalen run for a seat in the state legislature, Clarey said he is focused on the county elections. With still a year left, he added, there is a possibility that the district lines could be different after redistricting.

Whalen said relaxing is in her immediate future. After taking care of her husband, who is recovering from hip surgery, things are looking good for her, she

RCS budget fails again BC budget passes comfortably

Rejected plan matches contingency numbers

The residents of the Ravena-Coeymans-Selkirk School District for the second year running have rejected the proposed school budget.

The May 17 vote was a close one at 1,039 to 959. The proposed \$42.5 million budget was 0.8 percent higher than this year's spending plan, which is a contingency budget adopted after voters turned down a budget last May.

"It's disappointing after all the hard work the Board of Education and Finance Committee did," said Superintendent Daniel Teplesky.

He went on to say the

budget with a flat tax rate, but that was before the state made deep cuts to school aid. That and rising costs conspired to create a substantial budget gap.

"It really became a problem for our district when we found out we were \$2.3 million in the red," Teplesky said.

The tax levy would have gone up 3.4 percent under the plan — and it still might. With the budget rejected, the school board can put the same budget up for another vote, revise the budget and put it to voters again or go straight to a contingency budget. Last year the board decided not to hold another vote.

Interestingly, the failed budget and contingency budget are identical, Teplesky said, meaning the school board could adopt the very plan voters turned. down on Tuesday. The

district had prepared a matter will be addressed at the Tuesday, May 24, meeting of the Board of Education.

Voters also rejected a proposition to purchase new school buses. The vote came out 1.053 to 917. The library budget was approved.

Of eight candidates running for three-year seats on the school board, voters selected two newcomers in Jeff Lukens (with 744 votes) and Rodney Kryzkowski (with 788 votes). **Incumbent Mike Robbins** received 879 votes and will serve a second term. Christopher Pennock, the other incumbent, did not garner enough votes to return to the board for a second term.

Voters in the Bethlehem Central School District approved an \$86.8 million budget on Tuesday, May 17, by a vote of 3,186 to 1,581.

Superintendent Michael Tebbano said he was "elated" at the

"It's been a long year of work since the election last year," he said from the BC High School gymnasium following the tally. "I'm grateful for all of the people who made this budget happen."

That includes, Tebbano continued, BC employees. All agreed to some degree of salary freeze in the 2011-12 school year, saving the district \$1.3 million off its contractual salary baseline.

Three school board seats were open, for which eight candidates ran. Incumbents Laura Ladd Bierman and Matthew Downey both retained their seats with 2,443 and 2,227 votes, respectively, and newcomer Caitrin Navarro clenched third with 1,886 votes.

Board President James Dering did not run for another term.

The turnout of 4,767 voters was about 200 people less than at last year's vote, but the weather was also inclement for most of the day. The proportion of yes-no votes was nearly identical year-to-year,

Many voters on Tuesday said they were discouraged by some of the decisions made. but still felt the budget overall was a solid one.

Resident Mark Wolfsberg said he understands many criticisms but still voted

"I support the school system. I think they do a good job with the kids, he said.

Even resident Philip Carter, who in years past has been an outspoken critic of the district's fiscal choices, had kind words about the budget and the choices made by unions and administrators this year, and said those factors outweighed other concerns.

"I think that anybody who voted against the budget because they were mad really was cutting off their nose to spite their face," Carter said.

Tebbano reiterated that no one in the district wants to cut anything, but said the budget struck the best balance possible.

"The whole budget created a lot of difficult choices for us," Tebbano said. "We are trying to the best of our ability to move ahead. ... Things are going to be a little tight, but we're going to get through it.'

A proposition to purchase new school buses passed 2,563 to 2,146. The Bethlehem Public Library budget passed 3,100 to 1,376. All counts do not include absentee ballots.

Realtors get behind governor's version of tax cap

The manufacture of the second

State looking for ways to give residents relief

With four weeks left in the legislative session, the New York State Association of Realtors is making a \$750,000 push to get Gov. Andrew Cuomo's version of a property tax cap passed.

The property tax cap debate has been going on for years, but has picked up steam in recent months as the state looks for ways to give its residents relief from some of the highest taxes in the country. In February, the New York State Senate passed a bill that would cap property. taxes at 2 percent but would allow residents to override the cap with a two-thirds majority vote. With only five weeks left in the legislative session, the Assembly has yet to even bring the bill to the floor, although House Speaker Sheldon Silver, D-Manhattan, has said it

Cuomo's "People's First" tour has been making stops around the state touting his legislative priorities, of which his top

three are ethics reform, marriage equality and a property tax cap.

"After the governor and the Legislature passed the budget to try to address that large budget gap of \$10 billion, the next logical step is the tax cap," said NYSAR Director of Communications Salvatore Prividera Jr. That will force mandate relief, which we do support because the money won't be there. They're going to have to deal with how they provide those services.

Will cap drive mandate relief?

Where the discussion currently stands is what sort of effect the tax cap would have on school districts in the state. Many area school officials have argued that if a cap is passed, coupled with continuing state cuts to education funding, instructional programming will suffer.

An argument has been made that passing a tax cap before supplying mandate relief would be too painful for schools, but NYSAR Governmental Director Mike Kelly said feeling that pain would drive mandate relief.

schools, as a matter of fact, we do," Kelly said. "They are extremely important to people when they make important decisions in purchasing a home. Why do the taxes that are supporting our schools have to be 78 percent higher than the national average? They don't have to be. We have to make some changes, so let's make some changes to address that and still provide good schools."

Carl Korn, spokesman for the New York State United Teachers, said districts have already made changes, and most district budgets kept tax increases in line.

"In fact, spending increases this year were less than 1 percent," he said. "That's the lowest ever documented."

School boards have eliminated programs and have laid off teachers and staff to control spending in their districts, Korn said, but with a total of \$3.2 billion total in state education cuts over the past three years; the burden has shifted to the taxpayers.

"Campaign for Fiscal Equity sued the state and alleged the state had-

"Realtors support good violated the constitution for failing to fund public schools properly," Korn said referring to a 2003 case. "It went its way through the courts and [former Gov. Eliot] Spitzer settled and the state had to spend \$4.7 billion more to settle the court case. ... They've violated the court order; they've cut back state aid by more than \$3 billion."

It was an issue many superintendents stressed could potentially be a problem for the 2012-13 budget season.

South Colonie Central High School Superintendent Jon Buhner said it is frustrating to watch politicians cut billions in aid while nothing is being done to relieve districts of the burden of unfunded mandates. He said he doesn't view the budget as balanced based on revenue and cuts - all he saw was cuts.

"Look across the state. This year it was more difficult because of massive cuts to state aid," he said. "Most schools were near or below the property tax amount. This year we're projected at 2.93 and last year had something similar, but we came in much lower.

range regardless because they know it's the right thing to do."

Bethelehem Central School District Superintendent Michael Tebbano criticized Cuomo for promoting the creation of a mandate relief commission without ever seeing anything from it. And now the governor is continuing to go around promoting the tax cap. He even listed some of the unfunded mandates he said don't make any

One of them is a mandate that requires school districts to transport a child to a private school that is within 13 miles of the school district. Tebbano said it is a waste of money and time since within just five miles, there are perfectly fine private schools.

"If parents are that needy of private education, they should assume the cost," he said, along with questioning as to why it is 13 miles. "It's a legislative give to constituents. It has nothing to do with maintaining the educational quality of a school district.'

He also said the Department of Commerce

Schools have been in that . and the Department of Health have a wellness policy that places further mandates on a school's nutrition program and there is also heavy. restrictions on school nurses. All of this, he said, is just everyone trying to tell districts how to run its schools.

"They're not giving us any money, they're just telling us to do it," he said. "I keep asking why do we have to do it without all of that funding."

Homeowners feel property tax pain

NYSAR's main concern is that people are increasingly not able to afford the property taxes on their homes, something that particularly affects seniors who are living on a fixed incomes while their taxes continue to rise each year. And with a recent Siena Poll showing that 86 percent of the people responding said owning a home is part of the American Dream, Prividera said, eight out of 10 residents in New York are calling for property tax relief.

With only four weeks left in the current legislative session, the

Wemple Corners draws interest of neighbors

Huge Glenmont hamlet project starting review process

A developer seeking to build a large hamlet-style development in Glenmont is just launching into a rezoning review, but neighbors are already raising some concerns.

Milltowne Plaza Inc. made its first appearance before the Bethlehem Planning Board on Tuesday, May 17, to make the argument for rezoning 95 acres near the intersection of Wemple Road and Route 9W from "mixed economic development" to "commercial hamlet."

The Wemple Corners development would need the new designation primarily to allow senior

housing, said Donald Zee, local attorney for Milltowne Plaza Inc.

"Senior housing is not permitted. One of the key elements of what we are proposing the rezone for is senior housing, senior apartments," he said.

In addition to 150 senior apartments, the plans call for 240 conventional apartments in 16-unit

buildings, 80 mixeduse apartments above businesses, 56 townhomes and more than 140,000 square feet of commercial and office space.

The scope of the project has caused some concern among neighbors, who the developer recently alerted by mailing at the request of the Town Board.

"I think our main

concern is just how much of it is apartments," said Marcus Mastracco, a resident of Milltowne Plaza development off of Wemple Road and one of about 10 people who came to the Planning Board meeting. (Milltowne Plaza was built by the same company proposing Wemple Corners).

Mastracco pointed out that another hamlet development, Kendall Square, is already under construction at the corner of Feura Bush Road and Elsmere Avenue. It's to be a smaller hamlet project of 110 housing units, mostly apartments.

"It seems like an awful lot of additional apartment space," Mastracco said of Wemple Corners.

Zee, however, said Bethlehem's low vacancy rate when it comes to multifamily housing and especially senior housing means the market is ripe for this big hamlet.

"A lot of the time, seniors do not want to live exclusively in senior communities," he said. "We think there is a great need for this type of housing."

Beverwyck in North Bethlehem and the Van Allen Apartments on 9W are the only other two senior apartment locations in the town, though the large Van Dyke Spinney development is in the works.

Zee and developers met with more than 40 neighbors to the project on Monday, May 16, and had a discussion that also covered topics like community character and traffic impacts. Milltowne is proposing a roundabout be built at Wemple and 9W at the developer's cost.

It now falls to the Planning Board to issue

a recommendation to the Town Board on the rezoning request. Board members on Tuesday said they'd like to see more information on the various aspects of the project, especially on the number of housing units. Zee implied the developer may choose to build a less dense development, but is aiming high by seeking permission to build 526 housing units so it doesn't have to go back through the state environmental review: down the road.

"This is our wish list. This is our conceptual plan which is the basis set for doing the SEQR [environmental review]," Zee said.

Mastacco said he and his neighbors will also be eagerly awaiting more clarity.

"I think we just have to hear more," he said.





In Bethlehem's Youth Court competition, all are winners

Senior takes home \$250 scholarship

He is this year's recipient of the \$250. Bethlehem Youth Court Advocacy Scholarship, which was awarded at the group's second Law Day celebration on Wednesday, May 25.

Hartunian and two other seniors in the Youth Court program, Matthew Weber and Caitlin Willey, presented arguments on a fictional case involving a teen who allegedly stole and defaced a street sign. Using that basic scenario, they were free to add their own details and then play the part of a Charles Wiff/Spotlight prosecuting or defending attorney for three judges: Adrienne Foederer, law clerk to U.S. Magistrate Judge David Homer; Gene Primomo, assistant federal defender and a Bethlehem Youth Court board member; and Connie Mayer, associate dean at Albany Law School and a BYC board member.

The judges felt Hartunian made the most convincing arguments and praised him for submitting fictional evidence gleaned from Facebook in his arguments. But all three of the speakers made excellent oral arguments, said Primomo, and as a result of Youth Court are better prepared for whatever life brings

"Now the next thing, whether it's a college presentation or a job interview...it's going to serve you well," Primomo said. "You've given yourself a life lesson."

Hartunian will be attending Villanova University next year at

the School of Business.

Bethlehem Youth Court is, as the name implies, a student-run court that metes out punishments for juvenile offenders, usually in the form of community service. This year, there are 57 students in BC and RCS schools trained as members of the court. They rotate through the positions of attorneys, judges and court clerks.

Program Director Katrina Charland said she's glad Youth Court can also dispense scholarships to its participants.



an d cohesive management."

Messina said he was also surprised at the GOP's decision.

"I am very disappointed in the Republican Committee in Bethlehem," he said. "I think both as a supervisor and before that on the Town Board, I served all the people of this town well. I know of no area where I didn't meet the commitment that I made to people."

The Bethlehem Democratic Committee is scheduled to meet Tuesday, May 24, to designate its candidates, and other parties should also be making their picks soon. Messina (an Independent) is interviewing with all parties, as is Kotary.

If Kotary can secure an endorsement from his own party, he would be well on his way to appearing in the top two spots on the ballot. Messina could still wage a signature drive to trigger a primary for the slots.

The supervisor said it's still too early to make a decision on how to proceed. The petitioning process starts in June.

"I've indicated during my interviews to all the parties that I'd always keep my options open on primary or opportunity to ballot," Messina said.

In 2009, Messina was not endorsed by his own Independence Party, and primaried then-Supervisor Jack Cunningham for the slot in a battle that went to the courts.

The supervisor has sometimes been at odds with other members of the Town Board, Kotary included, although the newly announced candidate said a more cooperative atmosphere has come about at Town Hall and it's one thing he'd like to see continue.

"I'm going to talk about" what's most important for our town, and I'm not going to focus on what was or wasn't done in the past

but what is being done now and what is going to be done in the future," Kotary said.

Up until last week there had been much speculation that Cunningham would be returning to seek his former office, but he announced shortly before the Democrats' interviews he would not be running.

The Colonie Department of Public Works Commissioner is a member of the town's Democratic Committee and is involved in the endorsement process. Cunningham said he received encouragement to throw his hat in the ring but is deeply involved in his job at Colonie and wants to see several things through, including a proposal to forge a private partnership to help run the town's landfill.

"As much as it may sound corny to some people, my belief is that public service is not just about the individual but where you can fit in and best serve the public,' Cunningham said.

He added he is "looking forward to supporting a challenger for Mr. Messina."

Cunningham did not rule out the possibility of a future run at elected office.


"I really enjoyed being supervisor, I never said I would never run for the position again," Cunningham said. "We'll see what happens in the future."

The Republican Committee also made the following endorsements: Jeremy Near for Town Board; Jeremy Martelle for Town Board; Nancy Mendick for receiver of taxes; Gregg Sagendorph for highway superintendent; Rich Mendick for county legislator; and Mark Jordan for town justice.

If Jordan were to win in his race, he would have to cut his term on the Town Board short.



issue of a tax cap is being pitted against marriage equality and ethics reform. Despite Local" campaign is open competing priorities, Kelly said recent polls show that a tax cap remains on top for most residents.

> On May 19, a Siena College Poll revealed that 71 percent of New Yorkers hold a tax cap as a higher priority over the other three issues. Ethics reform came in second.

> Miguel Berger, vice president of NYSAR for the Capital Region and president of Better Homes and Gardens Real Estate, said he often hears the complaint that people can't afford their homes. He said the problem comes from the fact that the state has been paying "with an open checkbook," and a property tax cap is a way to curb that spending.



service to any of the handful of post offices in the surrounding area providing they change their address.

This didn't sit well with resident Sylvia Czuchrey.

"For what you're going to have to do change post offices, it just doesn't make any sense," she said.

Probably the most outspoken critic of a possible closure is a man with an intimate knowledge of the Guilderland Center post office: its former postmaster, John DeSorbo.

"That post office is a viable, profitable post office," he said at the meeting, noting he was given bonuses because of that fact.

But that is not a determining factor in the closure process, said Pepe, who listed for residents the three criteria used in nominating an office for closure: a vacant postmaster position, the inability to negotiate a lease and in the case of natural disaster.

DeSorbo retired in 2009 after 25 years as postmaster of Guilderland

But closing Altamont or any other fully staffed post office - isn't ... an option, said Pepe. She cites Section 404(b)(2) of title 39, United States: Code, as the reason. It states, in part, that "The Postal Service, in making a determination whether

or not to close or consolidate a post office. shall consider (i) the effect of such closing or consolidation on the community served by such post office; (ii) the effect of such closing or consolidation on employees of the Postal, Service employed at such.

Because of that second clause, Pepe said, the Postal Service "never goes looking to close a post office that is fully staffed."

That's a problem for customers, said DeSorbo.

"They'll never get rid of that postmaster criteria." he said. "They just don't to this story.

change — they don't change for the better of the community.

DeSorbo said that rigidity is one of the reasons he doesn't regret leaving the Postal Service after 35 years.

'When you come up with an idea, you're crazy, but when they come up with an idea that is crazy, it's a sound financial decision," he said.

Postal officials are seeking, and encourage, more of the public's input on the possible closing. That public input, Pepe said, is just as important as other factors the post office considers when a local office is on the

We've had community meetings where the , community comes forward and the post office hasn't closed," she said, but added the opposite has also happened. Pepe also said that if it's decided the Guilderland Center post office will close, residents will have 30 days from the date of the decision to appeal.



Burns speeds to victory Lady Dutch

Eighth grader passes Pezzulo to win 3,000

Welcome to the big time, Emily Burns.

The Guilderland eighthgrader stormed past Saratoga's Molly Pezzulo with 250 meters to go and pulled away for a 9.6second victory in the girls 3,000-meter race at the prestigious Eddy Meet Saturday in Schenectady.

"I didn't know how far ahead I was [at the end]," said Burns, who finished with a time of 10:17.84.

Burns - who finished ninth in the 1,500 at last week's Suburban Council meet - staved on Pezzulo's heels through the first 2,650 meters of Saturday's race before making her move on the backstretch.

"I had to try to stay with her," said Burns. "She was really good."

Once Burns took the lead. Pezzulo faded. The Saratoga senior finished with a time of 10:27.44 - more than 13 seconds slower than her winning 3,000 time of 10:14.07 at the Suburban Council meet.

"She just went, and there was no challenge whatsoever-[from Pezzulo]," said Guilderland girls track coach Dick

The victory couldn't come at a better time for Burns. With the Section II Class A meet coming Wednesday in Queensbury, she now has a blueprint for success against one of the region's top distance runners.



 Suspending a key player for a team violation is difficult.

Doing so the week leading up to the biggest game in a team's history is even harder.

Yet, University at Albany women's lacrosse coach John Battaglino made the call to suspend freshman goaltender Anna Berman prior to Saturday's NCAA Division I Tournament quarterfinal game at Northwestern for what he told a Chicago-area reporter covering the game for the Times Union was "a failure to meet team standards."

Berman had been one of the top goaltenders in all of Division I with a 6.82 goals against average, and she was named the WomensLax.com Rookie of the Week following her performance in the Great Danes' 10-7 opening round win at Dartmouth May 15.

But whatever it was that came to Battaglino's

attention in the days leading up to last weekend's trip to jumping to another school after transforming UAlbany Chicago — something that will probably never come to light, since coaches rarely ever talk to the press about the specifics involving internal team issues (I couldn't reach Battaglino in time for this column) — led him to leave Berman back in Albany and start Brett Yenger. It couldn't have been easy, but Battaglino made the call.

Ultimately, it probably wouldn't have greatly mattered who started in goal for UAlbany Saturday. Northwestern showed why it has been to the last six NCAA championship games by beating the Great Danes 18-4. The Wildcats jumped out to a 7-1 lead and controlled the ball for much of the game. Berman might have stopped a few more shots than Yenger did, but the score would still have been decidedly in Northwestern's

What happens between now until next February will tell a lot about where UAlbany goes as a program. The Great Danes will be able to boast of an 18-1 record, an America East title and a quarterfinal appearance in the NCAA Tournament, but they will also be losing several key seniors including Taylor Frink, Jodi Battaglia and Nikki Branchini. There are several talented underclassmen returning such as Rachael Burek, Ariana Parker and Allie Phelan, but will Berman be back as well after being suspended before the Northwestern game? And who is to say that Battaglino doesn't wind up

into a nauonany-ranked squad:

One thing is certain: Berman's suspension was a difficult call for Battaglino to make considering the timing of it, but it did not cost UAlbany a victory at Northwestern.

 While UAlbany won't be making the trek to Stony Brook for this weekend's NCAA Final Four, a team of some of this area's top high school players will be going there for US Lacrosse's annual Women's Division National Tournament.

As one might expect, Guilderland and Niskayuna have the most representatives on the Adirondack Region team. Guilderland is sending the Cietek twins, Kendall and Mackenzie, along with Shelby Iapoce, Nicole Levine and Kelsey Michele; while Niskayuna has four players on the roster - Ritchie Assini, Janeen Bell, Emily Ryan and Kelly Schalnsker. (Not coincidentally, Guilderland meets Niskayuna in Wednesday night's Section II Class A championship game.)

Shaker and Shenendehowa each have three representatives on the team. Anne Morrison and sisters Lauren and Madison Smith represent the blue and white of Shaker, while Kristen Connors, Sam Phillips and Kelly Wall represent the green and white of Shen.
