


BCHS class decorates journals for victims of domestic violence

TSA 'Pre-Check' security program takes off at Albany Airport

Some passengers will be flying through the security checkpoint at Albany International Airport thanks to a recently implemented expedited screening program.

The U.S. Transportation Security Administration expanded its "Pre-Check" program to Albany, allowing pre-approved travelers to skip the hassle of removing their shoes, light coats and belt, while keeping laptops and liquids in their bags. # Making a plan to plant

### **Garden Club partners** with town. DOT to improve median on Cherry Ave.

In its latest effort to improve the overall beauty of the town, the Bethlehem Garden Club is expanding its reach.

A new partnership has been forged among the town, Garden Club and state Department of Transportation to help develop beautification projects throughout Bethlehem. In a new pilot, the club began with the median along Cherry Avenue.

"This has been a longrange plan," said Virginia Acquario, a member of the club and co-chairwoman of the group's Community Projects Committee. "We've been trying to improve that median for years, and we finally contacted DOT to do a

Supervisor John Clarkson said the median project has been an "evolving topic" with the town and state DOT. The portion of Cherry Avenue where the bushes were planted is a state road but is mowed by the town's Highway Department because grass was preferred to asphalt. The state worked with the town and Garden Club to develop the layout for the landscaping done through the pilot.

"These plantings will improve the looks of the road without endangering automobile traffic, and may also have traffic-calming benefits," said Clarkson. "They should not increase maintenance for the town, and the Garden Club will be helping with weeding,

In June of 2012, Town officials went on a walk with members of the Garden Club, Chamber of Commerce, Rotary and Kiwanis to see what kinds of improvements

entrances of Bethlehem look more appealing. According to Acquario, the Garden Club wouldn't have been able to keep the group's initiative going without the continued support from the town.

At the time, Acquario said the group was looking to step away from planting traditional gardens and focus on plantings like bushes and trees in order to improve the overall look of the town. The group is also placing more sustainable plants throughout the community that need less care and paying for benches to be placed in more heavily populated areas.

At the Cherry Avenue site, the Club planted three spirea bushes and some sumac. No chemicals will be used to treat them because the town is toxin free, and the plants will not need artificial fertilizer. Acquario said the group wants to see how well the bushes hold up through the spring, at which time,



be planted.

"The real reason we are interested in doing this project is to help our environment," said Acquario. "It's important for people to understand this isn't just for beauty. It buffers the noise from traffic for people that live along the road and sequesters carbon, so this is a benefit in multiple ways."

wants to make sure that area is kept up since the road is dedicated to Capt. Timothy J. Moshier, a Delmar native and pilot killed in the spring of 2006 while on duty in Iraq.

Acquario said if the pilot works and the group's work along Cherry Avenue expands, members have other projects in mind. The Garden Club would like to re-plant canopy trees along that road and

# Thriller is a change of pace for high school acting troupe

character drives each scene, which also requires a lot of lines to memorize.

# Three RCS middle schoolers charged with robbery

Coeymans Police arrested three Ravena-Coeymans-Selkirk Middle School students and charged them with stealing money from a peer after police were summoned to the school on Tuesday, Oct. 29.

Police said school administrators called the department after determining that three juveniles allegedly had attempted to steal money from a fourth student. While attempting to steal the money, police said the suspects assaulted the student and held him against his will. The Coeymans Police Department school resource officer worked in conjunction with the middle school principal in investigating this case.

All three juveniles, including two 13-yearolds and a 12-year-old, were brought to the police station where their parents were notified. All three Albany County Probation. were charged with felony robbery in the second degree, gang assault and unlawful imprisonment, according to police. After consultation with the County Attorney's Office, one of the youths was transported to Capital District Secure Detention Facility and was to appear in Albany County Family Court on Oct. 30. The other two were issued appearance tickets for

"This case demonstrates the value of having a school resource officer who can work closely with school officials to ensure that we all respond quickly and appropriately to any incident which jeopardizes the health and safety of one student or all of our students," said Coeymans Police Chief Gregory Darlington.

Ravena-Coeymans-Selkirk Interim Superintendent Alan McCartney said he was proud of the actions of other students who got involved and didn't look the other way during this

"Several students were surrounding the victim and telling the other boys to leave him alone," said McCartney. "Another child went to the office to tell the principal that the boy needed help."

The students' names were withheld by police due to their age. Police also did not disclose how much much money was allegedly stolen from the student.

### Ravena man pleads guilty to police assault

A Ravena man pleaded guilty in Albany County Court to the attempted assault of a police officer last summer.

Shawn Ingeroll, 35,

of Ravena, pleaded guilty to one felony count of attempted assault in the second degree on Friday, Nov. 1. According to the Albany County District Attorney's Office, on June 1, officers responded to a residence in the Village of Ravena after receiving a call of a domestic incident. When officers approached the residence, Ingersoll opened the door and refused to come outside after being told by officers that he was under arrest.

Officers went inside attempting to place the defendant in custody, at which point Ingersoll shoved one of the officers to the ground before fleeing from the residence on foot. During the chase, one of the officers fractured her leg and tore several ligaments in her

According to the district attorney's office, Ingersoll faces two to four years in State Prison when sentenced on January 31,



# **Bethlehem BOE member** to lead state organization

**Lenhardt says** she'll work for more equal funding

A longtime member of the Bethlehem Central Board of Education has been selected to lead the state's School Board Association.

Lynne Lenhardt was elected by the NYSSBA Board of Directors to become the organization's president on Saturday, Oct. 26. Lenhardt has been a member of the BC Board of Education for 25 years and was elected to the NYSSBA board in 2001.

She said it was an honor and privilege to be elected to the position by delegates representing districts from the entire state.

'My theme is going to be 'Be the Change for Kids," she said. "I took it from Gandhi's 'Be the change you wish to see in the world.' I just feel there is still a lot to do with education."

The New York State School Board Association "provides advocacy, training and information to school boards in support of their mission to govern the state's public schools."

"For 25 years, Lynne Lenhardt has brought dedication, insight and guidance to the Bethlehem Central School District," said Bethlehem Central Superintendent Tom Douglas. "We are proud to support her as she shares her leadership skills

statewide with more than 5,000 NYSSBA members, representing communities from Niagara Falls to Long Island, who will surely benefit from her experience and informed decision making.'

Lenhardt said her goals while in her new position include helping school boards and teachers get through the different phases of the Common Core assessments and Annual Professional Performance Reviews. She would also like to see the end of the state Gap Elimination Adjustment, a formula that freezes or reduces a district's state aid based on it economical well-being, and equitable funding for school districts.

'There's a big gap in achievement between lower income districts and wealthier districts," said Lenhardt. "There is also a gap in funding, which is similar. Sometimes students suffer because of their zip code, and there needs to be equitable and fair funding to all school districts."

She also wants to work with school district staff on professional development

so instructors feel comfortable teaching to the new standards and can help students learn using the methods, instead of teaching to the exams.

As a former high school social studies teacher and adjunct college professor of mathematics, Lenhardt has an extensive background in education. Along with her time at the Bethlehem School Board, Lenhardt has served on the Board of Education of Capital Region BOCES, is a member of the Tech Valley High School Operating Board, and has served as president of the Capital District School Boards Association.

Lenhardt, who takes office Jan. 1, has also participated in and spoken at a large number of education seminar throughout the years and was formerly a member of the College Council of Empire State College.

"I want to look at these issues, and maybe not resolve them but at least deal with them in a way that ultimately helps the students," said Lenhardt. 'Sometimes we forget that the students are our ultimate consumers, and we have to do what's best for all of them."

Lenhardt will continue on with her role as a Bethlehem Central school board member, along with her new duties as NYSSBA president.

# A word on recent delivery delays

Newspapers make a business of being timely. Old news isn't really news at all. That's why a recent disruption in the mailing of our newspapers has had such a major impact on the work we do.

For years, our readers have been able to count on our weekly insight hitting their mailboxes on a Wednesday. It is no small amount of work shepherding all that local town, school and human interest news from hastily scrawled notes to a printed page, and Spotlight's reporters, copy editors, artists and ad reps take a lot of pride in what we do to get it there.

Needless to say, we were more than a little dismayed when the calls started coming in a couple of weeks ago from some readers saying they had yet to receive their papers by Thursday, Friday, or even Saturday. Although these delays only affected a portion of our readers, we take them very seriously. Here's what happened.

George Flood, a USPS spokesperson for the northeast unique to our publication, but have affected bulk mail across a swath of Upstate. This is the result of a decision to shift some mail processing duties to an Albany sorting facility, from a Newburg facility, combined with some equipment issues.

Flood said there are about 400 full-size processing facilities across the country. With dramatic changes in the way Americans send mail – namely, a decline in volume – the postal service is trying to rightsize its operations.

"We are adjusting and tweaking the network," he said, "and we hit some speed bumps along the way."

We have also been told that, moving forward, our readers can once again expect on-time delivery.

(We) will move mail around to be more efficient," Flood said.

To say these interruptions in delivery service have been frustrating would be quite the understatement. These

unexplained for weeks despite our inquiries, have had an impact on us here at Spotlight News. It's not just us, though.

We understand all of bulk mail, the delivery method for many local periodicals, was affected. The Guilderland Central School District also found itself a casualty of delivery delays when its fall newsletter notifying residents of an Oct. 29 building proposal meeting did not hit mailboxes until after the meeting was scheduled. The turnout at that important meeting was described by one official as "astonishingly low."

We appreciate the steps the post office is taking to improve the situation, and we're glad officials there are stepping up to take control of the matter. But explanations do little to repair some of the goodwill squandered during the weeks our message was not being received in a timely manner. While it's never a good time for news to get stale before it reaches the mailbox, these past

area, told us the delays were not repeated delays, which also went weeks have been particularly problematic because the time leading up to elections tends to be ripe for the type of discourse that local newspapers foster.

> Readers should know that we do not take delivery disruptions lightly. We have brought our complaints to every pertinent office of the USPS, and we are hopeful the postal service will deliver on its promise to fulfill the obligation we and our readers pay for, and get your newspapers to you in a timely manner.

# BC's coffee bar a disservice to everyone

When our children are in our schools, a fundamental role of our schools is to look out for the welfare of our children. This means keeping our children safe, while giving our children the tools they will need to help them through life. The school must set good examples and help our children develop good habits.

At first glance, a café in the Bethlehem High School and junk food in our school cafeterias seems like no big deal, but take a minute to analyze it, you will realize how contradictory it is to the purpose of our educational system.

Good habits are vital to our children's education. Math. writing, reading, exercise, work and living habits, the list goes on. In school, these habits are not options. English teachers don't say, "write legibly or illegibly." We don't allow bullying while teaching acceptance. We don't they drank two large coffees a day allow cheating while teaching honesty. So why are we teaching the immeasurable importance of a

healthy lifestyle while providing an unhealthy one? Do we say, "don't smoke," and hand out cigarettes?

Our teachers spend an enormous amount of time and resources, (our tax dollars), teaching our children the importance of health and nutrition, yet we send them off to the cafeterias and offer them the exact things they are told to avoid! Sugar, caffeine and saturated fats trigger the same drug addiction responses in the brain as cocaine and heroin. They actually alter brain chemistry. Our children become subject to side effects, including mood swings and depression, due to chemical dependency. Isn't child behavior turbulent enough already? They also lead to a lifetime of health and medical issues plaguing our country: higher health insurance rates, higher short and long term medical costs, lower standard of living, etc.

The school's claim is they are offering "Healthy Choices," which should outrage parents, because if you really analyze it, they aren't actually choices. It is not a "choice" when you are craving an addictive substance. Two students told us from the café, one in the morning, one in the afternoon. Their parents didn't know they drank coffee, so

they had to sneak out on weekends to get coffee otherwise they felt sick from caffeine withdrawal.

Your child choosing between cookies or chips versus an apple is not making a "free choice" because they are unaware of the addictive nature of these items. They're being sold unhealthy items that then cause them to crave more of those very items, that their school, who is supposed to watch over their welfare, is inviting them to consume. The school has the nerve to call this a "Healthy Choice?"

From every scientific and educational perspective this is a terrible idea. Health experts, scientists, doctors, our own educators, all tell you the worst thing a developing child can do is cheat their body of what it needs. Refined sugars and saturated fats in these foods are exactly what leads to innumerable medical conditions in our society costing billions of dollars every year. This is a lose-lose for everyone.

We teach good habits in school, coffee and junk food are bad habits. We teach sound science in school, science tells us caffeine and junk food are addictive substances. We teach good health in health class, coffee and junk food are the building blocks of disease and obesity (one in four Bethlehem

students). We teach sound economics in school, economically these products are an abomination, their seemingly inexpensive unit cost in no way representative of the disproportionate economic footprint from unsustainable farming practices to societal medical costs.

Depressingly, the Bethlehem Central High School made \$55,000 selling addictive products to our kids last year, such as coffee and junk food. This is money we gave the school to sell these products to our kids creating lifelong addicting habits that they may never be able

Selling these products in school is irrational, exactly how these products make our children behave while teachers are trying to teach. These products directly endanger their welfare. They directly limit their learning and athletic potential.

Put all the spin on it you want, but what we are doing is selling addictive products to our own children, and that's not right, and it is certainly not the role of our schools. Our children have plenty of opportunity for these products everywhere they turn in life, this should not include school.

But don't take my word for it, go online and read the research vourself.

# **Building improvements up to G'land voters**

**Majority of \$18M** in costs tied to infrastructure renovations; low turnout at meeting

Guilderland Central School District residents will head to the polls again on Thursday, Nov. 14, just over a week after Election Day to decide two building project propositions totaling \$18.17 million. However, at a recent community meeting discussing the proposals, only a handful of community members turned out to ask questions.

About 25 people attended the Tuesday, Oct. 29, informational meeting, but a majority were board of education members, facilities committee members and other school officials. Several district officials and the project's architectural firm were on hand to answer questions after a presentation providing an overview of the facilities improvement

The first building project proposal totals more than \$17.3 million and includes building infrastructure renovations (\$14 million), safety and security

improvements (\$1.5 million) and instructional technology upgrades (\$1.8 million). The second recommendation of around \$845,000 tackled high school auditorium renovations and replacing the high school football field light pole.

"Where you will see most of the dollars tied up in this project is the replacement of building components that are a safety concern, or are at or near the end of their useful life, or a detriment to the efficient and economical operation of a building," Superintendent of Schools Marie Wiles said. "We don't want things that are close to the end of their life to fail and put us in a position where we need to do emergency repairs that will, in fact, disrupt what happens each and every day during our school year."

The first proposition would result in an annual tax increase of \$65 for a home in the Town of Guilderland assessed at \$246,500, the median value. The second proposition would likewise result in an annual tax increase of \$3 to the same

The second and smaller proposal is contingent upon the first proposition being approved by voters.

The first proposal doesn't require the second to be approved.

Wiles said the committee decided to separate the two proposals because the bigger project "best captured" needed facility improvements. She said the committee was concerned some voters would see the second proposal as more "frivolous," but she considers that designation "a stretch."

Lori Hershenhart, instructional administrator for music, said the proposed improvements at the high school auditorium were needed because it's used as a classroom during about half of the school day and is used "extensively."

Hershenhart said the auditorium lighting is poor, requiring students to come on the stage to read any materials, and the sound system is in need of improvements.

Athletic Director Regan Johnson said replacing the light pole at the high school football field is important for safety.

"I know that the wind blows constantly here," Johnson said. "Especially on the football field, when the wind blows, I know where I am standing just in case."

# Town Board accepts Ethics Board recommendations

### Minor changes to appeals process to ensure employees' privacy

Following a proposal from the Bethlehem's Ethics Board to make several changes to the law after a year being in effect, Bethlehem Town Board members opted to accept the committee's recommendations along with some minor changes to ensure the privacy of town employees.

On Wednesday, Oct. 23, Town Board members discussed the recommendations presented by the Ethics Board after applying the code for a year. The recommended changes include amending the code to include a way for town staff and employees to appeal an advisory opinion issued by the Ethics Board. The group also wanted to amend the code to render advisory opinions issued by the Ethics Board to be binding.

Other recommendations included authorizing the board to initiate an inquiry into an alleged violation of the code, since it currently cannot launch an investigation absent a formal complaint. The board would not be able to begin an investigation without reasonable cause, but the change would allow for some initiative to be taken if the board found out about an issue and no formal complaint was filed.

Town Board members agreed with many of the changes, but Councilwoman Joann Dawson said by incorporating them into the law, new problems could

renders an advisory opinion and the requester seeks to appeal that opinion at the Town Board, is the advisory opinion still in effect during the appeal?" asked Dawson.

Ethics Board Chairwoman Theresa Schallaci said the Ethics Board could make it clear in their decision if their recommendations should remain in place until the appeal process is complete, and she did not think it needed to be changed in the law. Supervisor John Clarkson agreed.

Dawson said that decision was fine, but there could come a time when this issue arises and she says "I told you so.'

Eventually it was determined to add that the decision of the Ethics Board is to remain in place until the appeal process complete.

However, Dawson had another question. If an employee goes to the Ethics Board for an advisory decision, everything that occurs is confidential. If an employee was to appeal the decision before the Town Board, wouldn't the issue then be made public?

"It could be seen as a disincentive to appealed if it is known that the decision is made public," said Councilman Kyle Kotary.

Clarkson said it could be could remain private would good to have a disincentive to appeal so that the decisions made by the Ethics Board carries more weight. "We wouldn't want every decision to be appeal to us," he said.

To date, no formal decisions have been rendered by the Ethics Board.

Councilman Jeffrey Kuhn said because of the state Open Meetings Law, whether or not the appeal

depend on situation that is brought to the attention of the Ethics Board. Every situation might not be able to be held in executive session.

The board eventually

decided to include in the law that appeals would remain private, unless otherwise subject to state law.

A public hearing on the changes is set for the next Town Board meeting on Wednesday, Nov. 13.

opt-in through an airline's frequent flier program or trusted traveler service.

Brian Johansson, federal security director for TSA at Albany, said the program provides a different level of screening based on risk assessment of a passenger.

Johansson said the program allows TSA to focus its efforts on "passengers the agency knows less about while providing expedited screening for travelers who volunteer to provide" information before flying. The TSA started selecting passengers based on information provided through reservations last Thursday.

"The program acknowledges the fact that we recognize the vast majority of passengers pose no threat to security," Johansson said, "and it demonstrates a

shift from our one-size fits all approach to a more risk-based approach to security."

Travelers can enroll for the program through an application process requiring a background check, fingerprints will be taken and an enrollment fee of \$85 for five years. Those enrolled will receive faster security screenings more regularly, but it is never guaranteed.

TSA enhances security of the program through random and "unpredictable security measures." The expedited lane will not always be open either, but it will be available during peak hours.

"You have to inject a little bit of randomness into to it to ensure that somebody is not beating the system," he said.

The program is offered

to passengers traveling on Delta Air Lines, United Airlines and US Airways out of Albany, with Southwest Airlines expected to participate before the end of this year.

"When you get your boarding pass, take a look at it; look for that pre-check designation," Johansson said. "It is a much faster process. It is much easier — much less intrusive. As long as everything goes smoothly, you are right through the checkpoint and onto your flight."

Duber Winters, Woodbridge, Va., who was returning home from a business trip, said the program was "fantastic," but he did add he wouldn't pay to enroll in the program.

"I am hoping they have it everywhere," Winters said. "It is so much easier."

As long as security is maintained, he said he doesn't see the expedited program as having any potential problems.

# Making the most of waste

Albany County unveils \$8.6 million technology generating clean energy from sewage

Going green can sometimes mean looking for innovations and opportunities in the least likely of places.

Albany County Sewer District and state officials have done just that, unveiling Wednesday, Oct. 30, a new multi-stage combined heat and power system at the county's North Plant in Menands. The \$8.6 million Organic Rankine Cycle heat-toenergy technology is the first installed in North America. The plant previously burned sludge for disposal, but the new system will recapture the heat generated from the process and generate up to 3.3 million kilowatthours of power annually.

The county is estimated to save \$400,000 in energy costs annually, with the new system reducing up to 75 percent of its electric grid usage. During colder months, the heat will also be captured and used to warm up buildings.

"Ideas like this, that use what was once considered waste to produce energy, need to be examined not only as environmentally friendly and economically viable, but also as an example of how government can be more efficient, effective and accountable to the taxpayers," Albany County Executive Dan McCoy said in a statement.

McCoy said the renewable energy source would reduce the county's carbon dioxide emissions by nearly 1,500 tons annually, along with reusing around 50,000 gallons of water daily to cool the system.

"In short order, the Sewer District will be saving electricity, water and natural gas while reducing greenhouse gases with one of the most advanced and innovative projects constructed in the state," McCoy said.

New York State Environmental Facilities Corp. President and CEO Matthew Driscoll said the county competed against almost 300 other green projects in the state's Green Innovation Grant Program to win funding for the project.

"A primary goal of the Green Innovation Grant Program is to increase the awareness and use of sustainable, energy-saving technologies in New York," Driscoll said, "and Albany County's unique system will undoubtedly spur similar projects in the rest of the state."

The Environmental Facilities Corp. awarded \$5.8 million for the project, which was provided from American Recovery and Reinvestment Act funding. The New York State Energy Research and Development Authority also awarded \$2 million. The county funded the remaining expense.

"This project is a terrific addition to the Albany County infrastructure," state Sen. Neil Breslin said in a statement. "It will benefit the environment by cutting down on power consumption from the grid, and it will also benefit the county taxpayer by reducing operating expenses."

The North Plant was constructed 40 years ago and serves approximately 200,000 people. The plant is designated to treat an average daily flow of 35 million gallons.

Albany County Sewer District Executive Director Richard Lyons said the project provides long-term environmental and economic benefits for communities served, which includes a portion of the cities of Albany, Cohoes and Watervliet, parts of the towns of Colonie and Guilderland, and the villages of Colonie, Menands and Green Island.

Around 7,000 tons of dry sewage sludge is disposed annually at the plant. The heat created from burning off the dry matter will run through a closed-loop oil system and be pumped into a combined heat and power (CHP) system.

"The innovative aspects of this project will serve as a template for use by other communities in the state," Lyons said.

through difficult emotions and circumstances."

Segal is a longtime friend of Pascone and often volunteers at Unity House, a Rensselaer County-based human services agency that assists victims of domestic violence, adults with mental illness and those living in poverty. Pascone said one of the first possessions woman receive when seeking assistance from the organization is a journal.

"It becomes very important to them because it is often one of the first things in a long time the women feel is entirely their own," said Pascone. "A lot of times, these women go to the

police or hospital and come to us with only the clothes on their back."

The women of Unity House are encouraged to write in the journals on their own and are asked to use them during group writing exercises. Since Segal has used journaling for years as a medium for her artwork and often teaches different units on it in her classes, she felt a collaboration would be appropriate.

Prior to the lesson, Segal sent a letter out to parents explaining the project and asking for donations of journals. The students would then be decorating the front and back of the journals using a mixed-media, collaging method.

On Friday, Nov.1, Pascone gave a 20-minute presentation about Unity

House and the warning signs of domestic violence to students before they began their art lesson with Segal. The class was filled with about 20 teenage girls, who learned how victims of domestic violence are often controlled by their partners and how often the cycles repeat.

"Many times, when woman come to us, they do go back to their abusers. It can take three or more times before they actually leave, and some never do," said Pascone, explaining that some victims can find living on their own and facing the new challenges of everyday life to be overwhelming. "Some have never kept a checkbook before or may be confused about applying for a credit card so they feel it's easier to go back."

Pascone said the organization typically helps women between the ages of 25 and 45. To spread the word about their organization in a way that isn't embarrassing for victims, the group will leave pamphlets small enough to hide in a shoe in places like the grocery store and nail salons. They also give out everyday items, like chip clips, with their phone number on it for easy access.

The students will work on their journals in class

over the next month. Segal taught the class a special splatter technique for painting the covers. They will then be asked to find inspirational sayings and photos that will be placed on the journals in a collage style.

"It's meaningful for these woman to get these journals from these girls," said Pascone. "They were young once too and had similar dreams and aspirations. I think this project will work to form a unique connection between everyone involved."

Segal said if the project is a success, she would like to see it expand. Not only would she be open to teaching the unit in her other classes, but she said she would be willing to go to other school districts to work with art teachers or do lessons with other community organizations.


"I have a lot of ideas about how to make this work, the problem is finding the extra hours in the day," she said with a laugh.



# New York State Museum opens weather exhibit

### Colorful display draws from Burchfield archive

The New York State Museum's latest exhibition, "Weather Event," opened Saturday, Nov. 2, in the West Gallery at the Empire State Plaza in Albany.

The exhibit features more than 60 of artist Charles E. Burchfield's colorful depictions of the weather south of Lake Erie including watercolors, sketches and his journals. The exhibit was first organized by and presented at the Buffalo State College's Burchfield Penney Art Center.

"The Board of Regents and the state museum are committed to partnering with institutions across the state to bring a wide range of cultural treasures to Albany," said state museum director Mark Schaming. "We are pleased to host this important exhibition from the Burchfield Penney Art Center. This is a unique opportunity to see this collection of Charles Burchfield's visionary work, as

one of America's most revered artists of the 20th century."

"Charles Burchfield was an artist, writer, designed and naturalist whose character was defined by his observation of the here, the now and the hereafter," said Burchfield Penney Art Center executive director Anthony Bannon. "This exhibition, drawn from the 26,000 objects in the Burchfield archive ... observes the artist's contemplative transcription of weather, the cycles of environment and atmosphere — and what it all meant to him. We are delighted to have the opportunity to share his vision with the thought leaders of our state."

Burchfield's representations of weather, wind, skies and sounds are unique historical records of the environment near Lake Erie, where he lived for most of his life. Burchfield Penney curator, and manager of archives Tullis Johnson worked with climatologist and Buffalo State College professor Dr. Stephen

Vermette to present the dramatic and complex natural phenomenon chronicled in more than 50 years of Burchfield's writings, drawings and paintings.

Vermette also worked with Buffalo State College students to recreate historical weather forecasts for the days that many of Burchfield's early watercolors were made. These forecasts are accessible in the exhibit through the use of smart phone technology.

Burchfield's early works were imaginative, stylized landscapes and rural scenes that often incorporated a personal language of symbols. After moving from Ohio to Buffalo, he focused on the city's buildings, harbor, rail yards and surrounding countryside. From that period, his works show an appreciation for American life and an assessment of urban life in comparison to the countryside and his own small town background.



who was uprooted from his home and moved to the big city. It doesn't take long for Joshua and the rest of the Primm family to accept Lyle and take him in.

"He ingratiates himself by finding Mr. Primm's pipe, which was lost in the move; cleaning, dusting, setting the table, cooking and all these fantastic things that suddenly make him an indispensable part of the household," said Ric Chesser, executive director at Steamer No. 10 Theatre.

Not everyone is as accepting as the Primms, however. Lyle is threatened by a crabby neighbor with a very fitting name, Mr. Grumps, played by Joe Philips; a seasoned actor who has starred in a number of productions, the most recent being a musical piece about the making of the Erie Canal called "Clinton's Ditch."

Philips said Mr. Grumps is a man who is set in his ways and doesn't like anything that is different. "When he learns that he is living next door to a crocodile, he is not happy and makes some trouble for Lyle," Philips said.

The show is based on the popular children's books, "The House on East 88th Street" and "Lyle, Lyle Crocodile," by Bernard Waber.

When Waber introduced Lyle to his readers in 1962 in "The House on East 88th Street," it was the beginning of a series about life lessons on acceptance.

Hurley-Kimlicko said a few changes were made to the original story, but the overall message and the "storybookfeel" remains the same in the theatrical adaptation.

She added that one element of the show makes it different from most children's stage shows.

"Its message is really nice for kids," she said, "but when the music is added, it has such a jazzy kind of feel that it makes it really feel like a New York piece."

Chesser said the show features a pit orchestra and has a score that is along the lines of swing jazz.

"Very seldom do kid's musicals go in that direction," he said.

Philips added that the lyrics include a lot of lingo from the 1950s, which he said can be a bit advanced for some of the younger members of the cast.

The show is one of Steamer No. 10's Kids' Fare Series, which casts young kids alongside professional actors.

"When you have a cast of eight professional actors with varying levels of professional experience and a handful of very young kids ... with the mixture of people, it's been challenging to try and put this together fast," Philips said.

Still, he finds children's theater gratifying.

"I love working with kids in the theater. I have done quite a lot of directing in community theater that involves children. I've worked with a theater program out of RPI and coached young children on stage, so this is right up my alley," he said.

"Lyle the Crocodile" casts eight professional actors and

eight students from area high schools.

The role of Joshua Primm is played by Justin Jasiewicz, a high school student at Loudonville Christian School.

"He was in 'Pippi Longstocking' last year with kind of a non-descript role, but did well with it. During the summer we had him in 'Grease' as Eugene, and he just created this fantastic character enough that during scene changes when it was kind of halflight, he and this other

actor would come out and just continue their characters," Chesser said. "The audience never really realized this was just stuff that these two were making up as they went along and not part of the actual show."

Chesser said "Lyle the Crocodile" is a show for all audiences. "The Lyle series is the

kind of book that young kids would probably read, but our shows reach out to families," he said.

In the end, good will and courage win out when Mr. Grumps learns to appreciate Lyle for who he is.

"People who are different have a lot to offer. I think that's

kind of the overall lesson of this show. A lot of people are put off by meeting a crocodile, but when they learn he is versatile, entertaining and has a lot of talents ... and just a plain good guy, they learn to accept him," Philips said. 

event on Friday, Nov. 8, with a lecture about the uniqueness of our solar system, followed by a stargazing party.

There are several daylong activities and presentations planned at miSci, along with some happening at designated times, allowing people to learn and explore different avenues of science. The activities will run from 9 a.m. to 5 p.m. on Saturday and Monday, and Sunday they will run from noon to 5 p.m.

"There will be something going on in different places all the time, so you can wander around and pick what you want to see," Sudduth said.

Five Rivers **Environmental Education** Center staff will be at the event all three days with the "wild turkey" program. WMHT will be present the first two days with the program "Eat Like a Bird." New York Wildlife Rescue will also have birds on display, along with a bird demonstration once each day. Several dry ice demonstrations will be held by miSci throughout the event.

Some unique events on Saturday include Union College professor Jim Hedrick explaining how to talk to robots, Niskayuna High School students giving chemistry demonstrations, Empire State Aerosciences



Museum offering flight simulations and the Dudley Observatory offering a

solar viewing.

On Sunday, there will be a robot scrimmage between Niskayuna and Mohonasen high school students. On Monday, SI Group will present its popular bubble hoist demonstration, and Mr. Sly the Science Guy will have a presentation on energy and matter.

Cabot Creamery has also donated cheese to be used for a food science presentation.

"There is a lot of chemistry in food," Sudduth said. "I think a lot people don't realize how ubiquitous science is in our lives now."

The festival will also feature Harry Ringermacher, who will be giving a lecture starting at 7 p.m. on Friday at the **Dudley Observatory on** discovering planets around other "suns." There are around 3,000 candidate planets in the "Goldilocks zone" of their stars, and around three or four are considered "super-earths." Ringermacher though will explain what makes our

solar system rare.

Ringermacher retired last year from General Electric Global Research Center as a senior research physicist. He was project leader of the infrared imaging group, and he also worked with laser techniques and nuclear magnetic resonance for materials evaluation.

The "bread and butter" of miSci is families coming with children, Sudduth said, but seniors are also coming out to see what miSci has to offer.

"Parents and families are looking for things they can do with their children. And learning is lifelong, and I think a lot of people are still looking to learn things after they get out of school," he said. "If you look at individual sciences, everybody has one they are interested in."

Sudduth added learning more about science is a benefit for everyone.

"We don't think people are going to make every child into a scientist or engineer," he said, "but if you are familiar with it, you will be able to make better informed decisions.
