State-roots effort

Anticipating moves of an oil-friendly presidential administration could come at odds with local efforts against pipelines

ALBANY — Earlier this month, Gov. Andrew Cuomo delivered his annual report on the state of New York in a series of State addresses — each tailored to one of six regions and delivered over three days in New York City, Buffalo, Westchester, Long Island, Syracuse and Albany.

Entitled “New York State: Ever Upward,” the addresses featured almost 150 proposals from the governor’s office, including: the completion of the Empire State Trail; a \$2 billion investment in water infrastructure; the expansion of upstate ridesharing services; tuition-free education at public colleges and universities for families making \$125,000 or less; a task force dedicated to fighting discrimination and hate crimes; the closure of Indian Point Nuclear Power Plant; and the development of off-shore wind power sources.

In a heavily Democratic region, many local residents

Area CEOs part of a special pack

Local consulting company offers peer group just for business leaders

ALBANY — In a field typically seen as dominated by lone wolves, CEOs and businesses in the Capital District have a unique opportunity to branch out and learn from one another.

Mahoney Performance Institute, founded five years ago by Shaun Mahoney, focuses on providing companies and CEOs with the hands-on and educational tools that they need to further their own performances and grow their businesses. MPI offers a variety of different programs that focus on leadership development, according to Mahoney, including a series of leadership programs — one geared towards organizational leadership, one around team leadership, and one

about personal leadership. But for those looking to go one step further after those programs and searching for the next step in leadership development, Mahoney also runs a special CEO peer group.

“It’s sort of lonely at the top. Oftentimes, there’s not someone you can really talk to, unless you hire a consultant or you have a board of directors. And so, it’s a group where there’s a continuing education component, and there’s also a peer group that you can share ideas and problems with and get their feedback,” Mahoney said.

Mahoney is not a stranger to working in and with large companies. A native of upstate New York, he has worked for different companies, including JP Morgan Chase, Equifax and Housecall Medical Resources. After 10 years

as CEO of New York-based company NextRidge, Mahoney accepted the role as chairman.

After some time, Mahoney felt that he had several different options, including trying to find another CEO job in the area, moving out of the area or building a business where he could work with other people. Eventually, he decided to proceed with MPI.

“I felt like it was a need in the marketplace that wasn’t being addressed,” Mahoney said. “I thought it would be rewarding.”

The benefit of the peer

group is something his clients seem to agree with. Brian Helf and Casey Toomajian, two CEOs who are involved with the peer group, described their positive experience with Mahoney and his lessons.

“As the leader of an organization,” Toomajian said, “you want to win. I think sometimes for me, the fear of losing and being a lone wolf is more scary than being vulnerable with a group of peers.” He said that having the collective wisdom of the group of CEOs is invaluable and that if you’re in running a business for the long run,



five years. Companies who send their CEOs to the peer group are making an investment in their business, Mahoney said, and each year, people evaluate whether or not it makes sense to come back for another year.

According to Mahoney, there are five to six big decisions that CEOs make every year that could effectively help or hurt their businesses, and it’s his goal to help people through that process so the companies move towards growth and not decline.

“I get to work with a lot of great, bright CEOs. I learn every single day, I’m challenged every single day,” Mahoney said. “The opportunities to try to help make an impact on a company are available to me every single day. That’s what I love about what I do.”

you must be willing to learn from other people and those who came before you.

“I needed help,” Helf said. “I’ve always been a learner from other people, and I’ve always sought out those opportunities — whether its seminars, classes, audio teachings, whether it be book or conference or something.” After he went through the organizational leadership class offered by MPI, he jumped at the chance to join the CEO peer group.

The CEO peer group meets six times a year, but both Helf and Toomajian have been involved for

Drivers must ‘Move Over’ for emergency volunteers

ALBANY — The 2011 “Move Over” law, requiring New York state motorists to yield to law enforcement officers pulled to the side of the road, will now include emergency volunteers.

Gov. Andrew M. Cuomo announced Thursday, Jan. 19, the expansion of the state’s “Move Over” law protecting volunteer firefighters and ambulance workers is now in effect. The law, which the governor signed last year, requires drivers to slow down and move over a lane when approaching a vehicle displaying blue or green lights that are operated by volunteer firefighters or ambulance workers involved in a roadside emergency.

The “Move Over” law also requires drivers to use care, slow down and safely move over when approaching law enforcement vehicles, fire trucks, ambulances, tow trucks, construction and maintenance vehicles

Since the law took effect in 2011, it has been expanded three times to include a wider range of vehicles, and has resulted in more than 79,000 tickets issued to motorists in violation of the law.

“The ‘Move Over’ law is making New York’s highways safer and saving lives,” said Terri Egan, the state Department of Motor Vehicles executive deputy commissioner and former Bethlehem town supervisor.

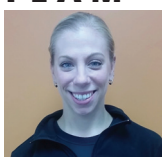

Thousands participate in Albany rally

ALBANY — 7,000 people of all genders and races joined together in downtown Albany this weekend to march in solidarity with other people all over the world against the recent inauguration of Donald J. Trump, the 45th President of the United States of America.

The march in Albany, which commenced at 155 Washington Ave. outside the Albany Public Library, wended its way down the street and ended in West Capitol Park. Thousands of people, some dressed modestly, others sporting pink, and rainbow wings, marched by onlookers with cameras, proudly holding signs denouncing

different aspects of Trump's administration, or professing their support for issues such as climate change, healthcare, and women's rights.

Citizen Action of New York organized the event. Co-sponsors included Albany County Central Federation of Labor, Amnesty International USA, Bethlehem Neighbors for Peace, Bernie Sanders Network of the Capital Region, Capital District Coalition Against Islamophobia, In Our Own Voices, Jewish Voice for Peace Albany Chapter, Mayor Kathy Sheehan, New York Civil Liberties Union Capital Region Chapter, New York Progressive Action Network, New York State Nurses Association, Niskayuna Teachers Association, North Star

Interfaith Peace Walk, Obama Democracy Club, Palestinian Rights Committee, Planned Parenthood Mohawk Hudson, Pride Center of the Capital Region, Robert F Kennedy Democrats of the Capital Region, Saratoga Unites, Schenectady Federation of Teachers Solidarity Committee, Upper Hudson Peace Action, Upper Hudson Planned Parenthood, Women Against War, and the Working Families Party. Local teachers and community leaders also spoke as well.

Jamaica Miles, an event organizer, spoke to the massive crowd gathered around the stage and implored marchers to stay further engaged and involved by joining with any of the groups that co-sponsored the event.

BCMS stages 'Once On This Island, Jr.'

BETHLEHEM — Nearly 75 actors and another 75 student crew members at the Bethlehem Central Middle School have been busy preparing their upcoming musical, "Once on This Island, Jr.," which will take place at the middle school — at 332 Kenwood Avenue — on Jan. 26, 27 and 28 at 7 p.m., with a matinee performance at 2 p.m. on Saturday, Jan. 28. In the event of cancellations

due to weather, there is a snow date make up performance scheduled for 2 p.m., Sunday, Jan. 29.

Tickets are \$5 for students and seniors and \$8 for other adults. Tickets are available to the public in the lobby of the middle school Saturday, January 21 from 10 a.m. to noon and beginning 90 minutes prior to each performance in the upper gym of the school,

just off the main lobby.

Highlighted by catchy songs and dances, the musical tells the story of an island population starkly divided by social class, but ultimately brought together by the powers of love and healing of an orphaned peasant girl, Ti Moune, played by student Frances Johnson.

New principal wanted

The deadline to submit an application to become principal of Bethlehem Central High School is Friday, Feb. 3.

The former principal, Scott Landry, offered his resignation last October, after being on paid administrative leave since May 2016. According to the school district, he was placed on leave due to complaints that he used his position to solicit potential clients. Landry had attended a Capital District-wide job fair as a representative of BCSD, where he reportedly obtained a mailing list of people looking for jobs. Soon afterwards, he had sent emails out to those people, offering his insight and coaching advice for a fee to help clients land prospective jobs in education. Immediately afterwards, Bethlehem Central began receiving complaints.

While Landry has not returned to his position since May 9, his salary — \$131,514/yr. — is still being paid. He contended that he was placed on leave as retaliation for information he uncovered regarding finances and grading practices at the BCHS Lab School. However, he did refund the \$160 he earned from the four clients who took him up on his offer.

While Interim Principal Mike Klugman, former Bethlehem Central Middle School principal, is currently running the high school, the district hopes to find a permanent replacement for the 2017-18 school year.

Tea and British history

Skidmore professors Catherine Golden and Tillman Nechtman will spend an afternoon at the library discussing the global history of tea in Victorian-era Britain and beyond.

The program, "From Wonderland to the Jewel in Victoria's Crown," takes place Sunday, Jan. 29, from 2 to 3:30 p.m., and starts with the display of a tea box, a popular object in the Victorian household, and touches on tea's literary influences, including the Mad Hatter's tea party in Lewis Carroll's "Alice in Wonderland."

From there, the conversation will turn to the global stage, discussing tea as a commodity in the broader British Empire. It's a perfect primer to the "Victoria" miniseries, which aired its first episode on PBS Jan. 22. Tea and refreshments will be served.



Golden is a professor of English at Skidmore College and author of "Serials to Graphic Novels: The Evolution of the Victorian Illustrated Book," due to be published later this year, "Posting It: The Victorian Revolution in Letter Writing," and "Images of the Woman Reader in Victorian British and American Fiction." In addition, she is editor or coeditor of five additional books on topics ranging from Charlotte Perkins Gilman to Victorian illustration, literature and culture.

Nechtman's teaching and research interests focus on Britain and its empire. He has published widely on the cultural relationships between Britain and India in

the 18th century. His work has appeared in such journals as History Compass, The Journal of Women's History, and The Journal of Eighteenth-Century Studies. His first book Nabobs: "Identity and Empire in Eighteenth-Century Britain" was published in 2010. He is now working on a new monograph-length study of Britain's empire at Pitcairn Island in the South Pacific.

and interest groups are looking to Cuomo to insulate New Yorkers from decisions expected at the federal level, particularly regarding things like the environment and health care, widely expected to be negatively impacted under the incoming Trump administration.

“The president-elect and a lot of folks that we see being appointed to Cabinet positions have been, I think, very pro-fossil fuel industry and certainly very pro-pipeline in their statements,” said Conor Bambrick, air and energy director for Environmental Advocates of New York (EANY). “It ultimately comes down to Governor Cuomo and his team and how much they’re willing to take a stand like they have been recently.”

In 2016, Cuomo and the DEC essentially thwarted pipelines that were vocally opposed by residents — those who would be affected by the pipelines themselves as well as those who would be negatively affected by the overall increase of fossil fuel transportation in the region, via the much-protested oil trains into the Port of Albany. While he didn’t specifically mention pipelines or oil trains in his 2017 addresses, the governor outlined several proposals that could have the effect of deterring the expansion of oil transportation around the state.

A proposal to reduce a carbon emission cap by at least 30 percent between 2020 and 2030 could make it difficult for the oil industry, even with the help of the federal government, to pass environmental standards set forth by DEC. “New York has a goal to reduce climate pollution in this state by 40 percent by the year 2030 and 80 percent by the year 2050,” said Bambrick. “And they have a state energy problem, so they have to look at these kind of projects in the context of those goals.”

Other proposals that could potentially affect the fossil fuel industry in New York state are greater regulation of methane-producing sources, such as those in the oil and gas sector, and the preservation of open spaces and farmland.

“Certainly the actions that both [President] Obama and Gov. Cuomo have taken administratively are commendable,” said Bambrick. “They’re doing what they can, but when you’ve don’t have a partnership with the legislature — whether the legislature refuses to work with the administration or the administration just

acts unilaterally — you run into a situation where a subsequent administration can undo all the good work that you’ve done.

“I think that’s a real threat on the federal level and I would hope that Gov. Cuomo sees that and feels the need to work more closely with the legislature to actually lock clean air and clean climate policies into law.”

“I have been advocating for those living in the South End of Albany over concerns regarding the transportation of crude oil for the past three years,” said Albany County Executive Dan McCoy. “Global Partners has now been required to update

“Cuomo has a history of only doing the right thing when pressured by grassroots organizations and public opinion,” said Diana Wright of People of Albany United for Safe Energy (PAUSE). “Much of his campaign donations come from the gas and oil industries so he is reluctant to alienate those donors.

“It is imperative that our state legislators, led by a proactive Governor,

quickly enact laws which protect the State from the climate-denying cabinet the president-elect is amassing,” she said. “NY Renews, a coalition of 82 organizations from across New York, of which PAUSE is a member, has called on Governor Cuomo to work with the legislature and enact the Climate and Community Protection Act, which will ensure all of New York’s decisions meet the dual standards of climate safety and environmental justice. This bill has passed the Assembly, but is again awaiting introduction in the Senate.”

In the meanwhile, said Wright, PAUSE will continue to do what they’ve been

sustainable energy future.”

“It’s always helpful when communities and residents make their voices heard,” said Bambrick, calling fossil fuels a statewide issue. “It certainly makes the case to the Cuomo administration to act or to not act.”

In response to the looming spectre of ACA repeal, and without proposing a specific plan, Cuomo told New Yorkers, “We will not go back to a place where nearly three million New Yorkers are uninsured or Medicaid is decimated and our world class New York healthcare system is dismantled. We will not allow that to happen in the state of New York.



doing since 2014: “Educate, organize, demonstrate; we have formed alliances with many environmental and social justice organizations across the state and the country to strengthen our messaging and our impact.” PAUSE recently became an affiliate of 350.org and is working with groups in Maine, Massachusetts and surrounding states to push a divestment agenda to convince financial institutions such as TD Bank — a major backer of the controversial Dakota Access Pipeline — to withdraw financing from that and other fossil fuel projects. This includes the Keystone pipeline, which Wright said has a good chance of coming back due to Trump investments in that pipeline. “We will continue working to keep fossil fuels in the ground, while advocating for a safe, clean,

We’re going to work with [healthcare union] 1199 and the greater New York Hospital Association to make sure that doesn’t happen.”

“These are frightening times,” Cuomo said, ending his final address in Albany. “And these are difficult times. And these are politically ugly times. And the election was dramatic and the political season was heated. And I can’t tell you how many people literally seem shaken by what has been going on in the country, and questioning who we are and what we believe and what we’re all about. But I want you all to rest assured that these are stormy times and they’re times of instability, but New York will always be New York.”

WHAT HAPPENED IN 2007...

10 years ago: full day kindergarten

DELMAR — Ten years ago, the Bethlehem Central School District was considering the implementation of a full-day kindergarten program.

Prior to the school board meeting on Jan. 17 of 2007, the district had visited the topic many times before, according to a 2007 *SpotlightNews* article. The revisitation of the topic was partly a response to a year before that, when the New York State Board of Regents suggested that full-day kindergarten programs be made mandatory in the state.

At that time however, the district had many other construction projects occurring simultaneously at the middle school and high school. The newest elementary school, now known as Eagle Elementary, was set to be complete in 2008. The projects were meant to ease the burden of overcrowding in the district.

With the implementation of a full-day kindergarten program, more classroom space would have been needed to accommodate the shifts of students. According to the article, \$3.6 million in

state funding would have been provided to do so.

"It will provide us with the kind of facilities our students and children deserve," Les Loomis, then superintendent said. "It's the first time we've ever had the opportunity to build space for full-day kindergarten without cost to the taxpayer."

He suggested in 2007 that the board act to implement the full day programs now while they have state aid available, in response to some board members wondering whether or not the aid was

only available for a limited period of time.

He also said that if the district opted to go the full-day program route, there would still be state aid money left over to use on other capital projects.

Other members said that the full-day programs would cause some costs to go up. For example, the district would have to pay the teachers for full days of kindergarten. Loomis countered that that would be offset by less money being spent elsewhere, such as the elimination of the mid day bus runs.

Busy chick

The interview was wrapping up just a few minutes before her show was to start.

Was there anything you'd like to add that my questions didn't touch upon?, I asked.

"We didn't even talk about my sobriety," said Erin Harkes.

The local musician and, as of four years ago, comedian is never shy about the subject of alcoholism. Her sobriety has been covered in newspaper features. It's a part of her comedy skit.

I didn't want to ask, because I didn't want readers to think it defined you.

"It's very much a part of me," said Harkes. "I would not be who I am without my sobriety."

According to the National Council of Alcoholism and Drug Dependence, Inc., roughly one and twelve people in the United States suffer from alcohol or substance abuse. Harkes has been sober for six years. Those participating in Alcoholics Anonymous carry a token depicting the length of their

Folk brothers

Livingston Taylor and Tom Chapin to share the Cohoes Music Hall stage Saturday

COHOES — Folk musicians Livingston Taylor and Tom Chapin know what it's like to have famous siblings.

Livingston is the younger brother of James Taylor — the man responsible for songs such as “How Sweet It Is” and “Carolina In My Mind.” Tom is the younger brother of the late Harry Chapin, whose song “Cats in the Cradle” still resonates with fathers everywhere.

“Certainly for both Tom and I, we share a unique relationship with older siblings who have had outstanding musical careers,” said Livingston.

This isn't to say Livingston and Tom haven't been successful in their own rights. Both are accomplished folk singer-songwriters who play to sold-out crowds in theaters across the U.S. — oftentimes sharing the same stage.

“I love performing with Livingston. He's an old friend of mine,” said Tom. “In fact when Harry died (in a July 1981 car accident), Livingston was the one who called me first to offer his condolences.”

Livingston and Tom will perform together again Saturday, Jan. 28, at the Cohoes Music Hall, 58 Remsen St. in Cohoes. They'll be joined by EVA — a young folk trio featuring Liz Simmons, Nicole Zuraitis and Kath Buckell — and opening act Yael Deckelbaum and Kristin Hoffman.

Tom said he's looking forward to performing in the Cohoes Music Hall, which re-opened as a concert and theater space last year after the Palace Theatre took over the operations of the 300-seat Vaudeville-era venue.

“I love all these old theaters,” said Tom. “I was a history major at SUNY Plattsburgh, and I feel those old rooms all have ghosts — ghosts of people

who once performed there.”

Livingston, Tom and EVA will all play mini sets alone before coming together at the end for a big folk jam.

“My songs — my writing — tends to be an encapsulation of my curiosity,” said Livingston. “The writing of music documents what I've been able to observe over the years.”

And along the way, Livingston and Tom are hoping to get the audience laughing and singing.

“There's something very powerful about getting people singing along to your songs,” said Tom.

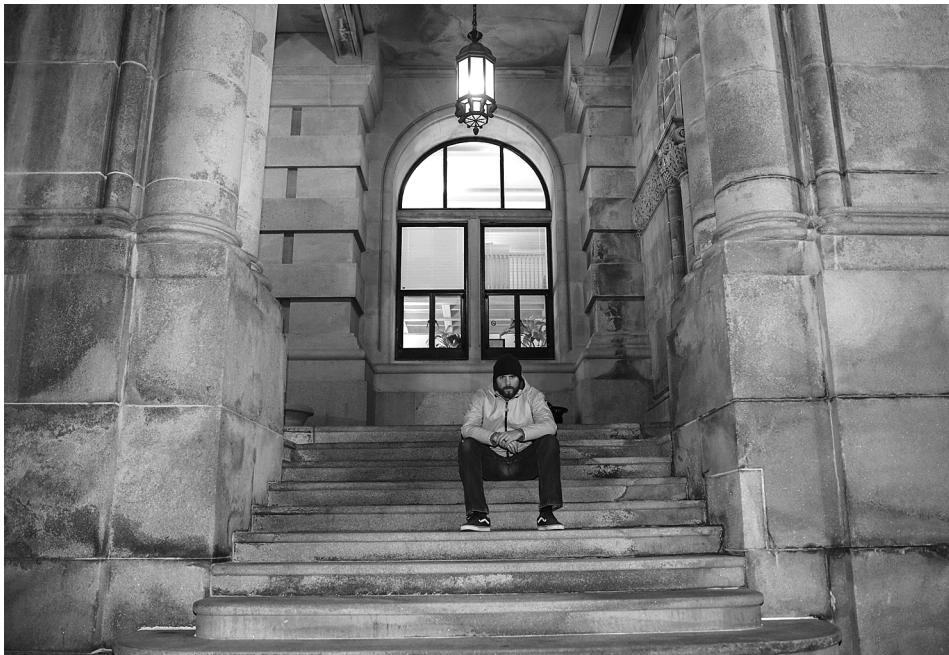

Breaking down Malk

CAPITAL DISTRICT — 2017 will be huge for local hip-hop artist and producer Big Malk. He has a few irons in the fire, the first of which should be out in February with a conceptual album titled "The Plaza." It's a compilation of 15 tracks

covering Albany's Empire State Plaza, that is to feature Elsphinx, Sev Statik, Sime Gezus, Darkstar and Juice Mega. Another iron involves a second compilation he expects to drop in April through a recently established partnership with Ok-Tho Records (ok-to.com).

A lot of hip-hop artists and producers in the industry didn't get there over night.

For Malk, it's a career 25 years in the making. Laying down a beat, maybe add a bass line, throw in some samples, and say, spit or rhyme something really prolific so it flows. When superstars reminisce on what influenced them, they often mention the underground music scene in the Bronx in the late '70s and early '80s — Boogie Down Productions, Sugar Hill Gang, Run DMC, Beastie Boys. Back when he was a kid, little Malk didn't know he would someday become Big Malk.

"I started off as a fan of hip-hop first," said Malk, as he reflects on what sparked his interest. "Like 1992, when Dr. Dre's 'The Chronic' came out. I was only 8, so my mom wasn't really having me try to listen to it. But, my cousin, he used to play me stuff. Early Gangstarr, Onyx, Dr. Dre and N.W.A."

Being a fan of hip-hop is one thing, but making the music yourself is the challenge.

Malk started his hip-hop life early. He grew up next to the original Drome Sound in Schenectady, so he was always into music. Malk and his friends would go in there and play with the drums and keyboards at a pretty young age.

"I had no idea about making beats back then," said Malk. "[I was] just was a fan. ... [Around] '94, '98, Media Play came to Mohawk Mall and I was buying tapes, then CDs, every Tuesday. That's why my label is actually named Media Play now, as an ode to that store that I spent hours in during my formative years."

Malk started earning his bones as a rapper as a young teenager. "I performed at my middle school talent show in 8th grade, and pretty much rapped all through

high school."

Now a dedicated, multi-talented staple in the Northeast, Malk is developing his own sound, as well as many others. His name is associated with Bumpy Knuckles, Roc C, Neek The Exotic and Dark Lo. Locally, he's had his share helping Sime Gezus, SMGs (Juice Mega & Darkstar), Sev Statik and Elsphinx. Google all and you'll be impressed with both their resumes and longevity.

"I have produced for a bunch of artists, both local and global," said Malk. "In 2006, I formed my first label, Degenerate Gamblers Music, and we put out a bunch of mixed tapes as DGM Squad, which was me, my little brother, my man Big Nucc, and Uncle Torr. Just fun stuff for the people we knew around the hometown scene. In 2008 I got together with Jack of All Trades and put out my one and only true album as an emcee, titled "Local To Global."

Malk started playing live and took inspirations and created from that.

"Jack of All Trades taught me how to use an EPS 16-plus keyboard and I studied him using that thing for five months straight," he said. "He had learned how to use it from PJ Katz and The Vinylcologist, and those three dudes were pretty much my first real inspirations as producers."

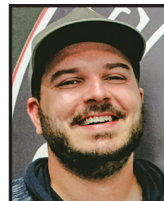

“Easy Breezy” Paneer

Paneer is an Indian cheese, though its roots can be traced to Ancient Persia, Turkey, Azerbaijan and Armenia. It is a simple unprocessed cheese. It is hard to get fresh and authentic paneer in the stores, so we recommend making it right from whole milk.

In this recipe, we first describe the process of making paneer, and then go on to describe a mildly spicy preparation that be used either as an appetizer or as a main course. The ingredients we have used can be obtained from any grocery store, and one doesn't need a separate trip to an Indian grocery store.

Cooking time: two hours

Ingredients — Serves four

- 2 quarts whole milk
- 1 cup lemon juice
- 1 tsp salt
- 2 cups oil for frying

For saute :

- 1 medium size onion Red onion : Medium size
- 1 one cubic inch peeled ginger
- 5 cloves of garlic
- ½ tablespoon red pepper flakes
- Salt to taste
- 4 tablespoon dry crushed basil
- 5 slices sun dried tomatoes
- 1 medium fresh tomato

Preparation

Add salt to whole milk and boil in a heavy bottom, one-gallon pan.

When the milk comes to a foaming boil, lower the heat and immediately drizzle in the lemon juice and stir very gently only in one direction. Clumps of cheese should separate from a light, yellow whey. Sometimes, desired clumps do not form immediately, and more lemon juice is added in increments of one tablespoonful until all the cheese has formed. Turn off the heat now.

Line the inside of a colander with a wet, heavy-duty cheesecloth, and allow a portion of cheese cloth to hang on the sides of the colander. It is best to keep the colander in the kitchen sink. Drain the cheese through the cheesecloth. For larger clumps, a ladle can be used, followed by draining the remaining small pieces all at once. At this time, sprinkle cold water around the cheesecloth so that you can handle the cheese safely. Gather the sides of the cheesecloth and twist to squeeze out bulk of the water from the cheese.

Use cold tap water as needed to help cool down the cheese. Let the cheese hang from its own weight inside the kitchen sink for at least an hour. You can also press down the cheese with a weight, like a heavy bowl. Cheese will attain consistency of mozzarella cheese or tofu. You should be able to cut it easily with a kitchen knife without the edges crumbling. Cut into 1-inch cubes.

Heat oil in a nonstick wok or sauce pan to moderate heat. It should be hot, but not smoking. Gently add paneer cubes in batches of 8-10 pieces at a

time. Turn constantly until the edges are sealed and golden brown. With a slotted spoon, remove the cubes and drain on paper towels.

Mince garlic and ginger separately. Dice onion. From the same oil in which you fry the paneer, take four tablespoons of oil in a separate pan, heat to moderate and sauté minced garlic for a minute — then, add minced ginger and sauté for another minute, and finally add the diced onion. Sauté for about five minutes on medium heat until the onions are soft and golden brown. Now, add diced sun dried tomatoes and, after another minute, add diced fresh tomato, dry basil, red chili flakes and salt to taste.

Add the fried cheese, and mix all the ingredients well. After about a minute, remove from heat.

Easy Breezy Paneer is ready to be served.

The Va Va Voodoos' 'Bubblegum Fury!'

'60s garage rock band already a local favorite

Something of a paradox presented itself after throwing "Bubblegum Fury!" by The Va Va Voodoos into the CD player. Contemporary technology produced a blast of lo-fi '60s garage rock one would expect out of the Mamas and the Papas.

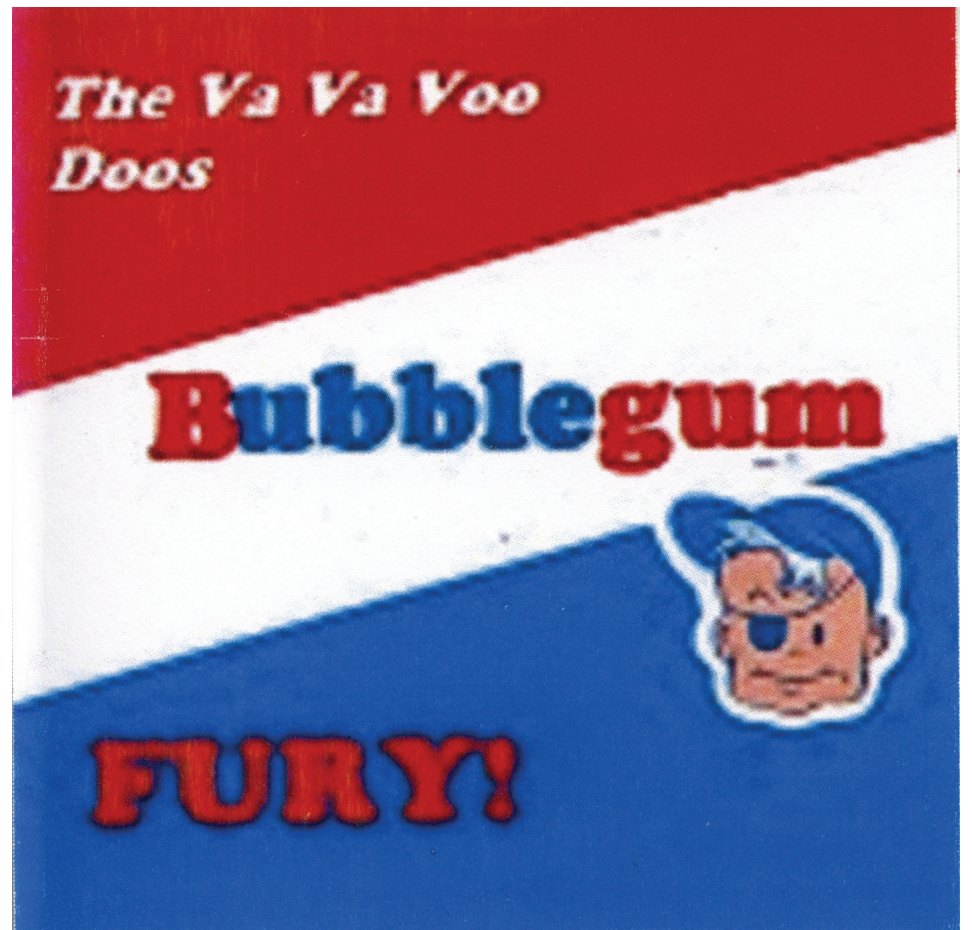
And, that's no mistake.

So, before I looked for the goon who somehow concocted a bluetooth connection between my CD player and a portable 8-track player, I looked into The Va Va Voodoos. Sure enough, this is their kind of thing. Exactly as described, '60s garage rock, with a little folk, a little sci-fi (see also "Theme From Surfer Ghoul") and all out fun. Take into consideration the band's collective interests: Monster movies, sci-fi, beat up flying saucers, cars

with balls, major and underground comic books, baseball cards, action figures and Mexican wrestling. This four-piece band out of Troy bends time backwards and takes you on a magical hippy-hop trip.

Formerly The Mysteios, The Va Va Voodoos recorded "Bubblegum Fury!" last January at The Burgherhof in Troy. Authentic to the time, Johnny Mystery and Jo Agopovich provide masterfully distorted guitar and bass, respectively. On "Going Back to the Rodeo," the band's most recent single from the nine-song EP, ironically features lead vocals from Tambourine Girl - never to be mistaken for the young, tambourine shaking wallflower, Tracy Partridge. She takes front and center on vocals, with Dan Electro in the back, behind the drum kit.

The only thing potentially ripping you out of this time warp is the 10-second synthesizer play introducing "Space Girl." Otherwise, you have an authentic reproduction of a by-gone time, short tracks and fast-paced. Some influences of The Fleshtones can be detected, especially from the bookend tracks of "Dance Like

You Have Some Soul," and "Theme From Surfer Ghoul." It is a fun experience to allow yourself. The Va Va Voodoos do for old school garage rock, what Off The Record does for '60s lounge music.

After receiving her Masters Degree in 1963 from Rensselaer Polytechnic Institute, Marjorie was invited to join the faculty of Russell Sage College where she taught art history. She was named Teacher of the year in 1972 and an Outstanding Educator of America in 1973. After her retirement in 1983, she painted full-time creating many of her finest works.

Semerad's art is in the collections owned by The Albany Institute of History and Art, Union College, Albany Law School, The Sage Colleges, and numerous banks, corporations and individuals.

Busy chick

respective sobriety. A reminder. A last extension of a helping hand before one walks into a bar.

Harkes spends her life in bars. According to last year's schedule, she worked 274 shows; on a 365-day calendar, that's three-quarters of her days. The musical comedienne quit her day job about four years ago. "It's a hard thing to do when you're surrounded by ...," she said, gesturing behind her: a bar that stretched the length of the room, lights bouncing off bottles of liquor and the shiny metal of beer taps. In a career that

often obligates her to perform in front of her former vice, she expressed pride in her ability to maintain the course.

But, Harkes said she understands not to be overconfident. She's her own manager, and her own accountant. "No one does me better than me," said said. She's her own boss in a line of work that requires a thick skin impervious to crowds unreceptive to her jokes, indifferent to her songs, or the occasional heckler. It's also needed when she listens to her body, feels a familiar urge, and packs up her equipment. She said it doesn't happen often, but it boils down to a short conversation between herself and the venue owner: the owner either understands or she doesn't play there again. Her attitude is not out of contempt.

In the end, she said, she has to take care of herself.

Despite her propensity for travel — again, 274 shows last year — Harkes has attempted to be more selective with her shows. When she first quit her job, she said she would take every opportunity presented her way. Last year, she attempted to taper off the number of shows by selecting quality over quantity. It was a means to prevent herself from burnout. There's also the balance between her music career, and her comedy one.

"If I wasn't doing music full time, I'd probably be doing a lot more comedy," said Harkes. Her reputation is strongest with music, so it pays more. "It's like you couldn't take an unpaid work day to go do whatever your hobby is. So, it's really hard

for me to take comedy shows. They have to be really worth it. ... I have to sit down and seriously look at it. Is it really worth it? Is it a good investment? Sometimes the return, you don't make any money at all doing comedy. So, I just work really hard on the other end to supplement it."

So, you're a double threat like a Bo Jackson?

"[Laughs.] Do you really have to make a sports reference to a musician?" she asks.

Adam Sandler?

"I prefer Bo Jackson."

Truth be told, she holds on to early comparisons to former Fleetwood Mac lead singer, Stevie Nicks. Harkes' soulful lyrics, her music delivery and, perhaps, her light-hued locks, has had people comparing her another double-

threat. (Nicks has long been known as a dancer during live performances, and is recognized for her contributions to fashion, as well.)

“The first music I remember listening to was Fleetwood Mac,” said Harkes. “I loved the harmonies. I loved everything about it. ... I was born in 1977. Clearly these albums were before my time. I’d just like to state that [for the record],” she said, as she laughs some more.

Jackson — again with the sports reference — was a rare gem of an athlete who excelled at two professional sports. He would often be asked as to which he preferred, and obscurely referred to one as a hobby over the other. Harkes said she loves both music and comedy — and doesn’t want to choose.

“I love music,” she said. “It provides for me. I feel very blessed. I mean, I work really hard and it just blows my mind that I’m able to do it [for a living]. The comedy is way harder. I don’t know if it’s because it’s still new to me still. The excitement is so fresh. I get nervous, and I enjoy that.”

“They each have their pros and cons,” Harkes said. “I wouldn’t say I love them equally. I love them much differently.” With music, she said, she sits down and dives into the music. No interaction with the crowd is needed. However, she describes comedy as sometimes “terrifying,” because she’s not able to hide behind anything. The interaction between performer and audience is vital to the quality of a show. “It’s like every few seconds, someone’s standing on your

chest.”

“With the comedy, you need the audience and you need the attention,” said Harkes. “It seems like I’m putting myself in a precarious situation, because I’m already an attention-starved individual.”

It’s January, and Harkes has her schedule planned out for the entire year. She’s the regular host of the all-female comedy show “Chicks Are Funny” at the Funny Bone in Crossgates, in addition to the hundreds of shows to which she travels. There is no time to reflect on her progression, but she said she sets goals with each coming year; one of which was performing last year at Carolines on Broadway in New York City.

“I don’t ever like to tell people my goals,” said Harkes, “and I’m the only

one who knows if I fail them.” But, just as she did when she quit her day job, she’s taking the opportunities that come to her. Only this time, the opportunities are getting much better. Before she was able to establish goals for 2017, she was already accepted to perform at the Boston Comedy Festival. And on television, she was asked to appear for the third season of Hulu’s “Laughs TV.”

“The things I didn’t expect, the things I didn’t anticipate I would get, I got them,” said Harkes. “I don’t know. Sometimes it’s throwing so many things up onto the wall and seeing what sticks.”

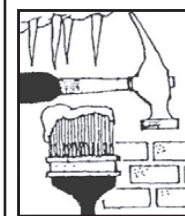

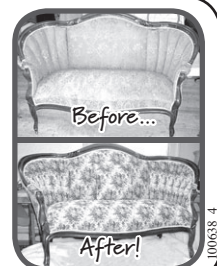

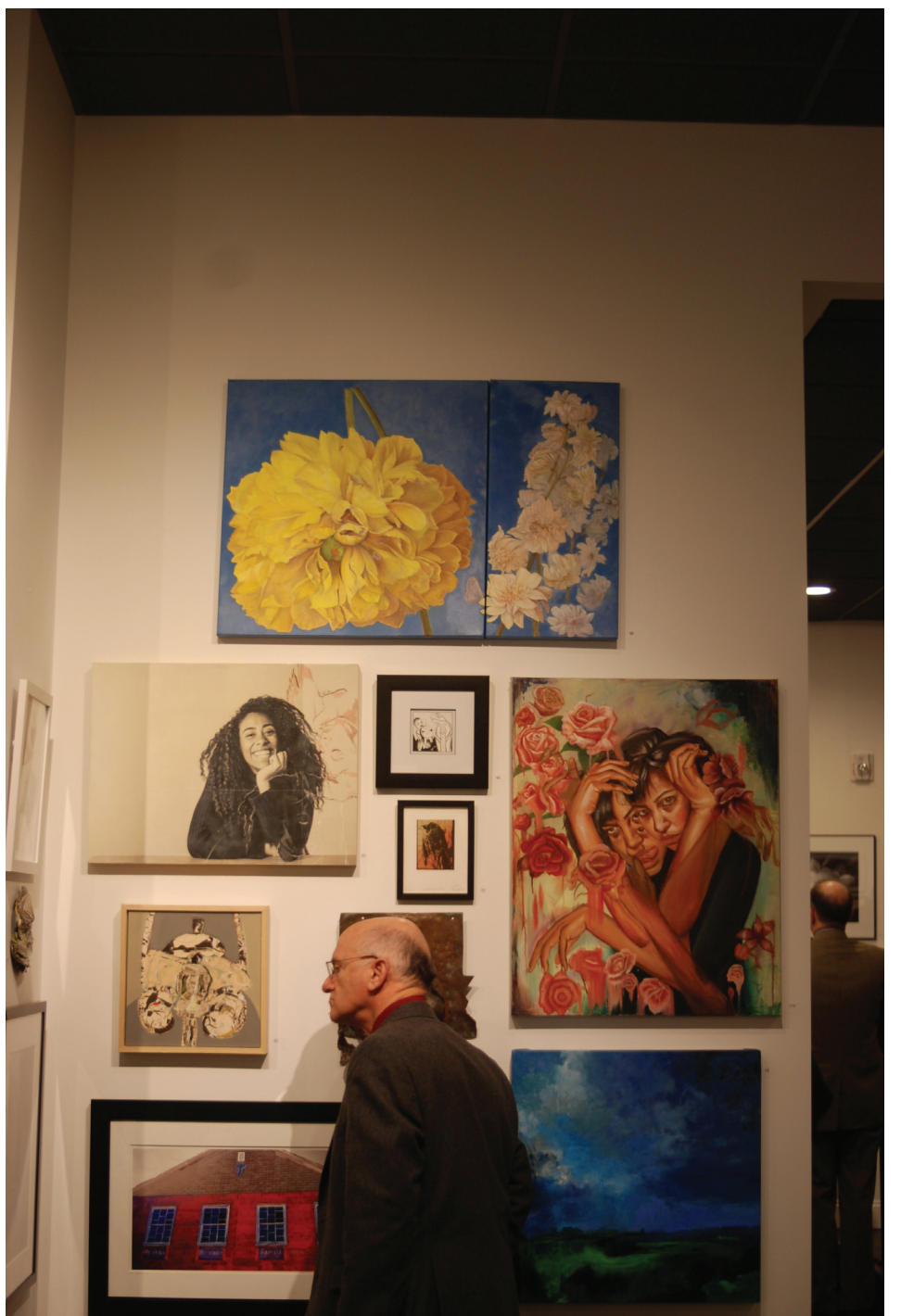
