Elsmere Eagle Scouts talk about what it takes to achieve BSA's highest rank, and why they didn't stop there

**BETHLEHEM** — Perseverance. The newest Eagle Scouts in the Boy Scouts of America Elsmere Troop 58 will tell you that's one of their biggest takeaways after having achieved a rank that only an approximate four percent of Boy Scouts have ever attained. In addition to learning how to tie a knot, administer first aid and survive in the wild, learning to overcome their own limitations and persist even in the face of adversity are skills they now know will continue to serve them throughout their adult lives.

In late December, Troop 58 held its semiannual court of honor ceremony, recognizing the achievements of Scouts who earned merit badges in a variety of areas, such as first aid, fitness, fire safety, reading, personal management, even dentistry. Five scouts advanced in rank, while Eagle palms were awarded to those who continue their service and involvement even after achieving the organization's highest rank.

"As you progress through the ranks, you go from learning the actual skills and, as you become an older scout and advance toward the rank of Star and the eventual Eagle and Eagle palms, your job is to then take that knowledge and practice what you preach and teach younger scouts," said Eagle Scout Connor Roddy. "And so you almost create a life cycle of scouts teaching and being taught, and so on."

"I earned my Eagle earlier this year," said Joseph Fierro. "I'm also a member of camp staff at Rotary Scout Reservation, and I have to say it is quite an experience to give back to the program that I once experienced as a camper."

In the nearly 100 years that Troop 58 has been in existence, hundreds of Elsmere Scouts have advanced to the rank of Eagle Scout. "We've had a very successful history," said Roddy. Nearing graduation, he said he would like to join an inner-city troop if he attends college in Boston — in the hopes of

# County sues big pharma for role in opioid crisis

# ALBANY COUNTY -

County Executive Dan McCoy announced on Friday, Jan. 5, that his office has filed a federal lawsuit against national pharmaceutical manufacturers that argues they should be held accountable for employing deceptive practices which contributed significantly to the opioid crisis currently affecting Albany County and rest of the nation.

McCoy was joined by Elizabeth Smith from Motley Rice LLC, the law firm representing the county in the case.

"One of the biggest crises affecting our community is the ongoing opioid and heroin epidemics," said McCoy. "It is unacceptable that our families, friends and communities continue to experience devastating heartbreak over the loss of life, just so these pharmaceutical companies can get rich. Today's litigation puts these companies on notice that Albany

County will not tolerate their actions anymore."

In 2014, opioids as a class generated \$11 billion in revenue for the pharmaceutical companies, according to the Office of the County Executive, which maintains it is a direct result of deceptive marketing from these companies, which has resulted in the overprescribing of their drugs.

Per McCoy, Albany County had 11 heroin related deaths, eight deaths from opioid pain reliever overdoses, and nearly 1,200 unique clients admitted to treatment programs for heroin and other opioids in 2016, who said the epidemic is costing the county millions of dollars for treatment, law enforcement and other related costs.

According to McCoy, while Albany County is among one of the first municipalities to bring suit against big pharma — in this case, Perdue, Endo, Teva, and Janssen — it is the first to invoke the Violations of Racketeer Influenced and Corrupt Organizations Act (RICO) to claim that the companies are collectively

guilty of engaging in racketeering by engaging in deceptive practices, knowing their products are addictive, with the intent of making money.

Of the other three charges brought by the suit, two invoke state law to allege false advertising and engaging in deceptive acts or practices in the conduct of business, trade or commerce. The third argues that the way the companies have conducted themselves constitutes a public nuisance.

For all four charges, the county is seeking damages. For the public nuisance charge, it is also seeking a permanent injunction prohibiting the named companies from "further statutory violations and from engaging the acts and practices that caused the public nuisance."

Any money awarded to the county would go toward treatment, services and programs for those impacted by the epidemic.

# BCSD weighs options to sell former school

**BETHLEHEM** — The topic of selling the former Clarksville Elementary School building to Albany County was tabled by the School Board on Wednesday, Jan. 3, as it mulls over its options.

The building's current occupant, the Albany County Sheriff's Department, presented an offer to purchase the building outright late last year. The offer forgoes its three-year lease-to-purchase agreement.

Albany County had an opportunity to purchase the building last August when it's original lease agreement expired, however no decision was made. BCSD then extended the lease to end at 2020. The County has now offered to buy the building for the \$325,000 price the two parties originally agreed upon.

The volume of Wednesday night's public comments contrasted against last year's fervor over the board's willingness to sell. Outside of the nearly two dozen high school students attending the meeting for class credit, only two residents stood to speak

"It seems like we've been talking about this for a year," quipped district Chief Financial Officer Judith Kehoe before detailing options to the School Board and residents. The School Board hosted three public meetings on the topic last

year, immediately prior to what some anticipated to be the sale of the former school building to the County.

Local business owner Jennifer Bull asked the board trustees if it considered seeking other potential purchasers, such as herself.

"I would be more than willing to pay \$325,000 to the School Board," said Bull, "if they're actually interested in selling it outright for that amount of money. Obviously, it would not involve in-kind services, but you'll be getting more money, total."

The question sparked discussion among board members. Trustee Jonathan Fishbein asked what steps could it take to entertain offers from other parties. No one knew.

"I don't know what the process is either," said Fishbein, "but, I think it's worth asking. ... I don't know if [Bull would] be willing to buy it at a higher price. I don't know if it's a piece of property that is worth more on the open market. ... I don't know if we've done anything more, because I don't think we thought we could get anything more. But, the question now is, [the County has] opened it up again, maybe we should look again."

The 70-year-old school building is on the National Registry of Historic Places. The district funded a renovation in 2003 through a bond and is obligated to continue making payments until 2022. Its full market value is assessed at \$1.7 million, however, an appraisal valued it at \$410,000. The agreement to sell the building to the Sheriff's Department at \$325,000 includes an adjustment of \$85,000 for avoiding maintenance costs upon the close of a sales deal. The County's

offer to the school district repeats the original agreement: \$198,000 in cash, with \$127,000 in-kind services, which involves regular patrols of the Clarksville neighborhood. It also includes a right-to-first refusal clause, which would allow the school an opportunity to buy back the property should the County later decide to sell. The only change is that, now, the County doesn't want to wait before taking ownership. If the school district rejects the offer, the Sheriff's Department will up and leave

Kehoe's presentation leaned away from reopening the building as a school citing such costs, including staffing and maintaining the building's infrastructure, in excess of \$1 million a year. Last year, the district pointed to decreasing enrollment as the cause for closing the 11-room school building in 2011. Nonetheless, Clarksville resident Judy Abbott begged the board to hold on to some land to address potential residential growth.

"So that if you need to build a new school, it's in Clarksville," said Abbott, wearing a black Clarksville Elementary sweatshirt featuring the district's eagle's head logo. "Because, you've been turning your backs on our elementary school children."

The District will wait for another property appraisal and research whether it can list the property for sale.

# Candidate cries syntax error

Fire department website ignites questions about district election practices


 $\mathbf{DELMAR} - \mathbf{Google}$  the term Delmar Fire District and you will be taken to a website. delmarfire.com. The site features district information and a link to the Facebook page for the Delmar Fire Department, which, according to Delmar Fire District Commissioner Chairman Gregory Gould, actually hosts the website.

While both Google and the Bethlehem Chamber of Commerce provide a link to that website under the search term and link, 'Delmar Fire District,' Gould contends that it was created and is maintained by the department, the nonprofit entity comprising volunteer firefighters who serve

the Delmar Fire District. (The fire district, by contrast, is a political subdivision of the state typically made up of a fivemember board of commissioners and administrative staff — that oversees and manages the department, and is subject to more regulation.)

The website was a source of contention during the recent district election, in which Heather Dorsey narrowly lost to George Williams, the fire police captain for the Delmar Fire Department and ostensibly its favored candidate for commissioner. During the weeks before the election, an endorsement of Williams was posted on the department's website and Facebook page and, according to Dorsey and her supporters, any comments she posted in an effort to promote and/or defend her own candidacy were erased from both

to the Delmar Fire District in any way, shape or form," said Gould. Noting that it's easy for unofficial sites to be put up on the web and other social media platforms, he continued, "The fire district does not have a website. It belongs to the department, not the fire district. So that's the biggest difference."

"A fire district can not endorse a candidate for anything," said Gould. Claiming he was not aware of the post promoting Williams, Gould added, "I don't even think

the department can endorse somebody."

Saving she was confused and hurt by the department's use of its website to promote Williams, Dorsey noted a series of internal district emails that circulated just prior to the election, beginning with a criticism of her candidacy and call to vote for her opponent that was written and sent by Arlie Hedges, First Assistant Chief of both the district and the department. An angry rebuttal

"Even though Bethlehem is a very affluent town, there are a lot of families that don't have enough money for food. Or, their Social Security benefits don't cover a


whole month and they have nowhere else to go for food," explained Holden.

# 'Vliet Heatly wins RCS wrestling tourney



sharing what he has learned with Scouts who may not have the same opportunities he has benefited from in Elsmere.

One of his favorite memories as a younger Scout was of hiking in the Adirondacks when he was in sixth grade. "One of the first big hikes I ever did," said Roddy. "Wet and muddy, it was an experience that I don't think any other activity would ever provide you. I can't think of any activity that I would be kneedeep in mud, cold and miserable, but at the same time having an absolute blast with my friends and learning how to do things like cooking breakfast, pitching tents, cutting wood, finding potable water, stuff like that."

Fierro said his scouting experiences have not only taught him to be more extroverted, but life skills such as communication and leadership as well. "Skills," he said, "that I'll carry with me for the rest of my life."

"This troop is very active and that's why there are so many Eagle Scouts," said Rose Ann Garry, a Committee Member for Troop 58. "And that's because we have adult leaders who are willing to go on outings with the guys, because those are

the things that are required for Eagle — you need to have 20 camping nights, for example, and there are other things like canoeing, hiking and community service — so, if troops don't have that support to get them out on those outings, they're not going to be able to get to that rank."

Community service, noted Andrew DeCandia, a Senior Patrol Leader and a Life Scout who is currently working on his Eagle rank, is a very important aspect of being a Boy Scout, even into adulthood. "We do a lot of community service to give back to the community," he said. "Because for us to go on all these trips that we go on, we need support from the community. We need them to support us in our fundraisers, things like when we do the pancake dinner - which is coming up on January 16 – and the car wash and the selling popcorn and all of these things. Certain badges and accomplishments, as well as time spent in troop service, are required for rank advancement and must be signed off on by the Scoutmaster or an Assistant Scoutmaster.

The requisite Eagle project must be approved by the Troop Committee and Council Advancement Committee before beginning, and the candidate is expected to give leadership to other Scouts in doing the work and to draw from his previous Scouting experience to see that the work is done well. After reaching Eagle, scouts may continue to work on merit badges, For every 5 additional merit badges plus 3 months of active participation in the Troop a scout may earn an Eagle Palm.

was then issued by District Commissioner Pat Dorsey, Heather Dorsey's father.

According to Dorsey, her platform included a plan to "keep taxpayer dollars in the town." She said she feels public safety is jeopardized when firefighters, particularly officers, live outside of not only the Delmar district, but out of town altogether. As the stations are not manned around the clock, volunteer firefighters respond to calls from their homes or businesses, driving to the station first, manning the apparatus and then driving to the fire. The increased response time is one concern, she said, but also the speed with which out-of-towners are likely to drive to the station when they receive a call. "It would be on my agenda not to allow this to happen," Dorsey said.

Dorsey said she isn't the only person who has felt disrespected by department officers, characterizing them as unwelcoming to new volunteers and more concerned with protecting their own than protecting district residents and taxpayers.

"To this day, I have no idea who George Williams is," she said, explaining that

she would have liked to debate him on a number of topics. "Has he dealt with budgets? We're talking about nearly a million dollar budget."

Short of a debate, she said she would at least have liked the chance to share her message on the Delmar Fire website and Facebook page. "Every time I tried to share that I was running, they deleted it," she said. "It would have been nice to be on that platform with the other candidate."

Unless they are codified in the department's by-laws, the department broke no laws by using the website to promote Williams, according to Joseph Frank, general counsel for the Association of Fire Districts of the State of New York.

"If a fire department permits candidates for their internal offices to speak to the membership of the fire department in order to state their positions and ask for their vote on the internal fire department website, that is an internal fire department matter," said Frank. "Fire department members are entitled to state their support for candidates in public elections like all citizens. They have freedom of expression. Fire department websites should probably not be used to do other than tell people to vote and give information on dates and locations of elections, but I am not prepared to state that any laws or rules are being broken."

"There was a lot of things that happened during this election," said Gould, referring to the emails. "I wasn't very happy, to be honest with you. That is not the way I conduct business."

Gould claims to have had no knowledge of the election content that was posted online and said he never saw it. (The post promoting Williams was reportedly taken down on the night of the election.) He also declined to speculate as to who was administering the website and/or Facebook page. "I'm not on social media," he said. "I don't get involved with that stuff."

While Gould appeared to agree that the use of the website was unseemly, he said, "It was both sides, back and forth." He also expressed displeasure that his personal email address had been widely shared during the argument between Hedges and Commissioner Dorsey. "That's not okay, either."

Asked whether the district would take any action to address the issue, he said, "Absolutely. Obviously, we're going to step up our electronic security. And things will be addressed." Gould declined to comment on steps the district was likely to take, saying he does not discuss personnel matters publicly.

"We had two candidates that were very passionate about what they do," he said.

"And they both ran however they ran."

Dorsey, who ultimately lost by nine votes, said that she felt good about those who supported her and said she felt at least some district residents had become more informed as a result of her candidacy. She also said she intends to run again in the future.

"I think that people really want to have someone qualified to look at all these things, not just someone who has love for the department," she said, referring a line in Hedges' email. "And I think it would be good to have a woman with knowledge of the district representing the district." (No woman has held the office of commissioner since the district was established in 1911.)

"Obviously, it was a very close race," said Gould. "Which is nice to see, to be honest with you. It's nice to see that people have that kind of interest and that people came out and voted. And it is what it is, at this point."

Editor's Note: Multiple attempts were made to reach Hedges and Williams through Gould, who said department officers and volunteers are not authorized to speak with the media regarding district matters. Gould told The Spotlight that he would reach out to Williams to have him contact the paper, but no call was ever received.





# **Excuse** us for a moment

Mister F: The Hiatus Interview

ot all bands make it. Some break up. Some grow apart, while others go on hiatus, and few never return. Mister F is a band about to go

The group formed in March 2013, when three members of Timbre Coup joined forces with Scott Hannay of Capital Zen to form a prog-rock jam band one that had a slew of songs right out of the gate. A cover of Particle's "Elevator" was a highlight, as were original tunes "This one Goes to 11" and "Hedgehog," among

Drummer Matt Pickering had incredible enthusiasm for this project when he first gave me the heads up. So did the half-capacity crowd at The Hollow Bar + Kitchen in Albany for Mister F's debut and not just the fans of the television series "Arrested Development."

During the next five years, the band played nearly 600 shows and produced one studio album, with another on the way in 2018. However, during a recent Saturday evening show at The Hollow, the quartet said goodbye from performing for the near future, beginning its hiatus in the same place it got its start.

NYS Music spoke to members of Mister F, both past and present, as well as the band's former managers, to get a first-hand account of what led the band to put its career on hold for a while.

Scott Hannay: We started writing music toward Mister F in late 2012 as a side project – a way to throw some tours in here and there, as Zen and Timbre Coup weren't able to be in tour mode at that time. We all wanted to get ourselves out there. It quickly became a vehicle to do that, and overwhelmed the other bands. I was let go from Capital Zen, who moved on without me, and later that year, Timbre Coup also folded.

Matt Pickering: When Timbre Coup was slowing down, the three of us who were living in the bandhouse were still interested in going full steam ahead and touring as often as possible. At the time, we really wanted to keep the same instrument switching aspects TC had and besides Dan (Gerken), Scott was really the only other person we could think of who played bass, guitar, and keys. We knew him as a keys player from shows with Capital Zen and we were quickly impressed with his guitar and bass skills when he sent us hopeful future parts/ tracks that he wrote. Scott was great from the get-go and

he was totally on board with our plan to play 140 shows a year. That was how the last five years of my life started.

Andrew Chamberlaine: Before joining Timbre Coup, I was pursuing a degree in Music Ed at (The College of) Saint Rose. I had known Ben for a while because we were in the Music program at SCCC together. I played in a band for a short time with Dmitry Bolotny (who went on to form Dirty Paris shortly after) and crossed paths with the rest of Timbre Coup while playing a gig with them at Savannah's in Albany sometime around 2008-ish. A few months after that gig, I got a message from Matt asking me to try out for their band.

We all knew that changes were coming for Timbre Coup, so Mister F was formed out of necessity to continue our passion for creating unique music. Initially, we wanted to keep the ball rolling with Timbre Coup and make necessary changes, but it didn't work out that way, so we re-branded and started from scratch (more or less). In hindsight, creating Mister F with most of our existing lineup allowed us to create some really cool new music and fix a lot of the things we felt Timbre Coup fell short with. TC's music was pretty complex. I mean, how does one dance to a song that's in 7/8, 5/4, and 4/4 at the same time? So, we decided to tone it back and reach our audience better while still keeping the music unique and original. At the very least, we discovered two things with Mister F: One: you really can make a song groove in an odd time signature, and two: the van doesn't smell good

As Mister F began touring, there was a drive for the band's members to set goals for themselves. Relationships that had been developed over years as fans and musicians, particularly with Umphrey's McGee, led to official after-shows and greater opportunities and encouragement.

**Ben Pickering:** I felt like there were a lot of factors pushing us when we first started touring. We started traveling as soon as we had enough material to play a show. Our sixth show was an Umphrey's McGee aftershow in Chicago. The relationships we made with bands in previous years allowed us to pick up great gigs and

some great festival plays really early on. It felt really good and it didn't take too long to feel like we achieved more in a couple years with Mister F than we did in our previous bands. Getting opening slots for some of the bigger bands almost felt like we got their approval and helped push us to work as hard as we could. We've always been very goal oriented, whether it be playing X amount of shows in a year, or hitting a couple big festivals a summer, we always


focused on one thing at a time and got it done. And we've always had a great team helping us along the way: David Limentani our booking agent, Mike Dean and Aaron Hagle both former managers, and Greg Bell were huge factors in getting us to this point.

Mike Dean: I think I had only heard one or two songs the band recorded in their practice room by the time I decided to make the move to Albany. I was a huge fan of Timbre Coup at the time, and knew what the guys could bring to the table musically. Aside from the logistics of moving roughly 700 miles away and entering an industry in which I had no experience, it was a no brainer.

We were fortunate to be able to kind of pick up right where Timbre Coup left off. Already having lots of contacts for venues, promoters and festivals along the East Coast was a huge plus. From that point, it was just a matter of increasing that base of contacts all across the country and trying to work our way further from home each tour. Most of what actually gave the guys their running start was their desire to tour relentlessly from the get-go. By 2014, we were already hitting 130-plus shows a year. We did quite a few Umphrey's McGee after parties during my time with Mister F. It was always a right place/right time scenario, and we were lucky enough to get the "official" stamp a number of times, which helped considerably with turnout.

As things got rolling early, all signs were positive. The band dealt with ironing out aspects of their sound, including ending the instrument switching mid-set that was a staple of Timbre Coup and early Mister F.

# Excuse us for a moment

Matt Pickering: We were so young when we started Timbre Coup but we learned everything we know about how to play shows in that band. We were very serious about it, but it takes a few years to learn the business and really be on the road. So we started Mister F with lots of experience and one thing we wanted to do was find our sound. We were going for more funky, a bit less edgy. Timbre Coup had so much material so it's hard to sum it up but it was prog based and more math-y fusion. We were shooting for a toned down version and with more keys. Just changing one member makes you sound incredibly different, though. So while we were writing early on, we worked fast but were very picky and choosy with what we went with. A couple years in we also decided to keep Ben on bass and off guitar, and Scott on keys and off guitar and bass. The instrument switching every show turned into a challenge. It also made it hard for us to find our sound we had so many that we could choose from with in our own band members we felt it was best and we wanted to put our best foot

Hannay: Our early goal after our other band obligations went by the wayside was just to tour as much as possible. We worked hard at booking ourselves in all sorts of places, doing it in-house with the help of our former manager Mike Dean. He had moved up from North Carolina to work for us because he was a good

friend who believed in us and really went to bat for us, and I've always understood that's the kind of person you want as your manager. We were reaching out to all our friends we'd made from our old bands to open for them, some were reaching out to open for us, we tried really hard to get everything we set our minds to. We got an opening slot for Suckerpunch (tDB/New Deal/Lotus side project) at the Howard Theater in Washington, D.C. in our third month as a band, just because our friends rallied for us.

**Dean:** I reached out about the opening slot for Snarky Puppy the day I saw the show announced at Upstate Concert Hall in Clifton Park, N.Y. We were playing directly before Snarky Puppy at Mantrabash festival in North Carolina a few weeks before said show, and I still hadn't heard anything back. I'm pretty fuzzy on the exact details, but at some point after our set, Ben was backstage talking to Michael League (bass/band leader for Snarky Puppy) and mentioned how we had tried reaching out about the gig. Michael said he'd touch base with their management as soon as he had cell service and make it happen. A few days later I got a call from an unknown number and it was Snarky Puppy's manager informing me that Mister F got the gig!

Over the next two years, the band soldiered on, touring around the east half of the country and filling festival bills and drawing larger and larger audience at the club level. Then the band ran into some unfortunate circumstances beyond their

**Hannay:** Unfortunately money for these things don't always align with the opportunity. To make matters worse, our van was broken into and we had two instruments stolen, one of which [was] a very unique and expensive custom-built guitar belonging to Andrew. Mike ended up not being able to keep up with the small amount we were able to offer him, and his time with us came to an end around the same time Andrew gave his

Dean: I hit that point where it became impossible to balance the life on the road with my own personal financial obligations. I think almost anyone who has ever been involved with a touring band at this level can relate. It was one of the hardest decisions I've ever had to make. Working for Mister F was the most enjoyable and rewarding experience I've ever been a part of, and it was tough to leave that behind. I'll always cherish the friendships and memories I made during my time with the band.

Andrew departed the band not because the guitar was stolen, but due to financial and family reasons.

**Chamberlaine**: As much as it sucks having a guitar stolen that's worth five times as much as your car at the time, that had little to do with my departure. I had two main reasons for leaving Mister F. The obvious one is money. Money had always been tight with both of our projects (Timbre Coup and Mister F), and we were working our asses off to create what we thought was good, forwardthinking music and I thought we were doing a pretty good job, however my wallet never seemed to agree. Around the same time Mister F formed I took a teaching position at Parkway Music.


Both were growing at the same time and the balancing act became impossible. I only had one choice if I wanted to use my guitar and music to pay my bills on time. I love creating my own original music, there's nothing quite like it, but I also love teaching the guitar & teaching people about music. I now have around 45-50 students, manage the lessons department at Parkway and can honestly say I love my

The other reason was family. Being on the road as often as we were led to missing out on a lot of things, which for a while I dealt with. The main factor for me was the loss of my last grandparent, my Grandmother Ila. She had always supported me, really ALL of my family has always supported my musical endeavors which is why I've been able to take it this far (shout-out to my girlfriend, mom, dad, aunts, uncles and friends!) But she was a huge reason I was even able to pursue my passion in the first place. Sometimes you have a family member that really holds the whole family together, so when she passed away I knew I had to step in and pick up the pieces and be there for those who needed me as much as I'd needed them before.

After briefly working with Mike Candela, the band found Fat Aztec guitarist Colin Shore to fill in, but there were complications.

Hannay: We then looked to Colin Shore for our full-time replacement. We'd played with his band Fat Aztec and had him sit in with us before. We'd had a lot of great musical conversations with him, and had unanimously decided "he's the guy". He took over mid-July 2016. But

shortly after he started suffering severe kidney stone issues that put Mike Candela back in the van with us for two full tours toward the end of the year. While it was fun playing with Mike again, we were all that time unable to pursue the growth in the areas that we were hoping to continue growing with Colin.

Colin Shore: Fat Aztec was coming to a pretty organic close at the time. The other members of the band were moving on into other non-musical endeavors while I was still interested in chasing the tour life. My joining with Mister F happened at a good time in my musical career for sure.

Having to take a break from touring to deal with medical issues was a huge drag. I was very fortunate that the guys in the

band are such good folks and good friends that they were willing to work with me and be patient despite the roadblock. There may have been some slight interruption to our musical advancement at the time. But overall I felt a renewed sense of purpose and connection with the band coming back into the fold in 2017. I felt the band really evolve musically throughout the year.

Starting in 2017, Colin was healthy and a new manager, Aaron Hagele, joined the band to work with the band and get things back on track. The band's van died only a few months into 2017, just as plans to record an album came into the picture. A Kickstarter with a simple goal of \$100 was easily met, but they could not fund both an album and a new van.

Hannay: We didn't owe it to people to buy a van, we owed it to them to record an album. And we were forced into an expense of minivan rentals for subsequent runs while not making any more than we were before. We then decided to take some time off from touring to complete the album that we owe everyone, and to figure out what as a band we need to do to carry on in a productive way without putting our own well-being at risk.

There are a lot of 'What ifs' in the story of Mister F. What if the wans hadn't broken down? What if touring led to a steady increase in revenue over the years? But more importantly, for touring bands out there who are just getting going, what are the lesson to be learned from the (still unfinished) story of Mister F? Andrew Chamberlaine offers this

parting thought on what might have changed the band's circumstances:

"Luck, and maybe more of a 'business mentality' but who the hell wants to treat art or music like a business?! So much of this industry is based on luck. For every successful band/musician we know of there are at least 100 bands/musicians with more talent and originality that we won't hear of because they didn't catch that break or weren't in the right place at the right time. I always think 'Well, what if I gave it more time?,' but, the fact is, time is finite for us all. Just do what you love, and have fun with the little time you have here on Earth, and I can guarantee you've 'made it' in your own right."

# Attack of the Seapods

"They were a name I would always see on old show flyers amongst other names that are still big in the scene today," said Kim Neaton, WEQX-FM radio personality. "I wasn't familiar with them when they were active, but their name often pops up in conversation and I always would think, 'Damn. I wish I got to catch a Seapods show!"

While Phish and Dave Matthews Band led the charge in a jam band culture described in 2001 as a phenomenon by the New York Times, moe., the Disco Biscuits and the Ominous Seapods pulled up the rear. At the time, both the Seapods and Disco Biscuits were signed under Hydrophonics Records, a subsidiary of Megaforce Records which itself earned success years earlier by introducing Ministry and Metallica.

"These guys can rip," wrote Dean Budnick, of the Seapods. The Relix Magazine editor named the group in a well-crafted Who's Who directory of upcoming bands in his 1998 book "Jam Bands: North America's Hottest Live Groups." "The humor of the players often celebrates the absurd, resulting in some memorable, spontaneous interactions between each other and between band and audience. ... Such as the time it hosted an eight-track release party."

Verna, Dana Monteith, Tom Pirozzi, Brian Mangini and Ted Marotta toured the nation, playing 200-plus gigs a year, a reputation recognized by SPIN Magazine, and appreciated by an online fanbase supported by a website at Dartmouth University affectionately called the Podnet. "We have some really loyal fans on the Podnet who have taken it upon themselves to get the word out and to spread tapes," Tom Pirozzi told Budnick. "So we've walked into a bar in Iowa City where the place is just packed full of people who have heard about us, know our music and are excited to have us there."

At one point, the website boasted of having more than 300 subscribers, known as mutants. It was maintained by David Merrill, a Dartmouth technician nicknamed The Bourbon Cowboy. It was a place to find setlists, lyrics and pictures. In its heyday, fans could swap tapes from live shows. The internet was still in its infancy in the late '90s.



Social media and smartphones, absolute requirements for networking and navigating new landscapes, did not exist. So, most fans found out about shows by signing up to the band's mailing list — postal, not email. (At the band's height, that list contained more than 10,000 names.) Fans could also call the band's dedicated phone line connected to an answering machine that listed upcoming show dates. The Podnet is still online, but the '90s design suggests it hasn't been maintained for years. Some of the mutants, including Merrill, have since moved on to Facebook.

Pirozzi recently shared his amazement over the power of social media. He said he posted word of the Seapods upcoming Cohoes show on Facebook twice. Once on his page, and another on the Mutants' page. A short time later, he said, the Saturday evening show was sold out.

"It sold out in five days," said Pirozzi. "I was surprised, actually. I knew we'd do well, and thought maybe by the day of the show we'd sell out, or be close to sold out. I didn't expect to sell out in advance. We were all shocked

The band opted to offer a second show on the preceding Friday, Pirozzi's 50th birthday. (It, too, is close to selling out.) Pirozzi said he's humbled by the response from fans, and looks forward to seeing faces he hasn't seen

"I could see on Facebook, people coming in from Colorado, from North Carolina, California," asid Pirozzi. "I think it's just going to be a great reunion for people I haven't seen in years. Obviously, people I haven't seen in 20 years. I'm looking forward to that."

The definition of an Ominous Seapod, initially sought by a Plattsburgh State undergrad, is less elusive today than it was nearly 30 years ago.

"By all accounts the band and their fans know how to have a real great time," said Neaton, who now associates herself with Guthrie Bell Productions. "And, if Greg Bell says a band knows how to party, I think the Cohoes Music Hall is perhaps in for a party unlike anything it's seen before. It's really cool to be part of a reunion that's bringing so many people in from out of town to celebrate a band that meant a lot to the jam scene for so long, especially in a room as special as this."


Hallisey: You are in the midst of a tour, do you have a record release in the
