# Talking circles

Town invites public to discuss options for Babcock Corners intersection

GLENMONT — The Town of Bethlehem held a public meeting at Glenmont Elementary School on Tuesday, June 26, regarding the roundabout that will replace the four-way intersection connecting U.S. Route 9W with Feura Bush and Glenmont roads in Bethlehem Center by spring 2021. Approximately 40 people attended Tuesday's meeting, the first of several that will take place as details of the project are considered over the next year. The project will also add sidewalks along Route 9W and Glenmont Road.

### MHLC, Five Rivers partner for property acquisition

**BETHLEHEM**-Residents of Bethlehem and New Scotland may have spotted cherry-red signs with white lettering on the corner of Fisher Boulevard and Route 85, which read: "Help us protect this land."

Mohawk Hudson Land Conservancy is working to protect the Fisher Boulevard property and is asking for assistance from the community.

"For over a decade, these 35 acres — one of the few remaining open spaces in Slingerlands — have been under the threat of development," says MHLC Executive Director Mark King. "The Fisher Boulevard property has been proposed as the site of eight-lot housing developments, and at one time even 35-40 houses were being considered. Now, MHLC is poised to protect these 35 acres forever, and we need the community's help to

raise the funds to make it happen." In an unprecedented

partnership with NYSDEC's Five Rivers Environmental Education Center and an anonymous landowner, MHLC intends to preserve these acres as open space while also incorporating them into the center, significantly increasing its acreage while expanding community access to nature, outdoor learning, and recreation. More than 100,000 people visit the center annually.

The Board of Directors of the Friends of Five Rivers citizens' support group has already donated \$5,000 to the MHLC to kick-start the effort to protect this property in perpetuity.

"The Friends of Five Rivers is happy to support this effort to save this open space," states Joanne Macklin, Executive Director of the Friends of Five Rivers. "The project will provide the community with access to Five River Environmental

Education Center from Fisher Boulevard in the near future." MHLC and Friends of Five Rivers hope that neighbors in Bethlehem and New Scotland will join in the effort and donate to the cause to help protect the Fisher Boulevard property from future development.

"The land itself is a donation to MHLC," explained Daron Blake, MHLC's communications and outreach coordinator, "but our costs are high because of years of working to solidify the deal. We are seeking community support to help with these expensive transaction costs. We also need to create longterm stewardship funding for future monitoring and stewardship of the property. "

Thanks to the Friends of Five Rivers, the conservancy is already a quarter of the way to reaching its goal of \$20,000. "If we don't reach our funding goal through donations from this campaign, we will

Its addition to the existing 450 acres of Five Rivers is one of the last opportunities to expand the Center beyond its current boundaries, according to MHLC. The conservancy hopes to add the 35 acres to Five Rivers and to forever extinguish the threat of development with

financial support from the community.

### TOWN GOVERNMENT Longtime Bethlehem public servant dies

**BETHLEHEM**—Former Town Board member George Lenhardt died on Wednesday, June 27, following a long illness.

Lenhardt, who served for 12 years on the Town Board and on the Planning Board prior to that, was a well known and much respected public servant. He graduated from Bethlehem Central High School in 1965. "I will miss him. I think the whole community will miss George," said former Town Board member Doris Davis. Davis served with Lenhardt on both boards and the two formed a friendship. "He was a real civil servant. He was smart, he had a dry sense of humor and he was just an all around really nice man. And the community was really important to him." According to Davis, Lenhardt always came to meetings prepared with all the background information necessary to address the various issues concerning the town and its residents. "I had a lot of respect for him," Davis said with emotion. "I still do. I always will."

He is survived by his wife, Lynne, and their children Brian and Kimberly.

### Failure to stop leads to DWI

Cardona reportedly committed grand larceny at the SEFCU in Slingerlands and was located after police tracked the vehicle and questioned his roommate, who

Cardona was taken into custody at that address and charged with the felonies. According to reports, he confessed to police and shared with them how he was able to obtain the victim's account information.

He was arraigned before a judge and sent to Albany County jail on \$25,000 cash/bond. A preliminary hearing was set for Friday, June 22. His next court appearance is scheduled for Tuesday, July 17.

### **Cohoes man arrested for cocaine**

**COEYMANS**—State troopers from Thruway Troop T and investigators from Troop G in Latham arrested a 31-year-old Cohoes man on Wednesday, June 27.

Nestor L. Baez of Cohoes, was arrested following a traffic stop on the Thruway in the Town of Coeymans, where he was reportedly found to be in possession of more than 25 grams of cocaine and more than five grams of marijuana. He was also reportedly found to be in violation of a court issued

order of protection. Baez was charged with the felonies of criminal possession of a controlled substance and criminal contempt. He was processed at the state police station in Albany and arraigned in the Town of Coeymans Court, where he was remanded to the Albany County jail on \$20,000 bail / \$40,000

### Marijuana merchant busted

**DELMAR**—Bethlehem police arrested Benjimin Miller, 26, on Tuesday, June 19, for criminal sale of a controlled substance, criminal possession of a controlled substance and criminal sale of marijuana, all felonies.

According to reports, police stopped Miller on Delaware Avenue in Delmar after noticing that his vehicle had a non functioning headlight and observed marijuana in a glass jar in the rear of the vehicle. Upon further investigation, police say they found multiple quantities of marijuana, plastic bags, a scale, a glass pipe and multiple containers of cannabis-based oils. When asked what he did for a living, Miller reportedly replied that he sold marijuana.

In addition to the three felonies, Miller was charged with three misdemeanor drug counts for paraphernalia and possession, and a vehicle infraction for the headlight. He is scheduled to appear in court on Tuesday, July 17.

# Town Supervisor paints over anti-semitic graffiti

**SLINGERLANDS**—After a resident discovered anti-semitic graffiti underneath the Cherry Avenue bridge along the rail trail, Supervisor David VanLuven bought a can of paint and painted over the offensive message on Wednesday, June 27.


On Thursday, Bethlehem Police Commander Adam Hornick said that the department had "very good leads" on the culprits' identities.

"As our investigation has determined that there are multiple people responsible for this graffiti, we are continuing working on this case until all involved subjects have been identified and dealt with," said Hornick.

"The Bethlehem Police Department also wishes to remind all businesses that sell spray paint in Albany County, that there is a county law prohibiting the sale of spray paint to anyone under the age of 18. Local Law 5 passed by the Albany County Legislature in 2008 made the sale of spray paint to a person under eighteen, a class A misdemeanor punishable by a fine of not more than one thousand dollars or imprisonment for not more than one year, or both. Concurrent to our investigation into the graffiti we are also conducting a parallel investigation into how the juveniles obtained the spray paint. In the coming weeks, members of our agency will be visiting local merchants that sell spray paint to help educate them on this law and its importance for the community."








It is the team's last home game before hosting a three-day 12U tournament at Line Drive Park and Elm Avenue Park on July 6, 7 and 8.



Also, after five weeks of seeing the price drop, the cost of gasoline is expected to rise as oil prices surged to \$73 a barrel on Wednesday, June 27, the highest since 2014

While the prices leading up to July 4 prices are below the summer high of \$2.98 in May, the latest increase will still cost motorists about \$1.02 billion more than last year.

## STATE GOVERNMENT **Sparkler safety tips**

ALBANY COUNTY-With Independence Day upon us, it seems like a good time to clarify fireworks regulations in New York state.

In 2014, the state Legislature passed a law allowing for the sale and use of a specific category of consumer fireworks called "Sparkling Devices" in counties that chose to legalize them. According to the New York state Division of Homeland Security and Emergency Services, the "Sparkling Devices" that state law refers to are considered, "ground-based or handheld devices that produce a shower of colored sparks and/or a colored flame, audible crackling or

whistling noise and smoke." In 2016, Albany

County legalized the use of sparkling devices. The neighboring counties of Schoharie, Greene, Rensselaer, Saratoga, Montgomery and Fulton legalized their use in 2015. To the southeast, Columbia County does not permit the use of any fireworks and, last May. Schenectady County repealed a 2015 law allowing them after the use of larger, illegal fireworkswhich some thought were permitted under the new law—alarmed residents and local police.

As of January of this year, all state cities and counties with a population of one million or more are permitted to use sparkling devices unless that city or county specifically prohibits their sale and use. In addition to Schenectady and Columbia counties, Bronx, Kings, Nassau,

New York, Queens and **Richmond** counties have also banned them, according to NYSDHSES.

Per state law, the type, size and construction of those devices is limited: they must be handheld or mounted on a stake or spike, and may not exceed 500 grams of pyrotechnic composition. Sparkling

### Some safety tips from NYSDHSES:

- Follow the directions located on the packaging
- Use sparklers outdoors, never indoors
- Wear eye protection when using sparklers
- *Keep sparklers and novelty devices in a safe, secure location* when not in use
- *Keep an approved fire extinguisher nearby during a display*
- Do not light more than one sparkler at a time • Do not point a sparkler tube towards anyone
- or any part of your body
- Do not use sparklers when under the influence of alcohol or drugs
- *Keep an approved fire extinguisher nearby during a display*
- Do not try to relight or handle malfunctioning fireworks
- Douse malfunctioning and spent devices with water before discarding to prevent a fire
- Purchase sparklers and novelty devices from *state registered retailers*

fountains, sparklers on wooden sticks (not metal) smoking devices, snakes, confetti-filled party poppers and paper-wrapped snappers are all allowed. Firecrackers, bottle rockets, roman candles, spinners and other aerial fireworks are not.

While the use of sparkling devices is now legal for adults, no one under the age of 18 is allowed to handle them in the state of New York. A parent who lets their child handle a sparkler, even one on a wooden stick, could

face charges. Under state law, that would mean a class A misdemeanor for the first offense and a possible felony charge (class E) for a second violation within five years.

The law passed in 2014 and signed by Gov. Andrew Cuomo lets retailers sell sparkling devices from June 1 to July 5 and Dec. 26 to Jan. 1 each year. Additionally, temporary stands or tents can get a state permit to sell the sparkling devices from June 20 to July 5 and Dec. 26 to Jan. 1.



resembled a farm.

In that time, the whole of Bethlehem has gone through considerable change. Out with the farms and in with residential developments that have caused its population to nearly double since 1960. One needs only to walk down Feura Bush Road to witness this boom. Shopping malls, apartments and homes dot the landscape. Expansive developments branch off from there, adding motorists to our roads. It wasn't too long ago that there was no sidewalk to walk upon on that stretch. Pedestrians straddled the narrow shoulder, and thanked generous motorists who nudged the yellow line to yield a more comfortable distance.

The old days are gone.

It's been more than 10 years since the Route 9W corridor has been identified as a focus area in need of change. Developments and big box stores have emerged, adding local and visiting traffic to our roads. What was once an intersection we were once able to manage while waiting for a few passing cars, has turned into a more panicked situation for those looking to turn left at any given moment. Keep in mind, these roads were first developed decades before as "turnpikes" to connect Albany to distant communities. They were the early day highways before such a term was coined in the '50s. Our traffic woes only bring this fact to light once again as we weigh in on our options to remedy this.

There is no quick fix,

people have to come to terms with the eventual need for a roundabout. Though there should always be a concern for pedestrian safety. This area of town, as more residential developments are built and proposed, will continue to be a home. But, the crux of the issue centers around the throng of motorists who travel through town each day. And, it's only bound to get worse if not abated.

The roundabouts along Route 85 in Slingerlands and North Bethlehem have done a tremendous amount of good to relieve the rush hour congestion that once choked it years ago. The perceived challenge of driving through one is often due to the shortcomings of a few individual drivers who fail to pay attention or should

learn the right of way. The safety of these traffic circles has been proven worldwide, and should not be ignored. As this town continues to grow, there are other corners of our neighborhood that could benefit, but that may prove an even tougher conversation than this.

We see the intersection of Kenwood and Cherry avenues in Slingerlands, and how rush hour traffic from New Scotland stagnates at that traffic light. The bridge and surrounding homes that abut those roads would make it near impossible to add a roundabout there without evasive measures.

This intersection, with it's odd angles and blind spots, can and should be replaced with a roundabout.

# **From page 1 ...** Talking circles

This intersection has long been a source of frustration for those who travel through it on a regular basis, due to increasing traffic congestion as well as its awkward alignment and blocked sightlines. When developing the town's comprehensive plan in 2005, the Route 9W corridor was not only identified as an area expected to continue experiencing growth and but it was also recommended that the six-mile stretch from Hannay Lane in the north to Cottage Lane in the south be evaluated for possible improvements to accommodate increased traffic volumes. In 2008, the town conducted a transportation study on the corridor, building on land use findings and recommendations identified by the comprehensive plan, to "develop a focused and targeted U.S. 9W corridor transportation and land use vision and management plan."

The results of that study recommended replacing intersections using signals to control traffic flow through that span with roundabouts. In 2015, after a number of traffic studies compared signalized intersections with roundabouts, the roundabout option was deemed the most desirable for improving both traffic flow and safety. The following year, after the state Department of Transportation announced that funding was available for traffic congestion mitigation and transportation alternatives projects, the town submitted a proposal to build a roundabout and sidewalks at the Feura Bush/ Glenmont/9W intersection. The proposed plan was approved by DOT, which will provide funding for 80 percent of the project's cost.

"We really want to hear from everyone tonight," said Creighton Manning engineer Steve Godlewski, emphasizing that the project is still in the draft phase. "What are the priorities? Is it pedestrian safety? Is it vehicle safety? Is it reducing the amount of time that someone needs to wait to get to Price Chopper? Is it having a beautiful area with beautiful lights or fancy historic lighting? Or landscaping, or streetscaping. That's the kind of stuff we want to hear tonight."

Godlewski said that there are certain requirements the project must meet to in order to qualify for the state funding. "There are minimum requirements we have to meet, whatever alternative we do." Easing traffic congestion and improving safety are among the things he stressed.

"We need to go through a detailed comparison of a traffic signal and a roundabout," he said, "just to verify that the previous studies are still valid."

Godlewski said that the town wants to know what concerns residents of the neighborhood have.

For example, "Is there a 100-year-old tree that someone's grandfather planted that would be in the way if we put the sidewalk on the south side?" he asked. "That's the sort of stuff we're trying to find out. We want to identify impacts to private property owners. We haven't done that yet. We have ideas, but that's very rough data at this point. We're going to meet with all those property owners.

"Last, but not least," he said, noting that the state owns the roads, "is DOT coordination."

Maps of the project area were available for attendees to look at in the back of the room where the meeting was held. Residents were encouraged to write comments on sticky notes and place them at areas of consideration.

Godlewski not only stressed that roundabouts are not traffic circles, but also discussed how municipal planners have gotten better at understanding and implementing geometric designs that slow vehicle traffic while promoting pedestrian and vehicle safety.

"One of the big benefits," he said, "is that [roundabouts] have traffic calming 24 hours a day." He explained how reduced speeds would make the intersection safer for pedestrians and dramatically reduce fatalities in the case of a car crash. "There are thousands of roundabouts in the United States of America," said Godlewksi. "Even more in Canada and the rest of the world. There's years and years and years of operational data. Roundabouts have been installed for the last 20-plus years. They've been operating around the clock and, in that time, there has been one pedestrian fatality. Traffic signals have a much worse track record for pedestrians."

Residents raised concerns about bicycle safety for experienced cyclists as well as young children. Godlewski said that, while an experienced cyclist may be able to navigate a roundabout, it would likely be safer for a 10-year-old to dismount and walk his or her bike through the intersection. He noted that there are certain features that could make the intersection more navigable for cyclists, such as dedicated lanes or a separate path.

To promote pedestrian safety, he said options such as raised crosswalks or flashing beacons that would alert drivers to the presence of pedestrians crossing the intersection have both proven effective.

One resident asked if the state Department of Motor Vehicles has been approached about educating drivers on how to navigate roundabouts. While Godlewski replied no, he did comment that it's an issue everywhere in the country and something people are working to change.

Other residents voiced concerns regarding large trucks, speed limits, lighting, making left turns from residences or local businesses and the impact of construction.

"Liz Staubach, our economic coordinator, and I reached out to every business with fliers," said Town Supervisor David VanLuven, "saying please come and participate. Because this is a project whose construction phase is going to have an impact on our local businesses. And so we need to work with those businesses to try to minimize that impact as much as possible."

"A lot of our objectives are going to be shaped by what we hear from you tonight," said Godlewski. "In terms of what your priorities are and what your objectives are."



"When I found out about Mel's cancer, the first question in my mind was, 'how can we help?'," Harkes said. "I like to think of myself as a proactive person and I felt like I had to do something. Melanie would do this for anyone if the roles were reversed." Ever since Krahmer announced her diagnosis on April 30, Harkes has been asking fellow musicians and comics to participate in a benefit for Krahmer. To date, she reports that she's been met with optimism.

"SIRSY was supposed to perform at The Saratoga Winery on the night of the benefit before everything happened," Harkes explained. "I contacted the winery and asked if they had found anyone to replace SIRSY, and they said no.

"I suggested putting together a benefit for Mel and getting everyone out to help her. They were so on board and have volunteered items to raffle off," Harkes continued. "Since then, it's been a work in progress. I'm still putting it together."

Harkes added that a member of The Lustre Kings, the internationallyrenowned rockabilly band that's based here in the Capital District, contacted her after hearing about the diagnosis and asked what the band could do for Mel.

"I immediately asked them to jump on board with us, and they agreed," she said. "I will be singing with them."

Harkes also reached out to Ubuntu, the band that's performing at the Winery just before Melstock! It "I finally said it's breast cancer because I needed someone to talk to. I was told by a friend that by saying it, that's how I'm raising awareness. I realized she was right."

#### – Melanie Krahmer, of SIRSY

has agreed to donate all proceeds from its show that afternoon to the benefit as well.

"[Ubuntu] stands for 'I am who I am because of all of who we are," Ubuntu manager and singer Sue Wolfer explained, adding there's a synergy between musicians that bonds them together. "You just step up and do the right thing. It's an honor to be a part of the bill."





rillmasters know that grilling for friends and family is about more than just burgers and hot dogs. For those who want to add some more flavorful fare to their backyard barbecues, the following recipe for "Smoke-Roasted Bell Peppers Stuffed With Green Garden Vegetables" from Andrew Schloss and David Joachim's "Mastering the Grill" is sure to please guests and grillmasters alike.

### Smoke-Roasted Bell Peppers Stuffed With Green Garden Vegetables

#### Ingredients — Serves 4

- 2 medium red bell peppers 3 medium mixed bell peppers
- (yellow, orange, green) teaspoon kosher salt 3/4
- teaspoon ground black pepper 1/2
- tablespoons butter 3
- onion, finely chopped 1
- cloves garlic, minced 2
- medium zucchini, 1
- cut into 1/4-inch dice

- medium yellow squash, 1 cut into 1/4-inch dice
- cups fresh or frozen corn kernels 2 medium tomato, seeded 1
- and cut into 1/4-inch dice
- tablespoons chopped fresh herbs (such 2 as parsley, oregano, basil, or a mix)
- cup plain dried bread crumbs 1/4 Oil for coating grill
- tablespoons grated Parmesan cheese 2

#### The Grill

Seed, core and cut one of the red bell peppers into 1/4-inch dice. Cut the remaining bell peppers in half lengthwise right through the stem, leaving a bit of stem attached to each half. Cut out the cores, seeds and ribs from the interiors of the peppers, leaving the stem intact. Sprinkle the insides of the peppers with 1/4 teaspoon of the salt and 1/4 teaspoon of the pepper.

Melt the butter in a large skillet over medium heat. Add the onion and saute until almost tender, about 4 minutes. Add the garlic, chopped bell pepper, zucchini, and yellow squash. Saute the vegetables until crisp-tender, about 4 minutes. Stir in the corn and tomato and cook until heated through, 1 to 2 minutes. Stir in



herbs, bread crumbs and the remaining 1/2 teaspoon salt and 1/4 teaspoon pepper. Cook and stir until the bread crumbs soak up most of the liquid in the pan. Remove from the heat and spoon the filling equally into the pepper cavities.

When the grill is hot, put the soaked wood chips or chunks over the coals on both sides of the grill. Is using gas, put the wood chips in a smoker box or in a perforated foil packet directly over one of the heated burners.

Brush the grill grate and coat it with oil. Put the stuffed peppers over the unheated part of the grill, cover, and cook until just tender, 20 to 30 minutes. If your grill has a temperature gauge, it should stay at around 350° F.

Remove the peppers to a large serving

platter. Sprinkle with the Parmesan (if using) and serve.



# Guard from sun-kissed eyes

B lue skies and ample sunshine help makes summer special. Come summer, many people spend more time enjoying recreational pursuits and everything seems a bit more laid back. Even though people may take a more relaxed attitude in summer, the National Eye Institute says people should wear sunglasses that block UV radiation whenever they head outdoors in daylight hours. This is essential for men, women and children. Sunglasses are necessary during the times of day when the sun's rays are at their strongest, but wearing them anytime the sun is out can protect one's vision.

Sunglasses present a great defense against UV rays that can cause short- and long-term eye damage, states the American Academy of Ophthalmology. Diseases such as cataracts, cancer and growths on the eye all can result from prolonged exposure to UV rays, which can damage the eye's surface tissues as well as the cornea and lens. Prolonged exposure to UV rays also may affect retinal cells.

When purchasing sunglasses to protect the eyes, consumers should consider these important factors.

• Ultimate protection: The American Optometric Association says that sunglasses should offer 100 percent protection against both UVA and UVB rays. Some glasses will simply list a numerical indicator. In such instances, sunglasses that offer protection against UV 400, which will encompass the wavelengths for both UVA and UVB rays, are best.

• Buy from a reputable retailer. Not all sunglasses live up to their claims. Sunglasses sold at doctors' offices, department stores and sunglass speciality shops often meet the standards for protection, advises The Vision Council, a trade organization for the optical industry.

• Choose tint for activity. Tint will not affect UV protection, but it can make certain activities more





enjoyable. Darker lenses may help at the beach, where there is more reflective light. Orange or yellow lenses increase contrast while driving or fishing. On cloudy days, amber or rose lenses can help improve contrast. Customers should choose a tint that makes them feel comfortable.

 Polarized lenses help fight glare. Polarized lenses and those with anti-reflective coatings can alleviate glare. Such lenses work by only letting in specific amounts of light at certain angles, which helps to reduce the brightness of that light, says the



Krahmer posted an announcement about her diagnosis to Facebook on April 30. She has been open about her previous battle with cancer and was in remission for a little over seven years before the recent diagnosis.

"She was probably flooded with

thousands of messages after she put that up," Harkes said, adding she had no idea Krahmer was awaiting biopsy results.

"I had just talked to her two days before to talk about trivial things in my life, and she didn't mention it at all," Harkes said. "I was heartbroken for her and Rich."

Rich, or Richard Libutti, is Krahmer's partner, both in marriage and in the band.

The duo performed 218 shows in 2017, according to the GoFundMe page created for Krahmer.

Krahmer is overwhelmed by the love and kindness shown by her community and those who have reached out, she said.

"I have been receiving cards and hanging them up on the walls in my kitchen," she said. "I feel special. I'm totally overwhelmed in a good way. I can't thank everyone enough for the cards, emails, Facebook messages and love."

She added the love and planned benefit are appreciated in a time where everything in SIRSY's life is on hold. Being full time musicians, performing is the couple's only source of income.

"People have been so supportive luckily," she said. "This disrupts every single part of your life. Without this, we'd have absolutely no money coming in. I'm so thankful and so blessed that people are so kind."

Krahmer has wrestled with many different emotions since receiving her diagnosis, she said. She found out her cancer had come back while she and







Libutti were driving to a show in Tulsa, Oklahoma.

"We pulled over into a gas station and just hugged one another and cried," she said. "We were heartbroken. I felt such sadness that the cancer had come back because I never thought in a million years it would."

This is her second bout of breast cancer in a decade. Krahmer had just celebrated her seventh year cancer free when she received the diagnosis. According to cancer.gov, most cancers that recur do so within the first five years, making

surprise.

Krahmer continued she then felt anger because SIRSY had to cancel its West Coast tour so she could return back to the Capital District for

treatment. "I'm now at a point of acceptance," she continued. "I'm also grateful because the doctors caught it early enough, and I'm going to live."

She also struggled with disclosing the type of her cancer because of the inevitable glances she would get.

"When I say breast cancer, eyes automatically go down to my breasts,"

she said. "It's totally involuntary; I know people aren't doing it to be inappropriate or malicious.

> "But I finally said it's breast cancer because I needed someone to

talk to," she continued. "I was told by a friend that by saying it, that's how I'm raising awareness. I realized she was right." Krahmer said she hopes to be back to the stage by SIRSY's Freedom Park performance in late August.

"We feel very lost and out of sorts right now," she said. "I can't wait to get back on
