# Town officials on what is Bethlehem's character

he concept of "preserving the town's character" has been frequently brought up, particularly as the comprehensive plan is now undergoing a major overhaul. But what exactly is Bethlehem's character as a town?

Town Supervisor David VanLuven said that Bethlehem "is a rich mixture of suburban neighborhoods, thriving commercial districts and big industries, along with farms and forests and fields. It has a fair amount of variety; that's what makes it so interesting and an attractive place to live."

# POLICE Car crash brings multiple DWIs

**DELMAR** — A 49-year-old Delmar man was arrested for drunk driving and speeding on Friday, Dec. 28 at 5:41 p.m.

Joel Elliot Sproul allegedly lost control of his 2016 Subaru Outback, causing it to strike a tree and crash into a ditch in front of 489 Orchard St.

Upon arrival, police reportedly found him standing on the side of the road near his damaged car.

They noted an alcoholic beverage odor from his breath, his bloodshot, watery eyes, and slurred speech.

When asked what happened, police observed his incapability of forming sentences and remembering the events that led to the crash.

He was found to have a BAC of 0.19 percent, was placed in custody and transported to BPD.

He was charged with aggravated DWI with a BAC of 0.18 percent or more, a DWI with a BAC of 0.08 percent or more, a common law DWI misdemeanor, failure to keep right to lane, and imprudent speed.

# Drunk driving, no turn signal

**DELMAR** — A 36-year-old Delmar woman was arrested for drunk driving and a traffic infraction on Saturday, Dec. 29 at 12:37 a.m.

According to police reports, an officer noticed that Stacy Marie Schueller failed to signal while making a right turn in her 2016 Honda Civic off Route 9W onto the Delmar Bypass.

Upon pulling her over, the officer noted an alcoholic beverage odor from her breath, her watery eyes and slurred speech.

After failing sobriety tests, she was taken into custody and transported to the Bethlehem Police Department where she was found to have a BAC of 0.10 percent.

Schueller was charged with DWI, operating a motor vehicle with 0.08 or higher percent of BAC, and improper turning with no signal.

# Glenmont roundabout workshop date set

**GLENMONT** — Residents can learn more about the upcoming roundabout project during an open house and public workshop scheduled to take place at Glenmont Elementary School, located at 328 U.S. Rte. 9W on Thursday, Jan. 17, at 6 p.m.

A 30-minute open house will begin at 6 p.m., followed by the public workshop at 6:30 p.m. This workshop, the second of three planned with regards to the roundabout's design phase, includes both a formal presentation and Q&A session. The first public workshop was held back on June 26, 2018, with nearly 100 residents in attendance and the third has yet to be announced.

The \$4.9 million project will transform the existing four-way intersection, where Feura Bush and Glenmont roads meet Route 9W, into a roundabout to reduce both traffic congestion and the frequency of right-angle and head-on crashes which occur there. Other improvements will include new crosswalks, rectangular rapid-flashing beacons, and establishing 2,800 feet of sidewalk which would connect pedestrians and cyclists from the Glenmont Elementary School and Vagele Lane.

The Jan. 17 workshop's presentation will feature project concept designs developed by Albany-based engineering firm Creighton Manning, the consultant retained by the town, andshowcase how public input received during last June's meeting was incorporated into those designs. Town staff and consultants from Creighton Manning are expected to be on hand to speak with residents who wish to learn more about it.

The impacts the roundabout's construction may have on nearby businesses is expected to be addressed during the presentation.

During the Dec. 21, 2018 Industrial Development Agency meeting, Bethlehem's Planning Division Director Robert Leslie said, "We've been meeting with several of the area's businesses by the intersection — like Town Squire [Plaza], gas stations, CVS — to talk to them about


potential changes and driving access and making improvements for safer turns in and out of those businesses, as the roundabout project is under design. We're doing a lot of the behind-thescenes work with businesses before moving ahead with the public meeting."

The project was unanimously approved by the Bethlehem Town Board in early May 2018. Eighty percent of the project's cost, or \$3.9 million, will be funded through a grant by the Transportation Alternatives Program, and Congestion Mitigation and Air Quality Improvement Program (TAP-CMAQ) of the state DOT and the town would pay the other 20 percent or \$975,000.

Construction on the project is scheduled to start in 2020 and wrap up no later than 2021.

# BUSINESS Monolith Solar is on a time crunch

# Building permits to expire on Jan. 31

BETHLEHEM — Solar panel installation company Monolith Solar has not provided any updates nor information since the town's Dec. 21 Industrial Development Agency (IDA) meeting regarding how it plans to move forward with construction of its incomplete Slingerlands headquarters building at the Vista Technology Campus.

The IDA had requested Monolith Solar to maintain some communication with them in the meantime so that it would not have to wait until the next IDA meeting on Friday, Jan. 25 to learn of any new updates.

Both Bethlehem Planning Division Director Robert Leslie and IDA Executive Director Thomas Connolly confirmed the lack of communication from Monolith Solar to Spotlight News on Friday, Jan. 4. While Spotlight News reached out to Monolith Solar requesting comment, a representative

declined for now, citing lack of staff availability due to the recent holiday season.

The lack of updates poses the question as to whether the company is able to restart construction on the aforementioned building, which had ceased abruptly in September 2017. More than 50 workers were furloughed that same month too. Leslie said that he was "informed by a stormwater officer" that the site is in compliance as a shutdown site though in terms of stormwater management and sediment control; however, it lacks some form of security fence which the town had requested.

Adding to the town's concerns are the site plan which expired on Thursday, Dec. 13, after having received two 90-day extensions — it was originally issued back in March 2015. The building permits will expire on Thursday, Jan. 31. In order to continue construction, the company is required to reapply with the Bethlehem Planning Board for re-approval of both documents.

Getting approval from the Planning Board shouldn't be an undertaking because the plans

from the previous application can be used again for this new application," said Leslie during the aforementioned Dec. 21 IDA meeting.

In addition, Monolith Solar is also facing at least three lawsuits from other companies alleging that it has not paid its bills, the most recent was filed by Solar Foundations USA in early December. The company had named Chris Stroud as its new CEO in late October after the previous one, Mike Hickey, left after one year in office for a job at Siena College.

Steve Erby, the owner of

Monolith Solar appeared at the Dec. 21 IDA meeting, saying that while he does not have many reassuring updates, he said that the company has been working with both Columbia Development developer Joe Nicolla and Pioneer Bank, which was financing the construction, to resolve the situation. He also confirmed that the company is "still operational on a very small basis ... our headcount is about 30 people, we have called back a few people that we had furloughed." He did not reveal the exact number of returning employees though.

When asked if Monolith Solar still has the budget and resources to complete the construction project, Erby said, "We do and we have outside turnaround consultants from KeyBank which are helping us with that and they've done a phenomenal job. The revenue for 2019 is projected right now to be a gross of ... I believe we're in the \$60 million to \$70 million range."

He also revealed that there is "no timeframe right now when the project would be resolved" and that the company had "hoped for an April restart construction timeframe, but now, we're hoping for January 2020, but only after going through the Planning Board process."

He concluded, "It's a shame, it's a beautiful building."

For now, Monolith Solar employees are working out of a Rensselaer office since leaving Corporate Woods.

The next IDA meeting, which is expected to include discussion on Monolith Solar, is scheduled to take place on Friday, Jan. 25, beginning at 8 a.m., inside Bethlehem Town Hall, located at 445 Delaware Ave. in Delmar.

Town Board member Jim Foster said that each resident can define what the town's character is differently and that "it's not only defined by buildings, our open spaces, historical landmarks and landscapes, but it's also by people and their history and their values."

He reiterated that it's the overall community feel that keeps the town close. "Ultimately, it's good, friendly, warm neighbors who love the community deeply and want to preserve the small-town feel. It can be anything from a passing exchange at a coffee shop, to sharing moments over a baseball field, or going to small

businesses and supporting neighbors."

#### Fellow Town Board member Maureen Cunningham appreciated how Bethlehem is a welcoming and familyoriented community. "I see safe streets where kids can walk and bike around. I also think of community events like the Turkey Trot and menorah lighting, which are different events that still bring in our community members to help keep make this town grow stronger."

She offered an anecdote where on Thursday, Dec. 13, her 12-year-old son had walked to the Four Corners —located at the intersection of Delaware

#### and Kenwood avenues in Delmar— and while she knew he was safe there, she knew the small business owners' first names there. "Knowing people's names is one way of knowing we have a strong sense of community. It's like getting a coffee or a sandwich in town and the people there know you personally. It's why, in my opinion, a lot of the town's character is

intangible." Speaking of neighbors, there was a general consensus among the town officials that engaging the residents in conversations about town matters and issues is of paramount importance.

VanLuven and Cunningham brought up, for example, how they've met dozens of residents to learn what issues those people cared about during the Slingerlands and Selkirk community forums back on Thursday, Nov. 29 and Thursday, Dec. 13 respectively. These meetings are among the numerous scheduled community forums through March 2019 across various hamlets where meeting residents will inform Bethlehem's comprehensive plan update process.

"In the Selkirk comp. plan forum, when asked about what the people like about Selkirk, one gentleman said he loves the small businesses and neighbors there," Cunningham recalled. "People want small businesses coming in."

She added that many Bethlehem residents overall have "mentioned Clifton Park as the example we don't want to be. Maybe it's because there are a lot of chain businesses, big-box stores, and strip malls there. But here in Bethlehem, people want to maintain the small businesses and neighborhood feel."

Foster chimed in, believing that Bethlehem is a strong small-business community and "I hope residents continue supporting them and those businesses are the ones that sponsor our teams and define us a town, as opposed to big-box stores. If you squeeze out small businesses, it's concerning."

VanLuven, Cunningham, and Foster collectively agreed that while the town has different hamlets with different sense of characters each, they do not

necessarily clash with one another.

Foster said that the community forums is a great way to stay proactive and seek each hamlet's voice equally. "Each individual hamlet should be considered and that goes a long way on preserving the community that we all cherish," he said. "It shouldn't be just the nosiest wheel that determines the direction the wagon takes."

VanLuven said that the forums would complement the upcoming comprehensive plan and come up with strategies that will guide the town's growth. Cunningham agreed that as the town sees more developments, "we need to see when a developer's proposal may be bad for the town and push back and ask for changes from that developer. We need to ask ourselves, 'Is this the right thing to develop and is there room to push back?"

When asked if Bethlehem's character as a town will feel much different in the future than what it is today, answers were mixed.

VanLuven believed that "it could change rather quickly in the next 20 years if we don't check development, but we can also backtrack that growth so we can protect our town's fundamental values like keeping that small town feel and being able to know your neighbors. Those values make our neighborhoods strong. We're at a crossroads now, since we're working on the comp. plan, but I'm optimistic."

Foster, however, thought that such a change will not likely happen "as we have many intelligent and involved people in town government working towards maintaining Bethlehem as a great community. I think we're on a great trajectory."



# New year, new terms

# A new face on Town Board and a familiar one in Town Court

**BETHLEHEM**-New Town Board member Dan Coffey and returning Town Justice Ryan T. Donovan were officially sworn in during a ceremony held on Thursday, Jan. 3 at 5:30 p.m. at Town Hall with their respective families, colleagues, supporters and other town officials in attendance.

Coffey, who ran on the Democratic line, takes over Giles Wagoner's seat and is serving a one-year term which expires on Dec. 31.

Donovan, who assumed office in mid-2006 and ran unopposed in last year's election, will now serve another four-year term through Dec. 31, 2022.

Following applause and swift photo-taking sessions with their own families, each gave brief individual speeches afterwards.

"I came up with the three C's and that kind of summarizes my feelings about Bethlehem and what we're going to be working on, moving forward,

Coffey said. "Bethlehem has a unique community feel that no other place in the Capital District has. We're five miles from downtown Albany yet you got a nice small-town feel.'

Coffey, who was born and raised in Plattsburgh, recalled first setting foot in Bethlehem in 1983 when he was still

enrolled at Union College in Schenectady and his roommate brought him over to Bethlehem's town park to play hockey.

It was there where he first took notice of and liked the small town environment.

He said his family relocated to Bethlehem later in October 1999 and has grown to enjoy places including the Delmar Farmers Market, the Albany County Rail Trail and the Four Corners.

Looking ahead, he brought up working on the comprehensive plan update, welcoming public input, and considering what Bethlehem should look like within the next two decades.

He concluded with desiring more connectivity among residents and businesses in town, and better pedestrian safety via sidewalk improvements. Donovan, a lifelong

Bethlehem resident, expressed his gratitude for serving his hometown for more than 12 years.

He also brought up the importance of balancing rehabilitation with incarceration and law enforcement, and "to come into each case with as much human compassion as possible while still keeping our town safe." Donovan made special mention of Bethlehem Police, a department he often works

closely with, as being "exceptional ... and they deserve a lot of credit. I think we're very lucky."

eppers play a significant role in the Mediterranean diet, providing nutrients such as vitamin C and potassium while also giving meals a fresh boost of flavor. Long touted for its health benefits, the Mediterranean diet has piqued the interest of men and women looking to get healthy. Those who want a meal with a little Mediterranean flare can try the following recipe for "Mediterranean Beef Ragoût" from Judith Finlayson's "The Healthy Slow Cooker (Second Edition)" (Robert Rose).

# Mediterranean Beef Ragoût

#### Ingredients: Makes 8 servings

- 2 pounds trimmed stewing beef, cut into 1-inch cubes and patted dry
- 2 tablespoons olive oil, divided
- 2 onions, chopped
- 4 cloves garlic, minced
- 2 tablespoons ground cumin (see note 2 below)
- 1 teaspoon dried thyme
- 1 teaspoon grated lemon zest (optional)
- 1/2 teaspoon salt
- 1/2 teaspoon cracked black peppercorns1 cup beef stock
- 1/2 cup dry red wine
- 1 14-ounce can no-salt-added diced tomatoes, including juice
- 2 bay leaves
- 2 roasted red bell peppers, thinly sliced, then cut into 1-inch pieces
- 1/2 cup sliced pitted green olives
- 1/2 cup finely chopped parsley leaves

#### Instructions:

In a skillet, heat 1 tablespoon of the olive oil over medium-high heat. Add beef, in batches, and cook, stirring, adding more oil as necessary, until browned, about 4 minutes per batch. Transfer to slow cooker stoneware as completed.

Reduce heat to medium. Add onions and garlic to pan and cook, stirring, until onions are softened, about 3 minutes. Add cumin, thyme, lemon zest, if using, salt, and peppercorns and cook, stirring, for 1 minute. Add beef stock, wine, tomatoes with juice, and bay leaves and bring to a boil. Add to slow cooker and stir well.

Cover and cook on low for 6 hours or on high for 3 hours, until mixture is bubbly and beef is tender. Stir in roasted peppers, olives and parsley. Cover and cook on high for 15 minutes, until peppers are heated through. Discard bay leaves.

**Note 1**: This dish can be partially prepared before it is cooked. Heat oil and complete step 2. Refrigerate overnight for up to 2 days. When you're ready to cook, complete steps 1 and 3.

**Note 2**: For the best flavor, toast and ground cumin seeds yourself. Place seeds in a dry skillet over medium heat and cook, stirring, until fragrant, about 3 minutes. Immediately transfer to a spice grinder or mortar and grind.



Michael Lang, who produced the original Woodstock as well as the ensuing anniversary concerts in 1994 in Saugerties and 1999 in Rome, has all but announced the detail of his own commemoration of the historic festival though no details have yet emerged. He will not be

involved with the Bethel event, which is being presented by Live Nation Concerts and INVNT, a branding and live storytelling agency. "While the

original site in Bethel remains close to our hearts, it no longer has the capacity to hold a real Woodstock Festival," said Lang. "I'm delighted that Bethel Woods is doing events in the coming year to celebrate what we brought to life in 1969."

The site of the original Woodstock Festival in 1969 will host its 50thanniversary celebration from Friday to Sunday, Aug. 16 to 18. The center is a series of venues that includes a covered 4,500seat pavilion with a sloping lawn that can seat an additional 10,500 people. The Woodstock Festival Field can accommodate up to 30,000 people. A third stage could entertain up to 1,000 people.

Which leaves to speculation where Lang will hold his festival.

Lang ruled Bethel out as the site for his festival. Each of the past three Woodstock festivals has hosted at least 400,000 people, with Woodstock <sup>6</sup>94 hosting approximately 500,000 revelers. Lang said Bethel would not be able to



Phish: There is a general consensus among fans that Phish won't play at Bethel Woods Center for the Arts. Trey and the crew last played there in 2011. The three-day event allegedly left the lawn in rough shape. A similar rumor recently circulated around Saratoga that alluded to a ban on Dave Matthews Band shows at Saratoga Performing Arts Center. With that said, it seems to be nothing but a rumor. According to a 2012 statement from Bethel Woods, the art center would welcome Phish and its fans. Question is, would Phish entertain such an invite? Phish has spent decades hosting its own festivals, all the while using shows as a means to help fund local charitable groups and promote environmental awareness through its WaterWheel Foundation. With Michael Lang stressing a globally conscious message for his up-coming festival, that would tie well into Phish's philanthropic efforts, too: WARM

**moe:** The band is currently on the East Coast leg of a nationwide tour that shifts west in March before coming back to play Moe Down in July. The band's next scheduled show is in Pennsylvania for the Peach Music Festival on July 25. That potentially keeps the band on the East Coast for Woodstock's August anniversary date. Remember, .moe was a Day 2 opening act at Woodstock '99. By

following these breadcrumbs, the band is a lock to be named in Lang's upcoming announcement. **HOT** 

As we look beyond the Empire State, other bands appear as possible locks.

Lang's Woodstock show could draw in several popular bands with his plans to promote awareness of social, political and environmental issues. **Green Day** immediately comes to mind. Not only did the band perform at Woodstock '99, it has served as an environmental advocate since launching its Move America Beyond Oil campaign in 2006. **Dave Matthews Band** could also use Woodstock as a means to spread the word of its Bama Works Fund. **Pearl Jam** could do the same for endeavors tied to its Carbon Portfolio Strategy. **Carlos Santana** has already expressed his interest in playing both events, bridging the 50 years that separate the two eras.

The Festive Owl, a Twitter page devoted to music festival music, has claimed to possess leaked information from INVNT, the marketing firm tied to the anniversary show at Bethel Woods. The alleged material names the Bethel Woods festival as "Journey On," and lists several acts that include **Bruce Springsteen**, **The Who**, **Bon Jovi**, Phish, Pearl Jam, **Foo Fighters**, **Elton John** and Santana. The information is questionable. Santana has expressed interest. He confirmed with *Billboard* magazine that he has spoken with Lang. However, he has not received an invite to play. Springsteen won't likely play either show. He stated as recently as last month he would be taking all of 2019 off from performing.





# **Princess Nokia's** '**Metallic Butterfly**'

rincess Nokia newest album "Metallic Butterfly" travels through most of the musical spectrum from radio pop to modern trap with glimpses of Afro-Cuban and soul, tied together by obscure, but smooth sing along – friendly choruses.

It's difficult to say whether the public should treat "Metallic Butterfly" as a new body of work. Nokia created the album before 2014 and had distribution under Nokia's original moniker, Wavy Spice — however, the work went largely unnoticed at the time and was pulled from shelves and the internet until now. Last December she re-released the material with redux packaging, promotion, and new tracks.

This project stays unique but maintains accessibility. "Earth is My Playground" and "Versace Hottie" are true to their bouncy titles, both carrying the feel of an electronic rave. The melody of "Hands Up" tributes Lana Del Ray's sultry croon, and the boom-bap percussion on "Seraphims" is a cousin to J. Dilla's frantic work with A Tribe Called Quest. Most songs find the perfect balance between vintage and modern with 808 sub hits weaved in and out.

The album slows down on "Young Girls," a chillstep track where Nokia addresses modern issues relevant to #MeToo and #TimesUp movements, discussing her feelings about the entrusted responsibility of women to be the "patrons of the earth." "They need their own respect," she says.

The slow, but progressive side continues with "Biohazard Butterfly" which introduces further melodies and encourages her listener to not settle for a toxic relationship. "She don't wear no chain, play no game, refuse to be a slave to a romance rage."

Although albums are typically praised when they fit a continuous theme, it is the "all over the place" manic feel of this body of work that gives it such strength. Although



it may have been recorded earlier in her career, this could certainly be Princess Nokia's strongest album to date. Metallic Butterfly is available on all major streaming platforms.
