

# Tree collapses onto Delmar house







The aforementioned stolen credit cards were allegedly stolen in Bethlehem and used in Clifton Park.






# **Felony charges**

# **Bethlehem CSD earns an A+**



Bethlehem Central School District was recognized by Niche, an online national ranking resource, for being a "top-rated, public school district" with 4,580 K-12 students and a student-teacher ratio of 15 to 1. It also noted that state test scores revealed that 74 percent and 69 percent of students are adept in mathematics and reading respectively.

# BCSD superintendent says there's still room to improve

BETHLEHEM — The Bethlehem Central School District was recently awarded an A+ grade on Niche, an online source of reviews and rankings of national K-12 schools, universities, workplaces and neighborhoods.

Other rankings include:

- 1st out of 28 Capital District school districts in terms of being the best and safest
- 13th out of 692 most safest school districts in the state
- 42nd out of 675 best state school districts
- 58th out of 689 state school districts with the best teachers
- 84th most safest school district in the country

"I think it's great that we received that A+ grade and it's always great to be recognized with having great students and a great community," BCSD Superintendent Jody Monroe said.

"While it's one rating and we certainly know there's things we do well and things we need to improve on, it's still nice to be recognized for our hard work."

Within its overall A+ grade, BCSD has an average 12thgrader graduation rate of 93 percent.

BCSD also scored A+ in the categories for academics, teachers, clubs and activities, health and safety, food, and college prep; A for resources and facilities, and sports; and B+ for administration.

However, it scored a C in diversity.

Monroe noted that it does reflect on how the district does not have a lot of diversity concerning race and culture, saying that the majority of students are white.

According to Niche, 87 percent of students are white, 6.5 percent are Asian, 2.9 percent are Hispanic, 2.5 percent are African American, and the remaining 0.9 percent are multiracial.

Also, 49 percent of students are female while 51 percent are male.

"We obviously can't control who's living the district but it's still always great to have diversity, which is a topic addressed in our recent school climate survey," she said. "Our obligation is to use more diverse instruction materials so that our students are aware of how diverse the outside world is after they leave our doors."

She further brought up that BCSD has an Equity Committee — this was created last year and comprises of around 30 staff members, including teachers, supervisors and administrators — which aims to teach other staff and students about being aware that each person has their own unconscious biases, regardless

of background, gender, and other socioeconomic factors.

"It's important to be aware that we all have our own biases at least. For example, when hiring people, you may lean towards people who are more like you but you should also have an open mindset," she said. "It shows how bias impacts your decision-making and then we bring such topics in class for the students."

Recognizing the Equity Committee as one way the district is addressing the topic of diversity, Monroe expressed gratitude to the local community and parents for supporting the district and the students. "Students come in and work hard, and we're very fortunate for that and for the support we do have," she said. "I'd like to thank them and also our staff for all the hard work."

# **RCS informs parents** of upcoming tests

RAVENA - Ravena-Coeymans-Selkirk Central School District's third through eighth grade students will have a chance to demonstrate their academic skills and knowledge on the New York State Assessments in English Language Arts and Math in April and May, according to a mass emailed letter to parents from C. Fred Engelhardt Jr., the assistant superintendent for curriculum and instruction.

The state assessment information would inform the district on how to better support their students, regardless of if they're struggling or excelling academically.

It would also help the district reflect on what to teach its students and how to improve instruction. However, it will not be used to penalize students or evaluate teachers.

These statewide assessments are a part of the state's plan to complement the Every Student Succeeds Acts (ESSA) which details mandatory requirements for the states to follow so that they can attain federal education funding -New York state alone would receive around \$1.6 billion for schools.

ESSA instructs that students in third through eighth grades need to be assessed in English Language Arts and Math at least once annually — under ESSA, the state would ideally need 95 percent of such students to participate in state testing.

The mass email also noted that students would eventually face more examinations and assessments with regards to their education and future potential careers, including the Regents Exams, PSATs, SATs, college and professional assessments.

It believed that the state assessment would help students grow academically and feel more comfortable with further assessments in the future.

Parents who have any questions or concerns are encouraged the contact their student's building principal, including if they would like to refuse their child to take the statewide assessment.

# It takes a village to care

Local initiative to support seniors who want to stay living at their own homes

**BETHLEHEM** — Local non-profit, grassroots organization Bethlehem Neighbors seeks to empower senior citizens to feel comfortable aging in their own homes, instead of having to live out their final days in retirement homes. It is also looking for volunteers to help out such seniors like with home maintenance, friendly visits, technology issues and driving them around town if needed.

Laura Jonas, its interim president, said that she recognizes and commends the town's Senior Services department for already providing various similar resources though like transporting local seniors, offering help with Medicaid, and having informational programs. "But they can't do certain things like go to your house and help change a lightbulb or care for your pet while you're away or help put your Christmas decorations away," she said. "We're not competing with or duplicating Senior Services, we just want to work with everyone and give more options for seniors to enjoy too."

Jonas offered several reasons why senior citizens may prefer living in their own homes, as opposed to retirement homes, and how they can benefit from becoming a Bethlehem Neighbors member.

'We and volunteers can help network to connect residents to resources to help them. It would help seniors to go or be transported around town to

attend more events, take up classes if interested, or ask for help with getting groceries," she said. "It would really help reduce social isolation in people and encourage them to get out of their houses and make new friends, instead of staying in all the time." Other resources would include a selective monthly calendar of events based on member interests, regular updates via email, newsletter or Facebook, and receiving referrals to relevant vetted service providers.

She also brought up

how a senior may feel more comfortable being in a home

filled with memories and familiar surroundings, as opposed to a retirement home — "It's better than picking up and moving to a pristine location that does not have those comfort feelings."

While giving seniors more freedom of choice in their later years, it also helps to maintain social connections among seniors, who sometimes may feel isolated. "Maybe it can even just be somebody giving you a phone call to check in if you're okay, since you may have caught a flu and no one knows about it, for example," she added. "Checking in with people alone would help a lot."

Jonas added that Bethlehem Neighbors follows the so-called "village movement" which started in the historic Boston neighborhood of Beacon Hill around 20 years ago where seniors began recognizing that they're nearing that age where they require more help but do not want to go into nursing or retirement homes. They eventually decided to work together to form a neighborhood-based organization that involves volunteers and a few paid staff to help provide services and resources like helping in the house or getting groceries for

them; seniors usually pay an annual fee in return for these services. This "village movement" model has proven successful and expanded nationally, causing "villages" to develop where seniors feel more connected and empowered, while aging in the comfort of their homes. According to the Village to Village Network, an online resource about the village movement, there are over 300 senior villages in the country now.

Jonas said that Bethlehem Neighbors is one such example, its roots originally starting back in 2014 in the Colonial Acres development off Feura Bush Road and only catering to senior residents there; such residents then realized in 2017 that senior citizens across the whole town could also benefit from that model, hence it grew. It was not until early 2019 that Bethlehem Neighbors would start pushing to raise awareness so that it could attract volunteers and seniors to learn more about it.

Looking ahead, Bethlehem Neighbors plans to have an informational meeting at the end of March where people can learn more or volunteer. Jonas mentioned plans to reach out to and partner with local businesses in town and provide discounts to Bethlehem Neighbors members too, as another incentive.

"Bethlehem Neighbors is a great model for anyone who wants to consider living in their homes as long as possible," she concluded. "It's also another way people can stay active in the community and help your neighbors out."


The Regional Science Bowl attracted over 150 students from 25 schools throughout the Capital District and winning teams will advance to the National Science Bowl Finals in Washington D.C. on April 25 to 29.

Developed in 1991, the Science Bowl was developed by the U.S. Department of Energy as a "highly competitive science education and academic event among teams of high school and middle school students who compete in a fast-paced verbal forum to solve technical problems and answer questions in all branches of science and math," according to its press release. Teams have four students, one alternate student, and at least one coach. The event also aims to promote mathematical and science activities among young students.


One BCHS team, who won against teams from Shenendehowa High School, another BCHS one which placed third, and Shaker High School, will compete in the finals.

The middle school team was beaten by Iroquois Middle School but did place ahead of Van Antwerp and Acadia middle schools.



# The Eagles fall in the finals

GLENS FALLS — The Bethlehem boys exceptional basketball season came to an end a game shy of winning the Section II title.

The No. 2 seed Saratoga got the better of the Eagles, the No. 1 seed heading into the tournament, on Saturday, March 2, at the Cool Insuring Arena by a final of 69 to 58.

Bethlehem finishes the season with a 15-1 record in the Suburban Council — losing only the last game of the regular season to CBA — and 21-2 overall.

The game was closer than the final score, but Saratoga did lead at the end of each quarter, and answered every time Bethlehem put together a run. Still, Bethlehem was only down four points at halftime and five points at the end of three so heading into the last quarter it was very much anybody's game. gotten."

Saratoga won its first Section II title since 1988. Michael Ortale, Jake

Laclair and Erik Salo had 12 points each for Bethlehem while Saratoga's Aidan Holmes led all scorers with 23.

"I'm so proud of the way they worked and we had some seniors who had some loft goals for us early on and they are feeling pretty good right now," said Saratoga coach Matt Usher on News Channel 13.

Irons mentioned "freelancing," and part of his philosophy is to have his team work together. That was exemplified by standout, Michael Ortale, not wanting to know when he was approaching 1,000 points in the Feb. 26 semifinal game against CBA.

"Not that he would not have done it if he wasn't part of this program, but playing as a team is something we stress and it was nothing I made up, it was something he wanted," Irons said. "It was a classy move, not just for CBA but our guys who were not worried about that, but worried about team play and winning the game."

Irons sent out a Tweet after the game, announcing Ortale scored 13 points putting him across the coveted threshold by four. The Iona-bound senior had 12 against Saratoga in the finals, so he finishes his high school career with 1,016 points. And he missed his junior year to injury.

To get to the finals, Bethlehem got some revenge against CBA in the semis after losing to the Brothers in the final game of the year to blemish an otherwise perfect season.

In all, Irons said, going 21-2 overall and 15-1 in conference play was something his team should be proud of.

"Today is a tough time to talk about it with the loss, and obviously you want to win it all, but overall a fantastic season," he said.

# Potential intergenerational community

Town to look into \$22 million community project again

**GUILDERLAND** — The town will continue looking into the possible rise of an 18-building intergenerational community development on Mercy Care Lane off Route 20 near the public library, after its planning board agreed to table the project discussion in their Feb. 27 meeting.

The \$22 million project was proposed by Bostonbased Beacon Communities LLC in partnership with Northern Rivers Family of Services and Center for Disability Services. According to town documents, the 10.7-acre development would contain 65 rental homes, including 52 senior living units and



The red parcel shows the proposed site just off Route 20. Submitted photo 13 multi-generational units — there will be two driveways from Mercy Care Lane to access the community. It would also feature two housing styles: single-story cottage homes and two-story townhomes.

Its purpose is unique in crafting a community for senior citizens, families who are adopting foster children, and young adults who are intellectually and developmentally disabled. Among the amenities it hopes to offer include intergenerational socializing events, a library, community gardening, a clubhouse, a playground, a commercial kitchen, laundry facilities and a computer lab. Senior citizens, who do not require assistance, would be able to engage with the foster children and their families in various social activities, which, in turn, helps the seniors themselves who may be craving a connection since they may feel alone or live far from their own

families. The community would also include some housing for young adults with disabilities who can live mostly independently, albeit with some support.

Beacon Communities development president Duncan Barrett, who appeared before the planning board, said that his firm already operates a similar development called the Treehouse in Easthampton Meadows, Massachusetts for 13 years now "and the outcomes for the children who were formerly in foster care have been extraordinary as compared to the outcomes for most children in foster care in this state." Adding that the Massachusetts project

has been "successful," he explained that his firm undertook this proposed Guilderland project after the New York State Office of Children and Family Services requested it to try to set an example of an intergenerational community in this state.

During the planning board meeting, numerous residents came up to voice their concerns of the project, often saying that the project would invite too much vehicular traffic, be physically too close to existing residential property, and hurt the local natural environment. While they generally supported the project's intergenerational community purpose, they requested for the developer to at least edit the project's site plan or heed their comments.

The project application was then tabled by the planning board until the developer can return again with potential adjustments to their site plan. Also, Guilderland is not the only one though to make any final decision-making as the project will be reviewed by the Albany County Planning Board, Army Corps of Engineers, and New York State Office of Parks, Recreation and Historic Preservation in the near future too.



New school planned

Classes to support K-8 students with trauma history and gradual emotional development

**COLONIE** — BOCES wants to build a new two-story, 41,712-square-foot "Pathways to Learning" school to support students with "intensive needs that are not met in their home school district."

The building, located on 3.25 acres on Airline Drive, was presented to the Planning Board on Tuesday, Feb. 26.

The school will provide education to K-8 students according to the narrative submitted to the Planning Board, and it will provide a "full continuum of services in a structured environment that supports the physical and social-emotional needs of students within a strong educational program."

It will consist of two models:

- The Ready to Learn program emphasizes class sizes of up to four students with a focus of helping them "get back on track for lost learning due to prior placement that did not provide supports allowing students to access educational opportunities."
- The Pathways to Learning program also serves K-8 students who also need significant support but in a less intense environment. Classrooms will give up to six students per classroom with a history of trauma and delayed emotional development access to equational curriculum and school

based learning opportunities while helping build and maintain relationships.

Students in both settings are working towards a Regents diploma or career development and occupational studies credentials.

According to the sketch plan presented to the Planning Board by BBL Construction Services, the site is vacant with scattered trees along the street side of the property.

There are wetlands on the site and there is a stream on the southern property line. However, they will not be disturbed during construction.

The project includes 78 parking spaces. An easement is in place to allow access by an existing access drive of the adjacent property.

It is in an Office Residential zone and a school is listed as a permitted use.

Developers are requesting the town waive the minimum number of off-street parking spots, the required number of landscaped islands within the parking lot and it is requesting Open Development Area, which is required since access is through an adjacent property.

The sketch plan review did not yield any action by the Planning Board. It will now move to concept acceptance and, after more review and potential modification, to final approval.

If approved, the building would back up to the state Department of Agriculture and Markets building and be between the Associated General Contractors building and Christian Brothers Academy.

It would share an access road off Airline Drive with the Agriculture and Markets building.







# Magnetizing look

Should you get stuck on the magnetic eyelash trend?

omen have long relied on false eyelashes to intensify their natural lashes with thickness and length. False eyelashes have come in many varieties through the years, from the classic adhesives to lash extensions individually woven onto lashes in specialty salons.

A new contender in the lash market, magnetic lashes are the latest trend to make news. But do magnetic lashes have staying power? And what are the health concerns, if any, with magnetic lashes?

Instead of fussing with glues and lashes, which often requires a delicate touch and lots of practice to master, falsies not lining up, or painful tearing out of natural lashes when it comes time for removal, magnetic lashes offer a new twist. These products work by sandwiching natural lashes between a false lash set that adheres with small magnets. To apply, one simply places the top lash and the bottom lash on the lash line with her natural lashes in between. The false lashes, which are reusable, click into place and are designed to be easily removed by sliding the magnetic strips apart.

As more people embrace magnetic lashes, some may begin to wonder if there are any potential health concerns associated with them. Magnetic lashes seem to present some of the same concerns of other false lashes and eyelash extensions. False eyelashes and eyelash extensions can cause various issues, advises Consumer Reports. Eyelash extensions have reportedly caused irritation to the conjunctiva (conjunctivitis) or cornea (keratitis). The irritation may be caused by direct contact from the lashes themselves or hypersensitivity to the substances used to attach them. Also, the College of Optometrists in England has warned that "repeated use of eyelash extensions or false lashes can cause traction alopecia, a condition where the hair falls out due to excessive tension placed on the hair shaft."

False lashes have been associated with other problems as well. According to a study from Guillermo Amador, a Ph.D. candidate at the Georgia Institute of Technology, changing the proportion of eyelash (which ideally is one-third the width of the eye in length) can increase airflow around the eye and lead to more dust hitting the surface of the eye. Consequently, this air and dust can dry out the eyes quickly.

While many proponents of magnetic lashes say they are easy to use, less messy and more convenient than glue varieties that may cause allergic reactions, there are those who lament that the magnetic lash strips, which need to be straight, do not bend with the curvature of the eye. This results in a less-than-natural appearance. There's also the risk of a disruption in the lay of the natural lashes because they're anchoring the magnetic sets. Exercise caution to reduce yanking on natural lashes during application and removal. False eyelashes should be cleaned and only be applied after freshly washing your hands.

Women interested in trying magnetic lashes should first speak with an eye doctor to gauge their safety prior to use, and with any false lashes, give the eyes a chance to rest between uses.

# **Coming together**

Music community to gather and kick off sixth annual Dustin Mele Memorial Concert

**TROY**— The sixth annual Dustin Mele Memorial Concert will take place at Brown's Revolution Hall on Saturday, March 9 at 6 p.m.

According to a press release, the benefit will feature some of the area's finest bands (including a special, one-timeonly reunion of the Bob Etoll Group), a 50/50 raffle and an auction — all to benefit suicide prevention and mental health intervention services. Area favorite bands — including Emerald City, Soul Sky and Super 400 — will also make an appearance.

The Meles lost their son, Dustin, to suicide in 2013. His father, a veteran of more than 40 years on the local music circuit, rallied the area's elite musicians to raise awareness of the growing suicide problem.

"Like so many people struggling with a mental health crisis, Dustin was a fully functioning, warm, bright person; a delight to be around," Mele's father and stepmother, Joe and Jenn Mele, said. "He had a job, an apartment with his beloved sister Lindsay, and a large group of close family and friends who loved and supported him. In the months leading up to his suicide, when he began showing signs of internal struggle, we scoured every resource available at the time to help.

"The help was almost non-existent and severely lacking, not to the fault of those who were trying," his parents continued. "The needed programs did not exist, there was very little focus, funding or understanding for those struggling with a



### mental health crisis."

Proceeds from this year's Memorial Concert will support three organizations, the American Foundation for Suicide Prevention (AFSP); National Alliance on Mental Illness (NAMI), and Rensselaer County mental health and emergency assistance programs through Catholic Charities CONSERNS-U program. All donations will be made in memory of Dustin. Past annual concerts have raised over \$50,000 for Capital District not-forprofits, and have drawn more than 2,700 people in all, including Congressman Paul Tonko and many Troy city officials.

"It's a blessing to be able to raise awareness and help to reduce the stigma surrounding mental health, yet it is so difficult to bring the focus of our days back to that horrible time and loss," Mele's family said. "It's more difficult than anyone can imagine, but we look around us and think how can we not do the benefit? How can we not gather hundreds of people and support in Dustin's name and help the community?"

# **Can we get an Encore?**

Busy March has Hartley's Encore dropping new single, playing shows up and down Hudson

ince dropping its debut album last April, Hartley's Encore has gained traction in the Capital District the band grows into its sound.

"I feel like we're heading towards Hartley's Encore 3.0," said Luke Malamood, the band's lead vocalist, keyboardist and co-founder.

Self-described as the "house band at your dance party for the apocalypse," Hartley's Encore is an energetic funk ensemble with a soulful horn section. Its sound is anchored by rock-solid songwriting flowing from Malamood (lead vocals/keyboards) and co-founder Chris Oliver (lead guitar and backing vocals). The band also includes Jeff Nania on saxophones with regular contributions from Phil Chow on trumpet and Suren Kyaruns on saxophones. Josh Gordon (bass), Mike Gilet (drums), Erik Pravel (drums), Brad Monkell (bass) and Alex Gonzales (percussion) are also a part of the band's lineup.

March is proving to be a busy month. The boys started this month by dropping a new single "Feels So Good on Spotify. It's a different approach from last year. Instead of raising money to produce a CD, singles like this will be released in a piecemeal strategy, said Oliver.

It's in the matter people choose to consume their music today. In a Billboard magazine article published last

September, CD sales continue to decline. Industry experts fall short of calling for the death of the physical format. A harbinger of this movement can be seen in the automobile industry, where car manufacturers replace CD players with Apple Play or other streaming options. CDs are heading towards a select niche market.

"Feels So Good" was recorded and mixed by Alan Evans at Iron Wax Studios, somewhere between Amherst, Massachusettes and Brattleboro, Vermont. This first track, since the band's self-titled release, reveals progression.

"It's a whole freaking notch above our record," said Malamood. "A complete song. The more you listen to that, the more that will be revealed. I promise. There's a lot packed in there." He added that the band was able to apply more of what they learned from recording the CD with Evans. "This time we really nailed 'the sound.' His mix is pretty epic," he said.

Hartley's Encore plays at Putnam Place on Friday, March 8 opening for Krewe Orleans at 8 p.m.

Krewe Orleans is a live big band Mardi Gras Experience. The mission of this band is to help keep the tradition of New Orleans Music alive and well. 



uring Lent, a 40-day period serving as a reminder of Jesus' profound sacrifice and ultimate resurrection on Easter Sunday, Christians across the globe focus on their faith and cut out the excesses of life, with many fasting and abstaining from indulgent behaviors.

Many Christians do not eat meat each Friday during Lent, also abstaining on Ash Wednesday and other holy days of obligation. That makes Lent an ideal opportunity to incorporate new meatless recipes, including seafood, into one's culinary repertoire. The following recipe for "Roasted Black Bean Cod" from "Low Fat for Life" (DK Books) by Sue Kreitzman can certainly fit the bill.

### Roasted Black Bean Cod

### Ingredients: Makes 2 servings

- 1 large garlic clove
- 1/2 inch piece fresh ginger, peeled
- 2 teaspoons teriyaki sauce
- 1 teaspoon rice wine vinegar
- 1 cod fillet, about 3/4 lb Freshly ground black pepper
- Spray made of water-diluted oil 1
- quantity of Black Bean Tomato Sauce (see below) Salsa of choice

### Black Bean Tomato Sauce

- 4 cloves garlic, peeled
- inch fresh ginger 1
- 6 to 7 scallions, chopped
- cups stock 11/4
- 1/4 cup dry sherry
- teaspoon oyster sauce 1
- teaspoon Chinese chili sauce 1
- teaspoons Chinese black bean sauce 2
- 1/2 cup passata

### Juice of 1 lime

tablespoons fresh cilantro 2

### Instructions:

Make the black bean sauce and set aside:

Crush together the garlic and ginger and put in a wok with the chopped scallions, stock and sherry. Simmer briskly until the liquid has almost evaporated.

Stir in the oyster, chili and black bean sauces and bring to a boil. Continue to boil, stirring for a few seconds.

Stir in the passata, and then simmer briskly for 30 seconds. Stir in the lime juice and chopped cilantro and simmer for a few seconds longer.

### Make the cod:

Crush together the garlic and ginger and put in a bowl with the teriyaki sauce and vinegar.

Put the cod on a plate and cover with the ginger-garlic mixture. Grind over some pepper. Marinate at room temperature for approximately 20 minutes.

Mist a baking sheet with the oil-water spray. Put the cod on the sheet, scraping all of the marinade over the fish. Spray with oil and oven-roast for 9 to 10 minutes per one-inch thickness of fish.

Spoon the heated Black Bean Tomato Sauce onto a plate. Set the roasted fish on top, then surround with salsa as garnish.

# A hit to the body

# How to handle setbacks in your workout routine


ew things frustrate athletes more than injuries. Sudden muscle pulls or the reemergence of nagging injuries can interrupt workout regimens and put athletes on the shelf until their injuries heal.

Some athletes may be tempted to fight through injuries and continue exercising, but doing so can make injuries worse and lead to even more time spent on the sidelines. Athletes who suspect they might have suffered more than minor aches and pains should consider the following approach when dealing with sudden setbacks in their workout routines.

• Visit a doctor. Medical websites like WebMD are valuable resources, but athletes should not assume that perusing such sites takes the place of visiting doctors. Self-diagnosing an injury, whether it's with the help of a website or simply going on your own intuition, is not safe, as many fitness-related injuries share similar symptoms that make it easy for men and women without medical degrees to misdiagnose. Doctors can determine exactly what your injury is and help get you on the path to recovery by prescribing medications or developing treatment plans. Such treatments can be the difference between a speedy recovery and one that lasts months on end.

• Recognize the importance of patience. No two people heal the same, but patience with an injury is a part of every athlete's healing process. If you don't allow time for an injury to heal or if you try to accelerate your healing process, the existing injury can worsen and you may even injure another part of your body while overcompensating for your initial injury. Go into the healing process knowing it takes time, and be as patient as possible during your recovery.

· Be careful about the rest of your body. One of the problems many athletes encounter when dealing with an injury is the effect that injury has on other areas of your body. Athletes who perform strength training may be able to continue part of their regimen even after suffering an injury, but they should make note of their form to make sure their body is not overcompensating for the area that is injured. Doing so can lead to new injuries or even exacerbate the existing injury. When visiting a doctor, get a specific list of which exercises, if any, you can still perform while recovering. If you plan to weight train during your recovery, reduce the amount of weight you lift, which can



help ensure your form remains correct.

• Report any new setbacks immediately. Some athletes suffer setbacks during their recoveries, and while setbacks can be expected, they should not just be accepted as another hurdle to clear. Report any setbacks to your physician immediately so he or she can advise you on the next steps to take.

• Return slowly. Once your injury has

healed, keep in mind that you can't just dive back in to your workout routine at full steam. Gradually increase the intensity of your workouts as your body once again acclimates itself to exercise.

Injury is a reality of life for many athletes. But how athletes handle their recoveries can affect how quickly they get back in the swing of things.

# **Consider the Source's** 'Metaphor'

Band leads listeners through frenetic dance of ecstatic play and complex progressions



onsider the Source's sixth studio release, "You Are Literally a Metaphor" is a creative picaresque, flushed with cultural influences, brought together in a thrilling narrative of layered instrumentation. The title, not to mention the playing, invites a literary reading and the expansive territory it explores, invokes the realms traveled by a surreal "hero" in an epic tall-tale of love, loss and weird trips around the sun. The real-ish universe stages a synergy of sketchy archetypes, faceless figures with obscure motives whose actions we recognize. "You are Literally a Metaphor" is a totem of the band's figurative playing, evocative songwriting, and exacting range. It is musical treasure trove too rich for a non-musician's explication, that journeys expressively through numerous genres, wistfully transitioning from prog rock to jazz-fusion, Middle Eastern sci-fi and blues over the course of nine tracks.

"Sketches from a Blind Man" opens the album with painterly, cinematic playing, provoking listeners to see scenes from this cryptic odyssey as they unfold. The sound is atmospheric and spacey, imbued with foreboding and a breakneck beat. The chase is on, as guitarist Gabriel Marin, bassist John Ferrara, and drummer Jeff Mann, compete in a frenetic dance of ecstatic playing, weaving intricate lines into complex progressions.

"The One Who Knocks" is a song akin to the work of Primus, and Bela Fleck the Flecktones, that spins folksy guitar lines and lean bass leads into a dark, heavy march, eventually escalating into a turbulent guitar section, before turning gracefully toward a triumphant, soaring conclusion. "It is Known" is a wild cruise. It begins as a red-eyed, breezy ballad with a hint of the blues, reminiscent of The Flaming Lips, but it lurches into a moody groove, la Eddie Hazel, before finally shapeshifting into a speed rock meltdown that recedes into blissful contemplation. The dignity with which CTS so casually blends these traditional elements with their own math rock sensibility, daredevil technicality, and genuine style, all while

connecting each track purposefully with the others, is proof that Metaphor represents a peak for the band.

Playing Twister with genres and influences seems to be CTS's way of taming the art of songcraft. These tracks sound like stories: rooted in place, with a beginning, middle, and end, repeated themes and motifs, and the hint of emotional development. Taking advantage of the familiar rituals inherent in a given genre provides CTS with the canvas on which they sketch their impossibly skillful illustrations. "When You've Loved and Lost Like Frankie Has" is a refreshing take on the blues. Mournful leads linger over an alluring pocket and hip-hop beat, as the tune's bluesy restraint coolly displays the profound sadness portrayed in Marin's playing. "Enemies of magicK" is a fitting finale to Metaphor, as it highlights CTS's prog rock prowess, bringing the album to an anthemic close, while also recapitulating many themes, changes, and elements developed over the course of the album.

"You are Literally a Metaphor" is a project articulated in full, an album seemingly without misstep or omission, on which the playing is peerless and without arrogance. The songs are delicately arranged and wisely executed. It draws on influences ranging from Mars to the Middle East, from Mississippi to Mahavishnu, from Dixie Dregs to King Crimson, and from ELP to epic psychedelia, but over the course of the album, it is CTS's originality and intrepid style that ultimately shines with the highest definition.

# Bruiser and Bicycle's 'Come Find Me'

In like a lion, out like a lamb

his is Bruiser and Bicycle's second stab at an album and they have found something worth sticking to. Nick Whittemore and Keegan Graziane decided to make a change of tone and left their first albums, post-punk basement-core group with dark undertones and synesthetic lyrics, as they described it on their Promo Juke Box page. Now, they are pursuing an indie, psychedelic and eccentric writing style that keeps the album spicy and plain fun to listen to.

They burst out of the gates with a quintessential indie and energetic tone in "The Theorem 2014"

"The Train," which is broken up by odd vocals choices. As for as an intro goes, it's definitely exciting but feels like a big tease. A huge build up, and then drop off. No big jumps or launches. But listen on and you'll see it's not their style.

"Casper" moves into their

straightforward, folky roots and we begin to realize how their vocal style and tone separates this group from others. It's not too deep in terms of production – we hear straightforward instrumentation, but also an omnidirectional and engaging sound. The duo showcases their lead guitar skills with a call and response from two very different voices. Static and distortion precedes a clean and spacious sound but both work over just the a-persistent, folksy guitar riff. It's brilliant!

"Woods" is about as mainstream as the group gets. Without the electronic and quirky touches, we can see how well tuned into the music industry these two are. They know what works and they can recreate popular sounds but make it their own. That's not a skills everyone has. However, we find ourselves on the other side of the spectrum with "Yonder" – it's an acid trip compared to "Woods." We get very trippy and lazy vocals, omnidirectional and experimental instrumentation and some guitar licks that are plain discomforting. Lets just say the chorus isn't something you'll be whistling along to at work.

"See Saw" is one of the best things about the album, how much fun it is to listen from beginning to end. It's a roller coaster of ups and down, sudden turns and unexpected sounds. You'll find yourself at the end of this song saying: how did it get here? There's so many mood swings

throughout each song and the entirety of the album for that matter. Their direction choices are intentional, not just changes for the sake of interest and keeping your attention. And that is no easy feat to accomplish seamlessly.

Their blend of psychedelic lyrics and relentless instrumentation is this band's party trick with "Horns." They leave little hints of this sound laced throughout the album as they do at the beginning of "Horns". They trail off into a cooky march with more haphazard vocal progressions and push into a huge build up with a pulsing beat, layer after layer of instruments and another sudden drop into nothing. Not a trace of resolution nor a sense of closure.

As said before, this is just fun to listen to... even if the ending of the last track can be unsatisfying to some. This group should be admired for what two people during humbling beginnings can do. Not to mention that this groups prior album, which was released a year ago, sounds like it was released in 2010 by four completely different people. Indie music has been vastly popularized in the last decade and this group goes against the grain making unique album billowing with character and passion without making things to avantgarde. Bravo, Nick and Keegan.

# Film 'respectable' to victims


'Garrow' avoids gore and applies focus to story

obert Gallow. A man whose terrifying acts haunted upstate New York in the 1960s and 1970s has seen a resurgence in public interest as an independent movie bearing his last name has been screened at numerous state theaters since late last year. Capital District residents, including those who lived through those fateful years, were finally able to witness the "Garrow" film at The Egg on Saturday, March 2 at 8 p.m.

Directed by Lori Kelly-Bailey, the film works to visually streamline his criminal acts and death, by offering staccato flashbacks which are interspersed between scenes of him being questioned at the Hamilton County Court in 1964. Made on a modest \$30,000 budget,



the director made the wise choice to film it on location across the Adirondacks region, taking advantage of the natural scenery with impressive wide shots and capturing the small-towns' atmospheres. Vintage TV sets, police uniforms and cars all helped to recreate that time period too.

Kelly-Bailey also was able to cast numerous real-life individuals who interacted with Garrow then to portray themselves here, including former corrections officer Dominic Arena whom Garrow shot but survived. Given all these facts, "Garrow" triumphed in coming across as a genuine communitydriven effort that attempted to cover Garrow's life. Speaking of

Garrow, leading actor Jay Alan Christianson portrays the spree killer, albeit appearing a bit more slender than Garrow himself. The film uses Garrow's time on trial at the aforementioned 1964 Hamilton County Court as the backbone of storytelling, where an interrogated Garrow recounts many disturbing episodes via flashbacks in his lifetime, including rape, murder, beastiality and kidnapping.

Appearing somewhat slumped in his wheelchair to feign partial paralysis, Kelly-Bailey's camera offered multiple closeup shots of Garrow -Christianson succeeded in depicting his restless facial expressions, quivering mouth, pronounced frown lines, and notably, a few tears pooling in his trembling eyes whenever he felt uncomfortable or accused by the questioning lawyer. The bordering-oninvasive camera intriguingly also picks up on the sounds of Garrow's tense breathing, throat closing up, and occasional sniffling, which could make the moviegoer feel uncomfortable in being that close to him. There is a sense of relief during his courtroom scenes as the lawyers continually badger him with queries and Garrow is unable to escape them, a welcome change from how Garrow's victims mostly couldn't flee from him prior.

During flashbacks, Kelly-Bailey did not seem afraid to showcase some of his violent acts, with the camera capturing Garrow's father abusing him as a child and striking him in the face, shots of a bloodied Garrow in anguish, and Garrow kidnapping some of his victims. Intelligent decision-making was evident with this film since the camera sometimes cuts into black or fades just as Garrow is about to stab someone or when he grabs a young schoolgirl in the night, leaving the audience to imagine for themselves what happened next. The film does contain

The film does contain two faults though. The background music sometimes grows too melodramatic which somewhat cheapened a few scenes and almost overpowered the actors' dialogue. The final action sequence which features officers shooting and killing Garrow in the woods who had escaped prison four days prior — could have been more dynamic and it did not offer much of a satisfying concluding catharsis as one would hope, since the film had been building Garrow up to be a terrifying, remorseless man. The film does end with an eerie shot, no pun intended, of Garrow lying dead on the ground though, with a notable bullet hole to his head, which all fades to black and white before the credits roll.

Nevertheless, "Garrow" is a respectable independent film which gives viewers a front-row seat into the types of horrific acts he committed in upstate New York. It also should be commended for incorporating actual photographs, court documents, crime photos and transcripts from when Garrow was alive, which helps to remind viewers that his crimes chillingly happened just a few hours away from the Capital District.



# TECHNOLOGY Prepare before you face repairs

### Develop a maintenance schedule for your family vehicle

he oft-sudden expense of vehicle repairs can throw monthly budgets into disarray. Maintaining a routine service schedule is one way for drivers to keep repair costs down.

The online automotive resources Edmunds.com says many car owners do not adequately prepare for scheduled maintenance, and may not give maintenance a thought until it's too late. The first step drivers take upon purchasing a new or preowned vehicle should be to familiarize themselves with the vehicle's owner's manual, which is filled with valuable information and likely includes maintenance interval recommendations.

Next, drivers should learn about their vehicle, which is particularly relevant when buying a preowned vehicle. Getting to know how the car or truck rides, as well as any sounds it may make, can provide drivers with a solid foundation they can then use to keep their cars running strong.

Routine service typically includes tire rotation, oil changes and topping off of fluids. So just how long between service appointments can a car go? Here are some generalized estimates.

• Oil change: Oil chemistry and engine technology have improved so much that most cars can go well beyond the once-recommended 3,000 mile interval

between oil changes. Now many vehicle manufacturers recommend between 5,000 and 10,000 miles between changes, advises Edmunds. Drivers should err on the side of caution if they do a lot of stop-andgo driving and short trips. Other drivers may want to invest in vehicles that have oil change maintenance minders built in. A light or countdown will come on the dashboard, indicating when the oil has reached the end of its usefulness.

• Tire rotation: Rotating tires helps prolong the life of the tires and alleviates uneven tread and wear. During the rotation, each tire is removed and relocated to a different position to ensure that all the tires will wear evenly. Michelin Tires states that tires should be rotated around every six months, or between 6,000 and 8,000 miles. PROCTORS\_ORG · CAPITALREP\_ORG

• Vehicle fluids: Your best bet is to see what the manufacturer recommends in regard to fluids such as transmission fluid, differential oil, brake fluids, coolant, etc. Some transmissions need regular maintenance, while others can go 150,000 miles between changes, according to the vehicle information site The Drive. Coolant typically can last 100,000 miles. For these types of changes, it may be best to go to a mechanic or service center familiar with your make and model rather than a quick-lube center, as knowing when to drain and refill can be more complicated.

Service schedules can be designed to adhere to manufacturers' recommendations and drivers' personal preferences.

Sheehan developed a love for the bass guitar as a kid growing up in Buffalo. While kids daydream of being rockstars, they typically imagine themselves as the lead singer, perhaps show off their prowess at shredding a mean air guitar, or wow playground girlfriends with an imaginary drum solo. However, Sheehan's first memory is that of the bass guitar's sound.

Sheehan recalls how he could hear his neighbor rehearsing with his band at night. His neighbor was a bass player.

"I could hear the bass at night," Sheehan remembers, "because, bass travels. I was a little kid, so I would have to go to bed but I could hear the songs out in the distance." He compared the experience to the concussive thump from a car stereo subwoofer. "I just loved the sound." It was the sound that "moved things around" as you played it. The shake and rattle in the room. "You'd really move the whole building," he said.

When he visited his neighbor, he learned why. He came across the instruments and picked up the bass guitar. It was "big, fat and giant" with thick chords. He then compared it to the guitar in the room.

a reputation of being the least competent musician in the band. But, he owns a different reputation.

Sheehan's story began soon after starting out with Talas. The power trio initially earned its name while performing gigs in the Buffalo and Rochester scenes playing covers from The Who. Through time, the original songs were introduced to the setlist. Sheehan had since modified his instrument and developed innovative techniques. He was twohanded tapping, threefinger picking and chording like a lead guitarist. He was playing bass solos.

In the years since Guitar Player magazine first published in 1967, Sheehan has earned the readers' choice as "Best Rock Bass Player" five times. It's an easy instrument, he said. But, he also said it has limitless potential.

"Bass players sometimes have the reputation of being the least competent musician in the band," said Sheehan. "It's not always true. In fact, some of the greatest and most successful players are [Paul] McCartney, Sting, Lemmy [Kilmister], Geddy Lee, Steve Harris. They're bass players, and it just shows that the instrument really is unlimited in its potential."

### The bass travels

The blue and white thruway signs that dot

across the Empire State show a jagged line cutting across New York's profile. When President Dwight Eisenhower conceived the idea of superhighways across the country, it was to better prepare the union for a potential war. What the retired general failed to envision was that the network later served as a great conduit between

music scenes. After a decade of playing, Talas' reputation grew throughout the communities chain linked across the New York state Thruway.

By the late 70s, Talas was the go-to band in Buffalo. With the help of a young Harvey Weinstein as its manager, the band opened for UFO, Blue Öyster Cult, Triumph Aerosmith and Iron Maiden. A young Irish band named after a spy plane once opened for them, a story Sheehan often shared but was never believed to be true. In 1980, Weinstein arranged a connection that later allowed Talas to open 30

shows on a tour with Van Halen. It established a



relationship that would later lead Sheehan to connect with Van Halen frontman David Lee Roth after his storied departure following the release of "1984."

Despite the national attention, Talas fizzled after the 1980 tour. The band remained unsigned by a major record label and couldn't seem to escape Buffalo. By 1983, the band's lineup changed. The band consisted of Rochester natives, vocalist Phil Naro, drummer "Machine Gun" Mark Miller, guitarist Johnny Angel and Sheehan at bass. Just before Talas was to launch a nationwide tour with Yngwie Malmsteen, Sheehan received a phone call beckoning him to Los Angeles.

Michael Normandin of Stormin Productions remembers that tour as it stopped in Albany. When Normandin learned Talas was scheduling shows around the region for 2019, he reached out and convinced the band to play at Jupiter Hall next Wednesday, March 13.

"It's going to be historic," said Normandin.

A fan of Sheehan, Normandin talks of how he attended Talas' last show in Albany. He remembered it as being a pivotal moment, recalling how the legendary bassist would leave the band to play in a new band with David Lee Roth. At that time, Sheehan said, his impending pairing with Roth was a "state secret." When Sheehan traveled to Los Angeles before the tour, it was to meet with Roth, who had just left Van Halen.

"It was tough keeping

that secret, but I managed it somehow," said Sheehan. The band was going to record an album through Gold Mountain/A&M, but once the tour ended, Sheehan broke the news that he would join Roth. "And, of course, they were very happy for me," he said.

Over the years, Sheehan would be associated with UFO, Mr. Big, The Winery Dogs and Sons of Apollo. In the Summer of 2017, Sheehan reunited with Naro and Miller. With guitarist Kire Najdovski on guitar, Talas was together again. It was intended to be for just one night. It's now the lineup that's touring today. Sheehan recalls that last tour nearly 35 years ago.

"A lot of people in the country saw the Talas and Yngwie tour," he said. "It was extremely successful all throughout the USA with that. To this day, I still get emails about it. We had a really wonderful time together."

Sheehan said it's been "a blast" since Talas reunited. The band has tentative plans to record an album with new material. Sheehan is also working on several other projects, one of which involves Michael Portnoy and The Winery Dogs. UFO announced last week it will go on one last tour before frontman Phil Mogg is to leave the band. Sheehan won't be joining the band, but he hasn't ruled out reuniting with Roth again.

"It's up to [Roth]," said Sheehan. "He has our phone numbers. If he decides to do something, myself, Steve and Greg are ready to join him anytime. That would be a blast, I'm sure."

Local favorite Kristen Capolino is a fireball in motion everytime she performs on stage. She is scheduled to perform at Bethel Woods at its Woodstock Anniversary festival in August. However, she will open for Talas on Wednesday, March 13 at Jupiter Hall.
