More from the Justice Center

ALBANY — The Appellate Division upheld three lower court rulings that dismissed charges brought by the Justice Center for the Protection of People with Special Needs based on the belief the state agency did not have the authority to prosecute.

The unanimous decision was written about the case of Nicole Hodgdon, a substance abuse counselor charged with raping a client at a residential treatment home. But, the seven judges attached that decision to two other cases — Marina Viviani and Justin Hope — thrown out by Albany County judges.

Basically, the appellate judges agreed, despite the Legislature granting the Justice Center the authority to prosecute cases, the state Constitution only extends that power to elected officials like the state attorney general and the county district attorneys.

“As a constitutional officer, chosen by election, a district attorney possesses prosecutorial authority, the essential characteristic of which has been defined as ‘the discretionary power to determine whom, whether

and how to prosecute,’” according to the decision. “The Legislature has no authority to transfer any essential function of a district attorney to a different officer chosen in a different manner. Consequently, there is no constitutional support for the Legislature’s attempt to provide for the gubernatorial appointment of a non-elected special prosecutor, independent of the and with unfettered prosecutorial power.”

Justice Center spokesman Bill Reynolds said in a statement the agency will appeal.

“History shows cases like these slipped through the cracks, which is the very reason the Justice Center was created,” he said. “Current Justice Center cases are protected from this type of challenge and this decision has no impact on operations. We will not stop our fight to protect this vulnerable population from dangerous predators. That fight continues by appealing this decision.”

The Court of Appeals, though, is not obligated to hear their case. There are automatic appeals from the lower courts to the Appellate Division.

The latest Appellate Division decision quoted a dissenting opinion on the appeal of Marthessa

Davidson, who was accused of assaulting a 14-year-old boy in the Finger Lakes. Court of Appeals Judge Jenny Rivera, in her dissent, said Legislation creating the Justice Center and giving it the ability to prosecute, would pass Constitutional muster only under the direct and involved supervision of the local district attorney.

In other words, the DA’s office in each county must first OK the prosecution and then maintain oversight of the case. The majority on the Court of Appeals did not weigh in on the merits of Davidson because of a technicality, her attorney did not cite his concerns during trial and therefore could not appeal the matter later.

As the most recent cases worked their way through the courts, then Attorney General Eric Schneiderman, in an uncommon brief sided with the defendants based on his reading of the state Constitution pitting his office against that of Gov. Andrew Cuomo. At the time Schneiderman was seen as a possible contender to Cuomo but had to resign in disgrace after allegations of domestic abuse surfaced.

Child pornography-related arrest

BETHLEHEM — State Police arrested a Town of Bethlehem man on Monday, July 1 for possession of child pornography.

State Police Investigators from the Latham Barracks took Anthony Scisci, 48, into custody at his place of employment, which was not released at this time, after they found child pornography on his electronic devices at his Glenmont home.

The arrest came after a joint investigation with the State Police Internet Crimes Bureau, the State Police Bureau of Criminal Investigation and the U.S. Department of Homeland Security. He is charged with the felonies of promoting the sexual performance of a child less than 17 and possessing the sexual performance by a child. He was arraigned in the Town of Bethlehem Court and sent to the Albany County jail.

Placed 10th in 10 days

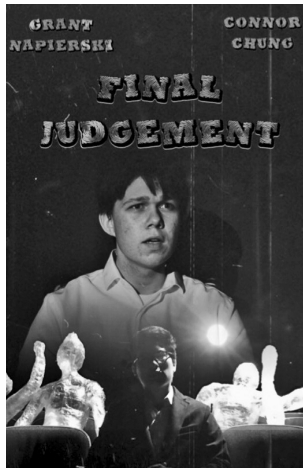
Local student film recognized

DELMAR — A group of film students at Bethlehem Central High School was rewarded tenth place for their film in an international film challenge last month. The task? Create a short film in just ten days.

"I was amazed at what [we] were able to do," said Bethlehem senior and director of the film Madaleine Kotary. "It was our first time participating; it was really great to see how our work was rewarded."

And work it was. The 10 Day Film Challenge, a competition for high school students, features strict requirements and was one of the culminating projects for Kotary's film class. "We're all in the

BCTV Filmmaking for Production class... we knew [the challenge] was coming but we didn't know the requirements until the first day."

The 10 Day Film Challenge, as described on its website, requires students to create a short and original film in only ten school days. On the first day students are given requirements to incorporate in the film, which may

include a specific character, prop, backstory, genre, and line of dialogue. The website describes the challenge as "intense" and "invigorating" and Bethlehem senior and sound editor Matt Stento agrees, stating that at times the challenge could be "strenuous and hard."

"The biggest challenge was the time we had to make the film," recalls Stento. "It was hard to edit in the time that we had... we only had class for 45 minutes per day, and we could work after school but many of us had sports and other activities as well." Despite the major time crunch, Stento declared "I had a lot of fun working with the group... we didn't really know each other at first so we had to learn to work together to get something done; the teamwork makes everything."

Kotary chimed in saying "I was excited going into

it. I knew it was going to be a challenge, but I was confident... everyone had their own unique skills to bring to the table. The most challenging part for me was just trying to make sure we all felt invested and happy with what we were doing. As director, I wanted to make sure it was really a team effort."

Both seniors emphasized the importance of teamwork and their group. Along with Kotary and Stento, the production team included Megan Arsanon, Tess Biggane and Zephan Conway. Acting was performed by Connor Chung and Grant Napierski. Kotary praised the two, saying "Grant and Connor really brought [the film] to life."

The film, named "Final Judgement," explores the courtroom-drama of a man who can't remember a crime that he committed. Kotary explained that the group drew inspiration from film and filmmakers like Alfred Hitchcock, "The Twilight Zone" and Kafka's story, "The Trial." A pocket watch and old video camera were used as props, the required line of dialogue was 'that makes

perfect sense,' and the film focused on the interactions and dynamic between the interrogator, played by Chung, and the accused, played by Napierski.

Out of 270 films, "Final Judgement" earned tenth place overall, a nomination for best sound and was chosen for a special screening. "There was one film that placed from Japan" said Stento. He continued, laughing, "I guess you could say we were tenth in the world!"

Kotary attributed the success of the film to the group, saying that "everyone was invested and contributing, which is what made it so successful." She added that "it was a wonderful thing to share with everyone."

With the film class being an elective at BCHS, not all the members are pursuing film. However, Kotary will be studying film in the fall at Boston University. She recalled her childhood, saying "I remember writing scripts on post-it notes in second grade" and describing her summer tradition of making movies with her cousins. Her love for filmmaking transferred

into high school when she took all three film electives throughout her junior and senior years.

Kotary concluded, "overall, my time in the film classes [taught me] the importance of unrestricted creativity and the importance of creative collaboration." As for the film challenge specifically, she believes that "the most helpful technique was just learning to communicate and appreciate our ideas... it's really to communicate effectively and efficiently and work as a unit in order to bring the story to life."

BCHS previously participated in the film challenge last year, with the 2018 group achieving third place and the title of Best Cinematography. With the continued success of the students, Stento thinks the film classes will continue to complete this contest. "I'm not surprised... I do think classes will continue this tradition." Additionally, Bethlehem was ranked as the best school district in the Capital Region, according to the Albany Business Review's 2019 school report.

The community forums, as part of the comprehensive plan update's first phase, had been held throughout town from November 2018 to March 2019 as a way for town officials to garner residents' input. People addressed questions about what they liked about their respective hamlet and the town overall; what they envisioned their hamlet would be like in 20 years; and what issues and opportunities their hamlet had.

The hamlets reached were Slingerlands, Selkirk, North and South Bethlehem, Delmar, Glenmont and Elsmere. According to Leslie's presentation, around 250 residents participated in the forums overall, which were facilitated by Planning Department staff and Planning Board members.

Such input collected has been said to help inform the creation of the

new comprehensive plan, which seeks to outline goals and visions for the town through 2035 or 2040. It would succeed the original 2005 plan which had concerned Bethlehem's journey through 2020.

"Through our seven meetings, we documented and received numerous comments that were logged by meeting recorders," Leslie said. "In sifting through the comments, we really tried looking into what the folks cared about and what are some of the themes that came out of them. We were able to identify seven themes that we thought were consistent throughout the discussions with all community forums."

A condensed summary of what residents thought about the seven themes follow below.

Neighborhoods

All hamlets generally acknowledged how close

the City of Albany is; how the hamlets offer many sources of employment, culture and entertainment; and how they appreciated the rural, country-setting feel as well as undeveloped pockets of land. Other factors like having quiet neighborhoods, open space and unique building architecture were brought up. Certain structures or landmarks were highlighted by different hamlet residents too, like Five Rivers Environmental Education Center, Henry Hudson Park and the Albany County Rail Trail.

While all hamlets regarded their school districts highly, some people did not like rising school taxes, school districts' budgets and expenditures, and how districts are affected by increasing residential development.

Speaking of development, there was a cacophony of varied perspectives on that issue. Glenmont residents feared that "over development" is already happening; those in Glenmont, Delmar and Slingerlands thought multi-

family housing has too high of a density now. People from Delmar, Slingerlands and Elsmere did favor mixed-use development and how old or historic buildings can be reused to keep up with the times. Many of them specifically wanted small commercial development in certain areas only; would like more museums, community centers and performing arts areas; and want underused or empty buildings to be taken advantage of somehow.

While virtually all hamlets wanted to maintain their own physical and small-town characters, Slingerlands notably brought up the importance of preserving historic homes and buildings in its own historic district.

Aging, Housing

Lack of affordable housing for seniors was an issue brought up in all hamlets which some feared would cause seniors to have to leave Bethlehem. Delmar and Elsmere residents, in particular, envisioned that affordable senior housing

near the Four Corners and other similar hubs can benefit seniors who can thrive on walkability and close proximity to resources.

Other residents brought up how the town can benefit from having more young adults, seniors and minority groups, but again noted that there may not be adequate affordable housing for them.

Regarding housing, residents' opinions differed in that some favored single-family and multi-family properties, while some did not like more multifamily and high-rise buildings. Others wanted just a few developments to spring up in the future.

Transportation

Residents in Slingerlands, Glenmont and Elsmere worried about how much traffic and speeding drivers were negatively affecting their communities, wishing for the town to come up with ways to confront those issues. New Scotland Road, Route 9W, Feura Bush Road and Elsmere Avenue were noted for specifically

experiencing such issues.

Glenmont, Selkirk and South Bethlehem residents disliked the regular truck traffic in their areas, with the latter experiencing them from Callanan Industries. All hamlet residents generally appreciated bicycle and pedestrian pathways for helping to connect them with resources and the outdoors, specifically highlighting the Albany County Rail Trail. Many people wanted more safe crosswalks, rapid flashing beacons, speed signage and bicycle paths.

Some residents also wanted more public transportation, especially in North Bethlehem, Elsmere and Glenmont, while others from South Bethlehem and Selkirk would like park-and-ride facilities.

Environment

Delmar and Elsmere residents particularly expressed hope in the town taking a more assertive approach to develop more environmentally-sustainable communities.

Town wants you

Town officials are seeking experts to fill advisory committee

BETHLEHEM — The Town Board began deliberating in its July 10 meeting on what the proposed Comprehensive Plan Update Advisory Committee should be like.

Town Supervisor David VanLuven began by saying that he wanted the board to consider four key aspects: the committee's purpose, its ideal size, what area of expertise it should have,

and what the appointment process would be like. He said that he would like for the committee — which represents part of phase two of the comprehensive plan process — to be readily assembled and started by early September.

Purpose

Town Board member Jim Foster said that the to-be-completed comprehensive plan needs to reflect that it "belongs to the community, not the Town Board." Fellow member Maureen Cunningham similarly echoed his words and noted the importance of how the committee "is not a Town

Board-led narrative, but it's a community initiative. It should include more people and it has the potential to invite more skill sets and diversity."

Member Joyce Becker said the committee needs to represent the whole town and be inclusive. VanLuven said it would ideally get residents engaged and "it would be a group of individuals going out regularly to town and acting as ambassadors and bringing people in. I see it as vital for bringing information out to residents." Regarding his latter point, he saw the committee as an opportunity to address misunderstandings that

residents may have about the town government's roles and the overall comprehensive plan process.

Ideal size

When Becker and VanLuven asked Robert Leslie, the town's Planning Division director, how big was the Comprehensive Plan Advisory Committee for the original 2005 plan, Leslie said there were nine people. Leslie added that in 2013, the Comprehensive Plan Assessment Committee had around 15 to 19 people.

Becker then said that in her years spent from being in many past boards, "If there's too many people, you don't get the job done." Member Dan Coffey agreed with her, saying that being a committee member is a major time

commitment. He believed that nine people may be too "light," 20 is too many but 10 to 15 people "may be enough to encourage diversity of people's backgrounds, skill sets and geographic locations."

Areas of expertise

There was a general consensus among the board that the committee should at least include members who specialize or have experience in government agency, planning and economic development. Cunningham brought up how Bethlehem benefits from being so close to the city of Albany where such people are in high supply.

Foster saw the town's local businesses as great places to start as they have

people whom he said have "a unique perspective on economic development. They can be good resources in government and the private sectors." Coffey wanted the committee to include at least an engineer or surveyor, and an attorney with zoning and planning backgrounds, as well as others to represent the town's large landowners and farmers.

Becker said that the committee needs to make sure it does alienate any hamlet, especially North and South Bethlehem, the latter which she noted for having the largest regions of open land. Cunningham warned that the committee should be mindful that some of its eventual members could likely be parents and they may face time constraints due to their schedules.

Diet vexes shop owners

Some local business owners oppose it

DELMAR — Around a dozen Delmar business owners and town officials met on Tuesday, July 9 to discuss their concerns about the upcoming Delaware Avenue Road Diet project.

The two-hour meeting, held at My Place and Company in Delmar, saw the attendees deliberating

on how the project may hurt local businesses, cause further traffic congestion, and not improve pedestrian and drivers' safety. Despite these concerns, there was a general consensus among the attendees that they still did care about the success of local businesses and road safety overall, but the road diet was not necessarily the best idea.

The project, slated to be done by 2022, is also known as the Delaware Avenue Complete Streets and Road Diet Project. Said

to relieve traffic congestion, improve pedestrian safety and encourage a more "community main street" setting, it would convert a stretch of Delaware Avenue — from its intersection with Elsmere Avenue to Normans Kill Bridge — from a four-lane to a three-lane road, which includes a middle two-way left-turn lane. Totalling a cost of around \$5.2 million, construction is expected to start in 2021.

One main concern the attendees brought up was

that project would include two bike lanes, which they believed was not ideal since it would truly be used by cyclists only in the warmer seasons, as opposed to all year round. They also noted that the nearby Albany County Rail Trail already offered an alternative for cyclists to use, which can connect them to many local businesses throughout the route.

"I don't think bike lanes are good on Delaware Avenue because it just won't be safe with all the traffic," said Delaware Plaza managing director Debbie Nolan, who appeared on behalf of her father and the plaza's owner, Howard Nolan. "I am a biker and I always go around the back of Delaware Plaza."

Albany-based attorney and author Barbara Collura said that she had gone through all of the project-related public meetings and comments since around 2007. "A majority of businesses and residents did not want the bike lanes put in and the town just listened to the minority in the project's last two meetings," she said. "Don't let anyone from the town

ever tell you that they didn't hear from you."

Town Board member Jim Foster said that in 2017's Delaware Avenue Complete Streets Feasibility Study, most of the roughly 200 crashes on Delaware Avenue were caused by distracted drivers, especially by those using smartphones while driving. While there were no fatalities listed in the study, Foster warned that if more crosswalks are placed on Delaware Avenue, more pedestrians will be vulnerable to distracted drivers and "you're inviting disaster. That same driver who used to not stop and hit a car, will now hit a kid or an unprotected individual like a biker. And that's when they get killed."

Foster also said that in one incident, he attempted to use the crosswalk on Delaware Avenue from Main Square to the Veterans Memorial Park so that he could access the Rail Trail. "I stood there, and this was 10 a.m. on a Tuesday so it's not during rush hour, and I pressed the button that would alert drivers that a pedestrian wanted to cross," he said. "I waited for six cars in one

direction to go through before one finally stopped. Six cars flew by and if we're under some illusion that the project will solve that same problem, it doesn't."

Another main concern was how during the planned 2021-2022 construction timeframe, it may deter customers from reaching their usual local businesses along Delaware Avenue which could have a negative economic impact. "When they had all that construction after the landslide on Delaware Avenue, most of our tenants were down by about 60 percent," Nolan said. "People can't stay in business like that for a ton of different reasons like insurance and it would make people not want to come to [Delaware Plaza] as much. This construction would really affect us."

Prominent local figure Steve Peterson, who organized the meeting, brought up the possibility that even after construction finishes, former customers may have grown accustomed to not doing their business along Delaware Avenue at that point and they may

First-time homebuyer tips for millennials

Millennials are in an interesting position. According to Forbes, they're making less than their parents did at the same age, adjusting for inflation, but they're the largest demographic of homebuyers. While more than one-third are relying on gifts or loans from relatives, there are other ways of saving for a down payment.

Conventional wisdom says it's best to make a 20 percent down payment when you buy your home. While this can help you lock in better interest rates and lower your monthly payment, you need to consider your individual financial situation and needs.

Go Under Budget

Home prices vary wildly depending on where you live, but you can expect to pay \$150,000 to \$250,000 on a starter home, typically a one- or two-bedroom. However, because millennials often rent longer, when they do purchase a home, they are opting to forgo the starter in favor of homes that cost \$300,000 and above, according to CNBC. However, just because you can stretch your budget doesn't mean you should.

Even if you're preapproved for a specific loan amount, you may find that a lower home price gives you breathing room month to month. For long-term homeownership success, consider not only your down payment, but your

monthly payments, property taxes, homeowners insurance and closing costs — which can amount to 2–5 percent of the purchase price of your home. Smaller down payments may require you to get private mortgage insurance (PMI), which would increase your total monthly mortgage payments.

Going under budget gives you flexibility for home repairs or other financial emergencies. Many experts recommend saving between 1 and 3 percent of your home's value each year for routine maintenance.

Time It Right

The homebuying process can take time. If possible, begin to prepare months in advance from when you want to move in. If you know you're going to apply for a mortgage within the next few months, forgo opening new lines of credit, whether via a credit card or loan. This can negatively impact your credit score, which can increase interest rates and, ultimately, how much you'll need to spend.

Also, know your FICO score and review your credit history. For the best rates, lenders will look for your score to be above 720. The higher your score, the better. If there are errors on your history, look to get them corrected. Delaying homeownership for 6 to 12 months to boost your credit score and clean up your history can save you tens of thousands of dollars over the life of your mortgage.

If you're renting a house or apartment, try to negotiate a month-to-month lease or find an apartment that allows for a shorter lease term. That way, when the time comes to pull the trigger on buying a home, you can do so without the stress of rent and mortgage payments. Some millennials even opt to stay in their parents' houses to save on rent.

Generate Additional Income

Anything worthwhile doesn't come without hard work. As such, many millennials with their heart set on owning a home are taking on additional part-time jobs or forgoing vacations to save up for their dream home. However, there's one income source you want to avoid touching: retirement funds. If you're going to tap into this money, carefully consider the risks.

Research Mortgage Options

There's no one-size-fits-all mortgage and your income, location and more can dictate your options. Talk to a professional mortgage loan

officer who can explain the home financing process and lay out the loan options that make the most sense for your situation.

Depending on where you're buying a home, your state may offer special programs for first-time homebuyers, or you may qualify for a Federal Housing Administration mortgage based on your income. Other options, like combination mortgages and VA mortgages, can eliminate the need for PMI. However, in the case of combination mortgages, you'll need a bigger down payment and VA mortgages are available only to veterans, service members and eligible surviving spouses.

Also, prior to applying for your mortgage, you can help streamline the process by understanding the most important factor for lenders is a borrower's ability to repay the loan. Be prepared to provide the following: current or reasonably expected income or assets; current employment status; current debt obligations, including alimony and child support; monthly payment on the mortgage; monthly payment on any simultaneous loans; monthly payment for mortgage-related obligations; monthly debt-to-income ratio or residual income; and credit history.

Prior to meeting with potential lenders, collect your

paperwork and documentation. You will need to provide pay stubs for the past 30 days, W-2 forms or your two most recent tax returns if self-employed, as well as statements from bank and investment accounts.

Before diving into the exciting journey to homeownership, use a mortgage calculator to see how much house fits your lifestyle and then consider any other expenses and financial buffers you may need now and in the future.

Calculating the costs of moving

Moving is stressful...and expensive. It is also something many individuals and families moving to a new location don't fully account for. The best way to de-stress a move and control cost is to plan. The following list provides a look at some things you should account for:

- Movers and/or rental truck or container. If you're going to hire movers, get bids from reputable providers and be clear on their price structure—by the hour, pound or cubic foot. Moving at non-peak times, such as the middle of the month or from October to March, can help you get more competitive rates. If you're more of a "do-it-yourselfer," recruiting friends and family to help you move can save you a lot of money. - Packing materials. Ask friends and family if they have any boxes lying around that you can use. You can also find boxes at the local liquor store, grocer or recycling center. If you need additional boxes, shopping online can help you land significant discounts.

- Delays. Closings get delayed. It's one of the surprising twists and turns that are an unfortunate but not uncommon part of the process. It is also expensive. First, you may need to put your household goods in storage. Second, you may need to pay for additional truck rentals or moving expenses. Third, you may need to pay for someplace to temporarily live. You would be well served to account for each of these unforeseen expenses in your moving budget.
- Tax deductions. In 2018, deductions for moving expenses for nonmilitary taxpayers was suspended. However, if you are an active member of the military and moving due to a permanent change of station, you can deduct your unreimbursed moving expenses. For more information, see IRS Publication 521, Moving Expenses.

You can't plan too much or too far ahead when you're making a move. Also, while it may be stressful, there are many resources available to you, from the Internet to moving professionals, friends, family and even your banker. You just need to seek out help.

Exit 3 to open later this year

Construction already ongoing along Interstate 87

ALBANY COUNTY — Interstate 87 is slated to have a new Exit 3 which would offer more direct access to Albany International Airport and improve local traffic.

The idea of an Exit 3, planned to open to vehicular traffic sometime before the end of 2019, has long been considered but never materialized until now.

For decades, Capital District residents and tourists mainly depended on Exit 4 for the airport, causing much congestion in that area.

Appearing at the airport on Tuesday, July 9, Gov. Andrew Cuomo announced that the new exit is a part of the airport's \$104.6 million project to modernize and improve it, and to help better serve locals and travelers alike.

Construction for Exit 3 is now underway, with lanes on Interstate 87 partially relined to facilitate the process; an overhead ramp has been installed in the past few weeks.

In an emailed message, Maureen McGuinness, president of the Bethlehem

Chamber of Commerce, wrote that the Chamber was present during Cuomo's announcement at the airport last week. She also wrote, "The more direct connection to the airport paired with modernization efforts at the airport enhances the traveling experience, reduces the environmental impact, and mitigates traffic. According to the Governor, transportation paves the way for economic development."

It can be assumed that businesses across the Capital District, including those in Bethlehem and Guilderland, may benefit

from increased traffic from the airport. It further may make the district more of a destination, instead of a pit stop for travelers between places like New York City and Montreal, Canada.

McGuinness included a quote from U.S. Representative Paul Tonko where he said that "these upgrades at Albany International Airport will play a significant role in supporting tourism, driving new and existing business development and making life easier for people who call our Capital Region home."

A Brilliant Bit of Color: The Work of Walter Launt Palmer

ALBANY — The Albany Institute of History and Art is displaying the largest public collection by artist Walter Launt Palmer (1854–1932), son of Albany sculptor Erastus Dow Palmer, now through December 31.

Busy weekend on Bethlehem ballfields

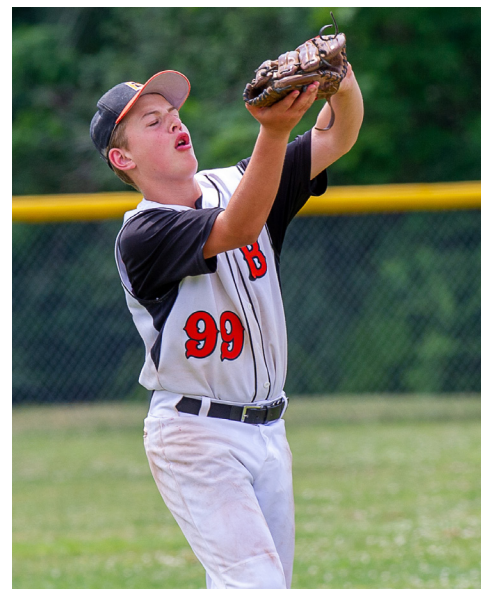

Ideas included pushing for more renewable energy, having economic incentives to encourage greener initiatives, renewable energy-powered street lampposts, and planting more trees.

All hamlet residents virtually enjoyed how there were farms, forests, parks and scenic countryside views throughout town but were worried future development can intervene to hurt the town's character and the environment. Fostering more farmland, open space protection and agritourism were some other ideas brought up that the town could embrace

down the road.

Parks and Rec

Parks in town were appreciated by many residents and they expressed interest in seeing more parks or improvements in the current parks, as well as having more connections between parks and other recreational areas. Many also wanted easier access to streams and greenery with walking trails.

Ideas brought up included having more dog parks, more recreational fields and picnic areas, improved park lighting, regular maintenance of

park facilities, and more community gardens. South Bethlehem residents wanted a new trail to lead to an abandoned rail bed; Elsmere folks envisioned a more direct trail for the Albany Waterline; and Glenmont, Elsmere and Slingerlands people wanted even more parks and playgrounds in their areas.

Economic Development

Small businesses across town were generally seen as providing opportunity and apt employment for locals and some residents wanted more small breweries, unique groceries and retail stores, and coffee shops. Others enthused in the town having more events, businesses,

agritourism, more diversity of business owners and their employees, and seeing improvement in the Delmar Farmer's Market.

Slingerlands and Elsmere residents, in particular, envisioned more economic development that follows how current businesses benefit from being located along or near the Albany County Rail Trail; they brought up the benefits of walkability, connectivity and maintaining the small-town feel. Some residents wanted more employment opportunities for teenagers and young adults alike.

Government

While many residents were concerned about taxes, they still appreciated

the various services the town offers, including the library, senior assistance and emergency services. However, some desired for more transparency and better communication between the town government and residents, in order to stay better informed.

South Bethlehem residents wanted the town to look more into its zoning regulations, its zoning districts, the approval-seeking processes and caring for vacant lots.

Next steps

Leslie said that the comprehensive plan process would be transitioning into phase two. Certain factors here would include the creation

of a Comprehensive Plan Update Advisory Committee; using more surveys and social media to keep up with the community dialogue; having informational tables at community events or locations whenever appropriate; having more community forums that would focus on topics; and continuing to engage key age groups like families, children and teenagers, and seniors.

Leslie added that the comprehensive plan hopefully would be completed by late 2020.

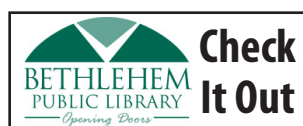

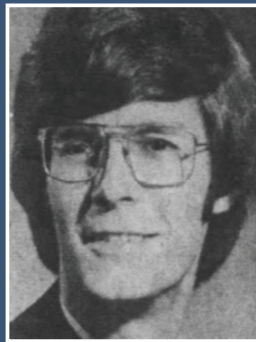

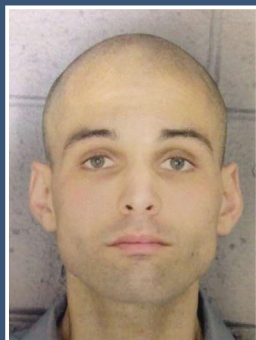

Kotary gave thanks to Ms. Giovanna Prezio, an art and film teacher at Bethlehem Central High School. The students participating in the challenge were enrolled in Prezio's film class and Kotary states that "she encouraged us to be free with our ideas and supported and gave us what we needed to succeed."

As a teacher, Prezio believes "in a system that supports the exploration of a students' individual path." She described that the challenge "gives students the opportunity to discover if working

on a production team is something that inspires and motivates them," and added that next year there will be two music students in the Filmmaking for Production class. This collaboration will require students to "[work] with their peers to create the sound and music each film requires. My vision is one where diverse students come together to make art that is meaningful."

With the award of top district, the success of the film challenge, broadening availability of fashion and art classes and the reconstruction of the auditorium, it seems that BCSD is strongly developing its arts programs. Prezio responded to this

assumption, saying "without a doubt... making art increases focus, teaches us about our unique creative process, helps us to practice following our guidance and inspires empathy and compassion. These are invaluable skills to learn and practice. We have so many different art classes. There really is something for everyone!"

Prezio was very proud of her students, including those in her film and graphic novel classes. "In summary, I hope future arts students feel their ideas are encouraged, heard and supported. We need their voices."

not return at all. There was also concern that the to-be-rerouted traffic would cause traffic congestion on parallel-running or nearby roads, which would negatively affect residents there.

The idea of a road diet itself was also criticized because the attendees believed that road diets do not always work in every type of road setting, and it would not help alleviate traffic on Delaware Avenue. A common situation they envisioned was that since the project would technically have just two opposing traffic lanes, if a vehicle slows down to make a turn or a bus stops along the road, it would force all vehicles behind them to also slow down or stop, which can lead to a congestion. They also worried that with many

vehicles making frequent turns along Delaware Avenue, a cyclist or pedestrian is bound to get struck; they also believed that the road diet design would prevent emergency vehicles from making its way through traffic quickly whenever necessary.

Finally, the attendees agreed that there should have been more transparency regarding the project. Peterson recalled that shortly after the project was originally approved by the Town Board, "I said to myself, 'I wonder how many of the businesses here know about this?' So I went out the next week and went door-to-door, and the answer was the same throughout from everybody: 'I heard about that. That went through?'"

Nolan said that her father was "furious" that no one from the town government had reached out to him regarding his perspective on the

project. She also said that she and her father have a scheduled meeting with Town Supervisor David VanLuven and Planning Division director Robert Leslie sometime this week to further discuss the project.

Looking ahead, the attendees plan to have a followup meeting, hoping more local business owners along the affected Delaware Avenue will attend, within a month. They also began making plans to start an outreach effort to gather more residents' support in opposition to the project, such as with social media and a petition which they could present to the Town Board later on. Despite their dissatisfaction with the project, they still maintained that they were looking out for local businesses, and pedestrian and bicyclist safety.

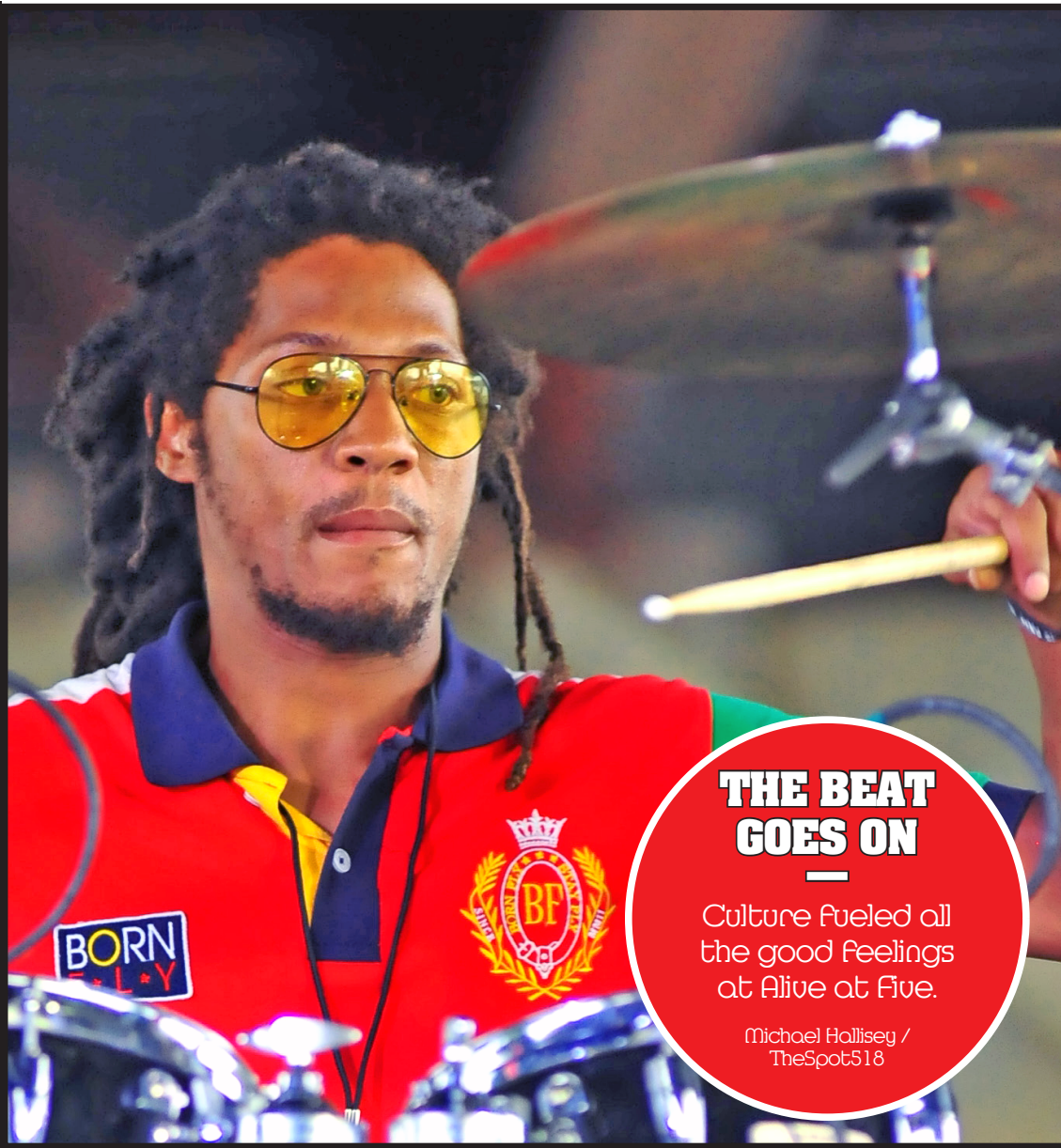

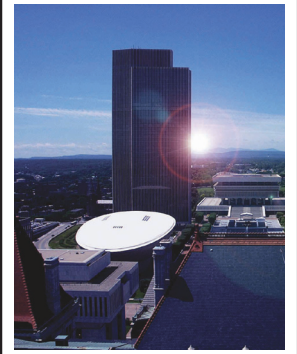

Duanesburg to Tokyo

National cycling champion and Olympic candidate rides in Delmar

DELMAR— Emma White, the youngest ever USA Women's Cycling Champion, met and rode with local cyclists on Thursday, July 11 at the Real McCoy Beer Company in Delmar. Members of the Mohawk-Hudson Cycling Club, Capital Bicycle Racing Club and more congregated to celebrate White's recent victory and wish her luck in her races to come.

White had a chance to meet, reconnect, take photos and speak with the other cyclists about her success and her future endeavors. The cyclists then proceeded with their 30 mile ride, which would end back at the Beer Company for the riders to enjoy food, drinks and more mingling.

Emma White, of Duanesburg, has been racing since she was 9 or 10-years-old. She has competed in all kinds of races like cyclo-cross, where the cyclist must carry their bike through a portion or obstruction in the course, and road racing, which includes specific races like time trials or criterium races. In White's case, she is the current professional criterium champion.

In pursuit of making the 2020 Olympics in Tokyo, White recently began track racing. She revealed, "I mean the Olympic track— it's a dream— I knew I wasn't gonna get there in cyclo-cross; I had 10 good years in cyclo-cross so I figured I wanted to try something new."

She also shared an anecdote of her first time on the track a year ago. "My first time on a UCI legal track was a week before the first World Cup... I remember I was in LA, training right before the World Cup and I was training with three world champions... I got on the track and the three other people were wearing world champion jerseys! I was like what the heck am I doing here!?" Despite her disbelief, she landed herself a spot on the podium in London.

As for her success, she is greatly influenced by her coach, Kristin Armstrong. "She's just a pretty neat person... she's a three-time Olympic gold medalist, so she's been my coach through it all."

White has been busy, juggling professional cycling with traveling and college classes. She attends school at Union College, and will be finished in November. This week, she is headed to Europe to compete. "I leave this weekend for France and I'm doing the Women's Tour de France, so I'm really excited about that. And then I'll head to London to race and then Scotland, Colorado and then Bolivia," said White. "It's quite the summer!"

Even with the multitude of races ahead of her, there is still no stopping White from achieving her goal. "I think an Olympic gold medal is definitely the ultimate dream... nothing is definite, but I'm definitely chasing Tokyo."

While nothing is for certain, it is clear that White will be one to watch as she rides into a bright future.

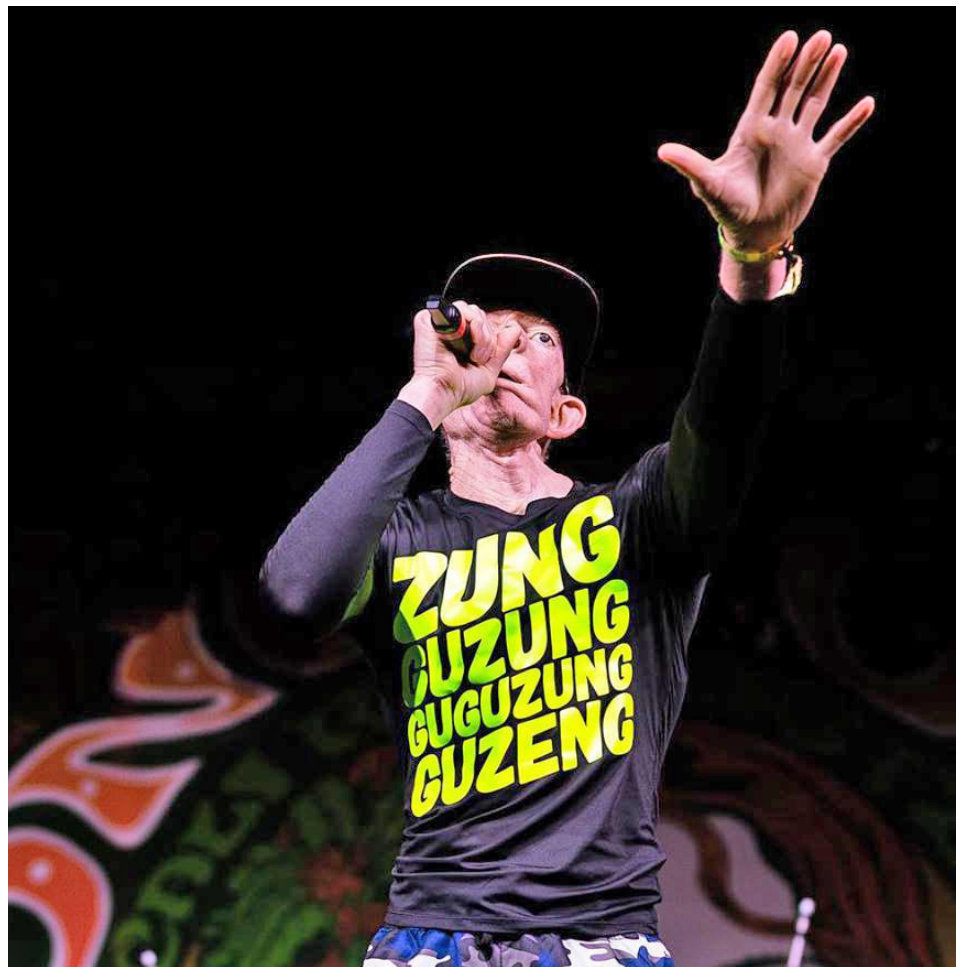

FOOD & VINO



Many people aspire to eat light meals that satisfy hunger pangs without creating feelings of fullness. Some may assume light meals must be lacking flavor, but the following recipe for “Silken Chicken” from Madhur Jaffrey’s “Quick & Easy Indian Cooking” (Chronicle Books) is light and packs that familiar flavorful punch that endears Indian cuisine to millions of people across the globe.

Silken Chicken

Ingredients: Serves 4

For marinating the chicken:

- 4 boned, skinned chicken breast halves (about 1 1/4 pounds)
- 1/2 teaspoon salt
- 2 tablespoons fresh lemon juice

- 1/4 cup heavy whipping cream
- 1/2 teaspoon homemade garam masala (see below)
- 1/4 teaspoon cayenne pepper
- 1/4 teaspoon ground roasted cumin seeds (see below)
- 1/2 teaspoon paprika
- 1 clove garlic, peeled and crushed to a pulp
- 1/2 teaspoon peeled, finely grated fresh ginger

For sprinkling over the chicken:

- Salt as needed
- Freshly ground black pepper
- A little homemade garam masala
- A little ground roasted cumin seed
- A little cayenne pepper
- 1 teaspoon dried mint flakes
- Generous squeezes of fresh lemon juice

Instructions:

Preheat the oven to its highest temperature and arrange a shelf in the top third of the oven. Cut 3 diagonal slits across the top of each piece of chicken breast, being careful not to cut all the way through and also not to go to the edge. Prick the chicken pieces with the sharp point of a small knife. Put them in a single layer in a large baking dish and rub both sides with the salt and lemon juice. Leave for 5 minutes. Meanwhile, combine the cream with the garam masala, cayenne, cumin seeds, paprika, garlic, and ginger in a bowl. Stir this mixture well and pour it over the chicken. Rub it into the meat and leave for 10 minutes. Lift the chicken pieces up (most of the marinade will cling to them) and place them down in a single layer in a shallow baking pan lined with aluminum foil. On top of each, sprinkle a little salt, black pepper, garam masala, ground roasted cumin seed, cayenne, dried mint, and lemon juice. Put into the top third of the oven and bake

for 15 minutes, or until the chicken is just white all the way through. Serve immediately, minted side up.

Garam Masala

Ingredients:

- 1 tablespoon cardamom seeds
- 1 2-inch cinnamon stick
- 1/3 of one nutmeg
- 1 teaspoon black peppercorns
- 1 teaspoon black cumin seeds
- 1 teaspoon whole cloves

Instructions:

Place ingredients into a clean coffee or spice grinder and ground to a powder.

To make ground roasted cumin seeds:

Put 4 to 5 tablespoons of the whole seeds into a small cast-iron frying pan and set over medium heat. Stir the seeds and roast them over dry heat until they turn a few shades darker and emit a wonderful roasted aroma. Wait for them to cool slightly and then grind them in a clean coffee or spice grinder. Store in a tightly closed jar.

Pairing:

Whispering Angel
Chateau D'Esclans — France

Yes. You can go red with Indian cuisine, but you have to be careful. With a dish that offers a bit of spice, you want to shy away from wines with higher alcohol content because they tend to enhance the heat. This rosé from France is a dry complement. It offers a delicious taste of strawberries and red fruits. It's versatile and the bottle should make for a conversation piece.

Pressing out the drama

Pugh transforms “Midsommar” into more than just a horror film

Ari Aster’s debut feature, “Hereditary,” was a horror sensation for last year’s summer movie season. While film critics approved of the family drama that spirals into a nightmare, it split audiences with its ambiguous ending and unconventional approach to the scares. This summer, the writer/director is coming back to the theaters hoping to shock audiences yet again with “Midsommar.”

The story follows Dani (Florence Pugh) and Christian (Jack Reynor) who are stuck in a cold and barren relationship. After suffering a devastating loss, Dani’s grief is all consuming and grows even more distant from her boyfriend. Then, out of the blue, she learns that Christian’s group of anthropology classmates have organized a trip to Sweden in hopes of studying and participating in the titular festival. Dani is pressured by both the group and by her own fears of losing her boyfriend completely to tag along.

Everyone has a great time; personal problems are sorted out and the central relationship is strengthened by this sun-kissed trip abroad.

If only that were the case...

Ari Aster confidently controls the pace of the story and does not arrive at the Swedish village of Harga until the 30 minute mark. This allows the prelude of the story to be dedicated to setting up Dani as a character. We are seeing the story through her eyes and Florence Pugh gives an incredible performance. She may

be the best cinematic screamer since Sheryl Lee in “Twin Peaks: Fire Walk With Me.” Her suffering in this first section is so oppressive that when she begins sobbing you can hear the weight of the trauma pressing down on her chest, squeezing out each cry.

It is very important to understand how Christian deals with Dani’s meltdowns because that relationship is the core of the film. Comfort and empathy are also important to the story and these themes are brought back and utilized in the final act of the film in ways that elevate the horror.

When the film starts to indulge in the more R-rated events that happen at this pagan festival, they are only momentary and pretty sparse for a two and a half hour runtime, but this does not lessen the impact of what you see on screen. In an interview with Bloody Disgusting, Ari Aster addressed the scarcity of gore and said, “that’s the least interesting thing about this movie. It’s the thing that’s inevitable.”

The lush cinematography takes advantage of the forest backgrounds and warm sunlight. It invokes the images of the classic Technicolor movies like “Black Narcissus.” Aster has stated in interviews that the whole town had to be built from scratch and the physical locations are really taken advantage of by cinematographer Pawel Pogorzelski. The camera is free to go anywhere and creates unique images that get seared into your memory.

“Midsommar” is a very strong work of character based storytelling that most of the time feels like a drama with bursts of violence. This should be supported in a year that has been dominated by Disney remakes and sequels.

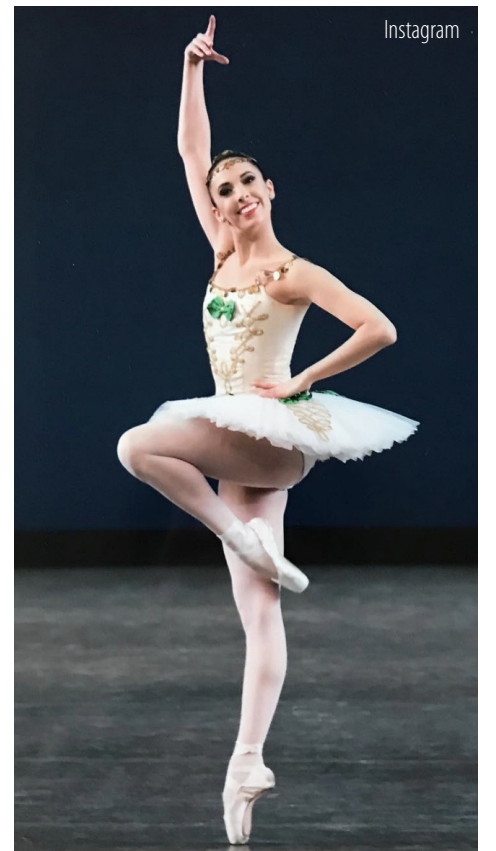

"I love SPAC... it just feels like home to me," said Pollack. And home it certainly is. She will be celebrating her thirteenth year on the Saratoga summer stage. She recalled, "my first performance as an apprentice at New York City Ballet (NYCB) was actually in Saratoga!" Pollack's debut performance was Swan Lake in 2006.

As a soloist with the company, Pollack is a seasoned veteran when it comes to performing. Like many dancers she grew up studying all styles, but began to focus on ballet after realizing that "ballet was what I was best at and enjoyed the most." After studying at the School of American Ballet throughout her teen years, she was offered an apprenticeship with New York City Ballet at age 17. Each summer at SPAC her career comes full circle as she celebrates another year of professional dancing. "It's a dream," Pollack stated.

New York City Ballet has had a home at Saratoga Performing Arts Center since 1966, when NYCB performed 21 times throughout the four-week season. For the past 53 years, NYCB has not missed a summer, and some of the most famous dancers in history have graced the stage at Saratoga. Pollack addressed the legacy: "It feels really special... I've seen photos of Balanchine and the dancers standing in the same spot we are... I grew up looking up to them."

As for performing herself, Pollack enjoys dancing in Saratoga because of its "fun, more relaxed vibe onstage." She added, "the shows are very family oriented; I love when you're on the stage and you see

kids running around outside on the lawn... it takes the pressure off.”

This week, audiences can expect a wide range of works and performances. On Tuesday, July 16 and Thursday, July 18, the company will be performing works by George Balanchine and Tchaikovsky. Wednesday, July 17 will feature premieres from 21st Century choreographers. The beloved ballet, “Coppelia,” will be performed on Thursday, Friday and Saturday, and the week will end with

SPAC’s New York City Ballet Gala on Saturday night at 8 p.m. In preparation the company will have one week of intense rehearsals leading up to the shows. Pollack explained, “It’s a lot of hard work... you have to love it to make it in this career,” adding “we’re always rehearsing... the best way to prepare is just running the ballets and being in the studio as much as you can.”

Pollack will perform in the final night’s gala in a Balanchine piece titled

“Apollo.” “It’s one of the famous, older Balanchine pieces... one of the classic ballets that every ballet dancer wants to do in their career.” Pollack will also perform “Principia,” a work by Justin Peck.

Peck, NYCB’s resident choreographer of five years, has been dancing for NYCB since 2006 and was promoted to soloist in 2013. In 2009 his choreographic career began, resulting in his creation of over 30 ballets, 17 of them being for NYCB.

Pollack praised Peck, saying that they “have always worked really well together.” She admires his sense of collaboration while choreographing, as “he always pushes dancers out of our comfort zones” and “seeks input from all the dancers and departments involved.” Peck and Pollack also recently worked together for the 2018 Broadway musical revival “Carousel,” with Pollack making her debut dancing Peck’s Tony-award winning choreography.

Performing on Broadway, as opposed to the NYCB stage, was a lot different for Pollack: the “hardest difficulty was

the repetition every night... I had to find ways to keep the movement fresh.” She also explained, “I learned a lot from the Broadway community; I had to find meaning through every movement... bringing that back to ballet, [it] adds a new level to my dancing.”

“Carousel” was not strictly ballet focused, and much of the choreography introduced contemporary movement, which can be seen in NYCB’s repertoire as well. The whole NYCB company is quick to develop and adapt to changing styles within the realm of dance. Pollack said “NYCB dancers are known for being able to do any type of style... dance, specifically ballet, is expanding a lot,” and she was quick to commend the company’s ability to “nurture up and coming choreographers” like Peck.

Pollack is ecstatic about performing “Principia” for audiences at Saratoga. “I love doing Justin Peck works... that I’m really excited about.”

From classical to contemporary there will be a performance fit for everyone, and Pollack hopes that audiences will “escape” into the works. She marveled, “the feeling I get when I’m onstage— it’s hard to describe but it’s a sense of relief. I’m not thinking about anything else while I’m on the stage.” Pollack believes that the atmosphere at Saratoga will ensure patrons and performers alike to “enjoy the moment.”

New York City Ballet will perform at SPAC with a variety of shows from Tuesday, July 16 to Saturday, July 20.

E3 lifts veil on coming year

With E3 2019 recently coming to an end, we have a multitude of new content to look forward to in the future of the video game industry.

The Electronic Entertainment Expo, more commonly referred to as E3, is an annual three-day event where some of the biggest computer and video game announcements are made from companies such as Microsoft, Nintendo, and Bethesda.

Electronic Arts started off strong with the first look at "Star Wars: Jedi Fallen Order," a Star War-themed action game where the player controls a padawan named Cal Kestis. EA also went on to reveal two new maps for "Battlefield V", called Marita and Al Sudan, and a new character for "Apex Legends" named Watson. Battlefield V is a war-themed first-person shooter and Apex Legends is a sci-fi themed first-person shooter battle royal game.

Microsoft had one of the most eventful presentations during this year's E3, making a number of huge announcements. The biggest was "Project Scarlett," the developer's newest gaming console in development. It will reportedly be four-times more powerful than the current Xbox One S console and launch with the release of its exclusive sci-fi first-person shooter franchise: "Halo Infinite." Microsoft continued to have big announcements, revealing plans for "Project xCloud", a streaming service that will allow you to stream your video games onto mobile devices.

Arguably more exciting than the announcement of Project Scarlett were the details on Microsoft's cyberpunk-themed role-playing game "Cyberpunk 2077." To be released next April, the game will include the likeness of Matrix and John Wick actor Keanu Reeves, which received a huge amount of enthusiasm from the crowd attending the expo.

In addition to all these large announcements, Microsoft gave details on their titles shooter game Gears 5, shooter game Borderlands 3, and their collaboration with George R.R. Martin on the newly announced game Elden Ring.

Bethesda's presentation was comparatively sparse, starting off by responding to the tremendous backlash that came from open-world role-playing game "Fallout 76," which disappointed fans due to performance issues and lack of content. The developer responded by announcing a new 52-person battle royal mode. Bethesda also revealed plans to bring back a handful of classic game titles including first-person shooters "Wolfenstein: Young Blood" and "Doom:

Eternal", and dungeon crawler "Elder Scrolls: Blades."

Square Enix had two major announcements to show off among a display of smaller announcements. These announcements are for the action game "Avengers" and the remake of 1997 turn-based fantasy role-playing game "Final Fantasy VII." Avengers has a release date of May 15, 2020 and will allow you to play as Captain America, Thor, Hulk, Iron Man, and Black Widow. The remake of "Final Fantasy VII" will be released episodically, with the first installment to be released next March.

Some of the less significant announcements from the presentation included downloadable content for and fantasy action role-playing game "Kingdom Hearts III," top-down racing game "Circuit Superstars," shooter game "Outsiders" and mobile game "War of Visions."

In addition to numerous game announcements, Ubisoft's press conference revealed their new subscription service called UPlay+. Using UPlay+, you can gain access to over 100 ubisoft games along with all the downloadable content from these games. The largest game reveal came in the form of the announcement for "Watch Dogs Legion," the newest in the "Watch Dogs" series which will allow you to control an entire team of resistance agents. Actors from the comedy show It's "Always Sunny in Philadelphia" were also shown to be working on a new comedy show with Ubisoft about game development. Other game announcements included the announcement for the next game in the Rainbow 6 shooter series "Rainbow 6: Quarantine" along with a new season of released game "Rainbow 6: Siege" called "Operation Phantom Sight," a teaser for the action game "Gods & Monsters," and the newest in the "Just Dance" series with its 2020 installment.

Nintendo had a massive amount of games to announce and discuss during their conference, including some anticipated titles and some unexpected treats. The biggest reveal would probably have to be the unexpected announcement for a sequel in development for the hit open-world adventure game "The Legend of Zelda: Breath of the Wild," but there were many other big titles getting attention such as gameplay trailers for horror collection game "Luigi's Mansion 3," the remake of adventure game "The Legend of Zelda: Link's Awakening" and a new installment in the "Animal Crossing" life simulator "Animal Crossing: New Horizons."

This year's E3 had a number of new releases and services to look forward to in 2020, it's shaping up to be a very productive and eventful year for the video game industry.
