

A new age for tobacco, e-cigarette sales

New legislation addresses youth access and addiction

NEW YORK — Gov. Andrew Cuomo approved legislation on Tuesday, July 16 to raise the minimum age from 18 to 21 in the state for the purchase of tobacco and e-cigarette products.

In an official statement, Cuomo said, that the state is taking "aggressive action to stamp out smoking among teens and children, but tobacco and e-cigarette use still persists thanks to irresponsible corporate marketing campaigns targeting young people. By raising the smoking age from 18 to 21, we can stop cigarettes and e-cigarettes from getting into the hands of young people in the first place and prevent an entire generation of New

and potentially deadly addictions."

While the new legislation goes into effect statewide "120 days after becoming law," there are already numerous counties that have established the minimum age at 21, including Albany, Schenectady and Ulster. According to the state Department of Health, state law mandates that all tobacco products must be

> In an emailed statement, Albany County Executive Daniel P. McCoy wrote that he "knew [he] was doing the right thing" when he had signed a law in 2016 that increased the minimum age to 21 for tobacco and e-cigarette purchases in Albany

County, recognizing it was among the first counties to do so.

"Smoking kills and we are working to improve public health," he also wrote. "We all know that tobacco is the leading cause of preventable deaths in the United States and it is our responsibility to do what we can to help spread the message that smoking is a dead end. It's important that the entire state is now dedicated to protecting kids and young adults from all tobacco products."

Elizabeth Whalen, the Albany County Department of Health commissioner, wrote in an email where she recognized that not allowing people aged below 21 to access tobacco products is "an important public health prevention strategy."

Adding that an adolescent's brain is more vulnerable to getting addicted and that nicotine addiction is mostly

lifelong, her department acknowledged that adolescents and young adults are mainly driving the sales of electronic nicotine products — high school students in the state "use these products at rates five times higher than adults."

Whalen brought up a study done and published in January 2019 by the state Dept. of Health's Bureau of Tobacco Control where cigarette smoking among high school students rose from 4.3 percent in 2016 to 4.8 percent in 2018; this was the first increase in the state since 2000.

Also, high school students' e-cigarette usage increased from 10.5 percent to 27.4 percent, from 2014 to 2018. It also determined that e-cigarettes were the most popular tobacco product among American youth as opposed to cigarettes, cigars, smokeless tobacco and hookah. For more information,

Bethlehem Town Supervisor David VanLuven wrote in an email that while the legislation applies statewide, he expressed support for any "steps to make it more difficult for children and young adults to access products." He added that "decades of medical studies [show] that tobacco products cause serious health problems, and children and young adults are particularly vulnerable."

As Bethlehem is currently undergoing a six-month moratorium regarding vape and medical marijuana stores in town, VanLuven acknowledged that the new state legislation "is one more piece of information for

Take a free survey about the Dive Tank

Survey to gauge public's input about future of the pool

BETHLEHEM — The

town is encouraging locals to take an online survey now through Wednesday, July 31 in anticipation for the Elm Avenue Park's Dive Tank's reconstruction.

The 10-question survey is available on the town's website at www. surveymonkey.com/r/ LLZ7H5K.

It asks questions like how often the surveyee visits the pool complex, how many of their family members come along, if the surveyee participates in aquatic or diving programs there, their opinion about the complex's fees, and to rate the complex's overall user experience.

Jason Gallo, the town's

Parks and Recreation administrator who said he helped create the survey with several town staff, said, "It's always good to hear how the public feels about certain things in the pool complex and it's important to get a feel of what they think."

Adding that the survey first became available earlier this month, Gallo said residents' input would help better inform the Dive Tank's anticipated reconstruction.

The Dive Tank has stayed closed for the summer season — the rest of the pool complex remains open though after its structural integrity was deemed compromised earlier this spring. Deteriorated concrete walls and water infiltration were among the discoveries

made. Potential solutions that Gallo brought up included replacing the concrete, introducing an underdrain and excavating around the perimeter of the pool's walls.

While it was decided to hold off further inspection and the eventual reconstruction of the Dive

Tank until this fall so as to not discourage the summer crowds, Gallo said there is a chance that the Dive Tank may not be reconstructed and would instead be possibly replaced with another amenity.

Potential replacing amenity ideas include a new shallow pool, picnic spot, a slide and a shaded grass

"It's not a huge possibility but our full intention is to reconstruct the Dive Tank. I'd rather have the survey information now than in the fall because we want to use all of the fall for active construction time," he said.

As a result, the survey includes some what-if questions like what type of amenity the surveyee thinks could replace the Dive Tank if the reconstruction becomes too

costly for example; if the surveyee thinks the Dive Tank should be repaired regardless of cost; and if the pool complex would still be attractive without a Dive Tank in the future.

Speaking of costs, Gallo said it's hard to determine how much repairs would be as of mid-July since

the town needs to further excavate the Dive Tank to check for any more potential damage. He confirmed that this would happen in the fall too.

When asked about the ideal timeframe for the reconstruction, Gallo said it should start around one or two weeks after the pool complex ceases operations on Sept. 2.

"The pool complex would undergo its typical maintenance that we do every season as we close up the pools," he said. "Then," we will hopefully be ready to go all in."

Gallo added that as of Thursday, July 18, the survey has attracted 875 responses, which he expressed gratitude for people taking the time to take it. For anyone interested to fill it out, it remains available at www.townofbethlehem. org/CivicAlerts. aspx?AID=1034 until Wednesday, July 31.

No one hurt in Glenmont two-vehicle accident

GLENMONT — A vehicular accident crossed the GMC truck's path and they occurred on Tuesday, July 16 at around 1:15 p.m. at the intersection of Route 9W and Plank Road, but no one was hurt.

According to Bethlehem Police Department Cmdr. Adam Hornick, a 2016 GMC truck towing a trailer — operated by Ryan N. Green, 38, of Albany — and a 2015 Mitsubishi car — operated by Amanda Chow, 28, of Cohoes — were both heading northbound on Route 9W.

But when the Mitsubishi — traveling in the middle lane — attempted to make a left turn onto Plank Road, this directly

collided. This caused the GMC truck and its trailer to flip over, with the truck itself landing on its roof.

Both vehicles sustained significant visible damage but Hornick said it "was a very lucky situation" that neither drivers sustained any injuries. The BPD, Delmar-Bethlehem EMS, Albany County paramedics, and the Selkirk Fire Department responded to the scene. Hornick added that witnesses who saw the accident happen helped provide more information.

The accident caused Route 9W to be partially closed to one lane for three hours, said Hornick, and it significantly impacted traffic. However, it reopened fully in time for the afternoon rush hour traffic.

Chow was issued a traffic ticket for moving from her lane unsafely and the investigation closed that same day.

"It's really all about being alert and knowing your surroundings while you're driving because sometimes, people can be the best drivers but you don't know about the actions of other drivers nearby," said Hornick.


Traffic on Route 9W was reduced to one lane after two vehicles struck each other.

the Town to consider when assessing our codes about where it is appropriate to site vape shops, and where it isn't."

In emailed responses, Theresa Petrone Butts, chair of the Capital Region Advisory Board of the American Heart Association, wrote that this "exciting" legislation will help discourage kids from becoming addicted to tobacco and e-cigarette products; she acknowledged that children's older friends have often provided them but the legislation would address that concern.

Adding that the legislation would save more lives in the state, Butts wrote that "there won't be enough prevention programs and resources until children stop picking up cigarettes and e-cigarettes."

According to her, the state's Tobacco Control Program receives around \$39 million in annual funding but the Centers for Disease Control and Prevention recommends around \$203 million in funding instead. "We need to have it fully funded so that we have the resources and programs necessary to reduce, and ultimately prevent, nicotine addiction. With the growing rates of e-cigarettes, we need these funds more than ever," she wrote, also expressing support for Cuomo's passed legislation.

Going to the Moon and back

Remembering 50 years since humans first stepped on the Moon

GUILDERLAND — When Apollo 11 landed on the Moon back on July 20, 1969, millions of people watched in awe as television helped broadcast the moment when a centuries-long dream became a reality. As people looked up to the sky with wonder, they had also looked up when Apollo 11 first launched prior on July 16, a metaphor for how mankind's reach transcended celestial boundaries.


A similar phenomenon happened this past Saturday, July 20 — the 50th anniversary of Apollo 11's Moon landing — at the Guilderland Public Library where a mostly-packed audience peered up as a projector screened a documentary film about the historic event. Aptly titled "Apollo 11" and directed by Todd Douglas Miller, the film was released in theatres in the spring and consisted of archival footage as well as never-before-seen material.

People were now more able to intimately witness the astronauts board the spacecraft, engineers work feverishly in the launch control room, the frenzied

media coverage and the public intrigue at the time. Regarding the latter point, the film offered a first-person view of the massive crowds gathered near the launch pad site, and the fashion and technology of the late 1960s.

Presented in color and assuming the perspectives of the astronauts, engineers and public then, the film felt like a well-packaged time capsule. It felt quite surreal to watch Neil

Armstrong, Michael Collins and Buzz Aldrin up close in such high definition in the film.

Maria Buhl, head of programming at the Guilderland Public Library, said that the library secured the rights to screen the documentary due to an annual contract and an

additional one-time screening licence with Movie Licensing USA. Provided with free popcorn and iced water, the audience that day was mainly a mix of

young families with awestruck children and older folks, some of whom were alive when the actual mission happened in 1969.

Buhl, who was eight years old at the time, said, "I remember everyone talking about it and asking where you'll watch it. It was amazing and newspapers had nothing but coverage on it with huge headlines. In fact, the family who lived down the street from us had a dog that had three puppies named after the astronauts. That showed how people were so obsessed with this back then." She added that due to her young age, she did not fully realize the significance of the Space Race between the U.S. and Soviet Union then but she acknowledged that Apollo 11's success "really displayed a sense of U.S. pride."

The "Apollo 11" screening was a part of Guilderland Public Library's "A Universe of Stories" theme which promoted spacerelated books, activities and events, partially to commemorate Apollo 11's 50th anniversary. Buhl said it was important for children and generations who were not alive in 1969 to acknowledge how "Apollo 11 was probably one of the most defining

moments for mankind and U.S. history. I think it's a good thing to remind kids that this was a tremendous accomplishment and it was also wonderful to see more recent missions including women. Women scientists working at NASA were fundamental too."

Speaking of younger generations, there has been a visible fashion trend this year among teenagers and young adults to wear outer space-, moon- or NASA-themed clothes and accessories. Examples include shirts and face masks bearing NASA's famous "worm" logo, and sweatshirts and silver bomber jackets with NASA's navy blue insignia on its back.

The Los Angeles Times reported on Friday, July 19 in its "The NASA logo is having a moment" article that NASAthemed fashion provides a sense of nostalgia and indirectly promotes public intrigue in the STEM fields -

science, technology, engineering and math.

In pop culture, singer Ariana Grande's 2019 album, "Thank U, Next" included a song named "NASA," which has become a fan favorite and inspired her own line of NASA-themed merch for her world

tour and Coachella performances earlier this year. Also, the recent "Toy Story 4" film includes the return of Buzz Lightyear, a fictional toy Space Ranger whose first name was borrowed from Apollo 11 member Buzz Aldrin

Furthermore, social media is now rampant with Area 51-related memes and jokes, stemming from a viral Facebook group event page called "Storm Area 51, They Can't Stop All of Us."That event page has jokingly attracted over one million people to want to storm Area 51, an

elusive military site in southern Nevada. The U.S. military has actually caught wind of the viral sensation and cautioned the public to not actually approach Area 51.

A July 15 article in *The New* York Times called "Storm Area 51? It's a Joke, but the Air Force is Concerned" included a quote from an Air Force spokeswoman who said that "any attempt to illegally access military installations or military training areas is dangerous." While Area 51 is not connected to NASA or Apollo 11, it has renewed public interest in similar nostalgic topics like outer space and alien-related conspiracy theories.

All these factors further drive up interest in NASA among younger generations and perhaps astronauts and aliens will be among the most popular costumes this Halloween season.

When asked if she has seen many young people sporting NASA-inspired clothing, Buhl said, "I personally have not seen it but we do have T-shirts from the Universe of Stories theme in the library. But that's cool that there's such an interest from young people."

Looking ahead, Buhl said the library is continuing with its Universe of Stories theme with more space-related activities and events through the end of July. "Apollo 11 still is remarkable today and the people who worked at NASA and the astronauts all showed incredible bravery," Buhl said. "The library is still having events like a Jedi Academy, a learn-to-use a telescope program and a talk about stargazing. It's all endless themes."

Katie Louise speaks up

ALBANY — It's been about four months since local singer/songwriter and classically-trained pianist Katie Louise released her debut EP. "Unleash," a seven-track collection of originals, was a labor of love — and an expression of pent-up baggage — that resulted in an album that somehow makes a piano fit in seamlessly with modernday pop music. Since the release, a lot has happened for Louise, including gigs, wedding planning and buying a new house. Our Kaitlin Lembo sat down with the 21-year-old to talk about what's coming.

KAITLIN LEMBO: It's been four months since you released "Unleash" and we've seen you in several

LEMBO: What made you decide to release merch with the EP?

LOUISE: I've always had merch, but I believe in 'new EP, new merch.' It's a complement to the EP and it's also a fun creative outlet. This merch has done better than ever; stock is moving quickly and we've gotten so much love! It's been a slam dunk.

LEMBO: How was the response to your EP?

LOUISE: People seem to really enjoy it. Again, I haven't had time to market much, so I know it could be much better. We had originally sat aside a bit of money for marketing and we just haven't had time to touch it yet; we are hoping to dip into it after the wedding and do some serious marketing. But those who have heard it seem to give overall very positive feedback. It's an amazing feeling to have people love what you write!

LEMBO: Do you think you'll be releasing another EP in the near future?

LOUISE: Ideally, I'd like to release something new every two years. It seems like a nice time period for something to do well, while not becoming boring or overplayed. I have been working on some new stuff but it's taken a backseat to the things happening in my personal life. But I would love to release something else at some point.

LEMBO: You played with Skeeter Creek and now you've performed with SIRSY just this past Sunday. What has it been like to perform with two staple upstate acts?

LOUISE: It's absolutely exciting. When I first started, I was booking a few gigs here and there. My fiancé helps me book gigs now and since he's taken over, he's everywhere and booking me with some really incredible people. I loved performing at Wicked because it's a whole different world musically from Trick Shot, even though it's in the same place. I used to perform here when I started gigging, and to come back full circle and perform with SIRSY and see where I've come from is so motivating and inspiring.

Ego and Hubris

The comedian and award-winning writer has lent his talents to several different mediums throughout his career. A comic career that started with his first stand-up gig in 1988 has spread into stints as a writer and an actor on television, film, and voice over.

"I just like doing creative things," said Oswalt, who graduated with an English degree from the College of William & Mary. "I like doing stuff that is new and challenging."

Oswalt often comes across as the affable characters he portrays on screen. The 50-year-old Virginia native can easily speak of his love for comic books with Jimmy Kimmel, and when asked whether or not he was a fan of the "skins," Washington D.C.'s professional football team, he answers with a creative

spin.

"Yes, I was a skins fan," stated Oswalt, answering an onslaught of online questions later published by *GQ* magazine, "if you're referring to the leathery skin on the bodies of trolls in the Dungeons and Dragons 2nd Edition, so many of which I fought with my dwarf character, a fifth-level fighter with a plus three axe of cutting. So, was I a skins fan? Yes."

Oswalt's comedic career started once he moved to the West Coast in 1992. He once appeared as a clerk on the hit-television



series "Seinfeld." He later applied his skills to the writer's table for "MADtv," followed by his own HBO comedy special in 1996. That same year, he made his film debut alongside Fraser's Kelsey Grammer in "Down Periscope." He was introduced to a younger audience in 2007, when he lent his vocal talents to breathe life into Remy in Pixar's Academy Awardwinning animation film, "Ratatouille."

His career has placed him in good company over the years, working with Grammer, Jerry Seinfeld, Tom Cruise, Ben Stiller, Kevin James and Matthew McConaughey. He's gone on to pen a handful of comic books and star in several specials, the latest of which was last year's "Annihilation." The Netflix special detailed the death of his first wife, crime writer Michelle McNamara, drew critical praise for its frank discussion of love, death and depression.

"To go into different directions and different disciplines, it really feeds into that [creativity]," said Oswalt. "Stand-up isn't like acting. Acting isn't like writing. Writing isn't like voice over. So, it kinda keeps you on your toes, and gets the juices going."

This week, Oswalt will take to the Palace Theatre stage once his Live 2019 tour runs through Albany on Thursday, July 25.

Performing in front of a live audience is not the most difficult of tasks, said Oswalt. Since he first walked upon the stage more than 30 years ago, he's developed confidence in his own voice. But, as with everything, it was a process of getting to this point.

Stand-up comedy is often the most intimate and vulnerable experiences. The comedian stands alone on stage in front of strangers, and there's no guarantee that the material will produce any laughter.

Oswalt penned a lengthy post online describing his fledgling career, both the struggle to find those laughs and the euphoria once he found it. After one night of laughs, he shared a time in which a colleague met him off stage. The laughs he received were from someone else's joke.

"Well, I stole a joke. Not consciously," stated Oswalt in a "closed letter" to himself that he posted online in 2013. "I heard something I found hilarious, mis-remembered it as an inspiration of my own, and then said it onstage. And got big laughs."

The joke was set on a commuter bus. Anyone who has sat on a crowded commuter bus relishes having an open seat next to them.

"Whenever I'm sitting on a bus, and someone asks me if the seat next to me is free, I have an answer that guarantees no one will want that seat. I look up and smile and say, 'No one but... The Lord."

Comedians are often students of the craft. They can recognize a voice, even if it's coming out of someone else's mouth. That night Blaine Capatch stopped Oswalt to praise him, took him aside and said that was Carol Leifer's joke.

The news hit Oswalt. He was apologetic. As soon as Capatch said it, he remembered how it happened. He watched a Leifer special, time had passed, and when the aspiring comedian was struck by an epiphany, he wrote it down in his notebook.

It happens in earnest,

without the intent to steal. Oswalt's friend told him as much, but he warned him to not let it become "a habit."

"In the exact moment after I'd realized that what Blaine said was true, that I'd cribbed a laugh from someone else's creativity and inspiration, my ego kicked in," stated Oswalt. "And, I mean, my real ego. Not ego's sociopathic cousin, hubris, which would have made me defensive, aggressive and ultimately rationalize the theft. No, the good kind of ego, the kind that wanted success and fame and praise on my own merits, no matter how long it took."

Oswalt's stand-up routine covers topics ranging from pop culture to, foreign policy and religion, the latter of which also covers his own atheism. In the years since his admitted mistake, the comedian has earned his own success, fame and praise. His 2016 special 'Talking for Clapping," which was televised on Netflix and later released as an album, earned a Primetime Emmy Award for Outstanding Writing for a Variety Special and a Grammy Award for Best Comedy Album. His two books, "Zombe Spaceship Wasteland," and "Silver Screen Fiend," are New York Times Best Sellers.

Oswalt still caters to the epiphany. The acclaimed comic said if he doesn't have his notebook handy, he texts himself a message on his phone. But, he no longer worries about "misremembering" another comic's joke.

"No. I've been doing it long enough now, I have confidence in my own voice," said Oswalt. "I don't have to be concerned with that. Stand-up is like second-nature to me now."



hope in the mental health system until hearing about this effective modality," said Seymour. "So, they come to us."

The way TMS works is a coil is placed on the patient's head where the left prefrontal cortex is located. Magnetic pulses are sent through the coil at a rate of 18 pulses per second for a two-second burst, followed by a 20-second rest period. This process is repeated 55 times and each treatment session

lasts 20 minutes, and sessions take place five days a week until the patient has his/her breakthrough moment. From there, the patient can choose to either spread out the remaining treatments or continue the pace they are on.

Director of Operations Rocco
Pezzulo said there is
gradual progress from
the time the TMS

through the point where
the patient experiences
a breakthrough, which
typically happens around
the 20th session.

He added that it's normally the patient's family and friends who first notice the improvements before the patient does.

Pezzulo said once the patient has his/her breakthrough, there can be strong emotions tied to it. A staff therapist will help the patient process these emotions in a healthier and more empowering way.

The only change is there won't be a fireworks night this year. Carl said the fireworks show are being set aside for special anniversary years.

Admission and parking are both free for the Punkintown Fair. Proceeds from the rides, food and raffle benefit the New Salem Volunteer Fire Department. The fair opens each evening at 6 p.m. at the field, located at the intersection of routes 85 and 85A in New Salem.



How biking to work can benefit your overall health

ommuting is a fact of life for millions of professionals. The U.S. Census Bureau reports that the average person in the United States spends 26.1 minutes getting to work, while Statistics Canada notes the average Canadian spends 26.2 minutes getting to the office.

Few people enjoy commuting. In fact, a 2004 study published in the journal Science found that female commuters cited commuting as their least satisfying daily activity, ranking it below housework. Perhaps that's because commuting, whether commuters recognize it or not, tends to have adverse effects on their overall health. A 2012 study published in the Journal of Urban Health found that longer commutes are associated with behavioral patterns that may contribute to obesity and other negative health conditions.

Commuters who live close to work can counter some of the negative effects of commuting by cycling to work. Cycling is a healthy activity that the Harvard Medical School notes can help people build muscle and increase bone density, which naturally decreases with age. And there are additional benefits to cycling to work that might compel some commuters to pedal their way to the office.

• Biking can help you meet minimum exercise guidelines. The latest Physical Activity Guidelines from the U.S.

Department of Health and Human Services recommend that adults get at least 150 minutes per week of moderateintensity aerobic activity or 75 minutes of vigorous aerobic activity each week. Biking to work can help people meet and exceed those weekly guidelines, providing a strong foundation for a long, healthy life.

- Biking to work can lower your risk of chronic disease. Regular physical activity like cycling can lower your risk of chronic diseases like cardiovascular disease, type 2 diabetes and certain cancers. Adults who can't find the time to exercise outside of work may find that exercising during their commutes by biking to work is their best and most effective means to lowering their risk for chronic disease.
- Biking to work can improve cognition. The American Heart Association notes that regular physical activity like cycling has been linked to improved cognition, which can positively affect memory, attention and processing
- Biking to work may help reduce stress. A 2017 study from researchers at Montreal's Concordia University attempted to investigate the impact of various commuting modes on workers stress levels upon arrival to their workplace. The study found that such levels were lower among cyclists than they were among people who drove or took public transportation to the office.

Biking to work may not help people reduce their commute times, but it might make those commutes less taxing on their overall health.



Drop in and dance

Delmar dance studio offers inclusion class and commercial hip hop experience for all

DELMAR — Word on the street proves that Delmar has got some new grooves. A local hip hop studio, The Drop In, is starting summer classes July 15 and offering "drop-in" hip hop classes and dance inclusion classes.

For the past few years, Donna Mannarino traveled all over the east coast seeking out professional hip hop classes for her daughter. Now, Mannarino is bringing those coveted classes to the capital region through her new business, The Drop In.

Growing up a dancer herself,
Mannarino is a hip hop teacher at Cindy's
Academy of Dance in Delmar, where
her daughter Angie also takes lessons.
Mannarino created The Drop In in August
2018, after she realized the need for more
hip hop in the Capital Region. Albany and
the area surrounding it has a multitude
of dancing schools, with studios teaching
many styles at many levels. Some schools
focus on recreational learning, while others
require performances at a competitive level;

You're able to walk in, take a class, pay a fee and leave" and Mannarino hopes for students to take the things they learn back to their home studio.

Classes are available for students of all ages with beginner, intermediate and advanced levels at the Cindy's Academy of Dance location in Delmar. Adult hip hop cardio "pop-ins" are also offered at Hiit it with Britt in Albany. When asked what students can expect, Mannarino described "I think every level will learn new techniques," adding that this summer she wants to focus on the patrons having fun and loosening up. Clutch's son has down syndrome and after being diagnosed with cancer at two years old, Clutch needed to



of this is for dancers to unite and support each other and be able to be who they are." She also added, "my biggest goal is to get this community to not be so competitive."

The Drop In's emphasis on community stems from Mannarino's childhood roots. "Growing up in Albany, there wasn't much to do, and Saint Teresa's church school would have The Drop In... we would all ride our bikes... and that's where people went." The original Drop In allowed kids a space to just have fun, and Mannarino is putting an educational and artistic spin on The Drop In, while keeping up the principle values of unity and enjoyment through hip hop dance.

This summer, Mannarino plans to introduce the community to different genres of hip hop. She will create classes that feature popping and locking, old school, and modernized and current hip hop. In addition to Mannarino and her daughter teaching classes, guest teachers are brought in for masterclasses.


Previously, Mannarino has brought in teachers from major metropolitan cities all over the country. One notable teacher was Jay Chris Moore, who has worked with artists like Usher, Missy Elliot, LMFAO and Black Eyed Peas. Moore, hailing



ew cuisines are as beloved as barbecue. Barbecue aficionados will travel far and wide to try a new barbecue joint, but those who can handle a grill need not leave their properties to whip up a delicious meal. The following recipe for "Barbecued Shrimp" from Neal Corman's "Virgil's Barbecue Road Trip Cookbook" (St. Martin's Press) is flavorful and simple, making it an ideal meal for barbecue fans who enjoy making their own meals.

Barbecued Shrimp

Ingredients: Serves 4

Garlic Barbecue Sauce

- 6 tablespoons unsalted butter, divided
- 1 teaspoon chopped garlic
- 1 cup mild barbecue sauce
- 2 tablespoons Virgil's Dry Rub (see below)

Shrimp

- 8 6-inch bamboo skewers
- 2 pounds fresh jumbo shrimp
- 1/2 cup olive oil
- 4 tablespoons Virgil's Dry Rub (see below)
- 2 lemons, cut into wedges

Instructions:

1. In a small pot over medium-high heat, combine 1 tablespoon of butter and the garlic for the garlic sauce. Sauté the garlic for 1 minute, add the mild barbecue sauce and Virgil's Dry Rub, and heat to a boil. Remove from the heat, whisk in the remaining butter, and set aside to use as needed.

2. Soak the skewers in water overnight.

- 3. Peel and devein the shrimp, leaving the tails on. Lay 4 shrimp out on a flat surface. Align them so that they are coiled with the tails on the same side, facing in the same direction.
- 4. Slide a skewer through the shrimp. Run another skewer through the shrimp, parallel to the first and about 1/2 inch apart. (This will prevent the shrimp from spinning on a skewer.) Repeat this process until all of the shrimp are skewered.
- 5. Brush one side of the shrimp on the skewers with olive oil, then dust with the dry rub. Flip the skewers over the repeat the process.
- 6. Place the seasoned skewered shrimp in a container, cover, and refrigerate overnight.
 - 7. Preheat the grill to high heat.
- 8. Reduce to medium heat and position the skewers over direct heat. Grill for 2 minutes, then flip and grill for 1 to 2 minutes more.
- 9. Remove the skewers from the grill and brush each with 2 tablespoons of the garlic sauce. Serve with lemon wedges.

Virgil's Dry Rub

Ingredients: Makes 5 to 51/2 cups

21/2 cups sweet paprika

1 cup granulated sugar

1/2 cup Texas-style chili powder

1/2 cup minced onion

1/2 cup granulated garlic

1/4 cup dried parsley flakes

6 tablespoons kosher salt

Regal and Chill

Movie theater chain is set to launch unique 'unlimited' pass for frequent movie-goers

\$13.70.

Every time you want to catch a movie, it costs \$13.70 for one adult ticket.

When you add a popcorn and soda to the total, the cost to go out to the movies is enormous compared to \$8.99 a month for a base plan through Netflix.

In the summer of 2018, MoviePass offered a solution to alleviate the cost of movie-going with a \$9.95 per month subscription service that would allow the subscriber *unlimited tickets*. The word "unlimited" would be followed with a group of asterisks that would restrict the consumer from 3D, IMAX and other specialty screenings. Sadly, the plan was not sustainable and after multiple instances in which the company ran out of cash, more restrictions were introduced and prices increased which led to a decrease in subscribers.

According to Deadline, Regal Cinemas is set to launch its own subscription service that will offer customers unlimited tickets. There will supposedly be three tiers that you can sign up for, each tier will have access to different Regal Cinemas across the country. The more expensive tiers will focus on more metropolitan areas like New York City and Los Angeles while lower tiers may only be able to use their passes at about half of the nation's Regal

Regal's parent company, Cineworld, also has an





unlimited ticket service in the United Kingdom which offers early screenings and discounts on concessions on top of the free tickets. These benefits are expected to roll over to Regal's program.

One very important aspect of this proposed subscription is that the subscriber would have to pay for the entire year up front. This introduces a very substantial risk for the customer because if Regal Unlimited has the same issues as MoviePass and they are unable to produce the tickets at a certain point, then it could lead to a similar spiral down.

Right now we are in a very interesting point when it comes to movie-going. The competition between theaters and streaming services is intense, and competition encourages companies to try new things to bring in more customers. At the end of the day, we are the ones who choose where our money goes and what gets our support.

Mayer in office

John Mayer makes musical magic for Albany in tour opener

ALBANY — John Mayer opened his 2019 tour at the Times Union Center to a sold-out crowd. Playing two full sets that each could have been stand-alone concerts themselves, Mayer required no opening band for his fans, some of whom held up signs with recommended setlists.

Mayer casually strode across the neon backlit stage after band members set up, picked up his guitar, and gave the room chills during this heatwave with his easy, bluesy playing. They would play two full songs before Mayer greeted the crowd with a gentle "Good Evening," and he swapped out his electric guitar for his acoustic one. The stage was bathed in purple light as Mayer responded to a fan holding up requested songs, "You're going to get your way, well at least half of your requests" he smiled. The crowd was entranced.

There was a mix of old and new songs, songs from Mayer's earlier career as well as hits from the present. The crowd sang along as he played "Who Says You Can't Get Stoned" like they were away at a summer camp, except the volume of the singalong was higher.

Mayer and his band took a few longer breaks between songs, leading one to wonder if this first night together performing brought up some unexpected moments they needed to problem solve. But no problems came through to the crowd; Mayer's relaxed performance, joined by his very joyful band of 8 musicians, seemed like it was simply a continuation of a longer standing tour.

Mayer announced mid-first set "Hey we're back everybody" with a big grin and was very chatty with the crowd. He

struggled to let go of the fan's request list, even sharing he has "low-grade guilt" thinking of a fan holding a sign and getting disappointed during his performance. He presented as a giant sweetheart, seeking to please others and humble about his own musical talent. He even gently shifted his setlist to include a fan's request, stating, "So I did some thinking," and added "Age of Worry" to the second set to please her.

Mayer is talented, too, possibly beyond what most folks who listen to him on the radio will realize. He started in Boston's Berklee School of Music but left the conservatory to begin performing before completing his degree. Mayer pulls melodies out of the guitar like magic; his fingers look incredibly loose as he moves them over the strings, and somehow he brings a great groove line out of the instrument. It looks effortless, but as anyone who has ever played guitar knows, that reflects years of practice.

His lyrics, too, often reflect aching and longing that the timbre of the guitar matches perfectly. Sometimes sounding like bluegrass, other times like pop, and again changing to blues, Mayer's versatility is constantly pronounced.

By set two, the laser cut backdrop had added some trees and sun, and some fun (if not irrelevant) visuals played behind the band as they performed "Still Feel Like Your Man." The dancing panda was completely adorable on the video, bringing a lighter vibe out. He shifted back to blues quickly with "Love is a Verb," where he stayed for a few more songs.

Mayer can really do anything, and the crowd at the Times Union was swaying with him, mesmerized by not only his talent but the clear talent of fellow guitar player Isiah Sharkey. Sharkey has emerged as a guitar giant in his own right, and many fans were screaming out his name in recognition of his also stunningly riffs on

the guitar.

For many fans, the best song of the night was the raw and brutally honest "In the Blood," a recent hit by Mayer that asks if we can escape our family of origin or if we are forever slaves to repeat earlier generations' mistakes. The crowd was clapping and singing along with the lyrics, highlights of which were on the screen overhead. This is a brutal song, if really listened to, and was a truly intense and authentic experience to watch Mayer take so many in the audience on this honest line of inquiry.

Mayer followed with a more upbeat but similarly honest "Waiting on the World to Change." He thanked the crowd for keeping the songs alive, stating "We only play these songs because you've made these great songs." He spoke about how each song brought him back to earlier days, and noted that songs hold memories for all of us, allowing us to go back and visit our earlier selves.

Mayer is a thinker, an artist who attempts to reach for joy but isn't afraid to grind into anxiety, sadness, lost love and the depths of despair. His writing and playing reflect that with integrity, and this resonates with fans who see themselves in that very human and raw experience.

By the show's close, Mayer performed 27 songs, some of which included long jam sessions with band members. And he never missed a beat.






