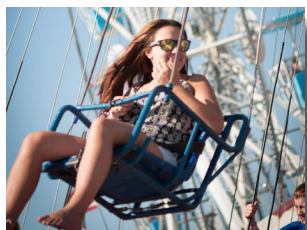

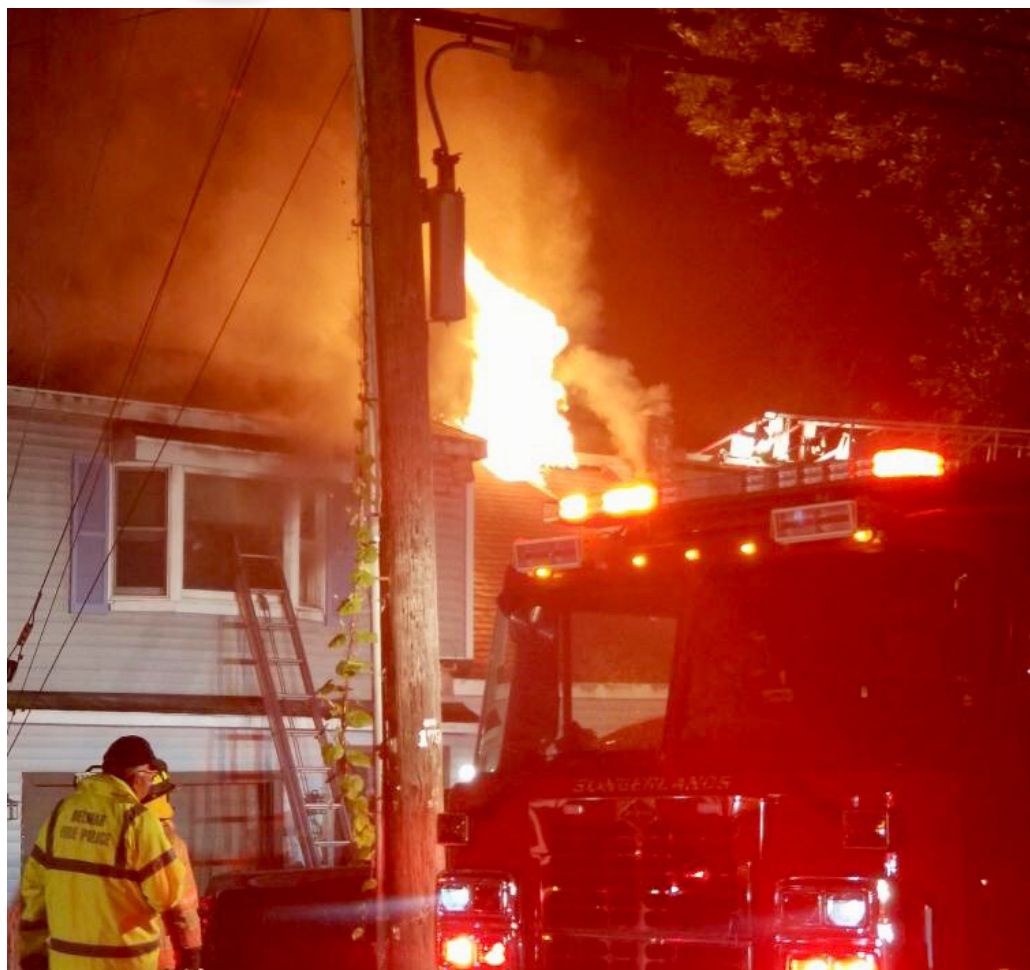

### Arrest warrant

A 26-year-old Albany woman turned herself into the Bethlehem Police Department due to an arrest warrant on Tuesday, July 23 at 4:30 p.m.

The arrest warrant was issued by the Bethlehem Town Court on Thursday, July 18 related to an incident that occurred on 311 Route 9W in Glenmont on Wednesday, July 3 at 6:34 p.m.

Kenya Jackson was charged with assault, criminal possession of a weapon and unlawful possession of noxious material. She was arraigned before Judge Andrew Kirby and released under supervision of probation.

She has a scheduled return court date on Tuesday, Aug. 20 at 4 p.m.

### Bench warrant

A 33-year-old Albany man was the subject of a bench warrant arrest on Monday, July 22 at 9:11 p.m.

Saratoga Springs Police Department had custody of John D. Kibbe at the time and he was transferred to the custody of Bethlehem police.

This was related to an incident on 311 Route 9W in Glenmont on Jan. 1 which the police report

did not detail.

Kibbe was processed and arraigned before Judge Andrew Kirby; he was remanded to the Albany County jail and has a scheduled return court date on Tuesday, Aug. 20 at 4 p.m.

### Arrest warrant

**GLENMONT** — A 53-year-old Glenmont man was arrested on Wednesday, July 24 at 12:53 p.m. for illegally growing cannabis.

Bethlehem police received a call earlier that day from the property owner of 620 Route 9W to report the discovery of a marijuana growing operation in apartment 12.

The owner reported finding the operation after entering the apartment to investigate a water leak that was infiltrating an apartment directly below it. A search warrant for apartment 12's resident was signed by Judge Andrew Kirby.

David Jonathan Pryor arrived home during this search warrant and was placed in custody before being transported to BPD. He was released on appearance tickets with a return date of Tuesday, Aug. 20 at 5:30 p.m.

Pryor's property and the evidence found inside it were

secured by BPD officers. Pryor was charged with unlawfully growing cannabis and criminal possession of marijuana.

### Arrest warrant

A 19-year-old Schenectady man was arrested on a host of charges on 462 Route 9W in Glenmont on Thursday, July 26 at 9:30 a.m.

Bethlehem police arrived at Dupree Joshua Williams' Schenectady residence and placed him in custody before transporting him back to BPD.

This was related to a forgery-related incident on Tuesday, June 25 where he allegedly stole someone else's identity. The victim's name and the specifics of the incident were not detailed in the police report though. After being processed, Williams was granted a request to write an apology letter to the victim. He was arraigned before Judge Andrew Kirby and released under supervision of probation.

Williams was charged with forgery, identity theft, grand larceny and petit larceny. He has a scheduled return court date of Tuesday, Aug. 20 at 4 p.m.

# The great American summer job

How summer jobs have evolved recently

**BETHLEHEM** — “Summer jobs aren’t what they used to be,” stated Drew Desilver in an article from the Pew Research Center.

The article explained its findings that fewer teenagers are engaging in work during their school breaks: “But even though there are more working-age teens today than in 2000, 16.7 million vs. 15.9 million, far fewer of them are in the labor force: 5.6 million as of last month, down from 8.1 million in May 2000.”

Desilver writes that while fewer teens are working low-skill, entry-level jobs, many have picked up unpaid internships, summer school, community service and opportunities abroad instead.

Is the same true for the Capital District?

Tracy Farrell, a business teacher and certified work experience coordinator at Bethlehem Central School District, believes that teens need “to have different experiences... a lot of what you gain in a job or internship, you can’t learn in a classroom.”

At BCHS, Farrell helps teens find internships, and they are able to get real world experience while gaining school



credit. Farrell described it as a “wonderful network opportunity,” as her students have paired with businesses such as the Chamber of Commerce, insurance companies, banks, the Audubon Society, government offices and more.

“Internships can help develop transferable skills,” stated Farrell, adding that these skills are beneficial to students when applying to colleges and future jobs. When asked whether teens are under a certain pressure to be employed, she said “I don’t think teens understand the importance... pressure is important and something that’s necessary.”

Upcoming Tufts University

junior and Delmar native Connor Doyle agrees that there is pressure on teens: “There is extraordinary pressure, for college sophomores [and] juniors to obtain internships for the subsequent summer. Applying for next summer’s internship is a top priority for me.”

Doyle, a Bethlehem High School graduate, has previously worked summer jobs as a lifeguard and swim coach. This summer, he has been living and working in Dubai as an intern for Endeavor at their United Arab Emirates office.

Doyle is one of many examples of students going abroad for summer study or work. With his major being international

relations, he reasoned, “I chose to pursue a job outside the United States because I am interested in the Middle East and North Africa region.” He also explained that he would “have more exposure to Arabic,” and “gain a unique perspective living and working abroad.”

While not all students choose to venture out of the states, many still choose to work at home.

Recent Bethlehem graduate Grace Hanifin is saving money and preparing for college while working at Perfect Blend Cafe and Twisted Vine in Delmar. She believes that jobs are necessary and have given her great skills.

“A lot of kids in this town don’t have jobs and they just use

their parents’ money to coast through the summer... but on the other hand you do have a lot of kids that are working,” said Hanifin. “I have two jobs; I know a lot of other people that have one job or multiple and I think that’s very valuable when you go to college because you learn that responsibility.”

Hanifin also explained the multitude of skills and valuable lessons she has learned working: responsibility, time management, communication and being a role model were only a few of the skills Hanifin has developed.

Many teens are often worried about their summer employment due to the pressure of college applications. However, Siena College junior and admissions worker Emily Crandall advises “It’s important to get involved. Find something that you like, or something that ties into your major...”

She added, “[Colleges] value whatever you’re involved in. The number one thing is definitely involvement; they want to see a well-rounded student.” Crandall continued, “It doesn’t matter if it’s an internship versus a job like working in an ice cream shop, as long as they see that you’re working.”

Whether you are interning abroad, taking classes, working at home, or saving for college, there is no doubt that summer jobs will always be an important part of school breaks for teens.

# Beauty and the Beast Jr. soars

Local musical production helps its cast grow as actors

**COHOES** — Tale as old as time, song as old as rhyme. While that lyric is famous from Disney's 1991 animated and 2017 live-action "Beauty and the Beast" films, Capital District residents were able to hear it live at the Cohoes Music Hall from Tuesday, July 30 through Saturday, Aug. 3.

Park Playhouse was presenting "Beauty and the Beast Jr." which was a mostly adolescent-oriented production comprising a mix of 33 elementary and middle school students, around 10 of whom are from the Bethlehem area.

The musical followed the original 1991 film closely and retained many of the

classic numbers, offering a euphoric mix of hopeless romance and nostalgic tunes. Tickets ranged from \$12 to \$25.

Director Rich Johnson, who lives in Bethlehem, wrote in an email that auditions and casting were held in February, and he gave a special

shout-out to his colleagues — choreographer Kellie Schweon, music director Brandon Jones and stage manager Nora Collins. Being his third time directing a production with Park Playhouse, he explained his return as stemming from Park Playhouse's "focus on

making the experience for the students a priority. When they have a great and educational experience, it always carries over into the show. I am proud of the work the team I get to be a part of does, it is a true collaboration of passion and talent."

Attending the matinee performance on Wednesday, July 31,

the production looked impressive with its large costume-adorned cast on a seemingly small historical stage. This was emphasized during grand numbers like "Belle" and "Be Our Guest" where despite occasional audio issues, the cast was able to recapture

the original film's animated extravagance with witty dialogue and revolving set pieces. Background cast members proved essential too as they operated like a Greek chorus to help move the storylines along.

The two leads, Belle and the Beast, were portrayed by Bethlehem Central Middle School students Catherine Fitzgerald and Gabe Martin, respectively. The couple shined with their initially-innocent dispositions and their shift from a captor-captive dynamic to a romantic couple felt natural.

Another highlight was Kevin Begley as the resilient Gaston whose strong vocals and raw physicality helped bring his character to life on stage. It almost felt sad to watch Gaston be defeated in the end as Begley's talents deserved more attention, which the character of Gaston probably would

have revealed in.

Fitzgerald, 13, who will start eighth grade at Bethlehem Central Middle School this fall, said she was "really surprised and happy" when she found out she landed the female lead, a part she had wanted but did not know if she would actually get.

Saying that "Beauty and the Beast" is among her favorite Disney films, Fitzgerald said since her casting, she has made many new friends among her castmates and enjoyed Johnson's direction. She added, "Well at first, I was really nervous about singing in front of everyone but everyone has been so kind and talented, and that helped so much. I also know the directors and they also have put on great shows."

Fellow 12-year-old castmate Yuna Chung, entering eighth grade at BCMS this fall too, portrayed Babette who is a maid and Lumiere's love interest who was turned into a feather duster. She similarly said she joined the production due to her personal love for theater, and Park Playhouse and the musical's company offering a welcoming environment to her.

She believed that the Park Playhouse program "is really good at teaching you how to become actors, singers and dancers, and they make it really fun to help you improve." She explained that while

# An update on BCSD's capital project

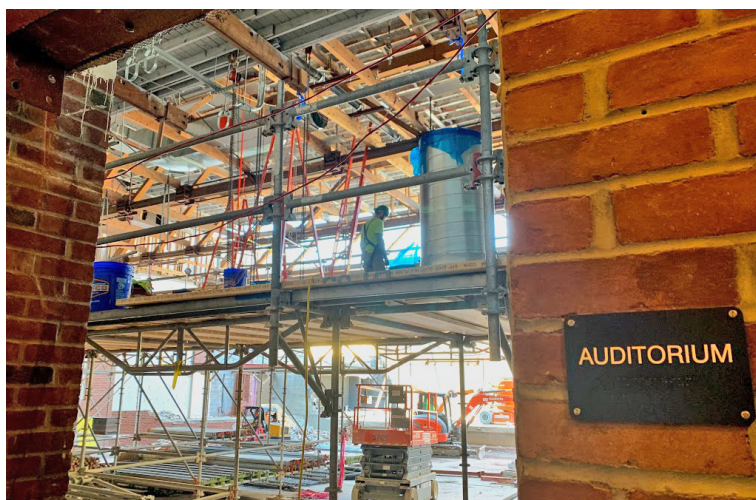
Renovation work began this spring and eyeing completion by fall 2020

**DELMAR** — The Bethlehem Central School District has been undergoing renovations and construction work since this spring as part of its \$32.2 million capital project that was approved by voters in 2016.

With an overall targeted completion by September or October 2020, the project would improve the district's schools in terms of security upgrades, electrical and plumbing work, renovating office spaces and certain classrooms, new drainage, more ADA-compliant restrooms, select windows improvement, adding parking spaces and more. The project's two main highlights are the renovation

of the current high school's auditorium and Library Media Center. The former is slated for completion in April 2020; the latter is slated to reopen as early as this November.

On Thursday, Aug. 1, Gregg Nolte, BCSD's director of facilities and operations, offered *Spotlight News* a private tour of the high school campus to showcase the work's progress

there. He said that work has been ongoing as well at the middle and elementary schools in the meantime.

The original high school auditorium, first constructed in 1952, looks unrecognizable now as a giant rectangular hole above has now allowed sunlight onto the former stage. The familiar interior seating and aisles have been overtaken by metallic bars

and construction equipment. The renovation, which began this April, is expected to renovate the seating and stage, expand the stage's proscenium, add air-conditioning, a new sound and lighting system, and take up parts of the outside lobby.

This would help enlarge the auditorium's space to better serve future elaborate productions, set designs and ensembles. Speaking of which, for the 2019-20 year, Nolte said that high school theater productions, depending on their size, would use the middle school's auditorium or The Egg in Albany while construction continues.

The high school's Library Media Center was closed just after Memorial Day. Originally birthed in 1967 and enlarged in 1996, it will be entirely renovated to have more teaching and study space, a welcoming central seating area, makerspaces and interactive classrooms, a new entrance to the Information Technology Helpdesk to better serve high student traffic than before, and wider windows to allow in more sunlight.

The LMC has been temporarily moved to room B122 where select book collections, shelves and computers are available in the meantime.

"Depending on the curriculum in the fall, we only moved the books and materials students are expected to need there," said Nolte. "The rest of the books and materials are in a temporary storage area. ... It took a lot of planning like knowing how many books we have, how many can fit on a shelf, how to organize them and it's a lot of moving parts."

Nolte added that the temporary LMC will be shut down once the official one is renovated and reopened, and it will turn into a conference meeting room. When asked if the temporary LMC may face potential overcrowding once the fall semester begins, he said this LMC is designed to have an open-flow feel and that students may hang at the cafeteria more or at designated hallway spaces if needed.

# Dutch season comes to an end

**COLONIE** — The Albany Dutchmen saw its season come to an end on Sunday, Aug. 5 after losing the first two of a three-game series against the Amsterdam Mohawks.

The Dutch got the East Division finals of the Perfect Game Collegiate Baseball League on Thursday, Aug. 1 by beating the Mohawk Valley Diamond Dawgs 9-5.

During that game, where the accompanying photos are from, the Dutch put together 15 hits at Siena College's Connors Park including a 3 for 4 performances by Chris Seng, of Louisville, and Justin Bench, of Ole Miss. Ryan McGee, of Siena, went 2 for 4 with two RBIs and Parker Noland, of Vanderbilt, went 2 for 3 with an RBI and a run scored and Ben Metzinger, of Louisville, went 2 for 4 with an RBI.

While the Dutch did commit five errors, the pitching only allowed four hits.

Ben Seiler, of Siena, started for Albany and gave up a run while walking two and striking out three through five innings of work. Aaron Dona, of St. Thomas Aquinas, threw the next two and gave up four runs on two hits while walking three and striking out two. Blake Bales, of Virginia, closed the game and struck out four of the six batters he faced in the last two frames.

The Dutch dropped game one of the East Division finals 8-4 in Amsterdam and then lost the second game at home 10-4.

In game one, Logan Savell, of Ole Miss, started and went three innings and gave up six hits and three runs while walking four and striking out two. Will Heslick, of Boston College, went the next four for Albany and gave up one run on two hits while walking three and striking out three. Three Amsterdam pitchers gave up four runs on seven hits while walking four and striking out 11.

Tommy Pellis, of Seton Hill, and Nick DeBrino, of Brockport, each went 2 for 4 with an RBI.

In game two, Blake Bales, of Virginia went the first four innings and gave up four runs on six hits while walking three and striking out three. Four relievers combined to give up six runs on four hits while walking four and striking out six.

Pellis went 2 for 4 with four RBIs while Seng and McGee each had a two-hit game.

Albany tied for second place with Mohawk Valley in the East Division four behind Amsterdam.

Amsterdam will play the winner of the West Division, either the Geneva Red Wings or the Adirondack Trailblazers for the PGCBL championship.

Ebersold was indoors with his wife, Debbie, and daughter, Ellissa, on Bridge Street when it happened. "It was almost simultaneous," he said. "We heard sirens not long after and we could see that Kenwood [Avenue] was blocked off." It made him realize that it was a much more serious situation than he initially thought.

That was because Ebersold's home was in fairly close proximity to another house on 632 Kenwood Ave. which was just struck by lightning.

Bethlehem Police Department Cmdr. Adam Hornick, who was among local law enforcement and emergency services to arrive on the scene, said there was a visible fire on the house's roof and upstairs bedrooms area. Besides BPD, the Slingerlands, Delmar, Elsmere, Selkirk and North Bethlehem Fire Departments, Delmar-Bethlehem EMS and Albany County Paramedics arrived within 10 minutes. BPD's own Cause and

Origin Team also worked to investigate the fire's cause and determined that the lightning did cause it.

The bedrooms received fire damage and there was a "huge hole" on the roof, Hornick said, and the house suffered additional water damage as it had seeped from the second to the first floor and the basement. "The water and smoke damage was pretty extensive," he said.

Hornick said the house's sole resident was a woman — he could not reveal her name and contact information though — who was seen standing outside her home as emergency vehicles arrived. The house was deemed unsafe for inhabitation and Hornick said the woman is now living with relatives in the meantime.

Chief Craig Sleurs of the Slingerlands Volunteer Fire Department said his team was the first one to arrive after receiving a call at 8:34 p.m.

minutes to an hour to totally extinguish the fire and get to all the hotspots. It was not as fast as we wanted as the building had different rooms and add-ons to the structure," he said. "We had to get through to the subceiling to get to the fire. Lightning had struck the roof but there was a fire on the back part of the structure."

Selkirk Fire Department Chief Joe Michinaw said, "When I got to the scene, the Delmar Fire Department had a couple

of ladders put up already to get to the flames on the roof." Sleurs said the Delmar firefighters cut ventilation holes in the roof to get better access to the fire.

While Michinaw said he was glad no one was seriously injured, one fire department officer was transported to the Albany Medical Center Hospital for heat exhaustion to be further evaluated. Sleurs confirmed that it was a female Selkirk firefighter and she has been treated and released since then.

Police interviewed nearby neighbors who confirmed that they also exited their own homes after hearing the loud thunder, to find smoke rising from the affected house's roof.

Hornick said that people's immediate cooperation and eyewitness reports helped speed up the fire departments' response to the situation. He also said that "the majority of Slingerlands lost power for a few minutes" and some houses experienced heat and water damage as a result of the incident.

Ebersold said he saw the hole on the house's roof, the

fire and smoke rising from the house; his family left their house to approach the scene within 15 minutes of hearing the fateful thunder and only once the lightning had partially subsided.

"There was hardly any rain when we walked over," he said, expressing surprise that his house did not experience a power outage. "As we were approaching, there was an ambulance but I didn't see anyone being taken away. The storm had been very severe but we dodged most of the rain."

According to preliminary data from the National Weather Service, the Albany area experienced an average temperature of 80 degrees that day and the wind was traveling westwards as high as 26 mph. The average recorded relative humidity that day was 66 percent and there was around 0.02 inches of precipitation. This data, however, are still subject to final quality control by the National Climatic Data Center and subject to revision.

Hornick said that no other houses were known to have been struck by lightning that night although several branches

across town were downed. These instances were "not extravagant" though and were removed by helpful citizens and the Highway Department, he added.

He also brought up that "a couple of houses in town have been struck by lightning in the last couple of years." Examples included two Glenmont homes in 2015 and one along New Scotland Road in May 2017. While each house suffered different levels of damage, which required different repair timeframes, Hornick recalled that the latter house took almost two years for its residents to return to live in it.

Neither he nor Sleurs know how long repairs may take for the 632 Kenwood Ave. home though.

Ebersold said, "Obviously, I was glad the lightning didn't hit my house but when you hear and see the lightning and thunder that close, it really could have hit your tree or house. It was pretty near me and it was loud. ... I feel bad for the people living in the house, although I don't know them."

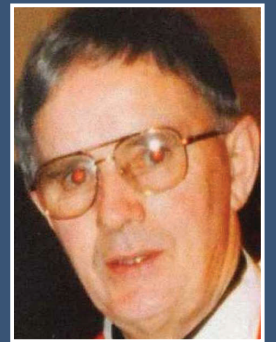

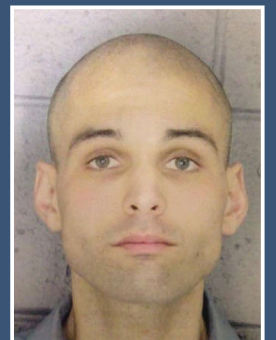

Elsewhere, the high school's kitchen, which closed in June and is expected to reopen in October or November, would elevate its ceiling height, see new lighting and have a separate office from the kitchen prep area. Its freezer and cooler have been removed since renovation work began.

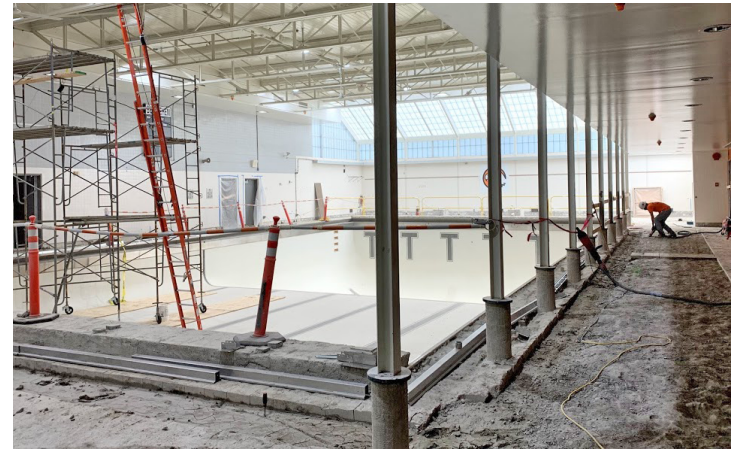
"We've since done a lot with temporary serving lines, we've adjusted our offerings of food," said Nolte on the kitchen and cafeteria's progress. "Part of the cafeteria is now a storage area and we also had to completely move out the custodial department for now. We also took a faculty break room and turned it into a temporary prep room. We did all this in house."

Also, the swimming pool area will have tile and equipment upgrades, a refinished steel structure and witness the replacement of its old pipes and starting blocks. However, Nolte said that its original target completion date has been pushed back

due to unforeseen circumstances.

"We first wanted to get it done by August 15 or 19 when sports starts but we realized we had to basically put in a whole new pool drain and that's delayed us," he said. "So now we're probably looking towards the second week of September. The students will be training and practicing at the [Elm Avenue Park] town pool until then."

Overall, Nolte believed that the project's work was forecasted to try to limit affecting the students' learning environment as much as possible, like by going full speed with construction during the summer. Acknowledging that construction work still would continue past the summer, he said, "We're constantly meeting with the impacted groups and users, and asking, 'When would be best to do this?' Every week, we're always looking at our schedule and adjusting. The pool has been the biggest setback

but we're getting through it."

Saying that the renovation works at the LMC, auditorium and kitchen will be mostly distanced from the general student population during class time, he said, "At that point, there's not going to be jackhammers and stuff like that. We're going to be beyond that."

When asked why the capital project is important right now, Nolte explained that it is essential to do improvements or repairs well before something that is left unchecked causes damage in the future.

"What's real nice about this project was that it's not just about boring maintenance items although we do always keep on top of that," he concluded. "We've done some educational components to bring us to different levels of technology like in the LMC and to include more different types of learning environments. We also have a great music and theater program and this project is going to elevate that tremendously. This is going to give a lot of tools for teachers and students and we're really excited about that."

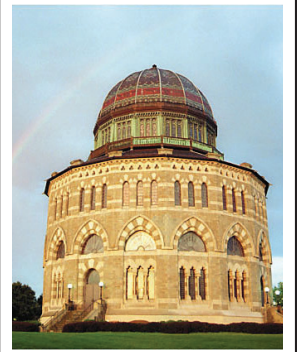

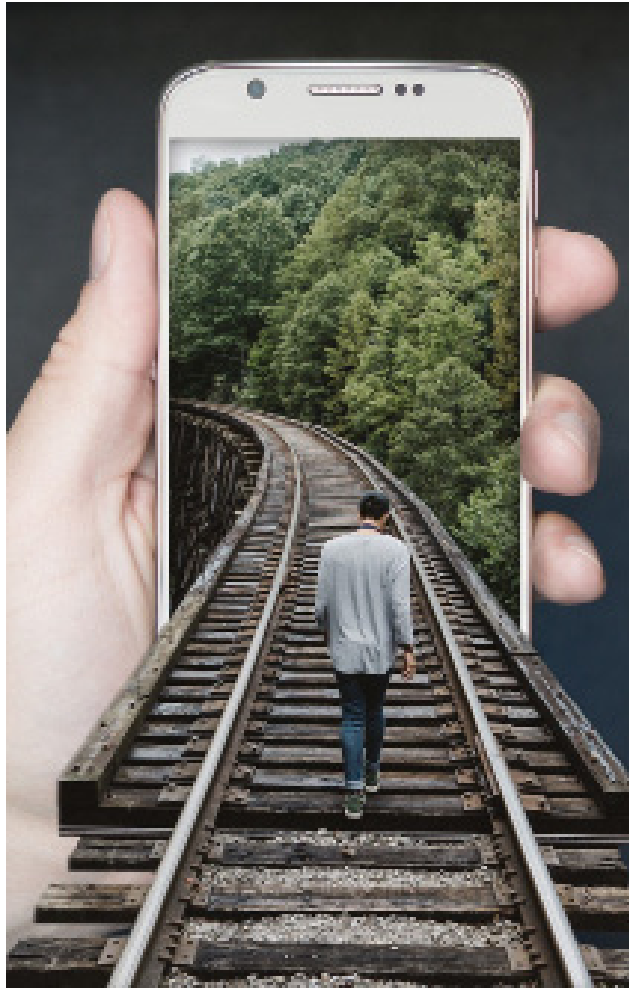

# Tethered to the net



The number of Americans who have an almost constant connection to the internet is increasing

**T**echnology has increasingly engulfed the way people live, work and play in recent decades. The rise of smartphones, social media and apps have further revolutionized how to handle technology for everyday use. While it may all seem convenient, it does bring up the question of whether there comes a point where using too much technology is personally detrimental.

A Pew Research Center study, its results released on Thursday, July 25, found 28 percent of American adults, an increase from 21 percent in 2015, reported going online “almost constantly.” This nationwide survey had attracted 1,502 American adult respondents and was conducted from January 8 to February 7 earlier this year. It also found that 45 percent of the participants reported going online “several times a day” and 9 percent reported doing so “about once a day” — this showed that 81 percent overall said they go online daily. The remaining participants either reported only being online “several times a week,” “less often” or “never.”

Furthermore, it found that 86 percent of participants use a smartphone, tablet or another mobile device type to access the internet occasionally. 92 percent reported using such devices to go online daily. The study implied that

Simple ways to help kids lose weight

Childhood obesity is a global health issue. In fact, childhood obesity is so prevalent that the World Health Organization identifies it as one of the most serious public health challenges of the 21st century. As daunting a task as tackling childhood obesity may seem, it's a problem that can be solved.

The WHO notes that, in 2016, an estimated 41 million children across the globe were overweight. That's a troubling statistic, as overweight and obese children are likely to remain so into adulthood, increasing their risk for various diseases, including diabetes and cardiovascular disease.

servings per day. Water is a healthy alternative to soda and juice, and parents can slowly transition their youngsters away from sugary beverages by diluting the beverages with water and only allowing kids to have them on special occasions.

### Switch things up

Many children eat daily snacks, and that's perfectly normal. Youngsters are growing and, as a result, tend to get hungry between meals. What parents serve at snack time can have positive or negative effects on youngsters' weights. The American Academy of Pediatrics recommends parents use snack time as a way to increase kids' intake of fruits and vegetables. Fruits and vegetables are nutrient-dense, and the WHO says increasing fruit and vegetable intake is a great way to fight childhood obesity.

### Go play tag

Focus on more than the dinner table. Getting overweight and obese kids to eat healthy diets is just one aspect of helping them lose weight. Routine physical activity is another essential part of a successful weight loss plan. The WHO recommends that children get at least 60 minutes of moderate- to vigorous-intensity physical activity every day. Parents can promote a physically active lifestyle and limit the time kids spend on devices or playing video games by only allowing access to such distractions after kids have been physically active.

Overweight and obese children may need help and some extra encouragement as they try to lose weight.

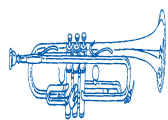

people with mobile devices were “especially likely to be online a lot.”

Younger adults, aged 19 through 29, appeared to be the most visible group in terms of going online, with 48 percent reporting they are online almost constantly. This paled from seniors, aged 65 and above, where only 7 percent of them reported going online almost constantly.

While the study did not comment on whether people going online so much was personally detrimental or not, the reader may start brainstorming questions like whether such heavy screen time is healthy, interferes with one's everyday life, affects one's working and sleeping habits, and so on.

The following are some tips to address that concern, particularly for users of Apple products like the iPhone which perhaps is the most popular electronic device worldwide.

### Limiting your time

In the case of smartphones, you should be able to keep track of how long you use your device or certain apps within it. For example, in the iPhone specifically, you can go to your “Settings” and head down to the “Battery” option. From there, you can toggle between “Show Activity” or “Show Battery Usage” option where you can see exactly how much time you spend on your most-used apps to give you an idea of your usage.

Similarly, many social media apps let you check how long you take using them and also, a setting where you can set a time limit on your app usage. For example, in

the Instagram app, go to your “Settings” on your profile, tap “Account” and then “Your Activity.” Here, it presents a bar chart detailing the amount of time you spend using Instagram daily. Furthermore, it has a “Set Daily Reminder” option where you can set a daily time limit — it can be for 30 minutes, a couple of hours or even half a day. Once you reach that time limit, you will receive a gentle notification to inform you.

### Limiting notifications

Typically, when you set up notifications on your electronic device, the point is to be instantly alerted if a new email, message, calendar event, alarm or social media



update comes your way. Naturally, you would want to pick up your device and immediately check on the notification.

However, while this may keep you updated and connected, it may also cause you to unnecessarily pick up your device all the time. The iPhone has a setting for “Notifications” where you can select the notification type you desire for each app you have. It also lets you choose to not allow notifications for any app; this helps to determine which certain important apps you only wish to receive notifications for.

Another way to possibly remedy this in the iPhone again is regarding a setting called “Screen Time” which breaks down how many notifications you receive throughout the day and how many times you physically pick up your device daily.

The setting also lets you designate “Downtime” where you can schedule a

time daily where certain apps, notification types and calls will be allowed. Similarly, it also enables you to set “App Limits” where you can manage how long you can spend on apps, which have been automatically organized into categories like Social Networking, Games, Entertainment, Productivity, Education and Health.

### Get out there

While technology provides for a great way to entertain and to get work done, it's not the only way. Learn to schedule enough time for other non-technology-related activities to get your eyeballs off a screen.

Instead of online shopping, visit a physical store or a mall where you're able to try out clothes and window shop.

Instead of using a Kindle or any e-reader device, pick up a book, comic, magazine or newspaper. Instead of playing video games, engage in an outdoor activity, board games or simply take a walk. Instead of scrolling through social media, plan to meet with your friends and engage in a physical social life beyond your screen. Instead of checking or typing too many emails, write in a journal or notebook.

The list can be endless as places like museums, cafes, farmer's markets, libraries and more seldom require the use of technology on your part.

The above tips and examples ironically show how technology has infiltrated virtually every aspect of everyday life but they demonstrate that there are ways to still keep technology at arm's length.

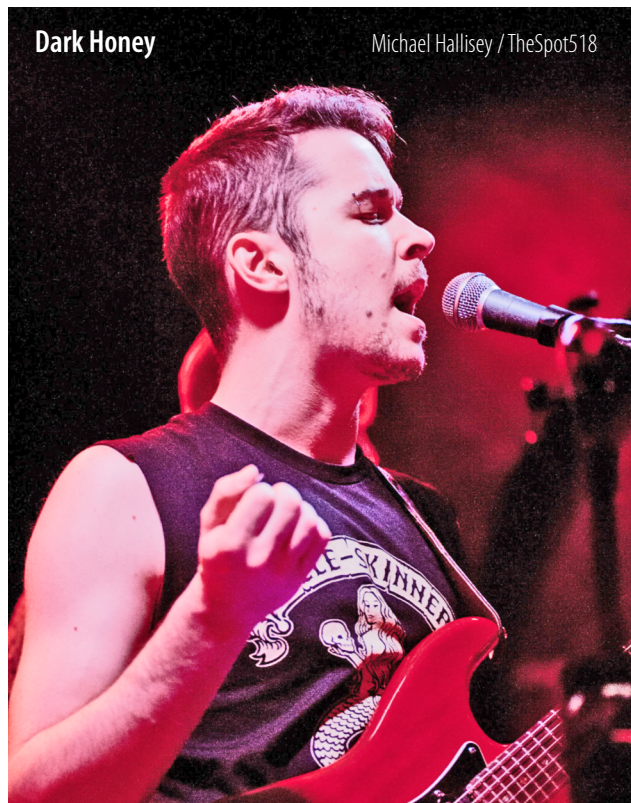
