Crossgates fight

GUILDERLAND

— Two police officers were assaulted and two underage males were arrested after a fight broke out at Crossgates Mall on Saturday, August 10 at 10:48 p.m.

Around 400 to 500 people were attending a "Get Air Trampoline Park" event at the third-floor trampoline park when a fight broke out among several females inside the venue, leading two Guilderland Police Department officers to attempt to stop it.

According to a Guilderland PD press release, as they tried to break it up, "a large crowd gathered around them and became unruly." The officers were then assaulted by multiple individuals and suffered minor injuries.

A teen-posted Facebook video seemed to show when officers believed the assault happened, showing an officer removing a girl off another girl who then hit the floor. A teenage boy

then engaged the officers and got pushed against a vending machine, with one officer falling down.

The Albany, Bethlehem, Colonie, Troy, Green Island, Watervliet and Cohoes Police Departments, SUNY Albany Police; the state Environmental Conservation Police and State Police; and the Albany County, Saratoga County and Schenectady County Sheriff's Departments arrived on the scene to assist.

The aforementioned arrested men, whose names were not disclosed, were charged with assault, resisting arrest and criminal trespass.

They have since been released to their parents and were referred to probation.

The injured police officers refused medical attention.

Motorcycle crash

— Bethlehem police responded to a serious motorcycle crash at around 3:40 p.m. on Saturday, August 10 on State Route 32 and Meads Lane.

A 1996 Yamaha motorcycle, operated by Robert A. Bruno, 78, of Pittsfield, Massachussetts, was heading north on State Route 32 when a vehicle ahead was about to make a turn onto Meads Lane. He lost control as he neared the vehicle's rear and fell off.

A third vehicle behind swerved to avoid Bruno but it went off the road and into a nearby embankment. Bruno, the only injured person, was transported to the Albany Medical Center by Delmar-Bethlehem EMS and Albany County Paramedics.

No charges were filed so far and the crash's investigation continues.

Proposed bill concerning straws

Asking for straws and plastic forks

ALBANY — Under a proposal by the county Legislature, if you want a straw or a plastic fork, you would have to ask for it.

Under the bill, all "Albany County restaurants, including fast food restaurants, beverage providers, or vendors shall offer plastic cutlery and straws, upon request."

It does not, however, prohibit any establishment from offering up nonplastic alternatives such as 'those made from paper, grain stalks, sugar cane or bamboo."

Municipalities and businesses across the country are banning plastic straws because of the negative impact they have when improperly discarded

into the environment. In January, California became the first state to ban them and businesses like Starbucks and McDonalds have announced plans to phase them out. Having consumers ask for a straw is a step towards a complete ban and is meant to limit the number of straws, and plastic, that is discarded.

"Littered plastic products, including straws and plastic cutlery have caused and continue to cause significant environmental harm and have burdened local governments with significant environmental cleanup costs," according to the legislation that has eight sponsors. "Plastic synthesized from petroleum and natural gas do not biodegrade. Even with the emergence of bioplastics, which are derived from renewable biomass sources, such as plants and microorganisms, there is no



certified type of bioplastic that biodegrades in the marine environment."

According to one estimate by the National Oceanic and Atmospheric Administration, a branch of the U.S. Department of Commerce, eight million metric ton of plastic enter the ocean each year, or the weight of 90 aircraft carriers.

What is becoming a greater concern to scientists studying the impacts of plastic, which takes decades or even centuries to biodegrade, is what they

have coined microplastic, what the larger pieces of plastic are reduced to after being exposed to ocean water, sunlight, wind and

A brief history of the straw, according to National Geographic:

People have used straws for centuries. The Sumerians, one of the first societies known to brew beer, "submerged long thin tubes made from precocious metals into large jars to reach the liquid sitting below the fermentation byproducts."

The first plastic straw was invented by John Wesley Hyatt and was made from a material that 'imitated animal products like ivory," according to National Geographic.

After World War II, straws were among the many throw-away products being rapidly manufactured by large corporations. New takes on the plastic straw, like jumbo straws and crazy straws, were produced in the 1980s.

According to National Geographic, Plastics Europe, one of the world's largest plastic producers, reports that 1.5 million tons of plastic were produced in 1950, but by 2015, the world was producing 322 million ton of plastic.

Because of the inarguable negative impacts plastic has on the oceans, and the increasing media attention it has gotten, there is a cottage industry of reusable straws, that

can come with kits that include tools and products to clean the straws after each use. They are made from materials like stainless steel, natural wheat stems or silicone and can come in a collapsible design and can be adorned with cool graphics or designs.

The bill, first introduced in May, was slated to get forwarded to a Sept. 24 public hearing at the Legislature's meeting on Monday, Aug. 12.

As it is written, which could change up to 72 hours prior to the public hearing, the county executive will determine which county department is in charge of "implementation, compliance and adherence to this local law."

First time offenders will receive a written reprimand, the second time will earn a \$100 fine which will increase to \$250 for a third violation.

A new reval

Looking into property value in Guilderland

The town underwent a comprehensive revaluation this past year and found that the value of properties is \$4.8 billion.

Guilderland's Assessor Karen VanWagenen said 2005 was the last time a town wide revaluation was done where all town properties were assessed at 100 percent of their market value; she confirmed there are 12,808 properties in Guilderland today. This year's revaluation was done because "the state was lowering our equalization rate dramatically" from 88 to 76 percent, she said, which affected property owners' taxes who live in non-Guilderland school district areas like neighboring Voorheesville and North Colonie.

In the past year,

VanWagenen said the town "did a mass appraisal, took an inventory and sent letters out to all our residents to check if our inventory was correct. Basically we compared every single house in town and came up with a property value for everybody." Such letters were sent out in February, she said, and assessment grievances were looked into and considered on May 28 and 29.

She confirmed that her office received 893 assessment grievances but she acknowledged that since the 2005 town wide revaluation, numerous new property owners have moved into the town and were not used to the revaluation process. "So it can be startling for some people to get a letter saying their value goes up a lot," she said. "They automatically assume their taxes go up but that's not necessarily true. To them, it can be a new learning experience. Others also

disagree with the value for lots of different reasons."

It is not clear yet exactly how many of the assessment grievances came from homeowners or as how many assessments were reduced as a result of grievances. Van Wagenen said, though, that most of the grievances concerned single-family homes and commercial properties. While Crossgates Mall and Stuyvesant Plaza did not file, most of the town's smaller neighborhood malls

"It was a lot of work and there's a lot of paperwork that still needs to be taken care of but everyone has been very polite in this process even though there were people who were stunned to see their value numbers," she concluded. An update on flavored tobacco products ban

Original ban opposed by convenience store, vape shop owners

ALBANY — The county Legislature has modified the controversial ban on flavored tobacco products to exempt flavored pipe tobacco, flavored cigars that cost more than \$10 each and tobacco used on-site at existing hookah lounges.

Still included in the ban are menthol cigarettes and all e-cigarette liquid that has any flavor other than tobacco.

The Legislature is expected to call for a public hearing on the modified law on Monday. Aug. 12. If approved, the public hearing will be on Sept. 24.

The ban, first introduced in March, has met considerable opposition from convenience store owners and the owners of what is known as "vape shops," those who sell e-cigarette liquid and the devices used to turn the liquid into vapor.

It was slated for a vote of the full Legislature last month but was pulled at the last minute.

Albany County already prohibits anyone under the age of 21 from entering a store that sells flavored tobacco products for e-cigarettes, and that prohibition makes it impractical for most convenient stores to sell e-liquid or other flavored tobacco products.

Banning all sales of menthol cigarettes, though, is what riled the New York Association of Convenience Stores. That organization represents come 1,600 stores across the state and, in an advertising blitz, said it's not just about the pack of cigarettes but also about all the other products a person purchases during a single stop. The ban in Albany County, it said, would just force customers to shop at stores in adjacent counties and not do anything to meet the bill's objective.

The 16 sponsors of the bill claim flavored tobacco products are what initially draws people, at once initiated, it doesn't take long for a person to become addicted to nicotine.

"As tobacco companies well know, menthol, in particular, cools and numbs the throat to reduce throat irritation and make the smoke feel smoother, making menthol cigarettes an appealing option for youth who are initiating tobacco use," according to the legislation.

The legislation also points out the attraction of, and dangers inherent to, the use of flavored e-cigarettes by today's youth.

"The 2018 National Youth Tobacco Survey cites research showing that youth and young adults identify flavors as a primary reason for e-cigarette use," according to the legislation. "Given the highly addictive nature of nicotine, it is not surprising that high school students who were current flavored e-cigarette users reported an increase in their frequency of

According to the legislation, some 85 percent of black smokers

use menthol cigarettes and the number of high school students vaping has increased from 12 percent in 2017 to 21 percent in

"There is a terrible youth vaping crisis but this proposed banning of all flavored tobacco, E-liquids and menthol cigarettes in Albany county impacts all adults and is not focused on those who are under 21 and vaping,' said Legislator Paul Burgdorf, R-Colonie. "It bans the sale of legal products in Albany County to those of any age, and would cost Albany County millions of sales tax dollars. There are adults who vape who are using it as a substitute for smoking carcinogen laden cigarettes; taking their preferred anti-smoking substitute away is like taking methadone away from a heroin addict. New York state just banned all cigarette, E liquid and tobacco sales to those under 21. Any restrictions should be considered on a statewide basis, and not just effect Albany County residents, small businesses, and taxpayers. We need a statewide solution to youth vaping which actually

reduces under age demand."

Reputable vape store owners say the majority of their customers are adults who use a form of e-cigarettes to wean themselves off highly addictive cigarettes. The legislation would still require retailers to purchase a license to sell tobacco in Albany County.

Legislator Mark Grimm, R-Guilderland, also against it, said the Legislature will likely vote on Monday to bring this version of the bill to a public hearing but that the language may change before the actual public hearing in September. A flaw in the process that is, he said, "unfair to legislators, the public and the media."

"Everyone is for protecting children but nobody is out there giving this stuff to kids. We were ahead of the state on banning cigarettes until 21 and there are enough regulations already in place," he said. "This would prohibit all adults from purchasing any flavored tobacco and that's why there is so much opposition to it."

Still a mixed bag

Updates regarding disposable bags

ALBANY — The money the county
Legislature is proposing to charge for disposable bags will be split between the state and the county
Comptroller's Office, and that is not sitting well with at least one legislator.

The county was poised to ban plastic bags, but they are now banned from any retail establishment across the state as of March 2020. Instead, a consumer in Albany County must pay a nickel for every recyclable paper bag used to carry merchandise out of a store.

Initially, the retailer, who has to purchase the bags, would keep the nickel. But, according to the legislation, which was amended after the state banned plastic bags, 3



cents will go to the state Environmental Protection Fund and 2 cents will go to the county Comptroller "for the purpose of establishing programs to purchase reusable bags provided to customers for their direct use."

"What I really don't like is that 3 cents is going to the state. The store owners have to pay for the bags so it's just another mandate," said Legislator Mark Grimm, R-Guilderland.

"And why is 2 cents going to the comptroller. It's our job to spend county money, not the comptroller's."

There are some who are exempted from paying the fee, according to the legislation: people using supplemental nutritional assistance and those using special supplemental nutrition programs for women, infants

In addition to purchasing paper bags, under the proposed legislation, retailers are required to notify with signage they are charging the fee, prohibited from extending credit to consumers to pay for the bags and are encouraged to adopt "leave-a-bag, take-a-bag" initiatives.

or children.

The county executive will determine which

department will implement and enforce the policy, should it pass the full Legislature.

Penalties for a first offense would entail a written warning to a retailer. A second offense would earn a \$100 fine, a third offense would cost \$250 and a fourth offense would carry a \$500 fine. For each subsequent violation, the retailer would be fined \$100 a day until compliance. Persistent violators could be closed down by the county.

The bill, first introduced in May, is on the Legislature's Monday, Aug. 12 agenda to get forwarded to a Sept. 24 public hearing. It is not clear as of this writing whether or not the Legislature will act on the local law at that time. If approved, it would go into effect on March 1, 2020.

Gas prices slightly fall



ALBANY — The average price for a gallon of regular dipped by 1.5 cents in the Capital District last week, according to a daily survey of 546 gas stations.

The \$2.71 per gallon is 3.2 cents lower than a month ago and 16.3 cents per gallon lower than a year ago.

Nationally, the price of gasoline fell 6.8 cents per gallon in the last week to an average of \$2.63 cents. That is down 15.9 cents from a month ago and 21.7 cents lower than a year ago.

"The national average price of gasoline has now fallen to the lowest level of the summer, but even better, the lowest since March as gas stations pass along the recent drop in oil prices brought on by the U.S./China trade rift," said Patrick DeHaan, head of petroleum analysis at GasBuddy. "However, the drops in gas prices could slow in the weeks ahead as some OPEC members talk about cutting oil production to stem the recent drop in oil prices."

Over the past decade the average price for a gallon of gas hit a high of \$3.82 in 2011 and a low of \$2.15 in 2016.

Setting a new stage for the law

Eyeing staged motor vehicle collisions

NEW YORK — Gov. Andrew Cuomo signed a bill into law on Thursday, Aug. 8 that criminalizes staged motor vehicle collisions for the intent of insurance fraud.

The legislation establishes a Class E felony for such an incident as well as a Class D felony for when a person commits the same crime and causes serious physical injury to another person.

"In New York, we have zero tolerance for insurance fraud, and anyone who puts others in physical danger to further their scheme should be punished accordingly," Cuomo said. "By signing this legislation into law, we are holding reckless individuals accountable by strengthening penalties for motor vehicle insurance fraud and taking a significant step to make our roads safer for every New Yorker."

This legislation, also known as Alice's Law, takes its name from wife and grandmother Alice Ross of Queens who died in 2003 after two men — cousins Ward Demoliere, 22, and Alex Carobert, 31 — randomly struck her vehicle to commit auto insurance fraud.

Ross was about to visit her daughter when it happened and the two men "planned to file insurance claims and receive settlement as a result of the crash."

"The signing of this legislation closes loopholes in the insurance law, adds higher penalties for those who stage auto accidents, and rightfully honors the memory of Alice Ross," said Assemblyman David I. Weprin. "I thank Gov. Andrew M. Cuomo for signing this important law and Sen. Anna M. Kaplan for carrying this bill the Senate."

"Many New Yorkers would be shocked to learn that there is no specific crime associated with staging a motor vehicle accident," said Sen. Anna Kaplan. "By finally criminalizing staged

have occurred in town although it's "not common."

He brought up that in most cases, a rental vehicle is used by a driver to collide with their own personal vehicle.

However, he acknowledged that insurance companies may sometimes find it cheaper to pay smaller claims, like \$3,000 or \$4,000, than to investigate if such claims are fraudulent.

This can make it difficult to determine exactly how many staged motor vehicle collisions

have happened in town, he said.

He expressed support for the legislation, saying, "Previously, you had to meet certain thresholds and dollar amounts in damage before you're able to get felony status and the felony depended on the dollar amount on the insurance claim. Now this law gives us a tool to use as creating automatic felonies for such crashes and it expands on previous legislation."

When asked how the police can determine if a motor vehicle collision was staged, Hornick said one way is to interview eyewitnesses of the crash.

"Maybe they saw that the driver was looking ahead but still hit the back of a car and also, we may prove that the affected drivers in a crash are related or know each other. You should keep in mind about the odds of them knowing each other and still crashing to each other," he said.

Walk this way

"The big issue about crosswalks in town is that we see a unilateral lack of knowledge about the law," said Hornick. "The goal is to educate people about the law and promote road safety. One example is to operate under the 'see and be seen' mindset where you're always looking out for other pedestrians, cyclists and drivers before crossing the road."

Other examples, according to the National Highway Traffic Safety Administration, include drivers slowing down and preparing to stop near a crosswalk as they should always expect pedestrians; drivers yielding to pedestrians in crosswalks and stopping before the actual crosswalk; drivers must not pass any stopped vehicle at a crosswalk due to potential crossing pedestrians; pedestrians need to look out for vehicles in all directions before crossing; pedestrians should continue watching out for traffic even while crossing; and pedestrians should seek a well-lit area

to best view vehicular traffic if a crosswalk is unavailable and wait for a sufficient time window before crossing safely.

Hornick said the BPD works closely with the town's Bicycle and Pedestrian Committee, made up of a group of volunteers, and police officers often attend the latter's monthly meetings. John "Tiger" Anastasi, the town's Highway Superintendent, said his department is starting to join the conversation and is invited to attend the meetings too. "We're looking into more direct communication in the next few months where I will get more involved because we want to make this community more connected," he said.

Anastasi also said that any new crosswalk idea needs to be brought before the town's Pedestrian and Safety Committee, which includes himself, Town Supervisor David VanLuven and Hornick. "We have a roundtable at the monthly meeting and we talk about potential traffic issues, residents' complaints, stop signs, people's want for more sidewalks and more," he said.

Hornick also said BPD took part this past June for two weeks in the state governor's safety council initiative called Pedestrian Safety Enforcement Mobilization for the second consecutive year to promote road safety with social media, the town's website and hand out pedestrianand driver-warning notices.

"During the two-week period, we found that just under one third of pedestrians were using the crosswalks in town inappropriately," he said. "The most common thing we saw is that they cross against the signal at a stoplight intersection. If an intersection is controlled by a traffic-controlled device like a crosswalk signal, it is a violation of vehicle traffic law for people to cross against that device."

He added that the most common location where this happened was at the Four Corners in Delmar where pedestrians were often seen pushing the crosswalk button but get impatient while waiting for the signal and they cross; if a vehicle strikes a crossing pedestrian in such an incident, the pedestrian is at fault, he said, as the vehicle

technically has the right of way in that moment.

He added that one day, he recalled being around the Four Corners and saw an adult male with two earbuds in crossing against the signal at the intersection. "The public should know that things like that is a recipe for disaster and you're not going to see or hear the car if you're listening with two earbuds and crossing when you're not supposed to then." Hornick also said that in terms of bicycleand pedestrian-related crashes with motor vehicles in Bethlehem, there were seven cases in 2018 and three so far this year. Concerning violations of crosswalks with motorists, BPD has issued five citations in 2018 and three this year so far.

Erin Svare, a mother of three children and a member of the town's aforementioned Bicycle and Pedestrian Committee, said she envisions Bethlehem to be a more walkable and bikeable community, and a place where pedestrians, cyclists and drivers practice road safety all the time. "It's not just about safety but it's also for health purposes where it's great to get out there and walk instead of staying inside all the time," she said.

Svare, also on the Hamagrael Elementary

School's Parent Teacher Association, said she has helped hand out "Roll Model Pledge" sheets for several years now to the school district's parents which encourages them to sign a pledge related to road safety. Examples include encouraging cyclists to always wear helmets; drivers to share the road with cyclists and yield to pedestrians at crosswalks and roundabouts; drivers to never use mobile devices while driving; pedestrians to always use sidewalks and crosswalks to travel safely; and drivers to maintain a three-foot clearance from cyclists and pedestrians on

"Hamagrael has so many kids walk and bike to school which is amazing but it's important to know about road safety," she said. "So the Roll Model Pledge is one way the town has collaborated with the schools and parents to spread awareness about what our roles as pedestrians, bicyclists and drivers are. We all have a responsibility and a road is something that's used by all users, not just drivers.'

the road.

She added that the BPD has ordered a new lawn sign design — a yellow, minimalist sign showing pedestrians using a crosswalk safely while a cyclist and a car waits; it also bears the words, "Bethlehem Walks and Rides... Please Look Out For Us! #BeCourteousBethlehem." The new lawn signs are available now for residents to pick up at Town Hall, located on 445 Delaware Ave. in Delmar.

One major event — a collaboration between the BPD, the Bicycle and Pedestrian Committee, and the Parks and Recreation Department — is the

annual Bethlehem Walk and Roll Fest in May; it was held on May 18 this year on 250 Delaware Ave. at the Albany County Helderberg Hudson Rail Trail parking lot.

Focusing mainly on bike safety, it was originally called "Bike Rodeo" which began around 20 years ago, according to Hornick, and it has manned stations to engage with bikers and the public alike. Such stations were mostly kid-friendly and touched on topics like avoiding obstacles, weaving around traffic cones and safe stopping distances.

"It's turned into the Walk and Roll Fest in the last two years and it's now a huge festival," he said. "This year, we received a microgrant from the Capital District Transportation Committee for the event. We received over \$1,300 in grant money. It helped us with publicity about the safety theme and we handed out backpacks with fluorescent stripes so cyclists wearing them can stand out in the road more."

Anastasi advised drivers to be aware that "we have a lot of elderly people in town. Just because there's a crosswalk, doesn't mean the pedestrian can nonchalantly travel on it without yielding to traffic. Sometimes, the road has ice or it's wet or has many fallen leaves which can make it harder for drivers to stop in time. Use good judgment."

Svare concluded that "seeing a shift in driving behavior will increase safety. Our hope is that by doing an awareness campaign, it will help people find the compassion they do have deep within so that when they see people at the crosswalk, they will slow down for them because I would want someone to do that for my kid."

Build it ... they will come

BETHLEHEM — Improvements to the athletic facilities at the high school are moving along and should be ready by the next time the respective teams take the field.

The old bleachers and press box were demolished to make way for seating that is compliant with the Disabilities Act. It will cost about \$1.2 million.

The baseball field, which was nearly underwater after even a sprinkle of rain, was bulldozed and the old, wooden dugouts were demolished. The new baseball field will cost about \$747,932.

There is a new ADA-compliant restroom building being constructed at a cost of \$380,000 and paving the access road will cost about \$189,750.

The swimming pool is also being redone with new tile and infrastructure improvements at a cost of \$645,427. The pool was supposed to be complete by the middle of this month when fall swimming starts but it was pushed back. The swim team will train at the Elm Avenue Park town poll until it is done sometime in early September.

The work is part of a \$27 million renovation project approved by voters in 2016 that includes work on every district school building.

Play like a girl

Albany hosts the first Aurora Games, an all-women's international competition, at the Times Union Center

ALBANY — Next week, world class athletes will shoot, jump, tumble and skate like girls in a first-of-its-kind event.

The Times Union Center is to host the inaugural Aurora Games, an international, worldclass, all-women's multisport competition and entertainment festival in downtown Albany from Tuesday Aug. 20 to Sunday, Aug. 25.

"This is an important cultural moment and we are excited to create an event that empowers female athletes and celebrates their unique contributions and accomplishments," said Jerry Solomon, creator and executive producer of the Aurora Games.

The six-day event will include team and individual competitions in basketball, tennis, figure skating, gymnastics, ice hockey and beach volleyball.

Designed to celebrate the best in women's sports, entertainment and culture, the Aurora Games will welcome all-star athletes, as well as coaches and trainers, representing more than 15 countries to downtown Albany to compete in an international competition of teams comprised of the Americas vs. the World.

"We did a lot of homework on a lot of different locations," said Solomon, who admitted that he did not initially see Albany as the first choice for the host city. "We had done some events here in the past. Have a good relationship with {TU Center General Manager] Bob Belber and

the people at the arena." When Solomon spoke with Belber about his idea for the games, he was encouraged to pay a visit.

"It was perfect," said Solomon. "The city, the state and the county have all jumped in and we think it was a great decision."

The high-profile advisory board for the Aurora Games includes such iconic athletes including nine-time Olympic medalist Nadia Comaneci, who was visiting the Capital District last October when Solomon announced that Albany would host the Aurora Games.

It's been more than 40 years since Comaneci flew into the imaginations of girls and young women when she earned the first Perfect 10 in Olympic competition during the 1976 Summer Games in Montreal.

Not first for just women, but in all competition.

"Usually your favorite event is the one you are best at," said Comaneci, standing in front of dozens of young gymnasts gathered at the World Class Gymnastics Academy in Latham. She had arrived after it was announced that Albany would be hosting a unique, all-women's international competition.

Children and parents sat doe-eyed as the Olympic champion spoke of her experience. Parents old enough to recall the awe in which the Comaneci name inspired with each Olympics, while images of 14-year-old Nadia still ran freshly through each kids minds. She was speaking their language.

"Gymnastics opened

the doors for me to travel and see places that I could never see as an 8-year-old," said Comaneci. "There were limited opportunities for us at the time, and gymnastics was the only thing I was thinking of at the time."

In the United States, Title IX legislation preventing gender discrimination in education, including scholastic sports, became law just a few years before Comaneci earned her first gold medal. Nonetheless, there would still be battles to create more opportunities for girls and women. For example, it wouldn't be until 1991 when the world competed in the first women's World Cup of soccer.

Shyann Bootnan, an 11-year-old gymnast at the academy demonstrated her skill on the uneven bars — the same event Comaneci earned her first Perfect 10. All eyes were on her, including Comaneci's, as she spun and flew before landing a flawless dismount, her face beaming with a smile as her feet planted firmly on the ground.

"I was so excited to meet her," said Bootnan, who also competes in vault, balance beam and floor. "I didn't know I was going to do [the demonstration] until I walked through the doors today. It was kinda, really nerve-racking."

Like many of the girls in the room, Bootnan started competing at a young age. Where Comaneci was 6, Bootnan was 4. Today, she's "always" competing. When asked which of her four events was her favorite, she said:

"My favorite event right now is all of them."



Delaware Ave. road diet is worth the inconvenience

As a Town of Bethlehem resident who lives in Delmar and works in town on Delaware Avenue, the road diet is especially important to me. With the negative press recently, I want to offer a different perspective. I fully support the Delaware Avenue road diet.

I look forward to bike lanes which allow me to ride safely to get groceries or a cone at Tastee Freeze. As a kid growing up in Delmar, I wanted to ride my bicycle to the Delaware Plaza, Del Lanes, and other local businesses. Usually I did not because riding on Delaware felt incredibly risky. Still as an adult I avoid riding on Delaware Avenue Aside from improving safety, bike lanes are an obvious choice to promote fitness, carbon-neutral commuting, and a greener community (which I strongly support).

I also support reducing the speed limit and lane count. Often, I get stuck driving behind cars going 30-35 mph in both lanes of Delaware. I can't pass and can't go 40 mph. The road diet might as well happen because a single-lane 35 mph Delaware Avenue is already the effective reality. Not only that, I strongly support any road changes that improve safety, even if that means extending commute times slightly. I want to get to my destination as fast as the next person, but my convenience isn't more important than the safety of those on the road around me.

As a community, I urge everyone to think of the road diet with an evidencebased approach. The idea of taking driving lanes away and reducing speed limits can be upsetting. After all, our brains are programmed with loss aversion: the tendency to prefer avoiding losses to acquiring equivalent gains. Let's overcome that gut reaction and look at the facts. Will the road diet improve safety, promote healthy carbon-neutral commuting, and retain customer traffic on Delaware Avenue? If so, that sounds like an overall gain. We trade a little commute time for all those benefits.

Deportations have been happening forever

After I graduated college, about 104 years ago, I made the best use of my degree by going to work for a construction company for a few years.

At the time, in about 1990, we were the general contractor working at the Extended Stay hotel, across Washington Avenue Extension from UAlbany, and everything was ticking along just fine until one day the equivalent of today's Immigration and Customs Enforcement, better known as ICE, showed up and arrested the entire sheetrock crew.

We really had no idea what was going on when about a dozen black vans pulled onto the site, but the crew of mostly Latino sheetrockers sure did because they scattered.

I saw one guy jump out a second story window. His feet hit the ground first but, thanks to a combination of momentum and gravity, his abdomen landed on a newly poured concrete curb. I really have no idea how bad he was hurt, but he didn't struggle when the feds put him in cuffs. A couple others had better luck and took off running. Not sure what happened to those guys.

Others just gave up and still others tried to hide. I distinctly remember one guy trying to conceal himself under a large box, that could fit a refrigerator, but his toes were sticking out of the bottom so that didn't work out too well.

In the end, the only person who was left sheetrocking

was the crew foreman, a white, middle aged guy, and safe to say he was not nearly as fast as the two dozen Latinos. Legal or illegal, those guys could sheetrock, and sheetrock in a hurry. I didn't get to know any of them, really, as they stuck to themselves but they seemed decent enough, and they were a hard working lot.

I don't know what happened to them. I would assume they were deported back to their country of origin, or maybe they first faced some sort of criminal charge for being in this country illegally with the punishment of being deported.

I honestly don't know, but I remember my boss at the time being very upset with the sheetrocking company for holding up the entire works while they found a new crew. I also don't know if that company faced any ramifications, criminal or civil, for hiring a bunch of illegals. Seems to me it should have.

The reason for his lookback is news of a huge raid by ICE on a Mississippi food processing plant that resulted in 680 arrests and the ongoing, very tiring, outrage at what some see as a recent enforcement of our borders — and the subsequent punishment of those who got here without following proper

It's been going on since we had borders.

And the entire Sanctuary City debate is even more tiring.

Take what transpired over the past few months in the City of Troy, for example.

The only voice of reason in that debacle was Mayor Patrick Madden, who quickly vetoed the inane vote by the Democratic majority on the City Council to make Troy a "Sanctuary City." As the mayor said, it carries no legal meaning and since laws, by definition, should have some legal precedent to back them up, it should not be on the books.

Being a sanctuary city doesn't mean anything to anyone except those who are in favor of it or those opposed. I bet it does make them feel better to voice their opinions. Yes, it may mean local police can't go out and arrest someone purely because they are an illegal immigrant but that's a policy decision, not a local law.

On the flip side, the Republicans tried to score political points too by saying they want to take the issue to a referendum. As the mayor said, it's not permissible under state law.

We don't live in a true democracy. If we did we'd be voting on every item on every agenda in every township in the country. We live in a democratic republic. That means everything is, or should be, voted upon, but we elect representatives, like town board members or city council members or state legislators, to cast a vote in our stead.

We can't have our representatives bringing every item that didn't go their way to the public with the hope of a better outcome.

Back to the issue at hand. People can scream about the number of deportations going up but that's only because of the number of

illegals are going up too. According to the Pew Research Center, from 1990 to 2007 the "unauthorized immigrant population more than tripled in size from 3.5 million to a record high of 12.2 million. By 2017, that number had declined by 1.7 million or 14 percent. There were 10.5 million unauthorized immigrants in the U.S. in 2017, accounting for 3.2 percent of the nation's population.

"The decline in the unauthorized immigrant population is due largely to a fall in the number from Mexico – the single largest group of unauthorized immigrants in the U.S. Between 2007 and 2017, this group decreased by 2 million."

And that's without a wall, which is a really stupid idea, by the way.

Illegal immigration has been an issue in this country for decades, and different presidents of different parties have not done anything of any real substance about it — including our current president and the last president too, who also used deportation as an enforcement tool.

Is there any other, really? Throw them in prison or send them back? To grant them citizenship for just walking across the border is not fair to the great majority of immigrants who did things the right way.

The useless, politically driven self-serving rhetoric on both sides of the issue does not help matters at all. All it does is throw gas on an already incendiary situation that has been simmering for

Poll: Cuomo is doing a good job but not likeable

ALBANY — New Yorkers think Gov. Andrew Cuomo has made the state a better place to live but his favorability ratings match the lowest in his nine-year tenure and his job performance rating is at an all-time low, according to a new poll by the Siena Research Institute.

"For the dog days of August, voters give Cuomo good news and some bad news. The good news: by a margin of 51-39 percent, they say he has made New York a better place to live in nine years as governor," said SRI pollster Steven Greenberg.

His favorability rating is a negative 43-50, down from 52-42 in June and his job performance rating stands at 34-64.

Meanwhile, Pres. Donald Trump's favorability rating, while still in the negative, has inched up over the last few months from 34-63 in June to 35-62 and his job performance rating went from 29-70 in June to 34-66.

"Trump continues to be viewed overwhelmingly negatively by his fellow New Yorkers – with the exception of Republicans, nearly three-quarters of whom continue to view him favorably and give him a positive job performance rating," Greenberg said.

Voters overwhelmingly support new laws to require vaccinations of children regardless of the parents' religious beliefs, according to the poll, institute a farmworkers' bill of rights, mandate zero carbon emissions in electricity by 2040, ban single-use plastic bags, and prohibit use of the gay and trans panic defense.

A majority, 53-43, opposes the law allowing undocumented immigrants to obtain a New York driver's license.

"Only Democrats support allowing undocumented immigrants to obtain a New York driver's license; it is opposed by independents and overwhelmingly opposed by Republicans," Greenberg said.

Other findings include:

- 53 percent think the U.S. is headed in the wrong direction
- 43 percent view the state Assembly favorable while 45 view the Senate favorably.
- 60 percent have no opinion of Comptroller Tom DiNapoli
- 53 percent view Sen. Chuck Schumer favorably while 41 percent view Sen. Kirsten Gillibrand favorably
- 32 percent say they would elect Trump to another term while 64 percent prefer someone else
- 65 percent favor banning single-use plastic bags

The poll was conducted July 28 through Aug. 1 by telephone calls to 810 registered voters. It carries a margin of error of +\-4.1 percent.




Attend

Manage hectic school mornings

f a typical school morning sees your family rushing around and out the door with nary a moment to spare, only to be left feeling like you ran a marathon by 9 am, a new approach to your routine might be necessary.

Mornings, especially in households in which parents who work outside of the home and have one or two kids requiring drop-off at their respective schools, can often be hectic. Starting off the morning feeling harried and stressed can carry over into the

mood of the day, affecting ready to go. productivity as a result.

According to Dr. David Anderson, PhD, senior director of the ADHD and Disruptive Behavior Disorders Center at the Child Mind Institute, busy mornings can be the most stressful moments of the day. Homework hour and getting prepared for bed are other typically stressful times of the day for families.

If less stressful mornings are a goal for your family, try these strategies.

Start the night before

Doing as much preparatory work the evening before can make quite a difference in taming hectic mornings. Things that can be done in advance include checking and stocking backpacks, signing paperwork, making lunches, setting out clothing, showering, and having breakfast foods

Establish a 'launch pad'

Ann Dolin, a Virginiabased education specialist, suggests having a launch pad, or a place where all schoolrelated items are prepped and stored. It can be a basket, box or another container big enough to contain school items. Children can drop and pick up the items as needed.

Routine is 'the boss'

Positive Parenting Solutions founder Amy McCready says families can implement a "whenthen" routine that sets the tone for the morning. "When everyone is dressed, hair combed, breakfast eaten, and school supplies packed, then you can watch 10 minutes of an educational cartoon." This puts the routine in control rather

than making the parents the bad guys.

Make kids responsible

Too often parents add more stress to their plates by showing up at school with forgotten lunch boxes or band instruments. Instead, parents can stop rescuing their children and help train them to be more responsible — an essential trait.

Chart wake-up times

It may seem like micromanaging, but scheduling wake-up and bathroom times can help everyone know where they should be and when they should be there. It also helps avoid bottleneck situations in the bathroom or kitchen.

Keep morning madness to a minimum with some simple strategies.

How to help kids Body talk make friends at school

he average student likely spends more time at school and participating in extracurricular activities with classmates than he or she does at home. In close proximity to so many peers, it may seem like making friends would be a snap. However, some students have trouble connecting and can use a little push to make friends.

The family and parenting resource Parenting Science notes that research indicates that the most popular children are those who exemplify certain traits. These traits include being caring; a willingness to share; a willingness to offer help; and strong verbal skills. Children who embrace these traits may prove better at making friends. Parents may find that youngsters need some encouragement to build their social circles, and the following are some ways parents can offer that encouragement.

Encourage

Encourage kids to seek out someone on their own. It may be challenging to walk up to a group and introduce yourself. Encourage students to seek out someone who is alone and then strike up a conversation, which can be less intimidating than approaching a group. Emphasize to kids that other students may also be a little shy and looking to make friends.

Ice breakers

Practice conversation starters at home. Children can work with their parents to come up with topics that can help foster communication. These can include ice breakers and common interests, such as favorite television shows or video

Teach kids approachable body language. Wearing earbuds or exhibiting negative body language, such as crossed arms or avoiding eye contact, can make a person seem less approachable. Smiling, engaging in conversation and being friendly can make it easier to make friends.

Ask for help

Ask teachers to help. The education resource Understood says teachers can give children responsibilities, such as the opportunity to hand out snacks or papers, which can build confidence and provide opportunities for kids

to converse with their peers.

Listen

Help children be active listeners. An active listener is someone who makes it clear that he or she is paying attention. Making eye contact, orienting the body toward the speaker and making relevant verbal responses are some active listening strategies that can help kids more fully engage with their peers. Feeling valued and listened to may encourage other children to be more friendly and engaging.

Open questions

Ask open questions. The social networking advisement site Young Scot suggests having

students ask open questions, such as: "How was your summer?" or "What sports do you like to play?" These types of questions can kick-start

Tips for finding an afterschool program

oday's children grow up differently than their parents did. Technology has changed the way students learn in the classroom, but perhaps the biggest difference between how today's kids grow up and how their parents were raised concerns the dynamic at home.

According to the Bureau of Labor Statistics, in 2018 both parents worked in 63 percent of households that were home to married-couple families with children. Many of those parents likely did not grow up in households in which both of their parents worked fulltime throughout their

childhoods, marking a significant difference in the dynamics of modern families compared to those of yesteryear.

Afterschool programs take on heightened importance when both parents work full-time, especially if neither parent works from home. Many schools and community organizations offer afterschool programs. While it's great to have options, too many options can make it daunting for parents to find the program for their children. The Afterschool Alliance (www.afterschoolalliance. org), which works to ensure all youth have access to affordable, quality afterschool programs, offers the following tips to parents as they look to find afterschool programs for their children.

• Contact educators at your child's school. Many schools have afterschool programs on school

premises. Speak with school administrators or teachers about school-sponsored afterschool programs. Even if a school does not have such a program, educators might be able to provide a list of nearby programs other students attend.

- Contact community organizations. The Afterschool Alliance notes that many community organizations, such as the YMCA, the Boys & Girls Clubs of America and the 4-H Council, may offer afterschool programs. Local churches, synagogues and mosques also may offer afterschool programs to local families, regardless of their religious affiliation. When speaking to community organizations, discuss how kids are typically transported from school to the program.
 - Speak with fellow

parents and neighbors. Your community is a great resource. Fellow parents and neighbors, even those whose kids may be in high school or even out of the house, may be able to recommend local programs. Reach out at school-sponsored events or via social media.

 Contact your local government. Local government offices and officials also can help parents find afterschool programs in their communities. Local Child Care Resource and Referral agencies (www. childcareaware.org) can be valuable assets for parents having trouble finding afterschool programs for their children.

Afterschool programs are invaluable to families in which both parents work. Finding the right program may involve a combination of strategies.

How to prevent busy kids from overextending themselves

oday's teenagers are busy. According to the American Time Use Survey from the Bureau of Labor Statistics, the average high school student spends just under an hour and a half each weekday participating in extracurricular activities that include playing sports, working/ volunteering and religious activities.

lots of encouragement to participate in their communities, teens can easily find themselves overextended. Extracurricular activities are important, and some have even been linked to improved academic performance. But it's equally important that high school students avoid burnout, which can adversely affect their academic performance and how much they enjoy school and other activities.

With so much do and

Parents can employ various strategies to help busy teenagers avoid overextending themselves.

• Learn the signs of burnout and look for them. Even the most overextended teenager probably enjoys many of the activities he or she engages in. So it's

unlikely that kids will self-report burnout to their parents, teachers, coaches, or other authority figures. Parents can learn to spot the signs of burnout to identify if their child is overextended. According to Understood.org, a website sponsored by 15 nonprofit organizations devoted to helping parents of kids between the ages of three and 20, procrastination, negative attitudes, testiness, difficulty concentrating, and a disinterest in things kids once liked are some potential indicators of burnout. Parents who notices any of these signs in their children might want to look at their kids' schedules to see if their children are simply taking on more than they can chew.

 Teach kids time management skills. Time management skills can help kids make effective and efficient use of their time. Encourage kids who are struggling with their schedules to use a calendar to plan their weeks. Knowing what's expected of them each day can help kids develop a plan to get everything done. In addition, when kids make a list of their daily activities, parents can go over that list with them to see if they're taking on too much. Discuss the calendar with kids, and if kids express feelings of exhaustion or burnout, go through the calendar to see where they can free up some time, even if it means

cutting some activities out of their schedules entirely.

• Teach kids the art of prioritizing. Parents know that some tasks are more important than others. But kids may not be so savvy. Teach kids how to prioritize, emphasizing that academics always come first. Give kids some credit if they're initially resistant to dropping some activities, as that can indicate an admirable willingness to commit. But emphasize that school comes first, and that activities that are low priority might need to be sacrificed during the school year. In addition, point out that certain activities that are not school-related can be revisited in the summer, when kids typically have less hectic schedules.

Burnout can be harmful to high school students. Parents can work with their children to ensure they aren't overextending themselves.

> A child with various interests can be a blessing and a curse. Burnout can be just as easy with him as it is with you.

Nutty chicken

s the seasons transition from summer to autumn, it is time to incorporate hardier recipes into the dinner repertoire. But just because something seems to be more filling doesn't mean it has to be high in calories or compromise light eating plans.

Cooks may be surprised to discover how much flavor is nestled within this 300-calorie "Spinach-Walnut Stuffed Chicken" dish from "Taste of Home: Healthy Cooking Cookbook" (RDA Enthusiast Brands) by the Taste of Home Editors. Spinach-Walnut Stuffed Chicken

Ingredients: Serves 4

1/2 cup finely chopped onion

2 garlic cloves, minced

21/2 teaspoons olive oil

1 10-ounce package frozen chopped spinach, thawed

and squeezed dry

1/4 cup crumbled Gorgonzola cheese

4 boneless skinless chicken breast halves, 6 ounces each

1/4 teaspoon salt

1/4 teaspoon pepper

1 egg white

1/4 cup ground walnuts

Instructions:

In a small skillet, saute the onion, mushrooms, celery and garlic in oil until tender. Stir in spinach and cheese; remove from the heat.

Cut a lengthwise slit through the thickest part of each chicken breast; fill with spinach mixture. Sprinkle with salt and pepper. Place egg white and walnuts in separate shallow bowls. Dip one side of chicken in egg white, then in walnuts



Summer hair, no fair

Prevent and repair seasonal hair damage

ummer is a great time to get outdoors, but summer sun can be hard on hair. Days spent diving through the waves at the beach, submerged in the backyard swimming pool or lying out in the hot sun can be particularly damaging to tresses.

As summer draws to a close, men and women find that their hair needs a boost to repair the damage that has accumulated over the last few months. It is important to note that hair that is split or broken has experienced permanent damage and cannot be repaired entirely. There are products that can help smooth hair or make it appear thicker, but such products will not repair the hair shaft. The only option in such instances is to cut hair shorter (if possible) and wait for new, healthy hair to grow in, according to the experts at Good Housekeeping's Beauty Lab.

A proactive approach to preventing hair damage all year long is a great way to avoid summer sun from wreaking havoc on hair. Here are some steps to take.

- Speak with a stylist. Make an appointment with your stylist to discuss your hair quality and what can be done. He or she likely knows of products or techniques that can mitigate any existing damage and what may prevent future issues. Seek out expert advice if damage may have been the result of do-it-yourself chemical treatments.
- Lay off of heat and chemicals. Let hair recover by skipping chemical treatments like coloring, perms, straightening, and other services for the time being. Limit

coloring to simply touching up roots, if possible. Similarly, let hair air dry whenever you can, and keep heat-based styling tool use to a minimum.

- Remove green hues. Metals present in swimming pool chemicals can leach into porous hair shafts and lead to a green tint that becomes more noticeable over time. The experts at Livestrong.com say to use a special swimmer's shampoo that contains chelating ingredients that break down and remove metals from your hair.

Repairing hair and preventing future damage can take some effort, but it's worth it for beautiful tresses.

Flach and his bandmates, who include keyboardist and violinist Danny Boudreau, drummer Rob Piccola, bassist Chris Brant and lead guitarist John Lenio (who joined the band in the last few months) are set to release 10 new songs later this month. The album, Perfect Stranger, is said to be more positive, more at peace and quite frankly, "more mature." Set to release Aug. 16, Perfect Stranger will kick off with a show at Lost & Found Albany the next

"With this album, we approached things much differently," Flach said. "When we recorded American Romance, we all recorded our parts separately and didn't hear it all together until it was fully mixed. We actively worked as a whole this time around."

Boudreau concurred with Flach's statement. Boudreau, who has only been playing the violin for a few years, was concerned about his parts in American Romance. This is his first time participating in a band, let alone one that's successful.

"I didn't understand how I was going to write my parts because I had no idea what everyone else was doing," he said. "Luckily, once it came together, it all worked. It was amazing."

Flach, Brant and Boudreau were the original trio, with some help from Flach's brother. After recruiting Matthew Copperwheat and Piccola, the band came into its own.

"I'm no longer handling a lot of production tasks, which gives me more time to write and work on music," Flach said. "Andrew and Rose are amazing at not only keeping us on track, but they are getting us gigs and marketing us in

a way we never could have imagined."

Andrew and Rose Gabriel are the owners and managers at the band's record label, Ambassador Music Group. The Gabriels pride themselves in handling all the business and marketing for their clients so everyone can focus on what they do best.

"Andrew is really good at keeping us going with deadlines and making sure we fulfill whatever responsibilities we have," Flach said. Brant added his managers are really good at keeping the group organized. All band members said Rose Gabriel is absolutely amazing with her marketing and social media management, garnering the band significant recognition.

"Between the two of them, we've been able to keep it moving along and stay focused," Brant continued. "It's been a great fit for us and I hope for them too."

The Management

Andrew and Rose Gabriel said their business is in "permanent beta" mode. What does that mean? It's pretty simple; they keep seeing what works for each client and then adjust the business accordingly.

The Gabriel force, who are also partners in life, has made quite a name for itself in the local community. They've worked with many of the acts in the Capital District music scene — including Grape Juice, Sydney Worthley through doing business directly or featuring bands on their hit live social



"During this album cycle, we did just that. We were pretty hands-off with the artistic direction of the album. We heard a few demos early on and knew that [C.K. and The Rising Tide] had something special in the works, so we got out of the way and did what we do best: take care of business.'

It's definitely a lot of work. The hardest part of managing groups like C.K. is no rest.

"It's been a whirlwind to watch them grow like this," Kielbasa said. "It's very hard to put all of these emotions into words because I've watched them blossom into what they are now.'



The Buzzards are Circlin' 'round

Drummer Piccola, who was recruited from Craigslist, said it didn't take him too long to learn his parts on American Romance. Taking over for Flach, who provided drums on the first album, has been exciting.

"Honestly, I think Curtis might be a bit better of a drummer than I am," he said. "But we all have a corner of the group that works best for us." Piccola added he's excited about the release because, like his bandmates, he wants to see how people connect with the music.

A chance to connect came on July 26, when the quintuple-threat released its first single from Perfect Stranger on YouTube, a hauntingly beautiful song called "Follow The Buzzards."The MP3 track was released several days later. Boudreau explained how "Buzzards" is only a glimpse of what's to come.

"I feel like Perfect Stranger is much more excited about the prospects of the future, while American Romance talked

about things long gone and bitter loss," Boudreau said. "One lyric that really stands out to me is 'Follow the sweet, sweet sound / leave it all in the cold, cold ground' because it's kind of a way to break with the past of hurt and move into happier times."



Shiragirl's 'Andi Underground'

'Andi Underground' is the anthem of a rebellion story

hiragirl's Andi Underground is a unique blend of old school punk rock and modern pop. This album described as a dystopian punk rock musical was co-written with Tim Armstrong of Rancid, and mixed by Cameron Webb (Motorhead and Kelly Clarkson).

The title and concept of the album are inspired by the infamous tale of Alice in Wonderland, where a girl is wanting to escape a society headed for digital chaos to an underground free world. Andi decides to break away from the dystopia and runs

away, and this is the soundtrack to her journey.

The album begins with the track "Controlled" where Andi is describing the controlling lifestyle she's experiencing. It's a single file march to brainwashing, where if you step out of line, you might end up dead. This track is the start of Andi going against the grain with the aggressive lyrics "We don't wanna be controlled" and breaking away from the conformity. This tune sets the reckless attitude for the rest of the album.

Another track that stands out is the third track of the album and hit single "Nothin To Lose." The song premiered on July 2, with deep roots and influence of old school punk rock, the hard-hitting track is the anthem of this rebellious story. The lyrics represent Andi running away and falling down a hole into an

underground co-existing world, and feeling like she has "Nothin to Lose," by following her intuition and venturing into this new unfamiliar world. The electrifying guitar solo in the middle of the song gives the imagery of breaking through metaphorical barriers, and a sense of rebellion from the world she escaped. The EP tells a story that's well thought out by Shiragirl and her manager, with the tracks cohesively placed to give the story order.

Shiragirl has made a name for herself in the music industry and proved to be more than a Warped Tour icon with this album. The group sky-rocketed their career when Shira and her band crashed Warped tour in her iconic pink RV and set up a stage on top the RV. The unknown band at the time rocked out and after receiving a rousing crowd response, Warped Tour founder Kevin

Lyman invited Shira to return the following summer to host the official Shiragirl Stage. The stage was shared by female artists from all over the nation and ultimately helped accomplish Shira's mission to empower women by providing a platform for creative expression. The stage went on to host over 200 femalefronted bands, some of them making their Warped debuts including Paramore's firstever tour, and the legendary Joan Jett.

Not only is Shiragirl a staple of the East Coast punk rock scene, but she's also a symbol of female empowerment in the music industry. It's no question why Shiragirl is considered a Warped Tour veteran. This album successfully serves as a rebellious anthem to break away from the norms in society and create your path. Expect to see Shiragirl grabbing the punk rock scene by the horns.



MUSIC REVIEW

Vaporeyes' 'Self Titled Album'

Syracuse jam band serving listeners with lush lyrics

ust try not to dance when listening to this album and your body might just spontaneously combust. Groovy, tight, spacious, perpetual - all things that describe the Vaporeyes' third crack at a full-length jam/progressive rock album. The group first joined forces in Syracuse in 2010 and has evolved into a well oiled, dance inducing machine, consisting of Jonas Niccolson on keys and vocals, Shannon Zory on bass, Sean Cadley on drums and Pat Tierney on guitar.

This time around, they've brought in

a much fuller, spacier sound that is sure to set any dance floor ablaze. Vaporeyes said it themselves ,they are going to, "... breakout onto the jam scene," according to its press release. Which they have done. They also say they "have put a lot of work and thought into creating an immersive and unique sound and live show."

Every track on here is exactly what listeners would expect out of a modern jam album. Catchy hooks, floor-on-thefloor drums, spacey guitar and elaborate solos. But the thing that really separates them from other groups is its vocalist, Niccolson. His sultry pipes are a perfect fit for this new direction. It's something that seems to escape the scope of a jam bands formula. But arguably, vocals are not the cornerstone of what makes a good jam band - hooks, builds and drops do.

Let's look at "Quip Stash." It checks all the instrumental boxes. We're thrown right into it with a quirky hook featuring a very prominent, an obese synth working in junction with stupendous guitar tone, that soon explodes into a wide open space for everyone to toy around with. But we're left in a trance and feel nothing special until Niccolson sneaks in with some lyrics that wrap through the air, breathing new life into a well executed jam song. It's very well done but it's not ground-breaking as the band suggests. We see a lot of similarities in "Phantom Pains" as well. Everything is tasty, groovy and catchy but the groups attitude can easily be lumped into most aspiring jam bands.

"Stay" releases a new variety of tones and genres, mainly consisting of blues and rock, laced with psychedelia. It's a crisp

jam with fun hooks and grooves. Once again, we get another taste of lush lyricism from Niccolson which adds unique flavor to the song, but it drops off again after the groups starts to solo. We don't see much a build and it doesn't leave much to the imagination in terms of what they might be like live. But, like most jam bands, they feed off the energy from a live setting which fuels creativity and the 'in the moment jams' they speak of in its press

It is not easy to be different in a music scene that is so saturated with talent. If you like the formula, hooks, upbeat riffs and extensive, experimental solos, than you should check out the album and go see them in a live setting. They are seasoned musicians with tons of experience that will make for a great show.







