County EMS going full-time

ALBANY COUNTY — The county's emergency medical services will be moving to full-time staff, which has been met with mixed reception from paying towns.

First announced in a Sept. 9 meeting with Albany County Sheriff Craig Apple, his colleague Brian Wood said it is impractical to tax all municipalities within the county since only a number of them make use of county EMS.

Hence, it was suggested that a district within the county would need to be designated in order for that district to be properly taxed for county EMS — this may take several years to accomplish by the state Legislature.

County EMS currently serves Voorheesville, New

Scotland, Coeymans, Ravena, Bethlehem, Westerlo, Berne and Rensselaerville.

The announcement was noted for happening in a time now where volunteer service departments are finding it more challenging to attract, train and maintain a satisfactory number of volunteers to carry out services.

Wood also addressed that current part-time service workers either cannot always fill every needed shift or are working overtime, hence turning it over to more full-time workers is a strategic move for the future.

EMS work was also noted for being both physically and psychologically demanding.

Grand larceny

DELMAR — A 20-year-old Albany woman was arrested and charged with two felonies on Monday, Sept. 9 at 12:30 p.m.

Let's chalk it up to art

Public invited to design chalk squares on the Rail Trail

BETHLEHEM — The second annual Chalk the Walk event will happen on Saturday, Sept. 21, hoping to marry a community event with visual art, fundraising and family-friendly entertainment.

To take place from 3 to 6 p.m., it will be on the Albany County Rail Trail, near Stewart's on 309 Delaware Ave. People can buy a 3-by-3-foot chalk square which they can design as they choose as part of a chalk art contest where the community can vote on which are the winning three designs – winners will be awarded special prizes in the end.

While the event wants to raise funds to maintain murals along the Albany County Rail Trail, it mainly wants to bring people out for a fun day with art, food, live music and smiles.

Art on the Rail Trail

in advance and can be done online at www.mohawkhudson.org/chalk-the-walk-tickets; it is \$15 on the day itself.

The event will be accompanied by food vendors including Market Pops, Field Notes and Emack and Bolio's. Live

music will be provided by regional talents like Hot Tuesday, a jazzy-upbeat band; Malvina, a local high school student and guitarist; and Capital Harmony, an a cappella group consisting of regional high school students.

There will be an artist fair where people can peruse through local artists' works including paintings, handmade quilts, flower arrangements and jewelry.

Chalk the Walk is an effort by Art on the Rail Trail (ART), a committee under the Mohawk Hudson Land Conservancy. It aims to raise funds to maintain the artistic murals throughout the Rail Trail and its co-organizer, Karen Shaw said, "We want to raise awareness and get people onto the Rail Trail and also bring in local businesses. The Rail Trail is not just a linear pathway for exercise but a place for gathering and a

community."

Shaw, who is also Bethlehem's open space coordinator, added that the entire Rail Trail will not be closed for this event and it would instead take place on just one side of the trail so other people can continue walking or cycling without interruption.

Caroline Barrett, an ART member, said, "We wanted to have something fun and involve the community. What we do is for and part of the community, and we want to bring people out and make art together."

She added that last year, 60 people registered to make chalk art, meaning that 60 chalk squares were purchased. It raised around \$600.

Both Shaw and Barrett said there is not really a set goal amount of money this year's event hopes to raise as they believe the main purpose is to bring people

in to join the fun.

While the former recalled that some of the memorable designed chalk squares last year had positive messages about nature and Bethlehem being a great town, the latter said she particularly loved one that had a portrait of famous Mexican painter Frida Kahlo, one that featured a loving father-daughter relationship, and one that showed a gay pride flag.

Although it was Shaw's idea to have a town chalk art contest in 2017 which came to fruition in 2018, Barrett said she and her husband, also an ART member, were originally inspired by numerous murals they came across when visiting colleges in Philadelphia with their daughter a few years prior. Her husband, Barrett said, then envisioned having murals throughout

Using a history of trains to look ahead

Local teen brings new train-viewing platform to life

VOORHEESVILLE — Local train enthusiasts have a reason to rejoice.

A new train-viewing platform is being erected across from the Albany County Rail Trail Pavilion on 8 Grove St. in Voorheesville, which allows people to enjoy the sight of passing trains under a designated roof. The platform, however, is not complete yet as it still needs a handicap-accessible ramp and a little barrier — possibly shrubbery or landscaping — which would deter people crossing that barrier and accidentally get too close to the tracks or passing trains.

The mastermind behind this project, 18-year-old

Voorheesville resident Michael Strauss, said it will likely be complete within the next two weeks. Construction had initially begun in late June but its conception has been on Strauss' mind for over two

years now.

Strauss, a senior at Clayton A. Bouton High School, is a boy scout at the village's Troop 73 who has been eager to receive the highly-coveted Eagle Scout

rank for years, which will become a reality later this fall. Since first joining at 12, he said he has enjoyed learning multiple life skills like becoming a leader and being self-sufficient, and he envisioned the train-

viewing platform as his project to help attain the aforementioned rank.

"I've learned what it is to be an Eagle Scout and what the project represents. It's about being a leader and leading a group of people to accomplish something," Strauss said, connecting this project's idea with how he himself is a train enthusiast.

"Voorheesville is a train village and a big reason is that Voorheesville became a place for people to live in since it was originally a vacation spot for people from the city of Albany and even maybe New York City. People would come down for the day and that's how Voorheesville was built up," he added. He said his project's site location is significant for being where the original train tracks were built in the village.

He perceived his project as an artistic and functional homage to Voorheesville's

history with trains as well as to complement fellow train enthusiasts. He had first pitched his ideas to the village two years ago as well as to Albany County officials, since the property is technically county property, he said. He received major support from them and then learned to get a building permit.

According to him, the overall project cost a hair over \$10,000 -- \$5,000 was donated by the Voorheesville Community and School Foundation and \$4,000 was donated by CSX Transportation, the freight railroad company that owns the tracks near the platform. The rest of the money stemmed from generous donations from throughout the village, including its volunteer fire department.

"Doing this project was a combination of sheer will to do something great for my community and I really appreciate the generous support, time, energy and encouragement from the people around me," Strauss said.

When asked what type of help he received to erect the platform, Strauss credited several local contractors who helped him realize and finalize the project's design; his fellow Troop 73 members for helping around the site; the Delmar-based Curtis Lumber for providing some essential materials; and the village's Public Works Department for helping him move soil and lay the platform's foundation.

These collaborations helped ease some of Strauss' main challenges with the project — how he initially did not know much about physically building a platform as well as the lengthy process of getting a public building project application reviewed and approved by the village and county. Regarding the latter point, he said he had to finish most of the project before he turned 18.

Strauss said he also learned how challenging it can be to organize and manage a volunteer

New urgent care gets accredited

The first accredited urgent care center in the Capital District

GUILDERLAND — A new Guilderland urgent care center has received a highly-coveted accreditation through the Urgent Care Association.

Located on 2080 Western Avenue in Hamilton Square, it originally opened in April and is independently owned by Jonathan S. Halpert who expressed both excitement and gratitude for the distinction — the Accreditation-Comprehensive Scope.

It has become the first urgent care organization in the Capital District to receive this, according to Halpert.

“I’m really happy and we’re all really proud

because we had to get through a lot of hurdles since opening,” he said. “We’re a small organization and we’re thrilled.”

Priority 1 Urgent Care provides patients access to digital X-Ray, EKG, IV Fluids and medications, as well as on-site and reference laboratory testing.

It also participates with numerous locally-accepted health insurance plans like CDPHP, MVP and Medicare; patients can walk in for unscheduled appointments and receive extensive medical attention too.

The process of receiving the accreditation was not always smooth though.

“We had chosen to undergo a high level of scrutiny by the accrediting body where they came in and evaluated all aspects of the business like our clinical professional services, and having great equipment and licensed specialists on

hand,” Halpert said. “There are standards that must be met and prescribe to the accrediting body. It’s a really deep dive into quality, business practices and care, and it supposedly allows to give a potential customer a higher level of assurance of what they expect here.”

Halpert has been involved in urgent care, health policy and administration for around a dozen years now, including having held positions at St. Peter’s Health Partners, St. Peter’s Hospital and the North East Regional Urgent Care Association.

He has also long been aware of the importance and benefit of being accredited.


“I knew that it’s good to get some distinctions under our belt if possible,” he said. “Sometimes people use those distinctions to make decisions about coming to us.”

He also felt grateful

for his fellow colleagues and perceived the work as “very much a team sport and it’s impossible to run it by yourself. Urgent care is a 24-hours, seven-days a week proposition, and we’re open most holidays so we have lots of people power to drive it forward. From nurse practitioners and medical assistants to registered nurses, for example.”

Looking ahead, Halpert exuded optimism and concluded, “By virtue of being accredited, I’d like the public to be aware that not only do we feel we’re an excellent resource for their medical needs, but the accrediting organization also agrees with that. Hopefully, that gives the public a measure of confidence to choose us moving forward.”

Credit card smarts: Tips for picking the right card and leveraging credit

When it comes to the benefit of credit cards, people have two stances. Either they are good, because they empower people to build credit and provide needed power, or they are bad, because they encourage people to overspend and fall into debt. The truth is, credit cards can be both good and bad—depending on the borrower.

The good: credit cards make it easy to purchase things, and they help borrowers establish good credit by demonstrating that they have the ability and character to repay debt obligations in a timely manner. Building a strong credit history can lead to obtaining other forms of credit, such as car loans and mortgages, with more ease and better terms.

The not so good: according to the Federal Reserve's G.19 report on consumer credit, total U.S. outstanding revolving debt, which is chiefly made up of credit card balances, was \$1.07

trillion as of June 2019, with the average card-carrying adult holding \$5,839 in debt.

However, credit cards don't have to be such a double-edged sword. In fact, with a little effort you can secure a credit card with great terms that suits

your needs and spending profile, which will help you reduce fees and maximize rewards.

Getting started

Every time you apply for credit, it gets reported with the credit bureaus and lowers your credit score. So do your homework ahead of time. Compare and contrast offers, but first, consider which type of credit card best fits your needs.

• **Revolving.** This is the traditional credit card, which allows you to make purchases and pay all or part of the outstanding balance on a defined schedule. Once all or a portion of the borrowed balance is paid, that amount becomes available again as credit.

• **Charge.** This card is similar to a revolving credit card in that you can make purchases and take out cash advances. The difference is that you cannot carry

a monthly balance. The benefit of a charge card is that you will not accrue interest on your debt.

• **Secured.** This card requires collateral for approval. Your borrowing limit is determined by the amount of deposit you make to secure the card. It is good option for those with little or no credit history.

• **Rewards.** Reward cards work the same as traditional credit cards but offer rewards, cash back and/or flyer miles in return for your spending.

• **Student.** Designed for students enrolled in an accredited four-year college or university, student cards are great for establishing a positive credit history.

Once you determine the best cards for your needs, begin comparing offers from a variety of financial institutions. For example, check interest rates. Different issuers of national bank cards such as VISA, MasterCard and Discover usually charge different interest rates.

You should also review and compare the following:

• **Annual fees.** Many of today's cards do not charge an annual fee. However, don't automatically remove cards with annual fees from consideration. They may have additional perks and benefits that will help you save money and stretch out the value of your dollar.

• **Introductory offers.** Some issuers offer 0 percent Introductory APR credit cards for the first 12 to 18 billing cycles for purchases and balance transfers. Make sure to read the fine print, because some cards may charge a two to four percent balance transfer fee. Other cards may jump to a high interest rate when the introductory period expires.

• **Rewards.** Whether it is miles, points, cash back or rewards, review how they accrue. Is the offer valid only during specific time frames? Are there limits on the amount for purchases you can claim with these offers? Some cards may offer

promotions for spending a specific amount of money over a set amount of time in order to receive the extra cash back bonus or rewards. Know the details.

• **Features.** Account alerts, FICO® credit score tracking, no penalty APR, travel insurance and fraud detection are some additional features that can increase the value of the credit card. Don't overlook these benefits when comparing offers.

Spend smart

Credit is only good if you allow it to work for you—not against you. And rewards and financial incentives can be great ways to earn extra cash and ben-

efits on regular purchases, such as groceries, bills and gas. But make sure you never borrow more than you can afford to repay and always try to repay your balances in full every month. If you can't repay your full balance, at least pay more than the minimum balance due. This will ensure that you begin building the credit history you need to secure the best rates and terms for future large purchases, like a home or car.

Understanding credit card terms

If you are considering applying for either your first card or a new card, it is helpful to know the terms issuers use in describing credit card features and options.

Annual percentage rate (APR) – This is the annual interest rate that the credit card issuer charges on the unpaid balance of the credit card. Some credit cards have set rates. For cards with variable rates the interest rate changes. The disclosure statement for each credit card gives the guidelines used to decide what the variable interest rates will be. If a credit card offer has a too-good-to-believe low rate, it is likely an introductory rate. After the introductory period is over, the rate will increase. A low rate could be as low as 0 percent while 28 percent would be high.

Grace period – This is the amount of time you have to pay your bill before interest is charged on your purchases. Most credit cards offer 20 to 25 day grace periods. Even though credit cards have grace periods, most charge interest from the day you make a purchase if you already have a balance on the credit card.

Annual fee – This is the charge you pay once a year for the right to use a credit card. Not all credit cards have annual fees.

Minimum finance charge (minimum payment due) – This is the least amount you

will have to pay if you have a balance on a credit card usually. The minimum finance charge is generally between two percent to four percent of the balance.

Transaction fees – These are the various fees you have to pay for cash advances, late payments, or charging over your credit limit.

Cash advance – This service allows cardholders to withdraw cash, either through an ATM or over the counter at a bank or store, up to a certain limit. Check the credit card for a cash advance limit, they are often lower than the credit limit. Also, there is often a fee of three to five percent of the amount being borrowed and the interest rate is generally higher than other credit card transactions. The interest compounds daily starting from the day cash is borrowed.

Balance Transfer – This is the process of moving credit card debt from one credit card to another. Card issuers will often offer lower initial rates to encourage balance transfers coming in and balance-transfer fees to discourage them from going out. If you're making a balance transfer, be sure you know exactly when the introductory rate expires.

Periodic rate – This is the APR divided by 12.

group – mainly Voorheesville residents, including contractors, volunteering to help around the site – due to their conflicting schedules but their generosity and expertise in building structures helped.

Despite the train-viewing platform remaining unfinished, Strauss' parents, Judy and Bryan, as well as several notable local figures like Albany County Executive Daniel P. McCoy and state Assemblywoman Patricia Fahy spoke at a press conference atop the structure on Wednesday, Sept. 11 to recognize Strauss' work.

McCoy said he decided to hold on the anniversary of 9/11 to also remember those who perished in the attacks as well as how Sept. 11 was designated by former President Barack Obama as Patriot Day.

Also acknowledging how train enthusiasts are connected with Voorheesville's long history with trains, McCoy said, "For [Michael Strauss] to look at this site and say, 'Hey, you know what? People come here, take pictures, and watch trains go by,' says a lot about you. And to earn your Eagle badge also says a lot and it's an honor to really thank you for everything."

He then looked over at Strauss' parents, also standing atop the structure with them, to thank them "for raising such an extraordinary gentleman and sharing him with us here in the county."

Fahy similarly echoed McCoy's words and said, "This is about building a community and strengthening our community. ... This is a wonderful way to have done this on 9/11 because you [Michael] are part of our future and it's somebody like you who gives us hope that we do have future leaders, that we have students

From page 1 ... Better to be safe than sorry

The breached data affected students' names, birth dates and email addresses as Bethlehem Central was among 13,000 other districts across several states that were also hit.

AIMSweb – a student assessment tool under Pearson Education, Inc. that BC had used up to June 2017 – had originally been breached in November 2018. Pearson discovered this in March 2019 before beginning to inform affected districts in July. Pearson finally informed BC within the past three weeks.

The number of hackers, their identities and motives remain unknown in the meantime. However, several cybersecurity experts and organizations throughout the Capital District offered their perspectives on the matter.

"It's not always a case where hackers are looking for money from an individual or institution," wrote Joshua S. Koons, the director of New Business Development at the Saratoga Springs-based Tech II Business Services, Inc. in an email. "In many cases, [they] are looking for that information to sell off in bulk to others. From there, it could just be used for marketing purposes but could potentially be more severe, depending on the detail of the information."

Victoria Kisekka, an assistant professor in information security and digital forensics at the University at Albany's School of Business, said, "The importance of cybersecurity isn't new but the reason is more important lately because cybercrime threatens nearly every aspect of our lives since almost every aspect of our lives is electronic. Essentially, you need to protect your information and devices from theft, misuse, damage and service disruption."

She said that if people are not too careful with their personal information online, they may be more vulnerable to being a victim of tax fraud, identity theft, having fraudulent bank accounts opened by a hacker and more.

The East Greenbush-based Center for Internet Security (CIS) provided a webpage called "Online Safety and Cybersecurity Tips for K-12 Kids, Family and Friends" earlier this month where it gave examples of cybersecurity risks for children and families like cyberbullying, identity theft or phishing, sexting and shady interactions on social media platforms.

It also encouraged parents to start discussing the importance of cybersecurity with their

children at an early age, as soon as children begin having access to a computing or electronic device. Parents should also be aware of what their children are doing online, especially when they are much younger, and to foster an honest and welcoming environment where children can feel comfortable coming to their parents with questions about their online experience.

"In every environment, the end user is always going to be the biggest vulnerability," Koons similarly echoed the above sentiment. "Education on even the smallest scale should start the first time a

child is allowed to turn on a device."

Both Koons and Kisekka agreed that people should embrace multi-authentication, where an organization would need more than one way to authenticate you before using its services. It would ask you to verify your email address and phone number, for example, as opposed to just needing one password.

While multi-authentication or two-step authentication is not always required, it provides an extra layer of security for the user. Major companies like Bank of America, Google and Microsoft are among those encouraging their users to use two-step authentication.

Kisekka offered several more tips like clearing out

one's browser and closing out of every session when using the internet or an online service; regular credit monitoring to see if someone else has opened an account without your knowledge; not auto-saving your passwords as someone may easily access every account and not need a password; keep up with software updates for your electronic devices; and use just one credit card for online purchases.

"A debit card is directly connected to your bank account and you're giving someone else direct access to your money more easily. It may take the bank some time to recognize fraudulent activity and then you'd need to provide proof," she said. "So, try not to use a debit card there. Also, with a credit card,

if Chase gets hacked, for example, and your card is Chase, then that's just one card you'll worry about."

Koons wrote that cybersecurity should not concern just schools and households but also businesses and municipalities, and that his company uses tools to monitor and fight against potential breaches every day.

Kisekka said, however, that cybersecurity threats are increasing in recent years and it's becoming more challenging to identify hackers due to technology remaining ever-evolving which makes it easier for hackers to launch new attacks.

Hence, as CIS stated, teaching cybersecurity to children at a young age can be very beneficial for them in the long run as they themselves learn to recognize potential cybersecurity risks and ways to avoid them.

Kisekka concluded that as more digital breaches occur and are reported in the news, she said she believes that there is an increased interest in recent years among people to study and pursue a career that is related to cybersecurity. "Every company has to worry about cybersecurity nowadays," she said. "Like how every company needs an HR and IT department, it's now very important to have a cybersecurity department too."







The local businessman has his fingerprints left throughout the Capital District's Tri-City area. In the Collar City, he converted a long-abandoned building into the Troy Innovation Garage, the home of Aurelius Coworks. He founded Bull Moose Club, a second coworks office space in downtown Albany. And in Schenectady, his public relations firm, Gramercy, was paramount behind Schenectady's effort to land Rivers Casino and Resort.

Aurelius Coworks recently announced its "The Future of Small Cities" initiative, a series of roundtable discussions paired with masterclasses designed to bring

nationally-recognized experts to the Capital District to explore topics such as urban waterfronts, climate change, design, public art, gentrification and community.

Nardacci said he had an atypical childhood while growing up in his grandparents' Rensselaer corner store on Broadway. He lived in a blue-collar neighborhood in a city whose economic health disproportionately depended upon the old BASF plant which shutdown in 2000. Conversations on local politics were abundant, which would lead to his later run as City Council President.

A short time after launching the Troy

It's one building that means something special to the block." That stabilizer lies the foundation for a larger community, something Nardacci said is what real estate investors are looking to establish. "People are coming here to do commerce, do trade, but also to be a part of something."

Throughout the series, which is currently scheduled to run through April, guest lecturers from Pittsburgh, Washington D.C., Bogotá, Raleigh and Chattanooga will present case studies relevant to issues of importance to the Capital District.





Are you a Goofy Goober?

'The SpongeBob Musical techs at Proctors before launch of nation tour, opens Sunday

Since it first aired in 1999, *SpongeBob SquarePants* has influenced the television habits and tastes in the humor of a generation or two of children and parents alike. So, naturally, a musical would follow.

Broadway actor Beau Bradshaw is of that generation or two mentioned above. The recent college graduate landed the role of Patrick Star, *SpongeBob's* loveable, if not dim-witted, partner in crime.

A quick glance at Bradshaw's headshot, with bright eyes and a broad, gaping smile, looks like

Patrick Star.

He darn well could be Patrick Star. Please forgive my vocabulary enhancer.

The complete cast is set for the upcoming national tour of "The *SpongeBob Musical*," which launches after a string of tech performances at Proctors from Sunday, Sept. 22 to Saturday, Sept. 28.

The musical is set in the fictional community of Bikini Bottom, an underwater township inhabited by various sea creatures, and a squirrel. If that last bit threw you off, you're a *SpongeBob* novice. I suggested pulling up a few episodes online. If you can suspend reality enough to accept talking ocean life, you'll push your boundaries wondering how they grill Krabby Patties in the water.



Weather during the months of September and October can be fickle. As a result, there may be some steamy days left even after summer is long gone. On such days, a light and refreshing meal can be ideal.

Salad may be thought of as side dish or an appetizer. But in this recipe for “Chicken and Spinach Salad With Avocado and Fruit” from Rose Murray’s “125 Best Chicken Recipes” (Robert Rose), salad is the main course. This salad bursts with flavorful fruits and vegetables that are full of antioxidants. While it stands on its own, the salad can be accompanied by crusty bread and corn on the cob and rounded out with brownies for dessert.

Chicken and Spinach Salad with Avocado and Fruit

Ingredients: Serves 4

Sweet-and-Sour Dressing

- 1/4 cup granulated sugar
- 3 tablespoons white wine vinegar
- 1 teaspoon grated onion
- 1/2 teaspoon paprika
- 1/2 teaspoon dry mustard
- 1/4 teaspoon salt
- 1/3 cup vegetable oil
- 8 ounces skinless, boneless chicken breasts
- 1 half cantaloupe or other melon, or 2 oranges, peeled and divided into segments
- 8 ounces spinach, trimmed, washed, dried, and torn into bite-sized pieces
- 1 avocado, peeled and thinly sliced

Salt and pepper

1. Sweet-and-Sour Dressing: In a small saucepan over medium heat, combine sugar and vinegar; cook stirring, for 2 minutes, or until the sugar dissolves. Cool. Stir in onion, paprika, mustard, and salt. Transfer mixture to a blender; with motor running, add oil in a slow stream through the feed tube.

2. Meanwhile, put chicken in a saucepan with 1/4 inch water and bring to a boil. Reduce heat to medium-low; cover and simmer, turning once, for 5 minutes, or until just cooked through. Remove chicken, cool and cut crosswise into 1/4-inch slices.

3. Scoop out melon with melon baller or cut into cubes. In a large salad bowl, toss spinach, chicken, avocado, melon, dressing, and salt and pepper to taste.

Tip: The dressing can be made, covered and refrigerated for up to 1 week. The chicken can be cooked, cooled, covered, and refrigerated up to 2 days.

Not fake after all

Gluten intolerance is a very real issue with measurable symptoms

Gluten is not for everyone. In fact, people who have celiac disease shouldn't eat gluten at all. Celiac disease is an autoimmune condition that affects the digestive process of the small intestine by launching an immune system attack against gluten, mistakenly damaging healthy cells lining the small intestine.

Even people who do not have celiac disease may find that consumption of gluten results in similar symptoms. These individuals may want to avoid gluten as well. Also known as non-celiac gluten intolerance or sensitivity, this condition is not currently well-defined within the medical community. The Celiac Disease Foundation says some people experience symptoms found in celiac disease, like foggy mind, abdominal pain, diarrhea, headaches, bone or joint pain, or chronic fatigue when they have gluten in their diets — despite not testing positive for celiac disease.

In July 2016, researchers at Columbia University Medical Center published a study confirming that wheat exposure to those sensitive to wheat and gluten triggered a systemic immune reaction and intestinal cell damage. Researchers previously thought that a sensitivity to wheat or gluten would not result in cell damage. But research now confirms that even without a positive celiac disease diagnosis, people can experience symptoms that mimic those of celiac disease, even in

terms of severity.

Doctors are not sure if gluten triggers the immune reaction in non-celiac cases, so more research is needed. That said, removing gluten and wheat products from one's diet provides relief for many people.

According to Schär, a company that manufactures gluten-free foods, anyone who experiences negative symptoms after eating foods that contain gluten should speak with a doctor. A doctor will order blood tests that will look for the presence



of immunoglobulin E antibodies that are indicative of an autoimmune response to gluten. An endoscopy also may check for damage to the lining of the small intestines, as can a biopsy of the intestines. Other tests, such as a radioallergosorbent test, or RAST, or skin prick test can test for a wheat allergy to see if symptoms are stemming from that alone.

Treatment for gluten intolerance or celiac disease involves avoiding products that contain gluten, which is found in wheat, rye and barley.

A growing body of literature suggests that people who do not have celiac disease can still experience non-celiac gluten sensitivity and many of the same symptoms felt by those with the disease.



Wallis Bird's 'Woman'

A Journey In Self-Exploration

Wallis Bird's upcoming album, "Woman," is both a rebellious act of self-advocacy and a call to action. Wallis Bird is an accomplished musician from Ireland with a unique sound. When she was young, Wallis was involved in an accident where she lost all of the fingers on her left hand. Fortunately, all but one were able to be reattached. This has impacted the way she plays her guitar. She performs with it flipped, lending to her distinct musical quality.

"Woman" comes twelve years after her first album, and it is a reflection on the things Wallis has learned, both about herself and humanity. It serves as a way to impart what she has discovered and to rouse her audience into wanting change. To change the world around them; to be a kinder place.

In "Life Is Long," Wallis reminds us that while a lifetime may seem like a long period, time itself is very brief. Each moment needs to be savored, which is something that is easy to forget in a world of instant gratification and constant distractions.

In the current political climate, as a woman, others in power feel that it is up to them to make decisions for you. Wallis Bird speaks out against this, fighting to take ownership of her own choices in life.

Wallis Bird presents you with singable tunes that are joyous in sound yet carry deep messages that comes from introspection and reflecting on the changing world at large. It is a blend of soul roots and her love of the various genres that have influenced her. It stands as a testament to who she is and who she has built herself to be.

MUSIC REVIEW

The Wood Brothers' 'Live At The Fillmore'

An auditory experience where listeners hear a great live band

Since their inception back in 2004, The Wood Brothers have been creating their own flavor of American traditional music on their own terms. The trio is comprised of brothers Chris (bass and vocals) and Oliver Wood (guitar and vocals), as well as Jano Rix (percussion). Together the trio has been successful in creating a unique musical gumbo that includes the fusion of blues, folk, country and rock.

The Wood Brothers also recently received critical acclaim for their latest studio release, 2018's *One Drop Of Truth*, which included a Grammy nomination for Best Americana Album. If that weren't enough to keep the band busy, The Wood Brothers have just released *Live At The Fillmore* a new live album, their fifth, that



was recorded over a two night stint at San Francisco's famed musical landmark. The trio is famous for their live performances and the band shines on the stage. The opening track on "Live At The Fillmore" is "Blue and Green," which is a stripped down, intimate number off of 2011's *Smoke Ring Halo LP*. The deft vocals that Oliver and Chris deliver, as well as the ambient noise of the crowd, easily transports the listener to the gig at the historic Fillmore.

The boys tear it up on the third track "Snake Eyes" with a great percussion intro by Rix, which leads into a nicely executed

guitar accompaniment by Oliver, featuring some heavy feedback. The Wood Brothers infectious performance, along with a little on stage prompting from Oliver persuaded the audience to join the band in the chorus of the upbeat number, creating a vivid picture in the mind's eye of the listener. The trio's harmonies were spot on and the track wrapped up with another nice guitar fill by Oliver.

The Wood Brothers keeps the energy flowing with "Raindrop," the fifth track from "Live At The Fillmore" LP. Oliver and Jano constructed an intro featuring guitar and percussion which effortlessly leads into the jamming number. With the catchy opening vocal "Broke a heart for a cheap thrill. Seemed worth it at the time. There's a hundred of 'em out there still. You can hear 'em all cryin'," Oliver is able to evoke the frustration that anyone can feel while trying to get over a painful breakup.

The sixth tune, "Chocolate On My Tongue," has an infectious groove that will get your foot tapping along with The Wood Brothers as they expertly

ply their trade. Catchy riffs and smooth harmonies make this tune a true gem of a performance and a highlight on the LP.

Overall the fourteen tracks on "Live at The Fillmore" are successful in proving The Wood Brothers are at their comfort zone on stage, playing for a live audience. It also illustrates how proficient the trio, who have had extensive time on the road performing, are able to anticipate and coordinate their playing together as a road tested unit. Oliver Wood once said while talking about selecting songs for a set list: "Sometimes it is like choosing between your children, you don't want to have to do that but sometimes you have to." Luckily for fans of The Wood Brothers, the band chose extremely well on "Live At The Fillmore," creating an auditory experience where the listener gets to experience the best of two nights in the life of a great live band playing at a historic musical venue.

New York Times-Bestselling author, writer and journalist Reif Larsen is to host the discussions, the first of which is titled "High Water Marks: Redeveloping the Urban Waterfront" on Thursday, Sept. 19. Guest speaker Ray Gastil, former planning director for Pittsburgh, spearheaded the steel city's conversion to a sprawling urban community. Part of that effort was defined by the city reclaiming access to its waterfront. After decades of neglecting the Hudson River, Albany, Troy and Rensselaer are working to do the same.

Two years ago, the Capital District Transportation Committee turned to the public to hear Albany's concerns over the 787 corridor. When the highway was built in the mid-60s it severed the city from the Hudson River. Today, as many as 88,000 motorists travel upon it each day. It's a main thoroughfare for

residents traveling between south of Albany to Cohoes. Nonetheless, as ideas were exchanged, a popular possibility was to tear it down for a more neighborly boulevard.

The committee was tasked with developing a regional plan for federally funded transportation projects. The corridor study fell under what is now known as its "New Visions 2040: New Visions for a Quality Region," identifying principles for transportation planning and investment. Other projects from this study included the conversion of a 787 off-ramp at Clinton Avenue into a walkway, and the merger of the Helderberg-Hudson Rail Trail with the Mohawk Hudson Bike Hike Trail. The latter projects are underway, but demolishing 787 as a whole was ultimately viewed as a logistical nightmare, both too expensive and too political in scope. Politics, is something Nardacci aims to



avoid with this endeavor.

"I think that we'll get a lot of variety in differing parties," said Nardacci.

"I do think we'll get the spectrum, and that's what

we want. The hope is that we'll be able to create a dialogue, take comments, take thoughts, take questions, and have this group that will talk a little deeper about it."


