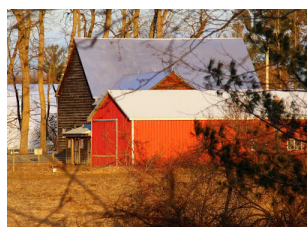

### Two felonies

Robin Laconia Jolly turned herself into the Bethlehem Police Department for an active arrest warrant. She was processed without incident and arraigned before Judge Andrew Kirby. While Jolly was sentenced to community service, she was charged with grand larceny and identity theft.

Jolly has a return court appearance on Oct. 15 at 4 p.m.

### Grand larceny

**GLENMONT** — A 29-year-old Albany woman was arrested on Thursday, Sept. 12 in relation to an Aug. 19 grand larceny incident at the Glenmont Walmart on 311 Route 9W.

The BPD received a

call from the Colonie PD that they had custody of Chantel Elizabeth Mudd; BPD then took custody of her without incident. According to the police report, Mudd said she was under the influence of drugs and had chest pain. She was then evaluated by EMS and transported to the Albany Medical Center, where she was arraigned by Judge Ryan Donovan who set bail for \$5,000 cash/bond.

Mudd has a scheduled return court appearance on Oct. 1 and was charged with a grand larceny felony. She has since been discharged from the Albany Medical Center and was turned over to Albany County Corrections.

### Grand larceny

**GLENMONT** — A 33-year-old Albany man was arrested on Tuesday, Sept. 17 at 5 p.m. in relation to an Aug. 19 grand larceny incident at the Glenmont Walmart on 311 Route 9W.

Danilo Emilio Medina was transported to BPD by the Albany County

Sheriff's Office; he was processed and arraigned before Judge Andrew Kirby. Medina was released under supervision of probation and turned back over to the custody of the county Sheriff's Office.

Medina was charged with a grand larceny felony.

### Criminal mischief

**GLENMONT** — A 26-year-old Menands man was arrested on Tuesday, Sept. 17 at 2:33 p.m. in relation to a Jan. 26 incident at Applebee's on 291 Route 9W.

Shakiem Raymond Maeweather turned himself into the BPD because of an active arrest warrant that had been signed by Judge Andrew Kirby back on Feb. 1. Maeweather was arraigned before Kirby and released under supervision of probation. He is scheduled to return to court on Oct. 15 at 4 p.m.

Maeweather was charged with a criminal mischief felony.

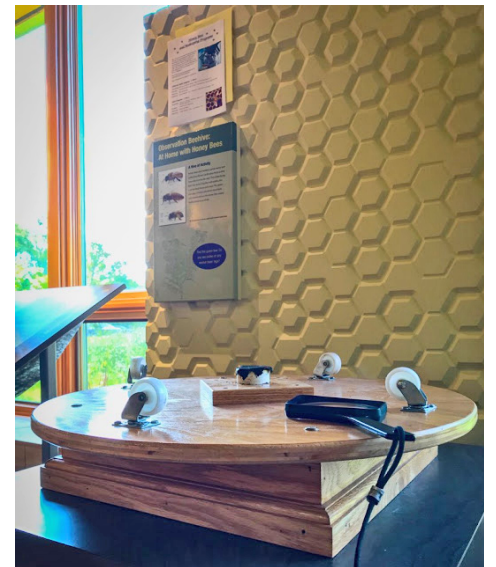
In the September 4 edition of *The Spotlight*, it was reported that a honey bee hive observation at the Five Rivers Environmental Education Center in New Scotland display fell victim to colony collapse syndrome. The information shared with us was from a staff member at the center sharing information with visitors. However, that information conflicted with a statement previously provided to our offices by the New York state Department of Conservation.

Since the publication of this news story, the state DEC has released a second statement reporting that colony collapse syndrome was not a factor for the disappearance of the colony.

The beehive had been on display to the public from July 2017 until May 2019.

In an emailed statement to *Spotlight News*, the state DEC wrote that the bee colony had originally been collected from a wild swarm in mid-2017 and an investigation was launched after its demise. However, it was found to not be due to parasites, colony collapse disorder, disease or foulbrood — the latter is a fatal bacterial disease to honey bee brood.

They noted, though, that "it is not unusual for honey bee hives to fail. Observation hives are even less successful, as there are additional stressors affecting their survival: smaller colony size, insufficient honey

production to sustain the colony, and the commotion of being on public display, to name a few."

Looking ahead, the observation display has been cleaned and is poised to accept a potentially new wild swarm of honey bees in spring 2020. The state DEC views this timeframe as ideal as they brought up how the new colony would have the necessary nectar and pollen they need for food at that time which would give them time to make honey for their winter food supply.

# Communication is key

Thinking of ways to reach out to affected residents, businesses

**BETHLEHEM**  
— Maintaining communication among residents and business owners about the Delaware Avenue Road Diet project was the main theme discussed at a Sept. 18 meeting hosted by the Bethlehem Chamber of Commerce.

The meeting, mainly catered to business owners, happened from 8 to 9:30 a.m. last Wednesday at the Nathaniel Adams Blanchard Post 1040 on 16 West Poplar Dr. in Delmar. More than 35 residents and business owners attended the meeting which featured an introduction by the Chamber's president Maureen McGuinness and

a presentation by the town's Planning Division director Robert Leslie. It initially summarized the history of the project, why the town government views it as beneficial and what future

updates people can expect through 2022.

Known officially as the Delaware Avenue Complete Streets and Road Diet Project, it seeks to transform the road's

stretch from Elsmere Avenue to the Normans Kill Bridge from the existing four-lane road to two opposing traffic lanes, a middle two-way left-turn lane, and two opposing

bicycle lanes. *Spotlight News* has already covered this project extensively in past articles and for more information, visit [www.townofbethlehem.org/830/Delaware-Avenue-Complete-Streets-Project](http://www.townofbethlehem.org/830/Delaware-Avenue-Complete-Streets-Project).

As there has been concern about how construction on the road may affect businesses, deter potential customers away and upset local vehicular traffic, the meeting brought up how imperative communicating with residents and business owners about the project's progress is.

"We didn't do a great job on the Delaware Avenue Enhancement Project and we need to do better on this one," said Town Supervisor David VanLuyen to the attending residents and business owners regarding communication. "We've got time to do it but in order for it to be effective, we need to do it with the Chamber of Commerce and

we need to do it with you. You have outreach in the community through your customer base; we need to get the word out. But the reality is that we're going to have a major construction project there regardless of the striping pattern on the road."

Such a communication strategy, he added, needs to be developed and implemented prior to construction which is expected to start in 2021 and end by 2022.

"I know that the Chamber has an e-newsletter where we communicate with our members and some non-members ... on a regular basis and we have an open rate that's higher than the national average," said McGuinness. "This is one way we're going to communicate about all of the processes that went into this project." While

# Voting on Farms and Forests Fund

Addressing town's growing development with a new option

**BETHLEHEM** — The Town Board will be voting to approve a resolution to create the Farms and Forests Fund at its Sept. 25 meeting.

The new fund would allow the town to purchase local agricultural easements and their development value from any interested landowners. While the land would still remain privately owned and can continue to be farmed, it would prevent it from being redeveloped into housing; the landowner can use the money to invest in operating that farm or their retirement, for example.

"The fund would allow us to participate in a purchase of the easement

and to partner with a conservation organization should they look to help with conserving an agricultural easement, and it would also establish a funding for local match for federal or state grants," said Robert Leslie, the town's Planning Division director. He previously spoke about the Farms and Forests Fund at the Sept. 11 Town Board meeting. "It would also

allow us to use these funds for land appraisals, title searches and land surveys — all those components of a land transaction that are involved in an agricultural easement or land purchase."

He added that each easement is different and tailored to the landowner's needs and goals.

Leslie brought up how the town already has two

land protection options for interested landowners: the Term Conservation Easement Program and the Parkland Set Aside Fund. The former allows a landowner to forgo development for at least 15 years to perpetuity and they can receive a property tax break where they could save more money if the easement period is

longer. The latter generates revenue from a fee on new residential developments but this applies only for parks, park equipment or parks planning; it cannot be used for active farms and working forests.

This led to the Farms and Forests Fund as a third option to continue addressing growing development in town. It would allow the town to partner with local non-profit land conservation organizations including the Mohawk Hudson Land Conservancy, Open Space Institute and Scenic Hudson.

Connecting this with the larger townside discussion on land conservation and open space protection, Town Supervisor David VanLuven had initially proposed this fund during his State of the Town

Address back in January. "It is vital for our community to step up and work with interested landowners to keep farms, forests and fields as part of Bethlehem," he said. "After the Address, we worked to find different ways to provide revenue for the fund."

Regarding funding, according to submitted town documents, the Town "Comptroller shall deposit into the Farms and Forests Fund unassigned funds in the General Operating Fund, based on the fund balance as a percentage of the most recent budget." It will use a formula, as shown in the table below.

## A new superintendent is coming

**VOORHEESVILLE** — Duanesburg school superintendent Frank Macri will leave this December to become the new Voorheesville school superintendent.

Macri, a father of four and a Voorheesville resident since 2005, expressed excitement for the opportunity and said, "It's nice to invest myself to a community where my neighbors and friends are. Just like in Duanesburg, I plan to help the Voorheesville community, work with the school board, work with stakeholders, and move the district forward from where they are now. I want to serve the students too and we're always here for the kids. As soon as I get in, I will look at everything and start from there."

Macri has been involved in education for 21 years throughout the Capital District. He has been the Duanesburg school superintendent since January 2018 and previously had been a music

teacher in the Salem school district. He went through positions like assistant principal, principal and district data coordinator at the Lansingburgh school district, where he said he started around fall 2001.

He added that he will miss the Duanesburg community and staff, seeing his upcoming exit as a "bittersweet decision. It's just personally a hard decision for me but I'm going to be in a wonderful location." Macri's start date is Dec. 15 and his appointment was due to an extensive search process by Capital Region BOCES.

"It's always students first and their education," Macri concluded. "I'm excited to continue that in Voorheesville and serve that community where I live."

Macri will enter into a three-year, six-month contract with a starting annual salary of \$160,000.

she added that she knew mailing has been sent to businesses along the to-be-affected Delaware Avenue stretch about the project, she said, "Despite all of that, people still seem to not know. We don't want that to happen as we move forward."

However, some attendees said people may receive too many emails and e-newsletters in general and they end up not reading them.

Some alternative suggestions people offered included:

- Sending out important project-related information via text messages
- Using the Nextdoor app to spread information (this is a private social network for any neighborhood)
- The Chamber of Commerce working with businesses to gather information with the town about when heavy customer traffic is typically expected year-round and when vehicular traffic gets busy at

that Delaware Avenue stretch

- The Chamber having a page on its website dedicated to projects like the Road Diet one where all relevant information is readily accessible to the public

Regarding the latter point, McGuinness said, "You're in luck. We're redoing our website and it should launch next month so we could do that." She added that it would be "not right" for patrons to "punish" businesses by not going there when construction is happening because they do not like the project itself.

Towards the meeting's end, Jim Giacone, the owner of My Place and Company on 241 Delaware Ave. in Delmar, asked if the project is a done deal and if public forums could be held to remodel the road configuration.

Leslie said, "This is the plan that was applied for, this is the plan that was funded and this is the plan that will go ahead in design. We will have public meetings but it will be on the specific design items of crosswalk location, bus pullouts and other specific design details. But going forward, this is the plan."

## From page 4... Farms and Forests Fund

"We have a General Fund and if we finish the end of the year above what we budgeted for the year, that's a surplus," VanLuven explained. "If that surplus is 20 percent, then nothing goes to the Farms and Forests Fund. If it's 21 percent over, then half of that extra 1 percent will go into Farms and Forests Fund and the other half goes to the Capital Reserve Fund. If it is 22 percent over, it will all go to the Capital Reserve Fund and nothing extra for the Farms and Forests Fund, but [the latter will] still retain the 0.5 percent amount it received from when it was over 21 percent. If it's 23 percent over, it will now be 1 percent [0.5 plus 0.5 percent] put into the Farms and Forests Fund. It's cumulative as you continue on."

The town would

also accept monetary donations from the public to the Farms and Forests Fund if they want to contribute but do not own large areas of land themselves.

Leslie said the money can accumulate over time, maybe a few years, so it can be enough to buy agricultural easements or purchase land outright. "If we were to apply this type of structure to the previous 2014-2018 Capital Reserve Fund, it'd have resulted today to over \$580,000," he said at the Sept. 11 meeting.

If the fund is approved, any interested landowner can submit an application to the town's planning department which would receive assistance from planning department staff and be advised by the Conservation Easement Review Board.

The application would be evaluated on whether it would protect at least one of four conservation values: community, character; recreation and greenways; forests, fields and wildlife ecosystems; and natural water systems

like streams, wetlands and the Hudson River.

After planning department staff look into additional funding sources like state or federal grants, a final recommendation by the CERB would be given to the Town Board to consider and make a decision.

Town Board member Dan Coffey expressed optimism that it can come into fruition and that residents can donate if they want. He wrote in a follow-up email that the town would not take title to the property so it would stay on the tax rolls.

Fellow Town Board member Jim Foster wondered if any of the fund's accumulated money could be used for purposes outside the fund's intentions.

Leslie said, "I don't think there's anything prohibiting the Town Board from moving that money out of the fund but be aware that should you move any money out that's not in compliance with the purpose, it is subject to

permissive referendum ... So, residents could call out the board on that and challenge the board for using that money outside its purpose."

Nevertheless, Town Board member Maureen Cunningham said at the Sept. 11 meeting, "I have to say Bethlehem does really face development challenges but we've really been innovative in our solutions and here we go again. Great job to have everyone involved and the Conservation Easement Review Board. I'm excited."

"In summary, it provides more town land protection options for landowners and gives us a way for the entire community to participate in conservation," Leslie concluded, adding that the resolution needs to outline the fund's purpose, its funding structure and any allowable expenditures.

## From page 1 ... Cooking with heart

Located on 25 Warren St. in the South End of Albany, its name is quite a misnomer. While it does have a functional kitchen, pantry and a cafe-like environment where free, healthy dinners are served to local elementary school children in need on weekdays, it also offers space for kids to receive personalized homework help, hands-on arts activities, games and toy sets for entertainment, and attention from a group of mostly volunteers and a few paid workers. Around half of the volunteers come from Bethlehem and Guilderland.

The children, however, mostly are homeless or come from families who lack easy access to transportation, money or making their own food.

"Food is food and we all need something in our bellies but we wanted to feed the kids healthy food because I think we can easily feed them healthy food as much as unhealthy food," said Killar who first opened it in November 2015. "The parents sometimes are invited to eat here although most of the time, they don't so our chef puts out to-go containers for them." Examples of food and drinks kids have access to here include 1 percent milk and water, fruits, salads, chicken and more, she said, which shows the variety of options kids can expect through a weekly basis.

The food is mainly donated from generous individuals and organizations, food drives, or result from checks made out to the cafe.

According to Killar, the cafe has served around 33,000 free healthy meals since opening and is mostly run by 20 volunteers to cater to about 32 South End children on weekdays. While free lunch and dinner are served in the summer, only free dinner is available in the other seasons.

Parents typically drop their children here after school at around 3 p.m. where they typically do their homework first, then they have time to play games or take a neighborhood walk with

volunteers, and their free dinners are later served at 5 p.m. To further facilitate social interaction and engagement, kids are not generally allowed to use technology like smartphones when they are at the cafe and their activities are hands-on.

### The grant

Earlier this year, Killar had pitched to the Women United Perfect Pitch, a Shark Tank-like event where six local nonprofit organizations explained to a panel why they would like a \$10,000 grant from the United Way of the Greater Capital Region. This event seeks to help causes related to women and children.

"My pitch was to ask for funding so we can do a second dinner service so that we could feed more kids because our space is such a small area and we have a capacity in the cafe of 64 people," she said. "We can't have more people inside for now but there's still so many kids to feed. With the second dinner service, a group of kids would come in for dinner and then after they leave, a second group of kids can come in to eat." This time, she added the cafe wants to provide meals for local middle and high school students in need, as well as additional homework help and non-technology activities for them.

She further said that limited space is the cafe's main issue now although "we make do ... But we always have a waiting list which breaks my heart." Another issue is money and the cafe both holds their own fundraisers or benefit from local ones, including from Albany and Bethlehem. However, with the grant, she also hopes to bring in more food and possibly hire a few more staff members.

When asked how she felt about winning the grant, Killar said, "Shocked. I was shocked but I am so grateful." The \$10,000 check, however, has yet to be delivered but Killar said she expects it sometime in October.

the South End Children's cafe is the workers and volunteers who come in for different shifts on weekdays.

Beth McCrea, a Delmar resident and retired teacher who volunteers there as a homework helper, said she heard about this opportunity from a friend and she believed that many kids seem to learn better when having one-on-one help with their homework.

Sue Bango, a Bethlehem resident and fellow retired teacher who also offers personalized homework help, said she still wanted

to continue working with children. Adding that her first day was Wednesday, Sept. 18, she said it "has been great so far and I thought this place was pretty awesome," adding that she first heard of it as she knew Killar from church.

Sandra Olson, the cafe's academic director and a volunteer since it first opened, supervises the so-called "Manners Cafe" within it where she picks four children to have dinner with her in a quiet corner in a separate room, as opposed to the main cafe where most of the children

eat. As its name suggests, the Manners Cafe is used to teach them how to maintain good manners and properly use silverware.

"I think a lot of kids here don't get the opportunity to sit around a dinner table with family and the Manners Cafe is a time for them to talk to each other and learn simple things like even saying 'thank you' and 'please,'" Olson said. "The kids also having somebody to help them with their homework is great because that's not necessarily the case at home for whatever reason."

Kate Lawler, a Guilderland resident who has been working as a kitchen cook there for almost three years now, said, "Some of these kids never have their own beds or know when their next meal is going to be, and that's their lifestyle. They need stability and people that they know who care, love and do nice things for them."

Lawler added she herself grew up in a family who did not have a lot of money but they always ate dinner together. Believing that a family eating dinner together helps to pass on morals and traditions to the next generation, she said the cafe welcomes kids who do not know when their next meals are or where they will live, as many are homeless or in financially-strained families.

"I want to keep working here as long as I can and I love kids," she concluded. "The kids here have so much love to give."

### The message

Killar said she wants to take advantage of the \$10,000 grant to continue addressing food insecurity, food equality and food justice in the South End, where many poverty-related issues exist.

"People don't have access to healthy food because it's expensive and a lot of times, they don't have transportation," she added. "Here in the South End, we're considered as a food desert where there's not a lot of affordable and accessible food, and our closest grocery store is about a mile away. Some families have to walk up the hill with their strollers and their kids wearing their backpacks to get to that grocery store. Then, you need to come all the way home with your grocery bags and kids, and sometimes you're doing all this as a single parent."

Despite this, Killar exuded optimism as the grant will make it a bit easier for the Children's Cafe to hopefully serve more children in need and attract more volunteers or workers. "We have created a community for the kids where they feel loved and cared about and I think they feel that way when they come through our doors," she concluded.

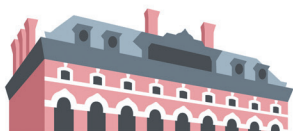

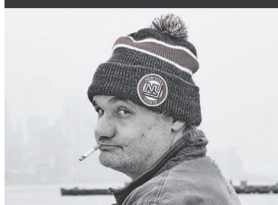

The evening will feature 12 top designers in the industry and will provide a glamorous red carpet experience for all who attend the Times Union Center, starting at 4:30 p.m.

Schinnerer's name has been associated with the Capital Masquerade, an annual theme party that puts an imaginative twist on your traditional charity gala. As with the masquerade, Stitched serves as a benefit to the Ronald McDonald House. The annual Halloween party has been such a success, Schinnerer said he was asked to try something new.

"Mike's productions are of amazing quality, and that is a regional benefit," said Richard Lovrich, creative director at Proctors. I work at Proctors. We bring the best shows in the world to our theater. And, Mike brings the best, best, best quality that you can possibly have. If it's a Halloween event or it's a fashion show, so that part excites me tremendously."

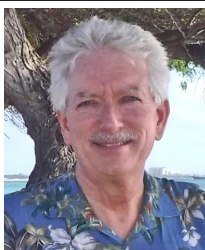

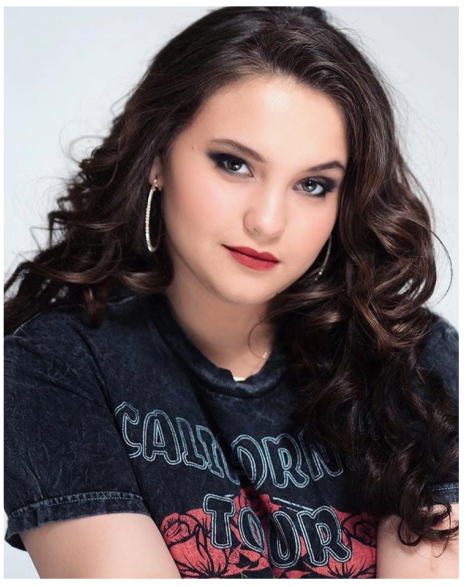

Ronald McDonald House Charities. He said he sees fashion and fitness going “hand-in-hand” together, as both involve making people feel comfortable. As for the scope of this event, he said he didn’t flinch. “I like to shoot for the stars. I’m a bit of a crazy thinker and will always want to go big. When [Schinnerer] told me what it was, I didn’t even question him.”

Ronald McDonald House is the beneficiary to Saturday’s Stitched Fashion, but it’s not the only mission behind the event. The overall mission is to support and elevate the local fashion community and provide opportunities for regional, national and international designers to connect with the upstate audience.

September is a big month for fashion. New York, London, Milan and Paris — the big four capitals of the fashion world — each host a fashion week twice a year, first in February and the other in September. Established fashion houses go to showcase the next look. It’s also a time when meek fashion designers walk away as household names. Philadelphia has recently started its own week. Schinnerer said he wants to see the same in the Capital District within the next few years.

Schinnerer has a passion for the arts and creative collaboration. His first full-time job was at Sports Illustrated where he designed Michael Jordan’s Career in Pictures commemorative and became friends with the magazine’s swimsuit editor. As a trendspotter, he rubbed elbows with the editors of top fashion magazines, and his first hands-on experience was Jay Z’s first fashion show for Rocawear in 1999.

As a resident of the Capital District for

the past 20 years, Schinnerer sees the local fashion scene as “poor.” He said, whenever he had then-Albany Mayor Jerry Jennings’ ear, he would advocate for a fashion district along North Pearl Street.

“But, nothing gets any traction,” said Schinnerer. “We do have some talented designers around here, but they never move forward to a storefront.”

The days have not shown us a hint of summer leaving town yet, but the nights have provided us with a cool, crisp reminder that autumn is, in fact, near. This recipe is reminiscent of some of the homecoming cookouts soon to be at our area colleges.

**Glazed Honey & Rosemary Grilled Pork**

**Ingredients:**

- 5 Tbs. honey*
- 5 Tbs. extra-virgin olive oil*
- 1 Tbs. chopped fresh rosemary*
- 1/4 tsp. red pepper flakes*
- 2 (12-16 ounce) pork tenderloins*
- salt and pepper*
- 2 Tbs. fresh squeezed lemon juice*
- 5 ounces (5 cups) baby arugula*
- 2 ripe peaches, halved, pitted, and cut into 1/2 inch thick wedges*
- 1/4 cup pine nuts, toasted*

Whisk 1/4 cup honey, 1 Tbs. oil, rosemary, and red

pepper flakes together in a bowl, and set aside

Pat tenderloins dry with paper towels. Brush tenderloins with 1 Tbs. oil and season with salt and pepper. Grill tenderloins over hot fire on a grill until well brown and meat registers 145 degrees (use a meat thermometer). 15-20 minutes. You can also bake in the oven at 400 degrees and thermometer registers same. Brush tenderloins with glaze and continue to cook, about 3-5 minutes longer. Transfer to cutting board, tent with aluminum foil, and let rest for 5 minutes.

Meanwhile, whisk lemon juice, remaining 1 Tbs. honey, and remaining 3 Tbs. oil together in large bowl. Add arugula and peaches to bowl and toss to coat. Season with salt and pepper to taste and sprinkle pine nuts over salad. Slice tenderloins and serve with salad.

**Pairing:**

Rombauer Chardonnay - Rombauer Vineyards - bordering Sonoma and Napa Valley, CA - This white is a little pricier than some of the others that I have paired with other recipes, but well worth it.

Displays juicy peaches, pineapple and lime aromas followed by vanilla and cedar. Tastes of tropical fruit and fig jam, with soft spice, vanilla, and nectarines, which mark a long finish with mouthwatering acidity. This wine is rich and creamy.

# Why it pays to store beer cold

It's all in the name of taste

**W**hen buying their favorite beers, beer lovers may have noticed manufacturers are using cans to urge customers to store their beers in a certain way. The instructions often advise beer lovers to "Store Cold" and/or "Drink Fresh." Why the sudden insistence on storing canned or bottled beers in such a specific way? The answer has a lot to do with flavor.

According to BeerandBrewing.com, an online resource offering brewing tips and beer news, light and heat can damage the flavor and stability of a finished beer. Modern beers contain hops with alpha acids that, when exposed to UVB light from the sun, will contribute to a skunky flavor. Limiting exposure to that UVB light, which can be accomplished by storing beers in cold refrigerators, can reduce the likelihood that the beer's flavor will be adversely affected. Craft brewers work hard to develop finished products with unique flavors, so it only makes sense that they prefer their

customers do their best to preserve those flavors until they consume the beer.

Another reason to store beer cold is what can happen to the flavor of beer when it's exposed to heat. BeerandBrewing.com notes that applying heat to finished beer can result in premature aging. All beers are aged, but craft brewers devote considerable effort to aging beers in a way that allows chemical reactions to occur slowly, ultimately contributing to a flavor and finished product brewers are proud to

call their own. By exposing beer to heat, the aging process is accelerated and the flavor changes. Specifically, the hops flavor many craft beer drinkers love tends to fade quickly when beers are exposed to heat.

As for drinking beers fresh, that, too, has to do with flavor. Over time, a beer's flavor profile may change, even if it's stored cold. By drinking beer when it's fresh, beer lovers are enjoying the flavor the brewers intended.

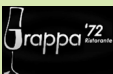

# Touching tribute to matriarch of folk

WMHT's 'Lena: A Life in Folk' goes deep into the life of Lena Spencer

Saratoga represents many things to many people. To the late Lena Spencer and her then husband, it was the place to start their coffeehouse. A bustling college town in need of a gathering place. They were two creative minds who sought to be in the middle of a creative community.

On Phila Street, in a building that was all but abandoned, they found the home for Caffé Lena.

Through decades of trials, tribulations, evictions, losses and near bankruptcy, Lena forged her vision. Her passion and perseverance provided a destination for some of the largest names in recent music history, a place where folk music continues to thrive and is now known as the longest-running coffeehouse in the country.

This iconic Spa City venue celebrates its 60th anniversary in 2020. Ahead of this milestone, WMHT Public Media (PBS) premiered "Lena: A Life in Folk" with a viewing at Skidmore College on Thursday, Sept. 19.

"I was drawn to Lena's unbridled ambition," states Lena: A Life in Folk

producer, WMHT's Nicole Van Slyke, "She was looking for something and she found it in a rundown building in downtown Saratoga. It was her destiny."

Through the years, Spencer hosted countless of legendary performers, including Bob Dylan, Arlo Guthrie, Ani DiFranco, Don McLean and more. The music venue earned such a reputation the Library of Congress named it "An American Treasure."

Van Slyke invites nearly a dozen voices, including Spencer's by means of recorded interviews, her songs and excerpts from her autobiography. Other speakers include family, friends, historians and associates from the caffè. Their words are accompanied by home movies, local news segments and several still photos that date as far back as Spencer's young childhood.

"Lena: A Life in Folk" is a touching tribute to a woman who epitomized a creative life. Whose name was large enough in stature that when she died in 1989 the news reached the Los Angeles Times. In the same article, however, the last paragraph took note of her financial dire straits. That the epicenter of the folk music world was never a financial boon despite the names that played there and the history it owned.

The love and reverence from those she left behind is clear. As members of a close family would be, speakers were honest in

remembering Spencer. From those who smiled while recalling how self-aware she was of her place in the global sphere of the folk music world, to the same voices who handled the "unromantic" details of her coffeehouse's decor with delicate words. Spencer was Mom, and as a mother, she provided all that she could. Despite

never becoming the next Irving Berlin, to whom she aspired to be while growing up in Milford, Massachusetts, she still drafted the resemblance of a song; created something out of nothing in Caffé Lena, and it continues to linger for others to enjoy.

# Marco Benevento's 'Let It Slide'

Benevento slides in and out of genres with new album

Marco Benevento, who hails from Hudson, could be described as a jack-of-all-trades, playing in jazz groups, the premier Grateful Dead cover band and touring with members of Phish and numerous other projects. With "Let It Slide" we get a true taste of the genius of Benevento's tastes, influences and abilities with tight arrangements and gorgeous songwriting.

After his first album *Invisible Baby* was nominated for the prestigious Independent Music Awards' Best Jazz Album, it is interesting to see how far this Berklee School Of Music has delved into the indie and jam band scene, covering artists such as My Morning Jacket and The Knife on his second record. Much of this was self-produced, so now with "Let It Slide," Benevento has an incredible treasure trove of experience and influences. Combined with the incredible producer Leon Michels, also from upstate New York, this record flows together impeccably. Benevento claims, "This record has a

really nice mix of what Leon does at his Diamond Mine Studio and what I do at Fred Short Studios. The final call on everything was always Leon's though, because I trusted him completely. I'd never put my music in someone else's hands before. I'd been hesitant to work with outside producers in the past, but the experience of making this record ended up being so freeing and exciting! I loved every single minute."

The new record showcases Benevento's ability to slide in and out of genres. At one moment he can catch you with the seemingly endless hooks and beautiful layers of the title track and then move to an atmospheric love song like "Solid Gold," celebrating the joys of living in the moment, a notion often lost in this day of technology and dating services.

One of the most beautiful tunes on the record is the John Lennon-esque "Lorraine," co-written by Simone Felice. Benevento says of his songwriting, "I started as an instrumentalist so I tend to write the music first and come to the words after. Often I don't know what the song is about at first and then I see my own personal philosophies subconsciously bubbling up throughout."

Another favorite of this reviewer is the very catchy and groovy "Send It On A Rocket" that almost sounds like a Beck

tune from Mutations. Fans both new and old can be thankful that this new record really hits an incredible stride and works as an entire piece of art. The maturity of the songwriting showcases Benevento's more than 20-year long career of creativity. Upstate New York is truly lucky to have such a talent, so be sure to catch him on the road with his own band, JRAD or

"The Duo" with Joe Russo. "Let It Slide" is another incredible installment on the continuous journey of an amazing player and poet.

# Cold Lazarus' 'Colors and Lights'

Despite some songs clocking in at 10 minutes a piece, 'never tedious'

Hailing from Jamestown, Cold Lazarus is a fusion four-piece that melds funk, psychedelic rock, reggae and soul with indie-style vocals and introspective lyrics. With three releases now in their discography, the band is established in their sound and aesthetic. Their albums all have a great flow, and in the past offered consistency with each song. While this is the case as a whole with the new release, "Colors and Lights," there are a lot of new ideas presented that break the band away from their regular brand of psychedelic jam-rock. This new release brings a lot of composition and arrangement without compromising on the live feeling Cold Lazarus emulates so well. Cold Lazarus is unconventional in their songwriting, and unrelenting in their audacity to make something distinct.

The opening track on the album, "A Dream Serene" sends the listener straight into space with a multi-dimensional ambient piece with a heavy emphasis on

vocals. The harmonies are tight and varied, and offer a real pallet cleaner to usher in the titular track "Colors and Lights." The low-fi funk opening leaves room for the song to build, as the band expands the production and enters the realm of hi-fi. The composition is very unique to Cold Lazarus- as opposed to each member holding big chords, the group has each person playing one or two notes that create a moving chord progression more similar to classical funk, and even classical music at that. The drums are agile with fills, fresh and diversified between phrases. The keys and guitar find themselves in conversations atop a steady and arresting bass line.

There are some really fun tunes on this album. "Don't Hide" is a great illustration of how the band can combine extended jams with compact choruses. While the song can meander into new spaces and ideas, there is always a return to home base. Something the band has that sets them in a league of their own are their longer jams that incorporate motifs and themes. The meat of the song is the organic performances in these live-feeling jams, but the potatoes are certainly the choruses. The characteristic harmonies that play off each other give these choruses more muscle and tension.

Between songs you will find interesting electronic-inspired breaks. "Trepidation"



and "Dimension Ascension" highlight an entirely new aspect of the band's abilities. Making use of 606's and glitchy drum beats, these sketches add more variety to the album than past projects.

Cold Lazarus has certainly accomplished their goal in creating an adventurous psychedelic rock album that doesn't place itself solely in the realm

of one genre. The talent of the band absolutely shines through in different ways in each of the songs. While some of these songs last upwards of 10 minutes, they never become tedious. Interesting composition and tight production work together to construct something that keeps the listener engaged and excited to see what the next turn brings.




