Rail Trail bridge design chosen

SLINGERLANDS — The final design for the “structurally-unsound” bridge along the Albany County Rail Trail near the intersection of New Scotland Road and Route 85 in Slingerlands was announced by Albany County Executive Dan McCoy on Monday, Sept. 30.

The two-girder bridge would cost about

\$1.9 million and pre-fabricated truss would cost around \$1.8 million; this decision comes after two informational public meetings, multiple stakeholder meetings and a public comment period. Three design choices were considered in the decision-making process’ final phase. One would rehabilitate the current structure, which could cost approximately \$3.2 million and would have an estimated 35-year design life, with

additional costs for ongoing maintenance. Two other choices would replace the bridge, each with lifespans of at least 75 years.

“As the County Executive, I take my roles in upholding public safety and being a responsible steward of taxpayer dollars extremely seriously. Our choice of the two-girder replacement addresses the current ongoing structural deterioration, potentially saves over \$1 million in construction costs and incorporates community input with a design that blends in with the historical nature of the area,” said McCoy.

The project’s final design phase is set to be complete later this fall and construction is expected to start in spring or summer 2020.

To meet the state Department of Transportation’s minimum required vertical clearance, the bridge will be raised to improve motorists’ line of sight. It will also allow the Slingerlands Fire District to travel under the bridge and improve emergency response times. A wider, newly-ADA compliant sidewalk on the northern side will replace the southern sidewalk on State Route 85. This will make maintenance easier and less costly for the Town of Bethlehem during the winter months, while wider roadway shoulders will improve safety for cyclists.

Glenmont Elementary School receives national honor

GLENMONT — Glenmont Elementary School was named a 2019 National Blue Ribbon School by the U.S. Department of Education on Thursday, Sept. 26.

The school is among 312 public schools in the country, among 19 New York state schools, and the only Capital Region school to receive this honor which recognizes schools for being “models of successful teaching and learning,” according to a Bethlehem school district release.

While the award assesses public and private

Town Board greenlights new fund

Farm and Forests Fund aids open space effort

BETHLEHEM — The Town Board unanimously voted to approve a resolution to create the Farms and Forests Fund on Wednesday, Sept. 25 in a move that has been expected since the town's 2005 comprehensive plan's creation.

The new fund allows the town to purchase local agricultural easements and their development value from any interested landowners; purchased land would still be privately owned and can continue to be farmed but it would stop the property from being redeveloped. The fund is one way the town is taking an active step towards addressing issues like overdevelopment and land preservation.

"In my view, active farms and working forests are important parts of Bethlehem," said Town Supervisor David VanLuven. "As we look into development patterns in town, we're too often seeing these landscapes convert into developments. If that is the direction landowners want to take, it's their right

and I respect that. But I believe we need to give landowners other options." Prior to the Farms and Forests Fund's creation, the town already has two land protection options — the Term Conservation Easement Program and the Parkland Set Aside

Fund. However, the Farms and Forests Fund gives the town a chance to partner with local non-profit land conservation organizations like Mohawk Hudson Land Conservancy and Scenic Hudson. Town Board member Dan Coffey said the town's original 2005 comprehensive plan envisioned a type of "open space fund" and he said, "It's a long time coming. ... I think it's consistent with the comprehensive plan and our town's goals of giving the town other tools in its arsenal, if you will, to go up against developers and try to preserve our spaces."

When Town Board member Maureen Cunningham asked if a formal application format has been finalized for any interested landowner, Robert Leslie, the town's Planning Division director, said a draft application is in the works. Cunningham later added, "In the resolution, it also says the town will not solicit or conduct fundraising

activities for this fund. However, separate entities such as a land trust or citizens group may solicit gifts and conduct fundraising activities, the proceeds of which may be donated to this fund."

Fellow Town Board member Jim Foster said he wanted the public to know that this Farms and Forests Fund will not be forced on any landowner, but rather it is available for anyone who is interested. He also noted that should any money be taken out of the Farms and Forests Fund for any other purpose, it would subject the Town Board to permissive referendum.

As the Town Board moved to unanimously vote for the resolution, Town Hall filled with applause from attending residents, many of whom were also in support of the fund. VanLuven held a thumbs up with a smile, "We've been working on that for a long time."

Tentative 2020 town budget

Final budget to be adopted on Nov. 13

BETHLEHEM

— Comptroller Michael Cohen introduced the town's tentative \$45 million budget for 2020 at the Sept. 25 Town Board meeting.

The \$45 million figure marks an increase of \$2 million or 4.6 percent from 2019's \$43.1 million amount. When divided across the town's departments, it roughly comprises of \$8.6 million to police, \$0.9 million to parks and recreation, \$0.8 million between parks and highway departments, \$8.5 million to highway, \$14 million to public works and \$7.5 million to all other departments. Also, \$1.4 million will go to ambulance/EMS and \$3.3 million will go to debt service.

Among the reasons

the town's budget would increase is because of the Clapper Road Water Treatment Plant's debt and how the money that goes to county EMS will increase by 13.9 percent, from \$1.1 million in 2019 to \$1.2 million in 2020. This relates to how county EMS was announced earlier in September that it would be moving to full-time staff.

In terms of taxpayer impact, the proposed 2020 town budget would raise the average property tax bill on a home assessed at \$260,000 by \$24.68 to

\$1,018.92, a slight increase from 2019's \$994.24 figure. From the \$1,018.92 amount in 2020, \$449.75 goes to the Highway Fund, \$235.92 to the General Fund, \$157.72 to the Water Fund, \$85.93 to the Sewer Fund, \$79.26 to the County EMS and \$10.34 to Delmar-Bethlehem EMS.

The tax rate sees an increase of 2.5 percent and the tax cap is at 2 percent; the latter has happened once before since 2013. The tax levy is up by \$532,089.

Cohen's presentation had a slide which demonstrated

a \$1 bill as a metaphor for how residents would pay \$0.67 in taxes to the school district, \$0.12 to the county, \$0.04 to the public library, \$0.04 to the fire districts and just \$0.12 to the town. Cohen also noted that town staffing has decreased from 241 in 2008 to 220 in 2019, all while still providing the same services to residents.

Looking ahead, the Town Board can begin asking questions and discussing the tentative budget further in its Oct. 10 meeting. A public hearing on the budget will then be held on Oct. 23 and the final budget is set to be adopted on Nov. 13.

elementary, middle and high schools, it is "intended to highlight and affirm the efforts of educators, families and communities in creating safe and welcoming schools where students master challenging and engaging content."

"I am thrilled that Glenmont has been named a Blue Ribbon School," said Laura Heffernan, the school's principal. "It is a testament to the hard work of a team that will do whatever it takes to meet the needs of each and every student. Our faculty and staff love what they do and it shows."

Glenmont is specifically recognized as an "Exemplary High Performing" school. This recognizes schools that rank among their state's highest performing schools in terms of state assessments.

"This is a well-deserved honor for the faculty, staff, students and the families of Glenmont School," said Jody Monroe, Bethlehem Central School District's superintendent. "It is especially meaningful for a school that back in 2013 found itself being challenged to close an unexpected achievement gap of its own. Building leaders, faculty and staff crafted a plan to erase that gap and carried it out successfully to ensure Glenmont's special education students would have every opportunity to succeed."

Glenmont Elementary School, serving 342 students in grades K through five, will be honored at a recognition ceremony on Nov. 14 and 15 in Washington D.C.; it had previously received this honor back in the 1989-1990 school year. Also, the Elsmere and Hamagrael elementary schools had achieved it in 2013 and 2009 respectively.

Take a walk down history again

Raising funds for historic burial vault

— The Friends of the Slingerland Family Burial Vault wants to continue inviting the public on a walking tour and raise awareness of the hamlet's history on Sunday, Oct. 6.

The tour will include local costumed actors, playing three long-gone Slingerland family members — Rita Machin, Peter Crouse and Bill Douglas will portray Leah Britt Slingerland (1776 - 1863), William H. Slingerland (1830 - 1910) and John I. Slingerland (1804 - 1861) respectively. These individuals, who made significant contributions to local and national endeavors, are now buried at the burial vault on 1566 New Scotland Road behind the former Mangia property. They also belong to a centuries-spanning bloodline that originated from Teunis Cornelisz Slingerland who left Amsterdam, Holland for Beverwijck, present-day Albany, in around 1650.

The burial vault, originally built in 1851, has suffered from deterioration through the decades like vandalism and inadequate maintenance. With the Friends' overall goal of raising \$100,000 to improve the entire state of the vault, the aforementioned walking tour is one way the Friends wants help in raising money to repair the vault's entrance facade which would cost around \$50,000 to \$60,000, according to Frank Slingerland, a living indirect descendant.

Frank described himself as a fifth cousin to the aforementioned three Slingerland family members and being in the ninth or 10th generation of the Slingerland bloodline. He is also a member of the Friends of the Slingerland Family Burial Vault and will be assisting at the Oct. 6 event.

Besides the intimate portrayals of three

Slingerland family members, the Oct. 6 tour will bring the public to a 1790s-era Slingerland home and the burial vault itself. Bethlehem Town Historian Susan Leath wrote in an email to *Spotlight News* that the actors have scripts to follow

which will bring up each of their historic contributions to help further inform the public about the hamlet's history.

The tour comes in three time slots — 3, 3:30 and 4 p.m. — and will run for 45 minutes each. Pre-registration for \$20 a ticket

is recommended and can be done on Eventbrite at slingerlandvault.eventbrite.com. If there is still any ticket availability on the day of, they will be \$25 each. People would first meet, rain or shine, at the pavilion behind the Slingerlands Firehouse on

1520 New Scotland Road in Slingerlands 15 minutes before their scheduled tour begins.

In fact, a historic public walking tour already occurred back on June 28 which Frank said raised around \$1,000 and attracted 50 people. "Events like this are great to raise awareness and funds to rehabilitate the state of the vault," he said. "It's important for a community to have a sense of who the main characters were in its development. It gives a sense places and makes you a more balanced community."

Leath wrote that over the summer, the vault's broken sarcophagus was repaired and new marble plaque was added, with the help of the June 28 walking tour's raised funds. She added, "Also, this time around, the entrance to the vault will be open, so participants may take a look

inside."

When asked which late descendant he would hypothetically like to meet, Frank said, "That's hard to choose, they're all great. But I'd say John I. Slingerland because he really was instrumental in starting the movement for the Homestead Act and other important legislation. By second choice would be William H. Slingerland because he was an engineer and I'm an architect so it's pretty similar."

Saying that he first realized he belonged to a significant historic bloodline when he was in his teens, Frank added with a laugh that he is looking forward to how "my deceased relatives will be talking" at the Oct. 6 event.

Family history

As a retired UAlbany professor of Africana Studies, Delmar resident Dr. Maurice Thornton has spent many years sharing the stories of African Americans throughout history. Earlier this spring, he focused on the men and women who make up his own ancestral history, writing and publishing the 160-page "The Thornton Family." The book details the family's perseverance in the face of unemployment, segregation and the tumultuous Civil Rights Era, stretching back from the time of his great grandparents in the mid-1800s to the present day.

Thornton will be at the library Thursday, Oct. 10, at 7 p.m. to share some of these stories and talk about the work that went into researching, writing and publishing his family's history.



Thornton, a veteran of the Korean War, is also a leading member of the 369th Veterans Association, an organization dedicated to preserving and sharing the story of the all-African American 369th Infantry Regiment (the Harlem Hellfighters) and instrumental in obtaining the Medal of Honor for local WWI hero Henry Johnson. He was part of the Historic March on Washington in August 1962 during the Civil Rights Movement and attended President Barack Obama's State of the Union Address as Congressman Paul Tonko's official guest.

LETTER TO THE EDITOR

On immigration enforcement

People migrate to the U.S. to escape violence, oppression and poverty. They also have a desire to improve their lives, to work, contribute to a community, and hopefully insure that their children have a better future, a goal familiar to parents everywhere. They come in the pursuit of happiness.

Not unlike citizens, most succeed in being able to provide for their basic needs. Many even prosper, and some fall short in certain areas and depend on the social safety net which did not exist 60 years ago.

Then, both citizens and immigrants had to work hard to provide for themselves and their family. Some now argue that only citizens should be provided assistance when

their efforts fall short.

Many who migrated legally were fortunate to have qualified because of sponsorships, quotas or special provisions not available to all. Those with means could obtain assistance to complete the paperwork and navigate the instructions in an unfamiliar language. Some of the fortunate migrants now argue that those not so fortunate are undeserving.

Many immigrants, if they didn't commit any crime and kept a low profile, were able to become part of a community. The possibility of being deported is and was an incentive to obey the laws.

We have been told that the focus of immigration enforcement would be directed toward criminals. The reality is that

enforcement is driven by numbers and to reach the numbers, enforcement goes after the low hanging fruit. Occasionally someone is apprehended whose footprint in the community is such that influential people will speak out on their behalf. This happened recently in the City of Albany. Others, just as worthy, work, provide for their family, patronize local businesses and otherwise maintain a low profile, may be apprehended in the night with no one of influence to speak on their behalf.

Do immigrants take American jobs? Recent suggestions have been made that immigration policy should be focused more on the better educated. However, the better educated will and do compete for the jobs that American citizens

want or hold. Merely to ask the question implies that some people are more entitled to a job than others regardless of their talents or willingness to work competitively. Immigrants will often do the work that American labor will not. They are hungrier and jobs become available to those who are willing to work the hardest. No matter one's wishes, there is no right to any job that one is not willing to learn and work hard to meet its requirements.

Employers should not have to seek approval from any government agency to hire the person that they feel is best qualified to do the job. The money they earn and spend on rent, clothing, food and transportation fuels the economy and benefits all.

While there are valid concerns regarding border

security, assertions that hordes of murderers, rapists and other nefarious people are seeking entry is but a cover for bigotry, racial animosity, or an irrational fear of anyone viewed as different from oneself. Our security will not and cannot be 100 percent. We might just as well disarm all of our police until we can be sure not a single police officer is of an unstable mind.

Far removed from border security is the issue of children brought to America illegally. Most have little or no connection to any other country. Educated in our classrooms, they have the same aspirations as their classmates. This country has invested in their education. A great many Americans agree that it would be cruel to deport them or to deport

their parents. It is equally cruel to perpetuate their uncertainty.

Polls indicate significant support for resolution of this issue. There is no reason action should be coupled with any other immigration policy. The taking of human hostages is extortion.

We all bleed when we are cut. The principles that are conducive to peace include honesty, integrity, truth, justice, and personal freedom. These are fundamental to all people. We all have a right to life, liberty, and the pursuit of happiness which includes the right to be somewhere.

Food for thought

Mark Warford, BCMS' assistant principal, said, "The main message with Farm to You Fest is to support local farmers and raise awareness about local farming but at the same time, it's also asking kids to be aware of their footprint on the planet based on the food that they eat. Food that comes from thousands of miles away and that is grown using chemicals to kill bugs and weeds have a negative environmental impact."

He added that when someone eats organically-grown food that was picked fresh the day prior, "there is a huge difference."

During morning announcements on the first five days of October, BC Middle School students will have an "Agricultural Question" to answer to test their agriculture knowledge. Students with correct answers can win a gift bag of vegetables and decorative corn from the middle school's garden, as well as gift certificates from the Delmar Farmers Market. One sixth, seventh and eighth grade winner will be announced each day.

Throughout all five days too, students can support people in need with the "Squash Hunger" campaign where students and parents

can bring in fresh produce — from their own gardens, a local farmer's market or farm stand, or a grocery store — to collection bins at each school. Any type of fresh produce is acceptable, including butternut squash, apples, carrots and onions. Designated volunteers will then take them to McCarroll's/Delmar Marketplace as well as local soup kitchens or food pantries. "Squash Hunger" continues the school district's partnership with Capital Roots' Squash Hunger Program and since Farm to You Fest was originally created, over 4,800 pounds of produce has been donated by BC.

On Wednesday, Oct. 2, students can take part in "Guess the Weight of the Pumpkin," a contest

where four big pumpkins are located at different spots inside the middle school. Students whose weight guesses are the closest to the actual weight have a chance to take the pumpkins home with them.

On Friday, Oct. 4 in all lunch periods, the "Salads for Kids Day" will offer students free garden salads which are prepared by parent volunteers from PTO and the Healthy Kids Committee. Salads will mainly be produced from fresh lettuce, tomatoes, radishes, green beans and carrots, all of which are harvested from the middle school's garden. It aims to educate students about how the food they eat are sustainably- and locally-grown food. Salads for

Kids Day is a collaboration between the middle school's PTO and Garden Club, BC's Green Team and the Healthy Kids Committee.

Warford said in past years, he has received emails from parents that they initially had difficulty getting their children to eat vegetables at home but after experiencing Salads for Kids Day, they "now have buckets and buckets of fresh-picked vegetables which they typically wouldn't have before."

Students can visit the Delmar Farmers Market on Saturday, Oct. 5 for the "Farmers Market Scavenger Hunt" where they would do a scavenger hunt by asking local vendors questions. Forms for this scavenger hunt

are available in any school office or at the Farmers Market's main table; winning students can expect prizes in the end.

Cindy Ferrari, BC's Healthy Kids Committee's co-president, said preparations for this year's Farm to You Fest "is like a well-oiled machine at this point" since it has been happening for years now.

"For kids to know that the food they can generously donate to people in need is a great teacher to them in itself," she said.

Warford said he has a passion for environmental education. To develop an appreciation locally-grown and organic foods at school, "is just the perfect venue to be able to model that for kids."

BCHS student arrested

BETHLEHEM — A 17-year-old Bethlehem Central High School student was arrested on Wednesday, Sept. 25 in relation to circulating an email containing false information of a potential threat of violence which caused public alarm, said Bethlehem police.

According to police, the email's content was investigated and found to have been sent by another student to "a large number" of fellow high school students. The email had included false information about an eventual crime happening as well as potential violence to other students. The investigation led to an arrest of an individual student — his name was not disclosed — who was charged with falsely reporting an incident.

The student was arraigned in the Town of Bethlehem Court before Judge Andrew Kirby and was released under the supervision of probation. He will return to court on Oct. 15 at 4 p.m.

Jody Monroe, Bethlehem Central's superintendent, released a statement as well to inform the district's families that the email contained "an internet meme that included threatening

language. The email was sent to all students at the high school and was a response to an email from another student." The email exchange had happened on Tuesday, Sept. 24 and was brought to the attention of Dave Doemel, the high school's principal who immediately informed the police.

While the police investigation determined that there was no imminent threat of violence, Monroe

said parents, especially of students in middle and high school, should speak with their children about the importance of speaking up; practicing good judgment on social media and email; and fostering a safe environment in school.

"Students need to know that it is never acceptable to even joke about threatening others. Perceived threats are serious matters and will be pursued as such," Monroe wrote, adding that the district will follow disciplinary procedures that follow the school's code of conduct.

Both the police and school district commended the students and parents who reported the email to relevant school officials and

law enforcement quickly, showing that the "see something, say something" mindset was beneficial here.

"They kind of just pushed me on stage and made me sing 'One Headlight' by The Wallflowers, because I really liked that song," he said. His father's band would work the local scene around Binghamton, a college town in Central New York, just north of the Pennsylvania border. He had played in the band since Vince was born.

"I grew up in that environment. I can remember being 5-years old and coming downstairs with my dad playing the piano, playing a song, practicing with the band. He plays guitar, too. He sings as well. At some point, subconsciously probably, I realized I wanted to do that as well."

His father plays a lot of classic rock: "I grew up listening to Chicago, Rolling Stones, Billy Joel, The Wallflowers — 'One Headlight.'"

"From as young as I can remember, I was always singing," said Palmeri. "Music was always there. It

was always accessible. Not that it was anything. It's what kids do: Sing songs and play music, and stuff."

Palmeri had lived in the Capital District for the past two years, but the work schedule at his 9-to-5 job didn't allow him to sample the area's nightlife. While friends were at the club, he was at work. Rose and Andrew Gabriel met him through Ambassador Group's artist application program earlier this year.

Rose describes their singer as possessing a "soft" personality. He's confident, she said, but is approachable and well-grounded.

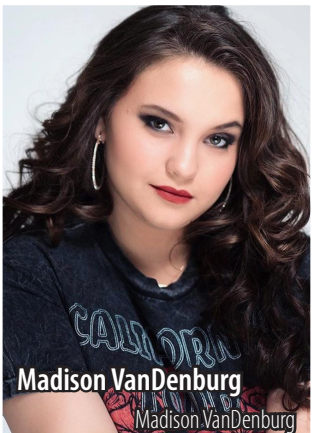

A story set to motion

Synergia Dance Project tells a story with help from The Sea The Sea, Girl Blue and Dark Honey

Dark Blue Sea aims to tell a story. That's what dance is all about. If you visit the Troy Dance Factory's Facebook page, a cover video is shown of dancers executing a routine perfectly. The moves, seemingly easy to the viewer, is mixed with perfect coordination and cooperation between the dancers. For the dance company, this seems like a natural step.

Dark Blue Sea — an amalgam of The Sea The Sea, Dark Honey and Girl Blue — is a production featuring the three groups and Synergia Dance Project, a seven-person dance company out of Troy Dance Factory. Nadine Medina, the owner of Troy Dance Factory, based the show from the quote, "Together, I lost myself with you."

Medina said the idea came from the ending of a long-term relationship. In the mix, she formed Synergia (synergy-a). The idea is to tell stories through collaborative means, such as choreography, live music and cinematic narratives.

However, this isn't the first time Troy Dance Factory has partnered with a local group for a show. In December, The Sea The Sea, which is comprised of married duo

Chuck and Mira Costa, visited the studio to talk to dancers about the inspiration behind their song, "All Go Right." According to the band's Instagram, the musicians and dancers were able to create something really beautiful.

"I really loved the process of working with [Chuck and Mira] and [Dark Blue Sea] kind of came from that amazing experience," Medina explained. "One night I texted Mira and asked her about it and she was down almost immediately."

Soon after Medina got the Costas on board, she was conversing with Girl Blue, aka Arielle O'Keefe, about another class idea she had. Medina admits she was nervous to pitch the idea about "Dark Blue Sea" to O'Keefe because they didn't know one another *super* well. Luckily, she didn't have to.

"Arielle mentioned that she thought it would be cool to do something like this and I was elated to hear her say that," she said. "She offered to use her music and it was amazing to hear her say that."

Dark Honey came later. When Medina first met the band in January through her boyfriend, who works at Chromoscope, it had about four songs out. Once Dark Honey agreed to join the show, it became a waiting game for new music it promised was coming in April. As the days ticked by and the band kept working, the days trickling into May, Medina was getting nervous. Would it work?

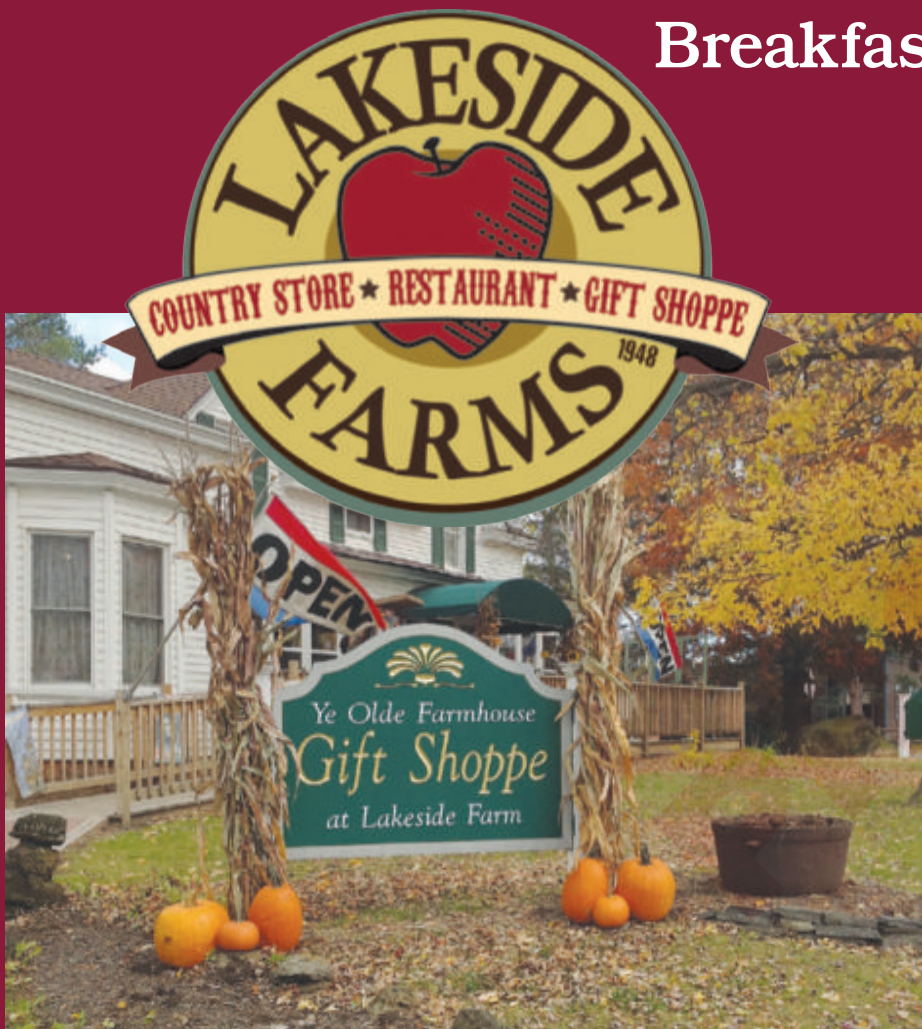

A taste of the vegan life

Whether it be the holidays or Sunday over for football, it is a time when people open their homes to family and friends. Having a series of tested recipes on hand can fulfill a variety of needs when having people over for dinner parties or informal gatherings.

Creamy Cashew Spread

Ingredients: Makes half a cup

- 1 cup raw cashews
 - 2 tablespoons lemon juice
 - 1 tablespoon tahini
 - 1/2 teaspoon salt
 - 1/2 teaspoon black pepper
 - 2 teaspoons minced fresh herbs, such as basil, parsley or oregano (optional)
- Assorted bread toasts and/or crackers

Rinse cashews and place in a medium bowl. Cover with water by at least 2 inches. Soak 4 hours or overnight. Drain cashews, reserving soaking water.

Place cashews, 2 tablespoons reserved water, lemon juice, tahini, salt, and pepper in food processor or blender; process for several minutes or until smooth. Add additional water, 1 tablespoon at a time, until desired consistency is reached.

Cover and refrigerate until ready to serve. Stir in herbs, if desired, just before serving. Serve with assorted bread toasts and/or crackers.

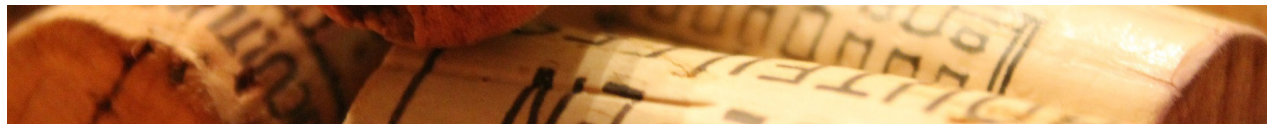

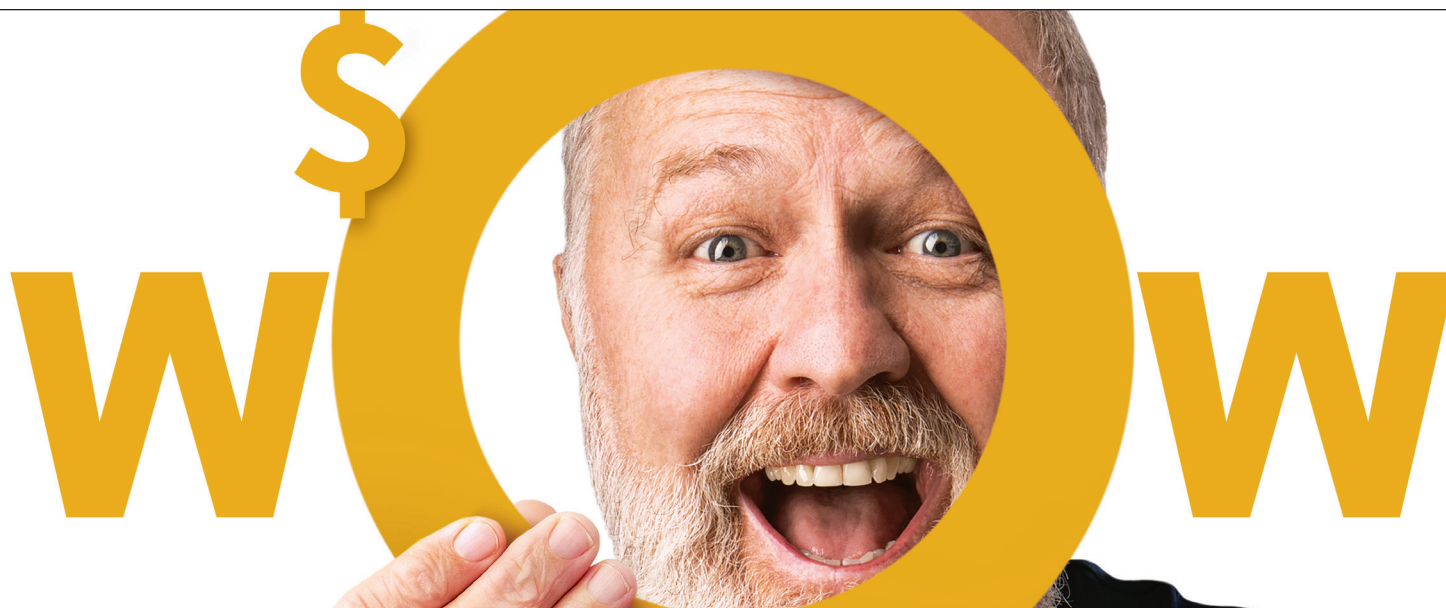

Debunking common breast cancer myths

Cancer claims the lives of millions of people across the globe every year. But the fight against cancer is anything but hopeless, as the World Health Organization notes that between 30 and 50 percent of all cancer cases are preventable.

Learning about cancer is one of the best ways for people to protect themselves from this deadly disease. Researchers continue to learn more about cancer everyday and routinely discover that information once thought to be accurate was actually off-base.

Despite researchers' best efforts, some myths about cancer still prevail. Some

of these myths are about cancer in general, while others refer to specific cancers, including breast cancer. Myths about breast cancer can be as harmful as accurate information is helpful, so learning the truth and debunking those myths can be an important part of women's preventive approach to breast cancer.

• **Myth: Drinking milk increases your risk for breast cancer.** The American Cancer Society notes that early studies raised concerns that drinking milk from cows treated with hormones could increase a person's risk for breast cancer.

However, ensuing research failed to find a clear link between the two. In fact,



a 2002 study published in the International Journal of Epidemiology found no significant association between dairy fluid intake and breast cancer risk.

• **Myth: Lumps indicate breast cancer.** The National Breast Cancer Foundation, Inc.® says that only a small

percentage of breast lumps turn out to be cancer. However, abnormalities or changes in breast tissue should always be brought to the attention of a physician.

• **Myth: Mammograms cause breast cancer to spread.** This myth is rooted in the incorrect notion that

breast compression while getting a mammogram causes the cancer to spread. However, the NBCF insists that cannot happen. In fact, the National Cancer Institute touts the benefits of mammograms while the ACS recommends women between the ages of 45 and 54 get mammograms every year. For additional breast cancer screening guidelines, visit the ACS at www.cancer.org.

• **Myth: Women with a family history of breast cancer are likely to develop breast cancer, too.** This myth is dangerous because, if taken at face value, it can give women with no family history of breast cancer a false sense of security.

However, the NBCF notes that only about 10 percent of individuals diagnosed with breast cancer have a family history of the disease. The Centers for Disease Control and Prevention note that a woman's risk for breast cancer is higher if she has a first-degree relative, including a mother, sister, daughter, or even a male family member, who have had the disease. But breast cancer can affect anyone, regardless of their family history.

Information is a valuable asset in the fight against breast cancer. Learning to decipher between accurate and false information can be especially valuable.

Breast cancer signs and symptoms

Breast cancer is a formidable foe. According to the World Health Organization, an estimated 627,000 women lost their lives to breast cancer in 2018. But women are not helpless in the fight against breast cancer, as the WHO notes early detection is critical and could potentially save thousands of lives each year.

A proactive approach is a key component of protecting oneself against breast cancer. While the National Breast Cancer Foundation, Inc.® notes that many breast cancer symptoms are invisible and not noticeable without a professional cancer screening, women can keep

an eye out for certain signs of breast cancer they might be able to detect on their own. Monthly self-exams can help women more easily identify changes in their breasts. During such self-exams, women can look for the following signs and symptoms and are advised to report any abnormalities they discover to their physicians immediately.

• Changes in how the breast or nipple feels: The NBCF says nipple tenderness or a lump or thickening in or near the breast or underarm could



indicate the presence of breast cancer. Some women may notice changes in the skin texture or an enlargement of the pores in the skin of their breast. In many instances, skin texture has been

described as being similar to the texture of an orange peel. Lumps in the breast also may indicate breast cancer, though not all lumps are cancerous.

• Change in appearance of the breast or nipple: Unexplained changes in the size or shape of the breast; dimpling anywhere on the breast; unexplained swelling or shrinking of the breast, particularly when the shrinking or swelling is exclusive to one side only; and a nipple that is turned slightly inward or inverted are some signs and symptoms of breast cancer that can affect the appearance of the breast or nipple. It is common for women's breasts to be asymmetrical, but sudden asymmetry should be brought to the attention of a physician.

• Discharge from the nipple: The NBCF notes that any discharge from the nipple, but particularly a clear or bloody discharge, could be a sign of breast cancer. The NBCF also advises women that a milky discharge when they are not breastfeeding is not linked to breast cancer but should be discussed with a physician.

Learning to recognize the signs and symptoms of breast cancer can increase the likelihood of early diagnosis, which greatly improves women's chances of surviving this disease.

Health screenings every woman should get

Routine wellness exams are essential for women who want to maintain and/or improve their health. Women may not be familiar with all of the screening options that can keep them on the right track.

Preventative health screenings can shed light on risks for certain diseases and provide insight into patient behaviors that may be harmful. Screenings also may help save a life.

Healthy diets and daily exercise are hallmarks of healthy people, but routine wellness exams are just as important. The following are some screenings women should include in their health and wellness routines.

• Blood pressure: Doctors will typically test blood pressure at every visit. Women whose blood pressure is below 120/80 mmHg can go every two years between blood pressure readings up until age 20, advises The American Heart Association. Adults 40 or older, or those with conditions that put them at risk for hypertension,

should go annually or as advised by a doctor.

• Cervical cytology: The American College of Obstetricians and Gynecologists recommends routine pelvic examinations with cervical testing that includes Pap testing and HPV testing. Consult with an OB-GYN for testing frequency, which depends on age.

• Cholesterol: Cholesterol levels alone are not indicative of one's overall health. However, a complete cholesterol test can determine a person's risk for heart disease. If levels are consistently normal, this test may only need to be performed every five years, advises the National Institutes of Health.

• Mammogram: Mammograms screen for breast cancer. Given the risk of false positives, debate continues as to how frequently women need these screenings. The most recent guidelines from the U.S. Preventive Services Task Force says mammograms are recommended starting at age 50, and should occur every two years. The

American Cancer Society advises starting at age 45 and having a mammogram annually through age 55.

• Blood-glucose test: The National Institute of Diabetes and Digestive Kidney Diseases says women should be screened regularly for prediabetes or diabetes beginning around age 45. Women can speak with their physicians to determine how often they should receive these screenings.

• Osteoporosis screenings: Bone density can be measured starting at age 65 or earlier if a woman has a high fracture risk, states Regis College.

• Skin examination: The American Academy of Dermatology suggests speaking with a dermatologist about skin exams. Self-examinations should be routine, but dermatologists may recommend more formal tests to women who meet certain criteria.

Women should speak to their doctors about personalized screenings based on family history and other risk factors.

Breast Cancer Awareness Month & FALL HEALTH

Learning breast anatomy is important for health

The well-known breast cancer advocacy and research group Susan G. Komen indicates that, according to the most

recent data available, 1.7 million new cases of breast cancer occurred among women worldwide in 2012. Western Europe, North America and northern

Europe have the highest breast cancer incidences in the world, according to the International Agency for Research on Cancer and the World Health

Organization.

Women diagnosed with breast cancer may want to begin their treatment journeys by educating themselves on the anatomy of the breast so they can better understand their disease and how it develops.

The structure of the breast is complex and comprised of fat, glandular tissue, connective tissue, lobes, lobules, ducts, lymph nodes, blood vessels, and ligaments. The following is a breakdown of the common components of the breast.

- **Fat cells:** The female breast is largely fat cells called adipose tissue. This tissue extends from the collarbone down to the underarm and across to the



middle of the rib cage. The main purpose of adipose tissue is to store energy in the form of fat and insulate the body.

- **Lobules:** Each breast contains several sections that branch out from the nipple. Lobule glands make milk and are often grouped together to form lobes. There may be between 15 and 20 lobes in each breast,

says the Cleveland Clinic. Each lobe has roughly 20 to 40 lobules.

- **Ducts:** Connecting the lobules are small tubes called ducts. The ducts carry milk to the nipples of the breasts. There are around 10 duct systems in each breast, each with its own opening at the nipple.

- **Nipple:** The nipple may be the most recognizable part of the breast. It is in the center of the breast. The lobules will squeeze milk into the ducts, which then transfer it to the nipples. Most nipples protrude outward, but according to Health magazine's medical editor Roshini Rajapaksa, MD, some women have flat or inverted nipples. The nipples do not have a singular hole for the milk to come out like an artificial bottle nipple. Rather, there are many lactiferous duct outlets in each nipple that correspond to the ducts in each breast.

- **Lymph system:** Snaking through the adipose tissue are lymph vessels and nodes. The lymph system distributes disease-fighting cells and fluids as part of the immune system, states the National Breast Cancer Foundation, Inc. Bean-shaped lymph nodes in fixed areas through the system filter abnormal cells away from healthy tissue.

- **Areola:** The areola is pigmented skin surrounding a nipple. The areola contains tubercles called Montgomery's glands, which secrete lubricating materials to make breastfeeding more comfortable.

Changes in any areas of the breast may be indicative of cancer. That is why women are urged to understand their breasts' "normal" appearance and feel so they can recognize any changes and address them with a doctor right away.

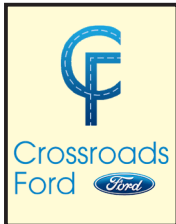

Fear of committing to your diet?

Three strategies to stay loyal to your diet when dining out

The right diet is an essential component of a healthy lifestyle. Once people get into a routine, maintaining a healthy diet can be simple. However, when such routines are interrupted, such as on nights out on the town, it can be much more difficult to stay the dietary course.

3 Say "so long."

Adults who dine out infrequently may not be adversely affected by the occasional indulgence in unhealthy fare. However, people who routinely dine out may need to be more selective, as certain foods, when eaten regularly, can increase a person's risk for high blood pressure, high cholesterol and other ailments. When dining out, the AHA advises diners to skip certain foods, such as bacon; salty meats; salty sauces, such as soy and teriyaki; French fries; white bread; white rice; and refined pasta, which is high in calories and low in fiber.

Dining out need not compromise a healthy diet. With a few simple strategies, diners can hit the town without derailing their diets.

What's old is new

Redburn Development will reopen old nightclub that frequently featured the likes of Frank Sinatra, Cab Calloway and Duke Ellington

ALBANY — Inside the expansive back room in the northwest corner of the old Kenmore Hotel hangs a drab, grey curtain concealing the last piece of history tied to the space.

The curtain protects a mural called “The Court of Cleopatra,” painted on the wall above a modest stage on which Frank Sinatra, Tommy Dorsey, Cab Calloway and Duke Ellington played. It’s a depiction of the Queen of Egypt, whose beauty was unparalleled and whose intelligence matched that of the powerful men she seduced, most notably Julius Caesar and Mark Antony. Its placement high upon the wall implied that this was the room in which the masters of the universe was expected to frolic.

The space is now in the midst of a

multi-million dollar renovation project that’s breathing new life to the North Pearl eyesore. Modern day Dapper Dons in hardhats expose the promise of a bright future, and at the same time enhance the ghosts of the hotel’s storied past.

When William Kennedy wrote about the Rain-Bo Room in “O’Albany,” he was still able to observe a piano on that stage. He imagined someone playing “Happy Days and Lonely Nights,” a tune Ruth Etting made popular in 1928, and a reported favorite of the Kenmore’s most famous resident, Jack “Legs” Diamond.

Diamond’s name was never mentioned during the press conference called by Redburn Development to announce the Rain-Bo Room’s intended rebranding as the Kenmore Ballroom. Nor would it be expected. He was a New York City mobster, whose charges included burglary, kidnapping and bootlegging. Nonetheless,



he was a celebrity.

Diamond’s vocation aside, his choice of haunts reveals that the Rain-Bo Room was Albany’s top nightclub during the Roaring Twenties. Stars of the Big Band area would flock up the Hudson River to play there, especially lured by the prospect of broadcasting their live performances on the radio.

“The Kenmore Ballroom is the heart

of this building at the heart of this development,” said Jeffrey Buell, principal of Redburn Development. “We want to fill the space with life, life that spills out into the surrounding streets and supports all of the Downtown.”

Katie O’Malley Maloney and her husband Nate Maloney will manage The Kenmore Ballroom.

O’Malley Maloney has her own long

"We are thrilled to be back in Albany and to be a part of the revitalization of Downtown" said O'Malley Maloney. "The Rain-Bo Room was once a vibrant centerpiece of Albany culture and society. We are excited to return the vibrancy of this historic space as the Kenmore Ballroom."

The Kenmore Ballroom will accommodate up to 300 people for a seated function. The ornate double staircase, demolished when the building was turned into offices, will be rebuilt as the

centerpiece of the space. It will also have a separate bar lounge and rooftop deck. For Elizabeth Young Jojo, she focused on the opulence of the room's past while choosing

all of its fixtures and accents.

"We chose an Art Nouveau inspiration," said Young Jojo, vice president at Redburn Developments. "That, mixed with some

super, super modern elements, as well." The Art Nouveau style was popular during the turn of the last century, a look characterized by curves and asymmetric shapes to provide the illusion of movement. The juxtaposition of elements, Young Jojo said, "I think will be very fresh, that there is no other space like that in the Capital Region."

"Projects like the revitalization of The Kenmore and its ballroom are transforming downtown Albany," said Albany Mayor Kathy Sheehan. "Thank you to Redburn for their commitment to Downtown, and to Katie O'Malley Maloney and Nate Maloney for believing in Albany and investing in Albany's newest neighborhood."

The Kenmore Building rehab project is part of a nine-building, \$82 million neighborhood revitalization that will bring 350 apartments and 11 commercial spaces to a three-block radius. The first phase of the multi-building project, The Knick at 16 Sheridan, will welcome new tenants this week. The Kenmore is expected to be open by October 2020.

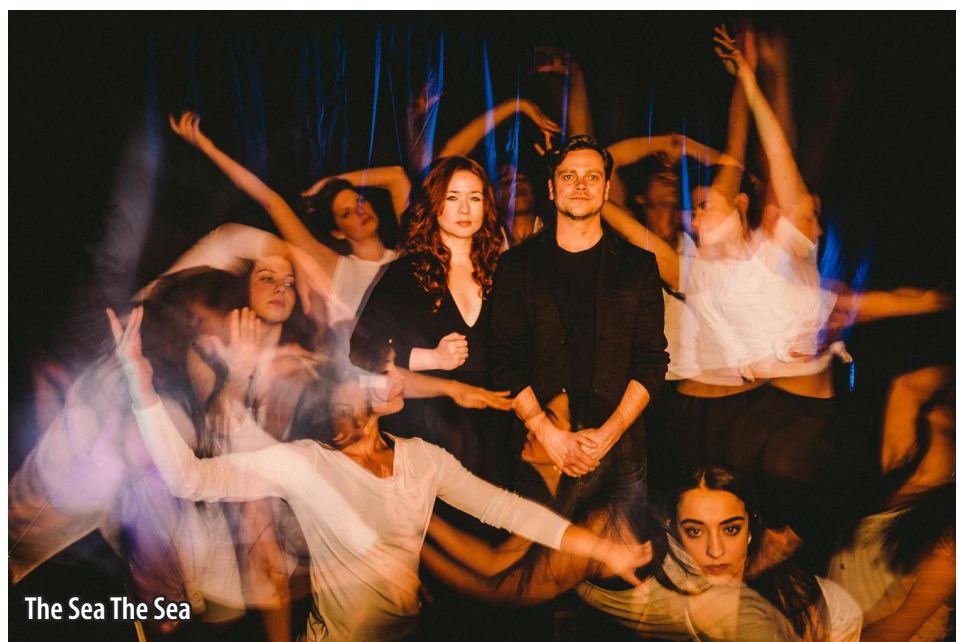

A story set to motion

“One day I was kind of getting anxious because I had put so much blind faith that this would work,” she recalled. “I spoke with my team and one of them mentioned that we should allow Dark Honey, a group of men, to tell the story from a man’s perspective. Instantly, I saw how great of an idea this was.”

Luckily, once Medina heard some of Dark Honey’s upcoming music, her fears evaporated. She said she was able to pull some “truly beautiful pieces” from the album.

“Originally I kept this pretty open-ended and it’s evolved into this,” Medina said. “What’s amazing is how every single person on this team, which is around 20 people [if you count the bands, the dancers, Chromoscope and the venues] knows what they need to do.”

Getting to Helsinki Hudson was another natural progression. Medina said all three acts have already performed at Helsinki, so when she pitched the idea to the venue, it jumped on board almost immediately. After renting out Cohoes Music Hall for the Friday after and one-night purchase from Proctors for the night before Helsinki, “Dark Blue Sea” has three homes.

O’Keefe and Dark Honey have been able to work closely in the area. Even though The Sea The Sea has been touring

the country all summer, the couple has been in “constant” contact with Medina through text and calls. Medina said she will send something to them and they will respond as soon as possible with super intricate, valuable feedback. While they aren’t physically present, they’ve been every bit as involved as their peers who have been home.

“This is such an elevated experience from every single one of us,” Medina concluded. “You’ll be seeing us as you’ve never seen us before. I don’t think we’ve ever put out this caliber of work. We’ve all pushed one another to create something amazing.”
