

### **Burglary**

**DELMAR** 

— A 37-year-old Schenectady man was arrested for a burglary-related incident at the Good Samaritan Nursing Home on 141 Rockefeller Road on Thursday, Oct. 3, at 12:30 p.m.

According to reports, the Bethlehem Police Department had been investigating a burglary where six types of medication were taken from a cabinet in the facility.

The missing medication were listed as a hydrocodone-APAP pill as well as hydromorphone, oxycodone, tramadol, oxycodone-APAP pills and guaifenesin-codeine syrup.

Fingerprints found at the scene helped identify the perpetrator as Robby Joseph Bialbowski, who had been fired from working at the facility in October 2015 "on bad terms."

Bialbowski was located at his Schenectady



residence at the aforementioned date by police where he was interviewed about the incident.

He allegedly denied being at the facility and said his fingerprints should not have been there.

He was nevertheless arrested and transported to BPD where he was arraigned before Judge Ryan Donovan. He has a scheduled return court date on Nov. 6.

Bialbowski was charged with burglary, criminal possession of a controlled substance and criminal misconduct.

### **DWI**

DELMAR — A

23-year-old Clarksville man was arrested on Friday, Oct. 4 at 11:52 p.m. in regards to a DWI incident in the area of 309 Delaware Ave.

Bethlehem police had observed a westbound black Honda Civic around the aforementioned area and it was traveling at 46 mph in a 30 mph speed zone.

When the officer had the vehicle pull over,

the operator identified himself as Thomas Andrew Hertel with his driver's license.

According to police reports, the officer noticed Hertel's bloodshot eyes and an odor of an alcoholic beverage from his breath.

He then passed one field sobriety test but failed the other

two, and a breath test tested positive for alcohol.

Hertel was placed in custody and transported to BPD where he agreed to submit to a chemical test; it revealed he had a BAC of 0.14 percent. He was then processed and released with a scheduled return court appearance on Tuesday, Oct. 15 at 12:30 p.m.

Hertel was charged with DWI with a BAC of 0.08 percent or more, a DWI misdemeanor and a speed in zone infraction.



# Gone but not forgotten

Elsmere firefighter, cardiologist dies at 67

ELSMERE — David L. Putnam, a firefighter, cardiologist and avid beekeeper, died on Tuesday, Oct. 8. He was at 67.

### **Background**

While the nature, time and location of his death have not been disclosed, Putnam, of Elsmere, was born on Dec. 29, 1951 in East Lansing, Michigan and was raised in Asheville, North Carolina, according to his obituary. He is survived by his wife of 43 years, Patricia C. Putnam; his three children — Emily Stalling, Jameson Putnam and Darroch Putnam — as well as his three grandchildren — Elliot Putnam, and Sonja and Laurel Stalling. His parents were Harold "Gordon" Putnam and Phoebe Putnam.

His obituary also indicated that calling hours were held from 3 to 7 p.m. on Friday, Oct. 11 at Our Lady of Assumption Church at 498 Watervliet-Shaker Road in Latham. A funeral mass followed in the church on Saturday, Oct. 12 at 12 noon. In lieu of flowers, people can make contributions in his memory to the Elsmere Fire Department, Adirondack Mountain Club, Catskill Bee Club or the Center for Donation and Transplant at Albany Medical Center Hospital.

Putnam graduated from the University of North Carolina at Chapel Hill in 1973, where he did his undergraduate studies and medical school, and also first met his wife. He then pursued his Internal Medicine and Cardiology Fellowship at Albany

Medical Center in 1977; he completed a Critical Care Fellowship at Ellis Hospital in and then received an MBA from Union College, both in Schenectady. Putnam later worked as a cardiologist at the Albany-based Capital Cardiology Associates, where he eventually became the medical director of the Blood Laboratories.

Putnam also spent

almost two decades with the Elsmere Fire District where he first joined as a social member in September 2000 and became an active member a month later. Besides being a volunteer firefighter, he later began serving as a medical advisor since 2009 and remained involved in the district until his death. He also served as a member of the Board of Directors at Delmar-Bethlehem EMS since 2013.

### Remember

Since passing away, Putnam has remained wellremembered by his peers throughout the Capital District.

Capital Cardiology Associates posted on Facebook that it "is deeply saddened by the passing of our partner, colleague, and friend, Dr. David Putnam. At this time, our thoughts and prayers are with his family and loved ones." Spotlight News reached out to the practice for further comment but did not receive any at the time of this publication.


The Elsmere Fire

Alexander J. Pope, the district's president, said Putnam "was one of the most approachable and friendly people, and he really had no problem with giving medical advice or just having a conversation. ... He made really great baked beans for the guys too and we're all really going to miss him. He was a wonderful man and a huge asset to the community and the fire district."

Speaking of baked beans, Putnam's colleague, Dan

# A hidden treasure in town

Town's Senior Services wants to help people age in place

#### BETHLEHEM —

While the town's Senior Services Department has long offered programs and information for residents aged 60 and up, its director, Jane Sanders, expressed concern, however, that not many people may even be aware of its existence or resources.

### **Background**

"We've always felt like we're the best kept secret in town but we don't want to be," Sanders said. "A lot of times, people don't look into Senior Services until there is a problem or an issue. People have come up to say that we have great things to offer yet they didn't always know we were

right here." She further compared the department's situation to how a person does not typically know about childcare services until they have a new baby and need them.

Senior Services is located at Town Hall on 445 Delaware Ave. in rooms 110 and 116. It is open on weekdays from

8:30 a.m. to 4:30 p.m.

Among the ways Senior Services communicates with the public about what it offers includes a section on the town's website, a bi-monthly newsletter and word of mouth. Bethlehem Town Board member Joyce Becker, who started helping the department grow in 1986 with founder Bethlehem Senior Services Department

Karen Pelletier, said she remembered she had been in charge of recruiting volunteers at the time as part of an overall dream "for people to age in place and live in Bethlehem."

She added, "Even to this day, I pick something out of Jane's newsletter and announce it at every single Town Board meeting." Senior Services, first created in 1978 by Pelletier who was a volunteer then, was originally under the Parks and Recreation Department. It separated from the latter in 1989 due to rising demand for services and programs. It has since grown to have a number of paid staff and more than 100 volunteers today; volunteers are recruited to help keep the department's costs low.

"Volunteers usually recruit other volunteers and we tend to have long-lasting staff," said Gerald Schimanski, Senior Projects' treasurer, who first got involved in 2004. Also, Sanders and Becker have been involved for 17 years and around three decades respectively.

Senior Projects, a non-profit organization, works closely with Senior Services to help with fundraising for things not within the latter's budget. Examples include helping to raise money for Senior Services vans and cars; paying for those drivers' hats, jackets, shirts and IDs; supporting the town's food pantry; and

paying for certain programs at the Bethlehem Public Library including the Coffee and Conversation series.

### Resources

Sanders brought up how the department — offering almost 40 programs and services — helps connect seniors with library programs, encourage them to go out for lunch, help with delivering groceries if transportation is difficult and keep things social by celebrating birthday parties and more.

Senior Services also offers financial, legal and utility assistance which can help seniors with enrollment for Medicarerelated health insurances and prescription drug plans; a grant program to help pay a household's energy bill in the winter months; a program to help with a household's insulation, weather stripping and furnace improvement; and the potential to help low-

# County proposed budget

**ALBANY** — County Executive Daniel P. McCoy's proposed 2020 \$732.9 million budget increases spending by nearly \$22 million but will not increase taxes.

If approved by the county Legislature, the tax rate will be \$3.51 per \$1,000 of assessed value, a 1.3 percent decrease from this year.

Included in the budget are raises for "virtually all employees," of about 2 percent, according to McCoy, which is in line with the contracts negotiated with unionized employees.

Three of the four county-wide elected officials would see bumps in their salaries of more than \$20,000. McCoy would see his salary increase from \$141,320 to \$163,900. Sheriff Craig Apple's

salary would increase from \$129,358 to \$149,900 and Comptroller-elect Susan Rizzo will see her salary increase from \$125,816 to \$145,900.

District Attorney David Soares' salary would remain at \$202,800.

timing of raises for elected officials are dictated by law.

"The sheriff, comptroller and county executive are only permitted salary increases during the start of the year after which they have been elected," she said in a statement. "In this case, that means in 2020 spokesman for McCoy said and then no salary increase

could happen again until 2024."

She said the district attorney's salary is required by state law to be equal to or higher than either the county judge or Supreme Court judge in a county.

The Legislature will now review the budget, hold hearings and make any modifications before approving the spending

"Large raises for elected officials and non-union employees are always controversial and the subject of review by the Legislature," said Legislator Paul Burgdorf, R-Colonie.

The budget, released on Wednesday, Oct. 9, funds 74 new positions including 18 in the Sherriff's Office, nine in the Public Defender's Office, seven in the District Attorney's Office, three in the Division of Alternate Public Defender's Office and five in the residential health

care facilities. There are 2,685 county employees.

This is the second year of the statewide implementation of the Hurrell-Harring indigent legal defense reforms McCoy fought for at the state level. An additional \$3.5 million will fund 30 new positions, including those in the Public Defender, Alternative Public Defender and 18-B Departments.

Also included in the budget are:

- \$250,000 for the rehabilitation of young offenders and help them avoid jail time.
- \$100,000 for Camoin Associates to create a regional economic development strategy.
- \$25,000 to help municipalities throughout the county with the 2020 Census.
- \$250,000 for the Albany County Land Bank, which has enabled more than 445 properties to return to the tax rolls and totaling \$26.1 million in assessed value of taxforeclosed real property since being implemented in

were not touched and have doubled to more than \$60 million in 2020 from \$30 million in 2011.

About 80 percent of the budget is mandated with 60 percent being state or federal mandates for things like social services.


"While we make Albany County a more affordable place to live and work for our families, this budget will allow us to continue the progress being made on the serious challenges they face each day," McCoy said in a statement. "Those include blight and divestment in underserved communities, social and criminal justice issues, the upcoming 2020 Census, continued economic growth in the region and so much more," continued McCov.

Chairman of the Legislature Andrew Joyce said he is happy there is no tax increase but is promising an "aggressive budget review schedule this month."

"Now that the Legislature has received the budget, it is our job to evaluate at what has been

submitted to ensure it's the best plan for governing efficiently in the upcoming

year and beyond," Joyce said. "The Legislature's focus this year is to ensure the County is fiscally stable for any potential economic impacts there may be in the near future so we can minimize any additional costs that could be passed on to residents."

The Audit and Finance Committee will kick off its annual review of the budget on Wednesday Oct. 16, at 5:30 p.m. in Room 730, at the county office building, 112 State St. in Albany. The Committee will meet with the county executive, comptroller, county clerk, district attorney, sheriff, coroners, comptroller and management and budget personnel.

The Audit and Finance Committee will hold four additional budget sessions with county departments on Oct. 16, 23, 24 and Nov. 6 with two public hearings scheduled on Tuesday, Oct. 29, and Tuesday, Nov. 19.

## Race candidate sheds light

Information came to light in his own letter to the editor

BETHLEHEM — In March, town highway superintendent candidate Marc Dorsey submitted a Letter to the Editor to clear the air on issues stemming from an arrest in Albany in 2003. Since then, he's been

asked to clarify those facts. Two decades ago, Dorsey was on a different career path than the campaign trail he currently finds himself.

Dorsey was finally pursuing a law enforcement career after a decade working under both the International Union of Operating Engineers and the United Brotherhood of Carpenters. It seemed like the right path. His father had spent years with the Bethlehem Police

Department.

Dorsey's time behind a badge started with two part-time positions split between the town of Coeymans and the village of Altamont. Altamont soon promoted him to a full-time officer in September of 2002. He anticipated a lengthy career. A year later, however, he was arrested in Albany on a misdemeanor stalking charge. On Dec. 4, 2003, two days after the arrest,

Dorsey was suspended from the force without pay.

That's how people often remember the story. Dorsey has spent the last 15 years having to share the rest.

"As soon as someone was to Google my name they are going to see that I was arrested — all charges were dismissed without prejudice — but [I wanted] to get it out there," said Dorsey.

After earning the Bethlehem Democratic Committee's endorsement in February to run for town highway superintendent, Dorsey submitted a letter to the editor to Spotlight News.

"I would like to share how an unfortunate event positively shifted my career path," he stated. "In 2003, my then-girlfriend began exhibiting unhealthy behaviors that had me concerned." In a recent interview, Dorsey said he found she was abusing drugs. It was a situation he said surprised him. When he confronted her about the issue, he said she denied it. He said he later addressed it with a member of her family, an Albany police officer.

"We didn't get along so well," Dorsey said. He said that her relative convinced her to press charges on him. "He told her to say it was domestic violence. Domestic violence is one of those laws in which you have to do something. You have to make an arrest."

Dorsey was arrested and suspended from the Altamont Police Department. According to a Bethlehem police report, his pistol permit, and his Ruger and Glock pistols were confiscated for safekeeping as he awaited

The case, however, never went to trial.

The City of Albany denied a FOIL request to obtain details of the Dec. 2, 2003 arrest. Upon appeal, it was learned that all information was sealed by the order of the Albany City Court. Dorsey, though, showed Spotlight News a copy of the court documents. That record stated that charges against him were "dismissed without prejudice" on June 23, 2004, due to significant deficiencies. Dorsey's

accuser was not identified. She died several years later, he said.

"I tried to help her. It did not work. She's no longer with us."

Dorsey was not automatically reinstated by the Altamont Police Department when charges were dropped. When he applied for reinstatement, it was beyond the four-month window allotted to him. A lengthy court battle ensued. The state Appellate Court sided with the village, and he was never reinstated.

"It's one of those things that taint your name," said Dorsey, in reference to the arrest. "My career was — I probably would have gone very far into law enforcement — and that kind of thing just taints it. Any department now will think, 'there must be something wrong with him."

The Bethlehem Democratic Committee considered Dorsey as its candidate for town highway superintendent earlier this year. Joanne Cunningham, the committee's chairwoman, said she was aware of the arrest and the executive committee proceeded with an "extensive" vetting process before recommending him to the BDC.

Though Dorsey said he provided a written explanation to the executive committee, several members of the BDC claim they were not aware of the arrest before voting him in as the party's candidate.

Cunningham confirmed that details of the arrest, and dismissal of charges, were not shared by the executive committee before it handed down its recommendation to the general committee. Through the executive committee's vetting process, she said she sought the insight of a very high level individual" in law enforcement."

"The person made me comfortable that Marc's accounting of things was consistent from a law enforcement standpoint," Cunningham said.

As Dorsey walks the campaign trail across town, he said people continue to ask him about what happened in Albany and Altamont.

"Even though I don't need to say anything — all charges were dismissed — I want to be upfront."

### Not forgotten

Sutherland, who was a fellow Elsmere firefighter from 1998 to 2015, said Putnam "used to make things like baked beans and pork, and he liked to cook for the firefighters after drills.

Fellow firefighter Joe Catalano explained that every year, the district's president assigns four to five people as a food committee to make food every month for the remaining firefighters after drills. "A couple of weeks ago, [Putnam] came up with potted chili in a crockpot with ghost pepper honey, and it was so hot and fantastic," he said. "He always took his responsibility extremely seriously and he took pride in what he did."

Jim Foster, another Elsmere firefighter and a Bethlehem Town Board member, said, "It was always a pleasure to be around [Putnam] and I liked the little things like how he made baked beans or ham from scratch. I was probably sitting on a fire call with him within the

past two months and he was still so active and great to be around."

Steve Kroll, the chief and executive director at Delmar-Bethlehem EMS, said he remembers how Putnam would show him and his peers photographs of his grandchildren before meetings. "He was brilliant, caring, community-minded and fun," he said. "There will now be an empty spot in our table which will be very hard to fill. We're not even thinking of that process to replace him yet. Right now, it's in his memory."

Beyond Putnam's work as in cardiology and firefighting, some of the men mentioned how he was a beekeeper too, especially Sutherland.

While Sutherland said that he and Putnam grew very close for almost 20 years, he recalled casually talking about how he had his own apiary last year while Putnam happened to have his own collection of bees too. "We then started getting involved in beekeeping together and we have over 260,000 bees which are classified as livestock," Sutherland said.

"We kept honeybees and produced honey and my apiary is still here and I'm still caring for his bees."

### Final thoughts

All five men agreed that Putnam's death came as a surprise to them since he had been physically active and healthy.

"The reaction was shock from so many people," Catalano said. "He was perfectly healthy and pretty young. We couldn't imagine how it happened." He added that as a cardiologist, Putnam often educated his peers about the risks of heart attacks, cardiovascular disease and stress, which can affect many firefighters.

While Pope similarly said the news felt "so sudden," Foster said the fire district is mourning the loss of a "valuable and dedicated member."

Kroll concluded, "I think we were all devastated when we learned that such a young, vibrant person was gone. He had so much to give and he gave so much to so many people and we'll have that forever. He made us all better people and we're all very sad."

income people with their telephone bills. Certain qualifying seniors can also have food stamp assistance, Farmer's Markets coupons, and access to the Bethlehem Food Pantry — the latter is only available by appointment for emergency or temporary food needs.

Seniors can also access health and wellness programs, like help with their prescription costs, listening to visiting guest speakers regarding health, and a brochure about senior physical exercise programs. In addition, the department can provide information on in-town housing options and connect seniors with social groups for networking and support. Seniors can also take advantage of special day trips for dinners, theater shows, monthly shopping center trips and more.

"Without a doubt, every person who has continuously used our services say, I don't know how we got around without these services," Schimanski said. "They're so thrilled that there's something out there and their kids or grandkids don't have to drive them around because they're doing their own things."

Regarding his latter point, Sanders noted that transporting seniors throughout town for their errands or medical appointments is one of the department's

highlights. She said the department currently has five cars and four vans, two of which are wheelchair-accessible.


"All the current vans are in need of replacement. The vans are pretty much the same age and at the height of their mileage," Sanders said, adding that the vans have a lifespan of eight to 10 years. "The town is purchasing a new van in 2020 if the town budget passes. Senior Projects will be purchasing a new van in 2020 too through a grant because we need it and separately, before the end of this year, we have an extra van that's already on order."

While Sanders added that Senior Projects has plans for a future fundraiser to help buy a van next year, Schimanski said each van would cost around \$65,000 and Becker said it would take about a year to raise the needed funds and at least another six months to receive an ordered van.

### Reflection

"We're here, call us, stop by. We know all the resources around," Sanders said. "It's our goal to help people age in place." Schimanski connected this with the department's motto, "Community-Engaged as We Age."

Becker chimed in and said it's important for people to research what their respective town offers in terms of resources and programs. Regarding working at Senior Services, she added, "It sounds so easy but it takes a lot of work. ### A hero laid to rest

Currey's death was announced in a Facebook post on the day he died by the Delmarbased Nathaniel Adams Blanchard Post 1040 of the American Legion, which he had been involved in. "Our Post's highest-decorated member Congressional Medal of Honor recipient, Francis S. Currey was called home to the lord. He passed this morning," it read. "May he rest in peace! A truly great man! ... Thoughts and prayers to his family!"

According to his

obituary, Currey, of Selkirk, was born in Loch Sheldrake, New York on June 29, 1925 and joined the U.S. Army when he was 17, just one week after graduating from Hurleyville High School. While he later became a technical sergeant, he was an automatic rifleman with Company K, 3rd Battalion, 120th Infantry, 30th Infantry Division.

According to the Digital Collections of the National WWII Museum, on Dec. 21, 1944, Currey risked his life when German

direction in Malmedy, Belgium during the Battle of the Bulge.

In a 2011 filmed special by Medal of Honor, Currey recalled how he and his platoon had been ordered to defend a bridge near the aforementioned Belgian town, and one morning, numerous German tanks arrived. Currey said he tried to shoot at one of the approaching tanks' commanders who had stood up and saw him. After failing to stop his tank which then crossed the bridge, Currey said he went to engage in a standoff in a nearby factory building.

He shot at a tank with a bazooka, rendering it

a tank. All it does is hit the tank, makes a hell of a noise, a lot of flames, a lot of smoke but it scares the hell out of the crew and they abandoned the tank. They gave me credit for all three tanks because they abandoned them.'

This led to the Germans falling back due to losing more tanks and increasing

> Currey was just 19 at the time. "I hope that my country can be as proud of me as I am proud of my country," he said.

Currey's heroic actions earned him the Medal of Honor the highest and most prestigious

decoration for an outstanding U.S. military service member for acts of valor — and has been said to win the battle and shorten the war. He also received the Belgian Order of Leopold, a Silver Star, a Bronze Star and three Purple Hearts. A July 14, 2006 article by the *Times* Herald-Record reported that a GI Joe action figure was crafted in his image back in 1998.

The National Medal of Honor Museum posted on its social media platforms that it has extended "heartfelt condolences to his friends and family and remain grateful for

his service." Gov. Andrew Cuomo directed flags to be flown at half-staff on state government buildings on Friday, Oct. 11 in honor of Currey.

Spotlight News has reached out to Currey's family and the American Legion Post 1040 Nathaniel Adams Blanchard Post for comment but did not receive any at the time of this publication.

After the war, Currey became a counselor at the Albany VA Medical Center for three decades, retired in 1980, moved to Bonneau, South Carolina and returned to Selkirk in

Throughout the Capital District, he was a South Bethlehem Volunteer Ambulance Service volunteer, a Hudson Valley Little League coach, a Bethlehem Conservation Committee member as well as being involved in the RCS Men's Association, Cornell Cooperative Extension, the American Legion Post 1040 Nathaniel Adams Blanchard Post and the Albany-based VFW Sheehy-Palmer Post 6776.

Currey is survived by his wife of 70 years, Wilma Eileen French Currey; his children, Michael, Kathryn, Domery and Jonathan Currey; his grandchildren Jessica Moran, Kyleen D'Ambrosio, Diane Lammers, and Christopher, James, Kevin and Travis Currey; and 12 greatgrandchildren.

immobile and forcing its men to abandon it; he then shot three German soldiers in a nearby house's doorway. Although it hasn't gotten much attention, our roads and highways will get a lot more dangerous if Gov. Cuomo signs legislation (by Oct. 12) that would upend New York's longstanding and successful driver safety program by allowing untested out-of-state internet companies to provide online-only training that replaces the in-classroom five-hour driver's licensing requirement of first-time drivers.

My family-owned driving school has trained thousands of students since 1971 and I can tell you from first-hand experience that nothing can replace face-to-face interaction and real-life discussion with trained instructors. In the classroom, they learn how their reactions are affected by distractions

like cell phones and how alcohol affects their reflexes. In fact, it's very common in the classroom instruction for a person who has gotten a DWI to share their experience as a teaching-moment, which can be very emotional and impactful that's a lesson you simply can't learn on

If this becomes law, New York would be rolling the dice on public safety and no technology is worth the price of putting lives at risk - the governor should veto this bill.







# One step closer for co-op

Electric City Food Co-op is working with developers to find a home in Schenectady

**SCHENECTADY** — The Electric City Food Co-op is seeking proposals from landowners and developers for a location for a full-service, community-owned grocery store within the downtown area of Schenectady, that is walkable, bikeable and near a bus line.

Since September, the RFP has been distributed to a number of local developers and real estate agents and is available for viewing and downloading at the ECFC website. The deadline for submissions is Dec. 15, at 5 p.m.

We are very excited to be launching this next phase for the Electric City Food Co-op, actively searching for a great location, said Brian Brosen, ECFC Site Selection Team Lead and Broker for The Capital Team at eXp Realty. "We look forward to sitting down with property owners and developers to bring the dream of the ECFC closer to fruition for the city of Schenectady and beyond."

Last December, a market study was conducted by a consultant that specializes in food co-op startups and has maintained a high degree of accuracy with forecasts. The market study report confirmed that Electric City Food Co-op could be successful, with a projection of over \$3.5 million in sales in the first year, with a 2 to 3 percent increase in sales per year – with the right location.

The Co-op is currently in stage 2B of its plan which entails securing a location, planning a capital campaign, finalizing finances and hiring a general manager.

Currently, the ECFC has 360 members and is in the midst of a "30 in 30" recruitment campaign for the month of October. The Co-op aims to register 500 member owners by the end of the year.

"Momentum is really building, we can definitely see a clear path to reaching our goal of 500," said board member Adine Viscusi, owner of Casa Visco. The ECFC has established numerous events during October to increase the organization's visibility and field questions from potential members, including the annual Farm to Fork dinner at the Mabee Farm Historic Site, and a meet and greet at Tara Kitchen. Additional membership drive events will continue to occur in November and December of this year as well.

The Electric City Food Co-op was organized by its founder Katherine Wolfram in 2013 to bring a community-owned, one-stop grocery market, featuring local and bulk foods, to the downtown area of Schenectady.

**ALBANY** — The plate of hard boiled eggs at the beginning of "Napoleon Dynamite" is about to be shattered Thursday when two main cast members visit The Egg.

"Napoleon Dynamite" will screen tomorrow (Thursday, Oct. 17) at the The Egg's Hart Theatre at 6:30 p.m. A full screening of the movie will precede a moderated, freewheeling discussion from Jon Heder (Napoleon) and Efren Ramirez (Pedro). Tickets range from \$35 to \$100.

The independent movie caught people by surprise when it hit the theaters 15 years ago. A high school comedy that catch all of the horrible aspects of 80s and early 90s pop culture. Surprising behavior towards the Tony Award-winning actor, who originated the role of Danny Zuko in the stage production of "Grease." He later earned his hardware for Best Actor in a Musical in "The Robber Bridegroom." He earned a Golden Globe for Best Supporting Actor in the 1989 television mini-series "War and Remembrance." He also has the distinction of portraying George Washington twice, earning a Peabody Award in the process.

The night will include Bostwick, his underwear, Bostwick in his underwear, singing, costumes and virgin shaming.

Bostwick plays a straight-laced, "young Republican" in Majors, who plays opposite to Susan Sarandon's Janet Weiss. The two are a newly engaged couple who happen upon a castle as they try to find help when their car suffers a flat tire on a cold, rainy night in the country. In the castle, they stumble upon a peculiar convention of people that includes

Tim Curry's Dr. Frank-N-Furter, a sweet transvestite from Transexual, Transylvania.

People have tried to tie the film's popularity to the LGBT movement. Just the mention of the film conjures either Curry's ruby red lips or his legs in fishnet stockings and suspenders. There's also some noteworthy bedhopping throughout the movie, too. But, Bostwick said he does not believe that was anyone's intent when the movie was made.

"It's just sex, drugs, and rock and roll," Bostwick said. "You can't go wrong with that. Every generation is drawn to that kind of freedom, and to that pure enjoyment and fun.'

"The Rocky Horror Picture Show" has been an

interactive experience for more than 40 years. Critics hated it when it was first released in 1975. But, it quickly developed into something of its own through midnight showings in New York CIty and Pittsburgh. In Greenwich Village, patrons of the Waverly Theater took to talking back to the screen while dressed as a character from the movie. It was the start of the "shadow cast."

The origin of the shadow cast is credited to the King's Court Theater in Pittsburgh. In addition to dressing in character, audience members would quietly perform in front of the film while lip-synching dialogue. The idea caught on in other cities and has evolved over the years with fans shouting back lines not in the film; for example, the habit of calling Bostwick an "a-hole" whenever his Majors appears on screen.


> The rebellious audience behavior paired with the make-up and cross dressing theme shared by the music world have married the film to punk. Bostwick said some inspiration was drawn from David Bowie's androgynous stage persona, Ziggy Stardust. Since then, pairing an elegant top hat or military jacket - symbols of conformity and order juxtaposed with studded leather and ripped clothing has been a staple in punk music.

"The movie has a certain element of innocence that I think people are drawn to," Bostwick said. "They can see themselves in one character or another, and they can throw crap at themselves."

Rocky Horror is the longestrunning theatrical release in film

history. Bostwick has attended a countless number of shows. To the shows in which he's expected to attend, fans know they will find him selling autographed pairs of "tighty whities." For him, it's been a career full of wonderful contrasts. This holiday season, you can expect to see him in a Hallmark movie dressed as Santa Claus.

"I've done really wonderful, crappy things and honest, honorable things," said Bostwick, now 74. "It's what keeps me interested in doing what I do. It's never just one thing. I love to sell my underwear at these things because I like to see people laugh... They'll look at my underwear — I have it framed in a shadow box I bought at Goodwill — but, then they'll look at a picture of me as George Washington... next to my underwear."







What to know about food portions

ortion control is a big part of a healthy diet. In fact, the National Institute of Diabetes and Digestive and Kidney Diseases notes that, when it comes to maintaining a healthy weight, how much food a person eats is just as important as what he or she eats.


# What if I am still hungry after reducing portion sizes?

It's likely that people accustomed to big portions will still be hungry as their bodies adjust to reduced portion sizes. In such instances, people can try taking more time to eat. Even if there's less food on the plate, eating slowly gives the brain a chance to receive the message that the stomach is full. According to the NIDDK, it can take as long as 15 minutes for that message to make its way to the brain. Eating slowly reduces the risk of overeating, and you may even be surprised to learn that a smaller portion size than you're used to is all you really need to feel satisfied.



ew dessert pairings are as beloved as chocolate and peanut butter. These are strong flavors that are coveted on their own, and especially so when eaten together. When packed in a decadent terrine, peanut butter and chocolate take indulgence to new

Whether hosting a gathering at home or preparing a dessert for family, this recipe for "Chocolate-Peanut Butter Terrine with Sugared Peanuts" from "Classic Stars Desserts" (Chronicle Books) by Emily Luchetti is sure to please. For best results, use chocolate with 58 to 62 percent cacao, rather than a chocolate of

higher percentage.

Chocolate-Peanut Butter Terrine with Sugared Peanuts

### **Ingredients: Yields eight servings**

#### Terrine

- ounces bittersweet chocolate, finely 11 chopped
  - ounce unsalted butter 1
  - tablespoons creamy peanut butter 6
  - 4 large egg yolks
  - cup granulated sugar

### 13/4 cups whipping cream

ounces bittersweet chocolate, finely chopped

21/2 ounces unsalted butter

teaspoons light corn syrup

### **Sugared Peanuts**

- large egg white
- tablespoons granulated sugar
- 11/2 cups unsalted peanuts

Spray an 81/2-by-41/2-by23/4-inch loaf pan with nonstick spray. Line the sprayed pan with plastic wrap, allowing a 11/2-inch overhang on all sides.

In a stainless-steel bowl, combine the chocolate, butter, and peanut butter. Place the bowl over a pan of simmering water, making sure the bottom of the bowl does not touch the water. Heat, stirring occasionally, until the chocolate and butter melt. Remove from the heat and whisk until smooth.

Combine the egg yolks and sugar in the bowl of a stand mixer fitted with the whip attachment and whip on high speed until thick, about 1 minute. Remove the bowl from the mixer stand. Using a wooden spoon, stir in the chocolate mixture in 3 equal additions. The mixture will be quite

In a separate bowl, whisk the cream until it starts to thicken. Using a spatula, fold the cream into the chocolate mixture in 4 equal additions. Spread the batter in the prepared pan. Cover with the plastic wrap overhanging the sides and refrigerate until firm, at least 4 hours.

To unmold the terrine, fold back the

plastic wrap and invert the pan onto a wire rack. Pull on a corner of the plastic wrap to release the terrine from the pan. Lift off the pan and carefully remove the plastic wrap. Line a baking sheet with parchment paper and place the rack on it. Return the terrine to the refrigerator while you make the glaze.

To make the glaze, in a stainless-steel bowl, combine the chocolate, butter and corn syrup. Place the bowl over a pan of simmering water, making sure the bottom of the bowl does not touch the water, and heat, stirring occasionally, until the chocolate and butter melt. Remove from over the heat and whisk until smooth. The glaze should be pourable but not so thin that it will run off the terrine. If the glaze is too thin, let it sit at room temperature for about 30 minutes.

Slowly pour the glaze evenly over the top of the terrine, allowing it to stream evenly down the sides. With an offset spatula, spread the glaze to cover the terrine smoothly and completely. Refrigerate until the glaze is set, about 30

To make the sugared peanuts, preheat the oven to 350 F. In a bowl, whisk the egg white until frothy. Whisk in the sugar. Add the peanuts and mix until they are evenly coated with the mixture. Spread the peanuts in a single layer on a rimmed baking sheet and place in the oven. Toast the nuts, stirring them every 5 minutes, until dry and golden brown, 15 to 20 minutes.

To serve, transfer the terrine to a serving platter and arrange the sugared peanuts on top. Cut the terrine with a hot, dry knife.



"Joker" delivers poignant view at serious mental illness

et me start this off by saying I'm a massive fan of the Joker character. He is by far my favorite of the D.C. Comics villains and superheroes. Why? I don't know. I've always been drawn to the character and after watching Heath Ledger's amazing take on the killer clown, I was definitely hooked. I wasn't a fan of the Jared Leto take in "Suicide Squad," so to hear the Joker was getting another go, this time one that would do the character some real justice, is phenomenal.

When I heard about "Joker" earlier this year, I was stoked; I was texting my best friend and dancing in my room. Those teaser trailers, though! I've had a countdown on my phone since I saw the first trailer. It doesn't help my cause that I'm a massive Joaquin Phoenix fan as well. Last Friday, my brother and I finally had a mutual night off and we took to the movie theater to catch the movie of the year.

Boy, oh boy, is it the movie of the year. In my opinion, we're looking at a major Oscar contender.

Let me just stop you right here: if you want to compare and contrast Joaquin Phoenix and Todd Phillips's take on the clown with that of Christopher Nolan and Heath Ledger, you can't. Ledger was playing a fully formed, criminal character of uncontrolled chaos. "Joker," and Phoenix's performance as the mentally ill, down-on-his-luck Arthur Fleck, demonstrates the descent into madness that the Joker is all about. As Fleck shows us, sometimes people are one bad day, one bad train ride, one bad conversation from becoming unhinged. To compare Ledger and Phoenix is unfair to both. Each did the role a massive justice and displayed

confidence and competence with the character at hand.

What "Joker" really did for me was shed some much needed light on the rampant appearance of serious, untreated mental illness in this country. Fleck is sick; there's no denying it. As he visits his countyappointed doctor for his seven medications and asks for an increase because "all [he has] are negative thoughts," you're saddened by the lack of help for the mentally ill. As he continues his downward spiral, you see where the system, and Fleck himself, could have stepped up and saved the next disaster in multiple occasions, but it isn't stopped. Mental illness is a slope and those who are afflicted often don't know how far they've slipped until they can't get themselves back up.

Everything about this movie was well done. The slow progression of Fleck's illness (and I do mean slow, you don't actually meet the Joker until almost the end of the two-hour-plus movie), the building tension, the inevitable crash is all what great cinema is about. While this isn't as action-packed as its cousins like "The Dark Knight," each scene and each line is needed. The violence, while graphic and disturbing for some viewers, is necessary and quite honestly, not obnoxious. It makes sense and the depravity of the circumstances not only gives the viewer an idea of what's gone wrong, but where 'Joker" is heading.

If you've been mulling over seeing "Joker," I recommend taking a night out and seeing it. Even if you end up not liking the movie, you might walk away with a much bigger picture of a major problem that needs righting in our society. Rarely does a fictional movie speak so successfully about a larger, real problem, but I think the team behind "Joker" has executed it.




