BETHLEHEM — Town residents will head to the polls next Tuesday, Nov. 5, to determine who sits on the board, and who controls the highway

up for grabs next Tuesday

Technically, Supervisor David VanLuven's job is on the line, but he's running uncontested this year,

which all but puts him back in Town Hall for another two years. Also running uncontested is Nanci Moquin, the town clerk.

Republicans are pushing to add

Re-Elect

another representative on the board to join Jim Foster. Jim Carriero is the party's lone representative vying for a seat on the Town Board. He runs against incumbents Joyce Becker and Daniel Coffey.

It's essentially deja vu for voters who decided a Coffey-Carriero race last year, as both jockeyed for the 12 months remaining out of the four-year position left vacant once VanLuven transitioned from the board to supervisor.

Inside this week's edition of *The Spotlight*, this year's candidates share both their ideas and concerns for Bethlehem, and why they believe they have the answers to the questions the town will face in the coming years.

# Thefts from parked vehicles

## BETHLEHEM —

Bethlehem police are investigating multiple reports of thefts from vehicles parked at the Elm Avenue Park on Wednesday, Oct. 23.

According to reports, the incidents happened between 4 and 6 p.m. and the suspects broke the vehicles' windows to steal valuable items that had

been in plain sight.

BPD Commander Adam Hornick said such items included purses, wallets, credit cards and cash; it is not known yet how much value the stolen items were though.

Initial witnesses told police they saw two males, one of whom had braids in his hair and wore a white T-shirt, breaking into a vehicle to steal items.

They then allegedly fled in a dark-colored Mitsubishi SUV.

Hornick said the police have not confirmed their approximate age range or any other specific physical descriptions yet.

"Unfortunately, we see things like this happen a couple of times a year between places like the town park, gyms and fitness centers, the YMCA, daycare centers and retail stores," Hornick said.

"Because those are the places people go that they don't bring all their items with them. For example, if you go to Price Chopper, you stop and bring your purse or wallet with you. But when you stop to see a football, lacrosse, soccer or basketball game, people don't always bring their stuff with them from their vehicles."

Looking ahead, Bethlehem police recommends that residents take the following proactive steps:

- Always lock your vehicle
- Keep valuable items

out of plain sight, like putting them under seats, in compartments or in the trunk

- Bring your wallet and cellphone with you when you leave your vehicle behind or lock them in compartments
- Be aware of your surroundings all the time as these incidents often happen after a suspect watches you

# Learning history through illustrations

Popular illustrator speaks to BC students about art and history

#### BETHLEHEM —

Bethlehem Central Middle School students discovered that history books are not the only way to learn about world history — illustrations work too.

Acclaimed illustrator and author Vesper Stamper visited the school for an art class and presentation on Tuesday, Oct. 22 to speak on how she illustrates historical fiction novels, gets inspiration from real-life world events and how art can start a genuine conversation about topics like humanity, discrimination and dignity. Speaking before a packed auditorium of students as part of their social studies curriculum, Stamper also

talked about her education and the creative process behind her recent 2018 young adult book, "What the Night Sings."

The book revolves around Gerta, a teenaged Holocaust survivor, who lost her family and the life she knew in Nazi concentration camps during illustrations, the learns that libe not necessarily better for Ger has to stay in a persons camp.

World War II but she has to learn how to rebuild herself and rediscover her Jewish faith after liberation. With hauntingly beautiful illustrations, the reader learns that liberation does not necessarily make things better for Gerta as she has to stay in a displaced persons camp

"What the Night Sings" has been nominated for a National Book Award, a finalist for a Morris Award, recognized among the Golden Kite Honor Books under young adult fiction, won the Sydney Taylor Book Award, named best young adult book of 2018/2019 by Young

"Let me ask you this question: Would you rather be safe or strong? That made me really think when I did this book."

# Vesper Stamper, author and illustrator


Adult Library Services Association, and noted by the Wall Street Journal as one of 2018's best children's books.

The students learn that "What the Night Sings" is more than just an illustrated novel; it deals with heavy themes like World War II, the Holocaust and its aftermath, genocide, concentration camps, Judaism and anti-Semitism. Stamper said that while many Americans know about World War II, not

many would recognize infamous concentration camps like Auschwitz and the reality for many displaced people after liberation.

Similar to the events in her book, Stamper brought up that Bergen-Belsen, one of the reallife concentration camps located in Lower Saxony, Germany, was turned into a refugee camp after it was liberated in April 1945. Despite much hopelessness among the displaced people, she said, "By June, teachers started a kindergarten there, less than three months after people were dropping dead there. I just was fascinated by this because the reason why they were still in the camp is because all their relatives had been murdered and their homes had been taken over. ... There was still rampant anti-Semitism all throughout Europe and people would attempt to

# BETHLEHEM —

One Town Supervisor, one Highway Superintendent and two Town Board positions are up for grabs this year. Early voting began on Saturday, Oct. 26 and residents can continue on Election Day on Tuesday, Nov. 5.

The Town Supervisor, Highway Superintendent and a Town Board member each serves a term of two years, two years and four years respectively. According to SeeThroughNY, an online resource for town positions' payrolls, in 2019, the annual salaries for the Town Supervisor, Highway Superintendent and a Town Board member are \$118,562, \$104,476 and \$15,643 respectively. These are estimated data though.

Of the six running candidates, four are incumbents seeking re-election: Democrats David VanLuven (Town Supervisor), Joyce Becker (Town Board member) and Daniel Coffey (Town Board member); and

Republican John Anastasi (Highway Superintendent). The remaining two have not held office before: Democrat Marc Dorsey (Highway Superintendent candidate) and Republican James Carriero (Town Board member candidate).

# Town Supervisor David VanLuven (D, WF, I)

David VanLuven first assumed this position in January 2018 and had been a Town Board member prior from 2016 to 2018.

VanLuven has a

background in ecology, urban and environmental policy, biology, working with nonprofit and government organizations, and budget maintenance. Moving to Bethlehem in 2001, VanLuven said he grew up in Park City, Utah which was transitioning from a silver mining town to a ski resort and he recalled being concerned that "millions of acres of natural forests and private lands" around him would be redeveloped eventually.

He said this helped inspire him to commit much of his career to protecting the environment, something that has applied to his current position like seeing the creation of the Farms and Forests Fund, working with interested landowners and collaborating with organizations like the Mohawk Hudson Land Conservancy — to address rising development too.

"It takes time to get things done and we've got a lot to do in town," VanLuven said, explaining why he's seeking reelection. "We've started our comprehensive plan process but that's going to take time to complete and looking to have it done by late 2020. But then, we need to implement it and that takes time too, and adapt our codes to keep the small town feel and hamlets'

characters."

He brought up the importance of making each hamlet feel included in Town Board matters, like the comprehensive plan process where public forums were held at each hamlet in the past year for the Town Board to hear residents' desires and concerns. "Selkirk and South Bethlehem often feel forgotten and we've been working very hard to improve communication lines and provide services they need," he said. "The Town Board views it all as one Bethlehem but each has different needs and personalities, and we should celebrate, not homogenize,

VanLuven said he wants to help the town continue to oversee major ongoing projects like continued investment in water infrastructure, the Elm Avenue Park Dive Pool renovations, the Clapper Road Water Treatment Plant works, the Glenmont roundabout and the Delaware Avenue Road Diet. Regarding the last project, he said, "It's looking to be done by 2022 so we've got two years to lay down a communication strategy

that we need to ensure our businesses are supported by residents during construction and that construction is designed in a way to minimize challenges for those businesses. We're taking it very seriously, working with the Chamber of Commerce and a professional consultant soon."

Connecting this with the importance of transparency with residents, VanLuven said, "People, not the town, deliver services. We need to appreciate, invest and celebrate such people for providing clean water and leaf pick-up."

Looking ahead, he envisions Bethlehem to be a more walkable town with increased connectivity and community spirit-minded businesses. "I am incredibly fortunate to have this job," he said. "I want us to continue doing well and find ways to do better. We still have a lot to do."

# Highway Superintendent

John Anastasi (R, C, I)

John Anastasi first assumed the position in January 2018. He was raised in Delmar, graduated from Bethlehem Central High School and pursued construction technology at Hudson Valley Community College in 1979.

Anastasi's background



in construction predates his college days as he said he grew up helping his father, a local developer and general contractor, to buy land, establish roads, build houses and install infrastructure. "I helped with the layout and I was hands-on with blueprint readings, and at 15, I owned my first piece of equipment called backhoe which dug foundations," he said. "I worked summers and weekends after school for my dad since even before I

was 15. At 17, I ran a crew."

After leaving college, Anastasi worked as a foreman with his father again from 1980 until he died in 1996. He said the company was called Stuyvesant Development Corporation and is now the Anastasi General Contractors, where he is still a consultant. Anastasi also volunteered at the Bethlehem Pop Warner Organization for over 15 years, eventually becoming its president, and then joined the Capital District counterpart.

He said all these experiences made him qualified for the Highway Superintendent position and regarding seeking re-election, he said, "My first two years were more of feeling the department out and seeing where it needs to go. Now, I want to put more effort into growing the department and make it more efficient."

Anastasi said he is looking to address certain challenges the department is facing recently. "Our

labor staff is aging out and since I've come into this job, we have a growing population," he said.

'Today's society is not always geared towards blue collar workers as people went to learn to be lawyers and doctors or work with computers. In reality, kids that go to trade school are going to be the doctors and lawyers of tomorrow because there's not many of them." While he said that he's interested in working with Capital Region BOCES and the town to encourage local trade schools, he added that some of his younger employees have come from the Glenmont Job Corps

Anastasi said his department — around 60 employees — continues to address potholes, add sidewalks and pave roads throughout town. "When we have a budget and the community grows, we could only do so much and my guys have been great," he said. "Our paving crew is second to none. Other municipalities have asked to come and train with my guys and they often subcontract their paving

We're setting the bar high."

Anastasi concluded that people should care more about what his department does as it always strives to ensure safety for drivers, pedestrians and bicyclists by picking up brush and debris; plowing roads in winter; mowing the town parks and handling stormwater infrastructure. "All my life, I've ran crews, done layouts and budgets and been responsible," he said. "I want to continue that for this community."

# Marc Dorsey (D, WF)

Marc Dorsey has lived in Bethlehem for almost 50 years now. He attended Bethlehem Central High School, Hudson Valley Community College and out while we pave in-house. Empire State College. At

HVCC, he participated in the International Union of Operating Engineers and the United Brotherhood of Carpenters apprenticeship programs.

Dorsey later became a state-certified law enforcement officer and was a policeman in Altamont and Coevmans. He has also been in the U.S. Army for around 10 years as a sniper team leader in Afghanistan and in the Air Force for six years where he teaches infantry tactics. He also became a staff sergeant in the Air National Guard in 2008, a former sergeant in the Army National Guard since 2014 and a logistics specialist for the state Department of Homeland Security Emergency Services since 2006.

While he has not taken office in Bethlehem yet, Dorsey said his extensive background in the military, law enforcement, carpentry and construction make him feel qualified to run for Highway Superintendent. "I have a ton of leadership experience and while I've had horrible bosses in the past, I'm fair," he said. "To see how their leadership transfers to productivity, it really can hamper any

kind of morale and that's just bad. But if you do one thing right, it can become contagious and if you keep moving that forward, things pick up and get done."

Dorsey said he believes there is a stigma associated with the Highway Department. "People think of the highway guys as standing on the side of the road with shovels and that has to change. The department's culture has to change," he said. "People think they just stand around all day and don't get enough work done. People may also see those guys as being of a different social class. That's got to change."

If elected, he said he wants to seek a balance between working sidewalks and paving roads, identify and rate roads' conditions before prioritizing which to fix first, lead the workers more efficiently, and address how the department's staff may not be enough for the growing town.

Dorsey also brought up how social media can be a great way to maintain communication between the department and residents in terms of identifying what roads, potholes or sidewalks in


town need addressing. "If we can identify and track them, we can address them much faster," he said. "With social media, you can ask the public and do maybe a survey of who needs what and where. It can also address complaints like with leaf pickup. Let the people drive that necessity in a sense."

Looking ahead, Dorsey said, "The highway guys need to have a good leader, someone to fight for them, push on and treat them fairly. ... It's not just about me, I want to make sure the next leader who comes along can have an outline of my plan and see that I had a plan that was working. And if something is not working, I need to know why it's not."

# **Town Board Joyce Becker** (D, I, WF)

Joyce Becker assumed her position originally in January 2016 and has lived in Bethlehem for 42 years now. Originally from Lexington, Kentucky where she graduated from University of Kentucky in

move to Bethlehem because of its small-town feel and attractive school district to raise their family.

She said she started working in the town in 1986 answering switchboards and she helped then-Parks and Recreation colleague Karen Pelletier to develop the Senior Services department. Tasked with recruiting volunteers then with a vision for Senior Services to help people age and still live in town, Becker has since branched off to be Bethlehem Senior Projects' assistant treasurer; a Bethlehem Community Fund trustee; a member of Bethlehem Business Women, Delmar Fire Department Ladies Auxiliary and Bethlehem Historical Association; and the former president of Salvation Army Auxiliary Services. Most recently, she was a Bethlehem Public Library trustee from 2009 to June this year.

Regarding the Town Board, Becker said she wanted to run again because "while my fellow members have different backgrounds, I feel like I'm the voice of the community because I've been in the community and provided services for so many years and I've maintained that contact with people. I still feel I have something to offer for the people."

If re-elected, she wants to help establish the new comprehensive plan and ensure it considers all hamlets; and take steps towards historic preservation not only in Slingerlands but in Selkirk and South Bethlehem. "I want to look harder into the background and original documents of the Delaware Avenue Road Diet again from 2017 and see if the municipality have any authority to change the markings on the roadway if it ends up not being successful," she said. "I need to know the answer to that and it's complicated because it's a state road. I personally want to do more research and get answers for that."

She added it's important, though, for residents to patronize the to-be-affected businesses along Delaware Avenue and encourage the owners during and after construction. The construction, she said, also enables the town to look into the underlying aging water and sewer infrastructure, much of which were installed after World War II.

Looking ahead, Becker said she'd want the town to encourage affordable housing for freshly-graduated university students who probably would be in much debt and for seniors to age in place in Selkirk or South Bethlehem. She also wants to see more responsible development planning in the future that do not interfere with landowners' rights.

"I consider Bethlehem as my home and where my heart is," she concluded. "I also want to encourage women to apply for town positions, even non-clerical ones, if interested and back in the day, there weren't as many. Women are great leaders and we need to empower each other."

# James Carriero ( R, C, I)

James Carriero has lived in Bethlehem for almost 30 years now and was originally from a small Italian-American community in Stamford, Connecticut; he graduated from Southern Connecticut State University with a degree in secondary education in 1976.

Growing up poor in a government-housing project until he was 10, Carriero said he learned to appreciate what poverty taught him about handling money, how generous the government can be during hard times and not judging people because of their socioeconomic status. Adding that as he received professional opportunities later, he said it was important for him to give back to the community.

Carriero began working at KeyBank in 1978 to support schools and nonprofit organizations, and is still a member of the board of directors at St. Peter's Hospital Foundation, Senior Hope Counseling and the Northeastern Association of the Blind at Albany. He said his extensive background in education and banking help make him feel qualified to run for Town Board.

"I'm a solution-based person and I don't criticize people for their political affiliations," he said. "It's important to find a balance in government and bring people together. In banking, I've learned to recognize who your customers are and how to treat them. That also applies in government."

He also said he feels the current Town Board is "rather passive because I don't see a lot of debate." He said debate is a healthy form of government but since most of the Town Board are of one political party, he feels that there is not much checks and balances.

If elected, Carriero said he wants to address numerous town issues including looking into aging underground infrastructure; minimizing water main breaks and ensuring residents have quality water; and wanting stricter environmental regulations as he is concerned the upcoming Port of Albany's expansion project around Beacon Island could lead to a coal ash spill. He also wants to improve communication between town government and the public.

Carriero brought up how the Delaware Avenue Road Diet would negatively affect businesses and he said most businesses owners were not happy about it after meeting with them this past summer. "Before you go into major reconstruction, you need to visit your customers and



# Boys volleyball digs pink






Junior varsity and varsity teams from CBA, Columbia, Guilderland, Niskayuna and Scarsdale competed and helped raised money for the cause.

go back to their towns but face brutality. So, many people stayed in the concentrations camps even after they were freed, many of whom were teenagers."

Stamper also said it "was mind-boggling" that a few years after liberation, more than 1,000 weddings happened and over 2,000 babies were born at Bergen-

She gave an example of how a Czechoslovakian woman named Lilly lost some of her family members in Auschwitz but she and her two sisters survived despite being transported to five different concentration camps. She then met a man named Ludwig Friedman at the Bergen-Belsen refugee camp and she wanted to start a family and get married in a white wedding gown, as a sign of hope and rebirth. Friedman eventually crafted a wedding gown out of a silk parachute with the help of a seamstress — Lilly and Friedman then married on Jan. 27,

"That gown, because it was so precious, was passed from girl to girl who's getting married and Lilly stopped counting after handing it to 17 women and it was far more," Stamper said. "Why did it matter to have a white wedding dress? It was a way to say that they survived through chaos and disaster, and they were determined." The gown, she said, is now on display at the U.S. Holocaust Memorial Museum in Washington, D.C.

Stamper said stories like Lilly's and the message of hope even after liberation were what helped inspire her "What the Night Sings" book. She added that she also visited many former Nazi concentration camps as part of her research process.

Stamper connected her creative process to how she was born in Germany and grew up in a Jewish home in New York City "that, for me, was not a safe place. I had never met my father because he was not a good man and he's an alcoholic and violent towards my mother, and when I was eight, she left him and never looked back. So, my mother was my hero in many ways and she had her own difficulties. As a result, my childhood was filled with many issues of abuse, neglect, trauma and mental illness, and I was honestly grateful that I had art and friends to go to."

Stamper pursued drawing and visual art at LaGuardia High School of Music and Art and Performing Arts, obtained a bachelor of fine arts in illustration at the Parsons School of Design and a master of fine arts in illustration as visual essay at the School of Visual Arts in New

York City.

Besides her personal and professional background, Stamper also showed slides with news headlines and photographs relating to the Pittsburgh synagogue shooting; the Charlie Hebdo shooting and Hypercacher kosher supermarket siege in Paris, France; and how every week, Jewish people are attacked violently in Brooklyn which are captured on surveillance footage. While she said that anti-Semitism and violence towards Jewish people are not new concepts and still happen in recent years, numerous students' eyebrows rose when she reminded them that Sunday, Oct. 27 was the first anniversary of the aforementioned Pittsburgh synagogue shooting.

"Jews are once more the most targeted group for hate crimes," she said, which led her to pose a thought-provoking question to the students before her, "Would you rather be safe or strong?"

That question, Stamper said, also helped inspire her to write "What the Night Sings," once again showing how complex her creative and writing processes were. When her presentation concluded, Stamper gifted one student a copy of her book via a raffle.

let them know of the potential impact," he said. "After I went out to meet with business owners six or seven times this summer, only then did the town supervisor, Chamber of Commerce and economic planning staff come out of their offices and listen to them." While he added that construction on Delaware Avenue in 2017 had hurt businesses there and are still recovering from it, he said this all showed the importance of town government being transparent with residents.

Looking ahead, he said, "I also envision us struggling to maintain the balance between nature, development and traffic congestion. These issues may always be around although we have many blessings like beautiful parks, access to the highway, the school system and more. But the challenge is finding that balance."

Daniel Coffey assumed his position this past January and has lived in Bethlehem since 1999. Born and raised



in Plattsburgh, he majored in political science from Schenectady's Union College in 1984, earned a master's in public administration from Columbia University and attained a Juris Doctor degree from Georgetown University.

He said he and his wife, Eileen, moved to Delmar because of its small-town feel and school district as well as easy access to downtown Albany. Zoning Board Chair; the former president of the Albany County Bar Association; and a former Bethlehem Democratic Committee officer. He also co-founded an Albany law firm, Bowitch & Coffey, in June 2012 where he is a trial attorney.

Coffey said he wanted to run again for Town Board because "it's a learning curve and I feel I'm just getting up to speed and getting warmed up. A full four-year term can let me take some of the progress we've made so far this year and continue it on." He added that his law background helps him as the Town Board often reviews contracts, goes into executive session and oversees public hearings.

If re-elected, Coffey said he wants to continue addressing development and open space in town; helping with the new comprehensive plan update which he said is a "massive undertaking;" seeing the town dive more into a regional Community Choice Aggregation program to give residents more choices for their energy providers and support renewable energy; looking into installing more electric vehicle charge stations in town; and seeing more bike lanes and

sidewalks to make Bethlehem a more connected community.

Coffey added that the town is undergoing projects like the Glenmont roundabout, Delaware Avenue Road Diet and Clapper Road Water Treatment Plant as well as noting concerns like aging water and sewer infrastructure, and outdated law enforcement facilities. "There's a lot to learn and absorb and I've made it a point to meet each department head when I first came into office and a couple times a month, I stop over at Town Hall to sit down with someone and learn what they do because it's complicated," he said. "Town Hall has a wealth of talented people and a lot of what they do goes unappreciated most of the time. So, it's important to thank them for what they do."

This past year, he expressed pride in how the Town Board has enacted a six-month moratorium on vape shops, started the Farms and Forests Fund, updated the Parkland Set Aside fees and more.

"I think of Bethlehem as a friendly community that has the nearby resources of Albany but has open space, great parks and schools and so on," Coffey concluded. "But Bethlehem isn't just one, there's multiple hamlets with different characters and that's so important."



# You, the road and everyone else

Ask yourself these questions before you next get behind the wheel

en and women know that adjustments must be made as they get older. Athletes nearing their golden years may not be able to push themselves as hard at the gym as they once did. Professionals nearing retirement age might not be able to pull long hours at the office like they used to.

But aging affects more than just work and play. As men and women age, their ability to perform everyday tasks, including driving, may diminish as well.

The National Highway Traffic Safety Administration notes that, as people age, certain changes they experience can affect their ability to safely operate an automobile. Changes in eyesight, physical fitness and reflexes may require aging drivers to reassess their skills behind the wheel. The NHTSA notes that drivers can ask themselves the following questions as they try to assess their driving abilities.

# How is my eyesight?

The American Optometric Association notes that vision changes naturally occur as a person ages. Such changes do not necessarily mean drivers have to give up the keys to their vehicles. In fact, they may just require more routine eye examinations.



The NHTSA says having trouble reading signs easily, recognizing someone from across the street, seeing streets signs and pedestrians, and handling headlight glare are common signs of age-related eye problems.

# Can I control my vehicle?

Age-related loss of strength, coordination and flexibility can make it hard for aging men and women to control their vehicles. Some signs that drivers might be having trouble controlling their vehicles include trouble looking over shoulders to change lanes, difficulty moving foot from the gas pedal to the brake pedal and difficulty turning the steering wheel. Pain in the knees, legs or ankles also can make it difficult for drivers to control their vehicles.

# Does driving make me nervous, scared?

Drivers who feel confused by traffic signs and traffic (including pedestrian traffic) should stop driving until they can discuss the issue with their physicians. Medication can sometimes make drivers



feel sleepy or confused, and some aging drivers even find themselves overwhelmed in otherwise normal driving situations.

# Are loved ones concerned about my driving?

Aging drivers may feel offended when family members question their ability to drive. However, the NHTSA notes that sometimes other people notice things about a person's driving that the person does not. The concern expressed by loved

ones should not be taken lightly.

# Do I drive with passengers?

Drivers who routinely drive with passengers, especially young children, carry extra responsibility. As a result, such drivers owe it to themselves and their passengers to honestly assess their driving abilities.

Various remedies can address agerelated driving issues, and drivers should discuss them with their doctors the moment they feel as though their skills behind the wheel are starting to diminish.

be managed appropriately?

These are all considerations that can be discussed with an attorney, but at the same time, should be given some initial thought in advance by the individual, and potentially with other members of the family. It is often very beneficial to have a complete and current list of your assets, which can be supplemented as circumstances change, including how each asset is titled, beneficiary designations (as applicable), and an approximate value.

The next step will usually involve meeting with an attorney to discuss your wishes, goals and the resulting implications. A last will and testament may serve as an important component of the estate plan. However, the difference between simply executing a legal document, such as a will, and actually getting your estate planning in working order necessitates the careful consideration of each asset and your personal circumstances. What property does your will control? What assets may be controlled by means other than your will, such as through joint ownership or designation of beneficiaries? Is probate avoidance and settling your estate outside of court an important consideration for you? Who will be involved with ensuring that these issues are properly addressed, and are there back-up options in place? Would a trust be helpful, or even appropriate? These questions are answered in a manner specific to the individual and/or family. It might be obvious that having no planning in place can produce unintended consequences. However, piecemeal planning or not taking into account all of your circumstances may result in the same problems. complex, but getting your planning set is just as much about thoroughness, as it is about taking initial action.


Finally, no estate plan is complete without the execution of advance directives, which should likely include a living will, health care proxy and power of attorney. A living will

can document your wishes to refuse extraordinary life-sustaining treatment if you are compromised beyond a reasonable expectation of recovery. A health care proxy appoints an agent to make health care decisions when you are unable to do so for yourself, and can include personal directions. A power of attorney appoints an agent to make financial and other legal decisions on your behalf. Each document is significant, but again, the legal terms are critical. Does your power of attorney have authority for your agent to assist in future asset protection planning? Is your health care agent empowered with enough information to know your wishes regarding end-of-life decision making? Are there secondary actors named, in case your primary option is unwilling or unavailable? A comprehensive plan will usually always include basic terms for contingent provisions when the primary terms are no longer relevant.

Planning with a purpose involves both action and attention to detail. With that said, though, you likely already know most of what you want to accomplish. With some preparation and foresight, you and your loved ones will be rewarded with the peace of mind you deserve by knowing that your estate plan is both in place and comprehensive.



# Don't mix and match



Tips to avoid medication errors

rescription medications are a necessity for many people. The American Academy of Family Physicians says that, each week, four out of five adults in the United States will use prescription medications, over-the-counter drugs and/or various supplements. Approximately one-third of adults take five or more medications at the same time.



The potential for adverse drug events is elevated when people are taking multiple medications at one time. For example, mixing pills has the potential to cause serious injury or even death.

Doctors, patients and pharmacies must work together to ensure that medication is taken safely. One of the best ways to prevent errors with medications is for patients to take an active role in their health care management.

• Know your dose. Children are at an especially high risk for medication errors because they require different doses than adults, offers the Mayo Clinic. Adults of different weights who share medications can run into trouble as well. It is key to follow the

dosing instructions, as even a minor error in regard to dosage can potentially cause a big problem.

- Follow up with your doctor. Certain medications can cause side effects that only can be noticed by lab testing, such as an impact to the liver. Doctors also may be under an obligation to follow up with patients taking psychological drugs to ensure the efficacy of treatment. Make sure you keep all follow-up appointments.
- Maintain a current list of meds. It is up to patients to share information with prescribing doctors regarding any and all products being taken to avoid harmful interactions. Using the same pharmacy for all prescriptions also is helpful.
- Be honest about height and weight. Medication labeling and package inserts typically use metric units to correlate dose to a person's physical attributes. Individuals should know their information in metric measurements and be honest with themselves about what they weigh.
- Use medications correctly. It is important not to chew nonchewable pills or cut pills unless the pharmacist or doctor has said it is safe to do so. Accurate dosing also requires using the right spoon or syringe, not silverware. Store certain types of medications, such as eye drops and ear drops, separately so they're not mistaken for one another.

These are just some of the ways to prevent medication errors. People can consult with their doctors and pharmacists for more assistance in staying safe.



# Snake oil?

CBD oil and arthritis

ealth-conscious consumers have no doubt encountered advertisements for CBD oil at some point in recent memory. Supplement stores, pharmacies and even gyms may promote CBD oil, prompting consumers to wonder just what CBD is

and how it may or may not play a role in the treatment of certain conditions, including arthritis.

According to the Arthritis Foundation, two kinds of the cannabis sativa plant, hemp and marijuana, produce cannabinoids, which Harvard Medical School notes is the second most prevalent of the active ingredients of cannabis. People unfamiliar with cannabidiol, or CBD, a type of cannabinoid, may

assume it gets users high like marijuana. However, CBD doesn't get users high, as another cannabinoid, a psychoactive part of the marijuana plant known as THC, is responsible for that effect.

Advocates for CBD often note its potential to alleviate pain associated with arthritis. While animal studies have supported those claims, the Arthritis Foundation notes that such studies do not always translate to humans. In addition, the Arthritis Foundation notes that, thus

far, human studies examining the potential efficacy of CBD in treating arthritis pain have produced mixed results, and the Harvard Medical School notes that more studies are necessary to determine the potential of CBD in treating pain, including that caused by arthritis.

Laws also vary regarding the legality of CBD, though many places allow some form of CBD. Consumers

should first consult with their physicians regarding their conditions and whether or not CBD might help them.

# The Caregiver's Conundrum

hen I meet with prospective clients who want to engage in estate or elder law planning, it is not uncommon to hear them forcefully tell me something along the lines of "I will never go to a nursing home" and/or hear them allude to preferring to take walk in the woods and 'take matters into their own hands', or something along those lines. I understand what they are saying. It should be nobody's life goal to ever call a skilled nursing facility their home. Nonetheless, we don't always have a choice in life and the truth is that with caring and compassionate skilled care, the quality of our life can greatly be enhanced, even in a nursing home. There is however, an alternative called "aging in place."

Aging in place is a relatively old concept which has had new life in recent years, coinciding with the increase in the elderly population and the stigma of nursing homes. The idea is simple. Keep your loved one in their most familiar environment, their home. All while balancing the needs for social interactions, rehab/exercise and the type of care they require on a day to day basis. After all, if a loved one has dementia, robbing them of their short term memory, why not surround them with pictures and furnishings that make them hopefully feel comfortable. Typically, aging in place requires not only a home that physically can accommodate a loved one (safety bars in bathrooms, larger hallways and doorways), but also someone ready, willing and able to provide the care. That brings us to one of the most overlooked parties in the long term care planning equation: the caregiver.

Earlier this month, the New York Times addressed the life of a caregiver in an article that told the heartbreaking, but increasingly familiar story of Mark Donham, the husband and now widower of his wife, Chris. Mark's wife had earlyonset Alzheimer's and Mark stood by his wife's side the entire time. As the article details, Mark quit his job in order to do the much harder job of being a 24-hour caregiver. Laundry, cleaning and later toileting, feeding, and transporting were all part of his new job description. By all accounts, Mark did everything he could until the disease took his wife. Along the way, his efforts had a negative impact on his life in more ways than just grief. The stresses of caring for his wife, whether financial, physical or emotional, took its toll. Know that help is out there.

When we do our educational Estate and Medicaid Planning seminars, it is routine for attendees to hear about "Community Medicaid" for the first time. A part of the federal Medicaid program, Community Medicaid is a vehicle through which people can get skilled nursing or home health aids in their own home. Community Medicaid can even include programs that get your loved one out of the house to get that valuable social contact. Similar to Medicaid coverage in nursing homes, Community Medicaid is a needsbased program and an applicant must be below certain resource levels in order to qualify. Unlike nursing home care however, Community Medicaid does not have a 5-year look back period meaning that it is never too late to get help caring for your loved one at home. In addition, with proper counsel, you can also use excess income you have for your expenses figuratively having your cake and eating it to, i.e. getting Medicaid to pay for hours of care for your loved one while using that loved one's excess income for either additional care or paying other expenses.

Aging in place is a wonderful idea. Taking care of your loved one through their dementia is a good and noble thing. Doing it alone however is something you should try to avoid. Look into Community Medicaid for the sake of your loved one and yourself.



# Run towards the horror

Jeff Kirkendall considers horror as his escape

orror movies require a special kind of talent—while it might be considered easy to scare someone, it's not always easy to make an entire movie based on fear. That's where Jeff Kirkendall comes into the picture. The Capital District-based actor and filmmaker is a veteran in his respective field and the passion is what keeps Kirkendall going.

"I really enjoy the overall creativity of making movies," Kirkendall said. "I love being behind the scenes and having some creative input into what is made."

## Take no prisoners with this tailgate meal

Savory sandwiches for tailgate fun

all marks the start of football season. Game day experiences are made even more enjoyable by hosting or attending a tailgate in the parking lot of the stadium.

Tailgate supplies must be brought to the tailgate the day of the game. That includes food, which is often prepared at home and then cooked on-site. This recipe for "Ultimate Steak & Mushroom Sandwiches" from Laurie McNamara's "Simply Scratch" (Avery) can be prepared at home and then put together at the stadium lot. These delicious sandwiches can be easily cut into small pieces and served as slider-type appetizers.

## Ultimate Steak & Mushroom Sandwiches

### **Ingredients: Makes 4 servings**

11/4 to 11/2 pounds rib-eye steak

- 1 cup Balsamic Herb Dressinade (see below)
  - 1 tablespoon unsalted butter
  - 1 tablespoon olive oil
  - 1 large sweet onion, halved and thinly

sliced

1 pint cremini mushrooms, cleaned and sliced

Kosher salt and freshly ground black pepper (optional)

1/2 cup crumbled blue cheese

11/2 cups grated provolone cheese

4 6-inch hoagie bungs, split Mayonnaise

### Balsamic Herb Dressinade

- 2 cloves garlic, minced
- 1 tablespoon chopped fresh basil or 1 teaspoon dried
- 2 teaspoons chopped fresh rosemary, or 1 teaspoon dried
- 1 teaspoon chopped fresh thyme, or 1/2 teaspoon dried

3/4 teaspoon kosher salt

1/4 teaspoon coarsely ground black pepper

- teaspoons Dijon mustard
- 6 tablespoons balsamic vinegar
- 2 tablespoons red wine vinegar
- 1 cup grape-seed or olive oil

In a 1-pint glass jar, combine all the ingredients. Secure the lid and shake until combined. Let stand for 30 minutes before



using. Refrigerate any unused dressing.

Place the steak on a small rimmed baking sheet and freeze for 20 minutes so it's firm and partially frozen. Holding a sharp knife on a slight angle, going against the grain of the meat, slice into very thin strips.

In a large resealable bag or a medium bowl, marinate the steak in the dressinade for 30 minutes.

On a griddle or in a 12-inch cast-iron skillet, melt the butter with the olive oil over medium-high heat. Add the onion, toss and spread out in an even layer. Once the onion starts to soften, add the mushrooms. Cook until soft and slightly caramelized.

Using tongs, remove the steak from the marinade (allow excess to drip back into the bag or bowl) and place on the griddle, toss with the onions and mushrooms, then spread in an even layer. Allow the steak to sear, forming a crust, for 4 to 6 minutes, then flip and cook for 4 to 6 minutes more.

Season with a pinch of salt and pepper, if desired, and sprinkle with the blue cheese and provolone. Turn off the heat on the griddle or remove the skillet from the heat and cover with a domed lid or tented foil to allow the cheese to melt quickly.

Toss one last time so the cheese is mixed throughout. Divide the steak



## Something exotic this weekend

hen it comes to grilling, anything goes. Many people stick to popular staples like hamburgers and hot dogs, but just about anything can be whipped up over an open flame. Those who want to try their hand at something more exotic than traditional backyard barbecue fare can try this Spanish recipe for "Pinchos de Pollo (Grilled Chicken Skewers with Harissa Couscous," which comes courtesy of James Campbell Caruso's "España: Exploring the Flavors of Spain" (Gibbs Smith).

Pinchos de Pollo (Grilled Chicken Skewers with Harissa Couscous)

### **Ingredients: Makes 6 servings**

- 6 boneless chicken thighs, cut into 1-inch cubes
- 2 tablespoons lemon juice
- 1/4 cup olive oil
- 4 cloves garlic, minced
- 1 teaspoon ground cumin



- 1 tablespoon ground coriander
- 1 tablespoon dry oregano
- 1 teaspoon turmeric

Toss the chicken with all the other ingredients and let marinate in the refrigerator for 4 hours (up to 24 hours is ideal). Thread chicken evenly onto 6 wooden or metal skewers. Prepare a grill on medium-high heat and grill the skewers for about 5 minutes per side, until chicken is cooked through.

### Harissa Couscous

### **Ingredients:**

- 2 cups dry couscous
- 2 cups chicken stock

2 tablespoons Harissa (see below)

Put the couscous in a large bowl. Heat the chicken stock and bring to a boil. Stir the Harissa into the chicken stock. Pour the hot stock over the couscous and cover with plastic wrap. Let stand for 15 minutes.

Divide harissa couscous onto 6 small plates and top each serving with a chicken skewer.

### Harissa

- 1 tablespoon coriander seed
- 1 tablespoon caraway seed
- 1 teaspoon cumin seed
- large cloves garlic, unpeeled
- 4 large red bell peppers
- 1/2 cup extra virgin olive oil
- 1 tablespoon sugar
- 2 tablespoons crushed New Mexico red chiles Salt and pepper to taste

Stir coriander, caraway and cumin in a small skillet over medium-high heat until aromatic, about 30 seconds. Transfer to a food processor. Cook garlic in the same skillet, covered, over medium-low heat until tender, about 10 minutes, turning occasionally. Let garlic cool, then peel it and add to processor. Char bell peppers over a gas flame or in a broiler until blackened on all sides. Enclose in a paper bag; let stand 10 minutes. Peel, seed and coarsely chop peppers. Add peppers, oil, sugar, and crushed red pepper to processor. Puree. Season with salt and pepper. (Can be made 1 day ahead. Cover and refrigerate.)

Toys are even provided to animals to help reduce the stress from their environments. It doesn't steal them away from their ultimate fate. In the end,

a mink will be picked up from their cage by the tail and dropped into a breadboxsized container where its filled with carbon monoxide, quietly killing it within minutes.

Younger customers have been attracted to fur through their parents are grandparents. Fur coats are found or passed down as an heirloom. The latter serves as another argument. Faux furs are a product of fast fashion — clothing and accessories assembled quickly and with cheaper material, neither designed to withstand long use. They are bought, worn, and relatively quickly toss away into the garbage. With faux fur fibre produced

from petrochemicals, conscientious consumers are left to question their impact on the environment.

Spotlight News received only one comment out of the 61 responses to our poll, one in favor of fur.

"Fur is light and warm," she said.
"It's more practical and less toxic than synthetics. My husband hunts and we use all parts of the animal. I understand why people react to killing animals just for their fur but I am comfortable with our practices which honor the traditional ways."



## 'Lucky Chops'

ew York City's brass-funk quintet Lucky Chops is releasing the band's brand new, self-titled album "Lucky Chops" to the public tomorrow. Fans who donated to support the album's production were treated to the full album a day early.

Lucky Chops isn't the band's first recording, however, the 11-track album marks the band's first full-length studio effort that brings a collection of original songs to the band's growing fan base, marked by careful attention to detail in the compositions and production. The band's first release, "NYC," came out around the same time that the band's New York City subway performances gained viral attention on social media and is comprised mostly of covers, and subsequent single and EP releases that established a foundation of original material leading to this latest project.

There is no single defining sound that the band has laid down on this latest release. By the fourth song, Lucky Chops has defined a well-crafted blend of original sounds for this multi-genre, multi-decade influenced banger of an album.

The medium paced disco groove of

"Halfway to the Hudson" leads things off with interludes laced with brassy, Daft Punk-inspired licks. From this catchy attention grabber, the album quickly flaunts a diversity in sound, traveling through a lighthearted "Dancing Babies" to the heavy, steady beat of "Traveler" where the band's own original dance style shines through.

The album's prominent track and first single, "Full Heart Fancy," is the best demonstration of Lucky Chops' writing and performing skills, with each of the five members featured throughout the song.

The album, as a brass band recording, is naturally instrumental and sans vocals. However, a unique part of the band's compositions is that several of the melodies beg the attentive ear to search for its own lyrics to sing in tune or harmony with those melodies. "Flyway," as an example, is a relaxed tune where the tenor sax line resonates with the familiar feel of Paul McCartney's singing on "Yesterday." Naturally, or even instinctively, unspoken words form at the tip of the tongue while listening to the album.

In a broader sense, Lucky Chops brings that aspect out in many of the tracks by how well the subtlety blends into the band's arrangements prominent elements of pop music styles of 1950's surf rock.

## Underwater Bosses 'Aqua La Vista'

he Great Lakes are the biggest lake system on Earth with a total shoreline of 10,900 miles, more than the East and West coasts combined. It should come as no surprise that Syracuse is home to a burgeoning Surf Rock scene and the birthplace of Underwater Bosses. These guys have been playing together in numerous projects for over two decades, but finally formed this band last September. The band's debut album, "Aqua La Vista," was released in April and consists of 12 original tracks that perfectly capture the spirit of the sport, that made the genre famous.

"Ride of the Surfers Ride" opens the album with everything you'd hope for in a surf rock song. Wet, arching guitar riffs, head bobbing drum beats and a bass line to boogie to. "Basshead" takes that and turns it up even higher, all while adding a salty organ to the mix. This is the kind album you play in your car on a sunny day with the windows down. In fact, it was the "Between the Black Sea and Me" that made me get into my car to take a drive in order to fully appreciate the sound and style of this album.

"Red Tide" is a prime example of how this band's sound can make the band's

music feel oceanic in size. This song itself is a powerhouse; large from the get-go like the algae blooms it's named after. This band continues to encapsulate the feeling of surfing with a sound that swells in and out like the sea itself. "KGB Tsunami," my favorite instrumental surf track on the album, has a super catchy guitar riff and Chris Stewart really lets his inner Dick Dale shine as he makes you feel like James Bond is catching waves. Bob Breen's intense drumming can't be highlighted by a single track but "Surfin Hand" really showcases his talent. The same can be said for Greg Bresett on bass, who obviously shines on "Basshead" but really kicks it up on "Heavy the Ride."


This album also consists of two vocal surf tracks and the really hold the band's own amongst the instrumental surf tracks. "Turtle Neck Sweater Zombies" is infinitely catchy and fits nicely in the first half of the album. However, "Surfin Lullaby" is the most unique song on this album and also the most beautiful. 

in Albany maybe once every six or eight weeks," Monforte said. "I knew if I was closer to them, it would increase the frequency of them coming to the Orchard Tavern without losing my base in Albany."

He added that locals have expressed their desire to patronize locally-owned restaurants in recent years because in chains like Cheesecake Factory or TGI Fridays, "you're just a number to them." At the Orchard Tavern, he said it makes more pronounced efforts to get to know its customers.

According to Monforte, the Guilderland location's construction began in June with an initial target completion timeframe of early September. Customers will eventually benefit from having two fully-operational locations since the Albany one has been undergoing renovations too which Monforte said

is expected to finish this week. Such renovations include cleaning the equipment, repainting, new flooring in the dining room, retiling the restrooms and improving the kitchen to better serve customers efficiently.

"It's definitely been a daunting task, for sure, to run the two locations but it wouldn't have worked without the help of a lot of people," he added. "My father, first and foremost, is 75 years old and retired but he's still here every single day putting in time and keeping everyone on track. He's taught me everything I know. My wife, Katelyn, and brother, Kevin, have helped me out to decompress, focus and they know we're putting in long hours."

Monforte and his colleagues' work finally received attention during its ribbon-cutting ceremony, accompanied by a buffet of pizza, salads and chicken wings. It was attended by numerous local well-wishers, members of the Guilderland Chamber of Commerce and local politicians.

"The Orchard Tavern has been a fabric

of Albany for many years and a lot of great memories were there," said Albany County Executive Daniel P. McCov who expressed support for the new Guilderland location and how it can provide new memories for customers to come.

"I was a patron of the Orchard Tavern in Albany for many years and the food is fabulous ... I want to give you a really warm welcome and thanks for adding to the culinary talents in the town of Guilderland," said Town Supervisor Peter

"The Orchard Tavern is an absolute institution in Albany ... and thank you for investing and replicating that institution here in Guilderland," said state Assemblywoman Patricia Fahy before gesturing to the large turnout at the ceremony. "It's very clear you have an amazing reception and it's great to see our small businesses — our family-run businesses — thrive and thank you to all those who've supported them and we look forward to many more."

Looking ahead, Monforte envisions

opening a third location somewhere in the Capital District and he has already started looking at potential areas although low unemployment rates could make it challenging to hire more workers in the meantime. "My goal is to have another one in the next 24 months," he said. "But for me, it's important to retain the same overall feel and I don't want to overexpand and then lose who we are. We do have customers from Clifton Park and Saratoga weekly so we want to expand eventually. But when? Time will tell."

Monforte added that the Orchard Tavern wants to continue helping people create memories and he has already observed families who gather in the Albany location for the holidays even if their children have grown up and moved

"People have even come in for remembrance birthdays and bring pictures of their lost loved ones because they all used to come here," he said. "It's important we honor, respect and maintain that. We owe it to the community."



## Adapter's 'Period'

Debut EP is a mix of hard rock and trippy blues

ometimes, often unexpectedly, life decides to take a plate of glass and smash you right in the face. When that happens, you can either retreat and regroup or take that sharp, broken glass and smash back. That is what Adapter did with their first EP, "Period." This is a band with a chip on its shoulder, and the chops to go out and make a statement about it.

To simply label Adapter as a modern mix between Zeppelin and The Allman Brothers Band wouldn't be a bad thing, but as one digs deeper into the EP, Adapter has subtly carved a sound of its own. That sound can loosely be described as a new-aged, hard-rocking spin on classic blues. The band, however, pairs that with an in-your-face rock and roll spirit. Even through headphones there is a sense of electricity and danger, both musically and lyrically, with explosive rocking chords that beg to be vibrating wall-to-wall in an

Lyrically, "Period" is a familiar peek into a songwriter who has been damaged

and cannot decide what to do next. The hard-rocking opening track "The Pains" delves deep into the mental struggle of whether to go back to a lover who has hurt you or not. This all too human battle continues as the EP plays out into the next track, "Mean Bitch Blues." This is where the band transports you into the dark unknown, where you don't know what to do next now that it has all ended. It exoudes both anger and sadness.

With just five songs, "Period" gives a snapshot of the band's capabilities; melding hard rock and trippy blues with a mix of angst and an the occasional, yet subtle, light side. Already sounding like a refined, authoritative group, Adapter will be a fun band to watch grow as it continues
