Town residents speak their minds about CCA Program before Town Board

BETHLEHEM — More than a dozen residents offered mixed reactions to the regional Community Choice Aggregation program the town is exploring during a public hearing at Jan. 8 town board meeting.

The public hearing addressed the Town Board intending to pass a local law authorizing the creation of the CCA program. The town board will vote on the proposed law in its Jan. 22 meeting. This local law is needed so that Bethlehem can continue exploring the program, which it has since last October. However, it does not force the town to ultimately enroll in it. It is important to note that Bethlehem is exploring it for now but it has not officially enrolled in it and the town has the option to leave the CCA program down the road.

A new agreement with mixed reactions

COEYMANS —

The Coeymans Police Department and Albany County Sheriff's Office will now provide nine dedicated patrols for the town daily.

This agreement became effective immediately after the Coeymans Town Board unanimously voted in favor in its Jan. 9 meeting. The town will also provide a substation for the Sheriff's Office and Town Supervisor George McHugh said the main objective is to increase public safety in Coeymans and Ravena.

"It's also about sharing resources between the Sheriff's Office and Coeymans Police Department to better train and support our law enforcement," he said. "It's about providing the Sheriff's Office with a more permanent presence in Coeymans and Ravena, to aid and support the

RCS Resource Officers as well as our own police officers."

He added that it would save the town around \$280,000 which can help remedy the Coeymans Police

Department's outstanding budget last year; two Coeymans police officers' shifts will be cut though and its 21 part-time officers will see fewer shifts. However, no police officer would lose their job.

Albany County Sheriff Craig Apple said the agreement would also result in six deputies being placed in Coeymans in exchange for a substation, office and parking spaces. "The biggest hindrance to us, quite honestly, is that our closest station to here is in Clarksville," he said, explaining that having a more permanent outreach



in Coeymans can help them in the long run.

A few dozen residents attended the town board meeting with mixed views on the agreement.

One resident said, "If we are not spending any more money, if we are increasing our patrol, especially in this day and age, I don't see why it's a bad thing."

In contrast, another resident expressed concern that the shift cuts would hurt the part-time officers' income. "They count on that for a living, so whether you're going to let them go or keep them, you're going

to lose some of them just by doing this," he said.

Michael Case, a Coeymans police officer, also chimed in, "Some of our officers will receive a biweekly paycheck

for three days total, and the one question I ask is how can we expect someone to make a living or contribute to their families, especially in the state of New York, on this merit." He said he preferred the town board to leave it up to residents to vote on the matter instead.

Other concerns brought up included perceiving this agreement as a way to generate more tickets to increase revenue for the town and village courts, as well as whether the incoming Albany County Sheriff's patrol officers will take the time to connect with the Coeymans community.

A resident who works at the local library said, "The officers from the Coeymans police force will stop by the library [even] when we haven't called them. They know the kids, they've been a tremendous resource. I can't say enough good things about them. And while I have respect for the sheriffs, I've never seen a Sheriff's officer swing by the library just to see how things are going."

Apple said, "I really understand that there's some angst attached to this. It's changed and nobody likes it but we're not here to harass anybody. ... I don't care about tickets, I'd rather give a warning. But if you do it again, then shame on you, and I'm going to give you a ticket. But it's not my job to funnel money into the town and states by writing tickets. That's not going to happen."

McHugh said the agreement's roots traced back to after last November's town election and he met with the Albany County Sheriff's Office to reintroduce himself as the newly-elected supervisor. The meeting lasted around two hours and "we came away from it believing we could benefit from having a substation in Coeymans and we could benefit with more police coverage," he

Moving forward, McHugh concluded, "It's about working together with our county law enforcement to increase public safety and patrols in Coeymans and Ravena, for the safety and security of its residents, property owners and business owners.... It's not about dissolving the Coeymans Police Department because that is something not one person on this [town] board is in favor of now or, I believe,

A new consultant to help communication

Crafting a new plan to think ahead for future roadway projects

BETHLEHEM —

The Albany-based Baker Public Relations firm will work with the town and the Chamber of Commerce over the next three months to develop a strategic communications plan for upcoming roadway construction projects.

The agreement was authorized by Town Supervisor David VanLuven during the Jan. 8 town board meeting. Baker Public Relations would be a consultant to help the town and Chamber of Commerce communicate about the extent and timeline of major construction projects with businesses located near and residents living in areas that will see major construction work, as well provide tools to help businesses communicate with their customers.

The strategic communications plan will focus on the upcoming \$4.9 million Glenmont roundabout project. With construction set to start this spring, this will transform the four-way intersection of Feura Bush Road, Glenmont Road and Route 9W into a roundabout. The strategic communications plan would also serve as a template that the town can use with other future projects like the Delaware Avenue Complete Streets

and Road Diet Project.

"In hearing feedback from the public about the Delaware Avenue construction work in 2017, there was some concern that the town did not communicate to business owners and residents there as best as they could, like about detours and construction schedules," said Robert Leslie, the town's director of planning. "So this effort is in response to that practice. We want to do a better job this time with the Glenmont roundabout project coming up, and we'll have a consultant assist us and communicate with the people."

Maureen McGuinness, the Chamber of Commerce's president, echoed Leslie's words, saying that town communication with residents and business during the 2017 Delaware Avenue construction work was "poor."

She continued, "The road work had an impact on people and businesses there, some of which could have been mitigated. It's very clear something needs to be done differently as the town moves forward."

With Baker Public Relations, Leslie said under contract, the town is paying the firm \$18,000 for its services over three months.

In an email to *Spotlight News*, Jason Politi, the firm's public relations and marketing director, wrote that it has had years of prior experience working with municipalities, construction and real estate development. While it has worked with other local

municipalities already, this would be the first time working with the town of Bethlehem.

Town staff had sent out a Request for Proposals (RFP) last October to get local potential public relations firms' attention and received five responses by November. The town's Strategic Communications Plan Committee comprising of Leslie; McGuinness; economic development coordinator Elizabeth Staubach; and the supervisor's executive assistant Robin Nagengast reviewed them based on each firm's experience with similar projects, having qualified personnel and their ability to meet the desired three-month schedule.

Leslie said the committee had been set up

by the town's Economic Development & Planning Department last October.

The committee then interviewed three of the five firms and later unanimously voted for Baker Public Relations in December.

"While all three were qualified, we thought Baker [Public Relations] really gives us what we need in terms of communication with businesses and assisting them with tools and ways to communicate with their customers and clients," Leslie said.

Politi wrote that his firm was notified of the unanimous vote on Dec. 18 and it would later be approved by the town board at the Jan. 8 meeting. "We are very pleased to be selected by the town's Strategic Communications Plan Committee and grateful for the opportunity," he wrote. "We put a lot of thought into our proposal and subsequent presentation to the committee. We are excited to get to work and build a relationship with

Politi added that his firm plans to submit the final strategic communications plan by April 1, which will be available to both the press and public. "We are eager to get underway with this project," he wrote. "The committee has clearly laid out its expectations for us and we will devote our best efforts to developing this plan."

"We'll have a kickoff meeting which includes a field visit to the intersection to look at the area," he said. "We'll also finalize the meeting date for when we meet with business owners."

Elsmere Elementary gets new 21st century tools

Capital Region BOCES grant offers a new tech cart for students

BETHLEHEM —

Elsmere Elementary School has received a \$3,500 grant to provide a special cart full of electronic tools to augment students' learning experience.


The cart contains sets and tools to help introduce K-5 students to robotics, coding, circuitry and design and it includes two Ozobots, two Dash robots, two Snap Circuits 300 projects, lesson plans, and more.

"It's a way in which students can get hands-on learning, use their critical thinking skills, collaborate, work together and solve problems — these are things they really are expected to have in the 21st News that "we are so

century," said Jaimee Meyer, Elsmere Elementary's school library media specialist. "To be creative, think outside of the box. We're constantly telling them what sort of things are expected of them in the future so it's a great way to do all of that in a setting."

The cart is the result of the INNOVATION! Grant, first announced last year by the Capital Region BOCES and it caught Meyer's attention. After she applied that fall, she found out that she and 15 other schools in the Capital District won the grant and a respective cart each in November. She said she was excited when the cart also came in that month and Capital Region BOCES trained her and the other schools in how to use the carts and make the most of it with students.

Elsmere Elementary Principal Kate Kloss wrote in an email to Spotlight

fortunate to have the dedicated Mrs. Meyer as a part of Elsmere." She added that the cart's tools complement the materials and resources the library already offers and "students clearly enjoy combining their creativity and curiosity with technology."

Since then, Elsmere students — fourth and fifth graders for now can come to the library on Mondays during recess to play and learn with the cart's tools and sets. "The sessions during recess are always full and they spend the time with me," Meyer

said. "They know the rules like cleaning up after themselves and everything is labeled in the cart. They now know the drill."

She added that she likes not giving the students too much instructions when handling the cart's contents. Instead, she makes herself available if any student has questions or needs help, and she likes giving them some independence and space to explore, troubleshoot and learn with the cart.

Meyer brought up plans of having an open house soon for Elsmere teachers to get to know the cart better and learn how it could benefit their students' education. "I don't know if teachers quite know what we have here yet," she said. "There are some teachers that I can immediately think of who would love to use this cart but there are some others who might need a little more prodding. But everyone here is open to learning and "It's a way in which students can get handson learning, use their critical thinking skills, collaborate, work together and solve problems — .these are things they really are expected to have in the 21st century."

The Blackbirds will host Cohoes on Thursday, Jan. 16.



Albany airport victim of hacking

COLONIE — The Airport International Airport was the victim of a Christmas Day cyber attack but the breach was limited to administrative servers and did not impact operations.

The attack was reported to the Albany County Airport Authority by LogicalNet, the

Authority's Schenectady based computer management provider. A crypto virus entered the airport's system through LogicalNet's maintenance server and subsequently overcame the airport's antivirus protection.

The Airport Authority notified the New York State Cyber Command, the FBI and sought assistance from ABS Solutions, a computer systems contractor. New York State Cyber Command advised the authority to shut down all connections with LogicalNet.

Airport staff were able to contain the attack so that no airport operations were effected. Subsequent analysis found that no Transportation Security Administration airline computers had been breached and no personal or travelers' information had been accessed.

The authority, working with ABS is in the process of a system redesign that will prevent such an attack in the future. The recommendations under consideration may include the purchase of new equipment and software as well as additional authority staff.

CDTA rolls out electric fleet

\$3.9 million pilot to test effectivness

ALBANY — The Capital District Transportation Authority unveiled the first battery electric powered buses in upstate New York on Friday, Jan. 10.

The four buses, purchase from New Flyer of America, will be part of a pilot program and used to test the technology, range and charging infrastructure of zero emission mass transportation.

"We take pride in being a leader in innovation," said CDTA CEO Carm Basile. "These buses meet CDTA's goals to reduce the region's carbon footprint. These are exciting times and CDTA continues to be at the forefront of progress in New York state."

Under the pilot, the

buses will be rotated throughout the service area to ensure they operate in all types of conditions. Customer and employee's reaction to the vehicles will be included in the data sets that will be collected and analyzed as part of the pilot operation.

Each bus costs \$900,000 and \$250,000 secured

and each charger costs \$121,000. Training and tools needed for maintenance cost close to \$200,000, bringing the total cost of the pilot project to \$3.9 million. Grants covered the majority of the costs including \$950,000 in federal money and \$250,000 secured

Another \$1.4 came from
a massive settlement with

emission equipment and
reporting and CDTA is
using \$1.3 million from its
vehicle replacement reserve.

The buses will produce zero emissions and also be quieter and are expected to yield lower operating costs than diesel and natural gas buses.

"Adding electric buses to our fleet is just one way we are staying current with the changing landscape of our business not just here at home but across the country," said CDTA Board of Directors Chairman Kayme Lahut.

New Flyer's Xcelsior CHARGE 40-foot buses will eliminate up to 175 tons of greenhouse gas emissions annually. This will also help the state reach its goal of transitioning to 100 percent renewable energy by 2040.

St. Francis Chapel to close

Shortage of friar forced decision

COLONIE — A popular chapel in a Wolf Road shopping plaza will close its doors this summer, according to the Franciscan Friars, Holy Name Province.

The St. Francis Chapel, which has called the Wolf Road Shoppers Park home since moving from the Northway Mall in 1998, is one of nine sites closing by the province because of a shortage of friars.

In 1985, Holy Name
Province had 708 friars.
That number dropped to
443 in 2001, and currently
stands at a little less than
300. While there are a
number of men in the
initial formation process,
just three friars have
professed their solemn
vows since August 2018,
according to the Holy

Name Province.

The closures, called "withdrawing from fraternities in mission," come after a two-year process and represent nearly a third of the ministry's sites. The Colonie chapel is one of two in New York state closing, with the other being in New York City. Other closures include ministries in South Carolina, Georgia, Florida and New Jersey.

"The decision to withdraw from these faith communities was not taken lightly, and in fact it was very difficult and painful,' said Fr. Kevin Mullen, provincial minister of the New York City-based Holy Name Province, in a press release dated Jan. 3. "But despite our long history and rich tradition – our friars have been present from three decades to nearly a century at most of these ministry sites - the reality of our declining numbers, and the challenges and strain it places on our ability to fulfill our fraternal

charism, made each of these decisions pragmatic and necessary."

The St. Francis Chapel was founded in 1970 in the Northway Mall but moved when that formerly enclosed mall was razed to make way for the open air mall that stands across Central Avenue from Colonie Center.

It is located within the Roman Catholic Diocese of Albany but is not a member parish. It is of the same province as friars at Siena College. The chapel's ministerial duties and undertakings will be transferred to the diocese.

"We are so grateful to the Franciscan Friars for their many years of ministry at St. Francis Chapel on Wolf Road. Although we are sorry to see the Wolf Road ministry end, we are happy to receive the people who regularly worship there into our local parishes," said the Roman Catholic Diocese of Albany in a statement. www.spotlightnews.com January 15, 2020 | **THE SPOTLIGHT** 9

Full of energy

Municipal Electric and Gas Alliance is a local corporation that would manage the CCA and help residents (and businesses that use under 2,000 kilowatt hours a month) purchase electricity in bulk from renewable energy resources. MEGA intends to get most or all electricity from renewable sources like solar, hydro and wind. By default, National Grid supplies and delivers electricity to all customers unless they choose a separate provider, but under CCA, National Grid would still deliver electricity while a new supplier is chosen after a bidding process through MEGA and agreement from enrolled municipalities. While National Grid's supply price changes monthly, the price per kilowatt hour is fixed under CCA so residents know how much they will pay in advance for the energy they use.

The CCA program is regional in nature because 14 local municipalities, totaling over 90,000 households, have also joined to explore it, including the towns of Guilderland, New Scotland, Niskayuna and Knox, the villages of Kinderhook and Voorheesville, and the cities of Glens Falls, Troy, Watervliet and Saratoga Springs.

While the public hearing was initially meant to only happen on Jan. 8, Town Supervisor David VanLuven said it is now extended to the Jan. 22 town board meeting because the local law was "inadvertently" not posted in the Jan. 8 agenda.

Residents who supported the program often brought up the importance of being environmental and the potential of seeing their bills reduced. Those who opposed or were hesitant about it generally disliked the opt-out feature and how there is not a 100

percent guarantee yet of seeing their bills reduced.

Under the regional CCA program, if a municipality enrolls in it after agreeing to a set supplier, its residents will get a letter in their mailbox, including information about the program, pricing and contract's terms as well as how to opt out of it, if they want. Residents have 30 days to opt out for free and if they don't, they are automatically enrolled in the program. But even after the program officially starts, residents can still opt out at any time with no penalty.

This caused some residents to be concerned that they would be forced into the program, have to take time and effort to learn how to opt out, and be worried that not everyone in town will be informed about the program in time or how to opt out.

"My opinion is that one should always have to opt in to choose something; they should never automatically be opted in to anything and if you want to get people in, opt in," said resident Frank Kuwik. "They should not force people to opt out of a choice. ... The town should have more regard for its residents and that they shouldn't be pulling a stunt on them. Instead of worrying how to get

opt-out information to everyone, instead it should be an opt-in situation, showing how great this is and why you should sign up."

Resident Linda Jasinski said, "This is not about the cheaper price for the people here. This is about your agenda for renewable resources and solar electricity. My agenda is a cheaper cost. Prove to me that it'll be a cheaper cost and I'll opt in." She added that having an optin feature would be better instead as it gives residents a choice to join something if they want.

In contrast, resident Pattie Beeler, who is involved in citizen action group Bethlehem Tomorrow, expressed support for the CCA program and amazement at how many municipalities have joined to explore it so far. She said opting out "may be an extra step for some but maybe that extra step will give the pause necessary to think and educate and make the choice to not opt out."

She continued, "A 100 percent clean energy Community Choice Aggregation is of vital importance to this community, to farming, to our forests, to the protection of our water systems and our earth."

Eliza Compton, a
Bethlehem High School
sophomore and the
secretary for its Students
for Peace and Survival
organization, said the
environment is a top issue
in the world now. She
brought up the current
Australian bushfires as
an example which have
devastated lands, killed

around one billion animals, are costly and more.

"Bethlehem is a town proud to lead by example in our county and our state. The CCA will allow us to show what the future can be like for towns across Albany County, New York and even the country," Compton said. "A vote for the CCA is a vote to continue Bethlehem's tradition of leadership. A vote for the CCA is a vote for the future of the youth of this town. And it is a vote that we can defeat the climate crisis together."

Louise Gava, the CCA project leader for MEGA, attended the meeting, briefly spoke about the program, listened to residents' comments on both sides and even spoke to some after the meeting. She said she was touched by Compton's words,

especially how she was a young student speaking at a full town board meeting.

In a phone interview, however, Gava said, "I think it's unfortunate that some folks who didn't like the program didn't get to attend an informational meeting or read the paper or whatnot. Some of their concerns come from how they don't understand the program but I'm always open to listening and answering questions."

She added that the concerns brought up in the meeting have similarly been discussed across other municipalities who have joined to explore the program too. "Almost all of the concerns I've heard so far are able to be managed," she said. "But what you can't manage are those who don't like the opt out option."

Consumers are confident

Poll sees strongest figures in a decade

Consumers ended 2019 on an optimistic note, according to the latest poll by the Siena College Research Institute.

The state Index of Consumer Sentiment in the fourth quarter of 2019 stands at 93, up 5.3 points from the third quarter of 2019. The state's index, though, is 6.3 points lower than the nation's index of 99.3, as compiled by the University of Michigan.

"Consumer sentiment, both nationally and in New York state, are at or within a couple of points of the highest readings we've seen in the last 10 years," said Don Levy, SCRI director. "The decade dawned with consumers pessimistic and reluctant to spend. By the end of 2014, New Yorkers had crossed the break even point and displayed growing optimism and now for the last three years, consumers have been strongly optimistic. Today's

index reading is 17 points above the break even point, 9 points above the end of 2014 and over 27 points higher than where the decade began."

Basically, the Index of Consumer Sentiment as calculated by the University of Michigan subtracts the percentage of unfavorable consumer replies from the favorable ones. Historically, it is based on variations of questions about current and future personal and household finances, the present and future financial condition of the nation as a whole and about plans to buy big ticket items like a home or a car.

In 2009, the year-end overall consumer sentiment in New York state was 65.8 while the current consumer sentiment was 63.7 and the future consumer sentiment was 67.2, according to SCRI. A decade later, the overall consumer sentiment is 93, while the current sentiment is 97.7 and the future sentiment is 90.

While overall consumer sentiment is up, 41 percent of New Yorkers say current gas prices and 58 percent say groceries bills are having a serious

or somewhat serious impact on their financial condition. Thirty-three percent of state residents say both gas and food are having either a somewhat or very serious impact on their financial condition, according to the poll.

"Concern over gasoline prices and food costs have varied across the decade with average concern over gas prices affecting 46 percent and food affecting 63 percent," Levy said. "Today, worries over affording those staples are below the decade average but above the lows of 27 percent for gas and 52 percent for food."

Republicans are more optimistic than Democrats, 105.9 to 85, and those under 55 years old are more confident than those over 55, 97 to 55. Men are more confident than women, 95.7 to 90.7, and those in New York City are more optimistic than those in upstate, 93.3 to 92.4. Not surprisingly, those making more than \$100,000 are more confident than those making less than \$50,000, 100.6 to 87.3.

The poll was conducted Nov. 19 to 22 by telephone.

The conversation continues

Nursing home gets facelift

COLONIE — Residents moved into the three new wings of the Shaker Place Rehabilitation and Nursing Center on Monday, Jan. 13.

Formerly known as the Albany County Nursing Home, the new wings at Shaker Place also have new names to honor well-known Albany Shakers: The Ann Lee, Father Joe Meacham and Father James Whittaker.

The nursing home is undergoing an \$80 million facelift including the new wings, which totals a 70,000-square-foot expansion.

The new wings feature bedrooms on the first floor for easy access, the first ever individual bedrooms for added privacy, country style kitchens and expanded common areas.

"Our residents at Shaker Place have worked hard throughout their lives, they've contributed to their

communities, some have even served in our military," said County Executive Dan McCoy. "They now have the modern facility that they deserve, one that truly looks and feels like a home, and one they and their families can be proud of," said County Executive McCoy."

Before the decision was made to renovate and expand the nursing home, what to do with the aged facility, built in 1971, that was losing \$20 million a year. The choices were to knock it down and re-build, privatize it or renovate.

Jocelyn and Chris Arndt tease track off upcoming new album due out February

ALBANY — Jocelyn and Chris Arndt premiered the first track off of their upcoming live album last week, revealing a unique acoustic release for 2020.

The sibling rockers released the video for "Mercy Me" through American Songwriter Magazine last Wednesday. The performance was recorded in front of an intimate crowd of friends, family and supporters last November at White Lake Music and Post.

The track will appear on the upcoming live album "One Night in November" once it drops in February. It's the band's second live album, and is a followup to a string of two releases that have produced Billboard charting tracks over the past three years. "One Night in November" features the performance of the full band, including Dan Zavadil on bass and David Bourgeois on drums. Dream team

New York State Industries for the Disabled, Inc. and Special Olympics New York recently announced a three-year \$90,000 grant to support an expansion of the Special Olympics NY Athlete Leadership Program, which empowers select athletes as messengers for the organization by providing public speaking training as well as opportunities to mentor their fellow athletes.

succeed in all areas of life. The Special Olympics Athlete Leadership Program, carried out in partnership with local media outlets, colleges and universities, and public and private businesses, teaches athletes to effectively develop their personal story and present it to an audience.

Jude Killar graduated from the program immediately before landing a job. In sports, the Delmar native excels on both the basketball court and softball field. He's earned the trophies to back this claim, but he buries it in conversation. There's something else that gives the 23-year-old more pride.

Killar was born with Down

Syndrome. It happens in about one in every 700 births. It means he's born with an extra chromosome. Those with it posses distinct characteristics. According to the Center for Disease Control, those traits include almond-shaped eyes, speech impediment, an IQ that measures on the lower scale, among other things. Nonetheless, it doesn't stop anyone from playing basketball, holding a job or speaking in front of hundreds of people.

Killar was introduced to public speaking while attending courses at Hudson Valley Community College. Speaking before an audience is a performance not unlike sports. There's the preparation and practice; developing the conscious control of body language, and making eye contact with the people in front of you. Then, there's showing those in front of you how ice runs through your veins while exhibiting flawless oratory skills.

Hengsterman recalls accompanying Killar to a speaking engagement in front of Google in New York City. While there, he shared his story as the evening's keynote speaker. Killar spoke before a crowd of nearly 700 people.

By the end of his speech, Hengsterman said Google was enamoured. They asked how they could help, offered to help with technology, and later assigned a team to assist Special Olympics with its data problems. Today, a member of Google sits on the Special Olympics board of directors.

"It was an impressive couple of days," said Hengsterman, who had only just started her leadership duties at Special Olympics. She admitted, it was a weekend in which she looked forward to having an audience with the \$52 billion internet giant. She credited Killar with doing that. Afterwards, Hengsterman hired him.

"Because of the Athlete Leadership program, I have learned how to tell my story to companies like Google that want to support Special Olympics New York and athletes like me," said Killar. "It has also helped me become a valued employee. I am happy to be able to help support my fellow athletes by sharing what I have experienced by being a part of Special Olympics New York and the inclusion revolution."







Ancient Egypt

Egyptologist and Guest Curator Dr. Peter Lacovara has incorporated the research and scientific discoveries revealed in the GE Presents: The Mystery of the Albany Mummies exhibition into a new exhibition about Ancient Egypt. Visitors to the museum will continue to enjoy the story of the Albany mummies, learn about the history of Ancient Egypt, and see how the intersection of new science, technology, and scholarship changes how we learn. In addition to the story of Mummy Ankhefenmut, theme and topics in the new galleries include: Egyptian History and Civilization; the Nile and the Environment: Crafts and Professions: Food and Drink; Gods and Goddesses; and Preparing for the Afterlife. The Jabbur Gallery now features the story of Albany's 3,000 year old mummy, Ankhefenmut, a priest and sculptor in the Temple of Mut, along with his recently discovered priest's robe, his coffin base from the museum's collection, and his beautiful coffin lid on loan from the Kunsthistoriches Museum, Vienna. The museum's Ptolemaic Period mummy and his coffin are now on view in the Heinrich Medicus Gallery

with a selection of over seventy objects highlighting ancient Egyptian daily life, afterlife, and animal mummies. Joining objects from the museum's collection are loans from the Phoebe A. Hearst Museum of Anthropology, Museum of Natural History, the Metropolitan Museum of Art, Museum of Fine Arts, Boston, the Semitic Museum, Harvard University, University of Pennsylvania, Williams College, and a number of private collections. Also included are a timeline and a slide presentation highlighting the trip the Albany Mummies took to Albany Medical Center for x-rays and CT scans, which revealed new information about the age, gender, and occupation of these mummies. Ancient Egypt is an ongoing exhibit. Albany Institute of History and Art is located at 125 Washington Ave., Albany.

"a small fort, which our people call Fort Orange" Fort Orange was the first permanent

Dutch settlement in New Netherland, built as a trading post by the West India Company in 1624 at the location of present-day Albany along the Hudson River. Between 1624 and 1664, the fort's role in the development of New Netherland changed—from a point of contact and trade between Native Americans and Europeans, to an enclosure with dwellings and private enterprises, and finally an abandoned space consumed by the development of Albany. Centuries later, Fort Orange on the surface had long disappeared. But in a six-month period in 1970 and 1971—just ahead of Interstate 787 construction—a small archaeology team from the State Historic Trust (predecessor to the Office of Parks, Recreation and Historic Preservation, or OPRHP), headed by Paul Huey and composed mostly of volunteers, made remarkable discoveries about life in the Dutch colony at Fort Orange. In 2016, a collection of 36,000 artifacts from Fort Orange was transferred from OPRHP to the New York State Museum. This exhibition examines the momentous discovery of Fort Orange and the lasting impact of events occurring there 400 years ago that shaped the character of the region, New York State, and the nation. The exhibition title is a quote taken from The New World by Johannes De Laet, a director of the Dutch West India Company, recorded in 1625. Select artifacts, film footage from the excavation, and four decades of historical and archaeological research are highlighted—including renderings of the fort by Historical Artist Len Tantillo. Dutch ceramics on loan from the Albany Institute of History & Art help bring life to the story. This exhibition is supported as part of the Dutch Culture USA program by the Consulate General of the Netherlands in New York and in partnership with Historic Albany Foundation. Special thanks to the New York State Office of Parks, Recreation and Historic Preservation for their support in promoting understanding of New York State history. Enterprising Waters: New York's Erie Canal (Phase Two)

The Erie Canal directed the course of New York and American history. When it opened in 1825, this "boldest and biggest American engineering project of its century" unlocked the Western interior for trade and settlement. Boomtowns sprang up along the canal's path and New York City, with its deep harbor connecting to the Hudson River, grew

to be the nation's most powerful center of international trade. One of the largest public works projects in American history, the Erie Canal inspired a nation-wide transportation revolution. Thousands of people poured into New York to work on or along the canal, or just to pass through. Though the canal would eventually be superseded by the railroad, a heady mixture of innovation and determination, and the industrious seeking and creation of wealth, was cemented in the American character. In honor of the Bicentennial of the Erie Canal's construction, New York State's Office of Cultural Education will present this rich story with the first phase of Enterprising Waters: New York's Erie Canal at the New York State Museum. In collaboration with organizations on the canal corridor and across the state, the State Museum will tell the Erie Canal's story with unique objects, documents, and images. Dominating the exhibition space is a gigantic windlass—a pulley mechanism that easily lifted and lowered heavy cargo from both sides of a warehouse with only one or two men. From 1831 through 1866, this windlass operated in the H. G. Root and Company Warehouse in the Village of Mohawk on the Erie Canal. The owners of the warehouse, Humphrey G. and Elias Root, also ran a general store and other small businesses along the canal. Phase Two of Enterprising Waters continues the story of the Erie Canal with components on the Canal's growth, politics, industries, social reform, and the Canal legacy. Enterprising Waters: New York's Erie Canal (Phase Two) will be presented in the New York State Museum's Exhibition Hall from now until Sunday, Oct. 25, 2020. New York State Museum Cultural Education Center is located at 222 Madison Ave., Albany.

The Historic Woodstock Art Colony: The Arthur A. Anderson Collection

Long before the famous music festival in 1969, Woodstock was home to what is considered America's first intentionally created, year-round arts colony-founded in 1902 and still thriving over 100 years later. Collecting the remarkable range of work produced there has been Arthur A. Anderson's focus for three decades, resulting in the largest comprehensive assemblage of its type. The artists represented in it reflect the diversity of those who came to Woodstock, including Birge Harrison, Konrad Cramer, George Bellows, Eugene Speicher, Peggy Bacon, Rolph Scarlett, and Yasuo Kuniyoshi, among many others. Anderson recently donated his entire collection-some 1,500 objects by almost 200 artists—to the New York State Museum. This exhibition introduces to the public for the first time just a sample of the highlights of this extraordinary collection, which represents a body of work that together shaped art and culture in New York and forms a history of national and international significance. The Historic Woodstock Art Colony: The Arthur A. Anderson Collection is presented in the West Gallery of the New York State Museum from now until Tuesday, Dec. 31. New York State Museum Cultural Education Center is located at 222 Madison Ave., Albany. The Hudson River School: Landscape Paintings from the Albany Institute

The Albany Institute holds a large and important collection of nineteenthcentury American landscape paintings, works often associated with the term "Hudson River School." They number more than ninety paintings and range in dimension from large wall-sized canvases to small business card-sized oil sketches on paper. We know from visitors the Hudson River School paintings are among the Institute's most popular collections, and other museums request to borrow them for exhibitions more often than other collections. With such great interest in these works of national significance, the Institute is making them more accessible. In the summer of 2017. the Institute opened a reinstallation of its Hudson River School paintings in the Hearst Gallery on the museum's third floor. For the first time, nearly all ninety paintings from this important collection is on view. These landscapes, painted by artists like Thomas Cole, Frederic Church, Jasper Cropsey, Asher Durand, and numerous others, capture America's scenic grandeur in all its magnificence from rugged coastal scenery to imposing mountains and rivers. Many paintings in the Institute's collection depict the nation during decades of transformation from a country of small towns and farms to one of industrial works and sprawling urban centers. The nation was also in the midst of rapid westward expansion and political conflict that reshaped its social identity and cultural outlook. Developments in transportation allowed artists to travel more widely, frequently beyond the nation's borders, to Europe and more distant corners of the globe, and return to their home country with sketchbooks full of inspiration and new ideas. The paintings on view, therefore, reveal a visual history of the United States during the nineteenth century, including its aspirations and growing nostalgia for a simpler and more harmonious past. 

any beloved dishes might be enjoyed more often if they were only a little healthier. Author and former personal chef Michelle Dudash was once asked by a client if the she could make a healthier version of chicken parmesan. The result of that request is the following recipe for 'Skinny Chicken Parmesan with Spinach," which Dudash ultimately included in her book, "Clean Eating For Busy Families" (Fair Winds). The recipe was a hit with Dudash's client and will surely be a hit at home cooks' dinner tables

Skinny Chicken Parmesan with Spinach

Ingredients: Makes 6 servings

For the sauce:

- teaspoons extra-virgin olive oil
- cloves garlic, sliced
- 28-ounce can whole tomatoes
- teaspoon dried basil
- teaspoon dried oregano
- 2 pinches salt
- pinches freshly ground black pepper
- teaspoon honey

For the chicken:

- tablespoons grated Parmesan cheese
- tablespoons whole-wheat flour
- teaspoon salt, divided

- 1/4 teaspoon freshly ground black pepper
- teaspoon dried basil
- pounds chicken breast, cut into 6 pieces, pounded to 1/4 inch
- tablespoons plus 2 teaspoons extra-virgin olive oil, divided
- cups baby spinach
- teaspoon lemon juice
- cup fresh mozzarella cheese, sliced into 6 medallions (or shredded)
- cups cooked whole-grain thin spaghetti tossed in 2 teaspoons olive oil

Instructions

Preheat oven to 375 F and coat the bottom of a 9 x 13inch pan with olive oil spray.

To make the sauce: Heat a medium saucepan over medium heat. Add oil and garlic and cook gently for 30 seconds. Do not brown. With your hand, squeeze each tomato into the pan and add basil, oregano, salt, pepper, and honey. Reduce to medium heat and simmer for 20 minutes, lowering the heat as needed.

To make the chicken: Combine parmesan cheese, flour, salt, pepper, and basil in a medium dish and coach chicken with cheese mixture. Place a large skillet over medium heat and add 2 tablespoons of oil. When oil is shimmering, add chicken, rounded-side down, and cook until golden on one side, about 5 minutes. Arrange chicken in a baking pan. Pour remaining 2 teaspoons of oil into skillet and add spinach. Cook spinach for 1 to 2 minutes until wilted and swirl in lemon juice. Gently press spinach to release water and divide spinach on top of chicken. Spoon sauce around and over the chicken, place mozzarella on top, and sprinkle with 1/4 teaspoon salt. Bake for 15 minutes until chicken is cooked through. Serve over spaghetti.



Facelift for Pauly's Hotel

Beloved live music venue received more than a fresh coat of paint under new ownership

ALBANY — Pauly's Hotel recently received a facelift and is ready for a revamped social life.

Albany's oldest tavern has been a go to for live music in the Capital City. Boasting live entertainment "seven days a week," its intimate stage has played host to various acts, both local and regional. In particular, the Washington Square venue has been a welcoming place for punk bands throughout the Northeast.

The pub has recently changed management, which has invested in a overhaul in both the appearance and performance of the live music venue.

Denis Entertainment Group was hired to upgrade the sound system and stage lighting. Improvements include room treatments to improve acoustics, additional amps, monitors and mixers and enhanced lighting.

"We have also reconfigured the stage lighting and added some fixtures and a DMX controller to properly light the performances," Denis Entertainment stated. "[Lighting] will be dramatically improved and Pauly's will be a great place for local and regional bands to play."

Pauly's Hotel has a long history of hosting live music. Marshall Crenshaw, Johnny Copeland and Dr. John were just a few acts to grace the stage in the 1980s. Some local Phish fans can boast seeing the venerable jamband play its first Albany show at Pauly's in 1989.

Pauly's, however, fell silent for more than a decade before it reopened in December 2010 under then-owner John Mancini. Last week, *Nippertown* reported that Pauly's new owner Kip Finck plans on reopening the Central Avenue venue soon. Finck, a longtime music promoter, formerly owned Northern Lights in Clifton Park.

Area promoter Joe Vonschinzel has been tapped to book shows on the redesigned stage. He stated on social media that Finck will continue to welcome the punk, rock and metal bands visitors are used to seeing there.

Albany is best music town

Best Of NYS Music 2019: Best Music Towns

ew York is a vast state with pockets of local scenes throughout. While a "scene" these days isn't what it was in the '80s or '90s where bands of similar genres created scenes out of necessity, the music scenes of the 21st century are, more or less, regions where live music is simply a way of life. Some regions are even cross-pollinating. So while we aren't seeing strictly area scenes, live music is no less prevalent around the state.

We polled our staff looking for the best music towns across the state and this year, our state's capital came out on top. The Albany area's diverse scene includes small venues such as Parish Public House, The Hollow Bar + Kitchen and The Low Beat, mid-size venues that include The Egg, Cohoes Music Hall and the Palace Theatre along with the storied Times Union Center.

The Times Union Center, then known as Knickerbocker Arena, was christened on January 30, 1990, by none other than Old Blue Eyes himself, Frank Sinatra. Other big-name acts that have performed at Kickerbocker/Pepsi Arena/Times Union Center over the years include the Grateful Dead, the Rolling Stones, Billy Joel, U2, Bruce Springsteen, Celine Dion and Phish.

The Palace Theatre opened in 1931 as a movie and vaudeville house and was placed on the National Register

of Historic Places in 1979. This not-for-profit building has also hosted the Stones and Springsteen and has been the New Year's Eve home for moe. and Twiddle.

When it comes to smaller venues, Albany has plenty to choose from, attracting national and international acts that are on the rise. The Hollow Bar + Kitchen has served as host for numerous Capital District acts as well as up-and-coming national acts such as White Denim and Barns Courtney.

Add all these venues to the varied acts in the local scene and you have a diverse music community that draws from influences from all over.

Glass Pony, Wild Adriatic, Hartley's Encore and Annie in the Water are spearheading the next wave of jambands not just in the Albany area but across the state and beyond. And while the term "jamband" may bring a certain style to mind, these bands are all unique in sound, all based in rock, but drawing from disparate influences.

When you look at Albany's music history, venues such as Valentine's come to mind. moe., the Ominous Seapods, God Street Wine and others of the third wave of jambands got their feet wet in and around the Albany



Doc before gym

The role screening should play before starting an exercise regimen

xercise plays a significant role in disease prevention. According to the Centers for Disease Control and Prevention's National Center for Chronic Disease Prevention and Health Promotion, physical activity helps to reduce individuals' risk of chronic conditions, including type 2 diabetes, heart disease, various types of cancer, and dementia.

As vital as exercise is to a healthy lifestyle, many people simply are not getting enough of it. A 2018 report from the National Center for Health Statistics found that only about 23 percent of American adults between the ages of 18 and 64 are meeting the benchmarks for physical activity guidelines set forth by the U.S. Department of Health and Human Services. And that problem is not unique to the United States. A recent study from Statistics Canada found that only about 17 percent of adults in Canada were meeting the minimum guidelines for weekly physical activity established by the Canadian Society for Exercise Physiology.

Such figures illustrate the emphasis that many adults must place on getting more physical activity. But returning to physical activity after a long layoff or becoming physically active for the first time are not as simple as lacing up a pair of running shoes and hitting the road. In fact, the American College of Sports Medicine notes the importance of preparticipation health screening for adults about to engage in physical activity after a period of inactivity.



What is a preparticipation health screening?

A preparticipation health screening is an examination conducted by a physician that looks for particular issues that may interfere with one's ability to exercise. Doctors will likely ask patients about their medical histories and their family histories as well, as each of these factors can be used to determine whether a person is ready for physical activity or any restrictions need to be put in place to protect them.

What happens after a preparticipation health screening?

Once a physician conducts a health screening, he or she will conclude if an individual can exercise and how much he or she can exercise. Adults who are cleared to exercise but have never been physically active or have gone years without exercising will likely be advised to take it slowly at first. Doctors may provide specific exercise recommendations or refer patients to a sports medicine professional who can help them devise an appropriate workout regimen. Doctors also may recommend followup appointments to track patients' progress. Such appointments can be invaluable, as they can help people whose overall health has improved after limited exercise ramp up the intensity of their workouts, which can help them continue on the course to a healthier life. However, it's important that people consult their physicians before increasing the intensity of their workouts. A second screening might even be worthwhile, helping people and their physicians alter workout regimens that reflect their improved overall health.

Many people aspire to exercise more. In many instances, a preparticipation screening is a vital component for people looking to become more physically active after a long layoff.

Sever the tether

Finding balance in a tech-driven world

t is impossible to dispute the many ways technology has positively affected the world. Tech has made interacting and collaborating with people from all corners of the planet as convenient as conversing with a next door neighbor. Technology also has changed the face of education, making it possible for students from all walks of life to easily access a wealth of information at the click of a button.

- Beef up in-person socialization. Instead of texting or emailing, speak with friends, family and coworkers in person.
- Increase exercise. Time spent outdoors away from computers or other devices can be beneficial to the mind and body.
- Find alternative solutions. Rather than running an internet search every time you have a question, look up answers in a book, travel to learn about new things, experience new hobbies, and immerse yourself in the physical world with renewed vigor.

Tech has changed the world, but it doesn't have to consume people's daily lives. With some mindfulness, individuals can find the right balance.




