RAVENA — Ravena-Coeymans-Selkirk students, teachers and senior residents have been working together on two different initiatives to help support Australia in its battle against uncontrolled bushfires.

The fires began in June 2019 and have reportedly burned 72,000 square miles, destroyed 5,900 buildings, and killed at least one billion animals and 34 people. The country's tourism industry, air quality and economy have also been devastated.

# **Fatal crash**

According to New York State Police, the victim, Dakisha Brown, was driving a 2012 Kia Sedona when it drove off the the right shoulder for an unknown reason. It struck an earth embankment, turned over several times, went through a right-of-way fence and came to stop.

Brown was pronounced dead by the Albany County Coroner before she was transported to Ellis Hospital. State Police troopers, Bethlehem Fire Department, local EMS, Thruway maintenance and traffic safety responded to the scene at around 7:45 a.m. State Police are still investigating the crash.

# Town takes action on land

**BETHLEHEM** — Town Hall has locked horns with the family who owns land on Poplar Island, exercising eminent domain in an effort to preserve access to a vital portion of its water infrastructure.

Last December, the town seized approximately seven acres of land where it established the Selkirk Wellfield off Dinmore Road. The New York Supreme Court will next evaluate the town's claim for full ownership. If the court agrees, each side will present its case to settle the land's worth.

Town Supervisor David VanLuven described an amicable relationship with the previous landowner who had leased it to the town since the the mid-90s.

The agreement allowed the town to access a wellfield that supplies a portion of the town's water. But the agreement appeared to deteriorate two summers ago after Daniel and Donna Ratner purchased the land.

VanLuven stated the town had started to discuss "securing permanent rights" to the wells in 2018.

Those talks failed, VanLuven said, after the town was issued a notice of trespass and was directed to speak with the Ratners' lawyer.

Dan Biersdorf, the landowners' lawyer, told WTEN his client's only argument is over the value of the

According to town records, the Ratners had quoted a \$400,000 asking price for the stretch of land that abuts the west bank of the Hudson River. The asking price reportedly far exceeds the town's expectation. The town has the land assessed at \$7,616.

Last February, VanLuven said the appraised fair market value was

"I am extremely disappointed that the landowner is refusing to talk to us," VanLuven said last February, as the situation dissolved to the point that the town first sought to take the land. "I come from the land-conservation world, so eminent domain are two of the filthiest words in my dictionary. But as much as I dislike the situation, we cannot play games with a public water supply that serves more than 11,600 residents and businesses and 1,670 fire hydrants. This is a critical public need, and one that had been

in place for about a decade before the new landowner even purchased the property."

Town records state the land has been under a permanent land conservation easement since 2011. restricting future development on the land.

Since 2005, the land has housed five drinking water wells. That water is treated at the Clapper Road water plant just north of the

The Selkirk Wellfield is one of four major sources that draws approximately 1.6 billion gallons of water each year. The town also receives water from the Vly Creek Reservoir and New Scotland Wellfield, and purchases water from the City of Albany, which comes from the Alcove Reservoir in the Town of Coeymans.

The act to seize the land came nearly a year after the town passed a resolution to proceed with eminent domain.

"As we have been through this entire process," stated VanLuven, "we are committed to paying the full market value for the property so that we, and the landowner, can move on."

# Bethlehem Central capital project update

Renovations still underway to improve district facilities

#### **BETHLEHEM**

— While work on the Bethlehem Central School District's \$32 million Capital Improvement Project is set to finish this fall, several major projects have already been completed.

The capital project, approved by voters in 2016, seeks to improve the district's schools regarding security upgrades, select windows improvement, office space and select classroom renovations, electrical and plumbing work, more ADA-compliant restrooms, new drainage, adding parking spaces and more.

Gregg Nolte, the district's director of facilities and operations, and JoEllen Gardner, who handles communications, gave Spotlight News a private tour of the high school on Wednesday, Jan. 22, highlighting the capital project's progress.


The improved high school swimming pool area had opened in early September 2019 before classes began. Redone to promote the school district's black and orange color scheme, the pool retains its original depth of at least four feet as well as its accompanying bleachers. Improvements include new filters, color-coordinated

tiles and pumps. Nolte said the pool had been anticipated to open by mid-August but workers discovered that its old pipes and drainage needed to be fixed as well.

The high school's auditorium, originally erected in 1952, is among the capital project's biggest works and is set to open this June. As of late January, the space looked almost unrecognizable as there were many temporary metallic beams, wooden supportive planks suspended above, dusty ladders standing throughout and construction workers hauling equipment around. Nolte explained that the

auditorium's stage area is set to be raised to 25 feet and its proscenium will be widened to allow more space for users and theater

productions.

The auditorium will also have renovated interior seating, new airconditioning, be ADA-compliant, have a new production/director booth and improved acoustical ceiling and walls, which includes so-called white or grey "river rocks" being suspended from above.

The river rocks appear to be large almost-circular-like panels, inspired by rocks found at the Hudson River, according to Nolte. "A lot of the design revolved around the founding of Bethlehem which had a lot of influence from the Hudson River,"

he added. "These rocks above us will help with the sound and acoustics in the auditorium; some collect and some absorb." During the tour, the river rocks were not yet completed but their skeletal-like structure are being installed.

A redesigned entrance will also require a user to open the entrance door from the main hallway outside; they would briefly walk straight and then make a left/right turn before actually reaching the auditorium itself. "Before this [capital] project, if a talking person or some light is right out in the hallway, people could see the light or hear the person talking from inside the auditorium," Nolte said. "The new design is going

to block any outside light from getting in and you won't hear as many sounds from outside. In turn, you wouldn't hear stuff going on in the auditorium if you're right out in the hallway."

The high school's Library Media Center was another area highlighted in the capital project.

Set to reopen soon, it has already been repainted in white, orange, yellow and turquoise to offer a more youthful glow but furniture, electronics and books have yet to be fully moved in. It will also feature a Makerspace studio space and a separate classroom for students and faculty.

Nolte noted a longrunning orange ribbon design, which stretches across the LMC's various ceilings, as a prominent feature as well as how many walls have a wavy and fluidlike design.

"I think the soft lines throughout are meant to give off a calming effect to people," Gardner said. Nolte said it makes the LMC look more modern and inviting, accompanied with how windows have been reworked to allow more natural light inside.

Since the LMC has been closed this past year, the high school converted a classroom — room B122 — into a temporary library space with select book collections, shelves and computers. Nolte said the temporary library would be converted into a conference meeting room after the LMC opens.

Nolte also showed how the Justin T. Brown Student Information Technology HelpDesk — run by 20 student interns and a few district technicians to offer assistance with electronics — has been moved from a dark room within the LMC to having a slightly bigger space and different layout beside the LMC's entrance. "It's going to be more inviting and accessible to students as opposed to having to previously walk into the LMC and find it," he said, showcasing how the new Student Help Desk has its own entrance door that faces out to the main hallway outside.

The new helpdesk opened the week of Jan. 30 and is named after

# Macy's to close underperforming stores

Crossgates Mall store may be safe but Colonie Center's remains unknown

ALBANY — Questions loom over the fate of the area's two Macy's department stores after its corporate office announced it will close more than 100 underperforming stores within the next three years.

The nation's largest department store chain announced Tuesday, Feb. 4, a three-year plan to stabilize and grow profits. That strategy will involve shuttering 125 shopping mall stores and closing its San Francisco, downtown Cincinnati and Lorain, Ohio offices.

Jeff Gennette, chairman and CEO of Macy's, Inc., said the company will work to "lower cost" and "reduce duplicative work" over the next three years.

"This will be a tough week for our team as we say goodbye to great colleagues and good

friends," Gennette said in a company statement. "The changes we are making are deep and impact every area of the business, but they are necessary. I know we will come out of this transition stronger, more agile and better fit to compete in today's retail environment."

Macy's has built a retail empire since opening its first storefront in New York City more than 160 years ago. It has erected stores or acquired smaller regional chains over the years, taking over such names as Filene's in 2005, Jordan Marsh in 1996 and several more along the way. Today, the

brand that currently includes Bloomingdale's boasts 842 locations.

The store chain's recent announcement noticeably referenced a New York dateline instead of Cincinnati. Macy's headquarters will move from Cincinnati, where it has been since 1994, to New York City.

Macy's completed an aggressive evaluation of its fleet of stores, including projected profitability of each location based on consumer trends and demographics. Stores identified as underperforming will be closed. In total, 125 locations are targeted, 30 of which are already in the process of closing. The stores slated to close represent approximately \$1.4 billion in annual sales.

The chain's new strategy addresses four components; strengthening customer relationships, curating quality fashion, accelerating digital growth and optimizing store portfolio. Part of that strategy was unveiled at Crossgates Mall last August.

The Crossgates Mall anchor

store went through a noticeable change last year as it prepared to open its newest Macy's Backstage. The 14,500-square-foot area within the store's first floor offers discount products, many of which line the aisle leading up to a cash register.

"Our customers expect convenience and a tailored experience across all channels," Gennette stated. "The more convenient, brand-right touchpoints we have, the greater loyalty and engagement we engender. This will enable us to grow with the next generation of American shoppers."

Gennette's announcement called the success of Macy's Backstage as one of the chain's "highlights." The company plans to open an additional 50 Backstage store-within-store locations this year with an additional seven freestanding, offmall Backstage stores.

Citing Macy's Backstage as a success may quell fears of the Crossgates Mall location closing, but that still leaves the question

# Helping Australia

The A.W. Becker Elementary School Council raised \$400 with a coin drop since last month, with all proceeds benefiting the Australia Wildfire Fund. Principal Debra Neubart said she sent a letter to students' homes on Jan. 13 regarding the ongoing Australian bushfires and the school's planned fundraising campaign. The coin-drop container is at the school's main office which also accepts donations in envelopes.

While this campaign concludes later this month, Neubart said, "Everyone has been very generous so far and if anyone still wants to contribute, we are still accepting donations." She added that some of the donations have been sent to the fund on the week of Feb. 2 and the next submission will be during the week of Feb. 16.

The aforementioned Jan. 13 letter also included a template for students to each draw and color a koala in support of Australia and to raise awareness of what's happening there. Around 150 students designed

their own koalas, which are posted as a giant mural in the school's main lobby.

Neubart said the school council's president was the one who brainstormed with her last month to find ways for the school to contribute to Australia's battle with its bushfires.

"She was passionate about doing something and I wanted to do something too," Neubart said. "She wanted something related to koalas and we didn't have to only donate to show support for the koalas. The koala mural will stay up until probably March.'

Neubart said she first heard about the Australian bushfires in the news and felt a personal connection because she has extended family there and she has visited the country before.

"I spent several months touring the country and my extended family is okay," she said. "But it was quite devastating to hear."

"Everyone has been very generous and the students have been very passionate in wanting to learn more about the efforts in Australia and how they



could help," she said.

# **Joev Pouches**

Also since last month, 15 RCS middle school and five high school students worked with six senior residents at the Van Allen Senior Apartments in

Glenmont to make around 125 Joey Pouches in response to the Australian bushfires.

According to the district's website, the Joey Pouches "are designed to protect and offer comfort to animals that were impacted by the crisis," inspired by joeys being nurtured inside their kangaroo mothers' pouches. There has been an international call from

Australia for people to make and donate Joey Pouches that mimic reallife kangaroo pouches; they will not just serve orphaned joeys but also other small affected animals like koalas.

Erin Sawyer, a middle school social studies teacher, said she and a colleague, Daria Carusone, run the STARS intergen program with Linda Bruno who heads it. The program connects RCS students with the aforementioned seniors so different generations can learn about one another through projects like learning how to cook and teaching seniors how to use technology. When they learned that Joey Pouches are in demand in Australia, they decided to make it a project for their students and the participating seniors.

Sawyer said there was an online pre-made template for Joey Pouches so she, Carusone and Bruno bought the fabrics needed for the students and seniors.

"It was really cool to see them working together for a common cause, especially in terms of sewing because that's usually something teens and pre-teens don't have on their minds today," Sawyer said. "There was

some difficulty with the template initially and some mistakes were made cutting it. But some students stepped up and created like an assembly line to get the work done."

Sawyer added that the project was beneficial to the students because "when you're anywhere between 12 and 17 years old, it's easy to think about your own personal world. But this was an opportunity for them to care about something outside their community that has a true global impact. The kids were very excited."

Sawyer said the 125 Joey Pouches were recently sent off to Australia and the students also have been working on presentations to show the seniors about what they have learned about Australia.

"The students were surprised when we showed them just how big Australia is compared to the U.S. after we superimposed the two countries together on a map," she said. "Young people also often associate one or two things with a country and for Australia, it's often kangaroos and koalas. But it's good for them to know there's so much more there."

# BC capital project

Justin Brown, a former BC technology staff member who co-founded the original student helpdesk. The 32-year-old man had worked at the district for a decade before passing away in September, 2018.

"The district held a memorial service in the fall of 2018 to celebrate Justin's life and his impact on BC. At that time, there was not a dry eye in the room when we announced the Student Helpdesk would be renamed in his honor," said Superintendent Jody Monroe. "More than a year later, the Justin T. Brown Information Technology Helpdesk now has a new permanent home, one that we hope he would be proud of."

Elsewhere, the high school kitchen has been improved to have a slightly higher ceiling, a few large windows to allow sunlight in, a redesigned dishwashing area, new office space for the district's food service director and assistant, two new freezers and a new fridge. Restrooms are still undergoing renovations and will be ADA-compliant, and the old employee training space in the district's transportation building is being redone too.

Although there is more work scheduled across the district through this summer, Nolte expressed optimism that everything will finish by this fall as scheduled and gratitude to students, faculty and parents for bearing with the ongoing construction work so far.

# Macy's

about the Colonie Center anchor store.

Sears vacated its Colonie Center location in September 2017. Its departure left behind Macy's, Boscov's, LL Bean and REI as the mall's remaining anchor stores. Sears' downfall was just further proof that the most recognizable brands are not too large to fail as brick-and-mortar stores fell

victim to online sales. According to Forbes, online sales outpaced brick-and-mortar retailers \$261.9 billion to \$179.9 billion in 2017.

Macy's has continually addressed decreased sales in recent years. Last year, it announced it was phasing out its sale of fur, and announced a rental service at Bloomingdale's, both to attract more millennial customers. The chain had also announced the planned closure of stores last February. Nonetheless, profits continued to decline for the department

chain. Revenue declined from \$5.4 billion to \$5.2 billion, which was short of expectations according to a survey by Zacks Investment Research.

KKR & Co. L.P and Colonie Pacific currently own Colonie Center. The group placed the 54-year-old shopping mall on the market early last year. Once sold, it will mark the third time since 2009 that the mall has changed ownership.

Macy's continues to own its portion of the mall.

appreciate the emotional ceremony and I think it's been universally positive," Barber said. "It's touching to see people see their loved ones' names highlighted."

VanValkenburgh said banners typically are removed in October due to the incoming winter weather and are either returned to the respective families during a retirement ceremony or placed indoors like at Crossgates Mall.

She added, "I still think there's people that should be honored that haven't had a banner done for them so I think there's a lot more veterans out there who deserve the recognition."

Walsh said seeing banners in town may cause people to recognize some of the honored individuals and think of others they know who have not been spotlighted yet.

For 2020, both women said they

are hoping to have 29 banners up. "It's been predominantly men in the banners so far but every year, we've had a few women and that's good. One was a World War II Navy veteran," VanValkenburgh said. Walsh noted that honoring more female veterans could be an opportunity this year and beyond.

Barber and Walsh said they may reach out to the town's fire departments this year about whether they know anyone who has served on duty or possibly putting the banners beside their buildings.

When asked if the project has faced any challenges, VanValkenburgh said there have been times when families did not provide all the necessary information — like proof of their service during a war, their names and ranks — needed for the chamber to process before honoring the individual with a banner. She added that some families had to search for good photos of their loved ones, some of which are limited or only available at a small size

that may not look optimal on a banner. "We like to get pictures of people in their military uniforms but that's not always possible," she said.

Walsh said it "would be a great problem for us to run into" if the chamber receives too many submissions from the public for banners to honor their loved ones, something that has not happened yet.

Looking ahead, Barber said that since the project has been successful since its first year, he does not see a reason to not have it continue for years to come. "It's really important and it makes people aware of those around us who have defended our country," he concluded. "We hope more people can take part."



# Nominations for Eddies

About 200 performers, professionals within local arts scene vying for annual award

**SCHENECTADY** — The nominees for the second annual Capital Region Thomas Edison Music Awards have been announced. Winners will be announced at an awards ceremony 6 p.m. Sunday, April 5 on the MainStage at Proctors in Schenectady.

This year's group includes a number of nominees and winners from last year's celebration, as well as some new entries including such well-known local artists as the blues/rock sibling duo Jocelyn & Chris Arndt, the folk group Lost Radio Rounders and country artist Marty Wendell

This year's 34 categories reflect changes based on feedback from members of the music community. Several were eliminated and six new ones emerged: Metal / Hard Rock Artist of the Year, Country Cover Band of the Year, On the Verge Presenter of the Year, Best Hang, Music Recording Studio of the Year and Record Label of the Year

"Adding the country cover band category allowed us to separate and nominate more country artists, and we separated metal and hard rock music from punk and hard core for similar reasons," said Jim Murphy, co-founder and co-organizer. "And the absence of recording studio and record label categories last year was an oversight we had to fix."

"The Best Hang category was something this year's judges mulled over and favored" according to Sal Prizio, co-founder and co-organizer. "It represents the favorite hangouts of people in the local music community when they are off duty."

The category On the Verge "represents recognition of promoters of smaller and/or fewer shows – but no less exciting and relevant – than others in the area," Prizio added.

One more change from last year – the Thomas Edison Music Hall of Fame induction ceremony is being held separately from the Eddies Music Awards. The Accents, Blotto, The Fidelitys, Hal Ketchum, Lena Spencer and John Sykes were recently announced as the Class of 2020 inductees. A dinner and induction ceremony will be held for this group on Sunday, March 9 at Universal Preservation Hall in Saratoga.

The Eddies Music Awards nomination process involved 40 members of the music community including artists, members of the media and others working in the music industry. "There were exactly 25 meetings in small groups over more than two months," said Rachel Hamlin, who is serving as administrator of this year's awards process. "The judges took the task very seriously."

Roughly 100 local members of the music community have been invited to vote for winners among the nominees.

The Eddies Music Awards event on April 5 will feature performances by a number of artists across many genres, including several collaborations between acts. Performers will be announced in March.



# What is love?

Love sometimes proves to be an elusive thing this time of year, but JoAnn Falletta has a handle on it. The Grammy Award-winning conductor seems to describe it as she shares the "amazing" feeling of fronting an orchestra.

"I feel like I'm in the middle of a force field of energy," Falletta said. "And, the talent surrounding me is

astonishing. The musicians and what they can do, and how they play their instruments. So, for me, it feels like I'm almost levitating because of their energy and the sheer beauty that I'm in the middle of."

On Valentine's Day this Friday, Falletta steps up to the podium in front of the Albany Symphony as guest conductor. She will lead the orchestra through selections of Sergei Prokofiev's "Romeo and Juliet" and other works at Proctors. It's a special night to draw the Albany Symphony out of the Palace Theatre. It's quite another feat to have someone else other than its own Grammy Awardwinning conductor David Alan Miller at the podium.

Falletta is lauded in the global music scene as one

of the best conductors in a generation. Washington Post's music critic Joe Banno bestowed his respect upon her while she headed the Virginia Symphony Orchestra. It was 20 years ago when he watched her lead an "unusually young and fresh-faced lot" through its debut performance at Washington D.C.'s Kennedy Center.

"Few women have been able to establish high-profile conducting careers, and of those who have, fewer still have Falletta's talent," wrote Banno. "Toscanini's tight control over ensemble, Walter's affectionate balancing of inner voices and Stokowski's gutsy showmanship."

Name a city in the United States that has an orchestra

and Falletta has stood before it. Philadelphia. Los Angeles. San Francisco. Dallas. St. Louis. Milwaukee. Indianapolis. Seattle. San Diego. Detroit. The National Symphony too. She has guest conducted over one hundred orchestras in North America and many of the most prominent orchestras in Europe, Asia, South America and Africa. But while she's not traveling, she returns to the City of Light, where she serves as music director of the Buffalo Philharmonic Orchestra.

The Buffalo Philharmonic Orchestra is the crown jewel of an arts and music scene Proctors CEO Philip Morris admires. At a December meeting of the Albany

Roundtable, Morris revered Buffalo's efforts to maintain its "inherited" heirlooms from when it was the 15th largest city in the union a century ago. While addressing Proctors' plans for the new home of Albany's Capital Repertory Theater, he spoke of how the local arts community could aspire to own a similar scene.

"Buffalo has one big Broadway house. Buffalo has one professional orchestra. Buffalo has one unbelievably spectacular art museum," said Morris. "How do we capture the fact that we are in this region, in such a way that in 10 years, we can actually compete with Buffalo?"

In addition to her accolades earned on the podium, she has appeared as guitarist, mandolinist and lutenist with several orchestras, including the New York Philharmonic, Metropolitan Opera Orchestra and the Juilliard Orchestra. She has received wide critical acclaim for her guitar chamber music recordings with the Virginia Arts Festival.

Throughout her career, Falletta has observed the music scene opening up and allowing more opportunities for women conductors. As an example, 33-year-old Mirga Gražinytė-Tyla was up for the 2020 Grammy Award for Best Orchestral Performance in January. Falletta had earned her first individual Grammy Award in 2019.

"I feel very lucky that I was able to study and be accepted as a woman," Falletta said. "Or, as a conductor, I should say. Not as a woman conductor, but as a conductor. But, I'm very happy to see that things are changing for women now."

The maestra said she looks forward to the end of her





# A Brilliant Bit of Color: The **Work of Walter Launt Palmer**

The Albany Institute of History & Art holds the largest public collection of works by artist Walter Launt Palmer (1854-1932), son of Albany sculptor Erastus Dow Palmer. It includes oil and watercolor paintings, pastels, pencil drawings, a rare painted ceramic cup, as well as letters and photographs. A new exhibition at the Albany Institute offers a visual overview of Palmer's life, travels, and artistic output. The exhibition includes works from all three of Palmer's major series: the early interior views where Palmer lavished attention on the textiles, ceramics, furniture, and wall decorations that filled well-furnished homes; his Venetian scenes that capture the luxuriant colors of the sea, sky, and buildings of this island city; and the snow scenes that continue to enchant viewers with their masterful tonal subtleties. Drawings, photographs, and ceramics accompany the exhibition. A Brilliant Bit of Color: The Work of Walter Launt Palmer is on exhibit from now until Friday, June 7. #### **Ancient Egypt**

Egyptologist and Guest Curator Dr. Peter Lacovara has incorporated the research and scientific discoveries revealed in the GE Presents: The Mystery of the Albany Mummies exhibition into a new exhibition about Ancient Egypt. Visitors to the museum will continue to enjoy the story of the Albany mummies, learn about the history of Ancient Egypt, and see how the intersection of new science, technology, and scholarship changes how we learn. In addition to the story of Mummy Ankhefenmut, theme and topics in the new galleries include: Egyptian History and Civilization; the Nile and the Environment; Crafts and Professions; Food and Drink; Gods and Goddesses; and Preparing for the Afterlife. The Jabbur Gallery now features the story of Albany's 3,000 year old mummy, Ankhefenmut, a priest and sculptor in the Temple of Mut, along with his recently discovered priest's robe, his coffin base from the museum's collection, and his beautiful coffin lid on loan from the Kunsthistoriches Museum, Vienna. The museum's Ptolemaic Period mummy and his coffin are now on view in the Heinrich Medicus Gallery with a selection of over seventy objects highlighting ancient Egyptian daily life, afterlife, and animal mummies. Joining objects from the museum's collection are loans from the Phoebe A. Hearst Museum of Anthropology, Museum of Natural History, the Metropolitan Museum of Art, Museum of Fine Arts, Boston, the Semitic Museum, Harvard University, University of Pennsylvania, Williams College, and a number of private collections. Also included are a timeline and a slide presentation highlighting the trip the Albany Mummies took to Albany Medical Center for x-rays and CT scans, which revealed new information about the age, gender, and occupation of these mummies. Ancient Egypt is an ongoing exhibit. Albany Institute of History and Art is located at 125 Washington Ave., Albany.

### "a small fort, which our people call Fort Orange"

Fort Orange was the first permanent Dutch settlement in New Netherland, built as a trading post by the West India Company in 1624 at the location of pres-


ent-day Albany along the Hudson River. Between 1624 and 1664, the fort's role in the development of New Netherland changed—from a point of contact and trade between Native Americans and Europeans, to an enclosure with dwellings and private enterprises, and finally an abandoned space consumed by the development of Albany. Centuries later, Fort Orange on the surface had long disappeared. But in a six-month period in 1970 and 1971-just ahead of Interstate 787 construction—a small archaeology team from the State Historic Trust (predecessor to the Office of Parks, Recreation and Historic Preservation, or OPRHP), headed by Paul Huey and composed mostly of volunteers, made remarkable discoveries about life in the Dutch colony at Fort Orange. In 2016, a collection of 36,000 artifacts from Fort Orange was transferred from OPRHP to the New York State Museum. This exhibition examines the momentous discovery of Fort Orange and the lasting impact of events occurring there 400 years ago that shaped the character of the region, New York State, and the nation. The exhibition title is a quote taken from The New World by Johannes De Laet, a director of the Dutch West India Company, recorded in 1625. Select artifacts, film footage from the excavation, and four decades of historical and archaeological research are highlighted-including renderings of the fort by Historical Artist Len Tantillo. 





ancakes are a beloved breakfast food. Fluffy and filling, pancakes can be soaked in syrup and/ or topped with any number of fruits or nuts. Pancakes also can be turned into delicious desserts when paired with ice cream and other treats.

The Danish have a unique spin on traditional pancakes. Known as "aebleskivers," these balls made from a pancaketype batter puff up in a special pan and end up resembling doughnut holes. They can be served for breakfast, snacks or desserts — making them as versatile as pancakes. Try aebleskivers for yourself with this recipe for "Aebleskivers" from "Small Sweet Treats" (Gibbs Smith) by Marguerite Marceau Henderson.

# Aebleskivers

# Ingredients: Makes about 3 dozen

- 1 Aebleskiver pan
- 2 cups all-purpose flour
- 1 teaspoon baking powder
- 1 teaspoon baking soda
- 1/2 teaspoon ground cardamom
- 1/2 teaspoon kosher salt
- 1/2 cup sugar
- 3 large egg yolks
- 1 teaspoon vanilla extract

- cups buttermilk
- 3 large egg whites
- tablespoon unsalted butter Raspberry or strawberry preserves Powdered sugar

# **Instructions**

In a medium bowl, combine the flour, baking powder, baking soda, cardamom, salt, and sugar.

In another bowl, beat the egg yolks, vanilla and buttermilk with a whisk or handheld mixer until frothy. Stir the dry ingredients into the wet ingredients just to combine

In another bowl, beat the egg whites until frothy and stiff peaks form. Gently fold the egg whites into the batter.

Rub a little of the unsalted butter into each indentation of a well-heated aebleskivers pan. With a paper towel, remove excess butter. Place about 1 tablespoon batter in each indentation, top with about 1/2 teaspoon of preserves of choice, and add another tablespoon of batter on top. Cook until the sides are set and bottom is golden brown, about 2 minutes. Using two wooden skewers, carefully turn the aebleskivers over to cook the other side. Cook for 1 to 2 minutes more. Transfer to a platter, dust with powdered sugar, and serve hot. Repeat with remaining batter.

# How much octane is in that cup?

Caffeine content in popular coffees







# Kicking the virtual tires

Tips before buying a car online

ar buying has come a long way since automobiles were first made available to the masses. Over time, drivers' options in regard to available vehicles have increased and the methods of paying for vehicles has changed. 
drive various vehicles and experience certain features for themselves. Buyers can then use these visits to inform their online buying decisions.



Buyers who cannot see a car in person but want to buy it anyway should familiarize themselves with return policies if the car does not meet their expectations upon delivery.







## TMS helps clients overcome depression

Pinnacle's treatments: A Positive Impact

ALBANY — Pinnacle Behavioral Health's Transcranial Magnetic Stimulation (TMS) therapy has been a great success.

In its first year, there have been more than 3,000 TMS sessions at the McKown Road office, and the results have echoed those of other similar facilities across the United

"Over 80 percent of our clients showed significant improvement of their depression, and of that 80 percent, 50 percent went into full remission," said Rocco Pezzulo, Pinnacle's Director of Operations.

TMS treatment involves the use of an

electromagnetic coil located within the helmet which is then placed on the patient's head, directed at the left prefrontal cortex – the area of the brain that is associated with depression. Each session lasts about 20 minutes, during which, electromagnetic pulses are sent through the coil to the brain at two-second intervals, followed by 20 seconds of rest. The technician gradually increases the intensity of treatment until the therapeutic dose is reached to ensure the patient can tolerate the stimulation.

Patients go through seven to eight weeks of TMS sessions. During the first month, patients must visit every week day in order for the treatment to "train the brain and regulate mood," said Pezzulo. Then, treatments are typically scaled down to two to three times per week over the final two to four weeks, although patients have the option of continuing daily treatments if necessary.

"Pinnacle offers morning, afternoon and evening sessions in order to accommodate our patients' busy schedules" said Pezzulo. "People often ask us what our hours are. We're open from 8 a.m. to

7 p.m. Monday through Friday."

Pinnacle doesn't rely on TMS alone to treat patients experiencing severe depression. They complement TMS treatment with some of its other therapeutic programs, such as Tai Chi, yoga and Qi Gong as well as offering a weekly TMS Support Group. This group is open to any individual, family member or loved one who is interested in TMS, patients who are currently in the program and those who have completed treatment.

"Our results have been slightly better than the national average" as a result of pairing TMS with other services, said Pezzulo.

Although TMS is not the first line of treatment offered, patients who

have not had relief from medications or therapy are perfect candidates. For those who have received it, the difference can be striking, said Pezzulo. "By the time they complete treatment, patients appear brighter and have an overall improved quality of life."
