

# 50 years of the Fifth Grade Musical

Performances scheduled this week

# SLINGERLANDS —

Slingerlands Elementary School will celebrate the 50th anniversary of its Fifth Grade Musical with a stage production of "Our School" this week.

"Our School" is directed and written by teacher Lester Betor in the style of "Our Town," a 1938 play by Pulitzer Prize-winning playwright Thornton Wilder. While the latter's story revolved around a fictional American town and its everyday citizens in the early 1910s, the former will focus on Slingerlands Elementary School's history, some of its past and current faculty, and the longtime musical program.

Performances will be held on Thursday, March 5 and Friday, March 6 at 7 p.m. at the school auditorium; doors open at 6:15 p.m. and seating is first-come, first-served. While advanced tickets were sold by Wednesday, Feb. 26, limited tickets for \$3 each may still be available at the door.

Accompanying Betor is

assistant director Connie Clarkson, accompanist Patricia Eberle, technical director Heather Reid, crew chief Bonnie O'Shea, graphic designer Megan Fargione and principal Heidi Bonacquist.

Betor said "Our Town" is his favorite play; he remembered watching it in high school and he "often wanted to do something based on that." As "Our Town" is staged with few and minimal props, he said he liked how imaginative the experience was while

still enjoying its story.

Betor has been involved in six stage productions at the school and "Our School" will be his last, saying that he wants to go out on a high note and it felt right that it ties in with the musical program's 50th anniversary. He added that "Our School" is a great way to reflect on the importance of the school's musical program, the opportunities it has given to faculty and students through the years and it recognizes key faculty members.

According to Betor, the Fifth Grade Musical began in 1970 by the late music teacher Virginia Spelich, who died in 1994 at 70. It originally started like a spring concert with a few speaking roles for students and some costumes. But as years passed, plays became staged and many students were given cast and crew roles.

This year, the 90-minute "Our School" production will have three acts and involves 76 students — 60 are portraying characters on

stage and 16 handling crew duties. Betor said more students have been able to be involved because since there are three acts, one character may be played by a different student in each

"We try to find the kids' strengths and work with them. If a kid feels too scared to get on stage, they could work backstage, for example," Betor said.

Bonacquist said, "My favorite part about the musical is that every kid who wants a part gets a part. For many of them, it'll be the only opportunity they'll have to be in a production without the chance of getting cut, which happens in middle and high school. They cut kids there in auditions. But here, if a kid auditions, they're in. If they want a solo or one line, they try out and get a part."

Kelly Ward, one of three parent co-chairs who help support the musical, expressed gratitude to parent volunteers who helped bring "Our School" to life and were understanding of their children's rehearsal schedules. Ward, whose daughter portrays Spelich in "Our School," said parent volunteers have been involved in hair, makeup,

costumes, props, designing the program, poster and logo, organizing the cast party and handling ticket sales.

"You definitely can't do them without parents' help and a lot of them luckily choose to be involved in things they're talented in," Ward said. "People who choose costumes are creative and can sew, for example. One of them [Fargione] has a background in graphic design and did the beautiful program's logo and poster."

Betor said "Our School" will feature numerous songs, that he purchased the rights for, which will complement the story. Songs he chose include Neil Diamond's "Sweet Caroline," Pharrell Williams' "Happy," the Beatles' cover of "Twist and Shout," ABBA's "Dancing Queen" and Andy Grammer's "Keep Your Head Up."

"As I was writing 'Our School,'I'm thinking about songs I'd like to use and traditionally, I use Broadway musical songs and this year I decided to make it a little different. ... The kids don't usually know the songs until we start

# Officials urge public to wash hands



NEW YORK — While Wall Street investors took a bath as the world panicked over how a developing epidemic would affect the global economy, health officials shared one common message to help settle concerns:

Wash your hands.

The World Health Organization has reported over 3,000 deaths and nearly 90,000 cases of novel coronavirus worldwide since Monday, March 2. Those figures include the death of a Washington state man who died after contracting COVID-19 while staying at a longterm care facility. The virus' spread to 59 countries and territories had Dr. Nancy Messonnier, the director of the National Center for Immunization and Respiratory Diseases, referring to the situation

last week as a near pandemic.

The Centers for Disease Control and Prevention scrambled in January to provide tests and information. According to the CDC, 15 cases have been confirmed in the

United States. A New York City resident was confirmed over the weekend as the state's first case. That person reportedly contracted the virus after visiting Iran.

"To date, our containment strategies have been largely successful,"

Messonnier said. "As a result, we have very few cases in the United States and no spread in the community. But as more and more countries experience community spread, successful containment at our borders becomes harder and harder. Ultimately, we expect we will see community spread in this country.

"It's not so much a question of if this will happen anymore but rather more a question of exactly when this will happen and how many people in this country will have severe illness," Messonnier said.

Messonnier's words resonated throughout Washington and New York. President Donald Trump would later appoint Vice President Michael Pence to head the country's response to the epidemic. However, it did not quell a floundering Dow Jones Industrial Average as Wall

Street reacted to fears the virus could cripple the world economy.

The Dow lost more than 3,500 points by last Friday's close of business, representing a 12 percent loss. Coupled with a 11.5 percent loss in the S&P 500, Wall Street witnessed \$3.6 trillion in market value cyphoned from investments, representing the worst week in trading since 2008.

Since efforts to prevent the spread of novel coronavirus to the United States started in earnest in January, the CDC has fielded criticism over its test kits. According to Buzzfeed News, the initial tests were based on three "primer" sets of DNA sequences that match the virus. Labs found that the third primer in the tests gave varying results. Messonnier confirmed that issue last week.

"I am frustrated like I know many of you are that we have had issues with

our test," said Messonnier. "I want to assure you that we are working to modify the kit and hope to send out a new version to state and local jurisdictions soon. There are currently 12 states or localities around the U.S. that can test samples as well as we are testing at CDC 400 samples were tested overnight."

Local health officials took initiative to inform the public on how to combat against contracting the virus.

No cases of novel coronavirus have been detected locally, according to an Albany County spokesperson. The county reported that one person who had previously exhibited symptoms was later released from quarantine after testing negative to the virus. Eight other households had been under observation after having returned recently



# Dive pool in the works

Construction is set to begin this fall and the pool will open in 2021. Summer construction was ruled out; Town Supervisor David VanLuven explained it was due to challenges in receiving bids and the work schedules of the interested pool construction companies, Midatlantic and the Buffalo-based P&S.

"The good side of that is that we're not going to have active construction going on in the pool complex during the summer months, so we'll have that eyesore and not have the dive pool for another season but everyone will still be able to enjoy all of the other amenities that we have at the pool complex without the roaring rumble of

construction," he said.

The original dive pool was built in 1973 but closed in summer 2019 after its deteriorated structural integrity was deemed beyond repair. This started a townwide discussion on whether to replace it with another dive pool or a new two-slide pool. In 2019, many residents expressed they wanted the original dive pool repaired or replaced when they spoke to the Town Board and took part in two public online surveys. At this year's Feb. 12 Town Board meeting, numerous residents spoke in support of the dive pool option again in a special interactive public forum.

"We are so lucky to live

in a community where we get to have a raging debate over a 15-foot-high double-slide pool or a wonderful dive pool," VanLuven said. "It reflects, I think, on the quality of life and tradition that we have in Bethlehem. I think that's something that we celebrate."

Town Board member Maureen Cunningham echoed VanLuven's statements, saying, "It was really incredible to see everyone — from Girl Scouts to older people in town and everyone in between — commenting, although most people really did want the dive pool."

She added that she hopes such public interest and discourse will not fade away when it comes to other important town issues, including open space, energy efficiency and a lack of a formal Black History Month event. "So, don't

go away," she said. "For all the people who spoke up for the dive pool, there are many other issues and I hope to see you again at the Town Board and writing to us on those issues."

Town Board member Dan Coffey also expressed appreciation for the public turnout, regardless of which pool option they preferred. "We saw a tremendous amount of participation from everyone ... and we just appreciate the amount of civic involvement on everyone's part," he said.

Town Board member Jim Foster chimed in, "I think this is a great lesson for the community and this has been a very positive experience for all of us. It's a great example of the fact that we can always revisit decision-making and there's nothing wrong with that. And I think we need to be cognizant of what the wishes of the community are and their opinions are certainly valuable."

He continued, "I think the outcome is a great one and we look forward to enjoying the dive pool for generations to come."

When Midatlantic Construction and Design Associates presented a bid for \$719,000 for the dive pool's construction, it was the cheapest out of the four bids the town received at its Feb. 12 meeting. This led Jason Gallo, the town's Parks and Recreation administrator, to recommend the Town Board to choose that bid. "The dive pool has been an instrumental part of the town's pool complex for more than four decades," he said. "There's a clear affinity among the community for it."

The dive pool's construction would have cost \$822,000 if the town moved forward with P&S. However, the slide pool would cost \$1.1 million with P&S or \$757,000 with Midatlantic.

singing them and then they become fans of them and their music," Betor said. "This year, I think they love 'Sweet Caroline' especially."

Bonacquist brought up that "Our School" will also feature a new piano that cost over \$7,000; Slingerlands Elementary School received the new instrument two weeks ago, thanks to Slingerlands students' parents, a school fundraiser and the Bethlehem Music Association. It is being dedicated to the Fifth Grade Musical's 50th anniversary.

"I've been here for 20 years and it's hard to believe that the musical program has been around for 50," Bonacquist said; she will retire after this year. "To me, it is really exciting and a huge celebration for a tradition that really means so much to this community."

During a brief tour of the school's hallways, she showed many framed

photographs of past musicals and their casts through the years and she said there have been times where there was not enough space to continue hanging all of them.

When asked if he experienced pressure in directing the musical for the 50th anniversary, Betor said, "I think there's a lot to live up to and it's different. # Coronavirus

from China, but no one showed signs of the virus.

"On Wednesday, Governor Cuomo announced \$40 million emergency appropriation to support DOH staffing and equipment as we prepare for future mitigation," the state Department of Health said in an email statement. "The New York State Department of Health is working closely with its partners at the federal, state and local level on this constantly evolving public health emergency. And while we prepare, it's important to note there are still no confirmed cases of the novel coronavirus in New York State."

The danger to local residents is low, said Director of Communications at Albany County Executive's Office Mary Rozak last week, repeating a statement released earlier by County Health Commissioner Elizabeth F. Whalen.

Though the effort against the virus' spread

has been taken seriously, said Rozak, she reiterated its comparison to the seasonal flu. Since last October, approximately 46,000 people have died worldwide from influenza. In comparison, novel coronavirus has killed less than 10 percent of that figure.

The CDC's press conference last week invoked documented steps on preventing the spread of influenza as a means to mount a domestic defense against novel coronavirus. Rozak shared a similar strategy last week.

"This is a daily changing situation," Rozak said. "I don't think anything is overblown when you tell people to follow best practices."

Cover your mouth. Wash your hands. Stay home when you're sick.

Those are the abridged guidelines stated in the Morbidity and Mortality Weekly Report's "Community Mitigation Guidelines to Prevent Pandemic Influenza — United States." It was presented in 2017 as a means to mitigate the spread of influenza while no vaccine is available.

"The best way to make sure we're not spreading anything is to follow these best practices," Rozak said.

# What once was lost

Universal Preservation Hall officially opens

SARATOGA SPRINGS — "We finally did it."

Universal Preservation Hall Director Teddy Foster exclaimed those words to a group of guests from inside the old church's grand hall moments before it would host Rosanne Cash on Saturday, Feb. 29.

The night represented a culmination of nearly 20 years — and more than \$7 million — worth of effort to save, preserve and renovate the former Methodist-Episcopal Church that was originally built in 1871.

The nearly 150-year-old church was condemned in 2000 and slated for demolition before a grassroots effort saved it in 2003. In 2015, Proctors announced it would join the effort to revitalize the church on Washington Street into an 800-seat venue for the arts, music and theatre.

The union between UPH and Proctors ties Schenectady and Saratoga counties in an effort to promote effective arts partnership through regionalism. Proctors manages operations, marketing and relationships for UPH.

The goal of the partnership is to generate commerce for downtown Saratoga Springs and surrounding business districts through patronage of restaurants, shops and

services as guests attend concerts of all types; wedding receptions; lectures; dance performances; theatrical productions; film festivals; corporate meetings; art gallery events and more.

The 12,000-square-foot venue is anticipated to host 200 hosts a year, with a concentration on music events. Some nights will be open for public and civic events such as political debates. An undisclosed portion of the property will be rented out for professional use.

The Great Hall, from which the entertainment will perform, is accentuated by a vaulted, 45-foot ceiling and banks of stained glass windows.

"I can't help but chuckle. It's just so surreal the difference these three days have made in my life," Gargano said in a phone interview last Wednesday. "It's definitely so whacky going from your family and friends as your fanbase to these random people messaging me."

One such random message came from a fan asking her to come to Brazil.

She's kept the results of the audition a secret to those around her, with the exception of family members who accompanied her to Washington, D.C. The obligation to keep news under wraps was immediately put to the test back in Albany. There, she performed at the same one-day festival as Madison VanDenburg.

"I almost wanted to run up to her, talk to her about it," Gargano said. "But, I couldn't. I couldn't talk to anyone about it."

The 21-year-old Staten Island native is currently in the last semester at The

College of Saint Rose, where she is studying music industry and composition. The school's music program has long been recognized among the best in the country. Her studies there follow time spent at Fiorello H. Laguardia High School, the New York City arts school made famous by the Broadway musical and subsequent movie, "Fame."

Gargano earned her ticket to Hollywood on the strength of her singing and songwriting with the performance of an original song, "Growing Pains." The choice to sing her own work instead of a cover was a decision she made after a long day of battling through nerves.

"I walk into the room and of course I see these three judges; three megastars, three insanely talented songwriters," Gargano said. This year's panel of judges includes Perry, country artist Luke Bryan and multi-Grammy Award-winning R&B artist Lionel Richie. Just walking into the room







# A Brilliant Bit of Color: The Work of Walter Launt Palmer

The Albany Institute of History & Art holds the largest public collection of works by artist Walter Launt Palmer (1854–1932), son of Albany sculptor Erastus Dow Palmer. It includes oil and watercolor paintings, pastels, pencil drawings, a rare painted ceramic cup, as well as letters and photographs. A new exhibition at the Albany Institute offers a visual overview of Palmer's life, travels, and artistic output. # **Ancient Egypt**

Egyptologist and Guest Curator Dr. Peter Lacovara has incorporated the research and scientific discoveries revealed in the GE Presents: The Mystery of the Albany Mummies exhibition into a new exhibition about Ancient Egypt. Visitors to the museum will continue to enjoy the story of the Albany mummies, learn about the history of Ancient Egypt, and see how the intersection of new science, technology, and scholarship changes how we learn. In addition to the story of Mummy Ankhefenmut, theme and topics in the

new galleries include: Egyptian History and Civilization; the Nile and the Environment: Crafts and Professions: Food and Drink; Gods and Goddesses; and Preparing for the Afterlife. The Jabbur Gallery now features the story of Albany's 3,000 year old mummy, Ankhefenmut, a priest and sculptor in the Temple of Mut, along with his recently discovered priest's robe, his coffin base from the museum's collection, and his beautiful coffin lid on loan from the Kunsthistoriches Museum. Vienna. The museum's Ptolemaic Period mummy and his coffin are now on view in the Heinrich Medicus Gallery with a selection of over seventy objects highlighting ancient Egyptian daily life, afterlife and animal mummies. Also included are a timeline and a slide presentation highlighting the trip the Albany Mummies took to Albany Medical Center for x-rays and CT scans, which revealed new information about the age, gender, and occupation of these mummies. Fort Orange was the first permanent Dutch settlement in New Netherland, built as a trading post by the West India Company in 1624 at the location of present-day Albany along the Hudson River. Between 1624 and 1664, the fort's role in the development of New Netherland changed—from a point of contact and trade between Native Americans and Europeans, to an enclosure with dwellings and private enterprises, and finally an abandoned space consumed by the development of Albany. Centuries later, Fort Orange on the surface had long disappeared. But in a six-month period in 1970 and 1971—just ahead of Interstate 787 construction—a small

archaeology team from the State Historic Trust (predecessor to the Office of Parks, Recreation and Historic Preservation, or OPRHP), headed by Paul Huey and composed mostly of volunteers, made remarkable discoveries about life in the Dutch colony at Fort Orange. In 2016, a collection of 36,000 artifacts from Fort Orange was transferred from OPRHP to the New York State Museum. This exhibition examines the momentous discovery of Fort Orange and the lasting impact of events occurring there 400 years ago that shaped the character of the region, New York State, and the nation. The exhibition title is a quote taken from The New World by Johannes De Laet, a director of the Dutch West India Company, recorded in 1625. Select artifacts, film footage from the excavation, and four decades of historical and archaeological research are highlighted—including renderings of the fort by Historical Artist Len Tantillo. Dutch ceramics on loan from the Albany Institute of History & Art help bring life to the story. This exhibition is supported as part of the Dutch Culture USA program by the Consulate General of the Netherlands in New York and in partnership with Historic Albany Foundation. # Enterprising Waters: New York's Erie Canal (Phase Two)

The Erie Canal directed the course of New York and American history. When it opened in 1825, this "boldest and biggest American engineering project of its century" unlocked the Western interior for trade and settlement. Boomtowns sprang up along the canal's path and New York City, with its deep harbor connecting to the Hudson River, grew to be the nation's most powerful center of international trade. One of the largest public works projects in American history, the Erie Canal inspired a nation-wide transportation revolution. Thousands of people poured into New York to work on or along the canal, or just to pass through. Though the canal would eventually be superseded by the railroad, a heady mixture of innovation and determination, and the industrious seeking and creation of wealth, was cemented in the American character. In honor of the Bicentennial of the Erie Canal's construction, New York State's Office of Cultural Education will present this rich story with the first phase of Enterprising Waters: New York's Erie Canal at the New York State Museum. In collaboration with organizations on the canal corridor and across the state, the State Museum will tell the Erie Canal's story with unique objects, documents, and images. Dominating the exhibition space is a gigantic windlass—a pulley mechanism that easily lifted and lowered heavy cargo from both sides of a warehouse with only one or two men. From 1831 through 1866, this windlass operated in the H. G. Root and Company Warehouse in the Village of Mohawk on the Erie Canal. The owners of the warehouse, Humphrey G. and Elias Root, also ran a general store and other small businesses along the canal. Phase Two of Enterprising Waters continues the story of the Erie Canal with components on the Canal's growth, politics, industries, social reform, and the Canal legacy. # Any time is good for coffee cake

Versatile coffee cake can be eaten any time of day

raditional coffee cake is a moist, tender pastry that might be topped with streusel or crumbs and is often served as the perfect accompaniment to coffee or tea at breakfast or in the afternoon. The British version of this cake is a sponge variety that actually is flavored with coffee and coffee butter icing.

Coffee cake is ideal to have on hand when entertaining. It fits well for breakfast, brunch or even as a lateafternoon snack.

This recipe for "Roasted Banana Coffee Cake" from "Simply Scratch" (Avery) by Laurie McNamara includes bananas, making it an ideal addition to the breakfast table. The author suggests roasting the bananas helps to perfect their texture without having to wait for the natural ripening process.

# Roasted Banana Coffee Cake

# **Ingredients: makes 8 servings**

- 8 tablespoons (1 stick) unsalted butter, melted and cooled, plus 1 tablespoon at room temperature for the pan
- 2 tablespoons granulated sugar
- 2 bananas
- 3/4 cup chopped pecans
- 3 tablespoons dark brown sugar
- 1 teaspoon ground cinnamon
- 11/2 cups unbleached all-purpose flour
- 1 teaspoon baking soda
- 1 teaspoon baking powder

- 1/4 teaspoon freshly grated nutmeg
- 1 cup granulated sugar
- 2 large eggs, lightly beaten
- 1/4 cup sour cream
- 1 teaspoon pure vanilla extract

# Instructions

Preheat the oven to 350 F. Butter a 9-inch round cake pan with the 1 tablespoon room temperature butter and dust with the granulated sugar and tip out any excess.

Place the bananas on a small rimmed baking sheet and roast for 15 minutes. Remove and set aside to cool.

In a small bowl, combine the pecans, brown sugar and cinnamon. Set aside.

Sift the flour, baking soda, baking powder, and nutmeg through a fine-mesh strainer into a medium bowl.

In the bowl of a stand mixer fitted with the paddle attachment, beat together the butter and sugar on low speed until light and fluffy, 2 to 3 minutes. Add the eggs one at a time, mixing well after each addition. Scrape down the sides of the bowl with a spatula, then add the roasted bananas, sour cream and vanilla. Beat until incorporated.

With the mixer running on low speed, spoon in the flour mixture and mix until just combined.

Pour the batter into the prepared pan and smooth the top with a spatula. Sprinkle evenly with the pecan topping. Bake for 40 to 45 minutes, or until a toothpick inserted into the center comes out clean with a few crumbs attached.

Let cool for 10 minutes before slicing

example, modern sensors can detect soil conditions, potentially producing hundreds of readings per second. These sensors help farmers know the best possible time to plant seeds so they can reach their full potential. That improves both the efficiency of modern farms as well as their output.

The NIFA also notes that agricultural technology has reduced waste. For instance, thanks to agricultural technology, farmers no longer have to apply water, fertilizers and pesticides uniformly across entire fields. Technology has shown that farmers can simply target specific areas or even treat individual plants differently. That saves time and allows farmers to use only minimal quantities of water, fertilizer and pesticides. In addition, according to the NIFA, employing agricultural technology in this fashion leads to higher crop productivity and reduces runoff of chemicals into rivers and groundwater, thereby reducing the farm's impact on local ecosystems.

# Haley in the Water

Annie in the Water talks history, influences and 'Rumours'

nnie in the Water followed a successful 2019 by embarking on an ambitious one-month tour across the Northeast up with Hayley Jane to perform Fleetwood Mac's "Rumours."

Annie in the Water's second album "Time to Play" was released last summer. It's an album comprised of songs the band has been playing live for years but hasn't received the studio treatment until now. It's an album that gives a snapshot of a band on the rise and a band ready to take on the live music scene with a vengeance.

While everyone in the band calls the North Country home, Annie in the Water has roots all over the map. Their origin story stems from a chance meeting in 2007 between singer-guitarists Michael Lashomb and Bradley Hester at Hobart College. The two hit it off immediately and began collaborating. They would reconvene during summers off from college, jamming together and coaching at lacrosse camps. They recorded their first album "Destination" four years later while Hester was a graduate assistant coach at Jacksonville University.

Since forming, the band has undergone several lineup changes with Hester and Lashomb the only constant over the years. The band is now a sixpiece ensemble with the addition of former Formula 5 keyboardist Matt Richards last July. Brock Kuca (drums/percussion), Ryan Trumbull (drums) and Chris Meier (bass) complete the unit.

NYS Music's Mike Kohli sat down with the band prior to its February run across the Northeast to perform tracks off of



Fleetwood Mac's "Rumors." They discussed their history, their influences and the Spread Rumours Tour with Hayley Jane.

Kohli: First, I'd like to start by finding out more about each of you individually. Where is each of you from? What path brought you to where you are today?

Bradley Hester: I grew up all over the place, born in Colorado. I also lived in Ohio, Japan, Virginia, and I came to Upstate New York by way of Hobart College. Since college, I've been in Upstate doing the Annie in the Water thing but also coaching lacrosse. I will probably always coach lacrosse because it's one of the ways I am bringing my value to life and I have learned so many things from the game that continue to impact the way I live my life.

Michael Lashomb: I was born and raised in Cleveland, OH. My parents were originally from Ogdensburg, New York. We would go visit Upstate and work on my grandfather's land whenever we had time off from school, so I was able to become familiar with the North Country landscape and innercity life throughout my childhood.

While I was in Cleveland, I was exposed to a lot of diverse styles of music. There was always new music coming through mainstream radio when I was a kid, also a lot of hip-hop and funk influence in the city. In the North Country, I was exposed to more roots style and country. So I had a good blend that influenced me. When I was about 11 years old, I heard blink-182's song "Dammit" on the radio and I immediately thought of ways to learn the song. That motivated me and I just started diving into all sorts of musical styles. I specifically started basing my early style of play on John Frusciante's (Red Hot Chili Peppers) fretboard work.

Throughout my late teens and early 20s, I was

always picking up different jobs to try to make it work. I moved down to Florida at one point and was recruited to be a lacrosse coach and teacher at a prep school in Jacksonville. After that, I went out to L.A. for a short time and worked on the TV show The Amazing Race. In my late 20s, I decided to go full-time music. No Plan B for me. I couldn't imagine not pursuing music as my life path.

Brock Kuca: I was born and raised in a little town called Morristown on the St. Lawrence River (Thousand Islands). I started playing music at the age of 10, the saxophone. That didn't really work out so well. I discovered the guitar at age 12. That's when the sparks flew and music became the main priority in my life. Before joining Annie in the Water full-time, I cooked fancy food in a local restaurant. I was also a mail carrier for the U.S. Postal Service and worked production at music festivals. Although I have a deep passion for cooking, it's hard to really imagine my life without some kind of musical influence in it.

I met Mike and Brad some eight or nine years ago. Wow, that's hard to believe. They would invite me out to play gigs in Potsdam, Alexandria Bay, Clayton and Watertown. I've shared the stage with various, very credible and outstanding musicians since then but the present combination of the six of us is a special thing. We are all writers/composers and are just starting to explore that realm with one another.

Chris Meier: I'm originally from Chatham, New York. My path to where I currently am heavily involved my time spent at SUNY Oneonta, where I met my bandmates from my first group, Space Carnival. We were lucky enough to have a great scene that eventually led to where I am now.

Ryan Trumbull: Well, I grew up in the Adirondacks. I was born in Saranac Lake. All of my family members had some sort of musical talent, especially my uncle who had played drums for a long time.

Matt Richards: I was born in Albany and reside just outside of the city in Delmar, NY. My life's musical journey through multiple bands - my high school and SUNY New Paltz band, The Assortment of Crayons, followed by my three-plus years with Formula 5 immediately after college — is what brought me to Annie in the Water. If I weren't making music, I'd likely be studying how birds make music.

Kohli: The group has evolved over the years, adding new members as recently as this past summer. Have the six of you started to gel as a unit yet?

BH: I feel we gelled the first time we played with each other in a rehearsal. The first show we played together felt like the right thing. The music and the feelings that go with it all get tighter as we continue to push ourselves into unknown territory. As long as we allow ourselves the freedom to explore at shows, we can uncover parts of our potential that would never have happened if we limited ourselves.

ML: The band finally became a full unit when Matt Richards joined in July of 2019. The first rehearsal we had, I personally felt that he was the glue of the entire unit and the gelling started then. Chris and Rippy (drummer Ryan Trumbull) had already been in the mix for six months and they were really sinking in with the backbeat and Brock has made considerable strides as a percussion player.

Everyone in the band is open to trying new things. They are constructive and they are professional. I am extremely lucky to have such great people in this band. I believe all of our collective experiences and knowledge have come together well. All of our



individual skills have made the growth quick.

MR: We certainly have. I find our unity became most evident in what is now known as "The Church Set."We were supposed to perform outside in Potsdam on Sept. 7 last year but due to poor weather conditions, we performed inside the local Methodist Church. We were effortlessly one cohesive unit this set, and have remained so since.

RT: I think we are just starting to mold our sound.

CM: Most definitely. We've really taken off as a unit and it feels like the sky's the limit.

Kohli: How does the songwriting process work for you guys? Is there one person doing all the writing or is everyone given free rein to submit material?

BH: Songwriting works in a variety of ways. The album "Time to Play" is a collection of some of the songs Mike and I have been playing and performing for years, but I really enjoy opening up the floor for all ideas while we are creating. I feel like the best ideas can come into something with an open canvas, so even if one of us writes a song, everyone else can add ideas to it and add great elements. Everyone in the group is a creator, so I like to keep open the possibility of anyone bringing a song

to the group and for the group to help develop.

ML: AITW music is a collective of material. Everyone in the band writes, which is terrific. Now that we have had some time to develop, we are more focused on writing as a unit. Sometimes a song can be written collectively but also one person may have a vision for a song, and as a group, it's important for us to all do our best to help facilitate that creation. Songwriting will always be an evolutionary process for this band.

MR: We all have so many songs from our past that we want to work in this group. Perhaps everyone in this band is a terrific songwriter. There is a strong desire to work as one to create music in the future. Additionally, Bradley and I have performed a number

of duo shos and write at least one song each time, live, in front of an audience. That is a process that is new to me but I love very much. Songwriting can be improvisation slowed down and improvisation can be songwriting sped up.

CM: This has been the most open format for writing I've ever been a part of. Everything is on the table.

Kohli: When did you first develop a relationship with Hayley Jane? What was the genesis of the idea to do a Rumours tour together?

BH: I first developed a relationship with Hayley Jane back in 2016 when I posted myself doing a vocal exercise for the first time in eight months. She contacted me and was curious about what

happened to me because she wanted to offer her experience going through vocal issues. We've been friends ever since, sitting in and co-creating whenever possible.

Sometimes it's hard to remember how fragile our vocal cords can be if they do not get proper attention and strength training, but they are also very resilient and can come back from injury stronger than ever, which is how I feel now. I was able to dissolve the cyst that formed on my right vocal cord by taking many months of pure rest and also learning how to properly warm-up. Staying away from alcohol and drugs and remembering to stay healthy and hydrated is key to my intention to make my vocal cords last as long as I can stay alive.

ML: Brad and I first

met Hayley Jane about four years ago in Vermont and that's when a relationship started. The Vermont music scene has a tendency to bring like-minded people together. The project idea started when we were all at Grassroots in Shakori Hills, NC. Our band had been on a pretty solid Fleetwood Mac kick for a while so when we were in North Carolina, Chris was talking with Hayley about playing a Fleetwood Mac song. I'm not exactly sure how the conversation went because I wasn't there, but now there's a tour put together and I'm playing in it.

CM: I've been aware of Hayley for a number of years but we formally met last fall at Shakori Hills Grassroots Music Festival. The idea was developed there over the conversations we had in our RV on tour.




