

# Black lives matter in Bethlehem

Town Board announces it will stand as advocate for the oppressed

#### BETHLEHEM —

Black lives matter is the common thread that has run through recent reform, so it's no surprise to see those words cross the Town Board's table in the form of a resolution.

"I have been thinking about this resolution for a long time, but I didn't want it to be performative," said Town Board Member Maureen Cunningham. "I wanted it backed by definitive action and positive steps forward."

Reform has been the defining term for a town that has hosted several social demonstrations and named its first female police chief this summer. Residents have clamored for change, joining a national discussion sparked by controversial events surrounding arrest tactics and law enforcement's use of deadly force.

"The deaths of Ahmaud Arbery, Philando Castile, Stephon Clark, George Floyd, Eric Garner, Freddie Gray, Botham Jean, Atatiana Jefferson, Tamir Rice, Alton Sterling,

Breonna Taylor and countless others have drawn intent for a communityattention to structural and systemic racism in our country," reads the first line of the resolution.

The resolution, passed by a 4 to 1 vote on Wednesday, Sept. 9, focuses on systemic racism, that everyday practices within society are structured against people of color. The drafted resolution mandate to reform law

also mentions the town's based advisory board through its Bethlehem Police Reform & Reinvention Collaborative.

The town is accepting requests from community stakeholders interested in sitting on such a board. The initiative falls in line with Gov. Andrew Cuomo's enforcement statewide.

"The town is forming an advisory committee to help ensure the Collaborative successfully improves trust, fairness, equity, and justice within our community and our police department and addresses any racial bias, discrimination and disproportionate policing of communities of color," Town Supervisor David VanLuven shared in a statement.

A copy of the resolution was uploaded to the town's website on the Friday before Labor Day weekend. Only a half dozen people attended the online board meeting, some of whom shared they were unaware of the resolution until that day. Town resident Michelle Sanders said she was "very happy" to learn of it.

"The resolution is important because, through my experience with the July 4 rally, it proved that racism is alive and well in Bethlehem," she said. She later warned, "resolutions are great, but actions speak louder than words."

The reception was mixed among the half dozen who spoke during the board's public comment

# Painting police dept by numbers incomplete

own Supervisor David VanLuven has shared how nearly 40 percent of all tickets issued by Bethlehem Police Department last year were to people of color.

That contrasts with the demographics of the town, which is overwhelmingly white. According to the 2000 census, of the 31,304 people who reside in Bethlehem, 94.74 percent are white.

But, according to the police department, that's not the best way to look at the data.

"It's a partial set of data that looks at the number of tickets issued and not the number of violators," said Bethlehem Police Cmd. Adam Hornick. Aside from knowing tickets are not exclusive to town residents, there are several factors not captured in the data.

# Virus fears strike games off the pitch

As surrounding schools prepare to play soccer, field hockey, Bethlehem decides not to play this fall

#### BETHLEHEM —

While the state and Section II did give school districts the OK to play soccer and field hockey this year, they will not be played here.

Instead, the Bethlehem Central School District will allow only "low risk" sports to commence this fall including varsity cross country, golf, tennis and swimming and diving. Soccer and field hockey are considered sports that present a "moderate risk" of spreading COVID-19 among the participants.

There will be no junior varsity or modified

programs playing in Bethlehem this fall.

The district's decision sparked immediate protest among the athletes left off the field this fall.

the Section II, Class AA title two years in a row — dressed in their soccer kits for an online video to protest the district's decision.

"We are very disappointed that our season has been canceled this year," said the four in a joint statement. "We would love the opportunity to play

again, one last time as a Bethlehem Eagle. Section II needs Bethlehem."

The Bethlehem girls soccer team won the Section II, Class AA title two years in a row.

An online petition started over the weekend garnered more than 1,000 signatures within its first 24 hours. It was supported by a line of protestors in front of the Bethlehem Central Middle School just as the weekend farmer's market started taking visitors.

"The Section 2
Executive Committee made the decision to allow low and medium risk sports to operate for the upcoming fall athletic season," Nolan Powers stated within the petition he posted on Change.org. "While all other school districts in the section have decided to participate in medium risk sports, which include

# McCoy signs Clean Air Act into law

LafargeHolcim continues to express disappointment with legislation

ALBANY — County Executive Dan McCoy signed Local Law B this morning, enacting the Clean Air Act designed to stop new waste facilities in Albany County and keep existing establishments from burning new waste.

"I want to thank the Albany County Legislature for its partnership to prevent the burning of hazardous waste like PFAS through the Clean Air Act, including the Republican members who crossed the aisle to make it a reality," McCoy said. "Air pollution has no county or state boundaries."

Local Law B will prohibit waste disposal facilities from burning or processing certain kinds of waste, including but not limited to garbage, hazardous materials, automobiles and electronic waste.

Judtih Enck, a former EPA regional administrator who has been vocal throughout the deliberation of the new law, expressed her gratitude in an online statement.

"Thank you Dan McCoy for signing this clean air bill," Enck stated. "Preventing tire burning and toxic air emissions from burning AFFF will protect the health of hundreds of thousands of people in the region. And thanks to the Albany County Legislature."

The Clean Air Act carries a penalty of a violation and fines up to \$2,000 or imprisonment of no more than ten days for the first offense. A second penalty would be

considered a misdemeanor and carries a fine of \$5,000 or no more than 30 days in jail. The signed legislation goes into effect once filed with the Secretary of the State

Opponents of the proposed law expressed concern over the legislature overextending its responsibilities, usurping state and federal regulations, leading to the threat of future lawsuits from two of the companies it seems to target — LafargeHolcim in Ravena and Norlite in Cohoes.

Similar laws as the one passed by the legislature in Maryland and Pennsylvania have been contested in court leading concerns over future litigation. McCoy squashed those concerns in his written statement before signing the bill.

"I am aware of the

naysayers, their criticism and arguments of illegality, but the truth is that as of today, there is no federal or state law or judicial decision that prohibits the enactment of the Clean Air Act," McCoy stated, "and any reference to any such law or decision is simply misguided and misplaced. When I was elected into office, I took an oath to protect our citizens and the

threat of a lawsuit is not going to deter or detract me from honoring that oath."

Legislator Joanne Cunningham called it "an

# On the road again

Passing a stopped school bus is dangerous — and expensive

**COLONIE** — School's open and that means school buses are on the road.

"It has been awhile, but once again, the familiar yellow school bus will be seen on our streets and roads picking up and dropping off school children, said Harold Nicholson, president of the New York Association for Pupil Transportation during a press conference at the South Colonie School District bus garage on Wednesday, Sept. 9. "We ask motorists to be especially mindful of the fact our school buses will be out in full force and we remind you that you must stop for stopped school buses with red lights flashing."

Passing a stopped school bus that has light flashing can be costly. According to state Vehicle and Traffic Law, penalties for a firsttime offense include a fine from \$250 to \$400, five points on your license and the possibility of 30 days in jail. A second conviction within three years will result in a \$600 to \$750 fine and up to 180 days in jail; while three or more convictions will result in a fine from \$750 to \$1,000, mandatory revocation of your driver's

license and up to 180 days in jail.

All vehicles to come to a full stop when approaching a school bus stopped with red lights flashing regardless of your direction of travel, or even if there is a multi-lane or divided highway.

New York Association of Pupil Transportation said there are some 2.3 million school children who ride school buses to and from school every day.

Sheriff Craig Apple said in New York state some 50,000 cars a day pass stopped school busses.

"We have not seen busses on the road since March and you are about to see the big yellow busses on the road. They are not hard to miss and we are begging you to slow down

when you see a bus on the road," he said. "This year, it's a little different, because most of the people who travel on the busses this year are the little guys, our K-5s, our K-6s. Kids who have a tendency to wander off and not pay attention. We are asking drivers to pay attention and not be distracted, don't look at your phone, don't text, because if something happens and you hit one of those children you will have to live with it for the rest of


# Looking through the windshield: An interview with Sarah Thomas

arah Thomas has earned the opportunity to experience what

few women in the world will ever know-how it feels to walk out of an NFL stadium tunnel on a Sunday afternoon.

As the NFL's first female official, Thomas is a trail-blazing inspiration to women everywhere. She says the feeling

On Thursday, October 8, Thomas will share her journey from college athlete to one of Sports Illustrated's 100 Most Influential NFL Figures of All Time with a virtual audience during the Annual Key4Women Forum. Here, she talks about overcoming adversity, maintaining worklife balance and looking through the windshield toward opportunity.

Susan Zongrone: In your profession, doing your job well often means going unnoticed. That's something many women in business can relate to. Can you talk about your experience with this as a football official?

Sarah Thomas: We do want to go unnoticed, because in my line of profession when you're noticed typically something bad has happened. For women in business, I think it's about wanting to blend in—to be recognized for our merit, our work ethic, the results and execution.

When Gerald Austin [Conference USA coordinator of officials] hired me, he wanted replaceable. Whether it's film me to tuck my hair and wear little or no make-up. I was tak- or mentor sponsors. It's all en back a little bit. But when so important. We don't have it comes to officiating, Gerald had already walked the path. He knew how hard it was even with his gender, so he was protective of me. Much like other women in professions, when people see something in them it can accelerate and elevate I just don't want you to like

So, I think it's truly not finding the 50-50 balance, if you will, but finding what balance is good for you. It may mean one day it's 50-50 and the next day is 90-10. I think the biggest thing is that when I'm at work. I'm at work. Then tomorrow I can spend that much more time on my family or something for me.

Zongrone: How did you gain the trust and respect of your peers?

**Thomas:** Some of the trust and respect is still happening, but I have never set out to prove myself to anyone. My colleagues realize I'm here for the same reason they are, I'm just a woman. I never have gone around with the chip on my shoulder. I'm here to do a job just like everybody else, and I'm going to prove to myself I belong, because this is something I absolutely love.

**Zongrone:** We often talk about the importance of failure...how it can be a catalyst for growth. In your profession, mistakes are replayed. criticized, and can influence the outcome of career-defining games. Can you talk about

I had a coach come up to me during my second year, and this is when it really hit home with me. My first year I wanted to go unnoticed. I just wanted to work and get it under my belt. In the second year, the coach came up to me and he said, "I just want to thank you for what you're doing. I have 2 young daughters, and I've coached in the NFL for quite some time. But because of you they now think they know more about football than I do." When he told me that, it just hit me—this is what I love, and it makes an impact.

> **Zongrone:** What has been the biggest obstacle you've had to overcome?

> **Thomas:** The white pants. I always joke about that, but if you don't feel like you look good and you're constantly tugging, sometimes you don't feel like you're going to perform good. We got rid of the white pants. Now I think the biggest obstacle is the travel. Juggling to get the kids situated when I have to get up at 3:30 a.m. to leave for a 6:00 flight. A lot of people don't deal well with change. In our world, you have to adapt to change pretty quickly.

period. Those opposed expressed concerns with wording that appeared to endorse the Black Lives Matter organization. Those residents balked at the idea while attributing blame on the organization for recent riots and social unrest.

"I understand the principle but I'm concerned about this," said Jay Ryan. "I like the idea but I'm very concerned with what the BLM movement is doing - in the wrong way.'

Jim Foster was the lone vote against the resolution, despite prefacing his decision by saying "it has great significance and it's certainly an important thing that we are undertaking.

The Republican's argument was that residents had little time to review the resolution before the board's vote. The draft shared with residents on that Friday was further revised after Cunningham received comments over the long weekend. The draft passed by the town board was uploaded "less than 7

hours ago," said Foster.

"I think as we heard in the public comment period here tonight, and also the recent appointment of our police chief, critically important issues like this resolution are too important to rush through without allowing people ample time to review and provide input. And, that's why I'd prefer to table it," he said.

The rest of the board felt the latest revisions were not substantial enough to warrant delay. Though members of the board have openly expressed support, capitalizing Black Lives Matter as a proper noun on social media, the last draft omitted "matter" from the resolution's title.

"We could polish this all we want," VanLuven said, "but sooner or later we've got to come to the table and eat dinner.'

The initial resolution was drafted with input from the Albany County Legislative Black Caucus, Cunningham's working group on race, and through members of the board.

"The biggest part that I get from reading this is 'silence is complicity," said Town Board Member Dan Coffey. "We've all been moved by what's going on in our country. Fortunately, Bethlehem has not seen a lot of the social upheaval that other communities have. We are moved by it and it forces us to take action."

State Route 144 stretches nearly 15 miles, running parallel to the Hudson River between the City of Albany and Greene County. The 55 mph speed limit on the majority not all — of it makes it popular with motorists. Known as River Road as it meanders through Bethlehem, it is heavily patrolled by town police. Because of the roadway's propensity for motor vehicle accidents, Hornick said the town receives

compensation to patrol the state route.

To explain the discrepancy in the data, Hornick used an extreme example of one motorist who was issued 15 tickets. If such a person leads the police in a chase, that person could receive several tickets for speeding, failing to comply, driving recklessly and other violations. A single event would drive the number of tickets up.

Relating the numbers

between residents and non-residents cushions the stark contrast depicted in the rate of tickets issued to people of color against the town's demographics. Some scrutiny is rooted in the past. A retired police chief's use of a racial slur more than a decade ago resurfaced upon the town appointing a new head administrator last month. However, Hornick said the department has not received any complaints regarding unfair policing.

"In the last five years, we have not had any documented race-related complaints," he said.



# Russell's Reds 2020 TVLL Champions

Nine takes local little league title after late-season struggle

Russell's Reds took home the 2020 Tri-Village Little League Majors Championship on a beautiful night at Magee Park. The Reds held off Employee Family Protection 3-0 in a very well-played game by two championship caliber teams. The Reds, helmed by coach Tony Healey entered the playoffs as the number 2 seed, while EFP, with coach Mike O'Connell leading the way entered as the 4 seed.

The Reds were led by ace Nolan Devejian. Devejian was dominant as usual, pitching a complete game shut out on an incredibly efficient 74 pitches, 55 of which were strikes. Devejian struck out nine batters, yielding no passes and allowed just three hits.

Starting on the

mound for EFP was Jack Cunningham. Cunningham lasted 2 1/3 innings allowing only one run, walking three and striking out six. Following Cunningham was cocaptain Kieran Barnes who finished up the game going 2 2/3 innings of his own allowing two runs on five hits and a pair of walks, while striking out two.

Both starting pitchers were very sharp early on with no runs scored through the first 2 1/2 innings. Barnes, one of the leagues best hitters all year did single off Devejian in the first but ended up stranded at third.

The Reds finally broke through in the bottom of the third when Nicholas Danaher lead off the inning with a walk. He advanced to second on a passed ball and then Jackson Vatter

moved him to third with a good piece of hitting on a ground ball to the right side. Danaher then took advantage of another passed ball scoring to give the Reds the 1-0 lead. Sam Coscio-Thiel and Brennan St. James walked before Barnes replaced Cunningham. Barnes got Sheamus Healey to ground into a fielder's choice and the inning ended with Coscio-Thiel getting called out at home while trying to score on a passed ball.

After EFP went down 1-2-3 in the top of the fourth the Reds were back at it scoring two in the bottom of the inning. Cameron Moon started the inning off with a hard hit single and advanced to second on a passed ball. Matthew Jones moved Moon to third on a ground out and was followed by





# Nice kitty

"It didn't seem to be bothered that I was outside," she stated. "Thank goodness, because I completely froze." Flood said she later called the town animal control officer to share what she saw.

Adult bobcats are twice the size of a domestic cat, according to the DEC. Long hairs around their cheeks and tufts of fur atop their ears give them an angular look. As they run away, they are distinguished most often by their stubby tails.

"We get calls about bobcats in that area a couple of times a year," said Mandy Bailey, a wildlife biologist for the DEC. "They are definitely around." The DEC maintains a furbearer survey that allows residents to report sightings to the state. Bailey was aware of a sighting in early August, but nothing else. "But I think a lot of people don't necessarily know what to do"

Seeing either can be a jarring experience; whether

you are an ardent, outdoor adventurist or casual, backyard gardener. As predators, they do their best to avoid detection. This time of year, however, the wild cats are on the move, said state DEC officials.

Though bobcats can be common in this area, mountain lions are rare. Both like rocky terrain and feed on the same animals; deer and rabbit. Bobcats have maintained homes in the Adirondacks, Taconics and Catskills. Though they flourish more in the mountains, a bobcat's territory can cover up to 30-square miles. That can cross over backyards secluded enough from the bustle of traffic. In all, bobcats occupy nearly onethird of New York state.

Aggressive hunting and urbanization destroyed native mountain lion populations in the late 1800s. Bailey said there hasn't been a breeding population in New York since the 1800s. That doesn't make them foreigners to the Empire



Bobcats, which grow up to 30 pounds as an adult, are more common to this area than mountain lions.

State. Bailey's office receives approximately 50 sighting reports a year.

"We do get quite a few sightings throughout the year," the biologist said.
"Most of those just turn out to be mistaken identity. ... a lot of them are bobcats.
Some — especially from trail cameras — are actually house cats but it's so hard to tell scale. On the camera, things look bigger."

Residents throughout Bethlehem have claimed to see one over the years, and as recently as a few weeks ago. "A mountain lion was spotted by many workers and truck drivers near the Callanan quarry in South Bethlehem a week or two ago," Donna McMullen stated. "About seven years ago I saw one hit and dead in the road on Rte 32 in Feura Bush. We have trees and mountains with water and wildlife — of course they are living around here!"

The state DEC has yet to confirm mountain lion sightings in the area. The last confirmed case was in Lake George several years ago. The Warren County sighting was confirmed through the analysis of scat and hair samples. Those samples allowed experts to match the cat from Lake George to one subsequently found dead in Connecticut weeks later. Through continued studies, experts determined the mountain lion originated from the Dakotas.

"My husband and I saw a mountain lion in our backyard last year," Jill MacLean stated. The Colonial Acres resident said she had no doubt in what she saw. There was plenty of daylight, and the big cat's "long, powerful twitching tail" left an impression upon the couple. "It was so big when it walked out of the bushes, my first reaction was that someone was playing a joke on me."

Mountain lions can weigh up to 175 pounds. North Dakota Game and Fish describes the big cats as "sleek." They have the body of your house cat, with a short face and rounded ears. Their coloring ranges from tan with white accents on the chin and tip of the tail, to nearly all black. Though there's no documentation of "black" mountain lions, North

Dakota Game and Fish states "many" sightings are of black ones.

In North Dakota, the mountain lion is hunted game, which may help contribute to its habit of traveling hundreds of miles. Bailey, however, said some of the movement we're seeing this time of year is from the young moving out of their respective dens. Both cats are solitary animals, unless a mother is traveling with her young. Kittens are born in the spring, and stay with the mother for the duration of the year. They move out on their own before another brood is born the following season.

Bailey said mountain lions have yet to reestablish themselves in New York. Mountain lion hunting, however, started in North Dakota last week.

"I've heard all the claims that [mountain lions] don't exist here," MacLean stated, "but we saw one, and it was an experience I won't forget."

# Clean Air Act

environmental win for Albany County."

"I am a proud original sponsor of the Clean Air Act and was delighted to see that County Executive McCoy signed this local law, which prevents tire

and waste burning, and the burning of noxious fire foam," she said. "This victory is the result of the hard work of hundreds of neighbors, community members and clean air advocates, who made their voices heard that clean air and environmental health are non-negotiable and should be protected."

The Bethlehem Democrat introduced the act, along with William Reinhardt, Jeffrey Kuhn and Matt Miller of Bethlehem; and Vicky Plotsky of Clarksville, before it was passed by legislators in August. The new law will

impact the LafargeHolcim plant located just south of Bethlehem.

LafargeHolcim expressed its disappointment in a statement issued later that day.

"We are disappointed that the Albany County Local Law B was approved as is," stated a LafargeHolcim

spokesperson. "Lafarge has a global company commitment to reduce our carbon footprint, and using alternative fuels and tire derived fuel in place of fossil fuels to run our kiln is one important way we do this. We're proud of our efforts, and the facts back this up. We will continue our efforts to educate local lawmakers and the

community about the true value of [tire derived fuel]."

LafargeHolcim had received a DEC permit to burn tires at its cement processing plant in Ravena. Before it was to start incinerating shredded tires imported from Connecticut, the Town of Coeymans passed a local law similar to that drafted by Albany County.

# Fears strike games off the pitch

soccer and field hockey, Bethlehem has elected to block these activities. Despite the decision from state, county, and section officials that medium risk sports are safe, Bethlehem has come to their own conclusion that, for largely unspecified reasons, it is unsafe to participate."

The district said it weighed the risks and benefits in order to "minimize the risk of a return to school."

"The decision to focus on low-risk play was made with the health and safety of students, staff and the entire Bethlehem school community as our primary considerations," said Superintendent Jody Monroe in a statement. "We weighed the risks and benefits, reviewed the official guidance, talked to our district physician and determined that this is the most reasonable way to provide opportunities for our student-athletes without jeopardizing the work we are doing to ensure the safe return of teaching and learning to our classrooms."

There is a separate push to move soccer and field hockey to the spring, as has already been done for football.

The New York State Public High School Athletic Association made the unilateral decision to postpone football, competitive cheerleading and volleyball until March 2021.

While the state did allow low and moderate

#### sports to commence this fall, it was not a mandate and it gave the districts the option to play or not to play.

Monroe said the district's decision to only have varsity sports stems from its reopening plan that does not include late buses for any student activities including athletics.

Spectators for cross country, golf and tennis will be limited to two per player. Swim meets will be held virtually at the high school pool with no visiting teams and no spectators. Team sizes and the number of competitors for each event will be limited to meet social distancing requirements set by NYSPHSAA.

"So many people students, staff and parents — have put their faith in us to minimize the risk of a return to school, said Monroe. "A return to low-risk activities is where we are right now. We look forward to being able to make choices for our students down the road without the added weight of our current public health

**ALBANY COUNTY** — Like many other things in the world, the COVID-19 pandemic is already affecting the general election for November.

The Albany County Board of Elections is faced with keeping the voting process as efficient as possible while meeting the several concerns of voters. As Gov. Andrew Cuomo has issued several executive orders for this election, voters are left with more options than before.

Albany County Board of Election commissioners Matthew Clyne and Rachel Bledi are working hard to ensure everyone in Albany County has ample time to cast a vote.

"It's going to be all in for counting these ballots," Bledi said. "It requires us to have a game plan going in and for us to work together to be as efficient as possible."

Clyne agreed, adding the exact plan has yet to be determined, but he and Bledi are expecting an influx of ballots this election. "This is going to be very time consuming, but with the balance of early voting and those who will come out on Nov. 2, it should help alleviate crowding."

Bledi and Clyne implore voters to understand the results will be a bit later than normal this year due to the influx of absentee ballots and the expected number of voters. Still, Bledi said she hopes to have everything counted within a couple of weeks, adding "people should not have to wait a month to learn who won an election." Bledi and Clyne said all ballots, both physical and absentee, need to be in the office by Nov. 10, and from there results should flood in within a timely period.

#### Why Vote?

The Albany County League of Women Voters

(ACLOWV) advocates for increased knowledge and resources around the voting process. Patricia Sibilia, president, said voting is important, specifically in local elections, because the result can be decided based on a handful of votes.

"In national elections, it's a little different, but there are several instances locally where an election has been decided based on under 100 votes," she said. "People like to say voting is irrelevant because their vote doesn't count, but that could not be further from the truth in our local elections."

Sibilia added local elections are also the place where change that actually affects residents happen. "These representatives are the ones that create policy that directly impacts you the most," Sibilia said. "They are the ones who decide when your roads are fixed, what your library looks like, if you have a local park and other local policy that can enhance quality of life. Change starts the election processes have

at the local level, where policy is created specifically for your neighborhood."

### **Options for Nov. 3**

Clyne, Bledi and the ACLOWV are working hard to get voting options out to residents. The BOE sent a flyer to Albany County residents, which started hitting mailboxes on Sept. 10.

There are three options for casting your vote in November. In fact, some of

already started. By Sept. 18, absentee ballots will begin to be sent out. There is still time to register to vote and request an absentee ballot.

The deadline to register to vote for the 2020 November election is Friday, Oct. 9. This is the last day for registration to be postmarked and must be received by the Board of Elections, or BOE, by Wednesday, Oct. 14. To register to vote, go to the Albany County BOE website. To check your registration status, go to

voterlookup.elections. ny.gov.

Once you have registered, you can request an absentee ballot. Tuesday, Oct. 27 is the last day to request an absentee ballot online, through email or a postmarked application. The last day to apply in person at the BOE for an absentee ballot is Monday, Nov. 2, the day before the election. To apply online, visit the Electronic Absentee Ballot Application Portal. To request a ballot through email, send an email to the

local BOE. Voters also have the option of calling the BOE to put in a request or sending a fax. Finally, voters can also go in person to the BOE for their absentee ballot.

Despite the deadlines recommended by New York State, the post office has advised that they cannot guarantee timely delivery of absentee ballot requests applied for less than 15 days before the election. To ensure your application for a ballot is received by the BOE, request one as soon as possible.

If you are unable to receive your ballot through the mail and are unable to pick up your ballot, you can designate someone to pick it up for you. Only the designated person on your application may pick up and deliver your ballot to you.

### **Casting Your Absentee Ballot**

To cast your absentee vote, make sure a series of steps are followed. Upon receiving your ballot, mark it according to your choices for office. After you complete filling out

the ballot, fold it and place it in the security envelope. This is the envelope with a place for your signature. Be sure to sign and date the envelope in the designated spot, then seal it.

Place the security envelope inside of the return envelope that came with your ballot. This envelope should have a logo that reads, "Official Election Mail." Seal the return envelope and decide how you will return your ballot.

There are four ways you can return your ballot. You may put it in the mail, making sure it is postmarked no later than Tuesday, Nov. 3. You can also bring it directly to the BOE or an official polling site by 9 p.m. on election day. To vote early, bring the ballot to an early voting poll site between Saturday, Oct. 24 and Sunday, Nov. 1.

USPS recommends that voters allow plenty of time for marked ballots to be mailed back to the BOE, generally seven days before the election. New York State requires ballots to be both postmarked by Wednesday, Nov. 3 and

#### **Step 1: Primaries and Caucuses**

There are many people who would like to become President. Each of these people have their own ideas about how our government should work. Some of these people can belong to the same political party. That's where primaries and caucuses come in. In these elections, party members get to vote for the candidate that will represent their party in the upcoming general election.



NOVEMBER

#### **Step 2: National Conventions**

At the end of the primaries and caucuses, each party holds a national convention to finalize the selection of one Presidential nominee. During this time, each Presidential candidate chooses a running-mate (or Vice-Presidential candidate).



#### Step 3: The General (or Popular) Election

When each party is represented by one candidate, the general election process begins. Candidates campaign throughout the country in an attempt to win the support of voters. In November, the people vote for one candidate

When a person casts a vote in the general election, they are not voting directly for an individual Presidential candidate. Instead, voters in each state actually cast their vote for a group of people, known as electors. These electors are part of the Electoral College and are supposed to vote for their state's preferred candidate.

#### **Step 4: The Electoral College**

In the Electoral College system, each state gets a certain number of electors, based on each state's total number of representation in Congress.

Each elector gets one electoral vote.



For example, a large state like California gets 55 electoral votes, while Rhode Island gets only four. All together, there are 538 electoral votes.

In December (following the general election), the electors cast their votes.

When the votes are counted on January 6th, the Presidential candidate that gets more than half (270) wins the election

The President-elect and Vice President-elect take the oath of office and are inaugurated two weeks later, on January 20th.



# Step into a world of sound at SPAC

GPS triggers unique audio experience composed by Pulitzer Award-winning artist

#### SARATOGA SPRINGS — Saratoga Performing Arts Center will soon allow patrons to step into an immersive world of sound composed by one of the most innovative sound artists of her generation.

SPAC will begin featuring "Ellen Reid Soundwalk," a GPSenabled work of public art in the Saratoga Spa State Park that uses music to illuminate the natural environment, on Monday, Sept. 21.

Patrons will be welcomed to download, tune in and walk around with a phone app that taps into the Pulitzer Prize-winning artist's music. What they hear will depend on where they are in the park. Movement around the park triggers Ellen Reid's soundscape - musical cells which she carefully crafted to harmonize with the park's landscape and attractions. The experience is guided by the listener: the path the participant chooses dictates the music they hear. ensuring that no two visits will be exactly the same.

"Bringing this project to our park is part of our vision to connect the unique beauty of our natural surroundings... the lush pines, woodland walks, geysers and natural springs...with art and music," said Elizabeth Sobol, President and CEO of Saratoga Performing Arts Center. "We're excited that Saratoga is only the second place, after New York City, to present the installation - and excited to be offering this unique art/ nature experience to visitors to the Saratoga Spa State Park."

SPAC is one of five locations across the country that will feature "Ellen Reid Soundwalk." The exhibit premiered last week at New York City's Central Park. After it's unveiled in Saratoga Springs, it will open in Philadelphia, Pennsylvania; Vienna, Virginia; and Jacksonville, Oregon.

"Working with SPAC on this special presentation of 'Soundwalk' for Saratoga Spa State Park has been incredible," Reid said. "This project is about sharing art and music with the community, but it's also an excuse to spend some quality time taking in our natural surroundings. Spending an hour or two in Saratoga Spa State Park is the perfect foil to our nose-in-computer daily lives."

"Ellen Reid Soundwalk" features a newly-written score, performed by Soundwalk Ensemble, as well as special musical "Easter eggs" hidden around the park for participants to discover.

Reid is one of the most innovative artists of her generation. A composer and sound artist whose breadth of work spans opera, sound design, film scoring, ensemble and choral writing, she was awarded the the 2019 Pulitzer Prize in Music for her opera, "Prism."

Along with composer Missy Mazzoli, Ellen co-founded the Luna Composition Lab. Luna Lab is a mentorship program for young, female-identifying, non-binary, and gender nonconforming composers. Since the fall of 2019, she has served as Creative Advisor and Composer-in-Residence for Los Angeles Chamber Orchestra.

"Ellen Reid Soundwalk" was co-commissioned by Saratoga Performing Arts Center, the New York Philharmonic, Wolf Trap Foundation for the Performing Arts, Mann Center for the Performing Arts in association with The Fairmount Park Conservancy, and Britt Festival Orchestra.

"These are unprecedented times: we're all experiencing the anxieties of living in an uncertain world. We miss our communities, and we miss the very thing that makes our cities special: the people," Reid said. "I hope 'Soundwalk' will inspire us and make us feel connected to something larger than ourselves. It is meant to serve as artistic nourishment -- a place to recharge, reconnect, and re-energize."

The exhibit is free to the public, and can be experienced while following social distancing guidelines. The installation will remain accessible in the park until Sunday, Nov. 1.










received by Tuesday, Nov. 10. Even if your ballot is postmarked by Nov. 3 and gets lost in the mail, if election officials do not receive the ballot by Nov. 10, the ballot will be voided.

Be mindful of posted collection times at USPS collection boxes if you choose to mail your ballot on election day. Ballots that are put into a collection box after the posted collection time will not be postmarked until the next business day.

If you are wary about your vote being counted through the mail, you still have the option to vote in person if you request an absentee ballot. The BOE is required to check the poll book before counting an absentee ballot. If a voter chose to vote in person at a poll site on election day, the absentee ballot is set aside and not counted. This eliminates the possibility of someone's vote being counted twice and lowers the chance of being victim to voter fraud.

Bledi added voters

are able to call the Board of Elections with any questions about their application or the status of their ballot. As the election draws closer and the office gets more overwhelmed, the option will be sparse, but it is early enough to literally follow your ballot back to the BOE, where you can confirm with a representative if your ballot was received and in good standing.

### **Early Voting**

Sibilia explained the differences with early voting this election. Early voting was first passed in New York last year after a law signed by Gov. Andrew Cuomo.

The biggest difference between last year's early voting options and this year's is the location. Previously, voters could only cast an early ballot at their specific early polling station. This election, New York is allowing voters to cast an early ballot at any of the six early polling locations in

the county.

Voters will have a choice of nine designated days for early voting, including weekends.

"Early voting cuts down the amount of people at polling stations on the day of the election," she said. "This is especially advantageous for those in the city, where lines can stretch hundreds of people and waiting times can be astronomical."

Sibilia said early voting is the exact same process as if you were to physically show up on Tuesday, Nov. 3; you enter a polling station and check in with an election worker. You sign in and you receive a ballot. You then fill out your ballot at a designated booth and tender it in the designated spot.

"There is really no difference between early voting and voting on Election Day," Sibilia said. "You just won't have results the day you cast your ballot, but this election will not have those instantaneous results anyway due to the influx of absentees."

Early voting is especially important for Albany's senior population. The

Bethlehem Senior Services Department and Colonie's counterpart is extending options for its clients to vote safely.

Both Colonie and Bethlehem are offering transportation to seniors who are looking to get to early voting, albeit limited. Due to social distancing, vans cannot hold as many people.

"We can only put four people in a van now, where we used to be able to transport 13 people at a time," William Vail, acting director, said. "We will also be prioritizing medical appointments for our clients, so transportation might be affected if there is an issue that needs to be addressed immediately."

Despite the pandemic dealing the senior population a harsh risk, Colonie director Diane LaCivita said her seniors are expressing a bigger interest in voting than ever.

"I've been here for four years and I do not remember this much interest in an election," she said. "We're doing our best to make sure we make options visible to everyone, both through word of mouth here and mailers going to residents."

Vail and LaCivita said seniors have adapted well to the obstacles, adding workers have been modeling behaviors like mask wearing and social distancing.

"They know this is what we need to do to make sure everyone is safe," LaCivita said. "We've taken incredible precautions to make sure everyone is safe, and we are happy to report we haven't had a single case of COVID-19 so far."

# Debunking a Myth

Rumors are swirling that if your signature on your absentee ballot is different than the one on record, your ballot will not count. Sibilia said that is not true.

If you are physically going to the polls this fall, you will be face to face with an election worker. Sibilia said election workers reserve the right to ask for official identification for any reason, including if someone's signature is way off from what is on record. Even with that precaution, Sibilia said it's rare that someone is so off that election workers

cannot recognize it.

If you are casting via absentee ballot, election workers are obligated to call the voter and will give instructions on how to rectify the issue. Sibilia said there's an option called an affidavit ballot that involves the court, but it's an extremely arduous process.

"Election workers are legally obligated to contact voters with any problems in a certain time frame," she said. "If there is a problem with your ballot, you will hear from them before it is voided."

### Resources

Along with the Board of Elections website, the ACLOWV has a website, www.vote411.org, that has resources including information about those on the ballot. Sibilia said it also should have instructions on how to fill out your ballot.

The New York State Attorney General's Office also has a hotline where voters can ask questions or report any illegal behavior. To contact the hotline, call 800-771-7755, or email civil.rights@ag.ny.gov. Sibilia said the hotline is a great resource for voters to learn what is legal at a polling place.

### It's Going to be Ok

As fear grips many residents and COVID-19 threatens a second wave this fall, Albany officials know it's a difficult time for all. However, Bledi said there are plenty of safe options for voting and residents should not be concerned.

"If you are absolutely apprehensive about showing up physically, I can promise you voting via absentee ballot is safe and we encourage you to cast your vote from the comfort of your home or office," she said. "If you're super concerned about mailing your ballot, come down to the office and fill out your ballot in your car. We will take it from you immediately upon turning it in and it will be safe.

Clyne concluded with the number of options and the time allotted, there is no reason for someone to miss out.

"We ironed out a lot of kinks from the primary election and we are ready to get this going," he said.
