COVID cases climbing

ALBANY — As the number of COVID-19 cases continue to spike across the country, the Capital District is seeing numbers not seen since the pandemic first took hold in the spring.

Over the past week, Albany County saw its highest one-day total, 147 cases, breaking a record of 99 set just two days before. The previous one-day record of 94 came on April 30.

More important the aggregate number of positive cases, said Albany County Dan McCoy, is the percent of tests that are coming back positive and those are spiking too.

“There are some who say we are seeing more positive cases because we are testing more,” he said during a daily briefing on Monday, Nov. 16. “While we are testing at a higher rate, our percent of positive tests are a better indicator of the spread of the virus and our percent positive rates are very much too high.”

Albany County is close to hitting the state mandated threshold that will put it in a “yellow zone,” or the first layer of color-coded shutdowns that includes testing at least 20 percent of the school population on a weekly basis, further limiting the number of people in churches and other houses of worship to 50 percent capacity and limiting the number of people at any other gatherings to 25. “Orange” and “red” levels of shutdown are more stringent and will be imposed should the numbers continue to spike.

“We have to make some presumptions, as the numbers go up people have to presume there is a risk everywhere they go and people have to act accordingly. We have people not giving us a full contact history and that is a problem. It is incredibly important and you can save a life with that information.”

First Night Bethlehem canceled

Annual Thanksgiving race still on, with changes

DELMAR — First Night Bethlehem has been called off.

The townwide New Years Eve celebration was canceled just as the number of COVID cases in the Capital District continue to rise. This will be the first time Bethlehem will go silent on Dec. 31 since the event launched five years ago.

Supervisor David VanLuven shared the news as part of his meeting announcements in Tuesday's Town Board meeting. He dovetailed the message with announcing the town's cancellation of its holiday parade and tree lighting ceremony.

"We cannot find a safe way to do it," VanLuven

said, "in a manner that ensures that everyone is safely socially distanced." The governor's mandate to keep social events below 50 people was also a factor in the decision, he said.

In lieu of a holiday parade, the Bethlehem Police Department plans to collaborate with local firehouses to conduct a "reverse parade" at Elm Avenue Park in mid-December.

As the town supervisor described the event, it sounds similar to the Capital Holiday Lights in the Park in Albany's Washington Park. Displays would be erected for display, allowing residents to drive through and observe.

The abrupt change to local holiday traditions comes with little surprise with how the year has gone

since March. However, the rising numbers the county Department of Health is seeing this month has officials concerned. Cases are rising to an amount that mirrors what the country witnessed as experts scrambled to combat COVID's spread.

Earlier that day, Albany County Health Commissioner Elizabeth Whalen pleaded with the public to increase its diligence by practicing mitigation protocols. In one week, the county's year-to-date number of cases jumped by 10 percent. The spike has Whalen concerned because health experts didn't expect to see such a jump until winter.

In Bethlehem, VanLuven announced there were 25 new cases.

"This is a slide back to the numbers we were seeing at the peak in April and May," VanLuven said. "Folks. We can do better

than this, and we must do better than this because COVID kills people."

The annual 5K race traditionally held at the Bethlehem Central Middle School each Thanksgiving morning has also been tweaked. Instead of a designated start time — that would otherwise promote a large crowd — the course is to remain open from 8 a.m. to 6 p.m. Donations to various causes will be accepted through eventbrite.com.

Carriero named GOP Chair

DELMAR — Jim Carriero was named chair of the town's Republican Party committee.

The move made Friday, Nov. 13 shows a continued effort to shakeup a political party struggling to find a foothold in county politics.

The former Bethlehem

Town Board candidate replaces Stephanie Dwyer as party chair, less than one year after she was unanimously voted into the position in January.

It's been a tumultuous year for local GOPs as the party appears to be cleaning house.

The Albany County Republican Party unanimously elected Randy Bashwinger, the superintendent of highways for the Town of Berne, as the party's new leader at its annual organizational meeting in September.

For years, Republicans in Albany County have struggled in two political fundamentals: fielding decent candidates and raising money. There has not been a viable candidate for county executive since Dan McCoy was elected in 2011, the only race for DA this year was during the primary when another Democrat tried to take on

David Soares and in 2019 the Republican candidate for county comptroller got beat by a near 2 to 1 margin.

Two COVID cases at RCS

COEYMANS — The Ravena Coeymans Selkirk Central School District learned late Thursday, Nov. 12 that two high school students tested positive for COVID-19.

These positive cases are associated with the RCS Middle School case that was initially reported on Friday, Nov. 6.

Contact tracing was completed for all of these students. The district said families of any student who has come in close or proximate contact to these students will receive an email and a phone call from the school.

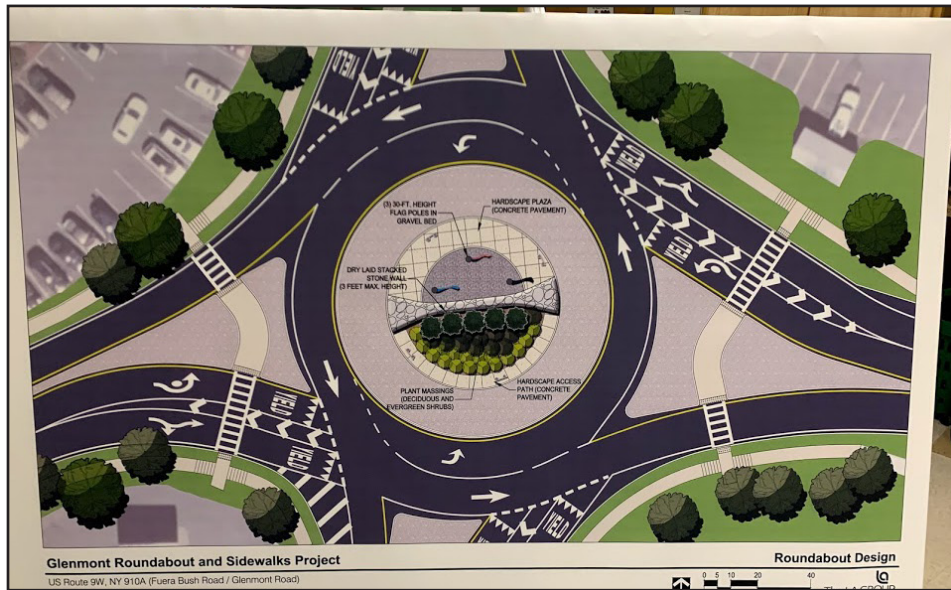

Work on Glenmont circle to start 2021

Town said pandemic factored into delay, was to start work this spring

GLENMONT — Work on the highly anticipated roundabout is expected to begin next spring, a full year after it

was meant to start. The traffic circle meant to mitigate traffic congestion coming from Route 9W, Feura Bush and Glenmont Road was supposed to start last spring. Robert Leslie,

Bethlehem's director of planning, said the pandemic had an impact on delays.

Work related to the roundabout this year included final engineering design, tree removal, property acquisition, and

utility pole and overhead wire relocation. The town will soon hire a contractor to complete remaining overhead utility relocation.

The intersection at Bethlehem Corners has developed into a commercial center over the years. Three strip malls and a large CVS Pharmacy reside at each cardinal point of the intersection. Another strip mall, with a Lowes and Walmart stand within a mile north. It was pegged as a future concern when the town drafted its comprehensive plan more than 15 years ago. Today, it sees more traffic from those visiting the several stores and restaurants, and residents who have moved into one of the many new developments erected since.

According to a recent traffic study prepared by CHA Consulting, Inc. of Albany, approximately 20,000 motorists cross from Route 32 to Bethlehem

Corners each day compared to 15,000 in 2000. The study also reveals an uptick in traffic related to developments off of Glenmont Road where numbers have doubled to more than 5,000 a day within the same time period.

CHA Consulting, which prepared its study for a proposed development off of Feura Bush Road, continued to state that the present intersection underperformed its "practical capacity" from all points. Where traffic flowing from the north operated at approximately 80 percent, capacity was down to 45 percent for Glenmont Road traffic.

Once construction begins, the town said two-way travel will be maintained as crews work from through daylight hours. Work will include the replacement of the existing traffic signal

with a temporary traffic signal, which will free up air space for relocation of overhead wires by Firstlight Fiber, Crown Castle Fiber, Charter Communications and Verizon Communications.

The Town received \$3.9 million from the Federal Highway Administration which was to cover 80 percent of the project's projected cost.

The chosen hybrid design is to feature single-lane exits, double-lane entrances and a center island, the outer shell of which optimally allows bigger vehicles like trucks or emergency vehicles to drive onto if they need more space as they make their way through the roundabout. The center island is also to contain landscaping, at least one flag pole and a stacked stone wall.

Women business owners find opportunity in adversity

It's tough to be optimistic right now for many business owners. This year has brought about changes and pressures from the pandemic that are taking a major toll on women-owned businesses, according to the latest Key4Women Confidence Survey. Compared to previous years, confidence among women business owners in their personal finances is down 22%, along with a 23% drop compared to two years ago among owners who say they are confident in the financial health of their business.

What we're seeing out of this pandemic is how resilient and capable of change so many businesses are, while also recognizing just how much relationships matter in supporting the needs or adjustments of our business clients. Since the point of the pandemic beginning, 70% of women business owners say they have relied on their primary bank to some degree for financial guidance. More than half of respondents say their primary bank proactively reached out to them when the pandemic struck.

The numbers show just how important the foundation of a relationship is for business owners to have with their primary bank. Obviously, the bulk in which we've seen this support has been through the highly publicized Paycheck Protection Program. More than one in three women small business owners in the Key4Women survey applied and received Paycheck Protection Program funding in the first wave. Nearly one in five

relied on resources from state and local government. While government sources of support have been fully utilized, the demand still exists. 54% of respondents say they are likely to apply for additional funding, if it is made available again.

Obstacles aplenty

With support, adjustment to the pandemic has still not been easy. About one in three women business owners say they have low optimism they will achieve their business goals over the next year. Six in ten report the pandemic directly impacted their business negatively.

Among all respondents, the three top challenges posed by the pandemic include adjusting to a new operating model, having trouble attracting customers and having trouble maintaining staff productivity.

Many businesses are putting their plans for growth on hold for now as well. In 2019, 90% of respondents said they planned to expand within the next two years. That number

has now dropped to approximately 75%.

That lack of faith in being able to expand and grow in the future is exactly where banks and financial institutions can help offer their support right now. Between the 2019 Key4Women Confidence Survey and right now, the confidence in the ability to handle finances is down 11%; the confidence in the ability to obtain credit is down 13%; the confidence to conduct negotiations is down 10%.

These times are difficult for business owners. Banks understanding and knowing their clients in the ways that can help restore this confidence is a major key towards our collective recovery.

Optimism abounds

While this all may feel like a lot of doom and gloom, there is hope on the horizon. While we're all glued to the herculean medical effort towards a potential vaccine, it's the outlook of many women business owners, 59%, who believe we could be back to normal business operations within the next year. Only 28% believe their business won't be back to normal for more than a year. The remaining respondents either have returned to normal or weren't affected by the pandemic.

Everyone has learned a lot from this pandemic. From the banks supporting clients

in unprecedented demand, to business owners making necessary adjustments. We have experienced the acceleration of business trends, and in many cases, the abrupt halt of expansion and growth. These changes have shown how a business owners' relationship with their primary bank has never been more important. Key4Women will continue to take steps to help support businesses with insight and advice for women in business to strengthen their networks.

Money and trees

Town pays paving bill, compost facility helps in storm pickup effort

DELMAR — Snow is in the forecast and your leaves still haven't been picked up? Bethlehem Town Supervisor David VanLuven said, "Be patient."

"This is our busiest season for pickup," said VanLuven. He added, the highway department has seven crews running six days a week to pick up leaves through the town's 150 miles of neighborhood roads.

Each year, the town highway department picks up 20,000 cubic yards of loose leaves. According to its website, that amount is equivalent to 200,000 lawn bags. But the wait has had some residents reportedly brushing leaves out into the road in an effort to keep the heat from decomposing leaves killing their lawns.

VanLuven asked residents to not do that.

"Leaves in the road are dangerous to motorists, cyclists and pedestrians," he said, "especially kids walking to school."

In addition to the volume of leaves, the highway department has had to combat against COVID. As a means to mitigate the virus' spread, crews have been reduced from three to two, impacting the usual speed of pickup.

VanLuven also asked residents to keep sticks and other debris from out of leaf piles. The vacuums used by the town are meant exclusively for leaves. Anything else leads to the potential of jamming or damaging the machinery.

"We've had to take

entire crews off of collection for a day or more because a resident mixed sticks in with their leaf piles," VanLuven said.

Storm aftermath

Dan Rain, the town's recycling coordinator, provided insight on the October 7 windstorm's aftermath. The town's beleaguered compost facility, he said, played a positive role in the massive cleanup.

In the two weeks following the derecho that toppled trees and knocked power out for more than 200,000 Capital District residents, town highway crews were picking up debris. Rain said approximately 9,000 cubic yards of trees were removed, "or, if you can picture a football field filled 5 feet deep with yard waste."

Crews took 451 trips to the Feura Bush compost facility, all of which deposited on its new, controversial pavement bed.

"The compost facility expansion has already proved vital by providing temporary room for this material on the new paved pad," Rain said.

The storm had contributed to nearly twice the amount of yard waste collected by town crews compared to last year.

Paying the bill

Minutes before the presentation, the town board agreed to cover the highway department's unexpected bills associated with a pavement project at the compost facility. Highway Superintendent Marc Dorsey requested a transfer from the town's general fund in

September to cover more than \$150,000 of excess expenses.

The bill from New Castle, the contractor hired for the paving project, was originally \$295,722. Dorsey negotiated a reduced bill after the board challenged both the cost and amount of material used by the contractor. Nonetheless, Dorsey was back to ask the board for more money.

With the reduced invoice and the combined cost of equipment and electric installation overages the excess amount jumped to more than \$200,000. As the town comptroller's office alluded in September, there was town material that needed to be reimbursed.

"As previously discussed, the project utilized existing highway stock in order to complete the drainage and site work in a timely manner," Dorsey wrote to the board. The material included manholes, drainage pipe and crushed stone. "In order to reimburse the highway fund for the value of these materials, this request for capital reserve funds also includes \$24,765.48 for this purpose."

Excluded from the contested paving project was the cost of electrical upgrades and new equipment for which the highway department had previously budgeted towards the facility.

"This has been a challenging situation," said Town Supervisor David VanLuven, "but I feel we've come to a productive path to resolving it. I appreciate the commitment I've heard from Marc about ensuring that the financing side won't happen again."

On Friday, November 13, RCS was notified of three more unrelated positive COVID-19 high school student cases. Contact tracing has revealed that, due to RCS High School being fully remote this week, these students had no close or proximate contact with any students or staff members in the contagion window prior to their symptoms or diagnosis.

As of this communication, RCS High School students will remain on completely remote instruction through Tuesday, November 17 with a return to in-person instruction on Wednesday, November 18.

More COVID at BC

DELMAR — The Albany County Department of Health confirmed on Sunday, Nov.

15, that a member of the BCHS community tested positive for COVID-19.

This individual is a student who has been in remote learning since the start of the school year and has not been in the school building. The health department has indicated there are no additional steps required for the district at this time regarding contact tracing.

There have been 13 confirmed cases of COVID-19 districtwide since the start of the school year; 11 have been linked to the high school and two

were confirmed this week at Slingerlands Elementary School.

All schools, including the high school and Slingerlands, remain open for in-person instruction.

Toll Booths coming down along Thruway

ALBANY — The New York State Thruway Authority announced last week the start of its deconstruction of 52 toll plazas on Saturday, Nov. 14.

Lt. Governor Kathy Hochul and Thruway Authority Executive Director Matthew J. Driscoll marked the start of the second phase of the project at the former Williamsville Toll Barrier in Western New York, which is one of six high-trafficked toll plazas statewide that will be the first to be removed. Approximately 20 million vehicles per year, or more than 54,000 per day traveled through the Williamsville Toll Barrier.

“As a native Western New Yorker, I have experienced firsthand the traffic backups the Williamsville and

Lackawanna toll barriers can cause, especially following Bills games,” said Lieutenant Governor Kathy Hochul. “When I started my career in public service on my local town board, I advocated for the toll barriers to be removed due to negative impacts including increased costs, the hassle of having to stop and pay tolls, and discouraging people from outside the area to travel and visit. Those days are quickly coming to an end with cashless tolling, which is already improving traffic flow, allowing motorists to get to their destinations without having to stop to pay a toll, reducing pollution to help combat climate change, and enhancing quality of life for Western New Yorkers and all New Yorkers across the state.”

For the safety and benefit of motorists, the contractor, Cashless Tolling Constructors, LLC is scheduling the removal and reconfiguration of the six high-volume toll plazas. The first locations to be removed include:

- Lackawanna Toll Barrier
- Williamsville Toll Barrier
- Exit 45 (Rochester – Victor – I-490)
- Exit 25 (Schenectady – I-890)
- Exit 24 (Albany – I-87)
- Canaan Toll Barrier (Berkshire Spur)

In the coming weeks, drivers should expect traffic shifts and increased construction activities near all toll plazas. Motorists should use caution while driving in these areas, as they will be active construction zones with 20 mph posted speed limits through the toll booths.

From page 1 ... COVID cases climbing

As of Monday, Nov. 16, there were a total of 4,531 positive cases in Albany County, an increase of 581 since the Monday before. That represents a spike of 916 since Nov. 1.

Among the new positive cases, 20 had close contact with positive cases, one reported traveling out of state and 42 did not have a clear source of infection at this time.

Dr. Elizabeth Whalen, head of the county Health Department, said of particular concern are the cases without a clear source of infection.

"We have to make some presumptions, as the numbers go up people have to presume there is a risk everywhere they go and people have to act accordingly," she said. "We have people not giving us a full contact history and that is a problem. It is incredibly important and you can save a life with that information.

"And there are those who are asymptomatic, individuals who are going around who don't have

symptoms and who are sickening other people. That is an unfortunate and mystifying and very difficult fact of COVID. It is different than a lot of other viruses."

Three people died over the last week — two women in their 70s and a man in his 80s — bringing the death toll to 147 since the pandemic began. It is unclear if the most recent fatalities had underlying health issues.

Hospitals

Hospitals across the region limited the number of people allowed into their facilities to those visiting patients near the end of life, the partner of a woman having a baby, two parents per child and there will be compassionate exceptions for extraordinary cases.

According to Dr. Dennis McKenna, president and CEO of Albany Medical Center Hospital, there were five COVID patients at his hospital three weeks ago but 27 last week. Likewise, there were 15 COVID patients at

hospitals across the Capital Region three weeks ago and last week there were 130.

At the height of the pandemic, when patients were being shipped up from New York City, there were 84 COVID patients at Albany Med.

"As we have seen from the beginning, these are people 60 and above many are 70, 80, and 90 years old," he said on Talk 1300 radio of the cases requiring hospitalization. "These are people with underlying medical conditions — obesity, diabetes, heart disease. We have no children in the hospital and we have not had a child in the hospital for quite some time. It's very rare if we find someone who is young and healthy and needs hospitalization because of COVID."

He reiterated that COVID is a virus that attacks mainly the upper respiratory system and the increased numbers at Albany Med are consistent with those hospitalized for seasonal flu during the fall and winter months.

As of Monday, there were 37 Albany County residents hospitalized including nine in the ICU

for a rate of .81 percent. McCoy said those who do require hospitalizations are not staying in the hospital as long as those in the spring and a fewer percentage are requiring a ventilator or ICU treatment.

Statewide

Last week, Gov. Andrew Cuomo closed gyms, bars and restaurants at 10 p.m. and, as we head into the holiday season, limited the number of guests to 10 at private gatherings.

The last mandate was the subject of ridicule across social media with many questioning how it will be enforced. McCoy was asked about enforcement in general, and kicked the ball further down the line by saying it would fall to the localities and their police departments to enforce the crackdowns.

"We will be handling this new mandate in the same manner we did with the other COVID-19 guidelines," said Tom Breslin, a spokesman for Colonie Supervisor Paula Mahan. "Our road patrols will note and also do spot checks on any establishments that appear to be disregarding the new

guidance. This information and any complaints we receive are followed up by the town attorney's office to the SLA. As with the past orders, we hope that everyone is self-compliant in order to keep our community safe."

Schools

A number of schools are reporting increases in COVID cases but just a few are moving to 100 percent remote as of Monday.

Any student who is symptomatic will need to get tested before returning to the classroom and one way to facilitate that return is through rapid testing. On Monday, the county announced Whitney Young will begin offering the rapid "PCR" test for K through 12 students at two sites to start: Albany High School and the Albany County Cornell Cooperative Extension at 24 Martin Road in Voorheesville.

If a student is symptomatic and the test comes back negative the student will still need to get tested in a lab before he or she can return to the classroom.

The county also released a new feature on its website

— albanycounty.com — to alert people where rapid testing is available and how long a wait is expected.

Medical Reserve Corps

With each positive case requiring an enormous amount of legwork contacting everyone that person has come into contact with along with monitoring hot spots and keeping track of data and those in quarantine and a host of other tasks, Whalen is asking for help.

"We have a Medical Reserve Corps and if you are in the medical field, and can donate some time and want to help the effort please let us know," said the head of the Health Department. "To have your name on a list and know we can reach out to you is helpful. There is a tremendous amount of work that needs to be done."

Any and all health care professional is welcome and other volunteers are needed as interpreters, administrative assistants, data entry and other tasks.

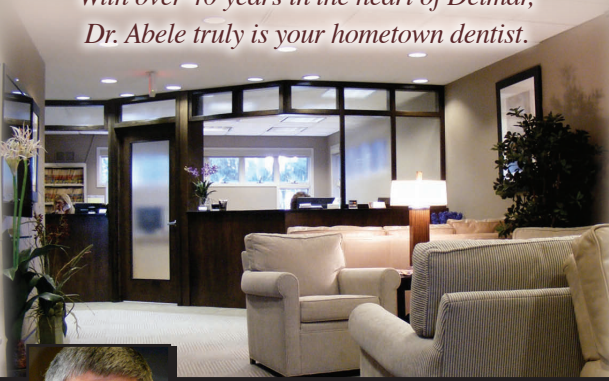

Save space, restore urban housing

I implore our leaders and community to take charge of our future and reject the trend of letting money and power control the game. Do what is right, and that is to put people before monied interests. If we save open space and use the market to restore urban housing infrastructure, everybody wins.

course it wasn't magic, it was literally thousands of hours of incredible work by the public servants of our Highway Department. These Town workers, who themselves had to deal with the aftermath of the storm at their own homes, worked tirelessly to clear roads, remove debris, and generally get our Town back to normal.

Now, as leaves are falling and being dragged out to yard fronts, we're seeing these Highway Department workers again step up in a big way. I've built three separate leaf-piles (each of which have been called 'leaf mountains' by our kids) in the front yard, and again like magic,

they disappear thanks to the round-the-clock work of our Town workers. After months of yard work to pass the quarantine-time, and then a devastating storm, and now the regular deluge of leaves, the Town Highway Department has been there keeping our community looking clean and providing the high-quality service we expect from our local government. I just felt compelled to say 'Thank You' to this crew for everything they've done, and continue to do, to make Bethlehem a great place to live, work, raise a family, and retire.

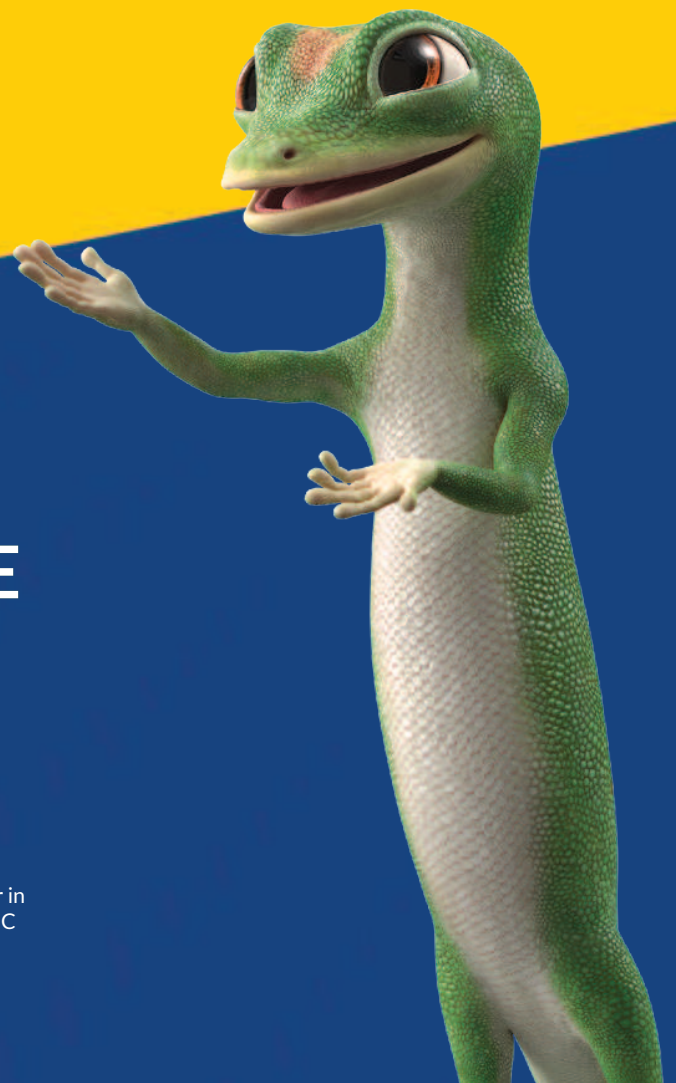

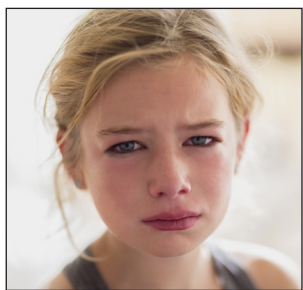

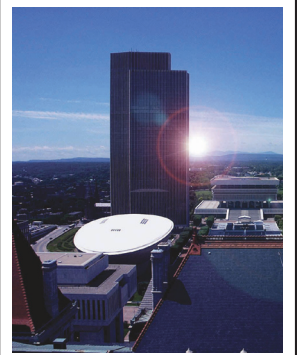

Pandemic a stress for adults and kids

Signs of stress in children

The global pandemic sparked by the spread of the novel coronavirus COVID-19 caught many people off guard. Life changed seemingly overnight, causing a host of unforeseen consequences that people were still confronting months after the pandemic began.

The pandemic has proven stressful for many people, and the Centers for Disease Control and Prevention notes that should not come as a surprise. According to the CDC, fear and anxiety about a new disease and what could happen can be overwhelming. Public health actions, such as the social distancing measures implemented during the



COVID-19 outbreak, can increase anxiety and stress. That's even true among children, millions of whom have been separated from their friends and forbidden

from participating in extracurricular activities for several months.

The U.S. National Library of Medicine notes that children may

not recognize that they are stressed. That makes it imperative that parents learn to recognize the warning signs that stress is affecting children. The USNLM says increased stress can manifest itself both physically and emotionally.

Physical symptoms

The physical symptoms of stress can mimic symptoms of other conditions, so parents should not jump to any conclusions before consulting their children's pediatricians. In addition, the CDC says not all children and teens respond to stress in the same way. However, there are some physical indicators that may be warning signs that a child is stressed.

- Decreased appetite or other changes in eating habits
- Unexplained headaches or body pain

- New or recurrent bedwetting
- Nightmares
- Sleep disturbances
- Upset stomach or vague stomach pain

The CDC also notes that children may confront stress by using alcohol, tobacco or other drugs.

Behavioral symptoms

According to the CDC, children and teens react, in part, on what they see from the adults around them. So the ways in which adults are responding to the pandemic could be affecting their children's behavior. Some of the behavioral symptoms to look for include:

- Excessive worry or sadness
- An inability to relax
- New or recurring fears, such as fear of the dark, fear of being alone and/or fear of strangers
- Clinging behaviors, such as an unwillingness to

let their parents out of sight

- Anger, crying or whining
- Inability to control emotions
- Aggressive or stubborn behavior
- Going back to behaviors present at a younger age
- Avoidance of things enjoyed in the past, including family or school activities
- Irritability or acting out, especially among teens
- Difficulties with attention and concentration

Many people, including children, have had to deal with heightened stress levels during the pandemic. Parents who recognize signs of stress in their children should consult their kids' pediatricians immediately.

BC to host talk to help parents

Presentation helps parents talk to kids about what's stressing them in today's COVID world

DELMAR — Bethlehem Opportunities Unlimited will host another tips and strategies presentation for parents this week, only virtually.

The local not-for-profit organization that promotes prevention education will present a "Talking with Your Teen" focused on helping parents and children cope with the stress and anxiety related to the COVID-19 pandemic.

Registration is due by today, Wednesday, Nov. 18. The presentation will run through a Zoom conference chat the following day on Thursday, Nov. 19, at 7 p.m.

Dr. Jennifer Smitkin, a school psychologist and

founder of Psychology Wellness Practice, PLLC, will speak during the free presentation. Smitkin specializes in providing psychological and psycho-educational evaluations for children and adolescents, as well as adults.

The presentation is to come just a week following National School Psychology Week, a time in which the area's largest teacher's union impressed the increased need for school psychologists this school year.

"Life is nowhere near 'normal' anymore. The pandemic has definitely caused an increase in anxiety and depression," said Kelly Caci, a member of New York State United Teachers' Health Care

Professionals Council. She added how students struggle navigating with the independence required of them during online learning. "The stress during the pandemic is clearly leading to an increase in substance use leading to addiction and overdose," said Caci.

NYSUT said school psychologists' roles have expanded as students struggle with isolation, family addiction issues, an increase in poverty and separation from classroom friends.

"School psychologists fill a number of roles within a school," said Beth Rizzi, president of the 900-member New York Association of School Psychologists. "We provide both mandated and non-mandated counseling services, crisis intervention, teacher consultation, assessment

for eligibility of special education, data collection to assist in decision-making, intervention and instructional support, collaboration with families, and collaboration with colleagues."

To help students cope, Rizzi said she promotes mindfulness practices, meditation, breathing practice and following a routine — depending on the student's needs and stressors.

"Each situation has its own unique challenges," Rizzi said. "I have worked with students over the phone rather than utilizing Google meet. Additionally, I try to ensure that the student has relative privacy to access their services. It is so important to ensure that the student trusts that you have their best interests at heart."

Smitkin earned her

Doctoral degree in School Psychology at the University at Albany, State University of New York in 2007. Prior to that, she received a Master's of Science degree in Educational Psychology and Statistics, and a Certificate of Advanced Study in School Psychology, both from the University at Albany, State University of New York. 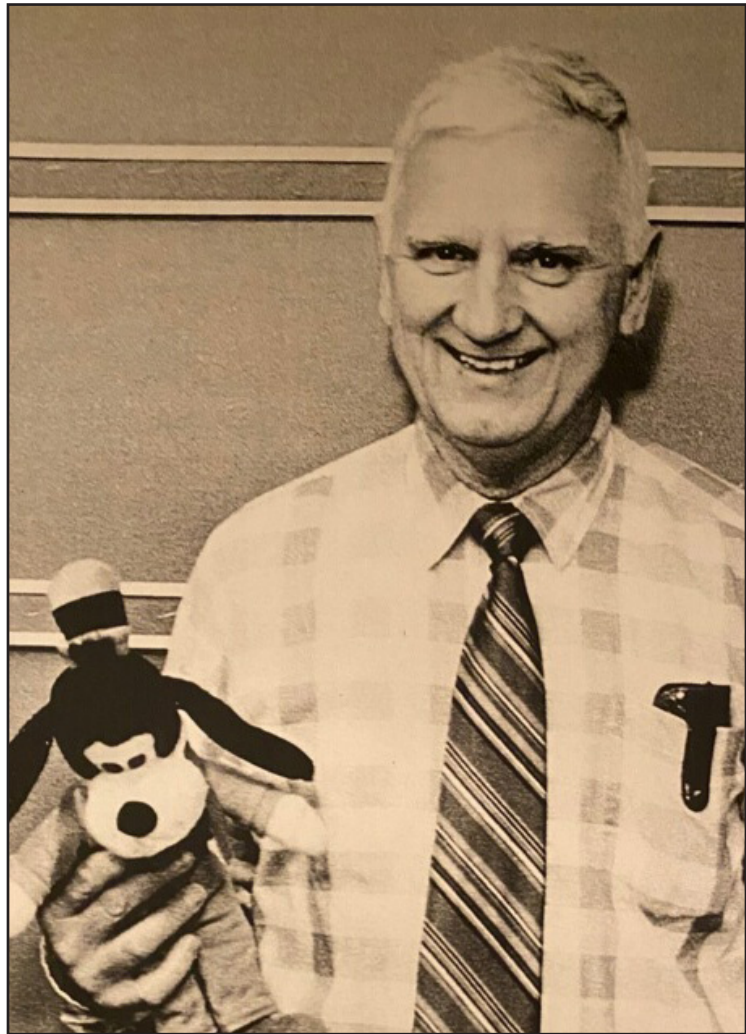

Daughters of beloved school principal starting scholarship

GLENMONT — When Donald Robillard, former principal of Glenmont Elementary School, died in April, the loss resonated through the Bethlehem community. Students and colleagues mourned with the family as the man with a golden heart and contagious enthusiasm was laid to rest at 85.

Seven months later, Jen and Michelle Robillard, two of his children, are starting a scholarship fund in his

honor.

"The idea behind this was to keep his legacy going and honor his memory," Jen said. "Our father always viewed the Bethlehem Central School District community as a second family and advocated for the betterment of the students and the teachers."

Robillard's achievements span decades. After spending years as both a third and fifth-grade teacher, he became principal at Watervliet High School, his alma mater. He landed at Glenmont Elementary

in 1973, starting a 22-year run as the quintessential principal. In that time, Glenmont Elementary earned its first National Blue Ribbon of School Excellence.

There are photos of him dressed in mixed patterns holding a Goofy doll and never-ending stories of the man with the friendliest smile. Hamagrael Elementary School principal Dave Ksanznak lauded Robillard for his uncanny ability to always push his students to "take risks and [learn from] making mistakes" at his service. BCSD superintendent Jody Monroe said Robillard brought a "spirit of innovation" to the school

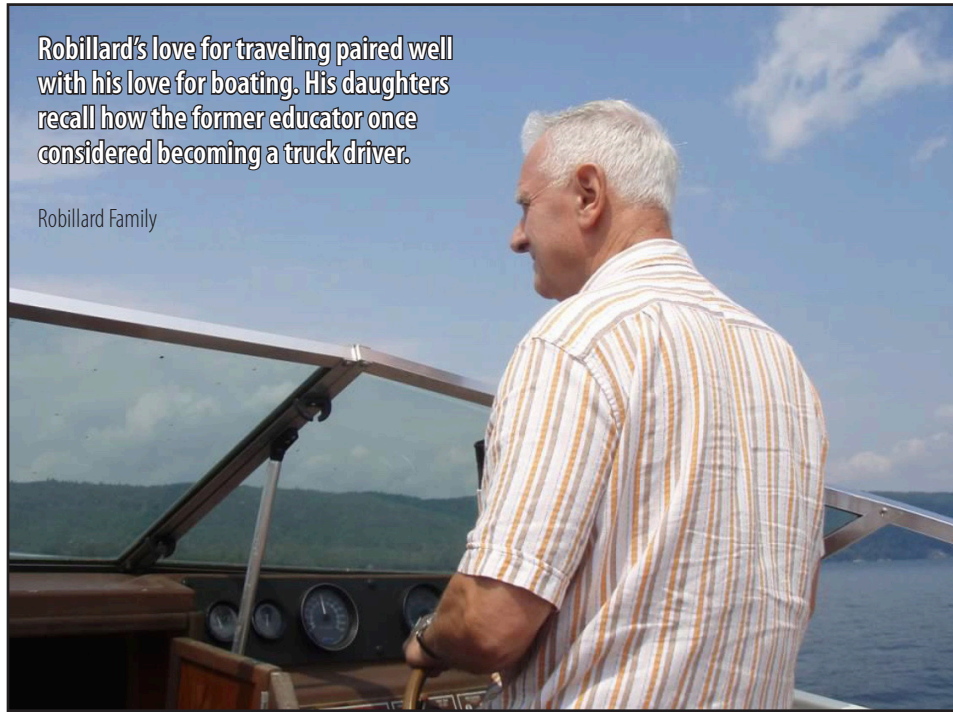

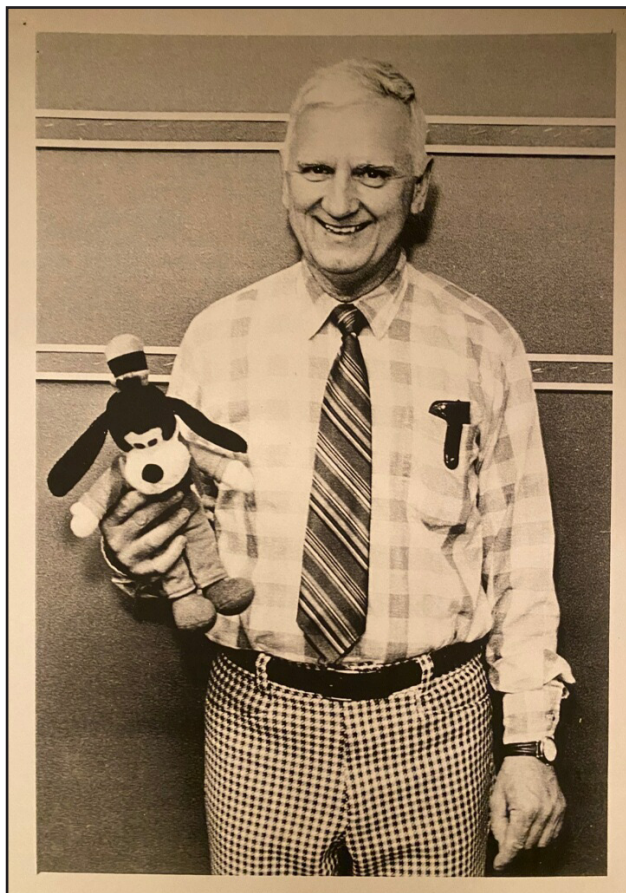

and the district.

The fund, which the Robillards hope will eventually become an endowed scholarship, is a testament to the dedication Robillard had to his profession and the charisma he carried both in school and at home.

"After he retired, Dad was trying to join a fitness competition and was lifting weights all the time," Jen said. Michelle added he got his motorcycle license. His love of boats and travel cloaked his retirement plans. At one point, Michelle said their father wanted to be a truck driver so he could see the world. Both women agreed their father was in better shape than 20 year olds. Despite his many accomplishments in his life, Robillard maintained an air of modesty and humility, treating everyone with respect and acceptance.

"The focus of the scholarship right now is a bit broader, so it could go to an individual, a family or the school itself," Jen said. Because the fund is currently controlled by the Community Foundation for the Greater Capital Region, the Robillards are not fully in control but have been assured the first grant will be awarded to someone who would fit the bill as a good candidate



for the scholarship. Michelle voiced hope the recipients to come would have attended Glenmont Elementary School, where her father's spirit still roams the hallways with gentle support.

"Our father was just so good at supporting teacher's endeavors and having the same end goal of being there for the kids," Michelle said. "It was amazing to hear how much

of a difference people were saying he made."

Jen added the family finds comfort in the stories of their father's life. As the ultimate students of the Robillard legacy, Michelle noted how Robillard always asked how school was.

"He knew how many doors he could open from that one question," she said. "His focus was always how he could make people's lives better."

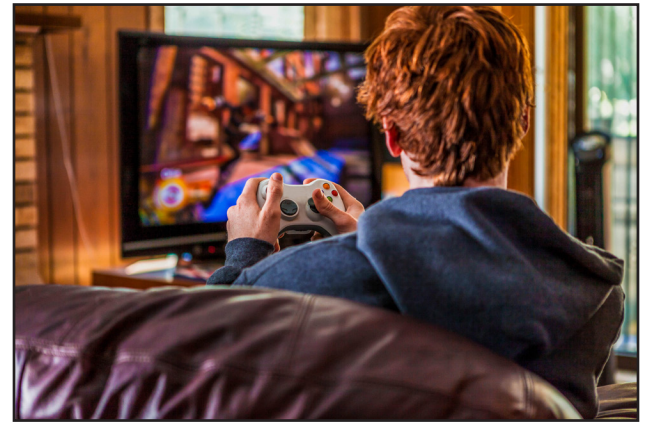

What a pain in the back

Shovel snow safely this winter

The beauty of freshly fallen snow is undeniable. Such beauty compels millions of people across the globe to ski and snowboard each winter, while millions more enjoy simply looking out their windows at snow-covered landscapes.

If it was as convenient as it is beautiful, snow would likely be welcomed with open arms whenever the local weatherperson includes it in his or her forecast. But heavy snowfall can be inconvenient, making it difficult to travel and even creating more work for individuals responsible for shoveling their driveways and walkways.

Shoveling snow can increase a person's risk for injury, and some may

be surprised to learn just how frequently such injuries happen. The U.S. Consumer Product Safety Commission notes that, in 2018, more than 137,000 people needed medical assistance for injuries that happened while shoveling snow or using snowblowers.

Sprains and strains in the back and shoulders are the most common injuries when shoveling snow. But people also can suffer lacerations and injuries related to below-freezing temperatures when shoveling snow. The American Academy of Orthopaedic Surgeons recommends people keep these safety precautions in mind when shoveling snow this winter.

- Stretch before shoveling. Just like you would do before exercising in a gym, stretch prior to picking up your snow shovel. Warm up your muscles with some light exercise for 10 minutes to

reduce your risk of sprains, strains and muscle tears.

- Stay hydrated and take frequent breaks. The AAOS notes that snow shoveling and snow blowing are aerobic activities. Such activities require participants to be hydrated. In addition, taking frequent breaks can help prevent injuries.

- Avoid shoveling snow if you're at risk for heart attack. Some people should avoid shoveling snow entirely. According to the Harvard Medical School, researchers correlated hospital admissions and deaths due to heart attack the day after it snowed in Canada between 1981 and 2014. Researchers found that the deeper the snow, the more men died of heart attacks. In fact, researchers found that there was a 34 percent increase in heart attack deaths the day after an eight-inch snowfall, and those rates increased when snowfall increased.

Most deaths were men, but both men and women who are at risk of heart attack should avoid shoveling snow, particularly after heavy snowfall. Adults who are unsure of their heart health should consult with their physicians prior to shoveling snow.

- Use the right equipment. Ergonomic snow shovels can make shoveling less taxing, reducing your risk for sprains and strains. Spacing hands on the tool grip can increase leverage, making shoveling easier and less likely to lead to injury.

- Pushing snow instead of lifting it. The AAOS recommends pushing rather than lifting snow when possible. If snow must be lifted, squat with your legs, knees bent and back straight. When lifting, lift with your legs and do not bend at the waist. Scoop small amounts of snow at a time and walk to where you want to dump.



The AAOS warns against holding shovels full of snow with arms outstretched, as doing so puts too much weight on the spine. Snow should not be thrown over the shoulder, as such a technique requires a twisting motion that puts stress on the back. In

addition, the AAOS notes that heavy wet snow should be removed in pieces and not all at once.

Anyone can get injured while shoveling snow. Such injuries are preventable when certain safety measures are taken.

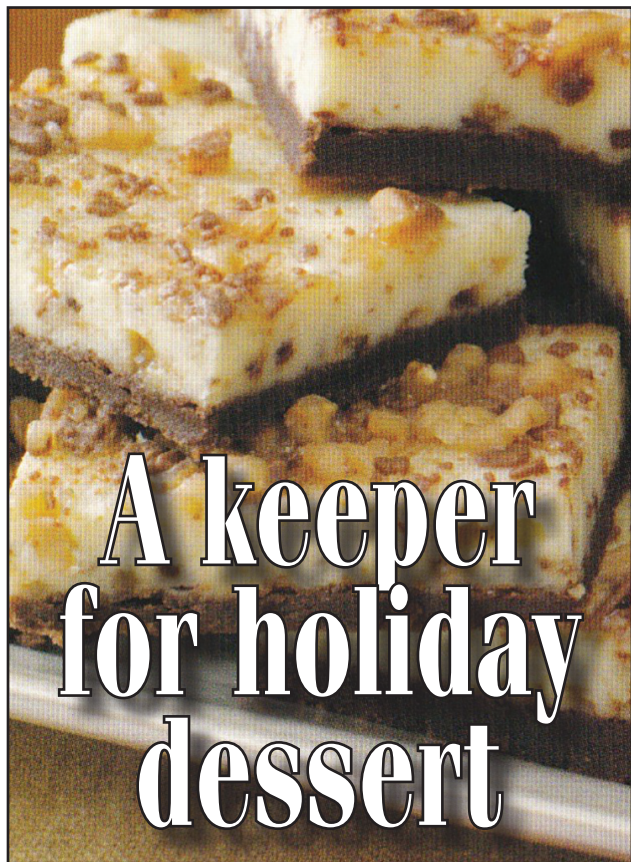

- 2 eggs, lightly beaten
- 1 teaspoon vanilla extract
- 1 1/4 cups milk chocolate English toffee bits, divided

INSTRUCTIONS:

1. In a small bowl, combine the flour, confectioners' sugar, cocoa and baking soda. Cut in butter until mixture resembles coarse crumbs. Press in the bottom of an ungreased 13-inch x 9-inch baking dish. Bake at 350 F for 12 to 15 minutes or until set.

2. In a large bowl, beat cream cheese until fluffy. Add the milk, eggs and vanilla; beat until smooth. Stir in 3/4 cup toffee bits. Pour over crust. Bake 18 to 22 minutes longer or until center is almost set.

3. Cool on a wire rack for 15 minutes. Sprinkle with remaining toffee bits; cool completely. Cover and refrigerate for 8 hours overnight.

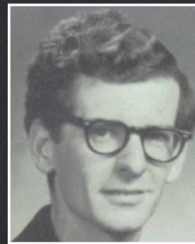

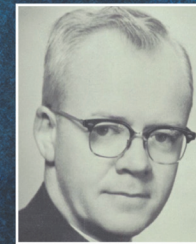

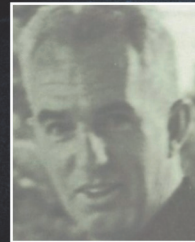
