Coeymans' Clean Air Law is in jeopardy

**COEYMANS** — Air knows no boundaries, but litigation does.

Under the threat of a lawsuit, the Coeymans Town Board is all but ready to amend last year's Clean Air Law. The proposed amendments will rip the teeth out from the law, circumvent legislation passed by the County Legislature earlier this year, and essentially allow LafargeHolcim to seek out tires to burn for fuel - exactly what the town sought to prevent just a year ago.

The board did not vote on the proposal following its public hearing on Thursday, Nov. 19.

# Police arrest man tied to FoCo crash



Rensselaer man faces litany of charges after allegedly fleeing from accident scene on foot

**DELMAR** — Bethlehem police arrested the man it alleged left a trail of damage at Four Corners two weeks ago.

Mark A. Boucher, 29, or Rensselaer, was arrested Wednesday, Nov. 17 on a litany of charges stemming from a motor vehicle accident that smashed storefronts, safety barriers and lamp posts along Kenwood Avenue on Saturday evening, Nov. 7.

The accident occurred at approximately 6:14 p.m. that Saturday evening. That's when Bethlehem police received several

Four Corners, a day after the Nov. 17 accident.

911 calls reporting a red Jeep Cherokee had struck another vehicle at the intersection of Delaware and Kenwood avenues.

Bethlehem police said Boucher took a right turn on Kenwood Avenue from Delaware Avenue when he veered off and went off the roadway. The car proceeded to knock down light posts, uproot several chained barriers and sideswiped two storefronts. Boucher allegedly struck another vehicle, a white pickup truck, before leaving the scene. A photo shared His jeep was later found further down the street behind Peter Harris Clothes with the chained barriers still wrapped around it.

The original press release stated Boucher had allegedly fled on foot,

#### disappearing near the First United Methodist Church of Delmar. Though Bethlehem police arrived with Albany County Sheriff's K9 unit, the suspect could not be found.

The accident's timing had several residents concerned it related to the Associated Press announcing Democrat Joe Biden winner of a contentious race against President Donald Trump.

"The Bethlehem Police Department is aware of some social media posts that indicated the Jeep had political markings on it at the time of the incident," stated Bethlehem police. "This information has been proven to be false based on witness statements and scene evaluation."

Police charged Boucher with several driving violations, including four misdemeanors for reckless endangerment, criminal

#### mischief, reckless driving and leaving the scene of a property damage accident. He was arraigned in Bethlehem town court and later released to appear again on Tuesday, Dec. 15.

### **Woman found**

**DELMAR** — Within a day of being reported missing, a young Delmar woman was found safe in upstate New York on Friday, Nov. 20.

Aliza M. Deierlein, a developmentally delayed 22-year-old, was last seen in the area of the Four Corners intersection of Delaware and Kenwood avenues before she was reported missing on Thursday, Nov. 19.

The following day, Bethlehem police reported that Deierlein was found safe near the U.S.-Canadian border in Malone, New York, more than 200 miles aware from home.

# Neighbors not keen on expansion plan

Exhaust fan focus of opposition to Real McCoy's plans for new commercial kitchen

**DELMAR** — Real McCoy's plans to expand with a commercial kitchen grew more contentious than the dozens of letters supporting the venture suggested in its file on Wednesday, Nov. 18.

Owners of the popular nano-craft brewery in Delmar's Warehouse District fielded questions during a public hearing in front of the Bethlehem Zoning Board of Appeals. The letters of support they filed along with their proposal, including those from state Assemblywoman Pat Fahy and Senator Neil Breslin, urged the board to allow for a disconnected kitchen at the end of the Hallwood Road property. Opposition, however, came from property owners and residents next door.

The zoning board has asked for more information regarding the kitchen's exhaust fan before proceeding with its decision.

Owner Michael Bellini

wants to modify two, 40foot shipping containers into a small, commercial kitchen. The renderings of the plan shows a continuation of the modern industrial look present in the town's warehouse district of Hallwood Road.

Each of the "high-cube" containers stand 9-feet and 6-inches tall, measure 8-feet wide and 40-feet long. The metal containers, often seen on cargo ships and freight trains, would be cut and modified with large, glass doors accented by black lattice. The interior would appear to include dark wood flooring with a large, granite counter top for patrons facing an open kitchen complete with stainless steel appliances. In addition to indoor seating space, the plan includes a patio-like dining area with umbrellas, just outside of it.

At issue would be the placement of the kitchen, which is proposed to sit at the back end of the 20 Hallwood Road property, nosing a property line defined by pine trees, a stockade fence and a

10-foot retaining wall. The kitchen will stand as close as nearly 9 feet from the property line and just over 12 feet from its back neighbor's closest structure.

Diana Skuza, whose family lives in the Delaware Avenue home behind Real McCoy, said she fears the kitchen's exhaust fan will not only be noisy, but it will blow grease and protein particles in their backyard. When Bellini's representative shared that the fan would be the same one used as a neighboring restaurant, she said you can see a "dirt spot" all around it. "So, thank you for that." The Winn family, who own and once occupied the rental property behind the brewery, also spoke against the prospect of added noise and debris. George Winn, who manages the property, said his tenant is no longer able to open their back windows on account of the noise presently there.

## Town holds public hearing on moratorium DELMAR — The


Bethlehem Town Board hosted a public hearing on its pending 12-month moratorium on Tuesday, Nov. 23. Board members could vote it into law as early as next month.

The town is preparing a 12-month moratorium that will affect applications for residential development. The move, which is subject to the town first passing a local law, has the potential to impact two dozen proposals already on the table, involving more than 800 housing units.

Like in 2004, the town is preparing an overall plan to direct future development and growth. The town is preparing to update its comprehensive plan, a task not expected to be completed for nearly a year. A moratorium is expected to allow the town more time so that development proposals don't overrun their efforts.

Once in place, none of the town boards will be allowed to review, hold a hearing, or render a decision on residential subdivision applications containing more than four units. This includes existing subdivisions proposing to expand. Also excluded are applications to establish a planned development district, and site plans containing units within residential care, nursing homes or senior citizen housing.

The intended threshold is to allow plans to proceed if they've already reached final approval. Other proposed plans still waiting for such approval would be held back through the duration of the moratorium. Whereas some proposals are cleared after a state environmental impact review, others such as a new subdivision still go through an additional plot review. Subdivisions still waiting upon a final plot approval won't be able to proceed.

# Step on a crack, break your ma's back

Committee suggests town sets aside more funds to fix 'deficient' sidewalks



**DELMAR** — Be careful the next time someone in town tells you to take a hike.

According to a recent Bethlehem Highway Department survey, about 25 percent of the town's 43 miles of sidewalks are deficient. The Bicycle and Pedestrian Committee has asked for the town board to pay more attention.

The committee is suggesting the town budgets \$100,000 a year towards sidewalk repairs, plus another \$2.85 million to install new sidewalks.

The committee cites a visual survey from 2014.



Since then, the committee had provided a long-term solution to maintain the town's walkways, including a "Top Ten" list of sidewalks in need of repair. But, the committee said, even had there been earnest plans to follow through with past suggestions, it'd be "impossible" with the turnaround at the highway superintendent position.

"The Highway Superintendent has independent powers to decide if money will be allocated to maintaining sidewalks and which sidewalks to improve. Complicating the problem is that we have had four different Highway Superintendents in the past four years which make developing a long-term solution impossible," the

Sidewalks on Delaware Avenue were repaired three years ago. committee stated. "So we turn to the Town Board for help in developing and implementing a long-range sidewalk maintenance program."

The town's proposed 2021 budget does not account for sidewalk maintenance. Virus-related shutdowns put a clamp on sales tax revenue, leading the town to freeze salaries and pull \$1 million from its reserve fund. The town's capital plan suggests setting aside \$50,000 a year starting in 2022 to restore sidewalks. Based on the committee's breakdown, that's not enough.

An annual budget of \$50,000 will afford repairs to two-tenths of a mile of sidewalk. The committee sees the need for 10.7 miles each year. Factoring inflation, the report estimates it will take 11 years to adequately repair sidewalks with an annual budget of \$100,000, seven years at \$150,000 per annum. But, \$50,000 "we will never fix all sidewalks," the committee stated.

That would require the highway department to devote 15 percent of its combined funds from the capital budget and state grants, or \$106,500 next year. Or, the committee suggests the town seek alternative means including Parkland Set Aside funds, private and public partnerships, and contributions from developers.

"Specifically our concern relates to the lack of an established and consistent sidewalk maintenance program which would bring the existing sidewalk system into a state of good repair," committee members stated in its report. "The town has taken the initiative to bring the water, sewer, highway and other infrastructure into a state of good repair, but not sidewalks."

# **COVID's climb reflected in schools**

**GUILDERLAND** — The high school reported five COVID-19 cases within a week, forcing the district to send students home for virtual study.

Superintendent Marie Wiles announced the move in an email last Wednesday, informing district parents high school learning would be entirely remote.

"Because of the stafgfing shortage at the high school level, we are transitioning to all-remote learning for grades 9-12," stated Wiles.

The week's jump in cases doubled the district's overall number to 10.

Like many of the area high schools, Guilderland High had conducted classes in a hybrid schedule, allowing students to either learn remotely or attend classes in-person.

The shift to remote learning was ordered on

Thursday, Nov. 19 and scheduled to last until Tuesday, Nov. 24.

### **BC quarantines 55**

DELMAR — The Bethlehem Central School District was informed on Friday, Nov. 20, of two confirmed cases of COVID-19 at Bethlehem Central High School. In each case, the individual who tested positive is in isolation and will not return to school until cleared by the Albany County Department of Health.

The Albany County Department of Health has determined through its case investigations that there was possible exposure at the high school in one of the two cases. As a precaution, the health department will quarantine several classes at the high school, including students and teachers. A total of 55 people, including students and staff, will be quarantined. The school

district is cooperating fully with contact tracing efforts by the health department. Families of the students who are subject to quarantine are being contacted by both the school and the Department of Health. The potential exposure took place on Monday, Nov. 16, the last day this individual was in school.

In the second case, the individual who tested positive had not been at the high school since Nov. 10 and the Albany County Department of Health determined there was no exposure at the school. In that case, there are no additional steps required for the district or the school regarding contact tracing.

Please keep in mind that the Health Insurance Portability and Accountability Act (HIPAA) and other privacy laws do not allow the district to disclose or confirm any personally identifiable information; therefore, we cannot identify anyone who has tested positive.

There have been 17 cases of COVID-19 confirmed by the Albany County Department of Health since the start of the school year. Fourteen of the 17 cases have been reported in the high school community.

All schools, including the high school, will remain open for inperson instruction. As a reminder, all school buildings are thoroughly cleaned and disinfected every night school is in session in accordance with guidance from the CDC and the New York State Department of Health.

It is important that families continue to complete the district's COVID screening tool every morning before school. Any indicator that results in a red "thumbsdown" on the screening should be reported to your child's school nurse as soon as possible.

## V'ville reports COVID case

NEW SCOTLAND — The Voorheesville Central School District learned Wednesday, Nov. 18, that a member of its middle school community tested positive for COVID-19.

However, based on the timing of when the individual was last on campus, the Albany County Department of Health has indicated no need for further action, on behalf of the school, to have school community members quarantined.

The Health Insurance Portability and Accountability Act (HIPAA) and other privacy laws restrict the district from disclosing or confirming any personally identifiable information, and we cannot identify anyone who has tested positive.

The district continues to follow all prevention protocols in accordance with guidelines from the New York State Department of Health and CDC — this includes a thorough cleaning and disinfecting of all school buildings. At this time, all schools remain open for in-person instruction.

DELMAR — Four Corners Pharmacy closed on Wednesday, Nov. 18, after 15 years in business. The privately owned pharmacy harkened back to bygone days before multimillion businesses cluttered towns and shopping malls.

"Paul [Pagnotta] and John [Croce] would like to give their sincere thanks to the Town of Bethlehem and the surrounding area for the support they have shown us over the past 15 years," the two owners wrote in an advertisement that appeared in last week's edition of The Spotlight. "It has been our honor to serve the community and it has been heartwarming to watch your families grow up with our business and families.

Croce and Pagnotta opened their doors for

business in March 2005. It first started with four experienced pharmacists that were looking to provide the community with their health needs. They settled into the former Bank of America branch office so they could use what was once the drivethru teller's window.

The self-described "vintage pharmacists" are not yet set to retire from the business. Instead, they each said "it is time to

Croce and Pagnotta will be continuing their careers in pharmacy. Croce will be working with a grassroots pharmacy organization called Community Pharmacy Enhanced Pharmacy Network. Pagnotta will manage the student operated pharmacy at Albany College of Pharmacy and Health Sciences.

Customers of Four Corners Pharmacy will be transferred down the street to the CVS Pharmacy at 260 Delaware Ave. in Delmar.

The proposed amendments still prevent hazardous and medical waste from being processed within town limits. It also states that no amount of waste can be considered a fuel source "unless approved and permitted" by the state DEC or federal EPA.

LafargeHolcim had previously warned it would sue the town for preventing it from using tire derived fuel to power its \$500 million kiln. The merit of that threat became more evident when the company successfully fought to overturn a similar law in Baltimore, Maryland earlier this year.

The Switzerland-based company had received a DEC permit to burn tires at its cement processing plant in Ravena. Before it was to start incinerating shredded tires imported from Connecticut, the Town of Coeymans passed legislation against it. The company has argued that tire-derived fuel is "environmentally progressive" and is

permitted through state and federal regulations.

Town Supervisor George D. McHugh said Coeymans has neither the money nor the means to enforce its Clean Air Law and would rather leave the matter up to the scientists and professionals on the state and federal level.

"I have to protect Coeymans residents from a frivolous lawsuit and I'm not going to spend hundreds of thousands of dollars to defend a lawsuit that I can't win," McHugh said at a town board meeting on Thursday, Nov. 19. "I'm not going to defend a law ... that I can't even enforce, anyway."

Opponents who spoke against the amendment said the issue was more political.

The laws in Baltimore, Coeymans, and later Albany County, were all drafted by the same Philadelphia lawyer, Mike Ewall, founder and executive director of Energy Justice Network. In August, he told county legislators

there should be no concerns immediately before they proceeded to pass its law. Albany County pursued

its own legislation following a shift of political power in Coeymans led by McHugh and his Coeymans Comeback Team. Then-Supervisor Philip Crandall, a Democrat, feared such a switch would lead to a repeal of the town law.

The town board swung Republican after McHugh and his two running mates, Zachary Collins and Brandon LeFevre, earned seats in last November's

election. The shift to Republican leadership was reflected on the county level, too, when former Coeymans Town Board member George Langdon beat Democrat incumbent Richard Touchette.

Up until last year, McHugh served Carver Companies as its general counsel. Carver operates the Port of Coeymans which earned a state contract to clean up old tire dumps. And, opponents are tying that with LafargeHolcim's







## **Restaurants start fund for themselves**

With temperatures dropping and COVID cases rising, the silver-lining is starting to fade away from local restaurants hanging on to survive

ALBANY — Guthrie Bell Productions' innovative series of shows pairing supper with live music performances at The Hollow Bar + Kitchen has been canceled.

The string of shows that launched in early October featured seating arrangements for live music fans sequestered to their tables behind a meal, entertained by live music.

"Due to the recent spike in cases in the area, we have decided to cancel all upcoming Supper Club events at The Hollow Bar + Kitchen," Guthrie Bell Productions announced in a statement shared on Facebook. "We love the music fans that come to our shows and the artists that make them possible, and want to see you all be safe and healthy so when the time comes we can all get back to doing what we enjoy most."

The first of such shows included a performance from locally acclaimed artist Girl Blue. The show sold out within days of the announcement, and was followed by four more events. Olivia Quillio was next to perform. According to the statement, those who bought tickets will be refunded.

"In March, one day after *the COVID-19 pandemic* forced a shut down here in New York, we formed Feed Albany - COVID-19 Relief to provide food and resources for at-risk and in-need individuals throughout the region. *Now, as a second wave* of COVID rips through the Capital District, we've created the Capital Region Restaurant Fund to provide supplemental financial assistance to restaurant employees and owners hardest hit by the pandemic."

The move comes as local restaurants pivot themselves in what many businesses already anticipate to be a tough winter. Restaurateurs lobbied before legislators to relax virus-related mandates limiting indoor seating months before Election Day. With temperatures dropping and COVID-19 cases rising, eateries see a repeat of last spring where businesses shutdown.

Guthrie Bell closed its statement by pleading with fans to support local restaurants.

"Please support them if you can during these upcoming months, you can stop by the restaurant for a meal, along with takeout and delivery options and gift cards. Local small businesses and restaurants need us more than ever now, be a good neighbor and help ensure they'll always be around."

Restaurant owners won't wait for the federal government to help them out. Jason Pierce, owner of the Savoy Taproom on Albany's Lark Street and founder of Feed Albany -COVID-19 Relief, is out front with a group of fellow restaurant owners asking for help now.

"In March, one day after the COVID-19 pandemic forced a shut down here in New York, we formed Feed Albany - COVID-19 Relief to provide food and resources for at-risk and in-need individuals throughout the region. Now, as a second wave of COVID rips through the Capital District, we've created the Capital Region Restaurant Fund SORRY FOR THE INCONVENIENCE DINE-IN IS CLOSED CURBSIDE PICKUP AVAILABLE WE ALSO HAVE GIFT CARDS AVAILABLE

to provide supplemental financial assistance to restaurant employees and owners hardest hit by the pandemic," Pierce said.

Pierce shared the launching of the fund just days before temporarily closing Savoy Taproom's dining room over concerns of Albany's rising COVID cases. The Lark Street restaurant will continue to serve take-out.

The Capital Region Restaurant Fund provides supplemental financial support for struggling bar and restaurant employees who are out of work due to a COVID-19 positive diagnosis or mandatory quarantine and provides limited financial support to operators whose establishments have been forced to close temporarily due to staff who have tested positive or are under mandatory quarantine.

Board members of the fund include Dominick Purnomo, of Yono's; Albany County Legislator Matthew Peter; Jen Fox, recently of Adirondack Basement Systems; and Joe Bonilla, of Relentless Awareness.

"In the same spirit as how Feed Albany -COVID-19 Relief was founded, the restaurant fund is in response to the crisis of the moment. The only way we will get through this together is to work together and support one another, especially those in the hospitality industry," Bonilla said.

The restaurant fund is established through a gofundme account. Board members are also asking supporters to share the link through social media to spread the word.


## New heights

Caffe Lena is holding on through a challenging pandemic, going virtual and offering classes

SARATOGA SPRINGS — Caffe Lena, located at 47 Phila St., is quaint. It's unassuming, sitting just east of the intersection of Phila and Putnam streets. Walking by it, you would probably miss it if you didn't know what you were looking for. It shares a building with Hattie's and Sweet Mimi's Cafe, both visible from different viewpoints of the site.

Caffe Lena boasts a revered reputation. Its roots in folk trace back to 1960, when Lena Spencer opened the venue.



down, Caffe Lena has been dark to the public. However, the little business with a big heart is staying strong during the pandemic. The venue has been live

streaming shows for about six years. It started with a camera in the back of the venue, eventually working its way up to full-scale production. With a totally dedicated setup, Caffe Lena's live streams have been strong since before it was forced to rely on them solely. Vivian Nesbitt, coordinator of Caffe Lena's School of Music, and Sarah Craig, Caffe Lena's executive director, are optimistic about the venue's future despite the ongoing bottleneck of restrictions the coronavirus puts venues in.

"I think we were pretty prepared to take a punch like this because we had that dedicated setup for the live streams and business was doing so well," Craig said. "It definitely helped that we received grants that helped us keep the staff full time, so we could create the best experience possible through these streamed events."


Caffe Lena is relying predominantly on its tip jar, an optional feature that it includes with each show. Because each live stream is free to view, Craig said

many people are tipping based on what they feel the show was worth, as opposed to just the flat price of a ticket; one tipper donated \$100, something the grassroots organization still can't believe.

Nesbitt is seeing significant interest in the music school, despite it being virtual for the time being. Caffe Lena's classes are unique because it recruits Grammy-winning and renowned musicians to teach the classes. Students are learning from the best

and reminded that even the most prolific musicians in folk history were once beginners. The pandemic has forced touring musicians to hunker down, giving them ample time to turn their talents elsewhere.

"Anytime I've reached out to these incredible musicians and asked them to teach a class for Caffe Lena, they've always responded with 'tell me more'," Nesbitt said. "We have such a far reach and deep respect within the industry. Our reputation

Nesbitt added Bruce Molsky, a beloved clawhammer banjo and fiddle player, volunteered to teach immediately upon learning of the classes. Nesbitt and the team have also recruited icons like blues guitarist Guy Davis, guitarist Marcy Marxer, songwriter Dan Navarro and clawhammer banjoist Allison DeGroot, amongst others.

"What makes this so successful is we have a faculty of working

musicians, as opposed to people whose sole purpose is teaching," Craig said. "All of these musicians have years of experience on stage and can actually apply these lessons to their own careers. There are different tricks they teach our students that help them understand how different shows and songs work."

Nesbitt and Craig said people all over the world are now tuning into Caffe Lena. Nesbitt added there are a couple of students from out of state. In the Caffe Lena's live streams, there are people from Germany and France. Of the classes so

far offered, 12 kids have taken more than one. Many people are using the time in quarantine to master a new instrument, something that can unite a community, even through a screen.

"We're not trying to create the next star here," Craig concluded. "We are sharing the gift of music — showing how it's a way of life — and sharing the cultural history of this music. It's about making friends and nurturing those bonds. We want people to participate and have a good time."

## In the search for what really matters

Kevin Barhydt's new book explores the journey of finding his birth family

hen I reached out to talk to local author Kevin Barhydt about his new book, "Dear Stephen Michael's Mother," Barhydt and I had a brief, pleasant conversation and seemed to click quickly.

I told him I wanted to push the interview a bit further out so I could read the book beforehand, and he graciously sent over a digital copy. I had heard from preliminary reviews that Barhydt's story was intense, but after reading books like "A Child Called It" by Dave Pelzer, I wasn't too concerned.

That night, I swiped open my iPad and finished "Dear Stephen Michael's <text><text>

You see, Barhydt looks boring; he even admits it. He's well educated, a spokesman for mental health and addiction recovery. He's a professor at a local college. He's smart as a whip and articulate our later conversation was full of abstract thoughts and concepts that are

normally hard to talk about. However, Barhydt's past is dark. 

Barhydt is open about the compounding traumas that lead him into addiction. Despite having a loving adoptive family and resources many would dream of, he found himself experimenting with alcohol, and then drugs, at a young age. It started with beer, then marijuana, then harder drugs like opioids and narcotics. At one point, he overdoses in school and ends up in the hospital. The lack of understanding about his past and not being able to reconcile why his birth mother gave him up served as the foundation; as he found himself falling deeper into the throes of addiction, the traumas that came with that lifestyle only accelerated the building of the house that would be Barhydt's downfall.

One thing is for sure: readers will hate the Barhydt they read about in the book. As I turned page after page, I was aghast at the decisions he made and the selfishness he portrays. Barhydt's visual writing throws you right into the room he's using in. However, I found myself wanting to hug this broken



young man. As he snorts another line of cocaine and his nose bleeds yet again, I want to slap him across the room, but then sit down and ice the bruises.

Now almost 36 years

sober, Barhydt is healing. He said his compounding trauma came with compounding healing, something he animatedly said is blossoming around him in his everyday life. He has four wonderful children and a beautiful wife. He's completed his search and is working with the results of it; Barhydt explicitly asked me to not spoil the ending, as he wants people to read the whole story and trust the journey he's on.

Barhydt now works with those suffering from addiction and in recovery. His sponsees have read the book. He credits his deep relationship with his higher being as the pedestal for his recovery. He starts each day with prayer and meditation, hoping to find the answers to some of life's continuous questions.

"I find myself looking for the blessings in each person because if I start looking at flaws, I'll have to look in the mirror," Barhydt concluded. "I'm hoping in many ways, by looking for blessings in each person, I'll be able to see the ones in me."



because they give context to a broader picture and allow a person to create a more well-rounded opinion. However, it's also important to discern motives from elected officials and the media.



2. Determine how much you can spend. Money for gifts and other holiday expenses should ideally come from your disposable income. Look at your finances in advance of the holiday season and figure out how much extra cash you have for the holidays, and use that figure to determine how much you should spend. Find ways to make up any deficit by curtailing expenses like dining out or entertainment extras. Many people plan to use credit cards to pay now and worry about the aftermath later. Only use credit cards if you have the money in the bank and can pay off the entire bill when the balance due is in January.

3. Set a spending limit for individuals. Based on your numbers and how much you plan to spend overall, start allocating money to categories, including gift recipients. Come up with a spending range for each person and stick to it.

4. Pay in cash as much as possible. It's easy to know what you're spending when using cash as opposed to credit. There is some risk with carrying around cash, but that risk may be offset by the benefit of spending only what you can afford to spend. 5. Track all purchases. Save the receipts and keep a running total of expenditures so you can see how your spending is measuring up to your budget. If necessary, scale back on one category if you've tipped the scales in spending on another.

6. Shop sales and deals. High-end stores may have the impressive tag, but their prices can set you back. Instead, look for comparable gifts at discount stores and other retailers. Also, if you must use a credit card, use one that earns you a cash-back bonus for added savings.

A holiday budget is a must to avoid overspending and finding yourself in debt early next year.


Season the chicken generously with salt and pepper to taste. In a large, deep skillet (big enough to hold all chicken fairly close together; or use two skillets), melt 3 tablespoons of the butter in 1 tablespoon of the olive oil over medium-high heat. Brown the chicken for about 8 minutes, turning so both sides get nicely browned. Transfer the chicken to a deep, broad, ovenproof casserole that can go from the oven to the table. Remove the skillet from the heat and pour off most of the fat.

Preheat the oven to 375 F. Place the skillet back over medium heat

and add the remaining 1 tablespoon butter and 1 tablespoon olive oil. Add the shallots and garlic and cook for about 1 minute, or until they become translucent. Add the vinegar and wine, and stir up the crispy bits that have stuck to the bottom of the pan. Allow the liquids to cook down a bit, stirring occasionally, for about 8 minutes. Whisk in the tomato paste and let the sauce simmer and condense, about 5 minutes more. Then add the chicken stock, a little at a time. Keep stirring to mix well.

Pour the sauce over the chicken. Bake for 35 to 45 minutes until the chicken is very tender, turning the chicken pieces halfway through, so that both sides are infused with the sauce. Remove one thigh and cut into it to make sure it is done and no red juices flow from the cut.

Remove the casserole from the oven, sprinkle the parsley on top, and serve.


Strategies to overcome seasonal affective disorder

inter can be an aweinspiring time of year. Snow-covered landscapes and opportunities to enjoy sports like skiing and snowboarding make winter a favorite time of year for nature enthusiasts and athletes.

As fun as winter can be, many people struggle with the transition from warm weather and long, sunny days to cold weather and reduced hours of sunlight. Sometimes mistaken or misidentified as the "winter blues," this phenomenon is known as seasonal affective disorder, or SAD.

## What is seasonal affective disorder?

According to the



National Institutes of Mental Health, SAD is a type of depression. The NIH notes that a person must meet full criteria for major depression coinciding with specific seasons for

at least two years to be diagnosed with SAD. The American Psychiatric Association says symptoms of SAD can be distressing and overwhelming and even interfere with daily

#### functioning.

The APA notes that SAD has been linked to a biochemical imbalance in the brain that's prompted by shorter daylight hours and less sunlight in winter. As the seasons change, a shift in a person's biological internal clock or circadian rhythm can lead to them being out of step with their normal routines. That can contribute to various symptoms, including: · Feeling sad or

depressed

• Loss of interest or pleasure in activities once enjoyed

• Changes in appetite, usually eating more and craving carbohydrates

• Loss of energy or increased fatigue despite increased sleep hours

• Increase in purposeless physical activity or slowed movements or speech that may be noticed by others • Feeling worthless or

#### guilty

• Difficulty thinking, concentrating or making decisions

· Thoughts of death or suicide

### Overcoming SAD

The weather can't be changed, but people can speak with their physicians about the following strategies to overcome SAD.

• Light therapy: According to the APA, light therapy involves sitting in front of a light therapy box that emits a very bright light. In the winter, patients typically sit in front of the box for 20 minutes each morning, and they may see some improvements within one to two weeks of beginning treatment. Light therapy is usually continued

throughout the winter. • Medication: The

APA notes that selective

serotonin reuptake inhibitors, or SSRIs, are a type of antidepressant that are sometimes prescribed to treat SAD.

• Spending time outdoors: People with SAD who don't typically spend much time outdoors when the temperatures dip may notice their symptoms improve if they make a concerted effort to spend time outdoors in winter.

• Rearrange rooms in the home: The APA notes that rearranging rooms and furniture in a home or office to allow more natural light in during the daytime can help improve symptoms of SAD.

SAD is a legitimate concern for millions of people across the globe. Working with a physician to overcome SAD can help people successfully transition to days with fewer hours of sunlight.


