Langdon resigns

County legislator was under pressure to guit after his disparaging remarks toward homosexuals came to light in a recorded speech

ALBANY — George Langdon, the first-term county legislator whose disparaging comments toward homosexuals ignited condemnation from local leaders, has resigned.

"It was never my intention to single-out or target anyone," Langdon shared in a statement emailed Monday, April 5. "I truly believe every individual should have the right to life and liberty in their pursuit of happiness."

The Republican representative of the 37th District apologized again for comments he had made at a seminar in Voorheesville last month. The speech he gave before the group was recorded and later came to light after the seminar's organizer, William Tryon, was arrested for his alleged actions during the U.S. Capitol building riot in January.

"We support George Langdon's decision to resign and for doing what he believe to be right for his family and constituents," said Minority Leader Frank Mauriello. "His recent statements were offensive and wrong. He is apologetic and understands the hurtful nature of his remarks. I wish George well in all his future endeavors."

Langdon had issued an apology last Thursday, a day after local leaders called for him to resign.



Local pinned to Capitol riot

William Tryon is allegedly tied to U.S. Capitol riot

ALBANY — A Selkirk man was arrested for his alleged involvement with the "riot and assault" on the U.S. Capitol building on Jan. 6.

The charges against William Tryon, who spoke at a Back the Blue rally outside the State Capitol building last August and was a counter-protester at a Black Lives Matter rally later that month in Colonie, are not known at this time.

"We will continue to coordinate with our colleagues at the FBI Washington Field Office and the U.S. Attorney's Office to

bring to justice anyone who broke the law that day," said the Albany FBI in a statement. "We remain grateful to the public for their invaluable assistance in this investigation and continue to encourage anyone with information to call 1-800-CALL-FBI.'

Tryon's arraignment was scheduled for Tuesday afternoon in federal court in Albany.

In a video of the Jan. 6 riot posted on YouTube, Tryon was seen sitting outside the Capitol in Washington wiping his face and holding a cell phone and a U.S. Flag.

"This is our Capitol building. All we want to do is enter and tell our representatives we want our country back. We are not going to take this," he told the person who made the video.

"Those two boys deserve what the boys in Normandy paid for," he

presumably young rioters, not seen in the video. "This is nothing so far. This is

your freedom." He said he got pepper sprayed as he entered the Capitol and got hit with batons "two or three times."

"I feel pretty good," he said on the video. "It's our country. What do we do?" Chants of USA were heard in the background

and the 11:14 second video

said referencing two people, showed up-close clashes between rioters and Capitol police.

Scores of people were arrested for their role in the riot that drew the world's attention to Washington. Rioters carrying American and Trump 2020 flags stormed the Capitol protesting Donald Trump's loss to President Joe Biden in November. More than 140 people were injured and five died.

Guilderland man gets 25 years for child sexual exploitation

ALBANY — Blake Spears, 40, of Westmere, was sentenced on Friday, March 26, to 25 years in prison for sexually exploiting a child.

The announcement was made by Acting United States Attorney Antoinette T. Bacon and Thomas F. Relford, Special Agent in Charge of the Albany Field Office of the Federal Bureau of Investigation (FBI).

Spears admitted that on December 1, 2018, he used his phone to video-record himself masturbating while standing over a sleeping child. He also admitted to using a phone messaging application to distribute, to others, videos depicting the sexual abuse of other children.

In imposing sentence, United States District Judge Mae A. D'Agostino found that Spears was

a repeat and dangerous sex offender, and had repeatedly exploited a minor. She also imposed a 20-year term of supervised release, to begin after the 300-month term of imprisonment, and ordered Spears to pay \$8,000 in restitution to individuals whose abuse was depicted in images that Spears possessed.

This case was investigated by the FBI and its Child Exploitation Task Force, which includes members of federal, state and local law enforcement agencies, including the Colonie Police Department and New York State Police. The case was prosecuted by Assistant U.S. Attorney Michael Barnett.

The case was prosecuted as part of Project Safe Childhood, Launched in May 2006 by the Department of Justice, Project Safe Childhood is led by United States Attorneys' Offices and the Criminal Division's Child Exploitation and Obscenity

Dutchess County man mailing white powder to fed offices

ALBANY — Jason Pantone, 36, of Hyde Park, New York, was sentenced Monday, March 15 to time served (more than two years in jail) for conveying false information and hoax letters.

The announcement was made by Acting United States Attorney Antoinette T. Bacon and Thomas F. Relford, Special Agent in Charge of the Albany Field Office of the Federal Bureau of Investigation (FBI).

Acting U.S. Attorney Antoinette T. Bacon stated: "With these hoax letters, Jason Pantone intended to terrify federal employees throughout Upstate and Central New York. emotional distress to some letter recipients, and for consuming the valuable time and resources of our first responders. I commend our law enforcement partners for quickly arresting Pantone shortly after his crimes began."

FBI Special Agent in Charge Thomas Relford stated: "Mr. Pantone's actions caused widespread panic and fear for employees who simply showed up to work that day, and he spent two years in jail as a result. The public should know the FBI will work diligently with our law enforcement partners to actively investigate and pursue prosecution of any individual who poses a threat to the safety of our citizens."

Pantone was arrested on February 27, 2019, and had been in custody since that time. As part of his guilty

plea, Pantone admitted that in February 2019, he mailed several envelopes addressed to Social Security Administration Offices in Plattsburgh, Binghamton and Utica. Additional letters were addressed to United States District Court offices in Syracuse, Binghamton, Albany, and Plattsburgh. All of the envelopes contained a typed note that read "ANTHRAX." Some of the letters included a smiley face with "X" in the place of the eyes, meant to indicate death.

Pantone's actions caused several locations to be evacuated and hazardous material teams to be deployed, to assess and clear the buildings. All samples of the white powder were tested and yielded negative results for anthrax or other hazardous material.

United States District Judge Mae D'Agostino also imposed a three-year term of supervised release.

This case was investigated by the FBI, the Social Security Administration Office of Inspector General, the United States Postal Inspection Service, the Federal Protective Service, the New York State Police. the Dutchess County Sheriff's Department, the New York State Department of Health, and the Department of Homeland Security. The case was prosecuted by Assistant U.S. Attorney Troy Anderson.

Legislator 'sorry' for homophobic words

Langdon: 'Give them an island, and they will be gone after 40 years'

ALBANY — A day after local leaders called for him to apologize and resign, County Legislator George Langdon issued a statement recognizing "hurtful remarks" he recently made towards homosexuals.

"I sincerely apologize to the LGBTQ community and all others for the hurtful remarks recently made at a conference," Langdon said in an emailed statement issued, Thursday, April 1. "I have never been homophobic nor do I think any individuals should be placed on an island. I deeply regret my foolish off-the-cuff comment that has caused so much pain. I commit to doing a better job of respecting diversity.

Langdon made disparaging comments towards homosexuals at a seminar organized in part by William Tryon at Camp Pinnacle last month. The Christian-based camp was the setting for a "Return to Liberty Under the Constitution" seminar in which Langdon attempted to explain, "everything God does is sustainable."

"Everything God does is sustainable. It is sustainable. It goes on and on and on. It's perpetual," he said. "Sorry, when

you have homosexual relationships, it is not perpetual. Give them an island, and they will be gone after 40 years."

Langdon's comments were captured in a near four-hour video shared by Liberty Bell Alliance 76, a conservative group Tryon founded. The legislator's speech came to light shortly after Tryon's arrest on Tuesday for his alleged involvement with January's insurrection at the U.S. Capitol building in Washington, D.C.

The thrust of Langdon's 10-minute speech centered around getting people involved in the political process either as a candidate or a volunteer. Towards the end of his speech, he spoke on the

Meadowdale Winery wins eight more medals, scores '95' Rating

ALTAMONT - When

Meadowdale Farm Winery's 295-yearold tasting room reopens for the season in May, visitors can try some of the wines that brought home eight medals for excellence in international competitions in 2020.

"We had the good fortune of winning medals in both the New York International Competition in Manhattan and the New York Wine Classic, which is held in the Finger Lakes," said Meadowdale's John Sheehan.

Winning awards were Meadowdale Ice Cider, a late-season, after-dinner wine; White Blossom, a full-bodied, dry white wine made from apples; White Egret traminette, a dry, spicy white hybrid grape wine; 1736 Birch Wine; historic recipe made with white birch sap; and, Corot Noir; a fruity, mediumbodied red hybrid grape wine.

"We are very happy to announce that our Ice Cider was awarded a Gold Medal and a rating of 95 in the 2020 New York International Wine Competition in Manhattan," said Meadowdale's Bernard Melewski. "Those judges also named us New York Ice Cider Winery of the Year and rated our White Blossom a 90."

White Blossom also won a bronze medal at the 2021 New York Wine Classic, where it won the highest honors of any New York apple wine.

The 2020 NY International Wine Competition featured 1,400 entries in 50 categories, produced in 24 nations. The NY Wine Classic features more than 600 entries from 96 New York wineries. Melewski said Meadowdale Winery sells eight varieties of its wine online year-round on its website (www. MeadowdaleWinery.com), but the tasting room is a special treat. It will reopen in mid-May Sat and Sun, 1 to 5 p.m.. It is located at 32 Fryer Lane, Altamont, NY 12009, off Route 156 at the Guilderland/ New Scotland border. Fryer Lane is about a mile north of Indian Ladder Farm and Cidery on State Route 156. This year, opening weekend will be May 22-23.

Since it began competing in 2018, Meadowdale Farm Winery has won 13 gold, silver and

bronze medals in the NY International Wine Competition and NY Wine Classic. Meadowdale Farm Winery is a producer member of the Capital Craft Beverage Trail and the New York Wine and Grape Foundation.

STATE COURTS Questions over Working Family signatures

Legitimacy of witness signatures could impact hundreds of political races

ALBANY — Working Families Party designating petitions across the state appear headed to court after Republicans spotted an irregularity in the witness signatures of the presiding officer and secretary.

According to Albany County Republican Board of Elections Commissioner Rachel Bledi, the signatures by presiding officer and secretary are either a stamp or a cut and paste which violates state Election Law. In addition, she said, they are photocopies rather than originals.

have a box around it," she said. "It opens the door to questions regarding fraud. There is no way to validate a certificate based on a photo copy."

She provided the designating petition documents for Dutchess, Green and Albany counties and the signatures of Jonathan Westin as WFP presiding officer and Daniel Langenbucher as secretary are exactly the same and all three include the same exact black box around each of the signatures indicating it is a stamp or a photo copy.

Anita Thayer, the secretary for the Capital District WFP, said the signatures were not photocopied or stamped but scanned which is allowed under the current Election Law as modified by the state during the COVID-19 pandemic.

"Our WFP authorizations (i.e. permission for our candidates that are not WFP registrants to run on the WFP ballot line) were filed in accordance with current Election Law, regulations, and the governor's executive orders," she said, "We anticipate that county BOEs will uphold the law and accept our authorizations regardless of Republican talking points."

It is unclear how many candidates the court action will include but in Albany County there are candidates running with the WFP line in Colonie, Bethlehem, New Scotland, Guilderland, the City of Albany and in most municipalities outside of villages. If the signature sheets in other counties are the same as those supplied by Bledi, it could impact hundreds of races across the state.

New York is one of a handful of states that still allows minor parties to endorse major party candidates. The Working Families Party generally endorses Democrats while the Conservative Party endorses Republicans. They are the last two minor party lines that got enough votes to gain automatic ballot status in this November's general election.

The process, generally, is candidates get a required number of petitions from voters enrolled in the respective party and then the party officials sign off on the petitions, granting permission for the candidate to run on the party's line.

Rules were changed this year regarding the number of signatures and even the process of validating them. But Bledi said while the state did allow a notary public to witness the signature via zoom or other video conferencing platform, it still requires an actual signature rather than a stamp and it requires the actual signature is handed into the Board of Elections and not a photocopy or facsimile thereof.

She said there is precedent based on a New Scotland case where an enrolled Conservative Party member attempted to file paperwork by fax to run as a Republican. In the end, the Court of Appeals, the state's highest court, ruled the Albany County BOE could not accept paperwork by fax but instead had to have the original documents.

The first court case could come as soon as the middle of this week, Bledi said.

Court of Appeals rules against Justice Center

Justice Center, as special prosecutor, is unconstitutional

ALBANY — The state's highest court ruled that the special prosecutor created by the governor for the Justice Center for Person's with Special Needs is unconstitutional.

As such, the court upheld the dismissal of three convictions brought by the Justice Center in a unanimous ruling dated March 30.

The decision does question the foundation of how the Justice Center conducts business but a spokeswoman said the organization created in 2012 will continue.

"It's clear that the Court of Appeals recognizes the critical role the Justice Center plays in the protection of vulnerable people," said Christine Buttigieg. "The agency's core functions including investigating allegations of abuse and neglect continue uninterrupted. Additionally, the Justice Center has worked together with local District Attorneys on prosecutions for years and will continue to work cooperatively with their offices. We are reviewing the decision to determine how best to continue that work."

Of the three cases, the rape conviction of Marina Viviani set the stage for the other two. She was charged with having sex with a student while she was a teacher at the LaSalle School in Albany. In March 2017, Albany County Court Judge Tom Breslin threw out the case. In his ruling, he said the only way the Justice Center could prosecute would be if the district attorney granted permission and maintained oversight of and responsibility for the case.

That basis of that ruling followed the cases as they worked their way from county court to the Court of Appeals.

"The Appellate Division affirmed in all three cases, holding that the Legislature may not grant the special prosecutor 'independent, concurrent authority with district attorneys to prosecute individuals accused of crimes against vulnerable persons," according to the most recent decision. "District Attorneys, the Appellate Division held, are elected constitutional officers who possess the 'prosecutorial authority' of determining 'whom, whether and how to prosecute, and the Legislature has no authority to transfer that 'essential function' of a District Attorney 'to a different officer chosen in a different manner.""

The Justice Center was created with much fanfare in 2012 by Gov. Andrew Cuomo. It was given "concurrent" jurisdiction with local district attorneys and proceeded to investigate and prosecute cases based on the belief it had the authority to act independently of and on equal ground as the local district attorneys.

Breslin, in his decision, wrote the state statute creating the Justice Center "can pass constitutional muster by reading it to require the district attorney to maintain ultimate prosecutorial responsibility for the prosecution of any case." And, he wrote, there was "no evidence" the office of Albany County DA David Soares maintained that responsibility, if it ever assumed it from the start.

The Justice Center has been investigating cases of neglect and abuse within state run or state funded homes for the disables since 2012 but the vast majority of cases do not involve any criminal charges. Most cases are settled by a staffer getting fired and being put on a do not hire list or facing some other form of sanction. Cases can also continue onto a civil proceeding.

The Court of Appeals found there was no

precedent for allowing the governor and Legislature to create a "statewide prosecutor" with "concurrent prosecutorial authority over a set of enumerated crimes."

The Justice Center has said their mission is necessary because crimes against the disabled are too ignored by the law enforcement and prosecutorial powers that be, the DA's office, do not have the resources or the expertise to handle the nuances of crimes against the developmentally or otherwise disabled.

But, according to the ruling, the Court of Appeals ruling said in 1801 the Legislature created the Office of the District Attorney and in 1818 it gave each DA jurisdiction over a county. It was made a constitutional officer in 1821 and in 1846 made the office an elective one.

"The legislature may not transfer or diminish the core responsibilities and prosecutorial powers of a constitutionally elected officer, such as a District Attorney, through appointment of an unelected official," according to the decision.

What the ruling means to other cases brought to conclusion, either by a plea bargain or a jury decision, is not clear.

"Gov. Andrew Cuomo's unconstitutional and illegal scheme disguised as a Justice Center to protect people with special needs was the exact opposite, it systematically obstructed justice by keeping thousands of reported crimes from county elected prosecutors - ultimately protecting the abusers,' said Michael Carey, a disability rights advocate. "Now that Cuomo's Justice Center is exposed and deemed unconstitutional by the top State court, it must be dismantled immediately, my 911 Civil Rights Bill must be swiftly enacted by law so that all reported crimes get to the local police and county elected district attorneys that are in place to ensure justice for everyone."

Dear BC family: There is no question we are living through difficult times - disease, division and a society that feels fractured. While each of our experiences is unique, I want to reaffirm that the Bethlehem Central School District is a community that stands together in strongly denouncing racism and condemning all instances of hate crimes, hate speech,

stereotyping or comments rooted in prejudice.

Put community over division

A couple weeks ago, my colleagues and I on the Town Board adopted a police reform and reinvention plan that reflected the collaborative work of an incredible committee that dedicated countless hours to the process. Their work was assisted and informed by discussions with and involvement from community members, school officials, members of the Bethlehem Police Department, and other valuable voices.

In addition to the many hours the committee spent in meetings, many more were put in behind the scenes drafting, pulling together data and citations, and editing the final report. The final product reflects the immense amount

of time, thought, and energy that went into the report. I once again want to thank everyone involved for sharing their talents, perspectives, and passion with all of us as we collectively seek a more just and equitable future. Throughout the process we were also reminded how overwhelmingly wonderful the men and women in the Bethlehem Police Department are. Nothing angers a good cop more than a bad cop, and Bethlehem has many of the best officers around.

It has been said many times but it nonetheless bears repeating that this plan is not an end in and of itself. This is absolutely true because the greatest of plans are nothing if they do not result in action. Without action, a plan is mere words. There is much more work to do, and there will undoubtedly be tough discussions and decisions ahead, but I am confident that we will ultimately do the right things and get to the right place — together.

We must put community over division in action and not words. This plan and the process that led us here shows us that we can and must do better not just in law enforcement, but in all that we do. Together.

As runner-up, Girl Blue earns a four-hour recording session at Troy Saving Bank Music Hall.



Being on 'Zoloft and Probation'


Erin Harkes debuts first all-comedy album

ALBANY — Perhaps the best way to describe Erin Harkes' comedy is with a line producer David Tyo named a project he was mixing for her — "Erin Said [profanity] And I Have To Make It Sound Like She Didn't."

Harkes' comedy is edgy, but not blue, as she'd call the really raunchy stuff. While she's no stranger to self-deprecation and the occasional innuendo, she's not all out X-rated. Nonetheless, the local comedian/singer isn't afraid to toe the lines of R-rated laughter.

Harkes released her first comedy album, Zoloft and Probation, on March 26. The album can be

found on Spotify, iTunes and any other major streaming service. The work, a 33 minute show, features 13 bits, ranging from her commentary on her engagement, jokes about her sobriety (Harkes is 10 years sober from alcohol), her escapades over cucumber wasabi dressing and getting older.

"The joke in the comedy

industry is once you've made a comedy album, the jokes you use on it are essentially burned; you don't use them anymore," Harkes said. "Some of this material, namely the very first line, where I say 'my name is Erin and usually I follow this up with I'm X amount of years sober,' is a joke I've been using since I was a year and a half sober. To think it's now almost 10 years old, it's now time for me to transition it out."

One of the highlights of Harkes' album is the track "Firefighter," which plays with the stereotypical needy girlfriend. Harkes uses the imagery of a woman who is cheering her boyfriend on as he enters a burning building, only to become irate when she sees him carry another woman out of the building and perform life-saving procedures, as her man is putting his hands and mouth all over someone else. While the subject matter is dark most of Harkes' comedy has a dark undertone to it, a reflection of her own experiences in life — Harkes delivers it in a way that makes you laugh.

"During the pandemic, I've written a ton of new material but I haven't had the chance to try it out," Harkes said. "I tried doing comedy over Zoom and I hated it. Comedians thrive on that instant boom of laughter after we deliver the punchline. Because Zoom has just enough of a delay, the laughter feels more pity than it does genuine."

Harkes said Zoloft and Probation wouldn't have been possible without her friends, namely her best friend Ed Eason. Harkes will call Eason with whatever she's testing and regards him as her best audience. If a joke falls flat at a show, she will often poke fun at Eason, saying he set her up.

"Ed finds me unconditionally hilarious, which is great because sometimes you just need that reinforcement," Harkes said. "My comedian friends and I will have jokes that will revolve around current events and they will go out of rotation as quickly as they come in because the context is gone."

As Harkes begins her transition back to live comedy, she's ready for the challenges of a live audience. The success of each set is contingent on the mood of the audience, which is why it's critical to have material that can suit as many people as possible.

"Pivoting your show based on audience feedback is the name of the game," Harkes concluded. "I'm ready to step on stage again and make people laugh."



Techniques to revitalize a lawn after a long winter



Remove any debris from the lawn after snow thaws to see what you're working with.

Pristine, snowcovered landscapes can be wonders to behold. While that blanket of white is idyllic, a lawn's delicate blades may be paying a hefty price beneath the cold, heavy piles of snow.

Snow plows push salt and sand up on the grass while subterranean animals like mice and moles dig burrows beneath piles of snow as they try to find food and stay warm. Such conditions are not favorable for thriving landscapes. When the spring thaw arrives, lawns may be in dire need of some TLC. The following techniques can mitigate winter-related lawn damage.

• Clear out debris. Remove any scattered leaves, branches and other debris that has been strewn across the property due to storms or snowladen trees. This will give you a clean canvas to work on.

• Dry out snow mold.

The Family Handyman says snow mold is a coldseason fungus that causes gray-colored circles or patches on the lawn where there has been snow. To alleviate snow mold, rake the lawn to loosen matted grass and facilitate the drying-out process.

• De-thatch the lawn. Heavy snow can compress the grass and cause some of it to die off. Dethatching helps to remove dead grass blades and separate any matting. This enables water, nutrients and air to reach the lawn's roots more effectively. Thinning out old organic matter also helps encourage new growth.

Aerate the soil. Coupled with dethatching, aeration involves loosening the soil or poking holes to allow nutrients to move freely to the roots.

 Lawns can be restored.

• Kill weeds before they spread. Weeds may be the first to start growing when the weather begins to warm. Address them promptly by manually pulling them or applying an herbicide.

• Overseed the lawn. Chances are there are some bare spots that have formed over the winter. Overseeding can help to fill in the lawn. Make sure that frosts are largely a thing of the past and soil temperature is around 50 F to 60 F before seeding. Water daily until grass fills in.

• Apply nutrients. Fertilizer and compost can restore nutrients to the lawn that may have been used up over winter. A soil test at a nearby horticultural center can tell you which nutrients are needed, according to the Chemistry Cachet, a guide to using chemistry secrets for healthy living, beauty, cleaning, and gardening.

Lawns can be restored to their pre-winter glory after some sweat equity and about five to six weeks of consistent sunshine and warm weather.

DIY strategies to deep-clean carpeting

then apply the solution to more visible areas.

need to be revitalized, and that can be accomplished with a specialized cleaning machine. Many are available for purchase (a good investment for homeowners with kids and/or pets), while others can be rented as needed.

Remove all of the furniture from a room and vacuum to clean dust, dander and any other debris. Address any darker stains first by pretreating with a cleaning solution. Let sit for around 20 minutes. While waiting, learn how to operate the machine, fill it and clean out the soiled water. Never allow the machine to oversaturate the carpet with water, as it can get into the padding and subfloor, causing problems like mold or wood damage. Spray the water-detergent solutions, and then pass the carpet cleaner over spots repeatedly until the carpet feels only slightly damp. DoItYourself.com advises running the machine at the pace of one foot per second.

Vitamins, supplements women need

balanced diet does more than provide sustenance and fuel for daily life. Eating an array of healthy foods gives people the best opportunity to naturally obtain the vitamins and minerals needed for optimal health. But certain nutrients may be lacking even when a diet includes an assortment of colorful produce and a careful mix of proteins, carbohydrates and fats. The right supplements can help overcome such deficits, and women often need different supplementation than their male counterparts.

Vitamins geared toward women are not just a marketing ploy; most contain formulations that cater to women's unique needs at various stages in life. The Office on Women's Health and WebMD recommends these vitamins for women to maintain good health.

Vitamin D

The Cleveland Clinic reports that 42 percent of Americans are vitamin D deficient. Vitamin D comes from diet but also is produced in the skin when the body is exposed to sunlight. Vitamin D helps the body absorb and maintain adequate levels of calcium and phosphate, which are essential to bone health. Rush University Medical Center says recent research suggests vitamin D may help guard against severe COVID-19 infections. Some populations have higher levels of vitamin D deficiency, particularly people of color, those with inflammatory bowel diseases and postmenopausal women.

Folic acid

Folic acid or folate (also known as vitamin B9) helps the body make blood cells and the DNA for new

cells. This B vitamin also is key to preventing birth defects like spina bifida. According to the March of Dimes, one in two pregnancies are unplanned, and adequate folic acid is required at the early stages of gestation to help the fetus develop healthfully. All women who are sexually active are advised to take a multivitamin that contains folic acid in concentrations of 400-800 mcg. In addition, folate can be found in dark, green, leafy vegetables, nuts, beans, and cereals with added folic acid.

Vitamin B12

Vitamin B12 comes mostly from animal products. Therefore, anyone who follows a vegetarian or vegan diet may need supplementation to ensure

they are getting enough B12. Pregnant women will find B12 is important for baby's development. Without it, the infant may have low birth weight or other health problems, advises the OWH. Vitamin B12 also helps produce healthy red blood cells, may support bone health, could reduce risk of macular degeneration, and may reduce symptoms of depression. After age 50, women's bodies cannot absorb vitamin B12 as readily, so supplementing or eating fortified foods can help.

Calcium

Growing girls need 1,300 mg of calcium each day to develop strong bones for adulthood. After menopause, women may need nearly the same dosage (1,200 mg) to help slow the bone loss that comes with aging. Calcium is found in low-fat dairy products and foods with calcium added.

How kids benefit from being read to

eading aloud to children is one of the joys of parenting. All children, whether they're infants, toddlers or schoolaged, can benefit from being read to, and parents whose youngsters have grown up often look back on story time as some of their favorite moments as moms and dads.

Reading aloud to children is about more than just establishing a bond between parent and child. According to Reading Rockets, a national public media literacy initiative, children as young as infants can benefit from being read to. periodically read to each day with kids who are read five books per day. Children who are read to daily may hear slightly less than 300,000 words prior to entering kindergarten, while those read five books per day will hear more than 1.4 million words.

Reading to children expands their imaginations.

The Northern Virginia Family

Services reports that research has shown that children who activate their imaginations through being read to develop higher activity in the area of their brain that's responsible for cultivating mental images and deciphering and comprehending verbal cues. That heightened activity bolsters youngsters' imaginations and instills in them a greater fondness

for reading.

Reading can help kids learn to focus.

Parents of young children no doubt know that such youngsters rarely sit still for any significant length of time. However, when being read to, young children, even those who are initially reluctant to engage in story time, will learn to sit still for the duration of the book. That can help them learn to focus, a benefit that will pay dividends when children begin school.

Reading to children can speak to children's interests or emotional needs.

Reading Rockets notes that children's favorite stories may speak to their emotional needs and interests. That's why so many youngsters insist on reading a favorite book over and over again. Though that's often boring for parents, it can benefit youngsters, who will eventually move on to other books.

Reading to children can benefit them in myriad ways and provide a great way for parents to bond with their youngsters.





hen the weather starts to warm, people are inspired to once again venture outdoors and spend more time away from home. People can benefit from having quick and easy dinner recipes at the ready so that hours are not spent in the kitchen after a day of fun in the fresh air.

With mere minutes of preparation and about 15 minutes cooking time, this recipe for "Chicken, ham, and Swiss roulades" from "Real Simple Dinner Tonight: Done" (Time Home Entertainment) from the editors of Real Simple makes a simple weeknight meal that is tasty, too.

Chicken, ham and Swiss roulades

INGREDIENTS: Serves 4

- 8 small chicken cutlets (about 11/2 pounds total)
- 8 thin slices cooked ham
- 8 thin slices Swiss cheese

- 4 tablespoons olive oil
- 6 cups mixed greens
- 1 cup grape tomatoes, halved
- *1 tablespoon white wine vinegar*
- 1/4 cup whole-grain mustard

INSTRUCTIONS

Heat oven to 400 F. Season the chicken with 1/2 teaspoon salt and 1/4 teaspoon pepper. Roll up each cutlet with 1 slice of the ham and 1 slice of the Swiss cheese. Skewer the roulades closed with toothpicks.

Heat 2 tablespoons of the oil in a large ovenproof skillet over medium-high heat. Add the roulades and cook, turning occasionally, until golden brown, 4 to 6 minutes. Transfer the skillet to an oven and roast the roulades until cooked through, 8 to 10 minutes.

Meanwhile, in a large bowl, toss the greens and tomatoes with the vinegar, the remaining 2 tablespoons of oil, and 1/4 teaspoon each salt and pepper. Serve with the roulades and mustard.
