Another six months?

Bethlehem comp plan is running late, Town Board to consider extending its one-year development moratorium

DELMAR — The Bethlehem Town Board has been told not to expect the update to its comprehensive plan in time to approve it before the end of the year, prompting steps to extend the one-year development moratorium another six months.

The Town Board will host a hearing to solicit public comment on extending the residential land use moratorium on Wednesday, Nov. 23.

Work on revising the town's 2005 Comprehensive Plan started with a presentation three years ago. That first step involved assessing what progress had been made since community leaders and policymakers envisioned how Bethlehem would appear in 2020.

The plan has been amended five times over the years, notably to address particulars such as solar photovoltaic systems that weren't as prevalent as they are today. There were also changes to be made in zoning and defining subdivisions.

The town's Economic Development and Planning Department started revision efforts by inviting community stakeholders and town officials to identify what was important. Work

on revising the plan was anticipated to focus on social equity and environmental sustainability by looking at transportation and traffic, open space conservation and the character of residential neighborhoods.

Town Planning Director Robert Leslie identified several factors behind the committee's delay while speaking before members of the Town Board, including the challenge to meet under the conditions from the COVID-19 pandemic.

"Given the complexity of the issues, the amount of public input, the public engagement challenges created by COVID-19 pandemic, and the comprehensive nature of the tasks undertaken, additional time is necessary to complete the plan update," Leslie told the Town Board. "To maximize the benefits of such a process, the enactment of a six-month extension of the town-wide residential moratorium is recommended by the

Planning Department."

The Town Board passed a 12-month development moratorium last December, halting the approval process for applications coming before it and the Planning Board. The legislation was said to be necessary in order to allow work on the comprehensive plan to proceed unhindered by a landscape continuously changing by approved housing developments. Leslie shared the committee's meeting itinerary for the year, including 21 meetings over the last 10 months.

The moratorium, however, struck the ire of development firms that have had plans under review, some of which for several years. Since the embargo, developers for three different projects have gone before the Town Board seeking exceptions.

In April, the Town Board denied Michaels Group Homes' request to allow its plan for an 87-lot development off Selkirk's Elm Avenue to proceed. Two weeks later, the Town Board started discussing a possible waiver for NRP Group plans to build 72 affordable housing units

just south of Jericho Drive-In.

An exception for the affordable housing project appeared favorable as the waiver application cleared the town's Planning Board despite public pushback. According to Leslie, it was the first proposal for affordable housing the town had received since the comprehensive plan was adopted. Outside planning commissions had identified the town as an ideal place for affordable housing. The Capital District Regional Planning Commission noted the town's above-average housing costs. The

New York State Office of Homes and Community Renewal identified its high-performing school districts as a benefit.

But resident protests pointed to several perceived deficiencies in the plan's location, devoid of sidewalks, away from the center of town and assumed lack of public transportation. Arguments were also against placing it within the Ravena-Coeymans-Selkirk school district, to which the Planning Board said that shouldn't be a factor. However, Albany County Legislator Matt Miller supported those arguments. The Selkirk resident and RCS teacher shared how the school district was already inundated by affordable housing. The waiver was subsequently denied.

The most recent waiver request, a residential development on 67 acres of Kleinke family farmland introduced by Cardona Development, LLC four years ago, was denied shortly after Leslie's request to schedule a public hearing before the moratorium expires on Thursday, Dec. 9.

BC unveils new branding for sports

New logos were revealed to students on Homecoming

DELMAR — Just in time for Homecoming Weekend, the Bethlehem Central School District has unveiled a series of redesigned athletics logos that will be used by all sports teams across the district. The custom-designed athletics logos – which depict a strong, determined eagle and feature collegiate lettering — are the first in a series of updated looks and a refreshed BC brand to be introduced over the course of the 2021-22 school year.

High school students got their first look at the new athletics eagle at the Homecoming pep rally on Friday, Oct. 15.

“If ever there was a time when we could all use a fresh start, it’s now,” said Superintendent Jody Monroe. “That said, it has taken more than two years of design and discussion, revisions and refinements, with many people at the drawing board to see these plans come together. Beginning with an athletics logo that can



be used by sports teams and all student groups, we see these designs as ushering in a new era for the orange-and-black, one that honors our longstanding eagle mascot.”

Other BC brand updates scheduled for the 2021-22 school year include:

- A new district logo that will reflect BC’s core values of academics, character, community and wellness (December 2021)
- Standardized icons and banners across all district social media platforms (December 2021)
- A new district website designed to be more user-friendly (Early 2022)
- Newly designed print publications for direct mail and correspondence (Early 2022)

Monroe said the rollout of the new custom-designed logos will be gradual, with the new designs replacing the existing circular eagle silhouette as new supplies and uniforms are needed and as facilities are updated. A district branding guide will be made available that includes all of the new images (district-level and athletics), colors, and fonts and how they can be used.

“We are very excited but

just getting to this point has taken years so we don’t expect an immediate changeover,” said Superintendent Monroe. “Many stakeholders have taken part in this process, beginning with three student artists who kickstarted our redesigns by bringing sketches and ideas to the table early on. Their valuable input can be seen in these designs.”

As part of an art class during the 2019-20 school year, then-

sophomores Cella Labarge, Acey Puccio and Emily Spada provided early design ideas and traded feedback with district officials from the student perspective. Their work helped identify a need to have separate designs for athletics use and for district use. Other focus groups have included administrators, staff, parents, coaches, Board of Education members and students. Design notes and feedback from those groups, through a series of designs, inspired the final artwork created by the Capital Region BOCES Communications Service.

“The longstanding ‘eagle in a circle’ doesn’t lend itself to lots of different uses and over time, our teams have gotten creative with some of their own designs,” said the district’s Director of Athletics and Wellness Len Kies. “However, in doing so, we have lost some cohesiveness. These designs will bring us back to being an instantly recognizable BC brand and hopefully seen for what we are, a fierce competitor on and off the field.”

Albany Med Golf Tournament raises \$145K

ALBANY — Albany Med raised a record \$145,205 at its 30th Annual Golf Tournament to benefit the Bernard & Millie Duker Children's Hospital, the only children's hospital in the region.

More than 200 golfers participated in the tournament at the Schuyler Meadows Club in Loudonville on Sept. 23. BBL Construction Services, LLC, and Columbia Development Group, Inc., were the title co-sponsors.

The Bernard & Millie Duker Children's Hospital at Albany Med is a 125-bed facility devoted exclusively to the medical needs of infants, children and adolescents, and is

the referral center for all seriously ill and injured children from 25 counties in upstate New York and western New England. It is staffed by 140 physicians trained in 40 subspecialties and more than 400 pediatric nurses, therapists, social workers and child-life specialists.

RPI leads first sociological analysis of lead exposure in soil

TROY — An ongoing project is helping people identify lead and arsenic pollution and enabling a novel approach to sociological research. Abby Kinchy, professor in the Department of Science and Technology Studies at Rensselaer Polytechnic Institute, describes her research approach as “ethnographic soil testing” — a novel method for studying how people encounter environmental hazards, reason through exposure risks, and take action to improve the health of their communities.

“The goal is not only to make soil screening tools available to more people,” Kinchy said. “It is also to better understand soil contamination as a social problem.”

Lead and arsenic dispersal into the environment turns soil into an exposure pathway. Kinchy hopes to help communities to change the circumstances in which heavy metal exposures occur, by studying how

environmental, social, and economic factors interact.

With a two-year, \$500,000 National Science Foundation grant, Kinchy's team is using community science to help people find contaminated soils and take action to prevent exposure to them. They developed a Community Soil Study Toolkit, a low-cost, easy access set of tools for screening soil for lead and arsenic.

Community workshops conducted this summer trained Capital Region residents to use the toolkit and take action to prevent exposure to any contaminated soils that they found.

Now, with additional NSF funding, Kinchy will conduct research for a book about how scientists, decision-makers, and affected communities attempt to reduce the harms caused by soil lead. She intends to expand the research project globally, using ethnographic soil testing in Chile, England, and Australia.

The interdisciplinary research team joining Kinchy on the project includes Kathy High, professor of arts at Rensselaer, Dan Walls, a post-doctoral researcher at Rensselaer, Mónica Ramirez-Andreotta from the University of Arizona, Salvatore Engel-Di Mauro at SUNY New Paltz, and Sebastián Ureta at Alberto Hurtado University in Chile.

The community workshops were conducted at the NATURE Lab at the Sanctuary for Independent Media in Troy.

Another local player in the wind game

ECONcrete Tech, Lafarge to develop ecological concrete scour protection for offshore wind turbines

CHICAGO, IL — LafargeHolcim announced last week that it will collaborate to design and produce an ecologically beneficial concrete scour protection unit for offshore wind turbine foundations ECONcrete Tech Ltd.

According to LafargeHolcim, the effort is not linked to the wind turbine construction to take place at the Port of Coeymans.

The Biden Administration set the goal of creating 30 GW of offshore wind by 2030 while protecting biodiversity and promoting ocean co-use, an effort which, to achieve sustainably, should use best available technologies to ensure the health of our marine environment and

species. The scour protection developed by this partnership would be the first, and currently, only structural solution to address the ecological impacts of offshore wind turbines on the marine environment, enabling a more sustainable industry and healthier oceans.

Offshore wind turbines require massive concrete foundations to anchor them in place. Hydrodynamic forces can create large holes around foundations, necessitating scour protections. Scour protections are units designed to protect sediments from being swept away by currents, and are often installed in a mound to protect the turbines' foundations. This kind of concrete infrastructure has a large impact on sensitive benthic, or seabed, ecosystems.

The goal will be to design and manufacture a fully-structural concrete scour protection unit that facilitates the growth of marine organisms, while meeting all industry standards for stabilizing the seabed. The R&D collaboration includes a large-

scale pilot project to evaluate the ecological performance of the innovative units in an offshore environment before implementation in full-scale installations.

"Offshore energy production is a rapidly growing market worldwide, and while there are certainly benefits of using renewable energy, there is also an impact of these giant structures on the sensitive underwater ecosystems," said Dr. Ido Sella, CEO and Co-Founder at ECONcrete Tech. "We view our collaboration with LafargeHolcim in the US as key to minimizing this impact."

"For LafargeHolcim in the US, we recognize that there are many paths to achieving our net zero commitment, and most require innovative partnerships and out-of-the-box thinking," said Josep Maset, VP, Commercial Excellence at LafargeHolcim in the US. "The work we're doing with ECONcrete Tech is a notable example of searching for solutions that enable increased use of renewable energy in an

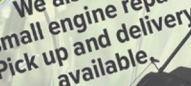

We're all neighbors, one community

The author, David VanLuven, is running for his third term as Bethlehem Town Supervisor. The following Point of View is a response to that of his counterpart, Republican candidate Paul Heiser, who submitted a similar essay in our Sept. 15 edition.

Bethlehem is a great place to live and work, and we truly are one Bethlehem. As I've served as your Town Supervisor over the

last four years, I've often set off for work, like you, depressed by the nonstop negativity that has infected our politics at the national level. But then I see my neighbors, and I see our incredible town employees at work, and I get my perspective back.

At the local level, we are neighbors first and foremost, members of a community who all want pretty much the

same things. We all want clean water, good roads, safe neighborhoods and schools, thriving businesses, fun parks, and all the other things that make Bethlehem Bethlehem. We just need to work together to achieve them.

And, here in Bethlehem, we have been getting good things done.

Services Continued Unabated During Pandemic: Our town

employees showed their creativity and commitment to serve over the last year and a half when our world was turned upside down by the worst pandemic since WWI, the worst economic collapse since the Great Depression, and the most important social unrest since the 1960s. One of my favorite examples was our Town Clerk lowering a marriage certificate out a window to a couple. Service with a smile (though now often behind a mask).

Protecting Farms & Green Spaces: Over the last 4 years, we've protected more farmland and green spaces than the Town conserved in the previous 25 years combined. This included purchasing 69 acres to create the 147-acre Normans Kill Ravines nature park in Delmar and Elsmere, and partnering with Scenic Hudson to add 21 acres to Henry Hudson Park in Selkirk. And we have more exciting projects in the works!

Leading On Sustainability & Climate Change: Climate change is one of the greatest challenges our town, our nation, and frankly everyone has ever faced, and we are taking it seriously. For example, we have installed electric vehicle charging stations at 3 town parking lots, and started transitioning our town fleet to cleaner vehicles (all paid for with grants!).

Building Equity

& Justice: Our Police Reform & Reinvention Collaborative planning process was an inspiring partnership between our community and our valued Police Department (led by the first woman to be named Chief of Police) to foster greater justice, fairness, and equity for all community members. We are now moving forward with the recommendations in the plan because they were developed by everyone working together with common goals and with an eye to implementation, not just good intentions.

Complete Streets = Safer Streets: Bethlehem's moving past the 1960s model of roads just being for cars to a more modern recognition that everyone – drivers, cyclists, and walkers alike – need to share our roads safely. This year, I tripled our annual investment in sidewalk restoration and construction. Construction is underway in Glenmont to make one of our busiest intersections flow better and be safer for pedestrians. And I'm strongly supporting Proposal 6 on the back of the ballot so we can use a \$2.9 million grant for continued community forums, detailed engineering and traffic designs for 3 different traffic patterns, and extensive sidewalk and crosswalk improvements (a no vote will send back the \$2.9 million and direct major construction only to

improving the underground pipes and repaving the road). Let's not lose this valuable opportunity - Vote YES on Proposition 6 so we can continue to improve Delaware Avenue.

And there's so much more. We're creating a new vision for our town's thoughtful residential and economic growth through the Bethlehem Forward comprehensive planning process, undertaking a cultural resources inventory to help protect historic buildings, improving our parks (did you take a plunge in our new Dive Pool this summer?), bringing the community together with concerts at our new mobile stage... the list's always growing!

Bethlehem is a strong community with good neighbors, vibrant commercial centers, great schools, and outstanding services. We are very, very lucky to live here. I'm very grateful to have served as your Town Supervisor for the last four years, and I hope that you will trust me and vote for me on November 2 (or during early voting from Oct 23-31 at the Lutheran Church, 85 Elm Ave).

The work is hard but always worth it. As I've said many times – I love this town and will always put its best interests first. I'll close with two of the very best words – Thank You!

On Election Day, Nov. 2, Bethlehem voters will be considering a referendum to fund a Complete Streets approach for the reconstruction of Delaware Avenue. I encourage everyone to vote YES on Prop. 6.

Documentary raises awareness about impacts of invasive species

ALBANY — New York State Department of Environmental Conservation announced the upcoming release of its sponsored documentary on the dangers of invasive species.

"Uninvited: The Spread of Invasive Species," is set to be released on Monday, Nov. 1 via YouTube.

DEC's Division of Lands and Forests contracted with the Westfield Production Company to produce this documentary about the significant threat invasive species pose to New York's biodiversity and ecosystems, as well as public health and the State's economy.

"Invasive species pose

a threat to New York's environment, economy, and our quality of life. To ensure New Yorkers understand this threat and what we can do to stop the threat of invasive pests, we encourage everyone to watch Uninvited: The Spread of Invasive Species. The release of this documentary demonstrates New York State's sustained commitment to educating the public about invasive species and deploying innovative technologies to stop the spread," said DEC Commissioner Basil Seggos. "Uninvited highlights the danger of invasive species and what we stand to lose without continued efforts to combat these destructive pests."

The film features the collaborative work of DEC and partners, including the state Department of Agriculture and Markets, New York Natural Heritage Program, Partnerships for Regional Invasive Species Management, and New York State Invasive Species Research Institute.

"A number of invasive species, such as Spotted Lanternfly, can devastate New York crops, resulting in major economic loss," said state Agriculture

Commissioner Richard A. Ball. "We are proud of the work our team at the Department is doing, in coordination with DEC and other state and federal partners, to combat invasive species. Uninvited spotlights these efforts and the collaborative work being done every day on the ground to ensure we can stop the spread of these harmful pests."

The documentary also addresses prominent emerging invasive species, such as spotted lanternfly, and lesser-known species of concern like scotch broom, while highlighting New York State's innovative efforts to combat these pests. The film's production was provided by the State's Environmental Protection Fund.

Planning is currently underway to offer viewing parties during the film's premiere week, Nov. 1 - 7. DEC encourages virtual viewing parties to prevent the spread of COVID-19. Organizations and individuals interested in hosting an event should fill out a registration form to receive a helpful toolkit for organizing a viewing party and have it listed on DEC's website.

Enter stage right

UAlbany theatre opens as student works embrace imagination, discovery

ALBANY — Imagination, discovery and experimentation take stage center as the Theatre Program presents New Play Arena, selected moments from two student one-act works in progress. Public performances will take place at the Performing Arts Center's Arena Theatre through Saturday, Oct. 23.

Both plays — Josephine by Yetunde Babalola and There Was a Dent Here, it's Gone Now by Claire Dell-Priscoli — are part of an eight-week development process in which the playwrights, director, design team and ensemble of actors work together in a laboratory environment toward a fuller imagining of the plays from page to stage. Putting an emphasis on experimentation, creative risk and interdisciplinary collaboration is director Sara Katzoff, a Theatre Program guest artist and curator.

"One of the reasons I am drawn to developing new work is that it is a living organism and a continual process of learning and discovery for everyone involved", said Katzoff. "The audience is an essential part of that dialogue. They step into the process with us, get to glimpse at the very beginning stages of something truly new and be part of the first steps these plays are taking off the page.

"New work has an ability to

subvert our collective expectations and expand our collective imagining of what a play is, whose stories are being centered and who gets to tell those stories."

Coming of age

Blending mythology, fantasy and comedy, Josephine tells the story of teenager Josephine Bello, who is approached by a mysterious figure on the subway, triggering a chain of events that reveal her true identity as a demigod endowed with superhero-like powers. There Was a Dent Here, it's Gone Now tells the story of an archetypical nuclear family, living in American suburbia in the 1950s, that appear perfect but are concealing disturbing psychological forces that reveal the dark side of an over-romanticized era.

"Although Yetunde and Claire each have a unique voice and have created their own distinct world and characters, both of their stories grapple with common themes of identity and coming of age at the intersection of societal and family expectations," said Katzoff, who added that both plays are "extremely imaginative and theatrical" and are works "poised to take a giant leap off the page and into the next phase of a development process."

She praised the creative and imaginative elements of the works, which include dream ballets, characters with magical abilities and stories that utilize flashbacks and other types of nonlinear relationships with time. "Because of that," she said, "our process has focused a lot on physical movement and physical storytelling and experimenting with those vocabularies and exploring what is possible

through a shared theatrical language."

The power of new works

Katzoff acknowledged that "these plays aren't by any means polished or 'finished,' but that is not the intention. New work is messy and imperfect and that is what is most raw and beautiful about it. The exciting thing about doing new work in this moment is that it allows us all to reimagine what a live performance is and what is possible within this shifting container during COVID."

The rehearsal process involved experiments, hypotheses tested and a sharing of data, producing new discoveries every day, she said. Along with changes in movement, staging and physicality, significant variations occurred with text as well. Katzoff expects such changes to occur through the run, and noted that the Arena Theatre facilitates this performance process. "Performing in the round creates such a strong connection between performers and audiences in a way that is so different from other spaces because it removes all distance, fourth walls and barriers," she said.

"We are all constantly learning! This process is really focused on giving space to let new ideas incubate, shift and evolve."

A season of engaging the imagination

New Play Arena opens the Theatre Program's season and will be followed by two classic plays, Strindberg's A Dream Play, Nov.

The Egg to host 'Kingfish' Nov. 4

ALBANY — Grammy-nominated blues sensation Christone "Kingfish" Ingram will celebrate the release of his dynamic second Alligator Records album, "662" with a performance at The Egg's Swyer Theatre on Thursday, Nov. 4.

In his short career, 22 year-old Christone has already become the most celebrated blues musician of his generation, and for good reason. Buddy Guy called him, "the next explosion of blues." Rolling Stone declared him to be "one of the most exciting young guitarists in years, with a sound that encompasses B.B. King, Jimi Hendrix and Prince."

NPR Music described his music as "blues at its raw and powerful best." He received an avalanche of national and regional press, in major dailies (New York Times, Washington Post), national publications (DownBeat, Relix, MOJO and just about all the guitar magazines) and a host of online media (RollingStone.com, NPR Music, AllMusic.com, NoDepression.com). He appeared on the cover of Living Blues in December of 2020 and on the covers of both Guitar World and DownBeat in February of 2021.

Ingram features aired on PBS-TV's "American Creators" series, NPR's All Songs Considered and World Café, and XM/SIRIUS' Bluesville channel. He's opened shows for Vampire Weekend, Jason Isbell and Buddy Guy. Besides his Grammy nomination for his self-titled Alligator debut, Kingfish, released in 2019 and cut when he was only 18, the album earned five Blues Music Awards and four Living Blues Awards, including Album Of The Year in both competitions.

Ingram's "662" debuted at No. 1 on the Billboard Blues chart. Tickets are on sale online at www.theegg.org or by phone at 518-473-1845.

Hattie's to fill a void in Downtown

Renown Spa City eatery to open third location at former Lombardo's in Albany

ALBANY — You take a story like Lombardo's from a few years ago and ask yourself, what will it take to fill the space of such an iconic Capital City landmark? Well, now you've got your answer.

Last week, someone hung up a "Future Home of Hattie's Restaurant" in the old eatery's window on Madison Avenue. The simple and clean sign needed little more description to single the charge of yet another iconic restaurant — albeit from Saratoga Springs — to come fill the void left after its doors closed in 2018.

Hattie's Restaurant is a Spa City landmark for residents and tourists alike. The legend says that before it opened for business on Federal Street in



1938, Hattie Gray was peddling her mouth-watering fried chicken to patrons at the Saratoga Race Track. Once she gathered enough money to open her own place, she introduced upstate New York to fine Southern and Louisiana cuisine that has stayed for nearly a century.

Since those first days of

offering chicken and gumbo to Saratoga's nightlife, the restaurant moved to its present-day Phila Street location, and spun off another room roughly eight miles south in Wilton. Both will remain open as the restaurant opens its third location in what was once Albany's Little Italy.

The 9,500-square-foot location

was sold in April, more than two years after Lombardo's closed its doors forever. The giant electric sign with the Lombardo named scribed vertically down an arrow still hangs above the street pointing would-be customers to its ballroom.

The Italian American joint had carried the family name of the man who first owned and operated the place. Charles N. Lombardo Sr. founded the restaurant in 1919, later expanding in 1933 to the footprint that remains. His son, Charlie, Jr. was a boyhood friend of Pulitzer Prize winning author William Kennedy, and inherited the business that would pass down through the family until 1991 when Paul and Rose-Marie Mancino purchased it.

In its time, Lombardo's was a place that lured everyone, from locals to state legislators, with a menu that promised generous portions of pasta, seafood, salads and more.

Paul Mancino announced his intent to close the restaurant on New Year's Eve 2018. Rose-

Marie had died the year before. For two years, it remained vacant, except for various signs to leave hints of its recent past. In March, Mancino's realtor announced a buyer with a particular interest in the kitchen and a rare parking lot to support business.

No date has been announced as to when Hattie's will open its Madison Avenue location. The signage announcing the venture states that all profits will go towards local charities. People expressed excitement over the news, with some more concerned that it signaled the end of the Saratoga Springs location.

"Both locations will remain open," someone from the restaurant stated on its Facebook page.

Hattie's is often listed among the area's best places for fried chicken. Before settling down in Saratoga, renowned chef Jasper Alexander previously worked at Seattle's Restaurant Zoe, Ponti Seafood Grill and Axis Restaurants, and New York City's Aureole, Gotham Bar and Grill and Gramercy Tavern.

Since launching the tour in July, they've added more stops. The two analog souls are hell-bent on inciting a new rock revival this fall – and they're bringing their unique retro-inspired original rock sound to the Palace Theatre on Tuesday, Oct. 26, at 5:30 p.m. to prove it. The show is a fundraiser for Cash for Coats, a community event collecting funds toward the purchase of new winter items for Albany kids in need.

Their latest single is their fourth to chart in the Billboard AAA Top 40. Since debuting in August it has remained on the chart. Right now, it's at No. 26. The single is also the artist's first to chart in Billboard AAA Monitored airplay, a panel

comprised of radio stations automatically monitored by Nielsen. The video for the single was also added to rotation on MTV.

The video is a peek into Jocelyn and Chris' recent retrovibe of warm colors, psychedelic trails and soulful backup singers. Hip huggers. Bell bottoms. Long hair. Fresh guitar licks that dip into the blues. It trips one back into the icons of a decade neither one had experienced before, walking through a cloud as silhouettes of Grace Slick and David Bowie.

"I just love the aesthetic of it," Jocelyn said. "Chris is going for a more androgynous style [and] We feel that our music is authentic and that aesthetic matches the vibe of the sound we've created. We're not trying to write music from the 70s, we're trying to write music from now. But, I think, harkening back to that authenticity."

The threads they both wear on stage are authentic to the time too. They said they score their best outfits through the thrift stores they are able to visit while on the road. The clothes pre-date today's fast fashion clothing that falls apart after a tumbles in the

wash. The era has come alive and other artists have latched on to the groove — and the comfort of elastic waistbands. Chris said he finds the best outfits in the women's section. There's far fewer glances darted his way, considering the sight of his 6-foot frame studying through the racks. Large pants work well, but finding a top that matches can be more difficult for him.

"You tall people," Jocelyn quips. She said her driver's license generously records her as 5-foot 1-inch. "I have no sympathy for you tall people. [Laughs.] I can not relate to that."

The past few years have been monumental for the Arndt siblings, who made their national TV debut on NBC's Today Show in addition to featured coverage in Relix, The Daily Beast, NowThis, Paste, Parade, and countless others. The release of their 2019 album "The Fun in the Fight" debuted at No. 1 on the Jambands Top 30 and in the Top 20 on the iTunes all-genre chart, landing them tour support dates with X Ambassadors and Jimmy Eat World along with festival and event performances nationwide.

Going into 2020, Jocelyn and Chris had big plans – but as it turned out, 2020's plans

were bigger than any of us could have imagined. Instead of giving in, the two chose to step up, streaming online 7 days a week and cultivating a connection with their fans around the globe that's now deeper than ever. "Sugar and Spice" not only marks the lead single of their upcoming album, Favorite Ghosts, but also a decisively confident return to musical life for the siblings.

Since returning to live performances, the two have continued their interaction with an audience once relegated to Facebook Live. Maybe bringing their living room sofa — another bygone relic — to the stage has added a familiar comfort. David Bourgeois has noticed something else.

"[Chris'] guitar play," which has always been exceptional, Bourgeois said, "has increased exponentially."

As the pandemic continued to grip everyday life and sequester artists into their homes, we've all been told to anticipate a renaissance of music. Prior to the shutdowns, Chris had been featured in various publications. But, bourgeois attributes Jocelyn and Chris' continuous livestreams to the quality he's seeing on stage.

"Playing these songs as just a duo [during the pandemic] has forced me to get very used to playing the foundational parts of the song," Chris said. "They've become so ingrained. ... [And] being in front of people was not always the most natural skill for

me. Having to talk so much, I've gotten really more comfortable in my own skin. So now when we're playing the live shows, I feel like I can go that much more deeper into the music, just get super into it and feel it more."

CONCERT REVIEW

Gregory Alan Isakov, Patty Griffin Juxtaposed at Troy Music Hall

TROY — On a drizzly autumn evening in Troy, we headed to Troy Savings Music Hall to enjoy intimate performances by Gregory Alan Isakov and Patty Griffin. The historic music hall offers one of the best listening rooms in the country, a perfect setting for such organically gorgeous music. While Jim and I had not listened to Isakov much, we both are huge fans of Griffin. Her last performance at the Hall left us longing for more of her honey soaked voice.

Isakov opened the evening with his colleague Steve Varnie. The two shared a microphone and these beautifully interlaced harmonies while playing banjo and guitar. The audience greeted them

warmly as Isakov stated, “We feel like the luckiest people ever. Thank you so much.”

The humble Colorado duo played with sound, using dissonance in a surprisingly pleasing way. With their third song, “Dark, dark, dark,” Isakov shared he wanted to “get the happiest song of the night out of the way.” And while the themes of their songs were about heartbreak, loneliness, and despair, the tonality and lushness of their sound was mesmerizing. Isakov called it a “God noise” when Varnie would pluck an electric guitar string and leave the sound open via a wah-wah pedal, and the resulting sound offered a layered sound against deeply cavernous lyrics.

Perhaps the favorite song of the night was the duo’s “Second Chances,” a song about forgiveness, or as Isakov joked, “a song about f*cking up.” It was hard to miss the duo’s respect for one another and overall joyfulness, even as they played songs with

quite the opposite emotion.

Troy Savings offers musicians an acoustic nirvana; the sounds they can produce and explore there are like no other venue. Isakov leaned into this, bending sound and using ironically sensuous music paired with content focusing on raw emotions.

During the break, fans circulated the music hall and remarked on Isakov’s talent, and the extreme heat in the hall. Wearing masks, fans were clearly red faced and sweaty after this first set. Many were drinking complimentary water offered by the venue to care for the guests.

After a very brief break, Patty Griffin entered the darkened stage to sit at the piano accompanied by a mug of tea. She opened with her luscious voice, and although it was hot in the room, fans quieted and settled in to enjoy this seasoned musician’s talent.

But something was simply off. With “Flaming” and “Bluebeard,” Griffin sounded scratchy; she was raspy. And as the night

wore on, her usually rich vocals and technical guitar playing seemed off, making many wonder if she wasn’t feeling well. The music was atypically hard to enjoy, and somewhat off balance as well.

Young fans who came to see Isakov left early into the set, which was sad because they may never know how absolutely lovely Griffin’s voice can be if that was their first exposure. But the environmental discomfort of the heat paired with the rarely discordant sound coming from Griffin made it a hard sell.

Isakov’s lush sound was juxtaposed with Griffin’s tired vocals. Interested fans should look for him later this month at Levon Helm’s Barn where he will be headlining. And if Griffin comes back, fans are urged to try her again. Everyone is entitled to an off night. Even the indelible Patty Griffin.

Chase Rice at Empire Live
