The day before, emails from local school officials were accompanied by separate messages from law enforcement agencies alerting families that they were working together to ensure safety within their respective school communities.

The latest challenge implied violence at schools, including elementary. The Bethlehem Police Department issued a statement to clarify no threats were directed towards any area school, but that its officers would be involved to ensure safety within the community. On Friday, two patrol cars were stationed within the heart of town at the Bethlehem Central Middle School parking lot.

Bethlehem Police Cmdr. James Rexford explained that the agency continued to put an operational plan though there was no credible threat.

"Today was all about making our school community feel safe," he shared in a statement to *The Spotlight.* "It has truly been a team approach. Our communication staff has been monitoring our tip line, our detectives have been working with school officials on operational planning, our patrol division has been following up on calls from the tip line and they have been highly visible at all our school buildings today."

Social media posts have recently challenged school children to perform acts of vandalism at school. Similar challenges have dared them to record themselves or record others as they break and damage school property and share on platforms like TikTok.

There were no reports of violence in Bethlehem on Friday, but other school districts reported a few disruptions. In Schenectady, a school went into lockdown after a perceived threat was reported on social media. Across the Hudson River, school administrators in

the Averill Park Central School District closed their buildings after a reported threat was directed toward their schools.

"If anything, the value of our partnership with the Bethlehem Police

Department really showed today," stated JoEllen Gardner of Bethlehem Central School District.

Superintendents across the Capital District had shared messages stating that their respective schools would add extra security while assuring families there was no "credible threat" to the schools.

"The origin of these posts is unknown, however, this appears to be the latest entry in a troubling trend of "challenges" that have been discussed extensively on TikTok," stated Jody Monroe, Bethlehem Central superintendent. "Earlier this year, schools across the country saw an increase in incidents of vandalism and, in some cases, violence related to these TikTok challenges that included the 'Devious Licks' challenge and the 'Slap Your Teacher' challenge."

Bethlehem police encouraged the public to adhere to the "See Something, Say Something" philosophy. In November, Bethlehem police were alerted by the public of online threats posted by a high school student. The student was later arrested and charged for making a threat to members of the school community.

"We want to be very clear, a specific threat has not been made against any of our RCS schools, staff, or students. This is a generalized threat that has been circulating around the state and country and we just want you to be aware," stated Ravena Coeymans Selkirk Superintendent Brian Bailey.

Freshman Romeo Vashishth's performance features rejected Dvorak piece from 1879

DELMAR — During District Superintendent Jody Monroe's report to board members on Wednesday, the head administrator shared student accolades accomplished outside the classroom; the first of which was that of Romeo Vashishth, featured by WMHT-FM who named him as December's Classical Student of the Month.

Vashishth, a ninth-grader at the high school, was recently featured in an interview and video performance of Antonin Dvorak's "Violin Concerto" on the station's website and social media channels.

"If you haven't seen it, it is very impressive for a ninth grade student, so congratulations to him," Monroe said.

His performance with pianist Dan Foster of Dvorak's "Violin Concerto in A minor, Op.53," was captured for the media station's website and social media channels. A lesser known piece by the Czech composer, but Vashishth told WMHT, "It's a very beautiful one."

Vashishth said he selected the piece for his feature because it is among his favorites. Ironically, the performer for whom it was originally written for in 1879 did not care for it. Dvorak had dedicated the piece to Hungarian violinist Joseph Joachim. Once presented to him, it is said he was critical of the work. At the time, Joachim was an acclaimed performer while Dvorak was a relative unknown. Joachim never performed it in front of an audience.

Though still a high school freshman, Vashishth shares a masters' critique of his own as he explains the structure of Dvorak's work. Despite being among his favorites, he said it doesn't fit well for the instrument he plays. The attention to the middle strings makes it awkward, he said and a challenge to play.

Nonetheless, watching him play his violin it is difficult to discern him from that of a seasoned veteran in a professional orchestra. There's no evidence of a boy in the midst of what is commonly an awkward time of growing up. The snip-bits of his performance shows him standing tall, gliding his bow across the strings of his instrument, fingers placed with precision and passion as his body sways to the sound — a young man intimately aware of his work. He not only plays the part, his ability to feel the music is evident as well.

"It has beautiful lyrical sections," Vashishth said. "And although there's a lot of technical passages, it is still very lyrical throughout.

The young musician was nominated for the recognition by Empire State Youth Orchestra's Director of Education David Bebe. He had been working with Bebe for the last three months, he said, and he hopes to continue doing so in the years to come.

"I'm very grateful to him for doing so," Vashishth said. "I had a wonderful time working with him."

EDUCATION Changes to teacher certification ahead

State Ed proposes changes to teacher certification, requirements to reduce barriers to certification while maintaining rigorous standards

ALBANY — The state Education Department proposed to modify teacher certification requirements to reduce barriers to certification while maintaining rigorous standards, Commissioner Betty A. Rosa announced last week.

The proposed changes would eliminate the requirement for teacher candidates to pass the edTPA and replace it with a teacher performance assessment during a candidate's student teaching or similar clinical experience in a state-registered teacher preparation program.

"The Department is transforming our approach to provide a continuum of educator development and support for teachers starting with rigorous and relevant coursework and clinical experiences for teaching candidates," Rosa said. "By eliminating the edTPA requirement, we are allowing our teacher candidates to focus on developing the critically important skills necessary to successfully deliver classroom instruction. To grow and sustain a diverse and qualified teacher workforce, we must ensure we are bringing as many candidates as possible into the profession. The amendments proposed today lay a foundation to streamline the pathway to teaching."

Building a continuum

The Department is committed to reshaping the teacher certification process by creating a continuum of educator development and support. This includes providing a supportive, responsive, and efficient certification process as well as mentoring, continuing education, and professional learning for teachers.

Under the proposed changes New York State-registered teacher preparation programs would be required to integrate a teacher performance assessment into a teacher candidate's student teaching or similar clinical experience. Through this multimeasure assessment, candidates would demonstrate their content knowledge and skill in teaching to the State learning standards in the grade band and subject area of certificate sought as well as the pedagogical knowledge and skills identified in the New York State Teaching Standards, which align with the four principles of the New York State Culturally Responsive-Sustaining Education Framework.

"Every student deserves a great teacher. The Board is committed to re-examining certification requirements to develop a more expedient approach to bring great teachers into our classrooms," Board of Regents Chancellor Lester W. Young, Jr. said. "As schools and districts across the state face a shortage of qualified teachers, we must do everything in our power to enhance the state's talent pipeline, including eliminating any financial barriers that may impede candidates from entering the teaching profession."

Background

Since May 2014, teacher candidates have been required to pass the edTPA to obtain most teacher certificates in New York State. The edTPA is a national teacher performance assessment where candidates demonstrate their readiness to teach. For the edTPA, candidates must pay \$300, plan for instruction and assessment, videotape themselves teaching and engaging students in learning, assess and analyze students' learning, and reflect on their practice. The Department has offered edTPA "safety nets" for candidates since the inception of the edTPA requirement, allowing eligible candidates to take and pass a different assessment instead of the edTPA to meet certification requirements.

During the COVID-19 pandemic, teacher preparation program faculty reported the

edTPA safety nets have been helpful and recommended that the edTPA be eliminated as a requirement for certification. They indicated the edTPA often becomes the primary focus for candidates during the student teaching experience, which detracts from other potential learning experiences and responsibilities. In addition, it is difficult for candidates to manage the multiple tasks and related logistics of the assessment (e.g., video recording) and it represents a significant out-of-pocket expense. Thus, according to these educators, the edTPA serves as a barrier to certification during this period of significant teacher shortages.

Next steps

Public comment on the proposal will be accepted through Feb. 28, 2022 via oheregcomments@nysed.gov(link sends e-mail). It is anticipated the proposed amendment will be presented to the Board of Regents for adoption at the April 2022 meeting.

Plug Power clears first hurdle with ZBA

Power cell company continues towards prop to build facility at Vista Tech Park

— Plug Power Inc. cleared its first hurdle towards establishing its proposed 350,000-square-foot facility at Vista Technology Park.

The Bethlehem Zoning Board of Appeals unanimously approved power cell producer's application for an area variance on Wednesday, Dec. 15, pushing the issue to the town Planning Board where it will hold a public hearing on Wednesday, Jan. 5, at 6 p.m.

ZBA members were first presented with the application because the proposed commercial



building did not meet with zoning laws pertaining to rear yard setback in a mixed economic development district.

The board approved the application without discussion, further allowing the Planning Board to be lead agency as the project goes through the state environmental quality review.

The Latham-based business proposes an expansive development named 125 Vista Boulevard that will encompass 26 acres at the end of the Vista Boulevard roundabout. The plan would triple the amount of development already witnessed at the tech park. Construction will include 50,000 square feet of offices, 85,000 square feet for manufacturing, 100,000 square feet for assembly and service, plus 115,000 square feet for storage.

Plug Power technology powers electric motors with hydrogen fuel cells. According to the company's website, it created the first commercially viable market for hydrogen fuel cell technology after it was founded in 1997. The company's GenKey technology powers forklifts for various customers, including Amazon, BMW, The Southern Company, Carrefour and Walmart.

According to several reports, the company's headquarters will remain on Albany Shaker Road in Latham.

According to Robert Leslie, Bethlehem's director of economic development and planning, the tech park's master plan approval previously included an Environmental Impact Statement that evaluated potential impacts and mitigation measures associated with approximately 1.4 million square feet of development. Nonetheless, the Planning Board will need to determine if the proposal conforms with that master plan.

To date, 107,500 square feet of office and commercial property have been developed at the park. Should plans proceed, Plug Power will be the first technology company since the tech park opened a decade ago. The park's courtship with Monolith Solar all but failed. The solar cell manufacturing company fell under financial hardship in 2018, but not before breaking ground on a new \$5 million headquarters at the tech park. Its steel skeleton and surrounding property were later foreclosed and are under the possession of Pioneer Bank.

Development of the project will require subdivision, site plan and variance approvals from both the Town of Bethlehem and Town of New Scotland.

New store for Xgates

Primark includes Crossgates in internat'l expansion plans

Primark, the international fashion retailer, is stepping up its expansion in the United States as it announced three new store locations in the New York — City Point in Brooklyn; Roosevelt Field in Garden City, Long Island; and Crossgates Mall in Albany.

Primark said it expects the prospective Crossgates Mall store will give it "a foothold in the dominant shopping mall in the State's Capital, Albany."

"Six years after we opened our first store in Boston, it's clear that U.S. customers – from Florida right up to Chicago – are loving the unique Primark offer," said Paul Marchant, Primark CEO. "The three new store locations in the New York region... are important new additions to our offer and the team is working hard to convert the sizeable growth potential we see in the market into more new Primark stores – and more loyal Primark customers.

"The future for Primark in the U.S. is looking very bright."

The retailer now has five new leases signed in New York, with its Jamaica Avenue store in Queens set to open next year and another in Green Acres, Nassau County. These are in addition to a new store lease in Tysons Corner, Washington, signed earlier in the year.

The new Brooklyn store in the recently constructed City Point complex will have frontage onto Fulton Street, giving Primark prime access to Brooklyn's principle retail high street. Meanwhile the Roosevelt Field location will position Primark in the pre-eminent mall serving Long Island.

The new leases continue the Irish headquartered retailer's steady U.S. expansion path since opening its first store in Boston six years ago. In the past financial year, almost a third of Primark's new store openings were in the U.S., including the most recent launch in September at Fashion District, Philadelphia, its 13th store in the country.

Looking ahead, Primark intends to accelerate the pace of expansion in the U.S. market, building on strong trading and a growing brand awareness. Over the next five years, Primark expects the U.S. store estate to grow to some 60 stores. The success of recent openings outside of its existing North-East footprint - in Sawgrass Mills, Florida and State Street, Chicago – has shown that Primark's unique formula of fashion and homewares at great value low prices is resonating more widely. The US business performed well in the past financial year, delivering like-for-like sales growth of 6 percent (excluding its downtown Boston store) on two years ago and a good profit margin.

Reflecting the step-up in the pace of expansion in the U.S., Primark has strengthened its leadership team with the appointment of a new President

to lead its U.S. Operations. Kevin Tulip, who most recently led Primark's Benelux business, will lead the retail operations in the US. Former President Andy Stewart, is taking on the new role of Director of Business Development for the US, working alongside the property team on the ground.

Primark sees further growth potential in all its existing markets. Building on the successful opening of 15 stores in the past financial year, it has 11 new store openings confirmed this year in Italy, Spain, Czech Republic, and Ireland alongside the Queens store.

SABIC moves lowcarbon tech forward

RIYADH, Saudi Arabia -SABIC has entered an agreement with the World Economic Forum and other global chemical sector companies targeted at formalizing the Low-Carbon Emitting Technologies initiative into a standalone entity by 2023.

In collaboration, LCET members will share early-stage risks and coinvest in developing and upscaling low-carbon-emitting technologies.

The project development company will be designed and developed by an inclusive stakeholder primacy collaboration between SABIC, Air Liquide, BASF, Clariant, Covestro, Dow, Mitsubishi Chemical Corp., Royal DSM, SIBUR, Solvay and World Economic Forum, and is supported by The Mission Possible Partnership.

The joint undertaking represents the LCET initiative's seminal transition from a knowledge sharing platform to the implementation vehicle as envisioned at its 2019 founding, and on course with its original mandate to accelerate greenhouse gas (GHG) reduction in the chemical production value chain. The Forum-hosted collaboration is designed to foster creative public/ private partnerships, partnerships

GLENMONT — Stuck in the weeds along the Hudson River lies a relic born out of the fiery collision of two coaldriven locomotives that blindly crashed, killing 14 people inside the Park Avenue tunnel in Manhattan in 1902. Steam locomotives had to be replaced within the city and new locomotives, powered with clean electricity, were designed, built and tested in the Capital District.. It was a monumental project to solve a massive environmental problem.

Fast forward 120 years. The Capital District is again innovating, gearing up to manufacture massive offshore wind turbines to replace fossil fuels as a major source of clean electricity for Gotham by 2035. The creation of 9,000 megawatts of power will come from the facilities built at the Ports of Albany and Coeymans.

The new project will have to wait, at least for a little bit, because of the one started a century ago. The construction of a new tower manufacturing plant cannot begin until four historic locomotives are moved from a cutoff and abandoned rail spur at the Port of Albany's property on River Road.

A group made up of rail historians, museums, enthusiasts, riggers and the owner of a Glenmont bus company are in a race against time to get the rusted pieces of history to the rail museum that owns them. The once fully-restored showpiece locomotives, that have sat abandoned while being abused by vandals and thieves for over 35 years, have to be moved for the wind plant to progress along the banks of the Hudson.

Why must they move? In order to stabilize

and strengthen the soil on the site, developers must lay piles of stone and allow it to compress the soil over four months. The locomotives are in the way of where these piles will lay, and will slow the process of development if they are not removed soon. The four locomotives weigh in excess of 1 million pounds, so moving them is no easy task, but all parties agree they need to be in a museum.

Four pieces of history.

The original S-1 prototype for the 1904 electric locomotive project and the only remaining T-motor electric locomotive sits at the head of the rail spur, followed by two retired diesel locomotives, an ALCO RS-2 and a GE U25B. While the diesels are old, they have less historic value.

The four engines have had many owners over the years, but currently the Railway Museum in Danbury, Connecticut holds the title to them.

"The S-1 was the space shuttle of 1904," Paul Marsh said. "The electric subways in New York City went into service starting in 1902, so everything before that was steam locomotives. The S was the first actual electric locomotive in the world."

Marsh, of Glenmont, has been working on moving the locomotives for over 30 years. He is the retired owner of Marsh Bus Company of Glenmont and is also a mechanic of all kinds of transportation equipment including buses and trains.

Removal to build

The locomotives currently rest on 80 acres of land owned by the Port of Albany. It is known as Beacon Island, located between the PSEG power plant on River Road and the mouth of the Normanskill in the Town of Bethlehem. The port is slated to begin the construction of four buildings on the island that will manufacture towers for off-shore wind farms off the coast of Long Island and New York City. The of the Port of Albany CEO Richard Hendrick, saaid in order to meet the goal of starting production by the fourth quarter of 2023, the locomotives have to move.

"Everything has to happen pretty quick," Hendrick said. "They're ready to move forward, we're just waiting for the town [of Bethlehem planning] board's [siteplan] approval."

The port will be working with Marmen-Welcon who will be making the wind towers and possibly the transition pieces that connect the foundation to the wind tower. Marmen and

Welcon joined together for this project with Marmen being the largest wind structure manufacturer in North America and Welcon being the world's largest manufacturer of offshore wind farms. A U.S. and Canadian company, Equinor, is also part of the project that manufactured structures for the first offshore wind farm in Scotland and also holds leases on two areas off the coast of Long Island.

What's the Plan?

One of the biggest challenges are the piles of toxic ash that covers Beacon Island. PSEG's Bethlehem Energy Center power plant next door was coal fired from 1952 to 1970 before switching fuel oil then to natural gas in 1981. The coal would come in by two rail lines, one from the CSX tracks and the other from the Port of Albany docks. The plant piled and stored the ash on Beacon Island and now project engineers have

come up with a design that leaves the ash undisturbed. By a process known as surcharging the ground, they can reduce risk of ash toxins leaching to the





surrounding property or the Hudson River.

"We're not really going to disturb any of that," Hendrick said. "Rather than run the risk of contaminating anything."

Surcharging is the process of laying aggregate, or big piles of stone, on the footprints of where the buildings will be. The aggregate will sit for four months, compressing the ash and soil underneath creating a stronger foundation.

How did they get there? The Mohawk and

Hudson Chapter of the National Historic Railway Society, based in Albany acquired all the locomotives over the years and stored them in various locations across the Capital District. Many of the local railroads, especially the Delaware and Hudson Railroad, provided facilities to store and restore the historic machines. The NHRS chapter displayed and showed the first

electric locomotive, the S-1, to teach people about the area's rich rail history and the deep impact it had worldwide.

"In the 1980s the S-1 was stored at the Altamont Fairgrounds inside a building and was on display for the public to see," said Richard Vanderbilt, president of Mohawk and Hudson Chapter of NRHS. "I used to sit in the conductor's seat and explain the history and function of the locomotive. It was a real showpiece and snapshot of history."

The chapter decided to move it from the fairgrounds when the D&H railroad planned to remove the switch from the spur in Altamont.

"The MHNHRS members did not want it stuck there so they moved it to the Colonie shop of the D&H in Watervliet," Marsh said. "That is where it met up with the T-3 motor. They have been together ever since. They were [maintained] at the Colonie shop and were still functioning at that time."

The second historic locomotive was from the second generation T-motor class, produced by the partnership of General Electric and American Locomotive Company in Schenectady in 1926. The T-3a, number 278, was last owned and used by Amtrak until 1987. It was an upgraded version of the original S-motor with more power and flexibility and the last one in existence, according to Vanderbuilt.

It was repainted, restored and stored in 1987 at the Colonie shops with other railroad equipment owned by the NHRS Chapter. The chapter members had access to a building that provided all the tools to maintain and repair the machines.

Then D&H filed for bankruptcy, and that was the beginning of the end of the ability for the chapter to use the facility.

"In 1984 Guilford Transportation Industries purchased the assets of DH including the Colonie shops. The NRHS members were able to continue to work on the historic trains there for a while," Vanderbilt said. "[Guildford] saw people breaking into the building and one time started a fire. They thought the liability was too great and evicted us and demolished the buildings."

The locomotives and five passenger cars had to move and found their way to the power plant on River Road, then owned by Niagara Mohawk. When the plant was sold to PSEG and upgrades began, the power company pushed the equipment onto the old spur that led to the port, on Beacon Island. They covered the tracks back to the plant when they built a state Department of **Continues on page 12**

Environmental Conservation-mandated wetlands remediation pond in 2003 and the bridge over the Normanskill to the port collapsed in the mid 2010's leaving the locomotives with no way out.

The Danbury Rail Museum acquired the locomotives from the Berkshire Scenic Railway in 2013 according to Stan Madyda, board member of the Danbury Railway Museum. Berkshire Scenic Railway accepted the locomotives as a donation from the NRHS chapter years earlier when the local chapter no longer wanted the liability of owning them.

After many failed attempts to remove the equipment from the site through negotiations with PSEG, the plans are coming together.

Hendrick hopes that the locomotives reach their new home within the next four to six weeks. During this time period, the port is also waiting for the Town of Bethlehem Planning Board's approval. At the latest, the team will be able to start in late February.

"There's gonna be a lot of work going on from day one to when we start shipping the towers," Hendrick said.

Once the locomotives are taken to the museum, all the remaining rail will be removed from the site. The original bridge on the site will also be removed and replaced with a road bridge. Hendrick,

MarmenWelcon and the rest of the team are anxious to start construction in the new year.

"The clock is ticking," he said. "It's up to the Danbury Railway Museum to successfully move them out of here and time is running on them."

The lowers

The hope is that MarmenWelcon will start producing by October of 2023. They'll shape the steel into the towers and then barge them to the offshore farm. In order to barge them from the port, part of the building plans included a lay down area, where finished products will go after manufacturing, and a wharf to transport them.

The actual plan to move

The locomotives will have to be disassembled, craned out and moved by truck to a place where they are reassembled on tracks. They cannot go by rail or truck, it has to be half and half.

They cannot be dragged on the rails, because no one knows if the wheels will turn. "They can't go completely by rail because the locomotives put on a flat car will be too tall to make it through a bridge in Pittsfield," Marsh said. "And the Danbury Museum is in the center of town and the only access with something that large is on rails. No trailers over 40 feet can make it through the downtown."

The team is waiting for RJ Corman Railroad Group, a national train service company with a location on Speeder Road in Selkirk, to finalize the plans and contract with PSEG to access the site. They will do the moving, with guidance from Marsh and the Danbury team.

According to Marsh, The idea is to truck the pieces on a flatbed to the Port of Albany where they will be checked to make sure the axles are structurally sound, because it has a train pit so they can see under the locomotive carriages. Then move it by truck to Berkshire Scenic Railway Museum in Lenox, Massachusetts and reassemble the locomotives and put them back on the tracks. They will then travel about 100 miles down the

Housatonic Railroad lines down to the museum in Danbury and they will be home.

Railroad owner, investor, enthusiast and historian Henry Posner III, the chairman of Railroad Development Corporation, has been involved with the quest of saving the locomotives for many years and agreed to fund the move.

"Henry Posner III has offered an unsecured loan to the museum to move the locomotives and he expects us to pay him back what we can," Madyda said. "He has been central to this effort and great to work with."

The Danbury museum has set up a dedicated fund to pay for the cost of the move and restoration. More information can be found at danburyrail.com.

"We will restore them to the way they were when they went to the New York Central Railroad," Madyda said. "Depending on what we can repair or replace, will be how far we can go. There is quite a bit missing, but we tried to take as many things as possible back to Danbury before people stole them."

Why are they so important to Danbury

The museum is at the end of the Danbury Branch of the Metro North Railroad, which acquired much of the routes of the New ork Central Railroad. It was New York Central that electrified the lines into Manhattan beginning 1903 after the horrific steam locomotive accident in the Park Avenue tunnel. The electric locomotives, like the ones going to Danbury, were the only ones used to pull trains to Grand Central Terminal after the state Legislature's ban on steam locomotives within Manhattan went into effect in 1908.

"These locomotives show the modes of transportation to New York City," Madyda said. "We will have all the locomotives that show the progression of technology that people used to commute into New York City."

Delmar man remembered as educator, author, fighter for social change

Dr. Maurice Thornton died at age 90

DELMAR — Dr. Maurice Thornton, educator, author and a steadfast fighter for social change, died on Tuesday, Dec. 14, at age 90.

Thornton earned a high school education in his hometown of Birmingham, Alabama at A.H. Parker High School, the largest of such schools for African Americans in the world, before ultimately obtaining his doctorate in secondary education. Both its historical distinction and social significance was never lost on him.

Thonton engaged in the Civil Rights movement of the 1960s. In August 1963, he joined more than 200,000 people in the March on Washington. It was a struggle he dedicated himself to through the years.

Thornton and his family moved to the Capital District in 1982 to take the position of Director of Affirmative Action for the State University of New York System. He had previously held a similar position at Cuyahoga Community College, where it is believed he was the first person to hold the title of Affirmative Action Officer at any college or university.

An avid learner with a penchant for reading about history, Thornton joined the efforts of the Albany 369th in obtaining the Medal of Honor for Sgt. Henry Johnson. Later, after returning home to Alabama to attend his brotherin-law's funeral, he was inspired to research his own family history.

In 2019, Thornton wrote "The Thornton Family," illustrating his family's history through generations that stretched from the west coast of Africa, to Europe and America. His

book tackled the significant periods of time marked by Great Depression, racial segregation, World War II and more. That story was captured in a feature published in *The Spotlight* that year.

When asked why he felt it was important to find out and write about where his family originated from, Maurice brought up parts of a supposed quote by classical Greek philosopher Socrates.

"Unless you know yourself, you really are not living in the world. You have to know yourself and in order to know yourself, you have to know as much about yourself because you're not just yourself. You also are your ancestors all put together and that helps to make yourself."

Dr. Maurice Thornton was born in Birmingham, Alabama on Dec. 31, 1930, to the union of Alberta Jones Thornton and William Lee Thornton. He confessed Christ at an early age and joined Bethel Baptist Church in Collegeville. He attended Hudson Elementary School and the historical A.H. Parker High School. While there he demonstrated an early interest in American and World History. He finished first in a statewide World and American History Achievement Test and was awarded a plaque for his achievement at Alabama State University. Maurice attended Alabama State University and graduated in 1952 with a major in Secondary

Education. While a student, he worked in the Graduate Office and was initiated in the Omega Psi Phi Fraternity, Inc.

He was drafted into the Armed Forces during the Korean War and for two years served in the Medical Corps at Fort Jackson, SC. He was honorably discharged as an NCO.

Maurice then attended Case Western Reserve, and School of Social Science in Cleveland, Ohio. He interned at Cuyahoga County Welfare Department and was recruited to work as a Social Worker at that Agency. Maurice became head of The Neighborhood Youth Corps. He served as Director of Personnel at the Agency. He was then recruited by Cuyahoga Community College to assume the position of Affirmative Action Officer. He was the first person to hold that position in a College or University. Struggle.

Dr. Thornton made time in his busy schedule to engage in Civil Rights activities. He was a participant at the "Historic March on Washington, DC" in August 1963. While there he reconnected with the Reverend Fred Shuttlesworth and others from the Birmingham Civil Rights Struggle (youtube. com 50th Anniversary of the March on Washington).

As a "Lifelong Learner," Maurice earned an MA at Cleveland State University in Education (1973) and a Ph. D.in education at Nova University, Fort Lauderdale, Florida (1981).

In 1982, he came to Albany, New York to become the Director of Affirmative Action for the State University of New York (SUNY) System which encompasses 64 campuses. He retired in 1998 and became Adjunct Professor in African Studies for ten years at University at Albany, SUNY, and lectured at Hudson Valley Community College in African American History, African American Family and The History of the Civil Rights Movement. In 2010, he retired from Hudson Valley Community College.

His passions and activities include family historian, writer, publisher of The Thornton Family legacy Book.


Maurice was a charter member of and Grapter for the Albany chapter of Beta Psi Boule, Founding member of Albany chapter of 100 Black Men, Lifetime member and a vice president of the 369th Veterans Assoc. Life member of Omega Psi Phi Fraternity, Inc., Elder at Westminster Presbyterian Church, Board member of New York State Department of Health Data Protection Review and Capital District Council of Churches, and a public speaker and Book Reviewer for Albany Public Library.

His significant achievements include being the first person to ever hold a full-time position at a college or university in Equal Opportunity in America and many citations and awards in education and public services.

Maurice, along with the Albany 369th, were instrumental in obtaining the Medal of Honor for Sgt. Henry Johnson posthumously for his heroic acts in World War I and erecting a statute honoring Henry Johnson in the city of Albany. In 2015, Dr. Thornton was honored by Congressman Paul Tonko for his contributions in helping Sgt. Johnson to receive the Medal of Honor. Maurice was also proud to attend the State of the Union Address of President Barack Obama and was in attendance at the White House when President Obama presented the Medal of Honor to Sgt. Henry Johnson's family.

Maurice is survived by his wife of 61 years, Elizabeth "Betty", two daughters, Karen Elaine Thornton, MD of New York City and Susan Eileen Thornton-Smith, Yonkers, New York and one son, Christopher

William Maurice Thornton, Delmar, New York; two grandsons, John Edward Smith II, Yonkers, New York, and Christopher Juan Thornton-Lopez, Concord, NH; sisters Alberta T. Kimbrough, Chicago, IL, Dr. Emma T. Shepard, Birmingham, AL, and Estelle T. Lavender, Lithonia, GA. He is preceded in death by his parents, and brothers, William Cullen Thornton and Charles Edward Thornton.

I am writing to voice opposition to the proposed affordable housing project in Selkirk which was recently granted a waiver to the town building moratorium. The Bethlehem Town Board saw fit to violate it's own building moratorium with a 4-1 vote in favor of granting a waiver to the moratorium, with Mr. Foster voting against granting the waiver. Then during the same session, the same board voted to extend the very same building moratorium for another six months....a rather dichotomous decision to say the least. Give an out of state developer a pass to the moratorium but not local

The current proposed site on a parcel between 9W and Jericho has no access to public transportation and no sidewalks. Pedestrian traffic along 9W is perilous to say the least. The strain that would be placed on the RCS school district would be overwhelming to an already overburdened faculty and staff due to the disproportionately higher than average population of special need students that are bused in from outside districts.

According to available data, the Bethlehem Central School District has an economically disadvantaged student population of 14.7 percent grades 3-8 compared

population for RCS grades 3-8. The same source also sites that the students with disabilities population is 25 percent higher at RCS than it is at BCSD.

Perhaps the town should consider giving economically disadvantaged students and students with disabilities access to the BCSD considering the dramatic disparity between the two school districts. It has been rumored that the town is being pressured by NYS to establish affordable housing within the town. If this is in fact true, then perhaps the town should consider other hamlets and school districts that could better support the needs of such a project.

According to U.S. News & World Reports, the BCSD has 54.3 percent of their graduating seniors "college ready" as opposed to just 12.7 percentfor **RCS**. Proficiency scores are 96 for math and 99 for English at BSCD as opposed to 68 and 81 respectively at RCS.

These numbers are in no way a slight against the dedicated, overworked faculty and staff at RCS district, but there are already glaring differences between the two districts, and it does not appear that the Town Board has taken this into consideration by any metric.

Advocates for affordable housing want to live in an affordable home, with access to jobs, schools

themselves and their children. Clearly, this proposal as well as the Town Board's support of it does not meet any of those desires.



Playin' With Fire loses its Rockstar

Guitarist Stephen 'Lefty'Wright died unexpectedly at 66

ELSMERE — Lefty played guitar. And he did so much more.

Stephen R. Wright, volunteer firefighter and local rock star, died on Monday, Dec. 13 at the age of 66.

A 46-year member of the Elsmere Fire Company, Wright was as visible as any one person could be without running for elected office. Within that fraternal order, he served several posts with the Red Knights, Fireman's Association of the State of New York and the state Association of Fire Chiefs. He chaired the Albany County Volunteer Fire Recruitment and Retention Committee. he has served as the chairman for the Hudson-Mohawk Volunteer Firefighters Association and Albany County Volunteer Fireman's Association conventions.

Wright was twice awarded Firefighter of the Year by the fire company; first in 2017 and again in 2020. He was honored in 2002 for his support in the 9/11 World Trade Center Response. Since joining the company in 1979, he had served as Property Clerk, Director, Vice-President, President and Fire Police Lieutenant. He became an active "life" member in 2000 after achieving 25 years of active service. Most recently, he was elected both President-Elect and Fire Police Lieutenant just four days before he died.

"It is deepest regret and sincerest condolences to his family that we announce

the passing of fire police member Stephen R. Wright," wrote members of the Elsmere Fire Company in an online statement. "Needless to say, Steve's hard work and enthusiasm will be sorely missed far beyond the Elsmere Fire Company Family. Our condolences to his family, including sons, son-in-law, and grandson who all carry on his proud tradition in the fire service."

Wright's love for his service melded in with his lifelong passion for music when he founding his band Playin' With Fire. For 15 years, he'd be on stage while playing his electric guitar. Through the years, the band earned accolades for being among the best within a local scene known well for exemplary music. Last month, he was in attendance at The 2021 Capital Region Thomas Edison Awards where bandmate Kim Cirillio Wickham was nominated for Songwriter of the Year.

"I don't even know what to say. I miss you already," Wickham stated as she began her online tribute. Her friendship with Wright started when she was 7 years old and developed more as she started singing in the band. "You'd send me lyrics via text and I'd reply back with a lyric to you. That's how some of our

songs were written. I have so many lyrics in my email that you have sent me over the years.

"You were not done!" Wickham and her family vacationed and spent holidays together with Wright over the years. She described him as kind hearted, passionate and compassionate.

"You always took the high road in everything you did," she stated. "You had the most amazing soft heart of anyone I've ever known."

Stephen R. Wright, 66 of Elsmere, N.Y. passed away unexpectedly on December 13, 2021.

His friends knew him by many names such as Big Daddy, Stevie, Lefty and Rock Star. He was born in Albany, NY to the late William Wright and Rosemary Blodgett (Pittz).

He was an appliance technician for 25 years

with RCA/Whirlpool and General Electric where he developed long lasting friendships.

Steve was a life member of the Elsmere Fire Company and the current President-Elect and Fire Police Lieutenant where he has served the community of Bethlehem for the past 46 years. He has been awarded Firefighter of the Year twice along with many other accolades. Through his many years of community service, he has served as the chairman for the Hudson-Mohawk Volunteer Firefighters Association and Albany County Volunteer Fireman's Association conventions respectively. He chaired the Albany County Volunteer Fire Recruitment and Retention Committee and was also tapped by the Town of Bethlehem where he successfully chaired the town's Bicentennial

Celebration.

Lefty was recently elected to the position of Vice President of the Red Knights, NY III motorcycle club of Albany, NY where he has been a member for the past 12 years. He also served as a Road Captain, riding in tandem with his RKMC family.

Passionate about music from childhood, Steve was a founding member of Playin' With Fire Band. They have been playing the Capital Region for 15 years and were voted one of the Capitol Region's Top 5 Best Local bands two years in a row by the Times Union Best Of. The band recently attended the Regional Eddie Awards after being nominated for songwriting. Steve will be remembered as a prolific songwriter, amazing rhythm guitarist, vocalist, and recording artist. He was the bands

driving force both in concerts and the studio.

Steve will be forever missed by all and is survived by; his wife of 43 years, Elaine Wright (Bidwell); his father Ronald Blodgett; his children Kristopher Wright (Sarah), Stephanie Moon (Michael), and Michael Wright; grandchildren, Trever, Kylianna, Cameron, Sydney, and Lucy; his brother David Wright and sister Rhonda Farley; many nieces, nephews, and extended family; and his constant K9 companions Bernie and Jeter.

Visitation was on Tuesday, Dec. 21 at Applebee Funeral Home in Delmar. A firefighter procession from the funeral home to the Elsmere Fire House followed the visitation with a short ceremony and reception.

Odds favor a white Christmas this year

Meterologists see weather pattern known to usher snow to the Northeast

STATE COLLEGE, Penn

— According to AccuWeather Global Weather Center, a climate pattern well-known for bringing precipitation to the northern tier of the country may tip the scales on which areas get a white Christmas or just a handful of flurries - if that - this year.

To forecast what kind of weather the different regions of the U.S. will have a month out from the big day, AccuWeather's team of long-range forecasters, led by Senior Meteorologist Paul Pastelok, looked to key patterns that could favor snow in time for the holidays this winter.

La Niña, a phase in which sea surface temperatures in the equatorial Pacific Ocean drop to lower-than-average levels for an extended period of time, was one such pattern that played a major role in drawing the map. The big thing to know about La Niña is that it tends to steer storms





northward, cutting the southern portion of the U.S. off from moisture.

With the La Niña phase in place, areas across the Northwest, upper Plains and interior Northeast will have a higher probability than average of having a white Christmas. "We're actually kind of in that normal zone for [the Northeast] just in case we get one of these sneaky, late-December systems coming in there," Pastelok said. "But I do feel like the probability of a white Christmas in Boston, New York, D.C. and Baltimore is slightly lower" this year. AccuWeather, recognized and documented as the most accurate source of weather forecasts and warnings in the world, has saved tens of thousands of lives, prevented hundreds of thousands of injuries and tens of billions of dollars in property damage.




thletes know that energy is vital to their training and performance. But every athlete experiences days or periods when energy levels wane. Lack of energy can compromise performance and derail individuals' fitness goals, especially if they can't find ways to increase their stamina.

Individuals can try various strategies to improve their stamina. 

Competing Currents: 20th-Century Japanese Prints - Japan's printmaking landscape underwent an unprecedented tidal shift in the twentieth century. During the Edo period (1603–1867) a new market of middle-class patrons had encouraged artists to create expressive and iconic images for mass distribution.

These prints, known as ukiyo-e (pictures of the floating world), became wildly popular not only in Japan but across the globe when the country opened to international trade in the mid-nineteenth century.

By the beginning of the twentieth century, however, woodblock prints had largely fallen out of vogue. Mass-market newspapers and magazines had taken Japan by storm, and the popular woodblock prints of the previous century seemed to many a relic of the past. Open: Now - January 30, 2022.

Anne Thompson-Trail Signs -Thompson has long explored the shifting meaning of signs and symbols in relation to their social setting, whether making paintings, prints, or outdoor projections. At the beginning of the COVID-19 pandemic, she began designing posters featuring bold, black-and-white symbols and installing them on trail kiosks throughout Berkshire County. This unsanctioned project sought to engage and complicate public messaging at a time when people increasingly ventured into and sought meaning in the outdoors.

Through photographic manipulations of sculptures found in books, and ones of her own making, Shirreff asks what is left of the original experience of an artwork once it has entered the historical record, and what traces of an artist's labor might still be legible after the fact. eople who avoid gluten for health reasons may feel left out when the bevy of desserts is distributed during home visits or office holiday parties, as they probably cannot indulge in these sweet treats. This recipe for "Mint Slims" from Danielle Walker's "Eat What You Love" (Ten Speed Press) ensures that even those who have gone gluten-free can enjoy some holiday sweets.

Mint Slims

INGREDIENTS: Makes 25

- 2 cups blanched almond flour
- 2 tablespoons coconut flour
- 1/2 cup unsweetened cocoa powder
- 1/2 teaspoon baking soda
- 1/4 teaspoon fine sea salt
- 1/4 cup maple sugar
- 1/4 cup light-colored raw honey
- 1/4 cup expeller-pressed coconut oil
- *2* ounces unsweetened chocolate, chopped
- 1/2 teaspoon pure peppermint extract

Coating

- 10 ounces dairy-free and soy-free semisweet chocolate chips
- 3/4 teaspoon expeller–pressed coconut oil
- 1/4 teaspoon pure peppermint extract

INSTRUCTIONS

In the bowl of a stand mixer fitted with the beater attachment, or using a food processor, combine the almond flour, coconut flour, cocoa powder, baking soda, salt, and maple sugar and mix thoroughly on medium speed. In a saucepan, combine the honey, coconut oil, chocolate, and peppermint extract and cook over low heat, stirring until melted. Pour the melted chocolate mixture into the dry ingredients and beat on medium speed until fully combined.

Using your hands, pack the dough firmly into two balls, then flatten each into a thick disk. Roll each disk into a 1/4-inch-thick circle on a piece of parchment paper. Stack the pieces (with parchment paper in between) on a baking sheet and refrigerate for at least 1 hour, or up to 2 days. (If chilling for more than 2 hours, cover the top piece of dough with another piece of parchment paper.)

When you're ready to bake the cookies, preheat the oven to 350 F and line two or three baking sheets with parchment paper or silicone baking mats. Remove one of the dough pieces from the refrigerator. Use a 2-inchround cookie cutter to cut out circles and place them on a prepared baking sheet. Repeat with the remaining dough, rerolling and cutting circles until all the dough is used.

Bake one sheet at a time for 8 minutes, rotating the sheet halfway through baking. Cool the cookies on the sheets for 5 minutes, then transfer them to a wire rack to cool completely. To make the coating, melt the chocolate chips and oil together in a double boiler or a heatproof bowl set over a saucepan filled with about 1 inch of boiling water. Stir the mixture frequently until the chocolate melts. Stir the peppermint extract into the melted chocolate. Turn off the heat and remove the bowl from the pan.

Dip each cookie completely into the melted chocolate and use a fork to lift it out. Tap the fork gently on the side of the bowl to allow any excess chocolate to drip off. Place the dipped cookies on the prepared baking sheets, then refrigerate the cookies for 1 hour to help the chocolate set. Serve chilled.

On Dec. 8, the museum opened its doors for an event that featured Albany City Historian Tony Opalka where he invited visitors to take a trip back 240 years to the start of the volunteer firefighter period in Albany and work their way back to the present day. It also featured a unique type of auction that included parts of a historic Albany fire truck, to raise money for the facility.

History never heard

The event was one of the first public events for the museum since the pandemic. However Tobler believes that the pandemic

helped the museum gain more information about individual firemen who served on the Albany Fire Department. In the few times that the museum was open to the public this year, visitors from as far away as Arizona and Los Angeles told stories of distant relatives who served.

"There's not too much literature written by the guys themselves,"Tobler said. "It's a hit and miss."

A lot of the physical history, like reports or stories, no longer exist or are proving to be hard to find. The reports filed by the department were destroyed in a fire at Albany City Hall in the 1800s. Historians have





no way to tell how many reports burned with the building.

However, Tobler and other active or retired firefighters did catch a bit of luck. The team found a ledger dating back to 1801 that listed every Albany fire company in service until 1867. 10,000 individual firefighters who served during that time are listed.

"We're trying to explore the individual firefighters," Tobler said. "We find a little information on a person and try to develop that as far as we can."

The museum fundraised in a unique way at the event, by auctioning off parts from the 1986 American LaFrance fire truck, Albany Engine No. 1. It is a historic truck because it was the first one manufactured by the company in its Century 2000 series. The museum wanted to preserve as much of the engine as possible and figured that an auction would be the best way to raise money to do so. "We're going to restore

the museum team were pleasantly surprised with the turnout of Wednesday's event. Many in attendance were firefighters; some retired, some active with a mix of both volunteer and paid service. Others in attendance were police officers, fire history buffs and families.

"We had more people in attendance than expected because we had to set out additional chairs," Tobler said.

The goal of the night was ultimately to raise money to continue the museum's work of figuring out the past. In total, the museum raised about \$1,000 from the event. Much of that money came from the silent auction. Four pieces were sold off Albany Engine No. 1, the most expensive, a pump panel, sold for \$310.

"The pump panel was sold to a retired Albany firefighter," Tobler said. "They served as a pump operator on this pumper in the 1980's and 1990's at many fires."

The night seemed like a success to Tobler and the museum team with them looking hopeful to the future. The fundraiser ultimately reminded the team of the importance and significance in retelling the history of fire service in the capital district.

The Inception

In 2014, Tobler and other retired and active firefighters thought there should be a firefighters museum. Tobler jokes that they were completely unaware what they were walking into. He says there is a real passion for this museum, not just for Albany, but the entire capital region. In the early days of the museum, the team realized that local firefighting history went further back than they thought.

"Our biggest find was Tony Opalka, who's now our museum director," Tobler said. "He's our heavy hitter."

With Opalka's help the team were able to find artifacts like the ledger and access to the common council minutes that weren't destroyed in the Albany City Hall fire. The minutes were saved because of the multiple editions made that weren't kept with the reports. There still isn't a lot of information to get from the minutes, so the team also relies on the newspapers from the time and visitor stories.

There have been other big finds that the museum found themselves or been given. One of those finds is the records of about 20 men who transferred from volunteer companies to the paid department. Out of the 20 firefighters, five were killed in the line of duty by 1890.

"We feel like there's a brotherhood between that group that we can't just totally dismiss," Tobler said.

A unique and important artifact to the museum is a 18 karat solid gold badge with a diamond inlay and other jewels. The badge was donated by a retired Albany firefighter and is originally from the 1890's. A lot of the physical history, like reports or stories, no longer exist. ... There are many artifacts and interesting stories that go along with them on display at the museum.

Tobler hopes that the event made people aware of the museum's existence, but also that someone comes in with stories, information or documentation about a distant relative that served with the department.

"We think, in some ways, their stories should be told,"Tobler said.

The men of the Albany Fire Department from 1773 to now have contributed to the growth of America. Their contributions should be seen and Albany Firefighters Museum is fighting to make that happen.

The McKrells usher in the Holidays with a Christmas Show at The Egg

ALBANY — It isn't Christmas in Nippertown until you've attended the McKrell's Christmas Show, or at least that's what Jim [Gilbert] told me before we headed out in a freezing rain storm to catch the Irish/bluegrass concert at The Egg on Saturday, Dec. 18.

Full disclosure: I love bluegrass, and I'm pretty in love with Irish music. And as most of you know, Christmas is my jam; there isn't a holiday tune I won't sing. But I wasn't sure what to make of a Christmas show with Jim who is, well, a bit Scrooge-y about the holidays. We tend to avoid these as they are a bit predictable, sappy, and sometimes repetitive. But Jim seemed super excited, so I donned my overalls and was ready for a fun time.

The McKrell's Christmas Show has been a tradition in Nippertown since it first was included in Mountain Snow and

Mistletoe Orchestra, and this year Kevin McKrell continued beloved traditions while adding in some crowd requests.

McKrell entered the Swyer Theatre stage promptly at 8 p.m., accompanied by some of the most celebrated local musicians in the genre. Brian Melick's infectious smile couldn't be missed behind the drum set, and Arlin Greene's understated bass was a constant throughout the set. With Frank Orsini on fiddle, one of the most prominent acoustic musicians in the upstate area, the crowd was prepared for a huge treat. Scott Hopkins on banjo and Peter Pashoukas on guitar rounded out the talent, promising an exceptional night of bluegrass.

And they didn't disappoint. McKrell started off the night by singing "Santa Clause is Coming to Town," but he only started each verse, encouraging the audience along until the theatre was filled with amateur voices. It was an unusual but fitting start to a holiday concert, pulling on the audience like family members at a holiday party to belt out easy carols. Everyone loves to sing a Christmas song, and these fans were no exception. They only needed minimal encouragement from McKrell to sing through their masks the familiar words.

From there, The McKrells made no time in shifting gears. The band launched into a unique "Drummer Boy" that highlighted Melick on the udu. The sound was unique and yet strikingly pleasing as the band worked around the pitches produced. They followed with "Silent Night" before launching into some bluegrass Christmas favorites.

McKrell is an entertainer, capable of telling a good story and holding the audience mesmerized even with familiar tales from holiday past. His clear enjoyment of the season was punctuated by laughter with bandmates, inside jokes, and humble self-mockery. He

apologized for mistakes he made, noting "The difference between Irish music and Bluegrass is the number of chords. The Irish look at this song and think we don't need half these chords, while the bluegrass musicians want to add more in!"

Hopkins jumped on tuba for a fun rendition of "Mr. Grinch," including adding his young son Carter to the stage on melodica and Greene using his classic bass voice at the front of the stage. McKrell's adult daughter Katie joined her father to sing "I Want a Hippopotamus for Christmas," a tune her father admitted he first sang with her as a young one.

The magical moments came, however, not in these popular Christmas tunes, but when the band launched into John Prine covers and took requests from the crowd. McKrell's "Danny Boy" was achingly tender and sounded perfect in The Egg; his voice, guitar playing, and expression were quite moving.

The band swung back to the holiday theme with a zany reading of "Twas The Night Before Christmas," with Melick performing the sound effects for the poem that was first published in the Sentinel, the local newspaper of Troy, NY in 1823. From there, the group crescendoed into the night, moving through "Auld Lang Syne" into a technically intricate "Lady on the Mountain."

Hopkins and Pashoukas dueled a bit toward the end with solos, and that was heartstopping. The younger musicians' work was met by wide eyes from Greene who looked authentically impressed.

McKrell led the audience in singing "All of the Hard Days are Gone" during the encore, and as band members left, McKrell left the audience alone singing the song. "It's all beer and whisky, and songs from now on," the audience members crooned as McKrell left the stage, throwing out a peace sign.

And just like that, it is Christmas in Nippertown, courtesy of The McKrells Christmas Show. If you missed it, it is completely worth catching at their engagements this week in Saratoga's Parting Glass Pub. Kevin McKrell leaves you with a shot of hope and laughter as he reminds you that Christmas comes this time every year – and is worth an embrace.



GLENMONT — Stuck in the weeds along the Hudson River lies a relic born out of the fiery collision of two coaldriven locomotives that blindly crashed, killing 14 people inside the Park Avenue tunnel in Manhattan in 1902. Steam locomotives had to be replaced within the city and new locomotives, powered with clean electricity, were designed, built and tested in the Capital District.. It was a monumental project to solve a massive environmental problem.

Fast forward 120 years. The Capital District is again innovating, gearing up to manufacture massive offshore wind turbines to replace fossil fuels as a major source of clean electricity for Gotham by 2035. The creation of 9,000 megawatts of power will come from the facilities built at the Ports of Albany and Coeymans.

The new project will have to wait, at least for a little bit, because of the one started a century ago. The construction of a new tower manufacturing plant cannot begin until four historic locomotives are moved from a cutoff and abandoned rail spur at the Port of Albany's property on River Road.

A group made up of rail historians, museums, enthusiasts, riggers and the owner of a Glenmont bus company are in a race against time to get the rusted pieces of history to the rail museum that owns them. The once fully-restored showpiece locomotives, that have sat abandoned while being abused by vandals and thieves for over 35 years, have to be moved for the wind plant to progress along the banks of the Hudson.

Why must they move? In order to stabilize

and strengthen the soil on the site, developers must lay piles of stone and allow it to compress the soil over four months. The locomotives are in the way of where these piles will lay, and will slow the process of development if they are not removed soon. The four locomotives weigh in excess of 1 million pounds, so moving them is no easy task, but all parties agree they need to be in a museum.

Four pieces of history.

The original S-1 prototype for the 1904 electric locomotive project and the only remaining T-motor electric locomotive sits at the head of the rail spur, followed by two retired diesel locomotives, an ALCO RS-2 and a GE U25B. While the diesels are old, they have less historic value.

The four engines have had many owners over the years, but currently the Railway Museum in Danbury, Connecticut holds the title to them.

"The S-1 was the space shuttle of 1904," Paul Marsh said. "The electric subways in New York City went into service starting in 1902, so everything before that was steam locomotives. The S was the first actual electric locomotive in the world."

Marsh, of Glenmont, has been working on moving the locomotives for over 30 years. He is the retired owner of Marsh Bus Company of Glenmont and is also a mechanic of all kinds of transportation equipment including buses and trains.

Removal to build

The locomotives currently rest on 80 acres of land owned by the Port of Albany. It is known as Beacon Island, located between the PSEG power plant on River Road and the mouth of the Normanskill in the Town of Bethlehem. The port is slated to begin the construction of four buildings on the island that will manufacture towers for off-shore wind farms off the coast of Long Island and New York City. The of the Port of Albany CEO Richard Hendrick, saaid in order to meet the goal of starting production by the fourth quarter of 2023, the locomotives have to move.

"Everything has to happen pretty quick," Hendrick said. "They're ready to move forward, we're just waiting for the town [of Bethlehem planning] board's [siteplan] approval."

The port will be working with Marmen-Welcon who will be making the wind towers and possibly the transition pieces that connect the foundation to the wind tower. Marmen and

Welcon joined together for this project with Marmen being the largest wind structure manufacturer in North America and Welcon being the world's largest manufacturer of offshore wind farms. A U.S. and Canadian company, Equinor, is also part of the project that manufactured structures for the first offshore wind farm in Scotland and also holds leases on two areas off the coast of Long Island.

What's the Plan?

One of the biggest challenges are the piles of toxic ash that covers Beacon Island. PSEG's Bethlehem Energy Center power plant next door was coal fired from 1952 to 1970 before switching fuel oil then to natural gas in 1981. The coal would come in by two rail lines, one from the CSX tracks and the other from the Port of Albany docks. The plant piled and stored the ash on Beacon Island and now project engineers have

come up with a design that leaves the ash undisturbed. By a process known as surcharging the ground, they can reduce risk of ash toxins leaching to the





surrounding property or the Hudson River.

"We're not really going to disturb any of that," Hendrick said. "Rather than run the risk of contaminating anything."

Surcharging is the process of laying aggregate, or big piles of stone, on the footprints of where the buildings will be. The aggregate will sit for four months, compressing the ash and soil underneath creating a stronger foundation.

How did they get there? The Mohawk and

Hudson Chapter of the National Historic Railway Society, based in Albany acquired all the locomotives over the years and stored them in various locations across the Capital District. Many of the local railroads, especially the Delaware and Hudson Railroad, provided facilities to store and restore the historic machines. The NHRS chapter displayed and showed the first

electric locomotive, the S-1, to teach people about the area's rich rail history and the deep impact it had worldwide.

"In the 1980s the S-1 was stored at the Altamont Fairgrounds inside a building and was on display for the public to see," said Richard Vanderbilt, president of Mohawk and Hudson Chapter of NRHS. "I used to sit in the conductor's seat and explain the history and function of the locomotive. It was a real showpiece and snapshot of history."

The chapter decided to move it from the fairgrounds when the D&H railroad planned to remove the switch from the spur in Altamont.

"The MHNHRS members did not want it stuck there so they moved it to the Colonie shop of the D&H in Watervliet," Marsh said. "That is where it met up with the T-3 motor. They have been together ever since. They were [maintained] at the Colonie shop and were still functioning at that time."

The second historic locomotive was from the second generation T-motor class, produced by the partnership of General Electric and American Locomotive Company in Schenectady in 1926. The T-3a, number 278, was last owned and used by Amtrak until 1987. It was an upgraded version of the original S-motor with more power and flexibility and the last one in existence, according to Vanderbuilt.

It was repainted, restored and stored in 1987 at the Colonie shops with other railroad equipment owned by the NHRS Chapter. The chapter members had access to a building that provided all the tools to maintain and repair the machines.

Then D&H filed for bankruptcy, and that was the beginning of the end of the ability for the chapter to use the facility.

"In 1984 Guilford Transportation Industries purchased the assets of DH including the Colonie shops. The NRHS members were able to continue to work on the historic trains there for a while," Vanderbilt said. "[Guildford] saw people breaking into the building and one time started a fire. They thought the liability was too great and evicted us and demolished the buildings."

The locomotives and five passenger cars had to move and found their way to the power plant on River Road, then owned by Niagara Mohawk. When the plant was sold to PSEG and upgrades began, the power company pushed the equipment onto the old spur that led to the port, on Beacon Island. They covered the tracks back to the plant when they built a state Department of **Continues on page 12**

Environmental Conservation-mandated wetlands remediation pond in 2003 and the bridge over the Normanskill to the port collapsed in the mid 2010's leaving the locomotives with no way out.

The Danbury Rail Museum acquired the locomotives from the Berkshire Scenic Railway in 2013 according to Stan Madyda, board member of the Danbury Railway Museum. Berkshire Scenic Railway accepted the locomotives as a donation from the NRHS chapter years earlier when the local chapter no longer wanted the liability of owning them.

After many failed attempts to remove the equipment from the site through negotiations with PSEG, the plans are coming together.

Hendrick hopes that the locomotives reach their new home within the next four to six weeks. During this time period, the port is also waiting for the Town of Bethlehem Planning Board's approval. At the latest, the team will be able to start in late February.

"There's gonna be a lot of work going on from day one to when we start shipping the towers," Hendrick said.

Once the locomotives are taken to the museum, all the remaining rail will be removed from the site. The original bridge on the site will also be removed and replaced with a road bridge. Hendrick,

MarmenWelcon and the rest of the team are anxious to start construction in the new year.

"The clock is ticking," he said. "It's up to the Danbury Railway Museum to successfully move them out of here and time is running on them."

The lowers

The hope is that MarmenWelcon will start producing by October of 2023. They'll shape the steel into the towers and then barge them to the offshore farm. In order to barge them from the port, part of the building plans included a lay down area, where finished products will go after manufacturing, and a wharf to transport them.

The finished towers will be shipped from the port horizontally on the barge as it moves through the Hudson River.

"Our business is shipping," Hendrick said. "We handle GE power systems, it's basically the same thing."

The actual plan to move

The locomotives will have to be disassembled, craned out and moved by truck to a place where they are reassembled on tracks. They cannot go by rail or truck, it has to be half and half.

They cannot be dragged on the rails, because no one knows if the wheels will turn. "They can't go completely by rail because the locomotives put on a flat car will be too tall to make it through a bridge in Pittsfield," Marsh said. "And the Danbury Museum is in the center of town and the only access with something that large is on rails. No trailers over 40 feet can make it through the downtown."

The team is waiting for RJ Corman Railroad Group, a national train service company with a location on Speeder Road in Selkirk, to finalize the plans and contract with PSEG to access the site. They will do the moving, with guidance from Marsh and the Danbury team.

According to Marsh, The idea is to truck the pieces on a flatbed to the Port of Albany where they will be checked to make sure the axles are structurally sound, because it has a train pit so they can see under the locomotive carriages. Then move it by truck to Berkshire Scenic Railway Museum in Lenox, Massachusetts and reassemble the locomotives and put them back on the tracks. They will then travel about 100 miles down the

Housatonic Railroad lines down to the museum in Danbury and they will be home.

Railroad owner, investor, enthusiast and historian Henry Posner III, the chairman of Railroad Development Corporation, has been involved with the quest of saving the locomotives for many years and agreed to fund the move.

"Henry Posner III has offered an unsecured loan to the museum to move the locomotives and he expects us to pay him back what we can," Madyda said. "He has been central to this effort and great to work with."

The Danbury museum has set up a dedicated fund to pay for the cost of the move and restoration. More information can be found at danburyrail.com.

"We will restore them to the way they were when they went to the New York Central Railroad," Madyda said. "Depending on what we can repair or replace, will be how far we can go. There is quite a bit missing, but we tried to take as many things as possible back to Danbury before people stole them."

Why are they so important to Danbury

The museum is at the end of the Danbury Branch of the Metro North Railroad, which acquired much of the routes of the New ork Central Railroad. It was New York Central that electrified the lines into Manhattan beginning 1903 after the horrific steam locomotive accident in the Park Avenue tunnel. The electric locomotives, like the ones going to Danbury, were the only ones used to pull trains to Grand Central Terminal after the state Legislature's ban on steam locomotives within Manhattan went into effect in 1908.

"These locomotives show the modes of transportation to New York City," Madyda said. "We will have all the locomotives that show the progression of technology that people used to commute into New York City."
