Case closed

Bethlehem Police Dept places name on mysterious 1981 'John Doe' death using 21st century tech

SELKIRK — Franklin D. Feldman was the talk of the town as residents speculated over the details of this community's 41-year-old mystery — just nobody knew him by name.

On Thursday, Jan. 13, Bethlehem police affixed Feldman's name to the department's long-standing cold case: identifying him as the man whose body was found in the wooded area of Frank Vadney's farm in the early spring of 1981.

DEC asks outdoor seekers to prepare

ALBANY — Current snow and cold weather are providing good conditions for winter outdoor recreation in the Adirondacks, Catskills, and other backcountry areas, New York State Department of Environmental Conservation Commissioner Basil Seggos announced last week.

To ensure a safe and enjoyable winter experience, visitors are advised to plan ahead and prepare with proper clothing and equipment for snow, ice, and cold.

“Winter conditions have arrived and it’s a great time to take advantage of all of the winter recreation opportunities New York has to offer,” Seggos said. “While enjoying the outdoors this winter, remember that conditions can be dangerous if you’re not properly prepared. Visitors exploring the outdoors should dress for the cold and use proper traction devices and skis to navigate trails.”

Snow depths range greatly throughout the Adirondacks, with the deepest snow at higher elevations in the High Peaks region and on mountains over 3,000 feet. Snow depths are thinner in the southeastern and northwestern Adirondacks. Ice is also present on high elevation trails, as well as many low-lying trails. Much of the Catskill Mountains are covered in snow, with icy trail conditions.

DEC recommends visitors to the backcountry carry snowshoes and trekking poles and use them when snow depths warrant. Snowshoes or skis ease travel on snow and prevent “post holing,” which can ruin trails and cause sudden falls resulting in injuries. Crampons or other traction devices should be carried for use on icy portions of the trails, including summits and other exposed areas. An ice axe may be necessary above tree line in the High Peaks. In the High Peaks Wilderness, snowshoes, or skis are required where snow depth exceeds eight inches. Town employee faces grand larceny charge

DELMAR — On Tuesday, Jan. 11 Bethlehem police arrested a Bethlehem Water Department employee for allegedly stealing \$63,481.19 of copper and brass from the town.

Matthew Stipe, 32, of Delmar, was charged with grand larceny, a felony, was arraigned and released. He will return to Bethlehem Town Court in February.

On Nov. 15 Water Department staff reported the materials missing from a storage building at 308 Kenwood Ave. to police after staff took inventory of the metals.

According to police, the thefts took place over a long period of time.

Credit theft solved

SLINGERLANDS — Bethlehem police closed a 2017 credit card case with an arrest of a Port Hewitt woman who was

known to the victim at the time.

Pamela Marshall, 51, is accused of taking possession and using two credit cards and one debit card to make multiple purchases including a stay at a Latham motel and purchases at Price Chopper in Slingerlands. The purchases were made in July 2017 while Marshall was living with the victim for three weeks.

After initially not wanting to press charges, the victim later had a change of mind and police issued an arrest warrant on Oct. 17, 2017.

The Ulster County Sheriff’s Department notified Bethlehem police on Thursday, Jan. 6 that they had Marshall in custody after they made contact with her at her residence.

She was transported back to Bethlehem and charged with grand larceny of a credit card, a felony, and identity theft, a misdemeanor. Marshall was arraigned, released on her own

recognition and will return to court on March 1.

Fraudulent car loan

GLENMONT — An Albany man was charged after he allegedly applied for a loan at CAPCOM Federal Credit Union with fake documentation.

On Nov. 24, Todd Townsend, 58, applied for a car loan at the Glenmont branch but an employee determined that the car’s title and pay stub he emailed to the credit union were fraudulent and involved in other scams. According to police, Townsend did admit he was involved and was arrested for grand larceny, falsifying business records and possession of a forged instrument, all felonies, and passing a false financial statement, a misdemeanor.

Townsend was arraigned by Judge Ryan Donovan and sent to the Albany County jail due to two previous felony convictions.

All 'green' ahead for Port of Albany

Governor Hochul announces key offshore wind milestone as contracts for Empire Wind 2, Beacon Wind projects are finalized

ALBANY — Gov. Kathy Hochul stood alongside U.S. Secretary of Energy Jennifer M. Granholm, Congressman Paul Tonko and other elected officials from the Port of Albany on a cold Friday morning to announce the finalization of contracts between the New York state Energy Research and Development Authority and Empire Wind Offshore LLC and Beacon Wind LLC on Jan. 14.

Each contract a 50-50 partnership between Equinor and bp, for the Empire Wind 2 and Beacon Wind offshore wind projects, representing a key milestone in the advancement of offshore wind development in New York.

"We know what it takes to build and sustain for the future, it's in our DNA as New Yorkers," Hochul said. "By advancing these significant offshore wind projects, we can maintain our cadence for developing projects that will spur much-needed green job creation and investment. No state has felt the impacts of climate change more than New York state, and now more than ever, we can continue to lead the way with our ambitious, nation-leading vision to transition to a renewable energy and a cleaner, greener future."

The \$350 million wind tower assembly facility will expand the Port of Albany's current footprint, pushing south down the Hudson River shoreline into the Town of Bethlehem. Town Supervisor David VanLuven, who was in attendance for the press conference, said he was excited to see the prospective benefits of green energy development coming out of Bethlehem.

"People sometimes think of Bethlehem as a sleepy little community," he said, "but from here we have the promise of 500 jobs in the Port of Albany, another 1,500 jobs coming from Plug Power. The future of Green Energy is unfolding right here in our town."

formally closed the state's second offshore wind competitive solicitation and also includes the first awards for the state's Offshore Wind Training Institute. Coupled with this week's issuance of the Bureau of Ocean Energy Management's Final Sale Notice for the New York Bight and the State of the State announcement of a nation-leading \$500 million investment in offshore wind ports, manufacturing and supply chain to be integrated within NYSERDA's 2022 solicitation, these events represent a significant step forward in advancing the Climate Leadership and Community Protection Act goal to develop 9,000 megawatts of offshore wind by 2035.

Also announced Friday were the first round of competitive awards under the State's \$20 million Offshore Wind Training Institute, the largest public investment in offshore wind workforce development by any state in the U.S. Through a partnership between the State University of New York's Farmingdale State College and Stony Brook University on Long Island, the training institute aims to advance offshore wind training programs and the educational infrastructure needed to establish a skilled workforce that can support the emerging national offshore wind industry. The Institute will certify and train 2,500 New York workers beginning this year to support both offshore and onshore renewable energy projects.

for taking a huge step towards lowering energy bills for New York households, creating thousands of good-paying jobs, and advancing President Biden's goal of a robust offshore wind industry in America," U.S. Secretary of Energy Jennifer M. Granholm said. "We can and will overcome the challenge of climate change, and we'll do it one clean energy worker at a time."

The governor's office said the average bill impact for customers will be approximately 0.8 percent, or about \$0.95 per month. Total project costs, including a cost-effective average all-in development cost of \$80.40 per megawatt-hour, are approximately

7 percent lower than those of NYSERDA's 2018 awards.

The 1,260-megawatt Empire Wind 2 and 1,230-megawatt Beacon Wind projects were provisionally awarded in January 2021 as a result of NYSERDA's second offshore wind competitive solicitation. Expected to enter into commercial operation in 2027 and 2028, respectively, the projects is anticipated to strengthen New York's economy and further drive investments in ports to directly support offshore wind projects while establishing New York as the hub of the offshore wind supply chain. NYSERDA payments to the projects will commence once they

obtain all required permits and approvals, complete construction, and begin delivering power to New York.

The final project contracts include both public and private funding commitments, including \$644 million in port infrastructure and \$357 million in the nation's first offshore wind tower manufacturing facility to be built at the Port of Albany. Another \$287 million is earmarked for an offshore wind staging and assembly facility at the South Brooklyn Marine Terminal, and more than \$8.9 billion in anticipated in-state

“Cold cases are unique,” said Bethlehem Police Chief Gina Cocchiara. “While sometimes they appear to be forgotten about, they’re always being worked on so we can find closure for all those who are involved.”

“I think that’s paramount to this.” A flock of reporters gathered around a small cadre of law enforcement officers at the Elm Avenue Town Park where a press conference was scheduled. The police agency alluded to the breakthrough in a statement the day before. Feldman’s body was found within yards of where nature trails meander through the woods in the back of the park’s expansive complex.

Feldman was identified through the use of Investigative Genetic Genealogy, the same forensic pathology used to identify the Golden State Killer in 2018. Genetic material extracted from a jawbone helped locate two relatives, a first cousin and aunt, through familial DNA databases.

It is the first case solved within the Capital District by using the technology. “We can prove, based on all testimony and physical evidence today, the confirmed two DNA samples on the body found on April 3rd, 1981, buried in Graceland Cemetery a couple of days later, is no longer John Doe,” said Bethlehem Police Cmdr. Adam Hornick. “But is, in fact, Franklin Feldman.”

Hornick has been the lead investigator since the agency started rebuilding the case in 2013. That was when the department’s administrative sergeant presented him with only two sheets of notes. Evidence gathered from the site in 1981 was since

suspected lost following a flood in the town hall’s basement sometime in the 1990s.

Early in the original investigation, Bethlehem police left a jawbone to Dr. Alan Rosell, a Saratoga County dentist, in an attempt to learn Feldman’s identity. However, the mandible was never retrieved back. It was rediscovered in 2017 following a review of the case notes that referenced it. Though Rosell retired a decade before, his practice remained in business, and those who remained in the office were familiar with the evidence.

The returned jawbone allowed the case to proceed. Bethlehem police reviewed the bones with a New York State Police forensic odontologist and confirmed a match to the dental chart from the case’s paperwork. It was then sent out to establish a DNA profile through work with the New York City Office of Chief Medical Examiner and the University of North Texas Center for Human Identification.

Investigative Genetic Genealogy is an emerging process thanks in part to the popularity of genealogy databases such as GEDMatch and FamilyTreeDNA. The technology led to the 2018 arrest and ultimate conviction of Joseph James DeAngelo Jr., otherwise known as the Golden State Killer.

After obtaining a DNA profile, Bethlehem police received approval from the Albany County District Attorney’s office to submit it for a familial search against both national and state databases. However, the use of investigative genetic genealogy is not allowed in every state. Up until recently, New York state did not permit it in cases such as this. Hornick proceeded with a media push in 2019, attempting to pressure for its use. In a 40-year-old case, he said he was afraid opportunity would disappear.

The state’s familial search laws were changed as a result of Bethlehem’s case to identify its John Doe. Feldman’s DNA profile was submitted to an FBI office

at Melville in 2020. With Othram Inc., a Texas-based corporation specializing in forensic genealogy, they developed a genealogical profile and generated a lead of potential family members: a first cousin who had never met Feldman, and an aunt described in her late 80s and in declining health.

“When we made the media push a couple of years ago, we referenced to the fact that if the case isn’t solved in the next few years, the likelihood of it being solved is low,” Hornick said. “We can stand here and say that is definitely true.”

In life, Feldman was described as estranged from the rest of his family. He would contact them sporadically while living in various places throughout the state — sometimes homeless. The police commander described him as being in and out of hospitals, suffering through “mental concerns.” He was found with a CDTA bus ticket, copies of two local weekly newspapers and a notebook listing addresses of local churches and soup kitchens. He wore a fur-lined coat with moccasin-style loafers. The date on each of the newspapers was Jan. 1, 1981. Police suspected he died soon after. No cause of death was determined, and police said there was no evidence suggesting foul play.

The Feldman case and the charge it generated to change state familial DNA laws is expected to help more agencies trying to close similar cases.

Hornick, a New Scotland native and graduate of Bethlehem Central, admitted to having mixed emotions while closing the case. He explained the satisfaction of being able to provide family closure, but that the end to this story meant telling someone that their loved one had died. He placed its timeline in context with everyone in the audience. How it dated farther back than everyone’s career within the agency, and that longtime residents could remember back to their childhood, knowing about the case but never learning who it was.

“I’m glad to be a part of this team that was able to get this case solved,” he said. “Not only for the family but for the community.”

Eat right, exercise, get vaxxed

Albany Med prez offers sage advice

ALBANY — As the number of the COVID-19 omicron variant cases continues to spike, the president and CEO of Albany Medical Center Hospital has a simple message — eat right and exercise.

“We know that higher body mass index and being overweight and having diabetes and having hypertension are serious and significant risk factors for landing in the hospital with COVID,” said Dr. Dennis McKenna during an appearance on Talk 1300 radio. “I would ask everyone to evaluate their own health plan, what they eat, are they taking blood pressure medications, are they exercising regularly.

These things can make a difference, not just with COVID, but they can make a difference with a lot of other diseases.”

While stressing a living a healthy lifestyle, McKenna did not dismiss the importance or effectiveness of vaccinations

“Of course I believe the booster is safe and effective and I encourage people to get the vaccine,” he said. “I think it makes a difference in reducing hospitalizations and if you do get COVID I think you will have a much more mild course if you are vaccinated.”

He said while the numbers are growing, there are less people in the hospital who require ICU care. Right now, he said, 15 percent of the 382 people hospitalized with COVID are in the ICU compared to as many as 46 percent

a year ago at the height of COVID.

He said about a third of those patients in the hospital with COVID came in for treatment of something else and were asymptomatic but were tested for COVID as per hospital protocol. In the eight-county Capital District Region, the number who tested positive after seeking treatment for something else was 24 percent as of Tuesday, Jan. 11, according to the state Department of Health, and statewide it was 42 percent of the total 12,540.

“This is a different kind of COVID. First of all, we have close to 80 percent of our population vaccinated and second of all this variant is more mild,” he said, adding that some 70 percent of those hospitalized are not vaccinated.

Meanwhile, Albany County reported a number of four-digit days last week with a new record being set for new cases, 1,585, in a 24-hour period from Thursday, Jan. 13, to Friday, Jan. 14. A day later, there were 1,526 new cases in Albany County.

From Sunday, Jan. 16, to Monday, Jan. 17, the last day before this paper went to print, there were 498 new cases bringing the total number of cases in the county to 53,592 since the pandemic took hold in March, 2020. The seven-day average in Albany county stood at 995.8 on Monday.

According to the state COVID tracker, the seven-day positivity rate statewide was 16.4 percent. In the eight-county Capital Region district it stood at 17.6 as of Sunday, Jan. 16. The Western New York region had the highest seven-day

positivity percentage at 21.5 percent and Southern Tier region had the lowest with 14.5 percent.

“I saw a headline the other day ‘United States sets world record for number of cases.’ On the one hand having 1.5 million people test positive for omicron is something that is perhaps news worthy but we have to understand we are testing people in this country on a magnitude that is not happening anywhere else,” McKenna said. “There is more to that than simply the fact he virus is going everywhere it’s the fact we are doing more testing. In addition, it’s not the fact we have 1.5 million cases, it’s how many are mild cases and how many are asymptomatic cases and how many people are being tested for different reasons.”

He didn’t demean the potential serious

ramifications of COVID, and highly recommends that if people are showing symptoms to consult with a physician “but the overwhelming, majority of people who test positive probably do not need to seek medical care,” he said.

As to hospital capacity, he said Albany Med, on any given day, has between 10 and 15 percent of bed capacity for medical concerns other than COVID.

“People in this region need to understand we have professionals who deal with seasonal viruses and hospitalizations that go up in the winter and we have been doing is since we have had hospitals and, quite frankly, we have been doing it long before the local elected officials made a lot of news about it,” he said. “We can handle this and we will always be able to handle this.”

Heating cost assistance available through HEAP

UPSTATE NEW YORK — National Grid is reminding customers there is still time to take advantage of energy programs that can help them pay and manage their winter energy bills.

The Home Energy Assistance Program provides financial assistance to make home heating costs more affordable for income-eligible customers as well as emergency funds for eligible households experiencing a heating or heat-related emergency.

HEAP funding programs are limited and made available on a first-come, first-served basis. HEAP is not a loan; it's a benefit available to customers who meet specific eligibility requirements. Customers are urged to apply as soon as possible, as program dates may be shortened or extended based on federal funding and demand. HEAP programs include Regular HEAP, which is scheduled to run through March 15, 2022. Qualification is based on household size and income.

One-time, Regular Arrears Supplements are limited-availability grants available to HEAP-eligible customers and are expected to be available through September 2022. These grants cover accumulated past-due utility payments up to \$10,000. Qualification for the Regular Arrears Supplement is based on household size and income, and customers must have past-due utility payments. To apply, contact your HEAP Local District Contact. Customers 60 years of age can apply through their county's Office for the Aging.

Emergency HEAP is scheduled to run through March 15, 2022. Qualification is based on household size and income. To apply, customers must be disconnected, disconnect-eligible or have a utility shut-off notice. National Grid customers requiring electricity to operate heating systems can apply for a Domestic Electric Emergency HEAP grant.

Customers must apply by telephone or in person through your HEAP Local District Contact. Customers 60 or older can apply through their county's Office for the Aging.

Customers who receive HEAP funding are automatically enrolled in National Grid's Energy Affordability Program. This program provides monthly bill credits above and beyond what the customer receives from HEAP. Customers may also qualify for EAP by participating in qualifying programs such as Supplemental Nutrition Assistance Program, Supplemental Security Income, Medicaid, Federal Public Housing Assistance, qualifying veterans' pensions, or Native American benefit programs administered by federal or tribal governments. Rehab plan could usher in a new ice cream parlor

SLINGERLANDS — The family that owns Toll Gate Ice Cream and Coffee Shop is proposing to rehabilitate the single-story building behind the shuttered eatery to open a new ice cream shop there.

Zautner Toll Gate Enterprises LLC is scheduled to present plans to the town's Development Planning Committee on Thursday, Jan. 20 for a new ice cream shop. It's to be located behind the one it closed five years ago when the proprietor fell into health problems. Toll Gate was once a popular stop for ice cream and fast food since it first opened in 1949. 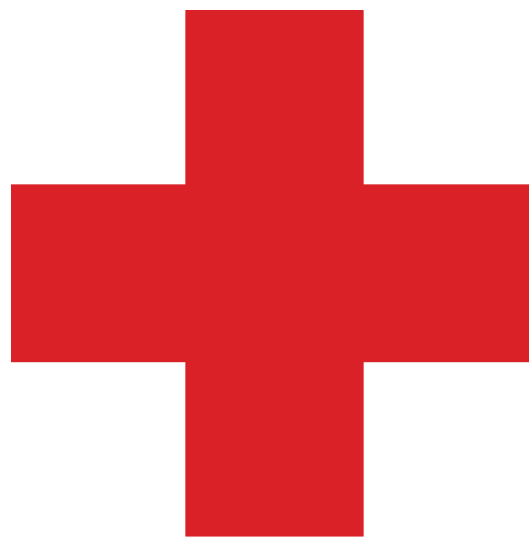
News of the proposal ignited excitement on social media last week from local residents who have missed the popular ice cream parlor.

Poll: Food and gas a concern for most

There's a growing concern amongst New Yorkers

LOUDONVILLE — The cost of gas and food are had a very serious or somewhat serious impact on the finances of more New Yorkers in the fourth quarter last year than the third quarter, according to a poll of Consumer Sentiment by the Siena College Research Institute.

Sixty-one percent, up from 54 percent, said current gas prices were having a "serious or somewhat serious" impact on their financial condition and 72 percent, up from 66 percent, say the same about the cost of groceries.

Meanwhile, the state Index of Consumer Sentiment is up 1.2 points to 73.1, according to the poll, that is 5.7 points higher than the nation's index of 67.4.

"After a precipitous fall in sentiment rose by a point as

New Yorkers balance an ongoing decline in their current economic situation with an uptick in their long-range outlook," said Don Levy, SCRI director. "Most noteworthy are concerns over the bite that gas and food are taking out of the budget as inflation has generated concerns over gasoline prices that we haven't seen since March of 2013 and food price worries not matched since July of 2011."

Concerns over the prices of gas and food are felt more strongly across the board — by both political parties, by men and women and by all income levels — but is being felt especially hard by upstaters, women and older residents, according to the poll.

The cost of food is having a more pronounced impact across all demographics than the cost of gas. Democrats say they are feeling the pinch more than Republicans, with 45 percent saying gas and food are having a very or somewhat serious impact on their financial condition

compared to 64 percent of Republicans. Fifty-nine percent of upstaters say the costs are having a very or somewhat serious impact while 49 percent of those in New York City say the same.

The current index in New York is 3 percentage points below the threshold where optimism and pessimism balance, which is about the same as when the pandemic took hold in March, 2020, Levy said. Looking ahead, it is 3.9 percentage points higher

in this state. Nationally, the current sentiment is 6.5 points below the threshold and the future outlook is 4.6 points lower.

"Only faith in a better tomorrow which rose to equal where we stood a year ago resulted in the one-point overall index increase," Levy said.

In the fourth quarter of 2001, buying plans were up for homes (10.4 percent from 10.1 percent,) and major home improvements (25 percent from 24.2 percent.)

But, they were down for cars and trucks (16.9 percent from 19.1 percent,) consumer electronics (43.5 from 45.5 percent,) and furniture (28 percent from 30.1 percent.)

The poll was conducted from Nov. 8 to Nov. 16 by making random phone calls to 395 New Yorkers. It has a margin of error of +/- 3.8 percent. The consumer sentiment analysis is generated as an index number and margin of error does not apply.

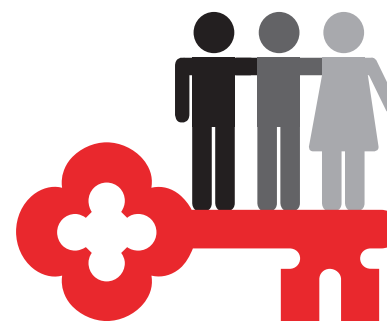

Polyfluoroalkyl Substances Health Study.

The by-invitation-only effort seeks to recruit eligible adults and families who will then be invited for a health clinic visit for blood and urine testing, along with a health evaluation, to measure exposure to PFAS. The study will also collect information about the immune response, lipid metabolism, kidney function, thyroid disease, liver disease, glycemic parameters and diabetes.

In return, confidential test results will be provided to participants at no cost to them.

The Multi-Site PFAS Health Study is funded by the federal Centers for Disease Control and Prevention and the Agency for Toxic Substances and Disease Registry. New York's effort is led by researchers from the New York State Department of Health and the University at Albany School of Public Health. Additional Multi-site PFAS Health

Study communities are located in California, Colorado, Massachusetts, Michigan, New Jersey, and Pennsylvania.

Mid-year Q&A for BC families

Dear BC family,
Thank you for your patience and your cooperation as we continue to navigate COVID's omicron surge. On Jan. 13, we received additional guidance from the New York State Department of Health regarding isolation and quarantine. Our health team is reviewing these documents and we will share any changes to our protocols with you early next week. The guidance from DOH mostly follows the CDC's five-day isolation and quarantine protocols that have been in place here in the district

since the beginning of the week.

We have been fortunate that our staffing levels have not necessitated a shift to remote learning, however, we still have many students who are unable to come to school due to COVID-related absences. This week alone, we have reported more than new 100 positive student cases, with 19 new cases being reported last Friday. Therefore, we will continue our livestreaming option for these students for another week. By next Friday, I hope to report that we have had a steep

enough drop in cases that we will be able to return to our tutoring model for addressing the needs of students who are forced to stay home. If so, we will end livestreaming at that time.

On Friday, Feb. 4, we are planning to host an afterschool Vaccine Booster Clinic. This clinic, in partnership with Crestwood Pharmacy, will be available to all eligible staff and students, ages 12 and older. The clinic will be for booster shots only. We will survey families and staff next week to get an estimate of how many

people are interested in receiving a booster shot at the school clinic on Feb. 4. Please watch for that information.

If your child has already received a booster shot, please share that information with your child's school nurse.

Vaccine locations and information are always available at the Albany County website..

Also, please note that I am planning a mid-year Q & A on Thursday, Jan. 20 at 7 p.m. to answer your questions regarding health and safety, instruction,

transportation and more. Please plan to join me then. As we look toward the weekend, I want to thank our hardworking faculty, staff and building leaders who have navigated the last two weeks with tireless dedication, professionalism, teamwork and even good humor. This is a very special group of people that I am proud to work with.

spending. More than 5,200 jobs is anticipated to be created, backed by prevailing wage and project labor agreement commitments.

"We know New York's potential for offshore wind development is tremendous. Today's exciting news will play a pivotal role in expanding this industry, creating good-paying jobs, training the energy workforce of the future, and helping address our most pressing climate challenges," said Tonko. "Thanks to all involved in this forward-thinking announcement that invests in our region and pushes New York further down the path to becoming a powerhouse of wind manufacturing."

The Port of Albany extension initiative was part of the bid Equinor submitted in response to the NYSERDA's offshore wind energy solicitation, which sought up to 2.5 gigawatts of offshore wind and multi-port infrastructure investment

plans.

The construction of an offshore wind tower/TP manufacturing facility at the Port of Albany is expected to provide an immediate economic boost to the area as it recovers from the COVID-19 pandemic, creating new employment opportunities as early as the second half of 2021.

"Today's announcement sets Equinor and bp on the path to provide over 3.3 GWs of offshore wind power for New York," said President of Equinor Wind US Siri Espedal Kindem. "It also offers a large-scale, tangible demonstration of the incredible economic activity and carbon reduction potential being driven by New York's green energy transition. We are proud to help lead the growth of this exciting industry in New York."

was named among the first two winning proposals that will receive a combined \$569,618 to support early training and skills development for disadvantaged communities.

Hudson Valley Community College is to help build a strong pipeline for the Capital District's offshore wind initiative. The Troy-based community school recently began offering a two-year associate degree in welding and fabrication and will focus student recruitment efforts on priority populations in urban

and rural disadvantaged communities, providing full or partial scholarships to participants.

Foundational welding skills training will be provided by the Capital Region Educational Opportunity Center, a division of HVCC with additional non-credit training and certifications be provided at the college's main campus. The college will also partner with regional manufacturers building turbine components to provide a skilled workforce pipeline of welders and

fabricators, aiming to train 75 individuals, including 65 from priority populations and disadvantaged communities.

"Hudson Valley Community College is committed to helping supply the workforce for New York State's clean energy future," said Penny Hill, Dean of Economic Development and Workforce Initiatives for HVCC. "In addition to those trained in welding and fabrication, the college is ready to provide other educational opportunities to support the offshore

wind industry. We look forward to partnering with manufacturers to provide job training and build stronger, more resilient communities."

New York State has five offshore wind projects in active development, the largest portfolio in the nation. This initial portfolio totals more than 4,300 megawatts and will power more than 2.4 million New York homes and is expected to bring a combined economic impact of \$12.1 billion to the state. The projects are also expected to create more than 6,800 jobs in project development, component manufacturing, installation, and operations and maintenance. Achieving the State's 9,000 megawatt by 2035 goal will generate enough offshore wind energy to power approximately 30 percent of New York State's electricity needs, equivalent to nearly 6 million New York State homes, and spur approximately 10,000 jobs.

Friday morning's announcement from the Port of Albany was the first leg of a regionwide tour that included stops to the University at Albany and Hudson Valley Community College.

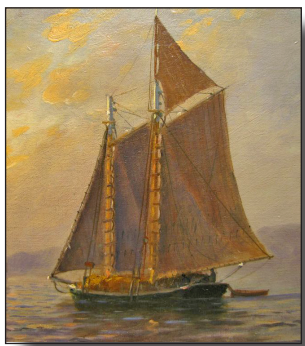

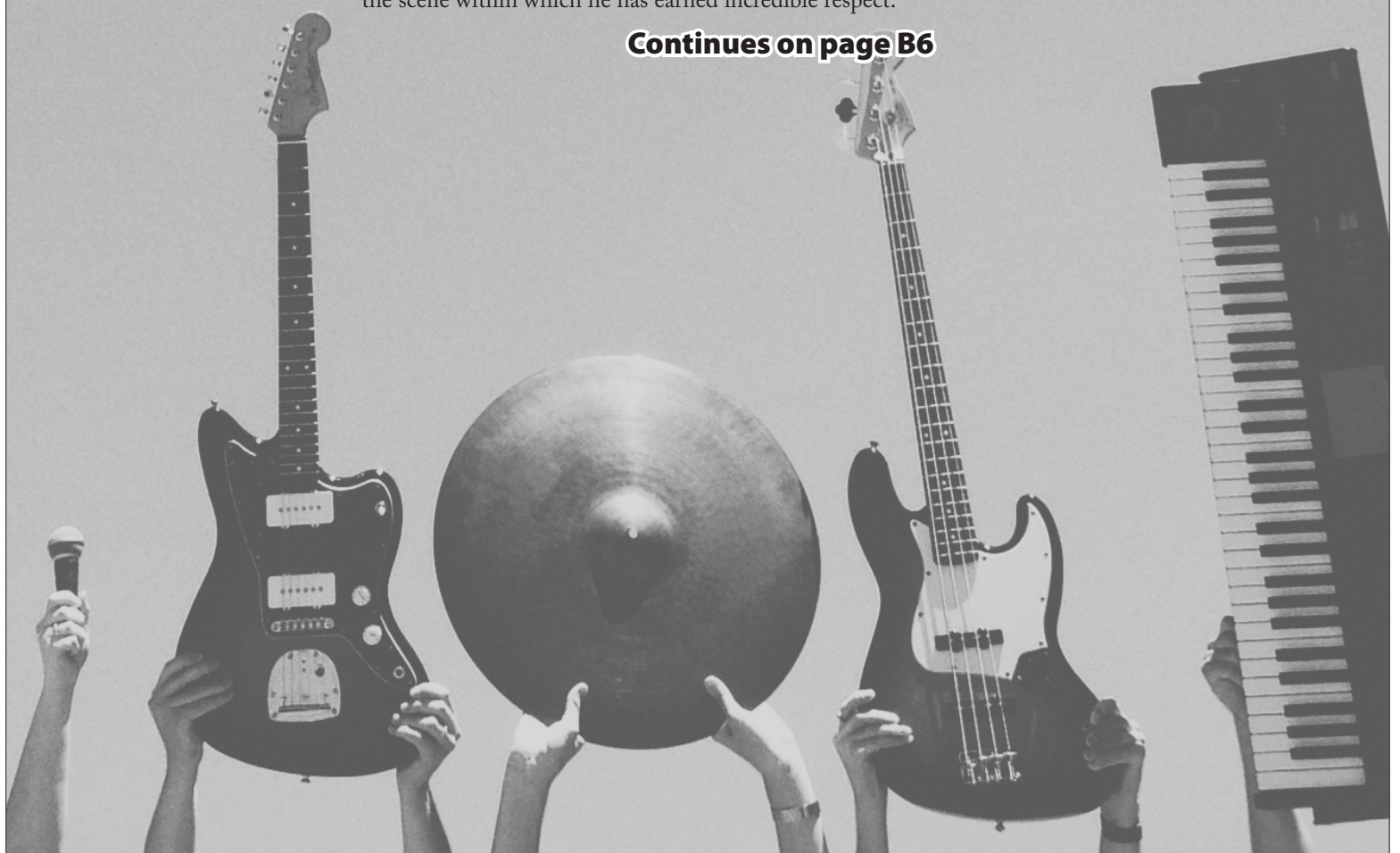

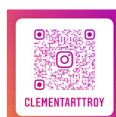

Art history for sale

Private collection of Hudson River School paintings on auction block

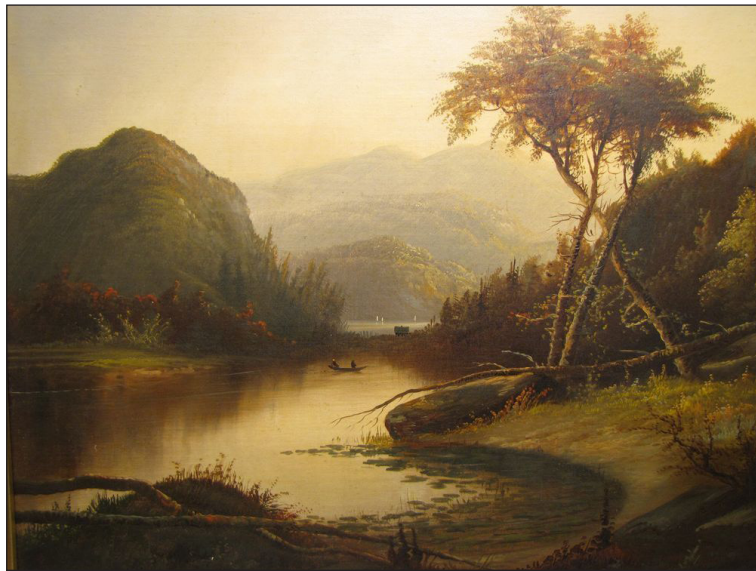
PLEASANT VALLEY – The private, single-owner collection of paintings by noted artists from the renowned Hudson River School – 62 works in all – is now held in an online auction that's to end on Wednesday, Feb. 16.

The Hudson River School consisted of mid-19th century "Nature Painters" who found spirituality in nature. These adventuresome artists hiked to see impressive views. They sketched and did studies in the field to bring back to their studios and create finished paintings. In doing so, these artists celebrated and depicted the pristine magnificence of the American landscape of the period.

The Hudson River served as the main route of travel to the best places; it also provided the best subject matter. New York City, with the National Academy of Design, was at the center of the American art world in the 19th century. Now, seasoned collectors, as well as novices to the genre, can experience the beauty, tranquility and grandness of nature from the palettes of these artists.

The curated auction is from the personal collection of Robert and Susan Doyle of Fishkill, dedicated collectors of the first American School of Art that later became known as the Hudson River School, in upstate New York.

All the paintings are original works and nearly all have been professionally cleaned and conserved. Every painting

would be a worthy addition to a collection.

Works of particular interest include the following lots.

Lot 1, by Thomas Benjamin Pope (1834-1891), is an oil on canvas titled *View from West Point* and is a classic Hudson River School depiction, of a cadet couple looking north toward Pollepel Island and the Northgate to the Highlands. The view has Storm King Mountain on the left and Breakneck Mountain on the right. The work is 12 inches by 22 inches (sight, minus the frame).

Lot 10 is an oil on canvas by William Rickarby Miller (1818-1893), titled *View of New York City from Weehawken, NJ*. It measures 21 inches by 35 1/2 inches and is signed and dated 1860 lower left. Miller was a prolific painter, producing hundreds of watercolors, oils and pen-and-ink sketches. His work can be seen in the collection

of the prestigious New York Historical Society.

Lot 60 is an oil on canvas *View of Sugarloaf Mountain on the Hudson River with Sailboat* by Norton Bush (1834-1894), artist signed and dated 1874. The artwork measures 13 inches by 24 inches (sight, less frame). Through many of his paintings, Bush's goal was to inspire the viewer with the overwhelming aspects of nature and the diminished relative position of human beings.

Touring Stephane Wrembel to stop at The Linda on Feb 4

ALBANY — Critically-acclaimed Jazz guitarist Stephane Wrembel will make a stop at The Linda on Friday, Feb. 4 as he gears up for his annual Django a Gogo Music Festival and Guitar Camp.

Wrembel is a composer, teacher, and one of the most heralded guitarists in the world specializing in the style of Django Reinhardt. Wrembel - who learned his craft among the Gypsies at campsites in the French countryside - has had a remarkable career, headlining shows worldwide while releasing 16 albums under his name and the nom de plume, The Django Experiment. In addition to "Bistro Fada," the theme song for *Midnight In Paris*, his original composition "Big Brother" was featured in *Vicky Cristina Barcelona*. *Midnight In Paris* won the Grammy Award for Best Soundtrack, and Wrembel has hand-selected by Hans Zimmer to perform in an all-star ensemble at the 2012 Academy Awards. Most recently, Wrembel recorded the entire score for Woody Allen's upcoming film, *Rifkin's Festival*, tentatively set for release in late January of 2022.

Most known for his original composition "Bistro Fada" from the Academy Award-winning film, "Midnight in Paris," Wrembel has brought together some of the finest musicians in the world to celebrate the Sinti guitar style at prestigious venues such as Carnegie Hall and The Town Hall. Django a Gogo is scheduled for March 2 to 6, in Maplewood, N.J., and New York City.

In October of 2019, Wrembel released the highly regarded *Django L'Impressionniste*, featuring 17 of Reinhardt's early preludes for solo guitar, followed by a book of his transcriptions in April of 2021. He is the only guitarist who can perform this entire repertoire.

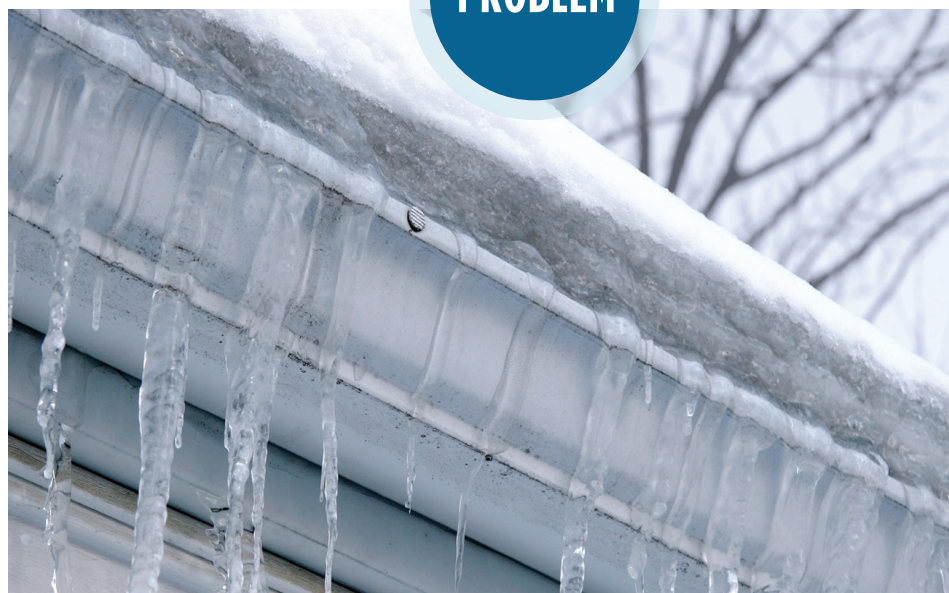

“Somebody goes down, three people pick them up. If there’s a fight in the pit, the pit takes care of it. Everybody always comes together,” said Kebabjian. “Because there’s a brotherhood.”

On Sunday, Jan. 23, the local hard rock scene is coming back together to pick up one of their own through a benefit show called Mark a Wish at Chrome Food & Spirits in Waterford. Super 8 Six, Uncivil Liberty, Maxx Thrust, China White — four bands, all of which Garrett has played drums for at one time or another, are scheduled to play from 2 to 6 p.m.

While behind his kit, Garrett has earned the nickname “Guns.” Kebabjian said he goes “all out” with an aggressive, hard-hitting sound he emulated in his own style of play while playing drums for Lost Reality. “He’s got a big sound when he plays, which is what I’ve always loved about him. Him

and Bill Ketzer, another local idol of mine. They hit the drums hard, and that inspired me to follow their path,” he said.

But while off the stage, Garrett’s described as an altruistic leader the helps out the show in as many ways he can. He’s one of those in the scene where he’d give the shirt off his back. He’ll go to the merch table, buy three more, and then had them out, too. He’s just that guy. At fundraisers, he’s known to take on three or more jobs. He’ll manage the stage, play the drums and sell 50/50 raffle tickets on the floor. At a fundraiser for China White’s Henry and Sean McFerran in 2019, Garrett sat behind the kit for three of the bands.

“There’s the normal backstabbing and cattiness that goes along [within the scene],” shared Kebabjian, who now hosts the popular “That Fuzzing Rock Show.” It happens in every scene. ... It’s like that family mentality where we can hate each other all day long, but when somebody else hates us, we love each other to death.”

Garrett was recently diagnosed with colon cancer. As news circulated throughout his extended music family, he was approached before they started organizing a fundraiser. At first, he was said to be humble about it, and shied away. A few days later, Kebabjian said, he offered up his drum kit.

“Currently Mark is undergoing a very aggressive chemo treatment and can not do the things he loves most in life; work, play music and spoil his daughter,” said Rich Sorensen, who organized the fundraiser on Garrett’s behalf with Holly Stah and others. “If you wish to donate in advance, you can do so directly through Venmo or reach out to Holly A Stah with cash or gift card donations.”

Seeing Ourselves: From Silhouette to Selfie - Imagine not knowing the look of their own face. For most people throughout history, this was the rule rather than the exception. It was only through the development of technology that we reached the modern day, where seeing yourself is as simple as looking in a mirror or pushing a button. Early prototype X-ray equipment, rare photographs, a collection of cameras, and a model of the first GE Magnetic Resonance Imaging (MRI) machine are also on view.

Interactive activities include Capture Your Shadow, Colorize a Photograph, Get In The Scene, Face Mixer, Fool a Computer Vision System, Make Your Bones Dance, and more.

Model Trains Show

An exhibition of approximately fifty photographs and works of art depicting scenes from the history of the American Locomotive Company and General Electric's development of locomotives will also be on view in the Museum's newly-renovated Lecture Gallery. Highlights include an 1895 photograph by famed GE engineer, Charles Steinmetz, of New York Central's Empire State Express, a steam locomotive that was built in Albany and set a world record by traveling 112 miles per hour; a photo of Big Boy, a 1.2-million-pound locomotive that was the largest ever built; and a 1932 work of art by Walter Greene titled More Power and Speed for New Haven that was commissioned by GE to promote their line of modern streamlined locomotives.

New York State Museum

Thomas Hart Benton

In 1956 Thomas Hart Benton was commissioned by Robert Moses, chairman of the New York Power Authority, to create two murals for the powerhouse building of the state's first hydropower facility in Massena. They feature Jacques Cartier's explorations of the St. Lawrence River and the Gulf of St. Lawrence. Alternately titled The Seneca Discover the French and Jacques Cartier Discovers the Indians, the murals depict the 16th-century encounters from two points of view. These life groups were on view at the Museum when it was at the State Education Building.

The original building in Massena where these murals were displayed is now closed to the public. They were removed and conserved beginning in 2018 and are on loan to the New York State Museum until Dec 31. Also, "a small fort, which our people call Fort Orange." This exhibition examines the momentous discovery of Fort Orange and the lasting impact of events occurring there 400 years ago that shaped the character of the region, state, and the nation. Select artifacts, film footage from the excavation preceding the construction of I-787, and four decades of historical and archaeological research are highlighted.

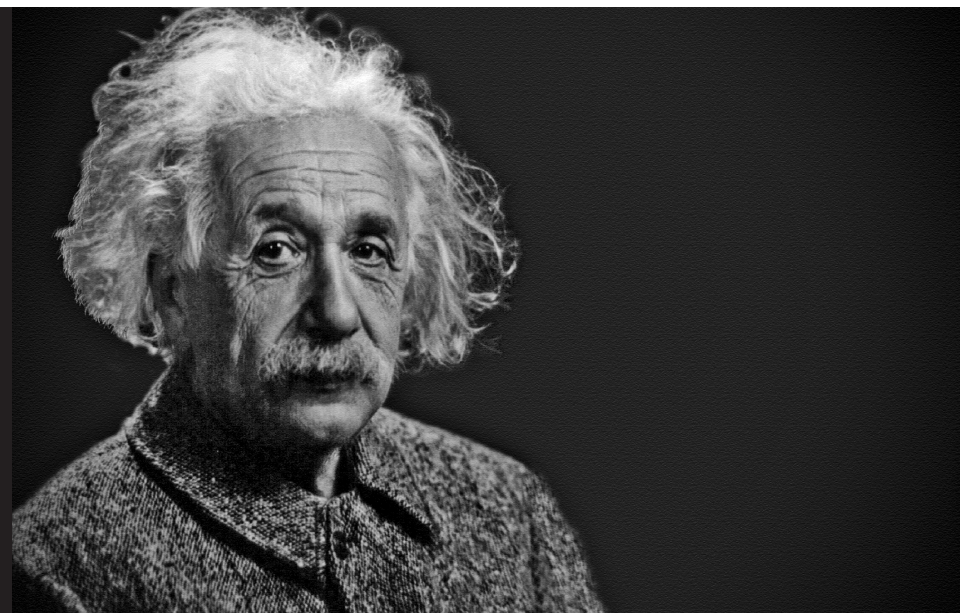

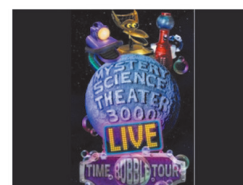

Participants sought for UAlbany study

State Health Dept, UAlbany to recruit for national PFAS study

ALBANY — The state Department of Health and the University at Albany School of Public Health announced that residents in the Hoosick Falls area and the City of Newburgh are invited to take part in a national Multi-Site Per- and Polyfluoroalkyl Substances Health Study.

The by-invitation-only effort seeks to recruit eligible adults and families who will then be invited for a health clinic visit for blood and urine testing, along with a health evaluation, to measure exposure to PFAS. The study will also collect information about the immune response, lipid metabolism, kidney function, thyroid disease,

liver disease, glycemic parameters and diabetes. In return, confidential test results will be provided to participants at no cost to them.

“New York State is collaborating with some of the best researchers in the country to collect data from participants with common exposures,” said New York State Department of Health Acting Commissioner Dr. Mary T. Bassett. “What we learn by working with these researchers could provide important clues about the complex relationship between PFAS exposures through drinking water and human health outcomes.”

The Hoosick Falls area and the City of Newburgh were chosen as part of the first national study to look at exposures to PFAS from drinking water. PFAS has been detected in public drinking water supplies

and in private wells in these communities as well as across the country near where these chemicals were manufactured, used, or disposed. These efforts are strongly supported by both communities.

A Community Advisory Panel, made up of unpaid individuals from the Hoosick Falls area and Newburgh communities, is a critical partner in this study. Members relay community questions and concerns and encourage community outreach and participation. They also help advise researchers on study design, outreach and progress.

“We truly hope the information gathered will aid every family across the U.S. now dealing with the same contamination to make more informed decisions for the health of their loved ones,” said Loreen Hackett, Hoosick

Falls area CAP member and long-time resident who has been a leader in raising awareness about the PFOA contamination in the area. “Our babies and children in particular need and deserve the health information collected for a chance at healthier lives.”

Researchers will look closely at the role PFAS may play in various health outcomes by analyzing results from blood tests, health-related laboratory tests and assessments, medical, exposure histories and children’s educational records. New York State researchers may also ask some participants’ permission to access newborn screening samples already on file to test them for PFAS exposure to help estimate people’s PFAS exposures over their lifetime, including the birth mother’s exposure leading up to and during pregnancy.

These data may also help to establish a timeline for how PFAS exposures from drinking water have changed over time.

NYSDOH intends to protect all personal information while contributing to national scientific publications, reports and presentations. These will be published in a way to protect participant confidentiality so that participants cannot be identified.

The available information on the health effects associated with PFAS, like many chemicals, comes mostly from studies of high-level exposure in animals. Less is known about the chances of health effects in people from the range of exposure that might occur in drinking water.

Bell, PhD., Associate Dean for Research and Professor, Department of Environmental Health Sciences, University at Albany School of Public Health. “Working together, we will contribute to the national effort to better understand the health effects associated with PFAS.”

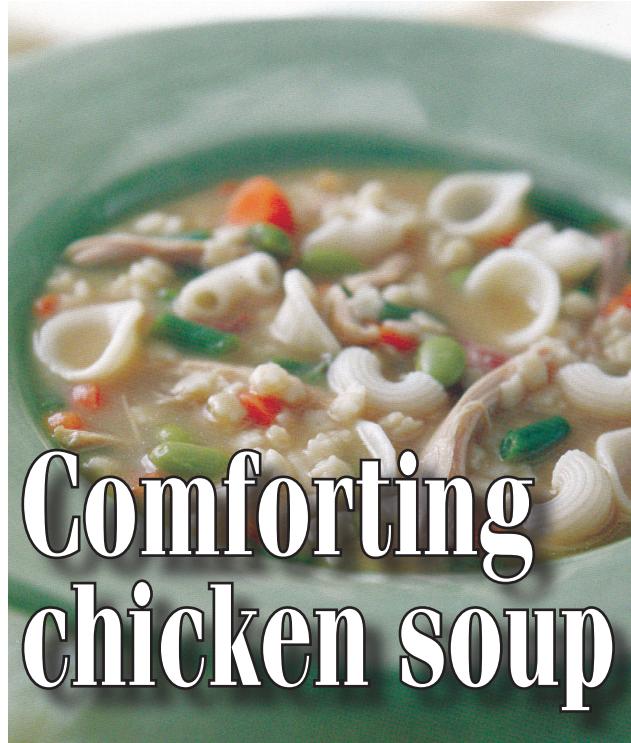

Comforting chicken soup

FOOD and VINO

Chicken soups and other soup recipes long have been touted as homeopathic remedies for colds. Not only are they hydrating, hot soups can break up congestion in the nose and chest. Plus their vegetable-rich content offers the vitamins and minerals needed to boost one's immune system. Any soup will do, but "Sylvie's Stars and Moon Soup" is whimsical enough to excite even the pickiest and youngest members of your household.

Enjoy this recipe, courtesy of "Soup's On: Soul-Satisfying Recipes from Your Favorite Cookbook Authors and Chefs" (Chronicle Books) by Leslie Jonath and Frankie Frankeny.

Sylvie's Stars and Moon Soup

INGREDIENTS: Serves 2 to 4

- 2 cans (10.5 oz or 14.5 oz) chicken broth (or homemade if desired)
- 2 medium carrots, peeled and cut into coins
- 1/4 cup orecchiette

- 1/2 cup elbow macaroni
- 1/2 cup mini pasta stars (pastina)
- 1 cup frozen shelled edamame
- 8 green beans, cut into 1/2-inch pieces
- 1 cup shredded, cooked chicken
- Freshly ground black pepper

DIRECTIONS

Pour the broth into a medium saucepan over medium-high heat. Add the carrots and bring to a boil. Add the orecchiette and cook for 2 minutes. Add the macaroni and cook for 3 minutes more. Add the stars, edamame, and green beans and cook for 4 minutes more. Add the chicken, cook until it is heated through, then sprinkle with pepper and serve.

Chef's note: Dana Corwin, from Food & Wine, makes this soup almost every Saturday in the winter with her daughter Sylvie. Feel free to take liberties with the recipe. Change the vegetables, add more broth or adjust the seasonings. The dish is very forgiving and versatile.

CONCERT REVIEW

Albert Lee shape shifted reality

HUDSON FALLS — The LED light on my dashboard summed it up. One tiny “oh,” zero degrees in the heart of darkness in the middle of the winter of humanity’s discontent. Saturday night before the storm that looks like a big red scar on the doppler radar map to signal the coming of a holiday that threatens to turn Martin Luther King Day into another reason for millions of Americans to cower in their homes. A day off for humanity that’s had almost two years “off.” How many inches will make the East

Coast hunker down in their homes?

But no!
For several hundred people at The Strand, the little theater that could, would, did, does, and still will, it was boys and girls’ night out with Thin Lizzy’s “The Boys Are Back in Town” playing on the sound system. British blues-rocker Albert Lee was making his fourth foray into the foothills of the Adirondacks, the adopted son of the movers and shakers who helped reconstitute this beautiful theater.

Albert Lee was back in town and we were gonna party. When the fog cleared on my glasses from a mask that didn’t fit right, I was ready to

hurtle into the music that has lifted my soul since before the first time I wrote about it in Vietnam. My readers then were terrified 18-year-olds tramping through the rice patties that with each step threatened to rip their legs apart and/or snuff out their lives and turn them into a tiny zero on the dashboard of existence.

Oh, the glory of great music, nectar of the Gods, heroin of the addicted, salve to the wounds of a world spiraling in the chaos of “fake news.” Saturday night in Hudson Falls is an alternate reality, as real to us as it was to those who baptized themselves in the soundtrack of their lives at the Fillmore East more

than half a century ago when I stood in line with longhaired hippies half of whom were tripping on yellow acid. All of us waiting to see and hear an albino Texan swoop us into nirvana.

In a world that measures an artist’s worth in numbers of products sold or streamed, Albert Lee is not a star. But he gets a standing ovation before he hits a note at the Strand. He turned 78 four days before Christmas. He’s a road warrior who casually mentions to us that he spent 23 years – most of them as music director – with Don and Phil Everly, both now gone. He got the job after Clapton fired him. He announced most songs

by announcing who had originated them: Hoyt Axton, Carl Perkins, Rodney Crowell, John Stewart, Emmylou Harris, Ray Charles, Chuck Berry, and Rickey Skaggs. Skaggs had a hit with Lee’s own “Country Boy,” Lee’s one charted hit and the centerpiece of his two-hour set.

His band consists of father keyboardist T.J. Thomas and his son John on drums. T.J. plays with a Yamaha keyboard throwing his entire body into it. He also plays accordion, his almost two-foot-long goatee threatening to get caught in the keyboard. Albert is dressed in black slacks and a black shirt, his white hair in a tangle that telegraphs his age as an

old rocker. He plays guitar with a whammy bar and no pedal effects. It’s all in his fingers, thank you.

Jonathan Newell, the Renaissance keeper of the flames that is the Strand, opened the show with his Strand House Band that did a 30-minute set of ’60s rock anthems that included “Jumpin’ Jack Flash,” “Angie,” “Miss You,” and “My Guitar Gently Weeps.” Newell put just enough of his own mojo into lead guitar, keyboards, and vocals to make them fresh. Albert Lee joined them at the end of the set, and Jonathan came up to me after the show grinning from ear to ear. “I played with Albert Lee,” he said as if to remind himself that he wasn’t dreaming.
