# Like a thief in the night

The political landscape in Bethlehem flips on its axis with recent redistricting

## Dash and smash

**DELMAR** — A car traveling at a high rate of speed left a trail of destruction after it crashed into multiple cars on Delaware Avenue near the high school on Saturday, Feb. 5.

According to the Bethlehem Police Department, Antonio Trivellotto, 24, of Schenectady, was driving westbound on Delaware Avenue near the intersection of Longmeadow Drive in a grey 2005 Acura approximately 12:47 p.m. a when he struck a white SUV, shearing off the driver's side doors.

Police said his car continued and struck a Honda minivan in the rear and another vehicle then travelled backwards past Meyer's Funeral Home into a tree on the left side of Delaware Avenue. The sedan left the roadway and hit a tree approximately six feet off the ground, before ricocheting across Delaware Avenue.

Trivellotto allegedly fled, but police were able to track his footprints in the snow to Canterbury Lane. While officers were interviewing, he allegedly punched one in the face. The officer was not injured.

Trivellotto was transported to Albany Medical Center with injuries sustained in the crash. Injuries to the occupants of the other vehicles were not disclosed. — John McIntyre

## Bail jumping

A Burlington, Vermont woman was detained as a fugitive of justice in Vermont and returned to Guilderland Town Court by State Police on Jan. 27 after she failed to appear on Oct. 14, 2021 to face drug charges.

Brittany Lawley, 24, was also charged with bail jumping, a felony, in addition to two counts of criminal possession of a controlled substance and a count of criminal possession of a narcotic drug from the prior arrest.

Lawley was arraigned and sent to the Albany County jail. Bail was set at \$5,000 cash or \$10,000 bond.

## **Fake plates**

On Jan. 27, Bethlehem police noticed a black 2004 Toyota Prius at the intersection of Route 9W and Maple Avenue in Glenmont that had a paper license plate from New Jersey. The officer observed the number format on the plate was incorrect and pulled the vehicle over.

The driver of the car, Maxime Lauture, 42, of Selkirk, was unable to provide any valid vehicle registration information. The paper plate on the vehicle had the letter at the end of the alphanumeric sequence and it albo did not have a QR code on it.

Lauture allegedly stated he got the vehicle from a garage in New Jersey, but could not provide the name of the garage or who sold the vehicle to him. According to police reports, he stated the paper registration plate was given to him when he purchased it. A police database search by the vehicle identification number revealed that the vehicle had an expired prior registration to another person and no temporary registration was in place.

He was charged with possession of a forged instrument, a felony, and operating a motor vehicle with improper plates, a violation.

Lauture was arraigned by Bethlehem Judge Andrew Kirby and released. He will return to court on Feb. 15.

### Aggravated DWI

Bethlehem police responded to a single-car collision with a tree at the intersection of Winne Road and Mcguffey Lane on Jan. 31.

When police arrived, The airbags of the 2023 Hyundai had deployed, the wipers were still on and the driver's side door was up against the tree. A passenger in the car had to be removed by Bethlehem EMS.

The driver of the car, Sherry Boomer, 26, of Ravena, had climbed through to the back seat to get out. The officers allegedly noticed an odor of alcohol emanating from Boomer's breath and that she had slurred speech and bloodshot, watery eyes.

According to reports, officers asked the driver for information multiple times without success. The vehicle was registered in Virginia and was a rental car.

Boomer allegedly said she did not know where she was or what time it was, but said she was not hurt and refused treatment by Bethlehem EMS. Boomer said she got agitated and distracted with a passenger in the car. After an investigation, police determined the vehicle failed to stop at a stop sign and crossed over Mcguffey Lane before striking the tree. Police also recovered two full bottles of whiskey and one empty bottle of rum in the vehicle.

Boomer failed field sobriety tests and was placed under arrest for DWI. She submitted to a chemical test at the police station and it returned a 0.20 percent BAC.

# **Happy Birthday, Sir Ken**

At 100, there's no chance in slowing down Ken Bailey

eaching any milestone in life is something to celebrate, but to Ken Bailey reaching 100 years is no different than any other year. Bailey reached that milestone on February 2, and is in no hurry to slow down.

"I just think it's absolutely incredible. There's not many 100-year-olds that have it so together," friend and minister Rhonda Cooper said. "He can run circles around all of us."

Bailey was born in 1922, lived through the Depression, served from 1942 to 1945 in World War II, moved to Voorheesville in 1950 and has lived there ever since. He even has the title of Sir Ken Bailey from the French government as a reward for his service during the war. In recent years, Bailey has found a new life that gained him a new extended family and a new outgoing personality.

"It's funny growing up my dad always worked and always occupied with work and then he'd come home and we'd sit together for dinner," Jack Bailey Sr, Ken's middle son, said. "But I don't remember him being as outgoing as he is today back then"

#### Happy to Be Here

For Bailey's 100th birthday, the celebrations spread out over two days and didn't disappoint. On his last day of being 99, Ken, Cooper and her husband went down to the State Police Troop G Headquarters to meet with First Sgt. Trooper Rich Betts. Unbeknownst to Ken, 22 state troopers were waiting for his arrival to surprise him on his special day.

"They all saluted him, he saluted them back and it was really moving," Cooper said.

After his day at headquarters, all Ken wanted to do was go to the Texas Roadhouse for dinner with the troopers. He was excited to have people sing happy birthday to him and dance with the servers.

Those that know Ken constantly joke that there are "seven degrees of Sir Ken Bailey", similar to the phenomenon people may experience in relation to Kevin Bacon. The idea being there are seven people in between you and Kevin Bacon, or in this case, Ken.

"Wherever he goes, someone knows him," Jack said.

A couple sitting behind the birthday table at Texas Roadhouse offered to pay for Ken's meal, not knowing who he was. After speaking to the couple, his family found out that the couple lived on the same street as Ken's grandson.

# Who gets on the bus, and who doesn't



## BCSD proposing changes to bus eligibility for students



**DELMAR** — Bethlehem Central is pitching a proposal that, among other ideas, would ask elementary school families living within 3/4 of a mile away to drive their children to school or have them walk.

The plan is just one of a few

the district is considering to phase-in to practice to address a nationwide and local driver shortage. Bethlehem is proposing changes to bus transportation eligibility to all five of its elementary schools, its middle school and high school for next year.

Currently, all elementary school students can take the school bus. Middle school students who live within a half-mile of the middle school and high school students who

live within one mile of the high school are not eligible for transportation.

Under the new plan, elementary students living within a 3/4-mile radius, middle school students within one mile, and high school students within a 1 1/2-miles, would be ineligible for school transportation.

The district currently has 58 permanent drivers on staff to cover 59 bus routes every day. In 2019, the district had 87 permanent drivers. The district changed its payment structure for its bus drivers earlier this year, offering the highest hourly wage within Albany County at \$23.60, in an attempt to recruit more drivers.

That's step one in a threeyear plan that includes changing transportation eligibility next year, and staggering school start times between the three levels of learning.

The district has discussed possible changes to transportation eligibility, which could impact up to 800 students beginning in 2022-23, since last November. The proposal now on the table would need to be approved by a public vote in May before they are implemented.

If voters approve the proposal, the district expects it could eliminate as many as five bus routes, reducing the number of drivers needed by just as many, and stabilize transportation needs.

Recruiting as many drivers as possible, streamlining routes and ridership and building more efficiency into the system continue to be priorities for both the Transportation Department Bethlehem Central School District

and the district. This year, the driver shortage has resulted in the high school having to return to an earlier start time, late arrivals and departures, changes to the late bus schedules for secondary students, and a shortage of buses for athletics and other afterschool or extracurricular needs.

District families were asked to provide the district feedback in an email last week. The Board of Education is expected to discuss details from that feedback when it meets again on Wednesday, Feb. 16.

Board members are expected to make a decision on eligibility next month. District residents would then be able to vote on the changes adopted by the board during the Annual Budget Vote, scheduled for May 17.

# **Dynamic shift in political landscape**

Bethlehem sees representation shift from Democrat to Republican in State Assembly **By MICHAEL HALLISEY** halliseym@spotlightnews.com

ALBANY — A nonpartisan group weighed in on local races prior to Gov. Kathy Hochul signing

into action the redistricting plans submitted by the New York Independent Redistricting Commission.

Though New York Republicans filed a lawsuit last week arguing that the new congressional maps violate the 2014 state constitutional amendment intended to protect against gerrymandering, Bethlehem Republicans see at least an opportunity in the state's lower house.

From a high-level view, the Campaign Legal Center out of Washington, D.C. sees marginal advantages in state races for U.S. Congress and the State Assembly, with a more balanced layout for the State Senate. However, a dynamic political shift in mapping takes State Assemblyperson Pay Fahy and U.S. Congressman Paul Tonko, both Democrats, away from the voters who elected them in Bethlehem.

Depending on which legislative house, and which one of the two proposed maps you look at, Delmar may share representatives with voters from as far as Valatie, Red Hook, New Paltz, Utica and Binghamton.

Tonko's seat in the U.S. Capitol represented all of the Capital District, including the Tri-City area of Albany, Schenectady and Troy. That's no longer

the case. A redefined 20th Congressional District no longer includes Troy. It no longer includes Bethlehem, either.

Bethlehem now falls under Democrat Antonio Delgado's 19th Congressional District seat, an expansive territory that includes Utica, Binghamton, New Paltz and nearly all of the border towns that abut the Massachusetts state line.

Though local Democrats said they were disappointed with losing Tonko's leadership in Washington, they expressed confidence in gaining Delgado's stewardship.

"I have every expectation that Congressman Delgado is going to be wonderful for Bethlehem, and will equally be responsive," said Bethlehem Democratic Committee Chairperson Joanne Cunningham. "We all look forward to working closely with him as we had with Congressman Tonko."

Sen. Neil Breslin's seat at the 44th District may change numerically to the 45th, but competing interests won't change too much with a new territory that excludes Troy but includes Ravena, Voorheesville and Castleton. The new district extends to Albany County's southern border, west to New Scotland and over the Hudson River into Columbia County.

According to data collected by the New York *Times*, the move adds more Republicans to what is still a predominately blue district. Based on the 2020 General Election, more residents voted for Donald



Trump than Joe Biden, but not by much. Biden won by a 65.4 to 34.6 percent margin compared to 69 to 31 percent.

In the State Assembly, Democrat Patricia Fahy represents the 109th District which previously covered the towns of Bethlehem, Guilderland and New Scotland. Her district also covers a large swath of the city of Albany, where the border zippers across midtown and downtown with a jagged North-South longitude. The new map now has all of Albany in the 109th District, lobbing Bethlehem off of Fahy's territory.

The State Assembly's new map breaks Bethlehem into two separate districts, and shifts representation from Democrat to Republican. The town's leading Democrat called that change "devastating."

Cunningham said she's not happy with two districts sharing Bethlehem. She called Fahy a "tremendous partner" to the town, having garnered funding for area school districts and local endeavors.

"I've looked at the districts, and they sort of looked like Bethlehem was just wedged into their districts," she said. "Bethlehem has a very high expectation and high bar set by Assemblymember Fahy, and we also have high expectations for continued representation."

Cunningham added that her party will work "very, very hard" to ensure town interests are represented under the new districts.

Assembly District 107 now absorbs Delmar and

North Bethlehem, running a southern border along Crebel Road, cutting across the back end of Elm Estates and stretching west along Feura Bush Road before adopting the town's westernmost border.

Delmar is now included in the predominantly rural communities of Rensselaer, Columbia and Washington counties of the current 107th District represented by Republican Jake Ashby. The rest of Bethlehem notably South Bethlehem and Selkirk - now falls upon Republican Chris Tague's seat in the 102nd District.

Tague, formerly Schoharie's town supervisor, is no stranger to issues related to rural communities. Within the state's lower house, South Bethlehem's interests will no longer compete against those of the City of Albany, but they will be included with the likes of Otsego County, the Catskills and everywhere in between.

General Election results paint a tale of different political bases within these two seats.

Tague's territory can be expected to remain red, where Trump earned 57 percent of votes. Ashby's, however, will go from a territory in which Biden squeaked out 51.5 percent of votes, to one where he would have garnered 53.7 percent. Bethlehem, where registered Democrats outnumber Republicans in nearly all of its 31 voting districts, will play a factor this November.

Bethlehem Republican Party Chairperson James McGaughan said his party will keep the town red in that house and anyone who aligns with the party platform "will benefit."

"I am wholly focused on turning Bethlehem red and getting sound governance back in Town Hall, shared McGaughan in an emailed statement to The Spotlight. "Any Republican incumbent or challenger that is newly aligned with the Bethlehem Republicans will benefit. We represent all seven hamlets regardless of changing district maps."

# Gerrymandering: What's it look like?

**ALBANY** — Gerrymandering is a term being thrown around as of late, especially by those who oppose the redistricting plans authored by the New York Independent Redistricting Commission.

The G-word refers to an act by the legislature to remap districts that favors a particular party or social class. The nonpartisan Campaign Legal Center out of Washington, D.C. calls it an act involving either "cracking" or "packing."

"Partisan gerrymandering is always carried out by cracking a party's supporters among many districts, in which their preferred candidates lose by relatively narrow margins; and/or by packing a party's backers in a few districts, in which their preferred candidates win by enormous margins," the organization states as it defines efficiency gap.

The nonpartisan Campaign Legal Center is dedicated to advancing democracy through law and fighting for every American's rights to responsive government and a fair opportunity to participate in and affect the democratic process.

The goal for a fair remapping of districts is to create an equal distribution of party representation among registered voters. There is also the need to balance socioeconomic groups within the proposed territories as well. Anything less would be inefficient.

Cracking and packing are each a matter of perspective. Cracking occurs when breaking down a group of voters against one party, while packing favors the other party for success.

The efficiency gap was created by University of Chicago law professor Nicholas Stephanopoulos. His measurement was used to argue against Wisconsin's redistricting plans before the U.S. Supreme Court in 2019.

In that case, state Democrats argued a Republican-led legislature remapped districts in 2011 to favor future GOP victories. The Campaign Legal Center's PlanScore project calculated an efficiency gap in all three houses — the U.S. House of Representatives, State Senate and State Assembly — that favored Republicans by as much as 11 percent.

New York's plans for redistricting have also been evaluated.

The Campaign Legal Center sees a 2.1 percent efficiency gap determining New York races for the U.S. House of Representatives based on the redistricting plans submitted by the independent advisory committee. That's enough to favor Democrats in 60 percent of predicted scenarios.

While there is more balance within the State Senate (a 0.1 percent gap favoring Democrats), Republicans show a marginal advantage within the State Assembly. In the state's lower house, there is a 1.2 percent gap that the Campaign Legal Center says favors Republicans in 63 percent of predicted scenarios.

Regardless of perspective, even Wisconsin's alleged packing attempts survived in court when in 2019 the U.S. Supreme Court ruled federal courts didn't have the power to decide. The court ruled 5-4, stating "partisan gerrymandering claims present political questions beyond the reach of the federal courts," in an opinion written by Chief Justice John Roberts.

Nonetheless, New York Republicans filed a lawsuit last week, arguing that the new congressional maps violate the 2014 state constitutional amendment intended to protect against gerrymandering.


## **Robert 'Hoagie' McFawn**

## NBT announces \$154.9M net income

**NORWICH** — NBT Bancorp Inc. reported net income and diluted earnings per share for the quarter and year ended Dec. 31, 2021.

Net income for the year was \$154.9 million, up 48.4 percent from \$104.4 million for the prior year primarily due to changes in the estimated impact of the COVID-19 pandemic on expected credit losses. Diluted earnings per share within the same period was \$3.54, as compared with \$2.37 for the prior year, an increase of 49.4 percent.

Pre-provision net revenue was \$195.3 million compared to \$193.4 million in the prior year. The increase in PPNR from the prior year reflected higher net interest income and higher noninterest income partly offset by higher noninterest expense. Income from Paycheck Protection Program loans increased by \$7.1 million from the prior year.

Net income for the three months ended Dec. 31, 2021 was \$37.3 million, or \$0.86 per diluted common share. Net income increased \$3.1 million from the fourth quarter of 2020, primarily due to higher net interest income and higher noninterest income, partly offset by higher provision for loan losses.

The fourth quarter 2021 provision for loan losses was \$3.1 million compared to the fourth quarter 2020 provision release of \$0.6 million. Quarterly net income was consistent with the previous quarter and reflected improved revenue generation offset by a higher provision for loan losses and higher noninterest expense.

PPNR for the fourth quarter of 2021 was \$51.5 million compared to \$47.4 million in the previous quarter and \$48.2 million in the fourth quarter of 2020. Income from PPP loans increased \$4.7 million and \$1.9 million from the previous quarter and the fourth quarter of 2020, respectively.



Ken was invited to the State Capitol after his granddaughter and grandson-in-law got in touch with the governor's office. He was given a proclamation for turning 100 and his service.

"It was the head of the NY Department of Environmental Conservation that did it, the senators were all there. I got a proclamation...two or three of them I guess. It was great," Ken said.

Ken had never been inside the capital before, finding the view and the million dollar staircase highlights of his indepth tour. Following his morning, he and his family had dinner at the Barnsider.

"It was kind of low key, but I thought it was meaningful for him," Jack said.

This celebration was smaller than years before, but those were prior to the pandemic. Jack wanted to be safe over having a big celebration. To Ken, the size of the celebration didn't matter much to him.

"I had two good days,' Ken said. "The way I look at it you have to celebrate the day because you can't remember yesterday."

## A Small Town Kid

Ken Bailey was born and raised in Delmar. Growing up during the Depression, he was never too worried about his family's access to food.

"We always had something to eat, didn't know what we were going to eat but we had something," Ken said.

The food security came mostly from his father who worked at A&P bakery repairing machinery. If there was a truck wreck, the family would be able

to pay 25 cents on the dollar for anything that was damaged. An 18-inch wheel of cheese with debris stuck in it would be bought discounted and the debris cut away.

Ken worked at Lavery Farm at 10-years-old and eventually moved to working in the repair shop at 13-years-old. When his boss got drafted for the war, he was told to go to Orange Motors where a job would be waiting for him. Ken only worked there for a year before he too was drafted, but returned to the dealership upon his return in 1945 and worked there for 46 years in total.

In 1942, just weeks before serving in the war, Ken married Florence Eckler. The two met at Sport Haven which was Peter Harris Clothes on Kenwood Avenue. Sport Haven was a popular Friday night hangout with bowling upstairs and roller-skating downstairs.

"I had to skate around three or four times to get up a nerve to ask her to skate," Ken said.

He recalls that in 100 years, marrying Florence and having his three sons were the best parts of his life. However, the newlyweds' time together was cut short.

"The chaplain saw that I just got married, he said, 'you just got married, I'm going to put you on reserve for two weeks," Ken said. "November 18 is when I actually went into the service."



into an almost-dried river bed after realizing they were behind enemy lines. The vehicle's tires kept spinning when Bailey tried to move it, so the quickthinking Bailey had his team cut down trees to get moving again and back to camp.

"I said, 'Colonel, I almost left the car there.' He said, 'if you had, I would've sent you back after it," Bailey said. For Bailey, that battle

was a turning point for the war.

On May 8, 1945 the 4th Cavalry met the Russians 60 miles from Lepzieg, Germany and the combat subsided for him.

Ken's return home, however, didn't take place until November 1, due to a strike in New York harbor. There wasn't a welcome

parade, but his wife did meet him at 2 a.m. that day.

#### Ken to Sir Ken

Upon his return to Delmar, Bailey built a house in 1946 and later built a house in Voorheesville for his family in 1950. Ken still lives there today. Once the war was over, Bailey's top priority became his family.

"He was kind of a person that always paid attention to us as kids and everything was done for the kids, he was that kind of person," son Jack said.

When Florence died in 2005 it left him by himself and unwilling to do much of anything. However, a 2013 Honor Flight sparked a new fire. His friend and minister Cooper said she was no longer taking no for an answer from Bailey, after he declined to fly multiple times. Honor Flights bring veterans to Washington D.C. to see the monuments and memorials. Before the flight, Bailey was quiet about his time in his service.

"It wasn't until my niece got to take the Honor Flight down to Washington D.C. and then he became part of the Patriot Guard

# The City Ballet returns to SPAC

Popular film nights return with Harry Potter and the Prisoner of Azkaban in Concert and The Princess Bride in Concert

SARATOGA SPRINGS — The Saratoga Performing Arts Center announced the return of its resident companies — New York City Ballet and The Philadelphia Orchestra — to their summer home in Saratoga for a diverse season featuring SPAC premieres and debuts by women and Black, Indigenous, People of Color composers, choreographers, performers and conductors, alongside iconic masterworks of the classical repertoire.

New York City Ballet returns with the full company from July 12 – 16, with its roster of more than 90 dancers under the direction of Artistic Director Jonathan Stafford and Associate Artistic Director Wendy Whelan, accompanied by the

New York City Ballet Orchestra, led by Music Director Andrew Litton. The Company will present four programs including the full-length story ballet A Midsummer Night's Dream; an evening dedicated to 20th Century Masters highlighted by Merce Cunningham's Summerspace, returning for the first time since 1967; and a program showcasing works by contemporary choreographers including new pieces by Jamar Roberts and Pam Tanowitz, and the return of Justin Peck's In Creases, gracing the SPAC stage for the first time since its World Premiere at SPAC in 2012. Back by popular demand is also a special "NYCB On and Off Stage" presentation designed to introduce the season with an intimate, up-close look at selected excerpts from the Company's repertory of ballets that will be featured during the residency.

"After two long years without the full New York City Ballet in residence at SPAC, it is tremendously exciting to be announcing the return of the full Company in July 2022. It will be a perfect celebration of their return with timeless works of Balanchine and Robbins, SPAC debuts by Jamar Roberts and Pam Tanowitz, the return of Merce Cunningham's Summerspace, beloved story ballet A Midsummer Night's Dream, and NYCB On and Off Stage. The latter, born from the need to conform to COVID guidelines in 2021, was a format that was immensely popular with audiences. It will be a perfect kick off to the residency – as both an intimate behind the scenes look at NYCB as well as a poignant reminder as to how far we will have come since March of 2020," said Elizabeth Sobol, president and CEO of Saratoga Performing Arts Center.

The Philadelphia Orchestra's three-week residency (July 27 – Aug. 13) will feature Music Director Yannick Nézet-Séguin (Aug. 10–13) leading four programs including a finale featuring Beethoven's Ninth Symphony. Highlighting the

residency is the return of worldrenowned cellist Yo-Yo Ma (Aug. 5) and violinist Joshua Bell alongside star soprano Larisa Martinez (JUL 29). Making their 2022 SPAC debuts is a diverse roster of artists including fourteen-time Grammy nominee Ledisi singing the music of Nina Simone (Aug. 3), pianist and NPR host Lara Downes (Aug. 4), soprano Angel Blue (Aug. 12-13), 26-year-old superstar violinist Randall Goosby (AUG 11), and Philadelphia's premier contemporary ballet company, BalletX (July 27), performing a new work choreographed by NYCB's Tiler Peck.

Also featured will be more than a dozen SPAC premieres including the East Coast Premiere of Contact by Pulitzer Prize-winning composer Kevin Puts composed for the genrecrossing ensemble Time for Three (July 28). SPAC's popular film nights will also return to delight audiences of all ages as the Orchestra accompanies, live to picture, Harry Potter and the Prisoner of Azkaban<sup>™</sup> in Concert (July 30) and The Princess Bride in Concert (Aug. 6).

"SPAC's ambitious and artistically inspiring programming continues our effort to bring significant contemporary works and iconic classics that have never been performed at SPAC to our stage, while also presenting a record number of works by BIPOC and female composers throughout the season," said Sobol.

Tickets will be available beginning on March 7 for members (tiered by level) and on March 16 for the general public. New for this season, evening performances will be held at 7:30 p.m.

#### Thomas Hart Benton

In 1956 Thomas Hart Benton was commissioned by Robert Moses, chairman of the New York Power Authority, to create two murals for the powerhouse building of the state's first hydropower facility in Massena. They feature Jacques Cartier's explorations of the St. Lawrence River and the Gulf of St. Lawrence. Alternately titled The Seneca Discover the French and Jacques Cartier Discovers the Indians, the murals depict the 16th-century encounters from two points of view. These life groups were on view at the Museum when it was at the State Education Building

The original building in Massena where these murals were displayed is now closed to the public. They were removed and conserved beginning in 2018 and are on loan to the New York State Museum until Dec 31. Also. "a small fort, which our people call Fort Orange." 



# More than good taste

Garden Bistro's 24 has a Farm-to-Table menu that promises a feast for the senses

**SLINGERLANDS** — Speak to John Grizzaffi about food and taste won't be the first sense he references, neither will it be the second.

It's a conversation the chef often has when people ask him to describe the contrasts between everyday food and his Farm-to-Table menu at Garden Bistro 24. The difference, he said, is first detected by the eyes and the nose.

"There's a lot more aroma, identifiable aromas to certain things," he said, explaining how herbs and berries enhance the flavor of a dish instead of other staples people are used to in processed foods. "I think a lot of the aromas are lost in transport. When you turn around, aromas are what follows next after sight, and I think it just makes a major difference."

Grizzaffi opened Garden Bistro 24 as the first eatery in Slingerlands' Vista Technology Campus nearly a decade ago with his father, Charles.

Grizzaffi is a graduate of the prestigious Culinary Institute of America in Hyde Park. Known for its food focus and world-class resources, the college is renowned for offering degrees in applied food studies, culinary science, food business and hospitality management. His kitchen is devoid of microwaves and freezers.

Grizzaffi curates fresh food from a dozen different farms, all of whom are listed on the restaurant's website. Outside of the fish made available along the East Coast, meat and vegetables are obtained from farms within the Capital District.

For Grizzaffi, there's nothing fancy about his restaurant. The food is welcoming and authentic, and it brings kids to the table. And, if it's to be a night without the kids, venture on to Garden Bistro's heated patio for a chicken pot pie, a craft beer or some wine.

"We hate the word 'fancy," he said. "When I was a kid, a nice restaurant had to be considered a fancy restaurant. As an adult, absolutely not. I don't crave fancy food. ... A great restaurant is a simple restaurant; and that is, to provide a great environment and food."

## Strength and courage

ALBANY - The world has known Wei Luo as an acclaimed classical pianist since stepping in front of her first orchestra when she was 11, but her passion for the arts extends beyond that of the ebony and ivory often in front of her.

"I think my biggest passion in life is the arts," said Luo. "Obviously, I am a pianist, so I want to express and I want to connect with people with my music, with the performances that I do. Making that connection with people and to love each other, I think that's the most important thing in my life."

Luo's realization of that passion became evident to her during the height of the pandemic. Marked by global shutdowns and frequent quarantines, she would find herself lost while sequestered in a hotel some of whom she has room without a piano. What she soon found was the desire to write poetry.

This Saturday, Feb 12, Luo will revisit her 2017 premiere with the Albany Symphony Orchestra with a performance of Sergei Prokofiev's Piano Concerto No. 3. Later this year,

however, she plans to host an immersive art exhibit in Midtown Manhattan featuring portraits and poetry she wrote about Prokofiev, all the while she plays the work of her favorite composer on piano.

The Russian pianist and composer is dear to her. The composition she is to play at the Palace this weekend is the same piece she performed before the Shanghai Philharmonic when she was 11.

As a child, Wei said, she was quiet. She learned to express herself behind the keyboard, where she would remain for hours. Today, the 22-year-old is in flight while on stage. The electricity she finds in Prokofiev's work appears to surge through her as she plays. Her promotional photographs accentuate this passionate play, freezing in time her long, flowing mane of black hair.

Wei has other favorites, shared on a YouTube channel. But, in recent months, she said she found herself drawn back to Prokofiev while looking for a source of strength and courage.

The Peter and the Wolf composer was a bit of a rebel. Prokofiev's early

works would stray from the conventional. Sarcasms for piano, Op. 17, in particular, presented a manic display of polytonality that prompted one audience to leave in disgust. But his use of the percussive, she said, is what strikes her.

"Especially during the last year, so many things were changing," said Wei, describing her mindset during the COVID pandemic. "I went back to Prokofiev the most and I found so much courage and power to be brave enough to deal with all of these ever-changing problems in life."

Wei comes back to Prokofiev's Piano Concerto No. 3, a fitting tribute to the composer she most admires, just days before Valentine's Day in Albany. The Valentine's Weekend program also includes Tchaikovsky's masterful Symphony No. 6, "Pathétique," and New York City-based British composer Hannah Kendall's The Spark Catchers.

"I am beyond excited to be back with Albany Symphony to perform this masterpiece," said Luo. "The Prokofiev Third Piano Concerto is one of the most powerful yet beautiful concertos of all time with touching melodies, percussive sounds, and electrifying rhythms. It will be a blast!"

Music Director David Alan Miller said he's



## Rensselaer leads workshop to develop New York's hemp industry as revolution in sustainable construction

TROY - Rensselaer Polytechnic Institute brought together academia, New York state government, and industry at a recent workshop to discuss the growing hemp industry and opportunities in New York.

The Seed to City Hemp Initiative combines Rensselaer expertise in design, engineering, and business to develop a holistic plan for a sustainable and economically viable hemp industry for New York.

York State Assembly, New York State Agriculture and Markets, Empire State Development, the New York Farm Bureau, the Manufacturers Association of Central New York, and Rensselaer Polytechnic Institute to discuss next steps for bringing the Seed to City Hemp Initiative to fruition. 

"It was eye-opening to learn more about its environmental benefits and wideranging uses. botanical class of Cannabis sativa cultivars grown specifically for industrial or medicinal use. Hurd makes up 70 percent of the plant by volume and essentially can be used the same way as wood chips. Hemp fiber is among the strongest in the plant kingdom and as strong as glass fiber on a per weight basis. It can be refined into a variety of commercial items, and it has great potential for the construction industry.

The use of hemp composites has the potential to reduce the carbon footprint of the built environment. Rensselaer researchers, including Alexandros Tsamis, assistant professor of architecture and associate director of the Center for Architecture Science and Ecology (CASE), and Dan Walczyk, professor of mechanical engineering and director of the Manufacturing Innovation Center (MIC), presented an overview of agricultural/ horticultural, processing, and manufacturing aspects of going from hemp plant to construction products.

The building and construction industries have embraced the environmental benefits of both hemp fiber and hurd. However, there are technical hurdles that need to be overcome, including the lack of effective stalk processing methods and equipment that does not damage the fiber, lack of material property data, lack of manufacturing methods and, crucially, lack of higher value end-products for the construction industry.

A Rensselaer team is developing several costeffective hemp processing technologies that separate fiber and hurd without adversely affecting their mechanical properties. They are also developing a sustainable degumming method and new hemp bio-composite processing methods.

The Rensselaer team has determined that processing facilities will be required to receive the plants after they are harvested. They are proposing the development

and deployment of hemp "barns" that would serve as multifunctional processing facilities for hemp. Strategically distributed between farming activities and end-product manufacturing centers, a network of processing facilities would help reduce the carbon footprint of the hemp industry and optimize its supply chains. Made out of hemp, the barn building would showcase high-value hemp composite materials for construction and would effectively demonstrate energy savings in buildings.

The Rensselaer researchers are also developing a hempbased rebar reinforcing technology for cement. They are addressing the issues that occur due to steel corrosion by replacing steel with a natural fiberreinforced thermoplastic rebar. Preliminary results have shown a significant reduction in carbon footprint, as well as strength characteristics comparable to steel. The project aims to extend the lifetime of cementbased buildings and infrastructure.

# LIFESTYLE Uptick in home delivery use won't last

## Influential new research can help inform shipping policies, shape industry decisions

TROY — Services like Instacart, Grubhub, DoorDash, and Amazon certainly existed before the COVID-19 pandemic. However, demand for groceries, food, and other products purchased online and delivered directly to your door substantially increased when the coronavirus forced many Americans to stay at home.

But just how much has the demand for deliveries increased, who uses the services, what kind of products are being delivered, and perhaps most importantly, will this increase in usage last? Researchers at Rensselaer Polytechnic Institute are answering these questions to aid policymakers and transportation logistics planners.

In the first comprehensive study investigating the initial adoption and continuance intention of delivery services during a pandemic, Cara Wang, an associate professor in the Department of Civil and Environmental Engineering at Rensselaer, found that over 90 percent of people who use online delivery services would likely revert back to their original way of shopping.

"It is likely that the increased use of e-commerce is not the result of market competition, where the most efficient competitor outperforms the others," Dr. Wang said. "Rather, an external disruption — the pandemic — significantly altered the playing field. Once this external effect is removed, some of the gains made by the delivery services will likely fall off."

Using a survey method and computer modeling, Dr. Wang determined that not all delivery products are the same, nor do all consumers use delivery services in the same way.

Dr. Wang identified four distinct types of users: non-adopters, prior adopters, temporary new adopters, and permanent new adopters. And delivery-service users access products in four different categories: groceries, food, home goods, and other items.

The research showed that both the initial adoption of delivery services and the intent to continue using them varies by goods type. Grocery deliveries had the highest proportion of new adopters, followed by home goods, food, and, finally, other packages. These results imply that the COVID-19 pandemic had a larger impact on the purchase opportunities for essential items than less essential items.

The study also found what while the number of users for grocery deliveries increased by 113 percent during COVID, almost half of these new adopters would not continue to use it once the pandemic is over.

Temporary new adopters accounted for a larger portion than the permanent new adopters for essential items, while there were more permanent new adopters for less essential items.

These findings are essential for investigating the impacts of the pandemic and predicting future demand.

"Answering these questions is essential to estimate the current and future demand for deliveries," said José Holguín-Veras,

director of the Center for Infrastructure, Transportation, and the Environment at Rensselaer and a co-author of the paper. "Transportation professionals and researchers have assumed that people would still rely on delivery services even after the COVID crisis is over. However, in reality, consumers' technology acceptance is much more dynamic and complex during a pandemic than during normal conditions. Understanding these nuanced behaviors is essential for sound transportation policy making.'

The paper, "Adoption of delivery services in light of the COVID pandemic: Who and how long?" was also co-authored by Woojung Kim and Joshua Schmidt, both doctoral students in the Department of Civil and Environmental Engineering at Rensselaer. Founded in 1824,



## CONCERT REVIEW

### Bruce Dickinson at The Egg By JOHN MOORE nippertown.com

ALBANY — It was Groundhog Day, but an appearance by Iron Maiden vocalist Bruce Dickinson – doing a band-and-(mostly)-music-free solo talking show – is hardly a Groundhog Day-type event.

Dickinson hasn't performed in Albany in over 30 years, since Iron Maiden last played the area in January 1991 at the then-Knickerbocker Arena, with Anthrax supporting. Strange, that. Maiden were regulars in the area from 1981, pre-Dickinson, when they first opened for Judas Priest at the Palace Theater, until that 1991 gig, also hitting the Glens Falls Civic Center (3x), and RPI Fieldhouse (2x), with Bruce himself, also playing a solo band show at Saratoga Winners in Latham in 1990. And then nothing for 31 years. Until now.

Bruce isn't known as a spoken-word guy. But the crowd was engaged and into it, and heavily populated by Iron Maiden shirts of all vintages. And why shouldn't Dickinson do spoken word? Aside from being the guy from Iron Maiden, he's a fencer (has competed internationally), an aviator (and a former airline pilot), an author (including some fun Douglas Adams-style novels), a DJ, and a brewer. Lots to talk about.

To be sure, there was some Iron Maiden-related talk from Mr. Dickinson, but this wasn't a night of Maiden stories: he covered a gamut of subjects, delivered animatedly, with English humor sprinkled throughout, and spot-on vocal imitations of band-mates, his manager, and stuffy, sexually inappropriate schoolteachers.

And he covered everything from birth (cleverly working in the "Egg" angle) to his battle with cancer. His early years were covered with humor – home town (Worksop, UK), parents, grandparents, attending "public" (i.e. private) boarding school as a youth, and getting kicked out for a manure delivery to the school's front steps. Regarding family, he returned often to an uncle, a former WWII fighter ace, which fit neatly into his early years and later aviation adventures.

And, of course, music. Bruce delved into school-era bands, discovering Deep Purple, being on his university concert committee and bringing the band Gillan to campus, and playing pub gigs with his University band Shots. As an NWOBHM enthusiast, I liked that he told a whole lot of stories about his pre-Iron Maiden band Samson, who put out some great LPs with Dickinson between 1979-81 and got exactly nowhere success-wise (although those are some killer metal records., if you can find them). And of course, there were tales involving Iron Maiden.

But he did delve – a lot, and it was a highlight of the talk – into his experiences as an aviator, being an airline pilot in the early 2000s, and travels connected thereto. And of course, as he discussed at length in his autobiography a few years back, his experiences with cancer, chemo, radiation, and a funny story of his beard falling right off his face as a result of chemo – while he was drinking in a pub.

The night finished lead to one of the best stories of the night – that Maiden drummer Nicko McBrain was actually the first band member to become a pilot, which led to a tale about how, while the band was rehearsing on the Isle of Jersey in the 80s, Bruce and a fencing comrade became trapped in northern France across the English Channel, and he convinced Nicko and his flight instructor to fly a 140 HP small engine plane over to France to get Bruce back to Jersey, a hilarious story punctuated with some great McBrain impressions.

The whole thing lasted a hefty 3-plus hours, but went quickly, and wrapped up with the only bit of music of the evening. Dickinson belted out an a cappella version of "Revelations", from Maiden's 1983 'Piece of Mind' record, and exiting the stage to applause.

Great night, and top points to Bruce for an engaging talk.

# More than good taste

Garden Bistro's 24 has a Farm-to-Table menu that promises a feast for the senses

**SLINGERLANDS** — Speak to John Grizzaffi about food and taste won't be the first sense he references, neither will it be the second.

It's a conversation the chef often has when people ask him to describe the contrasts between everyday food and his Farm-to-Table menu at Garden Bistro 24. The difference, he said, is first detected by the eyes and the nose.

"There's a lot more aroma, identifiable aromas to certain things," he said, explaining how herbs and berries enhance the flavor of a dish instead of other staples people are used to in processed foods. "I think a lot of the aromas are lost in transport. When you turn around, aromas are what follows next after sight, and I think it just makes a major difference."

Grizzaffi opened Garden Bistro 24 as the first eatery in Slingerlands' Vista Technology Campus nearly a decade ago with his father, Charles.

Grizzaffi is a graduate of the prestigious Culinary Institute of America in Hyde Park. Known for its food focus and world-class resources, the college is renowned for offering degrees in applied food studies, culinary science, food business and hospitality management. His kitchen is devoid of microwaves and freezers.

Grizzaffi curates fresh food from a dozen different farms, all of whom are listed on the restaurant's website. Outside of the fish made available along the East Coast, meat and vegetables are obtained from farms within the Capital District.

For Grizzaffi, there's nothing fancy about his restaurant. The food is welcoming and authentic, and it brings kids to the table. And, if it's to be a night without the kids, venture on to Garden Bistro's heated patio for a chicken pot pie, a craft beer or some wine.

"We hate the word 'fancy," he said. "When I was a kid, a nice restaurant had to be considered a fancy restaurant. As an adult, absolutely not. I don't crave fancy food. ... A great restaurant is a simple restaurant; and that is, to provide a great environment and food."
