#### **Grand Theft Auto**

DELMAR — Bethlehem police concluded a 6-month investigation with the arrest of a Glens Falls man for allegedly stealing a car from a local apartment complex.

Police responded to a call in Bethlehem last August regarding a stolen 2015 Subaru Forester. The victim said her Subaru was missing from her apartment building's parking lot when she went to go to work that morning. The car was unlocked and a spare key was in the vehicle.

Police found the vehicle the same afternoon parked on the shoulder at the corner of Creble Road and State Route 9W.

Kevin Kelly, 41, was transported by Bethlehem police detectives from the Saratoga County jail to the Delmar police station on Tuesday, Feb. 15, and charged with grand larceny auto and grand larceny, both felonies. He was arraigned and released on his own recognizance on those charges to return to court at a later date, but then was transported back to Saratoga County jail.

#### Crash leads to DWI

DELMAR — Bethlehem police allegedly found a motorist behind the wheel and smelling of alcohol when they went to investigate a significantly damaged car on the side in the early hours of Sunday morning, Feb. 13.

Bethlehem police road patrol conducted a vehicle check on a Honda CRV with significant damage after the officer observed it parked in the area of Wexford Road and Elm Avenue. The motor of the Honda was running and the back windshield wiper activated despite there not being any precipitation.

According to reports, John Callagan, 34, of Clifton Park, was in the driver's seat and the officer detected a strong odor of an alcoholic beverage emanating from his breath. The officer observed his face to be droopy and his eyes were bloodshot and glassy. Callagan allegedly told police that he had one vodka drink and had a prior conviction for DWI.

Callagan was given and failed field sobriety tests and tested positive for the presence of breath alcohol on a pre-screening device. He was placed in custody and transported to the police station where a chemical test returned a 0.18 percent BAC.

Callagan's front license plate was found on Elm Avenue and

officers completed an accident report where it is alleged he damaged a CDTA sign and two mailboxes. Neighbors reported hearing a loud bang in the area around 2 a.m.

Callagan was charged with aggravated DWI, driving the wrong direction on a one-way street and moving from a lane unsafely.

He was issued tickets, given his license plate back and will return to Bethlehem Town Court on Tuesday, March 1.

#### **Identity theft**

DELMAR — Bethlehem police arrested Syracuse woman after an investigation into funds taken from a local man's SEFCU account.

The victim reported that he had received his tax return of \$6,000 into his account, but observed \$8,750.16 was transferred out.

On Wednesday, Feb. 9, detectives traveled to Syracuse to interview Marisa Scott, 29, about the incident and later taken into custody. Scott was charged with grand larceny, identity theft to obtain goods and identity theft to commit a felony, all felonies. She was arraigned and released with a court date of Tuesday, March 1.

### AG cites food company for false claims

AG's office finds lead in'lead free' baby food sold in local stores

**NEW YORK** – State Attorney General Letitia James issued a letter demanding baby food company HolleUSA end what her office calls "false or misleading claims" about its products.

Last week James called for JSG Babyfood LLC and JSG Organics LLC which does business as HolleUSA — to stop advertising its baby foods as "lead-free" and as having no detectable traces of heavy metals. The levels at which the AG's office tested the HolleUSA pouches, however, do not exceed standards in place in the European Union, where the brand is based.

According to a statement from the AG's office, state-commissioned laboratory tests revealed that several HolleUSA brand baby food products contained detectable levels of lead, cadmium, and arsenic. The food products are sold locally at Whole Foods, and online through Amazon.com.

"New York parents should never have to second guess the safety of the products meant for their children," James shared in a statement. "My office found that HolleUSA is misleading or lying to

AG's office ordered three varieties of Holle brand baby food pouches "Carrot Cat" Fruit & Veggie Puree, "Zebra Beet" Fruit Puree & Veggie Juice" and "Veggie Bunny" Veggie Puree marketed to New York and U.S. consumers through HolleUSA's website (Holleusa.com) and Amazon (Amazon.com). Eighteen pouches were tested for heavy metals, arsenic, cadmium, lead, and mercury by an accredited

and nationally-recognized lab. The testing detected one or more of the heavy metals in all 18 of the sampled pouches.

Based on these findings, the AG's office ordered HolleUSA to promptly remove all false and misleading claims relating to its products being free of heavy metals from the company's website and virtual store fronts on online retailers such as Amazon.

The U.S. Food and Drug Administration presently has not established any lead, arsenic or cadmium limits for virtually any category of baby food products (including pureed baby food), though FDA's Closer to Zero plan proposes future changes.

Within days of a February 2021 congressional report finding "dangerous levels" of toxic heavy metals in commercial baby foods, Attorney

General James wrote to the Acting Director of the FDA urging swift action in setting standards for these metals in all baby foods, and requiring baby food manufacturers to test their finished products for toxic metals. After FDA announced a plan that deferred setting any final limits on lead and other heavy metals for years without requiring any stopgap or interim actions, Attorney General James led a coalition of 23 state Attorneys General in an October 2021 petition urging FDA to take several specific interim actions to accelerate protections for young children. The multistate petition is currently pending before FDA.

The AG's office said that it is also continuing her investigation into four of the largest U.S. baby food brands — Gerber, Beech-Nut, Earth's Best Organic (Hain), and HappyBABY (Nurture) — for inorganic arsenic levels in their infant rice cereal products and their marketing of these products in New York.

Engaging in repeated or persistent fraud or illegality, deceptive business practices, and false or misleading advertising violates New York Executive Law and General Business Law. Attorney General James' letter notes that her office reserves the right to pursue any appropriate remedy to HolleUSA's false or misleading advertising of its products.

### County presents \$50K to USCRI

Funding will offset costs for legal services, triage of immigration eligibility

ALBANY — Hundreds of Afghan refugees in Albany County could see a pathway toward citizenship through a new partnership between Albany County and the U.S. Committee for Refugees and Immigrants (USCRI) and Albany Law School.

On Thursday, Albany
County Legislature
Chairman Andrew
Joyce, Legislator Carolyn
McLaughlin and the
County Executive's Office
presented \$50,000 to
USCRI to provide critical
legal services in conjunction
with Albany Law School to
nearly 300 Afghan refugees
that are being resettled in
Albany and Watervliet after
fleeing Afghanistan.

"When I deployed to Afghanistan in 2007 as a Second Lieutenant with the New York Army National Guard to train the Afghan Army and police, the Afghans there taught me about something called pashtunwali. Pashtunwali is an ancient code centered on hospitality, forgiveness and justice. I will never forget how warm and welcoming so many of the Afghan people were to me and my unit during my time there. I am very grateful I am able to continue my service here at home, and to be in a position to extend our own brand of goodwill to the hundreds of Afghans who will now call Albany County home," said Albany County Legislature Chairman Andrew Joyce.

"Albany County has continually proven our commitment to those who immigrate to our country, and today that commitment continues. These Afghan refugees have left their homes and traveled across the globe for a better life, but their journeys are not over. These brave individuals should not have to worry about having their lives turned upside down all over again because they lack proper legal counsel," said Albany County Executive Daniel P. McCoy. "That's why I'm proud to welcome them here with open arms by joining the County Legislature in providing a matching \$25,000 to USCRI to ensure they are able to navigate the complex immigration process and start to rebuild."

The funding will be used to help the Albany office of USCRI, the only refugee resettlement agency in the Capital Region, complete a comprehensive legal screening intake of 250 Afghans to assess and triage their legal immigration eligibility before their chances for permanent immigration status is lost. While some of the refugees will be eligible for family or employmentbased immigration options, many will only be eligible for asylum, which requires applicants to file applications within a year of entering the United States. Without adequate funding, the future of the resettled Afghan community in the Capital Region would be uncertain.

"Albany County's investment in immigration legal services for Afghan evacuees brings us one step closer to providing a pathway to citizenship for our newly resettled neighbors and their families," stated Sara Lowry, staff attorney at USCRI.

Each screening intake requires hours of fact gathering, legal research and analysis as well as interpretation services for Pashto and Dari, the two most commonly spoken languages in Afghanistan. This is in addition to administrative tasks such as case management, scheduling and tracking.

Through the Justice Center at Albany Law School, students enrolled in the Immigration Law Clinic are representing several Afghan individuals and families, and the Immigration Law Pro Bono Society is continuing to help USCRI administer additional clinics to screen Afghan evacuees for immigration relief and match them with legal representation.

"Jacob Mantey, a thirdyear student at Albany Law School, wanted to help refugees affected by the U.S. withdrawal in Afghanistan who are resettling in the Albany area. He launched a project to support USCRI triage intake calls from the Capital District in the fall and since then Albany Law students have volunteered hundreds of hours to diligently address that backlog," said Sarah Rogerson, Director of the Justice Center at Albany Law School. "These students are learning first-hand how to put their knowledge and skills to work helping others. We're incredibly proud of the work they're doing."

#### What's the frequency?

Answers from the 2021-22 survey, which was administered at the height of the Omicron surge in mid-January, were released to district families online on Wednesday, Feb. 16. The district said more than 2,700 people participated in the survey, including 1,849 students in grades 5-12 from the district's seven schools.

"When we saw the alarming increase in COVID cases due to Omicron, we had considered delaying the School Climate Survey but decided to proceed," said Superintendent Jody Monroe. "We went ahead knowing that the survey results could be negatively impacted by another COVID wave. We were prepared to see results from students that reflected some of our own anxiety of living and working in uncertain times. Yet, what we discovered in looking at the data is a student population that still feels safe, supported and engaged at school."

The 72-question survey included responses about school safety, facilities, peer relations, social and emotional support, alcohol and drug use, and school discipline. The student survey results provide the first comprehensive look at how students' perceptions and experiences are being shaped by the COVID pandemic.

Despite nearly two full years of learning against the backdrop of the pandemic, Bethlehem students still report feeling a strong sense of belonging to the school community.

In 2021-22, students continue to be actively involved in extracurricular activities and are supported by faculty and staff with whom they have a positive rapport. Data reflecting the positive relationships between staff and students were largely unchanged or slightly improved since the last full-scale School Climate Survey was administered in December 2019, before the pandemic

began.

In the 2019-20 School Climate Survey, the student results showed some concerning data in the areas of peer relationships and substance abuse. The most recent survey data show small increases in positive responses regarding student-to-student relationships and some significant increases in positive data involving substance abuse.

Specific scores

from the survey can be observed on the district website at https://www.bethlehemschools.org/2021-22-school-climate-survey-results/.

"We continue to look closely at those areas where students are registering concern as well as where our staff needs more support and how we can improve the connections between school and home," said Monroe. "With a survey of this size, the data can tell many stories."

Participation in the School Climate Survey was voluntary. It was offered to students during the school day the week of Jan. 10, 2022. In addition to the student survey, parents and staff — both instructional and support staff — answered similar surveys during a two-week period in January.

"The most important things we are seeing is that our students are resilient in

the face of great challenges and that our faculty and staff have worked tirelessly to make sure students have the tools they need to succeed academically and socially," said Monroe. "We continue to examine all aspects of the data and the results have been shared with building leaders and department heads so it can be used to help guide decision making at the district, school and department levels."



### New Yorkers don't quit their jobs



According to the U.S. Bureau of Labor, food services and accommodation saw a higher percentage of employees leave their jobs last year. Fewer left their government jobs than in previous years.

Less than 2 percent of New Yorkers auit their jobs, fewest in U.S. last year

#### SAN DIEGO, Ca. —

As workers continue to leave their jobs en masse, the phenomenon known as the "Great Resignation" seems to be far from over. According to data from the Bureau of Labor Statistics, quits totaled 4.5 million in November, a record high, and have been trending upward since April 2020. The quit rate—defined as the number of quits as a percentage of total employment—rose to 3.0 percent in November, tying September's record.

Historically, job openings, hires and separations have tracked each other. However, the COVID-19 pandemic has disrupted this pattern. At the beginning of the

pandemic in March 2020, total separations rose to a record 16.3 million as businesses across the country laid off workers and shut down. Separations were also high in April 2020 but then returned to more typical levels and have been trending upwards ever since. At the same time, job openings have been climbing rapidly, reaching near-record levels in October 2021 amidst widespread labor shortages.

As businesses across the country struggle to hire, workers continue to quit in droves. Both total quits and quit rates have been rising since the spring of 2020, causing quits to account for an increasingly large share of total separations. The pandemic has caused many workers to reassess their priorities and look for jobs that offer more flexibility as well as better pay and benefits. Fortunately for them, the current labor market puts workers in

a good position to make headway on these goals. Job openings currently total 10.6 million, and with 6.9 million unemployed workers, there are about 1.5 jobs per every unemployed workers.

While quits tend to be higher in lowerpaying sectors, quits have been rising across nearly every industry. The accommodation and food service industry, which includes restaurants, bars, and hotels, had the highest quit rate for 2021 at 5.7 percent. Additionally, the industry had the greatest increase in its quit rate from 2020 to 2021, at 1.5 percentage points. Government had the lowest quit rate in 2021, and is the only sector that saw a decline in its quit rate year over year.

Quit rates vary across the country due to factors such as local job market conditions, cost of living, and local industry makeup. To determine the states with the highest quit rates, researchers at ChamberOfCommerce. org analyzed the latest data from the U.S. Bureau of Labor Statistics. The researchers ranked states according to the overall quit rate in 2021. Researchers also calculated the total guits in 2021, the percentage point change in the quit rate from 2020 to 2021, and quits as a percentage of total separations in 2021.

The analysis found that the overall quit rate in New York State reached 1.8 percent in 2021. Overall, New York State saw 1,581,000 quits last year. Out of all U.S. states, New York reported the lowest quit rate in 2021. Here is a summary of the data for New York State:





### Albany Med trauma team earns awards

Jasmin Adderley, LPN, Senior Trauma Registrar, who is responsible for ensuring complete and accurate patient demographics and information are entered into the Trauma Registry and submitted to the New York State Department of Health and National Trauma Data Bank.

Thomas Moran, MA, EMT, CPST, Trauma Education, Injury Prevention and Outreach Coordinator, who is responsible for planning, development and oversight of the Albany Med trauma injury prevention program. Moran also leads education efforts among members of the adult and pediatric trauma programs at Albany Med and across the region.

Damon A. Russo, MS, RN, Trauma Program Quality Specialist, who works with trauma program leadership to coordinate and facilitate performance improvement efforts. Russo uses data, focus studies and clinical indicators to develop standards and tools for the trauma program.

"There were only five Trauma Distinction Awards presented within the state and the fact that the Albany Med Trauma Program received three is a testament to what I see every day," said Kurt Edwards, MD, Chief of Trauma and Critical Care in the Department of Surgery at Albany Med. "These award winners are some of the most innovative, intelligent, and dedicated trauma personnel in the state."

### UAlbany among best for social research

ALBANY — The University at Albany has been recognized as among the best universities for Social Research according to the Higher Education Research and Development (HERD) Survey released by the National Science Foundation.

In 2014, New Yorkers overwhelmingly supported a constitutional amendment to form an Independent Redistricting Commission. It would put politics aside and ensure a fair and balanced system to redraw congressional and legislative maps for the next decade.

What could go wrong? Short answer, everything.

Despite meeting numerous times and receiving input from residents across the state, the commission failed to deliver an agreed upon set of maps, which in effect, left super-majority Democrats in the state Legislature with complete control of the process.

Unsurprisingly, they were quick to reveal their own set of maps which, coincidentally, favored many of their own members and jeopardized several Republican seats.

The Democrats gerrymandered maps were

### Did you know?

cientists note there is growing skepticism that the world will be able to keep global warming below 1.5 degrees Celsius during this century.

According to the National Oceanic and Atmospheric Administration, achieving that goal, which could prevent the more dire climate changerelated forecasts from becoming reality, will require dramatic action over the next couple of decades.

The 1.5 degree goal was a point of contention in the recent past, when many European countries felt limiting global warming to 2 degrees Celsius was sufficient. However, small island states felt that the 2 degrees model put their nations in grave jeopardy.

Those nations argued that the extra half a degree would contribute to a rise in sea level that would devastate their countries. That debate is worth revisiting as the outlook for achieving the 1.5 degree Celsius goal looks increasingly dim.

Leaked documents from the United Nations-backed Intergovernmental Panel on Climate Change noted that minimizing global warming to 1.5 degrees Celsius as opposed to 2 degrees Celsius could save the homes of 10 million people and reduce the percentage of the global population that would experience water scarcity by half.







These negative associations discouraged the practice even after technical advances had made it more feasible and affordable. By the terms of

the period, prints were understood as an

art of black and white; if a print had color, it failed to qualify as fine art and had to be considered within some other classification, like illustration or advertising. ### Alzheimer's study: Get yourself to bed

COMPUTER PROBLEMS?

Clearance of protein linked to Alzheimer's controlled by Circadian Cycle

TROY — The brain's ability to clear a protein closely linked to Alzheimer's disease is tied to our circadian cycle, according to research published last week in

The research underscores the importance of healthy sleep habits in preventing the protein Amyloid-Beta 42 from forming clumps in

PLOS Genetics.

the brain, and opens a path to potential Alzheimer's therapies.

"Circadian regulation of immune cells plays a role in the intricate relationship between the circadian clock and Alzheimer's disease," said Jennifer Hurley, an expert in circadian rhythms, and associate professor of biological science at Rensselaer Polytechnic Institute. "This tells us a healthy sleep pattern might be important to alleviate some of the symptoms in Alzheimer's disease, and this beneficial effect might be imparted by an immune cell type called

macrophages/microglia."

The research was conducted at the Rensselaer Center for Biotechnology and Interdisciplinary Studies, which has a focus on neurodegenerative disease. Dr. Hurley worked with Rensselaer professors Robert Linhardt, a glycans expert and inventor of synthetic heparin, and Chunyu Wang, whose ongoing research has detailed several mechanisms in the production and spread of proteins implicated in Alzheimer's.

"This insight reveals a new mechanism and path to treatment of

neurodegenerative diseases like Alzheimer's through an interdisciplinary approach, and is emblematic of the CBIS strength in research and discovery and provides a new angle to human health and well-being," said Deepak Vashishth, director of the CBIS.

The circadian system is comprised of a core set of clock proteins that anticipate the day/night cycle by causing daily oscillations in the levels of enzymes and hormones, ultimately affecting physiological parameters such as body temperature and the immune response.

Disruption of the circadian system is increasingly associated with diseases like diabetes, cancer, and Alzheimer's.

A telltale sign of

Alzheimer's disease is plaques, extracellular clumps of AB42 in the brain. Macrophages (referred to as microglia when they reside in the brain), which are immune cells that seek and destroy unwanted material, clear AB42 from the brain by ingesting it in a process called phagocytosis. In earlier research, Dr. Hurley and collaborators at the Royal College of Surgeons in Ireland investigated circadian control of macrophages, amassing an exhaustive dataset that made it possible to see which macrophage RNA and proteins oscillate with a circadian rhythm. The researchers noticed oscillations in enzymes that help to make two proteins on the macrophage cell surface – heparan sulfate proteoglycan and chondroitin sulfate proteoglycan-both of which are known to play a role in regulating clearance of AB42.

Could these cell surface proteoglycans be a link between the circadian system and Alzheimer's? In a series of elegant experiments testing this hypothesis, the team established that the amount of AB42 ingested by healthy macrophages oscillates with a daily circadian rhythm. That pattern did not occur in macrophages without a circadian clock. They also measured daily oscillations in the levels of heparan sulfate proteoglycans and chondroitin sulfate proteoglycans produced on the surface of macrophage cells with healthy circadian cycles. Peak AB42 clearance occurred as production of surface cell proteoglycans was at its lowest level, and removal of these proteoglycans increased ingestion, which suggests that the proteoglycans inhibit AB42 clearance.

"What's clear is that this is all timed by the circadian clock," said Dr. Hurley.

"When there's a lot of these cell surface proteoglycans, the macrophages don't ingest the AB42. We're not certain why that would be, but there is definitely a relationship."

That relationship could be used to develop therapies that would encourage greater AB42 clearance, perhaps by boosting the amplitude of daily oscillations, which tend to diminish as we age.

"In theory, if we could boost that rhythm, perhaps we could increase the clearance of AB42 and prevent damage to the brain," said Dr. Hurley.

At Rensselaer, Hurley, Linhardt, and Wang were joined in the research by Gretchen T. Clark, Yanlei Yu, Cooper A. Urban, Fuming Zhang, and Guo Fu, who is now at the Chinese Academy of Sciences. "Circadian Control of Heparan Sulfate Levels Times Phagocytosis of Amyloid Beta Aggregates" was produced with support from the National Institutes of Health, the National Science Foundation, and the Warren Alpert Foundation.

#### CONCERT REVIEW

#### **Tinsley Ellis** at Caffe Lena **By DON WILCOCK**

#### **SARATOGA SPRINGS**

- In the middle of the set, a sociology professor from a prestigious local college leaned back in her seat, cocked her head around, and in her best longshoreman's voice told someone talking behind her to please be quiet.

Tinsley Ellis was not playing a bar with five TVs all tuned to the NFL. This was Caffe Lena, THE listening club that still displays a photo of Bob Dylan sitting at a table with Lena Spencer prior to his signing with Columbia as she "auditioned" him to play her coffeehouse circa 1960.

Tinsley was playing a 1932 National Steel Guitar still so shiny new looking that it gleamed in the stage lights. This was a CD release party for his new Alligator release Devil May Care, a title Tinsley borrowed from a song sung by Elvis in Viva Las Vegas. But Tinsley was parenthetically wearing his dress blues, playing to an audience far more sophisticated than some of the stops on this tour, his first in two years.

While Devil May Care contains 10 originals pared down from 200 Tinsley wrote during his pandemic sequester, he is all about "playing to his receiver" as we used to say in advertising. After his sumptuously long set, he and I recalled his being on my WXLE Backstage Pass show in 1992 and running out to his renta-truck to hear "The Ax Is Gonna Fall" from Trouble Time, his third Alligator LP. He wanted to hear how it sounded on the truck radio. At Lena's, he stepped back from the microphone to hear how he sounded to the room.

He respects his fans and plays to each and every audience as unique and important to his career. He introduced "Shadow of Doubt" from his first CD Moment of Truth as having "sold well under a million copies." In a pre-concert interview, he said, "When I stop trying to get the big deal, then I can really focus on making good music for the fans."

Tinsley's bread and butter are blues-rock originals that he plays using every inch of the fretboard on three different electric guitars, a Gibson, a Fender, and what looked to me like a knockoff of a Lonnie Mack Flying V. He shows incredible dexterity in this realm on originals from his long

career including "One Less Reason," "Beat The Devil," "A Quitter Never Wins,""Way Too Long," "Gonna Cut You Loose," 28 Days without You," "A Message to My Baby" and "Slow Train to Hell."

But he showed a maturity at Caffe Lena that positions him in legacy territory with his Freddie King cover "Double-Eyed Wammy" and Howlin' Wolf's "Little Red Rooster." He told us that Bob Margolin, Muddy Waters' lead guitarist, taught him how to play "Can't Be Satisfied" correctly, and the standout display of his incredible prowess was on "It Hurts Me Too," a blues standard best known by Eric Clapton's cover but a song whose heritage goes back to Tampa Red and later, Jr. Wells.

Tinsley told us that as a teenager he was so intimidated by Howlin' Wolf's largerthan-life countenance that he was afraid to approach him. Now he honors the legacies' memories with covers that support his own much-lauded additions to the genre.

#### **John Mayer** at MVP Arena By CLAUDE SAWYER

ALBANY— John Mayer rolled into MVP Arena on Thursday night, kicking off his "Sob Rock 2022 Tour." This is the third time that Mayer has chosen the venue to open a tour, and his first time back since his summer tour in 2019.

Mayer has always surrounded himself with the world's best musicians and this show was no different. Their collective resume is linked with Elton John and Eric Clapton, The Who and Nine Inch Nails, The Rolling Stones Stevie Wonder and more.

From the opening notes of "Last Train Home" from 2021's Sob Rock, Mayer and company were all business. The track and album are a throwback to a 1980s sound reminiscent of Eric Clapton's "Journeyman." Mayer, for his part, seems to have gone all-in on the retro vibe. Sporting a tan linen suit and Nike sneakers, he looked like he just stepped out of 1988.

During "Shot In The Dark" a neon image of Bob Saget appeared briefly on the screen

behind the band. It was a nice tribute to Saget who passed away unexpectedly last month.


Early radio hit "Your Body Is A Wonderland" was dusted off and given its first full band treatment. The extra instrumentation really filled the song out.

The main set was closed out with fan favorites "Waiting on the World To Change" and "Gravity." The bluesy "Gravity" has always been a highlight of any John Mayer concert. It was nice to have it back in the setlist. He did not play it on the last Albany show in 2019. During the first chorus, Mayer stepped away from the mic and let the audience take over. It was one of those moments that I love about going to live concerts. Thousands of strangers connect over their collective love of the music.

A quick two-song encore followed. 2012's "Born and Raised" found Mayer channeling his inner Neil Young. He closed the set with the upbeat "New Light."Twenty-one songs in two hours is not too bad for a tour opener.


