SLINGERLANDS — On Wednesday, March 5, Bethlehem police observed a black Subaru perform an illegal U-turn on Krumkill Road by the traffic circle and continue on Schoolhouse Road, allegedly crossing the centerline into oncoming traffic.

Police executed a traffic stop and noticed an odor of alcohol emanating from the vehicle. The driver of the vehicle, Lajuan Morales, 40, of Albany, was allegedly putting multiple pieces

of gum in his mouth as the officer approached. The officer attempted to administer field sobriety tests but, according to reports, Morales failed or refused to complete them. He was taken into custody and transported to the police station where he refused a chemical test.

Morales was charged with DWI, a misdemeanor, refusing to take a breath test and other traffic violations. He was issued a bill of particulars and released. He is

scheduled to return to Bethlehem Town Court on Tuesday, March 15.

GUILDERLAND — After a series of traffic violations on state Route 20 on Friday, March 4, State Police stopped a Clifton Park man which led to DWI charges.

According to reports, at approximately 9:42 p.m. police observed Antonio Adonnino, 61, make a series of traffic violations and executed a traffic stop.

While speaking with him, the trooper noticed an odor of alcohol emanating from his breath. Adonnino was administered and failed roadside sobriety tests and taken into custody.

At the barracks he refused to submit to a breath test to determine BAC.

He was charged with DWI, a misdemeanor, and refusing to take a breath test and is scheduled to appear in Guilderland Town Court on Thursday, April 7.

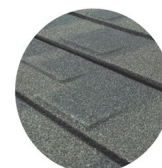

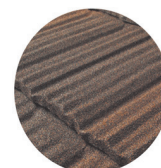

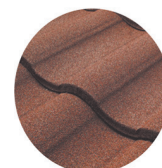

The power cell manufacturing firm is investing \$55 million to construct, outfit and equip Plug Power's new 350,000 square foot plant will be used for expanding production, warehousing and servicing, of its GenDrive fuel cell systems, which offers drop-in fuel cell solutions for existing electric truck fleets.

Additionally, the company has committed to creating 1,633 new jobs, and retaining another 701 jobs in Albany County, to support its new green energy production needs. Empire State Development has agreed to provide up to \$45 million in performance-based Green Excelsior Jobs Tax Credits to encourage the creation and retention of green jobs. In addition, the New York Power Authority (NYPA) Board of Trustees will review a power allocation award from NYPA's low-cost ReCharge NY power program at its public meeting later this month.

"My administration is committed to the aggressive pursuit of economic development opportunities that align with our nation-leading clean energy goals," Gov. Hochul said. "Our transition to clean energy won't just help us respond to climate change and lower utility costs, it will supercharge our economic

recovery and create good jobs. We are grateful to have Plug Power as a partner in our mission to become the nation's hub for green energy development."

Founded in 1997 in Albany County, Plug Power created the first commercially viable market for hydrogen fuel cell technology, and as a result, has deployed over 38,000 fuel cell systems for e-mobility – more than any company in the world – and has become the largest buyer of liquid hydrogen, having built and operated a hydrogen highway across North America. Plug Power announced a partnership earlier this year with SK Group, one of the leading South Korean business groups, to accelerate hydrogen as an alternative energy source in Asian markets. Through this partnership, both companies intend to provide hydrogen fuel cell

systems, hydrogen fueling stations, and electrolyzers to the Korean and broader Asian markets. Plug Power is also partnering with Europe's second-largest automaker Renault Group of France to produce fuel cell-powered commercial trucks.

The project in Slingerlands is just one example of how the Latham-based company has been aggressively expanding in recent years. Plug Power recently opened its \$125 million hydrogen fuel cell innovation center in Monroe County that will create 380 jobs, and has also begun construction on a \$290 million, state-of-the-art, green hydrogen fuel production facility and electricity substation at the Western New York Science, Technology and Advanced Manufacturing Park in Genesee County. The company, the first tenant at the manufacturing park, is also funding the construction of a 450-megawatt electricity substation on site that will support its hydrogen projection facility and future growth opportunities at STAMP.

"Plug Power is proud to further expand its green hydrogen network with our new manufacturing plant located in New York State's Albany County, where we were founded 25 years ago," said Plug Power CEO Andy Marsh said.

In 2019, Plug Power announced plans to expand its presence in New York

State, investing \$3.7 million to establish a Membrane Electrode Assemblies facility in Rochester's Eastman Business Park, creating more than 80 new jobs.

The governor said Plug Power's new footprint in Slingerlands complements the importance to New York State's comprehensive decarbonization strategy. In her 2022 State of the State, she announced that the State will undertake several direct actions to support the development of green hydrogen and invest in communities, including pursuing federal funding to create a green hydrogen hub and combining production and consumption focused activities into a single vision for decarbonization. It also marks the second large-scale project to be introduced within the town of Bethlehem.

"The future is green, and the green future is right here in Bethlehem," said Bethlehem Town Supervisor David VanLuven. "Our planning and engineering teams worked closely with the Town of New Scotland, Albany County, and Plug Power's representatives to move the project quickly and efficiently from concept to construction. The project is a testament to Bethlehem's business-friendly approach and commitment to clean energy, and we expect it to be just the beginning of more green businesses to come."

Laying down the line

SELKIRK — The Bethlehem Town Board approved a measure that will ultimately permit Champlain Hudson Power Express LLC to lay down part of a massive 339-mile underground transmission line that will deliver 1,250 megawatts of high voltage direct current to New York City.

The energy provider is preparing to break ground on the \$3 billion project after more than a decade since it was first proposed. Originally planned to run locally under the Hudson River, public input throughout impacted municipalities has helped shape the path of the transmission line to avoid disrupting protected wildlife or continued pollution of the river.

The local portion of the transmission line covers approximately 24 miles, to follow along CSX rail lines as it runs through four towns, two villages and four school districts, including Bethlehem Central. It's part of a larger, nearly 130-mile long corridor planned to run underground in order to avoid a PCB clean-up site in the northern Hudson River.

New York State Energy Research and Development Authority finalized a contract with Champlain Hudson Power Express last November, an agreement lauded both for the prospect of providing "clean energy" to New York City and for the promise of economic development across the state.

In addition to another contract with Clean Path New York LLC for its Clean Path NY project, the two projects are expected to deliver up to \$7.4 billion in overall societal benefits statewide, inclusive of greenhouse gas reductions and air quality improvements, and \$8.2 billion in economic development across the state, including investments in disadvantaged communities.

Champlain Hudson Power Express already has the necessary permits to proceed with constructing the massive infrastructure project. In relation to Bethlehem, it applied for a Road Use Agreement for West Yard Road, allowing the provider to run the transmission line along the CSX Rail Yard in Selkirk.

Town Board members approved the measure 3 to 1.

Construction is anticipated for later this year.

BC schools collecting goods for Ukraine

Personal hygiene products and baby supplies are also in demand. the collection drive will accept shampoo, toothpaste, toothbrushes, deodorant, bar soap, lotion, tampons/pads and chapstick. baby supplies in demand also include diapers, wipes, powder, infant formula, baby wash and baby food

The collection drive will also collect miscellaneous items that include duct tape, Ziploc bags, garbage bags, flashlights without batteries, Sharpie markers and scissors.

BCMS teacher named NYS Outstanding Social Studies Teacher

DELMAR — Awesome. Kind. Off the hook.

Anyone who has had a teacher they could describe this way would consider themselves lucky. Here in Bethlehem, sixth-graders in Khalan Micieli's classroom must be feeling that way because those are just a few of the positive words they use to describe their social studies teacher at the middle school.

Visit Mrs. Micieli's classroom and you'll understand why. There you'll see a teacher who has a way of connecting with students in a quiet, comfortable way that makes them feel they can open up, ask questions, give their opinions and learn together.

Only now, Micieli's quiet success in the classroom is no longer a secret. On Friday, March 11, she was awarded Outstanding Social Studies Classroom Teacher of the Year from the

Paving a new way towards progress

Elsmere Ave Extension could be key to improving future traffic congestion

DELMAR — Architects envision present-day traffic congestion with an Elsmere Avenue Extension connecting to a completed Kimmey Drive even with the added development it is sure to usher into town.

Without the proposed roadways, however, traffic will increase as development continues south of the Route 32 Bypass. Residents along Elsmere, Murray and Elm avenues will see more motorists on the street, as will those living along Wemple and Feura Bush roads. Homeowners along Hasgate and Dover drives would observe “significant increases.”

several outcomes as it presented its assessment of how the two roadways would impact Bethlehem before the town’s Comprehensive Plan Update Committee met Tuesday, March 8.

The plan to create a traffic artery connecting Elm Avenue and Wemple Road was first suggested when the town adopted its Comprehensive Plan in 2005. Since then, the town has required developers to incorporate a spur within their site plans prior to construction.

Kimmey Drive lies within feet of connecting with Wemple Road at Milltowne Plaza. Approximately a half-mile away, an idle roadway stands ready to intersect at Forsten Drive. From there, another 2,700 feet of undeveloped land remains before Elm Avenue.

Presently a dead-end road, Elsmere Avenue Extension has long been considered to extend and connect as a branch off of Wemple Road. One committee member recalled such plans dating as far back as the 1970s. Since then, housing has grown in developments where driveways connect to side roads, permitting a smoother flow of traffic on the collector road. But in 2010, the Town revealed tentative plans to connect Elsmere to Kimmey

Drive.

Michael Morelli, then Town Director of Economic Development and Planning, shared the idea in a public hearing on Kendall Square over concerns with traffic congestion south of the Route 32 By-Pass, specifically where Feura Bush Road crosses Elsmere Avenue.

What Morelli called a “little stub” is a microcosm of how suburban life appeared in 1954. That’s approximately when each of the four homes was built according to the online realty site Zillow. It has retained what was once farm country around that intersection. Its preservation is due in large part to the nearly 20 acres of productive farmland both east and south of the small neighborhood.

You can spy how development exploded in the area, introducing more than 10,000 more residents townwide since 1984 through timelapse imagery on Google Maps (<https://earthengine.google.com/timelapse/>).

Nearly 20 years later, Kimmey Drive is no closer to completion.

In the Planning Board’s recent letter of recommendation to the committee, it suggested zoning that would permit increased housing density, providing developers the opportunity to afford roadway construction costs. Otherwise, it said the town should pay towards the roadways as an alternative.

SWBR, the architectural firm retained as project manager as the town proceeds with its comp plan update, provided what it stressed as a high-level, regional analysis. Using regional traffic models and studies collected by the Capital District Transportation Committee, the firm assumed the effects of future development on 126 acres surrounding both corridors.

The first of three scenarios assumed various housing units per acre, resulting in approximately 380 units. From that perspective, the study doubles the density under the succeeding cohort producing approximately 750 and 1500 units, respectively.

“Why would we look at anything other than the three

units per acre," SWBR's William Price asked rhetorically. "It's just if this is to be built by the private sector, there's a \$9.4 million item that has to be made — basically your road, along with your utility extension — that has to be built before you even develop a house."

Leaving private developers to fund the proposed roadways adds costs to each unit. Under the current town code of three units per acre, the cost to build Kimmey Drive and Elsmere Avenue Extension would spread to \$25,000 for each unit. Under moderate development (750 units), the cost reduces to \$12,300. Assuming 1500 new units, \$6,130 would fall upon each unit.

While the committee has labored through the plan update process, it has observed detriments to low-density housing models. They work against the town's efforts to both preserve open space and to keep available housing affordable. Price suggested a "sweet spot" that allowed for moderate development around both roadways.

"Upon build-out of 750 units, you would not see increases to traffic, or the congestion much more than what you see today, because these roads would distribute the traffic — both existing and future — well across

the network," Price said.

The firm cross-referenced those numbers with regional traffic demands assuming weekday evening peak hour travel prior to the pandemic outbreak. It then developed three additional scenarios that assumed no new roads, a completed Kimmey Drive, and an Elsmere Avenue connected to a completed Kimmey Drive. The presentation did not quote from specific raw data collected by the CDTC.

SWBR's projections ranged from an increase to traffic flow in the thoroughfares south of the Delmar Bypass without aid from the new roadways, to focusing that growth on those new intersections at Wemple Road, Elm and Elsmere avenues — even decreasing the flow of motorists from Murray Avenue, and parts of Elm Avenue and Feura Bush Road.

Price said studies of specific road segments and intersections would be required to better appreciate the roadways' impact on traffic flow.

Homebuyers braved the cold in January

ALBANY — The Greater Capital Association of Realtors called January a “warm” month for the market in a report it issued recently.

There were 21,554 showings across the Capital District last month, but local realtors said inventory challenges remain, as evidenced by the months’ supply of inventory which decreased from the 2.7 months reported in December to a January supply of 1.4 months with the number of homes for sale 48.3 percent lower compared to last January.

Inventory of existing homes was at 910,000 at the start of the new year, the lowest level recorded since 1999, according to the National Association of Realtors. As a result, competition among buyers remains aggressive nationwide.

Locally, prices have increased compared to last January with the median sales price increasing by 9.2 percent to \$250,000. The percent of the original list price received at sale increased to 98.1 percent. List prices are expected to continue to increase in 2022.

Pending sales increased by nearly 2 percent from January 2021 to 939 for the month. Closed sales decreased 10 percent from January 2021 to 891 for the month. Sales dipped from last year with the continued lack of inventory having a negative impact on other sales metrics.

The sudden increase in rates and home prices means buyers are paying significantly more per month compared to this time last year, which may cause sales to slow as more buyers become priced out of the market.

According to Freddie Mac, the normalization of the economy continues as mortgage rates rise as the country shows signs of emerging from the pandemic. Rate increases are projected to continue due to a growing labor market and the rise in inflation.

Frank Adams has eyes for Wolf Road

Jeweler's plans before Colonie Planning Board outlines move out of Stuyvesant Plaza location

COLONIE — As it celebrates its 100th year in the jewelry business, Frank Adams is looking to move from its home in Stuyvesant Plaza to Wolf Road.

"We have been at three locations in 100 years. This location fits where we want to be for the next 100 years," Jeffrey Russell, one of the owners of Frank Adams, told the Planning Board on Tuesday, March 8. "The location is perfect and the design of the building looks amazing and it will be a focal point on Wolf Road and it will be a destination."

One reason for the move, he said, is the new location will have a dedicated parking lot for the jewelry store while Stuyvesant Plaza is an outdoor mall with many stores sharing a large parking lot. Parking, though, and the configuration of the two proposed buildings on 1.5 acres near the intersection of Cerone Commercial Drive, were a topic of discussion during the sketch plan review.

As presented, the front of the buildings — the second building does not yet have a tenant — would face away from Wolf Road. The jewelry store would be a one-story 7,050-square-foot building and the second would be one-story, 5,750-square-foot.

On the one hand, parking would be code compliant, in the back of the building and not along the major thoroughfare but on the other, the back of the building would face Wolf Road.

"There is a conflict of zoning, but historically, this board has had the practice of moving the building back and allowing the parking in front," said Planning Board member Craig Shamlan. "I would be in favor of pushing the building back further and allowing parking in the front."

Another drawback to the configuration, said Sean Maguire, director of the Planning and Economic Development Department, is that it does not further the objective of making Wolf Road the town's Main Street.

"We want to see Wolf Road active. Not a passive place where cars pull into the parking lot and the people to into the building. If there is no pedestrian activity it looks like dead space," he said. "If we want to leverage Wolf Road as the town's downtown we have to have pedestrian traffic."

Russell said parking in the back of the store is part of an overall security plan for the store that includes bullet proof glass and a full time security guard on site. Also, he said, the merchandise he sells — high end jewelry and watches by makers like

Rolex — does not lend itself to casual pedestrian traffic.

"You don't walk down Wolf Road and decide you want to come into Frank Adams Jewelry. You want to park comfortable in a place that creates a safe warm environment for customers," he said. "We have an approval from Rolex and the approval from some other brands we sell. This whole process has been a year in the works."

Steven Heider, chair of the Planning Board and the former police chief, wasn't necessarily buying the security argument but was not opposed to the configuration as presented.

"Of the activities we had on wolf road, they tend to leave the backway because they know they will get tied up on traffic on Wolf Road," he said. Wolf road wonderful walkable community but they are walking to one of the restaurant or the fast food places. They are not walking to the jewelry stores," he said. "I'm less concerned with parking in the front than the design of the front. It should look like the front of the building even if it is not the front of the building."

Jonathan Draper, the architect from WCGS who designed the buildings, said the side that does face Wolf Road would be glass and "attractive and dynamic."

The project will need to come back before the board at least twice more — for concept acceptance and final site plan approval — before construction can begin and the board is asking for a sketch of having the front of the building face Wolf Road to compare to the current layout.

The site, owned by developer and entrepreneur Tom Burke, is the former home of the Lazare auto store and redevelopment of the site was approved in 2018. A Longhorn Steakhouse was built on the south end of the site and opened in 2019. The two buildings currently in front of the Planning Board would be on the north end of the site and in between there is an approved Hyatt Hotel, but construction was delayed because of the COVID-19 pandemic and the impacts it has had on the hospitality industry.

The Planning Board had previously approved a restaurant for the portion of the parcel where the jewelry store and the second building are now proposed, said Nick Costa, of Advanced Engineering and Surveying, who presented the plan on behalf of Frank Adams. The site is zoned Commercial Officer Residential and would have 64 parking spaces and two means of egress, one on Wolf Road and on one Cerone Commercial Drive. Much of the site work has already been completed as per the approvals in 2018.

Fourth Quarter Fiscal 2021 highlights include Net sales of \$138.9 million, up 24.1% year-over-year, net loss of \$6.0 million versus net loss of \$2.7 million in the prior-year period, representing a 4.3% net loss margin, and an Adjusted EBITDA of \$27.3 million, up 56.5% year-over-year, representing a 19.7% Adjusted EBITDA margin.

Full Year Fiscal 2021 Highlights include Net sales of \$630.5 million, up 56.3% year-over-year, net loss of \$62.3 million versus net income of \$16.0 million in the prior

year, representing an 9.9% net loss margin and an adjusted EBITDA of \$139.8 million, up 66.8% year-over-year, representing a 22.2% Adjusted EBITDA margin.

Net sales for the fourth quarter of fiscal 2021 increased to \$138.9 million, up \$27.0 million or 24.1%, from the prior year's fourth quarter. The increase was primarily attributable to price increases, increased volume, and the acquisition of GL International, LLC ("GLI"), and to a lesser degree, the acquisition of Radiant Pools. 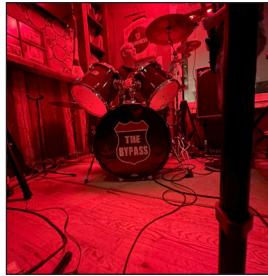

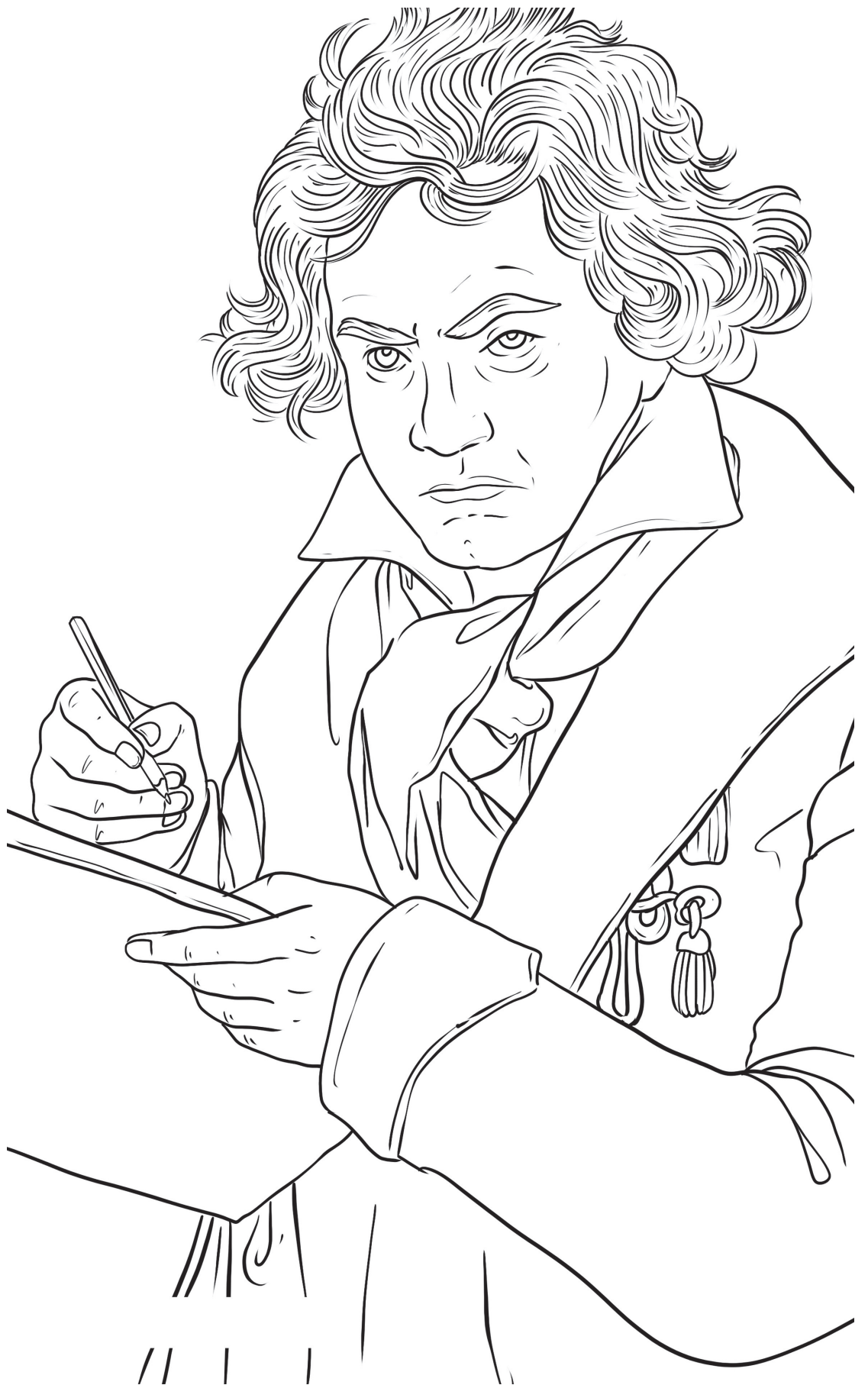

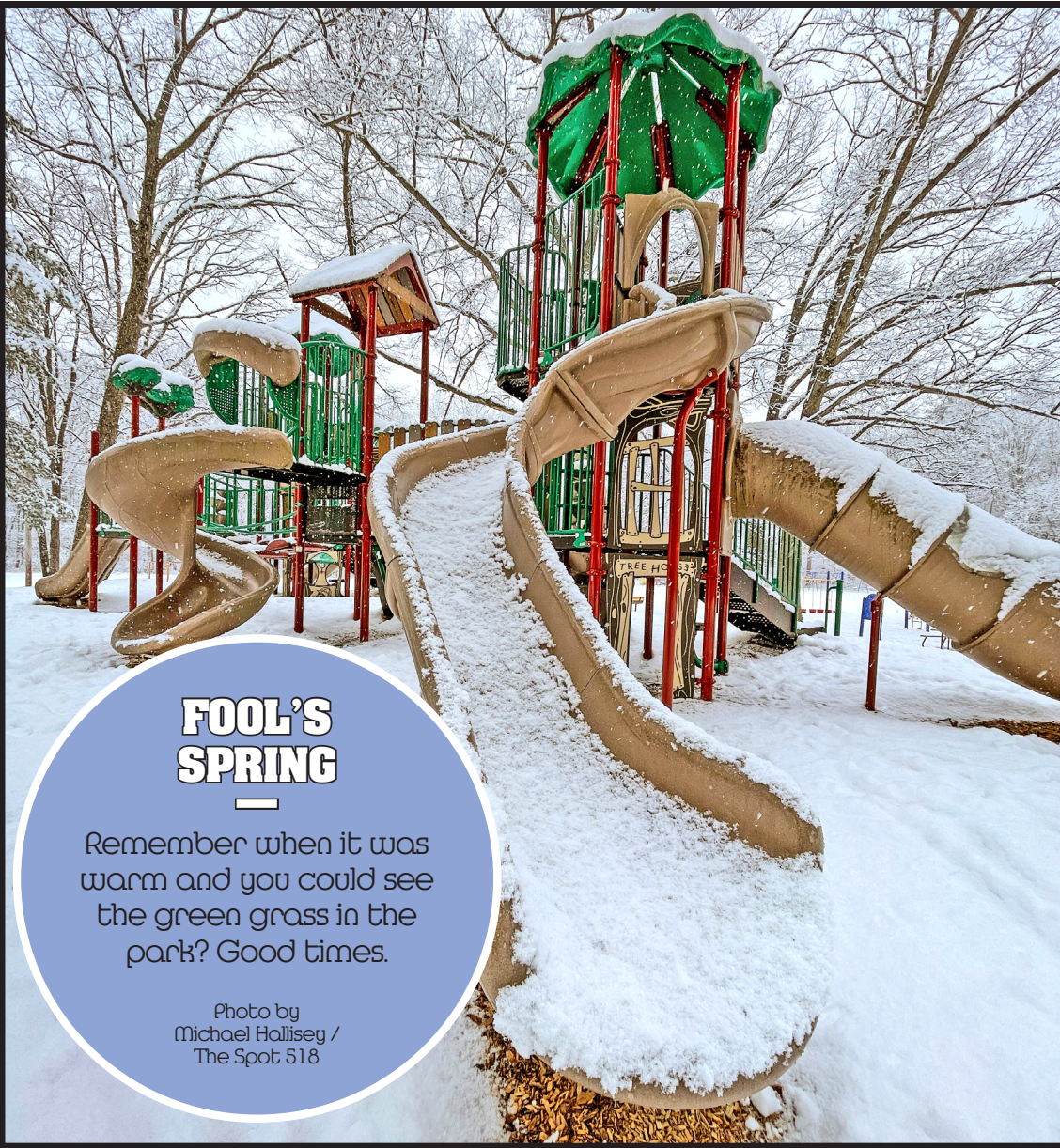

New biz satisfies your creperie itch

The Skinny Pancake opens first New York location in downtown Albany

ALBANY — The Skinny Pancake, a mission-driven eatery focused on serving local food, was welcomed to downtown Albany with a ribbon-cutting ceremony on Thursday, March 10.

The opening of the downtown Albany location, the company's first in New York, comes nearly 20 years after The Skinny Pancake started as a food truck that brothers Benjy and Jonny Adler constructed themselves.

Opening inside the Kenmore Building, the catalyst for the Downtown location came following their participation in a local event in 2019, when Capital Region Chamber President & CEO Mark Eagan recognized a natural pairing between the Vermont-based creperie and what Redburn Development envisioned for the historic Downtown property.

"From their delicious meals, to their fun and funky atmosphere, to their commitment to using local suppliers when possible, we are so pleased to welcome The Skinny Pancake to the Capital Region," he said. "They are the perfect fit for Redburn's redevelopment of the Kenmore

in downtown Albany. We are hopeful that this will be the first of several area locations that will open in the years to come."

With the owners sold on both the vision Redburn Development Partners Principal Jeff Buell shared for the 3,200-square-foot space and the building's development into a commercial and residential hub, the lease was signed, and construction began to build a restaurant where, Benjy Adler said, people would walk in and instantly feel comfortable.

"The Kenmore building is almost 200,000 square feet in total size. The most important spaces in this huge volume are not the 93 apartments, but the 10,000 square feet that make up our street front retail spaces," Buell

said. "These retailers, including the Skinny Pancake, enliven the streetscape and help us move towards our goal of creating an 18-hour downtown in Albany. We are overjoyed to have them in our neighborhood."

The Skinny Pancake customers are greeted by a dining area comprised of both tables and chairs along the walls and a lounge area in the center of the room. Accenting the space are paintings by local artists, a chandelier made from a nearly 100-year-old wagon wheel, and a cast-iron stove emblazoned with "Happy Thought" from a Vermont farmhouse that doubles as a coffee bar.

"At The Skinny Pancake we serve more than food, we serve a

purpose, and our customers are the reason we can fulfill it," Benjy Adler said. "We fell in love with the Capital Region long ago and are overjoyed at the great response we've had since opening."

Crepes, salads, and burgers including vegetarian, vegan, and gluten-free options are served at The Skinny Pancake, with the All Day Burrito and Everything But The Bagel Crepe launching with the opening of the new location. Favorite menu items for Downtown customers, Adler says, are the Johnny Crepe (maple BBQ-pulled pork, maple BBQ sauce, caramelized onions, and Cabot cheddar in a cornmeal crepe) and The Cheesy Chicken Pesto (roasted chicken, house-made pesto, caramelized onions, VT mozzarella and Cabot cheddar). Customers can pair their meals with coffee, teas, sodas, beer, wine, and cocktails.

The Skinny Pancake's expansion was about more than growing their footprint to include both the Green Mountain and Empire States. In Vermont, Adler says, the local food movement is increasingly becoming the standard and that to further their cause, The Skinny Pancake would need to expand outside the state to larger population centers. Customers at the Downtown location are tasting the flavors of local vendors that include Highland Hollow Farm, Halo Wholesale, Indian Ladder Farm, Stacks Espresso Bar, Yesfolk

Tonics, and Wild Hill Maple.

Their mission to build a safer, healthier, and more delicious foodshed while working with communities in ways that go beyond a transactional relationship generally associated with the restaurant industry has taken shape in many forms. The Skinny Pancake is committed to donating 1 percent of their revenue to organizations that directly benefit the local foodshed. On top of what's baked into the company's DNA, as a response to COVID-19 the Adlers launched ShiftMeals to help feed the many unemployed members of the community; since the program began it has grown to include, among other things, community collective garden initiatives.

Benjy Adler was present for the ribbon-cutting ceremony and was also joined by Downtown Albany Business Improvement District (BID) Executive Director Georgette Steffens, Albany Mayor Kathy Sheehan, Albany County Senior Policy Analyst Lucas Rogers.

"It's been amazing to experience people trying their first crepes or revisiting a memory from a visit to our Burlington location, and we are grateful to Redburn Development, our team, and our customers who have welcomed us so warmly into this neighborhood," Benjy Adler said.

Condoms decrease new HIV infections

Increase in condom use has potential to significantly decrease new HIV infections

ALBANY – An increase in condom use has the potential to prevent one in 11 new HIV infections among adolescent males who have sexual contact with other males, according to hypothetical modeling work out of the School of Public Health.

Published in Sexually Transmitted Diseases, the journal of the American Sexually Transmitted Diseases Association, the research team investigated effects of a hypothetical comprehensive sex education intervention, looking at how condom use may change based on different scenarios and simulations — considering important variables like the age of an individual during intervention delivery and whether the intervention is given before they start having sexual contact with other males.

“Condom use not only has the ability to reduce HIV burden

for adolescent males, but it also has the ability to reduce other sexually transmitted infections,” explained Elizabeth Rosenthal, a doctoral student in Public Health and a member of the team. “Creating estimates of how condom use could help avert negative health outcomes may help to inform development — and implementation — of public health interventions.”

Using various data sets that collected information on youth behavior between 2011 and 2017, the research team focused their work on adolescent sexual minority males (ASMM) between the ages of 13 and 18. They assessed condom use in relation to age, year and ethnicity, and predicted what would happen if their intervention increased condom use by 37 percent for five years, and if 62 percent of males who had sex with males received this intervention when they were 14 years old.

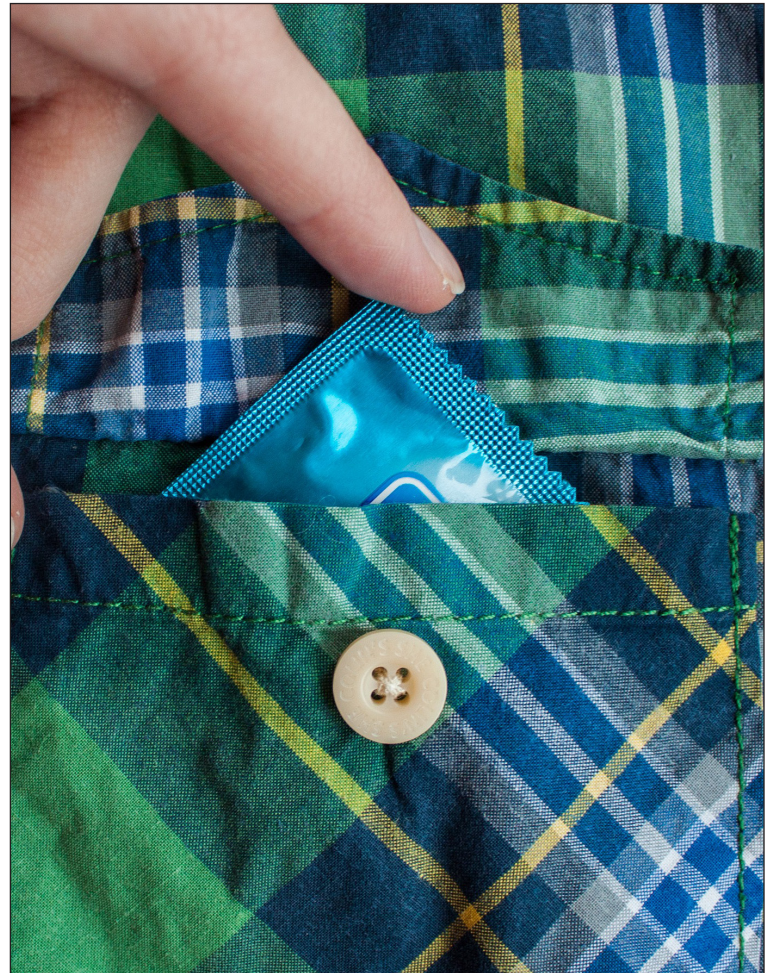
The intervention averted, on average, about 9 percent of HIV infections — or about one in 11 new HIV infections. Overall, the

intervention also demonstrated a lower HIV prevalence after ten years (4.0 percent) among 18 year olds, compared to 4.7 percent without the intervention.

“Despite having higher HIV incidence than heterosexual adolescents, ASMM haven’t received the same amount of research for HIV prevention,” said Associate Professor Eli Rosenberg of Epidemiology & Biostatistics, a contributor to the article. “More research is needed to identify the most effective and efficient strategies for improving condom use for this population specifically.”

The two-time Grammy Award-winning conductor is perhaps known to the public more for his penchant for theatrics than his accolades among the music world. In addition to establishing a career based on promoting contemporary orchestral music, he has taken on the mission of sharing the music with everyone.

"We are a community asset or a community good, and to fulfill that mission we need to be serving our full community," said Robert Pape, Director of Development and Marketing at Albany Symphony. "My mission is not to raise money, and my mission is not to sell tickets. My mission is to share the

experience of orchestral music with the Capital Region."

The symphony has what Pape shared as an IDEA task force. The name serves as an acronym that incorporates inclusion, diversity, equity and access. Albany has embodied that effort through education programs and community engagement. Sunday Symphony is another one of those endeavors.

Sunday's concert is unlike the symphony's other performances. The Sunday matinee opens to a general admission audience where a place in the room costs only \$10. It also strips down the misconception that orchestral music is for

starched-collar socialites. The showcase runs an hour long, with Miller forgoing his colorful socks for a costume more likely to capture attention from the children in the audience. This year's theme promises to bring one of classical music's most beloved composers back in front of a live audience.

The show is set to propel Ludwig van Beethoven over 200 years into the 21st century by means of a time machine just before the reveal of his biggest symphony ever. Kids and families of all ages will help the great composer, portrayed by Albany's maestro, as he prepares for the "premiere" of his latest symphony through an exploration of his fun and familiar music.

"It is David Alan Miller's 30th anniversary and we've been doing a lot to celebrate that this year," said Pape. "A lot of the programming has a particular connection to David. He programmed a lot of his favorite works and [invited] a lot of his favorite, great collaborators. And I think the same is true about Beethoven.

"When it comes to the Beethoven Back to the Future program, it could have been Cowboy Dave or any one of his cast of portrayals over the years. But at the heart of programming that engages youth and embraces his overall mission of making this music available and accessible to audiences... I don't think you can do anyone better."

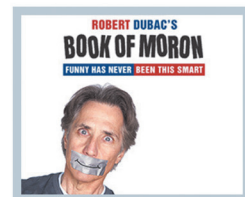

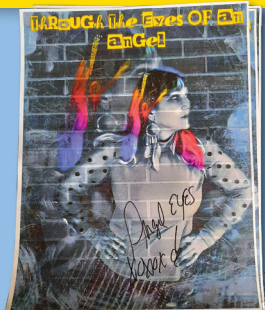

Many families have their own ancestral recipes for Shepherd's Pie, but for those looking to cook the dish for the first time, try "Shepherd's Pie," courtesy of Alton Brown, which appeared in Season 12 of his hit show "Good Eats."

Shepherd's Pie

INGREDIENTS: Yield 8 servings

- 1 1/2 pounds russet potatoes
- 2 tablespoons canola oil
- 1 cup chopped onion
- 2 carrots, peeled and finely diced
- 2 cloves garlic, minced
- 1 1/2 pounds ground lamb
- 1 3/4 teaspoons kosher salt
- 3/4 teaspoon freshly ground black pepper
- 2 teaspoons tomato paste
- 2 teaspoons chopped fresh rosemary
- 1 teaspoon chopped fresh thyme
- 1 teaspoon Worcestershire sauce
- 1/4 cup half-and-half
- 4 tablespoons unsalted butter
- 1 large egg yolk
- 1/2 cup corn kernels, fresh or frozen
- 1/2 cup English peas, fresh or frozen

INSTRUCTIONS

1. Heat oven to 400 F.
2. Peel the potatoes and cut them into 1/2-inch dice. Put them in a medium saucepan and cover with cold water. Set said pan over high heat, cover

and bring to a boil. Uncover, drop the heat to maintain a simmer, and cook until tender, 10 to 15 minutes.

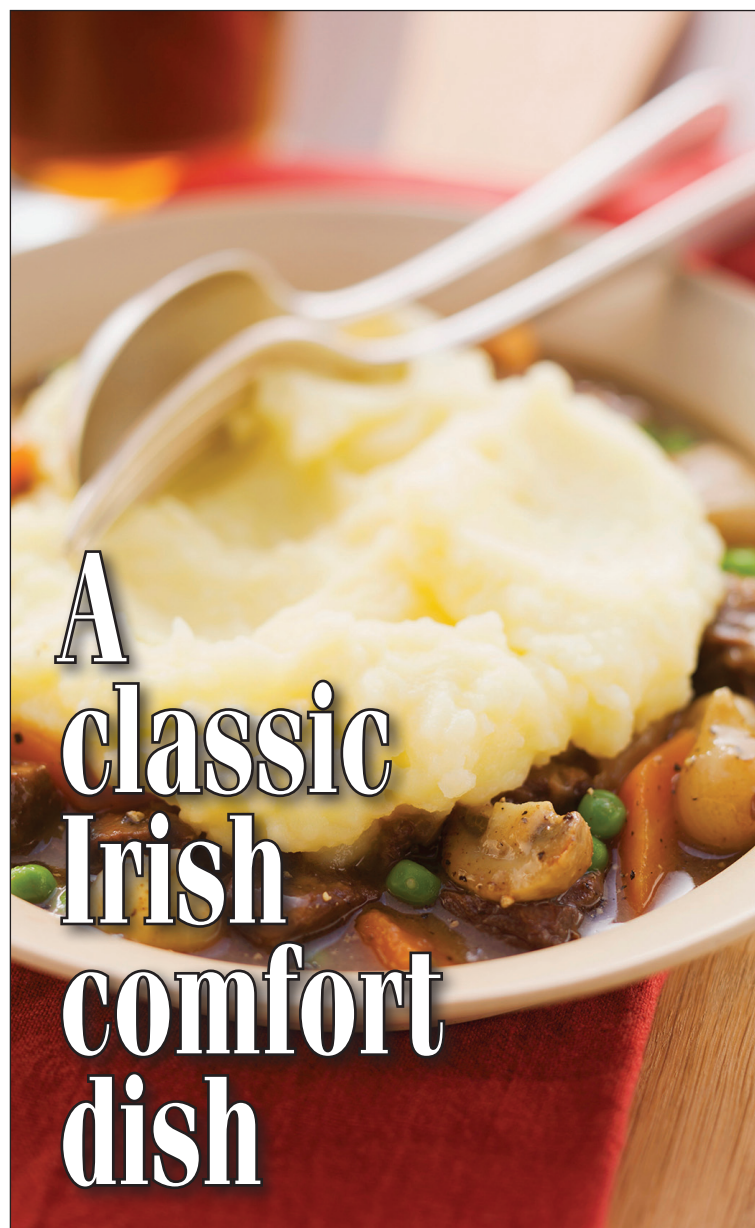
3. Heat the oil in an 11-inch saute pan over medium-high heat until shimmering. Add the onion and carrots and saute just until they begin to take on color, 3 to 4 minutes. Add the garlic and stir to combine. Add the meat, salt and pepper, and cook until browned and cooked through, approximately 3 minutes.

4. Sprinkle the meat with the flour, toss to coat, and continue to cook for another minute. Add the tomato paste, broth, Worcestershire sauce, rosemary, and thyme and stir to combine. Bring to a boil, then decrease the heat to low, cover, and simmer slowly until the sauce is thickened slightly, 10 to 12 minutes.

5. Meanwhile, combine the half-and-half and butter in a microwave-safe container and nuke until warmed through, about 35 seconds.

6. Drain the potatoes and return them to the saucepan. Mash the potatoes (a masher is an excellent tool for this, though a hand mixer will do), then add the hot half-and-half mixture, as well as the salt and pepper. Mash to smoothness, then stir in the egg yolk.

7. Add the corn and peas to the meat mixture and spread evenly in a 7-by-11-inch glass baking dish. Top with the mashed potatoes, starting around the edges to create a seal to prevent the mixture from bubbling over, and smooth the top with a rubber spatula. Place on a half sheet pan lined with parchment paper on the middle rack of the oven and bake for 25 minutes, or just until the potatoes begin to brown. Remove to a cooking rack and let rest for at least 15 minutes before serving.

MUSIC REVIEW

Saucer's Debut Record 'Outside'

POESTENKILL – On March 4th, Saucer released their debut record, *Outside*, and with it unveiled a record that not only remained compelling to listen to from the start to its finish, but also easily, and quickly cemented their sound. With an unmistakable harkening to sounds ranging from the vibes of 1960s through to the alternative rock scene of the early 1990s – as well as some indie-rock smatterings here and there – there was a lot in which one could sink their ears' teeth in to, so-to-speak.

The opening track, "Killing Time," featured a simple drum intro, with guitars coming in fairly soon. Before one knew it, the entire band was all in. Not only were there nice harmonies on this track – a fact often embellished in this album – but the instrumental break that led to the bridge served as an example of effective arranging; it broke up the otherwise monotonous nature of the track. As the band used a lot of alternative rock aesthetics and tendencies from the 1990s on this track, they soon showed their depth of influence with the following, "Miss Loneliness."

A track that contained a very classic chord

progression – especially with strong major and minor chord fluctuations – "Miss Loneliness" incorporated more of a 1960's sound in its instrumentation and arrangement. While not distinctly in the same genre, another callback to this era – in the ears of this particular listener – was "Weeping Willow," track nine. What I really enjoyed, was the almost polyrhythmic nature of this song. Though it was in a common meter of 4/4, it had an almost compound meter feel to it (think triplets). Very catchy and evocative in terms of the arrangement, "Weeping Willow" was simply a great song. It could seem like Saucer darted around with

their genres across this album, the tunes "Priority Targets" and "Beggin'," tracks three and four, respectively, showed the band's comfort with punk-rock elements.

A fairly straightforward, catchy rock tune, in the vein of such acts as Sugar, "Priority Targets" oozed a vocal quality highly reminiscent of Bob Mould. But, aside from a comparison to an icon of Pantheonic (is that a word? If not, it should be!) heights the likes of Mould, this sentiment of punk-alternative nostalgia of the 1990s was further exemplified in "Beggin'." That track was driven mainly by power chords spewing with overdrive and distortion. After the chorus,

a melodic guitar line was heard that hinted at the vocal motif of the track before exploring further sonic textures in the solo. The key change afterward served to develop the end of the song quite well. The band continued developing their sound of overdriven guitars with the following song, "Motorcycle," track five.

Though largely true is the sentiment that *Outside* featured a strong emphasis on various guitar tones, there were moments in the songs "Green Light" and "Attention," tracks six and seven, respectively, that brought more attention (I'm almost groaning at the forced pun, here. Almost) to the bass and drums. With the former tune, listeners

are greeted welcomingly with punchy drums and a slick bass intro. A sonic quality that might remind someone of Dinosaur Jr., it was all-in-all a very catchy tune.

A nice follow-up to "Attention," "Rest," was a pretty straight-ahead tune. What really brought the tune forward, in my opinion, wasn't the arrangement in my opinion, but the display of vocal finesse featured in the last chorus; the melody is shifted forward an impressive octave. The lyric to the chorus was just as memorable as the melody, "Stay with me/Try to get some rest."

The remaining three tunes, "Colors," "Blue Satellite," and "Outside,"

were all further examples of the power behind a good arrangement. For example, in "Colors," we hear a final chord that falls outside the overall key of the track. By doing so, one's ears have a strong potential to perk up, as it was something not expected. But, perhaps most noteworthy of this trio of songs was the final and title track of the record,

very long outro section to the song, and thus the album. A very nice, albeit predictable ending to an album, the method of conclusion gave credence to the mantra of, "If it ain't broke, don't fix it."

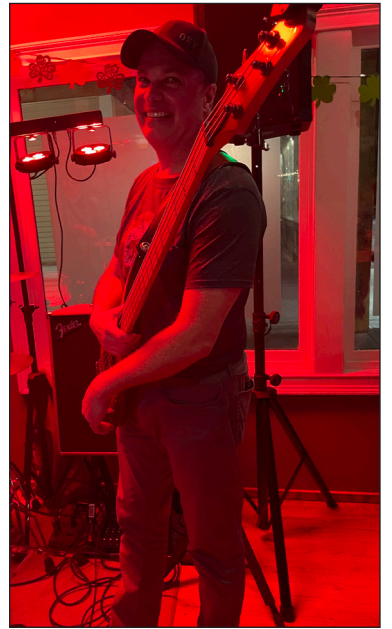
