Guns stolen from Walmart

Guns retrieved from woods, suspect still at-large

GLENMONT — Bethlehem police are searching for a suspect who broke into the local Walmart and smashed into a gun case before walking out the store with five long guns from its sporting goods section on Tuesday morning, May 10.

Bethlehem police said the stolen guns have since been recovered, along with property it said belonged to the suspect.

According to a statement released today, police were called to the Glenmont box store at 311 Rte 9W at approximately 1:16 a.m. for a burglary

The suspect had allegedly forced entry into the store through the garden center entrance before proceeding to the sporting goods department and taking a fire extinguisher to smash open

The suspect left the store with the long guns and fled to the wooded area near Bender Lane where the guns were later found with the help of the Albany County Sheriff's Department and New York State Police.

Neeley is scheduled to return to Bethlehem Town Court on Thursday, May 17.

Sold car leads to arrest of dealership employee

Albany County Sheriff's department arrested a Bethlehem man following an investigation involving a stolen motor vehicle on Tuesday, May 10.

On Dec. 22, 2021, Sheriff's Investigators received a complaint regarding a fraudulent vehicle sale involving Car Wash Cars located at 462 Route 9W in Glenmont.

According to reports, investigators learned that Jay Simard, 54, had sold the victims vehicle at auction and withheld the proceeds after promising the victim compensation for the sale of their vehicle.

Investigators continued to conduct the investigation with New York State DMV Investigators and determined that Simard also falsified business records relating to the sale of the vehicle. He was

charged with grand larceny and falsifying business records, both felonies and was processed Simard was arraigned at Bethlehem Town Court and released on his own recognizance.

Priest named 'credibly accused'

Father Gregory Weider, former St. Thomas priest and National Boy Scout Chaplain, placed on Albany Diocese credibly accused list

ALBANY — The Roman Catholic Diocese placed the Former National Chaplain of the Boy Scouts of America and St. Thomas the Apostle priest on its list of credibly accused of abuse.

The diocese removed Father Gregory Weider from public ministry on Aug. 14, 2021 after a change in diocese policy in response to Child Victim Act lawsuits alleging sexual abuse of minors and two other past claims of abuse in 2004 and 2010.

Weider, 85, served at St Thomas the Apostle as an associate pastor from June 1971 to July 1977 then at St. Mary's in Coxsackie until March 1982. He retired from full-time ministry in 2010 and has recently served as the sacramental minister at Sacred Heart in Margaretville and St. Anne's in Andes, according to a release from the diocese announcing his initial removal in August 2021. Weider was also the National Chaplain for the National Catholic Committee on Scouting in the early 1980s.

"After an extensive investigation, the Roman Catholic Diocese of Albany announced today that it will add Father Gregory Weider, a retired priest of the Albany Diocese, to its List of Credibly Accused for 'reasonable cause' related to

allegations of sexual abuse against minors," an emailed statement from the diocese said Sunday.

Prior to August 2021, the Albany Diocese did not automatically have its Diocesan Review Board open investigations

on CVA accusations, but it did send Weider's prior two accusations of abuse back to the board. Because the diocese was investigating abuse, Weider was put on administrative leave instead of being asked by Albany

Bishop Edward Scharfenberger to take a voluntary leave of absence, which was the protocol for other active priests accused in CVA allegations.

"Once he was placed on administrative leave he was no longer allowed to publicly officiate at sacraments, wear clerical garb, or present himself as a priest," the statement said.

Weider was not the only Albany Diocese priest accused of abuse while serving as Boy Scout Chaplain.

According to diocese records, Weider served as the Diocesan Chaplain for Scouting beginning in 1972 through 1980. His national role with the NCCS began when he was elected to be the Associate National Chaplin in 1980 for a three-year term. According to NCCS bylaws, that

position elevates to the National Chaplain automatically for an additional three-year term which he served until 1986.

During Weider's tenure with the scouts there was at least one claim of abuse against him, but he was not the only Albany Diocese priest accused of abuse to hold the title of Diocesan Chaplain for Scouting.

In 1981 Father James Rosch was appointed by then Bishop Howard Hubbard to be the next chaplain through 1994. He was assisted by Father Charles Gaffigan until 1985.

Rosch was removed from ministry in 2002 and was placed on the diocesan list of offenders in 2015. He is also named in two current CVA lawsuits alleging abuse that took place between 1992 and 1993 at St. Madeleine Sophie in Schenectady and in 1975 and 1976 at St. Joseph's in Scotia.

Gaffigan has two CVA lawsuits accusing him of abuse in 1974 at St. Michaels in South Glens Falls and from 1992 and 1994 at Holy Infancy in Lake Luzerne.

Hubbard then named Father Joseph Schuck in 1994 to the position.

Schuck was a priest in the Diocese of Brooklyn through 1983 but was put on leave and released by the Brooklyn Diocese. He was then picked up by Albany Diocese and served from 1983 until his removal by Brooklyn in 2003 for abuse in the 1950s and was added to their diocesan list of offenders. He did not, however, appear on the Albany diocesan list of offenders as a priest who was removed and served in the Albany Diocese until 2021 after Spotlight News inquired why Schuck was not on the list.

According to the diocese Weider also served at Blessed Sacrament, Mohawk; St. Anthony, Schenectady; St. Agnes, Cohoes; Holy Cross, Albany; Sacred Heart, Watervliet; and Holy Trinity, Schaghticoke, which was the merger of St. John the Baptist and Our Lady of Mount Carmel, Johnsonville, and St. Monica, Valley Falls.

Announcements will be made in the parishes where Weider served, the diocese said.



A paradox between grief and hope

Brother of missing Delmar woman speaks at Shaker High vigil

LATHAM — The hardest part, said Peter Naple, is not knowing. Not knowing if his sister, Meghan Marohn, is alive or dead. Not knowing whether to grieve her loss or hope for her safe return. Right now, he is doing both.

"I know there is the wedge that family and friends and people who care about her find themselves in these days. somewhere between grief and hope," he said during a vigil on Friday, May 13 at Shaker High School where Meghan Marohn is a teacher. "And the uncertainties and the investigations and the unanswered questions and the pain that comes with Meghan not being

to necessarily dwell on Meghan, Ms. Marohn, not being with us. We are here to acknowledge that pain, and bring together the idea of hope for all of us.

"The hope of Meghan Marohn. Her creativity, her beauty, her wisdom, her intelligence and her smile. And the hope for Meghan Marohn so that she will be here with us someday."

Naple, his frustration evident, has offered a \$50,000 reward and is planning to hire a private investigator to assist authorities in finding out what happened

He said he has been to Lee countless times to assist in the search but there are no answers. Her car was found in Stockbridge, near a Church Street trailhead, but within a short amount of time shifted the focus to Lee, Massachusetts.

"The thing is there are not a lot of answers for us right now. We know where her car was found and we know a couple data points from her cell phone but besides that there is nothing else out there," he said. "I can tell you the Berkshire Mountain Search and Rescue, the State Police and Lee Police have searched that area extensively."

He said his sister was a fan of the Berkshires, and has visited Williamstown and Pittsfield but he does not believe she was familiar with Longcope Park.

"It doesn't come up with any searches in the area if looking for a hiking trail," he said. "For her to end up there, we don't know why. My personal belief is the person who gave her the

Church Street trailhead didn't know about the Church Street three miles away."

The Church Street in Stockbridge, he said, is near the Stockbridge Cemetery where Norman Rockwell and other artists and authors are buried. That, he said, is a destination that makes more sense than Longcope Park.

Still, there is no logical explanation as to there being no trace of her whereabouts. He said he would like the investigation to begin exploring different avenues while acknowledging the fact the search effort as included a 100 percent effort.

"I'd like to see a deeper investigation into what happened prior. Why Longcope Park and why so few data points from her cell phone once she gets to Longcope Park for the rest of the day? There are three

data points after 10 a.m. but outside of a and couple cell tower pings there is nothing on her phone which is somewhat of an anomaly. I've been out here and I've seen what my phone does in that area, and the data points I get, and we are both Verizon customers. The lack of data points is what I question and that is what I would like them to delve into. Why only three data points?


You can see her data points, there are plenty and you can see a couple at the corner of Church Street and Lee and Stockbridge Road and besides that we have three ambiguous spots in the private property across from Longcope that extend eight house and nothing else besides her phone being shut off at 8 a.m. Monday morning."

Meanwhile, he said there is another meeting with authorities set for Wednesday, May 18. The search has not been called off, and it is still considered a missing persons investigation.

"The last seven weeks have been trying and we have received a ton of support to see it physically is extremely uplifting and it does give you hope moving forward," he said. "The uncertainty, and the space we have been in for the last seven weeks where we don't know whether to grieve, or we have hope. Is there hope, is there grief? What is there. We have to just continue to have hope we are going to find her and move on from there."

White, who last month prevailed against a field of more than 50 students representing their respective states, is now one of nine students who will compete. She advanced to the final round after a toprated performance in the semifinals of the poetry recitation contest.

A total of 54 students representing every state in the nation along with Puerto Rico, Guam, American Samoa and the U.S Virgin Islands began the semifinal round, reciting two poems each. White chose "Candles" by Carl Dennis "Oranges" by Roisin Kelly for her recitations.

"It has been a joy to have witnessed Pam's ascent through all four rounds of Poetry Out Loud this year; from the school contest to regionals to states, and then the National semifinal," said English teacher Andrew Rickert. "This has required a tremendous amount of time and dedication on her behalf which I commend her for."

The national winner will be awarded \$20,000 and all nine students will walk away with at least \$1,000. Poet, publisher, and New York Times bestselling author Kwame Alexander will host the virtual event that will include poetry recitations by each of the finalists and the announcement of the National Champion.

Rickert, who brought Poetry Out Loud to Bethlehem in 2018 and who has made it an annual tradition every year since had this to say about Pamela White's success in the prestigious poetry recitation competition.

"Advancing beyond the National semifinal truly cements her talent as one of the best in the country," Rickert said. "She's very modest and might not want to look at it like this but the truth is she's outlasted dozens of state champions

and tens of thousands of competitors nationwide. She's kind of a big deal."

For this competition, each student memorizes and recites classic and contemporary poems selected from more than 1,100 in the Poetry Out Loud anthology. Judges review and score the recitations based on criteria including physical presence, voice and articulation, dramatic appropriateness, evidence of understanding, overall performance and accuracy.

A total of \$50,000 in awards and school or organizational stipends will be given at the Poetry Out Loud National Finals, including a \$20,000 award for the National Champion, \$10,000 for 2nd place, \$5,000 for 3rd place, and \$1,000 for 4th-9th places. The representing schools/ organizations of each of the top nine finalists receive \$500 for the purchase of poetry materials. There was one honorable mention recipient announced on May 1 in each of three national semifinals competitions—Niveah Glover (Florida), Eakjot Kaur Sekhon (Nevada), and Morgan Sprouse (West Virginia). Those students do not advance to the June 5 finals, but will each receive a \$1,000 cash award and a \$500 stipend for their school or organization. The Poetry Foundation provides and administers all aspects of the monetary prizes awarded for Poetry Out Loud.

Poet, publisher, and New York Times bestselling author Kwame Alexander will host the virtual event that will include poetry recitations by each of the finalists and the announcement of the National Champion.

The 2022 national finals judges are Francisco Aragón, Candice Iloh, Rosa Joshi, Dante Medema, Joan Naviyuk Kane, and Marcus Wicker. For bios for the judges and more information on the 55 Poetry Out Loud state and jurisdictional champions, download the 2022 Poetry Out Loud program book.

The Poetry Out Loud national finals are administered by Mid Atlantic Arts. The 2022 competition will culminate on Sunday, June 5, 2022, with a one-time-only webcast available on the NEA's website at Arts. gov/Poetry-Out-Loud beginning at 7 p.m. ET / 6 p.m. CT / 4 p.m. PT. Closed captioning in English and Spanish and American Sign Language interpretation will be provided for the Poetry Out Loud national finals.

A partnership of the National Endowment for the Arts, Poetry Foundation, and the state and jurisdictional arts agencies, Poetry Out LoudTM is a national arts education program that encourages the study of great poetry by offering free educational materials and a dynamic recitation competition for high school students across the country. The program starts in the classroom/school or at the local level with an area organization. Winners then may advance to a regional and/or state competition, and ultimately to the national finals. Awards and placements are determined solely by the judges' scores based on the Poetry Out Loud Evaluation Criteria. Poetry Out Loud takes place in all 50 states, American Samoa, District of Columbia, Guam, Puerto Rico, and the U.S. Virgin Islands. Since the program began in 2005, more than 4.1 million students and 68,000 teachers from 17,000 schools and organizations across the nation have participated in Poetry Out Loud. COMPREHENSIVE PLAN

Plan pushes gently to sustainability

Residents ask for stronger language, green initiatives

DELMAR — Peter Iwanowicz thanked the Town Board for allowing him, and the speakers before him, three minutes to speak on the draft Comprehensive Plan update — not the first comment made about the time allotted to residents.

"I'm on the state Climate [Action] Council and we only give people two minutes," he said, before joining nearly two dozen residents who spoke to the board on Wednesday, May 11.

Iwanowicz, a town resident for more than 20 years, is a familiar name and face in Town Hall. As an environmental advocate, it's not uncommon for him to share his concerns on the ecological impact of proposed projects.

"We've also given people two years. So this isn't the first opportunity for people to speak," said Town Supervisor David VanLuven, eliciting a few laughs from the crowd.

The Town Board opened a public comment period nearly a month ago to provide input on the revised zoning plan. The draft document, provided by the Town Planning Department with the assistance of the Comprehensive Plan Update Committee, is more than two years in the making.

Within, the plan committee established several value statements organized by themes to define the plan's expectations for 2035, including community, public services, environment/sustainability, land use and transportation. and market forces, the end Six overarching principles, based on the American Planning Association's Sustaining Places: Best Practices for Comprehensive Plans (January 2015), were identified as interwoven equity, livable built environment, harmony with nature, resilient economy, healthy community, and responsible governance and regionalism.

"It's a good and solid document," Iwanowicz said, but one in which he and others suggest should be "explicit" in its language towards climate mitigation, including that the town outlaws fossil fuels as an energy source in new buildings. He further pushed against the use of fossil fuels, encouraging the town's effort to electrify its vehicle fleet and advocating against future installments of gas and diesel pumps.

"Between new state law

of internal combustible engines in passenger and other vehicles is rapidly approaching. Thus, there really is no need for additional gasoline and diesel fuel pumps than what fall under conservation we already have. So the plan easement. She also should be explicit that no new pumps be allowed in the town," he said.

The 216-page plan update, drafted with the assistance of project consultant firm SWBR, directs investing in infrastructure improvements and public facilities, addresses housing needs, considers new zoning regulations, conserves ecologically sensitive areas, becomes more environmentally sustainable by addressing climate change and resiliency, and recommends issues for further study.

Pamela Skripak, of Delmar, commended board members for the "awesome responsibility" they are each about to take in light of climate change — a common thread throughout the plan. She introduced herself as the owner of seven acres, six of which suggested stronger language for a plan she said will serve as a guideline "well past the tipping point for climate disruption."

Skripak suggested regulating pesticide use and only allowing "significant" tree removal with a permit.

"I know that landowners assure us that they are caring for their lands, and they are not looking to develop them, and I am truly grateful for their commitment and their stewardship," she said. "But, as we have seen, that stewardship only works until it doesn't. And then, all of a sudden, an important biodiverse scenic track of land is suddenly

turned into houses with monoculture lawns and paved driveways."

In an email to the town supervisor, resident Jeff A. Vadney stated he "wouldn't want to be in your shoes." The owner of 70 acres of farmland at the end of the Delmar By-Pass openly asked if residents appreciated the ramification of their suggestions. The push for preserving farmland, for example, is not environmentallyfriendly, he said. It requires pesticide use.

"There have been plenty of times when I thought, 'Gee, if I do ABC that would be a great idea.' Then afterward, when the consequences of ABC turned out to be XYZ, which was a bad thing, I wished I never did ABC,' he said. "Did the town residents who wished for all these ABCs really have the time or the knowledge to see the XYZs?"



Glenmont man named new Albany Med Dean

ALBANY — Alan Boulos, MD, a longtime Albany Med neurosurgeon and 1994 graduate of Albany Medical College, has been named the 18th dean of Albany Medical College.

Bureau to oversee unregulated pharmacy benefit managers

Department of Financial Services to establish standards to protect consumers, independent small businesses

ALBANY — Gov. Kathy Hochul announced last week the first-in-the-nation approach to bring much-needed oversight to pharmacy benefit managers with the creation of the Department of Financial Services' Pharmacy Benefits Bureau.

The new bureau, announced on Wednesday, May 11, will be tasked with licensing and supervising the industry, keeping a watchful eye on pharmacy benefit managers' impact on consumers and the cost of health care.

Pharmacy benefit managers are key intermediaries in the prescription drug supply chain that have, without regulatory oversight, long controlled the price of drugs for health plans and reimbursement rates for pharmacies.

"As we continue our comeback from the COVID-19 pandemic, it's crucial that we take every opportunity to improve the health care system and reduce costs for New Yorkers," Hochul said. "This landmark regulatory body will provide careful oversight to protect consumers from predatory practices in the largely unregulated pharmacy benefits managers industry. My administration remains committed to doing everything in its power to reduce the burden of health insurance and prescription drug costs on New Yorkers."

Earlier this year, Hochul signed into law the most comprehensive regulatory regime for pharmacy benefit managers in the country, assigning DFS new authority to license and supervise the industry. DFS now has the power to address the widely reported problematic practices in the PBM industry which in turn will help lower drug and health insurance costs, protect New Yorkers accessing those drugs, and support New York's pharmacies, many of which are independent small businesses.

Additionally, with the passage of the enacted 2023 State Budget, Hochul secured a \$5 million appropriation to fund and staff the new bureau. As the program fully develops, costs to administer this initiative will be offset through the application of fees, assessments, and penalties directly on the PBM industry, ensuring the cost of regulating this industry will fall on the PBMs, not on the taxpayers.

"The PBM industry had gone

unregulated for long enough," said State Senator Neil D.
Breslin. "PBMs, both here in New York and across the country, have been taking advantage of the lack of transparency at the expense of patients' well-being."

In addition to the regulation of PBMs, DFS' existing authority to investigate drug price spikes now falls under the supervision of the new Pharmacy Benefits Bureau. DFS will continue to review reporting, monitor the market conduct and ensure proper enforcement of consumer protections in New York.

"The health and wellness of New Yorkers depend on having access to fairly priced prescription drugs. With regulatory oversight of the Pharmacy Benefits Industry, DFS will increase transparency and accountability across the industry, ultimately putting more money in New Yorkers' pockets," said Superintendent of Financial Services Adrienne A. Harris.

DFS has met with external stakeholders in preparation for the registration deadlines. DFS reminds all PBMs of their requirement to register with the Bureau by Wednesday, June 1, and to submit their first annual report by Friday, July 1.

DFS will soon file regulatory amendments reflecting the creation of this Bureau.

insects, especially beetles, are scavengers, feeding on dead animals and fallen trees, thereby recycling nutrients back into the soil.

Now they depend on us. The Town of Bethlehem is responding by reimagining part of its front yard.

Saturday morning, April 30, volunteers gathered at the Town Hall to begin the first phase of installation. The group included members of the Bethlehem Garden Club, Cornell Cooperative Extension Albany County Master Gardeners, participants from the Bethlehem Children's School, and members of the Town of Bethlehem community, including Town Supervisor David Van Luven.

Together, this group planted over 30 native shrubs and almost 100 native perennials.

A second phase, scheduled for some time in May or early June, will see installation of another 125 perennials.

The garden was designed by Cornell Cooperative Extension Albany County Master Gardener Program Coordinator, Carole Henry, and Master Gardener Volunteer, Judith Fetterley. Plants have been chosen to be host plants and provide food for pollinators across three seasons, to offer four-season visual appeal to human visitors, and to require lower maintenance.

Funding has been provided by the Bethlehem Garden Club, the Cornell Cooperative Extension Albany County Master Gardener Program, and the Town of Bethlehem.

Future plans include installation of a memorial bench from the Bethlehem Garden Club in honor of Virginia Acquario whose leadership and vision helped to create and maintain many community gardens including the previous garden at the Town Hall. The Bethlehem Children's School will provide an informational kiosk on the site.

of cerebrovascular disorders of the brain and spine including stroke, cerebral aneurysm, carotid and intracranial vessel stenosis, and arteriovenous malformation, as well as complex skull-base surgery for brain tumors.

It was during Boulos's oversight that the former Division of Neurosurgery was granted departmental status in response to its continued growth and strength of its clinical, academic and research pursuits. He will continue to oversee the department.

Boulos comes from a line of neurosurgeons. His grandfather, Samuel Boctor, MD, is credited with bringing modern neurosurgery to Egypt. Dr. Boulos's father, Magdy Boulos, MD, followed in his father-in-law's footsteps, specializing in neurosurgery, and ultimately moving his

family to the United States.

Nearly 840 medical and graduate students are enrolled at the College, which was founded in 1839 and is one of the oldest private medical colleges in the United States.

Boulos will officially be installed as dean at a ceremony later this spring.



Opera Saratoga in search of director

Lawrence Edelson to resign at close of upcoming season

the 2022 Summer Festival
will be his final season
leading the company.

Edelson announced, Wednesday, May 11 that he's resigning to take a teaching position at The University of Houston. Known as one of the most prestigious programs for the training of operatic artists in the country, Edelson will serve the school as both professor of practice and as artistic director of The Moores Opera Center.

"While it is bittersweet to be leaving a company

that I love... the company's new leader will be able to build upon the six-decade history of this remarkable organization," Edelson said. "It has been my great honor to steward Opera Saratoga for the past eight years, and I am excited to see what the next chapter will be for this very special company."

Edelson joined the company in 2014. Highlights of his tenure include multiple world and American premiere productions, including "The Long Walk," by Jeremy Howard Beck and Stephanie Fleischmann, "The Witches of Venice," by Philip Glass and Beni Montresor, and "Ellen West," by Ricky Ian Gordon and Frank Bidart.

Opera Saratoga Board President Martha Strohl noted how such works with "social relevance" brought quality production to audiences, benefiting the experience for young artists and singers within the company.

"He enjoys a high level of success and recognition in the community, bolstering both the reputation of the company and facilitating increased levels of philanthropic support," she said.

Edelson continued the company's attention on its Young Artist Program, which doubled in size in

the near decade he served as director. Company board members also credited him for his continued commitment to community engagement and education initiatives, which included a new therapeutic music program for those living with Alzheimer's Disease and dementia to launch this fall.

With the company forced out of the Spa Little Theatre as the state completes needed renovations to the performance hall, Edelson fostered extensive new collaborative relationships to ensure the upcoming summer festival, which starts Thursday, May 26.

This summer, the company embarks on a tour across the region with performances that include "Sweeney Todd" at the Saratoga Performing Arts Center, "The Barber of Seville" at Proctors, "Sky on Swings" at The Egg,

and Rossini's "Petite Messe Solennelle" at The Round Lake Auditorium.

"Opera Saratoga has thrived under Larry's direction," said Opera Saratoga Board Chair Robert C. Miller. "With a passion for excellence, Larry led with focus, vision, action, and innovation. Larry understood the art as well as the business of opera, always aware that one could never exist without the other. Both artistically and financially, Larry is leaving Opera Saratoga far better than when he arrived. The skill, professionalism, and commitment so ably demonstrated here will serve him well in all his future endeavors. We thank him and we wish him well."

Edelson will continue in his role as Artistic and General Director of American Lyric Theater in New York City, where he mentors emerging opera composers, librettists and dramaturgs and oversees the development of new works.

The company's board of directors is assembling a committee to conduct a national search for Edelson's successor. During the transitional period, Edelson has agreed to serve as a consultant to the company to ensure continuity as Amada Robie continues on as managing director.

"I truly could not have imagined how rewarding my time at Opera Saratoga would be," Edelson said. "I have had some of the most meaningful experiences of my life during my time with the company, and I am deeply grateful to the artists, our entire staff, and our committed and generous supporters who make it possible for Opera Saratoga to contribute so vibrantly to the region yearround."

Skater park

"Discussions around the construction of a skate park have been ongoing for the last several years. Feedback and comments from neighbors, residents, and skaters will help assess the cost and feasibility of undertaking this project," said City Engineer Aaron Vera

The Hoosick Street Bridge has divided the city's hillside communities and downtown residents since its construction was finished in 1981. Nonetheless, attempts have been made to marry the neighborhoods back together over the years.

The area beneath the bridge is the site of The Uniting Line, the city's largest public mural project. Plans are already underway to include lighting and placemaking there to help encourage pedestrian traffic to the basketball courts and waterfront.

Adding a skate park under the bridge was identified in the city's Hoosick-Hillside Study. The 2020 study was intended to field public feedback on how to connect Hillside residents with businesses in the city's burgeoning downtown area. It's a turnaround for a city that had closed its municipal pools just a few summers ago under the weight of debt dating back to the 1980s.

Talk of the skate park follows less than four months after the city finished paying off its \$65 million debt to the Troy Municipal Assistance Corporation. The corporate governmental agency was established in 1996 to keep Troy out of bankruptcy. For 25 years, the city paid into a repayment schedule that involved annual checks of up to \$7 million.

Mayor Patrick Madden announced last week that the City is exploring the possibility of commissioning a brandnew cast-in-place concrete skate park. Grindline Skateparks, the company selected to design the park, is a privately-owned company based out of Seattle, Washington.

The company has designed and built over 400 skateparks worldwide since it was founded by skateboarder Mark Hubbard and co-founder Dave Palmer in 2002. Their portfolio includes the 25,000-square foot Herzliya Skatepark in Herzliya, Israel and the North Houston Skate Park — the largest skatepark in the county – a 75,000-square foot park built in Houston, Texas.

Grindline Skateparks is comprised of "concrete craftsmen" who are former professional skateboarders. Their design process involves collaborating with local skateboarders and stakeholders.

The closest of Gridline's projects includes an approved skatepark in Manchester, Vermont, where the town has as much as \$400,000 committed towards a 12,000-square-foot park. The town of 4,200 people approved the measure prior to the pandemic. A visit


from three-time Olympic gold medalist Shaun White inspired one resident to voice support for the park by means of a letter to the Bennington Banner.

Though not a skater, the author stated that he could see how "skating emphasizes individual style, improvisation, and relentless self-challenge.

"Skaters exist in community, watching and riffing off each other in a cool and slightly distant context, just right for the times," he wrote. "Newcomers catch their breath while watching advanced local skaters demonstrate what's possible with dedication and perseverance."

The City Council meeting will be in person and streamed online via Zoom. The meeting link is available here. Masks are strongly encouraged for in-person attendees, regardless of vaccination status. Attendees will have an opportunity to provide feedback to help shape the final design of the proposed park. An online survey is also available for residents to submit information on the project at https://bit.ly/ TroySkatePark.

Bridging the gap between dities

ALBANY — Gov. Kathy Hochul announced that the State Department of Transportation will host public hearings on May 31 and June 1, giving Capital District residents an important opportunity to learn about this transformative project and provide input. The new \$32.8 billion DOT capital plan includes up to \$400 million to replace the existing, Livingston Avenue Railroad Bridge with a new, modern structure capable of supporting higher-speed passenger rail, freight rail, maritime transport, and bicycle-pedestrian access. The bridge provides a critical link for passenger rail service from the Northeast Corridor to Albany-Rensselaer.

As They Saw It - Images have long been an accompaniment to war, whether to document fast-paced events in the heat of battle, to sway public opinion through propaganda, or to convey deep emotions like grief and fear. As They Saw It presents four centuries of war imagery from Europe and the United States, with an emphasis on the period 1820-1920 The artists featured in this exhibition were not simply bystanders. Many of them served as soldiers or had been expressly commissioned as war artists. To a great extent, artists' nationality and backgrounds influenced the version of events they chose, or felt compelled, to present. Even those who worked far from the front lines were engaged in one side or the other of a battle of images with representations of war playing a substantial role in how the parties to a conflict were perceived and how military and civilian experiences were interpreted, both in the moment and long afterward. From a modern perspective, photography may seem like the most powerful tool for documenting war because of its assumed truth-value. Yet we know this is far from guaranteed. Nonphotographic media like drawings and prints may sometimes convey greater intensity of feeling. Even in the era of photography, there was still a demand for handmade, "interpretive" images of war. Artists continued to rely on more traditional media to tackle wrenching subjects like violence, cruelty, bodily injury, loss of loved ones, and death—which suggests that perhaps there were certain places that the camera could not go, or certain aspects of war that photography was powerless to express. Regardless of the medium, images from conflicts long past force a reconsideration of standard narratives and a confrontation with profound human experiences and emotions. 





1/2 cup chilled all-vegetable shortening

31/2 tablespoons ice water

1/2 tablespoon fresh lemon juice

1 egg white, whisked to foamy (divided use)

Filling

41/2 cups fresh blueberries (room temperature)

1 tablespoon fresh lemon juice

3/4 cup granulated sugar

1/4 cup instant or quick-cooking tapioca, ground

2 tablespoons finely minced crystallized ginger

3/4 teaspoon ground cinnamon

1/8 scant teaspoon ground allspice

2 tablespoons melted butter

3 tablespoons orange marmalade

1/2 tablespoon raw turbinado cane sugar

INSTRUCTIONS

Crust

Combine lemon juice and ice water and set aside. In a medium bowl, whisk flour and salt. Cut in butter and shortening with a pastry blender until coarse meal forms. Sprinkle half the water/lemon mix over flour mixture; toss with a fork. Add remaining half, tossing until dough begins to form a ball. Divide dough in half, flatten it into 1/2-inchthick discs. Wrap each disc in plastic wrap. Chill 30 minutes


Filling

In a large bowl, toss blueberries with lemon juice. In a separate medium-sized bowl, stir sugar, tapioca, ginger, cinnamon, and allspice together until combined. Gently fold into blueberries until well coated. Melt butter, stir in marmalade, then fold into blueberry mixture. Let set.

Pie Assembly

Heat oven to 425 F. Line a baking sheet with parchment paper. On a lightly floured surface, roll one chilled dough disc into a 13-inch circle. Fit dough in a 9-inch pie plate. Trim overhang to 34-inch of edge. Brush egg white over bottom and sides of dough. Reserve remaining egg white. Set the lined plate in the freezer. Roll second chilled disc on a lightly floured surface into a 13-inch circle, then cut into 1-inch-wide strips with a pastry wheel. Retrieve pie plate and pour in filling, mounding slightly toward center. Weave strips of dough over filling to form a lattice top. Seal, trim and crimp edge. Brush reserved egg white over dough. Sprinkle evenly with sugar.

5. Set pie on lined sheet. Bake 18 minutes at 425 F. Reduce heat to 375 F. Bake 50 minutes or until pie is bubbling. Cool on a wire rack. Top with vanilla ice cream.

Feeling 'hangry'?

Factors that can adversely affect mood

o one is immune to the occasional bad mood.

A bad mood can make a difficult day feel even more so, and multiple-person households can become uncomfortable places to be if one person's mood is less than welcoming.

Bad moods can be easy to shrug off, and that may not inspire people to wonder why their generally upbeat outlooks can suddenly take a turn for the worse. Each person is different, so what triggers a mood swing in some individuals may not necessarily do so in others. However, various factors can adversely affect mood. Taking steps to avoid or minimize such factors can reduce the number of days when you feel as though

you woke up on the wrong side of the bed.

Lack of physical activity

A 2019 study from the Harvard T.H. Chan School of Public Health found that running for 15 minutes a day or walking for an hour reduces the risk of major depression. That link is likely connected to the release of endorphins triggered by exercise. Endorphins are hormones that studies have shown contribute to a general feeling of well-being, which explains why a lack of physical activity can adversely affect mood.

Chronic stress

Chronic stress has long been linked to a host of health problems. According to the Mayo Clinic, chronic stress puts individuals at increased risk for heart disease and weight gain but also issues that affect mood, including anxiety and depression. Individuals who find themselves routinely confronting bad moods may be dealing with chronic stress. Identifying the source of that stress and speaking with a health care professional about how to reduce and manage it may lead to improvements in mood.

Hunger

A 2018 study from researchers at the University of Guelph in Ontario found evidence that a change in glucose levels can have a lasting effect on mood. The study, published in the journal Psychopharmacology, found that rats injected with a glucose metabolism blocker experienced stress and depressed mood due to the resultant hypoglycemia. The study lends credence to the notion that many people

have about feeling moody when they don't eat.

Weather

Seasonal Affective Disorder is a type of depression that adversely affects certain individuals' moods during winter, when hours of sunlight are fewer than during spring, summer and fall and when temperatures outside can sometimes be so cold as to keep people indoors for extended periods of time. In addition, a 2013 study published in the journal Social Indicators Research found that individuals report greater life satisfaction on exceptionally sunny days than they did on days with ordinary weather.

Bad moods come and go for most people. Identifying common triggers for bad moods can help individuals prepare for potential mood swings and navigate them in healthy ways.

The show was announced only a few days prior under their alias "Monkeys on Ecstasy," a clue for die-hard fans who've been following them since the 90s. Suke's wailing guitar solos rocked the crowd, as Al Schneider got wild on strumming, making for a spicy jam during "Johnny Lineup". The set ended with fan favorites "Lazarus" and "Buster." "Lazarus" was highlighted by crashing cymbals and a primal, jungle rhythm, thanks to drummer Vinnie Amico and Laughlin. "Buster" got the crowd extra rowdy as they all sang along with the lyrics about pigs.

After a much-needed set break, moe. returned to the stage for a wavy yet robotic "Skrunk." The big show



CONCERT REVIEW

"Deathtrap" gets all the laughs and a fright or two By PATRICK WHITE

"Deathtrap" by Ira Levin is the perennial comedy thriller that opened on Broadway 44 years ago and earned the distinction of being the longest-running comedy-thriller when it closed after four years and nearly 2,000 performances. The Guinness Book of World Records honors the actor Marian Seldes who played the role of Myra Bruhl for every one of the play's 1,793 Main Stem performances as "most durable actress." "Most durable" can be said of the play itself which is never far from a community theater's schedule.

For those who don't know

the plot, it concerns one Sidney Bruhl (Kevin McNamara), a once-successful playwright, who is desperate for his next Broadway comedy-thriller hit when what lands on his desk but the perfect play titled "Deathtrap" by a student (Bill Geltzeiler) who is due to arrive at his remote converted barn studio to discuss the play. No copies exist of the play and as Sydney muses to his wealthy, neurasthenic wife with a weak heart, Myra (Christina Dixon Reeves) could it be possible to dispose of the young playwright and pass the play off as one of his

The play in manuscript Sydney and the student, Clifford, are about to work on is a mirror version of the performance you are witnessing "A thriller in two acts. One set, five characters. A juicy murder in Act One, and

unexpected developments in Act Two. Sound construction, good dialogue, laughs in the right places. Highly commercial." The hall of mirrors continues when Michael Caine is mentioned as a possibility in the movie or especially fun for ACT fans when Kevin McNamara quotes a line from "Angel Street"....a role which he played on this stage 7 years ago.

The cast could not be bettered. Kevin is as smooth as his brandy with a burnished glow, even if you might want something with a stronger kick, at times. Geltzeiler always seems to have a mad glint in his eye which pushes his Clifford right up to the edge of psychosis but his energy is so welcome. Reeves starts tentatively but jump-starts the evening with her horrified reaction to the first violent act in the middle of Act One which

provides one of the evening's genuine thrills. Joan Meyer swans in as the comic psychicnext-door, Helga ten Dorp, and luxuriates in her stage time, sussing out the crime scene and other transgressions, purring delightedly "In my teenage years, walking with boys... such images!" Michael O'Farrell provides yeoman work as the family lawyer updating Sydney on the family's fortunes but gets his own comic reversal as well.

The trick with comic thrillers is they have to be played for life or death stakes for the humor to provide relief otherwise it's just silly. Director Mike McDermott and his seasoned cast score all of the laughs with a small Preview audience but the frights are harder to come by. There's one terrific murder but the other confrontations need more impact, the fight choreographer

was Molly Waters.

It's all played out on a very attractive set (designed by Peter Kantor) that has the requisite wall hangings of window cards and murder weapons and also some great cognac accents. Props on the handbuilt secretary's desk, as well. There are unfortunately some serious lighting issues with weak spots center stage and a long stretch in Act Two played in virtual darkness, although the storm effects were persuasive and deservedly spooky. Lighting design by Robert Healy and sound by Anne-Marie Baker. Costumes by Kody Carpenter were well chosen and most attractive. I especially liked Helga's outfits but everyone looked good and periodappropriate.
