DWI leads to arrest in Feura Bush

FEURA BUSH — On Wednesday, May 11, State Police responded to the Stewarts on Indian Fields Rd for a report of a possible impaired driver.

When the trooper arrived, they located the vehicle and observed the driver, Kindra Prater, 38 of Greenville, pumping gas.

While interviewing Prater, the trooper observed signs she was impaired. She was given and failed field sobriety tests and taken into custody.

At the barracks, Prater was evaluated by a drug recognition expert then charged with DWAI-Drugs and aggravated unlicensed operation, both misdemeanors. She was released and is scheduled to return to New Scotland Town Court on Thursday, May 26.

Attempted dine and dash leads to charges

DELMAR — A couple who attempted to leave without paying their bar tab at a Delaware Avenue restaurant on Saturday, May 21, led to the arrest of a Delmar man for the theft of the

server's cell phone.

Bethlehem police received a call from the server that Joseph Amash, 50, of Delmar and another person attempted to leave without paying their bar bill and took the server's phone. The pair left the establishment in a Ford Escape.

A short time later, police received another call from the server that she had located Amash and the phone. Police responded and took him into custody.

Amash was charged with grand larceny, a felony, given an appearance ticket and released. He is scheduled to return to Bethlehem Town Court on Wednesday, June 7.

Man sentenced for stealing nude photos, possessing child pornography

ALBANY — Michael P. Fish, age 26, of Albany, was sentenced today to 111 months in prison for computer fraud and aggravated



identity theft in connection with his hacking of online social media accounts and theft of nude images of dozens of female victims, as well as possession of child pornography.

The announcement was made by Assistant Attorney General Kenneth A. Polite, Jr.; United States Attorney Carla B. Freedman; Janeen DiGuseppi, Special Agent in Charge of the Albany Field Office of the Federal Bureau of Investigation (FBI); and State University of New York-Plattsburgh Police Chief Patrick Rascoe.

As part of his May 19, 2020 guilty plea, Fish admitted that

from about 2016 to 2019—while an undergraduate at SUNY-Plattsburgh and then as a law student—he accessed the school email accounts of dozens of female SUNY-Plattsburgh students and used information from those school email accounts to gain unauthorized access to the victims' social media accounts.

Fish stole, and traded online with others, private nude photographs and videos stored in the victims' social media accounts.

As a result of these crimes, the school had to allocate money and staff to identifying compromised accounts, reviewing computer

and server access logs, resetting passwords, and notifying students and parents.

Fish further admitted that on March 19, 2019, he possessed several videos of child pornography on his laptop computer.

United States District Judge Mae A. D'Agostino also imposed a 15-year term of supervised release, which will start after Fish is released from prison, and ordered Fish to pay \$35,430 in restitution to SUNY-Plattsburgh.

A co-conspirator, Nicholas Faber, was sentenced to 36 months in prison on August 19, 2021, for computer hacking and aggravated identity theft offenses.

In January 2021, Fish was charged by criminal complaint with obstruction of justice for submitting six fraudulent character letters to the court in connection with sentencing in this proceeding. That case remains pending.

Real McCoy to expand

Brewer will open location at former Huck Finn's Warehouse & More

ALBANY — Delmar-based brewery the Real McCoy Brewing was named among four businesses that will soon occupy space in a newly imagined Huck Finn's Warehouse & More building renamed Slip 12.

Redburn Development Partners unveiled the name to its \$65 million-plus transformational project last week.

Slip 12, a name that harkens to the building's historical industrial use along the Erie Canal, will be the name of the project. The building, which was built in

1918 for the Albany Perforated Wrapping Company, will house 273 apartments and 45,000 square feet of commercial retail space.

"We are excited to be working with the team at Redburn. Since our first meeting it was clear we shared the same vision. Being part of this project in this building in this part of Albany is

very special. Using Albany's rich brewing history as inspiration, Northeastern Construction Services and KT Interiors have fashioned a space perfect for the Slip 12 project, all while maintaining our Delmar roots," said Michael Bellini, owner, the Real McCoy Beer Company.

According to the statement, the Delmar location on Hallwood Road will remain in business. The brewing company opened a baseball-themed storefront at Ballston Spa in 2019. According to advertising, the location stands in the same building General Abner Doubleday was born in 1819.

The first phase of the apartments will be done in October 2022. Commercial retail space will be complete by the late summer/early fall of 2022.

Best in music

“The process was particularly rigorous this year, as in addition to the usual very thorough and detailed questions about the music program, there was an extensive look at how we handled the challenges of music education during the pandemic,” said Brian Bailey, RCS Superintendent of Schools. “We are incredibly honored to receive this award, which we would not be able to receive without our amazing students, Music Department, teachers, staff, RCS Friends of the Arts Group, and community.”

The 2022 Best Communities for Music Education program recognized 738 school districts and 80 schools across 44 states for the outstanding efforts by teachers, administrators, parents, students, and community leaders and their support for music education as part of a well-rounded education for all children.

“This honor exemplifies the Guilderland community’s commitment to include music education as part of an overall quality education for students,” said Marie Wiles, Guilderland Central Superintendent. “As you attend spring concerts across the district, you will see – and hear – the result of the hard work and dedication that contributed to this well-deserved recognition for a twelfth time.”

This year — the program’s 23rd — schools

and districts were celebrated for adapting, innovating, and persevering in the face of change. Researchers at The Music Research Institute at the University of Kansas, in conjunction with The NAMM Foundation, created a new way for districts and schools to address the inroads and setbacks impacted by the pandemic, as well as goals for equity and access to music education for all students and national standards for music education in a short, qualitative survey.

“Music educators, administrators, and communities truly rallied to support and sustain music education through a period of intense change and adaptation. These districts and schools persevered in serving their students and communities and assured that music education was part of curriculum offerings,” shares Mary Luehrsen, Executive Director of The NAMM Foundation. “We applaud the commitment and efforts of all music educators, school administrators, and community members in providing students the opportunity to explore their creativity through music.”

In 2020, The National Federation of State High School Associations brought together a number of performing arts organizations, including The NAMM Foundation, to examine aerosol rates produced by wind

instrumentalists, vocalists, and even actors and how quickly those aerosol rates accumulate in a space. The study included several follow-up studies, including flow visualization, aerosol and CO2 measurements, and computational fluid dynamics (CFD) modeling to understand the different components that can lead to transmission risk from musical performance and risk mitigation.

“If there was one common theme to be taken from all submissions, it’s that schools and districts found ways to sustain music education and student engagement in even the most challenging of circumstances,” said Christopher Johnson of the Music Research Institute at the University of Kansas.

In addition to the 738 districts receiving Best Communities for Music Education recognition, 80 individual schools across the nation are being awarded the SupportMusic Merit Award (SMMA), which recognizes support for school-based music education programs.

Since its inception, over 2,000 schools and school districts have submitted a survey for evaluation. Based on survey responses in 2021, 686 school districts were recognized as Best Communities for Music Education, and 80 schools with the SupportMusic Merit Award. Past districts named a Best Community for Music Education included urban, suburban, and rural districts. Schools that have received the SupportMusic Merit Award designation included public and private schools and ranged from elementary to middle and high schools.

Make-A-Wish in search of new CEO

CEO to step down after nationwide successor search

ALBANY — William C. Trigg, III, the longest-tenured CEO in the history of Make-A-Wish Northeast New York, will be stepping down from the position following the conclusion of a nationwide search for his replacement, Trigg and the chapter's Board of Trustees announced.

Trigg has been CEO of Make-A-Wish Northeast New York since February 2006, making him the longest-tenured chief executive since the chapter's inception in 1987. In his role, he has overseen 60 percent of the 2,000-plus wishes granted in the chapter's history.

"After 16-plus years, it's time for fresh perspective from the CEO chair,"



William C. Trigg, III, CEO of Make-A-Wish Northeast New York since 2006, will be stepping down as head of the chapter after a successor is named. No timetable is set. He plans to remain involved with the local Make-A-Wish chapter in a to-be-determined advisory/ambassador capacity.

Make-A-Wish Northeast

Trigg said. "My passion for creating life-changing wishes for children with critical illnesses will never wane. But I believe the time is right for both myself and the chapter to turn the page."

The Board of Trustees, with assistance from Make-A-Wish America, will execute a nationwide CEO search, with Trigg remaining in place until his successor assumes the position. No timetable has been set on naming a replacement. After a new CEO takes the helm, Trigg, 67, plans to stay involved with the chapter in a to-be-determined advisory/ambassador capacity.

"On behalf of the Board of Trustees of Make-A-Wish Northeast New York, I want to express our deepest gratitude and appreciation for Bill's unparalleled leadership and the extraordinary impact he has had in growing the

mission of Make-A-Wish across our region," Board Chair Lisa Clifford said. "Through his dedication and mission-driven leadership, Bill will leave behind a strong and empowered staff, volunteers and community partners who will continue providing wishes for children with critical illnesses and their families."

In overseeing the day-to-day and long-term operations of the chapter, Trigg has been noted for being as comfortable with the smallest of wish kids and the biggest of donors. He has jumped out of airplanes (10 times at Wish Jump), been splashed in dunk tanks and even slimed in furthering the Make-A-Wish mission.

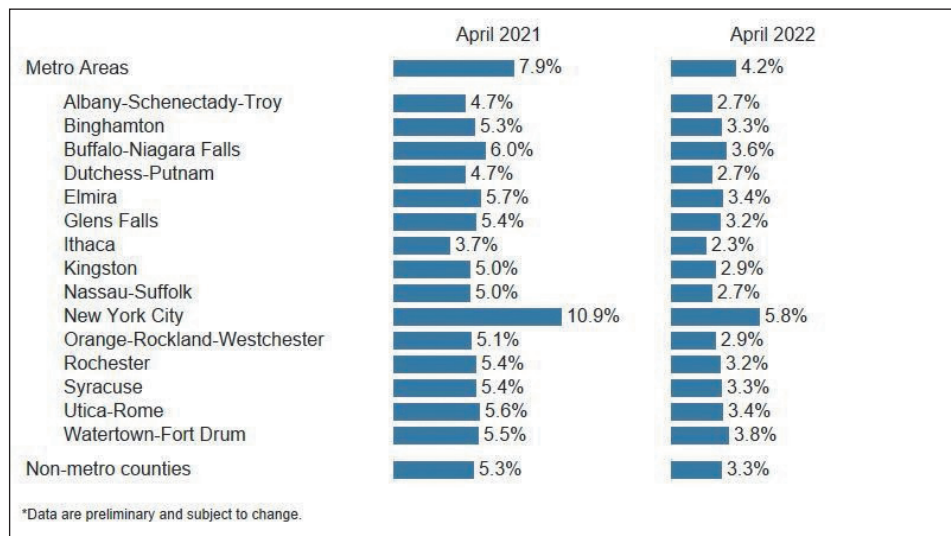

State releases April unemployment rates

ALBANY — The state Department of Labor released preliminary local area unemployment rates for April 2022 last week. Rates are calculated using methods prescribed by the U.S. Bureau of Labor Statistics. The State's area unemployment rates rely in part on the results of the Current Population Survey, which contacts approximately 3,100 households in New York State each month. To recap last week's statewide press release, New York State's seasonally adjusted unemployment rate decreased from 4.6 percent in March to 4.5 percent in April 2022.

The data in the table are not seasonally adjusted, which means they reflect seasonal influences (e.g., holiday and summer hires). Therefore, the most valid comparisons with this type of data are year-to-year comparisons of the same month, for example, April 2021 versus April 2022. Labor force data for the current month are preliminary and subject to revision as more information becomes available the following month. Revised estimates for prior months are available at: <https://statistics.labor.ny.gov/lslaus.shtm>

Labor force statistics, including unemployment rate for each state, are based on statistical regression models specified by the U.S. Bureau of Labor Statistics.

Heading to 'normal'

Experts say mortgage rates trending up to 'normal,' nothing to worry about, yet

ALBANY – Mortgage rates in April averaged their highest level since 2010, while the inventory of houses continued to decrease across the state, according to the housing report released by the New York State Association of Realtors.

According to Freddie Mac, the monthly average on a 30-year fixed-rate mortgage rose from 4.17 percent in March 2022 to 4.95 percent in April 2022. This is the highest monthly average commitment rate since January 2010 when it stood at 5.03 percent.

Despite rising interest

rates, the same scenario continues to play out in the local housing market that's defined by classic supply and demand — low supply and high demand create high prices.

Inventory of homes for sale across New York State fell 22.1 percent from 41,938 homes available in April 2021 to just 32,681 units last month. Months' supply of inventory declined 18.8 percent from 3.2 months of inventory in April 2021 to just 2.6 months in April 2022. A 6-month to 6.5-month supply is considered to be a balanced market.

Median sales prices continued to increase, climbing 28.8 percent from \$365,000 in April 2021 to \$470,000 just last month. This marks 24 consecutive months in year-over-year comparisons that the median sales prices have increased.

Closed sales were up

slightly – from 10,954 sales in April 2021 to 11,089 homes in April 2022. This represents a 1.2 percent increase. Pending sales dipped 0.4 percent in April – from 13,667 units in April 2022 to 13,606 last month. New listings dropped 14.4 percent to just 16,914 units in April 2022 from 19,751 homes in April 2021.

Realtors said early last month that they didn't expect the market to immediately cool on the promise of high-interest rates, but coupled with a 40-year high inflation rate, they said consumers have less spending power.

"The rates of the last two years were an anomaly due to the pandemic. Buyers and potential buyers should keep in mind that historically, a 5 – 7 percent rate is still low for a 30-year fixed-rate mortgage

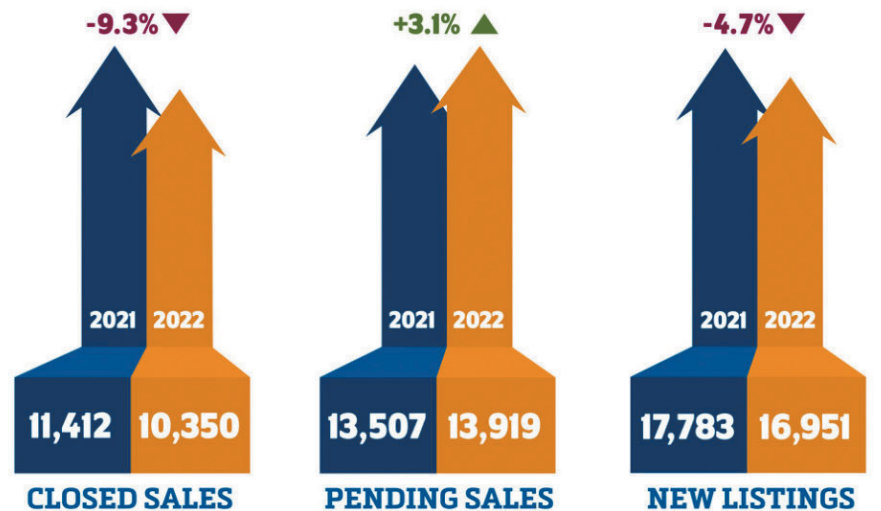

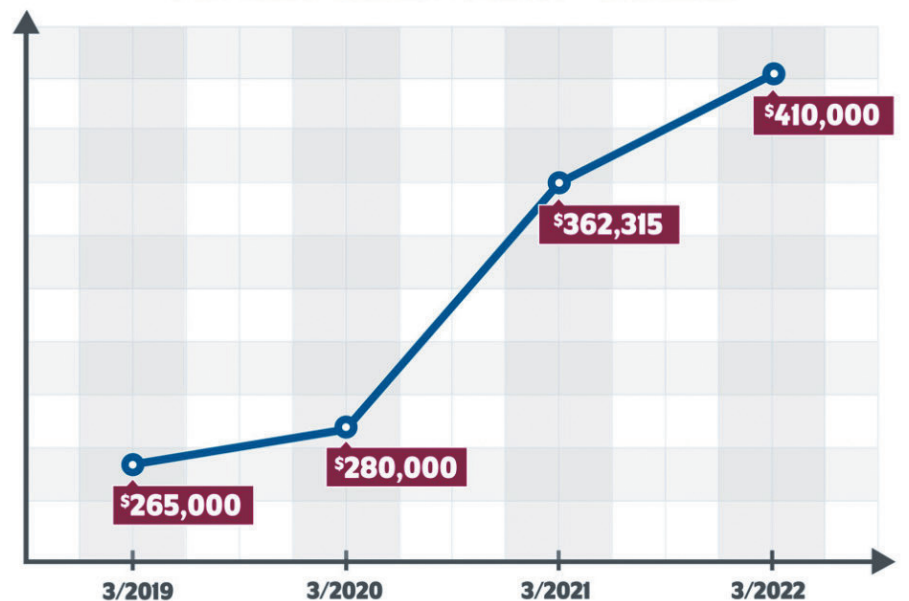

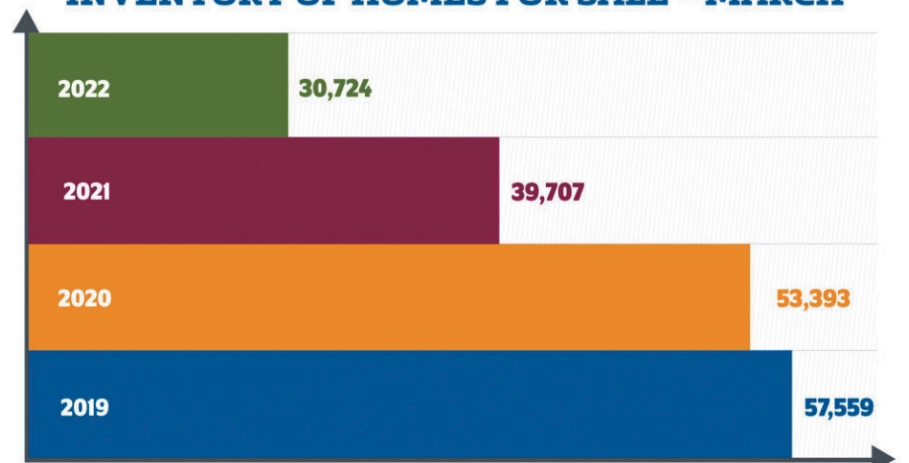
YEARLY COMPARISON FOR MARCH

Food Trucks Wanted for Town Pool

Housing rates

— nowhere near the 16 percent rate buyers dealt with in the early 1980s,” said Laura Burns, Greater Capital Association of Realtors CEO. “It’s not the 2 – 3 percent of 2020 and 2021 but that was a forced low rate to keep money moving during the pandemic.”

In March, homes in the Capital Region spent just 40 days on the market before sale.

Inventory of homes

for sale at the end of March totaled 1,547 units, down 44.6 percent from one year ago. Unsold inventory sits at a 1.3-month supply at the present sales pace, down from 2.2 months in March 2021.

“The housing market is starting to feel the impact of sharply rising mortgage rates and higher inflation taking a hit on purchasing power,” said Lawrence Yun, NAR’s chief economist. “Still, homes are selling rapidly, and home price

gains remain in the double-digits.”

Fewer existing homes for sale compared to last year turns attention toward new construction. With builders unable to keep up, new construction experienced a nearly 20 percent rise in median sale price over 2021 to \$470,818 in the Capital District.

If compared to the prior “normal” year of 2019, new construction’s price increase is close to 30 percent. As long as demand is high and inventory is low, 2022 will continue to see year-over-year price increases if buyers continue to show up ready to pay “normal” interest

rates in what remains an abnormal market, said Greater Capital Association of Realtors President Kendal Baker.

“As the Fed takes the corrective steps needed to get the economy on an even keel, with rising rates we know we’re really getting back to normal,” he said.

Time for schools to act

Editor's Note: The author is a retired teacher and administrator. Among the positions he has held are principal of Albany High School and adjunct instructor at both the University at Albany and SUNY Plattsburgh.

America just witnessed yet another mass shooting in an elementary school. At last count 19 fourth graders (aka 9-year-olds) and two teachers were brutally murdered by an insane 18-year-old who also shot his grandmother before heading to the school for a more heinous act.

Almost instantly, the politicians of our fair land began their usual kabuki dance decrying the murders (they call them tragedies) I call them what they are ... murders. The left screams gun control. The right shouts mental illness, and together, as usual, they will get nothing done that will make a difference to anyone.

We definitely do not need any more laws. "Thou shalt not kill," should pretty much cover it, but we have all kinds of laws to protect our schools and our most precious possessions, our children. None of those laws is working, nor will any new ones. Do we need to work on criminals and crazy people? You bet. Some people do not belong living amongst us.

How will we protect our schools and our kids? As a veteran of more than 40 years as a teacher, coach, athletic director, high school principal and superintendent of schools, I am well versed to speak on the topic of school safety.

School safety will never be attained by political action or laws. It is up to local school boards and administrators to protect the students and staff in every school in the land. If local action is not taken, shootings will continue in our schools as they have since the 1800s. This is not a new phenomenon.

The following steps are *non-negotiable* when creating a safety plan for a school. These actions should be made public to all and should be posted conspicuously throughout the buildings. These murderers are cowards. They want soft targets not hard ones that are protected.

- Every school should be staffed with school resource officers, armed police personnel. I do not want to hear about the trauma this might cause to some students. A lot of people will be traumatized for life by what they witnessed in that Texas school recently.

- The corridors and classrooms in schools must be monitored by security

cameras.

- Students and staff should all be issued identification tags to instantly show they belong in the building.

- Visitors must all report to a single point of entry. They must show identification to the staff at the entry. They must be logged in and escorted by school personnel to and from the area they have been approved to visit. No ID ... no entry. Try to get tickets at a will call window of a theater or athletic stadium without ID.

- Students and staff need to be well-versed in the safety procedures of the school. In addition to fire drills, procedures for lockdowns, lockouts, shelter in place, etc. need to be explained to all and understood by all.

- Every student and staff member needs to understand they are part of the school safety team. If you see something that might be a concern, report it. Hundreds of eyes and ears help to make a place safe.

- Every active entry to a school building needs to be monitored by security personnel and metal detectors. Again, cowards will not hit hard targets. If they know they will be scanned and observed, they will not try to enter.

- Visitors should never

be given direct access to a building. Bullet proof glass in windows and doors need to be used to create a double entry barrier with buzzers/locks to insure that unwanted individuals will not gain entry.

- School buildings need to be open and available for inspection to police and fire professionals. First responders need to be intimately familiar with the buildings, room numbers, alarm locations, school codes and all safety procedures. Seconds matter when a threat is live within a school building.

- All inactive entries to the building should be locked at all times. They should also be checked regularly by school personnel to be sure that they are secure.

- The security of the building must be maintained 24/7. Most schools have plausible safety plans in place during the school day. However, those plans are shredded as soon as classes are dismissed. For example: at many schools, doors to athletic fields and other venues are wide open and unobserved during practices and games. Visitors who easily gain entry to the school are free to roam around the building and they could be concealing weapons or other items that could be used in the future to hurt students and staff. One let

down can spell disaster.

- Last and most importantly, if an armed intruder is in a building, there is only one reason for that intrusion: *to kill students and staff*. The plan needs to be for that threat to be immediately neutralized by armed police officers who are trained to protect.

Once again, these steps are non-negotiable. Some will say it is too expensive, it is impossible to do, etc. I know a lot of grieving people in Texas today wish they had done these things.

I have visited many schools in the area for various reasons and usually find a way to walk in without being properly challenged and vetted. I also make it a point to bring this to the attention of the administration of the building.

I know some of this is very hard to read. I know many will want to argue with some of the points I have raised. I welcome those arguments. But understand, I am right. If these steps were in place at many of the sites that experienced mass shootings over the years, a lot of loved ones would still be with us.

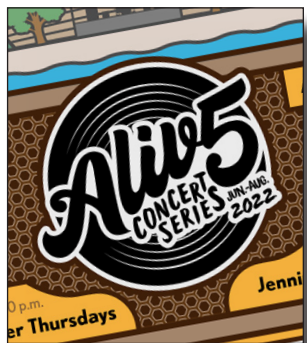

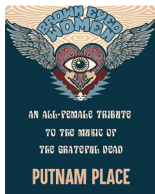

Art makes friends

Main Street Studio to open pop-up show for Charlton's Founder's Day celebration weekend

CHARLTON — Six miles down Swaggertown Road, one couple's plan to convert a longtime volunteer firehouse into a workshop and art gallery has transformed into a showcase for this community's proud, self-sufficient character.

Main Street Studio, located at 786 Charlton Road, will exhibit a pop-up show and market titled "Charlton Makes!" It's to be a celebration of artists and makers with close connections to the small, talented community, and it falls in conjunction with



the town's Founder's Day Weekend. The exhibit, featuring work from 33 artists, will run over two weekends, from Friday, June 3 to Sunday, June 5; and from Friday, June 10 to Sunday, June 12.

The show space is an example of what Jason and Dana Nemec call "rural industrial." It is a clean, modern-style art gallery with white, painted brick

walls and a black ceiling with exposed metal support beams. It's as fashionable a room as you'd find in any cityscape. Yet, it's converted from a century-old firehouse that, up until just two years ago, served this town of nearly 4,000 residents.

The Burnt Hills couple talked about moving to the West Coast now with their two sons going off to

college. Pandemic-related shutdowns and a turbulent real estate market led to more questions than solutions. But when a real estate agent friend shared a listing of the property, Dana said, "Oh! This could be interesting." They closed on the property a few months later in early 2021.

Jason had wanted to find a workshop to continue with his woodturning

crafts. A software designer by trade, he said he was drawn into the art about 15 years ago, when he had vacation time with nothing to do. He attended a woodturning workshop in Colorado. He bought a lathe and steadily built up his collection of equipment ever since.

"I've been working in software for a long time — from before there was

an internet," he said. "It's particularly taxing if you care about what you do, that every two to five years everything reinvents itself and all the rules change. Things that you made two or five years ago they're literally, objectively not good anymore.

"Woodworking is a practice that results in

TrailBlaze set to music

When Dogs of Desire returns to the Cohoes Music Hall on Friday, June 3, it will be to perform five world premieres, including “Moments in Motion,” an orchestration of music from Bear Grass by Jack Frerer.

Katie Hammon, singer and songwriter for Bear Grass, said she was approached with the idea several months ago. The songs draw from the band’s 2018 album “Left.” Hammon said one of the songs to be performed by Dogs of Desire was to be played live at Cohoes Music Hall for the first time in March 2020, but the pandemic shut the show down.

“While the album has been with us for a few years now, these songs breathe new life with the sounds of an orchestra,” Hammon said. “Jack has been sharing midi versions with me all

along, but I really cannot wait to hear Dogs of Desire amplify them in real life.”

Music by Bobby Ge, Loren Loiacono and Andre Myers will be featured. Natalie Draper’s “Biking to Amsterdam, NY” helps lend a hint to the festival’s running theme: The Empire State Trail.

The state launched the Empire State Trail in 2017 to promote outdoor recreation, encourage healthy lifestyles, support community vitality, and bolster tourism-related economic development across its now 750-mile length from New York City to the Champlain Valley and from Buffalo to the Hudson River. Miller, who is an avid cyclist, approached the state with an idea similar to “Water Music NY” to celebrate the Erie Canal’s bicentennial.

“We want, through art and through music, to tell the story of the trail,” Miller said, “and encourage people in the communities who may not know that

much about the trail... to come out and do fun stuff on the trail.”

TrailBlaze NY is supported in part by New York State through a Market New York grant from I LOVE NY, the state’s Division of Tourism, through the Regional Economic Development Council initiative, and the New York State Council on the Arts, with vital additional support from the National Endowment for the Arts and corporate and individual donors from across the region.

The Festival kicks off with a wall-to-wall week of new music in Troy and Cohoes, including performances by the Albany Symphony at the historic Troy Savings Bank Music Hall and the Dogs of Desire, the Symphony’s new-art chamber music group, at the historic Cohoes Music Hall.

“The Troy and Cohoes week of the Festival will culminate on Saturday, June 4, in a magnificent evening of absolutely incredible recent orchestral music,” Miller said. “Pulitzer Prize-

Imaginary City- The large-format, abstract paintings of Tomm El-Saieh (b. 1984, Port-au-Prince; lives and works in Miami) teem with dense and dynamic marks that evoke ornament, language, and architecture. By variously layering and erasing his linework, and using vibrant color to optically push or pull his pictures, El-Saieh creates rhythmic, all-over compositions from which larger forms appear to emerge—testing both the limits of our perception and our expectations about abstraction. The exhibition title, which comes from one of the works in the show, refers to a cityscape theme common in Haitian art (Wilaj Imaginé). El-Saieh's paintings, which resemble informal urban plans, likewise develop intuitively, without the use of preparatory studies or outlines. For the artist, who has been unable to return to his birthplace in recent years as a result of the instability there, Port-au-Prince now also exists mainly as a figure in his memory and imagination—a site of joy and trauma, potential and uncertainty. Tomm El-Saieh was born in Haiti and grew up in Miami; he is of Haitian, Palestinian, and Israeli descent. He was the subject of a solo show at the Institute of Contemporary Art (ICA) Miami in 2018 and was included in the New Museum triennial in New York that year. He is partner at the artist-run gallery CENTRAL FINE in Miami and long directed the El-Saieh Gallery in Port-au-Prince, a venue for contemporary Haitian artists that his grandfather established in the 1950s. This yearlong exhibition appears in public spaces around the Clark and is free and open to the public. It is organized by the Clark Art Institute and curated by Robert Wiesenberger, associate curator of contemporary projects. This exhibit goes from January 29th through December 31st. 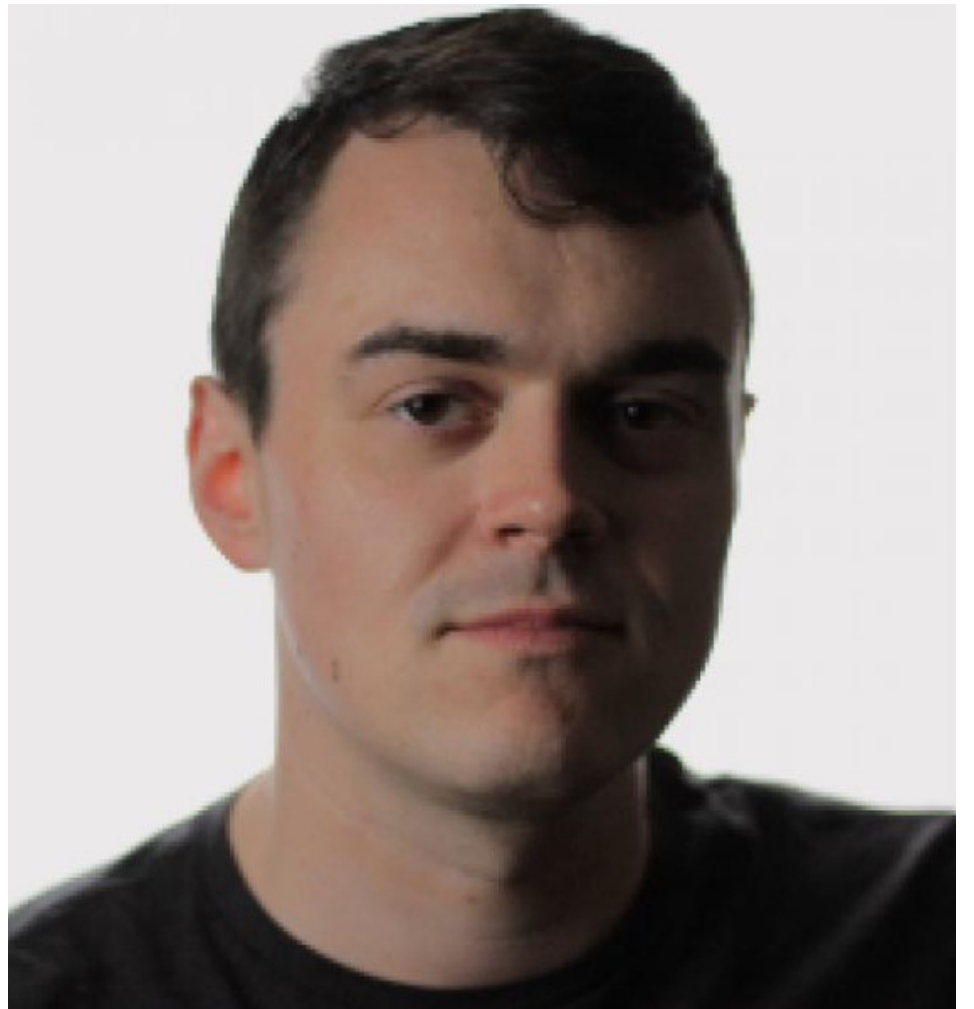

More personnel changes preceded the release of their debut studio album, 1993's Sermon of Mockery, with guitarist Tony Caravella joining the ranks. Released by overseas indie Hard Vinyl, the album helped to define the group as one of the premier American death metal acts, and was eventually reissued in 2015 by Century Media. Is shrimp on the menu tonight? Maybe it should be. Coming in at just around seven calories per medium-size shrimp, this crustacean is low in calories and high in lean protein and is one of only a few dishes that provides the beneficial antioxidants selenium and astaxanthin, according to The American Shrimp Company. The majority of North American shrimp is harvested from the Gulf of Mexico, ensuring fresh catches for the U.S. and Canada. Around 244 million pounds of shrimp are produced each year.

An abundance of shrimp means the opportunities for delicious meals are endless. For something with a lot of flavor and crowd appeal, try this recipe for a “Shrimp Quesadilla” courtesy of Eastern Fish Company. Plump shrimp are nestled between tortillas and seasoned with familiar Latin flavors, ideal for a fast meal any time.

Shrimp Quesadilla

INGREDIENTS: Serves 6

- 2 tablespoons vegetable oil
- 1 onion, sliced
- 1 red bell pepper, sliced
- 1 teaspoon salt
- 1 teaspoon ground cumin
- 1 teaspoon chili powder
- 1 pound uncooked medium shrimp, peeled and deveined
- 1 jalapeño pepper, seeded and minced

(optional)

- 1 lime, juiced
- 1 teaspoon vegetable oil, or as needed
- 6 large flour tortillas
- 3 cups shredded Mexican cheese blend

INSTRUCTIONS

1. Heat 2 tablespoons vegetable oil in a large skillet over medium-high heat. Cook and stir onion and red bell pepper in the hot oil, stirring frequently, until onion is translucent, and peppers are soft, around 6 to 8 minutes.
2. Stir salt, cumin and chili powder into onion and bell peppers.
3. Stir shrimp into mix and cook until shrimp are opaque and no longer pink in the center, 3 to 5 minutes.
4. Remove skillet from heat; stir jalapeño pepper and lime juice into shrimp mixture.
5. Heat a skillet over medium heat and brush with about 1 teaspoon vegetable oil.
6. Place a tortilla in the hot oil. Spoon about 1/6 shrimp filling and 1/2 cup Mexican cheese blend on one side of tortilla. Fold tortilla in half.
7. Cook until bottom of tortilla is lightly browned, about 5 minutes; flip and cook other side until lightly browned. Repeat with remaining tortillas and filling.

things that last for generations.”

Jason grew up just a street down from the firehouse. He recites the town’s history. How its founders traveled north from Freehold, New Jersey. A point of distinction only because that’s what they initially named the town. How life was hard for pioneers, especially those who crossed native Mohawks the wrong way.

The history of the firehouse is documented in crude, endearing ways. “Fuji ‘95” is etched into the concrete floor that is now the gallery room. A few more initials can be found elsewhere. The Charlton volunteer firefighters

kept the house well for more than 50 years. Like many rural firehouses, the size of modern equipment forced them to move out.

“We didn’t realize just how tight the volunteer fire department community is,” Dana said. “When we inherited this building, we also inherited five generations of all of the families who have put in the lighting, done the metalwork on the walls. We’ve met and become really good friends with a lot of the people who we probably wouldn’t have crossed with.”

When the Nemecs presented their plans for the building to town officials, they said residents were happy to learn of their want to preserve its history. Jason drew inspiration from the Saratoga Clay Arts Center. He observed how it offered studio space for artists, providing tools they wouldn’t necessarily have at home, all while providing gallery space to showcase members’ work. Jason felt it could “jumpstart” another artist’s creative efforts by providing a studio, a gallery, and class space under one roof.

“The town has been great.

They’ve been so supportive,” Dana said. “Just the connections we’ve been able to make. I think, coming out of the pandemic, I think people needed that connection.”

Among the 33 artists to be featured in “Charlton Makes!” is a nonagenarian woodworker who settled down in Charlton 50 years ago; a native utensil maker now living in Maine whose work was captured in *Bon Appétit Magazine*, a high school student who aspires to be an artist, and a Galway sculptor who commonly has his work featured and sold across New York City.

The show promises a wide variety of mediums, from the aforementioned woodwork to oil paintings and photography. Soahn Kuehner, who creates guitars out of locally-grown gourds and flutes from invasive Japanese Knotweed, will showcase his work. Jason’s award-winning furniture will be on display, too. All in the effort to bring something tangible and worthwhile to one’s hometown.

“I love Charlton. ... It’s a really cozy town,” Jason said. “It’s off the beaten track. I don’t know how that’s going to fare trying to get visitors here, but we’re going to take it one step at a time.”

'Sing in the Streets' Festival at Caffé Lena

SARATOGA SPRINGS — With six acts playing 50-minute sets simultaneously, you had to choose. Pick an artist you particularly wanted to hear, and settle in for an hour. Or, you could choose an auditory "sampler platter," and try to catch a little bit of everybody. We chose to do the latter, with each of us catching a bit of everyone and reporting back here what we heard.

For the first round of sets, Mike started up on Broadway with Russel the Leaf, the stage name of Lansingburgh's Evan Marre. His self-deprecating sense of humor set the theme for the whole event, when he quipped "lucky you, you're going to hear a bunch of original material from somebody you don't know at all." Which is – ironically – kind of what this whole event, and (in many cases) Caffé Lena itself is all about. and Carolyn Shapiro and her wonderful banjo playing greeted you as soon as you stepped inside the lobby. Probably the most unassuming artist of the day, she lets her voice – and her banjo – do all the talking.

Mike went up the stairs to the “big room,” and the North & South Dakotas (who refer to their own music as “Y” alternative Bluegrass”) were putting on a clinic with probably the rowdiest set of the day. Mike was pleased to be greeted by a saxophone blowing right out front when he stepped in.

After that, it was time to cross the street to Ben & Jerry’s to catch the

final two songs from the always-captivating Hot Club of Saratoga. The two things that always strike me with this outfit are their musicianship and timelessness, and today was no different. Laura started the afternoon there, and remarked similarly that time seems to never pass with this group. Clarinetist Jonathan Green, as always, stole the show for her with his sultry jazzy tone, transporting everyone back to the early 1920s. As a gentle breeze crossed her face, there was almost a de-realization to the modern-day automobiles behind us.

The 20-minute set changeover allowed enough time to hydrate and get

back up to Broadway to settle in for Round Two. Arielle O’Keefe (who goes by the stage name Girl Blue) kicked things off by immediately showcasing her tremendous songwriting talent, with the perfect voice to match. It is genuinely hard to walk away from her while she performs; you need only hear about 30 seconds of her to know she’s likely destined for widespread national recognition.

But Mike had committed to seeing all the acts, and he got down just in time to hear Jes Hudak recount how the Open Mic nights at Caffé Lena were the catalyst to her musical career. With the Caffé’s Executive Director Sarah Craig on the side of the stage, it was a poignant moment. Her song “1-800 Scam Likely” (title may be

wrong) was a winner, too.

Back to the family stage where Karl Bertrand was holding court playing a song Mike believes was “The Farty King of Wales,” or something to that effect. May he also say that it absolutely delighted the sizeable group of children that were there, along with their parents. It reminded us of Caffé Lena’s commitment to the new generation of music lovers with their “Folk Club Kids” series and their burgeoning music school.

From there it was back to the Caffé itself, where Reese Fulmer had such a large crowd in the lobby that it was difficult to get in. And deservedly so – this is another rising singer-songwriter who isn’t even close to topping out yet.

Fulmer sang some of Laura’s personal favorites,

and folks passing by the street paused in awe. One woman asked Laura his name, and when told to her, she wrote it down on scrap paper to remember it. “He’s going to be famous,” she remarked.

“He already is around here,” Laura smiled back. She stayed for his entire set, not willing to miss a moment of his live performance.

Upstairs, the Lost Radio Rounders were holding court, doing what they do best – blending timeless, well-played music with local history, stories, and pride. This is the band you want to bring your out-of-town friends to see. Finally, it was back outside to see the final act, the Bluebillies. country through-and-through (in all the right ways), they reminded us that Caffé Lena has grown

well beyond its traditional “folk-only” roots. Melody Guarino urged us to “listen to more Country music – it’s good for you.” Indeed.

The first Sing in the Streets festival was, in these writers’ opinions, a rousing, delightful success. Even with unbearable heat and humidity, it was refreshing to walk around the block and hear so much fresh local music.
