



# Delanson woman identified as victim in South Bethlehem DWAI

**SO. BETHLEHEM** — An accident on Sunday, Aug 14 at the intersection of Route 396 and Star Road claimed the life of Margaret Halvorsen, 80, of Delanson.

Halvorsen was returning home from visiting family Sunday night when the accident took place at the intersection. It is unclear if she stopped at the stop sign or inched forward to see traffic and was struck, according to police. The investigation is ongoing.

It is clear that Halvorsen's car was struck by a truck traveling on Route 396 driven by Samuel Keir, 52, of Hannacroix.

Keir was found to be unlicensed and impaired by drugs and alcohol.

"Samuel Keir was found to be operating his vehicle with his operating privileges in New York as Revoked due to previous DWI related incidents and was also found to be impaired at the time of operation," Albany County Sheriff Craig Apple said in a

release.

Keir was arrested and charged with aggravated unlicensed operation, a felony, DWAIcombination of drugs and alcohol, a misdemeanor and other traffic violations.

He was given an appearance ticket and released. Keir is scheduled to face a judge for arraignment in Bethlehem Town Court on Tuesday, Sept. 20 at 5 p.m.

Margaret's husband of 59 years, Richard, 84, died later in the week after a battle with cancer. The family has a celebration of life service planned for both of them on Saturday, Aug. 27. Please see the obits for Margaret and Richard on page 10.

# **Hidden Meadow course for sale**

# Executive golf course, house on the market for \$750,000

**GLENMONT** — In the market for a golf course?

Hidden Meadow Golf Course, an 18-hole Par 3 course just west of River Road, is for sale.

"Operated by the same owners for many years, this is an exciting investment opportunity for golf enthusiasts, investors, and developers," states the sales sheet. The property, recently listed by Gabler Realty, has been owned by Hidden Meadow Golf Course Inc. since 2003.

Characteristic of a Par 3, the course lacks doglegs and features nothing but straightaways, including the course's signature 149-yard 14 hole. Five of the holes challenge golfers with water hazards, three requiring players to drive shots over to reach the green.

Online reviews praised the conditions of the course and greens.

"If I lived here, I'd be here every week," wrote one visitor from Tennessee. "This course is bucolic, redolent with sleepy slopes that could either help or hurt your game."

The \$750,000 asking price offers the executive golf course, a 4,700-square-foot pro shop, and a 1,040-square-foot, three-bedroom ranch with a new roof and in-ground pool. The pro shop features a new restaurant and bar, a full kitchen, offices and storage. It also includes forced air propane heat and central air. According to the sales sheet, the seller is providing all equipment needed to continue operating the business as is.

The residence at 138 Smultz Road has a Glenmont zip code and is within the Bethlehem Central School District.

Port hits snag

Dredging permit held up on environmental concerns

**GLENMONT** — Two federal agencies have recently sucked the wind from the Port of Albany's sails as it waits for approval to move ahead on constructing a 500-foot wharf at Beacon Island.

As of last week, the port was waiting on obtaining a dredging permit from the U.S. Army Corps of Engineers, allowing it to move forward on the construction of a 500-foot wharf needed for the highly lauded \$350 million wind turbine tower manufacturing complex.

However, the National Marine Fisheries Service and the Environmental Protection Agency have pushed to withhold the permit over concerns for the environment, including potential harm to the habitats of sturgeon according to a report published by the *Times Union* on Thursday, Aug. 18.

Though the port's expansion plans include reconstructing a sturgeon habitat across the river from the port, the two agencies contend that less harmful alternatives have not been adequately considered.

The Port of Albany has been awarded the coveted bid to house the state's first wind tower manufacturing site last January when New York State Energy Research and Development Authority selected a joint bid from energy company Equinor, and wind industry manufacturers Marmen and Welcon.

It was considered to be the first step towards the state's larger plan to establish a home base for a global wind energy manufacturing powerhouse, including two offshore wind farms that will yield a combined 2,490 megawatts of carbon-free energy, and bring another \$8.9 billion in investments. It also includes an offshore wind turbine staging facility and operations hub at the South Brooklyn Marine Terminal, increased commitment to the Port of Coeymans, and maintenance out of Port Jefferson and Port of Montauk Harbor in Long Island.

The project is expected to expand the Port of Albany as it is prepared to produce 150 offshore wind towers, and create up to 350 long-term jobs.

However, since the port's expansion plans cleared site plan approval from the Town of Bethlehem, it has labored through several protests, including a lawsuit filed by neighboring residents who contend they were not properly notified.

Port officials said they were working with the U.S. Army Corps of Engineers to provide it with more information as it considers its decision on the permit.



# Ribbon cut for two new buildings on Watervliet Shaker Road

**COLONIE** — Capital Region BOCES is ready to open its new, \$63 million Career & Technical Education Center and Maywood Academy on Watervliet Shaker Road when classes start next month.

There are some 1,100 high school students from 24 school districts around the Capital District registered for classes at the new 170,000-squarefoot Tech Center and more than 200 adults are expected to take classes at the new facility as well.

Across the parking lot from the new tech center,

is the new 43,000-squarefoot home of the Maywood Academy. The former Maywood School on Central Avenue is closed, but the mission to focus on educating those with special needs will continue at the new building and will allow more than the current cap of 110 students to benefit.

Two dozen programs will be taught at the Tech Center including auto body collision repair, building trades, cosmetology, criminal justice, culinary arts and hospitality technology, early childhood education, digital media design, and manufacturing and machining technology.

"As an employer of a successful CTE alumni, we strongly support and applaud Capital Region BOCES on the opening of the Albany Career & Technical Education Center," said Jim Becker,

"Workforce development has been an issue and finding employees with the aptitude and desire for working in the telecommunications and networking field has been our industry's biggest challenge recently. with the latest and greatest technology is the addition of a Lincoln Electric VRTEX welding simulator for students in the Welding & Metal Fabrication program that was funded in part through a \$25,000 grant from the American Welding Society.

Similarly, students in the Heating, Ventilation, Air Conditioning & Refrigeration program will benefit from new refrigeration and heat pump trainers that will "simulate problems the students will face as HVAC/R technicians and allow them to observe and better understand the conditions inside a refrigeration system," said teacher Tim Duane.



The middle school has a garden club that meets regularly during the school year.


The success of the garden will come from more mornings and evenings of good conversation and hard work. Every Tuesday evening, community members tend to the garden as well.



# House market cool



Homebuyer activity continues to decline across New York State

ALBANY — The New York housing market continued to cool in July, as rising sales prices, low inventory, and high mortgage rates slowed buyer activity, according to the housing report released today by the New York State Association of Realtors.

Median sales prices once again rose, escalating 9.1 percent from \$385,000 in July 2021 to \$420,000 in July 2022. This marks 27 consecutive months in yearover-year comparisons that median sales prices have increased.

Inventory of homes for sale fell 13.9 percent in July 2022 – from 46,936 homes in July 2021 to just 40,426 this year. Months' supply of inventory fell 5.7 percent from 3.5 months of inventory in July 2021 to just 3.3 months' supply last month. A 6-month to 6.5-month supply is considered to be a balanced market.

Mortgage interest rates, which had risen for seven consecutive months, dropped slightly last month. According to Freddie Mac, the monthly average on a 30-year fixed-rate mortgage fell from 5.52 percent in June 2022, to 5.41 in July 2022. This is still over two percentage points higher than the rate of 2.87 percent in July 2021.

New home listings dropped to 16,841 units in July 2022 from 19,747 homes available in July 2021. This represents a 14.7 percent decrease. Closed sales declined as well, falling 14.1 percent from 14,302 homes in July 2021 to just 12,291 homes last month. Pending sales also were down, falling to 12,930 units in July 2022 from 14,221 units in July 2021, marking a 9.1 percent decrease.

# The Spinney plans solar array

# Approved 5-megawatt solar array could translate to energy savings

DELMAR — The Spinney Group, owner and operator of more than 650 market-rate apartments in the region, including Adams State and The Spinney VanDyke in Bethlehem is continuing to push the green envelope.

Recently the property company was approved by the Ballston Spa Planning Board for a 5-megawatt solar array. While the company doesn't have any apartments in the area, the solar array can assist homeowners and businesses who don't have the means or space to install panels on their own property.

What is know as a "community solar farm" will be situated on 65 acres. Utility customers who sign up with community solar partners can save money by getting a credit on their electric bills.

The Bethlehem Chamber of Commerce has a partnership with Energy Now Consultants, which is an example of one of the partners which can currently assist Chamber member businesses and residents with this type of credit. There are a number of companies that are available and can be researched on the New York State Energy Research and Development Authority website.

According to NYSERDA, New York has the largest community solar market offering in the country, at more than 1 gigawatt of installed community solar. That's enough to serve more than 200,000 homes.

The Ballston solar farm is expected to receive up

to \$1.6 million in incentives when completed next year, according to NYSERDA. The overall project will cost nearly \$13 million.

Because of the nature of the electric grid and solar farms, there is no way to direct the electricity generated at the Spinney solar farm specifically to its apartment owners, however, by adding more solar to the grid, more people can take advantage of green, renewable energy.

Still, tenants will have the option to sign up for community solar offered by The Spinney Group. It's too early to say how much they could save on their electric bills, but The Spinney Group CEO Morgan Ruthman estimated it will be 5-10 percent.

"We want to provide our tenants with a complete offering," he said.

Tenants in many of the units owned by The Spinney Group have access to electric car chargers at the complexes, as well as new all-electric heating units.

Ruthman worked on the plans with Renovus Solar of Ithaca, which has installed thousands of solar systems in New York over the past 19 years, according to the report in the Albany Business Review.

The projected output from the 5-megawatt solar system is about the same amount of energy consumed annually at all of The Spinney Group's rental units, commercial properties and common areas, based on a load analysis that was done with assistance from National Grid.

"It's a strong step toward decarbonization," Ruthman said.

# Liver expert joins Albany Med as Chief of Gastroenterology, Hepatology

ALBANY — Raza Malik, MD, PhD, a renowned expert on liver disease, has joined Albany Medical Center, a member of the Albany Med Health System, as chief of the Division of Gastroenterology and Hepatology and vice chair of research for the Department of Medicine.





SNAP/TANF/FDPIR Households: Households that currently include children who receive the Supplemental Nutrition Assistance Program (SNAP) but who are not found during the Direct Certification Matching Process (DCMP), or households that currently receive Temporary Assistance to Needy Families (TANF), or the Food Distribution Program on Indian Reservations (FDPIR) must complete an application listing the child's name, a valid SNAP, TANF, or FDPIR case number and the signature of an adult household member. Eligibility for free meal benefits based on participation in SNAP, TANF or FDPIR is extended to all children in the household. When known to the School Food Authority, households will be notified of their children's eligibility for free meals based on their participation in the SNAP, TANF or the FDPIR programs.

No application is necessary if the household was notified by the SFA their children have been directly certified. If the household is not sure if their children have been directly certified, the household should contact the school.

**Other Source Categorical Eligibility:** When known to the School Food Authority, house-holds will be notified of any child's eligibility for free meals based on the individual child's designation as Other Source Categorically Eligible, as defined by law. Children are determined Other Source Categorically Eligible if they are Homeless, Migrant, Runaway, A foster child, or Enrolled in Head Start or an eligible pre-kindergarten program.

If children or households receive benefits under Assistance Programs or Other Source Categorically Eligible Programs and are not listed on the notice of eligibility and are not notified by the School Food Authority of their free meal benefits, the parent or guardian should contact the school or should submit an income application.

Other Households: Households with income the same or below the amounts listed above for family size may be eligible for and are urged to apply for free and/or reduced price meals. They may do so by completing the application sent home with the letter to parents. One application for all children in the household should be submitted. Additional copies are available at the principal's office in each school. Applications may be submitted any time during the school year to Manon Desjardins, Reviewing Official, Food Service Department, 700 Delaware Avenue, Delmar, NY 12054 Please contact Manon Desjardins at 518-439-8885 with any questions regarding the application process.

Households notified of their children's eligibility must contact the School Food Authority if they choose to decline the free meal benefits.

Households may apply for benefits at any time throughout the school year. Children of parents or guardians who become unemployed o experience a financial hardship mid-year may become eligible for free and reduced price meals or at any point during the school year.

For up to 30 operating days into the new school year (or until a new eligibility determination is made, whichever comes first) an individual child's free or reduced price eligibility status from the previous year will continue within the same SFA. When the carryover period ends, unless the household is notified that their children are directly certified or the household submits an application that is approved, the children's meals must be claimed at the paid rate. Though encouraged to do so, the SFA is not required to send a reminder or a notice of expired eligibility.

The information provided on the application will be confidential and will be used for determining eligibility. The names and eligibility status of participants may also be used for the allocation of funds to federal education programs such as Title I and National Assessment of Educational Progress (NAEP), State health or State education programs, provided the State agency or local education agency administers the programs, and for federal, State or local means-tested nutrition programs with eligibility standards comparable to the NSLP. Eligibility information may also be released to programs authorized under the National School Lunch Act (NSLA) or the Child Nutrition Act (CNA). The release of information to any program or entity not specifically authorized by the NSLA will require a written consent statement from the parent or guardian.

The School Food Authority does, however, have the right to verify at any time during the school year the information on the application. If a parent does not give the school this information, the child/children will no longer be able to receive free or reduced price meals.

Foster children are eligible for free meal benefits. A separate application for a foster child is no longer necessary. Foster children may be listed on the application as a member of the family where they reside. Applications must include the foster child's name and personal use income.

Under the provisions of the policy, the designated official will review applications and determine eligibility. If a parent is dissatisfied with the ruling of the designated official, he/she may make a request either orally or in writing for a hearing to appeal the decision. <u>Jody Monroe,</u> <u>Superintendent</u>, whose address is <u>700 Dela-</u> ware Avenue, Delmar NY 12054 has been designated as the Hearing Official. Hearing procedures are outlined in the policy. However, prior to initiating the hearing procedure, the parent or School Food Authority may request a conference to provide an opportunity for the parent and official to discuss the situation, present information, and obtain an explanation of the data submitted in the application or the decisions rendered. The request for a conference shall not in any way prejudice or diminish the right to a fair hearing.

Only complete applications can be approved. This includes complete and accurate information regarding: the SNAP, TANF, or FDPIR case number; the names of all household members; on an income application, the last four digits of the social security number of the person who signs the form or an indication that the adult does not have one, and the amount and source of income received by each household member.

In addition, the parent or guardian must sign the application form, certifying the information is true and correct.

Beginning July 1, 2019, students in New York State that are approved for reduced price meals will receive breakfast and lunch meals at no charge.

Reflecting on a childhood memory and one person's pursuit to return to professional baseball

y appearances, Dan followed the advice that one shouldn't dress for the job they have, but for the job they want. When he rolled up into the school parking lot, the gravel crunching underneath the tires of his sedan, he emerged from his car appearing every part of a financial executive; a

sharp-looking dress shirt, a colorful tie, paired with a dark jacket and suit pants. It reminded me of the professionals in downtown Albany from which my father worked.

My father worked for a stock brokerage firm just across the street from Jack's Oyster House on State Street. That's where executives often wore their dark suits with boldcolored ties. That choice of attire shared a message to anyone paying attention, do this or fail.

Do you want to earn money off Wall Street? Invest in this or allow the next person to prosper. Do you want that promotion? Reach your quotas by the end of the

month, or someone else gets that corner office. Before the 4 p.m. bell rings, one has to understand that there is always a trade between comfort and potential gains. Gamblers say it best, "Scared money don't make money."

But as Dan stripped down to a pair of gym shorts and a baseball tee it grew more apparent that the job he wanted was not the one he left to arrive here at the schoolyard. And he has a purpose.

Baseball has a way of magnifying the disparity between the years. The divide is perhaps none more apparent than that observed by the adolescent sitting idle on his bicycle, with

his baseball mitt dangling from the handlebar. Life in baseball is a short one. We crawl to it in t-ball, and walk through basic drills in Little League. We learn to fly as teenagers, and just as we start to appreciate the minutia of the game, we trip and fall.

Most of us step away from the ballfield long before we graduate high school. A widely circulated estimate states that 1 in 8,000 high school seniors will make a Major League Baseball team. You're more likely to be accepted to Harvard University, assuming you have the grades. But baseball players are not normal. In the '80s, Will Clark and Wade Boggs boasted of having 20/10 vision better than perfect. When Boggs' batting average slipped from .332 to .259 the following year, an eye exam revealed his eyesight degraded to a mortal 20/20 standard.

Dan often visited the Slingerlands Elementary schoolyard, walking onto Photos by Michael Hallisey / Spotlight News

the soccer field with a fungo bat in one hand and a basket of baseballs in the other. Initially, he looked out of place. He looked old to a 12-year-old when in reality he was years before reaching 30. None of us could keep up with him as he sprinted the length of the field to start his workout. Even with his knee brace.

After curious kids asked about the brace, Dan shared he had injured it while playing in the minor leagues. He was once a prospect for the Baltimore Orioles before an unfortunate encounter while running the bases. Just as I can't remember his last name, I can't recall the details of his injury. It nonetheless shaped his present day, one defined by him running baseball drills with eager kids smashing fly balls to him.

From Dan, we learned to run after the ball in such a way as to keep our heads still, allowing us to track the ball better while it was in flight. We'd watch him pursue the ball. Like a cheetah running after its prey, his head remained level while his legs absorbed the shock of his footfalls. He'd snatch the ball out of the air, slap the gloved ball against his leg and let out a sound like he was clearing his throat. This collection of noise resonated across the yard. As kids, we followed along. We figured it was another way of dressing the part of a professional baseball player.

On the other side of the schoolyard's treeline lived a man who understood the look of a baseball player. While we actively dreamed of afternoons playing on the green grass of Yankee Stadium or Fenway Park, neighbor John Stokoe served as a head scout for the Baltimore Orioles. He started out as a local kid making headlines in the TImes Union as a lefthanded pitcher in high school. The Braves signed him, and with them he played in the minors for a few years before settling down to family life with his wife Barbara, taking a job with an insurance company.

Stokoe continued to play the game as an amateur in the Albany Twilight League. For six years, he was a player/manager winning championships for Mike's Subs and Finkle Jewelers. As the sun retreated behind the Albany skyline surrounding Bleecker Stadium, he met Barney Lutz. Lutz was a scout for the Orioles, and soon lent Stokoe the opportunity to do the same. A few short years after he was hired on, Stokoe signed Mike Flanagan, a young pitcher from New Hampshire despite having developed early arm trouble. Another six years later, the same pitcher would earn the Cy Young Award on the way to leading the Orioles to the

American League pennant. Flanigan's success earned Stokoe a promotion. Before he retired, the scout was responsible for assessing talent up and down the East Coast. To celebrate his career, he was honored by throwing the first pitch before a game at Camden Yards. Flanigan caught the pitch.

Stokoe died in 2019. His obituary read, "John's commitment to finding the best prospects for the Orioles was not limited to assessing a player's current physical ability but also to scoping out a future player's potential. John had the skill to develop a relationship with the prospective ball player and his family, thus, getting a picture of the player's character, as well."

Through the distant lens of hindsight, Dan was showcasing his talents, his abilities, and his knee to more than just curious kids. The undeniable crack of a fungo bat was an indiscreet knock on Stokoe's door, a bold invite to have him watch.

For a handful of nights, we all stood a few hundred feet away from playing professional ball. The dream was just farther away from being realized for some of us.

New York as a whole has he said. experienced a relatively dry summer. Residents outside of the Adirondack, Eastern Great Lakes and New York Metropolitan regions have been encouraged to conserve water whenever possible during the coming weeks. The National Weather Service in Albany reported that neighboring counties in Dutchess, Litchfield, Berkshire, and Windham slipped further into severe drought as of August 8.

Last week, the National Oceanic and Atmospheric Administration released its latest seasonal drought outlook for August 18 to November 30. The agency reported Delmar in Moderate Drought conditions and expects those conditions to persist over the next three months.

The monitor identifies a moderate drought by observing an increased use of irrigation, lower yields of hay and grain, declines in honey production, and an increase in wildfires and ground fires.

Fortunately, Bethlehem Town Supervisor David VanLuven said the Town's water supplies have not breached thresholds that would trigger the need for water restrictions.

"We have not had to implement water restrictions in more than a decade, and right now it looks like we will be able to get through this summer without any restrictions,"

Bethlehem draws water for approximately 12,000 customers from the Vly Creek Reservoir, New Scotland Wellfield, the Selkirk Wellfield and the Albany Aqueduct. Annually, more than 1.6 billion gallons of clean drinking are distributed across more than 220 miles of water pipes for public consumption.

"Right now, the reservoir is well over five feet above the trigger level," VanLuven said. "That's 150 to 200 million gallons available with no rainfall before we would have to consider restrictions; on an average day, our customers use about 4 million gallons."

Hochul directed the New York State Department of Environmental Conservation last Tuesday to issue an updated drought watch after consulting with the State Drought Management Task Force and federal partner agencies. The watch now includes most New York counties, including Albany County.

A watch is the first of four levels of State drought advisories, which are watch, warning, emergency, and disaster. No mandatory restrictions are in place under a state drought watch.

"This year's belownormal precipitation and above-normal temperatures continue to combine to

exacerbate low stream flows, reduced groundwater levels, and ongoing wildfire risk," said DEC Commissioner Basil Seggos. "DEC will continue to monitor water levels and the environmental impacts of the dry conditions and encourage residents throughout the state to monitor usage and avoid wasting water."

An increasing number of water supply challenges are being reported due to dry conditions. Below-normal precipitation during the last three months, low stream flows and low groundwater levels prompt the need for the expansion of the watch status to ensure adequate public water supplies. Local public water suppliers are urged to assess the current situation, promote voluntary conservation, and take appropriate actions to manage risk.

New York State drought region IIA, which includes New York City and Westchester, remains in normal status due to the satisfactory storage levels and refill probability of the New York City reservoirs. According to the New York City Department of Environmental Protection (DEP), the City's reservoirs are approximately nine percent below normal for this time of year, with 422 billion gallons currently in storage, compared to 469 billion gallons normally. DEC continues to work closely with DEP to monitor reservoir conditions and encourage responsible water use, especially outdoors, regardless of the hydrological conditions or

season.

The drought watch is triggered by the State Drought Index, which reflects precipitation levels, reservoir/lake levels, and stream flow and groundwater levels in the nine drought regions of the state. Each of these indicators is assigned a weighted value based on its significance to various uses in a region. The State Drought Index is attuned to the specific attributes of New York and may differ moderately from some national technical drought assessments.

DEC and U.S. Geological Survey are partners in evaluating hydrologic conditions across New York State. In addition, DEC supports efforts by local governments and stakeholders to undertake water conservation measures based on specific local circumstances. Observed precipitation has been less than normal with shortfalls of two to six inches common over the last 90 days. The dry weather began in the spring and is beginning to significantly affect other metrics. Stream flows and groundwater levels are well below normal throughout much of the affected regions. Groundwater levels have been declining over the past few months and they are not expected to improve in the immediate future due to the existing precipitation deficit.

The National Weather Service outlook for the remainder of the summer predicts above-normal

temperatures and belownormal precipitation. By voluntarily reducing water usage, and being extra careful with fire and outdoor flames, New Yorkers can help conserve our natural resources during

these dry summer days. Homeowners are encouraged to water lawns only when necessary, choose watering methods that avoid waste, and water in the early morning to reduce evaporation and maximize soil hydration. When possible, they are asked to reuse water collected in rain barrels, dehumidifiers, or air conditioners to water plants.

residents are encouraged to raise lawn mower cutting heights. Longer grass is healthier with stronger roots and needs less water. Use a broom, not a hose, to clean driveways and sidewalks, and fix leaking pipes, hoses and faucets.

"While recent rains have helped, severe dry conditions continue to persist across the state," Hochul said. "New Yorkers should take steps to conserve water whenever possible in the areas now under a designated drought watch. Simple steps to reduce water consumption will be crucial to our efforts to help prevent any increased drought levels."

"Whether you're planting a tree or shrub, or installing a deck or pool, every job requires a call to 811 to know what's below before digging," said Mark Prewitt, Vice President of Pipeline Safety & Gas Compliance at National Grid. "The depth of utility lines can vary for several reasons, such as erosion, previous digging projects, and uneven surfaces. Utility lines need to be properly marked in each location, even one that's previously been marked, to avoid risk. A call to 811 is the best safeguard to preventing strikes on underground utility lines.'

State laws mandate that 811 must be contacted 72 hours in advance of beginning projects that require excavation, excluding weekends and legal holidays.

On Thursday, Oct. 13, The Scottish Chamber Orchestra will be providing a rich experience by reimagining the classical masters and romantic greats, as well as sharing other contemporary works. "Ever since Chromatics has endeavored to present leading classical music performers of the day to our audience," Moschner added.

# The Clark Art Institute

Imaginary City- The large-format, abstract paintings of Tomm El-Saieh (b. 1984, Port-au-Prince; lives and works in Miami) teem with dense and dynamic marks that evoke ornament, language, and architecture. By variously layering and erasing his linework, and using vibrant color to optically push or pull his pictures, El-Saieh creates rhythmic, all-over compositions from which larger forms appear to emerge—testing both the limits of our perception and our expectations about abstraction. The exhibition title, which comes from one of the works in the show, refers to a cityscape theme common in Haitian art (Vilai Imaginé). El-Saieh's paintings, which resemble informal urban plans, likewise develop intuitively, without the use of preparatory studies or outlines. For the artist, who has been unable to return to his birthplace in recent years as a result of the instability there, Port-au-Prince now also exists mainly as a figure

in his memory and imagination—a site of joy and trauma, potential and uncertainty.Tomm El-Saieh was born in Haiti and grew up in Miami; he is of Haitian, Palestinian, and Israeli descent. He was the subject of a solo show at the Institute of Contemporary Art (ICA) Miami in 2018 and was included in the New Museum triennial in New York that year. He is partner at the artist-run gallery CENTRAL FINE in Miami and long directed the El-Saieh Gallery in Port-au-Prince, a venue for contemporary Haitian artists that his grandfather established in the 1950s. This yearlong exhibition appears in public spaces around the Clark and is free and open to the public. It is organized by the Clark Art Institute and curated by Robert Wiesenberger, associate curator of contemporary projects. This exhibit goes from January 29th through December 31st. 



New Orleans heavy metal institution Crowbar combines the doomy heft of Black Sabbath, the intense riffage of Pantera, and the intricate progressions of Metallica. Alongside Eyehategod, Soilent Green, Acid Bath, and Down, the group helped establish the NOLA sludge metal movement in the 1990s. Plunging into the mainstream in 1993 with their acclaimed eponymous sophomore effort, Crowbar has spent three decades at the fore of the scene, issuing uncompromising slabs of sonic devastation like Odd Fellows Rest (1998), Equilibrium (2000), Sever the Wicked Hand (2011), and Zero and Below (2022) that stand at the nexus of sludge, stoner, and doom metal. Crowbar emerged in the late '80s with a lineup featuring vocalist/guitarist Kirk Windstein, guitarist Matt Thomas, bassist Todd Strange, and drummer Craig Nunemacher. Once known as the Slugs, the group's slow, grinding, heavy sound drew comparisons both vocally and musically to Pantera, the Melvins, and Tad. Debuting in 1991 with Obedience Thru

Suffering, Crowbar subsequently signed to Pavement Music and released their eponymous sophomore LP. Produced by Pantera's Phil Anselmo, the album included the singles "All I Had (I Gave)" and "Existence Is Punishment," both of which appeared on MTV's Headbanger's Ball and the adult animated comedy Beavis & Butthead. After releasing 1995's Time Heals Nothing, Nunemacher left the group and was replaced by Jimmy Bower, the rhythm guitarist for kindred spirits Eyehategod. ### La Luz

Formed around the guitar playing and songs of Shana Cleveland, La Luz formed with the intention of blending surf music with garage rock while giving it a mystical dash of psychedelia. Early releases were punchy and raw, capturing the band as they sounded on-stage and showcasing Cleveland's fast fingers and way with a whammy bar. As they evolved, the surf receded in favor of more muscular playing and production as on 2018's Floating Features. By the time of 2021's self-titled album recorded with producer Adrian Younge, the band had become fullfledged psych rockers who had learned the value of space and dynamics. La Luz Pete Cortese and Scott McCooe, vocalist were formed in the summer of 2012 by Cleveland, who had previously recorded with the Curious Mystery and Shana Cleveland & the Sandcastles. Looking for a group to fulfill her vision of a band who were equally at home playing upbeat surf and moody garage, Cleveland joined forces with Alice Sandahl on keys, Abbey Blackwell on bass, and Marian Li-Pino (another former member of the Curious Mystery) on drums, with all four sharing vocals. Adopting the name La Luz (Spanish for "the light"), the new group wasted no time getting into the studio (in this case, a makeshift recording setup in a trailer), releasing a four-song EP, Damp Face, before the year was out. In 2013, La Luz issued 7" singles on Suicide Squeeze and Mississippi Records, and soon the Sub Pop-distributed Hardly Art label came calling, reissuing the Damp Face EP and in October 2013 releasing their first full-length album, It's Alive. 

### Tinsley Ellis World renowned Southern blues-rock

ond renowned Southern blues-lock

guitarist, vocalist and songwriter Tinsley Ellis like every other musician was caught off guard when the pandemic shutdown hit in March 2020. Ellis was forced to cancel the tour promoting his just-released album, Ice Cream In Hell, only six weeks into the 60-date run. This would be the first time in 40 years he'd be off the road, and as he drove the 2400 miles home from Reno to Atlanta, he was already formulating his future plans.Ellis resolved to dedicate his pandemic-forced downtime to creating new songs and growing as a songwriter. To get back to his musical roots, he began composing on amps and guitars that he hadn't used for decades. He explored obscure studio and live recordings from some of his greatest musical heroes, such as the Allman Brothers, Freddie King, Michael Bloomfield, B.B. King and beyond, and was inspired by his favorite artists all over again. Eighteen months later, Ellis had written an astonishing 200 new songs. Explains Ellis, "There was a lot of time to experiment. In my downstairs studio I set up every guitar and amp that I owned,

plus a Leslie cabinet, an old wooden Wurlitzer electric piano, an old Maestro Echoplex tape delay and 30 or 40 glass, steel and brass slides. Experimenting with different gear set ups inspired the songwriting. Plus, I was able to listen to more music than I had since the 1970s. My imagination was fired up!" As early as April 2020, he began regularly releasing his new material online, keeping his thousands of fans engaged and soaking up their comments and responses. He knew, thanks to the reactions of his fans to his new songs, that he needed to make a record and get back on the road as soon as possible. Ellis whittled his massive song list down to ten, enlisted his friend and co-producer, keyboard master Kevin McKendree, and headed for Franklin, Tennessee's famous Rock House recording studio. The result is Ellis' new Alligator album, Devil May Care, a record Ellis says, "is for the fans as much as for me." 
