



# **Police identify Marohn**

# Case remains open to continued investigation

LEE, Mass — The Berkshire County medical examiner positively identified the remains found near Fox Drive are that of missing Shaker High English teacher Meghan Marohn.

At this time, the circumstances are still under investigation and the district attorney, Andrea Harrington, is not releasing any other details such as how long the body was there or cause of death.

Marohn was last seen on March 27, and her family reported her missing two days later. It sparked a massive search involving authorities from two states in and around Longcope Park. A civilian discovered the body on Thursday, Sept. 1, near Fox Drive in Lee.

The 42-year-old who was living in Delmar while taking care of her father had been on leave from her position at Shaker High and had gone to Longcope for some hiking and a quiet get away. Her car was found near the trailhead to the park the day she was reported missing.

In May, there was a vigil held at Shaker High School and her family had offered a \$50,000 reward for any information leading to her whereabouts. Her brother, Peter Naple, said not knowing what happened to his sister was the hardest part.

Her colleagues and students remembered her as being passionate about social justice issues and climate change and one willing to look out for those who didn't always fit in with the mainstream crowd. She also started the Troy Poetry Project and was often seen at the farmer's market typing poetry on demand on an old, manual typewriter.

The area where she disappeared is densely wooded and the Lee Police Chief Craig DeSantis told the Times Union late last month that it could be while if that is in fact where she is. Recently, he said, a person died of a medical condition in those same woods and it took nine months to find the body.

Currently, Lee Police, the Berkshire State Police Detective Unit assigned to the Berkshire District Attorney's Office and Bethlehem police are investigating the circumstances surrounding Marohn's disappearance.

# Rabid skunk attacks

### DELMAR — A

Delmar man was attacked and bitten by what was presumably a rabid skunk as he sat down to read in his backyard last Sunday morning.

John Tobison shared on social media that he was sitting quietly reading in his backyard when he observed a skunk charging him from across the yard on Sunday, Sept. 4.

"I froze thinking he'd just run past me," he stated. "[But,] he proceeded to jump on me and chew on my ankle until I finally kicked him off and ran."

The Delmar man was initially concerned about being sprayed before heading to the hospital where he would begin a series of immunoglobulin shots.

Bethlehem Animal Control responded to the scene, but was unable to locate the mammal.

The threat of rabies is

a growing concern during the spring and summer months. In particular, the Albany County Health Department has issued advisories for residents to be aware of bats, which are also carriers of the virus.

The man was issued appearance tickets returnable to Albany City Court on Monday, Sept. 26 at 9 a.m.

# Diner on the move?

Johnny B's Glenmont Diner has a new home pending approval of Stewart's expansion

# GLENMONT —

Stewart's Shops expansion proposal for Frontage Road stands one board away from fruition, and it can't come soon enough for Johnny B's Glenmont Diner.


John Behiri, the eponymous "Johnny B," had closed his diner's doors following the governor's mandate in response to the COVID-19 pandemic. A sign still hangs in the window noting that time, behind the growth of weeds and scrub trees.

Since closing the diner, Behiri has brokered a deal to sell the land to Stewart's Shops as part of its expansion plan, and a restaurant chain has agreed to purchase the Silk City Diner model to incorporate into one of its eateries. All of which is contingent on the plan passing Town Hall.

"It's been almost eighteen months since I signed the purchase contract with the Stewart's Corporation. Eighteen long months in limbo waiting for this sale to go through, Behiri wrote the Bethlehem Town Planning Board in March. "But unfortunately, there hasn't been any talk about the diner at any of the meetings...l've seen the minutes. The only discussions regarding Stewart's proposal to purchase my property are about fossil fuels, diesel fuel tanks, canopies, electric car chargers, etc. All of which are permitted uses...are they

The proposal includes the merging of two neighboring parcels, the existing Stewart's Shop on 33 Frontage Road, and Johnny B's Glenmont Diner. The diner, which closed in June 2020, was formally known as Miss Glenmont Diner.

Stewart's Shops has had a storefront at the location since at least 1982, that's when the deed to the nearly half-acre lot was sold to Dake Brothers, Inc. "There hasn't been any talk about the diner at any of the meetings...l've seen the minutes. The only discussions regarding Stewart's proposal to purchase my property are about fossil fuels, diesel fuel tanks, canopies, electric car chargers, etc. All of which are permitted uses...are they not?"



The initial proposal, submitted to the town last February, suggested the diner was subject to demolition. News of the plan was met by public outcry over social media. Stewart's Shops' latest statement reveals a common interest in preserving the eatery's history.

The Zoning Board of Appeals granted a variance allowing for a diesel canopy that initially hung up the plans in June, just weeks before the Town Board adopted an update to its comprehensive plan that included, among other things, a commitment to prohibit new or expanded fossil fuel stations. Local environmental advocates noted as such in protest to the Planning Board.

"The project is inconsistent with the goals of the Town of Bethlehem's Comprehensive Plan. This fact was acknowledged by Stewart Shops in their latest redesign." Patricia Beeler and Peter M. Iwanowicz wrote in a September letter to the board. "However, their latest redesign continues to expand the number of

fueling pumps (four new diesel dispensers for heavy-duty trucks) at this location and, thus, we believe that it is inconsistent with the Comprehensive Plan."

Stewart's addressed the matter, modifying its plan in July to allow for eight fueling points, matching the same number as those present at the current site. The store chain also noted its plan to add eight EV charging stations, transitioning the Tesla vehicle chargers to universal chargers.

"So this would be our new proposal when we resubmit," Jim Gillespie, Stewart's Shops spokesperson, told Planning Board members Tuesday, Sept. 6.

# Plug Power wants to test in Selkirk's industrial zone

**SELKIRK** — Plug Power, Inc. was before the Planning Board again on Tuesday, only this time to propose a different endeavor involving performance testing within the town's existing industrial district.

The power cell manufacturer has proposed to lease a building and approximately 1.35 acres at 435 Creble Road to conduct performance testing of its stationary power units.

The site is already zoned as Heavy Industrial and the proposed project is a permitted use. The Latham-based company does not propose any site modifications, nor any building modifications. According to the site plan paperwork, it intends to use the site for testing the transfer of gaseous hydrogen.

The hydrogen will be located in up to two mobile tube trailers. Those tube trailers will be rotated into and out of the site to be refilled elsewhere. Hydrogen will be fed from the tube trailers into the stationary power units tested via temporary flexible hoses.

Once a unit has completed its performance testing, it will be loaded onto a truck and shipped to the end user. No units will be stored onsite.

Up until 2020, the site was previously owned by Security Supply, a plumbing supply wholesale company, that used the site for indoor and outdoor warehouse storage.

According to Plug Power, is already accustomed to truck traffic with a frequency of up to four trucks a day. The company stated that it has submitted plans to the Town due "to a change of use only."

An application has been submitted to the Albany County Planning Board to review the application at its September 15 meeting.

# Safety improvements continue in Guilderland

multi-modal transportation to and from school, the Guilderland Public Library, and our broader community here. I commend Supervisor [Peter] Barber for his commitment to seeing these projects through and improving the quality of life for all Guilderland residents."

According to the National Highway Traffic Safety Administration (NHSTA), there were more than 1,000 fatal school-transportation-related crashes between 2011 and 2020, with an average of 113 fatalities per year. Additionally, the AAA Foundation found that risky driving behaviors increased as a result of COVID-19 and the number of riskier drivers increased on the roads.

Officials all stressed that as students return to school schedules, motorists should obey traffic rules, school bus signs, and keep students and themselves safe on the road. More than 50,000 illegal passes of buses occur everyday school is in session in New York State.

'The library community is delighted that there are now sidewalks all the way to the SEFCU/Market 32 area and beyond," said Guilderland Public Library Director Tim Wiles. "This links the library with several apartment communities, and of course provides a safe walking route for families and children to get to the library. Gone are the days when we would see mothers pushing strollers and holding toddlers hands as they walked beside busy Western Avenue trying to get to and from the library. # **ACCORD** works

Analysis shows ACCORD provides successful alternative

ALBANY - A report from the University at Albany analyzing the first year of the Albany County Crisis Officials Responding and Diverting (ACCORD) pilot program has confirmed an alternative emergency response to behavioral health crises is not only necessary in Albany County, but can effectively connect underserved communities with needed social services while reducing long-term reliance on emergency services.

Findings from the report were shared by officials from the Albany County Legislature, County Executive, Sheriff's Office, Department of Mental Health and University at Albany on announced Friday, Sept 9.

The ACCORD program, which was designed to improve outcomes for nonviolent emergency calls. Officials also provided an update regarding the process to expand the program into all municipalities throughout the County.

Officially launched by Albany County in the Hilltowns in June 2021, the program consists of two response teams made up of social workers from the County's Mobile Crisis Team and paramedics from the Sheriff's Office. The law enforcement agencies have been trained to handle situations involving mental health and nonviolent emergency cases where law enforcement is not essential.

As of June 2022, 240 emergency calls were diverted to the ACCORD team resulting in 549 total encounters with 210 different individuals with the majority of calls related to general medical assistance and services/transportation for those experiencing immediate mental health emergencies. In most cases, the ACCORD team was able to de-escalate the situation,

assess the individual's needs, and offer coping strategies and referral services for care. The team also followed up with the individuals and their families to offer continued support and additional services when necessary.

"In the short time the ACCORD program has been in operation the results have shown the need for more mental health staff supporting the needs of Law Enforcement," said Sheriff Craig Apple.

Recommendations to expand the ACCORD program call for a long-term investment that includes additional training and collaboration between police, local officials, mental health professionals and the community.

In December 2021, the County received a \$350,000 investment from the NYS Legislature to help ACCORD expand into neighboring communities. Since then County officials along with the Sheriff's Office and Mental Health have met with all municipalities in the County to discuss how they can implement ACCORD. The next step is to review their 911 dispatch calls to better understand the need for ACCORD in that particular community.

In addition, the Albany County Legislature is moving forward legislation to establish a Mind Your Health Training program, which would provide mental health first aid training to county employees who have hands-on interaction with the public. Employees who receive the training will learn to identify signs that a person is struggling with their mental health; how to interact with a person in crisis; and how to connect that person with help.



# Faculty, staff honored for longevity milestones

**DELMAR** — Bethlehem Central School District faculty and staff officially began the 2022-23 school year just prior to settling into their own classrooms across the district, ahead of students who returned to school on Tuesday, Sept. 6.

The day included the traditional opening remarks from Superintendent Jody Monroe and a warm welcome from Board of Education president Holly Dellenbaugh.

In her opening remarks, Superintendent Monroe emphasized the importance of building healthy relationships between staff and students, and colleagues.

"I have become increasingly concerned about where we are headed with our relationships," Monroe told faculty and staff. "I am not referring to any specific relationship, but in general, societal relationships where we are lacking the ability to engage in respectful and meaningful ways."

Monroe encouraged BC staff to listen to one another but also to talk more and share more to build important relationships and strengthen the school community.

"We talk a lot about getting to know our students, but I think we sometimes overlook the fact that allowing them to get to know us can be very powerful and lead to closer relationships," said Monroe.

Monroe's goals included cultivating culturally responsive faculty, staff, and administration; increasing academic rigor and accountability while also maximizing student social-emotional growth and mental, and physical health; and increasing community engagement.

Part of the opening presentation was used to introduce new employees to the district and to celebrate employee milestones.





# Dearest Wife

He was a high school football and swimming star and collegiate diver who also understood he was fortunate in life.

"Sometimes I really wonder how I will make it. My luck is running way too good right now. I just hope it lasts." he wrote.

1969 was a rocky time, not just for those in the war zone, but also for the country. The United States, as a whole, had formed a general anxiety over fissures in our society over social, economic and political unrest. And the growing divide over the war in Vietnam. Dean was providing a snapshot of that time with his letter and his life before being drafted provided context.

# Early life in Bethlehem

ean Allen grew up on Plymouth Avenue with his parents Florence and Percy Brooks, just off Delaware and graduated from Bethlehem High School in 1959.

Dean had many challenges early on in his life including the loss of his father when he was very young. According to family friend Jean Marie (Oaks) Liberty, it was Dean who, when he was very young, could not wake up his father one morning.

"His mother Florence was one of my Godparents," Liberty said. "He was an amazing athlete and was such a good son and always took care of his mother."

Florence was a firstgrade teacher at Delmar Elementary School, now Bethlehem Town Hall, and retired in 1978 after 30 years of teaching. Although she never let it slow her down, Florence suffered from the effects of contracting Polio as a child.

"When I think of the boys in my graduating class, he was one of the nicest and we spent a lot of time together talking on my front porch," Jane (Mack) Marinello said. Marinello grew up on Delaware Avenue near Hudson Avenue and the two had a connection that was special.

"My dad died at home one day and he had

lost his dad. We had an understanding of what it was like," she said. "We spent lots of time on my front porch, watching the cars go by and we talked about homework, school and just about everything."

One thing that everyone agrees on is that Dean was an outstanding athlete. He was listed as an All-American Diver in high school and played football for Bethlehem. Once he graduated, many of his local friends lost touch with him, but he did teach swimming lessons at Normanside and Shaker Ridge country clubs during college breaks, where many families remembered him.

In 1961 he married Niegel Henry, a fellow diver in Indiana. She placed 8th at the 1960 Olympic trials in springboard diving, but was not on the US roster in Rome later that year. He did not return to the University's main campus in the fall, but enrolled at IU's Indianapolis branch and his son Lance was born in November 1961. They would have a daughter Teresa in 1964 while living in Indianapolis. The couple divorced the next year and Dean returned to Elsmere to work part-time at Verstandig's Florist.

That summer, he met Joyce Hallenbeck, of Voorheesville, while on a drive-in movie date with one of her best friends. During that date, he asked Joyce out. Six months later they were engaged, and a year later Joyce's friend was the maid of honor at their wedding.

"We're still great friends," she said.

In 1966 Dean took a full-time job with Mike's Submarines and Neba Roast Beef, helping them open stores across New York. He was opening

"There are many times while I am out in the field that I really feel the need to talk to you. Not so much about us but what I have on my mind," Dean wrote. a Neba shop in Buffalo and Joyce was teaching in Endicott when they got married in Endicott in November 1966. They honeymooned in Buffalo, where "We were sick as dogs from what we later learned was a gas leak. It was a rough start."

Things got rougher three months later when Uncle Sam came calling and Dean was drafted. It was a rare occurrence for a man, at 25 years old, to be drafted for service, especially for someone with three dependents.


"There were so many odd things that happened in how he actually got to Vietnam," Joyce said. "He shouldn't have ended up there, but he did."

# **Military**

nce he was drafted, he applied and was accepted to Officer's Candidate School at Fort Benning, Ga. Once he graduated, he was supposed to be commissioned Military Intelligence and ordered to Ft. Holabird, MD, but at the last minute, his commission was changed to Infantry and he was assigned to the Combined Arms School in Vilseck, Germany. He served as an instructor.

"That was the only time in our married life that we actually lived together. It was a great year," Joyce said.

Many of the other officers there were requesting to go to Vietnam for the combat credit that would further their careers. Instead, Dean, who had not made such a request, was sent.



After jungle training school in Panama and a stop in Hawaii for a lastminute physical. His old Delmar friend Liberty had an opportunity to reconnect with Dean, because she and her family were stationed in Hawaii.

"I had him stay with us at our house off the base," Liberty said. "We had the opportunity to talk about things. We had really gone our separate ways by the time we went to high school. I am glad we shared that time."

The next day, he was in Vietnam.

# **Quan Loi**

fter reaching Saigon on May 17, 1969, he was stationed with the Army's 1st Battalion, 8th Cavalry, 1st Cavalry Division and would be a platoon commander in Company C. The unit was stationed at an air base carved out of a former French rubber plantation in the Binh Long Province of South Vietnam named Quan Loi. The landing strip was designed for airplanes but it also housed the most-common mode of transportation for the Air Cavalry, helicopters.

Two days before his arrival in Vietnam, North Vietnamese forces attacked and breached the base's defenses. He spent two months at the base and wrote letters to Joyce about being in the jungles around the province.

"He wrote about what they were doing, but none that I remember were like the last one." Joyce said.

Dean started writing it on July 10 and finished

it the following day. His platoon was four kilometers north towards the Cambodian border on a mission to find and expel enemy units that were constantly attacking the base.

"There are many times while I am out in the field that I really feel the need to talk to you. Not so much about us but what I have on my mind," Dean wrote. "Many times like tonight-I am out on ambush with eleven men and a medicafter everything is set up and in position, I have nothing to do but lay there and think--why I am here as well as all the men in my platoon."

On July 15, the platoon encountered an enemy trap, the second one in as many days.

"An enemy explosive, possibly a booby-trapped grenade, was detonated wounding your husband," Dean's commander Captain Thomas Fitzgerald wrote her. "While he was being moved to an area where he could be evacuated by helicopter, a second piece of enemy ordnance was detonated. This device is believed to have been a land mine."

Two other men, Sgt. Luis Torres-Serrano, 20, of Puerto Rico and Cpl. Teddy Middleton, 19, of Mason, Ohio were killed.

The battalion day log read that the 51 men of the platoon were moving on a trail and Dean spotted a broken tripwire on the ground. Before he could move his men, it went off, injuring four, including him. The junior officer then instructed the men to move the wounded 75 meters to

an area where they could be evacuated by helicopter.

As Middleton, the lead man, moved towards the landing area. He hit another tripwire which detonated a larger charge that killed him instantly and wounded seven more men carrying the stretchers. Torres-Serrano died on the way to a field hospital. 11 soldiers in total were injured or killed in the incident including, Pfc James Howard, of Mich., who was wounded from shrapnel in the arms and legs, but survived and later wrote to Joyce.

Dean's wounds were horrific from the two blasts, but he survived the helicopter flight to Long Binh medical hospital just north of Saigon. Joyce was in Florida, where the couple decided to start their life together once Dean's tour was done in six more months, when she received a telegram on July 17 that told of his wounds and his dire condition.

The telegram read "He received multiple wounds to the brain, the left eye (and) face, the chest, the abdomen, both arms and legs. He has lost his left eye and is in a deep coma." Joyce found one sentence a gross understatement; one that only the army could produce: "In the judgment of the attending physician his condition is of such severity that there is a cause for concern," it stated.

The telegram referred to Dean as Joyce's son and gave the wrong middle initial, which momentarily gave Joyce hope that the telegram was a mistake. But there was no mistake. She received a second telegram notifying her that at 10:15 on the morning of July 18, Dean died.

"I served in your husband's platoon and was there when he was hit. This is why I wanted to write," Howard wrote in his letter. "Your husband was well-liked by the men. We felt he was a great officer to work under. You would have been real proud of him, and he will be missed by many. I thought it would help if you knew that. He was a good leader!"

Dean's body returned home, but Joyce had a serious problem. Dean's mother, Florence, was in Europe on vacation and could not be reached.

Inventory of the vehicle found a bag with .40 grams of crack cocaine.

She was charged with aggravated unlicensed operation - drugs, a felony, and DWAI - drugs, aggravated unlicensed operation - suspension, criminal possession of a controlled substance, all misdemeanors, and operating a unregistered vehicle, display plate violation and operating a vehicle without insurance.

"Applebee's Funeral Home kept calling me saying, 'We have to do something with his body; we can't keep it indefinitely,'" she said.

She insisted that she would not bury Dean until his mother returned home and could attend his funeral. The Red Cross finally found her and she was told the news of her son's death at JFK airport, Joyce said.

After the services, Joyce returned to Florida, then moved to South Carolina where she still lives today. The letter from Dean was the only one she kept out of the three or four he wrote while in Vietnam.

"I am not sure exactly why I saved that letter other than, I guess because it was the last one," Joyce said. "It was something from him. I also still have a dime and part of a keychain that the Army returned to me."

Shortly after, she put the letter into a cedar chest with other memories and began to restart her life.

Then something happened that would change everything.

29 years later, syndicated columnist Abigail Van Buren, in her Dear Abby Column, asked family members of veterans in her audience to submit letters received during wartime to a project created by Andrew Carroll. Joyce retrieved the letter and sent a copy to Carroll for inclusion in "The Legacy Project" and eventually it would be one of the 200 letters published in his book "War Letters" in

"History is usually recorded from the view of the big guys; the generals and leaders; this project was to capture the memories and create a record from the guys on the ground," Joyce said. "This became their story and it was from a very different perspective."

Dean's words told that story.

"Being a good platoon leader is a lonely job. I don't want to really get to know anybody over here because it would be bad enough to lose a man – I damn sure don't want to lose a friend," he wrote in the rain while his platoon stopped for the night in the jungle. "I haven't even had one of my men wounded yet, let alone killed, but that is too much to even hope for (it) to go like that. But as hard as I try not to get involved with my men I still can't help liking them and getting close to a few."

Carroll, in an interview with The State newspaper in 2001, reflected on the letter. "Honest to goodness, once I read that letter I knew that this project



was onto something," he said.

Allen's letter was featured in a Time Magazine article, multiple PBS documentaries, an NPR broadcast, ABC's "Nightline," NBC Nightly News, Stars and Stripes and many other publications and media across the country.

When Carroll first received the letter it was one of thousands and he had to code the letters to keep them organized. He marked Joyce's with "MY GOD."

In a letter to Joyce in December 1998 confirming the receipt of the letter, Carroll added a note at the end.

"P.S. Again, I truly cannot emphasize to you how overwhelmed I was by that letter. What an extraordinarily thoughtful and compassionate man. I read the letter late Saturday night, and almost tried to call you Sunday, but didn't want to disturb you. It is the only letter among the thousands that brought tears to my eyes," Carroll wrote.

Joyce and Dean had been married for only two years and eight months yet only lived together for 12 months of that time. She said as she looked at the letter, the topics written about were so serious and different from those discussed during the time they spent together.

"He was 27 when he died and I was 25. Before he was drafted and then went to Vietnam, we didn't pay attention to those things," Joyce said. "We were always thinking about getting through this stage and how we were going to build our life. Neither one of us would have ever guessed he wouldn't be coming home."

Old friend Jean Liberty said she cried when she read his letter to Joyce in Carroll's book.

"The letter was an amazing example of who he really was even though I knew Dean when he was so young," Liberty said. "It was him."

# Own a piece of 'American Pie'

Julien's to auction property from Don McLean

NEW YORK — Julien's Auctions recently announced details of its upcoming "Property From The Life and Career of Don McLean" auction, a celebration of the 50th anniversary of his timeless classic, "American Pie."

The auction is to feature over 300 items from McLean's personal collection curated from his homes in Garrison, New York, Camden, Maine, and Palm Desert, California, taking place from Friday, Nov. 11 to Sunday, Nov. 13th in Hard Rock Cafe New York and online at juliensauctions.com.

Headlining the event and appearing on the auction stage for the first time will be Don McLean's original lyrics of his classic hit single, "Vincent (Starry, Starry Night)," with an estimate of one million dollars.

It was also announced that a portion of the proceeds will go to the Don McLean Foundation, which contributes funds to underserved college students, homeless shelters and food banks in the state of Maine and throughout the country and "Kicking The Stigma," the Indianapolis Colts and the Jim Irsay family's national initiative to raise awareness about mental health disorders and to remove the stigma too often associated with these illnesses.

In 1969, McLean scored his first Billboard Hot 100 single, "Castles in the Air" with the flipside "And I Love You So," from his debut album Tapestry. "And I Love You So" became the most recorded song ever written by Don McLean with over 50 versions recorded. But it would be his next album "American Pie" that would rocket McLean's career as an international superstar with its titular single becoming a worldwide phenomenon and entry into the American lexicon.

The mythic eight-minute-long song with its poetic phrase, "the day the music died," in reference to the tragic 1959 plane crash that took the lives of rock legends Buddy Holly, The Big Bopper, and Ritchie Valens, gave voice to his generation's disillusionment

of American society and a loss of innocence as the tumultuous Sixties gave way to the uncertain Seventies. The smash hit single was No. 1 on the U.S. Billboard Chart for four weeks in 1972 and topped the charts in the UK, Australia, Canada, and New Zealand. The album was No. 1 in the U.K. for seven weeks in 1972, charted for 53 consecutive weeks.

"American Pie" received Grammy nominations for Album of the Year, Best Pop Vocal Performance (Male), Record of the Year, and Song of the Year, and the album's second single "Vincent (Starry, Starry Night)," an emotional tribute to the artist Vincent Van Gogh, charted in the U.S. and the U.K., and ranked Billboard's Top 100 songs for the year.

Local legend long claimed that McLean had written "American Pie" from Tin & Lint Company on Caroline Street in Saratoga Springs. Despite a plaque that commemorates the very spot in which the song was supposedly composed, the legend was debunked by local journalist Thomas Dimopoulos.

# Causing a splash

Mural under a bridge draws color, people to Albany County rail trail

**SLINGERLANDS** - The mural on the Cherry Avenue bridge is located on the columns underneath the bridge.

Last February, professor and artist Fernando Orellana was approached with the offer to create artwork to replace the previous installation painted by John DeMarco. The previous mural had suffered from years of weather and bridge construction.

Inspiration for the mural's design came after Orellana's recent visit to Europe. "In Europe my style loosened up a little bit, probably influenced by the street art I was seeing all around me," he said.

Visitors of the mural will see a variety of shapes, colors and designs intended for both children and adults to enjoy. Orellana purposefully explored a maximalist style for this mural. "As I was drawing it, I was thinking, *this is crazy, it's going to take me forever!*" he laughed.

"But as I was painting, I noticed people kept coming by. They might stop for a minute and see something and the next time see something different," he said. "I just thought it was worth it to push myself to paint something that's really complicated so that people can experience it in lots of different ways over the course of many visits. Maybe get a laugh from it! Maybe get inspired to go and draw."

Most of all, Orellana says it's a "celebration of joy and happiness". "We live in such trying, tough times, I hope that as you drive by or to stand and look at it, you sort of leave yourself for a while and get to be a little happy and playful," he said. "We created a safe space, a sanctuary."

The efforts of the volunteers to complete the new mural were

deeply appreciated.

"We've been really fortunate that we've had so many volunteers come and just want to paint," said Orellana. "I met such interesting, fun people."

"I feel like it's going to draw more people to the trail, just word of mouth, to come look at it," said member of the ART on the Rail Trail committee, Amy Griffin.

The mural is one part of a three-pronged project that included the unveiling of a miniature art gallery called MiniMoCa518 during a Chalk the Walk festival last week.

"I think I speak for all of us on the committee," said Paul Barrett, "that it brings us all great joy to see these projects completed."

He is partner at the artist-run gallery CENTRAL FINE in Miami and long directed the El-Saieh Gallery in Port-au-Prince, a venue for contemporary Haitian artists that his grandfather established in the 1950s. 



# State Champs' 'Kings of the New Age' **By LUCAS GARRETT**

ALBANY — Released on May 13th, Kings of the New Age is a veritable "banger after banger" of pop-punk tunes from local Albany favorites, State Champs. Serving up songs in quick fashion, as is well known for the genre, State Champs have written an album that is wellsuited for new and old fans alike. With a run time of just over thirty-five minutes, Kings of the New Age is a record that starts

and finishes with the same level of unrelenting energy.

Though much of the album in all candor seems to have a "more of the same" feel to the songs, with "Everybody but You," track three, acoustic guitars and passionately delivered vocals serve as the initial lynchpin. Soon, however, fullband instrumentation comes in, temporarily replacing the acoustics with an electric. As the song progresses, we hear a nice blend of acoustic and electric guitar instrumentation. While there isn't a "rap" section, per se, the bridge incorporates an almost singing version of this vocal style before returning to the chorus as

the song's conclusion.

One shouldn't neglect mentioning the production on this album: it's fantastic. Even for those that might not like the sound, the overall "shine" on this record is undeniable. In the view of this author, track six, "Half Empty," is the clear standout.

# CONCERT REVIEW

# Sting, Joe Sumner at Saratoga **Performing Arts Center** By MIKE STAMPALIA

#### **SARATOGA SPRINGS**

 Legendary singer, songwriter, bassist, and former frontman for the seminal new wave band The Police, Sting, brought his My Songs tour to a receptive late-summer crowd at SPAC Wednesday night. At first, the long-running and Coviddelayed tour (named after his 2019 album) appears to be simplistically named, almost a throwaway. But it's actually quite insightful. More on that later.

Sting (nee Gordon Sumner) delivered a brisk, always-solid, sometimes-excellent set of material, more-or-less split between Police songs and solo material from the 80s and 90s, plus a few tracks from his most recent album, 2021's The Bridge. As he noted at one point, this was his eighth time playing SPAC – seven as a solo artist, and one with the Police. I saw his most recent appearance in 2017, which I thought was a pretty impressive showcase from start

to finish. Last night's show fell a bit short of that one. It started a little stiff and, if I'm honest, had me a little worried halfway through the set that it would never catch. It eventually did, and provided some high points that were very high indeed.

He began his set, understandably, with three older classics: "Message in a Bottle", "Englishman in New York", and "Every Little Thing She Does is Magic". These are obviously all killer songs, that have only gotten better with the passing of time. But their performance was a little...clinical...for me. He was playing these classics, and the crowd was GOING to like them. Period. Well-deserved confidence from a living legend to be sure, but that's dangerous territory to tread. To be clear – I enjoyed these three openers. I just wasn't excited by them.

At this point, Sting "solemnly" (humorously) warned us that – yes – he was now going to play some new songs. First up, "If It's Love", which prominently features Sting whistling throughout. Songs that incorporate whistling and avoid being annoying are pretty uncommon. This was not one of those. "For Her Love" was the strongest of the new ones, elevated by the two backup

singers (Gene Noble and Melissa Musique) that I just now was noticing for the first time. An innocuous enough "Rushing Water" followed...

I was definitely a little bored at this point. And it wasn't "new song syndrome"; I'm one of those weirdos who generally like newer material from artists, because (usually) that material is the most exciting to the performer, and that (usually) elevates the performance. But as I really started to zone in Sting, I noticed that he, too, seemed a little bored. I was down in front, and the crowd had sat down as well. I looked around at the band a little more closely and wondered why it was so hard to notice them.

Three from '93 followed. "If I Ever Lose My Faith in You": I never particularly warmed to this song (that's on me), but I did notice the strength of Sting's voice, and (for the first time) the presence of the father-and-son guitarists (longtime sideman Dominic Miller and son Rufus). Some signs of life, but a tooantiseptic "Fields of Gold" was next, followed by "Seven Days". (The only song to name-check every day of the week and get away with it remains, IMO, The Clash's "Police on My Back"). I didn't like it any more live than I did on record.

I wasn't really expecting a recovery at this point, but...

18-year-old Shane Sagar and his harmonica were spotlighted for "Brand New Day" and - wow - the first song with real grit and the first to legitimately catch. Fluke? "Shape of My Heart" similarly gave sunshine to backup singer Gene Noble and again - wow! Where has he been? "Heavy Cloud No Rain" started a little slowly, but when Musique joined in, it transformed into a winner. Miller's guitar break added even more and, dare I say it, things were getting exciting!

Sting famously said in a recent interview that "grown men shouldn't be in bands" and that bands "are merely a vehicle for the songs, and not the other way around". No doubt everyone in the amphitheater was there to see him, and to hear his songs, but...the best songs last night were ones where the band had room to breathe and shine. His statements in that interview explained what I had been feeling; the best moments in this Sting concert were the ones that weren't 100% Sting, and the ones that allowed the other seven people on the stage to do more than just convey the song.

"Walking on the Moon" was well overshadowed by its successor, a killer "So Lonely",

with great guitar work by the Millers, and a great Bob Marley interlude. The uniqueness of "Desert Rose" kept the interest level up, before Sting's son (opener Joe Sumner) returned to the stage to sing "King of Pain". If this song wasn't necessarily super tight, it was at least fun and loose, and felt right for the moment. Requisite set closer "Every Breath You Take" wanted to be the triumph that everyone wanted, but actually paled a little following some of the high points of the last half dozen

A two-song encore of a workmanlike-and-slightlyreworked "Roxanne", followed by the intentional denouement of "Fragile" followed.

Was it a start-to-finish, barnburner of a show? No, but the second half of the set showed he's still capable of one. Sting (no slouch on the bass himself) works better in a band. And I'm not just talking about the Police. It's not just about My Songs.

Opener apple-not-far-fromthe-tree Joe Sumner delivered a likable, if somewhat quick, runthrough of eight songs. His craft has improved noticeably since his last appearance here five years ago. If his looks are unmistakably Sumner's, his voice occasionally evokes a little Bono for me.

coming up at the Waterhole in October.


