# Stopped with fake plates

Shotgun in the truck was found to be legal

#### DELMAR -

Bethlehem Police, on routine patrol, observed a 2017 Hyundai Sonata traveling westbound on Delaware Avenue on Friday, Dec. 9 at approximately 4:05 p.m.

The officer performed a traffic stop and asked about the temporary license plate that had an unreadable issuing state. Upon investigation, the Texas temporary registration did not show as valid and there was another registration under the one showing. That Texas registration expired in October.

The driver of the vehicle, a 24-year-old Albany woman, said that she had purchased the vehicle in Brooklyn and these were the plates issued.

Upon further investigation, the officers



found the woman only had an expired learner's permit and the vehicle was not insured.

The woman also told police that she had a shotgun and ammunition in the trunk. A check of the gun found that it was legal.

She was taken into custody and charged with possession of a forged instrument and aggravated unlicensed operation, both misdemeanors, and operating an unregistered motor vehicle on a highway, driving with an improper license, and invalid registration display, all violations.

The woman was given an appearance ticket to return to Bethlehem Town Court on Tuesday, Dec. 3 and released.

- On Saturday, Dec. 10, at about 10:48 p.m. State Police responded to reports of an unresponsive person in a vehicle at the Cumberland Farms on Western Avenue in Guilderland.

Troopers located a 44-year-old Niskayuna man in the driver's seat of a vehicle.

An investigation determined the man drove to the location where he fell asleep. He was arrested for aggravated DWI and transported to SP Guilderland for processing, where he provided a breath sample that returned a 0.18 percent BAC. The man was ordered to return to court on January 26.

# Vote official for court seat

Marcelle win to Supreme Court seat certified

SLINGERLANDS — It is finally decided. Tom Marcelle has been elected to the State Supreme Court in the Third Judicial District after the NY Board of Elections certified the November 8 vote.

Marcelle was one of four candidates vying for three seats on the court. He was the only Republican and joins Democratics Meagan K. Galligan and Sharon A. Graff to serve in a district that includes Albany, Rensselaer, Columbia, Schoharie, Greene, Ulster and Sullivan counties.

After election day and the counting of absentee ballots Marcelle led Heidi Thais Cochrane, the third Democratic in the race by just over 1,000 votes.

The slim margin triggered an automatic hand recount by the Board of Elections which was completed and then certified on Thursday, Dec. 15, according to Marcelle's campaign. The final number was 999 that separated Marcelle and Cochrane.

Because of recent changes in the election law, and the contest was within one half of a percent, it had to be hand recounted.

"It was a five week project, but it worked out in the end," Marcelle said. "It is a relatively new process



of an automatic recount. A few votes changed in each county, but it really wasn't anything significant."

The final totals according to the BOE website was Galligan 167,627 votes (16.19 percent), Graff 165,824 (16.02 percent), Marcelle 164,776 (15.92 percent) and Cochrane 163,777 (15.82 percent).

"It showed that there wasn't much difference between the machines and hand counts," he said.

Marcelle was the top vote getter in Green, Rensselaer, Schoharie and Sullivan counties while he gained the least number of votes in Albany, Columbia and Ulster. The term for the State Supreme Court is 14 years and handles criminal and civil cases.

it a challenge, but Marcelle

used his work experience in Albany County to overcome it.

It really wasn't a new concept for him since he has a history of running races with slim odds of winning, including a 1993 run for Albany County District Atorney against Sol Greenburgh.

"At 31 you have no idea what running as a republican in Albany County is like, but I found out fast," Marcelle said. "It was eye opening."

He did win election to the Bethlehem Town Board in 2005 and served until he launched an unsuccessful run for Bethlehem Town Justice.

During that time, 2001-2011 he was the Attorney for the Albany County Legislature Republican minority. But in 2012 his professional life would take a turn working for the Democratic-controlled County as the County Attorney.

He was then appointed by then Mayor Shawn Morse to be a City Court Judge in Cohoes. Morse was the former majority leader in the Albany County Legislature. Since then, he was reappointed by Cohoes Mayor Bill Keeler.

In the race for State Supreme Court, he was also the only candidate from the immediate capital district and was a familiar name and he believes that helped.

"I was the only candidate from Albany and Rensselaer counties, the two largest. I am from and I was known there," he said. "I had lots of strong supporters that were democrats that helped me that normally wouldn't if there was another candidate from the area."

Proof of that, according to Marcelle, is that he overperformed in all of the counties, winning more votes in those areas than Lee Zeldon.

"It showed that some people recognized me and my work," he said.

Marcelle said it will not be a problem to be on the bench as a Republican in a Democratic-dominated area, however.

"I am going to be a judge of the law. What the legislature writes and the court of appeals upholds as law, I will follow." Marcelle said. "I am going to follow the constitution and not reach decisions based on my views. It is that simple."

She joined Dunvagen Music Publishers, composer and musician Philip Glass' music publisher and management, in 2016.

White now lives in Brooklyn where she is currently pursuing a master's degree at NYU Stern in addition to her professional career.



# BC senior's heads to Lincoln Center stage

**DELMAR** — Who landed among the stars at a recent gala at Lincoln Center in New York City? If you guessed it was an aspiring singer, songwriter and musician from Bethlehem Central High School, your guess would be spot on.

That's because BC senior Maddie Gallagher got the chance in November to perform onstage solo and with her musical idol, Sara Bareilles, at a star-studded event that served as a fundraiser for a cause near and dear to Gallagher. That cause is support for a network of camps that are part of the SeriousFun Children's Network, a community of specialty camps serving children with life-threatening illnesses and chronic disabilities and their families.

While Gallagher is an alto in the high school's Choraliers and plays viola as a member of the Philharmonic Orchestra, it was through one of those camps - the Double H Ranch in Lake Luzerne - that producers of the Nov. 14 "Stories and Songs Gala" at Lincoln Center discovered Gallagher's talent.

The invitation to join Sara Bareilles and others on the big stage came as a surprise to Gallagher - a longtime Double H camper with Spina Bifida – who was more focused on completing college applications at the time the call came in.

"I got the message from the Director of Operations at Double H and she asked me, 'How would you like to perform with other campers at Lincoln Center alongside Julia Roberts and Sara Bareilles?" recalled Gallagher, who said she did not know camp staff had shared a video of her

performing at a local fundraiser in 2021 with organizers of the gala. "I literally dropped my phone after I read the email."

Gallagher spent five days in New York, four of them preparing for the big event with the help of veteran Broadway directors and choreographers who worked with all of the event's performers, including Gallagher.

"We got to work with some of the best, biggest music directors on Broadway," said Gallagher. "Our music director was Mary-Mitchell Campbell. She is amazing. She has worked with everyone in the industry."

Gallagher said the daily 10-hour rehearsals were strenuous but the experience was rewarding in so many ways.

"All the camps are free for all campers to attend," said Gallagher. "Camp is something I look forward to every summer so it's nice to give back to a place that has given so much to me. The gala raised over \$2 million," said Gallagher. "But also, my idol, Sara Bareilles was there. I have always loved her, and after meeting her and hearing her perform live, I have so much more admiration for her and the songs she writes."

Several numbers featured the seven campers, including a group number, with campers accompanying Bareilles on her hit song, "Brave." Gallagher was also chosen to perform a solo. She sang "Pure Imagination" from Willy Wonka and the Chocolate Factory.

After her solo, Gallagher ran into Bareilles backstage where the Grammy award winner offered feedback on her performance.





# Worth a shot

Last week, the Bethlehem Central School District reminded parents to keep children home and to test for COVID-19 when expressing symptoms. District officials included a list of precautionary measures for residents to follow, including washing hands, sneezing "into your elbow" and staying up-todate on vaccines.

Cautionary messages started going out from all offices, from local schools to the Centers for Disease Control. Each urging people to get their flu shot.

"Nationally, the last several weeks have shown a spike in the number of cases of respiratory viruses among school-aged children," shared Albany County Executive Daniel McCoy in an online statement on Wednesday, Dec. 14. "These viruses have included a triple threat of the flu, RSV, and COVID-19. While these diseases can cause various symptoms, the number of cases and their severity can be lessened by getting your child vaccinated."

The New York State Department of Health noted a new report

showing a 64 percent week-over-week jump in lab-confirmed flu cases across New York in the first week of December, and a 58 percent increase in hospitalizations.

"Our message is simple but urgent especially as we approach the holiday season: get vaccinated today," Štate Health Commissioner Dr. Mary T. Bassett said. "This year's vaccine is a very effective match to the currently circulating flu strain, as well as being a safe, widely available, and critically important step in curbing the spread of this highly infectious virus. As the flu can lead to serious health complications or even death, I urge every New Yorker who has not yet been vaccinated to do so as soon as possible to protect themselves, their loved ones and their community."

The weekly flu report also confirmed one influenza-associated pediatric death in the state. To protect patient privacy, the Department could only confirm the death.

Influenza has been widespread across New York for nine weeks, with

lab-confirmed cases in the latest report climbing 64 percent for the week ending December 3 over the previous week, and weekover-week hospitalizations up 58 percent. The Department's most recent influenza surveillance report also found cases in all of New York's 62 counties.

The report is available on the Department's Flu Tracker dashboard on the NYS Health Connector which provides timely information about local, regional and statewide influenza activity. It shows that so far this flu season, there have been a total of 113,345 positive influenza cases in New York.

Nationally, the weekly U.S. surveillance report from the CDC estimates there have been 7,300

deaths across the country so far this season attributed to flu, including 21 pediatric deaths. Additionally, an estimated 120,000 hospitalizations have been due to influenza, a cumulative rate that is higher than during the same time period in every flu season since 2010-2011.

As the holiday season ramps up with gatherings among family and friends and crowded activities, it is especially important to take precautions to protect against the flu, including getting vaccinated and wearing a mask if you are symptomatic or are among populations at heightened risk. Those considered most vulnerable to infection include children under the age of five, pregnant women, older people and those with underlying health conditions, such as a weakened immune system, diabetes, heart and lung disease, and asthma.

The state said that the

influenza vaccine is effective birth. For older adults, the in preventing individuals from getting the flu and reducing the risk of severe illness for children and adults if they become infected. Studies compiled by the CDC have found that the vaccine carries a number of important health benefits, especially for those

According to the CDC's studies, the vaccine prevents people from getting sick with flu, cutting the risk of having to go to the doctor by 40 to 60 percent. In children, the vaccine reduces the risk of severe, life-threatening influenza by 75 percent; decreases flurelated hospitalizations by 41 percent; and cuts the risk of emergency department visits in half.

Flu vaccination during pregnancy is said to also reduce the risk of hospitalization by an average of 40 percent and protect the baby from flu for several months after

CDC said vaccines reduce the risk of flu-associated hospitalization by about 40 percent. Among those with chronic health conditions, the vaccine is associated with lower rates of some cardiac events, as well as reducing the risk of hospitalization from flurelated worsening of lung diseases and diabetes.

The Department is utilizing a number of tools to increase public knowledge about rising flu rates and the importance of vaccinations as a critical prevention step, including sharing information on social media platforms Instagram, Facebook and Twitter.

The flu vaccine is also widely available, found at pharmacies, health clinics, and physician's offices across the state. To locate a flu vaccine location near you, visit vaccines.gov.



# **Keeping yourself healthy**

In addition to getting the vaccine, simple preventative actions can help stop the spread of flu and other respiratory viruses:

- Wash your hands often with soap and water for at least 20 seconds. If soap and water are not available, use an alcohol-based hand sanitizer.
- Avoid touching your eyes, nose and mouth with unwashed hands.
- Avoid close contact with people who are sick.
- Stay home when you are sick.
- Cover your cough or sneeze with a tissue, then throw the tissue in the trash.
- Clean and disinfect frequently touched objects and surfaces.

# Time for goodbye

The Purple Pub to close its doors after 50 years

**WATERVLIET** — The Purple Pub is closing its doors after 50 years in business.

With "incredibly heavy hearts," owners Greg and Butch Rentz announced they will close the restaurant to on-site on Friday, Dec. 30. The Purple Pub To-Go service, however, will remain operational.

"As the old saying goes, 'All good things must come to an end' and after 50 long, successful, and beautiful years, that end is now here," the two stated in an online statement shared on Wednesday, Dec. 14. "It's simply time to 'take a break', to prioritize our health, and to be able to spend time with our wonderful families."

The family opened the popular restaurant at 2 Cohoes Road in 1972, just north of downtown heading towards Cohoes. As one Yelp reviewer described it in April, it was an "old school tavern" with little frill to distract patrons from what it was.

"The decor hasn't been touched in decades, and I don't think much else has changed either judging by the stories my friends were telling me about the place," wrote the reviewer. "Everything was good in its own right and I get why people keep coming back.

... This is a family joint that has been kept in business for decades by devoted locals, and I am not one to hate on tradition."

Scores of faithful patrons shared their stories and gratitude for the restaurant. Within three days, the eatery's Facebook announcement garnered more

than 500 comments from past customers, many of whom represented generations who have passed through the doors.

"Been going there since I was a kid with my parents. I've brought my own kids there also," said Mike Sullivan. "Sad to see you go but you were truly a family-friendly restaurant always.. Good luck in your well deserved retirements."

Troy's Vito Ciccarelli said he often crossed the Hudson to visit, and had been for years.

"Being I've been a loyal customer since the day's of a \$1.75 club sandwich, I wish everyone all the best. This is very upsetting news to hear," he said.

The pub's announced closing comes nearly two years after the Rentz surprised followers with a similar social media post. The clamor that followed prompted them to clarify that they were not closing.

"This is more than likely the

direct result of two old guys not knowing the power of social media."

The last three years have grown difficult for restaurant owners. The Rentz alluded to labor laws changing overtime, split shifts and minimum wages among their reasons to retire. A lingering pandemic that has led to labor shortages and supply chain issues has also contributed.

"But, in our heart of hearts, we know the most important reason of all - it's simply time to 'take a break,' to prioritize our health and to be able to spend time with our wonderful families," the two shared in their note to customers. "It has been an absolute honor to have served each and every one of you over the past 50 years. There is nothing in this world we could have ever done that would have brought us the same pride and joy that the Purple Pub has brought to all of us - we could never have been 'us' without all of 'you'."

spellcheck fixed the spelling of that.



# Blessings Tavern loses matriarch

Elizabeth Altrock. beloved owner of Blessings Tavern, died unexpectedly at 66

Elizabeth Bennett Altrock, the matriarch owner who returned Blessings Tavern back to the community from a tragic fire, died suddenly on Monday, Dec. 12. She was 66.

Altrock had been the owner and operator of Blessings Tavern for more than 20 years, purchasing the popular venue from Ed Blessing in 2001, whom she had worked for since 1983. She recently noted the anniversary of her first day with a post on social media.

"39 years ago today I started working at Blessing's Tavern! What a ride!," she wrote just four days before. "17 years working for Ed Blessing, then buying it when he retired in February

2001. Many great memories...and still making more. Thank you [to] all our wonderful patrons."

Many of those patrons took to social media where the news of her death inspired posts of both sorrow and gratitude.

"One of a kind," Darlene Reynolds stated to describe Altrock. "Liz built a tall, tall



ladder and climbed it to the top all by herself. Definitely one of a kind and loved by so many people.'

Brittnie Love, an employee of the tavern, described "one of the worst days" of her life upon learning that her boss had

"I lost one of the most important people in my entire life," she wrote. "Never met someone who had the biggest heart of gold, and cared about so many people. .... My heart is truly broken."

Altrock, a native of Chenango County, had attended Albany Business College to pursue a career in secretarial science after moving to the area. She held a state job for a short time, according to her obituary, and took on a job at the tavern where she would stay.

The Blessing Tavern building, from which the original owners operated since opening its doors in 1950, succumbed to fire in 2016. The blaze was sparked by a fiery automobile crash from outside the tavern. Michael Carr, then an 18-year-old, was driving his car after having smoked marijuana and consumed rum.

Carr's friend Niko DiNovo was in the passenger seat when he lost control and crashed into a truck parked next to the side of the tavern. The crash sparked three explosions; one from the truck, another from Carr's automobile, and a third from the gas lines leading into the tavern. Altrock was helping behind the bar when the accident occurred. She described a fireball rushing through the dining room of more than 50 people attending to sing karaoke that night. She had helped rush people to safety.

DiNovo, who was pinned inside the car that sparked the fire, died after more than a year at Westchester Medical Center's Burn Unit. Carr was sentenced to six years

It took Altrock more than three years to return back to business. She reopened the tavern in a new building, designed with exposed wooden beams she introduced to remind her of her family's farm on Pigeon Hill, outside of Norwich. The horseshoes that hung on the wall were a nod to her father, Walter, who was a blacksmith. She said they weren't Amish, but they were close. When she posted the reopening event on Facebook, more than 1,500 people responded within a matter of days.

"The community was supportive," she said after the reopening. "They expected [a reopening] and they wanted it. This place was a landmark. There were a lot of people who were at a loss as to where to hang out. It's always been a neighborhood meeting place."

Survivors include two brothers Arthur (Joan) Bennett of Smyrna, NY and Maurice (Judy) Bennett of Plymouth, NY; two nephews: Wade (Amie) Bennett of Watervliet, NY and Brent Bennett of Plymouth, NY and a niece Melissa Grant of Sherburne, NY; many great nieces & nephews; cousins as well as many friends.

Funeral Services were held at Cannon Funeral Home in Colonie. A burial is to be in the spring at Cole Hill Cemetery in Otselic.

Eventually, she did follow in the family tradition, singing in church and then with the jazz band at Fordham High School for the Arts, with whom she won Best Vocalist at JALC's Essentially Ellington competition. That led to her enrolling in SUNY Purchase's jazz studies program, where she fell deeply in love with the music. Though she's young, she relishes the process of digging through the music's history and learning new standards. "I think maybe people connect with the fact that I'm not faking it, that I already feel embedded in it," Samara says. "Maybe I'm able to reach people in person and on social media because it's real." The gatekeepers of the jazz world tend to agree: in 2019, she won the Sarah Vaughan International Jazz Vocal Competition, and she's since performed with legends like Christian McBride and Bill Charlap. Legendary late pianist Barry Harris was a particularly important influence and mentor. "You inspired me as well as many others with this fire for teaching and playing that couldn't be dimmed by anything or anyone," Samara writes in Linger Awhile's liner notes, dedicating the project in part to Harris' memory. # Therein lies the rub

How to avoid repetitive strain injuries

epetitive strain injuries can upset workflow and compromise exercise routines. Though such injuries are often characterized as nuisances, for many people they're much more than a minor inconvenience.

Data from the Occupational Safety and Health Administration indicates that repetitive strain

injuries (RSI) affect roughly 1.8 million workers in the United States each year. Such injuries are common across the globe, as researchers in Sweden estimate that roughly one in 50 workers is suffering from the symptoms of RSI. These injuries also are not limited to adults, with one study from researchers at Australia's University of Technology finding that 60 percent of children suffered discomfort when using a laptop.

The Cleveland Clinic notes

that RSI most commonly affect certain parts of the body, including:

- fingers and thumbs
- wrists
- elbows
- arms
- shoulders
- knees

These areas of the body are vulnerable when people routinely engage in activities in which they repeat the same motions. For example, office workers who

spend eight hours a day typing away at their computers may develop RSI in their fingers, thumbs, wrists, and/or elbows. Such workers need their jobs, so what are they and others who suffer work-related RSI to do? Prevention of RSI is not always so easy, but individuals can try various strategies to reduce their risk of developing RSI.

- Make adjustments to your workstation. Individuals whose RSI are a byproduct of sitting at a desk and working on a computer all day long can adjust their workstations to see if this helps reduce strains. For example, a keyboard wrist rest is an inexpensive accessory that can be placed between users and their keyboards to keep their wrists in a neutral position and alleviate wrist pain that results from typing all day. Mouse rest pads serve a similar function and can be equally effective. A keyboard and mouse pad should be low enough to allow users to relax their shoulders.
- Consider replacing your desk and/or chair. Desks and chairs also could increase risk for RSI if it they are not compatible. Office workers should be able to pull their chairs beneath their desk when they're sitting and working. If the desk is too small or low to the ground to allow that, or if the chair is not adjustable so it can be pulled up to the edge of the desk while

working, workers' posture could suffer, as they will be forced to lean into their desk and narrow their shoulders when typing. The Cleveland Clinic notes that improving posture helps people avoid putting extra stress on their bodies that can contribute to RSI.

 Get up and walk around. Prolonged periods of sitting can increase the risk of RSI. Sitting at a desk all day long without taking routine breaks means those parts of your body vulnerable to RSI, such as the wrists, elbows and shoulders, are not moving all day. The strain that puts on these parts of the body increases RSI risk, which underscores the importance of taking routine breaks.

• Stretch before sitting down. Stretching may be something associated with a workout routine, but the principles of stretching also apply to sitting at a desk. Exercise enthusiasts stretch to loosen and protect their muscles and tendons from injury, and the same idea can safeguard office workers as well. Some simple stretches throughout the day can keep muscles and tendons in the hands, elbows and shoulders loose and reduce the risk of RSI.

Individuals vulnerable to repetitive strain injuries can employ various techniques to reduce the likelihood that these painful and potentially debilitating conditions develop.









parkling wines are made by sealing the beverages before the fermentation process is complete, causing the effervescent bubbles that is their hallmark. Sparkling wines are produced in various regions of the world, but "champagne" is unique to the Champagne region of northeast France, where vines were introduced by the Romans many centuries ago.

One of the most legendary and heralded brands of champagne was created by a French monk named Pérignon. Historians say Pérignon lived from 1638 to 1715 and was admitted in his lifetime to the abbey of Saint-Vanne. He acquired the honorary title of Dom while there, and also served as cellar master, creating what later would be known as the "vins de Pérignon."

Dom Pérignon champagne is still a prestigious brand today, joined by other leaders of the industry like Moët & Chandon, Veuve Clicquot, Nicolas Feuilatte, and Pol Roger. French champagnes are part of elegant toasts, A-list events and five-star dining experiences. They also may be poured on New Year's Eve. All champagne is sparkling wine, but not all sparkling wine is champagne.

Enjoying champagne on its own in the requisite stemmed glass is tradition, but champagne also can be mixed into any number of cocktails — from bellinis to mimosas. This "Blood-Orange Champagne Cocktail" is a variation on the classic mimosa, and doesn't necessarily need to be enjoyed at brunch. Serve it on New Year's Eve, or for any special occasion, courtesy of Martha Stewart.

# Blood-Orange Champagne Cocktail

# **INGREDIENTS**

21/4 cups freshly squeezed or frozen blood-orange juice 750-ml bottles champagne, chilled

## INSTRUCTIONS

Pour 3 tablespoons juice in each champagne flute. Fill flutes with champagne, and serve.

# Jorma Kaukonen at The Egg's Swyer Theatre

ALBANY – The near sellout crowd at The Egg's Swyer Theatre Tuesday night for Jorma Kaukonen's solo acoustic show was dominated by long-haired men "long in the tooth," as Jorma described himself when asked what's on his bucket list. The vibe was anticipatory waiting for the show to begin.

Jorma's fans were obviously beside themselves to see the man who founded the Jefferson Airplane, the group that 57 years ago broke the stranglehold that the British Invasion had on the Billboard charts. The Airplane was the first American rock band to break into Billboard's Hot 100, preparing the way for The Grateful Dead's redefining of youth culture, bursting on the world from San Francisco's Haight Ashbury hippy conclave.

But Tuesday night, Jorma refused to be defined or confined by The Airplane's heavy rock sound. Beginning in the late '60s he simultaneously recorded and toured with Hot Tuna, a

band that to this day performs in both acoustic and electric configurations. His solo Albany show was the second in a series that falls on the heels of an electric Hot Tuna tour. He performed alone on a bare stage, on an acoustic guitar. He had another one close by that he never picked up. I'm assuming it was there as backup if he broke a string.

"When you play with other guys, it's a conversation," he told me in an advance interview. "Playing with myself is a monolog, so you have to cover more bases when you're playing by yourself."

He opened the first of two sets with a 100-year-old blues standard "Nobody Knows You When You're Down and Out." That number set the tone for an evening that included "San Francisco Bay Blues," a folk standard in the repertoire of scores of folksingers I heard in the Boston coffeehouses of the early '60s. He also performed the standard "Hesitation Blues" with its familiar refrain: "How long do I have to wait/Can I get you now/Or must I hesitate?"

Scattered among these old chestnuts were Jorma originals that are practically indistinguishable from the standards. I say standards, but his own book of originals is part of that heritage. Still, it was fascinating to hear him perform them without any accompaniment. I've interviewed Jorma a number of times in his career and am consistently surprised by his complete lack of ego about the role he's played in formulating the American songbook.

He refuses to accept the label as being a protégé of the Rev. Gary Davis, if only because he didn't have the money to take lessons from that blues legend who taught so many folksingers back in the day. And while his merch table is dominated by Jefferson Airplane CDs, he once told me that if he hadn't been stoned in those early days, he'd have been too bored to continue in a band at a time when he was just learning how to play electric guitar.

Jorma's first few years in San Francisco included time spent with Janis Joplin, herself an artist who was a folky before going electric. On Nov. 25, Jorma released for Record Store Day Typewriter Tapes, a restored and remastered 1964 recording of Jorma on guitar and Janis Joplin on vocals. Jorma's first wife Margareta can be heard

typing away intermittently in the background.

"It was recorded on a half-track mono tape recorder I got. It's a great recording thing. Who knew? You know? Really! People talk about the Janis experience. I go, 'Look! Stop! We were just kids.' Janis was still a teenager then. I was only like 22, 23 years old. We were like just kids and having a great time, and having a musical connection. 'Cause people look back and assume you have some picture of what your life is gonna be. You know that. You don't know what's going on."

Jorma's voice Tuesday night was almost a whisper, and his picking was decidedly folky. His guitar work was mesmerizing for two sets lasting almost three hours.

# Pokey Lafarge and Cicada Rhythm at The Egg's Swyer Theatre

— Pokey LaFarge, "La La Blues"

An artist who wants to be seen as relevant, not retro, Pokey's reverence for the best of the past is evident in his wide-ranging, vintage-inspired rock and roll sound that dips into blues, folk, jazz, western swing, soul and R&B. After what he has called, "The worst year of my life, 2019. I was in withdrawal from a lot of things that were killing me," his most recent release, 2021's In The Blossom of Their Shade is also colored by LaFarge's new-found Christian faith. His Instagram lists him as: Christ Follower, Artist, Musician, Actor, Traveler. From "Long For The Heaven I

An energetic, magnetic live performer, Pokey steered his

band through an extended jam on "Something in the Water" and had people dancing in the upper aisles with "Central Time."

The sharply dressed band was appreciated by the audience, with one woman yelling out, "Your bass player is so hot!", the bassist replied, "Stop....go on!" A standing ovation at the end of the show brought the band back to encore and close with "Goodnight, Goodbye":

It's the end of the night, it's the end of the show

Could even be the end of the world as we know

# Doctor Baker's 'Trespassers' By LUCAS GARRETT

octor Baker's latest release, Trespassers, which came out on September 9th, is a nice blend of Americana, roots-rock, and a smattering of jazz. The group's first fulllength record, there's some great material to unpack; some straightforward and some not so much! Combining tightly performed instrumentation with a vocal that explores some low and high notes without ever getting too adventurous, there's something on this record for lots of various tastes in music.

To begin the album, "Exhausted," blends elements of post-punk with pop-rock of the late 1980's and early 1990's. The guitars on this track are extremely jangly! During the chorus sections, the vocals and guitar have a nice calland-response arrangement, and after the second chorus, we hear a very tastefully executed guitar solo, before the band jumps back into the refrain. Throughout the song,

the melody floats along in an enjoyable, albeit predictable way. To end the song, we hear one more chorus, followed by a brief instrumental outro.

One thing I really enjoy about this record, is the sardonic nature of some of the band's lyrics. Take for instance, "Miss Myself," track two. The song tells a rather narcissistic story of the concept of missing one's self after they have passed on, rather than those around the narrator who may actually be missing them. A lone guitar plays in the intro, and the band soon joins in. An unrelenting chordal motif plays throughout the verse and interlude sections, driving the vibe into listeners' ears. The chorus features pounding drums between the vocal phrases. At about the halfway point, the song takes a completely unexpected turn when it slows down, becoming far more plaintive, before kicking back up in tempo and energy.

"Hey Romeo," track three, features a higher-pitched guitar part; the audience has a chance to instantly familiarize themselves with a grooving part that sticks in the brain. Overall, the tune has a solid

swing feel, with some very nice interplay between the vocal and instrumentation. Throughout the course of the song, the melody alters a bit in rhythm, making it an ear-grabbing change; it's a great way to build an interesting arrangement. One thing that Doctor Baker really nails down well is crafting a memorable chorus section. While nothing is overtly difficult in lyrics or melody during these sections, that is precisely what makes them captivating and easy to get stuck in one's head.

For the next song, "Holiday Lights," some light guitar work brings the piece forward until we first hear the vocals enter. Through the tune, the instrumentation fills in the gaps nicely between melodic phrases. Developing further, the harmonies that are added gel quite effectively. In this song in particular, the drum fills are essential to the subtle jumps in energy as it progresses. During the latter half of the tune, overdriven electric guitar instrumentation enters the fray, bringing even more of a lift to the vibe, before we hear an interesting guitar solo outro. Not a lot of notes, perhaps, but all the right ones. Following this, we hear one

more verse section before the track ends.

Changing things up a bit in the title track, track five, audiences are greeted with an incredibly fuzzy bass line. It's filthy sounding and I love it. A lot of this instrumentation reminds this listener of Jethro Tull (no, not all Tull songs have the flute in them!). The blistering guitar performance turns a thus far "simple" sounding record strictly in terms of the songs' difficulty - into the goddamned stratosphere. After all of the frenzy concludes, the energy briefly tapers way down before building back up to finish the

Following up is "Dark Times." There're some really nice and snappy guitar chords on what

sounds like the classic "single coil" sound. The vocals during the verse are paced in a peculiar fashion. Drums push and pull the feel of this song quite a bit; at times it sounds like they're about to fall off the beat, but never do so. This cleverness in the arrangement is effective when executed well, as is the case with this tune. The fuzzy guitar solo that occurs about halfway serves well to break up the somewhat monotonous nature of this tune.

During the intro of "Little Space," track seven, one of the guitar parts performs a nice interlude that features mid-tohigh pitch bends. It's not long before listeners realize this serves as the overall motif of interlude music for the song; it's effective placing it in the intro in order

to establish some familiarity with it. The lyric in this one is definitely quirky! "I used to stand up so much straighter/ My spine stretching out to the sky/I could reach whatever I wanted/I thought I'd never be denied."There're also references throughout, including what this listener suspects to be a reference to Alice in Wonderland. To conclude the song, the same guitar interlude continues throughout the outro. From the start of the record, until now, the majority of the material has been fairly straightforward.

That being said, "Asylum," track eight, is a tune in 6/8. It moves along at a quick clip and the guitar part in the intro really drives the song into action. These lyrics are definitely socially driven; a commentary about where we are currently as a nation. While never naming any one person, it's fairly obvious who the words are being critical towards. After one of the choruses, a tasteful guitar solo is performed, at which point the drums kick up a couple of notches, and the overall energy of the piece soars. While the intensity of energy does slowly dip back down, it's never to the extent where it was prior to the solo. At the final chorus, we hear one final refrain that is accompanied mainly by drums, with the occasional guitar chord. An extremely interesting and ear-grabbing way to end a tune!

Doctor Baker really branches out of the record's sound with, "Keep it Shut," track nine. The

Latin inspired feel that permeates this tune is definitely a welcomed switch-up! Throughout the song, a bossa nova-esque groove (not quite a bossa nova pattern) really pushes the song forward. On top of that, the bass part on this track, in terms of how well it accompanies the other instrumentation, stands out far more than with other songs on this album.

The album's penultimate track, "Permanent Migraine," is a return to more straightforward songwriting. That being said, the subtle slapback delay on the guitar part sticks out nicely in the mix, as well as the vibrato. A sign of a good storyteller, and in this case, songwriter, is to have the details or info match the title of



the work. This is certainly done well for this tune, as the chorus sounds a bit cluttered, and might serve well to convey the "sound" of a migraine. It's the only tune on the record that has a fade-out.

Finishing off the record is "Us People." There're some really nice jazz voicings on the guitar in this track. On top of a bedrock of these types of chords, listeners are greeted with some nicely placed melodic guitar fills. This song incorporates far more jazz vibes than others on the album; it's a mellow tune that greatly breaks up the flow of the album. Being the last on the record, ending it this way - introducing a whole new sound to their listeners could very easily leave people wanting more.


