Public invited to comment

The Voorheesville board of education is presenting its draft of the district's new tobacco policy to the public to collect input on changes before adding it to the board of education's policy manual.

The new draft includes more specific wording about tobacco use and enforcement than the board's current policy.

Currently, the policy states thatstudents cannot smoke a cigarette, cigar, pipe or use chewing or smokeless tobacco on school grounds, as well as prohibiting smoking by staff or other tobacco use in all school buildings, on school grounds or at any school-sponsored event.

The new draft provides a detailed reason for the new policy, policy definitions and specific rules and consequences regarding the use of tobacco and related items by staff and students.

Superintendent Linda Langevin said the draft is a complete change from what is currently

County doesn't lose money in counterfeiting scam

Bank catches false county checks overseas By ROB IRWIN irwinr@spotlightnews.com

The Albany County comptroller's office has recently been notified that the county has been the target of two attempts to defraud the county of hundreds of thousands of dollars.

On Friday, Dec. 22, the county's Deputy Comptroller Billy Curran was notified by Bank of America that an individual had attempted to cash a counterfeit county check on Monday, Dec.18, in the amount of \$153,000 at a bank in India.

Bank of America detected the fraud because the check number was the same as a check issued to a county elections official in September for \$125.

After being notified, and checking records, the county told the bank not to honor the check.

"The county does not have a loss on this chain of events," said Albany County Comptroller Michael Conners.

The fraudulent check, dated Nov. 30, was made payable to M. Raja Paranthaman. An address on the check lists Paranthaman's address as Tamil Nadu, India.

This check was made payable to the order of Mat Noor Bin Sallah, who listed an address in Malaysia on the check.

Both fraudulent checks are nearly identical in appearance to the original county checks except the counterfeiters had changed some numbers on the checks, and removed the strip indicating that the check contains security features. The counterfeiters did not change the check numbers on either of the checks.

The county is keeping private the names of the county elections officials who had received the original checks.

office contacted the FBI to begin an investigation. It is unclear at what point the checks could have been taken by the counterfeiters to be altered.

Conners is concerned that this could happen again, and said there were other checks that were issued to county elections officials at the same time these checks were cut. Conners said the authentic nature of the checks bothers him.

"When you look at the fraudulent check, it actually looks like a better check," he said.

The check was probably scanned into a computer software program and printed. This is something, said Conners, that "someone with an eighth-grade education and a \$700 computer' could do.

mayed with the county's current safeguarding system. Currently, on each check, the county's system allows bank technology to verify the date, check number, and amount in on the check before the bank dispenses any funds.

A system called Payee Positive Pay takes this a step further by allowing the bank to verify the pavee's name on every check. This is the system Conners said he would like to see implemented.

"My concern, of course, is Albany County taxpayers don't get caught holding the bag," said Conners.

Conners said he was also concerned that the county's insurance against these fraudulent activities was inadequate.

"My concern is the two checks alone are over \$300,000," he said, adding that the amount is greater than the insurance the county has.

Charles Bruce, director of the National Check Fraud Center, said the county was lucky it was not held responsible for the fraudulent funds.

"Should the bank have paid these monies, it would have been hell getting these monies back from international banks," Bruce said.

Bruce, whose center handles an average of 1,600 cases per day, speculated that the county could expect more problems in the future.

Usually in situations like these, * said Bruce, the checks are obtained in the U.S., passed around the country and then deposited overseas. In these situations, said Bruce, typically the checks are taken from either the mailroom or the local post office annex.

In this case, the elections officials received their checks and both were deposited in two local banks.


Conners speculated the checks could have been taken from anywhere.

"You hope it didn't occur at the county, but it could have, you hope it didn't happen at the bank, but it could have," said Conners.

Charles L. Williams, an expert witness in check fraud and check forgery, said cases of this magnitude are special, and often harder to break than small scale operations in which someone like a bookkeeper may make checks payable to themselves.

"Two of the real key questions," said Williams, "are, how did this happen and who the bad guy is."

Ernesto Anguilla, who handles New York media relations for the Bank of America, said the bank could not comment on its clients' accounts.





Seasonal equipment sales slump for lack of bad weather

Dreams of a white Christmas may be over now, but area businesses relying on a steady fall of snow have been left high and dry since autumn. Adding to the winter woes is the fact that last winter also left snow lovers out in the cold.

"Our pre-season sales depend on what went on in the previous winter," said Duane Leach, owner of All Seasons in Scotia,

a snow blower sales store. "The whole year 2006 never budged out of the 40's and 50's degrees; it was amazing to see so much rain and no snow. I'll be glad to see the year end."

Leach, who has been in the snow removal equipment sales Sales in Charlton, prenon-wintry conditions are among the worst he can recall.

"We've had some bad years as far as lack of snow, but this is one of the really bad slumps," said Leach. "In 1974, there was no snow and no gas, and that was a terrible combination. We've gone through some low snow years, but this is a real doozy.³

Leach has had to slash his

inventory, but he still straddles said. "Most people don't buy a the fine line between cutting his losses and having enough equipment in stock should Mother Nature decide to turn things around.

One thing he is selling a lot of is rakes. The mild winter meant the manual leaf-clearing devices sold longer into the fall than usual.

clients are looking to cut a deal for this year's service.

"We have re-negotiated our contracts this year, but people always have to be ready for winter conditions," said Max Stafford, owner of AAA Pump Sales and Service in Schenectady, which also supplies snow removal, shoveling and salting services. "Senior citizens especially have to have a contractor ready to dig them out."

Stafford said he has stocked far less rock salt to sprinkle on icy walkways, but the salt is easily available on an as-needed basis, and his regular staff of could quickly be two augmented with a third person should a blizzard hit. But for now, his emergency snow removal service has melted into nonexistence, and so he is leaning on his other business offerings to stay busy.

We also do sump pumps, and we're relying on them right now for business," said Stafford.

The lack of snow has also hit suppliers of winter recreation equipment.

Snowmobilers need a good coating of snow for their sport; on grassy land, they turn instead to ATVs.

At Phibbs' Power Sports in Colonie, once a factorysnowmobiles, they're no longer stocking the Cats.

"We have Yamahas, but snowmobile sales have been flat the last three years," said Jeff Blair, a sales rep at the sports store. "This global warming is affecting snowmobile sales nationwide. People are very reluctant to buy anything."

Just as school kids are hoping to wake up to a snow day from school, people in business relying on a good old-fashioned winter wonderland are keeping their fingers crossed, waiting for those flurries to fly.

What we need is for a good Nor'easter to be predicted and everyone to rush in for snow equipment," said Emerich.

That could be a while, though.





In with the new

Gov.-elect Eliot Spitzer will start off the New Year and his new job with a bang. The outdoor swearing-in event (weather permitting) will be at noon in West Capitol Park and will launch a day and evening of entertainment and fun, with events for kids and adults.

But the true test of Spitzer's mettle and ability to change business as usual lies in the weeks and months ahead. New York is an unwieldy state,

with a history of governmental dysfunction and abuse that boggles the mind. The 20-year record of late state budgets



shows only some of the disdain state leaders show for the law. Failing to keep the lid on the state's high taxes is another flaw. Add to this the rising number of young people moving out of state for more bang for their buck, plus a cheaper price tag for government services, as yet more indicators of New York's failure to change.

State leaders of either political persuasion don't seem to mind being last or close to last in any kind of reform of accomplishment.

So whether one person can tackle such enormous deficiencies is questionable. It's hard to fathom what a single person can accomplish in the murky politically sullied seas of our state.

Still, it is a new beginning, and there must be some hope that some things will be changed or corrected.

We don't doubt that New York's recent governors were well intentioned, but the task of running, much less changing the way things are run, are monumental.

Right now, Mr. Spitzer seems highly charged and filled with enthusiastic, ambitious intentions. He should begin his term by hitting the ground running. He, after all, is familiar with some of the machinations of the state, so he should be able to skip that part of the learning curve when he begins work in earnest as governor.

We wish him success in his attempt to lead the state in a manner that raises its image to a higher level than dysfunctional at least.

Let us hope, despite the odds, the new leadership will register some success to redress some of the sins of the past.

The eternal quest for organization

Barely a day goes by but what at least one person, upon finding out what my business is, doesn't say, "I need you to get me organized." This time of year it's even more prevalent everybody's on the eternal quest to get organized.

Why, you might wonder, is everybody so disorganized and overwhelmed?

Aside from all the demands on our time like our jobs, homes, kids, community activities and other responsibilities, more and more people are acquiring more and more things, accumulating more and more paper and becoming more and more overwhelmed with their accumulated stuff, and that spells more and more business for the professional organizers of the world.

January is "National Get Organized Month" and that draws attention to this huge and growing problem.

There are many different kinds of people who seek the help of professional organizers, but let's talk about several I've seen repeatedly.

There's the person or family that is literally inundated with paper that grows by the day; there's the person who is an avid consumer or shopper and before he/she realizes it, is drowning in belongings; and there's the person who chronically hoards or obsessively accumulates a variety of things.

The most common organizing dilemma I face with my clients, or in the dozens of classes I teach, is that person who is drowning in paper. I read a statistic somewhere that claimed the average American receives more mail in one day nowadays than that received by an entire family in a week a mere 10 years. ago, and that doesn't even include printed e-mail or paper

from your kids' schools. Dealing with paper is a relatively simple process of reducing it at its source and implementing four or five simple steps.

Lots of people view shopping as a hobby, buy loads of stuff, and before they know it are looking around their houses unable to see a clear surface. Collecting wasn't really a conscious decision for this client.

Purchases just sort of accumulated over time, leading to a situation where this "typical" client is overwhelmed with the immensity of his or her organizing difficulties and he or she doesn't know where or how to begin. This is a set of circumstances that can be tackled successfully. I approach these big, overwhelming organizing challenges in a methodical manner that breaks the project down into smaller and smaller pieces that can be scheduled and completed over time so it's less Sorting, overwhelming. discarding and re-organizing takes place as we work our way through the entire house, office, room or target area. This approach is one anyone can follow when getting organized.

The chronic hoarder or obsessive collector is another problem altogether. If you or someone you know cannot bring him or herself to get rid of the most insignificant piece of paper, who constantly buys more stuff when there is no more room to store it, whose living space can no longer be comfortably lived in because stuff covers every surface or floor - whose clutter is made up of seemingly worthless stuff like packing peanuts, used wrapping paper, old magazines or something similar - chronic hoarding or obsessive and compulsive collecting might be the issue. This is the type of problem that demands the professional attention of a psychologist or psychiatrist who may be able to move the client to a point where the services of a professional organizer are beneficial.

Let's face it. We Americans love our "stuff." Often "stuff" represents wealth, love, comfort or security. It becomes a problem only when acquiring or maintaining "stuff" becomes the goal itself. I'm not a minimalist. I, too, love my "stuff" but there are some questions you should be asking yourself about your stuff. They are: • Can I find what I need when I need it? • Am I comfortable inviting family and friends into my home? • Do I miss opportunities to

do fun things like tràvel or go out with friends because I'm obsessed with organizing my stuff?

 Am I losing important mail or paying fees and charges because I'm paying my bills late?

 Am I missing important deadlines or events because of disorganization?

If these questions strike a chord with you, you may need to step back and get some help getting organized.

Downsizing and organizing can change your life. Much of my work is done with seniors looking to move to smaller homes or retirement communities. I find that many of them have collected a lifetime of loved possessions which they hope to leave to their children; universally, however, their children don't want any part of the "stuff" and the seniors are now struggling with not only a way to dispose of their accumulated possessions but the feelings that go along with downsizing, moving and getting rid of things that represent the events and emotions of a lifetime.

You know that great feeling of relief and weightlessness you get when you've completed some job you've been dreading, putting off or agonizing over? Well, multiply it by 10 and that's how my clients describe the feeling they get after they've taken the steps necessary to get rid of junk, pare down their belongings, and organize what's left.

My students and clients often say learning some simple approaches and strategies that get them beyond that feeling of being overwhelmed with the complexity and sheer magnitude of the organizing challenge allows them to be hopeful that they can finally get organized. Once the goal is achieved, the house or office is organized, there's less clutter, everything has a home and things are where they are supposed to be when you go looking for them. People report feeling freer, lighter, able to take advantage of opportunities and ready to face the challenges of the daily barrage of more stuff, more paper and less time.

Now, as the New Year begins, is the time to take stock of yourself and your own personal organizing challenges. Learning to get organized is not rocket science, it's a simple combination of some skills and the desire to change, combined with action that moves you toward the goal of living your life differently.







and ease in front of the congregation," Zimmerman said. "His maturity and his skills show that this was a real calling."

As the youth and family minister, Heine is strategizing on how the church might better serve community youth.

"He's got a lot of good ideas, innovative approaches, running through his head," said Mueller.

"He's seen the lay of the land, he's been reaching out to middle school, high school, and college-aged students," said Mueller. "It isn't the same as it was even 10 years ago. There are different influences. He connected very quickly with our youth. Instantly we saw an increase in participation in youth programs."

For some time, youth programs at the church have been event driven, organized around weekly or less frequent activities. But in a world where children are ever more scheduled, this approach doesn't work, Heine said. In a paradigm shift, he plans to make youth programs "ministry-driven" and structure them around everyday doings.

defined.

"It's so different I can't in all good conscience call it an update," said Langevin. "It has standards for everybody and specific consequences."

The board of education's vice president, C. James Coffin, said he thought that the new draft is comprehensive and adequately prepared with outside recommendations.

"I thought it was a pretty complete package," said Coffin.

Langevin said the school board worked with the Board of Cooperative Educational Services (BOCES) to complete a survey with a look at whether what the board had in place was adequate.

"Basically, we analyzed whether or not it was comprehensive enough," said Langevin. "We found it had several areas lacking."

Langevin said making the policy as effective as possible is important simply "because smoking kills."

The policy draft, which is very specific, includes guidelines that would prohibit tobacco promotional items and advertising on school grounds, in school vehicles, school supplies and in school publications. Students and staff will be prohibited from wearing clothing, shoes, accessories and gear promoting tobacco products on school property.

Additionally, the district will "strive to request tobacco-free editions of all publications in school libraries and classrooms."

The policy draft also states that the policy will be promoted and

well as understand the effects of tobacco use on both students and staff. The policy also lists preventative education as a primary component of the health education program, cessation counseling and community information as major parts of the district's efforts to prevent and alleviate smoking concerns.

According to Langevin, there are occasionally problems with students smoking on school grounds.

"I think every district has that problem," she said.

District residents can submit their input on the draft, found on the district's Web site, to the board until February when it will be looked again.

Coffin recommended that the community read the draft, and make decisions and comments about whether or not they feel it is adequate.

The board will move forward once all comments are collected from district residents.

• It took an Orange County jury fewer than six hours on Aug. 10, to find 23-year-old Christopher Porco guilty of murdering his father, Peter, and attempting to murder his mother, Joan, with an ax inside their Delmar home in November 2004.

"We stand before you crushed and profoundly disappointed," said Porco's attorney Terence Kindion.

Porco was immediately handcuffed and taken away from the courtroom by authorities. He was then driven by sheriff's deputies back to the Albany County jail to await sentencing.

The case lasted eight weeks and included the testimony of more than 70 witnesses and hundreds of evidence exhibits.

Jurors pointed to the timeline and the unaccounted whereabouts of Christopher Porco when the crime was committed as factors in their decision.

• A "ticking" canister found outside the Delmar Post Office on the morning of Aug. 11 shuts down Four Corners traffic in Delmar for several hours, forcing the evacuation of several nearby businesses and residences. The canister found under the monument sign in front of the post office did not have any explosive device attached. The state bomb disposal unit was at the scene and the FBI investigated.

• Construction in the Bethlehem School District continues with completion of a new high

• Owens Corning in Selkirk celebrates 30 years in the Bethlehem community with an anniversary celebration for its employees. The 630,000-squarefoot plant is one of 13 in North America. More than 360 people are employed at the plant.

• Students of Bethlehem High School protest a ban on wearing hats inside the school by presenting the school board with a petition signed by more than 800 students objecting to the ban. School officials say the no hats policy is common courtesy and some students wear them as a sign of gang activity. Students tell the school board there are no gangs in Bethlehem.

"The school has a right to set rules so that nothing is disruptive to the educational process," said Loomis. Board members decide to review the new code of conduct policy regarding the ban on hats.

October

• Thomas D. Robbins, a 1994 Bethlehem High School graduate, is posthumously awarded the State's Conspicuous Service Cross at a ceremony outside the Albany County office building on

n Oct. 2.

"We pay a tremendous price for freedom and that price is visible today," said U.S. Rep. Michael McNulty, D-Green Island, who attended the ceremony.

Robbins was 28 years old when he was killed in action in 2004 in a mortar explosion. Robbins is the first Iraq War veteran to be honored by Albany County's Honor-A-Vet program.

• The proposed 2007 Bethlehem town budget calls for a 2.75 percent increase to the tax levy. A final vote on the budget will take place in November.

Egan said the new budget holds the line on expenditures.

• An event called "Eagles Fly" is held Sunday, Oct. 8, to raise money for three sports programs in the school district. Organizers hope to restore \$52,000 for hockey, gymnastics and cheerleading at Bethlehem High School.

"Every student deserves an equal chance in their athletic programs," said organizer Beth Garbo. The fundraiser was held to offset cuts made by the school board in June after the first school district budget went down to defeat.

• A group of Bethlehem teen skateboarders approaches the town board at its October meeting asking them to approve a site for a skateboard park. The teens tell officials there is an opportunity to get a disassembled skateboard park from Croton-on-the-Hudson, but it would need approval from the town to find a site. Town officials say the Bethlehem Middle School is being looked at as a potential site for the park, but lawyers were working out legal aspects of the arrangement. The village of Voorheesville is also looking at the same skateboard park from Croton-on-the-Hudson.

November

• The Bethlehem Town Board approves a \$36.5 million dollar budget with only one board member voting no. Tim Gordon voted against the 2007 fiscal plan that carries a 2.79 percent tax increase. Gordon who is leaving his position at the end of the year to become the 108th district state assemblyman, said "property taxpayers are getting hammered," and called for his colleagues to use the fund balance to offset any tax increase.

• Tim Gordon and Ryan Donovan celebrated local victories on election night when Gordon defeated Martin Reid for the 108th District Assembly seat and Donovan turned back a challenge from Brian Murphy to retain his appointed seat as town justice. Gordon said his victory was "a team effort from the beginning." Donovan, who replaced Frank Milano as the town appointee to the justice seat this past summer, said he is "excited and humbled by the voters' support."

• Albany County Assistant District Attorney Michael Mc-Dermott announces he is leaving the office for a position with the Albany-based law firm of O'Connell and Aronowitz beginning Jan. 1. McDermott was the lead prosecutor in the murder trial of Christopher Porco.

Albany County District Attorney David Soares called McDermott a "loyal public servant and a wonderful friend."

• A newly released audit from the state comptroller's office revealed that former Voorheesville school superintendent Alan McCartney charged at least \$11,500 to the district for expensive dinners, an evening at a strip club and other activities.

The findings were released after the office of state comptroller decided to expand the Voorheesville school audit originally released in January. New school Superintendent Linda Langevin said "the district is seeking full restitution from Dr. McCartney."

• Eagle Elementary School is the name selected by Bethlehem students for the new elementary school to be built across the street from the high school. Construction on the new elementary school is scheduled in the spring.

December

• The long-awaited sentencing of Christopher Porco was held inside Albany County's Judicial Building on Dec. 12. Orange County Supreme Court Judge Jeffrey Berry handed a sentence of 50 years to life for the 23-year-old Bethlehem resident. Porco was convicted in August of murdering his father, Peter, and trying to murder his mother, Joan, with an ax inside their 36 Brockley Drive home in November of 2004.

Terence Kindlon, Porco's lawyer, is appealing the decision.

• Delmar's Old Fashioned Four Corner's WinterFest event along Kenwood and Delaware Avenue saw this year's weather go from warm and windy to cold and blustery within a 24-hour period from Dec. 1 to Dec. 2. Shoppers enjoyed the eighth annual event with plenty of activities and Santa Claus greeting the children.





he holidays are over, and Mother Nature isn't brightening the bleakness of winter with her usual blanket of white snow. Even the prospect of going to the movies again seems humdrum.

"Our 'Then and Now' series take place on some Sundays, beginning at 1





Open ice for everyone

Delmar parent's dream for son nears

sport his twin brother Ben plays, including hockey. The problem is, Luke's cerebral palsy prevents him from play-

ing competitively. Starting in September, though, Luke will have the chance to play a competitive sport. Bethlehem Youth Hockey is starting a region-

wide sled hockey program that is open to people of all ages. "I think it's really exciting. I can't wait to get on the ice," said

Luke.

Sled hockey has many of the same rules as regular hockey. The primary difference is that the players sit on specially designed sleds with hockey skate blades on the runners, and they propel themselves with two short hockey sticks that have metal picks at one end to grab the ice.

Luke's parents, Kim and Tom Wilson, spearheaded the push to establish a sled hockey program in the Capital District, and it didn't take them long to convince Bethlehem Youth Hockey's administrative board to give it a chance.

"They welcomed us with open arms. (The vote) was unanimous," said Kim. "They are actually sponsoring us by giving us ice time" at its home rink, the

Bethlehem Area YMCA.

The sled hockey program will start with a junior team in the fall coached by Ben Ferber, who has coached by Ben Ferber, who has "Our goal was to get a Thru-experience as a hockey player and "way league," said Sabres sled a youth team coach. A novice team, an intermediate team and a senior team will be added in the future.

"I've done a lot of research on the Internet," said Ferber. "There's a lot I still have to learn, but I've already got the basics."

To raise money and awareness of the sport, the Wilsons worked with the Buffalo Sabres sled hockey program to set up two exhibitions. The first took place Dec. 27 between periods of an Albany River Rats home game. The second exhibition takes place Jan. 13 at 1 p.m. at the Bethlehem Area YMCA.


