Town clerk excited for retirement

Newkirk has served 32 years in Town Hall

It began with a call at home, and it will end Jan. 1 as Town Clerk Kathleen Newkirk hands off the reins to her office and retires after 32 years working in Bethlehem Town Hall, more than half of them as town clerk.

She's served as clerk during the tenure of no fewer than seven supervisors, and before

that worked as deputy town clerk, a stenographer in the Building Department and as a part time clerk for the Board of Appeals. She made the decision to run for town clerk when Carolyn Lyons announced she was retiring, and was elected in 1992.

"Carol informed me she was not planning to run for reelection, so of course that made a decision for me ... next thing I know I was full time in the Town Clerk's office and running for election," she said.

Newkirk was first tapped for her shorthand skills in 1977. She had previously worked in

V'ville Chain Links Club inspired to help boy with a rare skin disorder

In the weeks leading up to the winter break, most middle school students spend their time wondering what kinds of presents will await them underneath the Christmas tree. However, at Voorheesville Middle School, a group of students have decided that this year they will be on the giving side of the holiday.

Spurred by local media coverage, students of Voorheesville Middle School's Chain Links Club have decided to promote a clothing drive in the month of December for a young boy afflicted with a rare skin disorder.

The boy, Randy Saunders of Greenwich, has a

rare skin disorder called ichthyosis, which causes his skin to grow three times faster than normal human skin. The result, according to Randy's father, Rick Saunders, is dry, constantly flaking skin. His parents have to bathe him sometimes up to three times a day in oil to help his skin retain moisture.

The grease on Randy's skin takes its toll on his wardrobe, making the clothing useless after a few uses. When the students of Voorheesville Middle

Officials put limited spending freeze in place

The Bethlehem Central School District's Tuesday, Dec. 15, state aid payment came in a little light as a result of Gov. David Paterson keeping his promise to withhold \$750 million in municipal and school aid payments in an effort to combat the state's worsening financial situation.

The district's Chief Business and Financial Officer Judith Kehoe said that about \$105,000, or

Man allegedly had guns, ammunition in truck

The Bethlehem Police Department arrested Mason G. Murphy, 34, of 26 Western Ave., Hudson Falls, and charged him with criminal possession of a weapon in the third degree, aggravated unlicensed operation in the third degree, unlicensed operation and two violations of federal motor carrier safety regulations on Wednesday, Dec. 2.

Police observed Murphy's pickup truck pulling a trailer that did not have its own lights attached and was not displaying an inspection certificate and pulled the vehicle over at 908 Route 9W in Glenmont, according to arrest reports. A DMV check showed Murphy's license to be suspended from the City of Glen Falls and the registration on the pickup to be expired, though the trailer registration was valid

through 2009, police said.

An inventory of the vehicle revealed three firearms in the backseat of the pickup: a Mossberg 12-gauge shotgun, a 30.06 scoped Remington rifle and a Saiga .308 semi-automatic rifle. Police also located a box of ammunition containing 365 .308 rounds and two high-capacity rifle magazines each loaded with 25 .308 rounds that police recognized to be illegal in New York State, according to police reports.

Murphy was remanded to Albany County jail on \$10,000 bail, which his brother posted. He was scheduled to appear in court on Dec. 15.

Other arrests

• The Bethlehem Police Department arrested Eilene P.

Studler, 38, of 19A King Court, Selkirk, and charged her with DWI, refusal to submit to a breath test, avoiding a traffic controller and failure to dim headlamps on Friday, Dec. 4.

Police said Studler's vehicle was observed flashing its headlamps several times by a patrol car waiting at a red light at Delaware Avenue and Elm Avenue. The car then drove erratically south through a Stewart's parking lot onto Elm Avenue, avoiding the red light, according to police.

The patrol car followed Studler's vehicle when the light turned green and the vehicle was observed following another car "extremely close" before police pulled it over on Wicklow Terrace, police said. Studler turned over her

license, registration and Price Chopper AdvantEdge card without being asked, according to police reports. When asked why she gave her AdvantEdge card, Studler replied, "It's all together," and when asked to clarify said, "You need that too," according to arrest reports.

Officers observed Studler as having glassy, bloodshot eyes, redness of the face and an odor of alcohol on her breath, according to police reports. Police said she failed field sobriety tests and when submitting to a breath test failed to provide an adequate sample before refusing the test, saying, "Not until I talk to my lawyer."

At the station, she became increasingly aggressive and stated that police had better have secured the large amount of cash in the glove box of her car, though

police did not observe money in the glove box, according to arrest reports.

She submitted to three chemical tests at the station but failed to provide adequate breath samples for any, police said. Judge Paul Dwyer remanded Studler to Albany County jail on \$1,500 bail and suspended her driver's license.

• A Bethlehem police officer found a counterfeit \$50 bill in the parking lot of 317 Delaware Ave., Delmar, on Friday, Nov. 27, according to police reports.

The bill was turned over to detectives, who determined it to be an approved replica of play money and, based on the circumstances of it being located, that there was no basis for criminal intent or a criminal charge.

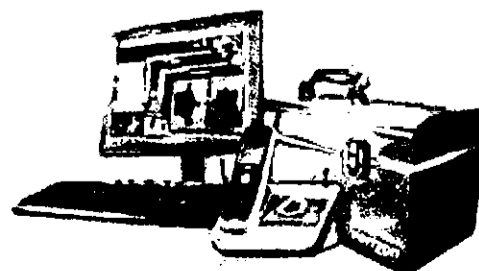

'Odd couple' have energy

Company's window panels see widespread use in Capital District

What do you get when you combine a former union leader and Irish rebel supporter with a young West Point grad? In the case of Jim Devine and Kevin Powell, a company that is making waves in the Capital District and elsewhere.

Together, the two run Windo-Therm of Hoosick Falls, which manufactures and installs Advanced Energy Panels. Devine, 65, started the company in 1999 after creating the panels, but his business really started picking up in the last few years when energy prices spiked and green building became a buzzword.

"I thought it was an idea whose time had come," Devine said.

Powell got involved earlier this year after seeing Devine's presentation at an Apollo Alliance conference on green jobs. He joined the company as chief operating officer.

"I liked his product and what he was up to," said Powell, who added that his details-oriented mindset and engineering background complement Devine's big picture thinking and amicable personality.

"He's got an uncanny ability to open up a room and to loosen up a crowd," said Powell of Devine. "We're in a field where we're often with architects and engineers, where it's often pretty dry ...

we're definitely the odd couple."

"I'm the dreamer who's running around trying to open up doors," said Devine. "I need Kevin to bring the professionalism. ... He's got a lot of skills in areas that I don't."

Powell, 28, graduated from Bethlehem Central High School the same year Devine started Windo-Therm, and then went on to study at West Point and serve a stint in the Army. He also went to Boise State once he was discharged and served as a congressional page in high school.

Windo-Therm specializes in the manufacture and installation of their Advanced Energy Panels — in short, an aluminum frame with a glazed material that keeps the cold out without spoiling the view. According to Windo-Therm, the average \$99 panel can pay for itself in three to five years.

It's a perfectly suited treatment for older buildings whose drafty, thin windows do little to keep out the cold but are often a part of the historical character of a building. Putting an AEP panel in can bring even the oldest windows up to Energy Star standards, said Devine.

"For the first time in history, it's actually possible to make an old window Energy Star efficient and not throw it in the dump," he said.

The company has already had success in the Capital District. Their panels are in the Bethlehem Public Library, Department of Environmental Conservation

offices, Amsterdam City Hall, Cohoes City Hall, Skidmore College, RPI, Hudson Valley Community College and other locations.

The company is pursuing other projects in the area. The Downtown Schenectady Improvement Corporation has agreed to pick up half the tab for downtown businesses installing the panels, for example.

But the duo is also focusing on training and education. While the company employs eight in Hoosick Falls, Powell emphasized that because work increasingly comes in from all over the state and country, having experienced people in place would be a real help, and also provide much-hyped green job opportunities.

"One of the ways we're looking to build our business is to put the work in the hands of people right

now," Powell said.

They've already trained senior citizens in Schenectady to install the windows through the group Umbrella for the Capital District and are in talks with Schenectady Youth Build to provide internships for younger learners. Additionally, Devine said, the company is close to forging a partnership with Father Peter Young's work in providing housing and training for ex-convicts and drug addicts. This statewide network could help bring the their business plan to an even wider area.

"We have physical orders in every corner of the state of New York, and we need people in every corner to install them," Devine said.

The most difficult part of running a small business is not the hours, the work or the

compensation, said Devine, it's being located in notoriously business averse New York. He remains Upstate, he said, due to a desire to bring jobs to the local economy.

"I feel oftentimes tempted to move to Massachusetts," Devine said. "I've resisted the urge to move because I like the people here. ... I'm very frustrated with the inability to get an ear in the State of New York."

As for Powell, he's hoping Windo-Therm will be successful and grow into a multi-million dollar venture, but he also likes keeping business moving in the Empire State.

"A lot of these town out here are literally dying," he said. "Part of it is the commitment to keeping jobs where the people are."

Bethlehem Planning Board tackles multiple issues

Board mulls Russell Road development and Beverwyck expansion plans

The Planning Board addressed several significant proposals at its Tuesday, Dec. 15, meeting, perhaps the most controversial of which was an application to build a gas station/convenience store and a condominium development on Russell Road in North Bethlehem.

The plans call for two areas of development separated by a stretch of federal wetlands that cannot be built upon. The developer is proposing a 2,900-

square-foot Stewart's store with fueling stations and 18 parking spaces at the corner of Krumkill and Russell roads.

To the east, down Russell Road, would be a development of six buildings housing 44 condominium units. Although the design of the condos has not been finalized, consulting engineer Daniel Hershberg of Hershberg & Hershberg said the buildings would likely hold 1,200- to 1,600-square-foot units on two floors with garages beneath. The buildings would be built on a grade so the garage spaces would only be visible from the rear, making for a two-story structure to the front.

Blessing Road resident Jim Martley addressed the Planning Board during public comment to summarize issues raised by a meeting of area residents in November. Both Martley and the developer agreed that the meeting was well attended. The town was not represented.

"A majority of the residents were not in favor of the Stewart's part of this project," Martley said. "It would be nice to have the condos there, but the Stewart's is not in the

personality of this area."

He cited a range of concerns including fumes from the fueling station, increased traffic in the area, minors having access to alcohol and tobacco and the general commercialization of the area.

Hershberg said that while there is a contingent of residents who are flat-out opposed to the project, many of those who attended the November meeting had legitimate concerns that also had legitimate answers. He presented the Planning Board with a letter from the Albany County Department of Public Works endorsing the traffic patterns proposed in the plan.

He also said that the Stewart's store would be built in the "Manchester model" of design, which he presented as more visually agreeable for suburban communities, and that the Stewart's will not have as big an impact on the surrounding community as many seem to think.

The issue of visual impacts is a chief concern for nearby residents however, and Hershberg posited that "very significant landscaping" would screen the project.

"We will obviously work with planning to have a good screen of evergreen trees," he said of the rear of the condo development.

Planning Board member Nicholas Behuniak said he would like to see more detail on the landscaping and the condominium buildings themselves in the near future.

He also praised the addition to the proposal of a sidewalk running down Krumkill Road.

The Planning Board voted unanimously to extend the deadline for the review of the Planned Development District until March 7.

In other business, the Planning Board closed a public hearing on a special use permit for the Journey United Church of Christ, which is hoping to relocate from Slingerlands to a space at 500 Kenwood Ave. in Delmar. The building is owned by Michael Parker, who operates an orthodontic practice there. The remaining space would have room for 70 persons to accommodate the growing congregation.

No member of the public spoke on the project. The Planning Board has 62 days from the closing of the hearing to make a determination on the special use permit.

Officials from Northeast Health and The Eddy Village at

Beverwyck presented plans to amend a Planned Development District that was approved in 2006 into something else entirely. The retirement community is looking to scrap its plans to build a 38-bed skilled nursing care and Alzheimer's expansion in favor of two, 12-bed structures in the greenhouse style of nursing home care.

The buildings would provide private rooms and communal dining for a more homelike living experience that has seen much success in other parts of the country. The company is in the process of building 16 such buildings at its Cohoes location.

The addition of the greenhouse units would also round out Beverwyck's Slingerlands offerings to cover all stages of nursing home care.

"They don't help with the institution's bottom line; they lose money" said Northeast Health's David Wendth of greenhouse designs. "The reason why we put them in is it's the right thing to do."

The Planning Board issued a 60-day extension to the Phillipin Kill Manor PDD application for 83 units of single-family homes and townhouses off of Fisher Boulevard. The project has been appearing before the town in various incarnations for seven years.

Two more sites join Western Turnpike junkyard in noncompliance

At its Oct. 20 meeting, the Town Board ordered Ciembroniwicz to clean up the waste, rubbish, unlicensed cars and other types of debris from his property. The Town Board also ordered Ciembroniwicz to submit a plan to eliminate the runoff of any non-storm waters into adjacent properties and any waters owned by the Town of Guilderland or the U.S.

At the Dec. 15 meeting, Zoning Enforcement Officer Rodger Stone reported on the progress to date. While admitting that some junk has been removed and work has commenced on repairing fencing around the yard Stone gave a lukewarm assessment of the situation.

"I see progress, but not a lot of progress. I would like to see more," said Stone, adding, "I think we are going in the right direction"

Salvatore Belardo, Ciembroniwicz's neighbor, appeared at the meeting of the board to express his concerns about runoff from the junkyard flowing onto his property.

"Nothing has been done, and I

don't expect anything to be done" said Belardo.

Stone informed the board that an engineering firm hired by Ciembroniwicz has controlled the runoff coming from the property. "Runoff has virtually stopped" said Stone, adding that now the engineering firm has to repair damage that runoff has caused to surrounding properties.

Of particular concern to the board is a crusher in operation on Ciembroniwicz's property. "Ordinance provides that the crusher be 1,000 feet from Western Avenue," said Supervisor Ken Runion.

While he admitted that Ciembroniwicz doesn't have 1,000 feet, he would like it to be moved as far away from Western Avenue and other properties as possible.

Runion is also concerned with Ciembroniwicz's failure to submit an environmental plan for the property.

"The environmental report was never provided" said Runion, referring to the report mandated at the Oct. 20 meeting.

The board eventually decided to give Ciembroniwicz until its Tuesday, Jan. 19, meeting to

satisfy the Oct. 20 orders. When asked what needs to be done to satisfy the board, Runion mentioned the need for the environmental report and said "we need a time frame for the crusher to be moved."

If the board determines that

According to a report prepared by zoning officer Stone, "the accumulation, storage and dumping of rubbish is a violation of Town Law "64-5-a." The report specifically mentions the storage of unlicensed vehicles, commercial vehicles and industrial equipment.

The report also states that the property's owner, Arnold Naparty, has promised to bring the premises into compliance,

however as of yet he has failed to do so. A public hearing on the issue has been scheduled, and will take place at the Tuesday, Jan. 19, meeting of the Town Board. If not brought into compliance by the date of the public hearing, the Town of Guilderland will authorize public officers, or contractors hired by the town, to bring the property into compliance.

The property located at 4646 Western Turnpike has also gotten the attention of the Town Board. According to a report prepared

by Stone, complaints have been made about the state of disrepair of the property since October 2008. In March 2009, the owner of the property, Dhanwattie Durkaran of 1322 Stratford Road, Schenectady, picked up an application for a demolition permit, however has not been heard from since.

When asked by the board why Durkaran hasn't proceeded with plans to demolish the property Stone said, "I think personally, it's complete disregard." Stone also expressed his concern over the lack of fencing around the premises, as well as the effects the winter will have on adding to the properties state of disrepair.

The board voted to schedule public hearing on the issues, also to take place at the Tuesday, Jan. 19, Town Board meeting. As with the other properties mentioned in this article, if the property is not in compliance, the board will vote to authorize town officials to bring the property into compliance, at the expense of the owner.

the orders from the Oct. 20 meeting are not fulfilled by the Jan. 19 meeting, members will likely vote to permit town officials to enter the property or hire contractors to enter the property to fulfill the orders. Any costs incurred by the town in such an event will appear on the owner's 2010 property tax bill.

Two properties fall under radar

A consideration to schedule a public hearing for zoning enforcement in regard to a property at 3393 Carman Road was also passed at the Dec. 15 meeting. The property violates zoning laws in a similar fashion to the Ciembroniwicz property.

Bushwhacked

If you were wondering what that rumbling was the other night, why you might have had the feeling that the ground was shifting beneath your feet, it wasn't another small-scale earthquake coming out of Berne.

It was the Guilderland Town Board agreeing on something.

On Tuesday evening, Dec. 15, the board put off dedicating 191 acres of town-owned land to the Albany Pine Bush Commission. The lands, located southwest of Interstate 90, and north of Old State Road, are part of the Pine Bush habitat. However they are a portion of the habitat not managed by the Preserve Commission.

Of course, this is politics and consensus wasn't reached without some back and forth. After the motion was made to approve the transfer, Republicans Mark Grimm and Warren Redlich raised concerns over the fact that no public hearing had been scheduled or notification given to adjacent landowners related to the transfer.

Eventually, the Democratic members of the board, including Supervisor Ken Runion agreed, and resolved to have Town Clerk Rosemary Centi notify residents located within a 1,000-foot radius of the land.

Despite your party affiliation, and despite the history of squabbling on that board, you have to respect the fact that they not only came together, but came together to do somewhat of the right thing.

Notifications concerning the dedication will be sent out by the week of Dec. 21. Residents will be given the opportunity to comment on the transfer before the town votes at the Feb. 2 meeting.

However, before we go gushing about the brotherly love and togetherness that fleetingly swept over the Guilderland Town Board, we at The Spotlight would be remiss not to mention that the 191 acres that will be no longer be available to the town will continue to be left off the tax rolls.

That's right, the land will be "dedicated" to the Albany Pine Bush Commission, without having its ownership transferred from the town. And once the land is dedicated, the town would need approval from the state Legislature if it wishes use the land in any manner.

So, the town loses close to 200 acres and the residents see no tax benefit. Let's see if next time they can agree on putting land back on the rolls.

A love of language is a life sentence

I have always loved language. Sometimes, language loves me back. Other times, it challenges me, pushes me too far, provokes me into retracting my love. However, I can't blame language for these difficulties in our relationship. The rules of language are fact, and mistakes I make are completely my fault.

I am sometimes guilty of wishing I could throw in the towel — use language without playing by the rules. But as a possible future English or linguistics major, I am fascinated by the different uses of words and the role of language in culture.

The first story I wrote was titled "My Pet Was on the News!" The main character was a 6-year-old girl (like myself at the time), and she made local headlines by finding a frog in the woods behind her house. Looking back at the story, written in a shaky hand on the wide-lined paper found in elementary schools, I realize that the concept of finding a frog is not newsworthy. However, it is not the plot that I think of first when I remember the story, it is the detail. My main character sees her frog through binoculars, but these are no ordinary binoculars. They are, as I described in a run-on sentence, "blue binoculars with red polka dots that looked like little freckles, that I got when I was 4 when I went to the Jolly Fun Circus." I don't remember much about writing the story, but I do remember that I was happy to realize that an image in my head could be translated onto paper with words.

I am constantly trying to find a new word for an old meaning. The tip-of-the-tongue feeling occurs often for me, and an elusive word can haunt me for hours, or

even the whole day. When the word finally announces itself, my spine straightens and my face brightens. I keep a stash of such words in my mind, and the next several papers that I write for school will likely be peppered with the most recent finds.

My schoolwork also affects my vocabulary. I often unintentionally mimic the language of the characters in my assigned reading. While reading "To Kill a Mockingbird," I would communicate surprise by saying "Oh, my!" like a southern gentlewoman. While reading "The Catcher in the Rye," I claimed, like Holden Caulfield, that everything "killed" me. I can become so absorbed in the time period or setting of the book, I apply the corresponding language to my own life.

My fascination with language also affects my relationship with music. I don't have an ear for rhythm or pitch, and usually enjoy the melody of a song without trying to analyze it. Lyrics, however, are a different story. I can't listen to a song without considering the lyrics, trying to understand references or uncover hidden meanings. This tendency has been handed down to me by my parents, who can spend an entire half-hour car ride debating whether a line in a nostalgic song was referring to a famous president or an iconic musician.

I remember sitting in the back seat, listening to them have this argument. I considered the songwriter's motivations for each particular reference. I considered the context of the reference, rolling the surrounding words around in my mind, trying to make sense of them. In the end, I reminded myself that language can't always be simplified. Sometimes it's beyond comprehension. Sometimes language asks questions that I can't answer, but I don't mind. If I was always able to make sense of language, there would be nothing left to wonder about in the back seat.

I am also interested in the cultural aspects of language. Several months ago, I learned in my Spanish class that there are 30-plus different terms for "popcorn" in the Spanish language, and that each term is used in a different geographic region. As I examined the list of terms, I imagined using a word, while in southern Mexico, understood to mean "popcorn" only in northern regions of Mexico. Would this be an embarrassing mistake? Would I be marked as a clueless tourist, faced with eye rolls and annoyed sighs? Next, I wondered about the origin of the different terms:

Why are some terms common to everyone who speaks a language while others differ by region? Regional differences are present as well in the United States, where a carbonated beverage is usually referred to as "soda" in the Northeast and southern West Coast, known as "pop" in the Midwest and the northern West Coast, and called "coke", no matter the brand or flavor, by many in the South. This is why I want to study linguistics in college: I would like to learn more about the relationship between culture and language and discover how to work with the subtleties of vocabulary and speech.

My fascination with language does not come without irritation. As early as third grade, I rolled my eyes when a friend corrected my pronoun use. Sitting cross-legged on the nubby carpet in the front of the classroom, my stream of dialogue would be interrupted by her correction: "My mother and I went to the store," she would remind me. The repeated corrections eventually took effect, and ever since third grade, I automatically correct my own pronoun mistakes. Generally I do so quickly, trying to pretend I never made the error. I am always ashamed of my own improper use of language, cringing at obvious mistakes emphasized by teachers' red pen marks. However, I find that these frustrations do not take away from my interest in language. When experimenting with language, embarrassing mistakes are bound to happen. I try to consider the lesson learned and move on. After correcting errors for a long time, not to mention obsessively replacing and rearranging words, I am always satisfied to print out a paper that shows my love of language.

Since I was in elementary school, whenever I asked my father for the definition of a particular word, he would tell me an extensive history of the word's origin and give me a long list of its uses in society. The lesson would start with a fairly standard definition of the word, one similar to a Merriam-Webster dictionary definition. Soon he would pick up momentum, and begin citing more obscure facts. "That word, actually, was first used with its modern meaning..." he would confide, and finish by naming a historical figure who had coined the term's use or a novel which had changed its meaning. Next, he would compare the word to terms with similar meanings, like a thesaurus. Finally, like my SAT prep books, he would use the word in several sentences to make sure that I understood its use. At first, I sat silently waiting for him to finish. Next, I tried to stop the lecture by assuring him, "OK, I get it now" as soon as he started to elaborate. Now, I don't mind.

Spotlight's view ignores real people, real jobs

Last night I read the editorial in this week's Spotlight entitled "Why not veto?" and truthfully was totally disgusted by it. The reason is so many people, now including *The Spotlight*, have no real idea as to what has been going on and then cast a view that is so totally off base that it is ridiculous.

We, the Family Council members, have been attending and meeting with Legislators from both parties, Albany County Executive Michael Breslin, Commissioner of Management and Budget for Albany County John Rodat, Deputy County Executive Michael Perrin, union members and officials, the County Comptroller, AARP, the state Health Department and the list continues. One or more of us are at various committee meetings, public hearings, legislative meetings, union meetings and presentations, almost on a nightly basis.

In attending these various meetings, and if anyone had bothered to do the same, you would have known that Mr. Breslin was in fact laying off people — real live people — while keeping "funded" vacant items and this was the tip of the iceberg. Our legislators took a stand and I am very proud to say that it is no longer status quo as Mr. Breslin had hoped it would be.

Our legislators went through the budget, line by line, and put the "people" back in while cutting the funded vacant items along with keeping the services to the elderly and disabled intact. They worked long and hard at this process and despite Mr. Breslin's claims, came

up with the same tax increase as Mr. Breslin but managing to keep the people and services. They also froze hiring in the County which the exception of those that would provide essential services.

As an Albany County taxpayer, I may not want to see my property taxes raised. Cutting the nursing home and more essential services would force more and more people out of Albany County and place those that need help out of County and out of State. These are not my facts

but those provided by the New York State Department of Health — over 1400 in 2007 and 2008 and I don't even know what 2009 figures will show.

As far as the statement that the legislators that voted no, must feel the same as Mr. Breslin, you need to check your facts. In speaking with the legislators who did indeed vote no, many had very different reasons as to why and for most, it was not because they agreed with Mr. Breslin.

I, for one, am tired of incumbents like Mr. Breslin who I really can't name one thing he has done for Albany County, who disgust me with the pat on the head stance, the misinformation he gives out and his not listening to the people he was elected to represent. But I am very proud of those of our legislators who have taken a stand and are now listening to the people they represent.

They deserve our praise and our votes, unlike Mr. Breslin.

Kendall Square project doesn't fit hamlet definition

Editor, *The Spotlight*:

The proposed development on the corner of Feura Bush Road and Elsmere Avenue in Delmar, (Kendall Square), has stimulated discussion within the Glenmont area.

After meeting with members of the Planning Board, developer, and the town planner, we concluded that the project as it stands, does not conform to either the definition or description of a Hamlet as presented in the Town Code. Attempts to persuade the developer to modify his plans were unsuccessful. The development is on the move and ground will be broken as soon as possible. We felt time was right to go to the public.

We are not against the concept of establishing a Hamlet on the property. We are, however, extremely disappointed with the current design and apparent lack of concern for the Comprehensive Code: Chapter 128-33, Hamlet District.

The developer proposes to establish four 5,000 to 10,000 sq foot commercial buildings surrounding a parking lot on the corner of the two mentioned roads. The rest of the property would contain 20 buildings containing 112 one or two bedroom apartments. Some apartments will have garages but most will not. Extensive re-grading of the property will be done to accommodate the plan, as the developer is interested in using the periphery to increase commercial visibility and avoid complications with wetlands within the property. The proposal is on file with the Planning Office and may be inspected by the public for details by filing a Freedom of Information form. A copy of the Town Comprehensive Plan is available on line at the Town of Bethlehem Web Site. Pertinent materials may be found under

"Hamlet."

We are most concerned with the project's lack of compatibility with existing housing in the area. Little greenery, landscaping, broad sidewalks, open areas, indicating pedestrian friendliness is apparent. Minimal setbacks and the absence of berms suggests housing density at the expense of the suburban/rural character of the neighborhood

We are also concerned with contributing to an already overloaded traffic rush hour pattern on Elsmere Avenue and Feura Bush Road. This suggests a need for either greater road capacity or a decrease in apartment density or both in order to avoid a traffic nightmare.

"Gang parking," or shopping-mall style parking is also an issue. A Hamlet suggests on-street or alleyway parking for its commercial areas; increasing its pedestrian accessibility.


The project should take advantage of the site's natural topography, rather than shape the land to maximize the number of buildings. The amount of grading will impact natural features and vegetation of the site as well as change the natural drainage pattern.

The Hamlet concept is an interesting one if properly integrated into the surrounding area. We have formed a committee to urge "making over Kendall Square" and are looking for additional like-thinking supporters:



Town holds off on dedicating Pine Bush land Employment training available for seniors

Neighbors will have the opportunity to comment on transfer

The Town Board decided to put off dedicating 191 acres of land owned by the town to the Albany Pine Bush Commission at its meeting Tuesday, Dec. 15.

The Town Board reached the decision after concerns were raised by Republican members Mark Grimm and Warren Redlich over the lack of public knowledge of the transfer. Redlich said he would like to give the public the opportunity to comment on the transfer.

Grimm echoed those concerns, and speaking of residents neighboring the lands said, "we have to notify these folks that control of the land is shifting."

Eventually the Democratic members of the board, including Supervisor Kenneth Runion agreed, and resolved to have Town Clerk Rosemary Centi notify residents located within a 1,000-foot radius of the land.

The lands, located immediately southwest of Interstate 90, and north of Old State Road, are part of the Pine Bush habitat, however they are a portion of the habitat not managed by the Preserve Commission.

According to Runion, the town currently owns the land, however, the town does not have any means by which the lands are managed. Dedicating the land to the Albany Pine Bush Commission would provide a means of managing the land.

Should the Town Board eventually decide to dedicate the land, the town will still retain ownership, however it would have no authority in the land's administration.

"The town will retain ownership to keep the land tax exempt. If ownership is transferred, it could become taxable," said Runion.

Once the land is dedicated, the town would need approval from the New York State Legislature if it wishes utilize the land in any manner independent of the Albany Pine Bush Commission.

Christopher Hawver, Executive Director of the Albany Pine Bush Commission, described the mission of the commission "to manage and protect land of the Albany Pine Bush, and provide the public with education and recreational benefits."

Hawver said he believes dedicating the land to the commission will provide a number of benefits to the community. He said "the habitat will be managed to promote the restoration of the pine bush" and facilitate the "removal of invasive species and plants." If transferred, the commission also plans to create trails for public use.

"Part of mission is to provide public recreational opportunities," said Hawver.

Redlich expressed concerns about the effect a controlled burn could have on the surrounding community. Hawver defended the ecological and social benefits of performing controlled burns saying "without controlled burns you will have wildfire."

Hawver said the commission did have a controlled burn get

out of control in 1999, however it resulted in no physical or property damage. After the incident, the commission evaluated their process for performing controlled burns and modified the environmental and weather parameters of performing controlled burns. Since then there have been no similar occurrences.

According to Hawver, if the Town Board should vote to dedicate the land to the commission a controlled burn would not be necessary for five years, perhaps longer.

"It's in need of restoration work; until native habitat is restored I don't anticipate a controlled burn," said Hawver.

Grimm also expressed concerns about controlled burns, however, he focused more on surrounding resident's lack of knowledge of the transfer.

"It can be easily done, it doesn't seem like that many homes," said Grimm.

Speaking of the eventual decision by the Town Board to notify residents Grimm said, "It's a good step for open government."

Notifications about the dedication will be sent out by the week of Dec. 21. Residents will be given the opportunity to comment on the transfer before the town votes issue at their Feb. 2 meeting.

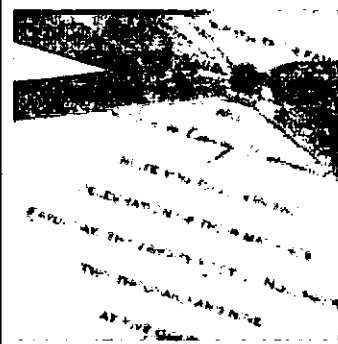
and supportive services; and employment lead development.

"Older workers have so much to offer - experience, knowledge, dependability and enthusiasm," Farrone said. "If we can help them retool, they can continue to be a vital part of the workforce."

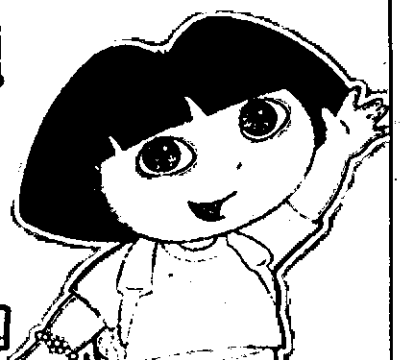

BC eyes new high school courses Hit

Annual review produces proposed language and forensics classes for coming year

The annual curriculum review at Bethlehem Central High School has resulted in several new course suggestions that will be put forward to students in the 2010-11 school year.

Principal Charles Abba said at a Wednesday, Dec. 16, meeting of the Board of Education that a committee of high school department supervisors, teachers and administrators meet several times every October to review the school's course catalog and evaluate suggestions for new or changed classes.

Any changes the council puts forward must make use of existing resources.

"This is not an attempt to try and create opportunity for more FTEs [full-time-equivalency positions]," Abba said.

Two entirely new classes were pitched in the science and world languages departments. Given enough student interest, forensic science will be taught next school year as a way to keep in the science department students who are not necessarily planning to take a core science class like physics in their junior or senior years. It would be an introductory program, and Abba said he expects the minimum enrollment would be easily met.

Science teacher Charles Evans has been putting the details of the course together.

"He's developed a course that a lot of kids talk about and would have interest in," Abba said.

A minimum of 17 students must sign up for a class for

it to be offered. Otherwise, it will be dropped from the schedule.

World Languages Department Supervisor Marisa Bel pitched an innovative and student-driven course called world language extended study.

Offered in one-semester blocks, the course would let students set their own goals in learning a language of their choice. They would be able to make advancements in their study by leveraging technology that would enable BC students to communicate with others around the world, which would also offer more choices to those who want to study beyond what the department offers.

"Students can certainly pick a different language that we're not able to offer," Bel said.

She added that in an increasingly globalized world, it's hard to say what languages will be most valuable to the workers of tomorrow.

"We want to try to teach the students how to learn languages independently," she said.

In the art, English and math departments, changes will be made to make the curriculum more accessible to students who are not taking traditional paths.

The measure was part of a \$750 million spending reduction plan, proposed on Sunday, Dec. 13, by the governor.

Also proposed in the plan is a 19 percent reduction in the STAR payment given to local school districts. The Guilderland Central School District stands to lose an additional \$971,195 on Jan. 4 if the plan is upheld.

The measures are part of the governor's latest plan to reduce the state's ever-growing budget deficit. Earlier in the month, a \$2.7 billion deficit reduction plan was enacted, however the governor places the current budget deficit at anywhere between \$3.2 billion to over \$4 billion. A constitutional requirement mandates that the state must have a balanced budget.

Speaking of the \$108,354 lost by the district on Tuesday Dec. 15, Superintendent John W. McGuire said, "We will not be immediately required to cut staff or programs." McGuire did describe the district as being in good shape financially; however, he did express concerns over the district losing 19 percent of its STAR payment.

"I see this as taking a cash flow problem at the state level and passing it on to the local level" said McGuire

According to information from the governor's office "As sufficient revenue becomes available, the state will potentially pay the amounts that were delayed," however the release goes on to say, "He [Paterson] also reserves the right to institute further payment delays later over the remaining months of the fiscal year in order to preserve the state's cash position."

The state's fiscal year ends March 31, 2010.

School called the Saunders' to see what they could do to help, Randy's constant need of new clothing was the first thing to come to mind.

"It's awesome, it really is," said Rick Saunders of the clothing drive being held for Randy.

The students of the Chain Links Club said they were particularly inspired by Randy's refusal to allow his rare condition to define his outlook on life.

Speaking of Randy's positive attitude, Rachel Goldberg, an eighth-grader and member of the club, said "It's inspiring for a boy to live like Randy and not be upset, but to be appreciative of life."

Carlee Nussbaum, also in eighth grade, said, "When we saw pictures of him, he was playing with friends, like a normal kid."

The Chain Links Club was started in the middle school in October, after the school was visited by a group from an organization

called Rachel's Challenge, which was born out of one of the most horrific events to ever occur in an American school - the Columbine High School shootings.

Before becoming the first victim of the shooters, Rachel Scott wrote an essay titled "My Ethics, My Code of Life." In the essay, she displayed her values of trust, compassion and kindness. She said, "I have this theory that if one person can go out of their way to show compassion, then it will start a chain reaction of the same. People will never know how far an act of kindness could go."

Inspired by Rachel's vision, the organization Rachel's Challenge visits businesses, schools and universities across the country to spread educate people about Rachel's ideals.

The movement caught on at Voorheesville Middle School, where upon entering the school, one is greeted by a large banner stating "I accept Rachel's Challenge," which is signed by dozens of students.

The students of the middle school have decided to take the

challenge a step further by forming the Chain Links club. When describing the goals of the club, member Emily Cole echoed Rachel's message by stating, "It's a club that promotes kindness."

Among the first projects the club undertook was writing letters referred to by Cole as "Targets of Kindness." The goal of these letters was to extend an act of kindness to people who may normally be overlooked. In the world of middle school youths, the primary targets of these letters were the hardworking, albeit often overlooked, bus drivers.

The clothing drive for Randy is a more recent, more ambitious project undertaken by the Chain Links club. When asked why they chose a clothing drive as a means to help Randy, the girls recalled hearing of Randy's need to bath in oil twice a day to keep his skin moisturized.

"Since he wears clothes over oil, he can only wear clothes 12 times. It gets really expensive," said Carlee Nussbaum.

The students of the Chain Links Club were also impressed

with the selflessness shown by their fellow classmates.

"It's nice for people to donate their own clothes for Randy," said Goldberg.

Wayne Manchester, the teacher supervising the club, commented on how wholeheartedly the idea of Rachel's Challenge has been embraced by the students participating in the club.

"The whole idea is to start a chain reaction of kindness. I'm inspired on the focus the club has given to Randy," said Manchester.

Manchester went on to say that the club has collected \$250 in addition to the many different articles of clothes.

On Wednesday, Dec. 23, after the school day has ended and the holiday break has begun, the students of the Chain Links Club will personally deliver the clothes and money they have collected to Randy Saunders.

"When we see him on the 23rd, I am looking forward to his reaction - to know that kids hours away were thinking of him," said Cole.

10 percent, of the quarterly payment would be withheld from the aid payment. She stressed the deferral will not have any immediate impact on programming.

"The impact is from a cash-flow standpoint. To the extent that we don't have it, we're not able to use it to pay for resources," she said.

Superintendent Michael Tebbano said that the district has instituted a partial spending freeze affecting unencumbered enrichment monies and professional development funds.

Enrichment money covers additional student activities like field trips, and the development fund covers teacher conferences and the substitutes needed for classes when teachers are away at those meetings.

The district had been examining Paterson's plan to make extensive mid-year cuts to school aid. BC was scheduled to have its roughly \$28 million in annual state aid reduced by \$1.6 million.

"Given that they were initially talking about a sizable reduction mid year, a delay in payment is the less harmful option," Kehoe said.

There has been no word from the state as to when the withheld funds might be released. Tebbano said that school officials are not holding their breath.

"We're not actually convinced we're going to see that money come back anytime soon," he said.

As BC enters its budgeting process, officials will be presuming that state aid will decrease by \$2.5 million in the 2010-2011 school year. Tebbano urged the community to make their opinions known at budget forums, the first of which is being held Tuesday, Jan. 12, from 7 to 9 p.m. in the Middle School library.

The BC 2009-10 budget totals \$87.6 million.

A number of organizations, including New York State United Teachers and the New York State Council of School Superintendents, filed a lawsuit against Paterson Wednesday, Dec. 16, arguing his decision was unconstitutional and seeking a release of the funds.

Tebbano said that BC had nothing to do with the lawsuit, but added that watching it play out will be "interesting."

He also said that while the withholding of funds from this aid payment does not constitute a major impact, other upcoming aid payments are far larger.

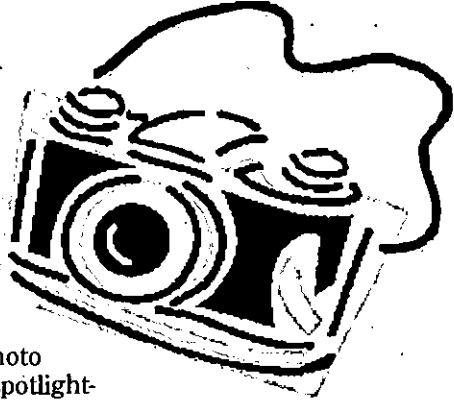
"If things worsen, as some of us are predicting, you'll see further cutback in the future payments," he said.

the state Health Department.

The Town Clerk's office has been awarded 17 grants totaling more than \$275,000 during Newkirk's tenure, many of which deal with archival and preservation activities. The latest grant for the preservation of minute books from 1793 to 1928 is being held back by the state in the midst of the budget crisis, though.

Besides serving as the town's records officer and registrar of vital statistics, the town clerk issues licenses and various per-

mits, provides notary service and compiles election information. A lot of the work is done away from the Town Clerk window at Town Hall.

"People have no clue as to the scope of the job. It's a varied job, and that's why it's never boring. You move from one thing to another so that it's always interesting," Newkirk said.

The town clerk must also coordinate with all town departments, as well as state and federal agencies, in the keeping of records and other matters. With the advent of the information and computing age, things have changed a great deal since Newkirk first took office.

"Since I've come, there's been total automation in my office because we didn't have computers when I started," she said.

Newkirk has been a Bethlehem resident since 1949, has two sons, two daughters and nine granddaughters (the oldest serves in the Air Force, the youngest is 4). She'll be spending her retirement traveling, she said, and is planning a trip to Disneyworld for the entire family next August.

After more than three decades serving the town, Newkirk said it was simply time for her to hang it up. She will be replaced by Nanci Moquin, who serves as records manager for the planning and zoning boards.

"It's been a wonderful experience; it's been good people to work with," Newkirk said. "I've really enjoyed my career with the town. When I started, I never thought I'd be town clerk, but it turned out that way."

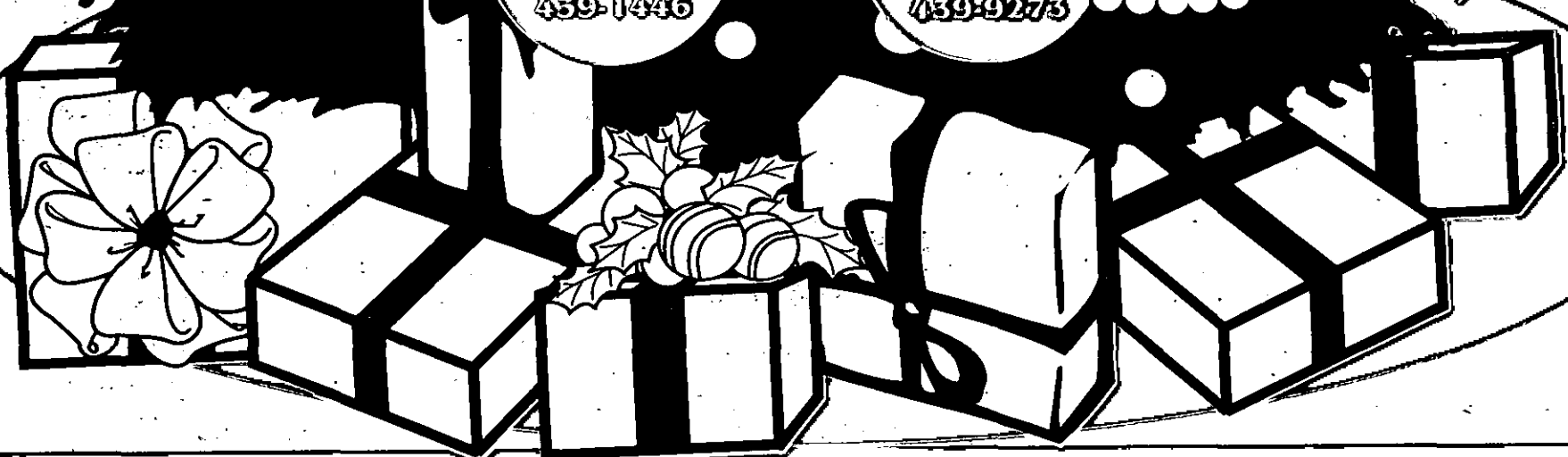

Entertainment *in the* Spotlight

The model trains at the Schenectady Museum always draw a crowd this time of year.

"We just get thousands of people in to see the trains," said Carmel Patrick, the museum's director of development. "It's become a holiday tradition in the Capital Region."

That got the staff at the museum thinking. It'd be neat, they agreed, if there were some other train-related things at the museum to complement the model trains.

So Chris Hunter, the museum's director of archives and collections, pulled together an exhibit called "All Aboard! The Power of Locomotives," which looks at the history of the rail industry in the Capital District. Visitors can check out both the model trains and the exhibit this weekend, Saturday and Sunday, Dec. 26 and 27. The trains will also run the following week, during school break, as well as weekends through Jan. 17, and "All Aboard" will be set up through April.

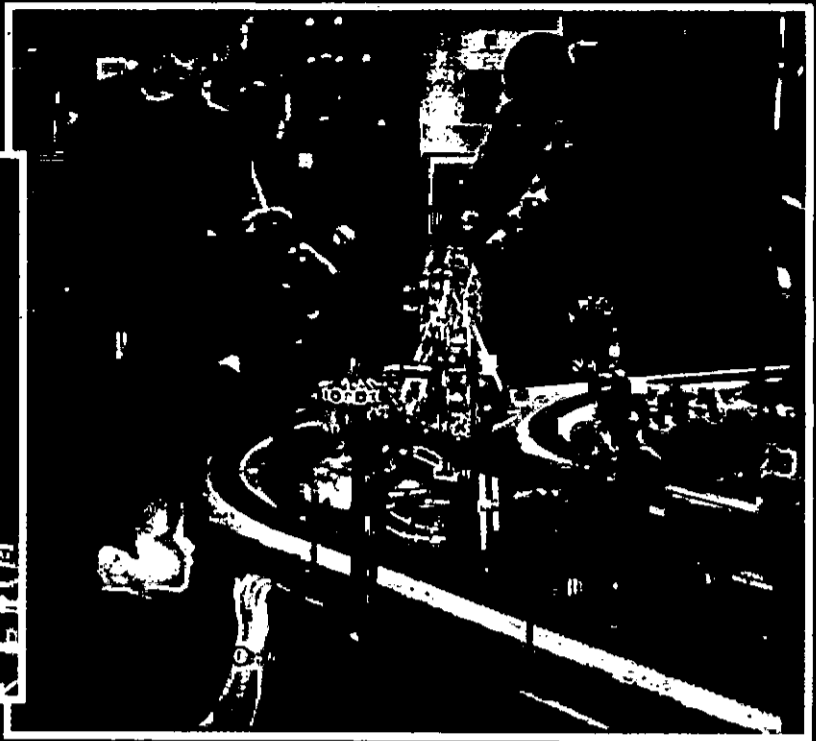
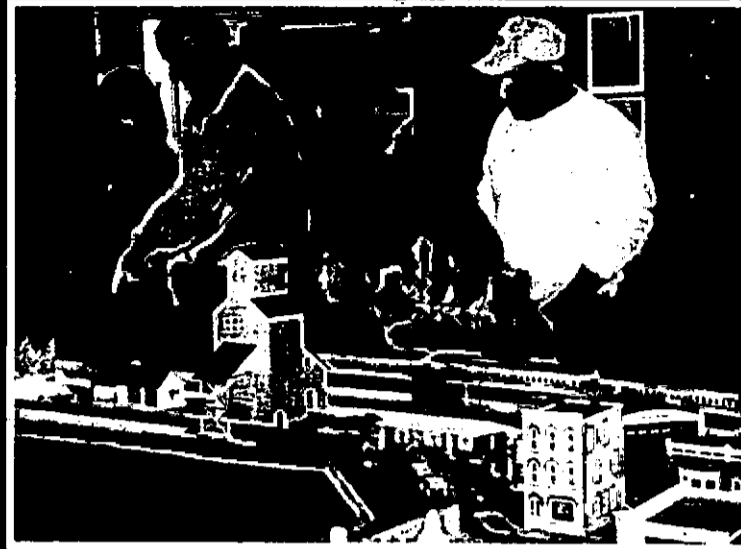
There's more train fun on tap, too: School break week will feature a host of train-related activities, and the January Little Wonders of Science program has a train theme.

Volunteers from the Upstate Train Associates put together the O Gauge model trains in front of the main entrance to the Suits-Bueche Planetarium. It's a 19-by-27-foot display, or, as Patrick said, "It's huge."

The display features several smaller themed areas, such as an amusement park where Santa is riding a roller coaster and a pond where children are skating. Patrick said children also get a kick out of the trains that load and unload their cargo of barrels and lumber.

Younger children also like the nearby Thomas the Tank

Engine display, which features a working Thomas the Train.

Patrick said the display draws people from counties throughout New York and even neighboring states. It's also a popular school program, with close to 10,000 students visiting the trains in the last academic year.

"All Aboard! The Power of Locomotives" has fans, too. Hunter said at least two people have made train-related donations to the museum after seeing the exhibit.

Highlights, Hunter said, include models created by the American Locomotive Company (ALCO), model trains that are nearly 100 years old and photographs from the museum's GE and ALCO collections.

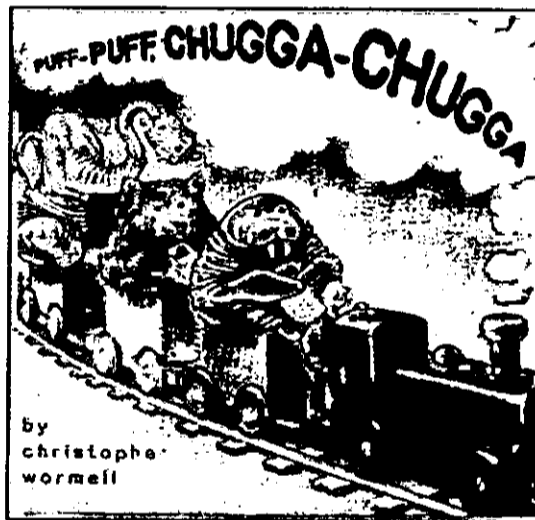
"There are a lot of pictures and video footage," said Hunter, adding that in the early days of General Electric, a lot of work was done on electric locomotives in Schenectady.

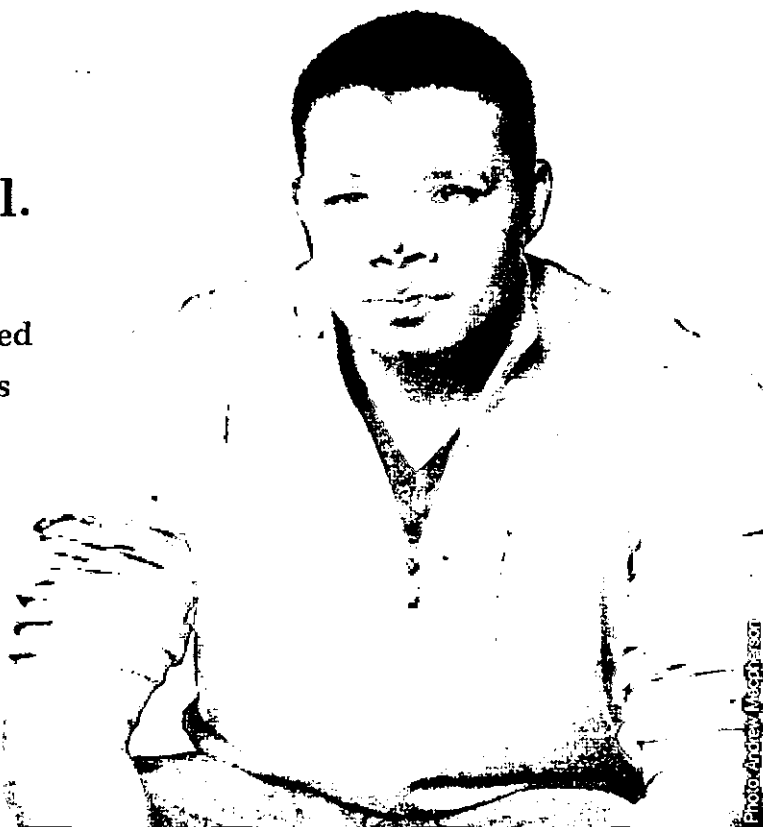

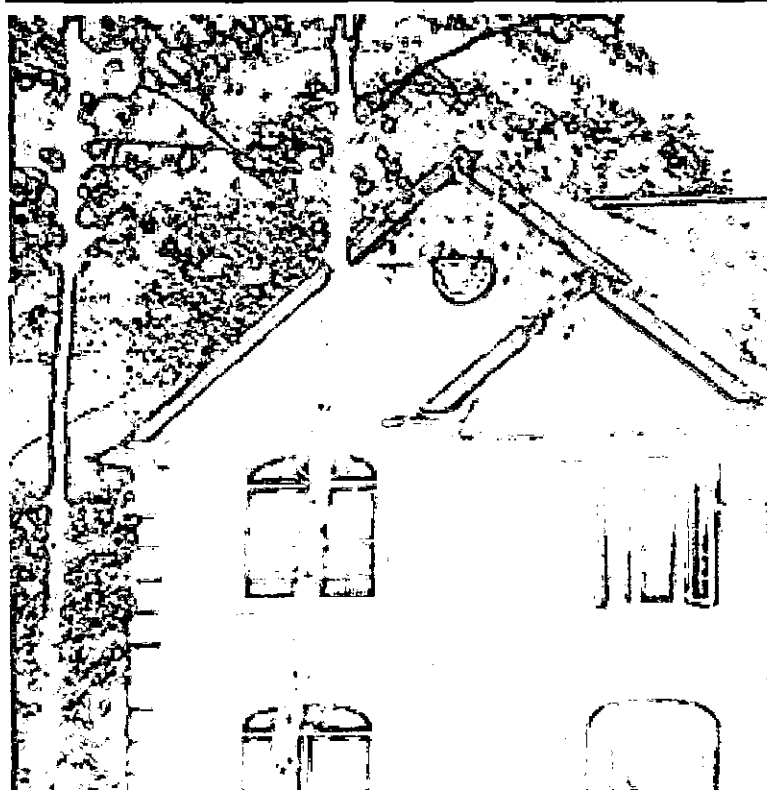
