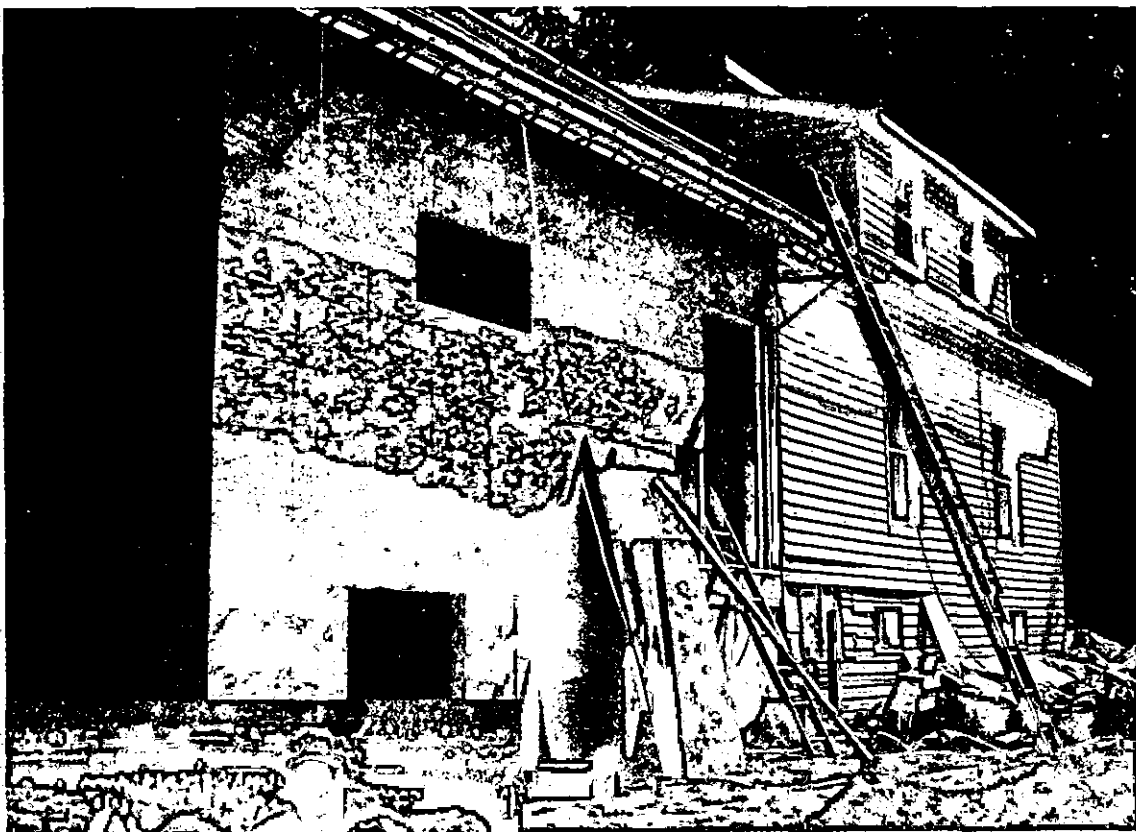

Businesses raise the roof

Donations will make homecoming a reality for injured Delmar man

Lisa DeStaso-Jones doesn't have unrealistic desires. She just wants her husband to come home.

But just a few months ago, that seemed like a scant possibility. While playing rugby in February, Michael Jones suffered a debilitating spinal injury that has left the Delmar man paralyzed.

Besides costly medical bills, his young family has had to contend with the fact it would cost a small fortune to overhaul their home to meet his needs.

"Michael had one request: 'I want to come home.' Not to Delmar, to our home," said DeStaso-Jones.

Jones is nearly there. Having made advances far beyond what doctors originally said was possible, he's now living at a Delmar nursing home just miles from the family's 1920s bungalow. But the more than \$150,000 price tag of the addition

Service districts look to team up

Fire and ambulance companies will finance project if grants can't be found

Emergency services districts in the Town of Bethlehem are looking to collaborate in creating a plan that would help them better work together in the coming years.

The town's five fire departments and two ambulance corps first began discussing in October partnering to develop a five- to 10-year development plan. At that time, the state's Local Government Efficiency Planning Grant Program was still handing out funds for such projects, but since then the program has run out of money and is unlikely to see more funding in the near future.

The districts are not looking for funding from the town, but rather support in finding grants and also in framing data when the study does get under way, said John Lutz, who is on the Board of Commissioners of the Elmsire Fire Department, at a Wednesday, July 28, meeting of the Town Board. The funding is needed to bring in a consultant to assist with the planning.

"We felt that it was important that a 5- to 10-year plan be put in place, and to accomplish that we felt a con-

Not much ado about judge's petitions

Alleged wrongdoing in signature collecting would have little effect on election

Sitting Bethlehem Town Court Justice Ryan Donovan has been accused of violating a code of ethics that guides the conduct of judicial candidates, but the matter will have little direct impact on the forming race for his office.

In fact, Donovan's opponent was adamant

that he doesn't wish to take a swipe at the incumbent.

"I never accused him of anything," said Ralph Ambrosio, the GOP-back candidate in the race. "I just think the facts speak for themselves."

Donovan was instead called out by the Bethlehem Republican Committee. In short, when gathering voter signatures this summer so he could appear on the ballot, Donovan also carried the petition of Assemblyman Tim Gordon, I-Bethlehem. Records show Donovan obtained 62 signatures from Independence Party members.

The Judicial Campaign Ethics Center's

handbook for judicial candidates says this is improper behavior because circulating petitions for other candidates could be viewed as an endorsement. An exception is if the judicial candidate appears directly on a slate of other candidates.

"A judicial candidate may circulate a petition for several candidates that includes his/her own name, but may not circulate individual petitions for other candidates," one opinion from the Judicial Campaign Ethics Center reads.

While Donovan and Gordon are both on the Democratic party's slate of candidates,

RCS High gets new principal

Brian Bailey makes the move from post at GHS

Students attending the Ravena-Coeymans-Selkirk High School will have a new principal when they return to school next fall.

The RCS School District Board of Education has chosen Brian Bailey to step in as the new principal, effective Aug. 20. Bailey has been assistant principal at Guilderland High School for the past six years.

In fact, other than a single year at Schalmont, Bailey has spent the past 18 years in Guilderland schools.



Brian Bailey will be taking over as principal of the Ravena-Coeymans-Selkirk High School next year, replacing outgoing principal Brett Miller. Bailey has 17 years of experience in the Guilderland School District, including the past six as assistant principal at Guilderland High School.

"It's like family. It's just like leaving home for the first time," he said of the move. "It's exciting and it's daunting, because I bring with me all of those things that I've learned. ... I'm going to a new place where they have their own experience and their own way, and I'm excited to learn that."

Bailey has his roots in music education, starting out as a choral teacher. Both his parents were teachers. "Growing up, music was something I always excelled at," he said. "I went off to college, and there didn't seem any better way to enjoy my art form and be able to share that with other people."

He said he also made the crossover to administration with the goal of helping people learn.

"Being an administrator is teaching with adults. ... We're all trying to grow and get better at what we do," he said.

"The principal interview committee recognized Brian's skills and talents," said RCS Schools Superintendent Daniel A. Teplesky in a statement. "He will be a great asset to our administrative team, and we look forward to welcoming him to the district as we continue our planning for the new

school year."

Bailey said he's most looking forward to working in a smaller school community. RCS High School has about 650 students enrolled compared to Guilderland's more than 1,900.

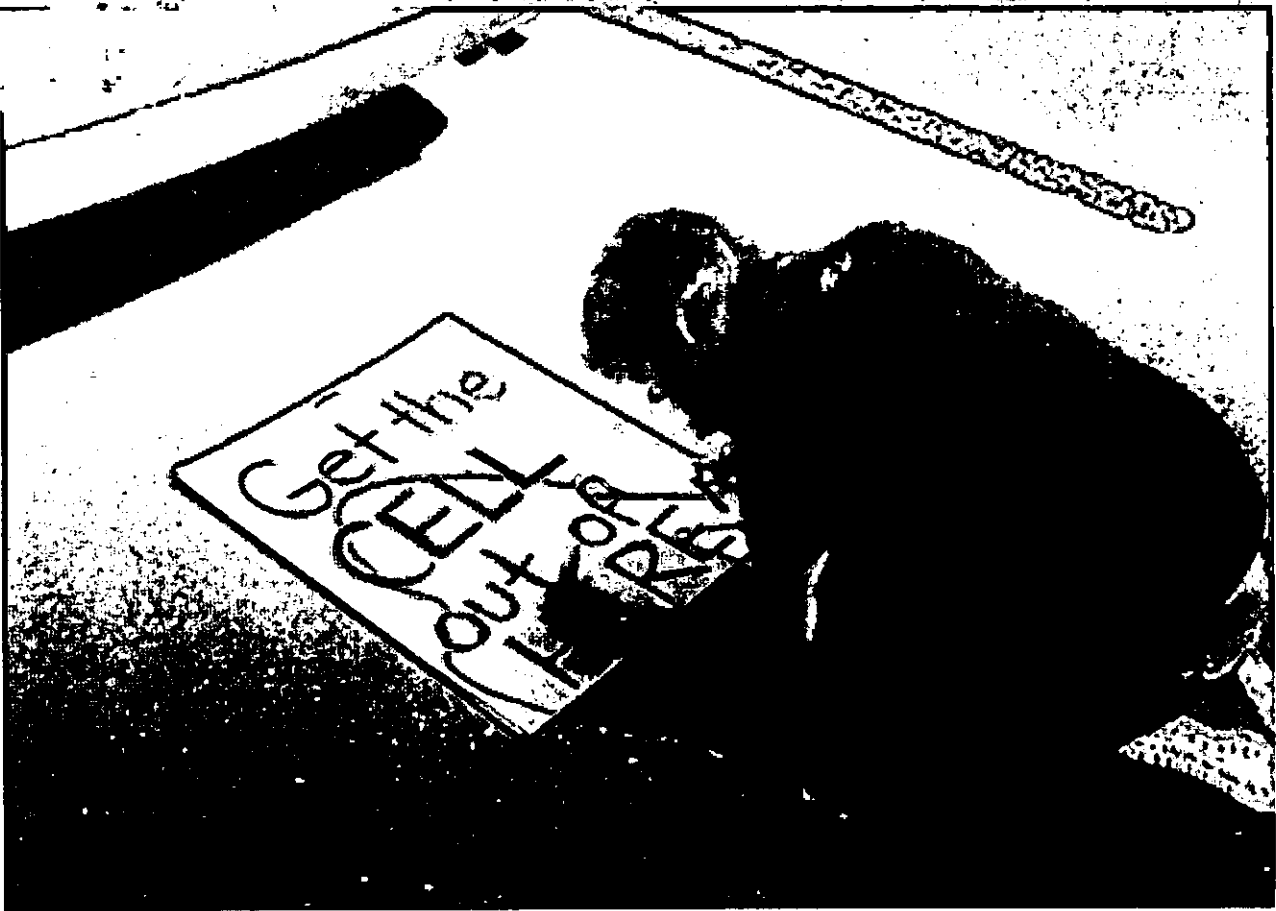
"I like very much the idea I can have the potential to have a relationship with every student, with every staff member," Bailey. "I think there's a lot more personable quality to working in a school of that size."

The district has had relatively high turnover in this position. The current principal of the high school, Brett Miller, headed the school for just two years.

Bailey said his goal will be to hold the job for the long term.

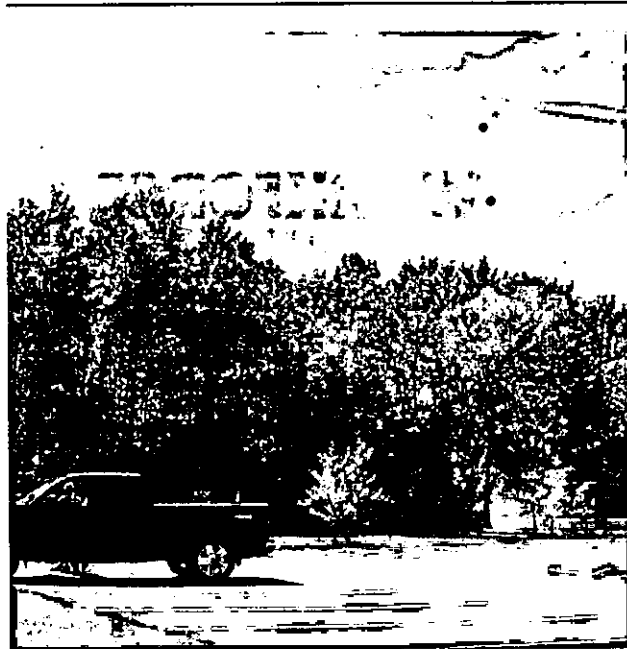
"I want to be there, and I'm dedicated to doing that," he said. "Growing up around here, having family members that live in the district ... I've had ties with Ravena-Coeymans-Selkirk and Albany and Greene counties for a long, long time."

Bailey's pursuing his doctorate at The Sage Colleges. Bailey resides in Voorheesville, has two teenage sons and is engaged to Kate Deane.

Cell tower balloon test draws onlookers

Delmar resident Kim Strosahl, pictured above, makes a sign to picket the proposed cell tower sites at 65 Elm Ave. on BC School District property and private land off of Van Dyke Road. The two companies looking to site towers at those locations, Independent and ESCO, respectively, floated test balloons at heights of 120 and 150 feet on Friday and Saturday, July 30 and 31.

Strosahl said she doesn't approve of either site, saying both are too close to school property. The sites are about six-tenths of a mile from one another, near both the high school and Eagle Elementary.

"It's a rock and a hard place. Both sites are too close to two schools," said Strosahl, who has a 7-year-old in Slingerlands Elementary. "I'm not anti-

Strosahl, joined on Saturday morning by fellow pickets Michelle and Steve Donnelly who have two children in Eagle Elementary, said she's concerned with effect towers will have on the community, but said her opposition goes beyond NIMBY-ism.

"Cell towers are a necessity," she said, "but there is nothing that makes it necessary to put them on school property or in residential areas."

Both tower applications are before the town's planning and zoning boards for variances and environmental impact studies. The balloon float test was integral to this process because there is little to distinguish the two sites from each other beyond their visual impact.

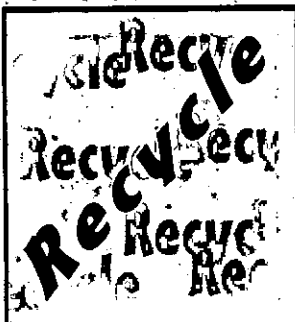

"Oh, right, you don't like the topic," he said.

I responded, "You're right. I don't like the topic, but my phone battery really is about to die. I've been telling you this for two weeks."

He said, "Go buy yourself a new phone."

"Phones cost a lot if you buy them when your plan is not up for renewal."

While we continued talking I walked to the locker room so I could plug in the phone. I've begun carrying my charger wherever I go.

"Hang on" I told my dad as I plugged in my charger and then connected it to the phone.

"You, OK?" he asked.

I told him, "I'm fine. I had to go to the locker room so I could plug in my phone because the battery was giving out." What I didn't add is, "See, I'm not purposely rushing you off the phone because of your choice in topics."

After a short while he said HE had to go. A friend was picking him up to go to a barbecue. He needed to get ready.

"Good, now I can leave the dark locker room and go back out in the sun."

"Go pee first while you're there so it shouldn't be a total waste."

I said, "OK," even though I felt like saying, "I don't have to pee. I peed before I left the house." But there was no need to argue. It's not like he was going to know whether or not I peed.

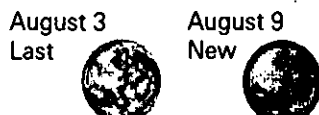

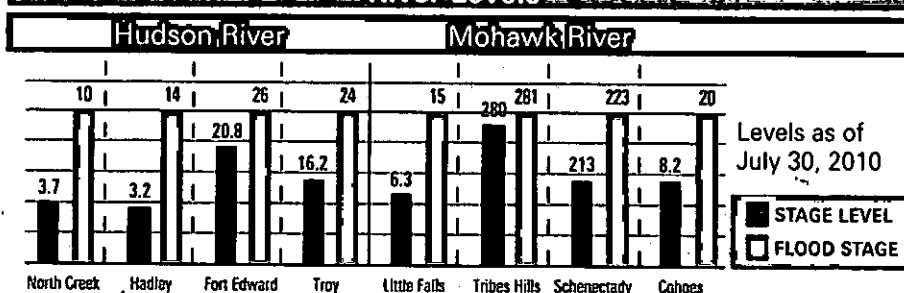

Town to lower speed limit on Old Quarry Road

Study finds 45 mph is optimal for South Bethlehem roadway

Motorists in South Bethlehem will soon notice a change on Old Quarry Road in the near future, as the Bethlehem Town Board has authorized the road's speed limit to be lowered from 55 to 45 mph.

The unanimous decision on Wednesday, July 28, was preceded by a presentation by Mark Sargent of Creighton Manning Engineering, which conducted a study on the roadway at the request of the board. The engineers found what residents already knew: The narrow, winding roadway demands a lower speed for safe negotiation.

As it is, 15 of the road's 17 curves are preceded by advisory signs warning motorists to slow down to a speed below 55. The engineering firm's research showed most motorists are slowing down to speeds around 45 mph on these curves, which constitute about half of the road's length. The road is currently not posted, making the

maximum legal speed 55 mph.

Data from a recorder that measures speeds showed an average speed of 53 mph, though. Sargent said this is likely because it was located just north of the intersection with Rupert Road, in a straightaway.

"That happened to be installed in one of the higher speed segments in the entire area," he said.

The town turned to Creighton Manning after a public hearing in April saw many residents saying the limit should be dropped even lower than 45. The town's own research has found records of 14 crashes in the past three years on the road, seven of which occurred in the past year. Four of those involved deer in the road.

When asked about lowering the speed limit even further, Sargent gave the same advice as town staff.

"People won't obey it," he said. "People will drive the road at what they think is a safe speed."

A northern sliver of the road is in the Town of New Scotland, and would not be affected by the change.

In related news, the Town Board is considering placing stop signs at two intersections in town after receiving advice from Creighton Manning. Both changes were pursued at the behest of nearby residents.

If approved, the three-way intersection of Brockley Drive and Orchard Street in Delmar would become an all-way stop. Sargent said the engineering firm's study had found cars turning left from Brockley had an obstructed view and not enough time to see westbound cars on Orchard.

"Installing a stop sign will mitigate that limited visibility," he said.

Also, the town is considering placing two stop signs at the intersection of Southwood Drive, Northwood Court and Thorndale Road. Southwood Drive's unusual split roadway makes traffic behave strangely here, as traffic has to bear right to continue on Southwood. The stop signs would be placed on Thorndale and Northwood where they intersect with Southwood.

Both proposals will be subject to a public hearing at the Town Board meeting on Wednesday, Aug. 25.

The second in a regular series of Business Forums will focus on programs designed to help employers find, train and retain employees.

The forum will be held Wednesday, Aug. 11, from 7:45 to 9 a.m. at Bethlehem Town Hall and is open to the public. Representatives from the state Department of Labor will discuss the Job Bank, Shared Work, HIRE Act & On-The-Job Training programs. Town economic development officials will also give a brief overview of the Kendall Square Hamlet Plan.

The forums, first announced by Messina at the Chamber's State of the Town breakfast earlier this year, are designed to explore opportunities and implement action that will support current, as well as new, businesses. The first meeting was held in May and will continue on a quarterly schedule.

"We were so pleased with the attendance and discussion at our first forum, which speaks to

the willingness of our government and business community to work together on these

issues," said Town Supervisor Sam Messina. "We are looking forward to another effective dialogue."

"We're thrilled to be able to let our businesses know these programs are out there," said Chamber of Commerce President Marty DeLaney. "It is an economic benefit to all if a business is able to hire someone who has been out of work and receive incentives for it, or consider alternatives to employee layoffs."

When you think about the nature of the entities coming together, this is no small feat. People involved in emergency services are (we believe rightly so) fiercely proud of their positions. There is a calling for people in those fields — it takes a certain type of person to make the decision to run into a burning building or have the knowledge and fortitude to aid and transport someone who's injured.

Traditionally, the pride that exists in those types of people is accompanied with a streak of territorialism, especially in the upper ranks. That's why it's heartening for us at *The Spotlight* to learn that these individuals put those feelings aside, saw a need to better their services — and decrease the burden on taxpayers as well — and are coming together to make it happen.

Unfortunately, as it seems is the case with any good application of government resources, the state's Local Government Efficiency Planning Grant Program, which the agencies were hoping to use to flesh their plan out, has run out of money and is unlikely to see more funding in the near future.

While John Lutz, a member of the Board of Commissioners of the Elsmere Fire Dept., said the agencies are prepared to spend what funds they have to see this to fruition and will send out a request for proposals for a consultant on the matter. The cost, per agency, has been roughly estimated at \$20,000 to \$30,000.

It may seem like a lot, but we feel the long-term savings — not to mention the improved emergency services — would be worth it.

Communities not lining up to raise property values with cell towers

Editor, *The Spotlight*:

The July 28 Spotlight coverage of the cell tower location issue left out several important considerations (*Town consultant: Sprint has not shown need, page 3*).

The information presented at the July 21 Zoning Board meeting left the impression that the application for variance was the first step, to obtain approval for a location with definite intent to expand the installation.

A variance from regulations must be based on a need that overcomes the imposition to the community. Analysis of the materials submitted in support of the request showed gaps in area coverage by Sprint based on formula calculations, which according to the board's engineer are not supported by field

tests and would not be remedied by the proposed tower. The later height and transmitter additions referenced in the application were also questionable in improving gaps in area coverage. Data addressing such area gaps may show a need of a particular provider but not an actual need for the community because it does not demonstrate call volume, density or dropped calls within those gaps, which reflect real service necessities.

Consequently, that raises the value of the aesthetics imposed on the community. The towers are highly visible structures that change the appearance of the neighborhood. Communities have not been anxiously competing for towers to improve their property values.

Delmar has continuously taken care to preserve its suburban nature by controlling cutting of trees, visual barricade treatments for developments and historic motifs in roadway improvements as at the Four Corners.

Water towers, electric transmission lines and light towers at school athletic fields can be accepted as necessary and beneficial. Balloon tests are a start toward assessing the visual impact of the proposed towers. It would be a simple matter to photo-shop the actual tower structures with their transmitter arrays into site photos to get a feel for the actual view that will be there forever.

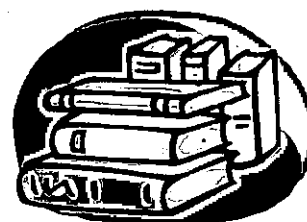

Local teens head to Maccabi Games

Four-day event a celebration of sports, service and heritage for Jewish youth

In the competitive world of sports today, it's easy to get caught up in medals, championships and tournaments. However, the 17 Capital District teens traveling to Richmond, Va., to compete in the annual Maccabi Games will focus on community service and celebrating culture.

The competition, for Jewish athletes ages 13 to 16, combines sports with community volunteering and cultural exposure. With competitors from all over the United States, Canada, Europe, Mexico, Israel and South America, the athletes get the chance to "build a relationship with teens from other places," said delegation head Andrew Katz.

Athletes are able to apply for selection at the February open house and are judged on athletic ability and community service experience. The athletes picked departed for Virginia on Sunday, Aug. 1, and will stay with volunteer host families in the area. Upon arrival, the teens will take part in Opening Ceremonies at the University of Richmond to celebrate the beginning of four days of competition.

Not only will the athletes compete throughout their time in Richmond, but they will participate in the "Days of Caring and Sharing" program, where the teens will work with local children from nearby YMCAs and

Boys and Girls Clubs. The athletes will help the children with art projects, field games and relays.

"It's more of a giving back type of project," said Katz.

The Maccabi Games offers a multi-faceted experience, as athletes get the chance to compete in their specific sport, make connections with teens from all around the world, as well as learn and celebrate Jewish culture.

"I think that it's going to be interesting. ... I think [the community service] is a good aspect. ... We'll be getting into the community of Richmond and working together as a team," said Sarah Fielman, 15, a swimmer from Selkirk who will compete in the games. The aquatic director of the JCC encouraged Fielman to apply for a chance to swim in the Maccabi Games.

"It sparked an interest with me," she said.

Fielman said she was interested in taking part in an activity that would help her learn about not only her culture, but others' as well. Being a part of a sporting event that also embraces Judaism is intriguing to her.

"I'm really excited. I've never done anything like this," Fielman said.

Another swimmer, 14-year-

old Samantha Ebersold from Slingerlands, said she "instantly became interested" in participating in the Maccabi Games after hearing her cousin talk about his experience playing baseball in the Westchester Maccabi Games of 2009.

"To me, the most exciting part of going to Richmond is getting to go and do the thing I love the most, while getting to meet others who have the same interests as me and who are Jewish," she said.

Ebersold said she feels a "nervous excitement" to meet her host family, one of the many Richmond families that will house the athletes during their six-day stay.

"I think it will be nice to have [Judaism] in common with everybody there," she said.

Adam Chaskin, assistant coach for Siena men's basketball, has been involved with the Maccabi Games since 1988. Chaskin said he comes back every year because he thinks it's a "terrific organization and a terrific experience."

Chaskin first got involved with the local JCC while living in Washington, D.C. He has coached all around the world, including coaching the US National Basketball Team in Israel. He said for a lot of kids, who might be part of the only Jewish families in their communities, it's great to connect with other people who share their heritage and identity. Chaskin will lead the Albany-Schenectady delegation's soccer team in Richmond this year.

Blackhawk training exercise draws attention

Army National Guard prepares to fight wildfires

Residents in Latham all the way up to Schuylerville may have noticed a Blackhawk helicopter flying overhead, but there is no need to worry; it was just a test.

The New York Army National Guard's Latham Unit Company A, 3rd Battalion 142nd Aviation conducted water bucket training on Wednesday, July 28, at the Garnsey Airport, a public airport just south of the village of Schuylerville and on the west side of the Hudson River. The company was preparing to fight possible wildfires in New York or other states if its services are needed.

AUH-60Lima Blackhawk helicopter was carrying what was referred to as a Bambi Bucket to pick up water from the Hudson River and carry it to an island, just south of the pickup point, where it would dump the water back into the river. The bucket can carry up to 660 gallons, or 5,405 pounds, of water, according to Lt. Col. Paul Fanning, the National Guard's public affairs officer.

"They can carry troops and they can carry lots of supplies. We call them sling load operations whenever the aircraft is going to be used to carry heavy objects," he said. "In

a combat zone, it can be used to carry an artillery piece, a humvee and it could be used to evacuate casualties."

With all that weight, the pilot of the helicopter, Chief Warrant Officer Jim McCauley, said there are certain precautions the crew has to take when carrying such heavy cargo. The most the aircraft can carry, as labeled on the hook, is 9,000 pounds.

"It does get a little sluggish, you just have to be careful and think about everything you're doing," McCauley said. "To [carry 9,000 pounds], we'd have to be stripped out and light

on gas. That would be the maximum."

Fanning described a situation where the unit assisted the town of Delmar during a mudslide in 2000. The aircraft was used to airlift a drill rig into position to drill deep into the ground to collect soil samples and help in planning rebuilding the area washed out by the mudslide.

"They had to do the lift in two pieces because the drill was so heavy and so complex," he said. "The next piece was flown over and they literally hovered so the second component could be carefully placed where it needed to be

placed, right on top of the base of the drill rig. Only the Guard could do that because we're the only ones with that aircraft and the crews trained to do that kind of stuff."

Not only does the Latham unit assist locally, Fanning said it helped in the Hurricane Katrina and Rita efforts, transporting people who needed to be

medically evacuated as well as bringing relief supplies such as water and food to areas that were not receiving it quickly enough.

For Wednesday's training, McCauley said members were briefed on how to release the water in the bucket, how to drop the bucket in case of an emergency, how to test whether the helicopter

has enough power to do the heavy lifting required of it and what the power limitations were.

"You get on the computer and you figure out the power margins with the load and without the load," he said, adding they also test how much wind will be a problem."

The training attracted some attention from local residents who came out to watch.

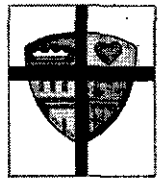
"This is phenomenal," said Joanna Valente, 67, who said if it weren't for her age she'd be up there with the unit. "I'm so happy I got to see it."

Valente has a grandson in the Air National Guard, Charles Lane, who does mechanical work on some of the aircraft. He is scheduled to be deployed to Afghanistan in 2012.

"He's the one who really got me hooked," she said of the military aircraft. "I love airplanes, the big stealth bombers, Blackhawks. I love 'em."

Susan Garnsey, who lives in the house directly next to where the training was taking place, said the sound of the helicopter doesn't bother her at all.

"It's kind of neat," she said. "I don't find it any inconvenience."

Delmar man's debut novel hits shelves

'Stash' examines affluent suburbia and its denizens' hidden trials

"Suburbia" is a loaded word, one that calls forward white picket fences, happy families and content spouses. But just like in any other part of the world, those who live in well-to-do communities struggle with themselves and others.

That's what author and Delmar resident David Klein is exploring in his first novel, "Stash," which hit shelves last week.

It takes place in a subdued suburban community in upstate New York and follows Gwen Raine, a stay-at-home mom with a perfect life who finds herself in hot water when cops find a small bag of marijuana in her car after an accident.

"She's constantly getting herself in a little bit deeper because she's constantly having to make these choices," Klein said. "It just kind of spirals a little bit for her, getting more and more deeper into this conflict."

Gwen's husband, Brian, has his own issues with drugs, as he works at a pharmaceutical company that wants to

market its antidepressant as a weight loss drug, to the government's chagrin. And the couple's daughter is involved with a soldier addicted to painkillers.

While it might sound like "Stash" revolves around drugs, that's not the case, said Klein. It's more about the characters' relationships with one another, told from multiple perspectives.

"I think of drugs as less of a theme and more of a setting," Klein said. "I really didn't try to do any moralizing or judging about drugs. I'm trying to put characters into moral dilemmas and having them work out one way or another."

Seeing the two worlds of carefree suburbia and a more deviant drug scene collide also pushed the novel

forward. Critics have been kind so far, characterizing the book as a summer page-turner that still has substance.

Klein has been writing for years, longer than the 15 he's called Delmar home. He's penned short stories that have been published in literary journals, as well as more technical writing and newspaper work. He also runs Klein Marketing as his "day job."

Although "Stash" isn't his first novel, it is the first one to be released. The 365-page book took about two years to write, but it took an additional year to get it to shelves.

"I've always kind of written what I wanted," he said. "With 'Stash,' I maybe wrote a little more with an audience in mind ... and I got a lot of interest when I started sending it around."

He doesn't think that has cheapened the experience or his vision, though, which is always a danger when an author writes to the marketplace and not his audience.

"I think I fall somewhere in between, where I want to write what I want to write, but I also have an eye to the audience," Klein said.

the house needs was beyond what even a second mortgage could cover.

But there is hope in sight for the Jones family. Work is already under way on an addition to their home that will include all the elements Michael needs, made possible by the generosity of local businesses.

Heading up the project is Keystone Builders of Delmar. When owner Steve Bolduc heard of plans to build the addition, he didn't hesitate to extend the services of his company gratis.

"It's just something I felt compelled to do," Bolduc said. "This community has been good to me... and it's nice to be able to give back a little bit here."

Katrina Bolen, neighbor to the Jones family, began trying to put together an effort to build the addition after estimates for the structure came back. It didn't take long for her to find companies willing to donate supplies and labor at-cost or for free.

"It was very quick," she said of the response. "Some people were on board with just a phone call."

Since starting on July

1, Keystone has already handled the excavation and foundation work, put up a frame and started roofing. Lumber has been donated by Curtis Lumber and 84 Lumber, concrete by Clemente Latham Concrete and Bonded Concrete. Andersen Windows and Doors have made donations, and Barrier Free Systems supplied the equipment to make the home handicapped accessible at no cost.

There are numerous other donors who made contributions big and small to the addition, which is slowly taking shape.

Even the neighbors are helping by letting vehicles onto their property when needed, said Bolduc.

"A lot of people are stepping up to the plate here and doing whatever they can," he said.

When finished, the home will have an addition with a handicap-accessible bedroom, washroom and sitting room, as well as an accessible deck and covered car port. The kitchen will also be modified so Jones' wheelchair can move through it.

It's hard to put a finish date on the home, in part because not all the needed parts are lined

up yet. Bolen said she's still trying to find an appropriate heating and cooling system that Jones needs because his body can no longer properly regulate its temperature.

Jones has been in the hospital or nursing home ever since his injury, which occurred in Florida. DeStaso-Jones spent months traveling to a New Jersey hospital with her 2-year-old daughter, Liliana. She's hoping to return to her job as a Colonie teacher soon.

While their lives have been changed forever, what has made it possible to continue forward has been her husband's strength and the generosity of friends, neighbors and strangers, DeStaso-Jones said.

"I did not expect nearly as much as the kind of support we're receiving," she said. "We're so grateful."

sultant was necessary," he said.

Among the topics the departments would coordinate on are future equipment purchases, standardizing operating procedures and training and seeking out cost savings. The departments would coordinate with the town through the supervisor's office.

Supervisor Sam Messina said this is the first he knows of such collaboration between the town's emergency service districts. He also made mention of the town's 20/20 Plan, which sets the goal of coordinating municipal services.

motives of the people who met with me," he said.

Other communities that are covered by multiple emergency services companies have conducted emergency services studies, including the Town of Malta, where companies are preparing for the opening of a GlobalFoundries manufacturing plant and the challenges that will present.

Other members of the Town Board said they liked the idea of creating a plan.

"I think it's a great, introspective kind of process. I couldn't be more supportive of it," said Councilman Mark Hennessey.

A request for proposals could be sent out to qualified consultants within two or three weeks, said Lutz. Until those quotes come back it's impossible to say exactly how much a study would cost, but he estimated it could cost \$20,000 to \$30,000 per department.

And if there isn't any other source of funding, this is important enough for the departments to foot the bill themselves, he continued.

"The districts are prepared to move forward and spend district funds for this process in lieu of the lack of money in the grant program," Lutz said.

Bob Richardson always wanted to buy a Ford Fairlane like he had in high school. When he finally found one, it provided more than a link to his past: It helped him make friends.

Richardson had moved to the Albany area for his job and found it a little lonely.

"I didn't know anyone," he said.

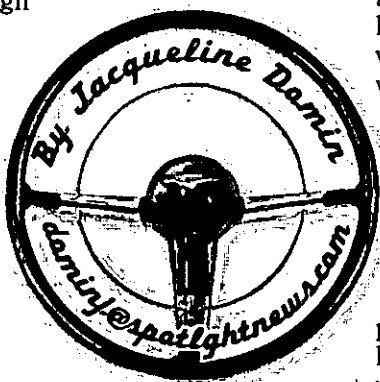
That changed when he started going to car shows and cruises with his Fairlane. Richardson formed some close bonds with fellow car owners, which only tightened when Guptill's Arena announced it was going to move the day it held its monthly cruises. The car club that was staging the cruises

couldn't do it on the new night, Richardson said, so he and his wife, Joan, decided to form a new club dedicated to keeping the Guptill's cruises alive.

That club, the Capital District Cruisers, holds cruises at Guptill's in Latham once a month during the summer. The next one is Monday, Aug. 9, from 4 to 9 p.m.

If you go, expect a crowd — Richardson said

there are typically 600 to 700 cars and upwards of 5,000 spectators.



"I've lived a lot of places, and I've never seen anything this size," said Frank Alguire of Ravena, the club's president.

Like Richardson, Alguire got involved in car clubs after he moved to this area and was looking

more likely to notice," he said.

Alguire noticed the car after which his custom hot rod is modeled while watching "77 Sunset Strip" when he was younger. The television show featured a character named Kookie who drove a 1923 Model T.

"I fell in love with the car," Alguire said.

Alguire thought about purchasing a Model T, looking at several that were for sale, before deciding he would build his own.

"I'm a hobbyist," he said, noting that he built the frame and got a junkyard transmission.

As much as he likes the attention that comes with owning the Model T, his favorite thing about

the Guptill's cruises, he said, is that they aren't competitions. There are no entry fees or trophies.

"It's just a lot of fun," Alguire said. "There's no pressure."

Erin VanVeghten of Latham

grew up enjoying the laid-back vibe at Guptill's with her dad, a longtime classic car owner. When she and her husband, Dana, learned the cruises at Guptill's were in jeopardy, they didn't think twice

about joining forces with the Richardsons.

"We could not see losing such a good thing to do," Dana said.

"Everyone looks forward to it," Erin added.

Dana said that he's drawn to the club and the cruises for a simple reason: Cars are his passion.

"That's my thing," he said. "That's my football. That's my golf."

That's a common sentiment among classic car owners, who largely aren't into sports or drinking, said Pat Villani of Glenville, the group's treasurer.

"It's a whole different breed of person," Villani said. "You can walk up to any car person and you're going to find a friendly person."

Another trait car owners tend to share is that they're mechanically inclined, he said. That's the case with Villani, who said his gleaming '57 Chevy was an "old rust bucket" when he bought it.

Villani has actually owned a number of '57 Chevys. But he eventually got tired of them and decided to buy a '66 Impala convertible instead.

That didn't go over well at home.

"My wife was very upset," he said with a

laugh.

So off he went to find another '57 Chevy.

Doug Roberts of Albany looked admiringly at Villani's car and a handful of others during the club's recent picnic at the Crossings in Colonie. Roberts is somewhat unusual in that he belongs to the club but doesn't own a classic car. He joined after the Richardsons, whom he knew from work, assured him that "having a car is not necessarily a big thing."

But that doesn't mean Roberts doesn't want to own a car someday. Recently retired, he bought a camper and then a truck to haul it. Once those are paid off, he hopes to get a classic car, probably nothing newer than 1970, although he hasn't settled on a make and model.

"Some of the old cars, I just love them to death," he said.

The appeal of the club, he said, is seeing just what every owner does to make his or her car a little different from the rest. Everyone is more than happy to talk to him about the modifications they've made and what cars they think might be a good fit for him.

There was a time when Joan Richardson would have felt lost in such conversations. But after marrying her husband, she came to enjoy the classic car scene as much as he does.

"We just like the camaraderie," she said.

Guptill's is the perfect place for that camaraderie to grow, according to Bob Richardson. For one thing, there's a lot of space, including a grassy area where owners can display their cars. Beyond that, it's fitting to hold the cruises at a roller rink, considering that skating was a huge part of people's childhood.

"It's perfectly in the era," he said. "We all went roller skating. It's just all part of the nostalgia and the memories."

Admission to the cruises is free, although the Cruisers ask for one non-perishable food item (or cash) to help support the Regional Food Bank of Northeastern New York. There is live music, and ice cream and other food is sold at Guptill's Coney Express. Cars as old as 1985 are welcome at the August cruise; the Sept. 13 cruise is also open to cars from any year with after-market customizing.

Jane (McClintock) Weidman

July 6, 1935-July 16, 2010

To her family, "Budge" was the energetic, loving, fiercely loyal woman who



knew about everything before the term was coined. She could do

from making clothes for her two children, Jane and John, to cooking and presenting a gourmet meal for a crowd. And she did all of that while moving the family nine times as a Navy wife married to CDR (ret) Russell H. Weidman. They lived in West Springfield, Va. for the past 35 years and celebrated their 53rd anniversary on December 29.

To another circle, Budge was the consummate researcher and historian, who led the all volunteer Civil War Conservation Corps at the National Archives from November,

1994, when it was created, to her retirement in December, 2009. She scheduled, supervised and befriended up to 55 other volunteers who engaged in preserving some of the priceless Civil War records: the Compiled Military Service Records, the field records of the Freedmen's Bureau, and the Civil War Widow's Pension Files.

An amazingly generous person, Budge happily shared information she learned from the Archives records with all who asked. She accepted speaking engagements, but took no pay, to discuss the CWCC work and some of their findings in the Civil War files.

Last year, the National Archives announced the creation of the annual Weidman Outstanding Volunteer Service Award and Budge and Russ were the first recipients.

The people in the records became like an extended family and Budge would talk about the injustice done one soldier or the

heartbreaking account of a widow's poverty resulting from her husband's or son's death in the war. She was highlighted for this activity in the Washington Post on February 1, 2010 in the Fed Faces. She was a member of the Lincoln Forum, and served on the Forum's Advisory Board. Budge was also a member of the Lincoln Bicentennial Advisory Committee.

She attended Slingerlands Grade School, Albany Academy for Girls (cy 1953), Northwestern University, and Katherine Gibbs School in New York.

Budge is survived by her husband and children - Jane W. Waligorski and her husband Martin and John R. Weidman and his wife Felicia - as well as her brother John McClintock, sister Gail Neil and sister-in-law Joyce Phillips and seven grandchildren: Russell, James, Elizabeth Waligorski and Molly, Jack, Michael and Katie Weidman.

Burial will be at Arlington National Cemetery at a later date.

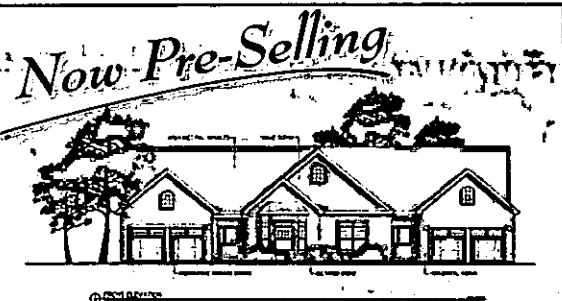

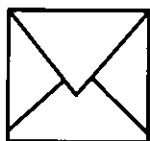

they do not appear together on the petition itself.

"I am not permitted to endorse candidates in any race and I have not done so, nor will I," said Donovan in a statement. "If my actions have been interpreted as an endorsement of any candidate, they should not have been."

He declined to speak directly about the matter further.

The Judicial Campaign Ethics Center is an arm of the state Unified Court System that seeks to provide ethics advice for judicial candidates. The body can also assist in mediation should there be disagreements between candidates.

A mediation seems unlikely in this scenario, as no one is seeking to have the signature disqualified.

"It would be a waste of effort and money," said Melody Burns, chairwoman of the Bethlehem Republican Committee. "[Gordon] had enough signatures, so it doesn't make any sense."

The rule in question

does not pertain to election law, so it's unlikely a basis would be found to have the signatures thrown out.

While Ambrosio said he was unconcerned about Donovan's petitions, it was apparently his own campaign that led the GOP to look into Donovan.

Ambrosio said he was asked to carry petitions for other candidates when he was canvassing for the Independence and Conservative lines. Canvassing is a time- and energy-consuming process, so it's not unusual for affiliated candidates to help one another out.

"Several of my fellow Republican candidates found out I was having some success [gathering third-party signatures] and asked me if I wouldn't mind carrying their petitions, too. ... I told them, I can't do it," Ambrosio said. "This being my first rodeo, I wanted to take a very, very conservative and careful approach to this."

Both Donovan and Ambrosio are seeking the Independence and Conservative lines, meaning there will be a Sept. 14 primary for those slots.

from the people she had come to the game with by that beam.

That probably happens all the time there, though. The Red Sox have sold out more than 600 consecutive games — even the seats that are blocked by those infernal beams.

If that would have been the only crazy part about our night at Fenway, Bill and I would have been
