

Police Blotter Bethlehem police arrêst Albany man for cocaine possession

Police Department on Sunday, Aug. 8, arrested Christian M. Marcucci, 36, of 79 Manning Boulevard, Albany, and charged him with DWI, criminal possession of a controlled substance in the fourth degree, aggravated unlicensed operation of a motor vehicle in the third degree, possession of marijuana and traffic violations.

Police stopped. Marcucci's Pontiac Grand Am on the Slingerlands Bypass at about 12:14 a.m. Sunday for speeding and following too closely, according to arrest reports. He had the odor of alcohol on his breath, bloodshot eyes, impaired speechand made admissions to drinking earlier, police said. A license check also showed his driver's license was suspended in July of 2009 for failure to answer a summons out of the City of Albany.

Marcucci performed several field sobriety tests and during the 'walk and turn" portion of the tests, a plastic bag with a white powder

pocket onto the ground, police said. The bag was recovered and was found to contain a small quantity of white powder in four individually wrapped bags, according to arrest reports, and Marcucci allegedly stated the powder was cocaine. The cocaine was later weighed at the police station and found to weigh 4.81 grams, according to police.

Marcucci also allegedly admitted to having a small quantity of marijuana in the vehicle. Police found marijuana in a plastic prescription bottle along with a ceramic pipe containing marijuana residue, according to arrest reports.

A further search of the car also recovered a box of baking soda and a tin foil tray, both of which were placed into evidence, according to police.

A chemical test at the police station showed Marcucci's BAC to be .10 percent. His license was suspended by Judge Paul Dwyer in the Town of Bethlehem Court and

The Bethlehem fell out of his left pants he was remanded to Albany County Jail in lieu of \$2,500 bail bond or \$5,000 cash bond.

Doctors brace for drug policy change

CDPHP will no longer pay for some brandname cholesterol medications

A policy change by health insurer Capital **District Physicians Health** Plan to make a switch from prescribing brand name drugs, such as Lipitor and Crestor, to generic drúgs in order to cut down health-care costs has some physicians celebrating and others ready to fight back. ck. In a memo to

practitioners, CDPHP stated that during a June 16 meeting with the Pharmacy and Therapeutics Committee, made up of 17 voting member-physicians and two voting memberphysicians who practice in the community, the health insurer will no longer

The changes will go into effect on Oct. 10.

"We're constantly looking for ways to balance the costs for our patients," said CDPHP Public Relations Manager Kristin Marshall. "The perception out there is brought on by the marketing of brandname drugs, but no one is marketing generic drugs.'

The decision was made in order to cut down on rising health-care costs, said Marshall, who added that there are drugs out there that can perform in the same way as the brand-name drugs at a lower cost.

There might be a slight molecular difference, but we wouldn't be making this decision if we thought it

With Crestor, a 40 mg dose will reduce a patient's cholesterol by 50 to 55 percent, according to Dr. Russell Zivkovich, who owns a family practice in Cohoes, while a patient using an 80 mg simvastatin. or the most effective generic brand, must take an 80 mg dosage to reduce their cholesterol by 47 percent.

The U.S. Food and Drug Administration released a study in March 2010 finding "an increased risk of muscle injury in patients taking the highest approved dose of the cholesterollowering medication, Zocor (sirnvastatin) 80 mg, compared to patients taking lower doses of simvastatin and possibly other drugs in the 'statin' class.'

"A higher dose of simvastatin-puts the patient at greater risk of injury or

Teen organizes benefit for juvenile diabetes

Cody Martel raises \$2,250 for a cause he and his family know well

Just an hour into a benefit for the Juvenile Diabetes Research Foundation on Aug. 15, already more than 100 people had shown up to support the cause, hear free music and eat cupcakes. *

Cody Martel, 16, who was diagnosed with type 1 juvenile diabetes almost 11 years ago, put together the event in two weeks at the Village of Colonie's Family Recreation Center, where local band Breaking News played covers of familiar songs and prizes donated by several local stores were raffled off. The event raised \$2,250.

There was even a CoccaDots Cupcake truck parked out in front of the recreation center, where a \$5 entrance fee got attendees a free cupcake.

Martel got the idea for the fundraiser after taking over the reins of running his mother's JDRF Walk Team, Colonie Cares, this year.

"My mom has always run our Colonie Walk team, and this vear, at the last walk actually, me and my friend were thinking of a bunch of different ideas to fundraise and we thought, 'Why don't we run the team? Why don't we just try and do it ourselves," he said. "So we were on the team and came up this idea [the fundraiser], and I

"They waived all the fees," Martel said.

His mother, Hiedi Ruth, was one of his biggest helpers, he said. She was involved with the JDRF before Cody was even born.

'I just always felt a strong draw to the JDRF, and I never knew why," she said. "But then when Cody was diagnosed at 5. I realized why I had a strong commitment to the JDRF.

She credits her son with being very responsible and mature, as a result of having to deal with being diagnosed with juvenile diabetes, but she said she was a bit hesitant when Cody first proposed the idea of holding a fundraiser.

"I'll be honest, when he said he

was going to do it I said, 'Uhhh; OK' He's a teenager, we'll see what happens," she said. "We were a little bit nervous, but he's blown me away. He's walked up and down Central [Avenue] to get donations. He got the band. I drove him around, but he talked to all the managers [of the stores]. He's done a really amazing job."

Cody said the biggest objective was to advertise the event as much as possible in order to get the word out. He went around to local publications and radio stations in order to promote the fundraiser.

"We had to advertise like crazy," he said. "We tried to contact radio stations to get it advertised. My uncle owns Martel's Restaurant at OTB, and he owns the OTB, so we got advertisement there.³

Even though organizing this fundraiser took up a lot of time,

with only a half hour into the event, he already knew it was time well spent.

Despite tough economic times, South Albany Airport soaring

Recent years have seen many improvements to private runway

You might have recently read something about recreational and hobby industries not doing so well. The recession is taking its toll in areas people happily spent their money in boom times but



now are pulling away from.

unsurprisingly, one of those areas. The Aircraft Owners and **Pilots Association's Pilot** magazine reports the ranks of pilot students is shrinking to its lowest levels in years. According to a 2009 USA Today poll, many general aviation airports operate at a loss, relying on public funds to stay open or fading into insolvency.

But while the industry picture is dim, at the South Albany Airport in Selkirk, nothing could be further from the truth, said manager and owner Ted Zabinski.

The airport has been in operation since 1947, when it was not much more than a strip of grass on a sod farming operation. In time, an asphalt runway was installed, and was widened in 2000 to 60 feet.

In 2005, security fencing was upgraded to circle the entire 60 acres of the airport. Electronic



11 - Tolard Harris Airport exit options narrowed to four

Project expected to ease congestion on **I-87 during rush hours**

It is an idea that has been proposed since the 1960s, but the New York State Department of Transportation finally is pushing forward on its Exit 3 project for Interstate 87

The project is meant to be a direct path to the Albany International Airport, as well as a way to reduce traffic during rush hours. The original list of nearly 40 alternatives for the project has been narrowed down to four options.

The ideas range from adding an extension to Exit 4 to building an Exit 3," said DOT Capital Region Spokesman Peter Van Keuren. "We're hoping over the next year to get rid of two of the options."

There are several partners involved in the decision making. according to Van Keuren. Among them are the **Albany County Airport** Authority, the Town of

Colonie's Department of Public Works and federal and environmental agencies.

"It's a major project," said Van Keuren. "It takes a lot of time to get a perspective, and we have to look at the overall impact of the options.'

The Albany County Airport Authority has already announced its favorite plan, which is to build an entirely new exit, which would require replacing the bridge that extends over Albany-Shaker Road.

New exit ramps would be built from I-87 southbound to Albany-Shaker Road, I-87 southbound to Wolf Road at Marcus Boulevard and from I-87 northbound to Albany-Shaker Road. The project would also include the removal of the existing Exit 4 southbound ramp, according to DOT.

"It will be a decision DOT will make," said Albany County Airport Authority Spokesman Doug Myer. "We will tell them what we feel is the best option."

Town of Colonie Department of Public Works Commissioner Jack

Cunningham said the project would be a big benefit in getting airport traffic out of a commuter area.

"It's really long overdue and a welcomed change," he said, adding that with the growth of the nanotech industry through GlobalFoundries, more traffic is expected. "We're going to see a spinoff growth throughout the region. A lot of people will be flying in and out of here because they need to do business."

Along with direct access to the airport, Cunningham expressed the need for a quicker entrance and exit for emergency vehicles.

"If there is any sort of problem over at the airport, direct entrance and exit could be beneficial" he said. 'Congestion impacts the ability to get in and out."

Van Keuren said the cost of the project will start at an estimated \$15 million, but he said the number will certainly go up as more components of the project fall into place. He added that they are scheduled to have a final design up for bid in 2012 with the hope of beginning construction in late 2012 to early 2013.

Nothing to see here

Thank you to the Town of Bethlehem Planning Board for "generally agreeing" that killing a cell tower project on farmer Chuck Preska's land is not worth the aesthetic benefits of a "monopine tower." (See page one for Charles Wiff's story on the matter.)

In short, now that the Planning Board has favored ESCO Towers' site on Preska's land, the debate shifts to what kind of tower they will consider. Three types are on the table: a latticework tower, which would be wider but made of thinner components; a monopole design, essentially a single, long flagpole; and a monopine, a monopole tower designed to mimic the appearance of a pine tree.

Monopine towers, for the uninitiated, are cell tower concealment structures made to help the tower blend with the surrounding foliage. To be fair, some of them look very good. But to put it in perspective, a good looking monopine cell tower is a lot

like a good looking fake Christmas tree — no matter how nice it is, everyone still knows it's not real.

And those are the good ones — the

more expensive ones. The ones that are least expensive look exactly like you'd expect them to: Like somebody tried to church up a 150-foot cell tower by sticking plastic branches on it.

Either way, whether it's the best attempt at making a cell tower look like a tree or the worst, monopine towers — to paraphrase what John Sheehan, communications director of the Adirondack Council said about the now infamous "Frankenpine" — don't look like any tree on this planet.

And there's the issue of cost. Monopines can cost 10 to 15 times what a regular pole would. As terrible as some of them look, we're not sure why. In the case of ESCO's proposed site, maybe it would be for someone to come back every spring and fall and switch the branches to match the deciduous trees that would surround it. Probably not.

But the Planning Board doesn't want to make the project cost prohibitive for ESCO and we commend them for that. We say go with the monopole design — it's less invasive than a latticework tower, and not as unnatural as a fake pine tree.

⁻ Computer graphics artists and robotics designers deal with something called "The Uncanny Valley" effect. Uncanny Valley is a theory, posited by a Japanese roboticist in the '70s, that the closer a robot or a computer illustration gets to acting or looking like a real human being, the more our minds will notice the differences. We at *The Spotlight* feel the same would hold true for monopines. Put a tower on Chuck Preska's land and people will get used to it; put a fake-looking pine tree there and you'll neither fool nor pacify anyone.

Can you tell the monopine from the real trees?

Drying hydrangeas successfully

One of the pleasures of gardening is growing lovely flowers for all to enjoy, but the real coup is to preserve the blooms for many months of enjoyment.

Prized among the summer bloomers are the hydrangeas, whose showy heads anchor a garden and add both softness and sophistication in one gorgeous package. Relatively trouble-free and at home in most situations except an extremely hot or dry location, the hydrangea is an easy plant to live with in the garden. Good choices for the Capital District area are the paniculata types such as PeeGee, which can be grown either as a bush or as a small tree; hydrangea arborescens such as Annabelle or Hills of Snow; hydrangea quercifolia, the oakleaf and lastly the climbing hydrangea, anomala petiolaris. Of these types, the paniculatas and the arborescens are the best choices for drying.

The cardinal rule for perfectly dried hydrangeas is to choose the right time to harvest them. Hydrangeas do best when allowed to dry somewhat on the plant before picking. To discover the "magic" time in your garden, experiment with harvesting during the August through October period. Try a variety of techniques to learn which suits you best:

• Air drying- starting with mature blooms, remove the leaves from the stem and bundle four or five together, tie them together and hang upside down in a cool, dry place that has good air circulation.

• Using water- choose mature booms on 18 inch stems, remove the lower leaves and place stems in a vase with a few inches of water, out of direct sun. When the water evaporates, add more, repeating this process until the blooms seem dry.

• Glycerin method-Purchase glycerin at the pharmacy and prepare in a vase a solution of two parts water and one part glycerin. Cut the stems at a right angle and crush the ends of the stems with a hammer to help with the uptake of the solution. The water and the glycerin are taken up through the stem; the water evaporates leaving the glycerin. This results in a rich, golden brown hue to the finished material. Should you prefer a subtle shade of color, add a drop of dye to the solution. The time frame for this technique is two to three weeks and the result is a softer bloom that will hold up longer than one air dried.

 Silica gel- Despite the name, silica gel is not a gel but a combination of a sand like substance and blue crystals. Using silica gel will retain the plants' true color and an amazingly natural appearance Containers of silica gel can be purchased at craft stores and although it is a more expensive method of preserving flowers the silica gel can be reused. This is a mor time consuming process but the result are well worth the labor! Work with on bloom at a time, trim the stems short an remove the foliage; use fresh cut bloom that are dry. Add a layer of silica gel in th bottom of a plastic container and place on bloom upside down and slowly add mor silica gel working it gently all around th bloom. It is important that the bloom b "suspended" in the silica and not touc the container. Continue until the flowe is completely covered; tap the contained occasionally as material is being adde to insure good contact and coverage. Fi container to within 1/2 an inch of the top cover and label with the date. It will tak four days for the drying process to wor its magic. After four days, carefully pou out the contents of the container onto layer of newspaper and gingerly remov the dried hydrangea bloom. Carefull tap the excess silica gel off the flowe and store it loosely in a plastic bag of standing upright in a dry vase. Do no leave the blooms in the silica gel for more than four days or they will becom brittle. The exception to this rule is whe using silica that is more than 2 years old Lastly, handle the bloom with care and d not be tempted to use hairspray or othe clear spray to further "preserve" them a hydrangeas do not respond well to thi treatment.

There are other methods of dryin that use borax and white cornmeal bu the results can be variable. If you would like to read more about this method and a more advanced technique involving th use of dye, consult the website: http:// www.hydrangeashydrangeas.com. On last piece of advice: always dry twice a much material as you think you will need for a project.

You can never have too much of a good thing!

Town Hall design work the 'lower cost of appropriate action'

Editor, The Spotlight:

The Spotlight's editorial "The high price of inaction" (Aug. 18) correctly noted the Town Board and I recently objected to Supervisor Sam Messina's plan to bond \$365,000 in unbudgeted spending on several new building projects at Town Hall.

There are many reasons I voted against this spending. In particular, it was an off-budget expenditure we simply cannot afford this year.

This additional spending would have more than doubled the over-\$250,000 in new spending already proposed by the supervisor this year, while we're faced with a growing deficit in 2010 that was already over \$500,000 at mid-year, with projections showing that number will likely be closer to \$1.5 million at year's end.

. In addition, the plan \cdot

had not been previously brought to our attention or fully designed out, and the supporting information was simply insufficient to justify such an expense.

As part of a compromise to address the muchneeded repairs to Town Hall, the board and I did support spending \$34,600 for required engineering and necessary design work for those renovations but did not support the supervisor's request to spend an additional \$20,200 for a facility study both The Spotlight and the Board determined to be unnecessary and unaffordable at this time. I would note that the funds we did approve were available in the current year operating budget and the entire board agrees we need to repair the disrepair at Town Hall.

As for the. 2006 comprehensive town-wide facility needs assessment, that report looked at our entire town government operations and our facilities at that current time, and made recommendations focused primarily on our highway and public works departments, including our aging infrastructure. The study also looked at our space deficiencies at Town Hall and the connected public safety building. We learned a lot from that analysis including the higher than expected costs of certain wants, which simply didn't match our needs or means.

Furthermore, that 2006 needs assessment and the recently approved engineering and design work are two entirely different products for entirely different purposes. The two studies are not redundant, they were both necessary, and were both paid for with budgeted funds.

In the end, while I mostly

agree with *The Spotlight's* take on this situation, I respectfully disagree with the calculation of the price estimate of "looking at these repairs" and the suggested "cost of inaction."

Five years ago, we acted to address and quantify our facility needs for the first time in anyone's memory. Money well spent. A few months ago, we acted to not spend another' \$365,000 we neither budgeted for, nor have. And last week, we approved budgeted funds for only what we need - to fix a leaky roof, failing wall, and inadequate facilities. In my opinion, that's "the lower cost of appropriate action."



AR2010081805682.html). According to the Centers for Disease Control, more than 100,000 Americans suffer from egg-borne Salmonella infections each year. Common symptoms 'include diarrhea, abdominal cramps, and fever.

Salmonella infection is only the most publicized health effect of egg consumption. An average egg contains loads of fat and 213 mg of cholesterol, key factors in the incidence of heart disease, stroke, cancer, and diabetes.

Incidentally, those 380 million eggs were the product of nearly 1,500,000 birds suffering for a year

in tiny wire-mesh cages that cut their feet and tore out their feathers. Their waste was dumped into a nearby stream, contributing to massive pollution of the Mississippi River, and eventually, to a "dead zone" in the Gulf of Mexico three times the size of the BP oil spill.

on the loved ones of the



death," said Zivkovich. "CDPHP doesn't have a license to practice medicine, but they are telling me how to practice.'

Zivkovich said that most doctors are irate over the change in policy but are too afraid to speak up for fear of being dropped by CDPHP.

"Seventy percent of my time is spent writing a note to document something for insurance companies to make them happy," he said. "[Before health insurance companies], there was better medicine, better care, and I wouldn't have to be buried in paper work."

Patient care is Zivkovich's main concern; which he said the new policy change by CDPHP is restricting him from doing right by his patients. He accuses the health insurer of "putting money in front of patient care."

He also said switching to generics could actually be more expensive after rebates given by doctors for brandname drugs. For example, if a patient needs to pay a \$25 copay he can give them a coupon for a \$25 rebate on the drug, essentially reducing the cost to nothing for the patient.

"It's cheaper to get the better drugs," Zivkovich said.

Another argument that has been made by some physicians is that patients who have reached their cholesterol goal on small doses of Lipitor will not be able to tolerate changing to a generic.

Cohoes Mayor John McDonald, who works for Marra's Pharmacy, said that in those cases, CDPHP will provide a way for the patient to access a brand-name drug such as Lipitor or Crestor.

"There will be people who have treatment failure," he said. "CDPHP will provide access to the brand-name drug, but it has to be clinically justified."

Dr. Laura Staff, who runs her own family practice in Colonie, said the application to get those drugs have become increasingly easy over the years, as now a doctor needs to fill out one form on one side of the page showing the patient has failed three months on 80 mg dose of simvastatin and three months on an 80 mg dose of pravastatin. She also added that it only takes a short amount of time to fill out the application.

"If [the patient] does as well on the generic as they do on the brand-name, then they don't need to go back on the expensive drug," she said.

Zivkovich has a different take on the process as he said waiting for a patient to fail on the two statins and Lipitor, which is on a preferred basis, could take up to nine months. It is a wait, he said, that could cost the patient his or her life.

"What if [the patient] dies during those nine months," he said. "The insurance company wouldn't back me up on that. Whether the insurance company covers [Crestor] or not, I can't use the excuse

that the insurance company wouldn't cover it in the court of law."

While Zivkovich says the new policy is designed to bury doctors in paperwork in order to force them to take the easy route and just prescribe the generic drugs, he said refuses to follow those guidelines and will continue to prescribe the brand-name drugs.

"When I do prescribe generics, I tell my patients to go to Wal-Mart because they have a cash plan," he said. "Because they pay with cash, it doesn't get submitted to the insurance company, so it costs less."

Another component of the change in CDPHP's policy is that they are offering doctors \$50 per phone call in explaining the new policy changes. Staff said the money is meant to cover the costs of pulling a patient's chart, reviewing it to see if a generic brand would be adequate and making up for the time it took for the physician to make the call.

"In a 15-minute dialogue you could explain the rationale, where to go from here and what monitoring needs to be done," she said. "It's making honest doctors who would have to absorb the cost of that not have to make the patient come in."

Zivkovich sees the money as a bribe.

This needs someone with a lot of money to hire a lawyer to challenge these policies." he said. "I hate insurance companies. I wish they'd all go away."

Notable attractions at this year's fair included "Wild About Monkeys," featuring Hollywoodtrained baboons performing all sorts of feats for the crowd.



Builder dumps condos in favor of townhomes

Plans change for Verstandig's Florist property


Keystone Builders has altered its plans for the Verstandig's Florist property on Delaware Avenue to build townhomes instead of condominiums. The local company last week submitted plans to the Town of Bethlehem Planning Board for a 27unit development.

Keystone gained approval for its 40-unit condominium project in March of 2009, but never put shovels in the ground. There were several obstacles, said Keystone owner Steve Bolduc, including limited options for condominium financing in today's economy. But the most daunting was that people just weren't committing to the condos.

"They had reservations about things like living over the home of someone else or living under someone else," Bolduc said.

They also worried about having only one garage available per unit. he continued stoist n

The townhomes would be considerably larger than the condominiums at 2,188 square feet. All would have two garage bays, with space in front

of each to park another car. The units would be three bedrooms with master bedrooms on the ground floor, and include fireplaces, den space and a full basement. Each would also feature a small covered porch area.

The townhomes would largely be in double

buildings, though there are two triple buildings and one single unit in the plans.

They're a luxury living design, said Bolduc, and would likely be priced in the high \$300,000s to low \$400,000s.

Keystone hopes to get started on building An artist's rendering of a townhome unit in a proposed development at the site of Verstandig's Florist on Delaware Avenue, Keystone Builders had gained approval to build 40 condominims units there, but recently changed their plans to 27 townhomes due to a lack of interest in the condos. 'Frozen Rabbi' inspired by Jewish lore

Steve Stern's books blur the line between things mystical_and_real By ALYSSA JUNG junga@spotlightnews.com

Steve Stern considers himself a "receptical for the angels to speak to" and he's been writing what they say since the late '80s when he had his first book published. His latest creation, "The Frozen Rabbi," debuted in May and he will give a reading of it at Red Fox Books in Glens Falls on Thursday, Aug. 26, at 7 p.m.

He describes his work as having no boundaries, no lines of demarcation between ordinary reality and pure fantasy. That blurred distinction that his tales take on makes pinpointing the source of his creative inspiration difficult, and "The Frozen Rabbi" is no different, with the only simple realization of the entire novel being its very literal title.

"The premise begins with Bernie, a fat, sluggish, uninspired teenage boy with a head full of erotic fantasies who is exploring in the deep freeze of his parent's meat freezer in the basement when he discovers an old hassidic rabbi frozen in a block of ice," said Stern, who lives in Ballston Spa. "The story alternates between four generations that schlep the rabbi from Eastern Europe to New York City to Memphis, with a digression into Palestine, pre-Israeli statehood. In the meantime, you get the thawing of the rabbi who's perfectly intact and he's found his enlightenment center. It's a completely cracked book."

While he can't describe exactly how his imaginative writer's brain works, he does acknowledge that his books are inspired, to some degree, by Jewish folklore, history, culture, tradition and Yiddish tales. The fascination with his heritage stems from an upbringing that lacked all that.

"I grew up in the south in a reformed Jewish community which was not very traditional, so I was virtually untouched by anything like a Jewish education until I was in my 30s. If I had grown up with the culture I'm not sure it would have been for me the kind of romance I conceived through reading," said Stern.

He got an "accidental" job



at a Jewish folklore center in Memphis, and it was there that Stern found what turned out to be the focus of many of his novels.

"The job involved researching an old Jewish ghetto community that had been long gone by the time I was born. I did a lot of interviews with survivors of that community and began to harvest their stories and memories. As a consequence, it began to constitute a setting for a lot of my stories," said

Stern. who estimates he's centered five or six books around the blighted, downtown community.

Stern has taught creative writing and literature at Skidmore College for 23 years. He said he doesn't incorporate the subjects of his own work into his teaching, so he found a way to nurture that passion by teaching occasional Jewish, studies courses at a summer seminar in Prague.

He said the audience for his books is "tiny" and "probably

shrinking all the time," but that doesn't bother him.

"There's not a large audience clamoring to hear about Jews in Memphis. It's a totally foolhardy enterprise," said Stern. "You write what you want to read and the problem is, what I want to read nobody else particularly wants to. Therein lies the paradox, but I can't help it."

Stern's book reading at Red Fox Books is part of The Adirondack Center for Writing's annual Reading Series, which do hosts writers and poets at local we venues. Stern kicks off the series with his free reading.

ot long ago, Mohawk Towpath Scenic Byway Coalition officials realized the road stretched 26.2 miles, the same distance marathon runners cover. So they figured a walking marathon would be a good way to introduce people to the byway and all of the recreational and historical resources along its route.

The walk last year drew a nice crowd, but the distance proved a little daunting. Some people walked only halfway; others mixed and matched spots along the byway.

Perhaps, officials thought, an easier way to get people to see the whole route was to hold a "Bike the Byway" event. After months of planning, the bike ride kicks off on Saturday, Aug. 28, at 9 a.m. at the entrance to Colonie Town Park on Schermerhorn Road. There is no cost to take part, and bikers will actually cover about 36 miles since the ride is not just a straight shot along the byway's walking path.

"We're doing this to make people aware of the byway and the wonderful resources we have here, said John Scherer.

Scherer is more familiar with those resources than most, serving as Clifton Park's town historian. He's also the historian emeritus at the state museum, where he worked for more than 40 years. He also sits on the board of the byway, which was recognized as a state byway in 2003 and a federal byway in 2005.

Eric Hamilton, the byway commission's executive director, explained that those designations mean the byway has a unique story to tell. Made up of local, county, state and federal highways between Schenectady and Waterford, the route follows the Mohawk River and captures the importance of the water route to early settlers and travelers in this area.

For the Bike the Byway event, Scherer will illustrate that importance by speaking at several stops along the way - stops that he devised to best capture key points on the route.

"We couldn't stop at every place or we'd never get through," Scherer said with a laugh, adding that he tried to space out the stops, some of which will include refreshments.

Highlights include:

• The Rexford Aqueduct: Built in 1841 as part of the you get out of your car," Hamilton said. Erie Canal's enlargement, the acqueduct used to carry canal boats across the Mohawk River. In 1917, the Barge Canal replaced the Erie, and the old aqueduct was used as a bridge for cars before the present bridge was built in 1964.

 Vischer Ferry Nature and Historic Preserve: Created in 1977, the preserve covers 600 acres and contains remains of the Erie Canal, including an original lock and dry dock. It is part of the Vischer Ferry Historic District. The cast iron canal bridge at the preserve's entrance was designed and built by Squire Whipple, an 1830 Union College graduate.

 Crescent Park: The longest aqueduct on the Erie Canal, the Crescent Aqueduct carried the Erie Canal

into Saratoga County. It was 1,160 feet long and with 26 arches to support the towpath.

• Waterford Waterfront and Visitor Center: The center stands at the confluence of the Mohawk and Hudson rivers.

· Cohoes Falls: The recently opened overlook at Cohoes Falls lets visitors gets closer to the falls than ever. The overlook has "really developed into one of our defining parts of the byway," Hamilton said, adding that the City of Cohoes has done a "great job" trying to maintain the Erie Canal locks that remain throughout the city.

Although it's possible to drive the byway, both Hamilton and Scherer recommended people try biking the route or walking it when time allows.

"The neatest things are the things that you see when

When the men give tours of the byway, it's common for people to express surprise at its rich history.

"People will say, 'I've lived here all my life and never knew this was here," Hamilton said.

"They're just amazed that this history and these sites are so close to the Capital Region and they didn't even know about them," said Scherer, who added he likes connecting people to the region's past and giving them a "sense of belonging."

To take part in the Bike the Byway event, simply show up at Colonie Town Park with a bicycle by 9 a.m. Saturday. Riders are expected to travel at about 12 to 15 miles per hour, with everyone regrouping at each stop. A fifth anniversary



Stories a slam dunk

Clifton Park resident takes home national prize

When she saw three teenagers — one Jewish, another Hindu and the other Muslim — sitting in a storytelling circle laughing and joking about a "village of fools" in Israel, it left her awestruck, said Kate Dudding.

"I was so struck by that because for one reason. how many places in the world would you find a Jew, Hindu and Muslim sitting together as friends and sharing stories? Second, who would have imagined one path to world peace had to do with a village of fools," said Dudding, of Clifton Park.

Dudding has been a storyteller for 15 years now, giving up her job as a computer scientist with GE's Global Research Center to pursue a far freer yet equally intricate life as a teller of tales.

"I fell in love with the art form. I did a little of it, just mimicking other storyteller: I'd heard, and I realized if I didn't pursue it, I'd regret it the rest of my life," said Dudding, who was introduced to storytelling when her son was young at the New York State Museum.

Dudding used her storytelling prowess to win top prize in a Story. Slam at the 2010 National Storytelling Conference in Los Angeles in early August. Around 100 people attended the conference and 11 names were picked out of a hat for a chance to tell their stories at the

"For five years, teenagers from different faith communities have gotten together and learned how to tell stories from their own faith traditions," said Dudding. They're just teenagers, grouped together, talking, gesturing and clearly friends.'

Dudding said her experience with Children at the Well is an honor and has made a lasting impression.

"I really believe it is the path to world peace. Storytelling has been used in the reconciliation process in northern Ireland and South Africa for years. It's a very powerful tool that can bring people of diverse backgrounds together." said Dudding. "Once you've heard someone's story you can no longer hate them; you may not like them, but you can't hate them as the unknown other.",

She said she makes it a point to attend as many storytelling gatherings as possible.

'Since 2000, I've gone to every National Storytelling Conference there's been. I go to the New England Storytelling Conference every year and take weekend workshops with various storytellers,' said Dudding.

To make storytelling a life, Dudding has taken on the role of an organizer, running various programs for adults, families and schools, like a storytelling slam. Battaglino added that what he's done in creating high-scoring offenses is nothing innovative. "You



Only once did I see a quarterback taken in the top three overall (Peyton Manning), and that person was soundly mocked for doing so.

The truth is fantasy football team owners are still holding fast to the concept that a top-notch running back is more valuable than a top-notch quarterback - even though the NFL is transforming itself into a quarterback-driven league. In their minds, they'd rather have a tailback that gains 100 or more yards and scores a touchdown per game than have a quarterback who throws for 275 vards. two touchdowns and an interception per game.

Those kinds of running backs are becoming more rare every year, though. Many NFL teams utilize two or three

This is why I make the argument that it's better to draft a quarterback early on. Most starting quarterbacks don't have to share the field with another signal caller, so there are no split stats to worry about. The only thing you have to worry about is if you've drafted a quarterback who goes in the tank (i.e. Matt Hasselbeck, Alex Smith, Jay Cutler). Then, you might run into some problems.

Ultimately, most fantasy football team owners will stick with the concept of drafting a running back first and worry about a quarterback after that. I'm OK with it, as long as those owners are OK with fretting over every sub 100-yard performance their running backs put up this year because they're sharing carries with their real teams.
