



Professor: **'These aren't** kitchen sink chemicals'

Brother of Keenan Sanchez arrested following discovery of chemical cache


Police last week arrested the brother of a Delmar teen caught in an explosion a year ago for al-~ legedly storing harmful chemicals in the basement of his apartment complex.

Bethlehem police arrested Jason Sanchez, 24, Tuesday, Nov.

30, and charged him with reckless endangerment in the first degree, a felony, resisting arrest and obstructing governmental administration

in the second degree, both misdemeanors. Police allege Sanchez had chemicals including acetone, xylene, laboratory grade nitric acid, sulfuric acid, propane and butane, and also had "a commergrade vacuum chamber" in the basement. In arrest reports, police said the items "pose[d] a serious risk of death" to residents of the complex and emergency responders.



Police said this compression chamber was found in the basement of a Delmar apartment complex, along with chemicals that could be used to construct a bomb. Jason Sanchez, the brother of a Delmar teen caught in an explosion last winter, has been arrested in connection with the find.

Lafarge's health impact studied

Lafarge files environmental impact statement on plant modernization

A state Department of Health report on the Lafarge cement plant in Ravena has shed little light on whether that factory's emissions are having any effect on residents' health.

The report states that while the public could be exposed to chemicals from the plant by air and settled dust, health data collected in the ZIP codes around the plant "appear to be similar to rates across New York State." The plant has been in operation for almost 50 years.

The Community Advocates for Safe Emissions (CASE) group pressed the DOH for the study in 2009, but at the release of the findings said they were unhappy with the scope.

"I'm not sure that our questions are completely answered by what we have here," said CASE's Elyse Kunz, who noted the five ZIP codes covered by the study do not completely cover the area surrounding the

Albany County passes 2011 budget

Spares county nursing home, raises taxes 5 percent

After dragging County Executive Michael Breslin through the mud for wanting to close the Albany County Nursing Home and raise property taxes by 15 percent, the Albany County Legislature on Monday, Dec. 6. passed a 2011 budget that will spare the nursing home and raise taxes by 5 percent. With only two dissenting votes from Legislators Brian Scavo and William Hoblock, many of the remaining 36 legislators and members of the community congratulated and thanked Audit and Finance Chair Shawn Morse for his hard work on the budget.

We were looking at a living breathing document that will affect many people's lives," Morse said. "This is a very difficult budget, but I believe through our hard work

and a lot of effort through this legislature it was understood that there are people that will be affected and they need us to step up and be creative if figuring out ways to solve these problems."

In the legislators' budget, property taxes would only rise by 5 percent and it would keep the current nursing home opened until a new one is built. Morse said as his first year chairing the Audit and Finance Committee, it was certainly not a very enjoyable experience







Few complaints at Albany International over pat downs

While the news has run rampant with passenger complaints over new security measures brought on by the Transportation Security Administration, the agency claims the reports on the new procedures have not been accurate.

"We try to be sensitive to both children and, of course, the parents."

International spokesman Doug Myers said on Nov. 24, one of the busiest traveling days of the year due to the holiday, that there were no complaints coming from passengers. "Our average line today was 5-8 minutes," Myers said. "People were surprised they could walk right up to our check point," The airport reviews projected statistics of passenger loads and ticket loads and analyzes how much staff they will need for the day, said Myers. With the new security measures, he has advised that passengers arrive 90 minutes before the flight.



The media has blown this out of proportion to such a degree," said TSA spokeswoman Ann Davis. "Passengers are complimenting us and are happy with what we've been doing.'

Before boarding a plane, passengers must undergo a full body scan by using one of the Advanced Imaging Technology machines, or they can opt out and be administered a pat down, which TSA Administrator John Pistole has admitted is a more invasive than previous pat downs.

In Albany International Airport's case, since they do not have the AITs in place, if a passenger sets off an alarm when they go through a metal detector and the issue can't be resolved, they must then be administered a pat down. Albany

"It seems to have worked very well today," he said, adding that they will most likely follow the same procedures during the Christmas travelling period.

Davis said that while Albany International is "well suited" for the machines, she hasn't seen a plan for when they will be put. in place.

Stretching the evergreen to forever green

My wife is nuts.

This is what goes through my head every year we head to Jim Ely's tree farm out in Nassau to cut our own Christmas tree.

I don't see the difference in Christmas trees. Now, I'm not saying that I can't tell the difference between a Colorado Blue Spruce and a Scotch Pine (I can't, by the way), I'm saying that I don't see the difference between "great" Christmas trees and those that are just "good."

My wife can see that difference. If you give her about two-and-ahalf hours to look at every single tree on the farm, that is. Like I said, she's nuts.

We usually go late in the season, which doesn't help with the selection. Usually the farm's been pretty picked over by the time we get there, so if you think you want a tree but want to look around a bit more, etiquette dictates you mark the tree with a glove or mitten to let others know you're coming back.

But, because my wife, Jess, is nuts when it comes to Christmas trees, about an hour into our tree search, she's standing in her thermal underwear by her latest find. She has left in her wake a path of good-looking trees marked with mittens, boots, a hat, a scarf, her snow pants and one of my children.

she's considering, there are approximately two trees left on the 4-acre farm for other families to choose from: a scrawny, Charlie Brown Christmas tree that stands 3 feet tall and has a form of athlete's foot that up until then I was sure trees could not get, and a 7-foot, immaculate plastic tree — fully.decorated - that my wife has planted as a decov.

She calls us over to the one she's standing near — well, not the son she left at the Douglas fir a few rows over.

"What do you guys think?" she asks.

"I think it looks like every other tree on this farm," I say.

"Can I let go of this tree now?" yells my son. At least, I think it's my son. A few other families have taken my wife's lead and started using their kids as markers.

We decide on that tree and while my wife is gathering her clothing, Kevin, almost 8 years old, and I cut it down and start to carry it to the car. On the way there, we notice Nathan, our 3year-old, has a collection of new gloves.

those gloves?" asks Jess.

"The trees gave them to me." he says. We spend the next half hour trying to find the owners of the gloves in question and apologizing profusely to them if thèir trees have been taken.

We get the thing home and lay it on the kitchen floor so I can cut off another 3 or 4 inches of the stump. Jess goes into the other room to ready the ornaments. As I cut, our Golden Lab, Sophie, alternately fights and tries to mate with the tree. This causes my son Nathan to come to believe there is a squirrel in the tree that the dog is trying to get out. My other son, Kevin, starts shaking the tree a little to convince Nathan the "squirrel" is moving. Nathan then starts beating the tree with a broom, which scares the dog so much she pees on the floor and bolts out of the room, knocking Kevin over in the process.

'What are you people doing !?" my wife screams as she comes back into the kitchen.

The kids look around, scared to say the wrong thing.


There is something wrong with that dog," I finally say, and move to get the mop.

Putting the tree up is a twophase construction project. First comes the seating of the tree in the stand so that it at least looks straight. Everyone knows their role when we adjust the tree: I hold the tree with a pair of work

gloves; Jess stands in the kitchen, 20 feet away, so she can tell me when it's straight; and the kids are relegated to the couch, out of the way.

After about 30 minutes of needles scratching my arms to shreds and falling into my eye sockets, my wife has found what she believes is the perfect position for the tree. She then takes about five steps closer, changes her mind and] finagle the tree for another half hour.

Then we water it.

Now, there are many old wives tales as to what to put into the water in a Christmas tree base so that tree lives the longest I can tell you we've tried them all.

We've done water and lemon juice, water and vinegar, adding aspirin, adding sugar. We've rubbed the stump with molasses (I really don't know where we got that one from) and Jess has even stayed up late at night reading to the tree in order to give it a reason to live.

One year, we tried encasing the base of the tree in Vaseline to keep it from losing moisture. And while it did make a cool sucking noise when we took the dead stump out a few days later, it did not have the preserving effect we thought it would.

In recent years, I have found

that a mixture of ginger ale and white rum has been most successful --- not at preserving the tree, but rather at preserving my sanity as the dog and I drink it from the stand after everyone's fallen asleep.

While my wife is looking however, I add boiling water.

After that's done Jess emerges from the basement wearing a hardhat and carrying a set of blueprints. This is important. There is an order in the universe as to where a certain Christmas tree ornament should go. The store-bought silver bells cannot be higher or more prominent than the hand-blown glass ornament my Aunt Kathy got us for

our first Christmas as a married couple. The ornaments Kevin made from construction. paper cut outs of his hands, while cute, should not be higher than the wooden sled that has little wooden mittens with all of our names on it.

Like I said, nuts.

I give my wife a hard time about her Christmas tree antics, but the truth is that my mother was the same way when I was growing up, and my brother and I loved it.

We used to joke that my mother would put up her Christmas tree the Friday after Thanksgiving and not take it down until July, which is only a little bit of an embellishment. The latest the tree ever stayed up was Cinco de Mayo, at which point it had been decorated with Valentine's Day cards, St, Patrick's day shamrocks and, for some reason, an alarm clock, which I can only guess was put there to commemorate Daylight Savings Time.

I can see Jess being the same way as my mother, putting the Christmas tree up earlier and keeping it up longer. And that's fine, as long as we don't get to a point where we're putting up the new tree right next to the old one.



Local pol commissioned to U.S. Navy

Albany County Legislator and Colonie resident Carl Zeilman commissioned to U.S. Navy as a public information officer

While serving his county as an Albany County Legislator, Carl Zeilman will now also be serving his country as being commissioned in the public affairs community in the U.S. Navy Reserves.

Zeilman, 34, from Colonie⁴ was commissioned in August but was not called to drill until Nov. 3, the day after Election Day where he had served as spokesman for Republican Candidate for the 46th Senate District in New York State Bob Domenici. Zeilman said it was a two-year process where he had to get recommendations, submit writing samples, submit to a background check and have the Navy look through his educational experience.

"You sit before a board where you're either selected or denied," he said, adding that he appeared before captains and admirals for the interviewing process. "I was selected into a very small community, which is public affairs."

His friend, Michael DeMartino, a Lieutenant in the Navy based out of Rome and Colonie resident, suggested the position to him and Zeilman referred to him as his "big brother" throughout the process. He helped Zeilman in purchasing the right attire for the interview, helped purchasing the right equipment and helped him even with saluting correctly.

"Carl is a long time friend of mine and we came up in politics together," said DeMartino who currently works for the District Attorney's Association. "Politics aside, you tend to recognize people who are full of it and are self interested in their 'town careers as opposed to people who want to get out there and get in the fabric of society and be a public servant."

DeMartino said he learned Zeilman wanted to serve at a higher level when they got to talking about his father who served in the Navy during the Vietnam War. DeMartino said he knew the Navy

does direct commissioning with people who have skills already and don't need to be trained as a public information officer, just need to learn how to wear a uniform and how to march.

"Carl stands up straight and puts himself out there as someone who wants to help," he said. "I was more than happy to put my name on a letter of reference."

For his next training date, which he speculates will be in the spring or the summer, DeMartino said he will go through two weeks of programming where he will learn about the ins and outs of the U.S. Navy.

"Things like proper use of uniform, Navy jargon and rules and regulations," he said.

Zeilman said he will go through all the normal training besides boot camp, which DeMartino said he doesn't even ne ϵ d it.

"He's already self motivated," he said. "He just needs help in learning to become a naval officer, which he'll learn like introducing and duck to water."

Information such as Navy letter writing, now many squadrons make up an air wing and knowing who to salute "It's a great responsibility and I'm looking forward to doing it Being it's such a short time, I encourage people out there looking for something to give back to the community that this is a great way to do it."

and who salutes you, will be the types of things Zeilman will learn.

The position is an act of Congress and will be an eight-year term, said Zeilman, but he said this will have no interference with his position as an Albany County Legislator, which only meets once a month and has committee meetings at the end of the month.

His duties for the navy will be writing press releases, writing letters, maintaining the website and crafting news articles for papers and magazines, most of which can be done from home, even though he is based out of Norfolk, Va and attends Naval War College in Newport, R.I.

"There shouldn't be conflicts of interest or time conflicts," he said, adding that he has a certain amount of drills per year he must complete but said he could roll four into one week. "It's a little more flexible."

As a volunteer firefighter and a volunteer EMT, Zeilman said he is "giving back to the community at a

greater scale," and cited it as one of the main reasons he wanted to be a part of the Navy. Even though it is an eightyear term, he sees himself holding the position longer than that.

"I can see myself doing more than the allotted time," he said. "There's opportunities to travel around the world and there is a chance you might be called to active duty and put in harms-way, and that's all a part of it. This was my first opportunity at doing so and I was fortunate enough to be selected."

Zeilman admitted to being a little nervous when having to put on the uniform and having to make sure everything was being warn correctly, but now that the moment has passed, he's ready to jump into it.

"It's a great responsibility and I'm looking forward to doing it," he said. Being at such a short time, I encourage people out there looking for something to give back to the community that this is a great way to do it."



quantities of mistletoe. If you believe your pet has ingested any of the above plants, contact a veterinarian immediately.

Another area of concern around the holiday season is the potential for foreign body ingestion. Cats and kittens are attracted to tinsel and ribbons. Once ingested, the linear material can cause the intestines to bunch together and even perforate or rupture. Ornaments or small objects can also lead to intestinal obstruction if ingested. If you know that your pet has ingested a foreign object it is advised to seek veterinary assistance immediately. Symptoms consistent with obstruction include but are not limited to vomiting, lethargy and anorexia. As you decorate the tree or the rest of your home, make sure that ornaments and linear objects are out of your pet's reach. Electrical cords should also be carefully placed. Electrocution in pets can lead to painful burns around the mouth and throat, fluid in the lungs, cardiac arrhythmias and death.

While waiting for answers, support improvements

As Charles Wiff reports on page one, the issue of Lafarge's impact on the health of the people who work and live near the cement giant's Ravena plant is one that has yet to be fully settled.

A state Department of Health study collected data in the ZIP codes surrounding the plant, and the resulting report found that while the public is exposed to chemicals from the plant by way of air and settled dust, its health

is similar to statewide levels. Now, of course there are those who are unhappy with the methodology of the study



— saying the scope was too narrow, not including all of the surrounding communities — and they are right to be skeptical of its findings thus far (a second phase of the DOH study will focus on potential impact).

We at *The Spotlight* aren't saying we don't think the DOH study is adequate, we're saying the residents of Ravena, New Baltimore, Coeymans, Selkirk and the other communities near Lafarge are well within their rights to question any information given in regard to something that has potential health implications. This is not, however, a tacit endorsement for residents or groups like The Community Advocates for Safe Emissions or the Friends of Hudson to shop around for studies until they come up with results that confirm their preconceptions.

Hardly a concrete stance on our part, we know. So we will offer this:

. Regardless of the studies, their findings, the beliefs of the industry and the layman, we can support Lafarge's endeavors to improve their operation and its impact on the community. The Department of Environmental Conservation recently accepted the company's draft environmental impact statement for a modernization project, one that will change its production process and therefore its emissions. The cement maker wants to replace the current wet-kiln process with a dry one that promises to save energy and reduce many emissions.

The 90-day public comment period is now open on the project. Written comments can be submitted to the DEC at an informal public information session on Wednesday, Dec. 8, at RCS High School at 6 p.m.; at the legislative hearing on Jan. 20, 2011; hand-delivered or mailed to the DEC Region 4 office at 1130 North Westcott Road, Schenectady, NY 12306-2014; faxed to the DEC Region 4 office at 357-2460; or e-mailed to the DEC Region 4 office at r4dep@gw.dec.state.ny.us.

To some people this may seem like an ecological disaster or a crime against nature but in fact, the opposite is true. The flip side of the harvest is that more than 100 million trees are planted each year as potential Christmas trees. The net result is actually a gain of more than 50 million evergreen trees that would never have been planted if the Christmas tree market did not exist.

In New York alone there are more than 1,000 members of the state Christmas tree grower's association. Christmas trees are a wonderful example of a renewable resource that provides many environmental benefits. Don't feel guilty about cutting down or buying a pre-cut Christmas tree. It has been grown as a crop, just like a poinsettia, to delight your senses and help celebrate the holiday season.

Nobody feels guilty about



killing a potato when they orcer I States french fries at McDonald's and no one should feel guilty about illy for a buying a Christmas tree.


In Upstate New York it requires at least 8 to 12 years to grow a decent Christmas tree depending upon the species. During the growing period these trees provide oxygen, habitat for wildlife and preservation of open space as well as income for the rural landowners who raise them. The trees are a longterm agricultural commodity that benefits the local economy and sequesters significant amounts of carbon in the process. Visiting a local "choose and cuf" Christmas tree farm is also a great way to enjoy the outdoors for a family adventure.

We are lucky to have a wide variety of evergreen trees to choose from in this region. I seem to recall that only white or Norway spruce trees were available when I was a kid growing up in Jersey City, although at the time, I did not know the difference between a spruce and a fir or a pine. I do recall that the needles were sharppointed, short in length and they quickly dropped off the branches onto the tracks of my toy train set. This pretty much describes spruce trees, but freshly cut ones

will hold their needles for weeks indoors if kept well watered. Blue spruce trees are very beautiful with stiff branches that support lots of lights and ornaments but their pointed needles are not nice to touch.

Pine trees such as Scotch pine or Austrian pine, Red pine or White pine have the longest lasting needles. Like all pines their needles are arranged in bundles of two to five that are joined at the base. Pines may be cut as early as August and will still retrain their needles until after January or even later. Fit trees such as Douglas fir, white fir, Balsam fir, Fraser fir and noble fir are perhaps the most fragrant types with good needle retention and a wide range of needle lengths, and different shades of green.

Whatever type of tree you select, be sure to make a fresh cut on the base of it when you get it home and immediately place it in a pail of water. Cut of at least two inches from the bottom to allow for easier water uptake. A freshly cut tree may "drink" as much as a quart of water a day indoors. This insures that the tree will smell and feel nice as long as the holidays last and not present an undue fire hazard. After the holidays the tree can be recycled as an outdoor bird feeder. I will have more to say about this in a future column. Happy Holidays

Doctors will ring in **New Year with pay cut**

At the stroke of midnight on Dec. 31, doctors who treat Medicare patients are scheduled to absorb a 25 percent pay cut - a cut that threatens the ability of seniors to see their physicians and receive the care they need. It is up to Congress to stop this pay cut and ensure that doctors are not driven out of Medicare:

On behalf of the more than 2.3 million AARP members in New York State and all seniors who have earned their Medicare benefits by working hard and paying into the system, I am calling on Congress to take responsibility and act to ensure that older Americans have access to the doctors they trust.

AARP is not alone in believing that the Medicare payment system is broken and requires a permanent fix." But it isn't the flawed physician payment system that concerns so

many of our members here in New York and elsewhere. It is, rather, the prospect of suddenly being without a physician.

According to a recent AARP poll, over 80 percent of AARP members are concerned that a Medicare pay cut will threaten access to their doctors. As people age, they face increasing health issues so a trusted relationship with their physician becomes increasingly important. They are also less likely to be able to travel long distances for care.

As the New Year approaches, there is one resolution that Medicare patients would like to see made by Congress: 'honor the commitment to Medicare patients and the physicians who care for them.

The gap between the "haves" and the "have-nots" is growing increasingly vast, especially for low-income individuals and minorities where unemployment hits hardest.

Good-paying, familysustaining jobs are few and difficult to attain. The age-old tradition of trade apprenticeships as a pathway to earning a living wage still exists, but there are only limited openings, with tough entry criteria of skills, knowledge, math and experience requirements.

In 2008, the Building Bridges program was developed for lowincome and minority individuals to prepare for the apprenticeship application process at no cost to them. Created in partnership between The Capital Region Workforce Development Center and with direct input from the Building Trades Council, the outcomes have been remarkably good. Of those who have graduated, 99 percent have been minorities and the majority of them are in apprenticeships or on waiting lists to start one.

The content of the program includes construction math, safety training, work readiness training, reading comprehension and more. Hands-on experience is offered and on-going mentoring helps assist the participants through the process. The program has been so successful that the same model is being used in two other regions of the state.







as many legislators agreed that this year's budget was one of the hardest. He said that many seniors and people with fixed incomes making poverty level wages could not afford Breslin's budget.

The main topic of the evening was the nursing home, in regard to which the legislature passed a bill to issue a Certificate of Need to the State Department of Health with a vote of 36-2. Legislator Timothy D. Nichols said that through this budget

process it appeared that Breslin was doing " everything he could to make sure the facility was shut down.

"The executive is obsessed with closing the "And the realization came through when we saw his budget." .

Nichols referred to the vote on the Certificate of Need as a "referendum" on needing a new nursing home.

The budget drawn up and ultimately passed by the legislature seems much easier to swallow than the previous version of the 2011 plan proposed by the county executive, but before the vote, some legislators were wondering if the lawmakers' proposal will work anywhere but on paper.

Breslin in October nursing home," he said. released his executive budget for the coming year, which called for a 20 percent reduction of the county workforce on top of a 15 percent increase in the tax levy and a plan to sell the county nursing home.

> But the legislature's Audit and Finance Committee recently came up with a plan that restores many of those cuts — including keeping

the nursing home — and raises taxes by just 5 percent. The disparity between the two caused no small amount of friction between county leaders.

Morse, D-Cohoes, chairman of the Audit and Finance Committee, said the legislature was able to identify many revenue items that were not in the executive budget, as well as retool some programs to realize savings.

"I think our budget is really a sound budget, it's a budget the legislature should be proud of," he said in an interview before the vote. "We spent many months going through the budget, we spent much of our time trying to have budget management and the county executive's people respond to our questions and requests."

But days before the vote, Breslin was quick to take issue with many elements of the plan.

"I have serious concerns. regarding the budget course the Audit and Finance Committee has taken. The committee's proposed changes to the executive 2011 budget significantly overestimate revenues and savings and will not sustain critical County operations,' he wrote in a letter to Morse.

Popular model train exhibit returns, as well as a few 'favorite things'

n what has become a holiday staple in the Capital District, visitors come each year to the Schenectady Museum & Suits-Bueche Planetarium to see the model trains run. Volunteers from the Upstate Train Associates construct an elaborate 19-by-27 foot display of running O Gauge model trains. These are the trains most people know and love as the Lionel trains. show includes a live presentation about the winter night sky. This year, the Schenectady Museum will be sharing a


few of its staffers' favorite things with visitors.



Beebe said police haven't established a definite reason Sanchez allegedly had the materials, but did say they could collectively be used in bombmaking. He described them as outside the realm of common household products.

Associate Professor Paul Toscano, chair of the University at Albany Chemistry Department, upon examining the above list said, "These aren't kitchen sink chemicals, the ones I've seen. The only one that's moderately common is propane...the other things, they aren't particularly common.'

Toscano said a use for having those chemicals in one place didn't spring to mind, but he did say several were dangerous and unfit for storage in a residential setting.

Sanchez allegedly ignored several orders to evacuate the building when police arrived on Tuesday and tried to push past officers into the storage area. He allegedly resisted when police tried to put him in handcuffs.





past and present county employees enroll in a Medicare Advantage program for healthcare. Breslin's plan had proposed a hike in employee contributions to healthcare.

Some people are going to feel the pain a little more than others....but the majority of people are going to see a better

benefit, and the county is going to see savings upward of \$3 million," Morse said.

But the key difference. between the two plans is the nursing home. The Audit and Finance Committee wants to keep running the facility instead of selling it - which would eliminate many of the layoffs Breslin proposed --- and banks on a large intergovernmental aid transfer to make that plan feasible.

Breslin, on the other hand, said it's doubtful that aid money would ever come.

"This is unrealistic. We have received no indication from the state that Albany County will see any of this funding in 2011, particularly as the state grapples with its own looming budget deficit," Breslin said.

The legislature similarly sparred with Breslin last year over the nursing home and ended up passing a budget keeping it open, but not all legislators were happy with this year's plan - or rather, plans.

Legislator Richard Mendick. R-Selkirk, said in an interview with The Spotlight prior to the vote that he'd like to see a consensus on where the executive and the Legistlature stand.

The problem with the budget is you now have two conflicting sources of information, and they seem to be quite a distance apart," he said.

Mendick, who sits on the Audit and Finance Committee, also wondered if the new proposal might be too optimistic.

"It makes it difficult for me to accept the changes the majority have come up with, because they are hoping everything breaks our way...that may be a little too much wishful thinking," he said.

Mendick was among the 36 legislators to vote in favor of Morse's plan.

The Suburban Council boys basketball landscape has changed dramatically since February.

Many of last season's top players have moved on to college, leaving many of the league's coaches scrambling to fill holes in their line-ups. And in some cases, coaches are having to build new starting line-ups from scratch.

· Saturday's 88-82 overtime victory showed how far the University at Albany men's basketball team has come and how far Siena College has to go.

With its trio of Logan Aronhalt (24 points), Tim Ambrose (27 points) and Mike Black (16 points), UAlbany has three legitimate scorers on the floor at one time. That's something that the Great Danes lacked since the 2006-07 season - the second of UAlbany's two consecutive trips to the NCAA Tournament.

Aronhalt has been making his mark this season, averaging 20 points per game. But with all due respect to Aronhalt, it's Black that has made the difference for the Great Danes. When the sophomore guard was sidelined with an injury, UAlbany won one of its first five games. Since Black's return, the Great Danes have won three of their last four games and could have been 4-0 had they held on against Detroit one week earlier in



Meanwhile, Siena is still searching for an identity after seven games. Senior center Ryan Rossiter has been playing very well, averaging a double-double every game. But senior guard Clarence Jackson has shot the ball erratically, and neither O.D. Anosike nor Kyle Downey have played consistently well. Freshmen Rakeem Brookins and Trenity Burdine have shown promise, though, and their development could help the Saints turn things around once the MAAC season begins in earnest.

Bottom line: UAlbany looks more like a NCAA Tournament-caliber team than Siena at the moment. We'll have to see what both teams do in league play, but I like the Great Danes' chances in an America East conference where several teams are in the process of rebuilding. The Saints have some work to do if they have any hopes of contending in the MAAC.

· Saturday's game was the final scheduled meeting between UAlbany and Siena, though both schools are looking to extend the rivalry.

The sticking point, as always, is the fact that UAlbany can't get a true home game in the series. That's because its home, SEFCU Arena (less than 5.000 seats), is much smaller than Siena's home, the Times Union Center (more than 14,000 seats). And with nearly 11,000 people

Frankly, there is a way to give UAlbany something close to a true home game: Create a secondary court at the Times Union Center for the Great Danes. It doesn't have to be a second floor with UAlbany's purple-andgold color scheme - just add some floor tiles with the UAlbany logo on it to put in place of Siena's logo when the Great Danes are the home team. Do that and make more tickets available to UAlbany students and alumni, and the Great Danes get a home game against Siena.

(Side note: The added bonus is that UAlbany would be able to host bigger non-conference games at the Times Union Center. For instance, how about a game against Duke that didn't involve the Great Danes having to travel to Cameron Indoor Stadium and get harassed by the Cameron Crazies? No? Duke won't go for it? Oh well.)

If the Times Union Center can't accommodate that concept, UAlbany should bite the bullet and continue the series with Siena - especially since the Great Danes are back on even terms with the Saints on the court.
