



Greatest generation, meet next generation

Glenmont Elementary classes adopt 'grandparents' from Delmar Place

Students at Gelnmont Elementary School are forging connections with the past, and not through the pages of a history book.

Since last year, the school has welcomed residents of Delmar Place, an assisted-living community, into its classrooms to come speak to and interact with students. The program of adopting "grandparents" for classes, which Glenmont Principal Laura Heffernan described as an unqualified success, has benefits for all participants.

"It's a great chance for the senior citizens in the community to connect with the young people," Heffernan said. "They learn from each other. ...

The children get a history lesson, in a way."

Delmar Place residents first came to the school during Glenmont Elementary's Building Community Through Dance program last year. Seniors were invited in to talk with students about their own experiences with dance and what the trends were back in their day. The visit was such a success the school decided to invite Delmar Place back, and before long, the grandparents program was born.

Now, about once a month, about 10 seniors visit the school to sit down with classes K through 5. Though they try to visit the same classrooms, sometimes seniors have to skip a trip and kids get to interact with someone new. They spend an hour with the children playing games, doing activities or just talking.

Sometimes it's the grandparents who learn about what's new with kids. One class was showing

A Bethlehem Police officer on disability has filed a lawsuit against the town and against Police Chief Louis Corsi, in a move that could be part of an effort to get back on active duty.

Christopher Hughes filed the lawsuit through his attorney on Dec. 9... It seeks compensation for damages,

punitive damages against Corsi, as well as a clean record for Hughes that does not mention disciplinary charges that have been brought against him. The suit also asks that the department "fairly consider [Hughes] for positions for which he qualifies without retaliation," indicating Hughes may be trying to rejoin the force.

Hughes referred questions to his attorney, who had not returned calls as of press time.





Kilimanjaro quest ends

Delmar couple return safely from international expedition

A Delmar couple has just returned from a journey across the ocean that reached high into the thin air of Africa.

Dave and Linda Burtis spent several days on the side of Mount Kilimanjaro in Tanzania earlier this month. Though they did not make the final summit, they did raise thousands for Laureus Sport for Good Foundation of America, an organization that offers sporting opportunities to underprivileged youth.

Dec. 11 was the date the international expedition was to push to the summit, over 19,300 feet above sea level, but a number either forewent the summit attempt or turned back partway in.

The Burtises elected to stay at the final summit camp rather than set out with the other climbers. Summit attempts start at midnight, and climbers hike

all night so they can summit during daylight. After days of hiking in the rain and snow, they decided to rest instead.

It's a decision Dave Burtis does not regret after hearing about the final ascent from returning climbers.

They came back in the camp the next morning just exhausted, and for many of the them it was beyond exhaustion," he said "We're kind of slow, so it would have been really tough for us."



The expedition was beset 🍾 by rain and, at higher altitudes,

"It started raining the first day as we were partway into the hike, and it was raining when we got to the tent," Dave Burtis said. "That just went on for three or four days, there was literally no sun.

The entire party had to take precautions to stave off altitude sickness, including drinking



The skinny on reverse mortgages

For some seniors, reverse mortgages offer a way to unlock equity

Many seniors (and their adult children) are hearing about reverse mortgages from sources ranging from AARP and the media to lenders and financial brokers.

Recent headlines have touted the fact that numerous banks. are waiving or reducing fees on their reverse mortgage products. And bankers point to thousands of seniors who have smartly managed reverse mortgages to remodel homes or help grandchildren with college. That's certainly good news. Mixed with the good news, though, are comments by the National Consumer Law Center saying some brokers have over-hyped the benefits of reverse mortgages, calling the loans "free money" and failing to disclose the associated fees

or accurately describing the -should determine their goals terms of such loans.

To make sense of it all, let's start with the facts: There are a variety of reverse mortgages. But the most popular is known as a Home Equity Conversion Mortgage, or HECM. Simply, it's a loan that homeowners age 62 and older can use to turn part of the equity in their home into tax-free funds. During 2009, the U.S. Department of Housing and Urban Development calculates that lenders wrote 114,000 HECMs nationwide.

"The HECM is the federally insured reverse mortgage product, and the percentage growth of these loans has been high since

a traditional mortgage, a reverse mortgage doesn't require that homeowners have a minimum income level or credit rating to qualify. That's because the customer doesn't make

loan payments to the bank. The loan needn't be repaid until the homeowner sells the home, changes his or her primary residence for more than 12 months, or dies, in which case the estate or executor must pay off the loan.

To combat misunderstandings about reverse mortgages, HUD requires everyone who qualifies for a federally insured HECM to first receive counseling from a housing counseling agency.

"Every loan has a story behind it," added Bell. "Some people turn to reverse mortgages because they have a healthcare issue that's not covered by insurance. . Some just want money to travel and visit their

family more frequently."

Critics suggest other ways to unlock the cash from a senior's home. For instance, a senior could refinance an existing mortgage, apply for a traditional home equity loan or sell their property. But selling a home when and for the price you want, even in a market as relatively stable as Upstate New York, comes with its own challenges.

To determine if a reverse mortgage is right for you (or a parent age 62 or older), educate yourself and define your financial goals. Stick to a single financial goal; it keeps your loan-shopping manageable. If you're helping a senior make this decision, find a government-approved, reverse-mortgage counselor in your area at www.hud.gov. Counselors' fees range from free to no more than \$125. Finally, choose a lender who will educate you, not someone who just wants to write a loan.

He added he's confident the Glenmont restaurant will flourish.


"It's a great area,' he said. "A lot of our customers from Schenectady live over there."

My dog was recently diagnosed with Cushing's disease, what does that mean?

Cushing's disease consists of a series of symptoms which result from the body being exposed to excess levels of cortisol and other related hormones. The adrenal glands secrete these hormones in times of stress. These hormones mobilize sugar and tat and change the metabolic rate. When cortisol levels decline in the blood, the pituitary gland at the base of the brain secrets a hormone called ACTH, which in turn signals to the adrenal glands to release cortisol. Cushing's disease results when there is an abnormality in this pathway. A large majority of Cushing's disease cases (85%) result when there is a benign tumor in the p tuitary gland. The turnor is usually very small and does not cause any additional problems other than excess cortisol production. The other two common causes of Cushing's disease result from a tumor in the adrenal gland or excess glucocorticoid (steroid) use.

tt is much more common for dogs to develop Cushing's disease than cats. The most common signs demonstrated by dogs include increased thirst and urination, increased appetite, the development of a pot bellied stature, increased risk of infection and other skin problems such as hair loss, blackheads and the deposition of calcium in the skin (calcinosis cutis).

If your veterinarian suspects that your dog has Cushing's disease he/she will perform specific blood tests. Once it is determined that your pet has Cushing's disease your veterinarian will discuss available treatment options with you.

The danger of loaded allegations

That last part is a bit hard to print, as some of our readers will no doubt find it a bit hard to read. We understand that some readers may lend a credibility to the allegation because they see it in print, some may use the allegations to confirm a bias they may have against the police department and some may see the allegations and immediately dismiss them as

Needless to say, we don't offer this information lightly.

Spotlight reporter Charles Wiff met with the claimant on two separate occasions, in addition to numerous telephone interviews and e-mail exchanges over the course of a few months. The Spotlight has also obtained the claimant's notarized statement in which he alleges. he was sodomized.

Let's be perfectly clear: The Spotlight is not insinuating that this allegation is legitimate in any fashion simply because we have been thorough in investigating its circumstances or are reporting it. We bring this information to you, our readers, because it is the town's business and, thusly, your business.

Leandra's Law: one year later

New York drivers passed a noteworthy milestone on Dec. 18, which marked one year since the first phase of the much-publicized Leandra's Law went into effect. How significant the milestone is will be determined years from now after much analysis and number crunching, but early indications are that toughening state DWI penalties had a positive effect on the number of New Yorkers who drove impaired during

the past year.

According to statistics compiled by the New York State Division of Criminal Justice Services, there was a significant decrease in DWI arrests in the year after Leandra's Law took effect. It should be noted the comparison is not precise because the DCJS compared the one-year period ending in December 2009 (56,937 arrests) to the 11-month period ending in November 2010 (47,011). A projection based on those figures would equate to nearly 6,000 fewer DWIs over the course of a year, so the drop-off of mandatory. remains substantial regardless The nature of the previous of the exact totals.

There is much to consider when analyzing preand post-Leandra's Law data. Facts and figures, numerical and intangible, may glean an answer eventually, but we will not know the precise effect for quite some time.

DWI involving children, a system is in place for yearto-year analysis. One thing we know for sure is that 653 drivers were charged with DWI under Leandra's Law during an 11-month period ending in

November 2010. This time next year we'll be able to examine data from the preceding 11 months and the first reliable analysis will be possible.

There are a number of additional factors that make any telling determination impossible at this stage. Since Leandra's Law was designed for the specific intent of limiting DWI's involving children, any effect the law has had on drunk driving in general could be considered residual. The law certainly made headlines, which may have had an effect on the collective consciousness of drivers, especially after the second phase of Leandra's Law went into effect in August, and required all drivers convicted of misdemeanor or felony DWI to have a breathalyzerstyle device installed on their

Cautious optimism sounds about right this early in'the game. Encouraging numbers do not necessarily need an explanation to be encouraging. But let's hold off on talking about cause and effect in factual terms. Wait a few years. See if children and DWI become less intertwined. Then we can crunch numbers and determine whether Leandra's Law was a colossal success or if the reality is something a bit more sobering.

was drunk at the time, recently pleaded guilty to manslaughter and more than a dozen other charges and was sentenced to 4 to 12 years in prison. The resulting law made it an automatic felony to drive drunk with a passenger under the age of 16. Previously, driving drunk with a child passenger could result in a misdemeanor charge of endangering the welfare of the child, but the charge was at the discretion of the police rather than being mandatory.

law is precisely why it is too early to say what effect Leandra's Law has had. Since the endangering charge was discretionary under the old law, there is no way to confirm how many times children were actually in the vehicle during DWI arrests. For every endangering charge handed' out there may have been a dozen other DWI-only charges to drivers who had children in the car. We simply do not know, so a direct comparison between then and now is not available.

Officials talk Medicare changes

'Doughnut hole' addressed

The open enrollment period for Medicare, which. ends Dec. 31, along with questions about coverage were discussed at the Scotia-Glenville Senior Center on Friday, Dec. 10. The talk was lead by Region II Director for the U.S. Department of Health and Human Services Dr. Iamie Torres. Also in attendance were Representative Paul Tonko, D-Amsterdam, and Chairwoman of the Schenectady County Legislature Susan Savage, D-Niskayuna.

"This is the time that you can check your plan," said Torres. "This is the time to find out if your plan still meets your requirements and your needs.'

He encouraged people to make the open enrollment period a "family affair" to discuss what options would be the best. If someone's medication has changed or he or she has developed a new disease, he said, there might be a plan to better suit those needs.

Seniors in attendance also wanted to know a little more about the elusive "doughnut hole," a gap in enprescription medication coverage; that lawmakers i have made steps to address.

some Seniors who reach the doughnut hole, which is the point where Medicare nь coverage has reached a cap, will receive a \$250 check, and beginning in January, seniors will be able to buy brand-name medication at 50 percent off while in the coverage gap.

"Slowly they will start closing [the doughnut hole] by having discounted medication, and that is how it will be closed in the next 10 years," said Torres.

Torres also warned

seniors about scams that ... their health status is." involve being contacted to provide information to receive their check because if someone reaches the doughnut hole, the check will be mailed to them automatically.

"The federal government never asks you for your Medicare number or Social Security number -that is as private as your credit card information — make sure you don't give it to anyone,' said Torres.

An important element " reason for Torres' visit was to discuss changes prought. by the Patient Protection and Affordable Health that sure that Medicare is here passed in March.

"The matter that the Patient Bill of Rights was passed in September of this year as part of the Affordable Health Care Act is historic, because now, for the first time in the history of our nation, children can no longer be denied coverage because of a preexisting condition," said Torres. "We can guarantee that every child below the age of 19 can get coverage no matter what

People will also have the right to go to the emergency room of their choice, even if it is out of the person's network.

With the national push toward reforming health care, Medicare has seen positive changes, said . 20 ** Torres.

"Not only are your benefits going to stay, but they have been strengthened," said Torres to seniors in attendance about Medicare. "The Medicare Trust Fund has also been extended (until 2029), so we want to make generation."

Medicare recipients will te able to get preventative care for free too, which Le said will also help keep cown costs through regular check-ups with doctors' and promoting healthy Lifestyles.

"Important changes are already taking place and changes that really many of us have been fighting for years," said Torres.





Varied past makes man a driving force

Ted Thompson has a doctorate in 4 geography, but what really moves him has four wheels (or more)

In his younger days, Ted Thompsor spent time with the Peace Ccrps in Ethiopia, earned a doctorate in geography from Syracuse University, and worked with the State Department of Transportation, so one could understand if he wanted to spend his retirement years taking it

But Thompson is happiest when he's on the move. The 70-vearold drives rental cars and makes deliveries several days a week, despite an impressive resume.

Thompson, however, is humble about his achievements, and he wouldn't be too upset if there wasn't the prefix "Dr." before his name.

"A Ph.D or a doctorate is a big deal at the secondary level, at a high school level. At the university level, everyone's got a Ph.D," he said. "The Ph.D is your union ticket to teach at the college level."

But instead fof teaching, upon graduation Thompson, of Niskayuna, decided to enter the school

transportation business in Western New York. He spent a year ir. Jordan-Elbridge as a supervisor and five years in Liverpool as a school dispatcher before heading to DCT.

The transportation industry has a ways held a deep sway over him, and he has driven everything from tractor-trailers to taxi cabs.

Thompson held three

different jobs with DOT, first dealing with bus transportation for four years, then being part of a strategic planning unit for five years, and for the last 14 years working in the Region 1 office in Schenectady:

"Absolutely great job," he said. "Basically, if you . look at it really crudely, at all over the state. in the regional office, in the winter time they plow snow and ice, and in the summer time they take care of roads and bridges, I didn't do any of that. I was in a planning unit, and basically what happened was if something came up with trucks, buses, planes, trains, park and ride lots, I could take care of it."

He said that while his job dutes were very broad, he was able to establish a lot of contacts and act as a salesman, adding that his success in the position relied on his relationship with people out on the job.

Region 1 covered eight different counties, which has nearly 300 railroad crossings, according to Thompson. His job was to annually fund repairs to the crossings, which led to one of the more enjoyable jobs he can recall that took him

. The federal government has an inventory of every railroad crossings across the country, including private crossings, which travel from field to field of cifferent farms. There are even some crossings that the federal government is not entirely sure whether they still exist, some of them being along the shore of various bodies of water.




over driveways and farm paths," he said, "It was the kind of thing where it's easier to say I'm sorry than ask permission. I just kept driving until somebody said something."

Bionic fingers open a new world to area teen

Lake George girl among early recipients of prosthetic

Paige Edwards, 14, was born with what her prosthetic doctor calls "remnant digits" on her right hand. That means her palm is intact but the fingers are too small to grasp most things a typical teenage girl can.


Edwards' difference has never gotten her down, though. In fact, she's molded a remarkably ordinary routine for herself, made even easier with her new ProDigits prosthetic hand by TouchBionics.

"It helps me do stuff I've never been able to do before. The first day I had it we went on a field trip and my friend had a water bottle. All I did was practice holding and opening it. A big thing for me is doing stuff so simple like everyone else," said Edwards, of Lake George.

Edwards recently attended her last fitting at Prosthetic and Orthotic Associates in Middletown, so all that's left to complete her bionic transformation is to get fitted for LivingSkin, a silicone material that looks realistic and covers the otherwise mechanicallooking fingers. Edwards said sensors pick up on what her smaller fingers or hand is trying to do, so if she pinches, the prosthetic hand pinches. If she gives a "thumbs up," the fingers do, too.

While having a fully functional right hand is exciting and convenient, Edwards said she made adjustments before her bionic fingers came into the picture.

"I've had it since I was born, so I adapted to everything. I was supposed to be right-handed but had to be left-handed. A lot of active stuff I used my wrist for, like monkey bars, I use my wrists. I do have some motion so I can grab something little," said

Edwards. "Some things were harder to accept than others, but I just got used to it, I guess."

She got so used to it that she said her friends often forget she's any different than them.

"My friends will be talking to me and I'll have an ice cream cone in one hand and they'll ask me to hold theirs for a second ... and then they feel bad because they forgot [I can't]," said Edwards. I don't ever

it was something negative in my life. I always made it something positive."

Edwards first saw ProDigits on "The Today Show" and quickly urged her mother to look into it. Edwards' mom found the Hudson Valley practice that could fit her with ProDigits of her own.

This particular form of electronic 'bionic' prosthesis for a finger are really relatively brand new and have only been available to the world remember a time where community for one year



this month. Prior to that, for something like this young woman, there really was nothing available to allow her to be able to pick up an apple or orange; not technically small enough to actually bend and extend like fingers do," said Tom Passero, her prosthetic doctor. "She's

one of the first 150 people in the world getting this technology and the first in the Hudson Valley."

Passero's company has been involved — accidently he said — since the very first whispers of ProDigits began circulating throughout a global

clinical team around two years ago. The prosthetic fingers were developed by engineers and clinicians in Scotland at a company called TouchBionics, which introduced the first bionic hand, a precursor to ProDigits. What TouchBionics didn't have, though, was a covering that looked like real skin. Passero did, having developed the product LivingSkin himself, so the companies merged, making Prosthetic and Orthotic Associates one of a few dozen in the world that knows how to fit for bionic fingers.

Besides convenience, ProDigits will cut down on health risks Edwards could have faced.

"Someone who uses their one hand all the time for opening and closing and grasping, is at risk of overuse or repetitive stress injury .. these will enable her hold objects in both hands and decrease with stress and strain on her natural hand that she's been using almost exclusively for 14 years. That's roughly 28 years of use on knuckles.

ProDigits only at school, except during gym, and then takes it off at home. She's looking forward to doing a few new things.

"One thing was cutting my meat; I always have my parents cut my meat for me. Another thing was being able to do two things at once, like use a hairdryer and hairbrush. I couldn't do that before,", said Edwards.

She used to get questions like "Does it hurt?" from curious classmates, but not anymore.

"Now after everyone has seen it, they're like 'Oh my God, that's awesome," said Edwards.

Local woman launches weekly parenting show

'Parentology' premieres on the CW

Paula Gretzinger knows that parenting is a non-stop job.

"It deals with everything. Usually people think when you talk about parenting it's only newborn to 2 or 3 years old, but it's also teens and beyond," said Gretzinger.

Gretzinger, of Clifton Park, is referring to her new television show — a mix of reality series, lives guests and pre-produced stories - that premiered on the local CW affiliate Sunday, Dec.5. "Parentology" is a survival guide to parenting, packed into a weekly half-hour show, and will touch on topics like nutrition, family profiles, activities, juggling kids and work, and anything else that can help make the busiest caretaker's life a little easier.

"I wanted to have a show that targets everybody: moms, dads, grandparents. Some of my guests will be teens and every week I'll profile a different family. I have experts, local doctors, local parenting experts, nutritionists and fitness experts," said Gretzinger.

The first show, which aired at its weekly time of Sunday at 8:30 a.m., featured a stay-at-home mom with five kids, a stay-athome dad with two kids and a single working mom. The three very different families discussed whether or not parenting was a difficult job.

"A single mom has a different perspective compared to a stay at home dad. He thought it was very difficult, and the single working mom said 'No way," said Gretzinger.

Offering perspectives and a platform to share parenting tips, challenges and stories, is what "Parentology" is all about. Gretzinger said she hopes the show comes off as authentic and real, because after all, she's no expert herself. She's just a mom.

"The reaction has been very positive ... one of the things a parent said was that she really liked the show because it showed real parents and it's not a show like 'The Nanny' that talks about making one family look bad," said Gretzinger. "Mine is about giving tips to other parents in similar situations; it's a feel good show because nobody really has the answers for parenting. You think you know everything but you don't."

Gretzinger got the idea to combine two things she's a natural at —television broadcasts and raising her three kids —on a family trip to Florida.

"I used to work two jobs and did so much, it was non stop ... in Florida with my family, we decided not to bring any cell phones or computers, just be disconnected from the world, and something hit me then where I said I want to do.

crossing and said, This is nuts." he said. "The only thing they do on that crossing is they launch boats right into the lake. [We] looked at that and said, "We should close this."

A subsequent hearing was held where they discovered that the launch was used for other areas on the lake only accessible by boat.

The traveling life has always been in Thompson's blood. In the 1960s, he joined the Peace Corps and headed to Asella, Ethiopia, earning a master's degree in secondary education from Cornell University. At the time, his mother, who was from a German family that grew up on coffee plantation in Guatemala, suggested he go see the world a bit before he went into the workforce.

"She probably meant, 'Go see your relatives in Germany," or something like that," he said. "I wanted to do something more, so I wanted to go into the Peace Corps. And Guatemala may have been an option for me in the Peace Corps. It didn't come up and they offered me the opportunity of being in Ethiopia and I said, 'All right, give it a shot."

His group was the third one to head over to Ethiopia from the Peace Corps. He went through three weeks of training at UCLA where he learned about the language, culture and health. When finally arriving in Ethiopia, his group met with three other volunteers who were there from the previous trip.

The school in the area. where he taught was wellestablished, he said, and the buildings were made from what he called "solid masonry" not mud.

Thompson taught the children history and geography, which allowed him to travel around the country and learn about the actual landscape. And he did just that, doing an entire circle around the country in one of his extensive trips.

At first, he traveled the country with his Peace Corps group, but he eventually decided to do something different. Something he said he would disown his son, Ian, for doing. He began traveling the country by himself.

By train, by bus, by taxi and even through hitch-hiking, he traveled throughout the country. Even while he was doing this, he didn't think it was the greatest of ideas.

"I'm by myself and I'm thinking, What am I doing?" he said. "Well I get into town and some friendly people come up to me and say, "You know, white people aren't really liked around here.'

The area he was in, Mozambique or Zambia, was a hotspot for training freedom fighters, and they were trying to keep the area quiet and keep white people out of town. Thompson said they drove him out of town to keep him out of the way, and he then got on a bus and headed up a little further.

He completed his crosscountry trip in a month, and would only stay in each city for a couple of days.

"I'm not the kind of guy that hangs out in one place for too long," he said.

With his penchant for driving. Thompson said he took whatever chance he could to drive the Peace Corps vehicles, which were Land Rovers or state trucks, where he would do the grocery shopping or locate new Peace Corps volunteers coming in.

"One of the things I'd like to find, and you can't, is a model of a long wheel based Land Rover," he said.

"You just can't."

Thompson began striking up conversations with the bus drivers around town who operated the 20-25 person mid-sized vans. While they would sometimes be driving Mercedes, his favorites were the Fiats.

"One time, coming back ... the guy said, 'Do you want to drive?"

Thompson's mustachioed face beamed with joy as he recalled the story.

"Do I wanna drive? Is the Pope Catholic?" he joked. 'So it was just the last few miles and it was kind of funny, I got in there, and some of the Ethiopians in there were like, What's going on?"

To this day, his passion lives on for various automobiles.

He has been married to his wife for 34 years. and his son Ian attended schools in the South Colonie School district. Ian has since graduated from the University of Florida and was about to move on to get his Ph.D in behavioral neuroscience, but decided to take a break while living in Buffalo, where he is now an EMT before attending the University of Buffalo medical school.

Now, Thompson drives rental cars for Hertz on Thursday afternoons and Sunday mornings, and on Monday, Tuesday, Wednesday and Friday he delivers foreign auto parts for BAP-Geon.

A PIG PHENOMENON

Local candy shop specializes in old Saratoga tradition

ike Fitzgerald loves everything about Christmas, which is lucky for him, since he gets a start on the holiday season in August.


Fitzgerald is the owner of Saratoga Sweets, the Halfmoon-based candy shop perhaps best known for producing the only traditional peppermint pigs in the world. Sporting a Santa hat everyday from August to New Year's Eve, with Christmas tunes blaring throughout the small kitchen called the "Pig Pen," he spends all day, every day, cooking up the sweet, minty and historical treats.

The best we can make in a day is 1,000, but those days are few and far between. If we can get 400 to 500, we're happy," said Fitzgerald, rapidly stirring a liquid version of the candy pig in a bright red tea kettle. "This year, we'll make 130,000 pigs."

Back in 1988, when Saratoga Sweets first opened in Saratoga Springs, the historical society approached the candy shop about making peppermint pigs. The tradition of passing one around after Christmas dinner and whacking it with a hammer after reflecting on something good that happened throughout the year had died with the city's last candy maker.

Fitzgerald made around 60 pigs that first year, which turned out to be far too little for the throngs of older Saratoga residents who showed up at the shop's doorstep on Christmas Eve.

"One older gentleman came in holding



a little hand, his grandson, and said the last time he'd gotten a pig he was the little hand," said Fitzgerald. "It was really rewarding and nice. With all due respect to Saratoga, my wife and I thought we were off to the races and every year we expand what we do."

Saratoga Sweets moved to its Halfmoon location on Route 9, and after creating molds specifically crafted to mirror the original peppermint pigs from the late 1800s, Fitzgerald found the perfect recipe and process to create the one-ofa-kind candy glass. The trick to making it shatter? A high sugar content. And, the ability to break it apart isn't the only thing that sets the pigs apart from other hard candy.

."We use peppermint oil. Most modern day candy is made with extracts and flavorings, which are radically less expensive. Most of my critics were people who had them as children and if I tried to slide by a lesser product, I would have heard about it, so I knew we had to make them with oil and I still make them with oil," said Fitzgerald.


The candy shop will go through two dozen large jugs of peppermint oil each season at \$750 apiece. Opting Pig Page 21








cut that cost by about 70 percent, but as Fitzgerald explained, it wouldn't be

'We don't scrimp. Our oil is made for us specifically, so from the way it's made to the way it tastes, you won't find another piece of peppermint candy made anywhere in the world that's like it," szid Fitzgerald.

Only a few people know how to make, an actual peppermint pig, but many contribute to its success by shrink wrapping it, packaging it and selling it, all on site. Fitzgerald said the homegrown feel of the whole operation is special, but so is the notion that he s creating one of the few Christmas traditions that originated in America.

'Santa Claus, Christmas trees, candy canes, it's all great, but the origins are in Europe. Peppermint pigs were never made in Europe, only here in



Saratoga Courty, so it's nice we've been able to revive it," said Fitzgerald. One Christmas night, there could be 100,000 pigs shattered all over. I make a joke with the kids that if they listen real hard, around 5 p.m. they'll hear it."

The pigs are sold in three sizes: small, medium and large. The medium size is the most popular and comes with a soft bag and miniature hammer for \$13.95. Saratoga Sweets also sells Pig Poop, Pig Puddle and Pigsy Dust, because, as Fitzgerald pointed out, accidents happen.

We basically sell everything. When they

break we sell the pieces as Pig Poop. Pig Puddle. is mixed with white chocolate and Pigsy Dust is very fine and can be sprinkled on cupcakes or hot cocoa," said Fitzgerald.

The peppermint pig is undoubtedly the most sought after holiday product the store sells, but almond butter crunch is a close second, and this year it will cook up 150,000 pounds of it.





The suit accuses the department, and Corsi specifically, of retaliating against Hughes for his involvement in the police union and for going to town administration and the press with allegations Corsi had uttered a racial slur on a taped phone conversation from his office.

That tape was later found, and Corsi was issued a 10-day suspension without pay.

Town Attorney James Potter said the case has been passed on to the town's insurance carrier, and added the department took disciplinary actions on substantiated issues.

"Based on everything we have seen, the police department took action for proper reasons," he said.

Man sues town for \$75 million

The town is also the target in another lawsuit filed by a Selkirk resident. John A. Robinson filed the suit in May, alleging two Bethlehem police officers falsely arrested and beat him. It also claims the officers sodomized Robinson with a nightstick.

John Bailey, an attorney at the firm representing the town in the case, said the allegations set forth in the lawsuit are unfounded.

"Needless to say, we emphatically - and I do mean emphatically - deny these accusations," he said. "The chief and his command staff are first-rate people. If anything remotely like this ever happened, the officers involved would be disciplined in a minute over this."

A police department representative said BPD officers are issued collapsing batons, and referred all other questions to attorneys.

The suit says the incident occurred in May of 2008, when officers Chad Rice and Michael-Whiteley arrested Robinson on charges he approached two teenage girls walking on the side of the road and offered them money to let him sniff their feet. Röbinson signed a statement admitting to the incident, but he now says it was coerced through violence.

In an interview with-The Spotlight, Robinson denied the foot-sniffing incident. He said the police fabricated the charges to discredit and embarrass him, and to intimidate him to drop a wrongful termination lawsuit he had against a heavy equipment repair shop in town. That lawsuit was eventually settled for \$10,000. The business, Robert H. Finke and Sons, of Selkirk, has done business with the town before.

The case against Robinson, which includes charges of endangering the welfare of a child and harassment, has been transferred to the Town of Colonie, where Robinson is scheduled to appear later this month.

Potter said the police department has conducted an investigation into the suit's the claims, but declined to go into specifics

'If the claims in the complaint were true, they would be very disturbing. However, anybody can make allegations,' Potter said. "Detectives Rice and Whitely have excellent records with the department, and it's inconceivable they would do something like this. The allegations in the complaint seem preposterous." - 1713

"Robinson's arrest records include statements; from the girls who made the complaints. Robinson was also arrested by Troy police in 2002 for allegedly menacing people from his car, charges he said were filed due to mistaken identity.

Robinson was arrested on several occasions in the weeks following his arrest by Bethlehem police for allegedly missing court dates, violating court orders and for a similar incident in the Town of Coeymans.

The lawsuit alleges that on one occasion, Christopher Hughes stuck his stockinged feet in Robinson's face while he was awaiting arraignment at the Bethlehem police station.

Hughes declined to speak on those accusations and is being represented by the same lawyer as the rest of the defendants.

Robinson is representing himself. He claims the incident caused damage to his spine and ultimately paralyzed him. He's seeking more than \$75 million in damages.

In a lengthy notarized statementabout the incident, Robinson said he had been paralyzed from the waist down in a 1995 automobile accident and underwent physical therapy. He claims he was fired from his job at Adirondack Trailways after the May 2008 arrest.

The lawsuit is still in early stages and before a federal district court. Robinson is seeking a jury trial.

Plotter Kill gains ground

County land purchase paves way for **Long Path trail**

Schenectady County officials announced the purchase of an additional 12 acres at the countyowned Plotter Kill Preserve in Rotterdam, which brings the total size of the area to 645 acres. The county paid \$50,400 for the land, but the purchase won't cost taxpayers anything. Funding was provided by a federal recreational trails grant the county received from the state Office of Parks, Recreation and Historic Preservation totaling \$75,840.

"Preserving open space and adding to our parks and nature areas is a top priority for the County Legislature,' said Susan Savage, D-Niskayuna, chairwoman of the Schenectady County Legislature. "This purchase will increase access to our beautiful trail system for all county residents at no cost to taxpayers while improving the safety of this trail.'

County officials plan to construct a new trailhead and a half-mile trail, which will tie into the current trails at the preserve. The land acquisition will provide a much-needed access point at the lower end of the preserve and allow the Long Path trail to access 2.5 miles of the Plotterkill rather than using existing roadways. An additional entrance off Gregg Road will allow emergency personnel to have quicker access to the opposite end near the state Thruway. The original access point is located off Mariaville Road.

"It is an additional access point into the preserve and will help with any emergency personnel if there was a lost or injured hiker," said Joe McQueen, spokesman for the county.

The new land allows the preserve to become a part of the Long Path trail too, which starts in Fort Lee, N.J., and extends to John Boyd Thacher Park. Vincent J. Schaefer of the Mohawk Valley Hiking Club conceived the pathway more than 70 years ago. He based the Long Path off the

Long Trail in Vermont, which was the country's first long-distance hiking

"Ironically the Long Path trail was the vision of a Schenectadian," said McQueen. "I thought it was kind of ironic that he had the idea for the trail and it had never hit into Schenectady."

The Long Path will access 2.5 miles of the preserve for the trail rather than using nearby roadways. After a twoyear study conducted by the Trail Conference and the National Park Service, the Long Path is now being built following the original route envisioned by Schaefer. Future plans for the trail involve extending it to the Mohawk River and into the Adirondacks. One obstacle in building the trail is acquiring privately owned land so roadways are avoided.

The new park area is also located near the Great Flats Aquifer, which is a main water source for the county, said McQueen, so the purchase will help protect an important water source for county residents.







Not that Black is the second coming of Jamar Wilson, but he certainly has a deft scorer's touch (13.5 points per game) that gives UAlbany a third offensive weapon to go along with Logan Aronhalt (17.9 ppg) and Tim Ambrose (17.3 ppg).

I caught a little heat a couple of weeks ago for suggesting that the Great Danes are in better shape to make the NCAA Tournament than Siena. But when you consider how much better UAlbany has played since Black's return and how woefully thin the talent pool is around America East (name one good AE team other than Vermont at the moment), the Great Danes have a legitimate chance of challenging for the league title. Meanwhile, Siena (3-6 entering the Georgia Tech game) looks shaky at best as a contender in the Metro Atlantic Athletic Conference.

If UAlbany can pull off a worst-to-first turnaround this old hometown crowd. He has a new career path to year, though, it will likely be because of what Black can do for the Great Danes.

 Switching gears to the high school ranks, any lingering questions about the Shenendehowa girls basketball team were answered last Friday when the Plainswomen defeated Colonie 58-35 in a game that wasn't even as close as the final score indicated. The defending Section II Class AA champions built a 29-16 halftime lead and then put the game out of Colonie's reach with a 17-7 third quarter.

The way the Plainswomen did that was they made the Garnet Raiders a one-dimensional team. Forward Tehresa Coles got her points (14), but no one else on Colonie's roster could get in gear against Shen's tough

Shen may not be as balanced in the scoring department as it was last year (Emily Weber and Allie Setter have accounted for more than half of the total points the Plainswomen have scored through last Friday), but it's still coached well by Ken Strube, especially at the defensive end. And with wins over Colonie (3-1) and Shaker (3-1) already under their belts, the Plainswomen appear ready to take on any challenger.
