## Messina delivers State of Town

**Supervisor wants to move** standing studies and initiatives ahead

One year ago, Bethlehem Supervisor Sam Messina was standing before a packed Town Hall auditorium to deliver his vision for his first term in office. Last Wednesday, Jan. 5, at his second State of the Town address, he reflected on what has been done halfway through that term, what remains to be accomplished and how to best plot a course to the future.

He once again grasped the compass that sits in his office, the same one he referenced when he was sworn in to office. Like at his inauguration, Messina said the task ahead is one he will not tackle alone.

"The compass is still there. I use it as my guide," he said. "My responsibilities here are more to use the powers of the board of elected officials, staff and town volunteers to get where we need to go. The power is not in the supervisor."

After a busy year, Messina had plenty to talk about when it came to looking back at 2010, which saw the implementation of several long-discussed ideas, including the passage of a law mandating the release of Town Board meeting agenda attachments, ☐ **Town** *Page 21*

## A year-round window

**Art group installs mural** at Good Samaritan Home

Residents of the Good Samaritan Lutheran Home now have a window to all four seasons year round, with the installation of a mural in the dining room of the nursing home.

The mural, which is designed to look like a window facing out to a landscape of rolling hills, dotted with trees and buildings, is the product of months of work by Good Samaritan residents and the Capitolers volunteer art group.

Planning for the project started over a year ago. Good Samaritan Director of Recreation Therapy Sharon Rappaport brought the idea to Capitoler Tina Greenfield, who comes to the nursing home to hold a weekly art class.

"I kept looking at this wall, and I said to my-

self, this wall needs something, and that's how this all started," Rappaport said.

Greenfield obtained four, 4-by-4-foot planks for the mural. A committee of Capitolers worked out what the mural would look like. The four seasons was chosen as a theme not only because it offered a lot of possibilities, but because the four canvases made it a natural fit.

Good Samaritan residents painted the background of the mural during their weekly class with Greenfield before turning them over to the Capitolers, who added the details like trees and houses. Those elements were meticulously added over the course of 11 sessions, taking 250 volunteer hours, said Greenfield.

"I find that art is often solitary, but when the detail painters get together on a project, it's very collaborative," she said.

The painters chose landmarks from the surrounding community, working off of photographs, but also added their own personal

## Mercury levels high in Ravena subjects

No conclusions on source of metal, but researcher says fish unlikely

Blood and hair samples taken from Ravena residents in May of 2010 showed mercury levels well above the national average, and about 10 percent of those tested had amounts above safe federal guidelines.

That's the preliminary findings from a study conducted by the Harvard University School of Public Health, which studied samples from 172 people to test for heavy metal levels. On Thursday, Jan. 6, Harvard's Michael Bank went over the data with residents at the Ravena-Selkirk-Coeymans High School, located across the street from the Lafarge Cement plant. one of the highest emitters of mercury in the state.

Bank emphasized the study cannot identify the source of the mercury found, but he did say questionnaires filled out by participants indicate fish a common source of the metal — is probably not to blame.

"Some people who had high mercury were not high fish consumers [and vice versa], which is very interesting," Bank said. "This is something that needs to be followed up on."

Bank said his research shows 16 percent of mercury found in adult blood could be explained by fish consumption, and 50 percent of that found in the blood of children. The

## Scouts honored

Two local young men attain the highest rank in Boy Scouting

Two Colonie gentlemen have obtained the highest rank in the boy scouts and were honored last week at the Christ Our Light Catholic Church in front of their friends, family and their superiors.

Alex Mastromarchi, 18, and Nick Cicchinelli, 18, received their pins from their families with the badge of the Eagle Scout; a goal they said was a long and difficult journey to get to. It shows that the person has shown they are a valuable leader both within the organization and in the community.

"For me, it was the culmination of everything we've been working towards in the program," said Cicchinelli. "It was the coming together of all the experiences that we had as boy scouts and it makes you reflect on all the things you had to do and all the people that helped you."

The path to become an Eagle Scout means having go through the ranks of boy scout, first class, star scout and life scout. This also encompasses service hours and having to serve a leadership position to earn the next rank for a certain amount of time, which can average from four to six months.

Both Cicchinelli and Mastromarchi had to complete a project that would serve as a betterment to the community and be seen as an improvement, not something that would help just the troop itself. Mastromarchi said that it is very time consuming and that all of the details of the step by step instruction must be laid out all the way down to where bathrooms will be available for workers.

"It took me almost an entireyear," he said of his project to provide books for children at the Whitney M Young Health Center in Albany. "In order to get the project approved you have to do a write up and fill out a whole application for it. After all the paperwork is done. it takes time to everyone together to build it, get books collected and take them to the house."

His project was to provide books to children in lower income families or those without any insurance at all, which the hospital provides service to. A program is already in place and run by Liz Espinoza called the Reach Out and Read.

Mastromarchi helped in building two book shelves and put baskets in the shelves to be located in the main waiting area.

"There's never enough books," he said. 'There was also no place for them to read while they were

Mastromarchi said he enlisted the help of the Colonie High School Key Club, which he was president of when he attended, as they helped collect over 700 books. 150 of them were placed in the waiting room while the other 600 were given to the Reach Out and Read program.

Cicchinelli's project involved building park benches for the Colonie Town Veterans Memorial in the Crossings. After reading

articles about the need for benches in the park, he decided he would lend a hand in helping.

Both Curtis Lumber and Garden Concrete donated materials to Cicchinelli's project and with the help of Barbra Mahaney, formerly of the Colonie Youth Bureau, and the help of the 1022 Scout Troop, he was able to put together the benches and deliver them to the site at the Crossings.

"It took me about a year for the whole process," he said. "The physical building took the whole summer, about 160 hours. I started fund raising in the spring and early summer in 2009.'

Both said that the skills they have learned throughout their years of involvement with the boy scouts will help them immensely as they move forward in life. As they now have experience in leadership positions such as senior patrol leaders and assistant patrol. leaders, both positions you need to be elected to, has provided them the real world experience they'll need in life.

"The real world experience is you already have interview experience," said Mastromarchi. "Every time you go up a rank you have to go through a board review and have to answer yes or no question,"

Cicchinelli said he believes his experience in the boy scouts and becoming an eagle scout will help in job searching later in life and he said it is something that looks good on resumes. But not just because of the title, but because of the commitment and discipline involved in getting there.

"It is so much work and does take so much time," he said. "It speaks to your character and it's good to have something not a lot of people stay with."

Troop 1022 Committee Chairman Marty Berloff, who guides the committees and acts as the MC for the meetings, said both of the men were "extremely" qualified to earn the position of eagle scout as they both possess the qualities of being great leaders.

"With completely different personalities and completely different personal styles, both represent potentially outstanding leaders," he said. "It was neat to have the opportunity to watch these guys grow up."

## School district's community budget forum schedule set

Officials expect tough decisions as state aid dries up 🏸

The first Bethlehem Central School District's first community budget forum will be held later this month, signaling the start of the 2011-12 school year budget

The district has held the forums for the past few years. Administrators generally give a presentation on various parts of the budget then take questions

and suggestions from audience members. The meetings will be held in the middle school library, with the first of two sessions scheduled for Monday, Jan. 24, at 7 p.m.

The second session will be held on Feb. 7, and Superintendent Michael Tebbano is scheduled to present a budget proposal at a meeting of the Board of Education on Feb. 16.

That will be followed by a series of workshops when the school board will examine various departments and parts of the budget. The board is scheduled to adopt a budget on April 6, and the community will vote on May 5.

Like last year, administrators are anticipating plenty of difficult decisions in the coming months. It's likely state aid for schools will again decrease. BC received \$2.8 million less this year than it did in 2009-10. Simultaneously, health insurance costs and mandated pension contributions are expected to continue rising.

The district budget this year totals \$88.3 million.

The district said the ramifications of a property tax cap will also be carefully considered. Though a cap has been approached before by the legislature and failed to pass, there's renewed rhetoric about tax relief at the capitol, including from incoming Gov. Andrew Cuomo. The district realizes 63 percent of its revenue from tax collections.

## Vista project back on the radar

Shovels could go into ground this year

After many months of inaction, it looks like 2011 might be the year shovels go into the ground at the Vista Technology Campus.

That's according to BBL Construction Services, which wants to bring site plans for the first phase of construction on the massive project to the Town of Bethlehem later this month.

That phase would include construction

of Vista Boulevard — a long road into the heart of the development that would split off the lonely two-pronged roundabout on Route 85 — and the campus's first 40,000square-foot office building. Vista is cleared to have 1.4 million square feet of retail, commercial and professional space.

Jonathan deForest, vice president at BBL, at a recent Planning Board meeting declined to say who would be occupying the office building, but said there is significant interest in Vista and

there might be multiple takers.

We kind of languished in the last year and a half, partly because of the economy," deForest said. "We need to have curb and facade and have something for customers to see."

The project was last in front of the Planning Board in September of 2009.

DeForest said BBL and partner Columbia Development would like to begin construction in the spring. Providing a firm schedule to interested

tenants will be key in securing commitments to come to Vista.

DeForest declined to identify any potential Vista tenants, but he did say a grocery store has expressed interest in one large retail building.

"A lot of different vendors or operators have expressed interest,' he said. "The intention right now is it would be a grocery store."

A Price Chopper is located across the street from Vista as an anchor for a shopping plaza.

## Sage advice

"[I]t's time to organize the government— make it professional, make it efficient, make it effective. To undergo a comprehensive review lets eliminate transfer and consolidate the funds. I propose setting up SAGE, a spending in government efficiency commission, it would be styled like a Berger Commission where the commission would come up with a reorganization report that is submitted to the Legislature and the Legislature has 30 days to reject it otherwise it's passed. The charge to the commission would be operational improvements, metrics and targets; a reorganization plan due in 6 months; and it would consist of private sector experts who could come in and advise us on how to do it and incorporate members of the Legislature."

—Gov. Andrew Cuomo in his Jan. 5 State of the State Address

It's the right idea that has the possibility of going amiss if guided by the wrong reasons.

The public perception of New York's state workforce is arguably lower than a snake belly, and may be deservedly so on some levels. Non-government employees — Regular Joes, like you and me — run the risk of having a "throw the baby out with the bathwater" mentality. The Spending

Editorial

and Government Efficiency (SAGE) Commission, must take care to work with surgical precision.

Lumping the good state employees - and there are good ones, fel-

low Regular Joes — in with the bad and then making across-the-board cuts is the best way to ensure a similar problem in the workforce 10 or 20 years from now.

The SAGE Commission must realize that the culture is the problem, and that the culture is the result of weak leadership and management who, driven by the tenets of a unionized workforce, never bothered to differentiate the good employees from the bad.

Peter Casale, a public service professor at the Rockefeller College Graduate School of Public Affairs and Policy, said last month in the Times Union, "simply put, if the workforce doesn't feel valued, nothing else will change."

That notion, or a variation thereof, can be found in nearly all good management and human resources guides. And it's one that has been echoed by local politicians since Casale applied it to the state workforce an entity that most people feel functions in a reality far removed from our own. But the concept is as right on the money for state workers as it is for any employee, manager or business owner in the private sector.

This doesn't mean cuts aren't necessary, or that some morale boosting in the ranks of state workers will somehow turn the ship around and address the decades they've been vilified.

What it means is that the retention and recognition of hard-working, forward-thinking state workers is as vital to changing the culture in the public sector as is the removal of those workers who live up to their stereotype.

We would ask one more thing of the SAGE Commission: Whatever its recommendations may be, whatever plan it has for revitalizing the state workforce and making it a place Regular Joes don't look down upon stipulate that it's coupled with ethics reform for all of our public officials, so state workers can learn from example.

## **BBB** outlines top scams of 2010

The Better Business Bureau released a list of the top 10 scams, rip-offs and complaint types of 2010 for Upstate New York. Job hunters and those struggling to make money and get out of debt were common targets of fraudsters, hackers and deceptive businesses in this tough economy.

"Scammers had a field day even though the economy is showing signs of a mend, targeting struggling families who were looking for work and trying to make ends meet," said David Polino, Better Business Bureau president. "While some of the most popular scams are persistent problems that continue to plague consumers, some new additions to the list are signs of our tough economic times.

Following, in no particular order, is BBB's list of top scams and rip-offs that took advantage of consumers and small business owners in 2010:

- Job Hunter Scams Scams targeting job hunters vary and include attempts to gain access to personal information such as bank account or social security numbers and requirements to pay a fee in order to even be considered for the job. BBB issued alerts to warn against phony payment processing jobs and other online offers.
- Work from Home Schemes Some work from home schemes promise to train you, teach secrets to making money online, claims to make money assembling items at home or get paid to be a mystery shopper. Some victims even found that their opportunity to work from home was a job to fence stolen goods or launder money. The end result is that instead of getting paid, you can end up losing hundreds-if not thousands-of dollars
- Not So "Free" Trial Offers Misleading free trial offers online for diet supplements, penny auctions and money making schemes blanket the Internet resulting in thousands of complaints ever year. The free trial offers seem no-risk but complainants state they were repeatedly billed every month and found it extremely difficult to cancel.
- Checks in the Mail Spoof Scammers with the ability to create very real-looking counterfeit checks fooled recipients into believing checks are legitimate. When checks arrived in the consumers' name, many took them to the bank for deposit only to find out they now owed the cash instead of actually receiving it. BBB issued alerts to avoid being taken by the surprise cash from unknown sources. Sizable checks stating you have been left money, won a lottery, are eligible for a government grant or have landed a job as a mystery shopper - but had to pay any type of fee - scammed thousands.
- · Debt Relief and Settlement Services BBB warned consumers in 2010 to seriously consider third-party assistance for getting

out of debt. Relief and settlement companies often require upfront fees

and potentially leave the consumer drowning in even more debt. Complaints to BBB about debt relief and settlement services increased by approximately 30 percent in 2010 across the country, according to year-end estimates.

- Door-to-Door Home Repair/Roofers - BBB received complaints from consumers who answered a knock from a door-to-door salesman or itinerant worker who eventually failed to deliver on promises to do home repair, fix their roof or conduct other work to the home. Complaints to BBB about roofing companies across the country. increased by roughly 40 percent in 2010, according to tentative estimates, due in part to one company that solicited door-todoor nationwide, American Shingle, which received nearly 1,000 complaints after going bankrupt and not providing new roofs to angry customers.
- Identity Theft—There are any number of ways a person can become a victim of identity theft. Through low-tech theft, phishing emails, vishing phone calls, smishing text messages, or even through no fault of your own as the result of a corporate data breach, millions fall victim to identity theft every year.
- Advance Fee Loan Scams A perennial problem, advance fee loan scams prey on consumers and business owners who are struggling financially. Victims are told they qualify for large loans but must pay upfront fees-often more than a thousand dollars. The victim wires money to the scammers, but never receives the loan.
- Over-Payment Scams Over-payment scams typically target small business owners, landlords or individuals with rooms to rent and sellers on classifieds or sites like Craigslist. The scammers overpay the amount for the services or products and then ask the victim to wire the extra amount back to them or to another fraudulent entity. Ultimately though, the check is forged and the victim is out the money wired back to the scammers.
- Lottery and Sweepstakes Scams The victim-often a senior citizen - receives a letter in the mail or phone call from someone pretending to be with Reader's Digest, Publisher's Clearing House or a phony foreign lottery. The scammer claims that the victim has won millions but must first wire hundreds or even thousands of dollars back to the scammers to cover taxes or some other bogus fee. The victim wires the money, but the prize never arrives.

Consumers or small business owners victimized by a scam can contact their local BBB or file a complaint at bbb.org. BBB advised to always research a business with BBB before doing business, signing any contracts or handing over any money.



on January 6, 2011. The impact of this is that these products may not arrive until late January 2011." As you are probably aware, banks and post offices no longer distribute these forms; it has fallen to GPL and other libraries to do

Should you need extra copies of the forms you get from GPL, you'll need to use the pay copier to make them. Remember, you can always file online.

The Good News:

As of January 10, you can call the Library to make a Tax-Aide appointment to get assistance preparing and filing your 2010 tax return. Starting Saturday, February 5, 2011, and continuing through Monday, April 18, the allvolunteer AARP Tax-Aide Program will provide free tax preparation and e-filing on Mondays and Saturdays at the Library. You may make an appointment by calling the Library at 456-2400

Volunteers are trained and certified in cooperation with the IRS. They prepare personal Federal and New York State tax returns for taxpayers of all ages with low and moderate incomes.

Appointments are required; a separate appointment is required for each taxpayer. Bring a copy of last year's return and all 2010 W-2s, 1099 statements, the purchase date and cost basis for any investments you sold, and supporting documents if you plan to itemize deductions.

Tax-Aide volunteers cannot prepare returns with rental income or returns requiring Schedule C. If filing a joint return, both taxpayers need to be present except in cases of illness or infirmity.



Do I need to take special precautions with my dog during winter activities?

Excellent question. Dogs, just like humans, are susceptible to hypothermia when exposed to cold temperatures. Although hypothermia v develops after prolonged exposure to cold, it can a short time in indement weather. In mild cases, hypothermia creates discomfort. In severe cases, the end result can be death.

Signs of hypothermia include shivering, a change in behavior, lethargy, weakness, depression in respiratory and heart rates and, in the worst cases, unresponsiveness.

Frostbite is another common symptom accompanying hypothermia. The extremities of the body (tail, ear tips, feet) are the first parts affected. Typical signs of frostbite include blistening, color change or swelling. Some frostbite symptoms may not be evident until a few hours after initial insult. Many different salves are available to help protect the foot pads during the winter months.

When preparing your pet for transport to the veterinary hospital, be sure to try and warm them as best as possible with blankets and hot water bottles. Once you arrive at the hospital, your veterinarian will initiate further warming treatments and perform diagnostics. The most severe cases of hypothermia will require aggressive intravenous care and possibly oxygen therapy.

You can help prevent hypothermia by limiting your pets exposure to the cold and not leaving them outside without proper shelter. When identified early on, hypothermia carries a good prognosis.

## Website seeks to 'connect your world'

Founders hope community groups will use iZoca.com to get the word out

It all started during a long layover at the airport. Jeffrey Goronkin, with plenty of time on his hands, wished there was a way for him to connect with other people around him. That's when iZoca. com's "community pages" was born.

"We plan on focusing heavily on the Capital Region and from there, once we feel like we are firmly established, will branch out to other communities," said Goronkin, president and CEO of iZoca.com. "We're going to grow community to community."

IZoca.com is a group networking website launched in 2007 that "connects your world" by offering businesses and non-profit organizations a way to promote themselves in the geographic community they're active in. The new feature, community, in to provide hyperlocal pages, was launched on Tuesday, Ján. 4, and

takes that concept a step further by providing enhanced interaction between community members. That could mean discussions about local issues, calendar event postings, sharing photos and news.

"Nonprofit organizations can definitely benefit from something like this. They can talk about their mission, promote their fundraising efforts, post photos of events," said Goronkin.

Businesses too can use iZoca.com as another marketing tool and way to get their name and service out there.

"Businesses can use our website to create group. For example, a restaurant can post weekly specials and customers can have discussions about dishes they have or post photos of their restaurant in a community photo album, said Goronkin. "Whatever anybody does, whatever product or service they offer, can create a group and promote that."

IZoca.com partnered with a New York Citybased company Outside. news from various communities onto the site, including the latest news stories and blog posts by neighborhood, zip code or state.

Goronkin said he also hopes residents will catch on to iZoca.com and use it to have community forums, talking about "hot button issues" like politics or anything else that is important to them.

So far, Albany, Schenectady, Saratoga and Clifton Park have been "founded." When members "found" a community, they get a green "key to their community."

While the site is completely free for everyone to use, businesses can buy ads if they choose. Those ads are the site's primary funding source and Goronkin said in the future there may be additional features available for a small fee.

Norreida Reyes of Thinkwellspring, a ghost blogger company, was one of iZoca.com's first paid advertisers. She met Goronkin and Chief Marketing Officer Susan Bardack at a social media meet up.

"I see it as strengthening local communities and in

these hard times it's more important than ever that we're able to be closer to our neighbors," said Reyes. "Their model is the same kind of model we should be using in our everyday lives."

Reyes said iZoca.com's mission is something she felt comfortable and confident putting her support behind.

"Primarily, the founders Jeff and Susan have demonstrated a tremendous commitment and I have absolutely no doubt of their success," said Reyes. "When I'm advertising somewhere I want to go to a place I know is working hard to make themselves successful as well as myself. I know they're looking out for all of us as a team.'

The "tremendous commitment" that Reyes and other advertisers saw was how Goronkin and Bardack never gave up on iZoca.com, even when it seemed like there was no other choice.

"In 2009 it was so

difficult to raise money. A lot of people didn't quite understand [iZoca.com] when we first started out and when the economy started to tank, people weren't investing in startups," said Goronkin. "Susan and I created Buzz Media Solution, a public relations and business development company. We secured some clients and that helped to allow us to keep moving forward using funds we collected. We were committed from day one to making this work."

IZoca.com's foundation is currently built on groups that connect geographic community pages, "my world" membership pages and soon organization-based community pages for institutions. Throughout the new year, Goronkin is already looking to see how much more the site can expand.

"We want to further refine the website as it exists today. We want to make events searchable as well as discussions and photos by keyword,' said Goronkin. "Once everyone starts letting events known to the community we want to be able to filter them. We also want to provide companies even more exposure than just having a generic group on our site, so we envision having some type of service we provide for a small monthly fee.'

Even further down the line, iZoca.com will connect communities around the country, said Goronkin. But for now, it's all about promoting the site with the resources they have, so they can reach their expectations.

"We don't have funding to do broad marketing campaigns. We're doing grassroots where we reach out to chamber of commerces; meet with non-profit organizations and business, anything in the area that is community driven," said Goronkin.



## Niskayuna couple's chicks kicked from coop

Judge rules pet chickens in violation of town code

For a group of chickens in Niskayuna, a new home will need to be found as the coop was ruled to be in violation of the town

Judge Stephen Swinton Jr. ruled on Monday, Jan. 3, in Niskayuna Town Court that John Helm was violating sections 220-4 and 220-10D of the town code and fined Helm \$20 dollars for every day since the notice was issued in early June, which totals almost \$4,000. Swinton said if the chickens were removed from the property within 72 hours he would entertain a motion to reduce the fine. The Court could've fined. Helm \$500 for every day the chickens were on the property. property.

## Applying to college in a digital world

BC high's counseling center first area public school to go paperless

For high school students, the college application process is a long and taxing affair, as teens make a major life decision they've been preparing for much of their lives.

At Bethlehem Central High School, that harrowing trial has been a little bit easier this year on students, families and the staff at the school's counseling center. Beginning in 2010, most students used an Internet system called Naviance to do all of their application work electronically.

It's a monumental shift for counselors, who are used to wading through seas of school summaries, essays, letters of recommendation and transcripts.

Registrar Mary Dugas said she'd spend weeks buried in paperwork, but now does most of her work at a computer terminal.

"We literally would have somebody hired to stand at the photocopy machine" during the busy time, she said. "This year, we didn't have to hire anyone."

Since the school adopted the system in 2007, the counseling center had come to rely more and more on Naviance, to the point where this year all students

are completing their applications entirely electronically, with minor exceptions. For these seniors, paper applications are part of a world they never knew, but they said the convenience of having all the information about schools in one place is a major convenience.

"You can just see where you are and how hard it would be to get into the program," said Anna Miroff, who has made the early decision to attend Columbia University.

Students said most of their peers complete about half a dozen applications, with some filling out 10 or more. Naviance makes that easier because many schools now accept a standard application or resume, then ask for their own supplemental materials. Not only that, but like an online dating service Naviance can take information about a student, including grades, test scores and even a personality profile, and make

suggestions to students about what schools fit their criteria.

It's more convenient for families, as well. Students and parents can access the system from home, at any time of the day or night, and the progress checklists provide parents and counselors with an easy reference to how the application process is coming along, without having to rely on the student.

Sarah Light, who hopes to go to Brown, said her mother often logs in to Naviance to take a look at her progress.

"Otherwise she'd be on me all the time," Light said. "She can do her own searches and find out information."

That works for the student in more ways than one. They can confirm that admissions offices are receiving information, ensuring nothing gets virtually lost in the mail.

"Through Naviance, we can see not only when we submitted it, but when the school uploaded it," said Counseling Coordinator Gayle Moriarity.


Though we live in an increasingly digital world, Bethlehem High School is the region's first pubic school to fully adopt Naviance. Counselor Lisa Carr, who spearheaded the adoption of the online system, said she's often fielding requests for training from local districts like Niskayuna, Guilderland, Shenendehowa and Voorheesville, as well as schools as far away as the Binghamton area.

"We've always been a cutting edge school, and I think people look to us as a resource," Carr said.

One of the reasons Naviance is so attractive is the savings a paperless system can offer, especially during such tight times for schools. At BC a \$3,600 part-time position is no longer needed, and the counseling center is using about 12,000 fewer sheets of paper than in 2009.





ALafarge representative noted the first phase of a state Department of Health study into the area had not revealed significant health risks cropping up in area residents. That study is using existing information, and will be continuing in the months ahead.

'Like our neighbors, we look forward to a complete understanding of Dr. Bank's study, including the testing protocols he used and his detailed results," said Lafarge Ravena Environmental Manager John Reagan.

Individuals who participated in the Harvard study will have their results returned to them, but not for the full gamut of tests. State law only permits the distribution of results derived at a state-licensed laboratory, and blood was only tested for mercury, cadmium and arsenic at that lab. Harvard tested for lead, aluminum and selenium in its own lab. Such rules don't exist for hair sampling, though, and Bank said he hopes those full results will be turned over to individuals.

That won't happen until the study is completed, though. Harvard is looking to publish a final report in June.

"This sharing of what we have to date now is one step forward in a long process," said Harvard's John Spengler, a collaborator in the research. "I feel we're very much at the end of the beginning."

approval on a slew of housing projects and the opening up of the Clapper Road Water Treatment Plant to service more residential customers, the last of which Messina characterized as the most important town government action of the year.

"It made us more independent ... it showed the businesses in our town we're concerned about our costs ... and more than anything else, to me, it showed me that our Town Board had the courage to do what was right," Messina said.

Last year also saw what most town leaders said was the most difficult budget process in recent memory. The Town Board was often at odds with Messina when it came to how finances should be handled, but they came to an agreement on the budget just days before adoption was scheduled.

In his State of the Town address, Messina said instances of disagreement — of which there were many in the early part of the year — were not bad things.






