Dues a hot topic

Bethlehem to re-examine what it pays for trade memberships

The Bethlehem Town Board tackled its yearly organizational; tasks Wednesday, Jan. 12, making the dozens of votes needed to officially staff town offices and set policies:

Though most of the items were unremarkable, the Town Board did table a motion on authorizing the payment of thousands of dollars inmembership dues to various trade and professional organizations. Several board members said the town should reexamine what it gets out, of the dozens of memberships it pays for town employees. ""I have some concerns about the value we get, including with the Association of Towns," said Councilman Kyle Kotary. "Although it's not a lot of money, it adds up and it's symbolic." The board did approve spending \$1,650 in dues for membership in that organization, with Councilman Mark Hennessey casting a dissenting vote. He later said the possibility of a property tax cap being passed is something the town should seri-

ously consider now, and the dues

Police: Burglary leads to crash, hospital

Schenectady man arrested

Bethlehem police have arrest ed a man they say plowed into two vehicles early on Tuesday, Jan. 11, as he fled the scene of a burglary, hospitalizing himself and another driver.

Anthony R. Young, 38, of Mc-Clellan Street in Schenectady, is facing a number of charges. He's in Albany Medical Center being treated for a head injury and was arraigned at the hospital. Nearly a week later, police said he's still there.

Police allege Young was in the process of burglarizing a home

on Mason Road in Delmar when the homeowner returned at 6.28 in the morning. Finding Young hiding in a closet, the homeowner called 911, police said. He fled the scene and responding patrol cars in a 2003 Hyundai, reaching speeds estimated at up to 80 mph down Kenwood Avenue, police said.

Young struck a vehicle near. Delmar Place, and then came to a stop at the Four Corners when he hit another vehicle, police said. The driver of that vehicle was also transported to Albany Medical Center to be treated for injures to his hip and shoulder area.

The Four Corners was closed for some time, delaying morning commutes:

Town expands plastic recycling

Recycling options in the Town of Bethlehem are increasing with a change to the town's mandatory recycling law requiring waste collectors to recycle more types of plastic containers.

The law had previously only required the collection of No. 1 and 2 bottles though many waste haulers voluntarily collected others - but now nearly all plastic items will be taken. Area recycling facilities have advanced to the point all are taking a greater range of plastics, so the new rule shouldn't present anyone hardship, said town **Recycling Coordinator Dan** Rain.

"The change has been a long time coming," he said. "It's going to take a lot more of the recyclable plastics out of the waste stream."

The change will take effect immediately at the

town's Rupert Road Transfer Station, where many residents drop off their trash. Plastic recyclables account for 12 percent of the nation's waste stream, but since they're light, they can take up a lot of space in landfills.

Rupert Road processes 120 tons of trash per month and 25 tons of recyclables, on average, said Rain.

applied to waste haulers in mid-March.

The transfer station and haulers will now accept butter and yogurt containers, drinking cups, prescription medicine bottles and plastic lids and bottles caps.

Polystyrene or Styrofoam containers are still excluded, as are small items like plastic straws or utensils, as they cannot be handled easily at recycling centers. Many packing materials like Styrofoam or bubble wrap can be taken to local shipping stores like Ship Copy & More for recycling.

Rain added plastic store bags and films, like cereal bags, sandwich bags, plastic wrap, etc., can be recycled at large retail or chain stores, which are required to have a plastic bag recycling program.

Full FiOS service to begin rolling out in coming months

Bethlehem is the latest community to approve Verizon FiOS television. opening the door for the company to hopefully start providing service later this quarter.

The Town Board on Wednesday, Jan. 12, unanimously approved a franchising agreement with Verizon that closely resembles the existing terms with cable provider Time Warner which, until now, has been the only option for residents to receive television besides satellite and broadcast.

A public hearing was held before the vote and a steady procession of residents braved the snowy weather to voice their support of the plan, most of them saying competition will be welcomed.

'I know competition makes businesses better, it's as simple as that." said Richard Schaefer, owner of local business Ship Copy & More.

Others described themselves as satisfied

customers of Verizon's phone and Internet FiOS service, which is provided by a fiber optic cable, and said they could not wait to ditch Time Warner's television.

You should have put a sign-up table in the back, it would have saved you a lot of time," said resident Bob Baker.

Several residents said Time Warner had already offered discounts on their bills following the news of the impending agreement with the town. Councilman Kyle Kotary related a story of having a promotional offer rescinded when the cable provider learned FiOS was not available at his home.

Verizon still has to get approval from the state, said Sam Caldwell, director of state government affairs for Verizon, but if that process goes smoothly service will begin rolling out in the near future. Caldwell declined to say which neighborhoods would be getting service first, but said if residents call Verizon they can be given an estimate.

When we plan to be in a given neighborhood is information we deem to be competitively sensitive," Caldwell said.

Verizon has laid fiber optic cable to cover about 65 percent of homes in the town, according to the company. Its application sets a schedule to continue building that network out, with 100 percent coverage in five years.

That coverage does not and will not extend to less densely populated areas, though. Areas with fewer than 20 homes per mile of road will not be included in the build out, which is the same agreement the town has with Time Warner's cable coverage.

Ed Kleinke, of the Albany County Farm Bureau, protested this arrangement. He noted agriculture is becoming a more tech-savvy

Vista developers seek tax-exempt bonds

Stakeholders in the Vista Technology Campus are hoping the Bethlehem Industrial Development Agency will issue \$5.7 million in tax-exempt bonds to fund the building of Vista Boulevard, the long road into the massive of the development. Slingerlands project.

In a special meeting of that public benefit entity, IDA board members granted conceptual approval to the plan, which would see the town creating special taxing districts in the park to have tenants pay off the loans.

Columbia Development's Joe Nicolla said this unusual plan is necessary to get Vista moving ahead. He said many tenants are ready to sign leases, but it's hard to get commitments without any infrastructure at the site.

"We're under time constraints to get all these people in and we need the road," he said. "You'll see this thing develop very, very quickly if we can get

this road in place."

The commercial lending environment has made obtaining the substantial loans from banks difficult, he said. Albany County has said it would pay \$1 million to the project, which is factored into the equation.

Nicolla also confirmed several of the retailers who will come to Vista, including a ShopRite grocery store. CVS, SEFCU and Berkshire Bank are also set to locate there, as is an unnamed restaurant "that everybody knows.'

Nicolla said it's essential development get under way to attract the campus' first high-tech tenant to

a 110,000-square-foot building. He would not mention the company's name, but said it is an "electronics publishing group" that does work with Amazon's Kindle ereader and Apple's iPad. The company would employ about 600 at the location.

The company also needs to be in that space by Jan. 1 of next year, which sets an aggressive schedule for Columbia and builder BBL Construction. Nicolla said he'd like to start construction in March, which is probably sooner than the complex financing approval schedule could be completed but he said Columbia would be themselves as ar

Our first customer was the Delmar Marketplace. It's been like our fourth baby, slowly growing and taking on its own personality.

This is the thing that has kept Paul at home. That same little baby business, the one that started with one store and a stovetop, now sustains us. Our little side company now occupies all of our time. We go to our commercial kitchen in the morning and when we turn off the ovens and the lights at the end of the day, there is always more to do. Our little side business is now our way of life. We named it Our Daily Eats, and now we sell more than just almonds. We make seven different types of roasted nuts and seeds and four varieties of granola. We sell to small grocery and health food stores in states as far as Oklahoma and from Florida to Maine. Our philosophy is simple: use simple, quality ingredients and make nuts and seeds part of a healthy diet.

There are many days when I sit in awe of my husband. In awe of how he totally, completely, hasgiven-everything he has for our company. We are proud of how far we've come, and boy, do we dream * big. We've got a long way to go. Every day I wake up, excited to go to work with my husband and business partner. We complement

serves 6

olive oil 2 leeks, chopped into 1" pieces 1 head garlic, separated

and peeled

1/2 bulb fennel, cut into large chunks

2 carrots, peeled and diced

1 14-ounce can cannellini beans

1 28-ounce can crushed tomatoes

4 cups chicken broth

1 Parmesan rind

2 handfuls green beans, trimmed and cut into 1" pieces

1 cup pastina (tiny pasta or orzo)

1 tablespoon rosemary, chopped

1 teaspoon thyme, chopped

sea salt and fresh ground pepper

Serve with cheesy toast: slice thick pieces of sourdough bread, toast and drizzle with a bit of olive oil, then cover each with shredded Parmesan. Place under the broiler, watching carefully, until golden brown. Serve with the soup.

Pulse the leeks, garlic and fennel in a food processor until finely chopped. In a large pot, heat a swirl of olive oil over medium low heat and cook the leek mixture for 5 minutes, stirring. Add the carrots and cannellini and cook for another few minutes. Add the crushed tomatoes, chicken broth and Parmesan rind, cover and simmer for 10-15 minutes. Meanwhile, cook the pasta until al dente in a separate pot. Drain and rinse. Add the green beans to the soup, cook for another 2 minutes (don't go longer because mushy green beans are terrible). Turn off the heat and remove the cheese rind (if you can't find it, that's okay). Stir in the pasta and herbs, season to taste and serve hot. Can be doubled and frozen. Also great in a lunchbox.

worked. Worked very well.

The successes have come handin-hand with sacrifice. Everything we spent money on before has been re-evaluated. Vacations are non-existent. Dinners out, a rare treat. The rosemary lamb chops we ate have been replaced with rosemary beans and greens, and the dark, organic coffee I loved is now just whatever is on sale. But you know, it doesn't matter. I don't miss any of it. My husband is here, with his family, happy.

So on any weeknight, we will 'sit down and eat something like this minestrone soup. It relies on herbs and vegetables for flavor. Cheaper, yes. But also better for you. Plenty of vegetables, low in each other well and so far, it's . fat, also high in fiber and protein. As we sat to eat this, I thought, oh boy, Zoe will never, ever eat this. Too much stuff, too many little chopped things floating around. She surprised me, though. True, she didn't love the green beans. But the carrots, cannellini and all the herbed, rich broth were slurped up. She even asked for another bowl.

So I did have time to think about our year that day. I sipped my piping hot tea and felt sure that we are doing the right thing. It feels very American, this path of sacrifice and following our dream. The future is there too, albeit at times scary. Right now, we aren't sure exactly what our destination will be. But for now, we are on the journey, together.

Matters of Opinion in The Spotlight

The King's speech

The writer is a Guilderland town councilman, professional public speaker and ASTD Trainer of the Year. He wrote "Everyone Can Be A Dynamic Speaker: Yes, I Mean You!"

Ask someone to name the best speech they have ever heard and they will often mention the 1963 presentation in our nation's capital by civil rights leader Dr. Martin Luther King, Jr. The speech changed the course of American history. This enormous impact did not happen by chance.

The answer to why the "I Have a Dream" speech changed history fills scores of books and columns (and now blogs). Its effectiveness was certainly due in part to key public speaking principles that were followed, which makes the speech a wonderful learning tool for all orators. Here are some key public speaking attributes of this historic address:

Passion

Dr. King, no doubt, had stomach butterflies as he prepared to address more than two hundred thousand people at the March on Washington. Obviously, he was able to channel that nervousness into positive energy. He was passionate, a passion that chilled the spines of so many who were listening. How many speeches have we sat through where the speaker showed little enthusiasm? After all, why should anyone care about your topic if you are not passionate about it yourself? Though civil rights was, and still is, an extremely complicated issue, he effectively used passion and clarity to convey a simple, straightforward message about his "dream."

Clarity

Simplicity is not a simple task. Speakers often bombard us with too many details. They are so caught up in the details that they miss the big picture and, unfortunately, so does the audience. The clarity presented in King's speech can be outlined in this brief way: Making effective use of symbolism and visuals, he began with a Lincoln reference with the Lincoln Memorial as a backdrop. He made a powerful case in order to define the injustice that existed, citing specific examples of racial wrongs. While he expressed a defiant tone attacking racism, he also saluted his "white brothers" and called once again for nonviolence. His speech was not simply a collection of powerful rhetoric; it included a call for action to "remind America of the fierce urgency of now." That call for action was reinforced by a simple yet powerful phrase, "I have a dream."

Point of View

Relevance

The best speeches are not about the speaker, they are about the audience. Rule Number One in my public speaking book is, "It's Not About You, It's About Them." Talk to an audience about what they care about and their hearing seems to improve dramatically.

Dr. King understood this and the real genius in his speech was in its mass, multi-racial appeal. If the speech was relevant to African Americans alone, it would not have had the same impact. It was, in large part, a patriotic speech, appealing to all Americans to make their country better. It was relevant to all Americans that one day all children would "not be judged by the color of their skin but by the content of their character."

Dr. King's feel for relevance was no accident. He spent a lifetime living his message (with the scars to prove it) and his extraordinary breath of experience was the potent reservoir he tapped into to make his speech relevant to millions of people. He had plenty of "street cred" on the civil rights issue. Not everyone can live such a life, but the truth is each of us has a lifetime of values, experiences and emotions to share. That makes you interesting and important. It can also make you "dynamic" if you follow the same approach the best speakers take.

Takeaway

What's in it for me? Our attention is very much a tangible commodity, so much a commodity advertisers spend tens of billions of dollars to get it. We want to get something out of a speech that has value to us. No one needed notes to explain the significance of King's remarks. His "takeaway" was clear and compelling — "the situation can and will be changed." People just don't look to leaders to define a problem, they expect them to produce a plan that fixes it. Dr. King had a clear goal in mind.

The following year, Congress passed and President Johnson signed the landmark Civil Rights Act of 1964. It was legislation once thought to be impossible to establish.

Great speeches are not just about words, they are also about the imagery they invoke. The throngs of people assembled in the name of justice, the Lincoln backdrop, the sense of conviction, determination and righteousness in a man's voice. They all make a speech valuable. They all can make a speech unforgettable.

Passion, clarity, relevance, takeaways – all great speeches have them. Do yours? By the way, the speech was just 16 minutes long. One of the most common speaking mistakes will not surprise you – they often last too long.

If you build it, they will come

You know, we at *The Spotlight* like to see a balance between towns in the state of New York being downright hostile toward business and alternately throwing billions of dollars at them.

That's why we commend the Bethlehem Industrial Development Agency for considering a unique plan to make the concept of the Vista Technology Campus a tangible, economy-driving reality.

See page 3 for Charles Wiff's full story, but the gist is that the IDA will issue \$5.7 million in bonds to fund the building of Vista Boulevard, which will connect the tech campus to Slingerlands and the rest of the world.

The town would then create special taxing districts within the campus, so that the tenants actually pay off the loans. That's right, the tenants — the people using the road to do business within this wonderful town.

Now, the argument can be made, and justly, that if there are no tenants, the IDA will have issued \$5.7 million in pointlessness, the debt service of which will still have to be satisfied one way or the other.

But that's a pretty big if.

The fact remains that if you want tenants in Vista, you need that road. If you want



that road, you need tenants in Vista. And in this commercial lending environment you're not going to get the road any other way.

Too many entities have too much at stake for this to become a "road to nowhere." The private owner of the land wants this to be successful, as does Columbia Development, who is itching to get tenants into the park, and BBL Construction, eager to start pouring cement.

Though ShopRite, CVS and a couple of banks are being bandied about as potential tenants, Columbia has no signed agreements as of yet.

The hold-up? Lack of infrastructure.

It takes money to make money, and it takes that and time to build a road. An electronics publishing group that does work with Amazon's Kindle e-reader and Apple's iPad, wants to be in by Jan. 1 of next year. The company would employ about 600 at the location, according to Columbia's Joe Nicolla. If that's the case, the town should try like heck to get that road built and that tenant in place.

In a perfect world, the Town of Bethlehem wouldn't have to worry about building this road. But in the real world, when you're dedicated to getting something done, you have to put your money where your mouth is.

The Bethlehem Central School District's Board of Education will hear on Wednesday, Jan. 19, a longterm initiative to provide a "personal computing device" to every district student grades five through 12.

Administrators said the fiveyear program would result in "1:1" access to a laptop, smart phone or tablet computer for students. It will be rolled out first to fifth, eighth, ninth and 10th grades.

A district representative said the cost of the program will be discussed on Wednesday.

Many pets like to eat the snow; which is generally safe as long as the amount is limited and there are no toxins nearby. Ideally, you should avoid letting your pet consume snow. Some pets with long fur in between their toes can develop interdigital

ice formation. This is often painful and can lead to limping. These pets can benefit from dipping the fur between the digits shorter in the winter.

One potential danger facing our pets during these winter months is due to the salt used to melt the snow. Walking in heavily salted areas can cause footpads to crack and even form ulcerations. Additionally, if your pet licks the snow mixed with the salt from his or her feet, gastrointestinal irritation can occur. One way to counteract these potential complications is to wash your pet's feet after walking outdoors. Other available options include pet booties, topical wax or simply using pet safe ice melt.

Some of the thick coated dogs and cats choose to spend hours outdoors. Make sure that your pet has access to a sheltered area to escape the wind and the cold. In addition to shelter make sure that the water and food provided for your pet does not freeze. Many pet supply stores sell water heaters that keep your pet's drinking water at a comfortable temperature. It is important not to use heat lamps or heating blankets that are not approved for use in animals. These products can lead to thermal burns.

Fostering respect

Siena and ADL team up to teach students the values of Dr. Martin Luther King Jr.

In memory of Dr. Martin Luther King Jr., the Anti-Defamation League and Siena College partnered up on Friday, Jan. 14, to provide a venue for young people to reflect on the tenets the civil. rights leader preached.

The STOP Conference, or Students Together Opposing Prejudice, is a component of the Martin Luther King Jr. Lecture Series put on by Siena College, and involved students from all over the Capital District coming together to explore the different facets of prejudice and how to promote diversity.

This is the college's sixth year holding the conference, and it is the ADL's third year being involved.

Mechanicville High School students Austin Bryant, a senior, and Kabe McClenents, a sophomore, said the activities they took part in that day taught them to

than they should be," said Bryant. "Everybody has their own difficulties and their own problems. To harp on that and annoy them about it just adds more to their plate, which they really don't deserve."

McClenents referred to "the Golden Rule" and said it is important to think about it when interacting with others.

"Treat others how you would like to be treated and not to disrespect people for how they choose to live," he said.

Bryant said that he used to use the word "gay" quite freely and not think of the consequences that come with it, but he said now he realizes how much it can hurt and offend people.

'I kind of just used that as lingo," he said. "Of course, it means something else, and it might hurt people.'

ADL's A World of **Difference** Institute Coordinator Kate Jackett was on hand at the conference to help facilitate the day's events. She said the organization prefers to use the word "respect" as opposed to think before they speak. to lealing with prejudice and

diversity.

"Respect is a higher form of appreciation for another person," she said. "Often people might say they tolerate someone. It tends to give a connotation of just putting up with someone, and we try to move beyond just putting up with someone and actually respecting them and understanding where they come from."

The event, geared at middle school and high school students from around the region, was held at Siena to give the young people a chance to experience the environment of a college campus. With universities sometimes serving as the melting pot for various cultures, Jackett said it is important to expose children to different ways of life as early as possible.

"At any age level, it's important to expose students to all kinds of diversity and give them the opportunity to experience diversity in all its forms," she said. "We take a very broad spectrum approach to the concept of diversity. Often when we think of diversity we think of the visual diversity such as skin

display in the Sarazen Student Union. Many of the pictures featured King, President Barack Obama, as well as the artists' visions of world peace. Ellard said he noticed a lot of connections between environmental conservation and what students believe King would be doing to combat global warming.

Family friendly event 6 P.T. takés place at Saratoga National Historic Park

hen Clark Dalzell got out of the Navy and was considering a career, he thought back to the summers he spent working at Saratoga National Historic Park. Dalzell had always enjoyed his time at the park, so he decided to become a ranger.

Dalzell spent 38 years at the park, eventually becoming the trails director. His enthusiasm for his work never waned. In fact, even though he retired this year, he's coming back Saturday, Jan. 22, for the annual Frost Faire to reprise his always-popular scavenger hunt. Playing the part of a park ranger, Dalzell will help kids find candy and other hidden treats.

'It's kind of funny," he said. "I came in as a park 🐐 ranger and now I'm imitating one."

The Frost Faire hasn't been part of the park as long as Dalzell has; it's entering only its 16th year. But its roots stretch back much further than that. Popular in the 1700s, Frost Faires gave people a chance to escape cabin fever by socializing and sharing food and drinks with friends.

In that spirit, the Frost Faire, which kicks off at 10:30 a.m., will offer cookies, cheese and cocoa around a bonfire all day. There will also be sledding, d there's enough snow. Kids and adults are invited to bring snow tubes (no sleds or toboggans) to use on the park's big hill.

Horse-drawn carriage rides are one of the activities offered at Frost Faire Even if there isn't enough snow for sledding, visitors can enjoy horse-drawn carriage rides and games such as ice bowling, a giant soldier puzzle and bottle fishing.

Ice bowling is pretty much what it sounds like, according to Ranger Bill Valosin: you try to knock down pins set up on the ice. The giant soldier puzzle, meanwhile, is geared toward young kids, with easy-tohandle pieces.

"It's laid out on a big board, and the soldier is basically about 6 feet high," Valosin said. " It's a pretty good size."

For the bottle fishing, several empty glass soda bottles will be spread out on the ground. Using a washer attached by a string to a dowel, players have to try to hook the bottles and get them to stand upright. "It is harder than you would imagine," Valosin said. "It's frustrating, challenging and a lot of fun." Some of the day's offerings mix fun with education. There will be contra dancing and a Colonial handwriting demonstration, and a children's craft room will

feature decorative tin piercing and copper embossing. At 10 and 11 a.m., noon and 1, 2 and 3 p.m., there will be cannon firing demonstrations. Musket firing

question-and-answer session about deer, birds and other wildlife. Once he has their attention, he lets them know about the hidden treasures.

"We stash stuff down on the horse trail," he said. Watching the kids search for the prizes always makes him feel good.

"It's nice to see them getting away from the TV and the Gameboys," he said.

Former NHLer has his uniform retired

Craig Darby neverthought he would see the day where a hockey team would retire his jersey number.

The Colonie native saw that day happen Saturday when Albany Academy retired his No. 17 jersey prior to the Cadets' home game against Canterbury School.

"It was definitely not something I planned on doing, but it's something I'll never forget," said Darby.

Albany Academy honored Darby not only for what he did during his career at the private school — a school-record 302 career points and a state title in 1991 - but also for what he did after he graduated. He played two seasons at Providence College before embarking on a 15-year professional

career that included stops in the National Hockey League, American Hockey League and Europe.

During the short ceremony, Darby thanked the school and his coach, Dave Rider, as well as his parents for supporting himn throughout his formative years as a hockey player.

"They made some huge sacrifices," Darby said of his parents. "The commitment of having children playing hockey is a full family commitment, both financially and in terms of time."

Darby knows that commitment very well. Today, he's coaching his son Kyle's Saratoga Blue Knights bantam division team, and his daughter Cristina plays.

It wasn't long ago that Darby was lacing up his skates, though. He bounced around Europe for several years after it became apparent to him that the NHL was no lönger within his reach, and he retired only two

Winney was seemingly unstoppable in the first half. as he drained five three-pointers as part of a 21-point performance. It didn't matter if there was a Hudson Falls defender in his face, either. Winney's shots fell true.

When Winney's three-pointers stopped falling in the third quarter, he got creative as he drove to the basket and picked up a couple of layups. When he left midway through the fourth quarter, Winney had 31 points - only three points less than what Hudson Falls managed up to that point.

It's not as if this was the first time Winney had a big game for Scotia-Glenville. The senior guard is averaging

entering this week's action. He's scored more than 20 points in nine of his team's first 10 games, including a 31-point performance against Schalmont in a non-league game Dec. 18. And he's been especially good from behind the three-point arc, as he's drained 36 threes an average of more than three per game.

Scotia-Glenville's success may be centered around Winney's shooting, but the Tartans are not a one-man show. Junior forward Casey Norton is averaging 11.3 points per game and is demonstrating a knack for hitting outside shots (23 three-pointers). Still, the Tartans will go as far as Winney takes them. And the way he's playing, Winney should take them deep into the Section II Class A playoffs.

• Let's not forget the Scotia-Glenville girls basketball team. The Lady Tartans are undefeated after 11 games. and have rarely been challenged. Their closest margin of victory within the Foothills Council is eight points (a 49-41 victory over Johnstown Jan. 4).

Much of the Lady Tartans' success can be traced to the trio of sophomore guard Cassie Broadhead (16.7 points per game), junior guard Sarah Janson (11.6 ppg)

Regan Burns' defensive system - one that has been influenced by the one she used to play in while helping Voorheesville to three consecutive state tournament appearances in the 1990s - has been equally helpful in Scotia-Glenville's surge to the top.

If the Scotia-Glenville boys team can't bring home a Sectional title, perhaps the Scotia-Glenville girls team will.
