Draft
budget
calls for
tax hike

No raises and other
austerity measures
highlight town plan

The draft 2012 budget for the Town of Bethlehem calls for a 1.27 percent tax hike and a number of austerity measures in an effort to brace for what officials say are dark times ahead.

The budget was unveiled on Wednesday, Aug. 31, to the Town Board, town staff and a few on-lookers at the first of many budget workshops. The comptroller and Supervisor Sam Messina have been working with individual departments to draft the plan that calls for \$38.6 million in spending — almost exactly the same amount as in this year's budget.

Messina described the budget as "a very, very, very good first step." Unveiling a complete plan at the first budget workshop is a reversal from the process used in past years.

"We're not starting going through reams and reams of data; we're starting with the big picture," Messina said.

That big picture also calls for no raises whatsoever for town employees in the coming year, and assumes none will be built into a new contract with the police union that expires this year. Five positions that sat unfilled

Candidates debate

Budget, leadership, level
of partisanship recurring themes
during lively evening

The meeting room of Bethlehem Town Hall was packed Thursday, Sept. 1, as the two candidates in the upcoming Democratic primary for the office of town supervisor met for a debate sponsored by the League of Women Voters and Spotlight Newspapers that featured some verbal sparring but also frank discussions about the town's past, present and future.

John Clarkson and Kyle Kotary made opening and closing statements and fielded 14 questions provided by the audience and relayed by Spotlight Newspapers Managing Editor William R. DeVoe. These covered a wide range of topics, and by the end, the differences between the candidates' platforms — or perhaps more accurately, their opin-

ion of the town's position and path — were laid bare.

Kotary pointed often to his more than five years on the Town Board as experience that makes him an ideal candidate for the office of supervisor. Clarkson countered that the current state of things in town is the very reason his opponent shouldn't be given more responsibility.

"We both agree on much of the issues that have to be addressed. The unfortunate thing is they have not been addressed," Clarkson said. "We need change in Bethlehem's town government."

Kotary described himself as a consensus builder.

"As a member of the Bethlehem Town Board I have fought to make our community a better place to live, work and raise a family," he said. "I believe we can have local government that is innovative, progressive and fiscally responsible."

The primary race is of great importance to both candidates. If Kotary emerges on top he'll be the presumptive incoming supervisor, as he would

Walking to a cure

8th Annual Walk for Hope
continues to grow

When 15 people stepped off on a walk in 2004, it was but a slight start to what was to become an enormous event.

This year, hundreds will gather in Bethlehem's Elm Avenue Park for the 8th annual Albany Capital District Walk for Hope, which benefits the Lustgarten Foundation in its mission to find treatment and early detection

methods for pancreatic cancer. The race is on Sunday, Sept. 11, at Bethlehem's Elm Avenue Park.

In last year's walk, about 400 turned out and ended up raising more than \$100,000 for the Lustgarten Foundation. That's a far cry from the first walk in 2004, when \$4,000 was raised.

This year, registration and fundraising is putting the walk on the path to exceed even 2010's levels. Corporate sponsorship alone is topping \$20,000, including from Rensselaer Honda, which donated proceeds from its June Tom Gorman Memorial Golf Outing

Financial impact of Irene's punch still uncertain

Town of Bethlehem still assessing scope of tropical storm's damage

Tropical Storm Irene wrought destruction all over the state, and while many places are certainly worse off, the Town of Bethlehem wasn't spared from the storm's fury.

Town officials said it will be some time before a price tag can even be put on the damage, which has affected large swaths of municipal infrastructure. In the days following the storm, town workers and engineers have been trying to get a handle on things, said Deputy Commissioner of the Department of Public Works Erik Deyoe.

"Some of the facilities can't really even be seen at this point because of the water level, particularly some of the sewer facilities," he said.

What's clear is the town's water facilities in New Scotland have taken a brutal hit. Water flowed over an emergency spillway at the Vly Creek Reservoir, eroding the surrounding lands. On the Onesquethaw Creek, a similar set of circumstances on a diversion dam has made it so that runoff actually bypasses the dam through newly formed paths. Roads to this area were also washed out, compounding the difficulty of making repairs.

The town's wastewater

treatment plant became clogged with debris at the height of the storm, causing a manhole cover on the inflow to the plant to blow off when the system backed up. The plant is back in operation now, though repairs will likely have to be made to the sewer system once the water level goes down.

In South Bethlehem, an old railroad bridge on state land near the landfill will likely have to be removed after a raging river damaged its abutment.

As is the case across the state, a lot of the town's infrastructure damage was caused by water, not winds.

"We were at historically high [rainfall] levels to begin with, then we just threw a hurricane on top of it," Deyoe said.

The town's Henry Hudson Park in Selkirk also sustained some damage. The fishing pier took a beating but is still there despite the Hudson flowing up

into the park, and a tree crashed through the roof of a pavilion, said Administrator of Parks and Recreation Nan Lanahan. Additionally, the whole park up through the softball fields is now covered in mud.

"The park is open, it's just not really usable right now with all of the muddy conditions," Lanahan said.

A silver lining in the devastation is the town's roads. Highway Superintendent Gregg Sagendorph said the state-, county- and town-owned roads escaped damage beyond a few shoulders washing out. The department's

still focusing on cleaning up all the debris the storm created, though, to the extent it will impact paving plans for the year.

"I don't want to say we've suspended the program, but we've sure put it on the back burner," Sagendorph said.

Bethlehem residents are asked to pile branches at the side of the road for collection and heed any road closures that might still be in effect.

President Barack Obama has declared many areas of the Northeast disaster areas, including Albany County. That opens the door to federal disaster

aid, but the process is just getting under way. Even then, it can take years for municipalities to collect checks in these instances, and federal relief rarely covers the full pricetag for recovery.

Some estimates put the hurricane's U.S. damage as high as \$1 billion. Gov. Andrew Cuomo recently put the damage in New York at \$1 billion.

Residents who suffered damage in the storm may also qualify for federal assistance. To apply for Federal Emergency Management (FEMA) aid, visit disasterassistance.gov.



9/11 memorial ceremonies planned

Vigil and service to be held in Slingerlands

The Town of Bethlehem Fire Officers Association and the town will be partnering to hold a candlelit vigil on the tenth anniversary of the Sept. 11, 2001 terrorist attacks.

The vigil and prayer service will be held at 6:30 p.m. at the Bethlehem Firefighters and EMS Park, located next to the Slingerlands Fire Department at 1520 New Scotland Road. It's the first time the association will hold a formal 9/11 ceremony, save for one held in 2011 in the days following the attack.

"I figured it's the 10-year anniversary coming up... I figured the fire officers and EMS people should mark the anniversary with an event," said Heidi Cornell, who is captain of the Bethlehem Volunteer Ambulance Service and is organizing the memorial.

Firefighters and EMS squads from around town are invited to the ceremony, which will be led by Pastor Mark Mueller of the Bethlehem Lutheran Church. The ceremony is expected to last about half an hour.

"There will much going on around our State and nation

on this 10 year remembrance day of the Sept. 11, 2001 terrorist attacks, that took so many people's lives, and left families behind that will be forever heart broken. It is also important in local communities, and in our Town of Bethlehem that we show our respect and lasting remembrance by joining together to let those we have lost and their families know that we will never forget."

Bethlehem Supervisor Sam Messina said in a statement.

Other events in the Capital District

• The Selkirk Fire District will hold a prayer service on the morning of Sept. 11 at Selkirk Company No. 2 in Glenmont, 301 Glenmont Road. The event will begin at 8:46 a.m., the time Flight 11

crashed into the World Trade Center, and conclude at 10:28 a.m., when the north tower collapsed.

The names of 343 New York City firefighters who lost their lives at the scene of the attacks will be read. Music will be provided by Carole Doody, a piper with the City of Albany Pipe Band.

Members of the public as well as area fire companies are

encouraged to attend and will be invited to assist with the reading of the names.

"Each year Selkirk Fire District answers approximately 300 calls. At the sound of the tones, we don't always know what to expect but we answer the call. On September 11, 2001, our brethren did not hesitate to respond and answered the call," said Selkirk Fire District Chief Bill Asprien in a statement.

• The Town of Clifton Park will be holding a remembrance ceremony at 3 p.m. on the Clifton Common stage. The event will include prayers by local clergy, a military color guard, bagpipers, a presentation by the Clifton Park Community Chorus and featured speaker Rev. Kenneth Paulli, chief of staff to the Siena College president.

Residents are encouraged to bring a small American flag to be placed in front of the Clifton Common stage for the duration of the event.

• The Burnt Hills-Ballston Lake Inter Church Council will hold an interfaith service at 4p.m. at Indian Meadows Park on Droms Road in Glenville. Attendees will be invited to place memorial ribbons with the names of loved ones lost on Sept. 11 on a living memory tree that will be planted at Indian Meadows or another local location.

New Scotland fire ruled arson

A New Scotland man is in the county jail for allegedly torching his house following a domestic dispute.

The Albany County Sheriff's Office said Robert G. Ferullo, 35, called 911 at about 6:45 p.m. Tuesday Aug. 30, and reported a fire at his home at 99 Youmans Road.

After an investigation, police said it was discovered that Ferullo had allegedly set the fire with a candle and a bedsheet.

"There was a domestic incident at the residence in the early evening hours, and shortly thereafter

the female party left the residence... He later admitted to setting the fire, he was upset at breaking up with the female party," acting Albany County Sheriff Craig Apple said.

The woman took three children with her when she left, Apple said. The Red Cross is providing them with shelter and assistance, as the house is no longer habitable.

Apple said Ferullo initially told firefighters the fire was electrical, but they called for the sheriff's cause and origin team when that story didn't add up.

Ferullo was charged with arson in the third degree and criminal mischief in the second degree. Both are felonies. He was remanded to Albany County jail in lieu of \$50,000 bail.

Arrests follow closed-road travel

Roadblock scofflaws found with drugs

The news has been abuzz with reports of disaster befalling those who failed to follow authorities' instructions during Tropical Storm Irene, but it turns out driving on closed roads can land you in all sorts of trouble.

The Albany County Sheriff's Office announced today the arrest of two people who allegedly circumvented barriers blocking closed roads in the wake of the storm.

One, Michael T. Jones, 22, of Voorheesville, allegedly was found to be drunk after he drove around barriers on Delaware Avenue in New Scotland on Monday, Aug. 29, at 9:15 p.m. After

being stopped, police said his female passenger was found to have been reported missing from a group home in Schenectady.

After failing sobriety tests, Jones was charged with DWI, failure to obey a traffic control device, endangering the welfare of a minor and unlawful possession of marijuana, police said. A breathalyzer test allegedly showed his BAC to be .08 percent. He was scheduled to appear in the Town of New Scotland Court at a later date and released on tickets.

Sheriff's Deputies also arrested Adam J. Mineau, 22, of Coeymans Hollow, on charges he was driving with a suspended license and had anabolic steroids in his possession.

Police allegedly saw

Mineau drive around road barriers and road closure signs on Route 32 in the Town of New Scotland. He was charged with aggravated unlicensed operation of a motor vehicle in the third degree, criminal possession of a controlled substance in the seventh degree and failure to obey a traffic control device. He was released on appearance tickets and is scheduled to appear in the Town of New Scotland Court on a later date.

The Albany County Sheriff's Office reminded Capital District residents to heed all road closures, and said failing to do so can endanger not only a motorist's life but those who will eventually have to rescue him or her.

Blessed with umbrellas and boneless chicken

So there I was standing out in the pouring rain with an open umbrella in each hand. In my right hand was a medium-size umbrella patterned with a map of the New York City subway system. Our lawn, however, was littered with debris that had been blown from the trees, so it was possible that something had hit the device on our property. My techno-savvy spouse tossed on a hooded jacket and went to inspect our "unit" for any obvious damage. After a few minutes I followed Jeff out into the pouring rain and offered to shield him with an umbrella. Highly self-sufficient, Jeff was already leaning under an umbrella, the handle wedged under his left arm and the top propped against the side of the house. With his free arm and hand he checked the cables. Nothing seemed amiss.

"Well, I'm outside, so I might as well finish fixing

"I'll hold an umbrella over you" I told him, wanting to be helpful.

About a half hour later Rachel appeared in the den. She had been startled awake by the buzzing of her cell-phone. "You should have turned the phone off." I told her. She said nothing, but looked at me quizzically as if I had said, "Please go milk the cow."

Then I asked her to read what I had written.

"Did this happen today?" she asked after the few first sentences.

"Yes, it happened today. Didn't you notice both Dad and I had gone outside?"

"I saw it this morning when we still had service."

"This morning? And you didn't think this news was worth sharing?"

"I dunno. I was sleepy."

I thought about my cousins in New Jersey.

"What did it say about the damage? Was anybody hurt?"

She recalled no further details, except, "Oh, and Cousin David commented that Jenna should move up North."

Paying tribute to the tenth anniversary of Sept. 11

It seems amazing to me that almost ten years have passed since the attacks on September 11th, 2001 (9/11), a date with profound resonance for all Americans and particularly so for New Yorkers as well as funeral professionals. After a tragedy such as this, we often hear people talking about "closure" as if there is a door that can be shut after losing a loved one or being witness to a horrific event such as the terrorist attack on the World Trade Center. Friends might ask "Haven't you reached closure yet, it's been ten years?"

Grieving for a lost loved one can take ten years, and sometimes a lifetime. Quite frankly, grief is different for everyone, so there is no such thing as "closure." Those who refuse to begin the journey through grief simply delay their own recovery. It should come as little surprise that a generation of people brought up with instant coffee and microwave ovens would search for quick relief from something we call grief. There is no set schedule or magic formula for working through it. We all experience and react to loss in different ways depending on the relationship of the deceased to us, our past experiences with loss, and sometimes even our health and emotional state.

But after a disaster such as 9/11 or the recent Japanese tsunami or Haitian earthquake has occurred, what happens to the grief process when

a loved one's body has not been found? Psychologists tell us that denial is one of the steps in the grieving process. Until bereaved persons accept that death has happened, no progress can be made in resolving their grief. Most people need the experience of seeing a loved one's body because it makes the loss real and allows survivors to take the next step in the grieving process.

As shown by the awful aftermath of 9/11, sometimes body recovery is impossible even though herculean efforts are undertaken. On May 30, 2002, a solemn ceremony at Ground Zero marked the end of search and recovery efforts; only 291 bodies had been found intact and the remains of only 1,102 of the 2,823 victims had been identified. Ten years later survivors are still coping with the sudden and tragic loss coupled with the absence of a body.

Struggling through their

grief, many of these survivors turned to their family funeral directors for solace and advice on memorialization. One funeral director who helped many families victimized by 9/11 was impressed with the enormous community outpouring of support for the victims' families. He told us that regular funeral services were generally conducted, but with emphasis on unique ceremonies to memorialize the victim's life. For instance, basketballs played an important role in the services for a young man killed on 9/11 who had been a star basketball player.

Why would anyone seek closure? Why would anyone want to close the door on thoughts about a departed loved one? Grief will soften in the years after a loss, but the door to memories should always be open, particularly after a tragic event such as Sept. 11.

Houses of worship get home on web

Latham-based company hopes to change the way churches get online


While in the online news world "pay walls" are the topic of the day, in the non-secular sphere some churches are thinking about "prayer walls."

At least, those that are early adopters in steepleconnect.com, the latest development of eSolve Solutions, a Latham web company owned by Guy Cortesi. Part website, part social network and part donation plate, Cortesi said the idea was born when a church in the Binghamton area was on the hunt for a new website.

A congregant of the church, Adam Smallcomb, partnered with Cortesi's son, Timothy, in getting things started.

"We decided to take it a lot further," Guy Cortesi said, adding that once they got under way, it became clear there was an untapped market for a robust, easy-to-use, affordable web presence for churches.

"We found that in like 60 churches, there might be 30 that don't have a site, or have a minimal site," Cortesi said. "We also found that most of them aren't being maintained, and if they are being

maintained it's a lot of work."

Churches that join steepleconnect (there are three right now, but Cortesi hopes to add more, including Capital District Houses of worship) get their own corner of the website that integrates a lot of features Facebook users might be familiar with. There are places for full-featured calendars, blogs and general information about a church. There's also a way to make a secure donation to the church and even to share podcasts of the sermon from each week's worship.

The Rev. David Murphy, of Valleyview Alliance Church in Vestal, said the website has been a

useful too for his church in many ways. Even serving as the guinea pig for the development of the system and putting in money up front, it's been cheaper than getting similar features out of website built privately from the ground-up, he said.

A dynamic web presence has also resulted in people showing up for Sunday worship, and staying.

"Most of our shopping is done online now ... people are doing that for ministry as well," Murphy said. "People are unlikely to just do a cold call to a church nowadays."

For those who already belong to the congregation, Valleyview's site on steepleconnect offers a

digital directory of church members (which also saves the church the cost and hassle of printing one) and a way to donate online. That's ended up being used often, especially by younger people who don't carry checks or cash.

"It has increased giving at the church and really helped us recover from a deficit at our church. A lot of people traveling through the summer, they're not giving to the church," Murphy said.

A feature that programmers are now working on is a "prayer wall," said Cortesi, which would allow members of a congregation to post calls for prayers to a central board. Members out of the area or unable to make

it to worship could keep up on goings on in this way, and also save church staff the hassle of putting together email bulletins.

Churches can pay \$35 per month or \$350 per year for use of the steepleconnect system, which includes eSolve Solutions helping with setup and support. That's more than setting up a free presence on Facebook, for instance, but Cortesi thinks churches will see the value on going into a system targeted at their needs.

"Some churches spend \$2,000 to have somebody build [a website] for them, and they can't really change that. It costs them a lot of money to maintain it keep it up to date," he said.

That's good for small churches that want a foothold in the digital world. Opinions on the necessity of an online presence are bound to vary, but for Rev. Murphy it's required in the present and the future.

"Our older congregants will get older and they will eventually die. The younger people and families we're trying to draw into the church are trying to use technology more and more as their principal mode of communicating with the church," he said.





My dog has been itching all the time. Do I need to be concerned?

Itching is a very common symptom in dogs and can be very frustrating to treat. The four main causes of itching are ectoparasites (fleas), environmental irritants, allergies including food, and secondary infections of the skin. It is important to seek veterinary attention to determine which type of irritation is causing your dog to itch and scratch.

Fleas can be the cause of itching even if you do not see them. Fleas can survive in low numbers year round, and often-times adult fleas fall off during itching. Flea saliva is a major allergen and it only takes a few bites to cause great discomfort. Your veterinarian can help you achieve safe flea control to ensure that this is not the cause of the itching.

Environmental allergies, also known as atopic dermatitis can range from mild irritation to severe hives. Most mild cases can be managed with as needed anti-histamines whereas more severe forms may require skin allergen testing and long term medications.

Food allergies arise when the animal develops hypersensitivity to an ingredient in the diet, usually a protein or carbohydrate. If food allergies are the cause of your dog's itching, your veterinarian will work with you to facilitate a proper food trial to determine the origin of the allergy.

Allergies are usually lifelong problems. However, proper control of the discomfort can be achieved through identification of the underlying cause and maintenance with medications and/or diets.





RCS establishes tax rates

District will use \$50K of savings to offset hike

Property owners in the Ravena-Coeymans-Selkirk Central School District will be paying a touch less than expected on their 2011-12 school year taxes.

The district's school board has decided to use \$50,000 worth of the undesignated fund balance to lower the final tax levy to a 2.28 percent increase, instead of a 2.5 percent hike voters had

approved in June, after the district's original budget proposal was defeated.

The final tax rates by town are as follows, per \$1,000 of assessed property value: Bethlehem: \$19.44; Coeymans: \$18.86; New Scotland: \$19.64; and New Baltimore \$26.37.

The owner of property assessed at \$100,000 in Bethlehem will see a tax bill increase of \$45.43; in Coeymans, a tax bill increase of \$44.07; in New Scotland, a tax bill increase of \$5.09; and in

New Baltimore, a tax bill decrease of \$51.17.

The different rates are due to the varying states of assessment in each of the municipalities. The state issues equalization rates each year to better spread out the tax burden.

The 2011-12 school year budget is \$42.4 million. Tax bills will be mailed in early September and are due back by Sept. 30 without penalty.



These pipers play for passion

Area band competes at international competition

The Capital District is known for a number of things, but being home to one of the world's finest pipe bands probably doesn't come to mind first for most people.

The Albany based Oran Mor Pipe Band is ranked as the 14th best pipe band in world after the World Pipe Band Championships in Glasgow, Scotland, on Aug. 13. Andrew Douglas, a Schenectady resident, leads the bag pipers in the band and fellow Schenectady resident Eric McNeil is the drum sergeant. The 29 member band's performance was featured on BBC Scotland and BBC's website. Also, the band competed in the Grade 1 finals for the first time, which is the highest level.

"We do a lot of competitions, this is obviously the biggest one, it is definitely a thrill when the band is going well like it was this year," said Pipe Major Andrew Douglas. "The bagpipes have a really amazing sounds, especially when it is played properly. I don't think it is paralleled by any other instrument. It is a very expressive instrument that has a lot of potential for great music making."

Also, while the band was

in Scotland it finished second at both the North Berwick Highland Games and the Bridge of Allan Highland Games. Band members got the chance to play at the Piping Live Festival in George Square and at the National Piping Centre too.

"We're competing with the best bands in the world, and doing so on their own turf," said Douglas, a 26-year-old. "Our members combine strong fundamental skills with a dedication to spirited music-making. Each year, we take it to an even higher level, and I can see Oran Mor placing even higher in years to come."

The band was founded in 1992 in Central New York, but since 1997 its operated out of the Capital District and practices at the Celtic Hall in Colonie. Douglas said the area is one of the better places to be for experienced and talented bagpipers.

"This is definitely one of the top spots (for a bagpiper)," he said. "I think it has to do with the fair degree of Scottish and Irish lineage, but also there is a lot of excellent bagpipers in the area that have taught students as well."

During nice weather, he said the band practices in area parks. Even practicing at home isn't an issue with "practice version" of the instrument,

which he said isn't too loud and could be used almost anywhere without disturbing others. Besides helping lead the band, Douglas also owns The Pipers Dojo in Colonie, which is a bagpipe shop. He said the "economy" bagpipes have a starting price around \$1,200 and the more elaborate pipes approach \$10,000.

"Bagpipes are pretty expensive ... it is somewhat

of an expensive hobby," he said. "I think the key if you are interested in getting into is to find a good instructor that will teach you the fundamentals."

To be a part of the band, he said, being able to play the pipes is a key requirement.

"There are a lot of pipe bands out there looking to get people into a kilt and get them out in parades," he said.

Douglas started learning

how to play the pipes when he was 8 years old and was taught by his father. His great grandfather came to the United States from Scotland in 1911, but he actually didn't play the bagpipes. His grandfather did play though and started the family tradition spanning three generations.

"I remember sitting down with my dad at the dinner table and going over the lessons."

Pedal-Paddle-Run brings back family friendly triathlon

Event takes place Saturday, Sept. 24

Get ready to hop on your bicycle, lace up your running shoes and grab your kayak and paddle with other local residents for a friendly race around Collins Park.

Schenectady County's second Pedal-Paddle-Run event on Saturday, Sept. 24, continues the focus on offering a more laid back race with teams competing as a group or individual. Proceeds from the event will benefit childhood obesity prevention programs and other wellness programs provided by the Schenectady County Department of Public Health.

"The way the distances are laid out and the way it is set up is really to make it welcoming to families and teams that are made up of friends or co-workers," said Wendy Voelker, special events coordinator for the county. "Last year we found a lot of our teams were just regular people that wanted to go out for a day of fun."

The biking distance is approximately 8 miles through Glenville and Scotia. Paddling consists of a 1.6-mile course on Collins Lake. A traditional 5K distance is used for the running portion of the

race. Participants, based on team size, could do all or just a section of the race.

After the inaugural event, said Voelker, some participants said they wanted the biking portion of the race to be longer, so this year's PPR will feature a longer distance. She said many people felt it was a challenging race, but something they were able to complete. The solo competitors are usually the most competitive, she said.

"I think our majority of our teams last year were three person teams, although we did have a significant number of solo competitors ... 25 percent of the people that competed last year did it by themselves," she said.

The unique area of Collins Park also fit perfectly with the event and was one of the few locations in the county able to host it.

"Collins Park makes the most sense, because we were looking for a location where we could have each leg of the race start and end at same place," said Voelker.

There will be a prize for a first place finish in each category of age groups and team or single classifications. This year's event will also have more precise timing for each section of the race. Once a leg is finished the time will instantaneously be



available because of a computer chip placed on a Velcro strap around a competitor's ankle. Team members will trade off the ankle band to other fellow members.


"Once the race is finished we will know who finished and in what order," she said.

hold all party lines except the Working Families Party line and the Conservative Party line, the latter of which is open as an opportunity to ballot in the primary.

Clarkson on Thursday said if he doesn't win the Democratic line that would be the end of his bid for supervisor, even if he were to secure the Conservative line (which the party offered but was later invalidated on a challenge by Kotary on the procedural paperwork). He transitioned from this thought to discuss what has been the linchpin of his campaign from the start: the fact Kotary garnered endorsements from the two major parties.

He said this was his chief reason for pursuing the office.

"I think we should honor our two-party system," Clarkson said. "If our two-party system at the local level doesn't provide competition and choice, it really fails us."

Kotary said he would continue his run even if he were not to hold the line of his own Democratic Party.

"I'm not running for supervisor to simply be a choice, or to support one party or another. At the local level especially, it's

about people and not about politics," he said.

Clarkson returned to the subject of partisanship often, accusing Kotary of "a general pattern of obstruction" toward the agenda of now-Supervisor Sam Messina for political reasons, pointing to a failed proposal to broadcast town meetings on the Internet and to funding for the repair of Town Hall that wasn't approved before the parapet wall collapsed.

These assertions were at the heart of several spirited exchanges throughout the evening.

"I think you kind of lost your mantle of non-partisanship, if you want to talk about that," Clarkson said early on.

"What's important is to speak up and to be accounted for, to stand up when you have a difference of opinion, and that's what I have done," Kotary retorted, also explaining the reasons for his decisions.

The opinion of the state of affairs in town government and affairs was probably the point the candidates diverged on the most. In fact, they largely agreed on the way forward on a number of issues, including on moving ahead shared services initiatives, revisiting the town's ethics law, focusing on commercial development and the need for a viable long-term plan to address the town's crumbling infrastructure.

Kotary brought up revisiting the town's comprehensive plan and brought up his plan to utilize Youtube and other free online tools to expand the town's cyber presence and get meetings on the Internet. He said the town's planning and zoning boards should be more business friendly.

Clarkson said he would take a pay cut if he were elected supervisor and said he'd like to see a committee look into government reform ideas. Proposals made by a 20/20 committee Clarkson served on to extend the supervisor's term and make several elected positions appointed never gained traction on the Town Board. He also said the town should make sure it exercises control during the planning process for big projects.

The town's fiscal position was a recurring theme, and on that subject, the candidates had different thoughts.

Kotary outlined the need for changes, including an end of "off budget" spending and a reassessment of the town's revenue streams, but ultimately said this year's budget is a shining example of the power of compromise and, as a result, one of the strongest fiscal plans the town's put out in recent memory.

"We have, I think, appropriately used fund balances," Kotary said. "That's money used for rainy days, and it's raining, literally

and figuratively. That is there for emergency spending, for capital projects, and that's what we've used it for."

Clarkson, on the other hand, asserted there are deep-seated issues in the town's budget and its budgeting philosophy. He advocated that the town cut down on its borrowing and put a halt to the spending of the town's reserve funds.

"For the last four years, we have been balancing the budget by spending down reserves at a rapid rate. That is in essence like paying your mortgage using a savings account," he said.

When asked after the debate about the recently unveiled draft budget for the town (see related story on page 1), Kotary intimated that there's a long road ahead.

"It's a late, but a good place and plan to start," he said. "I'm not for the tax increase right now, but I think it's a solid start and we have a lot to do."

Clarkson said the budget implements some of the things he'd like to see done, but also referred to it as a "tight budget."

"They're moving away from spending reserves... that's at least a start," he said.

Clarkson's bid for supervisor is his first run at elected office. In the Town of Bethlehem, he's been involved in the town's 20/20 Advisory Committee for years, including being a co-chair on the group's subcommittee on modernization and economy, efficiency and effectiveness of town government.

He's now retired and still serving as an adviser on government efficiency at Hudson Valley Pattern for Progress Group. He had a career in state government, including stints in the Division of the Budget and the comptroller's office. He was the executive director of the Commission on Local Government Efficiency.

"Management is a continuous job... you cannot lead a large group of people unless you have their trust," Clarkson said at Thursday's debate. "I'm very proud of my reputation in state government, and people have approved of what I've done."

Clarkson lives in Slingerlands with his wife and has two children.

Kyle Kotary

Kotary is endorsed by the Democratic, Republican and Independence parties. He's nearing the end of his sixth year on the Town Board, and is midway through his second term having first been elected in 2005.

He owns an Albany-based communications firm, Empire Public Affairs, specializing in public relations work. Over the years, he's worked at various levels of government, often in a communications role, including as communications director in the state Senate and as a special assistant in the U.S. Department of Health and Human Services.

"I know what it's like to make a payroll, I know what it's like to manage groups small and large," Kotary said at Thursday's debate. "We need a super who's going to set the vision, who's going to work with the board to get the majority if not the entire board to support that vision."



"She said she did not need to hear her," she said. "She saw she made chambers and got second place in Colonie Idol and just knew she was good."

All of this confidence stems from a third grade talent show at Forts Ferry Elementary School where D'ippolitti opened the show with a number from "Mary Poppins" and close the show with the song "Car Wash" by Rose Royce. Afterwards, everyone was telling her how well she did.

"I sang and afterwards everyone told me I was really good, even though I was shaking and nervous," she said. "That made me realize I

When she performed a song from "Mary Poppins," some of her classmates acted as backup dancers behind her. She had been taking dance classes at Cindy's Academy of Dance, which she incorporated into her performance. The classes were a means to keep her active on the weekends.

Someone in the audience yelled, "Licorice!" and Kat Koppett thought quickly.

Licorice. Licorice. Did she have a prominent memory of licorice? A funny story about licorice?

She thought back to when she was a kid, when she would visit her grandmother in her tiny apartment in New York City. There was a bowl in the apartment, and it was always full of soft licorice.

"I would always kind of steal pieces of licorice," Koppett said.


Aha. There was her story.

Koppett shared it during a recent performance at Proctors Theater with the Mop and Bucket Co., the improv group she co-directs. It was part of the group's most recent show, "Chortle Combat," a new format that has Koppett and co-director Michael Burns excited. During a recent interview, both also talked enthusiastically about four actors who recently joined the troupe.

The Mop and Bucket Co. moved into Proctors' basement about a year ago, hosting weekly shows on Friday nights. There's Theatersports, where teams of actors vie for the audience's approval by turning suggestions into scenes, songs and stories; Spontaneous Broadway, in which musical numbers are inspired by audience suggestions, and Tapestry, which turns audience suggestions into "epic stories."

And, for the last month or so, there's been Chortle Combat. Koppett said the group was looking for a new format, one that would let the actors have more say in the show. That way, if the audience one night seemed to really be into musical numbers, the actors could incorporate more of those into the show. If "clever word games" proved to be a hit, there could be more of those.

The way Chortle Combat works is two actors - it changes each time -

are chosen as directors. They share the remaining actors for the first part of the show, putting on skits that they hope will win the audience's favor. Because when the first act wraps up, the audience votes on which director they liked better, and he or she gets

words, and then have the actors create scenes where they demonstrate passion for one of the words.

The second half, meanwhile, tends to be "longer-form" improv, meaning it's one continuous story or play. The audience might be asked to suggest

to choose the format for the second half of the night.

The first act usually involves smaller, shorter skits. Koppett gave an example of a director who wants to focus on passion, "explore what people care about." He or she might ask the crowd for 10 or 15

musical, and then the actors spend the rest of the show creating it. An actor might have to tell a true story based on a word from the audience, as was the case when someone shouted "Licorice!" and Koppett took the audience back to her childhood visits to her grandmother's. From there, she talked about her grandmother's early life in Russia and how she eventually came to the United States. The story was a springboard for the other actors to "pull out stories, songs and scenes" for the rest of the show, Koppett said. One acted out someone sharing the history of his or her family. Another built a scene around the idea of being an outsider in a new place. One did a scene about drinking vodka.

The format, Koppett said, is fun for the actors because it gives them a chance to do so many different kinds of improv. "It's a great training

ground," she said. "It helps them feel supported and successful."

To that end, Mop and Bucket recently cast four new members, who will be getting their feet wet here and there for the next few weeks before a welcoming show in early October at Proctors. They had limited

improv experience, but Burns said he and Koppett have been hoping to land each for a while.

"All four, when they auditioned, it was like, 'Oh goodie, they're as great as we thought,'" he said.

It's not improv experience that's important, he said.



to the Lustgarten Foundation, as well.

Some even participate if they can't make the walk.

"Because we've been so successful, it's exhilarating," said organizer Shari Piper. "We have quite a few virtual walkers, people who register online with their family group and then fundraise in their own geographical area."

Shari's husband, Neil, has over the years lost his mother, cousin, sister and brother to the disease, and he has felt the touch of pancreatic cancer as well, having undergone a surgery just last year to remove a suspicious growth from his pancreas. It was detected as part of an early detection study at John Hopkins University that was partially funded by Lustgarten.

Neil has made a great recovery and retained 40 percent of his pancreas, which allows him to live healthy and drug-free. He will be walking on Sunday.

Pancreatic cancer is the fourth

most deadly cancer in the U.S., in large part because there is a lack of effective early screening tools or treatments. Since there aren't usually symptoms, most cases of the cancer are caught in the late stages when a recovery is unlikely. Sadly, many of those who participate in the Walk for Hope do so in remembrance of a family member, Shari Piper said.

"It's one of those cancers that's not found generally until its in stage 4," she said. "You don't have the

inspirational survivors, but we are starting to see some."

The Walk for Hope isn't just about fundraising, though. Before and after the walk there will be plenty opportunities for fun and fellowship. The band Code Blue will be playing, there will be silent auctions, a visit from the Albany Devil Dawg, face painting and The Puppet People. The Coccadotts Cake Shop van will be on hand for a post-walk pick-me-up, with part of the proceeds going to benefit the Lustgarten Foundation.

Kate Welshofer, weeknight anchor for YNN, will serve as emcee.

The Walk for Hope steps off at 10:30 a.m. on Sept. 11 from the large pavilion at Elm Avenue Park, rain or shine. The step off will be preceded by a moment of silence for victims of pancreatic cancer and the terrorist attacks of Sept. 11, 2001. The walk is 1.2 miles long but many go around more than once. Strollers and wheelchairs are able to take the course.

this year would be struck from the budget.

These measures were influenced by many factors, said Comptroller Suzanne Traylor, not the least of which is soaring pension contributions. The impending loss of \$1.75 million in PILOT receipts in 2013 and the state's 2 percent yearly tax cap also played a role

in coming up with the tax hike, she said.

The levying of taxes is also a consideration when it comes to the town's bond rating, which highly influences the rates it can get when borrowing money. Bethlehem has a AA rating now, which is near the top of the scale.

"We risk the downgrading of our bond rating. ... The property tax represents the collateral [on the loan]," Traylor said.

Officials also set out with the goal of minimizing the town's spending of reserve money. Indeed, the draft calls for about half of the amount of fund balance spending this year, at a proposed \$1 million.

Other notable features of the draft plan: the town would forgo a reassessment in 2012 and 2013 — the town's at 97 percent of a full assessment now; copays for doctor visits for town employees would be increased to \$25; 3 percent rate increases were built

into the water and sewer funds.

It's possible the budget will see shifts in the coming months before the adoption target of Nov. 9. Compounding budgetary issues is the damage caused by Tropical Storm Irene. The town's still cataloging the destruction to its infrastructure; a price tag on repairs could take some time (see related story on page 1).

The next budget workshop is scheduled for Thursday, Sept. 15.

Voters urged to double check polling places

Residents eligible to vote in the upcoming primary — or planning to vote in November's general election — are advised to double check

their polling places.

Due to Albany County's recent redrawing of legislative district boundaries, some residents might find themselves assigned a different polling place than they are accustomed to. Redistricting generally only comes along once a decade, when the U.S. Census is conducted.

Voters can check their polling place in several ways. The Board

of Elections mails out reminders every election, and these yellow postcards list the voter's correct polling place.

Those who are still unsure or don't have the card can contact the Board of Elections at 487-5060 or visit albanycounty.com/voteinfo where there is a tool to look up polling places by address.

The primary election is on Sept. 13, and the general election is on Nov.

Interfaith blood drive to commemorate 9/11 anniversary

"We are here to reclaim our religion back and educate what the true teachings of Islam really are."



light. Unfortunately, Islam has been hijacked by terrorists who wish to subvert its peaceful message for their own political agenda," said Khan. "We are here to reclaim our religion back and educate what the true teachings of Islam really are, which is simply [that] Islam means peace."

The events of 9/11 affected the Ahmadiyya Muslim Community in a

huge way, said Khan. "It made us realize that we needed to step up and shout even louder what the true teachings of Islam are, to help both Muslims and non-Muslims alike," said Khan. "After the tragic events of 9/11, we were in acute stages of pain as these hijackers demolished people's lives, not only within New York City and around the world, but also destroyed the true teaching of Islam where terrorism is absolutely forbidden in any form."

drawing whose proceeds go to the American Cancer Society.







on in the game."

Rockmore isn't the only Bethlehem player dealing with an injury as the season starts Wednesday. Six other Eagles had minor injuries as the team wrapped up its preseason last weekend.

"That's why I keep 27 players on the roster," said Ridgway. "There are some little knocks — a lot of ankles and some shins, but nothing out of the ordinary."

"The depth is great," said senior defender Brad Campion. "We took a lot of numbers because of the injuries, but the number of players we took was because they can all play."

Campion and goaltender Alex Kessler are two of the anchors in Bethlehem's backfield this season. De-

fenders Kevin Maddock and Seth Partridge also return for their senior seasons.

"They know the routine, and they know the system of play, which helps a lot," said Ridgway.

That veteran defense will come in handy for Bethlehem this season, since goals could be hard to come by in a highly-competitive Suburban Council.

"It's not too much pressure [on us] because we are returning three starters, and a lot of the teams in the league have lost a lot of players on their defenses," said Campion.

The South Division alone could be tricky for Bethlehem. Several teams have their sights set on first place including the Eagles' two closest rivals in terms of distance — Guilderland and Colonie.

"Guilderland will be very good. They have a lot of guys back from last year. And Colonie is always strong," said Ridgway. "I [also] think Mohonasen will be better than they were last year."

As difficult as the South Division will be to navigate, the true strength of the Suburban Council is likely to be the North Division where all six teams — Ballston Spa, Saratoga Springs, Shenendehowa, Niskayuna, Shaker and Burnt Hills-Ballston Lake — are legitimate Section II title contenders.

"It's going to be a tough go in the North Division because everyone has got players back," said Ridgway.

Bethlehem avoids the North Division through the first three games. After hosting Averill Park Wednesday, the Eagles play Guilderland Friday before traveling to Colonie Tuesday, Sept. 13. Their first cross-divisional game is Thursday, Sept. 15, against Burnt Hills-Ballston Lake.

Campion said the Guilderland and Colonie games are important for Bethlehem.

"Guilderland and Colonie are definitely threats [in the South Division]," said Campion. "We face them twice, so we have to step up when we play them."



"It's a physical game going from JV [junior varsity] to varsity," said Gunty. "I'm just going to play my game, but I'll be showing them how to play and react to what's going

Now that I've been on Twitter for a few months (@jonas_spotlight), I'm starting to think that I could actually write a game story based on my Tweets.

Since I'm trying to provide my followers — all 47 of them as of last Friday — with the latest updates from the games I'm at, I find that I'm actually providing a narrative if you extract my Tweets from all of the other Tweets on the news feed.

Greetings from Clifton Park, where the host team [Clifton Park] has a runner on third with two outs in the 1st [inning].


Bad throw by Guilderland catcher allows Clifton Park runner to score for 1st run.

(Side note: I didn't Tweet during the second and third

On Clifton Park's second run of 1st inning, the run came home on a throwing error, not an infield hit. [Yes, I make corrections as I go.]

Neither pitcher has allowed a hit through 3 [innings].

No hits for either team through 4 innings.

A walk and a double steal gives Guilderland runners on 2nd and 3rd.

(Side note: It's hard to judge when I've reached 140 characters on my cell phone, since my text messages can stretch nearly 2,300 characters at a time. It's very irritating to try to do math while writing a Tweet via text message, so I just shorten everything.)

its first run.

Guilderland leaves the bases loaded in the 6th. CP leads 4-1.

Going into the 7th inning with CP leading Guilderland 4-1 [and my grammar begins to take a hit].

Guilderland loads the bases with 1 out.

Brandon Peda's hard shot hits teammate running from second for 2nd out, but a run scores.

Correction — no run scored, and then Cameron Long popped out to end the game.

Final score: Clifton Park beats Guilderland 4-1 to advance to tonight's final.

So looking at how all the Tweets fit together, I can safely say that I can construct a narrative out of them to get the basics of a story. However, the grammar would not be considered good journalistic style.

This is not to say you shouldn't follow me on Twitter, though. After all, as you can see by this sample, I do a pretty good job of keeping my followers updated as to what is going on with the games.
