# Long list for Town Board seat

## Bethlehem members meeting with hopefuls

With a Bethlehem Town Board seat set to be vacated at the start of 2012, the four known members of the board are meeting with a lengthy list of candidates interested in an appointment to the body, and for the first time, a list of names has been revealed.

Incoming Supervisor John Clarkson has identified eight candidates he's considering for the position, including former state commissioners, former board members and Bethlehem residents who are active in town government.

All eight, Clarkson said, have told him that they have no interest in holding the seat past 2012, a factor the supervisor-elect has said is important to him.

"These are people who I know of or know well enough that I've asked the other board

members to consider them," said Clarkson.

Clarkson said there have been "at least a couple" of resumes that have been submitted to the town in addition to the eight names. He said there may be people who have expressed interest to other board members as well. In all, nine names are now known. They include former Bethlehem Supervisor Jack Cunningham, who announced Dec. 14 that he would seek appointment to the board.

# Back from the brink



## Normanside changed hands in early 2011; improvements slated for 2012

In February, the future of the Normanside Country Club in Delmar was very much in question.

Months after a debate that even included discussions of the property becoming municipally owned, the club's new owners are putting new life into Normanside, while keeping the amenities that members were accustomed to.

"By the end of the year, we were happy with where things were at, how things progressed, and it beat our expectations," said David Hostig, the director of operations at Normanside.

Hostig's family, along with Rafael Flores, who owns country clubs elsewhere, made up an investment team that purchased the club for \$1,575,000. The chief change the group instituted was to open up the once-private course to the public.

Memberships were reinstated at a reduced price, too, but Hostig said the quality didn't suffer at all. He said members had the same experience but saw improvements to the golf course and an upgrade to the food being served at the club.

"We're seeing a lot of people looking into memberships that didn't have the country club membership before, or may not have been affiliated with the club," said Hostig. "They are not just old members who were members at Normanside before."

He added that they are still seeing many of those who had Normanside memberships in the past.



Rounds of golf are also available for non-members, and one constant mission for Hostig and staff is to promote the club's restaurant, Grille One Six Five, which is open to the public.

"The hardest thing for us right now is getting people to realize that this restaurant is here, first off, because we're not right on the main road, and also that we are open to the public," said Hostig.

The new ownership group put in a bid that exceeded the \$1.5 million figure submitted by the Town of Bethlehem. Hostig said the relationship  **Back Page 10**

## The top stories of 2011

### July

**Slingerlands student has made name for herself at young age**

Phoebe Gatta has six months until she graduates from Bethlehem Central High School, but since third grade, she's known that she wanted to be an artist.

Specifically, Gatta has her eyes set on the fashion world, and she has made a name for herself at a young age with striking and colorful designs.

"I think why I've known what I wanted to do is because I've been influenced by such strong personalities like my mom, my sister, and my dad," said Gatta while displaying some of her pieces at her home.

While she has received some of her training at BC High, Gatta has sharpened her skills during weekend and summer college courses offered by the Fashion Institute of Technology in New York City, along with classes put on by Syracuse University and Marist College.

Gatta has created a multitude of pieces, from quilts with intricate designs to handbags and accessories that she displays through her Facebook page (P. R. G. Designs).

Like any teenager, Gatta has times when she isn't sure what the future holds. When she starts a piece, however, the picture gets a lot clearer.

"I tell my parents all the time that I can stay up until 2 a.m. and not even think an hour has gone by because I'm so involved with the piece that I'm doing, I'm in love with it so much, that I just can't think of doing anything else," said Gatta.

Part of her drive and inspiration can be traced back to her mother, Deidre, who has an art background and years of experience as a successful interior designer. That experience has helped her to guide her daughter.

"Being an artist, I actually would take a step back and I wouldn't say anything unless she would approach me," said Deidre Gatta. "Then, I would give her sometimes a tough

criticism, because I remember my time in college. The professors can be extremely tough on you."

While offering advice, Deidre Gatta understands what the future could hold for her daughter.

"Being in the profession, I've seen people that have the

potential, and that don't," said Gatta. "She has it, and I feel the colleges that she's looking at and the classes that she's taking, she'll do very well. She knows that it is a long road."

For now, Phoebe Gatta is creating more designs, mainly accessory pieces. She is exploring more and more opportunities, and has even met with a designer in the

Schenectady area to try and land an internship. She knows, however, that she lives a little more than two hours north from New York City, a major fashion hub.

"I am trying to get some things here, but every time I go into the city, I fall in love with it more and more. I've always felt like that's where I've wanted to

be," said Gatta.

Gatta said she pictures herself as an assistant designer or owning her own boutique. However, she remains grounded and knows she has to take things one step at a time.

"She's one of these very fortunate students where she knows where she wants to be," said Deidre Gatta.



# Police: Man assumed dead brother's identity

The Albany County Sheriff's Office reported the arrest of a man they say gave authorities his dead brother's name when stopped Dec. 22 in New Scotland.

Jean M. Cesar, 41, of Haiti was stopped along Route 443 after a Sheriff's sergeant observed a traffic violation. Cesar gave authorities a Pennsylvania license with the name Jean H. Cesar.

According to the Sheriff's Office, Cesar was found in possession of more than two grams of crack cocaine and two plastic bags of marijuana. He was charged with criminal possession of a controlled substance, a felony. Cesar was arraigned in Bethlehem Town Court and remanded to the Albany County Correctional Facility.

Further investigation revealed that Cesar used the identification of his brother, who died in August.

Cesar was also charged with forgery, a felony. He was set to be arraigned Dec. 30 in New Scotland Town Court, and will also be re-arraigned under his real name on the drug charges against him.

The Sheriff's Office said Cesar faces forgery and criminal impersonation charges in Colonie for allegedly using a false name when booked into the Correctional Facility.

Because Cesar is not a citizen, U.S. Customs and Immigrations Officers are investigating the matter as well, according to the Sheriff's Office. Cesar is also wanted in Georgia for a parole violation.

## Mall brawl leads to two arrests


Two men have been arrested after a fight broke out at Crossgates Mall, with the victims sustaining minor injuries. Guilderland police received a call at 5:37 p.m. on Dec. 28 about a fight between four people inside the mall. Police said Kevin Miguel Fontanez, 19, and Roberto Alexander Valentin, Jr., 20, used nunchucks, a knife and a baton during the fight with the intent to injure the other men. Fontanez and Valentin were each charged with assault with intent to cause physical injury with a weapon, a felony.

A traffic stop ended with an Albany woman being hit with drug charges on Sunday, Dec. 18, according to State Police reports.

State Police arrested Nyketa S. Hilts, 25, of Albany, and charged her with criminal possession of marijuana, a felony, according to police reports.

Around 5:44 p.m., police stopped Hilts' 2001 Lexus on I-787 in the City of Albany for having an unsecured rear license plate and Hilts was found to be in possession of a large suitcase that contained about 35 pounds of marijuana, according to police reports.

Hilts was arraigned and remanded to the Albany County jail in lieu of \$15,000 bail.

## Woman charged with theft from booster club

A Clifton Park woman was arrested for allegedly stealing from a booster club on Friday, Dec. 23, according to State Police reports.

Kelly DeRosa, 44, of Clifton Park, was charged with two counts of grand larceny in the third degree, falsifying business records in the first degree and three counts of criminal possession of a forged instrument in the second degree, all felonies, as well as petit larceny.

State Police received a complaint of a larceny from the Ultimate Cheer Booster Club in the Town of Colonie, and while investigating the report it was discovered that DeRosa stole \$9,040 from the club and \$32,440 from the Pepsico Foundation, according to police reports. DeRosa was also found to have stolen a check from the Booster Club which she then forged, and she forged contract applications to Pepsico in order to fraudulently receive donations, according to police reports.

## Mom, daughter charged with burglaries

State Police arrested a mother and daughter for allegedly burglarizing several homes in the towns of Princetown and Duaneburg.

State Police on Tuesday, Dec. 20, received a complaint of a daytime burglary at a Princetown residence. As police were investigating the reported burglary, a woman called police claiming she had been woken by an unknown female in her residence. The witness provided police with a description of the woman and the vehicle in which she fled from the witness' home.

A short time later, State Police saw a vehicle

matching the description and police stopped the vehicle on State Route 159 in Princetown. The occupants of the vehicle were Terry Hutton, 49, of 2205 Broadway Avenue, Schenectady, and her daughter Crystal Renkawitz, 28, of 1068 Pleasant Street, Schenectady.

Several items of stolen property from area residences were allegedly located inside the vehicle.

The investigation led police to obtain a search warrant for Renkawitz's apartment, where they allegedly found several more items of stolen property reported to be taken from recent burglaries in Princetown. Police believe the suspects are responsible for at least five other burglaries

in Princetown and Duaneburg.

State Police arrested Hutton and Renkawitz on the charge of burglary in the second degree, a felony.

Both women were arraigned before Town of Princetown Justice Michelle VaWoert. Hutton was remanded to the Schenectady County jail without bail and Renkawitz was remanded to the county jail in lieu of \$10,000 bail.

# Celebrating milestones with our Sweet Patriarch

Disclaimer: The following is not a eulogy.

I say this because every time I write something about my father he claims it's his eulogy. Or he makes photocopies of the column and offers to sign them for people in his apartment building. Once he made me sign the complimentary issue of the newspaper kept in the coffee shop, as if I were some kind of celebrity. He is obviously a proud papa. What other kind of guy keeps on his desk until retirement a pencil holder fashioned out of Popsicle sticks painted blue?

So, in December 2010, inspired by Neil Diamond, I wrote a birthday song for my dad, honoring his various hobbies and accomplishments. All the kids and grandkids were present, including my nephew Joe who had just returned from a semester in Spain. Together we sang "Sweet Patriarch" (to the tune of "Sweet Caroline"):

*Where it began  
Was back in Brooklyn,  
New York  
In the year 1929;  
Gittel the mom  
Gave birth to baby Jerry  
She raised him to be  
mighty fine;  
Hands, carving wood*



*Carving clocks,  
Clocks for me, Clocks  
for you;  
Sweet Patriarch  
(ba, ba, bahmm)  
You are here  
And we feel good  
(so good, so good, so  
good)  
We've grown up fine  
Just the way you knew  
we would;  
Joe's back from Spain  
Everyone's back in New  
York  
And today you turn 81;  
You're an old guy  
Still acting like your  
sixteen  
Telling us jokes and  
having fun;  
Poker, Playing Poker  
Winning Cash  
Cash for me, Cash for  
you;  
Sweet Patriarch  
(ba, ba, bahmm)  
You are here  
And we feel good  
(so good, so good, so  
good)  
We've grown up fine  
Just the way you knew  
we would

his birthday, despite  
feeling particularly*

crappy, my dad kept his promise to come see his granddaughter perform in her high school play. It was five minutes before opening curtain. Outside the auditorium door my brother, sister and I were standing in the lobby circling the chair in which my father was seated. Dad looked like hell. He wasn't sure he had the breath or energy to walk to his seat. "Should we be going to the emergency room?" we asked.

"No," said Dad, "I told you I'd come to the school play. And then we'll all go out to dinner."

Despite numerous medical issues, my dad has kept up his spirits by looking forward to and participating in a series of family milestones: a bat mitzvah, a birthday, an awards ceremony, a concert, a play, etc.

And yet, there are times when it's more important to seek medical attention than to attend the school play. You don't want to have to say to your child, "Grandpa was here, honey, but we can only give him partial credit for attendance. Unfortunately he keeled over in the lobby before the announcement regarding the emergency

exits and prohibitions on flash photography."

Since my father is not one to be bossed around by his three grown, loving, responsible children, we helped him to his seat. During the show I monitored his oxygen tanks and woke him up whenever my daughter was on stage.

After the show, when Dad barely had the energy to exit the auditorium, we again asked, "Should we be going to the emergency room?"

"No," said Dad, "I want you to go out to dinner."

At the restaurant Dad remained unusually quiet. No joking with us, no flirting with the waitress. Clearly he felt awful.

The next day he was admitted to the hospital. It was the end of March.

At my office, a colleague asked about my dad. I told her, "He's got fluid on his lungs, so they put him on some diuretics." I said this in the same manner that someone might say, "Yeah we've got some water in the basement, but we've cleaned out the French drain and the sump pump is taking care of the situation."

My colleague said,

"Congestive heart failure or pneumonia?"

"Um, all I've heard is that he's got fluid on his lungs."

She said, "That means either congestive heart failure or pneumonia."

I thought to myself: Well, no one's mentioned anything to me about him having pneumonia, and congestive heart failure sounds really, really bad, so I'm sticking with "fluid on the lungs" which sounds somewhat less ominous.

It was congestive heart failure, which is really, really bad.

And yet, after four nights, he was discharged. Two weeks later the kidney specialist asked, "Who do you live with?" Dad responded, "No one. My wife couldn't stand me anymore, so she left me." The doctor was writing notes so he didn't see me rolling my eyes. He asked, "How long have you lived alone?" Dad replied with the exact date, to which the doctor asked, "Is that how long you've been divorced?" I jumped in, "He's NOT divorced. My mother didn't leave him. She died. He was making a joke." I wanted to smack him, but I decided instead to be grateful that he was

still alive.

Six months later, in November, Dad was back in the hospital. It was congestive heart failure again. After a week the diuretics started to take a major toll on his kidneys.

My birthday was now just five days away, "You bastard," I told him, "you better not die on my birthday. Plus your birthday is next month."

"I'll try to hang on until at least your birthday," he said quietly, making it clear that he was at peace, and he was not afraid to die. And yet, it was not his time.

It's hard to convey the joy and wonder my family felt when we gathered for Dad's 82nd birthday on December 20th. After dinner we sang a revised version of "Sweet Patriarch." This year, Joe had just returned from Oregon, and the phrase "telling us jokes and having fun" was changed to "telling us jokes both old and new" to rhyme with "82."

It is troublesome for me to see a former Town Supervisor seeking Town Board support to fill a Board seat that will become vacant on January 1, 2012.

I am a member of the Independence Party. I vote for the person who I believe will do the best for our Town. I am not alone. In recent elections Bethlehem voters have responded in a clear and resounding way they want elected officials who serve their community, not politics and themselves, first. They have rejected self-serving candidates who have a misguided sense of their right to hold public office.





narrow it down or they might put another name in there. At this point, the nine are people who have put their names out there," said Clarkson.

Cunningham's name is not featured on Clarkson's candidate list. The incoming supervisor said he would not be supporting Cunningham's bid, and Cunningham said he would be running for the seat in November 2012 no matter what.

Board members for 2012 include Clarkson, Kyle Kotary, Joann Dawson and Jeffrey Kuhn. The fifth seat is the one being vacated by Mark Jordan, who ran unopposed for a Town Justice seat in November.

Jordan's term on the Town Board expires at the end of 2013. A special election will be held in November for the right to serve the final year of Jordan's term. Another election will be held in 2013 for the chance to serve a full four-year term on the board.

One candidate is Ted Putney, a Selkirk resident and former town board member who said he is interested in town government and issues like open space.

"I just enjoy it. I think I have enough experience to be able to be effective for a year, and that's what I want to do," said Putney.

The eight candidates put forth by Clarkson, have all said they have no interest in serving any longer than a single year on the board, according to Clarkson. He has publicly stated that he believes the

board should select a non-political appointee who has no interest in serving beyond 2012.

There is also a growing possibility that a public meeting would be held to collect input from town residents.

As of Dec. 28, the nine known candidates for the town board seat are:

- Kevin Crawford, executive director of the New York Municipal Insurance Reciprocal and member of the town's 2020 Implementation Committee

John Hudacs, former commissioner of the state Office of General Services and state Department of Labor, and 2020 committee member

• Christina Kidera, finance specialist for 35 years with state Division of the Budget

• George Lenhardt, former Town Board member (1994-2005), and current chair of the town's Board of Ambulance Commissioners

• Ted Putney, former Town Board member (1994-97) and member of Bethlehem Industrial Development Agency board

• Loretta Simon, a member of the Board of Directors of the Albany County League of Women Voters

as it did in the beginning of the 20th century.

• The Bethlehem Police Department puts two officers on two wheels with the establishment of bike units to patrol the town during the summer. Chief Louis Corsi says the department has considered the idea in the past, but with growing amounts of development over the past two years, he says the idea now makes more sense than ever.

• The state Department of Environmental Conservation accepts the final environmental impact statement (FEIS) for a modernization project at the Lafarge cement plant in Ravena. It's a significant step forward for the \$400 million dollar project, which consists of a replacement of the facility's wet kiln with a more efficient dry kiln. Later in the month, the DEC issues air and water discharge permits needed for the project.

• Bethlehem supervisor candidate John Clarkson gains the endorsement of the Conservative Party and turns down the endorsement of the Working Families Party. Clarkson files 850 signatures to primary Kyle Kotary on the Democratic

line in September. Challenges are filed to Clarkson's petition to be included in the Democratic primary. Steven Thomas, who filed the challenge, says he and members of the town's Democratic Committee reviewed Clarkson's petition signatures and found various errors. Kotary says he has asked all his Democratic supporters to not object to Clarkson's petitions.

Kotary files a lawsuit seeking to invalidate Clarkson's Conservative Party nomination on the grounds of improper notarization. Clarkson questions the motive of the lawsuit, while Kotary raises questions about a "shady, midnight deal" to get Clarkson on the Conservative Party line.

• The Working Families Party makes a new choice in the race for supervisor of Bethlehem. Richard Reeves-Ellington gains the endorsement of the party, which first backed Messina, then was notified that Clarkson would not accept its endorsement.

• The Bethlehem Town Board gives approval to the Bethlehem Babe Ruth league for construction of a large shed at the town's Elm Avenue Park. Construction of the shed started when league officials obtained

with the town has been strong.

"They've been willing to work with us on anything we've thought up, or anything that has come across with them," Hostig said. "Some of their board members have supported us. I've seen them in the restaurant. It's nice to have that support from the town."

In turn, the club has tried to make its presence known. Recently, the club's owners donated sauce for a pizza sale held by fifth graders at Elsmere Elementary School.

Without having completed a full year at Normanside, Hostig said it's tough to see what kind of impact the economy has had on the club. However, increases in memberships and a 250-person turnout for Thanksgiving are indications that the club is headed in the right

direction.

"We're really excited about next year," said Hostig. "We think that things are going to start booming after March."

Renovations are planned for the lobby and ballroom at the Normanside clubhouse. The owners are able to commit to the projects due to early success and because they are not on the hook for the debt accrued by the club's previous owners, Hostig said.

a building permit from the town, however, it was halted when town officials realized the work had started without the board's approval.

• At its yearly organizational meeting, the Bethlehem Central Board of Education appoints Diane Giacone-Stever as president and Matt Downey as vice president for the 2011-12 school year. Stever, who was vice president the previous year, takes over for James Dering, who did not seek another three-year term in the May election.

• Guilderland Town Clerk Rosemary Centi notifies Supervisor Kenneth Runion that she will no longer serve as the town's marriage officer. Centi cites her Catholic faith as the reason for the decision. In July, a new state law took effect allowing same-sex couples to marry. Centi will continue to issue marriage licenses but won't officiate over any ceremonies at Town Hall.

• The search for a new superintendent of the Bethlehem Central School District is narrowed down to three candidates. Board of Education members prepare to interview

the final candidates chosen from a pool of 40 applicants.

• Army Specialist Rafael Nieves, 22, is remembered during a service at McKownville United Methodist Church in Guilderland. Nieves, a 2008 Guilderland High School graduate, was killed in Afghanistan when his mounted patrol unit came under attack by enemy forces. Nieves joined the Army in 2009.

## August

• Elisabeth Smith, the Assistant Superintendent for Curriculum and Instruction in the Ravena-Coeymans-Selkirk Central School District, is chosen as interim superintendent. Smith takes over for Daniel Teplesky, whose resignation took effect at the beginning of the month. A search for a permanent replacement continues.

• Albany County Supreme Court Judge Thomas McNamara rules in favor of Kyle Kotary's lawsuit seeking to invalidate the Conservative Party's endorsement of John Clarkson for supervisor. Instead of leaving Conservatives without a candidate, members of the party will have an opportunity to write in a candidate of their choice

in a September primary.

• Campaign finance filings show Kotary with more than four times the fundraising money as Clarkson weeks before the Democratic primary. Kotary criticizes Clarkson for not meeting deadlines to file campaign finance information, saying he has properly and punctually filed his public statements. Clarkson says his campaign is filing all information properly, and had a problem with a PIN number needed to file his information electronically with the state Board of Elections.

• In a split vote, the Bethlehem Town Board votes down a proposal to hold a public hearing on a proposal to extend the supervisor's term from two to four years. Kotary and Supervisor Sam Messina vote to advance the proposal, with board members Joann Dawson, Mark Hennessey and Mark Jordan voting it down.

• At the same meeting, Messina is the only one to support the use of \$35,000 for repairs to the tennis courts at the Elm Avenue Park. The four other board members express concern about using money from a parkland set aside fund. Dawson says it would be a moral violation of the purpose of that money.

Board members agree to amend Bethlehem's noise ordinance. The new regulations exempt businesses that were already in operation when the town adopted its noise law in 2009. New businesses will have to consider noise regulations when they appear before the town's Planning Board.

• A ruptured natural gas line along the Thruway in Guilderland leads to a highway closure and evacuations. The 12-inch gas main makes a loud noise alerting those nearby of the problem. The Thruway, between exits 23 and 24, is shut down, and several dozen people in nearby businesses and homes are evacuated until the problem is fixed. One construction worker

suffers a minor injury.

• Two local developers unveil their plans to build a travel plaza just south of the exit 22 tollbooths along the Thruway. The project would include construction of a small hotel, travel center and fast food-type restaurant along River Road.

• The 188th Altamont Fair is held, but bad weather hampers attendance on several days of the event. However, organizers say turnout remained strong at the fair, which featured the North American debut of The Stinger, a ride that spins fairgoers around and send them eight stories into the air.

• 504 Regents exams taken by Guilderland Central School District students are found to have

been graded incorrectly. 15 of the students who would have received failing grades if the test was graded properly will retain their passing grade. Superintendent Marie Wiles says the errors were mostly tabulation mistakes.

• The Town of Bethlehem receives no appropriate bidders for a project to install solar panels at the Elm Avenue Park. The project, which would be funded with \$111,500 of Recovery Act money, hits a snag when none of the bidders submit proposals within the amount and limitations of the federal award.

• Josh Cansler, the Town of Bethlehem's Commissioner of Public Works, announces he will

leave the department for a job with NATO in the Netherlands. Deputy Commissioner Erik Deyoe takes over as interim commissioner.

•A draft Bethlehem budget calls for \$38.6 million in spending and a 1.27 percent tax hike. The budget, prepared by Supervisor Sam Messina and Comptroller Suzanne Traylor, calls for no raises for town employees, and factors in a \$1.75 million loss in PILOT receipts in 2013.

•Downgraded from a hurricane, Tropical Storm Irene packs a serious punch as it sweeps through the northeast, including the Capital District. Bethlehem Highway Department Superintendent Gregg Sagendorph tells The Spotlight that in his 39 years with the town, he has never seen water higher in some of the town's streams than he did during the storm.

•A Clarksville woman dies after being swept into the Onesquethaw Creek during Irene. Police say Sharon Stein, 68, was last seen loading belongings into a car as she and her husband prepared to evacuate

their Slingerlands Avenue home. Stein's body was spotted more than four hours after she was reported missing by her husband.

## September

•Towns across the region try to assess the damage done by Tropical Storm Irene. Erik Deyoe, Bethlehem's deputy commissioner of public works, says some of the town's sewer facilities can't even be assessed due to high water levels. Water facilities in New Scotland are badly damaged as well.

•The Spotlight and League of Women Voters sponsor a highly anticipated debate between John Clarkson and Kyle Kotary, the two Democratic candidates for Bethlehem supervisor. Clarkson accuses Kotary of "a general pattern of obstruction" toward the agenda of Supervisor Sam Messina. Kotary touts his record, saying it is important to speak up and be accounted for when you have a difference of opinion.

•With more than 60 percent of Democratic voters supporting him, Clarkson wins a primary against Kotary, saying he is looking forward to unifying the Democratic Party. Kotary decides to continue his campaign,

running on the Republican and Independence lines.

•The state Court of Appeals hears arguments in the case of Christopher Porco, the man found guilty in 2006 of murdering his father and attempting to murder his mother inside the family's Bethlehem home. The appeal focuses on a head nod by Joan Porco the night of the attack when she was asked if her son was the assailant. Joan Porco claimed no memory of the head nod during the 2006 trial.

•Later in the month, the Bethlehem Town Board considers a Freedom of Information Law request by Christopher Porco. The board votes 2-2 on an appeal request by Porco, who previously failed to obtain copies of all materials related to the murder investigation that led to his conviction. The split vote means no response will be issued to Porco's appeal, which is effectively a refusal of the new request.

•A disaster recovery center is established in Voorheesville for residents impacted by Irene. Federal, state and county services are provided at the center at the Cornell Cooperative Extension.

•In an example of the outpouring of support in the wake of August

storms, members of the Delmar United Methodist Church load up two delivery trucks filled with household supplies, from rugs to sofas, and deliver them to residents of Schoharie County impacted by Irene. The church collects items from donations for its fall fair and reaches out to the community for items as well.

•The first-ever reported case of West Nile Virus in Albany County is announced to the public. County health officials release few details, but say the person is over 60 and was hospitalized for a short time. Officials link the incident to the amount of standing water brought on by flooding from Tropical Storm Irene.

•The parents of Jonathan Carey receive \$5 million in a settlement over the wrongful death of their son. Michael and Lisa Carey brought a suit against Edwin Tirado and Nadeem Mall, two caregivers at OD Heck, a state facility for the disabled. The men were caring for the boy, who was autistic, when he was asphyxiated and died on an outing.

## October

•Acting Albany County Sheriff Craig Apple first pitches an idea to the

Bethlehem Central School District regarding the use of Clarksville Elementary. Apple says he's interested in leasing space at the shuttered school for use as a substation. If approved, the Sheriff's Office would relocate from its space at the Cornell Cooperative Extension facility in Voorheesville.

•Apple says later in the month that he has had multiple conversations with members of the district regarding the proposal. BC Schools Superintendent Michael Tebbano says he's unaware of the conversations, adding that Apple has avoided a face-to-face meeting.

•Albany County Executive Michael Breslin unveils a preliminary budget proposal for 2012, which calls for a 19.2 percent property tax hike for residents. Breslin calls it the difficult and right thing to do. The budget would eliminate 89 vacant positions in an attempt to avoid layoffs.

•An independent audit of the BC schools shows a declining fund balance and growing expenditures due to increased employee benefit costs. The audit shows a \$2.4 million loss in revenues, and notes the district will have to pass its first budget for the 2012-2013 school year with a 2 percent property tax cap

in place.

•Notable Bethlehem police officer Christopher Hughes is charged with possession of a forged instrument. State Police say Hughes submitted a forged police retirement ID to a Kentucky-based company for processing. A search warrant was executed at Hughes' home in Feura Bush in March.

•Candidates for Bethlehem town offices participate in a debate sponsored by The Spotlight and the Albany County League of Women Voters. Supervisor candidates John Clarkson, Kyle Kotary and Richard Reeves-Ellington debate issues ranging from housing to open space. Four candidates for two Town Board seats debate what to do to spur economic development in the town while shedding an "anti-business" label. The standing room-only crowd at the Town Hall auditorium also hears from candidates for Bethlehem Receiver of Taxes and the 36th District seat on the Albany County Legislature.

## November

•Slingerlands resident John Clarkson is elected as the next supervisor of the Town of Bethlehem. Clarkson defeats Kyle Kotary and Richard Reeves-Ellington, saying he thinks the town can make progress moving forward. Incumbent Town Board member Joann Dawson wins another term in office, while newcomer Jeffrey Kuhn wins the race for a second seat on the board. In January, another seat will open up, as Councilman Mark Jordan ran unopposed for Town Justice, and will fill that role beginning in 2012.

•The Bethlehem Industrial Development Agency adopts a resolution for the first tax breaks to be granted to tenants at the Vista Technology Campus. In all, the PILOT agreements, or payments in lieu of taxes, will add up to about \$200,000 in tax breaks for ShopRite, SEFCU and Berkshire Bank – the first three tenants at the park. The businesses will be exempt from paying property taxes for their first two years, and will pay a sliding scale of taxes over the following ten years.

•A second attempt leads to a contract for a project to install solar panels at Elm Avenue Park in Bethlehem. The town awards a \$100,000 contract to a central New York company for installation of the panels. The town will contribute a small amount, with the rest of the money coming from a Recovery Act award to Bethlehem.

•Work wraps up on the portion of the parapet wall at Bethlehem Town Hall

# Town Board hears ideas for development

## 20/20 Committee strategies include new part-time job

Members of Bethlehem's 20/20 Implementation Committee have laid out suggestions to the Town Board regarding how the town can foster economic development.

During a recent presentation, members of the 20/20 Economic Development Subcommittee gave their recommendations for establishing an economic development strategy, including the addition of staff to make their goals more achievable.

"The report is meant to serve as a playback for future economic development," 20/20 and Industrial Development Agency member Joe Richardson told the board.

One significant suggestion was the addition of a half-time staff person who would be dedicated exclusively to the cultivation of economic development projects in the town.

"The new staff position would be helpful in representing Bethlehem in the regional collaboration that is taking

With a final presentation on citizen engagement and leadership, the 20/20 Implementation Committee, which has analyzed a number of elements of Bethlehem town government, wrapped up its work.

For now.

After presenting findings and recommendations to the Town Board over the past year ranging from commercial re-use of properties to potential unification of the town's highway and public works departments, members of the committee have finished

their main task of coming up with proposals to streamline town government.

Committee co-chairs Terri Egan (former Bethlehem supervisor) and George Leveille (Chairman of the Town's Planning Board) were at the Town Board's final meeting of the year on Wednesday, Dec. 28, to thank them for allowing and supporting this type of work.

"While we said this was our final, final report, George and I talked and to the extent that decisions are made as you move forward over the next couple of weeks, couple of months, and if there is an interest in convening this type of group again, we would certainly be open to having a conversation about process," Egan told the board.

The committee's work has

served as a spark for conversations regarding elected and appointed seats in town government and better ways to ensure the town is maximizing its revenues and monitoring its money.

Supervisor Sam Messina said the committee's work is an example of what sets Bethlehem apart.

"There's nowhere that I look at the state level, county level or other town or city levels that has quite the wealth of people volunteering their time, their energies, to come up with such wonderful documentation, such strong and clear guidance for the town board to consider in the future," said Messina.

include support for work at Vista, implementation of the New Scotland Road Hamlet Master Plan and a reconstitution of a Selkirk Yards Industrial District Focus Group to ensure the long-term viability of some of the town's largest employers and taxpayers.

Board members were also reminded of how vital it is to market what the town has through tools such as website marketing.

Richardson spoke about the opportunities the town must explore to promote economic development events "by using electronic newsletters, and with other cost-effective communication tools."

The recommendations within the 15-minute presentation drew no questions from the Town Board, which took no formal action to adopt any of the suggestions put forth by the 20/20 committee.

place," said Richardson, who argued that the town needs a "professional" at the table to promote Bethlehem.

The committee suggested that once resources are identified and as economic development growth occurs, the position should be increased to full time.

The recommendations highlight the point that the town is competing against more sophisticated

business organizations in neighboring communities in Saratoga, Schenectady and Greene counties.

"It's imperative, I think, from our perspective that the Town of Bethlehem has to take this under their wing and auspices, because the county of Albany has nothing to help us with this," said 20/20 member Keith Bennett.

The problem, committee members say, is that as currently staffed, the town is at a distinct

competitive disadvantage when it comes to bringing in new development in the region.

Another recommendation is for the town to leverage the resources of its Industrial Development Agency. That body has seen relatively little activity in the past few years, but has been a vital part of helping with financing and progress for the Vista Technology Campus in Slingerlands.

"This report lays the

ground work for beginning to identify short-term initiatives, while seeking more detailed discussion on specific long-term projects," said Richardson.




# From Maine potatoes to the main stage

**Ellis Paul to play Caffe Lena with shows for adults and kids**

**E**llis Paul went to Boston College on a track scholarship, but music wound up making a far bigger impact on his life than running.

Growing up on a potato farm in Maine, Paul's exposure to popular music was pretty much limited to a scratchy Top 40 station. At BC, he listened to singers like Bob Dylan and Joni Mitchell for the first time.

Paul also discovered the guitar at BC. After a track injury left him bedridden, the guitar was "a beacon," he said. He eventually transitioned from playing other people's songs to writing his own, and a career was born.

Paul felt a draw to folk music, and that's

where he's made his name, mentioned these days in the same breath as his early inspirations like Dylan and Mitchell. In the years since he graduated, Paul has heard his songs not just on the radio, but in a number of popular movies and television shows. He's also added children's music to his repertoire as a way to connect with his daughters, now 5 and 7.

Both of Paul's styles will be on display this weekend at Caffe Lena in Saratoga Springs. On Friday, Jan. 6, he'll give a show geared to adults at 7 p.m. On Saturday, Jan. 7, the whole family is invited for a performance at 11 a.m.

He called the family music "a natural extension" of his career. Paul has embraced folk music because it's bigger than just him; even when his songs are personal,

they touch on topics and emotions that are shared by so many others. That's the essence of folk music, he said.

"It's about the community, the collective process we're all going through," he said.

Make no mistake, Paul has seen his share of commercial success. He has 14 CDs to his credit. He's performed at Fenway Park for the Red Sox and Boston Garden for the Celtics. His songs have been featured in a number of commercials as well as on the television shows "Ed" and MTV's "Real World! The Farrelly brothers have tapped him for music in three of their movies: "Hall Pass," "Me, Myself, & Irene," and "Shallow Hal."

But, Paul says, his music has never been about turning a profit.

"There's a higher

purpose than making money," he said.

He has sung, for example, about Hurricane Katrina and about someone who was laid off. He tends, he said, to have empathy toward the people he's writing about, a hallmark of folk music. Another defining characteristic of folk music is that it relies solely on acoustic instruments. Paul, who was a trumpet player in his younger years, which earned him a summer scholarship to the Berklee College of Music, builds his concerts around a simple guitar.

He tours frequently, and Caffe Lena is a common stop. He loves the vibe of the venue, along with the history of Saratoga Springs. He calls Caffe Lena "an important place" and looks forward to engaging audiences of all ages.

Paul said the family shows have a special energy about them, with kids on their feet and moving around. Adults sing along to his songs, he said, "but they don't react physically."

"There's nothing like watching kids laugh," he added.

His first children's album, "The Dragonfly Races," was "kind of all over the place," Paul said. So for the second one, he decided to take a different approach, focusing on a theme. "The Hero in You" contains songs about

American heroes like Rosa Parks, Thomas Edison, Albert Einstein and Jackie Robinson. Pleased with the way the album turned out, Paul thinks he'll stick to the theme concept for future children's albums.

Tickets for the 6:30 and 9 p.m. Friday shows at Caffe Lena are \$25 in advance and \$27 at the door. Admission to the family show on Saturday is \$10 for adults and \$5 for children under 13. The show starts at 11 a.m. For more information, visit [www.caffelena.org](http://www.caffelena.org).





that fell earlier in the year. Supervisor Sam Messina says the cost of repairs for that portion of the building came to \$345,000. That's in addition to \$61,000 worth of emergency repairs done before the complete project was approved.

uptick in total attendance over their first two years while playing at Bleecker Stadium.

The on-field product was also good for the first half of the PGCBL season, as the Dutchmen contended for a playoff berth. Injuries and departures eventually took their toll on the Dutchmen, as they faded to a tie for third place in the four-team Eastern Division with an 18-29 record. The 18 wins still marked a franchise record, though.

One of Albany's top players was Guilderland High School graduate Steve Anderson. The first baseman/designated hitter belted a team-high six home runs and drove in 27 runs. LaSalle Institute graduate and Latham native Will Remillard came on strong in his first season of collegiate summer league ball with a .297 batting average and 24 RBI.

## Fall

- The College of Saint Rose women's soccer team won its first NCAA Division II title by beating Grand Valley State 2-1 in the finals. The Golden Knights had made the last three Final Fours only to lose in the semifinal round each time before breaking through in 2011.

- The Schalmont girls soccer team made school history by winning its first state championship. The Sabres completed a 23-0-0 season by beating Greece Olympia 4-0 in the Class B final. Megan Strijek led the way for Schalmont in the state tournament by scoring back-to-back hat tricks, which earned her the tournament's most valuable player award. Overall, Schalmont outscored its opponents 123-7 and didn't allow a goal in regionals or the state tournament.

Burnt Hills-Ballston Lake and Bethlehem both reached the state semifinals in girls soccer. BH-BL made its seventh consecutive trip to the Class A state tournament before losing in the semifinals, while Bethlehem went to the Class AA semifinals for the first time in school history.

- BH-BL's girls volleyball team won its fourth state title by defeating Mercy of Rochester 3-1 in the Class A final at the Glens Falls Civic Center. Kaitlyn Valade led the Lady Spartans with 15 kills and eight digs in the championship match, while Natalie Ziskin contributed 37 assists, six digs and three blocks. It was BH-BL's first state title since 2005.

Voorheesville made its second consecutive trip to the girls volleyball state tournament, but the Blackbirds were eliminated in pool play.

- For the third time in

four years, BH-BL's football team reached the Class A state final. This time, the Spartans led Maine-Endwell 20-14 before the Section IV representatives struck for two fourth-quarter touchdowns to pull out a 27-20 victory.

Shen was hoping for its own trip to the state finals, but Newburgh Free Academy stunned the Section II champions 16-6 in the Class AA semifinals. The loss ended Brent Steuerwald's coaching career, but not before he picked up his 25<sup>th</sup> league title and his 13<sup>th</sup> Sectional crown.

Schalmont had its own hopes of a state title in football dashed by Croton-Harmon in the Class B semifinals. Tigers' tailback Trevor Wolstencroft scored the go-ahead touchdown with 3:34 left in the fourth quarter to lead his team past the Sabres 15-12.

- The University at Albany football team earned a share of the Northeast Conference title and a berth in the NCAA Football Championship Subdivision playoffs, and Guilderland High School graduate Andrew Smith was a big part of it. Smith was the team's leading running back with 1,092 yards and 10 touchdowns. It was the Great Danes' first NCAA playoff berth at the Division I level.

- Things went swimmingly for Section II at the New York State Girls Swimming and Diving Championships in Buffalo. The region won its first intersectional title since 1999 with help from Niskayuna's Kina Zhou and Maggie Jordan – both of whom won individual events and swam as part of the Silver Warriors' state record-setting 400-yard freestyle relay team. Guilderville's Jenna Bickel defended her state title in the 100 backstroke, and Ballston Spa's Addison Walkowiak earned her first state diving championship.

- Shaker (boys) and Saratoga (girls) won the team titles at the Federation cross country championships. Shaker went on to win the Nike Team Nationals New York regional, while Saratoga

placed second both in the regional and the national meet.

- The Shenendehowa boys soccer team got as far as the state semifinals in Class AA before losing to Long Island champion Hicksville 3-0. The Plainsmen edged Colonie 3-2 for their 13<sup>th</sup> Sectional championship since 1988.

The Mohonasen boys soccer team won its third Class A Sectional championship in the last four years by beating Queensbury 2-0. Cameron McDermott and Joseph Avery scored first-half goals for the Mighty Warriors. East Syracuse-Minoa ended Mohonasen's season with a victory in the regional final.

- Shaker's Cat Crummey finished fourth at the state girls tennis tournament. Crummey reached the singles semifinals before losing to Wallkill's Morgan Herrmann 7-6, 0-6, 7-6. Crummey then fell to Seton Catholic's Claire Minnoe 6-4, 3-6, 6-3 in the third-place match.

- The Bethlehem boys volleyball team qualified for its second consecutive trip to the state Class A tournament by beating Shen for the Section II title and Suffern in regionals. The Eagles split their six pool play games at states.

- Shen avenged two regular season losses to Niskayuna by beating the Silver Warriors 2-1 in the Section II Class A field hockey championship game. The Plainswomen lost to Section IV champion Greene 1-0 in the regional round.





# Championships pile up for locals

## Bethlehem wins titles in girls soccer and boys volleyball

The second half of the 2011 sports season provided several highs, as well as a couple of lows. Here is a look back:

### Summer

- Clifton Park was more than a host to the Babe Ruth World Series last year. Clifton Park went to the national finals before being shut out by California's Tri-Valley 12-0. In making it that far, the Bulldogs became the fourth host team to reach the championship game in the history of the Babe Ruth World Series – a tournament that started in 1952.

- To get to the title game, Clifton Park had to get past Guilderland in the semifinals. The Bulldogs took advantage of four Guilderland errors to defeat the Eastern New York State champions 4-1. Clifton Park pitcher Mason Munger threw six innings of two-hit ball to lead the Bulldogs.

- Prior to the start of the Babe Ruth World Series, there was another significant story happening in Clifton Park as long-time Shenendehowa High School football coach Brent Steuerwald announced his retirement effective at the end of the 2011 season.

- Steuerwald started the Shen football program in 1967 and guided the Plainsmen to 24 league titles and 12 Section II championships through the 2010 season. The question would be, could the 2011 Plainsmen give Steuerwald one more championship? The answer would come

in the fall.

- In Saratoga Springs, the oldest thoroughbred race track continued to rake in the money for the city and the region. Saratoga Race Course saw an increase in on-track wagering in 2011, despite a slight drop in overall attendance. The economic impact of the 39-day racing season was estimated at \$200 million for the region, according to a study done by the Saratoga County Industrial Development Agency.

- On the track, trainer Todd Pletcher and jockey John Velazquez repeated as meet champions. Pletcher set a new Saratoga record by saddling 38 winners, while Velazquez rode 54 horses to the winner's circle. Mechanicville native Chad Brown was second to Pletcher in the trainer standings with a career-best 22 winners.

- The University at Albany's practice fields were unusually quiet in 2011, thanks to the National Football League lockout.

- When a collective bargaining agreement couldn't be reached in time to save the traditional training camp schedule, the New York Giants announced that they would not be coming to UAlbany for the first time in 15 years. Instead the team trained at their New Jersey facility. In the same statement, though, Giants principal owner John Mara said that it was his team's intention to return to UAlbany in 2012 to honor the final year of their contract with the university.

- The Albany Dutchmen saw some positive gains in 2011. Playing in a new stadium (Bellizzi Field) and in a new league (Perfect Game Collegiate Baseball League), the Dutchmen had an
