# **Smart** House breaks ground

**Living Resources'** modern G'land group home to house six residents

A modern and efficient living space is what many homeowners set out to achieve when building a house, but for those with developmental disabilities, that dream tends to be far from reality.

That is set to change with the construction of the state's first barrierfree "smart house" designed especially for those with intellectual and developmental disabilities. Living Resources, a Capital District nonprofit, held a groundbreaking ceremony on Wednesday, May 1, for the group home to be located off Ardsley Road in Guilderland.

Living Resources CEO Frederick Erlich said he was thrilled to see the project entering the final stage and the frame being built. It has been five years since the project was first conceived.

"As our residents age, they face more daunting challenges than other senior citizens because of

# Bethlehem to keep highway super position

## **Referendum fails by** vote of 3,086 to 1,969

The office of superintendent of highways in the Town of Bethlehem will remain an elected position after residents voted down a local law that would have placed its duties with the commissioner of public works.

The final unofficial vote count on the public referendum was 3,086 vote against to 1,969 votes for the abolishment of the superintendent as an elected position. The vote took place on Tuesday, April 30, the same day former Highway Superintendent Gregg Sagendorph chose to retire.

"The voters have spoken and while I'm disappointed that local law No. 1 wasn't affirmed, we have an agenda to fulfill

given the verdict," said Town Supervisor John Clarkson.

The supervisor said the next step is to spend the remainder of this year working with the Highway Department to "ensure the shared service savings already achieved with the cooperation of Gregg Sagendorph are preserved." The town will also be preparing the department

time on Saturday, May 4. The event is meant to encourage people to volunteer at their favorite local state park to assist with cleanup and beautification projects. The New York State Office of Parks, **Recreation and Historic** Preservation and Parks & Trails New York sponsor the event.

thought it would be a great way to come out and explore."

Altamont resident Jim Schaller, also a member of Friends of Thacher Park and trail volunteer, was part of a group that placed fencing around a sinkhole that developed off of a trail.

Schaller said when the park was established and roads were built, the natural drainage was cut off and "big heavy ditches" were made to funnel water into the natural sinkhole.

"Over the years, erosion has greatly enlarged it and when there is water coming down here during the wet seasons it is a torrent of water," Schaller said. "It was determined that since this section of the Long Path is only 20 to 30 feet away from it that people walking or hiking might get over there and fall into the hole by mistake. ... We decided to put some nice green fencing around it to keep folks at a distance."

Schaller said further up the path the group rerouted the trail and cleared a pine tree that had fallen across the pathway.

Becky Nold of Glenville and her 13-yearold son, Andrew, were a part of Schaller's group.

"We enjoy the parks, all of them, and we enjoy

hiking so we wanted to spend the morning maintaining the trails so that we could enjoy them later," Becky Nold said.

Andrew said he goes hiking about every two weeks once the weather is nice and he enjoys being outside. Becky Nold said her family probably comes to Thacher once each year and they often head north to the Adirondacks, as well.

At around 1 p.m. the volunteers gathered to eat lunch, which consisted of a bounty of food from hot dogs and hamburgers to vegetarian chili.

Eileen McFerran, of Albany, and Jayne Maloney, of Delmar, picked up some food after volunteering, but they also had done work before the event and would continue to do more afterwards. The two women are a part of the Thacher Garden Gang, which is an offshoot group of the Friends of Thacher Park.



## **Arugula Pesto**

Very good on chicken, steak, fish, pasta or vegetables.

- 1 pound fresh, young arugula
- 3 fat garlic cloves (see note)
- 1/3 cup raw almonds
- 1 small handful fresh basil
- juice of 1/2 lemon
- 3/4 cup olive oil
- sea salt and black pepper, to taste

Combine the arugula with the garlic, almonds, basil and lemon in a food processor. With the motor running, pour in the olive oil until the pesto is a smooth paste. Add salt and pepper. Keep sealed in the refrigerator for a week or so. Freezes well.

Note: I like to simmer garlic cloves in an inch of water for a minute, then drain and cool before adding to pesto. It takes the bite out. Leave them raw, if you like the garlic spice.

## From the Editor's Desk On nursing home, voters deserve a vote

Let us preface this by saying if you read this opinion page approximately 13 months ago, you're probably going to be bored.

That's because we're about to make the same arguments and call for the same type of action on the Albany County Nursing Home. Indeed, it seems that issuing a plea for sanity on this never-ending train ride has become something of a semi-annual tradition.

That is to say, this is a talk we've been having for quite some time, and it would appear that on May 13 the County Legislature might actually take a vote on the privatization of the nursing home. We certainly hope that is the case, because the suspense has become almost too much to bear.

Albany County Executive Dan McCoy has not been shy in calling nearly every recent action taken by lawmakers on this long, inglorious road to an Upstate Services Group agreement a stall tactic aimed at ensuring the measure never comes to the floor for a vote. While that might be an exaggeration at times – legislators have not only a right but a duty to fully vet any proposal, doubly so for this landmark resolution – McCoy is right to point out the plan has been on the table for about a year. And the entire idea of fixing the county's nursing home issue has been out there for much, much longer than that.

So while legislators deserve the time to review, revise and politick, at this point we'd say the public has earned the right to an up-or-down vote on the USG privatization agreement, if only by virtue of its collective monk-like patience. At this point, there is little to be added to the conversation that has not already been repeated many times over.

The nursing home quagmire is a problem on which McCoy (and Michael Breslin before him) has at least one thing right: it badly needs a solution. The county operates the nursing home deep in the red. Exactly how much has a lot to do with how you massage the numbers, but there's no denying it's in the millions every single year.

The people of Albany County, who have seen their county property taxes soar in the past few years, deserve at the very least some manner of forward progress. Even if the proposal is defeated, it would be a victory for progress because that would give policymakers a direction to move in. At the moment, as in so many moments before it, the legislature appears all but paralyzed by virtue of the fact there is no clear consensus.

The interesting thing about governing is not all of the decisions will be easy, like issuing a taxicab passenger bill of rights or regulating electronic cigarettes. The decisions that matter will rarely be unanimous.

What is important is that forward progress be made and a decision reached. And in our system of government, that is done from the parliamentary floor. Hopefully, we've made it to that point in Albany County.

## **Guest opinion** New York's forests: An endangered species?

Recent studies by Cornell University and The Nature Conservancy concluded that up to 70 percent of our state's forestland is not regenerating.

Since our current secondgrowth forests are entering the last quarter of their life cycle, this is a problem that should concern every New Yorker.

Our forests provide critical services to the ecosystem, including the purification and holding of water and the prevention of soil erosion. A single mature tree can sequester 48 pounds of carbon dioxide per year and produce enough oxygen to meet the needs of two people. Forests provide habitat for countless species of wildlife, and recreational opportunities and aesthetic values that contribute to our quality of life.

Forests also provide important economic benefits to the state. The forest products industry employs more than 60,000 people and contributes almost \$9 billion dollars per year to the state's gross annual product. Forests cover 65 percent of our state, and their

1800s. During the last half of the 20th century, in the absence of natural predators, deer populations exploded to levels far exceeding the carrying capacity of the forest. In many woodlands the deer consumed the entire understory of the forest, including seedlings of desirable tree species. In some cases, the natural understory has been replaced by undesirable vegetation not eaten by deer, and this vegetation is so well established that it prevents the germination of tree seeds.

Aggressive management action will be required to address this problem before the seed trees are gone. Deer populations will have to be significantly reduced in some areas, or the deer will have to be fenced out of woodlands where forest regeneration is being attempted – an expensive alternative. Broad use of EPAapproved forest herbicides will be necessary to control interfering vegetation. Heavy thinning of the existing forest may be required to admit sufficient sunlight to establish the future forest.

Eighty percent of New York's forestland is privately owned, and forest owners will need the public's understanding of the measures necessary to establish the next forest. They will also need cost-share assistance from established state and federal programs in order to succeed. The New York Forest Owners Association (NYFOA) is a non-profit organization of private woodland owners whose mission is to promote sustainable forestry practices in New York state.

In conjunction with its 50th anniversary, NYFOA has announced the "Restore New York Woodlands" (RNYW) campaign to engage and educate other forest stakeholder organizations and the general public about the regeneration issue and its solutions. NYFOA's 10 regional chapters will be hosting public woodswalks in May to celebrate the many benefits our forests provide and discuss the threats they face. 



# **Tech Park talk in Slingerlands**

## Town wraps up **Community Town** Halls with updates on Vista, hamlet plans

The focus was on the Vista Technology Campus as the last of the Bethlehem Community Town Hall meetings came to a close in Slingerlands.

The final meeting of the community tour spearheaded by Supervisor John Clarkson took place on Monday, April 29, at Community United Methodist Church on New Scotland Road. About 20 residents attended the meeting, where town officials discussed the progress of Vista over the last year and also touched on the New Scotland Road Hamlet Master Plan.

The majority of the presentation was given by the town's Economic Development and Planning Director Michael Morelli. He showed those in attendance a slideshow of aerial photographs taken throughout Vista's development from May of 2012 to several months ago. He explained the tech park's progression and described how 20 percent of the site was approved by the Town Board for secondary uses.

"We get questions all the time asking how people thought this was supposed to be a technology campus and what's with all the retail. In fact, that was all part of the master plan," he said.

Morelli said the idea was to allow service-based businesses in order to attract more offices and tech companies to the park. Sites that have what's considered "one-stopshopping" for employees are considered to be more attractive to employers.

Right now, secondary businesses consist of ShopRite, two banks and a medical office building. Another building that will house the Garden Bistro restaurant is under construction, while a doctor's office is proposed along with a mixed retail building. Morelli said a Moe's Southwest Grill is proposed for the mixed retail building, as well as a yogurt shop and a massage therapist office.

The first technology building has also been proposed at Vista. It is slated to be built on the site behind the ShopRite grocery store, with

# **Forest Walk stops in Normanskill**

## **Forest Owners** Association looks to promote knowledge of responsible festry

Members of the Mohawk Hudson Land Conservancy are looking to educate landowners about forest management with a woods walk through the Normanskill Preserve.

The nonprofit organization has partnered with the New York Forest Owners Association to celebrate the association's 50th anniversary. The Forest

Owners Association preserve is now home to has scheduled events throughout the state. with the local walk being hosted by forester Jeff Kehoe.

"We were hoping to attract locals who may not be aware of our organization, or those who have small woodlots that are looking for some more information," said MHLC Executive Director Jill Knapp.

The walk will take participants through the Normanskill Preserve. Kehoe will point out examples of invasive species and forest succession.

Knapp said the

several invasive species, including multiflora rose and buckthorn. The conservancy is looking to put a stop to the spread of these species because the preserve is located near the Normanskill Creek and healthy vegetation prevents streamside erosion.

Knapp said the goal of the evening is to "increase the public's awareness of the lack of understory regeneration in the state's forests due to invasive species, overpopulation of deer and poor forest management.'

"It's really an

annoyance for us," said Knapp. "We want to get people out to see how we can make improvements to our property as well."

Kehoe said many of the talks he's volunteered to give are in more urban areas because he's found those residents are usually poor at forest management and have more to learn from the experience.

"A lot of people are more confused about forest management than logging," he said. "I want to explain why our forests are threatened and how to help."

Kehoe said he encourages landowners to consult a forester about setting up a visit to their individual properties. He said most will visit for free and forest management tips will be different for each property depending on

the landowner's goals.

"(There are) Many reasons why people own forested land," he said. "Some use it to hunt, some want it for aesthetic purposes and some use it for income. Whether they want to control their deer population or bring in song birds, for example, a forester can help bring in a knowledgeable logger to make those things happen."

Kehoe said its important to hire a logger who knows the science behind forest management in order to take out the appropriate materials to get the desired results.

# **Nursing home vote May 13**

## **Operating agreement** moves ahead, as some lawmakers push for other options

A vote on the future of the Albany County Nursing Home has been set for May 13, even as some lawmakers lobby for other options.

Albany County Executive Dan McCoy announced on Wednesday, April 24, that the

legislature's Audit and Finance Committee had advanced the nursing home lease agreement with Upstate Services Group for a vote in the County Legislature. It had just last month been tabled by the committee. Although McCoy said he is

pleased with the movement, he's worried legislators like Frank Commisso are "trying to get the votes away" and stop the vote altogether.

'What they're doing is just delay on delay," McCoy said. "Frank Commisso knows how to stall ... how to confuse the other legislators.'

Commisso, the legislature majority leader, said he wants to take a harder look at a proposal from nursing home operators Lowell Feldman and Martin Lieban, who would not privatize the facility but instead oversee the day-to-day operation of the nursing home and look for ways to bring income in. USG, on the other hand, would lease the county-run nursing home for at least 10 years. McCoy has said it would save the county more

than \$100 million.

Commisso said Feldman had responded to a request for proposals, but the pitch never went to the legislature and he never heard a response. Commisso added he believes USG had never responded to the RFP.

"How did they (USG) get into the mix?" Commisso said. "How did someone who did answer the proposal not get into the mix?"

McCoy said when he first brought proposals before the legislature regarding privatization or

From there, after hearing recommendations for the Department of Health, McCoy said he came up with USG. As for Feldman and Lieban's proposal, McCoy said they wanted "\$1.3 million to manage it, fire two positions and lay off 80 to 100 workers."

"There's no savings immediately in the plan. Where's (the) savings for the taxpayers?" McCoy said. "Under my proposal, everyone's going to be offered a job. I gave the (legislature) a roadmap to recovery to be under the 2 percent cap. Under their plan, we can never, ever get there."

McCoy said he spoke about that plan publicly, including having open meetings with the legislatures "for those that showed up.'

for the county executive's office, said Feldman was an operator of Albany's Julie Blair Nursing and Rehabilitation Center and the Department of Health determined the residents were in "imminent danger," revoked their license and putting USG in charge of that nursing home. Commisso said Feldman was not the operator of that nursing home but instead just a shareholder "in a corporation with many shareholders.'

"He basically had virtually no say in that operation of that nursing home," Commisso said.

McCoy said each month the vote is delayed, the county loses another \$1 million. Commisso said "we don't know if that is a correct number," but if it is \$12 million a year, "that's approximately 10 cents per day for Albany County residents."

"Less than a cup of coffee a week will allow us to continue to give elder care 24/7 coverage and keep our workforce in place ... we can continue to give the care we have given for many years," Commisso said.

their disabilities. Building new energy-efficient, barrier-free housing will offer a permanent, cost-effective solution while promoting the concept of independent living," Erlich said.

Guilderland Town Supervisor Ken Runion welcomed the home and applauded it for being environmentally friendly. He said the home was a "good fit" for the town.

"Our board was 100 percent behind having this home in the Town of Guilderland," Runion said. "We realize and we welcome the opportunity to serve our disabled population as well as our aging population."

Erlich thanked BBL Construction Services for sticking with the project even though it "took so long to get up and running."

"This is a big and important project for us ... and is great to be here today to see this," BBL **Construction Services President** Steve Obermayer said. "This was a real eye opener for us to see the way Fred (Erlich) battles for the funding of these projects."

The project is funded by a \$650,000 grant secured from the state legislature by Sen. Neil Breslin, D-Delmar, and some additional technology enhancements will be privately funded.

The single-floor home will have natural lighting with automatic lighting in designated areas, and solar panels will help reduce the building's carbon footprint. There are also webbased medical supports for medications and tracking the vital signs of residents. Other features are to make the home more accessible, such as wider doorways and expanded bathrooms with roll-in showers.



Erlich said Living Resources has already identified six people to live in the home, which is anticipated to be ready in September. The organization houses 36 individuals in facilities that don't meet their current needs.

"Living Resources expects as many as 33 percent of our group home residents to reach the age of 60 over the next decade. The combination of emerging health issues among the aging population and the structural limitations of housing that doesn't accommodate the needs of consumers can no longer be tolerated," Erlich said in a statement. "Building more homes like ours is a critical step in the search to find compassionate solutions to the challenges of caring for one of the most vulnerable segments of our population."

# **Tkaczyk proposes election reforms**

## Senator's court battle spurs bills efforts to change ballot requirements

State Sen. Cecilia Tkaczyk had to wait more than two months after the polls closed to be declared the winner in last year's elections, and now she is proposing legislation aimed at preventing lengthy court battles and what she argues is the disenfranchisement of voters.

Tkaczyk D-Duanesburg, unveiled two bills she is sponsoring during a news conference on Wednesday, May 1, which address legal challenges raised by her Republican opponent George Amedore's legal team. The first bill would eliminate the requirement for voters to include their previous address when completing an affidavit ballot and would stipulate the ballot must be counted if the voter is in

"substantial compliance" with voting regulations. Another bill would remove the two-week restriction for ballots given to election inspectors.

"These are two bills that are very simple," Tkaczyk said. "To me, they are no brainers."

Tkaczyk said she was "appalled" to see election laws being used to "disenfranchise" voters. Drafting changes to election laws became a priority once elected, she said.

"When I ran for the 46th Senate District, I knew I was facing an uphill battle. ... I knew it would be challenging," Tkaczyk said. "I thought it would be over though on Nov. 6 ... I had no idea that it would take two-and-a-half months and a tumultuous up-and-down process before I finally got seated and sent to the Senate.'

The race for the newly drawn 46th Senate District was first ruled as a victory for Amedore, but Tkaczyk's attorneys appealed a judge's

decision. The state Supreme Court Third Judicial Department's Appellate Division ordered the counting of around 100 disputed ballots, which ended with Tkaczyk defeating Amedore by fewer than 20 votes

"These were two of the issues that we fought over in the court," Tkaczyk said. "In my race, democracy stumbled but justice prevailed."

Democrat Kevin Cahill of Ulster County is sponsoring the two bills in the Assembly and said it's time to revise election laws. He said lawyers battling in court shouldn't be necessary "to make democracy happen."

"In the case of Ulster County ... ballots were challenged for poll workers," Cahill said, "not because the poll workers did anything they were told not to do by authorities but because of the hyper-technicality of New York state law."

One bill would require local Boards of Elections to notify voters when their ballot is received and if it was accepted or rejected. A rejection would have to be explained and an opportunity given to correct the ballot.

Other proposals would change annual report requirements for Boards of Elections, allowing poll clerks to work a half-day shift, providing an amount of affidavit ballots totaling at least 15 percent of the last voter turnout for the polling site and providing an adequate number of pens at each site.

for the arrival of a new highway superintendent in January. Voters will select a person to fill the office in November.

Commissioner of Public Work Erik Deyoe has been selected to fill the position on an interim basis until the end of the year. Deyoe has also been working for several months with Sagendorph to learn highway procedures and make sure the transition is smooth.

The proposal to abolish the highway superintendent position was first put forward by Clarkson during this year's State of the Town address, shortly after Sagendorph announced plans to retire after holding the position for 22 years. If the referendum had passed, a civil servant would then have been hired to help manage the Highway Department under the Public Works umbrella.

Citizen advisory committees have studied the idea since 2006, under the administration of former Town Supervisor Terry Egan. The town's Governance Committee found 59 other towns in New York, mostly larger suburbs, no longer elect their highway superintendents. Estimates were the town could save between \$180,000 to \$375,000 annually through the consolidation of departments. Clarkson has been in favor of making the change since it was first proposed, and was the driving force behind a "Modernize and Economize" campaign. The supervisor said he was glad the issue was finally put to a vote and the town's residents were able to make a decision after so many years of talk. "I think the Town Board and I did the right thing by bringing it to the voters and I regret nothing," he said. "It can be hard to

convince people to make fundamental changes in government, no doubt. But a lot of people did support that change. We'll see what we can do without it and move forward."

Jeffrey Kuhn, a Town Board member and the Bethlehem Democratic Committee chairman, agreed with Clarkson.

"The Town Board unanimously, after a public hearing where there was unanimous support, opted to hold the referendum," he said. "We allowed the people to weigh in on this issue. They have done that and I have the utmost respect for the outcome. The people weighed in the way they did and I think it shows the democratic process at its finest."

A group called Keep the Vote Bethlehem campaigned against the local law. The effort was formed by Bethlehem **Republican** Committee Chairman Fred DiMaggio, Republican committee member Mike Kelly Sr. and Democrat town resident Dan Cunningham, after the Town Board set a public hearing on the topic in February. Cunningham described the group as a nonpartisan coalition formed because members felt the reasons for the change were that will be brought to bear as we move forward," he said. "We're pleased with the victory tonight because it demonstrates the peoples desire to have a choice. This was an important issue that transcended party lines."

Members of Keep the Vote Bethlehem, along with some others in the town, were unhappy there would be only one polling place. They also did not agree with how soon the vote took place and felt it should have been held in November during the typical election cycle.

Preparations for the referendum were complicated due to state law, which fueled the decision to have a single polling place. In order for the town to offer absentee ballots for the vote, each polling place had to establish a Board of Registration and Board of Inspectors, so those who are not already registered to vote with the Albany **County Board of Elections** may vote in this special election.

Clarkson said for multiple polling places to be used, mailers would need to be sent out notifying each resident of where they would be voting in the special election, since the location might not be the same as where one would typically vote. Those needing to register would need to do so at that polling location during designated times and those times would have to be published in two newspapers. Given the outcome, DiMaggio said the **Republican** Committee plans to put forth a strong candidate to run for the position of highway supervisor in November.

"We're hoping that the girls see they have the ability to make a difference even though they're still young," said Poust. "This project is something concrete. They can see their making a difference right here in their own community."

Community Maternity Services is a communitybased outreach group that focuses on social services and parenting education for adolescent mothers. The charity includes several residential programs, along with continuing education efforts and employment preparation programs.

At the beginning of the year, the troop placed playpens at several locations in Bethlehem and Albany to collect donations of new baby supplies. Enough items were collected to create 24 gift bags for mothers in the residential program at Community Maternity Services. The girls also made fleece baby blankets and beaded bracelets as more personal gifts for each mother.

"Most of these kids don't have a lot of family support. We become a family to them," said Ann Marie Couser, the communications director



at Community Maternity Services. "So when they see people they don't even know are doing something for them, it's a thrill. They're not used to special treatment."

Couser said the supplies would be a big help to not only the mothers, but the charity itself. A large portion of the group's budget goes to purchasing baby supplies like diapers, wipes and formula. Donation drives similar to the one done by the Brownies help to offset costs.

Some members of the troop said they voted for the Community Maternity Services project because they thought collecting the supplies and making blankets sounded more fun than the average food drive. Some also made a family connection.

"I liked this project because I have a cousin who is having a baby and she's young," said Bella Perrotto, 8. "It made me think she might not have The Brownies selected the project as a way to earn a "Journey" badge.

enough money to care for her baby."

Others said the project made them think of their own mothers and how happy they are to be remembered on Mother's Day.

"I think they're going to be happy and surprised," said 7-year-old Erin Mash of the program's mothers. "I hope we get to visit them so we can see their faces when they get their stuff."

The troop was scheduled to visit Community Maternity Services and meet with several of the mothers and their babies on Monday, May 6.

"We want (this experience) to stick with them to know they have the ability to make changes for the better as they grow," said Poust.

DiMaggio said he was very happy with the turnout and especially thanked the people of South Bethlehem for driving to Town Hall to vote.


"(There is) no question that when you take away people's right to vote there are strong feelings about that, and this is something Clarkson said he hopes that's the case.

art contest to coincide with Tulip Fest

ach spring, thousands of tulips take over marks the beginning of spring in the city and have a way of bringing a feeling

of renewal to Albany each year.

The concept of renewal can have a number of meanings, and for a group of youth from the Equinox Outreach

Center, the word brings to mind a multitude of ideas. On Thursday, April 25, young adults began to turn the sidewalks of Central Avenue into a canvas, each using chalk to create what renewal means to them.

"Everything from water, a nature scene with water dripping down and flowers to a recycling mural piece, to this kind of cool video game look with a maze inside," said Belmont, describing the scenes that developed.

The chalk creations were a practice run for an event coming to Central Avenue on Saturday, May 11, coinciding with Albany's Tulip Fest, called "Drawing Up Central."



"We are always interested in bringing visitors to our downtown Albany. The appearance of the flowers district, and Tulip Fest is an excellent opportunity," said Belmont.

> Belmont said the folks at Central BID and Equinox put their heads together and came up with the idea of a sidewalk chalk contest.

"It's something that has been done elsewhere and really well received," said Belmont.

There are artists who do sidewalk chalk art, but it's also something families can do."

Registered to participate in the contest are artists who have won similar contests in the past along with local youth and families.

A number of squares have been chosen along Central Avenue from Henry Johnson Boulevard to Lexington Avenue. Each artist will be assigned a 3-by-5-foot square. The creations will be judged and prizes will be awarded for the best youth and the best adult creation.

Belmont said a grant from the Albany County Convention and Visitor's Bureau has enabled them to give out a cash prize of \$500 to the adult winner. The youth winner will receive an iPod Nano and gift certificates from local businesses. "Another category as a way to open it up more to community participation is a Central's Choice Award which is kind of like a People's Choice Award," said Belmont

Tulip Fest activities begin on Friday with the tradition of scrubbing State Street.

"It goes back to very early festivals. It's an old Dutch tradition where before a big event people would go out

and clean the streets. We have people in Dutch garb and Boy Scouts scrubbing the streets with long-handled brooms and buckets of soapy water," Bonafide said. "It's a pretty interesting event if you haven't seen it before."

Although the tulips are the subject of the festival, the flowers serve as the backdrop for live music on three different stages, crafters, artists and a host of food vendors.

"We always have a great lineup of both national acclaimed artists as well as some great up-and-coming local groups. This year on our amphitheater stage I believe we have 10 of the best


