# Common Core questions

#### **Education forum focuses on** new testing requirements, state mandates

Students may have already taken the first round of tests using new Common Core standards here in New York, but the debate over the new standardized tests is far from over.

State Sen. Cecilia Tkaczyk, D-Duanesburg, and Assemblywoman Patricia Fahy, D-Albany, organized a forum, "Education at a Crossroads: A

Forum on the Impacts of Testing and Mandates," on Wednesday, June 5, in the Legislative Office Building at the Capitol.

Several representatives from Capital District schools talked about the effects standardized testing has on students and the financial constraints districts are facing when implementing state mandates. Lawmakers from both sides of the aisle were in attendance and questioned educational representatives from students to superintendents.

Tkaczyk said she and Fahy were discussing the "hundreds" of emails



# RCS opens greenhouse as a teaching tool

**Learning tool eight** years in the making

Since she was a little girl, Casey Young has always been interested in earth and environmental sciences.

The Ravena-Coeymans-Selkirk senior said she planned on going to college to study earth science, but until this year there was one thing she lacked – a more hand-on experience with the field of study she loved. Young said she knew the concepts, but wanted to do some experimenting for

"It's by far easier to learn about the effects you have on your own environment if you see it," she said.

Now, Young's getting her chance. On Tuesday, June 4, faculty, students and parents gathered at RCS High School for a dedication ceremony and open house to showcase the school's new greenhouse. The new facility will be used to help students with a number of classes, including several science courses and electives.

Principal Brian Bailey said he hopes the greenhouse can also be incorporated into other curricula. He said business students might be able to develop a plan to sell items from the greenhouse at

"We actually retooled the science curriculum to include lessons about the her students are learning greenhouse several years ago before it was even built," he said.

Bailey said the greenhouse was purchased through a grant that a staff member applied for eight years ago. There are now 34 juniors and seniors taking an environmental sciences elective at the school. Teacher Erin Roberts said to analyze the various components that make up soil to determine which are necessary to be present when growing certain types of plants. They are also learning about germination, hydroponics and how plants reproduce.

"We want the students to on experience as possible," said Roberts, who said she hopes the lessons her students learn now could someday help them in their future careers. "We want to be able to provide this experience as a new opportunity for kids who haven't been able to spend time around a greenhouse."

Young, 17, said she already knows what she learned will help her in her future studies. One of her favorite lessons so far was a soil study about how organic fertilizers affect growth when compared to commercial fertilizer.

"It all has to do with the pH balance and what nutrients are included," she said. "A slight difference depending on the plant can change everything.'

# Man arrested on warrant for threatening mass shooting

Man allegedly threatened to 'shoot up' Monmouth University, kill woman

Guilderland police arrested a Slingerlands man wanted by police in New Jersey on charges he threatened to kill a woman and shoot up a university.

Police arrested Chad M. Blackman, 23, of 6077 Johnson Road in Slingerlands, at his home on Friday, May 31, on a warrant out of Cliffside Park New Jersey Municipal

The warrant alleges Blackman threatened to kill a woman through the Internet service Skype and called her cell phone 52 times, according to police. He allegedly threatened to perform a mass shooting at Monmouth University by saying he was going to "shoot the place up," police

When the Cliffside

Park Police Department contacted Blackman he allegedly threatened to stab the officer in the throat, according to police reports.

Guilderland police arrested Blackman without incident on the warrant that included charges of making terroristic threats in the third degree and harassment. He was arraigned before Judge John Bailey in town court. He was remanded to Albany County jail without bail and was awaiting extradition from Cliffside police.

Police said Blackman had cuts on his wrist, which he indicated occurred the night before being arrested. Judge Bailey ordered a mental evaluation of Blackman.

#### Other arrests

• Guilderland police arrested Sharayah Linee Cancer, 25, of 635F South Pearl St., Albany, and charged her with grand larceny in the fourth degree, a felony, on Friday, May 24, at approximately 6:29 p.m. Cancer was transported from Albany County jail on a warrant out of the town court. She was remanded to county jail on bail of \$2,000 cash or \$5,000 bond. She was scheduled to reappear in town court on Thursday, May 30.

• Guilderland police arrested Haider A. # **Candidate under fire from own party**

**GOP** serves supervisor hopeful **Jared King with** accusatory letter

Republican and Bethlehem supervisor hopeful Jared King is on the outs with his own party.

Although it's not inconceivable that would be the case when it comes to a committeeperson challenging a party's endorsed candidate, it is rarely put to paper.

The leadership of the Albany County Republican Committee has sent King what amounts to a cease and desist letter, claiming he has exhibited a history of defamatory action that has come to a head with his recent effort to primary the party's pick for supervisor, Fred DiMaggio.

DiMaggio has stepped down from his position as the Bethlehem GOP Committee chairman to focus on his campaign, and Peter Kermani, the former head of the County Republican Committee, has taken over.

DiMaggio said the committee's troubles with King started long before the past few weeks.

"We repeatedly tried to engage him in a positive way," DiMaggio said. "He has not worked for the collective good of the committee. ... With Jared, it's not the common goals, it's what Jared's goals are."

Counsel to the county

Republican Committee Bryon McKim, who is also a committee member hailing from the City of Albany, composed the letter sent to King. He said he's been aware of the leadership's problems with King for about a year.

McKim said King has made defamatory statements about members of the party, though he did not elaborate on specific charges. He described the letter as an instrument to make it clear King does not speak for the party. He also said King has regularly derailed meetings and made it difficult to get the party's work done.

"Jared has disrupted and hurt the town committee to the point where there's members who don't show up anymore. There are members who have walked out when he's gone on his diatribes and disrupted meetings," he said.

McKim emphasized the committee has not taken steps to remove King from the committee, and that it is not a step under consideration. State law allows for the removal of a committeeperson "for disloyalty to the party or corruption in office.'

King, however, said he think it's obvious this is the opening move in an effort to oust him from the committee.

"They are getting very nasty, and they do not like the idea of me talking about what I call 'love of people Republicanism,' doing stuff that is in the people's interest and

not just their personal interest," he said.

He described the county's Republican party as a "cabal" whose leaders routinely cut secret deals with Democrats to lock up elections and secure patronage. He also accused DiMaggio of locking committeepersons he disagrees with out of the process and demanding monetary donations from

"The Republican voters in this town have to understand how thoroughly corrupt the county party leadership is under Peter Kermani, (County GOP Chairwoman) Rachel Bledi and their puppet, Fred DiMaggio," King

The final straw came

last week, McKim said, when King was asked to leave the grounds of the Good Samaritan Village Nursing Home in Delmar as he was gathering signatures for his petition.

Staff at the adult home there said King had been barred from the home last year for approaching residents while walking petitions.

"He was going right into their private rooms and shutting the door. They didn't know him," said administrator Courtney Stricos.

She said unlike an apartment complex, the residents of the facility's Kenwood Manor are in the care of the staff there. Some have dementia or other medical issues.

"For an unknown person to walk into their rooms is inappropriate," Stricos said.

She said last week, King left the premises, but not before arguing with staff over his right to be there.

King said he had indeed been asked to leave while carrying petitions in 2012, but it was not his understanding he was barred from the facility.

"If they don't want me to come back, that's fine. I left a message with that activities director, and I didn't get a response," he

As for his petition drive, King said he's received a good response from Republican voters thus far.



# June's arrival means paperwork for politicians

If you're a registered member of a political party, there's a chance that in the coming days someone holding up clipboard will walk up to your door, pull you aside at a farmers market or catch you at the shops, and ask for your John Hancock.

It's the annual funfest of designating petitions. Collecting signatures is the way many candidates for office will end up on the ballot, and in local races (like the ones being held this year) it's a battle fought door-to-door in our communities. And it just started.

The process is not exactly intuitive. So what is petitioning all about? Well, it's about deciding who ends up on the ballot. Here's how it works.

Local political parties have already made their nominations through caucusing in recent weeks. But what remains is the petitioning process, when those who were not nominated can get onto the ballot.

Hopefuls may collect signatures from voters registered in their party - this year, they have from June 4 to July 11. If successful, the candidate will appear with any other candidates for that line in a September primary. Voters take part in their own party's primary, and the candidates run in November on the line or lines they won.

Candidates must collect signatures of 5 percent of the active, registered voters in a party, or either 500, 1,000 or 2,000 signatures, depending on the office (whichever of the two categories is smaller).

Collecting signatures can be a tricky business. Suffice it to say every piece of information on a form must be exactly correct - if a single voter's address is written as "Delmar" when the Board of Elections records has it as "Bethlehem," the signature and all other signatures on the petition sheet can be tossed out.

Candidates will likely "walk" their petitions themselves, but many also employ volunteers to carry it on their behalf. Some candidates will pool their efforts with other campaigns and ask voters to sign on to several candidates in one go.

Phew. So, what should *voters* be sure to remember? Firstly, know that you only give one signature per office - you can't sign for both supervisor candidate A and candidate B. You also can only sign a petition for the party you're enrolled in. Oh, and if you lie about anything and affix your signature to a petition, it could well be considered perjury (Democrats in Troy could tell you a little about that).

But wait, there's more! There's also a thing called an opportunity to ballot. If a candidate gathers up enough signatures, this will open up a write-in position on the September primary ballot next to an endorsed candidate who has no individual primary opponent.

A candidate may then stage a write-in campaign to take the line from the endorsed candidate. As an example, this mechanism allowed Jack Cunningham to wrest the

Working Families Party line from Sam Messina in the 2009 Bethlehem supervisor

The period to circulate these opportunity to ballot petitions is June 25 to July 18 this

If that doesn't sound like enough paperwork, there's of course more. Most candidates will also form a campaign committee to handle all the matters of money. The candidate or his/her committee must register with the state Board of Elections and then submit campaign finance disclosures at certain intervals. The public can access that information (donations and expenses) through the board's website.

(Candidates who don't spend more than \$1,000 are not required to submit itemized reports. The utility of these public reports is also somewhat dubious; the law requires committees to submit a disclosure report 11 days before an election, and 10 days after. So whatever money changes hands in the days leading up to the election is masked until the votes have already been cast.)

This all means that when you give money to a candidate, that contribution is out there for the world to see. Under state law, anonymous donations must be handed over to the state and placed in the general

The point is, you have important decisions to make well before the voting booth. We hope this information helps.

# Pass public funding of elections

The author is an activist and Loudonville resident working with moveon.org and has a longtime interest in public campaign funding.

In response to the recent Spotlight editorial concerning New York state corruption scandals, the many coalitions of citizens that support campaign finance reform (with a central focus on public funding of elections) correctly maintain that this is the only way to combat the corrupt system that allows and encouraged the crimes of 27 legislators, arrested, indicted or forced to resign over the past 12 years. This may be just the tip of the "pay-to-play" iceberg, threatening to sink our democracy.

The results of this nonfunctioning system are defunded education, unfair

taxes, an impoverishing minimum wage, continued costly privatization of essential public services and threats to our environmental and personal health from ill-conceived energy extraction plans lacking proper safety evaluations. Think fracking.

Trust in our government continues to evaporate rapidly, accelerated by the lack of accountability and transparency. Large donations by the wealthy and corporations bring them big pay backs, preventing our government from functioning for ordinary people, working instead for those with expensive lobbyists and deep pockets. These nifty investments are rewarded with special rewards, often up by up to 100-to-1.

Public funding of elections is not simply an "interesting idea" but it already works well in Arizona, Maine and Connecticut, as well as in many cities and towns, for both candidates and voters, allowing those elected to serve and spend time with their constituents rather than dialing for dollars and catering to special interests.

This voluntary participation proposal, working well in New York City, allows candidates raising a certain number of small donations to demonstrate their viability in their own communities, then are given public matching funds (6-to-1) to run in primary and in the general election, if they commit to using no private money, including their own.

This levels the playing field by allowing potential candidates who otherwise qualify but lack money or the time and help, to run for office.

Republicans allied with the crossover Democrats in the NYS Senate are refusing to allow the bill to come to the floor for discussion, despite the support of the governor and its usual passage in the Assembly. In the latest Siena poll 60 percent of New Yorkers want public funding. It works and we need it.

Ιf w e want government back we need to tell the Republicans to allow a democratic process to proceed on this bill and stop their obfuscations and misrepresentations.

This law will save much of now wasted taxpayer money, for only \$2 per voter we will be spared the loss of taxes, the subsidies, exorbitant no-bid contracts, payments to create jobs to corporations that never materialize, and other such outrages and rip-offs.

"Don't go home Without It" was the message of 500 or more demonstrators from all over the state demanding passage of this bill at the Capitol last week.

Let your senator and the governor know public funding of elections should finally happen in New York state.

We have until the June 20 adjournment to convince Republicans and the rebellious "crossover" Dems to pass this law. We are closer than ever to success.

It is a moral issue - and simply, the right thing to do.



# **Bethlehem YMCA installing Sport Court**

One of the largest capital projects at the Bethlehem YMCA since its construction will take place this month when a state-of-the-art sport court surface is installed in the Y's ice rink. The multi-sport surface will be the only one in the Capital Region and the first of its kind in Northeast New York.

"One of the most frequently asked questions is what do we do with our ice rink during the summer," Bethlehem YMCA Executive Director Derek Martin, said. "The sport court is the answer. This unique, state-of-the-art surface opens up a world of new opportunities for local teams, athletes and schools to play and practice indoors."

The sport court is comprised of more than 47,000 individual. modular tiles that are assembled on top of the concrete floor when the ice is removed from the rink in the spring. The seamless surface mimics many types of playing surfaces from basketball courts to soccer fields. The tiles are incredibly durable and even bulletproof.

"We hear from many people who can't find places to play sports in our area, they have to reserve space late at night or travel out of the area," Martin said. "There is a great demand for real competition space and, with the new sport court, the Bethlehem Y is prepared to help meet that demand."

Around the country, sport courts are gaining popularity, from simple, backyard play areas for kids, to the massive, the

200 foot-long, ice-blue, playing surface that will be installed at the Bethlehem Y. Sports courts have been used in many large-scale events including the NCAA Final Four, USA Volleyball tournaments, even at sporting exhibitions at the White House.

"We envision using the sport court for indoor hockey, soccer and lacrosse, basketball tournaments, even baseball or softball," Martin said. "We have already heard from some local sports leagues that want to play on the sport court and we will be actively reaching out to others who looking for space to play."

The Bethlehem Y is one of only four YMCA's in the entire country with an ice rink. Having the sport court will enable the Y to make better use of that space in spring, summer and fall, opening up the gym space to be used for more basketball, pickleball, and other

"The sport court is going to have a huge

positive impact on the Bethlehem Y and the entire community," Martin

# **Subdivision clears first hurdle**

**New Scotland** planners give preliminary approval for 12-home Biernacki development

A 12-lot subdivision in New Scotland saw considerably less public protest in its second public hearing before the town's Planning Board, leading the board to move the project forward in the planning process.

Last month's New Scotland Planning Board meeting overflowed into the hallway when residents protested a residential subdivision that would split up a 31.4-acre parcel to make way for 12 homes. Planning Board Chairman Charles Voss decided to keep the public hearing open until the Tuesday, June 4, meeting, but at that meeting concerns about drainage appeared to have been assuaged given the smaller turnout and fewer outspoken opponents.

Parcel owner MJ Biernacki Builders, LLC, received unanimous preliminary plat subdivision approval from the Planning Board Tuesday. The board is scheduled to review the project for final approval

"We left it open because we wanted to provide an opportunity for those who had questions to be able to review the materials," board member Jo Ann Davies said.

Davies led the meeting and said chairman Voss was unable to attend the meeting. Alternate board member Thomas Hart sat in, as well.

Expanded notification of the second public hearing was given to homeowners outside of the initial 500 feet radius required by law. Town Building Inspector Jeremy Cramer said notification was extended along Route 85A to just before Voorheesville High School.

The proposal consists of two lots to the south of Route 85A, with the remaining 10 to the north of the road. Seven lots would face Picard Road and the remaining five would face New Salem Road. There is also a small parcel of land Mike Biernacki

at its Tuesday, July 2, is negotiating with town officials to acquire, which would be added onto lots 2 and 3.

> The majority of development would be within an inactive cornfield and the project was scaled down from 15 to the present 12 lots.

> Residents had expressed concern the project would negatively affect drainage issues and worsen flooding problems already present.

> Joe Bianchine, of ABD Engineers & Land Surveyors and representing the developer, said some minor adjustments were made to address the Planning Board's concerns. He restated the project would actually be reducing run off from the cornfield by 20 to 25 percent.

> "By doing infiltration we will actually be reducing the amount of runoff from this site after development than what currently happens now," Bianchine

Board member Robert Stapf asked if the land would be able to support more groundwater from stormwater infiltration. Bianchine said the development would not negatively impact groundwater levels.

"We looked for seasonal high groundwater ... so you can tell where the high groundwater reaches at various times of the year," Bianchine said. "We'll have minimal if any impact on groundwater by recharging into the ground."

Even if the Planning Board grants approval to the project it won't be the last step for the developer, because the Planning Board is recommending the Town Board establish a stormwater drainage district for the area.

The recommendation was given largely because it's seen as the simplest method for the town to be reimbursed if any maintenance or other work is performed on drainage systems.

If the Town Board approved the district, homeowners would be billed for work on their tax bills. Without the district, the town would need to bill the homeowner for work performed and seek collection, which the board's attorney Jeffery Baker said would be more likely to lead to

"Many of our candidates interview with other parties and it would be unfair of us to say they could only run on our line," he said. "There's a lot of people who run for selfish reasons. It's a real breath of fresh air to see people run strictly for the betterment of their community. We're really pleased with this slate of candidates."

The Albany County Conservative Party has backed the same candidates for Town Board and supervisor. The endorsements mirror the Republican choices for the candidates on the Bethlehem United coalition.

"We chose these candidates based on their independent viewpoints. said Conservative Chairman Richie Stack. "This effort really came together because of the heavy handedness of Supervisor John Clarkson and his attempt to disenfranchise the people of Bethlehem by taking away their right to vote for their highway superintendent. # Stuyvesant Plaza adding parking

Project will include improvements at small adjacent park

Finding a parking spot at Stuyvesant Plaza will be a little easier after 24 parking spaces are added at the shopping center.

The Guilderland Zoning Board of Appeals approved the plans for additional parking on Wednesday, June 5. Twenty-one parking spaces for shoppers and employees and three spaces designated for McKownville Reservoir Park visitors will be built between T.G.I. Friday's and Route 20. The project will also replace several trash bins near the park with enclosed, energy-efficient trash and recycling compactors.

Stuyvesant Plaza plans to continue working with town officials to enhance the park by planting additional vegetation and installing a small retaining wall.

Vice President of Real Estate for Stuyvesant Plaza Janet Kaplan said the company has worked with town officials to address concerns it and residents raised over the parking proposal.

"The stores are completely filled at the plaza and it has been busy," she said. "We noticed more and more people at certain times of the day filling up the lot and that was sort of the genesis that we needed more spaces."

Employees for several years have been asked to park at the back of the shopping center or at its adjacent Executive Park, Kaplan said.

The town granted an easement in 2009 for the additional parking spots, and the plaza agreed to contribute \$123,000 towards addressing drainage issues at the former reservoir.

The initial plan had called for more parking spaces than what was ultimately approved and the design was modified so the parking lot was built around trees already present at the site. Modifying the design largely reduced the number of spaces.

"We have a great relationship with the town and we're delighted to move forward with a plan that will heighten the shopping experience at the plaza and encourage visits to the park," Kaplan said in a statement. "The combination of parking spaces and visual enhancements will improve access and beautify the area"

The small park primarily consists of a trail with benches around the former reservoir.

"Most of the visitors to that park walk over, I think," Kaplan said.

The project is expected to be completed this summer.



# **BC** to fill vacancy with appointment

School board will seek applications to replace Laura Ladd Bierman

The Bethlehem Central School District Board of Education has opted to appoint a new member to the school board after Laura Ladd Bierman announced she was submitting her letter of resignation at the end of May.

On Wednesday, June 5, Superintendent Tom Douglas told the board after researching state education law, it was determined the district has the "duty and power to fill the vacancy" as the board sees fit because Bethlehem is a central school district.

"The Board of Education has to look at the specific seat in question and decide on that seat," said Douglas. "With this happening after the election that poses a unique situation, however it is about the seat, not the election at this point."

Bierman resigned from her position on the school board at the end of May, following the vote on the school budget. Bierman said she has been thinking of leaving the school board for a while because of additional responsibilities at her home and work. She delayed the decision to see whether or not the budget would pass.

Douglas said school law stipulates the vacancy could be filled by special election or appointment by a majority vote of the board. In rare cases when a decision could not be made, the BOCES Superintendent or the Commission of Education could be asked to appoint someone.

Douglas said if the board had decided to hold a special election, the district would have to adhere to all general election laws. According to the district's Chief Business and Financial Officer Judith Kehoe, the cost of holding the vote would be around \$10,000.

Board member Charmaine Wijeyesinghe said she felt spending the money on an election was not appropriate at a time when the district is attempting to cut costs.

"It's going to be the summer months and people aren't going to come," she said. "I would suggest going the appointment route."

Board member Caitrin Navarro said she would like to see the board appoint Christine Beck, who came in a close third during the election held two weeks prior.

"She put herself out there, she showed interest and received a substantial number of votes," Navarro said. "I think the point of the election is for the community to decide and she was within 70 votes of being on this board anyway."

Wijeyesinghe agreed with Navarro, but said she would be comfortable with whatever the majority of the board decides.

Other board members said additional candidates might be more likely to apply now that there is an open seat and there isn't fear of taking a position away from a sitting board

member.

Board member Lynn Lenhardt said in similar instances in the past, the board asked for residents to submit applications and to be interviewed.

"I feel that is important to do," she said. "We always had about 10 to 12 people show interest and it was a very fair process."

The majority of the board opted to appoint a new board member after seeking applications. Douglas recommended for transparency's sake, the names of all applicants should be released to the public before a selection is made, but that decision is at the board's discretion.

The district is now looking for applications from residents who would like to be appointed to the school board. Applications should be submitted to the school board by July 1.

# Y officially opens new pavilion

\$490k project years in making, already being used by summer campers

More than a year after the Bethlehem YMCA broke ground on a new lunch pavilion to accommodate the organization's summer campers, the structure is complete.

On Thursday, June 6, staff of the Bethlehem YMCA gathered, along with members of the community and benefactors of the pavilion, to celebrate the project finally becoming a reality. Fundraising and planning had begun nearly five years prior.

"This pavilion represents our commitment to the Bethlehem community and the hundreds of children who participate in our camp each year," said Capital District YMCA President and CEO David Brown at the dedication ceremony.

The 3,200-square-foot pavilion includes an eating area, space for activities, a food service area, bathrooms and a storage room. A walking path and at the list of folks who've a utility road from the parking lot will be built in the future. The building also has water, sewer and electrical connections.

The pavilion was completed before camp began in June last year at the 14-acre property located at 900 Delaware Ave. About 150 campers attend the Bethlehem YMCA summer camp per week, and it runs for nine

Bethlehem YMCA Director Derek Martin said volunteers were doing finishing touches, like the construction of picnic tables, just three days before campers arrived.

"In this case, many hands made for light work, but it certainly didn't make for light anxiety on my part," said Martin.

The entire project cost around \$490,000. More than \$250,000 was obtained through grants, with the rest coming from donations. Sen. Neil Breslin, a Bethlehem resident, secured the largest portion of the funds needed. The pavilion was dedicated in his name.

"I'm just so thankful to be even a small part of this," said Breslin. "I look given their own money and their own sweat and efforts to make this a reality, and the fact over 350 kids will get use of it over the summer, it brings me joy.'

Large donations came from the Slingerland family through the Slingerland Foundation, Christopher and Christine Edwards, Woodward Connor Gillies & Seleman Architechs and the Standish Foundation.

"Just seeing the kids faces and the fun they're having is what really hits home about being able to provide this type of facility," said Don Slingerland. "Not just the pavilion, but all of the Y."

Martin said the pavilion is part of the Bethlehem branch's capital campaign. The entire plan also includes the installation of activity fields, a welcome center and a playground. The projects total an additional \$150,000. Those plans will be completed as funds become available.

The pavilion will be used exclusively for YMCA members and those who attend camp, but corporations and the community can rent it out for local functions during

the off season. Martin also said some exercise classes might use the pavilion on a regular basis for things like yoga instruction.

"When we built this pavilion, the vision was first and foremost for the kids, but it has so many more uses," said Martin, calling the

pavilion a lasting legacy to the Y's commitment to Bethlehem. "We do these things to engage our community, and to engage our members."







"It depends on how much money we can raise, but that is one of the things we are targeting," Gallo said. "You can fit families underneath it."

Gallo said the town's pools have been a "centerpiece" of the summer for families over the years. There are even some vintage photos people can look at showing the facility's history.

Splash islands replaced the sand pits more than five years ago. Gallo said they "did a number on the pool filters," because kids would be covered in sand and then jump in the pool. Splash islands now shoot, spray and dump water on kids.

"It is not like the beach where you can just go wash the sand off, the sand actually went somewhere into our filtration

system," he said.

The Elm Avenue Pool Complex building has essentially remained unchanged for 40 years, with repairs and slight renovations made.

James Knox, of Delmar, was with his two daughters and son sitting by the band after getting out of the pool. Knox said he comes to the pool every year with his kids.

"It is just a great place to come and take the kids and see people from town," Knox said.

Steve Phelps, was standing in the pool as his 3-and-a-half-yearold son, Will, jumped from the pool's edge into his arms. Phelps said coming to the pool makes for a break from everything around him.

"My wife made me stop doing yard work," he said and laughed. "I left the smartphone at home and the whole nine."

"I've got a few years of proven leadership and hands-on experience," Zeoli said. "There's a lot of things the Highway Department does now that I've had experience doing while I worked with the Department of General Services. I can bring these things to the table and hit the ground running."

Zeoli has worked for the City of Albany for the past 15 years in a number of positions. The last four years, he has been the city's director of recycling. Zeoli said he has kept up-to-date on trends in paving, stormwater management and solid waste management. He also would to implement some ideas at the compost facility that

"Good service and safety is my mantra," he said.

Zeoli said he would want to make sure paving stays on a routine schedule and pledged to work closely with Deyoe in an attempt to share employees and equipment.

"I heard some equipment is sitting there unused, so that is something I would like to evaluate," he said.

Meredith has a degree in engineering from Clarkson University. He was a civil and environmental engineer with the federal government for 13 years before moving to Delmar in 2000. Since that time, he has been a stay-athome dad.

"I wanted to do something to help the community I lived in and the superintendent of highways remains an important job, no matter what your views on how the vote should have gone," he said. "I have the experience and the background needed."

Meredith said he has yet to speak with anyone within the department about what they would like to see changed, but would like to try achieve some of the same efficiencies that were talked about by Town Board members when there was talk of consolidation with the DPW. So far, he is paying for his campaign himself and petitions are being circulated on his behalf through the work of family and friends.

"I think my experience and work with the Navy makes me the most qualified guy in the Democratic race," he said. "People care about this and I don't think we can rely on someone the party picks who may or may not be qualified."

Meredith interviewed for the endorsement of the Democrats, but was neither nominated nor selected.

Meanwhile, Bethlehem Republicans and county Conservatives have endorsed the town's Coordinator of the Development Planning Committee Terry Ritz. Howard Hyer, a manager within the town's Highway Department, said he plans to primary Ritz on the Republican line.

Ritz, a member of the Independence Party, has worked with the engineering division of the town for the past 27 years and was the previous executive director of the Bethlehem Industrial Development Agency. He has been attending highway superintendent training and finished up with classes in October, he said. For the past four years, he has also been working with highway employees to see where he could improve the department.

"Most of my goals came from current highway staff, and I'm already a familiar face," he said.

Ritz said he would also like to evaluate the department's equipment to see what could be consolidated with other departments. He would also like to eliminate a policy that stipulates when employees have to take their mandatory two-week vacation.

"There's almost a month when the department is at half staff because of the policy," he said. "It causes paving to be off schedule and pushes back leaf pickup. It's also inconvenient for employees because their scheduled time off might not coincide with when their family and children have off."


Hyer is also a familiar face with highway employees. He has been working with the town's Highway Department for 21 years and has been a foreman for 10. He is now the director of administrative services and fleet management. Hyer said he already works closely with the supervisor and Devoe, and would also want to create efficiencies between the two departments.

"I've worked with the town on consolidation from the beginning," he said. "I integrated management between the office staff for highway and DPW and I think it's a good goal if it can be done where it works and where it fits."

Hyer said he's looking to make the department more environmentally friendly by cutting back on the use of road salt. He's also interested in looking into bringing some new technology into the department, such as using liquid de-icers.

"I feel like I'm the most experienced," he said. "I believe I have the support of the employees and the former superintendent. He worked with the Town Board for years and I feel I would follow in that mold as well."

Candidates will be collecting petition signatures into July. This year's primary falls on Sept. 10.





The barrels are designed for outdoor use, with overflow connections, a nylon spigot and a drain plug. They can also be linked together for additional capacity. The barrels have screw on lids, and the overflows are designed to fit any standard garden hose to make it easier to redirect the overflow.



Within Tkaczyk's fivecounty 46th Senate District is a wide variety of schools districts from "wealthy lowneed suburban districts to poor, high-needs rural and urban districts," she said. A common thread is the concern over increased testing, she said.

Colin Winters, an eighth-grader at O'Rourke Middle School in the Burnt Hills-Ballston Lake School District, said increased testing is negatively affecting his education. The amount of time spent testing and how long the tests take to complete is too much, he said.

Fahy said though 45

states have adopted the Common Core Standards, New York state is only one of two states testing on the new standards this year.

"I worry about the self esteem, not just the stress on children," Fahy said, "especially when I don't know a single child ... in some of our highest performing schools that finished some tests that were given this spring.'

Winters recalled the second day of state testing on English language arts when he hit his "breaking point" after becoming increasingly frustrated.

"I wrote comments all over my test hoping that somebody would see them. After I realized no one would see them I wrote a letter to the commissioner of education and before I even knew about this forum," Winters said. "I am still looking forward to hearing back from him."

He said the tests "have done harm" and have added "real stress" for students.

Guilderland Central School District Superintendent Marie Wiles said her main request to the State **Education Department is** to "please slow down."

Since the testing on the Common Core has already been done, Wiles said student achievement should be reviewed to

determine how tests were interesting and he should be designed for next school year.

Assemblyman James Tedisco, R-Glenville, said he believes there is not enough autonomy for districts when it comes to implementation.

"I think the money would be better and well spent by the school boards, by the administrators," Tedisco said. "The differences are widespread and the funding needs are different."

Wiles said Tedisco's concept is an improvement, because reforms lean towards "one size fits all." She said the state could define goals while giving districts more ability to determine what is best for its community.

Gregory Diefenbach, assistant superintendent for business at Voorheesville Central School District, stressed more inroads must be made on mandate relief.

"Many of the mandates we are already doing in some fashion, so we are doing it in a redundant way," Diefenbach said. "They need to be reviewed and in many cases I believe a lot of them can be eliminated, which would save a lot of money."

Diefenbach said some of the ideas presented by legislators at the forum

is looking forward to continuing the dialogue. He urged lawmakers to simply talk to local school officials on how to tackle problems.

Winters said because of the Common Core, he learned the vocabulary word "bureaucracy firsthand this year.

"These tests are a bureaucratic solution to a problem that often does not exist and there is no reason to have a solution when there is no problem," he said. "I feel kids are overworked and stressed out. The last thing my peers and I need is another

# **Lady Dutch shut down in regionals**

# Dutchmen start strong

#### After power outage and two rainouts, Albany wins two in a row

The Albany Dutchmen showed what they can do when the weather and National Grid cooperate.

The Dutchmen rallied for a 3-2 victory at Elmira Saturday and defeated Newark 6-3 Sunday at Bellizzi Field to start their Perfect Game Collegiate Baseball League season with a 2-0 record.

Albany endured a series of mishaps before completing its first official game of the season.
