Soccerplex gets variance

Indoor dome project heads to town's Planning Board

The Bethlehem Zoning Board of Appeals has unanimously approved a height variance for the Bethlehem Soccer Club's proposed indoor soccer complex on Wemple Road.

The soccer facility is being proposed through a new partnership between the soccer

club and Afrim's Sports. The plans call for a 43,000-square-foot indoor, inflatable dome to be built on the club's property at 450 Wemple Road. At 55 feet, the structure would be 20 feet taller than what is allowed for a building in a Rural Zone, thus requiring the variance.

"There will be some aesthetic impact to the immediate neighbors, but the impact will not be of a significant nature," said Zoning Board Chairman Dan Coffey.

A balloon test was held

earlier in the month at both the proposed site and an alternate site on the property to get a visual representation of how high the building would be.

On Wednesday, July 17, Brian Sipperly, of L. Sipperly and Associates, gave an updated presentation on the project to answer questions posed by residents during the first portion of the project's public hearing.

Sipperly said if a structure were built at 35 feet, it would limit

Super hopefuls fill their coffers

Guilderland candidates nearly neck-and-neck in early fundraising

Democrat and Guilderland Supervisor Ken Runion has more cash on hand than Republican challenger Mark Grimm, but both have raised a similar amount of money since campaign season got underway.

Seven-term incumbent

Runion reported a closing balance of almost \$23,100 in his campaign's July financial disclosure filed with the state Board of Elections, while Grimm reported just over \$8,200. Runion has raised approximately \$8,860 since January, but Grimm's contributions were on par with Runion for that period at \$8,166.

Grimm said the figures show a strong support from the public, but Runion discounted the concept fundraising is a measure of public approval. Runion said a committee raises funds for his

Glenmont playground effort gets under way

With Elsmere nearing its goal, PTA begins fundraising in earnest

As a parent-driven effort to upgrade the Elsmere Elementary School playground nears its fundraising goal, the drive to do the same at Glenmont Elementary is officially shifting into gear. \$128,100 was included for a new playground at Glenmont within a facilities upgrade bond approved by voters earlier this year. However, a percentage of those funds will be used for “soft costs,”

leaving \$93,000 for the equipment itself. The PTA has seen estimates that it will cost about \$200,000 to replace the playground, so the group is still looking to raise about \$100,000. Amy Scharf, co-chairwoman of the Playground Committee for the Glenmont Elementary Parent Teacher Association, said because the district is now putting forth some of the money, costs raised slightly because the work must go out to bid. The original plan was to use volunteer labor to construct the playground after the equipment was purchased.

The Glenmont PTA is now taking many of its cues from the successful fundraising campaign for a new playground by Elsmere Elementary PTA members. In less than two years, the group is little more than \$1,000 away from its goal, with the hope of an installation happening sometime this year. Glenmont has now raised close to \$28,000 through its efforts.

Scharf said now that Elsmere is almost done with its campaign, Glenmont will now begin its major fundraising efforts. The PTA knew it might be burdensome on the community if two similar fundraising drives were happening at the same time. Future activities will include a Glenmont Elementary Fall Community Day and Family Fun Day in September. The PTA will also be holding a 5k walk and silent auction. Other community member have donated money outright, and some children have opened lemonade stands and donated the proceeds to the cause. The school also recently sponsored a dunk tank at the Glenmont Fireman’s Fair, with district faculty and staff taking the seat. “We want the kids to be able to get exercise and have fun,” said Scharf. “Right now it is not a place to take kids and we felt the students wanted a new (playground).” Scharf said the school’s playground is nearly 20 years old and several pieces of the structure are no longer functional. The playground is now outdated and school officials are looking to replace the playground

out of safety concerns. “It was a good playground,” said Scharf. “It served us well, but seen its day.” At times, some pieces of equipment has been roped off with caution tape to keep children away, while some parts of the playground are missing large pieces of plastic. Scharf also said the bottom of some slides now touch the ground, as do some ropes and chains that are meant for children to climb and balance on. “The district has been good about trying to keep up with the repairs, but there are just too many and there is a cost,” said Scharf. There is also an issue with drainage, and some equipment is not up to code for children with disabilities. “Glenmont’s goal is to accommodate all children,” said Scharf. “For instance, plans call for ‘cocoon swings’ for those with autism, swings for those in wheelchairs and play equipment to welcome every child.” To learn more or donate, visit glenmontplayground.com.

Hot rods head to high ground

Thacher Park to host fourth annual 'Wheels in the Woods' car show

Mother nature will have something to compete with in the splendor department for one afternoon.

John Boyd Thacher State Park in New Scotland is revving up for its fourth annual "Wheels in the Woods" car show on Saturday, July 27, from 10 a.m. to 4 p.m. at the Pear Orchard Picnic Area. Classic rides, specialty cars and tuners will be (hopefully) glimmering under the sunlight. Thompson's Lake Reformed Church will offer food and refreshments during the event, with a DJ playing some classic tunes.

"When you have the nice weather and all the cars out, everybody is in a good mood and I love seeing people up here and enjoying themselves at the park," Park Manager Chris Fallon said.

The idea for the car show formed during a brainstorming session of events the park could

host, Fallon said.

"We were just kind of looking for something different that might attract some people up to the park," he said. "The idea of the car show came up and we all thought it sounded like a good idea."

To help promote and spread the word, the park tapped Jason Rittner, a local car enthusiast who regularly attends car shows.

"I had been involved in a couple other ones before, so I figured I could help out," Rittner said. "They need publicity and they need ads and it is hard for us to do from a park level and my level."

Rittner said he enjoys hosting the event, but is also happy to help the park.

"It just brings awareness that there is more going on at the park than just having a picnic and leaving," he said.

Rittner said he started down the path of becoming a car enthusiast after purchasing his first car, a \$70 Dodge Aspen. The starter blew on the car and he stopped at a garage near his school to get it fixed.

The mechanic said it would cost around \$150 to



replace or he could "man up and go to a junkyard and put it in" himself. Rittner did just that, getting a starter for \$20 and putting it in himself.

Rittner, now 40 years old, said he has owned more than 70 cars at "various stages of repairs." Many he has fixed up and sold, with others being sold as-is.

"It is the thrill of the chase," he said. "I enjoy going to these shows and knowing all of these people have done the exact same thing."

Rittner and Fallon agreed turnout was affected by weather at last year's event. Fallon said the first year was a "real good start," with more than 50 cars and the sun shining.

"The last couple of

years it has been on the rainy side so it was not as well attended and not as many participants, so we are keeping our fingers crossed for nice weather," Fallon said. "We are also trying to avoid other shows in the area on the same day."

There will be awards given to the top 10 people's choice award winners, Rittner said, with attendees selecting their top five picks. A little reward will be given to each winner.

"The quality of the cars that are up here is fantastic," Fallon said. "They have the classic models and everyone has the hoods up and the engine blocks are incredibly clean. There are a lot of neat features and old style cars."

Families can also check out Thacher's new playground at the picnic area that opened this spring. The former playground was of an older style, with a climbing dome and swing set, Fallon said. The new playground is of plastic construction with slides and climbing features. Recycled rubber chips were used as the new surface material.

For cars, there is a \$10 fee for pre-registration, with it costing \$13 the day of the event. There is not a cut off year for cars

Anonymous tip leads to heroin discovery

State Police have arrested a Jackson Heights man after police received an anonymous tip the car he was driving contained illegal drugs.

On Wednesday, July 17, State Police said a car matching the description was observed speeding in the Town of Bethlehem. The

anonymous caller had said the vehicle was originally traveling north on I-87 and may have been transporting a large amount of drugs.

State Police said they stopped the vehicle and interviewed the driver. He was identified as Miguel Hemenegildo, 27, from Jackson Heights.

During the investigation, police allegedly discovered a hidden compartment located inside the vehicle that contained approximately 1 kilogram, or 2.2 pounds, of heroin.

Police said Hemenegildo was arrested and charged with criminal possession of a controlled substance in the first degree, a felony. He was also charged with speeding and other vehicle and traffic law violations.

Hemenegildo was held without bail in the Albany County jail to await a felony hearing.

Three-car crash causes injuries

The Albany County Sheriff's Office is continuing to investigate a three-car crash in the Town of New Scotland that left three people with injuries.

Police said on Wednesday, July 17, at approximately 11:56 a.m., Joseph Deangelis, 85, of Slingerlands was driving northbound on State Farm Road with his passenger, Ascenza Deangelis, 76, when Marion B. Parmenter, 70, of Voorheesville, who was traveling southbound, entered into their lane. Parmenter struck Deangelis' vehicle head on, which caused extensive damage to both vehicles, police said.

Police said Carol Monterosso, 64, of Voorheesville, who was driving northbound, then swerved to avoid the accident, but Deangelis'

vehicle spun around and stuck Monterosso's vehicle.

Joseph and Ascenza Deangelis were transported to Albany Medical Center for treatment of multiple injuries, according to police, along with Parmenter for minor injuries. Police said Monterosso did not report any injuries.

Albany County Sheriff's Office deputies responded to the incident, along with the Sheriff's Office Paramedics, Voorheesville Fire Department, Voorheesville Area Ambulance Service and State Police.

Hometown history highlighted at fair

New Salem Fire Department to host 71st Punkintown Fair

A local fair that's been running for more than seven decades has its hamlet's history to thank for its unusual name.

The 71st annual Punkintown Fair, hosted by the New Salem Volunteer Fire Department, kicks off Thursday, July 25, this year, and runs through Saturday, July 27, with doors opening at 6 p.m. each day. Though the hometown fair raises funds for the volunteer fire company, the event purportedly began before the fire department was established. Many things about the quaint fair remain tied to its roots, with a family-friendly tradition shared by generations.

Around 1770, the area of New Salem was settled as farmland with a road running through the community. Stu Morrison, past event chairman and former fire department captain, said the area was known as Punkintown before a post office was established in the hamlet in the 1830s.

Why the area was

called Punkintown is tied to its superior gourd produce.

"Supposedly, there was a pig that raised her piglets in a huge pumpkin that was chewed out," Morrison said.

The fire department entered an annual contract with the town in 1949, but additional funds were still needed to operate, according to the New Scotland Historical Association. The fire district surrounds the Village of Voorheesville and covers around 23 square miles, or 40 percent of the town.

"The history is it actually started out prior to the fire department being formed during WWII and the fair was used to raise money for troops overseas," Morrison said. "There are not too many people left that remember when it was started, but from the town historian that is what I get as gospel."

The fair remains the biggest fundraiser for the department if there isn't inclement weather, Morrison said.

"When we have a good year, it is easily our biggest fundraiser and when it rains it is number two," he said.

For many people, it is also about a family

tradition, he said, with the fair acting like a sort of homecoming for some former residents that have left the hamlet.

"A lot of people that grew up here come back and bring their kids because they remember coming here as a kid," he said. "I remember coming here as a kid and winning my goldfish."

Morrison even said he has a couple fish at his house he won at the fair around seven years ago.

Originally, the fire department owned its own rides, but for several years it has contracted out that portion of the event. That has led to more rides, too.

"It is more of classic fair feel now," Morrison said, "because kids can go on the big swing and things that make them hurl up their lunch."

Raffle tickets were mailed out, but tickets will also be available during the fair at the announcer's booth. The raffle has a first place prize of \$2,500, second place prize of \$1,000 and third place prize of \$500.

Opening night there will be a "meet and greet" with local D.I.R.T Modified Racing Champion Matt DeLorenzo, whose father is a fire company member. Then on the following two nights, Dean Davis and his "animals that nobody loves" will be the special attraction. Of course, classic fair food will be offered.

"Every year we try to update some of the older things and keep it fresh," Morrison said. "We are all family people and we run it as such. We very much want to make it a good experience for everyone."

From the Editor’s Desk

Alms for the schools

You’ll read this week about efforts by the Glenmont Elementary Parent Teacher Association to upgrade that school’s playground equipment (page 2).

According to Amy Scharf, of the PTA’s Playground Committee, that goal is long overdue. Some pieces of equipment are broken, to the point they’re roped off to keep kids out of danger.

It’s similar to the situation at Elsmere Elementary, where the PTA there launched into a fundraising campaign last winter. That group is nearly at its goal as of this writing, having collected roughly \$75,000.

The generosity of the Bethlehem Central community is commendable, as is the drive from these groups to make these projects. But the fact Glenmont is following hot on the heels of Elsmere raises some valid concerns about how our communities support schools.

Glenmont waited until this point in part to let Elsmere do its own fundraising for its playground and avoid community

fatigue. That’s certainly understandable, because the BC community has also been almost entirely supporting several sports teams for years and chips in for plenty of extracurricular clubs.

These are “wants,” to be sure, but they’re not extravagances by any means. (We would, in fact, argue the intrinsic value of a playground for a child may well exceed that of an iPad.) But these costs are starting to add up, especially when considering parents and teachers (who will be disproportionately solicited to add additional support to the schools) already must supply community items like extra pencils, tissues and the like for their child’s classroom every fall.

To be fair, the district is paying for part of the playgrounds project through a building project bond, but that support was dialed back in light of the PTA fundraising. It certainly seems the developing trend is to let parents and community members pick up the pieces of what’s crumbling at BC.

Unintentional or otherwise, these mounting instances set dangerous precedence for the future.

In a community like Bethlehem, which is affluent and engaged, these may seem like quibbling concerns. Indeed, BC students are lucky to have neighbors and parents willing to open up the checkbook and make their time at school better.

We are concerned that this sort of arrangement may become the new normal, however. Members of the Glenmont PTA are right to worry about the community becoming overburdened, and so should officials in the district that are increasingly relying on the power of donations.

This might be an acceptable approach for getting through tough times, but it is hardly a way to live. We encourage the school board to view PTA and community support as a stop gap measure only, and to continue working to increase efficiencies and one day in the future wean itself off of public charity.

Guest opinion Gardener’s alert: Rose Rosette Disease

Blights, fungus and insects from Asia move over to make room for the latest threat to our backyard gardens: a viral disease that is spread by mites that attacks all types of roses. Rose Rosette Disease is not new but it is new to our area and it seems to be making its mark rather quickly so let’s try to understand why. This disease was first identified in the 1940s but the causal agent was not pinpointed until 2011. As is often the case, many factors are at play but the main culprit is a tiny eriophyid mite that also causes rose leaf curl. The microscopic mites travel on the wind or on birds or insects in search of rose plants. As the mites feed on the rose leaves, they spread a virus that causes bizarre symptoms such as rapid elongated growth that is reddish in color with many thorns, malformed buds and

an excessive number of new shoots or witches broom. Close observation will easily reveal the disease – it is easy to spot. The virus is also spread by pruning tools, and so careful disinfection of pruners between plants is important. Grafted rootstock can also harbor the virus so inspect all potential rose purchases carefully. Management is total removal of the plant as soon as the virus is detected. Since this is not a soil borne pathogen, roses can be planted in the same area.

One of the main contributing factors to the spread of Rose Rosette is the invasive Multiflora rose. A native of Asia, it was introduced in the 1800s as an

ornamental and as rootstock to gain hardiness for more tender roses. In the 1930s its use spread to conservation as erosion control and for reclaiming land used for strip mining. Time has revealed that these very qualities also make it a horrible weed that proliferates everywhere. This rose is very susceptible to Rose Rosette disease and considerable numbers are being killed by the virus. It takes about two years for the virus to kill a plant and so during that time the mites multiply and so the Multiflora roses become a source of inoculum for the virus.

The mid-west and southern regions of the country are experiencing a surge in Rose Rosette disease due to the fact that Knockout roses have become a huge part of commercial and home landscaping. A monoculture of roses has emerged as a result of the popularity of the new Knockouts and this plus the proliferation of the multifloras has created a perfect storm for Rose Rosette. Last year the Schenectady Rose Garden

found the virus in a few plants and a recent article in the Gazette (July 2) stated that it has been found again this year in that garden and it is suspected in the Yaddo Gardens in Saratoga.

There are no chemical controls for this disease or effective miticides available to homeowners so be vigilant and keep a close eye on your roses. A good offence is the best defensive against this disease so maintain the health of your roses, disinfect tools religiously and water from the base during dry spells to discourage disease and mites. Removal of all invasive Multiflora roses within 300 feet of your garden is also recommended. A prayer or two won’t hurt, either!

Demonstration drives home distracted driving

AT&T stores, Valley Cats partner for texting and driving simulator

In an effort to demonstrate the dangers of distracted driving, local AT&T locations teamed up with the Tri-City Valley Cats to spread the company’s “It Can Wait” campaign.

On Friday, July 19, a texting-while-driving simulator was set up at the AT&T location in Glenmont. The event was attended by company representatives, town officials and the Tri-City Valley Cats mascot. The company went on a local four-day tour with the simulator. They were also asking people to sign the “It Can Wait” pledge.

“This is an important time of year because we are smack dab in the 100 deadliest days of summer, which is a time roughly between Memorial Day and Labor Day when distracted driving and drunk driving are at their heights,” said AT&T Director of External Affairs Ed Bergstraesser. Bergstraesser said

a recent AT&T survey found 97 percent of teens asked knew texting and driving was dangerous, but 75 percent said it was a common practice. The company has since received 1.2 million pledges in its campaign and is now working on giving presentations to high schools across the country.

According to the state officials, one in five accidents in New York is a result of distracted driving. From 2005 to 2011, the number of deaths and injuries from distracted driving increased by 143 percent.

Earlier in the month, Gov. Andrew Cuomo detailed a \$1 million summer initiative to increase enforcement of distracted driving laws by boosting undercover operations statewide. State Police will use unmarked vehicles that are specially designed to enhance the ability of troopers to catch people using their phones while driving.

Throughout the afternoon, AT&T customers were asked to test the simulator in order to gain a better understanding of how difficult it is to text and drive, and to witness

the repercussions. Participants were sent text messages while using a computer program to drive, complete with a fake steering wheel and pedals.

Participants were able to choose if they wanted to receive business or casual related texts. The texts included questions like what the person wanted for dinner or gossip about school. If participants waited too long at a stop light or swerved over the

lines, they were stopped by police. But most didn’t make it that far before getting in an accident.

Bethlehem Chamber of Commerce President Jennifer Kilcoyne used the simulator. She did well driving, but often ignored the texts in

order to stay between the lines.

“It was even more difficult than I thought it would be,” she said. “With all the distractions and busyness of traffic these days, I don’t know why people would take the risk.”

Kilcoyne said she thinks the simulator is a great tool for drivers to grasp the focus needed when driving an automobile.

“It’s not something you really can do, while doing other things,” she said.

the length and width of the facility. That would mean older children and adults would not be able to use the facility for games, since the two smaller fields within could not be turned into one large field. It would also limit the use of the facility for other sports, such as lacrosse.

Additionally, the developer said an inflatable dome was chosen instead

of a solid structure because of cost.

"A solid structure would be double the price of a dome," said Afrim Sports owner Afrim Neza, adding estimates put an indoor facility without a dome at about \$1.2 million. The additional height of the dome is also needed for the building's protection in order to withstand snow buildup and high winds.

Soccer dome opponents complained of the potential for additional noise, loss of property value and an obstructed view. Other residents were concerned about an increase in traffic. Proponents said the dome would be valuable for the community's children, would bring jobs and would help the local economy.

With the ruling, the Zoning Board did ask the developers to plant some trees along the perimeters of the property to obstruct the view from neighbors. Residents countered it would be decades before the trees reached 55 feet to block the building from view.

Neza owns two other facilities in the Capital District. The partnership would mean both the club and Neza would pay for the facility to be built. After construction, day-to-day operations would be left to Afrim staff with the Bethlehem Soccer Club acting as a landlord.

The project will now go before the town's Planning Board.





Entertainment in the Spotlight

For many Capital District residents, summer doesn't officially begin until the Saratoga Race Course opens.

For more than 100 years, Saratoga has been the August place to be. Close to a million people pass through the Union Avenue gates each year, many decked out in fancy hats, dresses and suits, and others dressed comfortably in T-shirts and shorts with a wagon and cooler in tow.

This year, the summer has been extended in Saratoga, and organizers are saying it's a party you don't want to miss. The track gates may have opened nearly a week ago, but the party started back in May when "Saratoga 150" kicked off its sesquicentennial celebration, and the celebration doesn't end until Sept. 30.

Over the last several weeks, Saratoga storefront windows and front porches have been dressed to impress, candy shops have been cranking out special candy bars and jewelry stores have been selling special jewelry all to commemorate 150 years of thoroughbred racing in Saratoga.

What first began as a four-day meet in 1863, Saratoga Race Track has become a mecca for racing enthusiasts, attracting people from all over the world to the little City of Saratoga.

This year, the whole town is joining in on the celebration, and with more than 200 events scheduled through the month of September, there is something for everyone.

Joe Dalton, Executive Director of Saratoga 150, said the initial planning began in the fall of 2011.

"I got a call from Charles Wait, the chairman of the committee who said we will have a little party to celebrate the 150th anniversary," said Dalton. "That little party turned into over 200 events."

The festivities, which include exhibits, concerts, contests, parades, balls and more, have the city bustling with entertainment for five months.

Step back in time on Friday, Aug. 2, when Saratoga will host a Floral Fete Promenade beginning at the corner of Route 50 and North Broadway and continuing down Broadway to Congress Park. Dalton said the tradition dates back to the late 1800s. Carriages, vintage automobiles, floats, bicycles, wagons and baby carriages will be decorated with flowers as they make their way down Broadway. An ice cream social will follow the promenade in Congress Park with live music, strolling entertainers, free ice cream from Stewart's Shops and special Saratoga 150 carousel tokens.

On Thursday, Aug. 8, Saratoga Performing Arts Center will celebrate with a world premier concert and performance by The Philadelphia Orchestra. The famed ensemble, which performs at SPAC from Aug. 7 through 24, will premier Richard Danielpour's *Serenade*, a work created especially for the anniversary.

A Bettor's Ball is planned for Saturday, Aug. 17, at the Saratoga



Summer in Saratoga is a special institution. And with the 150th anniversary of the Saratoga Race Course's opening this year, it will be celebrated all summer long in style.

Springs City Center. Dalton said most balls require fancy attire and pricey tickets, but not this one.

"It's not for the champagne and caviar crowd," Dalton said. "It's for the average person."

Three ballrooms will host dance bands of seven different generations from the '40s until today. Inexpensive food and beverages will be available. The fun begins at 7 and goes until 11 p.m., and costs \$10 per person.

Saratoga socialite and philanthropist Marylou Whitney and husband, John Hendrickson, will give five racing fans a chance to bet \$15,000 of the couple's money at this year's meet, beginning with the Whitney handicap on Aug. 3. A \$15,000 wager will be offered each Saturday throughout the racing meet. Registration for the contest is required at www.saratoga150.com/contest.

Walking tours will be available throughout the racing season for the first time since 2000. The tours are 45 minutes long and are led by Saratoga Race Course professionals with a vast knowledge of the track and its 150 years of history. The tours start on the first floor of the grandstand at 9:30, 10:30, 11:30 a.m. and 1:30, 2:30 and 3:30 p.m. every day except Traver's Day.

A number of the museums in town have created exhibits especially for



activities from 4 to 7 p.m. For more information, visit www.saratogafarms.com.

Fridays at the track are family fun days. From noon to 4 p.m. a family-friendly festival takes place with face painting, arts and crafts, reptiles, science exhibits and bounce inflatables.

For those who want to celebrate all summer, Saratoga 150 is offering a package that will get you admission to hundreds of the events. The packages run from \$15 to \$150 and include admission to museums, shows, races and more. These can be purchased at Adirondack Trust Banks, Impressions of Saratoga at 368 Broadway in Saratoga Springs, The National Museum of Racing and Hall of Fame, 191 Union Ave., in Saratoga Springs, N. Fox Jewelers, 404 Broadway, in Saratoga Springs and online at Saratoga150.com. The packages include free admission to the track on Mondays, discounts and early entrance opportunities at concerts and events such as the Bettor's Ball.

Not everything comes with a fee, however. Dalton says the majority of events are free of charge, such as Sunday night jazz concerts in Congress Park and a variety of other performances and tours throughout the city.

Saratoga's racing season runs through Monday, Sept. 2, six days a week. Tuesdays are considered "dark" days when the track is closed. Gates open at 11 a.m. on weekdays and 10:30 a.m. on weekends. You can enter at 7 a.m. to claim picnic tables, but you must leave and reenter when the gates officially open. Admission is \$3 for grandstand and \$5 for clubhouse. Children under 12 are free.

GCSD eyes \$18M facilities improvement plan

The Guilderland Board of Education recently heard the district's Facilities Committee unveil proposed capital projects totaling almost \$18.2 million. If pursued, the spending would require voter approval.

The first recommendation totaled more than \$17.3 million and included building infrastructure renovations, safety and security improvements and instructional technology upgrades. The second recommendation of \$845,000 tackled high school auditorium upgrades and replacing the high school football field light pole.

Both recommendations as proposed would be presented to voters in separate referendums. The district "conservatively" estimated around 90 percent of proposed project costs would be eligible for state building aid reimbursement of up to nearly 65 percent.

District Superintendent

Marie Wiles said the committee worked throughout most of the spring with architects to develop its next capital project.

"The multiple perspectives that were around that table brought us to a place where we have an excellent product," Wiles said at the board's July 2 meeting.

Wiles said while students must have an environment conducive to learning, the district's "most important" responsibility is to keep children safe during school.

The first and larger proposition would result in an annual tax increase of \$65 for a home in the Town of Guilderland assessed at \$246,500, the median value. The second proposition would likewise result in an annual tax increase of \$3 to the same home.

Assistant Superintendent for Business Neil Sanders said critical areas of need include replacing building components that are creating safety concerns, near the end of useful life

or are a "detriment to the efficient and economical operating of the building."

Security concerns largely focus on controlling visitor access to buildings and securing classrooms from being accessed by intruders, Sanders said. Technology concerns focus on creating or improving wireless Internet access at all school buildings.

Some of the most expensive recommendations include replacing roofs at various buildings for around \$4.7 million, paving parking lots for more than \$2 million, replacing boilers and controls for almost \$1.2 million and nearly \$1 million for replacing building floors.

The second proposition focusing on the high school was broken out for being dissimilar from other projects.

"After a lot of discussion, two items where we felt that it didn't quite fit the same model as what we were talking about ... are being split out," Sanders said.

Board members are scheduled to review and discuss the projects and adopt a bond resolution on Oct. 1. The referendums are scheduled to be presented to voters on Nov. 19. If approved, project design and development would begin, with the state Education Department reviewing the projects from July to December 2014.

The first phase of construction is projected to begin in April of 2015, with the second phase starting in September of 2016.


