Neighboring state parks to merge

Public hearing yields support for Thacher and Thompson's Lake draft master plan

Albany County residents were generally welcoming of the state's proposed plan to improve and enhance John Boyd Thacher and Thompson's Lake state parks to meet modern recreational demands.

The New York State Office of Parks, Recreation and Historic Preservation on Thursday, Aug. 1, held a public

hearing on its draft master plan and draft environmental impact statement for Thacher and Thompson's Lake state parks at New Scotland Town Hall. The master plan, which merges the two parks, includes the state parks' envisioned capital improvements and operational enhancements for the next 10 to 15 years. The exact timing of or possibility for proposed improvements isn't clearly defined because it hinges on several factors including availability of funds.

"All substantive comments must be taken into consideration by the agency

A camp of their own

Bethlehem Senior Services program invites residents 60 and older to relive summer camp experience

Summer camp is considered by many to be an important rite of passage consisting of nature walks, junk food and forging new friendships. Others may have missed out on the experience.

For those looking to add some adventure into their summer and re-live their days at camp, Bethlehem Senior Services is featuring a new program for residents 60 and older. Beginning in September, a two-day summer camp will be held with events and activities planned for seniors.

"It's a way to make new friends and acquaint with old ones," said Senior Services Director Joyce Becker.

The program is being held during the day on Sept. 7 and Sept. 8 at SUNY Cortland's Robert C. Brauer Memorial Education Center in South Bethlehem. This is a pilot program for the department, so space will be limited to the first 20 seniors who sign-up.

"It may also be fun for people who grew up in a city environment to enjoy some activities in a rural setting," said Becker.

The program is being coordinated by Department of Senior Services Outreach Worker Will Vale. He said the idea is based on a similar program being done in Delaware County that has expanded to an overnight camp. For the time being, Bethlehem's program will only take place during the day.

Vale said the idea is for seniors to re-live their youth, meet new friends and get out of the house.

Different events have been scheduled throughout the camp's two days. There will be talks and demonstrations on wildlife and the environment, fitness lessons, arts and crafts projects, live music, and food.

Vale said members of the

community have volunteered their time to make the camp a reality. Five Rivers Environmental Education Center staff plan to give a geocaching demonstration, while local artists will help campers tie-dye shirts and press flowers. Paul Doyle Jr. of the Critter Patrol will give a presentation on amphibians and reptiles, and an instructor

Clarkson urges IDA webcast

Supervisor says move would promote disclosure and productivity

Bethlehem Supervisor John Clarkson and other members of the town board are once again encouraging Bethlehem Industrial Development Agency members to webcast their meetings for reasons of transparency and efficiency.

Clarkson attended the IDA meeting held on Friday, July 26, to ask members to reconsider their previous decision to not webcast their meetings. At the time, the agency had opted against using the town's online video capabilities because members were concerned it would limit open discussion.

"I think this is about more than ramping-up disclosure and transparency, it's also a productivity tool," said Clarkson.

The supervisor said the town's Meeting Portal has been extremely useful to town staff and board members over the past year and a half. The system has made it easy for town officials and residents to find information from previous meetings, re-watch meetings they may have missed and become informed about past town issues.

However, Clarkson said, they have

Fitness and fun reach new heights

Guilderland reopens rock-climbing wall housed in historic barn to public

A look inside one old barn tucked among the hills near Guilderland’s Tawasentha Park won’t reveal the expected animal inhabitants, but there is still plenty of activity brimming beneath its roof.

The Guilderland Rock Adventure Barn, or GRAB, reopened to the public last month after closing its doors several years ago following waning interest. The historic 1800s barn, located on Route 146 across from Tawasentha Park, hasn’t held farm livestock and supplies for many years. The red barn features more than 3,000 square feet of rock wall climbing surface and is suited for first-time to advanced climbers. All of the necessary gear is offered in-house.

Public use of GRAB is limited to Friday from noon to 6 p.m. and Saturday from 11 a.m. to 5 p.m. until the end of August. The town started this trial period in July to gauge public interest.

The cost is \$5 per person, which includes necessary gear.

“We thought we would give it another try,” town Parks and Recreation Director Dennis Moore said, who indicated the response has been moderate. “There weren’t enough people using it — not enough customers to make it worthwhile.”

Moore said the rock climbing is “challenging,” “fun” and offers a different form of fitness. Along each wall are typically two routes, with one route being easier than the other. Some of the more strenuous climbs take you all the way up and onto the underbelly of the barn’s roof.

Once someone learns how to properly climb and belay, which is protecting a climber from falling, they can participate without the help of trained town employees.

Moore said declining interest in the facility could have been from people not wanting to climb during hot summer days. The facility isn’t heated, so it can’t be used during the colder months. Active rock climbers will also be outside when the facility is usually open.

“People who want to

really rock climb, they will go outside now,” he said. “They will climb on the real rock outdoors. They would use this to train on more.”

Moore said the town “likes to break even” on its cost to keep the facility open to the public. He said it isn’t seen as a way to make money.

Even though the facility hasn’t been open to the public it was still being actively used through the town’s youth summer camp.

“We use this as fitness for the kids,” Moore said. “We have around 250 kids in camp that we bring over here every day. We bus them over from right across the street at Tawasentha, and they come and climb as one of their activities.”

Stepping into the facility you’ll notice the spongy floor, which is made from the rubber of ground up tires and has been in the barn since it opened. One of the workers will likely greet you if they aren’t already belaying someone and can teach you climbing basics.

Taylor Treadgold, an Altamont resident and University at Albany senior, was running the

facility on Friday, Aug. 2. Treadgold became interested in rock climbing as a college freshman through a weeklong outdoor exploration program.

“I went and I did the trip, and I pretty much got hooked on climbing from there,” Treadgold said. “Since then I have been climbing three or four times a week.”

Treadgold said he enjoyed climbing because of the sense of adventure it offered along with the “sports sense” of it.

“It’s nice because it has the dichotomy between an activity and a sport, so you can be really serious about it but you can also just go in and have a good time,” he said. “It is kind of for the love of it as opposed to for sport or anything else.”

He enjoys working at GRAB so he can teach kids and share his passion.

“It is really fun to work with the kids,” he said. “They all seem to really enjoy climbing, so it is nice to see other people being exposed to climbing and getting into the sport.”

Around 15 years ago Moore, with help from

New era for Delaware Plaza

Shopping center welcomes new tenants; expands eatery options

Changes are coming to Bethlehem's Delaware Plaza, as the shopping center will soon be full for the first time in several years.

Delaware Plaza Manager Debbie Nolan-Battaglia said upgrades began last year after Hannaford Supermarket opted to expand and renovate its Elsmere location.

"They basically gutted the store, and I think made it much more appealing for the customers and the community," she said.

Next, a former bookstore space has been divided in half to make way for two businesses. Subway has moved into one of the new locations in order to provide a larger dining area for customers. Nolan-Battaglia said a Lemondrop frozen yogurt shop is expected to open next month in the location of the former Subway.

"We're trying to attract stores we know our neighbors want to visit," she said.

A new eatery called Dilmun Cafe has opened in the other half of the former bookstore. It is owned by Leo Ashiq, who operates both Shalimar Indian Restaurant and the new Manama Grille. Also new is the H and I Upscale resale shop, specializing in cloths for adults and children.

The Nolan family has co-owned Delaware Plaza for more than 30 years.

"It needed a lot of work," he said. "We put in a new parking lot and a new roof. It was built in the 1950s."

Nolan said the plaza's tenants have changed over the years, as there was a major shift from locally owned businesses to national chains.

"The whole shopping world has changed over the years, and we're pleased we have been able to keep the plaza full over the great majority of that time," he said. "We're in a great location."

Nolan-Battaglia said the plaza has worked over the years to address the concerns of shoppers.

This year they fixed a drainage issue that was a recurring concern.

"Constantly trying to improve the property for the community," she said.

"We are very fortunate because the people of this town support their local businesses. We support the residents, and they support us."

others, actually built the interior rock walls. The idea was spurred by outdoor climbers wanting somewhere to train during the off-season.

"I had been familiar with rock climbing," Moore said. "We had done some climbing a little bit and my family had done some."

As Moore and fellow workers were building the facility inside he said naming ideas kept bouncing around, but dubbing it GRAB for short seemed "perfect."

The town purchased the property from the Houck's, which had used the land as a dairy farm.

"It didn't harm the barn at all," Moore said. "It was an old dairy barn at one time that the cows were in."

Acquiring the land essentially expanded Tawasentha Park. There are trails located on the property along with the town's community gardens that residents can rent plots to grow produce.

"If you add this land, the Tawasentha land and the Western Turnpike Golf Course, which is all connected, it is probably 500 acres," Moore said.

County corrections officer charged with blackmail

An Albany County jail corrections officer has been arrested after allegedly trying to blackmail a former jail administrator.



The Albany County Sheriff's Office arrested Carlo Sorriento, 48, of Sharpe Avenue, Wynantskill, Tuesday, July 30, on charges of felony coercion, misdemeanor harassment and official misconduct. Police said Sorriento was allegedly harassing the former administrator with calls and texts, and if his demands weren't met, Sorriento would then release

damaging evidence that would ruin the Bethlehem man's reputation.

Officials have not released the name of the former jail administrator.

According to Sheriff Craig Apple, Sorriento wanted the former jail administrator to use his connections at the jail to get Sorriento preferential treatment. If he did not, Sorriento said he had "disparaging information," including photographs that could harm the man and his family.

Apple said the man shrugged-off the blackmail attempts at first but as they became more frequent, he notified authorities. Sorriento had allegedly wanted changes made to his contract, and preferential jobs that would allow him perks, like more overtime.

"This was coercion, and it is something we will not tolerate," Apple said of Sorriento.

Apple would not say what kind of information Sorriento was alleged to have, as the information was of a sensitive nature. The Sheriff's Office is now performing an internal investigation to see if inappropriate actions have taken place at the jail. However, Apple said the man that was blackmailed is a former employee, and is unsure what steps can be taken.

Sorriento was arraigned in Bethlehem Town Court and released on \$10,000 bail. He has also been suspended without pay.

"This was extremely foolish on his part," said Apple of Sorriento. "He jeopardized a 23-year career for nothing."

Other arrests

Bethlehem police arrested a homeless man for allegedly stealing a generator from the Shoprite in Slingerlands. Jason Najdek, 30, was arrested on July 19 on charges of burglary. Police said the generator was found behind a residence. Najdek was charged with burglary in the third degree, a felony, and petit larceny, a misdemeanor. Najdek was sent to the Albany County Jail.

Guilderland police arrested Sylvester M. Flora, 17, of 416 Hegeman St. in Schenectady, and charged him with forgery in the second degree, a felony, criminal impersonation in the second degree and petit larceny on Thursday, July 11. Police said the arrest and charges stemmed from a warrant issued by a town judge on June 24.

Bethlehem police arrested Michael J. Ferrell, 54, of Orchard Street in Delmar, on charges of felony DWI on Wednesday, July 31.

He was arrested by police after an employee of the Hess Express on New Scotland Road called to report a man in their store buying beer and unable to stand on his own. The employee said the man was hugging things as he made his way to the beer cooler. He then allegedly got in his car and left. Police followed Ferrell back to his home where they attempted to interview him. Officers said Ferrell allegedly had to be held up against a wall because he couldn't stand. Police said Ferrell failed all field sobriety tests and a breath test. He was arraigned and remanded to Albany County Jail on \$15,000 cash or bond.

Guilderland police arrested Gabriel M. Prusko, 22, of 4049 Ryan Place in Schenectady, and charges him with DWI, unlawful possession of marijuana, drinking alcohol in a motor vehicle on a highway and violating a conditional license at approximately 12:04 a.m., Friday, July 19. Police received a call about an

altercation on the upper level parking lot of Macy's at Crossgates Mall. Police observed Prusko to allegedly have his keys in his car's ignition and motor running. He allegedly told police he drove from Ruby Tuesdays to the movies. Police said he had slurred speech, impaired motor coordination and an odor of alcohol on his breath. Police said he had a BAC of 0.22 percent and allegedly had a "vaporizer" in his vehicle with marijuana residue in it.

Guilderland police arrested Dominique T. Church, 19, of 213 Swift Road, Voorheesville, and charged him with DWI, unlawful possession of alcohol and a traffic device violation on Church Road at approximately 9:39 p.m. on Friday, July 12. Gillibrand requests emerald ash borer funding

Senator calls for federal funding to eradicate invasive species

The fight against a particular pest affecting local trees could receive a boost of support from the federal government.

U.S. Sen. Kirsten Gillibrand on Tuesday, July 30, urged for additional federal funding for research, control and eradication efforts on the emerald ash borer, which is an invasive species that kills ash trees. Gillibrand wrote a letter to U.S. Secretary of Agriculture Tom Vilsack advocating for the “proper resources” to address the spread of the pest and protect the state’s forests. Her announcement hinged on the number of infested New York counties increasing to 15, with Delaware and Otsego counties recently confirmed.

Gillibrand, in her letter to Vilsack, said two more

counties joining the list of statewide infestations does not give her “confidence” the spread of emerald ash borers “will be subsiding any time soon.”

“Due to the pervasive nature of this issue, I am asking for funding to be made available to assist the research, control and eradication of this population of insects that threaten the ash tree in New York and throughout the United States,” Gillibrand said in her letter.

Locally, the Town of Bethlehem is the epicenter of Albany County’s infestation. The state Department of Environmental Conservation in October 2011 confirmed the initial discovery of the metallic green beetle near the CSX rail yard in Selkirk.

The Spotlight recently covered a presentation hosted by the Cornell Cooperative Extension of Albany County featuring Mark Whitmore, a forest

entomologist at the Department of Natural Resources at Cornell University, who discussed the ash borer in the county and state.

Whitmore urged immediate action from government officials and property owners to tackle the invasive species.

“Right now, they

should be looking at all public infrastructure and property and determining where the ash (trees) are. That way they know their liabilities,” Whitmore told The Spotlight.

Gillibrand stressed the economic impact of the beetle potentially destroying up to 7 percent of forests statewide. More

than 60,000 workers are employed in forest industries that generate around \$4.6 billion annually, according to Gillibrand. The state DEC estimates there

are around 900 million ash trees statewide.

Albany International Airport gets federal funds

Service road will be repaired with \$1M

Albany International Airport has been awarded more than \$1 million in federal funding in order to improve the facility’s main service road.

The funds were allocated through the U.S. Department of Transportation’s Federal Aviation Administration’s Airport Improvement Program. The award was announced on Thursday, Aug. 1, and was obtained through the help of Senators Charles E. Schumer and Kirsten Gillibrand, along with Congressman Paul Tonko.

“The airport’s perimeter roadway is essential to security of the airport and the efficient operation of airline and airport vehicles and our fleet of fueling tankers,” said Albany County Airport Authority CEO John O’Donnell in a statement. “This grant will help ensure that the roadway is maintained in a safe and operable condition.”

Albany Airport spokesman Doug Myers said airports across the country pay into the FAA’s Improvement Program through the taxes collected on airfares. Airports then place requests for the funds needed for certain projects, and awards are granted as the government sees fit.

“Albany International is a tremendous driver of our local economy, and by providing the Albany County Airport Authority the resources it needs to improve its operations, we can ensure that the facility will continue to grow and

service more business and leisure travelers each year,” said Congressman Paul D. Tonko, in a statement.

The money is being used to upgrade Albany International’s main service road. About 2 miles of road is set to be repaved.

Myers said the project is one of many upgrade projects the airport in undertaking. He believes it’s been about 10 years since the road was last paved. Other projects include enlarging one of the main parking lots, improving fencing around the airport’s property and building a new, heated building for sand storage.

Work is scheduled to begin in August, with the project expected to be finished in the fall.

milestones and classified listings.

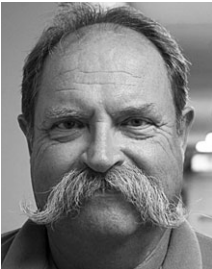

This article quotes out Board Chairman Dan Coffey saying, "There will be some aesthetic impact o the immediate neighbors, but the impact will not be of a significant nature."

If we collectively, the neighbors, had or even wanted to replace our homes a today's prices—we could be looking at more than that 1.2 million that was the estimate put on the solid indoor facility by Afrim. Time for reform at Bethlehem IDA

Editor, The Spotlight:

The announcement last week by Columbia Development that Breonics will not likely become a tenant at the Vista Technology Park is not surprising to those of us who have followed this story. More importantly, it points once again to problems within the Bethlehem IDA and why reform is needed.

First, BIDA has strayed in its mission. Tax concessions are supposed to incentivize businesses to locate in the town. The Breonics embarrassment shows that it is “pound foolish” to grant tax giveaways to developers for buildings that may or may not become occupied. The tactic employed with Columbia/Breonics is an inappropriate application of the IDA’s tax concession authority.

This and other actions by the BIDA foster the sense that BIDA is working on behalf of the developers and at great expense to the taxpayers. Millions of dollars of tax giveaways, such as those that went to Shop Rite and other retail establishments at the Vista location, have cost the town and the Bethlehem School District dearly. And we all know that this occurred at the same time that the town imposed a 14 percent property tax increase and the BCSD had to go above the tax cap to balance its budget.

Sadly, much of this has occurred effectively behind closed doors. To date the agency has steadfastly refused to webcast its proceedings

in a manner consistent with every other Town board. This culture of secrecy at the BIDA should not be allowed to prevail. Supervisor Clarkson recently urged that meetings be webcast. I believe that this move is long overdue and, although not yet certain, carries with it the promise that the business of tax concessions will no longer be carried on behind “closed doors,” or in the words of BIDA Chairman Venezia, “in executive session.”

The BIDA is an autonomous board, appointed by our elected representatives on the Town Board. It is the Town Board that has the power to more strictly regulate the agency in a way that would ensure accountability to the taxpayers of Bethlehem. Members should be appointed for specific limited terms instead of “for life” as is now the case. The supervisor and the board should move to ensure that the BIDA’s new Uniform Tax Exemption Policy is more broadly applied such that all existing businesses in Bethlehem are protected from encroachment by those who locate here with the benefit of tax giveaways.

The Breonics mess at 65 Vista Boulevard should serve as a clarion call to the voters and their representatives that change is needed. Now is the time for change that will make the process fairer and the BIDA more open and accountable to the residents of our Town.

in the preparation of the final master plan and final [environmental impact statement],” Karen Terbush, environmental analyst for State Parks, said. “Our job ... is to listen and understand. ... We are particularly interested in any comments on the accuracy of the information that is within the plan.”

Salim Chishti, state park planner, provided a brief summary of the plan before hearing comments. The plan states all proposed improvements “cost tens of millions of dollars to implement.”

The immediate priorities are expanding the Bird Conservation Area through both parks and creating a Natural Heritage Area that includes the Calcareous Cliff Community and land below the cliffs.

Capital infrastructure improvements are broken

into three priority levels and operational enhancements have two priority levels.

Priority 1 improvements include demolishing and repurposing material from the barn on Ketcham Road; adding four comfort stations throughout the park; designing and installing the first phase of the Tory Cave Trail; viewshed restoration of Hailes Cave, Horseshoe and Indian Ladder trails; installing a bat gate at Hailes Cave; and several trail improvements, along with creating a mountain biking skills course.

Operational enhancements being eyed first include opening all park gates during the day to increase access to areas; planning and implementing rock climbing proposals; seeking proposals for a commercial adventure course; and upgrading lighting and mechanical systems to increase efficiencies.

A flagship first priority improvement is constructing a new visitors

center at the park, which will feature meeting rooms and a warming hut for colder months.

“The visitors center will be that ... so that when people come to the park they have a place to orientate themselves, to ask questions, to look at some of the exhibits about the geological history of the land,” Chishti said.

Several people did express opposition to the expansion of the sandy area of Thompson’s Lake beach, along with expanding the lake’s campgrounds.

“I just wonder what kind impact this is going to have if we are dumping tens of thousands of pounds of sand onto a soft bottom lake,” said Michael Raily, of Albany, who owns a camp at the lake. “Is this going to sink down into the mud, which is the argument given for why we can’t put shale in?”

Thompson’s Lake Improvement Association President George Christian expressed the desire for the state to increase awareness

about the presence of zebra mussels in the lake. He said signs currently aren’t specific enough relating to invasive species in the lake and what precautions should be taken.

Bob Addis, president of the Northeastern Cave Conservancy, said his organization was pleased to see the plans focus on developing caves. The group manages around 12 caves, and he offered its help with the park plan.

“We would certainly encourage that a cage management plan be written before very far along in this process,” Addis said.

Jim MacNaughton, of Albany, said his son is “in love” with the park’s nature center and he was “excited” to see a mountain bike skills area being developed.

from the Bethlehem YMCA will teach campers how to do “chair yoga.”

Camp runs the first day from 9 a.m.-5 p.m., with lunch provided by the Village Deli. Camp begins later the next day at noon, so campers can take part in a cooking class where they will make their own dinners. Later that night, everyone will sit around a campfire eating s’mores and listening to tales told by local storyteller Joni Goldberg.

Becker said the Senior Services Department is hoping to create a unique experience for the town’s residents. She said the program may help those with feelings of isolation and she hopes to expand the camp overtime to a longer period of time with overnight options.

“Some people might not feel comfortable staying the night and may want to sleep in their own beds. We understand,” she said.

The property for

the Brauer Educational Center was gifted to SUNY Cortland by Everton and Elsie Brauer in 1974. Their son, Robert, was a geology major at the school, but was fatally injured after his junior year during a zinc mining accident. The Educational Center now hosts students for 10 weeks each year for field experiment studies. The facility boasts bunk rooms, classrooms, a dining area and bathrooms with showers.

Becker said the Brauer Center is the perfect place to hold their new program because there is room to grow. She called the facility “beautiful.”

The camp will run from 9 a.m. to 5 p.m. on Sept. 7 and noon to dusk on Sept. 8. The cost is \$25 per person and is open to Bethlehem residents 60 and older. Those who sign up must also be living independently as some activities may be more strenuous than others.

been notified the town is using the system more than originally planned. If the IDA were to agree to webcast meeting, the company overseeing the system may ask for a \$3,000 fee in order to provide more storage space.

IDA Assistant Executive Director Tom Connolly said that’s why the agency has its own website and all information is posted and disclosed appropriately, according to state law.

The IDA’s Governance Committee plans to meet in August to discuss the issue more thoroughly. Committee Chairman Sam NeJame said members are researching to see how other area IDAs with webcasting capability use the technology before moving forward.

Clarkson said he believes the Bethlehem IDA is a model agency, and it would be to their credit to put their good work out there for all to see.

“That said, if we based

our decision on what other town boards did, I don’t know if we would be disclosing as much as we are now,” said Clarkson. “I don’t know of another town board that posts all of its agenda online well in advance of the meeting, webcasts the meeting, and then keeps it online forever, as far as I know.”

Earlier this year, IDA members decided to place more focus on attracting residents to public hearings in order to better gauge public perception on future projects. Those public hearings have been webcast, and the time has been changed to Wednesday nights prior to Town Board meetings instead of at the early morning IDA board meetings.

Because the times have been changed for IDA public hearings, some members wanted to know if the times for all meetings would need to be changed if they opted to use the webcast system.

Clarkson said he did not believe that would be necessary since no one is ever scheduled to use the town’s main meeting room

so early in the morning.

Connolly said he felt the IDA’s website is much easier to use than the town’s website, and he doesn’t know if the town’s website is compatible with the agency’s needs.

“We need to feel comfortable with its capabilities,” he said.

IDA Chairman Frank Venezia said since the town is working to build its new website, it might be more helpful to hold off webcasting until the new site goes online. He said

IDA members would like to sit down with the town’s Management of Information Services director to discuss the capabilities of the new site.

Members also wanted to know if the IDA could keep its own website, or if it would be expected to then be housed on the town’s website. Clarkson said it might make more sense to be hosted by the town.

“I wouldn’t expect the move to be difficult, even given the amount of information you have,” said Clarkson.

Town of Bethlehem Dissolution Plan for Three Town Ambulance Districts: Bethlehem, Delmar-Elsmere-Slingerlands, and North Bethlehem Although entitled a "Dissolution Plan," this is really a unification plan. It is another step in the process that began last fall, with the issuance of a Town wide "Certificate of Need" for EMS services, and continued with the merger of the Town's two major ambulance squads. Technically speaking, however, it is dissolution of three town ambulance districts – geographic partitions of the Town which are no longer necessary. The three districts are: the Bethlehem Ambulance District, the Delmar-Elsmere-Slingerlands Ambulance District, and the Bethlehem Ambulance District Extension District. This Dissolution Plan describes the reasons for, and effect of, dissolving these three districts. The ambulance services in these districts were previously provided under the certifications of three separate entities: the Bethlehem Volunteer Ambulance Service (generally serving the Glenmont and Selkirk areas of Town within the boundaries of the Selkirk Fire District); the Delmar-Elsmere-Slingerlands Volunteer Ambulance Service (serving the areas covered by those three Fire Districts); and, the Western Turnpike Rescue Squad (serving North Bethlehem – or the area of Town within the borders of the Elmwood Fire District). Since January 2013 the Town of Bethlehem has been operating under a town-wide "Certificate of Need" from the NYS Department of Health, which

means the Town is fully empowered to provide ambulance service anywhere within its borders, and this service is sanctioned with the Town, rather than relying on the certification of individual ambulance squads. The resolution establishing the town-wide ambulance service passed on November 14, 2012 with the goals of ensuring improved billing, full operational integration of town-subsidized agencies to ensure maximum efficiency, and uniform tax impact. In addition, since the beginning of the year the Delmar Volunteer Ambulance Service and the Bethlehem Volunteer Ambulance Service have merged, operating as Delmar-Bethlehem EMS, which remains a combination of volunteer and paid members from both units under the direction of a mixed cadre of officers and board members from the two former EMS responder groups. Since its inception in January 2013, the new consolidated EMS unit has answered 1,066 calls through April. This averages 266 calls per month or 8.8 calls per day. Of these calls; 42.9% or 457 were answered by the volunteers within the ranks. The volunteer members of the combined unit committed 5,406 hours to answering emergency calls in addition to the many hours of training, leadership and administrative duty hours. A full year extension of these statistics would mean over 3,000 emergency calls and over 16,000 volunteer response or duty hours. The transition from two independent units, to a single coordinated and functioning response group appears to be seamless. The positive proactive consolidation of assets, personnel and the management, while certainly not without any growing pains, is a tribute to the leadership and management ability of both former units and a testament to the ability of the leadership team. Delmar-Bethlehem EMS covers the vast majority of Town (94% by assessed value). However, in North Bethlehem, the Western Turnpike Rescue Squad – a for-profit service – has been providing service for some time, as well as through the rest of the Elmwood Park Fire District (covering all of the Town of Guilderland and parts of other towns). This difference in providers, as in the other areas of Town, grew out of the history of the service being provided through individual fire districts. Today, these distinctions and boundaries are no longer necessary, and as recommended by the District Board of Ambulance Commissioners, the service, tax effort, and other charges should be uniform. Service could still be provided by different providers, if the Town Board so chooses, because the goal is to provide the highest quality of service, with taxpayers and service recipients treated equally throughout the Town. Previously substantial differences have existed. In North Bethlehem, for example, town residents have been responsible for their own insurance co-pays, which are substantial for ambulance service (ranging from \$100-\$200). This practice is contrary to what residents in the rest of Bethlehem experience, where the Town covers insurance co-pays or deductibles for Town residents. Additionally, Western Turnpike does not bill third party insurers for Advanced Life Support (ALS) services when they transport patients receiving them (which could reduce our costs), and does not disclose the substantial amount of insurance payments received from Bethlehem Town residents. While the Town of Bethlehem has long contracted with Western Turnpike for ambulance service, and this difference was accepted because it was a different model, we have now taken full responsibility for this EMS service through the Town-wide Certificate of

Need, and are proposing dissolution of the separate ambulance districts and tax rates. Therefore, we are offering a resolution tonight to cover the co-pays for Bethlehem town residents who are transported by Western Turnpike and to cease collection efforts for uninsured Town residents receiving emergency services. This will ensure equal treatment of all Town residents receiving EMS and ambulance services. The current town-wide tax levy for EMS services is \$1.2 million, including \$526,000 for Advanced Life Support Services provided by County Paramedics and \$709,000 for the Ambulance Districts. For an average home (\$250,000 assessment) the town property tax covering these services is \$86.93, with higher charges in the Bethlehem Ambulance District generally serving the Glenmont, Selkirk and South Bethlehem areas (see attached table). Moving to a uniform tax rate across Town would reduce taxes for ambulance service in these areas by \$17.57 on an average home, based on 2013 tax rates. The precise savings will depend on 2014 Budget Actions, but those who live in the Glenmont, Selkirk and South Bethlehem areas will have reduced taxes for EMS – specifically those who live within the Bethlehem Ambulance District (the same area of Town served by the Selkirk Fire District). However, all of these figures include a \$275,000 "Dispatch Charge" tacked onto the Ambulance Districts tax levy by the Town, which then flows into the General Fund. This charge was added to the Ambulance District levy in 2008 to address Town fiscal needs, and is inserted into tax bills without identification. Without this charge, the town-wide tax levy for EMS services would be \$960,000, and the tax on an average home (\$250,000 assessment) would be lower by \$19.35 – accordingly, this charge will be reviewed for elimination in the 2014 Town budget. We are currently working with Albany County, Delmar-Bethlehem EMS, and the Western Turnpike Rescue Squad on their requested budgets for 2014. Because these amounts are unknown, we cannot yet estimate the tax rates in 2014. Improved billing practices, economies of scale developing over time from the merged EMS operation, and tighter control of County-provided Advanced Life Support are expected to yield substantial savings over the next two years. The Town will also explore restructured relationships with Albany County and Western Turnpike Rescue Squad. According to the requirements of Article 17-A of the General Municipal Law, Dissolution Plans must contain the following 14 elements: Entities To Be Dissolved: The Bethlehem Ambulance District. The Delmar Elsmere Slingerlands Ambulance District. The Bethlehem Ambulance District Extension District. These three discrete ambulance districts are collectively referred to hereinafter as the "Ambulance Districts," and the Town of Bethlehem as the "Town." Territorial Boundaries: The aggregate territorial boundaries of the three ambulance districts are coterminous with the boundaries of the Town of Bethlehem and the area served by the Ambulance Districts consists of the entire area of the Town. The territorial boundaries of the individual ambulance districts are more particularly described as follows: The Bethlehem Ambulance District is coterminous with the area of the Town contained within the Selkirk Fire District. The Delmar-Elsmere-Slingerlands Ambulance District is coterminous with the area of Town contained within the Delmar Fire District, the Elsmere Fire Dis-

guys believe they can win which is a good place to start.”

“Obviously, it’s a step up all around,” added quarterback Will Fiacchi, who is back to run the offense. “You’re going to see bigger and faster players on both sides of the ball.”

The Great Danes had been one of the best teams in the Northeast Conference, as they won or shared six league titles from 2002 to 2012. But now, they must find a way to carry on their winning tradition in a league that has produced two national champions and three finalists since 2006.

“There are three ways to win in college football,” said Ford, who owns a 255-159 career record. “You can out-recruit your opponents. That’s what we did in the NEC, but we’re not going to out-recruit most teams in the CAA. The second way to win is to out-coach your opponent.

And the third thing you can do is out-develop your players. Those are things we’ve got to do.”

Ford said the biggest disadvantage the Great Danes face is a lack of depth on the roster.

“Everybody in the NEC had 35 to 38 scholarships, but everybody in the CAA has 63 scholarships,” said Ford. “So, we’re at a disadvantage because we don’t have nearly as many scholarship players as the rest of the CAA has. If we’re going to be competitive, we’re going to have to stay as healthy as we can.”

“A lot of these CAA teams go two or three deep at every position,” added Fiacchi.

Ford has been recruiting for an eventual upgrade in the Great Danes’ level of competition while not forgetting to look for local talent. This year’s UAlbany roster includes 13 former Section II players including Guilderland quarterback Ryan Smith, Bethlehem kicker Jonathan Martin and Shaker running back Ryan Griffin.

“I’m excited to be part of a new (football) family and a new energy,” said Griffin.

Some of that new energy comes from the new Bob Ford Field, the university’s 8,500-seat stadium built next to SEFCU Arena. The stadium includes amenities not found at the old University Field including a synthetic turf field, a concourse, corporate boxes and a giant video scoreboard.

“I think it’s a piece of the puzzle we need at the university,” said Ford.

The Great Danes’ first CAA contest and their first home game in their new stadium is Saturday, Sept. 14 against the University of Rhode Island. And win or lose, the players are determined to give the Rams and all the other CAA teams a run for their money.

“We expect to be competitive and be tough on the field, and make teams respect us,” said Griffin.

Albany carried the momentum back to Amsterdam for Sunday’s Game 3. Tyler Orris drove in Marks with an RBI single in the top of the first inning to give the Dutchmen a 1-0 lead.

Smith and Ed Charlton each drove in runs in the bottom of the first to put Amsterdam ahead 2-1, and Jordan Ebert added an RBI single in the second inning to extend the lead to two runs. But, Matt Dacey belted a three-run homer in the top of the third inning to give Albany

a 4-3 advantage.

Jordan Sansone’s two-run homer in the bottom of the third inning moved the Mohawks ahead again, and they added four runs in the seventh inning to seal the Dutchmen’s fate.

Despite falling short of reaching the PGCBL championship series, Davey said Albany’s first playoff appearance will help the team in recruiting for next year.

“We’ve gotten better every year, and a playoff push can only help us,” said Davey.

Extra inning madness

Marks' 10th-inning single gives Dutchmen first home playoff win

The Albany Dutchmen's season ended Sunday, but not before they made some franchise history.

The Dutchmen made the Perfect Game Collegiate Baseball League playoffs for the first time and gave defending champion Amsterdam everything it could handle before losing to the Mohawks 9-4 in Sunday's deciding Game 3 of the East Division finals at Shuttleworth Park.

Albany (28-24) survived three elimination games prior to Sunday's loss, each time winning in extra innings. The Dutchmen defeated Glens Falls 6-5 in 16 innings last Wednesday to earn the third and final playoff berth in the East Division. Then, they edged Mohawk Valley 4-3 in 11 innings during Thursday's play-in game to reach the division finals.

Amsterdam took the first game of the best-of-three series 4-2 before Albany posted a 9-8 10-inning victory over the Mohawks Saturday at Bellizzi Field to force a third game.

"This week has been wild," said Albany coach Nick Davey. "This team said they love free baseball."

Saturday's game between

Albany and Amsterdam featured five lead changes before Anthony Marks drove in Justin Brock with the winning run in the bottom of the 10th inning.

"I know as soon as we go into extra innings, the guys are up for it," said Marks.

Amsterdam took a 2-0 lead on Dylan Smith's two-run homer to center field in the top of the first inning, but Albany's Luke Nethaway responded with a three-run blast to left-center field in the bottom of the second to put the Dutchmen ahead 3-2.

"This (stadium) is a graveyard," said Nethaway, a

Fonda-Fultonville graduate who plays college ball for The College of Saint Rose. "To hit it out is pretty cool."

Albany tacked on a run in the bottom of the third inning before Amsterdam used four consecutive hits in the top of the fourth to take a 5-4 lead. An RBI infield single by Marks and a fielder's choice by Bradley Noland in the bottom of the fourth put the Dutchmen ahead 6-5.

The seesaw battle continued in the fifth inning. A bases-loaded walk and a sacrifice fly by Smith moved Amsterdam back into the

lead at 7-6, but it was short lived as Brock — a recent addition from Franklin Pierce College — drove in Chris Suseck with a two-out single to tie the score at 7-7.

Smith, who finished with three hits and four RBI, put the Mohawks ahead 8-7 with an RBI double in the top of the seventh inning. Nethaway came through once more for the Dutchmen with a one-out RBI double in the bottom of the eighth inning to knot the score at 8-8.

Albany reliever Thomas Belcher and Amsterdam reliever Chris Kalica each got through

A lot more than thrill rides and good eats: Three-county event marks 120th year, continues focus on agricultural history

Everyone has a favorite thing at the fair, whether it is stomach-churning carnival rides to the bounty of fried food, but at one local fairground, you could also take a step back in history.

The Altamont Fair is opening its gates and welcoming patrons for its 120th year on Tuesday, Aug. 13, featuring many of the popular attractions people look forward to every year, with some new ones mixed into the three-county celebration as well. Once again, tickets are all-inclusive at \$15 from Tuesday to Thursday, and an additional two dollars on the weekend. You'll still want to bring some cash for the fair's classic fare. The grounds open at 10 a.m. daily, with exhibits following at 11 a.m. and the midway at noon.

Pat Canaday, an Altamont Fair board member, said the fair strives to be family-friendly and offer something everyone will enjoy. She said sticking to the fair's roots is also important.

"Our goal is to preserve a lot of what people remember about the county fair when it is was a simpler time and this was

the biggest community gathering of the year.”

The nonprofit, Albany, Schenectady, Greene County Agricultural and Historical Societies, Inc., hosts the fair annually, with the event largely supported through admissions, volunteer efforts and sponsors.

New to the fair is the “Tim Dyson FMX Show”, which features freestyle motocross stunts, with performances Tuesday through Thursday. Another new attraction is the Wildlife Sports and Educational Museum, featuring exhibits showcasing the “centuries-old sporting traditions of hunting, fishing and all sports afield memorabilia.”

There will be plenty of rides for the more daring fairgoers. Reithoffer Shows, dubbed the largest traveling midway in the word, is again hosting unlimited rides. The famous “Sky Flyer” will also be returning to lift people 120 feet into the air before swinging them sideways.

There is a calmer side to the fair if you need a rest from zooming through the air or chowing down a bloomin’ onion.

“Our hope is people will certainly enjoy the rides if they wish to, but our hope is people will go through the barns,” Canaday said. “It just gives you a chance to experience something else you wouldn’t see in your backyard.”

There are several museums at the fair, including the Antique

Farm Machinery, Farm House, Carriage, School House, 1890’s Village, Circus, and Auto: Past and Present. This year the Auto Museum is hosting Satan Cycles, a group that will build a motorcycle from start to finish during the fair.

“A lot of what we do is related to both history and agriculture,” Canaday said. “We have a huge museum component here at the fairgrounds, and a lot of people have dedicated their volunteers hours to keep it going and share them.”

Providing space for local 4-H exhibits and competitions is an important aspect to the fair. The event provides some people with their first look at farm animals.

“Part of what we do is to help people understand other animals,” Canaday said.

There will be some exotic animals displayed, including a Giraffe Menagerie petting zoo and the “Two by Two Zoo” that lets people get up close to animals. The Utopia Percherons will be exhibiting their six-horse hitch of prize winning black geldings.

“If we don’t do it, people won’t see it,” Canaday said. “It is a real underlying drive for us to have people understand what they are seeing ... and at least they are exposed to it.”

The Disc-Connected K9’s World Championship Frisbee dogs will be jumping and the porky Hollywood racing pigs are returning by popular demand.

Plenty of contests that anyone can enter will be held, including photography, painting, drawing, floral arrangements, and fruits and vegetables. Some rather

delicious competitions include Hershey’s Anything Chocolate Challenge and Local Orchards Baked Goods contests. The Home Front Café’s Father Larche’s egg-flipping contest will allow people to win a free breakfast at the patriotic-themed Altamont restaurant.

The annual Miss Altamont Fair pageant will also crown winners in various age groups for girls. Pageant contests will be judged on “poise and public speaking.” Winners will receive a crown and be responsible to positively represent the fair throughout the year.

Tying the fair in with the

community is what has kept it going strong over several years.

“We just draw on more and more on the community and try to involve more and more of the community to keep people in touch with each other on some of the earlier lives,” Canaday said.

Several bands will be playing throughout the fair, everything from county and rock to big band and oldies. During the final night of the fair on Sunday, Aug. 18, there will be a fireworks show presented by Quick Response.

There are two special admission days starting with

Senior Day on Wednesday, Aug. 14, and Armed Services Day the following day. On those days, respectively, those 65 and older and active and retired members of the military will receive free admission until 4 p.m. These special free tickets do not included rides. Chauffeured golf carts will be available for seniors and veterans to assist travel across the fairgrounds, courtesy of St. Peter’s Health Care Services.

The market is one of the oldest and largest in the area. It began in 1933 and is now based at 381 Broadway in Menands.

Al Lansing, chairman of the Capital District Farmers Market Committee, said the market is not only a way for residents to get fresh produce that has been picked within hours, but it also allows farmers to interact with the costumers on a more personal level. He said those exchanges often dictate the type of produce he grows.

“I’ve diversified my offerings because people started to ask for new things,” he said. “Kale has become popular, and we now grow that. We also have leeks and more collards. If they’ll buy it, we’ll raise it.”

Lansing said the market is all about supporting local farmers and the local economy. It also helps people to see where their produce comes from and be on a more personal level with growers.

At Family Day, representatives from Cornell Cooperative Extension will be on hand to give instructions about canning and preserving produce. They will also demonstrate how to select fresh produce, which can be a good reminder or lesson for those of all ages.

“This can be both a bonding experience and learning experience,” said Lansing.

The event also acts as a fundraiser and adoption site for the Mohawk & Hudson River Humane Society.

The Society’s Marketing and Development Director Nancy Laribee said some people don’t like to visit the organization’s animal shelter because they

think it will be sad or depressing. The exposure allows potential adopters to see the animals outside, having fun, which makes the experience more positive.

“It’s a different environment, which is helpful” said Laribee. “Many get adopted right then.”

The day will include hayrides and tractor rides for the kids, along with live entertainment. There will also be raffles and prize giveaways, with the proceeds going to benefit

the Mohawk & Hudson River Humane Society.

“It’s a chance for residents to gather at a common focal point and intermingle with one another,” said Lansing. “They can see what’s going on with the neighbors and purchase some local goods.”

The fifth annual Family Day at the Capital District Farmers Market in Menands will be held on Saturday, Aug. 10 from 9 a.m. to noon. Admission and parking are free to all attendees.

A rodeo way of life

On summer weekends, the Double M in Ballston Spa feels a lot like the Wild West

July and August are not just about horses in Saratoga County. Step through the gates at the Double M Rodeo in Ballston Spa on any Friday or Saturday evening in July and August and you will feel like you stepped into the Wild West. Complete with angry bulls and rodeo clowns, the Double M is a piece of the West nestled in the woods of Ballston Spa.

Cindy Martin, who owns the rodeo with her husband, said it's common to see 1,200 people each weekend sitting in the stands hollering for their favorite competitors.

"It's good, clean fun, family oriented and a relaxed atmosphere," she said. "It's like a park out back so people come and

hang out, little kids are running around and parents are watching."

The competitors come from as far away as Oklahoma to compete at the Double M.

The rodeo also has its share of local competitors.

"We have doctors and lawyers, professionals that work for New York state, corporate owners – all kinds of professionals," Martin said. "This is their extracurricular activity. In fact my son's pediatrician is a barrel racer."

The rodeo is host to a number of events, including barrel racing, bull riding, bareback riding and steer roping. The competitors are not paid performers. They compete for prize money.

Martin said the events can get very competitive – even between family members.

"Right now I have a grandfather and his granddaughter that rope

together and a grandmother and granddaughter competing against each other in barrel racing," she said. "At the end of the night, you could go home and have two sisters battling it out as to who is going to win money because they compete in the same event."

Martin said the bull riding event is by far a favorite with the crowd. Often you will see onlookers in suspense as the rider is jerked around while holding on for what he hopes to be eight seconds.

For the Martin Family, rodeo is just a way of life.

Martin's mother-in-law and father-in-law, Kathy and Ron Martin, brought the show to the Double M in 1987 after organizing rodeos in the 1970s at Lake Luzerne's Painted Pony Ranch.

Martin and her husband, Wayne, took over the rodeo and

accompanying western store 18 years ago. The rodeo tradition is continuing through the generations with Martin's two children now a part of the show.

"We all have our own part in it. My husband is the pick-up man during the rodeo," Martin said. "That's when two bucking horses come through, he is the guy who comes in and saves the guy on the back of the bucking horse."

Martin's 14-year-old daughter, Jessica, carries the American flag horseback during the opening of the show and competes in the youth barrel racing competitions. Clayton, Martin's 8-year-old son, does a trick act with whips.

"It's a big 6-foot bull whip that he swings over his head and snaps it, which is hard to do for most," she said.

Martin said rodeo is basically a part of their family heritage – it's what they love and what they do.

"We've been doing it

for so long that it's old nature. For us, we don't think much about it. It's all in our heads and we just do it," she said.

The Double M is located at 678 Route 67 in Ballston Spa. Catch a rodeo any Friday or Saturday evening through Aug. 30, at 8 p.m. General Admission is \$15 for adults and \$5 for kids ages 5-12. Recent Tony award winner honors his roots

**Early inspiration led
Altamont native
toward theater fame**

Leon Rothenberg wanted to share his Tony award accolades with those who helped shaped him as an artist early on, so he come back home to honor his roots and mentors.

State Sen. Cecilia Tkaczyk, Albany County Executive Dan McCoy and Altamont Mayor James Gaughan honored Rothenberg, an Altamont native and Guilderland High School grad, on Tuesday, July 30, before the village's summer concert performance at Orsini Park. Tkaczyk and McCoy presented Rothenberg with proclamations honoring his Tony award for Best Sound Design of a Play for "The Nance." The award was also proudly displayed at the ceremony.

At the ceremony

Rothenberg pointed to how his interactions with teachers and faculty at Guilderland High School helped him achieve such an honor.

"I feel like it is incumbent upon me ... to talk about how I got where I got to and draw a little bit of light on what I gained from this area," Rothenberg said. "When I was in school ... I had the pleasure of working with, learning from and collaborating with some pretty special teachers at Guilderland. Each of them contributed in fantastic ways to my own development."

McCoy also stressed how much someone's future is shaped by the school they attend, community they're raised in and the encouragement from parents.

"Leon, for you putting Altamont on the stage and putting Albany County on the stage, it is just incredible," McCoy said. "You look at a small

journey, and it does start out at home."

McCoy said Rothenberg showed that if "you stay determined and focused," while enjoying what you do, a person is able to accomplish great things.

Fred Heitkamp, retired

teacher and former theater director, said Rothenberg first was drawn to theater through sound mixing, so winning a Tony for sound design brought Rothenberg full-circle.

"He saw some things about it that he thought

would be interesting if somebody could find a solution to them, and it is something that he has continued to work doing," Heitkamp said.

Heitkamp has kept in touch with Rothenberg since he graduated from high school, along with other former students.

"I actually contacted him the night that he got the Tony and sent him a congratulatory message," he said.

Heitkamp estimated he taught around 8,000 students over his 30 years in education, and there were some, like Rothenberg, who stood out.

"He was very cooperative ... whatever he was given to do, he did, and he did it very willing," Heitkamp said. "He was the kind of student that you kind of assume he is going to be successful."

Jim Corigliano, former music theory teacher at Guilderland High School, also said he saw something special in Rothenberg.

"Leon was an unusual student in that not only was he gifted and intelligent but somewhat precocious. He had lots of confidence and he wasn't afraid to take a chance," Corigliano said. "If you are going to compose music you can't be afraid to take chance, or you will never write anything."

Corigliano said many students that tried to write music often would never get started because they were afraid of it not sounding good. Corigliano said Rothenberg has a "flare" for writing music, and he always had a passion for theater.

"Leon had a good musical ear, a great imagination, and he had listened over the years, so he had a good musical vocabulary to build on of classical composers mostly," he said. "Leon wanted to write contemporary music from the get-go, and I sort of fought with him that music is a craft and you got to

learn your craft. ... I'm not so sure he liked that, but he understood that musical composition was a craft. By the time he headed off to college he was prepared to study that craft."

Rothenberg studied music composition in college, and he said Corigliano was the person that led him down that path.

"(Corigliano) really encouraged me to figure out how to write music," Rothenberg said. "It was through his tutelage that got me writing music and then got me applying and gave me a portfolio so that I had some to apply."

Rothenberg went on to earn a bachelor's degree in composition from Oberlin Conservatory and then earned a bachelor's in computer science from Oberlin College. He later earned a master's of fine arts from California Institute of the Arts.

He has served on the Theater faculty at CalArts and also spent the fall of 2009 teaching at Bennington College in Vermont.

Some of his recent credits include plays and musicals performed at the Arena Stage, Seattle Repertory Theater, New York Stage and Film, La Jolla Playhouse, New York City Center, The Theater at Madison Square Garden and on Broadway. He also designed sound for Cirque du Soleil's Kooza and Cirque's winter holiday show, "Wintuk," performed in NYC.

Rothenberg said his advice to anyone interested in entering the entertainment industry or a creative field isn't too different from the standard guidance someone might hear: "Do what you want to do and go at it full blast."

He said pursuing your dream "won't ever be easy," but you have to go after what you love. A little bit of luck doesn't hurt, too, he said.
