

Altamont floats new sewer charges

Village to hold public hearing over addition of \$90 annual fee

Altamont residents could see their semi-annual sewer bill increase by \$45, but they will get to have a say before the proposed fee hits their wallets.

The Village Board of Trustees on Wednesday, Sept. 4, approved holding a public hearing on a proposed change to the village code regarding sewer service changes. The new \$90 user fee would be split between each semi-annual bill. The required hearing will be held Tuesday, Sept. 17, at 7 p.m. during a special meeting of the board at Village Hall. The board would be able to vote on

the amendment following the hearing if members wish.

The sewer rate would remain unchanged. The April bill is calculated as 1.8 times the April water bill and the October sewer

charge equals 1.5 times the October water bill. "For the past two-anda-half years we have been reporting on this project at every meeting," Mayor James Gaughan said. "We have reported about the estimated fee structure that we

had calculated as we went along. We forewarned everyone that it is coming."

Allyson Phillips, legal counsel for the village, said the amended law would change how the sewer

service charge is calculated. Phillips said the only thing to change would be the additional \$45 semi-annual charge.

The sewer service charge is being implemented to cover the \$3.5 million wastewater treatment plant improvement project. The state Department of Environmental Conservation mandated improvements following a 2010 order of consent citing the village for overflow of untreated sewage during weather-related, high water events.

House calls for the house trained

Guilderland native starts mobile veterinary service

Many pet owners know the feeling of dread that accompanies getting ready to take an uncooperative animal friend to the veterinarian.

Capital District Mobile Veterinary Services is looking to take some of that stress out of the experience, though, by bringing the vet's office to the pet. Owner Sarah Nolan and veterinary assistant Anne Giagni started making house calls about three months ago, and according to Nolan, things have taken off faster than she could have imagined.

Nolan, a Saratoga Springs native, had been working at an Albany practice for eight years and said people would "constantly" call and ask for a veterinarian to come to their home to see their pet. Now, that's exactly what she does offering a variety of services, such as annual wellness exams and vaccinations, behavior consultations and blood work.

"A lot of big cities have that service and I thought it would be a great way to own my own business without all that overhead and a lot more personal experience going into people's homes," Nolan said. "The biggest reason I did it is the stress for animals. By going into their homes they react so differently."

Giagni, a Guilderland native and Latham resident who has been in the veterinary field for 17 years, agreed easing stress was the biggest difference from operating out of a brick-and-mortar location.

"Everybody is a lot more calmer in the home and the pet isn't looking at us as the bad guy," Giagni said.

Being outside of an office during work also has its benefits.

"I love not being in one building all day,' Giagni said. "You get a better client relationship going into the home and you don't have that rushed feeling about the appointments."

The only real limitations of her mobileonly business, Nolan said, are not offering X-rays or surgeries, but she

will recommend a local veterinarian to perform such procedures if needed.

There is a \$40 house call fee for appointments within most suburban Albany County communities, which goes up for more distant appointments, but Nolan said she in turn tries to make all of her prices lower than at traditional animal hospitals. All new clients receive \$20 off their first visit, she said.

For some, the service is about convenience, but for others it's the only way they can have their pet see a veterinarian. Nolan said she sees "a lot of elderly clients" who can't drive or have trouble transporting their pets.

"It is really nice to go to these people's homes who might not otherwise get care because they can't get them out of the house," Giagni said. "There are quite a few animals we have seen where the owners were not able to get out of the home."

There are also two endof-life services provided hospice care for terminally ill pets and at-home euthanasia. Nolan said clients have found at-home euthanasia to be a more



peaceful experience for their pet and themselves.

Both women said they knew very early in life that they wanted to be in the veterinary field.

"I wanted to be a veterinarian since I was very, very young – around 5 or 6 years old," Nolan

said.

Her parents owned a dairy farm in Fort Edwards when she was growing up, which first led her towards want to be a large animal vet. Around halfway through her studies she switched over to small animals.

"I never wavered from it," she said. "I couldn't imagine doing anything else; it was that or nothing."

Guilderland launching building study

School district's study said not to be 'all about closing schools'

The Guilderland Central School District is turning to physical space in its quest to control costs.

The district held a community meeting Tuesday, Sept. 3, at the high school to have Paul Seversky, a consultant with the planning service at Madison-Oneida BOCES, discuss the goals and methodology of a district-wide building capacity study he will soon begin.

"This will be fantastic tool for us here in Guilderland as we work to make really good decisions on behalf of our kids," Superintendent Marie Wiles said.

Seversky will analyze how the district uses building space, scheduling patterns, current enrollment and future enrollment trends. After gathering this data and performing observations of facilities, he will present several options for the district to use existing space with certain programming models.

Over the next several months, Seversky will review if there are more cost-effective ways or patterns to organize programming from kindergarten to 12th grade over the next three years.

"I would suggested this an example of good, diligent planning by the board and your superintendent," Seversky said. "Given this new normal that we are all in ... there is a whole new normal to financials and more importantly, to demographics of our country."

He said people are not having kids at the same rate that prior generations have, which has resulted in school districts seeing declining enrollment.

"Previously, successful ways in decisions on how to serve young people may or may not be viable solutions in this new normal," he said.

According to Seversky, the Board of Education and superintendent do not have any preconceived notions on what the results of the study might yield. As an outsider, he said he does not want to know what the "politics" are of the situation and what any group of stakeholders may want.

"The job is to hold up a mirror to a lot of real data and real understandable data that exists," he said. "Looking at that data ... organizing it so that the board and the community can utilize that data as a tool to answer the study question."

The baseline data will include enrollment projections, pupil capacity of the schools, local class size goals, local culture of deploying staff, programming elements, visiting each school through a tour hosted by the principal and an interview session with the district's leadership team. He also plans to have



elements of the study, such as enrollment projections, posted online before the entire study is completed. He said all of the final options presented would be "doable" options for the district.

"The heart of the study is using existing resources to best serve young people," he said.

The various options identified for the district will each have its unique challenges and opportunities. Sometimes. he said opportunities would become challenges and vice-versa.

"There is not going to be one that is all roses,' he said.

Once the study is completed and results are published online, a community focus group would likely be established, to include around 30 to 40 community members to represent a diverse range of stakeholders. The focus group would ensure the list of opportunities and challenges for each scenario is complete.

"This is a community taxpayer decision,' Seversky said. "My job is to listen and record ideas and perceptions of the various scenarios that are in the study."

He said the district isn't in dire financial stress, which allows time for the community to weigh the best programming option.

"Your district is not in crisis," he said. "There are districts I work with that are in crisis and they are literally out of money."

He added the study "isn't all about closing schools," but that could be presented in options.

Board of Education member Colleen O'Connell said the study sounds more long-term than the "next three years," with a longer focus of the next five to 10 years.

Seversky said enrollment data for secondary students would be forecasted for the next 10 years, which could provide an indication of what the future might bring. He said the study would also name possible variables that could affect enrollment.

"We will use the best data we know at the given time," he said.

Wiles said the district is also discussing a capital improvement project. There are two separate recommendations totaling more than \$18.2 million.

The building capacity study wouldn't be complete

consider a capital project, but Wiles said some improvements would need to be made regardless of the study's conclusions.

"We need to have a good understanding of the relationship between our needs and our building capacity for student programs," Wiles said. 'We also have basic housekeeping kinds of needs with the seven before voters are asked to buildings that comprise

our school district. That work truly must be done no matter what."

Wiles said the outcome of the study would be considered before the district borrows any money for the improvements, so voters would be approving a "threshold" for the district to borrow.

# Alleged bank robber appears in Bethlehem court

**Victor Shear pleads** not guilty after being apprehended in **South Carolina**

Alleged Trustco Bank robber Victor Shear pleaded not guilty to felony charges in Bethlehem Town Court on Tuesday, Sept. 3.

Shear was arrested by police in South Carolina late last month and appeared before Justice Ryan Donovan after being flown back to the Capital District. His case was then transferred to Albany County Court, where he was scheduled to appear on Wednesday. He was charged with robbery in the first degree and grand larcenv in the fourth degree, and remanded to Albany County jail without bail.

The Canajoharie resident was captured by the North Myrtle Beach Police Department nearly a week after the robbery occurred at the Trustco Bank on New Scotland Road in Slingerlands. Shear, 45, is accused of entering the bank, displaying a handgun and

demanding cash.

#### **Ravena man** arrested on drug charges

A Ravena man has been arrested on drug possession charges investigation and a sealed indictment presented by the Albany County Grand Jury.

# Voorheesville looking at EMS options

#### Tough contract negotiations spur a review, bring allegations to light

Voorheesville officials are investigating what, if any, emergency medical service options it might have, as contract contentions are becoming the norm with its historic provider.

Mayor Robert Conway said the village has had preliminary discussions with the Voorheesville Volunteer Fire Department about the organization providing ambulance service for the village. The possibility was brought up at the Board of Trustees' Aug. 27 meeting. The matter will likely be discussed at each of the board's meetings for several months.

"We are not moving towards the firehouse, we are just exploring the possibility of having the firehouse take on the ambulance service," Conway said. "Given the nature of our last

The village is currently covered by Voorheesville Area Ambulance Service. The village signed a contract for the current year's service recently, but not before a contentious negotiation process.

Conway said he believes there is "some interest" among fire department volunteers to provide EMS service, but he was not sure if the interest would be enough for the village to pursue that option.

"Nothing is set in stone and nothing has been agreed to," Conway said. "The current ambulance service is insistent on being treated like any other vendor and this is what happens."

He said the village has also had "some very preliminary' investigations into possibly bringing in another service, along with "very preliminary" conversations with the Albany County Sheriff's Department taking it over full time. The sheriff's department covers the village from 6 a.m. to 6 p.m. already.

#### Allegations abound

VAAS Board of Directors Chairwoman Denise Garrah said problems with the village began in 2007, when the village and Town of New Scotland requested the service bill patients transported to the hospital to offset expenses.

The service did start billing for services provided, but Garrah said Conway criticized VAAS for not starting to bill quicker. Garrah added the bureaucracy around billing for services took some time to implement and some volunteers felt it was difficult to ask sick or injured patients what their insurance company was.

Garrah claimed for the

was about to expire. Conway balked at the allegation the board did not keep the ambulance service informed.

Also at issue have been meeting times and handling of finances. Conway argued the ambulance service has not been fiscally responsible, but Garrah countered since the service started billing patients its costs have been reduced dramatically.

Conway said the village is not trying to do a "power grab" for the ambulance service, but he is concerned VAAS cannot provide coverage 100 percent of the time.

"I don't want to be the guy standing there caught totally off guard and people start wondering what are you doing," Conway said, "and part of that is being fiscally vigilant on how the

money flows to them and what are they are using it for."

He said he understands the issue is "emotionally charged," because the volunteers are "very dedicated" and emotionally attached to the company. Board members haven't expressed and qualms over the quality of service being provided.

"I think we are both trying to do what we think its best for the village and village taxpayers," Conway said, "but we are just coming at it from different perspectives."

# From the Editor's Desk School's in session, so drive safely

Over the past few days, parents all over the Capital District have stood on porches and on street corners to wave goodbye to their progeny as they're whisked off by the school bus. For some, it was for the first time.

The start of school means the return of school buses to our roadways. As such, police and the American Automobile Association are reminding motorists drive with extra care, especially during the morning and afternoon rush. We'd like to add our voice to that call for safe driving.

The AAA figures 55 million kids are heading back to school nationwide, and about 13 percent of them walk or bike to school. Motor vehicle crashes are the leading cause of death for children from 5 to 14 years old, so be extra alert for kids out and about. Then, of course, there are school buses. On the way to work or to drop off the kids, a stopped school bus might seem like an excruciating obstacle. But it's best to simply give the commute a few extra minutes in the morning and remember why one must stop for a bus.

If safety isn't a big enough motivator, there's the law. Passing a school bus that has its red flashing lights on carries a minimum fine of \$250 and a maximum fine of \$400, along with five points on one's license. A second conviction carries a fine of up to \$750, and a third can cost up to a cool \$1,000. You can even be sent to prison over a conviction. Are the extra few seconds one might save worth the cost?

The law says motorists must stop for a bus with its flashing red lights on, even on a divided or multilane highway or on school grounds. Flashing yellow lights mean a school bus is preparing to stop, and drivers should slow down and prepare to halt.

Motorists should also be aware of school zones with lower speed limits – a speeding conviction in one of these areas will carry increased penalties, to say nothing of the increased risk to children trying to cross the street.

A pedestrian hit by a car traveling at 25 mph is 65 percent less likely to be killed that one hit by a car traveling at 35 mph, so it does make a difference.

So the next time you're running late and see those flashing red light up ahead, fight the frustration and try to keep things in perspective. A few extra minutes to make things safer for schoolchildren is not a huge price to pay.

# **Guest opinion Protect your garden from winter wildlife**

There's no doubt that managing critters in the landscape can be a challenge especially as food supplies start to dwindle. If you are battling with rabbits, deer, groundhogs or other wildlife, don't let down your guard as the growing season begins to wind down.

*Be proactive.* Start before they get into the habit of dining on your landscape. It is easier to keep them away than break the dining habit.

*Fence them out.* Fencing is the best defense against most wildlife. A four-foot tall fence around a small garden will keep out rabbits. Secure the bottom tight to the ground or bury it several inches to prevent rabbits and voles from crawling underneath. Or fold the bottom of the fence outward, making sure it's tight to the ground. Animals tend not to crawl under when the bottom skirt faces away from the garden. Go deeper, at least 12 to 18 inches, if you are trying to discourage woodchucks. And make sure the gate is secure. Many hungry animals have found their way into the garden through openings around and under the gate.

A five foot fence around small garden areas can help safeguard your plantings against hungry deer. Some gardeners report success surrounding their garden with fishing line mounted on posts at one and three foot heights.

Break out the repellents. Homemade and commercial repellents can be used. Apply before the animals start feeding and reapply as directed. Consider using a natural product that is made of herbs, safe to use and smells good.

*Scare 'em away.* Blow up owls, clanging pans, rubber snakes, slivers of deodorant soap, handfuls of human hair and noise makers are scare tactics that have been used by gardeners for years. Consider your environment when selecting a tactic. Urban animals are used to the sound and smell of people. Alternate scare tactics for more effective control. The animals won't be afraid of a snake that hasn't moved in weeks.

*Combine tactics*. Use a mix of fencing, scare tactics and repellents. Keep monitoring for damage. If there are enough animals and they are hungry, they will eat just about anything.

*Don't forget about nature.* Welcome hawks and fox into your landscape. Using less pesticides and tolerating some critters, their food source, will encourage them to visit your yard. These natural pest controllers help keep the garden-munching critters under control.

And most importantly, don't give up. A bit of persistence, variety and adaptability is the key to success. Investing some time now will not only deter existing critters from dining in your landscape, but will also reduce the risk of animals moving in next season.

# **Race battles the 'silent killer'**

#### 5K run/walk aims to raise ovarian cancer awareness and support research

The "silent killer" of women might not be making much noise, but a local nonprofit is making sure it's heard of.

The 12th Annual Teal Ribbon Run/Walk, coordinated by Caring Together, will be held on Sunday, Sept. 15, and kicks off at 9 a.m. at Washington Park in Albany. The event aims to raise awareness of ovarian cancer and raise funds to support research to developing an early detection test, along with more effective treatments for women with recurrent ovarian cancer.

Caring Together President Mary Davis said education awareness is the "best line of defense" against ovarian cancer. Davis is also a survivor of ovarian cancer after being diagnosed 15 years ago.

"If you don't know much about the disease it is an opportunity to learn and there is an awareness table there staffed by survivors. It is chance to talk to somebody that is well versed in it," Davis said. "It is a chance to talk a walk in a beautiful park, or if you are a runner it is a sanctioned 5K."

Race Director Pam Robbins said there is no effective screening tool for ovarian cancer, which leads it to be among the most deadly cancers.

"We are really focused on the fact there is no screening tool ... so they need more research dollars," Robbins said. "What we do with our money from the Walk/Run is we donate that almost exclusively to a couple of large research grant organizations.'

Caring Together also partnered with St. Peter's Hospital Foundation, Albany Medical Center Foundation and CR Wood Cancer Center at Glens Falls Hospital to provide financial assistance to Capital District women that are either uninsured or underinsured and have a high risk for ovarian cancer, or have symptoms of it. The group is also in talks to expand the program to other area hospitals. Women must qualify for the program by meeting income and resource requirements. Over the years, participation has grown from a small group of people to around 1,100, according to Robbins. The group is hoping to surpass a total of \$1 million raised from the event over the years, a goal that is in reach this year.



Ovarian cancer is particularly devastating because it often goes undiagnosed until the late stages. Many walk the Team Ribbon in memory of loved ones.

"There are many, many people who come back year after year and are committed to this cause," Robbins said. The number of survivors and families that are involved in this has turned it from where there was a couple hundred to over a thousand.

Robbins said many of the possible symptoms of ovarian cancer tend to get overlooked, which is exactly what happened to Davis.

"I blew it off for a while," Davis said. "I had felt so lousy for a couple of years and couldn't figure out why so my initial response (to being diagnosed) was, 'Wow, where do I go from here?"

The most common symptoms include bloating, pelvic or abdominal pain, difficulty

eating or feeling full quickly and urinary symptoms of urgency or frequency. The key, though, is if any of these symptoms last for more than two weeks.

The American Cancer Society estimates this year there will be around 22,240 newly diagnosed cases of ovarian cancer and more than 14,000 women nationally will die of ovarian cancer. Ovarian cancer is the tenth most common cancer among women, but it is the fifth leading cause of cancer related death for women, according to the Ovarian Cancer National Alliance.

The Alliance claims mortality rates for ovarian cancer have not improved over the past 40 years. It accounts for 3 percent of cancer diagnoses in women.

The five-year survival rate is 44 percent, but early detection increases that to 91.5 percent. Only around 15 percent of women are diagnosed early. The majority of women aren't diagnosed until the cancer has spread to distant organs or lymph nodes, which brings the five-year survival rate to around 25 percent.

From 2005 to 2009, the median age of ovarian cancer diagnoses was 63, according to OCNA. The four most prominent age categories of all diagnoses include 45 to 54 (19 percent), 55 to 64 (23 percent), 65 to 74 (20 percent) and 75 and 84 (18 percent).

Davis said putting a face on the disease through the race is important.

Caring Together was first formed in 1996 solely as a support group for ovarian cancer by nurse practitioner Debbie Cullinan, who helped organize it after being diagnosed. Cullinan died from her cancer, but the group has continued and expanded its cause and mission.

"My favorite part is just seeing all the survivors there and they remind me why I am doing it," Robbins said. "It makes me think of Debbie and reminds why I got involved.'

# **New home for Treasure Cove**

#### Church seeks a permanent spot for its long-running thrift shop

The First United Methodist Church of Delmar is looking to move its Treasure Cove Thrift Shop into a bigger location.

Representatives of the church appeared before the Bethlehem Planning Board on Wednesday, Sept. 4, to seek approval to move the store to its property at 135 Adams Street, across the street from the Kenwood Avenue church. The new location would be larger and allow for the store to be a permanent fixture in the community.

The Planning Board unanimously approved the site plan.

'Our proposal is to take over the entire building," said Treasure Cove Manager Linda Graf in a later interview. "We're doing (the move)

because every week our volunteers have to set up the store and take it down. It's a giant pain in the neck."

The church previously rented out the building's downstairs to several commercial businesses and rented apartments upstairs. Graf said they now believe the property will be better utilized by moving the thrift shop from the church's basement.

"The space we use now is used for other purposes during the week, like the choir and other church activities," Graf said. "So it's been a long road of taking down and setting up. It takes a lot of manpower."

At the end of this month, the thrift shop will be celebrating its 21st year in business.

Those wishing to visit the new store will still be asked to park in the church's parking lot. A sidewalk is being installed from the parking lot to the new shop, to make the building more accessible for the elderly and disabled. Some doors will also be widened within the building to make room for wheelchairs.

Graf said the goal is for the new shop to be open by Halloween, but it depends on how fast the sidewalk and renovations can be completed. If more time is needed, the backup

goal is for the shop to be

open by Thanksgiving.

Graf said the plan is for the downstairs of the shop to contain adult clothing. The upstairs most likely will be used for children's clothing and a reading corner. A separate section for household items and collectibles may also be added, depending on the space.

With the move, Graf said volunteers hope to be able to open the shop for additional hours.

"A lot of people want to come on the weekends, but we don't have the hours," said Graf.

Treasure Cove will remain open the longest on Tuesdays, but plans are to open on for four hours on Thursday, Saturday and Sunday.

Graf said with the new store, the church is also looking for additional volunteers. New cashier positions will be available, along with positions sorting donated items.

"We're very excited," Graf said.



"They have looked at the whole system, taken into account the number of units that are hooked up and evenly spread out the cost of this increased indebtedness, so that everyone is paying a proportional share,' Phillips said.

Gaughan said the idea behind charging every unit a \$90 annual fee was to spread the cost equally, because all users would be benefiting from the infrastructure upgrade. He said the committee "spent a great deal of time" analyzing the financial aspects.

The interest rate on the loan secured by the village for the project falls at 2.07

percent.

"We had no choice but to fix it," Gaughan said. "The question becomes, how do you pay for it?"

He said there will always be some people who don't like seeing their bill increase by even a penny, but the increase shouldn't be coming as a surprise.

The project is substantially finished, according to Gaughan, but there are still a few details that must be completed. The last 10 percent of the payment to the contractor is being held off until those aspects are completed.

He expected the small items to be completed by the end of the September. Construction on the project started in June 2010.

Narcotic Enforcement led an investigation that allegedly revealed Quinn illegally obtained methylphenidate, commonly known as Ritalin, in an amount that exceeded her prescribed dosage.

On March 5, Quinn allegedly went to a local nurse practitioner's office seeking a new prescription and claimed the pharmacy where she filled her previous prescription was only able to partially fill it with a month's supply, according to a complaint filed in Colonie Town Court by a state narcotic enforcement investigator.

But the pharmacy dispensed an 84-day supply only 28

days prior, according to the complaint, which included 270 tablets of 20 mg Ritalin. The felony charge stems from Quinn allegedly possessing more than 1 gram of a stimulant.

All documents filed in the town court, other than the complaints, pertaining to the case are sealed, because certain documents might contain confidential or privileged information, according to the court's seal order. These documents may include health information subject to privacy and security provisions, the order said.

# Learning a lifelong adventure at Bethlehem HILL

Institute dedicated to providing collegelevel courses celebrates 20th anniversary

Delmar retiree Barry Isenberg is versed in political affairs, international relations, Judaism, life in China and Islamic architecture. And that's just the beginning.

Isenberg is one of thousands of people in the Capital District who have attended college-level classes taught by local college professors thanks to The Humanities Institute for Lifelong Learning, or HILL, in Delmar. The program was founded in 1993 to enhance lifelong learning opportunities for the adult community in the Capital District.

HILL was the brainchild of Fred and Helen Adler. Helen Adler was a former English teacher at Bethlehem Central High School and a huge believer in lifelong education.

This month, the institute is celebrating its 20th anniversary.

Isenberg, who is also a member of the HILL coordinating committee, said what makes HILL unique from other local lifelong learning centers is that it is run by volunteers. The nonprofit group runs as an adjunct organization of the Bethlehem Central School District, which helps by distributing the HILL program brochure as an insert in the school's continuing education newsletter.

Isenberg said because of the connection to the school district, people often think you must be a Bethlehem resident to attend. This is not so.

"Initially, it was basically Bethlehem centered, but we've been trying to expand our reach to other areas of the Capital District," Isenberg said. "We have a number of people that come from Colonie, Latham, Albany and Voorheesville."

According to Isenberg, the institute has grown tremendously since 1993.

"Our first semester in the fall of 1993 - there were only three courses at that time – we had 155 registrants," Isenberg said. "Our last semester, we had over 550 registrations."

Isenberg said part of this is due to the larger number of courses available now compared to in 1993, although he said the objective is not to have a large number of attendees, but to have a nice mix of courses including art, literature, studies about foreign countries, political and economic courses.

"The political courses and courses about upcoming elections are always very popular and we get a lot of people there," he said. "One of our biggest courses was one on Shakespeare."

Professors come from local universities and colleges, including the University at Albany, Siena College, Albany Law School, Russell Sage, Skidmore College and Union College.

Alfred D'Alauro, a New York State retiree from Altamont who has been attending HILL classes for about 10 years, said some of his favorite courses have been given by Sheldon Solomon, a psychology professor at Skidmore College.

"He has come in a number of times," he said. "Psychology was one of my minors, so I was interested. He was a wonderful teacher."

D'Alauro said he generally takes at least two classes each semester and has his eye on an upcoming literature arts course.

Isenberg believes people continue to return each semester both for the social aspect and out of a desire to keep intellectually active.

"Most of the people who

go to our courses are very active people," he said. "We have a broad base of people – retired teachers, librarians, attorneys they may be retired from their profession, but intellectually they are extremely active."

Isenberg said it was his wife who first started taking HILL courses when she retired.

"She was a teacher in the Bethlehem School District, and she told me how great they were," he said.

It was then that Isenberg found he was hooked on learning.

"I find the courses extremely interesting and intellectually challenging," said Isenberg, who has

been attending classes regularly for eight years.

Campbell, who said she is most interested in history and current events, found she has been drawn to courses such as the Britain Empire in India taught by a professor from Skidmore. and another course about the Supreme Court.

two or three," she said. "The HILL committee does a phenomenal job year after year of coming up with interesting and different programs.'

Isenberg said the classes are focused more on discussion than note taking and tests, the way most would think of a college class.

"It's good to go to a class where you don't have to worry about tests or notes or homework," Isenberg laughed.

The classes are kept relatively small and are held in both the fall and spring.

Isenberg said there is often a misconception that students must be over a certain age to attend a HILL class.

"Because our courses "At this point I know a are held in the morning and afternoon, it's pretty much retired people, but we do get some younger people depending on the subject matter," he said.

> However, Isenberg said if you are looking for a class in "how to" do something, HILL is not what you are looking for.

"We don't do 'how-to' classes," he said. "We have had photography but more about photography as art and the history of

"A lot of times, I will do photography as art, but not how to take digital pictures."

> Isenberg said they leave that up to the continuing education programs at the school districts.

> D'Alauro said being an active lifelong learner has been an enlightening experience for him.

> "I wish my college experience was as rich as the one through HILL," he said adding that the courses he has taken have allowed him to explore topics he never had a chance to do.

> "It's one thing to pick up a book, but it's different to have a professor in the field presenting the subject,' he said.

> You have to wait until you get old to do that," D'Alauro laughed.

> The HILL fall semester begins Sept. 23 and each class meets six times for two hours. Courses being offered this semester are The Arab Spring, The Contemporary Novel, The Beatles, Judaism and the Origins of Christianity and the Presidency and Democracy in America. 





**NYS Writers Institute** announces season's **Visiting Writers and Classic Film series**

As the weather cools down the local literary world is heating up, as renowned writers make their way to the University at Albany.

The New York State Writers Institute recently announced its fall semester Visiting Writers Series and Classic Film Series, which kicks off Wednesday, Sept. 11, with fiction writer and essayist Jonathan Lethem and extends until the final event on Dec. 3 with author Ayana Mathis. All of the events are free and open to the public, with most writer events held at UAlbany's Uptown Campus and most films being shown at the university's Downtown in Albany. Campus in Page Hall.

"The Visiting Writers Series brings many of the best contemporary writers around to Albany for free visits with the audiences and readings. We do these afternoon sessions, too, where the writers talk about their work and answer questions." institute Director Don Faulkner said. "We got a lot of firepower here, but it covers a broad range from history to poetry to fiction writing, even to political writing and biography."

The state Writers Institute, hosted at UAlbany, was founded by Pulitzer Prize-winning novelist William Kennedy in 1983 and the following year Gov. Mario Cuomo signed legislation creating the institute as a statesupported cultural program. Since 1984, Faulkner said the program has been "going at a pretty high pitch," with more than 1,000 writers sharing their work.

"The institute has been doing this for nearly 30 vears and it is really a mainstay of the art scene in the Capital Region







"It's good to see them come back and be committed, but the Fall Festival brings us people who we haven't seen the rest of the year or may be their first introduction to the site."

Five Rivers is open year-round, and has more than 10 miles of hiking, snowshoeing or cross-country skiing trails for public use on its 450 acres. Thousands of students take field trips to the center every school year.

The festival is a collaborative effort between the state DEC and the Friends of Five Rivers group. About 2,000 people attend the event each year.






