Bethlehem eyes abandoned building

Building Dept. asks to secure property, board reaches out to bank

Officials from the Town of Bethlehem Building Department have asked the Town Board for permission to secure an abandoned building on Monroe

Town Building Inspector Gil Bouchard said a fire destroyed the home at 46 Monroe Ave. last November. The building was severely damaged and deemed

Nobody has been living in the home since the fire and the bank has since taken over ownership of the property. Bouchard said the department has received complaints from neighbors about the building and recently, children and teens have been caught inside.

"It's an emergency situation," Bouchard said in an interview prior to the Town Board meeting of Wednesday, Sept. 11. "We've been getting calls and it's

dangerous."

Bouchard said the Building Department hasn't been able to get a response back from the bank or the former owners. Officials were seeking permission from the Town Board to board up any windows or doorways that are open to keep out trespassers.

Guilderland Dems fend off primary challenges

GOP candidates fail to grab Independence or **Conservative lines**

Guilderland Democrats overcame opportunity to ballot challenges from town Republicans vying for Independence Party lines, and also fended off GOP challenges for Conservative slots.

Town Democrats secured all contested third-party ballot lines during the Primary Election on Tuesday, Sept. 10, according to unofficial election results. Democratic

Independence lines for in challenges for the two Town Board seats, town clerk, receiver lines for two Town Board of taxes and two town justice seats. Democrats also prevailed in Conservative Party primary battles for Town Board and town justice Patricia Slavick and Paul ballot lines.

Independence candidates for the town now include incumbents Pastore for Town Board. Democratic Jean Cataldo for town clerk, Lynne Buchanan for receiver of taxes and Richard Sherwood and incumbent Denise Randall for town justice.

Slavick, Pastore, Randall and Sherwood also secured Conservative Party approval for their respective races.

Slavick received 147 votes (37 percent) and Pastore garnered 137 votes (35 percent) on the Independence primary for Town Board, with 112 write-ins cast.

Republican Lee Carman, who is a county legislator, had his name on the ballot for the Conservative Party primary for Town Board

and received 82 votes (28 percent). Pastore, however, garnered 87 votes and Slavick received 99 votes, according to unofficial results. There were also 21 write-ins cast in that race.

Democrats Randall and Sherwood handily secured Independence and Republican ballot lines for town justice against Republican candidates Christopher Aldrich and Stephen DeNigris, the latter of whom a registered Democrat endorsed by the town GOP.

The Independence town justice primary saw Randall securing 152 votes (37 percent) and Sherwood receiving 138 (34 percent), with Aldrich and DeNigris trailing at 58 and 45 votes, respectively, according to unofficial results. There were also 13 write-ins cast.

Similar results were seen in the Conservative primary for town justice, with Randall holding 112 votes (35 percent) and Sherwood garnering 108 votes (34 percent). DeNigris had 42 votes and Sherwood had 38 votes, along with 18 write-ins cast.

Three prevail in highway primary

Meredith, Hyer, Ritz make tracks to general, while Zeoli out of running

Three winners have emerged from the primary election for Bethlehem Superintendent of Highways.

Voting took place from noon to 9 p.m. on Tuesday, Sept. 10. Poll workers said voting was generally slow throughout the day and dropped off steadily after 7 p.m.

In the Democratic race, Brent Meredith handily won his challenge against nominee Frank Zeoli, 1,418 - 659. Meredith had the backing of Town Supervisor John Clarkson, and said after the race he felt his campaign's message was what resonated with town Democrats.

"I think Frank ran a great campaign, and I just told him so on the phone, but I think our message got out that we need a qualified person in this position," Meredith said.

The Democratic candidate said his campaign has begun talking about minor tweaks they will be making before heading to the Nov. 5 general election. Meredith said he also plans to speak more in-depth with Highway Department employees.

In the Republican primary, current highway manager Howard Hyer beat Building Department employee and GOP nominee Terry Ritz, 478 - 337. Hyer thanked Republicans for coming out to vote and said he believes his experience helped him win.

"I'm happy with the results," he said. "I worked really hard and talked with a lot of Republicans ... I think they understand I was someone with experience and years in the department and it was successful for me."

Hyer said he would take a few days off before beginning to regroup for the general election, but said he is ready to take over the job come 2014.

"I have the experience, I know the guys and I know how to handle the budget," he said.

Ritz said he was frustrated that only 13 percent of the town's enrolled Republicans turned out.

"It was a lot of work for little return," he said. "Luckily, anyone can vote in the General Election, not just those enrolled in a certain political party."

Even though he lost the Republican line, Ritz was nominated on the Conservative line and faced no challenger there, leaving him a slot in the General Election.

Ritz beat Zeoli 100 votes to 86 votes on the Independence line. The results of this race mean Zeoli was the only primary candidate to be left without a spot in November's General Election.

"I'm disappointed Frank didn't make it," said Ritz. "I thought he did a great job during the debate."

Zeoli could not be reached for comment.

Justice races shake out

In the primary races for Bethlehem town justice, Andrew Kirby beat Matthew Kelly for the Democratic line 1,199 votes to 887 votes. Kelly, however, was able to stay in the race on both the Independent and Conservative lines, the latter of which he won over Dale Denoyers, 52 - 22. In the three-way Independence primary, Kelly garnered 89 votes, Kirby 78 votes and Desnoyers 38 votes. Desnoyers retains the Republican nomination.

Bethlehem turns out for primary

The results of the Bethlehem highway superintendent primaries are in.

One question that has been reverberating around the Spotlight newsroom in past weeks didn't have to do with which candidate had the advantage or how the results would shake out. It had instead to do with the electorate.

We wondered whether the interest in the highway superintendent position would carry on through to the primary. You'll recall in that in April there was considerable excitement regarding a public referendum to abolish the elected position and turn the post into an appointed job. That translated into turnout – 5,055 residents turned out to a single polling place to cast a paper ballot on a single issue. The referendum was resoundingly defeated, clearing the way for Tuesday's primary

So going into the primary, the question was, would this fever pitch interest carry through? Going off of unofficial results for votes cast in the highway superintendent primaries, 3,252 residents showed out to vote in the races. So less, right?

Well, the answer's not quite that clear cut. Only Democrats, Republicans and Independence Party members had the option to vote in the highway race thanks to New York's closed primary system. So while there are about 25,000 registered voters in Bethlehem, only 18,158 were eligible to vote on a highway race. That comes to an effective turnout of about 18 percent, two

points under the turnout for the townwide referendum itself.

So it would appear interest did not wane, or at least not by an appreciable margin. In fact, Democrats came close to matching the turnout seen in the contentious 2011 Kotary-Clarkson primary.

Still, we'd be remiss if we didn't point out having one-in-five eligible voters bother to go to the polls is hardly reason to throw a party in the name of civic engagement. So now, as we turn our attention to the general election, we hope you'll mark Nov. 5 on your calendar and keep your eyes on our pages and our upcoming candidate forums in anticipation of coming out to the polls to make an informed

Vista already a net positive for town

As chairman of the Town of Bethlehem Industrial Development Agency (BIDA), I am writing to provide important information to the residents of the town about the role of the BIDA in economic development projects and in particular about our role in the advancement of the Vista Technology Park over the past eight years.

The BIDA is a public benefit corporation separate from the Town of Bethlehem whose seven members are appointed by the Town Board and who serve without compensation. Each member is a resident of the town and pays taxes to the town and school district. The BIDA is regulated as a local public authority by the NYS Authorities Budget Office (ABO) and the Office of the State Comptroller (OSC). The ABO has stated that IDAs "are intended to function as independent public corporations, governed by boards of directors and free of direct governmental control and political influence.' The BIDA's mission is to attract and retain high quality jobs and capital investment to the town by focusing on appropriate commercial, industrial, manufacturing, warehousing, educational, research and recreational projects. The tools available to the BIDA include the ability to grant exemption from certain taxes (sales tax paid on construction and other purchases, mortgage recording tax, real property tax abatement and issuance of tax-exempt bonds). The BIDA does not lend

All of our meetings are public, noticed in advance and attended by members of the public. In 2012, we began webcasting our hearings on potential projects, using the town's new system. We are now considering extending the use of this system to our regular meetings as well.

As far back as 2005, the town promoted the Vista Technology Campus as desirable economic development that would produce significant tax revenues for the town, Bethlehem Central School District and Albany County. Vista has been supported by a succession of supervisors and Town Boards as a key economic development goal. The town zoned Vista as a "mixed economic development" district and in 2007 approved a master plan which described the types of businesses that could locate there. The BIDA was not involved with the zoning of Vista.

In 2011, after seven years of promotion, Vista was still vacant. At that time, the developer packaged ShopRite, Berkshire Bank and SEFCU as the first prospective tenants, but said that those tenants would not commit to Vista unless they received enhanced abatements because there were substantial challenges to bringing businesses to a completely undeveloped site. The dilemma was this: the town had been trying for seven years to develop the site without success; would occupancy by the first retail tenants be a catalyst to bring desired development to Vista? At a hearing regarding the abatements in 2011, then Supervisor Messina, as well as representatives of the Bethlehem Central School District supported

the use of enhanced abatements. After careful consideration, the BIDA decided that providing the enhanced abatements was the proper decision. Based on new tax revenue to the town. school district and other tax jurisdictions, our decision has proved to be the right one.

In 2011, Vista tax revenue for all local tax jurisdictions was about \$16,000 for the undeveloped property; in 2014 the property taxes, PILOT payments and water fees will total over \$230,000; in 2015 and beyond they will be higher still. In addition to the three initial projects, four additional projects have been built: two medical office buildings with standard real property tax abatements and two retail buildings with no real property tax abatements. Vista is already a net positive for local government, and at full development – which will take many years - it will provide substantial tax revenues. Since the Vista campus is now actively being developed, the BIDA has adopted a policy that retail projects will not receive abatements absent compelling justification.

In 2013, the developer applied for exemptions on another building to house technology businesses. The developer represented that a technology tenant engaged in medical research would occupy part of the building, along with other possible technology tenants. This promised to bring the first scientific and technology uses to Vista. Once again at a hearing on the project, the supervisor, school district and others urged the BIDA to grant an enhanced abatement. The BIDA analyzed the costs and benefits and determined that the total cost of the enhanced abatement and tax exemptions would be offset by substantial new tax revenues. Additionally, the BIDA granted tax exemptions because the BIDA believed that other technology users would follow once this building was constructed and occupied. At present the developer is negotiating with potential tenants and may or may not proceed with the building. However, it should be noted that if qualifying tenants do not occupy this building the enhanced abatement will not be provided.

The BIDA has never granted an exemption that was not supported by representatives of the town and the school district. We value the opinions of our residents as well as those of the town and school district leaders. We have and will continue to seek such input to facilitate public discussion of the costs and benefits of each potential project. The BIDA will continue to serve the residents of the Town of Bethlehem by working to attract good corporate residents to our community.



Town votes to combine ambulance districts

Bethlehem brought under single tax rate after EMS merger

Bethlehem's two volunteer ambulance agencies merged at the beginning of the year, and now the Bethlehem Town Board has voted to dissolve the town's separate ambulance districts.

The vote was taken on Wednesday, Sept. 11, following a public comment period on the plan. No members of the public spoke on the topic.

Because of the town's three separate taxing districts, residents were paying different tax rates for ambulance service depending on where they lived. With the dissolution of the districts, all Bethlehem residents will be paying the same rate for ambulance service.

"This is about accountability to our residents," Supervisor John Clarkson said.

In January, Delmar EMS and Bethlehem EMS combined into Delmar-Bethlehem EMS, following a September report from the town's District Board of Ambulance Commissioners that concluded money could be saved if the two agencies joined forces. Originally, leaders of the two groups felt Jan. 1 was an unrealistic target date to complete the restructuring. But after several months of working

together, the consensus is the project went smoothly.

"These folks are not only doing an excellent job distinguishing themselves and attracting volunteers, they're also helping us lower costs," said Clarkson.

The District Board of Ambulance Commissioners was created under former Supervisor Sam Messina in July of 2011 to look into the rising cost of emergency medical services. The group's report found a

"great variation" existed between services provided in the southern and northern parts of the town.

Through the merger, insurance and vender costs were reduced. Practices and procedures are now also the same throughout the agency and all volunteers are familiar with those measures. In addition, all ambulances have been set up exactly the same way so every one is equipped to the same standard.

Gymnastics!

The property tax rate is expected to decrease for all residents to around \$30 for a home assessed at \$250,000.

Clarkson said he wants to work to eliminate dispatch charges for the town and has been working with Delmar-Bethlehem EMS to reduce the fees for the coming years. The \$275,000 in fees expected for this year will be offset by partial use of the Local Government Efficiency Award the

town received in June.

Along with the combination of the three tax districts into one, additional changes will also come for North Bethlehem residents. By Jan. 1, 2014, all those living in North Bethlehem will no longer have to pay co-pays or deductibles for ambulance services. Residents

annually pay about \$13,700 in co-pays now. Those fees will be waived.

The dissolution resolution was unanimously passed by the Town Board. Many of the changes that come with the resolution are already taking place. Others will begin as of Ian. 1.

Retirement straight talk

mericans are not saving Another source of enough for retirement. This is hardly breaking news. When measured against accepted benchmarks—85 percent replacement of preretirement income or 50 percent of preretirement income if you factor income from Social Security—a recent report by the National Institute on Retirement Security states that we're about \$14 trillion short on savings for retirement.


Fortunately, doing a better job saving for retirement isn't insurmountable. Americans have been overcoming challenges since we were colonists. I was recently reminded of this when traveling to Concord, Mass., with my son and we walked along the path where our country's history was forged.

So rather than weighing vou down with demoralizing statistics, this article will attempt to lift you up by offering a different perspective on retirement planning.

You are your money manager The advent of the 401(k) turned everyday workers into money managers. The 401(k) was originally a supplement to a worker's pension. However, with pensions having gone substantially in the last two bear

Here's the problem. If you are like most American workers, and statistics suggest you are, you're both ill-equipped and ill-prepared to manage your retirement assets. Making decisions about how much risk to take, which assets to invest in and how much you should invest can be a daunting task. Even with a wealth of information on a full range of investment topics at our fingertips, history suggests we need to step back and consider how much risk we're really taking, regardless of the advice we're receiving.

Risk is a three-legged stool Retirement assets declined

Risk is a threelegged stool, yet most investment tools, data, and so forth are geared toward only one leg, and here lies the problem. The three legs are comprised of a worker's willingness, ability and need to take risk. It is one's willingness to take risk that gets all the media attention.

Think back to when you received advice or read about investment risk. You may recall the following question: "What is your risk tolerance?"

Or perhaps you were told what your risk tolerance was based on your age. But did you happen to consider or were you ever advised about how much risk you actually need to take to meet your goals?

The answer to how much risk vou need to take can be found in modeling your retirement using probability analysis. You may be surprised to find you can take less risk and still achieve your goals. Think of it this way. If two horses were running in the fifth race at Saratoga Race Course, other horse with 10-to-1 odds, which horse would you bet on if your goals were met regardless of which horse won?

Risk is not exclusive to investments

We face risks throughout life and at different times we must decide whether to accept the risk ourselves or transfer it—in part or in full.

Think of your life as a risk cycle. Early in your career you face risks pertaining to medical costs, property damages and personal liability. As you move through the cycle you may need to consider family members who are dependent on you and manage the risk of unexpected income loss resulting from a disability or death. Later in the cycle, you may have accumulated more assets, such that you need to reevaluate your personal liability risks, the need to further protect your income and how to manage the risk of paying taxes on your accumulated assets.

Last, as you model your spending for retirement, you are faced with the possibility of unexpected expenses, namely skilled and unskilled care costs. As you did earlier in the risk cycle, you must decide to either accept this risk and its inherent costs or opt to transfer the risk in part or in full. Of course, risk transfers do come at a premium,

away for many people, 401(k) markets, which suggest workers one with 3-to-1 odds and the but perhaps it's better to hedge your bets than a simple roll of the dice.

> Ask yourself this question: if you had the option to live in 100 percent of your home with no coverage for damages or 95 percent of your home with full coverage against loss, which option would you choose?

> Now imagine that your income, investments and assets make up your "financial house." Given the same question, what would you do? Live such that you use all your financial assets with no coverage for damages or use 95 percent of your assets and protect them from an unexpected loss? In both scenarios, the latter seems more prudent.

> Last, if you are in the midst of college planning, remember what the flight attendant recommends prior to takeoff. "If you are seated next to a child, please place the oxygen mask on yourself first, and then place the oxygen mask on the child." In other words, pay yourself first. Your own financial independence is an immeasurable gift to your child—and yourself.

ave you ever seen the commercial with Robert ■Wagner on the benefits of reverse mortgages? He calls it a "retirement loan" and tells viewers: "It's a loan that pays you."

For many, a reverse mortgage reversing the process of paying off your mortgage so that the lender is making monthly payments to you against the equity in your home—seems counterintuitive to the American Dream. However, a reverse mortgage can be a great tool... provided it's used properly. Yes, the fees can be relatively expensive. Yes, depleting equity in your home by taking income distributions against it decreases your estate, which leaves less to your beneficiaries. But you can't live in your investment portfolio so this is where taking a different perspective is helpful.

Let's travel back in time to April 15, 1912—the sinking of the Titantic. Assume you are a secondclass passenger . . . with a ticket on a lifeboat. After you arrive on the ship, you find an offer in your room to move up to first class, but there is a caveat. You must give up your seat on the lifeboat in exchange for moving to first-class. Would you do it?

My point is this: reverse mortgages should be used like a lifeboat. If your "financial ship" begins to take on water and it appears you're sinking, get to the lifeboat. Don't go down with the ship—water doesn't discriminate between the classes. Cover your needs rather than your wants. It may come at a cost, but expense is a relative, situational term. I wouldn't pay the same amount for a lifeboat in dry dock as I would for one on the Titanic.

Also, today's reverse mortgage is very different from what it once was. For starters, the FHA implemented regulations in 1993 to ensure homeowners retain the title to their home. Provided the borrower remains current on tax and insurance payments, the loan does not need to be repaid until the home is sold or otherwise vacated. The FHA also added protections against declining home values and made fee schedules fully transparent.

If you're considering a reverse mortgage, you should consult with your financial advisor to learn more about the fees, payout schedule and borrower responsibilities.

Gap closed on Rail Trail repairs

New Scotland Town Board awards \$4,500 to complete bridge work, open trail

A bump in the road to opening another section of the Albany County Rail Trail has been cleared after New Scotland bridged a financial gap.

The New Scotland Town Board on Wednesday, Sept. 11, approved donating \$4,500 to the Friends of the Rail Trail to complete bridge renovations to open up a section of the Rail Trail from Upper Font Grove Road to the Route 155 bridge. The county would not allow trail work to continue on this portion until necessary improvements were made to the Vly Creek bridge and Route 155 bridge.

Town Highway Superintendent Ken Guyer said this portion of the trail was only open to volunteers helping clear the trail, but that hasn't stopped people from using it.

"It does got a lot of use," Guyer said. "It sees a lot of walkers."

Town Supervisor Tom Dolin said the funds could be drawn from the parkland set-aside fund. "This thing is not going to get open unless we help, and for this amount of money, if it will get it open, I think we should do it. It doesn't trouble me to help out getting the bridges fixed, because mostly people from this town will use those bridges."

The New Scotland Town ard on Wednesday, Sept., approved donating which is reserved for park improvements.

"This thing is not going to get open unless we help, and for this amount of money, if it will get it open, I think we should do it," Dolin said. "It doesn't trouble me to help out getting the bridges fixed, because mostly people from this town will use those bridges."

Dolin said the town "hardly uses" the set-aside funds.

In June 2012, the Mohawk-Hudson Land Conservancy reached an agreement with the town, Village of Voorheesville and Albany County to open a 2.4-mile section of the county's Helderberg Hudson Rail Trail. In the summer of 2011, a 1.8-mile trail section was opened in Bethlehem through volunteer work and donated funds.

Friends of the Rail Trail member Scott Lewendon said "rather simple" improvements are needed at the Vly Creek bridge, including installation of a wood deck and railing system. Volunteers would complete this construction.

The improvements needed at the Route 155 bridge are more complex, such as installation of an 8-foot-tall pedestrian safety fence on each side of the bridge to meet Department of Transportation standards. An outside contract is needed to complete the estimated \$13,000 worth of renovations.

In April, request for proposals was sent out for the work, but there were no responses, Lewendon said. He asked some potential bidders what happened and heard there wasn't enough work for a fencing contractor to make a profit from the job.

By speaking with Jack's Constructing in Selkirk, Lewendon found there to be significant costs in traffic control and insurance. Just setting up safety netting required at the job site would also be more expensive than the fencing itself.

After meeting with county officials about the predicament, Jack's agreed to handle traffic control for no cost to the group. A "minor" design change was also made to the fencing. This resulted in a \$17,000 estimate.

"That is their best price, but we were still short of money," Lewendon said.

The Voorheesville Community and School Foundation contributed \$10,000 and the Mohawk-Hudson Land Conservancy compiled its restricted funds and donations for \$7,076.

The cost to complete the project includes an engineering fee of \$1,000, the construction contractor bid at \$17,000 and the materials for the Vly Creek bridge totaling \$3,515. The \$21,515 project was at a shortfall of \$4,500.

"We are crying humble and we are coming to you ... if you would consider donating \$4,500 to partner with all the rest of the organizations," Lewendon said.

"We are trying at this point to rev things up on the New Scotland section," said Mark King, director of the Mohawk Hudson Land Conservancy, said. "We are hoping to have an event this fall and we are hoping the town might participate that event to draw attention to kind of keep the county motivated to keep working on this and motivate local folks to help us out getting this thing opened.'

King said years ago, he believed this portion of the trail would have already been opened.

"I started working on this project 20 years ago and I thought pretty sure by now we would have a trail," King said, "but I guess I underestimated."

Firefighters honor those killed in terror attacks

Members of the Selkirk Fire Department were joined by members of the Elsmere and Delmar fire departments in a ceremony on the evening of Sept. 11, 2013, to honor the lives lost in the terrorist attacks of 9/11. The names of the 343 firefighters that perished were read by the firefighters and members of the public.

This was the third year the department has held the ceremony. It is meant as a way not only to remember fallen brothers, said Selkirk Fire District Chief Bill Asprion, but also to pay respect to the 2,977 victims of the terrorist attacks.

"Those firefighters that we lost fought to the end," Asprion said. "Part of the reason we're here is to help them rest in peace."

The reading took approximately an hour, including opening and closing statements. Daniel Silvernail, 10, also



played the bagpipes to both open and close the ceremony. The event was held inside the vehicle bay of Selkirk Fire Station No. 2 in Glenmont, which shielded the attendees from stormy weather outside.

The ceremony was briefly interrupted at around 7:30 p.m. when a call came in for downed wires. Selkirk firefighters shed their dress uniforms and jumped into gear before pulling away in an engine. They returned

The market table will be offering a selection of t-shirts, garden and cook books, and other items, including a 50/50 raffle which helps support our music program and free coffee.



Burch said while he "ordinarily would be watching the Yankees," he thought it was important to voice his support for sustainable practices. He said it was important to "take small steps" to make improvements, such as the plastic foam ban.

Several other people spoke in favor of reducing the county's environmental impact. The **Environmental Protection** Agency has determined the polystyrene manufacturing process is the fifth highest producer of hazardous waste nationally.

Paula Brewer, of Cohoes, said people generally haven't been as focused on reducing consumption when compared to recycling and reusing.

"As I look around and see the growth in disposable items, I think we need to start embracing that first

'R," Brewer said. "Not everything is recyclable, nor will it ever be, not everything is reusable, so I think we need to think about actually reducing our impact on the environment."

Another contested issue is possible negative health effects of using plastic foam containers for food and beverages. Brewer, who identified herself as a nutritionist, said removing toxins from our environment could help improve people's health and reduce the

prevalence of obesity.

Daniel Morrissey, environmental chairperson for the Aurora Foundation, a nonprofit advocacy group, said the **Environmental Protection** Agency determined people have some styrene in their body. The EPA also determined the chemical may leach from polystyrene containers

used for the food industry.

According to the EPA, people exposed to levels of styrene exceeding regulations for a short period of time may experience nervous system effects such as depression, loss of concentration, weakness, fatigue and nausea. Those exposed to it at high levels for a lifetime may develop liver and nerve tissue damage, along with cancer.

"That is from some

type of exposure, whether it is from the water supply, through a heated Styrofoam container ... or possibly an air contamination,' Morrissey said. "Fifteen percent of all urban litter is polystyrene."

Sandy Steubing, of Albany, urged legislators to listen to county residents over any lobbyists fighting the ban.

"I would be very surprised if a resident from the county would come forward today and speak in favor of Styrofoam without being paid to do so," Steubing said. "Please listen to us: the unpaid voters who live here in this county."

Nobody spoke against the proposed ban at the meeting, but there also was no agenda items relating to the local law. Natalie Nussbaum, of Colonie, didn't see any good reasons for businesses to continue using Styrofoam.

"There is really nothing good to using Styrofoam. It is all harmful and bad in many ways," Nussbaum said. "Many (businesses) have switched over voluntarily ... and are doing very well after making the switch.

"It is important for our environment. It is important for our health. It is important for our future," she continued.



Glenmont man's short stories drawing from Vietnam experiences arranged into book

Good, bad or indifferent, much has been said about the experience of the American soldier in the Vietnam War. But less so through a Vietnamese

The collection of stories in Redwood's book "Love Beneath the Napalm," stretches across several settings, including the former imperial capital of Hue at the end of the Nguyen Dynasty, Hanoi after the American pullout from Vietnam, the Chinese invasion of Vietnam in 1979, contemporary San Francisco and even Schenectady, where his

award-winning story is set.

"Love Beneath the Napalm" is the story of Vietnamese man scarred by napalm who ends up working in a Schenectady restaurant, and the reactions others have toward him

Vietnam has heavily influenced his writing, but Redwood believes it's a subject whose complexity Americans should tackle.

Vietnam problematic and it is difficult for us to really deal with what happened there, because we lost the war. That was something that was new in the American experience," Redwood said. "If we looked at it a little more objectively the reality is most countries have lost some wars and won some wars."

As the Vietnam War begins to fade from the American conscience, he believes it is also important for people to not forget it.

"I think you learn more from your mistakes than your successes sometimes," he said.

admires the autumn color from high above. This weekend, close to 100 will launch into the open sky for the four-day Adirondack Balloon Festival, now in its 40th year.

The festival began in 1972 in an effort to bring tourists to the area after Labor Day.

"It started with a few balloons and then 18 balloons the following year," Donahue said. "Now it is the largest ballooning event on the East Coast and largest not-for-profit free ballooning event in the nation.

Donahue said people come from all over the world to showcase their balloons at the festival.

"We have some balloonists that have been here 30 to 40 years," he said. "The event is one of those must-attend events for balloonists. There is a waiting list."



film before. They began by doing extensive research on the mummies. Next, the pair reached out to the Institute and the Albany Foundation about making a documentary, and found friends who work as professional crewmembers in Hollywood to help with production.

"We sort of pulled together this group of people," said Valentis. "We didn't know what we were doing, but Bill and I wrote the script and eventually pulled the film together."

Old assumptions put to the test

Brown purchased the mummies from officials at the Cairo Museum during a trip to Egypt more than a century ago. Curators had told Brown one of the mummies – the oldest one is now about 3,000 years old-was female. The other, which was unwrapped so Brown could verify that they really were mummies, was said to be male and born in the Ptolemaic era around 300 B.C.

Brown had the mummies sent back to Albany by steamboat, where they've stayed for more than 100

"I had first seen the mummies in third grade

on a field trip at the Institute when it was down on Washington Avenue, as I'm sure many other people have." said Valentis. "They've become part of the Albany lexicon."

In 1988, Albany Med and the Albany Institute partnered to perform several scans on the mummies. X-rays were taken that showed some organs wrapped in cloth, but for the most part little new was learned. The Institute still believed they housed one male mummy and one female mummy. However, updates in technology would help dispel those assumptions 30 years later.

Unraveling the

Valentis said it was Bob Brier, an Egyptologist at Long Island University, who had doubts about the female mummy's actual sex. The coffin that the mummy was sold with included hieroglyphics that suggested in life, the mummy was a male sculptor and ancient priest.

"We were excited to find out the truth," said Valentis.

The crew was able to shoot footage for the entire documentary in one day. They began by getting shots of the two mummies being transported from the Albany Institute to Albany Med by UAlbany's studentrun, volunteer Five Quad

ambulance service. While writing the script, it was actually Rainbolt's idea to get the university's ambulance service involved.

"They were extremely careful while moving them," said Rainbolt. "It was amazing to see the reverence for what was going on here through the whole process. Even the technicians took the same approach."

At the hospital, CT scans and new X-rays were performed over the course of a day. The film crew was allowed to get very close while the procedures were being done and also used the time to speak with the medical professionals and Egyptologists present.

In March of 2013, a year later, the results from the tests were announced. Tests confirmed the mummy that had been presumed female over the decades was actually a man.

Scans indicated the older mummy had the narrow pelvis of a man. Other indicators included an angular jaw, hooded eyebrow ridges and the fact his right arm was longer, suggesting he may have commonly used tolls like a hammer and chisel.

Valentis said the experience was "amazing and stunning."

people who lived at one time," said Rainbolt. "Sure, it was several thousand years ago, and their time and culture was a lot different than ours, but in other ways they are just like us."

The former professor said the two men probably asked questions about the meaning of life and what comes after death.

"Mummification is what these people had for dealing with those questions," he

Rainbolt said he believes our bodies leave a record of how we lived our lives, and these mummies are no different. By examining them today, medical professionals can find out how they lived, what diseases existed at the time

"These are just two or if they suffered from stress like we do now.

> The idea now is to let the mummies rest for some time. Perhaps in another 30 years further medical advancements will mean more can be learned about the two Egyptian men.

> "This is really a journey story," said Rainbolt. "It's about two people not connected in any way during their lives but have been together since they were bought in Cairo and housed in Albany."

> Both Rainbolt and Valentis called the entire experience "moving."

Crab, Dingbat and Pigheaded will appear.

The event begins on Thursday, Sept 19, at 4 p.m. in Crandall Park in Glens Falls with the launch of 20 balloons. Events then move to

the Floyd Bennett Memorial Airport in Queensbury through Sunday afternoon with closing ceremonies and a final balloon launch once again in Crandall Park.

Donahue said it is important to read the schedule of events. Although activities are going on all day at the airport, the balloons only fly at certain times of the day due to weather.

"Balloons fly close to sunrise and sunset because of the wind midday, but there is activity going on all day," he said.

Airport gates will open at 3 p.m. on Friday and more than 80 balloons are scheduled to launch at 5 p.m.

Saturday and Sunday mornings kick off with a "Big Balloon Breakfast" at 5 a.m. when one of the airport hangars will be converted into an all-youcan-eat pancake breakfast. Food vendors will serve food all day beginning at 6 a.m. Various kids activities, a craft fair and live music will be ongoing Saturday and Sunday. On Saturday, balloons launch at 6:30 a.m. and 5 p.m. The balloons will light up the night at 8 p.m. that night when more than 20 balloons are tethered to the ground after dark.

"The balloons glow. It's quite a show for people to see," Donahue said.

At 6:30 a.m. on Sunday, 100 balloons will lift simultaneously for what is called Walter's Mass Ascension.

"Walter was a co-founder who ran it for many years and passed away two years ago. We dedicate the Sunday morning launch to him. We encourage balloonists to wait for a set time and everyone lifts off at the same time," Donahue said. "It's an awesome sight to see."

Donahue said seeing the brightly colored balloons against the blue sky and the backdrop of the Adirondack mountains has an effect on everyone, young and old.

Special VIP parking will be available at the airport's main entrance for \$15 for the weekend. Parking passes can be purchased online at the festival's website, ww.adirondackballoonfest. org, where there is also a complete schedule of events.




